Job, price rise, LAC to heat up Winter Session

EWS quota, women reservation Bill, collegium system also in Opp basket

PNS NEW DELHI

Ahead of the Winter Session
Of Parliament beginning
Wednesday, the Opposition parties on Tuesday demanded discussion on a slew of key issues, including unemployment, price rise, quota for the EWS sections, and situation at the Sino-India border in the allparty meeting called by the Central Government. The issues are set to be raised by the Opposition during the Winter

In the meeting, the Biju Janata Dal (BJD) pitched for the passage of the long-pending women's reservation Bill in the Winter Session. The onethird reservation for women in the Lok Sabha and State legislators was also raised by the TMC, the JD(U) and the SAD parties in the Business Advisory Committee meeting called by Lok Sabha Speaker

The session would proceed amid the key poll outcomes of Municipal Corporation of Delhi (MCD), Gujarat and Himachal Pradesh Assembly

polls.
Exit polls on Monday pre-

dicted a big majority for the BJP in Gujarat and a dead heat in Himachal Pradesh where most pollsters gave an edge to the ruling party over the Congress. The session which had to be delayed by a month due to the Gujarat election schedule would witness the Government introducing 16 Bills during 17 sittings of the

Leaders from more than 30 parties attended the all-party meeting to discuss the legislative agenda and the issues likely that would be taken up during the Winter Session of Parliament.

The meeting was chaired by Union Minister and Deputy leader of the BJP in the Lok Sabha Rajnath Singh. Leader of the House in the Rajya Sabha

Pivush Goval Parliamentary Affairs Minister Pralhad Joshi were also present. Talking to reporters after

the meeting, Congress leader Adhir Ranjan Chowdhury said, There are so many issues before the country, such as unemployment and price rise, and the Government owes an answer to the people."

'Morally wrong': Ukraine slams India's oil import from Russia

Aday after External Affairs Minister S Jaishankar defended India's decision to buy oil from Russia during the ongoing Ukraine conflict, the Ukraine Foreign Minister on Tuesday said it is "morally inappropriate."

Ukraine's Foreign Minister Dmytro Kuleba also said, "The opportunity for India to buy Russian oil at a cheap price comes from the fact that Ukrainians are suffering from Russian aggression and dying

Making this assertion in an interview to a private television channel, the Ukrainian Minister said, "If you benefit because of our suffering, it would be good to see more of your help addressed to us."

Jaishankar on Monday said India's decision to buy oil from Russia was largely driven by market forces adding the European Union (EU) has bought more oil from Russia than India during the last few months, External Affairs Minister S Jaishankar said.

Jaishankar's assertion came during his talks with visiting German counterpart Annalena Baerbock. "The European Unions from February to November have imported more fossil fuel from Russia than the next 10 countries combined. The oil import in the European Union is six times what India has imported, gas is infinite times because we don't import

Addressing a joint Press meet with the German Minister after talks, Jaishankar also said, "I would urge you to look at these figures. There is a website called 'Russia Fossil Fuel Tracker' it would give you country-by-country data of who is really importing what and I suspect that might be very very helpful."

Jaishankar also said there is a finite amount of energy resources and Europe cannot make choices to prioritise its energy needs while asking India to do something else.

On economic ties, he said India's trade with Russia is at a very small level-\$12-13 billion, in comparison to European countries. "We have also given Russians a set of products... I don't think people should read more into it other than the legitimate expectations of any trading country to increase its trade," he said. Responding to this asser-

tion by Jaishankar, Kuleba said 'It is not enough to point fingers at the European Union and say, Oh, they are doing the same thing." According to Kuleba,

India's decision to import cheap Russian oil needs to be seen through the prism of human suffering in Ukraine.

Maha-K'taka border crisis escalates

Fadanvis to take up matter with Bommai, to speak with Shah

The vexed Maharashtra-Karnataka boundary row sparked minor violence in the border city of Belagavi on Tuesday, prompting Deputy Chief Minister Devendra Fadanvis to take the matter with the southern State Chief Minister Basavaraj Bommai and announced that he would speak to Union Home Minister

Amit Shah in this regard. A day ahead of the start of the Winter Session of Parliament in New Delhi, the Maharashtra-Karnataka border row escalated in Belagavi as "Karnataka Rakshana Vedike" (KRV) stopped trucks bearing Maharashtra registration numbers and smeared them with black ink and hurled stones at one of the trucks damaging it extensively

While Fadnavis asked Bommai to initiate action against those behind Tuesday's violence in Belagavi, NCP chief Sharad Pawar warned the Karnataka Chief Minister that if the violence did not stop within 48 hours, then Maharashtra — which had hitherto been maintaining "restraint" — would have no alternative but to "take a different stand in the matter".

Pawar also said he would visit the affected areas in Karnataka if the Bommai dispensation did not restore normalcy in the border areas in the next two days

Following the incidents of violence, two Maharashtra Ministers, Chandrakant Patil and Shambhuraj Desai, can-celled their scheduled visit to

Meanwhile, the Karnataka Police detained as many as 100 KRV and Maharashtra Ekikaran Samiti (MES), an organisation fighting for the inclusion of the Marathi-speaking villages in the border areas, as a precautionary measure.

Taking serious cognisance of the incidents in Belagavi, Maharashtra's Deputy Chief Minister Fadnavis spoke to the Karnataka Chief Minister and asked the latter to restore normalcy in the border city.

Interacting with media persons in Mumbai, Fadnavis said, "I spoke to the Karnataka Chief Minister and expressed my displeasure and concern over the incidents in Belagavi." I asked him to initiate action against the miscreants behind the incidents.

Ensure nobody goes to sleep on empty stomach: SC to Govt

'Foodgrains under the National Food Security Act must reach last man'

PNS NEW DELHI

The Supreme Court on Tuesday asked the Central Government to see to it that foodgrains under the National Security Act (NFSA) reach the last man.

The court observed that it is our culture to ensure nobody goes to sleep empty stomach. A bench of Justices MR

Shah and Hima Kohli directed the Centre to submit a fresh chart with the number of migrant and unorganised sector workers registered on eShram portal.

"It is the duty of the Central Government to ensure food-grains under NFSA are reach-



ing the last man. We are not saying that the Centre is not doing anything; the Union of India has ensured foodgrains to people during Covid. At the same time, we have to see it continue. It is our culture (to ensure) that nobody goes to sleep on empty stomach," the

bench said. The SC was hearing its suo moto case on the plight of migrant workers during the Covid pandemic lockdowns.

Prashant Advocate Bhushan, appearing for three Anjali social activists Bharadwaj, Harsh Mander and Jagdeep Chhokar, said the

country's population has increased after the 2011 census and so has the number of beneficiaries covered under the NFSA. He argued that many eligible and needy beneficiaries will be deprived of the benefit under the law if it is not enforced effectively.

said Bhushan Government claims the per capita income of people has increased in recent years, but added India has slipped rapidly in the global hunger index.

Additional Solicitor General Aishwarya Bhati, appearing for the Centre, submitted there are 81.35 crore beneficiaries under the NFSA, a very large number even in the Indian context. He said the 2011 census has not stopped the Government from adding more people to the list of ben-

eficiaries which is growing.

Trains to zip at 75 km/hour to cut fog delay

In its preparedness towards train operations during the foggy days of winter, the Indian Railways has decided to enhance the maximum permissible speed of trains to 75 km per hour from the present 60 km per hour to combat delays caused by inclement

weather. "It has been decided that with the use of fog devices in locomotives, the maximum permissible speed during foggy/inclement weather conditions can be enhanced from 60 kmph (km per hour) to 75 kmph," the Indian Railways said in a statement.

The national transporter has also asked railway zones to keep adequate supply of detonators — appliances fixed on rails that explode with a loud report when an engine passes so as to attract the driver's attention. It also said lime marking across the track at sighting boards (or at distant signals in case of double-distant signals) must be done.

"All signal sighting boards, whistle boards, fog signal posts and busy vulnerable level crossing gates, which are accident prone, should either be painted or provided with yellow/black luminous strips.

Babri demolition anniversary: Little extra security, but just another day



It was business as usual in the pilgrim city on Tuesday, the day that marked the 30th anniversary of the Babri mosque demolition.

In a break from the curfewlike situation on some past occasions, life remained normal in the city with schools, colleges, offices and public institutions remaining open. Police, however, remain on

Like any other day, local people were seen queuing at the Ram temple complex for a 'darshan' while traffic remained heavy during morning rush

hour.
Unlike in the past, the Vishwa Hindu Parishad is not



celebrating any "Shaurya Diwas" (bravery day) and there are no plans by the Muslim community to observe a Black Day. With the Supreme Court judgement in 2019 ending the Ram Janmabhoomi land dispute, people from both the communities appear to be yearning for peace.

In past years, Ayodhya used to be turned into a fortress ahead of the Babri mosque demolition anniversary. Not this time, though.

Senior Superintendent of Police, Ayodhya, Muniraj G said "routine arrangements" have been made in the city as precautionary measures.

"We are also continuously monitoring social media platforms, while hotels are also being checked," Muniraj G, who was recently appointed as the SSP of Ayohdya, tol reporters.

'All vehicles coming into Ayodhya are being thoroughly checked. Nothing unusual has been reported so far, however, we are keeping a strict vigil," the SSP, who inspecte the city markets on Monday night,

VHP spokesperson Sharad Sharma told PTI on Tuesday that no event is lined up for the day on the occasion. Sharma had earlier said events organised to mark December 6 were toned down after the Supreme Court decision "in favour of the Hindu side".

Some passerby saw some dogs scratching a white gunny bag lying near the Nagnath temple close to the bypass leading to Madarpur early

The Ukrainian Foreign Minister also said India, specifically Prime Minister Narendra Modi, has a key role to play in helping to end the war.

'India is a very important player in the global arena and the Prime Minister of India, with his voice, can make a change." At the same time, New Delhi, he believes, needs to be direct in referring to the situation in Ukraine. "We are waiting for the moment when Indian for-

eign policy will call spade a spade, and name the conflict - not 'war in Ukraine', but what it is, a 'Russian aggression against Ukraine," he said. Asked if New Delhi's intervention could realistically make a difference in the thinking of Russian

President Vladimir Putin, Kuleba said it was important to make a concerted effort. 'If you don't try, nothing can change," he said. We have seen some encouraging messages coming from your Prime Minister - when he said this is

not the time for war. We hope that (there) is more active, even if it is quiet, behind-the-scenes diplomacy (that) will take place in the coming weeks. It's worth trying (in) any way to end the war," he said.

The work of repainting for their proper visibility should be completed before onset of the foggy season. Lifting barriers at busy level crossings, where necessary, to be provided with yellow/black luminous indication strips.

"The new existing Seating Cum Luggage Rakes (SLRs) are already being fitted with LED-based flasher tail lights, therefore, the existing SLRs with fixed red lights should be modified and fixed with LED lights. This will be a very important step to ensure safety in foggy weather," the Railways said.

"During fog, when the loco pilot in his judgement feels that visibility is restricted due to fog, he shall run at a speed at which he can control the train so as to be prepared to stop short of any obstruction; this speed shall in any case not be more than 75 kmph (km per hour).

It has also directed loco pilots to whistle frequently to warn the gatemen and road users of an approaching train at level crossings," it said.

Chowdhury alleged that the Government did not "properly" inform the Opposition about the stand-off at the Sino-India border. "In the House, we demand a discussion on it and also on the killings of Kashmiri Pandits," he added. Congress leader Naseer

Hussain demanded discussions on the appointment of Election Commissioner in just one day and the Economically Weaker Section quota. The Congress list of issues to be raised during the session also include "Centre's attack on judiciary and refusal to accept Supreme Court collegium's recommendation.

The party will also take up the Supreme Court's judgement on 10 percent reservation for Economically Weaker Section and Morbi bridge collapse in Gujarat. Trinamool Congress leader Sudip Bandyopadhyay said he, along with party colleague and Rajya Sabha MP Derek O'Brien,

sought discussions on price rise, unemployment, alleged misuse of agencies and economic blockade of States. O'Brien also told the Government that the Opposition should be allowed to raise issues of importance. The BJD demanded passage of the women's reservation bill in the Winter Session of Parliament.

"On behalf of my party, the BJD, I demanded that the women reservation bill be passed in the winter session," Patra told reporters after the meeting. BJD leader and Odisha Chief Minister Naveen Patnaik and the party are committed to the cause of women empowerment, the MP said.

The Bill which seeks to reserve one-third of seats in Lok Sabha and state legislative assemblies for women could not be passed by the 15th Lok Sabha. While the bill was pending in the Lower House of Parliament, the term of the 15th Lok Sabha ended and the constitution amendment bill lapsed.

Meanwhile, the Trinamool Congress, JD(U) and the Shiromani Akali Dal demanded convening an all-party meet to build consensus on the women's reservation bill at a meet convened by Lok Sabha Speaker Om Birla, TMC leader Sudip Bandyopadhyay said. The TMC raised the issue at the meeting of the Lok Sabha Business Advisory Committee, while it was supported by the JD(U) and the SAD.

Because, we are interested in development and we can ill-afford to have conflicts between the two States. Our Constitution has given freedom of movement to the citizens in the country. People in the country have the freedom to visit any State, do business or live in any state. If citizens' rights are being violated in any state, the local government will have to take action in the matter," Fadnavis said.

Replying to a question, Fadnavis said while he anticipated some "reaction" in Maharashtra to the violence in the two states following statements by the Karnataka Chief

Minister. "Maharashtra has so far maintained restraint, but our people will not remain quiet for long. If these attacks don't halt within 48 hours, we will have to take a different

stand. Then the Karnataka CM will be responsible for the con-sequences," Pawar said. Pawar exhorted the Chief Ministers of the two States to work towards an "urgent" and "amicable" solution for the current situation. Pawar asked Maharashtra MPs — who are planning to meet Shah — to convey that if attempts were made to take law into hands by vested interests, the Centre would be blamed for

the consequences. Shiv Sena (UBT)'s former Minister Aditya Thackeray and Chief spokesperson Sanjay Raut came down heavily on the ruling BJP and Eknath Shindeled Shiv Sena for contributing to the current situation in the border area.

They said the ruling alliance partners and the Maharashtra Government "got scared" by the Karnataka Chief Minister's "scolding" and were handling the situation in a timid manner. MCD poll results to be declared after counting of votes under tight security

Authorities are all geared up for the counting of votes polled in the Delhi municipal elections, with officials saying 42 centres have been set up for Wednesday's exercise which will begin at 8 AM amid tight security. At least 20 companies of paramilitary personnel and over 10,000 officers of Delhi Police have been deployed at the counting centres. Delhi recorded a voter turnout of 50.48 per cent in the keenlywatched polls held on December 4, results of which may have ramifications beyond the national Capital.

"We are all set for the counting of votes tomorrow for which 42 centres have been set up. Counting will take place amid tight security arrangements," a senior official of the State Election Commission (SEC) said. The centres are located in areas across the city, including, Shastri Park, Yamuna Vihar, Mayur Vihar, Nand Nagari, Dwarka, Okhla, Mangoliuri, Pitampura, Alipur and Model Town.

This was followed by the Hauz Khas ward, where only 38.72 per cent turned up. Areas such as Green Park, Greater Kailash, Munirka, Lado Sarai and Dwarka also saw a turnout of less than 40 per cent. Turnouts in areas such as Greater Kailash, Vasant Vihar and Hauz Khas have remained below the 50 per cent mark in both 2012 and 2017 municipal

The figures for some of the other wards were -- Civil Lines (44.86 per cent), Chandni Chowk (44.48 per cent), Karol Bagh (44.72 per cent), Najafgarh (51.97 per cent), Rajinder Nagar (44.26 per cent), Malaviya Nagar (44.89 per cent), Greater Kailash (38.99 per cent), Laxmi Nagar (49.02 per cent). As is usual, rural pockets saw high turnouts, with Northwest Delhi's Bakhtawarpur recording the highest at 65.72 per cent. The rural pocket of Bhati in South Delhi saw a turnout of 62.49 per cent.

According to data shared by the SEC officials, the total number of voters in Delhi is 1,45,05,358 -- 78,93,418 males, 66,10,879 females and 1,061 transgender people

A case of cheating was registered against MLA Balraj Kundu, his brother Shivraj Kundu and VK Lamba at Moti Nagar Police Station, Sagar in Madhya Pradesh in 2021.

It has been alleged that the three had contracted a Jhajjarbased firm to construct a road in Madhya Pradesh but refused to pay the dues to him.

"They asked me to build a road from JC Nagar to Sagar in Bhopal. The entire project cost around ₹7 crore and I was asked to set up the plant in

When the contractor asked Madhya Pradesh and was for money, the accused alleged-promised a payment every month," Dharmaveer said in his complaint, according to the

> He said that after he set up crore and the work began. But as the work progressed, with continued supply from his end, the Kundus stopped his payments. He soon ran up a bill upto ₹6 crore and asked Kundu brothers for his money, but they threatened to kill him, he

"Under compulsion, I had to keep the plant running. Later they bought my plant for about ₹ 62 lakh and gave me ₹31 lakh. They gave me a cheque for my dues of about ₹6 crore but it bounced," he added.

Man threatens female friends on Insta with acid attack, held

24-year-old man was arrested for Aallegedly harassing several women online by threatening to throw acid on them and making their "objectionable" videos viral if they did not meet him.

According to police, Aman Yadav created a fake Instagram profile about one and a half years back and had gathered around 1,100 followers, most of them women.

From his fake profile, he sent messages to women and later, threatened to throw acid on them and make their "obscene videos" viral in a bid to force them to meet

him in person, police said. The matter came to light after a woman, a resident of Farsh Bazaar, lodged

a police complaint. "She alleged that on November 27, she on her Instagram chat was threatened by a user, anshikasharma188, that acid would be thrown on her and her videos would be made viral", said the police.

Deputy Commissioner of Police (Shahdara) R Sathiyasundaram said the IP address of the Instagram page (anshikasharma188) and some call records were analysed. The page was being oper-

ated by the accused Aman Yadav, he said. Police conducted a raid and Yadav was arrested from Subhash Nagar, Sathiyasundaram said.

"During investigation, we found out that Yadav had created a fake id anshikasharma188 — on Instagram around one and a half year ago and since then, he had been chatting with different victims," the officer said.

"Initially, he followed random profiles of beautiful women and then sent them messages. When any women responded to his message, he would threaten the victim with making their objectionable videos viral and throw acid attack on them," Sathiyasundaram said. Out of "fear, many women met with him and accused did this act just to meet the women", he said.

2 students nabbed for cheating people on pretext of providing discounted IDs for online game

In his complaint, the victim alleged that he saw an advertisement on a video sharing platform regarding the sale of the player ID at a 30 per cent discount. He submitted his mobile number, as per the requirement, and immediately received a call from an unknown number.

The caller promised that the victim would be provided with an ID. Subsequently, the victim transferred ₹88,800 to them through several transactions, the police said.



When he didn't receive the ID even after transferring the money, he lodged a complaint.

Deputy Commissioner of Police (Shahdara) R Sathiyasundram said the number was registered in the name of Bunty. The cops also analysed the bank account details linked to the number.

"On the basis of technical investigation, our team found that the cheats were operating from Sonipat in Haryana and subsequently they were arrested," he said.

Chinese man held in ₹1.25 cr fraud case in Greater Noida

33-year-old Chinese national was Aarrested by the police in Greater Noida Tuesday in connection with a probe into a case of fraud worth over ₹1.25

The case was lodged at the Dadri Police Station in April 2021 and four other accused in the matter — all Indians have already been arrested, the officer said.

"Accused He Haomin was arrested near the Hair roundabout in Greater Noida around 1.30 PM on Tuesday. Haomin, who possesses a Chinese passport, currently lives in Gurugram," the

officer said.

According to the complainant Mohammad Anas, he was hired in April

2020 by Haomin and the other four accused who had told him they were running a construction and engineering

"I was hired to install water pump plants in 2020 at their company site in Greater Noida. While the total bill amount was decided to be around ₹1.40 crore, the payments were initially made in parts. However, after some time, the group stopped paying," Anas alleged.

He further alleged that to avoid pay-

ing the remaining amount of ₹27 lakh, the accused stopped his employees from finishing work at their site and also kept his equipment worth ₹1.25 crore that he was

According to local police, the Chinese national had been on the run since the FIR was lodged in April last year.

The other accused arrested earlier were identified as Anupam Sharma, Sachin Giri, Shuzen, and Taylor Tag, police said. Further investigation and legal proceedings in the case are underway, the

'Af shouldn't be safe haven for terrorists'

India pitches for collective efforts to combat terror in India-Central Asia NSAs' meet

India and Central Asian countries on Tuesday cautioned that Afghanistan must not become a safe haven for terrorist activities and called for collective action to combat challenges like terror financing, radicalization and use of terror proxies for cross-border terrorism.

National Security Advisor (NSA) Ajit Doval said monetary resources are the "lifeblood" of terrorism and coun-

tering it should be a priority.

This appeal was made here at the first meeting of the National Security Advisors (NSA) of India and Central Asia hosted by Doval. The high-profile conclave also emphasized the need for respecting Afghanistan's sovereignty, unity and territory and urged noninterference in its internal affairs. Doval said the meeting was taking place at a time of "great churn," in international relations.

The NSAs of Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan are attending the conclave while Turkmenistan is being represented by its ambassador to India.

Addressing the meet focusing on combating terrorism in the region and situation in Afghanistan, Doval pitched for giving greater priority by countries of the region to counter terror financing, saying monetary resources are the "lifeblood" of terrorism.

Doval also said all United Nations(UN) member states should refrain from providing any form of support to entities or persons involved in terrorist acts and fulfill the obligations and participatory, with respect for sov-

conventions. He described Central Asia as India's "extended neighbourhood", and said New Delhi accords "highest riority" to this region.

"Afghanistan is an important issue concerning all of us. India's concerns and objectives with regard to immediate priorities and the way forward are similar to those of many of us around the table," he said.

Doval said connectivity with Central Asian countries remained a key priority for India and that New Delhi stands ready to cooperate, invest and build connectivity in the region.

'While expanding connectivity, it is important to ensure that connectivity initiatives are consultative, transparent enshrined in relevant counter-terror ereignty and territorial integrity of all

countries," he said, seen as an oblique reference to China's Belt and Road Initiative (BRI).

Doval hosted the conclave with a focus on evolving a common framework to deal with challenges of terrorism in the region including Afghanistan and ways to bolster overall security cooperation in sync with a decision taken at the first India-Central Asia summit in January.

He said the meeting is taking place at a time of "great churn" in international relations and uncertainty about the future, noting a peaceful, secure and prosperous Central Asia is in "our common interest".

Today's meeting, therefore, assumes importance as it provides us an opportunity to discuss matters which require greater cooperation and coordination amongst the regional coun-

A joint communique said the officials agreed that the expansion of terrorist propaganda, recruitment and fund-raising efforts have serious security implications for the region, and therefore, a collective and coordinated response is essential.

'The misuse of new and emerging technologies, arms and drugs trafficking, using terrorist proxies for cross-border terrorism, abuse of cyber space to spread disinformation and unmanned aerial systems present new challenges in counterterrorism efforts and call for collective action," it said.

The mentioning of cross-border terrorism is seen as a reference to Pakistan's support to various terror groups which have been targeting India. The meeting also strongly called for an early adoption of the UN Comprehensive Convention on International Terrorism to effectively deal with the menace.

It also reiterated that greater connectivity could be a force multiplier for enhancing trade and commerce as well as for ensuring closer interactions between India and Central Asian countries. Doval also referred to the first India-Central Asia virtual summit in January that was hosted by Prime Minister Narendra Modi.

'Your presence is a testimony to our cohesiveness and it will enrich the discussions. Central Asia is our extended neighbourhood with which we have civilisational linkages and we accord highest priority to this region," Doval

HC nod for rare 33-week pregnancy termination

In a rare instance, the Delhi High Court on Tuesday allowed termination of a 33week pregnancy by saying that the "ultimate decision" in matters of abortion ought to recognise a woman's choice to give birth and the possibility of dignified life of the unborn

Justice Prathiba M Singh observed that while the right of a pregnant woman to terminate her pregnancy has been the subject matter of debate across the world, India recognises the choice of a woman in its law.

In the present case, the petitioner, a 26 year old married woman, sought to terminate her 33-week pregnancy after she found out that the foetus was suffering from certain cerebral abnormalities. Normally, termination is not allowed after 24 weeks of preg-

The petitioner had said during her ultrasounds till the 16th week of gestation period, no abnormalities were found in the foetus but on November 12, an abnormality was observed in the foetus. The court clarified that prior to undergoing termination, the informed consent of the petitioner would be



taken and she would undergo the procedure at her own risk.

The judge, while permitting the woman to immediately undergo medical termination of pregnancy, noted that the medical board unfortunately did not give a "categorical opinion" on the degree of handicap or the quality of the life of the foetus after birth and thus opined that "such unpredictability ought to weigh in favour of the woman seeking termination of pregnancy".

"In conclusion, the court holds that the ultimate decision in such cases ought to recognise the choice of the mother as also the possibility of a dignified life of the unborn child...This court holds that medical termination of pregnancy ought to be permitted in the present case," the court

"The right of a pregnant woman to terminate her pregnancy or abort her foetus has been the subject matter of debate across the world. This right gives the woman the ultimate choice as to whether she wants to give birth to the child

she has conceived. India is among the countries which recognises this choice of a woman in its law," the court

The court said that in the present case, it was able to gauge the mental trauma affecting the parents as well as their economic and social condition, and the petitioner was taking an informed decision to terminate her pregnancy after weighing all factors. "The court comes to the conclusion that the mother's choice is being made in a bonafide manner", it added while allowing the petitioner to undergo medical termination of pregnancy immediately at LNJP, GTB or any other approved medical facility of her choice as per law.

The woman represented by advocate Anwesh Madhukar and Prachi Nirwan had approached the High Court last week after the GTB Hospital declined her request for termination of pregnancy on the premise that the process required judicial intervention since the current gestational age of the petitioner was beyond the permissible limit, that is, 24 weeks as per the amended Medical Termination of Pregnancy Act which came into effect from September 24,

court would have been willing to grant him bail," the Bench told Additional Solicitor General SV Rau, appearing for probe agencies CBI and the ED.

The bench said what is worrying the court is the complexity of trial as there are over 250 witnesses in the case and the coaccused government officials have been granted bail for want of sanction for prosecution. CBI arrests Railway DCE for taking bribe, seizes ₹2.51 cr

The CBI has recovered cash to the tune of ₹1.38 crore cash and ₹1.13 crore in bank accounts of Deputy Chief Engineer of Railways, Arun Kumar Mittal, who was arrested for allegedly taking a bribe from a contractor.

Immediately after Mittal's arrest last week, the CBI had seized ₹38 lakh cash and about ₹1 crore was recovered during searches at his premises. Kumar was posted as Deputy Chief Engineer (Construction), Northern Railway, Lucknow.

Out of the ₹1.13 crore recovered from the bank accounts of the accused and his family members, majority of the amount was allegedly deposited in cash in various bank accounts, the CBI said. A case was registered on a complaint against Mittal on the allegations of demanding bribes from the complainant in lieu of passing the bills of his firm engaged in project work at Charbagh, Lucknow. The arrested accused was produced on December 2 before the Competent Court, Lucknow which remanded him to CBI custody.

'Most Asian countries fail global biodiversity target'

Most countries in Asia have failed to achieve a global minimum target of protecting at least 17% of land by 2020, according to a study based on data from 40 countries.

Under the current trends, the outlook for achieving the UN Global Biodiversity Framework's 2030 target to protect at least 30 per cent of land is bleak, with Asia set to miss this by an even greater margin, the researchers said in a study published in the journal Communications Biology.

To counter the global biodiversity crisis, at the 2010 UN Convention on Biological Diversity, almost 200 countries pledged to protect at least 17 per cent of their terrestrial environments by 2020 (known

To investigate whether they achieved this, researchers from the Universities of Oxford and Cambridge in the UK, with collaborators in Asia, analysed data from official reports submitted to the World Database on Protected Areas.

In particular, very few countries in West and Central Asia achieved the target. Overall, Asia was the most underperforming continent, with just 13.2 per cent of land being designated as a terrestrial protected area in 2020 compared with a global average of 15.2 per cent protection, the researchers said.

Asian countries also tended to have a slower year-onyear increase in the amount of land protected for conservation, at just 0.4 per cent per year on average, the study said.

For 241 highly at-risk

mammal species across Asia on average 84 per cent of their ranges fell outside protected areas, the researchers said.

They calculated that almost all Asian countries will fail to meet the 2030 target unless their rate of establishing protected areas increases by up to six times faster. Under the current trajectory, Asia would only achieve 18% coverage by 2030 — far below the target of 30 per cent protection. The outlook was worse for

West and South Asia, projected to achieve 11 per cent and 10 per cent coverage respectively by 2030.
"Asia is a challenging con-

tinent for setting targets for protected areas, since areas of high biodiversity typically conflict with dense human populations and rapid economic growth," said study lead author Mohammed Farhadinia.

... he was arrested because he tweeted against the Prime Minister," on Morbi bridge collapse incident. Gokhale had allegedly written fake news on the Morbi incident and later went on to write that the Prime Minister's visit to Morbi cost more than the compensation provided to the kin of the victims of Morbi.

"The party has been trying to contact him since midnight ... but the police have confiscated his mobile and he is thus

3 hurt in yet another blast in West Bengal

Barely four days after the Bhupatinagar blast that left three persons dead and an unspecified number of victims injured three persons including a woman and two children were severely injured at Ramnagar area of Basirhat sub-division in North 24 Parganas district some 50 miles north of Kolkata.

The incident happened on Tuesday forenoon when a child brought home a round-shaped object taking it to be a ball ... the ball-like object that the child found in the fields exploded inside the kitchen of his house injuring another child and his mother, sources said. All have been admitted to the Basirhat district hospital,

The incident occurred four days after the blast at Bhupatinagar in East Midnpore district where a Trinamooll Congress leader's house literally caved in after a stockpile of explosive went off while the victims were allegedly making bombs. While Bengal Opposition Leader Suvendu Adhikari wrote to Union Home Minister Amit Shah seeking an NIA investigation into the Bhupatinagar incident, a Public Interest Litigation petition too was filed in Calcutta High Court demanding a similar

About a dozen people have lost their lives and tens of them have received grave injuries in bomb blasts and gun fights in the past little more than a month in Bengal. Such incidents were likely to go up at next year's panchayat elections draw nearer, experts say.

On expected lines

Exit polls have not thrown up any surprises, BJP and AAP are winners and Cong a big loser

■he results of exit polls for the Assembly elections in Gujarat and Himachal Pradesh and of the Municipal Corporation of Delhi are on expected lines. Most reports and experts were suggesting that the Bharatiya Janata Party would increase its tally of 99 out of 182 seats in Prime Minister Narendra Modi's home state, overcoming 27 years of anti-incumbency and even the bad press that the saffron party got after the Morbi mishap. The average of nine exit polls for the BJP in Gujarat is 132, whereas for the Congress it is 38 and the Aam Aadmi Party, eight. In the Himalayan state too, where the electorate prefers to change the state government every five years, the BJP was seen as a party that wasn't leaving any stone unturned. A video went viral in which no less a person that the PM was heard trying to coax a rebel party candidate to withdraw his candidature. Exit polls show a tough contest in



Himachal, which has 68 Assembly seats, the BJP's average being 35 and the Congress' 30, while AAP is unlikely to open its account. Only Aaj Tak-Axis My India, which gave 30-40 seats to the Congress and 24-34 to the BJP, has thrown up the possibility of the grand old party coming back to power in the hill state. For the MCD election, there were four exit polls, all of which gave a comfortable majority to AAP, the average being 154. The BJP's average was 84 and the Congress' six.

If exit polls are correct on the whole, they highlight a few facts. First, the BJP's election machine is unrivaled. The party's detractors may accuse it of having amassed wealth and using law-enforce-

ment agencies like the Central Bureau of Investigation and the Enforcement Directorate to further its electoral ends, but it would be wrong to deny the magnitude of effort put in by its cadre and that of the RSS. They don't leave anything to chance; they are not deterred or daunted by events like the Morbi bridge collapse or the incidence of rebels everywhere; they just don't give up. The Congress, on the other hand, is just not willing, able, or both to take up the challenge that it faces today—the existential challenge against Modi's BJP. Rahul Gandhi is busy uniting the country, even as his own party is withering away. His sister, Priyanka Vadra, did work in Himachal, but not as much as her party leaders in the state wanted her to. What was once seen as a low-hanging fruit for the GOP seems to have become an apple of discord. The AAP looks like a winner. It appears to be winning the MCD election; for 15 years, the local bodies (there were three MCDs till recently) were under the BJP. Typically, the saffron party did everything to win the MCD election—from a high-profile campaign involving its stalwarts to the use of Satyendra Jain's video clips—but to little avail. Its performance in the two other states, however, compensates for the loss. The GOP, however, has no such compensation.

Urban Voter's apathy

Low urban turnout in the recent elections reflects

disenchantment of city dwellers with political system fter a high decibel campaign in three states of Gujarat, Himachal, and Delhi, it was a damp squib response by the voters, especially in urban areas. Not many came out to vote, especially in the urban areas where the voter turnout was abysmally low. Even the election commission acknowledges the fact that despite so many efforts the voter's interest in the elections was rather low. In Shimla, the turnout was dismal, 10 percentage points lower than Himachal's average of 75.6%. The trend of lower voter turnout in the urban areas was also seen in Guiarat as well. The urban turnout in the first phase in Gujarat was also lower than in 2017. In Delhi's local polls, the same trend was visible in the affluent constituencies of Delhi. The voter turnout of voters has decreased since independence. In the 50s, 60s, and 70s, the

urban voters were more active than the rural ones but gradually the rural voters took over and the urban voters started keeping away from

the polling booths. Many factors have contributed to the low voter turnout in general and urban voter turnout in particular. The notion that rich people do not care about elections is largely true and this is reflected in the voting pattern in affluent neighborhoods. In villages, voting is largely a group activity and people vote decisively to effect a change or maintain the status quo. Besides, rural elected bodies are more alive in rural areas than urban ones. Besides, the political parties work harder in rural areas. Group mobilisation is difficult in cities where localities are not based on castes or a particular community. Besides, rural vot-

ers need political favours more than their urban counterparts as the rural infrastructure is still evolving whereas the urban voters do not need the government services that ardently and take them for granted. However the most worrisome is the general disenchantment of voters with the political system. Perhaps people are tired of hollow promises and antics of politicians who take voters for granted. The paradigm of two India's is visible in voting pattern also, though there is nothing wrong in high voter turnout in rural areas, and more so on lower-income rural poor. But the disconnect between city middle-classes and elections is still a trend which must be checked as it would mean caring for one at the cost of another.

EMOTIONS SPOIL LIFE GOAL; AIM SENSIBLY

Lord Krishna counsels a realistic and sensible approach

ord Krishna guides in the Bhagavad-Geeta, when He states, "In the bonafide Sankhya philosophy, these five causes have been stated for success in all actions." (18.13) These are, "The place of action, the doer, many different kinds of instruments, many different efforts and the providence." (18.14) The Lord states further, "Whatever action is begun by a man by body, speech and mind, these five are the causes of them." (18.15) Lord Krishna summarises, "This being the case, still, who on account of immature intelligence thinks himself as the only doer, he is foolish; he does not understand." (18.16)

Are we being foolish? Are we aiming too big or too small? Are we being realistic and sensible in setting our goals? Let us see if we are. There should be a fair assessment of the following. What are our abilities? Connected with this is our potential. An example will help us understand. Suppose there is a girl. Unfortunately, she is not pretty. On top of it she has tendency of becoming obese. Should she plan to enter the glamour world? No, she must focus on something to do with intelligence, if she is sharp in studies. Next come resources. What is available to us? Suppose there is a boy from a poor family, focus on getting a good job to begin his professional life. On the other hand, a boy from a rich family can plan to become a businessman. He should study and specialise in management from the best institutions



The third criterion must be circumstances and opportunities available. A boy born to a yogi couple can think of becoming a yogi himself, blessed as he is. He has a tremendous start for making good spiritual progress in the present life. The fourth yardstick must be 'yukta cheshta' (appropriate efforts), as instructed by Lord Krishna in verse #6.17. Too much is counterproductive like a student appearing for an important exam studying all night. Too little is sick because all of us are expected to help ourselves as much as possible

What does the Bhagavad-Geeta teach us in this connection? What did Lord Krishna promise Arjuna? In verse #2.37, He told Arjuna that if victorious he will enjoy the earth and if slain will achieve heaven. God did not even mention liberation because Arjuna was not an advanced devotee; he was just thinking of getting started, as he expressed in the verse #6.38. Lord clarified that a yogi, which Arjuna was not, achieves perfection due to practice of many births. (6.45) The creation works on the karmaphala principle, and mostly what we bring from our previous births come to fruition in the present life. Therefore, it is futile to imagine that we can achieve almost anything by our present efforts. This is not the way the creation works. For the present life, He counsels a realistic and sensible approach, when He states, "Be satisfied with any benefit, which comes of its own accord due to acts done earlier." (4.22)

If we continue to harbour unrealistic desires, we will only get frustrated and waste a valuable human life. This is a materialistic way of thinking, in which God and His rules are ignored. One violates the 'maryada' (limit) of thinking and goes very far from reality. Lord Krishna has clearly warned that we have right in action, not ever in predetermining fruits. (2.47) 'Ahankar' (ego) prompts it and should be shunned. We will be well served.

Amrit Mahotsav: Saga to tell untold stories



Yesterday was the death anniversary of Ambedkar, which gave us the opportunity to remember the unsung heroes of India

he dawn of the historic 76th Independence Day has marked the beginning of the era of 'Amrit Kaal'. The valorous saga of struggle against the British Raj and subsequently earned freedom is the outcome of the immeasurable sacrifices of unsung heroes.

Amrit Mahotsav is celebrated to mark the 75th Birthday of the sage in mythology. Prime Minister Narendra Modi has conceptualized 'Azadi Ka Amrit Mahotsav' by drawing a similar parallel to Independent India's 75th year journey. The ever-increasing public participation in Amrit Mahotsav events further pushes for the amalgamation of everything that aids in strengthening the political, social, and economic uplift of a value-driven India.

After the birth of Independent India, the pages of history remained knowingly and unknowingly skewed to celebrate specific Ideas and ideals that have shaped the India we breathe in today. The political aspiration and increasing groves of nepotism had hugely hampered the cause for crediting recognition to builders of the Nation. This opaque idealism towards their contribution might have been addressed in the short-term agenda of the then decision makers, but it became a sentimental hurt for many for a long time.

One such tallest nation builder, Dr Bhimrao Ambedkar, had a similar fate as the subsequent regimes didn't heed the wholesomeness of Ambedkar's deed and the subsequent psychological undercurrent among his well-wishers and followers. It is a crystal clear fact that it took 34 years to posthumously award him Bharat Ratna, similar is the fate of the installation of his portrait in the Central Hall, a place where he drafted the Constitution of India. The echo of Ambedkar in the Central Hall was an echo of social, political and economic justice for newly budding independent India. The journey for installing a life-size portrait in Parliament's Central Hall is very heartening commentary for every fellow Ambedkarite.

A brief account of the record tells a grim picture of the happenings. As Dr Ambedkar breathed last on December 6, 1956, then onwards demand for installation for the Central Hall portrait was raised by his fol-

Despite the need, Jawaharlal Nehru rejected the demand for Dr. Ambedkar's portraits, and Moti Lal Nehru's portrait was installed on 30 March 1957. JL Nehru's intentions and deep-rooted superiority complex visibly come out in his remark dated July 23, 1957 on the portrait demand of Prantiva Jatav Sabha, Gwalior, wherein he says: "So far as Dr Ambedkar's portrait is concerned, I would have no objection to its being put up in the library or somewhere else provided it is relatively small or otherwise good."

Later, the same demand was declined again by the then Jawaharlal Nehru Portrait

Parliamentary Committee on August 26, 1965, citing the unavailability of vacant panels in the central Hall. Ironically, the same unavailability turned to availability on May 5, 1966, when the Central Hall witnessed Pt Jawaharlal Nehru's

Under this pressure, the Rajiv Gandhi-led government consented to the portrait installation, and then Lok Sabha Speaker Balram Jakhar installed the central Hall portrait on August 9, 1989, which the B.R. Ambedkar Vichar Manch donated. These dynamics made it clear that this step resulted from compulsion and not

by choice. It is ironic to learn that the installed portrait of Dr Amebdkar was withdrawn by suc-cumbing to the ill-will agenda of congress leaders.

The portrait was removed from the Central Hall and found its new home in the Parliament museum along with other freedom fighters. This whole episode made a severe dent in the feelings of fans and followers of Baba Saheb. Many ambedkariate associations and Dalit MPs protested against this unruly gesture of the congress government. Atal Bihari Vajpayee, a reasoned voice of opposition, was a keen observant figure of the whole portrait dynam-

The widely held precedent that the Central Hall portrait can be displayed only for the person whose portrait/statue/ bust not already installed in Parliament estate was contravened for the Nehru family by subsequent congress regimes. It was ironic that despite these exceptions, the same precedent was argued during the consideration and delaying of Ambedkar's Central

Hall portrait. The awakened conscience of the followers of Dr. Ambedkar remained fully intact to check the long-drawn insensitivity of the congress-led dispensation. It was in 1989 that VP Singh's government, externally supported by BJP, came to power, and Atal Bihari Vajpayee proposed to address this long pending grievance. A genuinely justified decision showed a path of light to the dark-ridden aspirations of fellow Ambedkarite, with the return of Dr Ambedkar's Portrait in the Central Hall.

The life-size portrait, made by artist Zeba Amrohawi and donated by 'The BR Ambedkar Vichar Manch, was unveiled by prime minister VP Singh on April 12, 1990, as part of the centenary year celebration of Ambedkar's birth anniversary.

Notably, the earlier regimes' exhibited biases and insensitivities in recognizing the founding father's significant contribution compelled us to reflect on the time scale for much-needed course correction. It carries a mammoth task to unearth the harsh realities as an outcome of indifference to the aspirations of a downtrodden section of society. The phenomenon of duly recognizing effort and sacrifices is a gesture that presents a better understanding of our past and adds dimensions to rational reasoning for bringing out the best in the future generation.

The ongoing 'Azadi Ka Amrit Mahotsav' is a righteous initiative of the Modi Government to express our sincere gratitude to the noble souls and all stakeholders whose unaccounted and undivided efforts are fulfilling the aspiration of the masses, enabling them to realize their full potential. It is a journey or building a value-driven India for nurturing upcoming generations. This festive occasion has brought up the spirit of independence alive again on a massive scale. Today on the death anniversary of Baba Saheb, let's seize the opportunity by crediting due recognition to the unsung heroes of India by bringing out their hitherto untold stories. Let the spirit of 'Amrit Mahotsav' take everyone to scale new heights for the Nation.

How to check cheque bounce? Don't issue cheques

With the advancement of technology of digital transfer, there is no reason to accept cheque as a payment instrument at all

s there is a large num-ber of pending cases relating to cheque bounces in Maharashtra, Delhi, Uttar Pradesh, Gujarat, and Rajasthan, the Supreme Court in May 22 has directed to constitute special courts in these states with retired

Before the introduction of Section 138 of Negotiable Instruments Act in 1989, bouncing of cheque for want of funds was not straightaway a criminal offence. It was considered only as a civil dispute. There was a possibility to invoke Section 420 of Indian Penal Code to treat the cheque bounce as cheating. But in such cases, the beneficiary of the cheque had to prove the intention of the issuer of the cheque to

cheat him. But after introduction of Section 138 of NI Act, if the cheque has been issued for clearance of liability and if the cheque is returned for insufficient balance in the account, it becomes a criminal offence. Of course, there are procedural aspects as to the need to give notice to pay, etc. This was made to enhance the acceptability of cheques in the country.

Now it is reported that many suggestions were made at a high-level meeting recently called by the Government to deal with the high incidence of cheque bounce cases and the government is contemplating to introduce some of the sugges-

cheque issuer in case of insufficient balance in one account which results in return of cheque. It is strange that the suggestion has been made without understanding the legal relationship between a banker and a customer. Banks open and operate accounts for customers as per the contract between the bank and the customer and it is subject to various provisions of Indian Contract Act.

Bankers cannot be made a party in the dispute between the drawer and payee of a cheque. The banker is there to execute the order of the drawer as the contract is between the banker and its customer. Making the banker help the beneficiary of a cheque will be

patently illegal. Banks can debit a cus-

mandate and not otherwise. There is Section 31 of NI Act which states as follows: Liability of drawee of cheque The drawee of a cheque

having sufficient funds of the drawer in his hands properly applicable to the payment of such cheque must pay the cheque when duly required so to do, and, in default of such payment, must compensate the drawer for any loss or damage caused by such

The Government is looking at another suggestion that is to prohibit opening of new accounts to offenders of cheque bounce cases. It is possible to implement this suggestion just with an administrative order from cheque bounce cases. Again Reserve Bank of India. But patently it is illegal to stop

The issuer of the cheque bounce case cannot be considered as a person who has committed the offence until convicted by the court.

Yet another suggestion is to treat the cheque bounce similar to loan default and to inform credit information companies for necessary

downgrade of score. Industry body PHDCCI has suggested to the Finance Ministry to take measures like compulsory suspension of bank withdrawals for a few days to make cheque issuers accountable for their action in

operation in bank accounts for such a reason. Operations in bank accounts can be stopped only when there is a court order like Garnishee order, or where there is attachment order from Income Tax department, etc. Or there can be a banker's general lien over the balance.

The industry body has also suggested enacting a law that from the date of dishonouring of cheque, the dispute between the two parties must be settled within 90 days through mediation. Enacting such a law may be easier. But how to implement the time line? Even in mediation there is scope to drag the case endlessly.

The best way to check cheque bounce cases is to

reduce the incidence of issue of cheque. With the advancement of technology of digital funds transfer, there is no reason to accept cheque as a payment instrument at all. We may even remove the penal provision under Section 138. This penal provision was introduced when online transfers were not possible. Now there is no necessi-

ty to continue the same and to provide an avenue for a number of criminal cases. If someone is still accepting a cheque as a medium for payment, it should be their funeral. Let them understand the risk and let them take that risk. Let them not be allowed to strain the already overburdened judiciary.

drone strikes on bases

A fire that broke out at an airport in Russia's southern Kursk region that borders Ukraine was the result of a drone attack, the regional governor said Tuesday, a day after Moscow blamed Kyiv for drone strikes on two air bases deep inside Russia and launched a new wave of missile strikes on Ukrainian territory.

Kursk Governor Roman Starovoy said in a Telegram post that the drone attack ignited an oil reservoir in the area of Kursk airport and the blaze was being contained by crews at the scene.

Ukrainian officials have not formally confirmed carrying out the drone attacks, maintaining their apparent policy of deliberate ambiguity as they have done in the past when it comes to high-profile attacks on Russian targets.

Presidential adviser Mikhail Podolyak taunted Moscow in comments on Twitter.

"If something is launched into other countries' airspace, sooner or later unknown flying objects will return to the point of departure," Podolyak wrote. "The earth is round."

The unprecedented attacks in Russia - more than 500 km (300 miles) from the border with Ukraine - threatened a

month war. One of the airfields houses bombers capable of carrying nuclear weapons.

The attacks also exposed the vulnerability of some of Russia's most strategic military sites, raising questions about the effectiveness of their air

Russia's Defence Ministry said three Russian servicemen were killed and four others wounded by debris, and that two aircraft were slightly dam-

The ministry didn't say where the drones had originated. But Russian military bloggers said they likely were launched by Ukrainian scouts, and argued that the strikes had inflicted serious reputational damage on Moscow.

In a daily intelligence update on the war in Ukraine, Britain's Defence Ministry said



Russia was likely to consider the base attacks as "some of the most strategically significant failures of force protection since its invasion of Ukraine".

It said the bombers would likely be dispersed to other air-

Kremlin spokesman Dmitry Peskov said that Russian authorities will "take the necessary measures" to enhance protection of key facilities in view of the latest Ukrainian attacks.

Speaking in a conference call with reporters Tuesday, Peskov said "the Ukrainian regime's course for continuation of such terror attacks poses a threat.'

Peskov reaffirmed that Russia sees no prospects for peace talks now, adding that "the Russian Federation must achieve its stated goals.

Russia, meanwhile, maintained intense attacks on Ukrainian territory, shelling towns overnight near the Zaporizhzhia nuclear power

Russian airfield hit day after EU, Western Balkans to boost partnership amid Ukraine war

 $E^{ ext{U}}$ leaders and their Western Balkan counterparts gathered Tuesday for talks aimed at boosting their partnership as Russia's war in Ukraine threatens to reshape the geopolitical balance in the

region.

The EU wants to use the one-day summit in Albania's capital to tell leaders from Albania, Bosnia, Kosovo, Montenegro, North Macedonia and Serbia that they have futures within the wealthy economic bloc and give them concrete signs, rather than just promises, that they will join one day.

Since Russia invaded Ukraine in February, the EU's top diplomat, Josep Borrell, has been repeating that stepping up the bloc's engagement with the six nations is more crucial than ever to maintaining Europe's security.

As Europe's relationship with Russia deteriorates further because of the war, tensions have also mounted in the Balkans and the EU wants to avoid other flashpoints close to its borders.

"In the Western Balkans, several crises are looming, and partners feel the immediate damaging impact of Russia's aggression against Ukraine," Borrell said last

month. "The shockwaves of this war are hitting the Western Balkans. To counter that, we are stepping up our engagement as the Western Balkans remain our geostrategic priority - the closest and most important geostrategic priority.

According to a draft of the declaration to be adopted at ithe summit, the EU will repeat "its full and unequivocal commitment to the European Union membership perspective of the Western Balkans" and call for an acceleration of accession talks with the incumbents.

In return, the EU expects full solidarity from its Western Balkans partners and wants them fully aligned with its foreign policies.

That particular point has been problematic with Serbia, whose president, Aleksandar Vucic, claims he wants to take Serbia into the European Union but has cultivated ties with Russia.

Although Serbia's representatives voted in favor of various U.N. Resolutions condemning Russia's invasion of Ukraine, Vucic has refused to explicitly condemn Moscow. His country has not joined Western sanctions against Russia over the war.

Although the progress of the six nations toward EU membership had stalled recently, there has been some progress over the past few

This summer, the EU started membership negotiations with Albania and North Macedonia following years of delays. And Bosnia moved a small step closer on its path to joining the powerful economic bloc when the commission advised member countries in October to grant it candidate status despite continuing criticism of the way the nation is run.

Kosovo has only started the first step, with the signing of a Stabilization and Association Agreement. It said it would apply for candidate status later this month.

Among the concrete measures to be adopted in Tirana,

atvia has revoked the license Lof an independent Russian TV channel exiled in the Baltic country for, among other things, voicing support for the Russian military and including Crimea in its map of Russia, media authorities said on

The decision by the Latvian National Electronic Mass Media Council was based on number of recent violations by TV Rain and the license was revoked on the grounds of a threat to national security and public order.

Hungary vetoes EU Ukraine aid, deepening rift with Brussels

A rift between the European Union and member state Hungary deepened Tuesday when Budapest vetoed an 18billion euro (\$18.93 billion) financial aid package to Kyiv, exacerbating a dispute over the rule of law in the country and Prime Minister Viktor Orban's outlook over Russia's invasion of Ukraine.

EU finance ministers also postponed any decision to punish Hungary by withholding bil-lions of euros for failing to implement solid rule-of-law

Instead of ensuring unanimous support for aid to Ukraine, Hungary's veto made sure that the EU's other 26 member states would need technical plan to make sure aid can keep flowing to Kyiv in the

ÊU nations have been mulling for years now whether to punish Orban for what he calls his brand of "illiberal democracy" but what is seen by many others as unfit for the EU's traditional sense of Western democratic liberalism. On top of that, Orban has

also angered the bloc's officials with his repeated criticism of EU sanctions targeting Russia for its war in Ukraine.

Russia unleashed what Ukrainian authorities called the latest "massive missile attack" across their country, striking homes and buildings, killing civilians, and disrupting electrical power and water supplies in areas - notably in the Black Sea port city of Odesa. Ukraine's air force claimed it shot down more than 60 of the 70 missiles fired.

Hours earlier, explosions rocked two air bases deep inside Russia, and the Defense Ministry in Moscow said it had shot down two Ukrainian drones attacking the sites, and that three Russian servicemen were killed by falling debris and four others were wounded.

The attacks at the bases in the Saratov region on the Volga River and the Dyagilevo base in the Ryazan region in western Russia raised the threat of a dangerous escalation in the war.

Kviv had not commented on the explosions at the Russian

Russian President Vladimir Putin, meanwhile, drove a car across a bridge linking his country to the Crimean Peninsula following its repair from a truck bombing in October that had

embarrassed Moscow. Russia responded to the bridge attack by firing waves of missiles at Ukrainian infra-

structure targets in the weeks that followed, and Monday's onslaught was just the latest round of retaliatory strikes. Russia is seeking to disable Ukraine's energy supplies and infrastructure as winter approaches - part of a new strategy in its nine-month war. Defiant as ever, Ukrainian

praised his military forces and the technicians who snapped into action to repair the damage. "Air defense shot down most of the missiles," he said in brief comments on social media. "Power engineers have already

Our people never give up." Ukraine's air force said early indications showed Russian forces fired 38 cruise missiles from carriers in the Caspian Sea and from the southern Russian region of Rostov. Another 22 Kalibr cruise missiles were fired from its Black Sea fleet, and kong-range bombers, fighter jets and guided missiles were

also involved, it said. "In total, more than 60 invaders' missiles were shot down!" the air force said on its

Telegram channel. Ukraine's electricity provider, Ukrenergo, lashed out at Russia over "the eighth massive missile attack by a terrorist country," saying its facilities had been hit, triggering blackouts. It urged residents to stay

in shelters as its crews tried to repair the damage. In the capital of Kyiv, scores

of people quickly filled the central Zoloti Vorota metro station after the warnings, and many checked their phones for updates. There were no immediate signs of whether the city or the surrounding region was

Air raid sirens sounded across the country. Ukrainian media reported explosions in several parts of the country south of Kyiv, including Cherkasy, Kryvyi Rih and Odesa. Officials said water, electricity and central heating was cut to many parts of Odesa.

"The enemy is again attacking the territory of Ukraine with missiles!" Kyrylo Tymoshenko, the deputy head of the Ukrainian president's office, wrote on Telegram.

Tymoshenko said two peole were killed and three others injured - including a 22-month-old child - in the village of Novosofiyivka in the southern Zaporizhzhya region.

In neighboring Moldova, the Interior Ministry said on its Facebook page that border patrol officers had found a rocket in an orchard near the northern city of Briceni near

Emergency services, including a bomb squad. Were sent to the scene. Controls in the vicinity have also been tightened, the ministry said. It was not immediately clear when the rocket may have landed or who fired

The Dyagilevo air base, which houses flight tankers used to refuel other planes in the air, is located about 500 kilometers (over 300 miles) northeast of the Ukrainian border.

The Russian Defense Ministry said four other servicemen were injured and two aircraft were lightly damaged by the drones' debris.

China strictly adheres to its policy of no first use of nuclear weapons "at any time and under any circumstances," its Defence Ministry said Tuesday in a scathing response to a US report alleging a major buildup in Beijing's nuclear capabilities.

The Pentagon last week released an annual China security report that warned Beijing would likely have 1,500 nuclear warheads by 2035, and that it has provided no clarity on how

it plans to use them.

That report "distorts
China's national defence policy and military strategy, makes groundless speculation about China's military development and grossly interferes in China's internal affairs on the issue of Taiwan," ministry spokesperson Tan Kefei said in a statement.

Tan accused the US of being the "biggest troublemaker and destroyer of world peace and stability," and repeated that Beijing has never renounced the use of force to conquer self-gov-erning Taiwan, a US ally that China considers part of its ter-

Tan did not directly address the report's allegations about a Chinese nuclear buildup, but blamed the US for raising nuclear tensions, particularly with its plan to help Australia build a fleet of submarines powered by US nuclear technology, which the French president has described as a "confrontation with China."

Australia has said it will not seek to arm the submarines with nuclear weapons. Tan also accused the US of having the world's largest nuclear arsenal, although that title is actually held by Russia, a close Chinese military, economic and diplomatic partner.

As of 2022, Russia possessa total of 5,977 nuclear warheads compared to 5,428 in the US inventory, according to the Federation of American Scientists. China currently has 350 nuclear warheads, according to the federation.

South Korea's Joint Chiefs of Staff said it detected North Korea firing around 90 artillery rounds from the eastern coastal town of Kosong around 10 am and another 10 rounds from the nearby town of Kumkang around 6 pm.

It said the shells landed in the northern side of a maritime buffer zone the Koreas established in 2018 to reduce border

The South said it communicated verbal warnings to North Korea and urged it to abide by the military agree-The South Korean assess-

ments were slightly different from details announced by North Korea's military, which said it fired 82 shells from multiple rocket launchers.

An unidentified spokesper-

People's Army's General Staff said the firings were meant as a warning against "enemy side" artillery exercises in a region near the inter-Korean land bor-

The spokesperson said South Korea was being hypocritical in criticising North Korea for breaching the 2018 agreement, saying the South's unspecified past actions in violation of the agreement must be "calculated first."

India's growth forecast by any international agency amid the global turmoil. In October, the World Bank had cut India's GDP growth forecast to 6.5 per cent from 7.5

per cent earlier. Now, it has

upgraded the projection to 6.9

per cent for 2022-23 (April 2022 March 2023).

The report 'Navigating the Storm', said while the deteriorating external environment will weigh on India's growth prospects, the economy is relatively well positioned to weather global spillovers compared to most other emerging markets.

Sebi can relax rules for Govt for PSU disinvestment

Capital markets regulatory Norms for the Central Government in relation to strategic disinvestment of public sector undertakings (PSUs), according to a notification. 'The Board (Sebi) may

after due consideration of the interest of the investors and the securities market and for the development of the securities market, relax the strict enforcement of any of the requirements of these regulations if an application is made by the Central Government in relation to its strategic disinvestment in a listed entity," Sebi said in a notification made public on Tuesday.

To give this effect, the regulator has amended LODR (Listing Obligations and disclosure Requirements) norms.

Earlier in September, the Securities and Exchange Board of India (Sebi) had decided to dispense with a requirement for calculating open offer price with respect to the disinvest-



ment of PSUs

As per Sebi norms, one of the parameters prescribed to determine the open offer price of a frequently traded scrip is Volume-Weighted Average Market Price (VWAMP) for 60 trading days immediately preceding the date of the public announcement. The board of Sebi approved

amending the takeover regulations in the context of strategic disinvestment of PSUs and consideration payable under open offer.

"The market price of the PSU company undergoing strategic disinvestment becomes susceptible to... Periodic disclosures

"Considering the unique nature of transaction and process involved in a PSU disinvestment spanning over a long period, such a requirement of determination of open offer price under the takeover regulations many a time acts as an impediment in fructifying such strategic disinvestment of PSUs," Sebi has said.

Against this backdrop, Sebi has decided to dispense with the requirement of calculating 60 days' VWAMP for the determination of open offer price in case of disinvestment of PSU companies wherein it results in its change in control, either by way of direct acquisition or indirect acquisition.

Cut excise duty on CNG till gas included in GST: Parikh panel

The Union Government **1** should moderate the excise duty it levies on CNG till such time that the environment friendly natural gas is included in the one-nation-one-tax GST regime, Kirit Parikh Committee has recommended.

Natural gas is currently outside the ambit of GST, and existing legacy taxes -- central excise duty, state VAT and central sales tax -- continue to be applicable on the fuel.

While the central government does not levy excise duty on natural gas when sold in gaseous form, it charges a 14 per cent tax on compressed nat-ural gas (CNG). States levy VAT as high as 24.5 per cent on gas. The Parikh Committee,

which was formed to recommend fair price of gas to the end consumer and a "market-oriented, transparent and reliable pricing regime", in its report to



the Oil Ministry last week suggested that "gas should be brought under the GST

"The committee recognise that this requires consensus among the states," it said.

"To obtain this, if need be the states may be compensated for five years for any loss in revenue. The process of getting the needed consensus should be initiated now.'

Natural gas along with crude oil, petrol, diesel and ATF were kept out of the GST

regime when the single rate of taxation for goods and services was rolled out on July 1, 2017. Gas-producing states, such

as Gujarat, feared a loss of revenue if VAT and other taxes were to get subsumed into the

"Till the time the GST regime is implemented, Government may consider moderating the Central Excise duty rate on CNG to reduce the burden of higher natural gas costs on the consumers," the committee report said.

Fertiliser subsidy bill in FY'23 seen at ₹2.3-2.5 lakh cr; may fall 25pc in FY'24: FAI

The government's fertiliser subsidy will rise to Rs 2.3-2.5 lakh crore in this fiscal but the bill may fall by 25 per cent in the 2023-24 financial year with moderation in global prices, according to industry body FAI.

Fertilisers Association of India (FAI) expressed concern that the fixed cost of urea has not been increased affecting the viability of urea plants. It also pointed out that the industry is running on a very thin margin, which is hampering new investments in this sector.

The industry body said there is sufficient availability of fertilisers, including urea and DAP, for the ongoing rabi (winter-sown) season.

"We estimate the fertiliser subsidy bill at Rs 2.3 lakh crore to Rs 2.5 lakh crore," FAI President K S Raju told



reporters here late Monday.

This has helped insulate the farmers from the impact of a steep increase in the cost of all fertilisers due to sharp rise in international prices of fertilisers and raw materials, he

The fertiliser subsidy stood at Rs 1.62 lakh crore in the previous financial year.

FAI board member P S Gahlaut, who is MD of Indian Potash Ltd. said the subsidy bill in the next fiscal year could fall by around 25 per cent as the global prices have softened. However, he said a lot will depend on the future trends of global prices.

Global airline industry to post USD 6.9 bn loss in 2022: IATA

The global airline industry is projected to report a lower loss at ÚSD 6.9 billion in 2022, mainly due to stronger passenger yields and cost control by carriers amid rising fuel prices, according to industry body IATA.

In June, the International Air Transport Association (IATA) projected the industry loss at USD 9.7 billion. In October 2021, it forecast a loss of USD 11.6 billion for this

On Tuesday, IATA said the global airline industry is expected to return to profitability in 2023 and post a small net profit of USD 4.7 bil-

After being significantly impacted by the coronavirus pandemic, the airline industry is on the recovery path.

In 2022, airline net loss is expected to be USD 6.9 billion.

This is significantly better than loss of USD 42 billion and USD 137.7 billion in 2021 and 2020, respectively, it said.

"We are on the right path... But still a long way to go," IATA Director General Willie Walsh said at a briefing here on Tuesday.

For 2022, IATA said the improved prospects stem largely from strengthened yields and strong cost control in the face of rising fuel prices.

"Passenger yields are expected to grow by 8.4 per cent (up from 5.6 per cent anticipated in June). Propelled by that strength, passenger revenues are expected to grow USD 438 billion (up from USD

239 billion in 2021)," it noted. In the Asia Pacific region, airlines are projected to post a loss of USD 10 billion this year and the loss is expected to narrow to USD 6.6 billion in 2023.

The Asia Pacific region, IATA said, is critically held back by the impact of China's zero COVID policies on trav-



Having failed to take the last wicket when Bangladesh needed more than 50 runs, Indian bowlers could not deliver but there is no denying the fact that a star-studded batting line-up

needs to show more responsibility.
The last time India played a bilateral series in Bangladesh was back in 2015 when under Mahendra Singh Dhoni, the team lost the three-match series 1-2 and the only win came in the dead third rubber.

History could repeat itself at the Sher-e-Bangla Stadium if spinners Shakib Al Hasan and Mehidy Hasan Miraj can once again keep the Indian batters under wraps between overs 11-

That was the real period of struggle for all Indian batters, save KL Rahul (73 off 70 balls) who was the best player on show in the opening game.

While there are still 10 months left for the ODI World Cup, it is not yet clear what exactly will be Indian team's approach.

Stokes hails 'special' win in Pakistan

Skipper Ben Stokes hailed England's nail-biting victory in the first Test against Pakistan as "one of the best" of his career -- particularly given the state of the lifeless Rawalpindi pitch.
With just minutes to spare

in dying light after five days of enthralling cricket, England finally halted a heroic last stand by Pakistan's tailenders to win the first Test by 74 runs. It was only the third time

England have won a Test in Pakistan, although they haven't visited since 2005 because of security issues.

"To be able to get a result on this type of wicket is mindblowing," Stokes said ahead of the second Test starting in Multan on Friday.

"I think it's probably one of the best. The effort that everyone has managed to put in this whole week is just incredible.'

England have "Bazball" to thank for their victory -- the free-wheeling brand of cricket coined from the nickname of new head coach Brendon 'Baz" McCullum, a New Zealander.

McCullum was an aggressive batter in his playing days
-- he holds the record for the fastest individual Test century - and under him, and skipper Stokes, the English have brought one-day cricket to the five-day game.

Records tumbled in Rawalpindi with England becoming the only team in his-

tory to score 500 runs on the first day of a Test -- courtesy of four individual centuries, another record. Overall, some 1,768 runs

were scored in the match -- the third-highest aggregate since Test cricket began. Still, Pakistan did well to peg back England's daunting

657-run first-innings total to trail by just 78 runs. England again turned on the fireworks in their second innings before a bold Stokes declaration left Pakistan seek-

ing 343 runs for victory. For a while, it looked as if the home team would do it -but a devastating last session

saw England shine as the light dimmed for a famous victory. "We're pretty lost for words," said Stokes, who now has seven wins in the last eight

"I feel very honoured and feel a very privileged position to be able to lead these guys.

"Jimmy Anderson was saying he felt a bit emotional, so having a bloke with near enough 180 Test matches (176) feeling like that at the end of this is proof that we've achieved

something very special." Stokes suggested "Bazball" was here to stay.

"Test cricket is generally exciting when England are playing," he said. "That's what we set out to do from day one."
