# **GST** prosecution limit doubled to ₹2 crore

Council defines SUVs, slaps 22% cess, decriminalises certain offences

PTI NEW DELHI

The GST Council on Saturday agreed to decriminalise certain offences and doubled the threshold for launching prosecution under the tax law to ₹2 crore, but retained the limit at ₹1 crore for fake invoicing.

The Council also clarified on the definition of SUVs (sports utility vehicles) for the levy of 22 per cent compensation cess over the 28 per cent GST and decided to come out with parameters to define MUVs (multi utility vehicles).

Briefing reporters after the 48th GST Council meeting, Finance Minister Nirmala Sitharaman said the Council could decide on only eight out of the 15 agenda items due to paucity of time, but added that no new taxes have been brought in.

The agenda items which could not be considered included taxation for pan masala and gutkha firms and a report by a Group of Ministers (GoM) on setting up of appellate tri-bunals. The report of another

GoM, chaired by Meghalaya Chief Minister Conrad Sangma, on GST levy on online gaming, casinos and horse racing was also not part of the agenda for Saturday's meeting.

Sitharaman said in case of SUVs, the clarification that has been given is that the higher rate of compensation cess of 22 per cent is applicable to a motor vehicle fulfilling all four conditions — it is popularly known as SUV; has engine capacity exceeding 1,500cc; length exceeding 4,000 mm; has ground clearance of 170 mm and above.

"So this clarification is not new tax, it's more to say what defines that commodity which is under taxation as SUV," the Minister said.

Sitharaman said the discussion on MUVs began when some States asked whether sedans should be included in the SUV category. The States also suggested bringing in a definition for MUVs.

The Minister said the

Council decided that if any other motor vehicle categories need to be added to the 22 per cent cess, the panel of central and state tax officers (or the Fitment Committee) will look into it. The Centre and states would attempt to widen the GST base at every level to increase the tax mop-up which is averaging about ₹1.4 lakh crore every month.

"So the focus will be on how much all of us are putting effort... To widen the tax base, she said.

Currently, 1.40 crore tax payers are registered under GST. Revenue Secretary Sanjay Malhotra said the Council took a "path breaking decision" with regard to decriminalising three types of GST offences obstruction or preventing any officer in discharge of his duties; deliberate tampering of material evidence; and fail-

# Gui Govt competent to decide on Bilkis' convicts' release: SC

The Supreme Court has dismissed the review petition filed by Bilkis Bano against the May 13 judgment that held that the State of Gujarat was the "appropriate Government" competent to examine the application for the pre-mature release filed by a convict in the gangrape and murder case.

The separate writ petitions filed by Bano and many others like CPI(M) leader Subhashini Ali and TMC MP Mauha Moitra against the remission of the accused persons is, however, pending before the apex

The order was passed by a bench of Justices Ajay Rastogi and Vikram Nath on December 13, but uploaded on the apex court's website on Saturday. In its May 13 order, the apex court had asked the State Government to consider



the plea of a convict for premature release in terms of its policy of July 9, 1992, which was applicable on the date of conviction, and decide it within a period of two months.

Bano's separate petition challenging the remission of the sentences of the 11 convicts by the State Government is pending before the Supreme

Bano was gangraped in the aftermath of the 2002 riots and her three-year-old-daughter was among twelve people killed by a mob in Limkheda taluka of Dahod district in

# Why BSF needs 'so much' land, Mamata asks Shah

The Centre had earlier increased the BSF's jurisdictions from 15 km to 50 km much to the chagrin of the Chief Ministers of the border States, including Mamata.

According to reports the Chief Minister raised the issue

for a second time in a private one-on-one parley with Shah. After the two-and-a-half-hour EZC meeting, Mamata met minutes where she reportedly raised the BSF issue once again,

sources said. The Chief Minister asked on what basis the BSF was asking for so much land and added that it would be not possible for her Government to allot the amount of land thus

demanded. Later Bengal Opposition Leader Suvendu Adhikari said that the Chief Minister was reluctant to provide requisite land to construct BSF out-

posts as also fencing the border. "Questions are being raised as to why the long border with Bengal has not been fenced entirely ... it is the State Government which is not ready to provide the land ... we will request the Home Minister to get the land purchased for the construction of BSF posts and fencing in order to stop border smuggling and infiltration which helps the Trinamool Congress," Adhikari said.

# Maha Morcha: MVA flexes muscles, demands Guv's removal

The belligerent Opposition Maha Vikas Aghadi (MVA) - comprising Shiv Sena, NCP and Congress - flexed its muscles on Saturday by rooting for the removal of Governor Bhagat Singh Koshyari over his controversial statements about the state icons and hitting out at the Shinde-Fadnavis government for its ineffective handling of the Maharashtra-Karnataka border row.

On a day when the MVA and scores of political smaller political parties, trade unions and various organised a massive 5 km morcha from Byculla to the Chhatrapati Shivaji Maharaj Terminus (CSMT), NCP chief Sharad Pawar led the Opposition attack against the Governor, by asserting that Maharashtra would "erupt" if Koshyari was not either recalled or removed from his post. Addressing a public rally

after the MVA morcha culminated at the CSMT, Pawar

ridicules state icons like led Shiv Sena-BJP alliance Mahatma Phule and Savithtribai Phule has no moral right to continue in his post. In Maharashtra, we have seen Governors of the stature of Shankar Dayal Sharma, Dr C Subramaniam and P C Alexander. But, we have not seen such a Governor in the history of the state...As of now, the people in the state are quiet. If the Governor is not removed from his post in the near future, Maharashtra will erupt over this issue".

Mincing no words about his displeasure over the manner in which the ruling BJP leaders "defaming" Maharashtra through their criticism of state's iconic figures like Chhatrapati Shivaji, Mahatma Phule, Jyotiba Phule and late B R Ambedkar, Pawar said: "We expect competition among the ministers and party leaders over the development matters. But, what we witnessing among them is a competition in defaming the state".

Debunking the quality of

government in the state, former chief minister and Shiv Sena (UBT) president Uddhav Thackeray said: "There are such ministers who have such low intellectual capacity. There are ministers who insult women leaders like NCP MP Supriva Sule. These rascals have no moral right to invoke the name of Chhatrapati Shivaji. The rascals are in politics to loot Maharashtra".

in 1995, they said. Anuj Sharma's mother had died last year, they added.

On December 11, Anuj Sharma's father had gone to Indore and the accused and the victim were alone in the house, police said.

Anuj Sharma wanted to go to Delhi but the woman refused. It led to a heated argument and he hit her with a hammer, they said.

The incident took place in the kitchen. The accused dragged the body to the bathroom and cut it into eight-10 pieces with a marble cutter.

Bano's revision plea against the top court's May 13 judgment contended that the remission policy of State of Maharashtra should apply in the present case, instead of 1992 remission policy of Gujarat since the trial in the case had happened in Maharashtra. The top court had on, May 13, ruled that remission of the convicts in the case should be considered as per the policy existing at the time of conviction in the State where the crime was actually committed.

tax amount for launching prosecution under GST has been raised from Rs 1 crore to Rs 2 crore, except for the offence of issuance of invoices without supply of goods or services or both.

Also, the compounding amount has been reduced to the range of 25 to 100 per cent, cent of the tax amount.

Central Board of Indirect Taxes and Customs (CBIC) Chairman Vivek Johri said currently under the GST law offences exceeding Rs 1 crore are considered for criminal prosecution. "What was proposed in

Council and what came out of the discussion was that the limit would be enhanced from Rs 1 crore to Rs 2 crore now. So cases involving tax amount of up to Rs 2 crore will go out of the purview of criminal action,

except cases of fake invoicing, Johri said. the current threshold of Rs 1 crore for launching criminal prosecution will continue in fake invoicing cases which continue despite many measures taken by the tax authorities.

The Centre in September issued directions to Central GST officers to launch exceeding Rs 5 crore. That direction was given through a circular, but the GST law currently sets the limit at Rs 1 crore. Malhotra said the amendments in GST law to give effect to the Council's decision on decriminalisation of GST offences would be brought in the Finance Bill, 2023.

After that, the state legislatures too would have to pass the amendments and pave the way for making the changes


# Jet CEO stuck in midnight traffic, blames trucks

Stuck for more than 45 minutes in mid-night traffic, Jet Airways CEO Sanjiv Kapoor, while leaving from IGI terminal-3 towards Gurugram, blamed the large number of trucks heading out of Delhi to Reporting the problem, the

airline's CEO posted the problem on Twitter and tagged Union Road Transport and Highway Minister Nitin Gadkari to find a solution for the problem. In the post, he also tagged the Delhi Traffic Police and National Highways Authority of India (NHAI) to address the issue.

It has taken 45 minutes to get from DEL T3 parking to the right turn under the highway to get onto NH-48 towards Gurgaon. And we have been stuck at this spot here for at least 15 minutes at 12.39 a.m., he tweeted on Friday. "The cul-



12.45am," his tweet read. Besides the problem of traffic, the CEO also pointed out the randomly parked trucks in the middle of the highway without any lights "As we approach the Haryana border, trucks randomly parked in the middle of the highway, not even on the leftmost lane. How many accidents and how

many lives lost due to accidents caused by this? Can this not be controlled?" he said in another tweet. Later on, describing the problem further, Sanjiv Kapoor further added, "Besides the traffic snarl at 1am getting onto the highway towards Gurgaon from T3, the bigger worry is the random parking of trucks with all lights switched off almost in the middle of the highway near the Haryana border. How is that allowed to continue so brazenly?" The Delhi-Gurugram e-way, which was built for a smooth and highspeed travel, has lost its very objective. Lack of lay-by spots, increase in volume of vehicles and not following lane driving norms leads to massive traffic jams throughout the day. The 27.7-km stretch spans from Rao Tula Ram flyover near the Delhi airport to Kherki Daula toll plaza in Gurugram. Over 4 lakh vehicles use this stretch during peak morning and evening hours.

Traffic bottlenecks can be witnessed not just during peak hours, but also throughout the day, due to poor condition of service lanes and missing direction boards around Terminal 3 of the Delhi airport.

As thousands of people commute daily between Gurugram and Delhi for office work, jam is witnessed at the Sirhaul border. It takes an hour to reach from Shankar Chowk to Sirhaul border. Even the MCD toll at border has been disturbing movement of traffic.

## Pvt schools will no longer be able to deny admissions under EWS cat after HC order: CM

 $P^{\text{rivate schools in the nation-}}_{\text{al capital will no longer be}}$ able to deny admission to children under the Economically Weaker Section category as per their will after a Delhi High Court order. Terming it a big victory, the Arvind Kejriwal government said that private schools will not be allowed to refuse EWS admissions as per their will now.

The High Court on Friday ruled that private schools will no longer be able to deny admissions to children under the EWS category selected through the draw of lots by the Directorate of Education, Delhi government officials said.

This order by the High Court will provide relief to thousands of poor families, as private schools will not be able to deny admission to their children, the officials said. Directorate of Education received several complaints about private schools refusing to give admission to the children allotted to them, they said.

Private schools were arguing that they are not giving admission to EWS category children due to non-fulfillment of admissions in general seats, they added.

In this case, it was observed that many private schools were giving admission to one student of EWS category only after getting admission in three seats under the general category, due to which many

children selected in the draw were eventually denied admission, the officials said. After this issue was taken to the court, it deliberated on the arguments of both parties and reached a decision on Friday that private schools will no longer be able to deny admission to the children selected in the draw, they said. Legal action will be taken against the schools refusing admission, the officials said.

At present, under the Right to Education Act, there is a provision for students from backward classes to 25% of total seats available in recognized private schools.

Every year before the session begins, private schools inform the Directorate about the number of entry grade seats on the basis of which 25% seats are allocated for admission to children of EWS/DG

After this, the Directorate of Education invites online applications, selects children for EWS admissions in a transparent manner through a randomised draw of lots and allots schools to them.

# Bangladeshi infant with cyst undergoes successful head surgery at AIIMS

three-month-old boy from ABangladesh, suffering from a rare congenital condition, got a new lease of life after doctors at AIIMS here removed a protruding part of his brain which had turned into a giant cyst, larger than the size of his head.

Giant Occipital Encephalocele is a rare congenital condition in which there is a big sac-like protrusion or projection of the brain and the membranes that cover it through an opening in the skull. If left untreated, the giant cyst can rupture, causing meningitis and then death, Dr Deepak Kumar Gupta, Professor of the Department of Neurosurgery at AIIMS told PTI.During the three-hour

the cyst and also "covered the functional part of the brain by expanding the skull.""Large swelling from behind the skull causes difficulty in positioning of the baby, difficulty in feeding and nursing and there is always a fear of sudden rupture of the swelling containing brain tissues," he said.

Dr Gupta said the father of the child Abid Azad, Development Outreach and Communication Specialist, USAID, Bangladesh, had approached him a couple of months back. "After evaluating the baby's condition, we decided to perform the surgery. On December 12, the surgery was done during which the nonfunctional protruding part of the brain which had taken the shape of a cyst was excised, all

served and expansile cranioplasty was done at same time giving space to brain to continue to grow in future," Dr Gupta said.

Six days after the surgery, the child Arhat Aydin is doing well and is likely to be discharged on Monday. While, Arhat's twin broth-

er is healthy and is with his mother in Bangladesh, his father travelled all the way to Delhi for the surgery and is now taking care of him single-handedly, Dr Gupta said. In this case, the neurosurgeon said the mother didn't take any folates (Folic acid tablets) which could be the reason behind this condition. Folic acid prevents fetal neural tube defects. "This case emphasises the need for folic acid supplereproductive age group planning to conceive," he said. Mandatory folic acid for-

tification of centrally produced food staples to provide all woman of reproductive age who eat fortified foods with at least 150 microgram/day of folic acid has been recommended by WHO, 2009.

"This is to reduce the prevalence of spina bifida and anencephaly, encephalocele and associated disability and mortality, thereby helping countries achieve their 2030 Sustainable Development Goals," he said. Woman becoming pregnant should consume 400 microgram of folic acid/ day from fortified foods or supplements or both in addition to that obtained through a normal diet.

Congress general secretary communications Jairam Ramesh said in a statement that it is the political duty and moral responsibility of the Prime Minister to share his "mann ki baat" on the seven questions posed to him by his party.

The nation wants to know...Why are you insisting that there should be no debate in Parliament on the border situation and the challenges we face from China," he asked.

You have met the top Chinese leadership an unprecedented 18 times and recently shook hands with Xi Jinping in Bali. China launched an incursion into Tawang shortly thereafter and continues to unilaterally alter the border situation. Why are you not taking the nation into confidence?" the Congress leader asked.

Ramesh said why did the prime minister say on June 20, 2020 that "there has been no incursion by China into Indian territory in eastern Ladakh?

"Why have you allowed Chinese companies to contribute to PM CARES Fund? Why have you allowed imports from China to zoom to record levels in last two years," he


## BJP calls Rahul Jaichand for 'insulting' Army, demands his sacking from Congress party



# Russia launches another missile attack on Ukraine

Ukraine's capital came under one of the biggest attacks of the war on Friday as Russia's invading forces fired dozens of missiles across the country, triggering widespread emergency power outages, Ukrainian officials said.

Gunfire from air defense systems and thudding explosions combined with the wail of air-raid sirens as the barrage targeted critical infrastructure in cities including Kyiv, Kharkiv, Kryvyi Rih and Zaporhizhzhia. The head of the Ukrainian armed forces said they intercepted 60 of 76 missiles launched.

"My beautiful sunshine. What am I going to do without you?" wailed Svytlana Andreychuk in the arms of Red Cross staffers. Her sister Olha was one of at least three people killed when a missile slammed into a four-story

## \$2B in loans to help Ukraine's agriculture, fuel import sectors

Private businesses in Ukraine are in line to receive \$2 billion in financing arranged by the International Finance Corporation (IFC) to help rebuild the country's agriculture and fuel import industries and other ventures, which have faced extensive losses because of the war.

The IFC, a member of the World Bank Group, provides private sector financing to developing countries. The loans differ from the billions that Ukraine has received in grants and other forms of nostrings-attached aid from donor nations, as they must be paid back. Since Russia invaded in February, at least 5 million jobs have been lost, according to Ukraine's Ministry of Economy. The National Bank of Ukraine estimates that 11% of businesses had closed as of September and more than half were operating below capacity.

Loans to the country's private sector will become more important in coming years as Ukraine's finance ministry copes with a widening budget deficit. In addition, grants and other foreign aid are not guaranteed, and Republicans in U.S. Congress have signaled uncertain support for Ukraine when they take control of House in January. Getting private financing is difficult for countries facing war, floods

## UN: Thousands in Africa could face starvation

More than 25,000 people could face starvation in conflict-plagued parts of West Africa next year, a United Nations official warned Friday. Federico Doehnert of the World Food

Program said violence and the economic fallout of the COVID-19 pandemic and the war in Ukraine are largely driving the threat to people in Nigeria, Mali and Burkina Faso.

"One of the most striking things is that where we already had issues with severe food insecurity last year, this year we're seeing a further deterioration" Doehnert said in Dakar while presenting findings from the latest food security report by regional governments, the U.N. And aid

The cross-border region between Burkina Faso, Mali and Niger is the epicenter of West Africa's escalating humanitarian crisis, which is compounded by climate change, severe floods and droughts placing more than 10 million people in need of assistance, the U.N. Said in a statement this week. Doehnert said nearly 80% of people facing catastrophic hunger - some 20,000 - are in Burkina Faso's Sahel region, where jihadis linked to al-Qaida and the Islamic State group have besieged cities and cut off assistance. Residents of the city of Djibo have been blockaded for months, unable to access their farms.

"We only get food when convoys come. Unfortunately, they are not coming on a regular basis," Sidi Dicko, a resident of Djibo, told The Associated Press by phone. "We pray for God to help us out of this situation

Dicko said the little food that arrives gets through with military convoys, which often are attacked on the road. Aid groups need to use helicopters to transport food,

Doehnert said that in Mali, where violence has been ongoing for a decade, 1,700 people will face catastrophic levels of

Displaced people there say they lack jobs and can't afford food. "Before (the violence), I would go to the market to work and bring back food for my family," Oumar Barry said, speaking to The Associated Press from a camp in Mopti city

where he shelters with his 10 children. His family eats twice a day now instead of three times, Barry said. Other regional nations that aren't plagued by the same levels of violence also face hunger problems.

In the last quarter of the year, Benin, Ivory Coast, Guinea, Guinea-Bissau, Liberia, Sierra Leone and Togo experienced a 20% increase in food insecurity compared with 2021, according to the food security report.



# Philippine Communist Party founder Sison pases in exile at age of 83 years

Tose Maria Sison, the founder of the Communist Party of the Philippines, whose armed wing has been waging one of Asia's longest-running insurgencies, has died. He was 83.

Sison died peacefully late on Friday after two weeks of confinement in a hospital in Utrecht, the Netherlands, the party's spokesman, Marco Valbuena, said in a statement on Saturday. The cause of death was not disclosed.

Sison had lived in selfexile in The Netherlands since then-President Corazon Aquino released him from detention in 1986, shortly after the "People Power" revolt overthrew dictator Ferdinand

# Malaysia landslide death toll rises to 24, more 9 missing

## Minal Patel convicted in \$447 genetic testing scam

n Indian American labo-Aratory owner from Atlanta has been convicted of involvement in a \( \text{\text{\$\text{\$\text{\$447.54}}}\) million genetic testing scam to defraud Medicare.

Minal Patel, 44, who owns LabSolutions LLC conspired with patient brokers, telemedicine companies and call centres to target Medicare beneficiaries with telemarketing calls falsely stating that their package covered expensive cancer genetic tests, federal prosecutors alleged. After the Medicare beneficiaries agreed to take tests, Patel paid kickbacks and bribes to patient brokers to obtain signed doctors' orders

authorising the tests from telemedicine companies, the Department of Justice said. To conceal the kickbacks, Patel required the patient brokers to sign contracts that falsely stated that they were performing legitimate advertising services for LabSolutions.

A federal court in Florida has convicted Patel of one count of conspiracy to commit health care fraud and wire fraud, three counts of health care fraud, one count of conspiracy to defraud the United States and to pay and receive illegal health care kickbacks, four counts of paying illegal health care kickbacks, and one count of conspiracy to commit money laundering.

# **'Online games with certain** outcome under 28% GST'

¬entral Board of Indirect Taxes chief Vivek Johri on Saturday said online games where winning is dependent on a certain outcome would attract 28 per cent GST on the full bet

Though the report of the Group of Ministers (GoM) on online gaming did not come up for discussion at the GST Council, the department would go by the view that 28 per cent GST is payable on full bet value put in by a player, and not net of margins.

The comments assume significance as the Gameskraft Technology Pvt Ltd (GTPL) GST evasion case is still in the court. Directorate General of GST Intelligence (DGGI) in September issued a show cause notice to Bengaluru-based online gaming company Gameskraft Technology Pvt Ltd (GTPL), for not Goods and Services Tax (GST) to the tune of Rs 21,000 crore.

Asked what would be the position of the Central Board of Indirect Taxes (CBIC) since the Council has not decided yet on the GoM report, Johri said the department's view is that 28 per cent GST is payable on actionable claims arising out of betting or gambling and the tax is to be payable on full value, not net of margins.

"The gaming activity is



considered as gambling because the winning is dependent on a certain outcome,"

The report of the GoM could not come up for discussions in the GST Council since it came in just two days ahead of the Council meeting and hence could not be circulated to the states. Usually, GST Council secretariat gives notice to members in the GST Council before tabling any agenda. Meghalaya Chief Minister Conrad Sangma chaired Group of Ministers (GoM) had on Thursday submitted its report to Finance Minister Nirmala Sitharaman.

The GoM, in its last meet-

ing in November, had agreed on a 28 per cent GST on online gaming casinos and horse racing. However, in absence of

consensus on whether the tax should be levied on only the fees charged by the portal or the entire consideration, including the bet amount, received from participants, the GoM had decided to refer all suggestions to the GST Council for a final decision.

Briefing reporter after the GST Council meeting on Saturday, Finance Minister Nirmala Sitharaman said the GoM report would be "discussed threadbare" when the Council takes it up for discus-

# 'Centre, States GST payer base'

The Centre and States are working out strategies to widen taxpayer base under GST and have started pilot projects on sharing of data with discoms and property tax details to identify non-GST registered businesses.

Central Board of Indirect Taxes and Customs (CBIC) chief Vivek Johri said a pilot project on data sharing with discoms is ongoing in Madhya Pradesh, while Gujarat is undertaking a pilot on PANbased linkage of businesses. Maharashtra is doing a pilot on sharing property tax data and geo tagging businesses and linking with their property.
"We are working out (a)

strategy, we are discussing with states. Widening GST base would mean we have to see taxpayers who ought to be in tax net are they there or not. What we are looking at is robust data from all agencies," Johri told reporters here.

Explaning how the data sharing with power distribution companies or discoms would work, Johri said the department would match data base to see who are electricity consumers with commercial use connections and not in the tax department data base



He said the missing link can be detected if the property or electricity connection is registered for commercial use but not registered under Goods and Services Tax (GST).

Currently, there are 1.4 crore businesses registered under GST, which was launched on July 1, 2017.

Briefing reporters after the 48th GST Council meeting on Saturday, finance minister Nirmala Sitharaman had said that the Centre and states would attempt to widen the GST base at every level to increase the tax mop-up, which is averaging about Rs 1.4 lakh crore every month.

"The focus will be on how much all of us are putting effort... To widen the tax base,"

# Have sufficient foodgrain stocks to working on to widen meet needs of welfare schemes: Govt

The Centre on Saturday said it has sufficient foodgrain stocks to meet the requirements under the food security law and other welfare schemes.

The government is also regularly monitoring the prices of essential commodities.

"Government of India has sufficient foodgrain stocks under central pool to meet the requirement of NFSA and its other welfare schemes as well as for additional allocation of PMGKAY," an official statement said

About 159 lakh tonnes of wheat and 104 lakh tonnes of rice will be available as on January 1, 2023, as against the respective buffer norms requirement of 138 lakh tonnes of wheat and 76 lakh tonnes of rice as on January 1.

As on December 15th, around 180 lakh tonnes of wheat and 111 lakh tonnes of rice are available in the central pool. Buffer norms requirements have been envisaged for particular dates of the year as on 1st of April, 1st of July, 1st of October and 1st of January, the ministry noted.

The stock position of wheat and rice under central pool have always remained well above the buffer norms, it asserted. Around 227 lakh tonnes of wheat and 205 lakh tonnes of rice were available as on 1st of October, 2022 against the respective buffer norms Under the PMGKAY, the requirements of 205 lakh Centre provides 5 kilogram tonnes of wheat and 103 lakh foodgrains per month free of tonnes of rice as on 1st of cost to around 80 crore people



# MESSI TARGETS WC GLORY AGAINST MBAPPE'S FRANCE

ionel Messi is hoping to crown his stellar career by Leading Argentina to World Cup glory on Sunday but Kylian Mbappe's history-chasing France are standing in his way. Qatar's World Cup has been

tarnished by controversy off the pitch but it concludes with the electrifying prospect of a final between two of global football's powerhouses.

France may need every hour available as kick-off looms after their camp was struck by illness, forcing a number of players to sit out training and giving coach Didier Deschamps an unwanted headache.

Argentina and France are both aiming to win the trophy for the third time, with Les Bleus returning to the final four years after their triumph in Moscow.

Back-to-back titles would be a monumental achievement for the side coached by Deschamps -- the only teams to have done it previously are Italy in the 1930s and Pele's Brazil in 1958 and 1962.

Yet that potential achievement is trumped by Messi's quest to win the ultimate prize in the game in what is almost certainly his final World Cup match.

The former Barcelona star has won everything going at club level, also claiming the Ballon d'Or seven times, and last year led Argentina to victory in the Copa America.

Messi has been brilliant in his fifth World Cup as the team bounced back from a shock opening loss to Saudi Arabia, while his new sidekick, Julian Alvarez, has scored four times.



"It is exciting to be in the final, but there is still one step to go," said coach Lionel Scaloni.

#### **CHASE FOR 3RD TITLE**

Aged 35 and driven by his desire to make up for defeat by Germany in the 2014 final, Messi has scored five goals and produced some sublime assists.

Sunday's match is likely to be his last chance to match the achievement of Diego Maradona, who inspired Argentina to

victory in Mexico in 1986.

"I am really enjoying myself. I have felt happy throughout this World Cup," Messi said after Argentina's 3-0 semi-final win against Croatia.

But will this World Cup be remembered as Messi's tournament, or will France be top dogs once again?

# France not worried about hostile atmosphere in World Cup final

Holders France insist playing in front of a largely hostile crowd in Sunday's World Cup final against Argentina will not have an impact as they attempt to become the first team in 60 years to retain the trophy. Argentina may have the

backing of a majority of neutrals as Lionel Messi bids to win his first World Cup in probably his last ever game at the tournament

In addition Argentina will also have far more supporters in the crowd at the Lusail Stadium, with up to 40,000 expected in Doha for the occasion, while French fans are set to number around 6,000.

"I am well aware that Argentina will have a lot of fans behind them," said coach Didier Deschamps, who is hoping to become the first coach to win back-to-back World Cups since Italy's Vittorio Pozzo in the

"I expect a festive atmosphere with the Argentine people who are passionate and will be right behind their team.

"They sing a lot and are very expressive. That's good, it's a World Cup final after all, but our opponents are not in the stands.'

France can become the first side since Brazil in 1962 to retain the World Cup. Both teams are looking to win the trophy for the third time, with Argentina's last triumph coming



"It's the same objective for the two teams. One of the two will have a third star on their shirt after tomorrow's game," said Deschamps. Meanwhile captain Hugo

Lloris insisted France are not focusing solely on Messi, with Argentina coach Lionel Scaloni having built a solid team around their superstar.

"We came into this competition looking to go as far as possible. Lots of people didn't believe in us but here we are back in the final again," said goalkeeper Lloris, with France having arrived in Qatar minus a host of key players due to

Mbappe has been given the freedom to roam for France but very rarely does he get back to help out defensively, a point Didier Deschamps addressed by bringing on Marcus Thuram against Morocco with France protecting a 1-0 lead.

Theo Hernandez is a more dynamcleft-back than his injured brother Lucas, but it could allow Argentina right-back Nahuel Molina — set up by Messi for the opening goal in the quarter-final against the Dutch — to push forward as well.

#### VIRUS CONCERNS IN FRANCE

France left Adrien Rabiot behind at the team hotel for the game against Morocco, while Ibrahim Konate replaced Dayot Upamecano in defence after the pair experienced "flu-like" symptoms in the build-up.

Deschamps downplayed concerns over Upamecano, who was well enough to sit on the bench, and said Rabiot "should be available" for the final.

But there was surely growing unease Friday at the illness spreading through the squad when Konate, Raphael Varane and Kingsley Coman all sat out training due to illness.

"There is little bit of flu going around but nothing serious," said Randal Kolo Muani, scorer of France's second goal against Morocco less than a minute after coming on as a substitute.

While Zakir and his young opening partner Najmul Hossain Shanto (67, 156 balls) frustrated the Indian bowers for an entire session and added a record 124 for the first wicket, the visitors pulled back things in the second session to regain control of the proceedings. Axar (27-10-50-3), who had a

dream Test debut against England at home in 2021, perhaps had his best performance in a short career in the longest format, considering that the fourth day wicket didn't have a lot of help for spinners. The Zahur Ahmed Chowdhury track didn't show considerable wear and tear and surviving wasn't difficult with only a few deliveries turning appreciably.

Three batters — Yasir Ali (5), Mushfiqur Rahim (23) and Nurul Hasan (3) — actually preempted Axar's deliveries and made a fatal mistake.
Yasir and Mushfiqur didn't cover

On Mohammed Siraj, he said, "It's about the character and attitude he carries. Every game that he plays, he gives you that opportunity, even on a placid track like this, he created opportunity."

# England lose early wicket after dismissing Pak for 304

Spinner Jack Leach snared 4-140 and England's youngest ever test debutant Rehan Ahmed picked up two wickets to dismiss Pakistan for 304 in the third and final Test on Saturday.

Pakistan hit back early through spinner Abrar Ahmed, who claimed Zak Crawley leg before wicket without scoring in his first over, and England finished the opening day at 7-1. Ben Duckett (4 not out) and Ollie Pope (3 not out) are at the crease.

Abrar had a terrific Test debut when he grabbed 11-234 at Multan in the second Test but Pakistan still lost that thrilling game by 26 runs inside four days. Leach bowled an 11-over spell in Karachi with the new ball and Ahmed overcame his nervy first five overs to finish with 2-89.

Ahmed's father, Naeem, was among a sparse crowd at the National Stadium and the proud dad was earlier in the England team's huddle when former captain Nasser Hussain handed toss. At the age of 18 years, 126 days, Ahmed is 23 days younger than Brian Close, who made his Test debut for England against New Zealand at Manchester in

Pakistan captain Babar Azam (78) and Agha Salman (56) hit composed half centuries for the hosts, but England always came back hard on another dry wicket which offered slow turn to both Leach and Ahmed. Babar looked set for his sec-

ond century of the series but couldn't beat Harry Brook's timely throw and good work by wicketkeeper Ben Foakes in the final session and was run out. Leach had Salman stumped off a delivery which spun sharply away from the righthander before wrapping up the innings.

Ahmed replaced James Anderson after England rested the 40-year-old seamer with an unassailable 2-0 lead while Foakes returned after missing the first Test due to illness.

Ahmed dismissed Saud in the series when he had the lefthander caught close to the wicket by a diving Ollie Pope in his seventh over, but Babar continued to dominate the legspinner and took Pakistan to 204-5 by tea. Ahmed then dried up the runs in the last session and also had Faheem Ashraf trapped lbw off a perfect googly from round the wicket.

England, looking for a rare 3-0 clean sweep in its first test tour to Pakistan in 17 years, had made early inroads after Babar won his first toss in the series and chose to bat.

Azhar Ali fell for 45 in his farewell test match at the stroke of lunch after Ollie Robinson's short pitch delivery down the legside caught the gloves of the righthander. Azhar, who announced his retirement from Test cricket on Friday, was snapped up by Foakes and the television replays confirmed it was a clean catch as Pakistan reached



## INDIA DOWN SPAIN 1-0 TO WIN FIH WOMEN'S NATIONS CUP

'ndia clinched the inaugural FIH Women's Nation's Cup title with a 1-0 win over Spain in the summit clash here on Saturday.

The win sealed India's berth in the 2023-24 Pro League. Gurjit Kaur scored the allpenalty corner as the Commonwealth Games bronze medalists ended the eight-nation tournament with five wins on the trot.

The Janneke Schopman-coached side had beaten Ireland 2-1 via shootout in the semifinals here on Friday.

India were ranked a spot below Spain (seventh) in the FIH chart.

By virtue of winning the Nations Cup, the Indian team has been promoted to the 2023-24 FIH Hockey Women's Pro League, a key event ahead of next year's Asian Games and 2024 Paris Olympics.

It was Spain who first earned an early penalty corner but Indian captain and goalkeeper Savita Punia made an excellent save.

India earned their first penalty corner in the sixth minute and converted it to take the lead. Drag-flicker Gurjit Kaur sent the ball to the left side of the Spanish goalkeeper Clara Perez and managed to beat her.

India played brilliantly at the start of the second quarter. Lalremsiami earned a PC for the team but

this time Gurjit could not manage to beat the goalkeeper with her drag-flick.

Spain soon regrouped and made several raids on the Indian circle before earning a PC at the halfway stage of the second quarter.

# Aus beat India by seven runs in 4th women's T20I



Harmanpreet Kaur and Richa Ghosh's late power hitting proved not enough as Australia rode on Ellyse Perry's masterclass half-century to secure a series-clinching seven-run win in the fourth women's T20I here on Saturday.

Continuing her dream comeback. Perry smashed a blistering 72 not out from 42 deliveries (7x4, 4x6) to power Australia to 188 for 3 after being invited to bat. The visiting side's captain Alyssa Healy retired hurt after scoring 30 due to a calf injury.

In reply, India managed 181for 5 in their 20 overs as Harmanpreet's 30ball 46 and Richa's 19-ball 40 not out went in vain.

World champions Australia thus clinched the five-match series as they have taken an unassailable 3-1 lead going into the final T20I here on Tuesday. India were down 49 for 3 inside seven overs and they needed 105 from 54 balls when Harmanpreet stepped it up against Megan Schutt.

The Indian skipper then punished Heather Graham, smashing her four boundaries from five balls in the 13th over that yielded 17 runs to revive the

But Harmanpreet fell four runs shy of her half century as India still needed 68 runs from 34 deliveries when Richa took over.



#### **LIONEL MESSI'S LAST CHANCE AT WORLD CUP GLORY** While he has long been hailed as one of

the best players of all time, some have said that only a World Cup triumph can cement Messi's position of football's G.O.A.T.

At 35 years old, this is Messi's fifth World Cup, with the closest he has come to winning it a 1-0 loss to Germany in the 2014 final in Brazil.

While he has dominated the game on a domestic level - Messi has seven Ballon d'Or trophies to his name and four Champion's League titles - the Rosario native has been perceived to have underperformed when it came to the World

Cup.

But all that's changed this year in Qatar as five goals and three assists en route to the final testify to. Messi is now Argentina's record World Cup goalscorer with 11 and is in pole position - along with France's Mbappe to win this year's golden boot.

If Argentina are to win their first World Cup since Diego Maradona lifted the trophy in 1986, it's almost unthinkable that they can do it without the mercurial talents of Messi in the final.



Pele is the only player in history to have won two World Cups before his 24th birthday, but all that could change on Sunday if France's Mbappe triumphs in the Lusail Stadium in Qatar. With nine goals in two World Cups, including five so far in Qatar, Mbappe looks like he is born for this

stage. But the young PSG player isn't just about goals - his two assists this campaign show he is as adept at providing as he is finding the back of the net himself.

Mbappe has tasted more success in the World Cup than Messi, having scored the fourth goal in the 4-2 victory over Croatia in the last final in Russia And it's hard to forget his performance against Argentina

#### **JULIAN ALVAREZ: THE PLAYER MESSI CALLED 'SPECTACULAR**

Just 22 years old and starring in his first World Cup, Julian Alvarez has proved to be a revelation for Argentina.

The young Manchester City striker started the first two games of the tournament on the bench, but has since begun every game in

Argentina's run to the final. Four goals represent an excellent contribution from **Alvarez**, but it is the importance of those goals that have set tongues wagging. A brace in the semi-final against Croatia and a seemingly innate ability to link up with Messi are just two reasons why you won't want to keep your eyes off him in the final.

He even had the great man himself salivating over his performances in Qatar, with Messi describing Alvarez as "spectacular".

#### **ANTOINE GRIEZMANN: FRANCE'S NEW MIDFIELD MAESTRO**

in breaking up opposition attacks. Against England in the quarterfinal, Griezmann's ability to pull players out of position gave France space to exploit in their opposition's backline - a feat he repeated against Morocco as he played a vital role in France's first goal

# CANCER TREATMENTS BOOSTED BY IMMUNE-CELL HACKING

Elaborately engineered immune cells can not only recognise cancer cells, but also evade defences that tumours use to fend off attacks, researchers have found. The HEALTH PIONEER brings the report

wo studies published recently in Science journal build on the success of chimeric antigen receptor (CAR)-T cancer therapies, which use genetically altered T cells to seek out tumours and mark them for destruction. These treatments have the potential to lead to longlasting remission, but are not successful for everyone, and have so far been effective against only a small number of cancers.

Last-resort cancer therapy holds back disease for more than a decade

To bolster the power of CAR-T therapies, researchers have further engineered the cells to contain switches that allow control over when and where the cells are active. The hacked cells produce a protein that stimulates T cells, to counteract immunosuppressive signals that are often released by tumours.

Both studies are a tour de force in T-cell engineering and highlight the direction that researchers want to push CAR-T-cell therapy, says systems immunologist Grégoire Altan-Bonnet at the US National Cancer Institute. "We know a lot of the parts, now it's being able to put them together and explore," he says. "If we engineer the system well, we can really put the tumours into check-

#### **ENGINEERED IMMUNE CELLS**

T cells typically patrol the body, looking for foreign proteins displayed on the surface of cells. Such cells could be infected with a virus, for example, or they could be tumour cells that are producing abnormal, cancer-associated proteins. A class of T cells called killer T cells can then destroy the abnormal cells.

CÁR-T therapies involve genetically engineering T cells from a person with cancer to produce CARs, which are proteins that recognize the proteins displayed by tumour cells.

The approach has been approved to treat some leukaemias, lymphomas and myelomas. But researchers have been pursuing ways



to make the treatments safer and more effective, and to expand their use to other diseases.

#### **HIGHLY MUTATED CANCERS RESPOND BETTER TO IMMUNE**

In one of the new studies, Ahmad Khalil, a synthetic biologist at Boston University in Massachusetts, and his colleagues wired a complex system of 11 DNA sequences into CAR T cells. The resulting genetic circuits can be switched on and off using alreadyapproved drugs, which allows

researchers to control when and where the hacked T cells are active, as well as their production of a protein called IL-2, which stimulates immune responses.

The other group of researchers, led by synthetic biologist Wendell Lim at the University of California, San Francisco, programmed CAR T cells to produce IL-2 only when the engineered T cell encounters a cancer cell. The team found that this IL-2 production was most efficient at fighting tumours in mice with pancreatic cancer when it was activated through a pathway that was separate from the one used to recognize the cancer cell — a detail that could help in shaping future therapies, says Andrea Schietinger, a tumour immunologist at Memorial Sloan Kettering Cancer Center in New York City.

#### **SOLID PROGRESS**

Both approaches could be particularly useful in crafting CAR-T therapies that can target solid tumours, Schietinger says. Solid tumours have posed a particular challenge to CAR-T approaches because the engineered cells have dif-ficulty in filtrating the tumours and ficulty infiltrating the tumours and,

once there, can be disabled by signals that cancer cells use to suppress the immune response. "These engineered T cells overcome both road-blocks," she says. "They find their way in and then, once they're in, get the signals in the right space and at the right time to be really effective in killing the cancer cell.

The ability to turn the T cells on and off could also help to reduce a phenomenon called T-cell exhaustion, in which T cells become inactive after a prolonged period of stimulation, says Evan Weber, a cancer immunologist at the Children's Hospital of Philadelphia in Pennsylvania. Some studies have found that giving T cells a 'rest peri-od' can reduce T cell exhaustion and boost their overall effectiveness against tumours3.

#### **BUILDING BETTER CAR-T**

Lim plans to further develop the system for testing in clinical trials, and to tweak it to explore the effects of producing other molecules that, like IL-2, stimulate immune cells. There has been a growing realization that such molecules, called cytokines, could be pivotal to the success of CAR-T therapies, says Weber. "We know we need smarter ways of tapping into them," he says, "rather than just turning on a receptor all the time or secreting a cytokine constitutive-

Khalil hopes that the system that he and his colleagues have developed will be usable in other cell types, including another type of immune cell called macrophages, which are better than T cells at penetrating solid tumours. His genetic circuits were designed with adaptability in mind, so that researchers who specialize in cancer immunotherapies or fields such as gene therapy or stem-cell biology — can tweak them to suit their needs. "I hope this will capture the imagination of a lot of researchers out there," he says.

The authorities have start-

ed realising the potential of drones in various areas including health. While the unmanned Aerial Vehicles were deployed by the Union Health Ministry during Covid pandemic to deliver Covid-19 vaccines to access compromised areas and strengthen the vaccine delivery system, a study has found that the cutting-edge technology can play a vital role in India's battle against Tuberculosis (TB) by reducing sputum transportation time. A team of ICMR scientists

had conducted a feasibility study comparing transportation tests between two modes of vehicles UAVs and conventional bikes in Chamba in Himachal Pradesh. They observed that sputum transportation by UAVs was feasible, cheaper and an effi-cacious potential alternative to conventional modes of transportation. The study is published in the Royal Society of Tropical

# Erdogan's goal beyond securing Syrian refugees

Turkish President Recep Tayyip Erdogan has once again intervened in northern Syria, making a desperate bid to bolster his political prospects in 2023 by impressing upon many of his countrymen who are unhappy with Syrian refugees staying in his country.

For Ankara, the purported incursion in northern Syria is to create a safe zone along the border to resettle the Syrian refugees. But Erdogan's real intention, it seems, is to flush out all the rebels belonging to Kurdish People's Protection Units (YPG) which Turkey considers as a terrorist organisation affiliated with the separatist Kurdistan Workers Party (PKK). It's a long-drawn battle wherein the vital interests of major world powers, like the US and Russia, is directly targeted by Erdogan.

The Syrian predicament has lingered for over 11 years. The conflict has uprooted nearly 13 million people, more than half of the pre-war population of that country. Further the historic crisis has left an estimated 14 million people in

Syria, a West Asian country situated on the Eastern Mediterranean and the Levant. is in the midst of a serious humanitarian crisis and economic chaos. In French language, the word "Levant" means 'rising', but it is almost a dying nation ruled by its embattled President Bashar al-Assad, largely supported by Russian President Vladimir Putin and his forces since the upsurge that began in 2011.

However, the battle in Syria has triggered an enormous refugee crisis in West Asia. Of the displaced Syrians, 6.6 million are staying as refugees in neighbouring countries: 3.8 million in Turkey, 8,40,000 in Lebanon, 6,75,000 in Jordan, and over 2,50,000 in Iraq. In fact, there is more than 20 per cent increase in the movement of refugees from Syrian land between 2021 and 2022.

These new residents have turned Turkey from a relatively homogenous nation composed mainly of the ethnic Turks and minority Kurdish into a more diverse country. This trend of migration has made Turkey a place of millions of Arab and Afghan people. The demographic change has a serious impact on the lives of the locals. Erdogan is posing as a Turkish Muslim messiah in the eyes of his supporters. He is making his own brand and competing against himself only, and hardly has left any of his opponents active in politics, particularly after the coup in the country on July 15, 2016.

Since then, Erdogan has virtually eliminated all his political rivals. Many consider him as the force resurrecting the Muslim Umma, the global Muslim community. For long he has branded the opposition as blasphemous. And anyone who is against him is publicly treated and targeted as anti-

While looking at Erdogan's plan to stamp out the Kurdish militias in northern Syria, it is pertinent to see what he is planning to achieve. plan, he includes all the leftists, liberals, seculars, social democrats and finally the Kurdish.

No wonder, Erdogan may win his next presidential bid. It is easier for him as there are hardly any strong opposition forces. It would be quite possible as since 2003, he has been making strategies to gather the conservative support base and raising popularity among the political Islamists. And fortunately, he has come at a time when the entire West Asia, particularly his neighbouring nations are all bedevilled by uncertainty, growing radical Islamic movements and a fast-changing global political calculation wherein stability is key concern for nations. Erdogan's opportunism and anti-democratic agenda is largely supported by growing uncertainties in the global governance system as well.

Finally, Erdogan seems to have forgotten that politics is the "art of the possible" as rightly echoed by German statesman Otto von Bismarck. The forces propelled by Erdogan might topple him one fine day and make democracy thrive in this country. He is omnipotent for now, no doubt. But his executive style presidency and the illiberal democracy that he has been championing for almost two decades now might give way to a true democratic order in Turkey.

It is high time he won a popular referendum as his AKP has failed to win more than 50 per cent of the popular support. His attempt to punish the alleged Gulenist plotters and proxies has morphed into a witch hunt that continues even today. And this political vendetta has been extended to include anyone whoever has defied Erdogan, including the Leftists, liberals, and Kurdish nationalists. He must be careful while pursuing his desire to remain the permanent president of Turkey simply by organising a periodic democratic festival called election simply to legitimise his stay in power.

# English literature's dilemma: The Indian mind

Literature delves into human experiences and is communicated through language. In other words, languages are not simply communicative or reductively informative; they are culturally represented and deeply symbolic. Hence, "Indianness" is

T iterature departments in LIndia face, at least, some sort of a double challenge to reckon with. To begin with, they are endowed with the task of defining how literature posits itself to the Indian mind. This entails how students and teachers locate "Indianness", and hence, the problem expands to explore the question of some greater identity when exposed to world literature. In this context, let us remember a couple of tenets. Literature is not another discipline under the social sciences despite its increasingly conspicuous dalliance with the latter.

It is a recent academic phenomenon, in vogue since the last five decades. If truth be told, literature has even approached a section of the natural sciences like ecology and the environmental studies to understand greater problems concerning human existence. But literature, with all its body of research, varies radically across its methodological outlooks and soars above any distinct formula to understand the human condition. In short, literature engages with human experiences and their narrative elements, which in themselves, cannot adhere to broader generalities or fit within the "accuracy" of sample sizes. The other tenet would be to understand that engagements with literary practices are essentially plural, poly-vocal and dialogical; there is a plane constructed by literature where identities are not stable. There is a constant, reciprocal process of informing and being informed by other cultures.

"Indianness", thus, is a fluid and a difficult concept. In a plural society like ours, the term would spread across different languages, cultures and traditions. Indian literature would, within itself, comprise a wide, plethora of perspectives towards life and social interactions. This challenge towards defining "Indianness" within a

singular composite term seems to be an impossible task; and hence let us look upon it as an umbrella term which defines all Indian experiences of life. But the more significant caveat to remember is about our colonial past and thus to look into every idea that is still romanticised within the colonial

Here, the suggestion is not to eradicate every non-Indian idea but to engage with them with a critical mind. I use the term "critical" in terms of cultivating a conscious identity of being "non-western", oriental, South Asian and being "Indic".

This problem, I believe, is far more real in English departments and it isn't an

arduous task to guess why. The language itself had a foreign identity but for the recent urges of "writing back to the empire" and thus inflecting the language with an Indian flavour. This is the same cultural phenomenon that philosophers like Deleuze and Guattari use to talk about "minorising" the major. It

remains uncontested that tive, of course, is a detached English is the current language of power and has achieved a hegemonic status in consensus. But the question that we face today is how would an Indian mind deal with a discipline that uses an originally foreign language and a department which

Most academicians would agree that translation is a step in the right discussion. True, but not too much to assure us. Literature delves into human experiences and is communicated through language. The question then modifies itself. With English to be used to hear and be heard, how do we root for an "Indianised" perspective? The response might be positive if we understand what it is to have an "emic" perspective. The term "emic" is a contrast to its academic antonym "etic" where the former emphasises on  $understanding \, \bar{knowledge} \, and \,$ culture through the "native" perspective. The etic perspec-

Critics in India might fret over the polarities of ethnocentric narratives against xenocentric narratives to finally lay their thrust behind cultural relativism. Maybe this grants us a safer space to tread away from historical deviances. But "emic" understanding is not essentially "ethnocentric". It is open to critiquing itself but with a more rigorous and empathetic understanding of its own. Thus it is not about ethnic narcissism.

However, what it rescues us from is a worrying detachment of one's own civilisational ethos; a scholarly, almost pedantic isolation of the scholar from their culture to identify themselves as an "intellectual" floating in some selfcontained vacuum. This sardonic and disconnected identification is perhaps what categorises the majority of today's academia. And to burst those bubbles, some sort of an identifying process is necessary. There has to be some truth to one's culture, traditions and community ideas; critiquing is to pierce through those human realities where the positive and the negative are both thrown open but with a responsible approach.


