Assessment based on Covid-19 surge trend in previous waves

PIONEER NEWS SERVICE NEW DELHI

A gainst the backdrop of the Trise of Covid-19 in several Asian and European countries with the onset of winter, officials said the next 40 days will be crucial to see the extent of the breakout in India.

"Previously, it has been noticed that a new wave of Covid-19 hits India around 30-35 days after it hit East Asia . This has been a trend," an official told the PTI.

While the Government is bracing up for a surge in Covid-19 cases and taking precautionary measures, the Health Ministry officials are counting on the fact that the majority of the Indians are fully vaccinated, which could reduce the severity of the infection. They feel that even if India is hit by a Covid-19 wave, deaths and hospitalisation will be very

19 at the Chennai airport. Twelve passengers arriving from high-risk countries tested positive for the virus at the KempeGowda International Airport in Bengaluru on Monday. Four foreign nationals who came to attend the religious preaching of Tibetan Spiritual Leader Dalai Lama in Gaya tested positive for Covid-19. While one of them was

from Myanmar, the other three are residents from Bangkok.

They are currently in isolation. Four international travellers from Myanmar tested positive for the Covid-19 virus at Delhi's Indira Gandhi

International airport. Two international travellers on Wednesday, one from Japan and another from America, who are residents of Ludhiana, have also tested positive for the virus

At the Mumbai international airport, two UK returnees have tested positive for the virus, and their samples have been sent to the National Institute of Virology, Pune, for genome sequencing.

In another news, a 40year-old man, who returned from China, had tested positive for Covid-19 on Sunday, following which he has been isolated. The man returned to Agra from China via Delhi on December 23.

India on 40-day watch Terror attack foiled, 4 ultras killed in Jammu

Security forces on Wednesday averted a possible terror attack when they gunned down four Kashmir-bound heavily armed terrorists, hiding inside a truck cavity, near Sidhra bridge in the close vicinity of White Knight Corps headquarters in Nagrota area.

The security forces suf-fered no collateral damage during the operation which lasted around two hours.
On December 6, 2022 a

grenade blast was also reported at the same spot. Soon after the encounter started in the area around 7.30 am, traffic on the sensitive route was suspended. Large number of passengers were stranded on the highway at different locations during the encounter.

Additional DGP Mukesh Singh, who visited the encounter site, said, "Four ter-rorists were killed in an encounter in Sidhra in Jammu on Wednesday morning".

During the heavy exchange of fire, the truck also caught fire. The bodies of the terrorists were charred beyond recognition

Prime Minister Narendra Modi arrived at Ahmedabad and met his 100year-old mother Heeraba, who was admitted to UN Mehta Institute of Cardiology & Research Centre in Ahmedabad on Wednesday.

Modi flew back to Delhi after staying with her mother in the hospital for 90 minutes. Heeraba's condition is stable, the hospital said in a brief

Heeraba turned 100 this year. Early this month, she also voted in the Gujarat Assembly election sitting on a wheelchair. She had difficulty in breathing and high blood pressure and a local doctor was consuted before she was rushed to hospital about 9 am.

Modi reached the hospital at 4 pm and left the hospital at 5.30 pm, spending around 90 minutes with her mother.

Gujarat Chief Minister Bhupendra Patel accompanied Modi to the hospital and left while the Prime Minister staved back with Heeraba.

UNSC raps Taliban for anti-women policies

larmed over the situation Ain Afghanistan, the United Nations Security Council (UNSC), under the current presidency of India, has voiced concern over the Taliban dispensation imposing restrictions on women and girls' education and work.

The UN urged a swift reversal of these policies which human rights. This appeal came days after the Taliban banned women from attending university and working for non-governmental organisations (NGOs). Since seizing back control of the war-torn country in August last year, the Taliban have steadily restricted women's rights despite promising their rule this time would be softer than the regime

seen in the 1990s. India's Ambassador to the UN and currently the UNSC president for the month of December, Ruchira Kamboj, issued a Press statement late Tuesday on behalf of the 15nation Council. It said its members are "deeply alarmed" by

reports that the Taliban have suspended access to universities for women and girls.

The Council reiterated its "deep concern" over the suspension of schools beyond the 6th grade, as well as its call for the full, equal, and meaningful participation of women and girls in Afghanistan. It called on the Taliban to reopen schools and swiftly reverse these policies and practices, which represents an increasing erosion for the respect of human rights and

tal freedoms. The statement further said the members are profoundly concerned by reports that the Taliban have banned female employees of NGOs and international organisations from going to work, which would have a significant and immediate impact on humanitarian operations in the country, including those of the UN, and the delivery of aid and health

It said these restrictions contradict the commitments made by the Taliban to the Afghan people as well as the expectations of the international community.

Woman gangraped in moving vehicle on Yamuna Expressway

In a horrifying incident , a woman was gang-raped on the Yamuna Expressway while in a moving vehicle. According to the police sources, all the three accused including the driver of the vehicle, were arrest-

In her complaint, the woman claimed that as the taxi was traveling on the expressway from Noida to Firozabad, the three other male passengers, including the driver, raped her. The victim was dropped near Etmadpur in Agra. The woman approached the police at Etmadpur and lodged a complaint. Acting swiftly the police managed to track the vehicle



and the driver and later arrested all the three accused per-

According to information provided to the police, the complainant took a taxi from Noida to Firozabad. She said that as the automobile was being driven on the Yamuna Expressway, the three accused-who were also in gang-raped her.

The woman had boarded

in Noida around 8.30 pm on Tuesday. The taxi was going to Firozabad from Noida. The woman claimed that three occupants of the taxi raped her on the Yamuna Expressway and dropped her at Etmadpur, from where she took an autorickshaw to Firozabad," Agra Police Commissioner Dr

"On Wednesday morning, the woman came to Etmadpur police station and filed a complaint after which an FIR was lodged before sending her for a medical examination," Singh

Preetinder Singh said.

The police commissioner said CCTV footage of toll plazas was analysed to track the taxi, a Maruti Éeco, which was

used as the cab and it has been impounded.

'The three men who were involved in the case have also been apprehended. They are being interrogated and further legal proceedings are being carried out," Singh added. Police said that the woman,

who studied in Prayagraj, was in Noida in connection with some work and had boarded a car from Sector 37 Noida on Tuesday evening to return to her home district. At around midnight, the other passengers in the vehicle got down at Kuberpur near Agra. The woman was told by the driver that he would drop her at Firozabad, which was closer to

Talking to media persons after his release from the prison, 72-year-old Deshmukh said: "On the basis of these baseless allegations, I was behind the bars for nearly 14 months. However, I have full faith in the judiciary.... the High Court has observed that I was implicated

"False allegations were made against me. (Mumbai's former Police Commissioner) Param Bir Singh had made an allegation of Rs. 100 crore corruption against me.

However, he only told the court through affidavit that his allegations were based on hearsay and that he did not have any evidence on the same.

HC imposes ₹10K cost on MHA, Personnel Ministry on plea by CISF inspectors over promotion denial

 $T^{\text{he Delhi High Court has}}_{\text{imposed a fine of Rs 10,000}}$ on the Union Home and Personnel Ministries and others for their failure to file response to a petition filed by more than 500 CISF inspectors, who have not been promoted for 19 years as compared to the stipulated five. A bench of Justices Suresh

Kumar Kait and Neena Bansal Krishna issued an order on December 21, giving a "last opportunity to the respondents to file the written submissions within four weeks subject to costs of Rs 10,000 to be deposited with the Delhi High Court Legal Services Committee.

The respondents in the case include the Union home ministry, under whose command the Central Industrial Security Force (CISF) functions, the CISF director general, the chairman of the Union Public Service Commission (UPSC) and the personnel ministry.

More than 540 inspectors of the CISF filed a writ petition before the court early this year



alleging "deprivation" in their career progression as they got only one promotion (from subinspector to inspector) in more than 34 years of service and they have no "future prospects" to look forward to for their next promotion to the officer rank of Assistant Commandant

The petition of the inspectors, recruited in the central force between 1987 and 2005, has provided figures and data to apprise the court about their

"As on date, the senior-most inspectors (executive) who joined the CISF in 1987 as direct sub-inspector have earned only one promotion (from SI to inspector) in 28 years and the reduction in promotion quota (from 50 per cent to 33 per cent) has further brought down their chances of promotion," the petition stated.

contributed to the greater good. United Nations Women Executive Director Sima Bahous said in a statement the de facto authorities of Afghanistan have once again found new ways to harm the women and girls of Afghanistan.

As the world remains outraged by recent decisions to ban women and girls from higher education, the decree barring women from working in national and international NGOs is yet another "stark violation" of women's rights and humanitarian principles, she said. "We strongly condemn this without reservation," Bahous said The Security Council reit-

erated its full support to the Special Representative of the Secretary-General Afghanistan Roza Otunbayeva and the UN Assistance Mission in Afghanistan (UNAMA) and the importance for Otunbayeva to carry out her mandate including monitoring and reporting on the situation, and continued engagement with all relevant Afghan political actors and stakeholders, including relevant authorities, on these issues, consistent with the mandate of UNAMA, and keeping

the Security Council informed on the progress.

Bahous said in barring women from contributing to the efforts of aid organisations, the Taliban suspended aid for half the population of Afghanistan, "aid that they depended on and without which they will not survive."

She said 11.6 million women and girls are no longer receiving vital assistance. Women-headed households, which make up almost a quarter of households in Afghanistan, have nowhere left to turn and no livelihood sup-

The New Delhi Municipal Council has neither increased nor introduced any new taxes in the annual budget for the next fiscal.

Presenting the annual Budget for the year 2023-24, the NDMC on Wednesday announced that the arrangements of food festival, flower show, fun runs and live music are going in full swing for the general public and foreign dignitaries ahead of the G20 Summit here next year.

NDMC chairman Amit Yadav presented a surplus budget of Rs 224.98 crore in current financial year 2022-23 and Rs 583.29 crores for financial year 2023-24 against Rs 178.95 crore surplus projected in its budget estimate 2022-23. The NDMC has allocated around Rs 60 to 100 crore for preparations in the city ahead of the G20 meetings that began in March.

"FY 2023-24 is going to be pecial with the presidency of G20 coming to India under the leadership of Prime Minister Narendra Modi.

The NDMC is quickly taking up a comprehensive beautification of flyovers, roundabouts with sculptures by eminent artists, reflecting our art consciousness," Yadav said.

"We have assigned Rs 60 to 100 crore of the NDMC budget for G20. The city will also host a food festival with flavours from all G20 countries. A park dedicated as the G20 park will display national animals of the Group of 20 (G20) countries on a Waste-to-

Wonder theme," he added. This budget, Yadav noted, will reflect the NDMC's

The Delhi Government on Wednesday said 77 major infrastructure development projects worth Rs 19,545.86 crores in the education, and health etc was implemented in the past five years in the national Capital.

This statement came during the Deputy Chief Minister Manish Sisodia reviews the major infrastructure development projects along with the senior officials of the Public Works Department and other concerned departments.

Sisodia said that after coming into power, it has been a priority of the Delhi Government to ensure the best infrastructure and facilities of education, health and city infrastructure for the people of

"These projects include the construction of more than 20,000 classrooms, new sports complexes, hostels for students, various hospitals with state-ofthe-art facilities, six new and two double-decker flyovers, two new university campuses, installation of more than two lakh CCTV cameras, road beautification projects, installation of

500 flags and the Signature Bridge in Wazirabad," said Sisodia. "In the education sector itself, the Delhi Government approved 26 major projects worth Rs 8683.81 crores, since 2017. The projects include the construction of various new school buildings, more than 20000 new classrooms, sports complexes and the installation of CCTV cameras in Delhi government schools," said

Sisodia said that the Delhi Government is also constructing two new campuses of Ambedkar University in Rohini and Dheerpur.

Most of these projects have either been completed or are currently ongoing.
"In the health sector, the

These hospitals and ICUs with state-of-the-art facilities will make quality healthcare services more accessible to the people of Delhi. City Govt's proposal to outsource pvt diagnostic, lab services approved

Expressing grave reservaat private outsourcing of Diagnostic Services in Delhi Government Hospitals, rather than strengthening them, Lieutenant Governor Vinai Kumar Saxena on Wednesday gave his nod to a proposal of Arvind Kejriwal Government to outsource private diagnostic and lab services to Mohalla Clinics to three private players as a fait accompli presented to him.

The LG in his noting on file has also brought to the fore that despite the number of Mohalla Clinics rising to 519 from 450 in 2022, the number of patients being treated at Mohalla Clinics had come down from 3416 patients per month per Mohalla Clinic in 2021 to 1824 patients in 2022. Even as the number of patients tests being prescribed rose from 6,30,978 per month in 2021 to 9,30,000 tests per month in 2022.

The Delhi Cabinet, on July 28, decided to outsource private diagnostic services to government-run health facilities, hospitals, dispensaries, polyclinics and health camps, including PUHCs, similar to the arrangement that has been in vogue at mohalla clinics since December

The Cabinet also selected three private vendors for providing specialised diagnostic services government hospitals and mohalla clinics. On December 12, 2022, the Kejriwal government wrote to the L-G seeking his approval to outsourcing private diagnostic and laboratory services to government hospitals and mohalla clinics. After giving his nod to the proposal, the L-G slammed the AAP government for not sending the file to him

"Caught on a wrong footing, due to an obvious lapse of not having taken a decision on time, and even after deciding way back in August 2022, not sending the file to LG for concurrence, the AAP and its Ministers, specifically Manish Sisodia indulged in characteristic gimmickry.

Even while no decision had been taken, they kept announcing things in the media and to avoid embarrassment, after sending the file to LG on December 12, 2022, Sisodia wrote a letter to LG on December 24, 2022, in just 08 working days, requesting clear-ance of the file," Raj Niwas said in a statement.

The instant proposal to extend outsourced Diagnostic Services to a higher level to Government facilities through extension counters of private bidders, who have already won the contracts to do so, is prima facie admission that Government Hospitals/facilities run by the State Government have failed on



the parameters of something as basic as pathological and Diagnostic testing.
"While such a decision on

the part of the Governments in remote places, that lack facilities in term of physical infrastructure and trained medical professionals in the sector. would have made sense, it obviously does not meet the requirements of a rational decision in the Capital of the country, owing to the fact that Government Hospitals/facili-Government, as often claimed by the them itself, are replete with ample physical infrastructure in terms of building, space, machinery and equipment as indeed medical professionals of highest caliber," it

Suggesting the alternate to method to strengthen the health facilities in the city, the L-G advised the Delhi Government that instead of outsourcing to the private players to strengthen and augment capacities of the Government Hospitals/facilities to the extent, that they became enabled to provide Labs/Diagnostic services to the Mohalla Clinics, instead of the other way around as is being proposed through the instant Cabinet Decision, it said.

Hitting out at the government, the L-G said the government has failed to provide pathological and diagnostic testing at government hospitals in the national capital.

"Doing so is prima facie admission that Government Hospitals/facilities run by the State Government have failed on the parameters of something as basic as pathological

and Diagnostic testing.
While such a decision on the part of the Governments in remote places, that lack facilities in terms of physical infrastructure and trained medical professionals in the Government sector, would have made sense, it obviously does not meet the requirements of a rational decision in the Capital of the country, owing to the fact that Government Hospitals/facilities in Delhi run by Government of National Capital Territory of Delhi (GNCTD), as often claimed by the Government itself, are replete with ample physical infrastructure in terms of building, space, machinery and equipment as indeed medical professionals of the highest calibre," the statement read

Days after Shelly Oberoi and Aale Mohammad Iqbal, AAP candidates for the Municipal Corporation of Delhi mayor and deputy mayor posts, filed their nominations, Deputy Chief Minister Manish Sisodia took them to the Okhla landfill sites on Wednesday. After visiting the site, the

Sisodia said he would personally monitor the work to clear the landfill site and visit the garbage dumping sites every week to take stock of the situation. "Working towards removing the mountains of garbage from Delhi, I visited Okhla landfill sites today along with AAP's mayor and deputy mayor candidates. It is our resolution to raze down these landfill sites and make the city clean and beautiful. I will visit all three landfill sites every week and will personally monitor the work," he tweeted.

Sisodia, along with Oberoi



and Iqbal, conducted a detailed assessment of the works going on at the landfill site. He also made several suggestions upon noticing some gaps in the projects and directed the officials to get things back on track

"AAP councillors have started working even before taking oath. We visited the Okhla landfill site and inspected the progress here so far.

"Work needs to speed up and I am hopeful that after January 6, AAP councillors will ensure the same. We need to visit the landfill sites every

week to ensure the height of the garbage mountains reduce," Sisodia added. During the visit to the site, the Deputy Chief Minister said that currently the work of clearing the landfill sites is going at a slow pace and we need double the speed to achieve our goals.

"From now onwards, I will inspect these landfill sites every week and monitor the work being done closely. As soon as the Mayor and Deputy Mayor take oath the speed of the clearing process will be doubled," he added. Sisodia further said that the number of waste

disposal machines will be increased at the landfill site to expedite the work. "Along with that, regular inspections at these sites will also give a boost to the work. So far, the previous government had only deceived the people of Delhi in the name of removing these sites." Coal, unclean fuels banned in | '4L senior citizens' pension withheld **NCR** cities to keep air healthy

¬aking a tough stand against pollution arising out of emissions from heavily polluting fuels like coal, the Commission for Air Quality Management (CAQM) on Wednesday reminded industries that the use of coal (except coal with low sulphur in thermal power plants) and other unapproved fuels is banned in the entire National Capital

The ban on heavily polluting fuels like coal, Light Diesel Oil (LDO) and Naptha in NCR will come into effect on January 1, 2023. The agency said that it will impose a fine on industries found using unapproved fuels.

"Use of unapproved fuels w.e.f. 01st January, 2023 to straight away lead to closure along with imposition of heavy (Énvironmental Compensation) since adequate

time has been given to shift to cleaner fuels," CAQM said. The Flying Squad of the CAQM are under instructions to conduct incognito visits to ensure compliance of Directions regarding use of approved fuels in the entire

Firewood and biomass briquettes can be used for religious purposes and cremation, wood or bamboo charcoal can be used for tandoors and grills of hotels, restaurants, banquet halls (with emission control system) and open eateries or dhabas. The use of wood charcoal for cloth ironing is allowed, the CAQM said in a statement.
"Violations and non-com-

pliance of the directions issued by the Commission including use of unapproved fuels will straight away lead to closure Environmental Compensation

(EC) and initiating prosecution action against the defaulters flouting the statutory directions," the Commission said. The commission had in June issued directions to ban the use of coal in industrial, domestic and other miscellaneous applications in the entire Delhi-NCR region from January 1

Around 1.7 million tonnes of coal is used annually in industrial applications in NCR, with about 1.4 million tonnes being consumed in six major industrial districts alone. The panel had earlier invited suggestions from general public and experts in field to find a permanent solution to air pollution problem in Delhi-NCR.

A large number of suggestions were related to banning of coal. The CAQM then constituted an expert group to examine and deliberate upon all such suggestions and proposals.

The Petitions Committee of Delhi Legislative Assembly had summoned officials of the Finance Department and Social Welfare Department on Wednesday and directed them to find a permanent solution to the problem immediately, Bhardwaj said.

 $T^{\text{he Ministry of Road}}_{\text{Transport and Highways}}$ (MoRTH) has introduced authorisation certificates for the dealers of registered vehicles to identify the authenticity of a dealer, a move that will promote ease of doing business and transparency. The new rules will come into force with effect from April 1, 2023.

MoRTH in a notification issued on Wednesday, has amended chapter III of the Central Motor Vehicle Rules, 1989 to build a comprehensive regulatory ecosystem for the pre-owned car market aiming to ensure transparency in the sale and purchase of registered vehicles through dealers.

According to changes proposed by the MoRTH, an authorisation certificate for the dealers of registered vehicles has been introduced to identify the authenticity of a dealer. The changes have been

proposed keeping in mind the fact that in the current ecosystem, many issues are being faced during transfer of vehicle to subsequent transferee, disputes related to third party damage liabilities and difficulty in determination of defaulter. Dealers have been empowered to apply for renewal of registration certificate and renewal of certificate of fitness, duplicate registration certificate, NOC, transfer of ownership, of motor vehicles in their possession.

As a regulatory measure, maintenance of an electronic vehicle trip register has been mandated which would contain details of the trip undertaken related to trip purpose, driver, time, mileage etc. These rules will help in recognising and empowering intermediaries and dealers of registered vehicles as well as providing adequate safeguards against fraud-ulent activities to the selling or purchasing of such vehicles, official sources said.

'Naxalite Op in Gadchiroli has suffered setback due to Surajgarh mines project'

Maharashtra Chief Minister Eknath Shinde on Wednesday said the Naxalite movement in Gadchiroli district has declined since the Surjagarh iron ore mines project became operational.

Speaking during Question Hour in the Legislative Council, the chief minister assured that local people would be given jobs in the project on a priority basis. "Since the project was

operationalized, the Naxalite movement in the district has slowed down," he said, replying to a question by Jayant Patil, Ramdas Ambatkar and Abhijeet Wanjari.

Union Minister for Housing and Urban Affair Hardeep Singh Puri released the draft guidelines for a new ranking system of cities based on financial performance and beautification. The cities have until January 15 to submit their comments before the guidelines are finalised and issued by January 30.

"India has embarked on the most ambitious plan for urban rejuvenation undertaken anywhere in the world. A healthy sense of competition gives the best performing cities a sense of pride," he said at the launch event. According to Manoj Joshi, Secretary of the Ministry of Housing and Urban Affairs, it is also an effort to analyse and help the ULBs in identifying

Zero responsibility

Punjab under AAP has transitioned from a 'debtstressed' to 'debt-trapped' state

hanks to the Aam Aadmi Party's political recklessness, nine out of ten electricity consumers are not paying their bills. According to a news report, while 90.07 per cent domestic consumers get a 'zero bill,' 97.9 per cent people in the state will avail of some kind of subsidy on power in December. At any time, fiscal profligacy is undesirable; but when fiscal and revenue deficits are soaring, pleasing people with such decisions is downright egregious. A group of prominent economists from Punjab have informed Union Finance Minister Nirmala Sitharaman that the state has transitioned over the years from being "debt-stressed" to "debt-trapped." The deficits, they pointed out, have destroyed developmental institutions and derailed the process of development despite three decades of peaceful governance by the elected governments. Fiscal policy has turned dysfunctional, read the letter. This has generated a



typical crowding out effect on private investment in Punjab, resulting in a slow growth and distorted structure of the economy. The Bhagwant Mann Government was finding it difficult to pay salaries to state employees in September. And yet, the number of zero-bill consumers has been going up! It looks like the AAP regime has exiled commonsense and reason. It would, however, be wrong to single out AAP for criticism for its rash populism; other parties are also guilty of the same. The earlier Congress government in the state, for instance, had made travel free for women in the state-run Pepsu Road Transport Corporation (PRTC) buses. As a consequence, PRTC is incurring a daily loss of Rs 1 crore.

It is looking at the state Governmen — which is hurtling towards bankruptcy — for succour so that it would release salaries and pensions on time.

As for the Bharatiya Janata Party, it has taken a tough stand against the freebie culture — in principle. In practice, however, it is not far behind its rivals when it comes to distributing freebies. Last week, the Central Government decided to provide free foodgrains to about 81.35 crore beneficiaries under the National Food Security Act (NFSA) for one year, beginning on January 1, 2023. Announcing the decision, Consumer Affairs, Food and Public Distribution Piyush Goyal said that this was a historic decision that reflected the sensitivity of Prime Minister Narendra Modi towards the beneficiaries of welfare schemes. This is likely to cost the public exchequer around Rs 14,000 crore. What is sauce for the goose is sauce for the gander — so goes the saying. In the BJP's scheme of things, however, when a rival party or leader indulges in mindless populism, it is profligacy, but when BJP leaders do the same thing, it is the consequence of their concern for the poor. Politicians being what they are, not much can be expected from them, but as people of India we should at least stop rewarding those who entice us with freebies.

Financial Emergency

Pakistan's economy is in shambles. It is facing crisis of debt obligations, falling rupee, and fiscal deficit

akistan's economy has hit a rock bottom, its currency is depreciating and foreign debt is mounting putting it in a Sri Lanka-like situation. To deal with this financial emergency Shehbaz Sharif government has resorted to cut government costs to meet ever-rising debt obligations and curb inflation. In a notification issued on December 20, the Cabinet Secretariat called for drastic measures to deal with the "financial calamity of the state" and shortage of funds. In its desperate bid to cut costs it is rationing the fuel for the vehicles used by government officials, restricting their air travel, scrapping leave encashment, and other benefits such as medical bill payments and allowances. These are, however, token steps that might not have a desired effect on the economy as the seriousness of the situation demands some drastic measures. The Pakistani

government has failed to pull back the rupee slide against the dollar which has seriously impacted the exporters and put extra pressure on foreign exchange reserves. The slashing of perks and remuneration of government employees would not be sufficient to bail it out from the difficult situation Pakistan is in. It will have to take some tough decisions to bring the economy back on rails like curbing pilferage and leakages, slashing military budget, giving incentives to exporters and facilitating their busi-

> The cash-starved Pakistan received bailout package from the International Monetary Fund (IMF) in August and has been on the Extended Fund Facility (EFF). The IMF approved the disbursement of SDR 894 million (about \$1.1 billion), bringing total

purchases for budget support under the arrangement to about \$3.9 billion. Despite that, almost all its economic indicators are showing a negative trend. The devaluation of the rupee has also played a key part in the increase of prices in Pakistan but hasn't helped much in offsetting its adverse balance of trade. Pakistan's economy has been facing structural inflation. Pakistan is experiencing spiralling high inflation, unemployment, and low profitability. Fiscal mismanagement is hurting the common man the most. The economic meltdown is eroding the Shehbaz Sharif government's political credibility as well. If Shehbaz Sharif is unable to come up with a viable plan to manage the economy he would be in deep trouble as it may be a great opportunity for Imran Khan to make a comeback by mobilising the popular sentiment.

Budget must boost Farmers' income



The Government must give priority to the farmers' in its budgetary allocation as their distress is increasing that cannot be mitigated by cash assistance.

espite giving huge subsidies to farmers on Agro inputs such as, seeds, fertilizer, electricity and water, majority of farmers are under perennial distress causing suicides and agitations. For all practical purpose, the benefits of these subsidies are enjoyed by consumers and not the farmers. Key impediment is "low sale price of food grain" at farm gate which has adversely affected farmer's income. That can't be resolved by meagre cash assistance of Rs 6000/- per year.

After independence, India was facing food shortage and hence, the farmers were getting remunerative prices in the open market. In 1950-51, the share of agriculture was 65% in GDP and 56% till 1965. Unlike the modern industrial economy, the majority of trade and services were also dependent upon Agriculture. Considering food shortage, in 1960, PDS was introduced for urban poor and in 1970 and 1980; it was extended to tribal blocks.

Considering population growth and consistent food shortage, the Government pursued farmers to boost production and built irrigation facilities and several fertilizer plants. The Indian Agriculture Research institute was also established. Farmers responded and the Green revolution started in 1965 and White revolution in 1970. Farmers could produce surplus food and save India from the food crisis but their reward is still overdue upon all Indians.

With surplus food production, the market price was gradually softening and the profitability was declining. Majority of private trade channels also diversified to other remunerative businesses. Hence, in 1964, FCI was incorporated and in 1966-67 MSP was introduced; that gave some relief to farmers. In 1992 and 1997, the PDS scheme was widened and thus, PDS procurement was increased.

In FY-2020, under MSP, the Government had procured 23 eligible crops barely 26% by value. This might be below 15% of all crops. Despite this, unsold stock facilities to resolve any dispute with FCI is about 32.0 million by purchaser. Unsold stocks

tons and 24.0 million tons with States. Debt of FCI has exceeded Rs. 4.0 lakh crores incurring huge interest.

Due to prolonged stress, poor farmers can't afford storing and waiting for the remunerative prices and hence; they sell to trade channels at prices much below MSP. In sequel, farmers are demanding "guaranteed MSP" for the entire produce. Their demand is genuine. But it is not feasible for any Government or FCI to buy entire production. Considering complexity,

the budget should announce an "out of box" scheme". By which, farmers will get MSP without major fiscal burden. However, the Government should build storage and logistics infrastructures for FCI from budgetary resources. More so, the Government should extend export incentives to FCI and private channels including processing industries. Fiscal burden due to export incentives shall be gradually compensated by cutting down farm input subsidies. FCI must assist farmers for selling to private channels through auction. Floor price must be kept about 93-95% of MSP. FCI should fix quality standards and provide testing

must be essentially stored by FCI and the cheap loan may be extended to farmers up to 90% of stock value at MSP price. Same can be refinanced by Banks to FCI at SLR rate. Failing which, the farmers shall be compelled to sell at distress price to the trade channel.

"Goods receipt" (GR) may be issued to farmers against stocks with a six month's validity. GR must be tradable in the open market, e-NAM and Commodity exchange. FCI must assist and charge a nominal fee of 0.5% of sale value. Interest and storage charges may be levied @ 9.0% per annum on the stock value. That may be recovered from the ultimate buyer or farmer and balance be remitted to farmers. This will eliminate interest and storage cost of FCI.

Generally, the price of food grain increases till the next crop arrives. Thus, farmers shall get better prices after availing storage facilities. After expiry of GR validity, it shall be deemed for sale to FCI at MSP and FCI may use it for PDS, sell to private channel or export. By this, FCI need not keep separate duffer stock for PDS, as is being done now. Thus, debt burden on FCI shall reduce.

By such arrangements, farmers shall certainly get about 95% of MSP on the entire produce. In due course, there are fair chances for farmers getting higher prices. FCI shall also be benefited since; its debt burden and storage cost

shall reduce. At times, due to poor market demand, the stock with FCI might increase. Therefore, FCI must quickly export directly. Government must be liberal in giving export incentives to FCI.

Simultaneously, India must promote food grain processing industries and trade channels near to FCI godown and share logistic infrastructure for exports and onward marketing. Farmers may also pursue crop diversion and adoption of new technologies; that will boost productivity, reduce Agro-imports and enhance farmer's income.

A composite plan will certainly increase farmer's income and fetch rural prosperity. With healthy growth of agriculture, India could be a large exporter also. And Agro GDP in combination with food processing shall surge generating additional GDP, consequential revenue and employment.

INDO-NEPAL RELATIONS

Sir — The elevation of Pushpa Kamal Dahal alias Prachanda as the Prime Minister of Nepal after the fractured mandate of the November election is not entirely a surprise, even though the Nepali Congress emerged as the single largest party with 89 seats in the 275member Parliament. This is the country's second election since becoming a republic. With this Prachanda becomes the Prime Minister of Nepal for the third time. Prachanda's party CPN (MC) contested the election in alliance with the Nepali Congress, but the two parties were at loggerheads over who would lead the coalition government first. It has been agreed that Prachanda will be the PM for the first two and a half years of the fiveyear term and KP Sharma Oli for the subsequent two and a half years. Nepal is no stranger to the power struggle and political instability. It remains to be seen if the Prachanda-Óli duo can provide a stable government.

The developments have major implications for India. Prime Minister Narendra

said that the unique relationship between India and Nepal rests on the deep cultural connection between the two countries and the emotional attachment of the people on both sides. He also expressed the hope of further strengthening the friendship between the two countries. But beyond these formal statements, the truth is that both Oli and Prachanda are considered close to China. Oli's previous tenure as Prime Minister was famous for his Chinese favoritism, decisions, and statements inciting anti-India sentiments. However, even during that time, leaders like Prachanda were insisting on balancing the policies to a great extent. Then there is also the fact that this time there is no singleparty government. If the message of the election results is seen, then it is also clear that the anti-India sentiments could not get the majority, let alone the status of the largest party. There is no need to assume that the new government will follow the old customs and policies. But looking at the current equations between India and China, no negligence can be done on this front. Most people believe that God is One, Truth is One



Regulatory assets are created when state electricity regulatory commissions accept that the tariffs don't cover discoms' purchase cost but don't raise rates

he Power Ministry has taken two decisions which have a bearing on viability of the beleaguered power distribution companies (discoms). It has (i) warned state electricity regulatory commissions (SERCs) against creating a pile of 'regulatory assets'; and (ii) proposed a pool of efficient thermal power units more than 25 years old to act as a balancing source for the increasing share of renewable energy in the electricity grid.

Mostly owned and controlled by state governments, discoms purchase power from public sector undertakings (PSUs) such as the National Thermal Power Corporation (NTPC) and independent power producers (IPPs) under long-term contracts or power purchase agreements (PPAs) up to 25 years—covering nearly 95 per cent of power generated in the country.

Under instruction from the top political brass in the state, discoms sell a major slice of electricity to some preferred consumers, viz., poor households (PHHs) and farmers, either at a fraction of the cost of purchase, wheeling, and distribution, or even free. On the units sold to these target groups, they incur colossal underrecovery. This is aggravated by aggregate technical and commercial (AT&C) losses - most of it is plain theft.

To offset the losses, discoms charge high tariffs on supplies to industries besides non-poor HHs (NPHHs). The irony is despite this cross-subsidization, a big slice of the losses remains uncovered. As a result, discoms are in the red. This is despite the Centre implementing four financial restructuring packages (FRPs) in 2002, 2012, 2015 and 2021 - a sophisticated nomenclature for condoning the loans discoms took to fund their accumulated losses.


Regulatory assets are created when SERCs accept that the tariffs don't cover discoms' power purchase cost, but don't raise rates to the desired level or defers the hike, mostly under pressure from state governments. The gap between the cost of purchase and the revenue generated from sale at tariffs (albeit unrevised) for supplied power, is then booked by discom as receivable and classified as RA.

Over the years, the RAs have proliferated. According to government statistics, these were Rs 88,720 crore as on June 30, 2022. The very idea of creating RA is flawed. Once the SERC has accepted that in view of increase in the cost of electricity purchase, transmission and distribution, the tariff has to be raised then it should be done. But the commission doesn't; it doesn't even specify as to when this would be done. Yet, it allows the discom to book it as a receivable. This is anomalous as until such time the increase in tariff is approved and notified, the resultant extra revenue can't be treated as an asset (read: receivable).

Second, the discoms leverage DIRE STRAITS. AS the ambiguous classification (neither outright rejection of a claim for tariff hike nor approval) to pre-2022, THEY HAD sent claims to the SERC which the latter is unwilling to accept. This PILED UP A has led to a scenario whereby substantial claims are bogged down in legal disputes at the appeal level or OF OVER RS in higher courts. As a result, the actual RAs could be much high-600.000 CRORE. er even exceeding the Rs 100,000 THEY ALSO OWE crore mark—against Rs 88,720 crore as per government data.

Third, having failed in their endeavour to allow tariff to reflect 130,000 CRORE costs and leaving things on an TO IPPS AND uncertain trajectory (albeit by creating RAs), the regulatory com-OTHER missions often allow a surcharge to be levied (for instance, in GENERATORS Delhi, there is eight per cent surcharge) which results in arbitrary increase in cost to the consumers.

The Electricity Act and the revised tariff policy clearly say that "tariffs must reflect costs and regulatory assets should not be created". Yet, RAs continue to proliferate. In this backdrop, one wonders whether the missive sent by the Power Ministry to the SERCs (November 11, 2022) will prompt them to go for course correction.

As for the second move of the Union, states have been petitioning the power ministry to exit costlier PPAs with central generating units after a period of 25 years as they have access to plentiful renewable power at cheaper rate and even spot market offering low tariffs. Early this year, the ministry agreed to this demand but now intends to hook discoms to those very plants under a different garb.

It proposes to create a pool of such plants (albeit efficient thermal). If a discom needs to relinquish a PPA with a 25-year-old power unit, it will be allowed to do so, but will be allotted a comparative quantity at an average cost from the pool. The allocation will be in line with the cumulative generation capacity of the pool.

In April/May 2022, the ministry had directed all IPPs based on domestic coal to import at least 10 per cent of their requirement, besides asking all imported coalbased plants to operate and generate power at their full capacity. Concurrently, it allowed 'pass-through' of the higher cost due to use of expensive imported coal under the PPAs.

We have a peculiar regime. While, on one hand, powers that be let everything happen (pass through of fuel cost, guaranteed return to generators, inefficiencies

in wheeling and distribution, etc.) that results in increasing cost of power purchase by discoms, on the other, they don't let the latter charge even bare minimum tariff from a big chunk of consumers viz. farmers and PHHs. This is the root cause behind the yawning gap between the cost and revenue.

Under the Ujwal Discom Assurance Yojana (UDAY) launched in November 2015, the Centre had promised that AT&C losses of discoms will reduce from 20.7 per cent during 2015-16 to 15 per cent by 2018-19 and the gap between revenue and cost to decline from 0.59 per unit during 2015-16 to 'zero' by 2018-19. Against these targets, during 2019-20, AT&C losses were 18.9 per cent, while the revenue gap was at a high of 0.42 per unit. But the current AT&C losses at 25 per cent are even higher than in 2015-16.

As a result, discoms are in dire

straits. As of March 31, 2022, they had piled up a mammoth debt of over Rs 600,000 crore. They also owe about Rs 130,000 crore to IPPs and other generators. Even as the Center exhorts SERCs to increase tariff to bridge the gap between revenue and cost, industries/businesses are the only class from whom they could charge more as political brass in states won't let them touch farmers and households. But, tariffs on supplies to industries already being exorbitant (in Delhi, it is Rs 16 per unit), even this won't be possible. No wonder then, we have RAs the elephant in the room.

Military leadership not long cherished traditions

There has been no opposition by our military leadership against a completely ill-conceived initiative that is Agnipath Scheme

A fter nine months into the conflict with Ukraine, with reputation and capabilities in tatters, the Russian Armed Forces are just hanging on by the skin of their teeth, hoping that the winter will allow them a badly needed reprieve to reorganise. One cannot help but wonder as to how they found itself in such dire circumstances, despite a decade of reforms and modernisation.

Though many of the missteps may be attributable to faulty intelligence assessments, the responsibility for the military's non-performance rests squarely on the senior hierarchy of the Russian Armed Forces. Their obvious incompetence, lack of leadership skills and professional acumen, and the corruption that has been laid bare are without parallel. Yet, they are the lucky ones, given that Stalin executed Generals for much less.

It is standard practice in all countries that selection of the military's top leadership is overseen and approved at the highest political level, as it should be. Where autocracies and totalitarian regimes differ from democracies is in the necessity for them to fied by the manner in which

give primacy to ideology or a retired officer was promotloyalty to the Supreme Leader even at the cost of professionalism. diers in the Russian Armed Forces! We cannot afford to be so obdurate as to not see what any comparison between the Russian and Ukrainian Armed Forces makes crystal clear, the immense value of high-quality manpower.

Similarly, in the altercation in Arunachal, where the Chinese attempted to use overwhelming force to occupy our Post on the Yangtse Plateau, using batons and riot gear suggests they were confident, and correctly so, that we would not open fire, whatever be the provocation, for fear of escalating matters. Min: Ukraine aims to develop air-to-air combat drones

kraine has bought some 1,400 drones, mostly for reconnaissance, and plans to develop combat models that can attack the exploding drones Russia has used during its invasion of the country, according to the Ukrainian government minister in charge of technology. In a recent interview with The Associated Press, Minister of Digital Transformation Mykhailo Fedorov described Russia's war in Ukraine as the first major war

He credited drones and satellite internet systems like Elon Musk's Starlink with having transformed the conflict.

Ukraine has purchased drones like the Fly Eye, a small unmanned aerial vehicle used for intelligence, battlefield surveillance and reconnaissance. "And the next stage, now that we are more or less equipped with reconnaissance drones, is strike drones," Federov said.

"These are both exploding drones and drones that fly up to three to 10 kilometers and hit targets," he said.

He predicted "more missions with strike drones" in the future, but would not elaborate. We are talking there about drones, UAVs, UAVs that we are developing in Ukraine. Well, anyway, it will be the next step in the develop-

ment of technologies,"he said. Russian authorities have alleged several Ukrainian drone strikes on its military bases in recent weeks, including one on Monday in which they said Russian forces shot down a drone approaching the Engels airbase located more than 600 kilometers (over 370 miles) from the Ukrainian border.

Russia's military said debris killed three service members but no aircraft were damaged. The base houses Tu-95 and Tu-160 nuclear-capable strategic bombers that have been involved in launching strikes on Ukraine.

Ukrainian authorities have never formally acknowledged carrying out such drone strikes, but they have made cryptic allusions to how Russia might expect retaliation for its war in Ukraine, including within Russian territory.

Ukraine is carrying out research and development on drones that could fight and down other drones, Federov said.

Russia has used Iranian-made Shahed drones for its airstrikes in Ukrainian territory in recent weeks, in addition to rocket, cruise missile and artillery attacks.

"I can say already that the situation regarding drones will change drastically in February or March," he said.

Federov sat for an interview in his bright and modern office. Located inside a staid ministry

Ukraine has some 30,000 mobile-phone towers, and the government is now trying to link them to generators so they can keep working when airstrikes damage the power grid.

The only alternative, for now, is satellite systems like Starlink, which Ukrainians may rely on more if blackouts start lasting longer.

"We should understand that in this case, the Starlinks and the towers, connected to the generators, will be the basic internet infrastructure, Federov said. Many cities and towns are facing power cuts lasting up to 10 hours. Fedorov said . Ukrainian President Volodymyr Zelenskyy signed a decree that instructs mobile phone companies to ensure they can provide signals without electricity for at least three days.

Meanwhile, with support from its European Union partners, his ministry is working to bring 10,000 more Starlink stations to Ukraine, with internet service made available to the public through hundreds of "Points of Invincibility" that offer warm drinks, heated spaces, electricity and shelter for people displaced by fighting or power

Finland gets floating LNG terminal to replace Russian gas

AP ■ HELSINKI

 Γ finland's first floating liquefied natural gas terminal was moored on Wednesday at the southern port of Inkoo where it will supply gas to the Nordic country that was cut off from Russian gas imports earlier this year amid the war in Ukraine.

The massive 291-metrelong and 43-metre-wide offshore support vessel Exemplar, which sailed to the Baltic Sea from Spain earlier in December, has a capacity of 68,000 tons of LNG and is scheduled to be operational from the beginning of

FSRU Exemplar, owned by the US company Excelerate Energy Inc., will ensure future availability of gas in Finland, replacing supplies earlier imported from Russia, Finland's state-owned Gasgrid Finland

The vessel will reconvert LNG to gas which will then be fed into the Finnish network for distribution. The arrival of the Exemplar will also enable gas deliveries to the Baltic states — Estonia, Latvia, Lithuania — and possibly also to Poland through the undersea Baltic-connector pipeline between Finland and Estonia that runs near Inkoo.



Gazprom halted gas exports to neighbouring Finland in May, citing Helsinki's refusal to pay in rubles, as Russian President Vladimir Putin has demanded European countries do since Russia invaded Ukraine on February 24.

Gazprom's move marked a likely end to Finland's nearly 50 years of importing natural gas from Russia. The two parallel Russia-Finland natural gas pipelines were launched in 1974. Natural gas currently accounts for just some 5 per cent of total energy consumption in Finland, a country of 5.5 million.

Until May, nearly all of that gas came from Russia, and has been used mainly by Finnish industrial and other Russian energy giant companies with only an esti-

mated 4,000 households relying on gas heating.
As Moscow has cut off elec-

tricity exports to Finland — also in May - and the Finnish state-controlled oil company Neste has replaced imports of Russian crude oil with other sources, Finland's energy ties with Russia are now all but gone. Gasgrid Finland has leased the Exemplar for a period of ten years for an estimated total cost of 460 million euros (USD 490 million).

European Union member Finland, which shares a 1,340kilometre (830-mile) long border with Russia, applied to join NATO in May and is currently waiting for the remaining two members - Hungary and Turkey — of the military alliance to ratify its membership.

Southwest Airlines flight cancellations

 $\mathbf{F}^{ ext{amilies}}$ hoping to catch a Southwest Airlines flight after days of cancellations, missing luggage and missed family connections suffered through another wave of scrubbed flights, with another 2,500 pulled from arrival and departure boards on Wednesday.

Exhausted travellers sought passage by other means using different airlines, rental cars, or trains - or they've simply given up.

According to the FlightAware tracking service, more than 91 per cent of all cancelled flights in the US early on Wednesday were from Southwest, which has been unable to recover from ferocious winter storms that raked large swaths of the country over the weekend.

The operational systems of Southwest have been uniquely effected, so much so that the federal government is now investigating what happened at the Dallas carrier, which has frustrated its own flight and ground crews as well.

Snowbound Buffalo braces to find more dead

Buffalo was set to emerge from a deep freeze Wednesday, bringing some relief but also the tragic possibility of finding more victims amid melting snow from the area's deadliest storm in decades.

Officials said more than 30 people so far have been reported to have died because of the blizzard that raged Friday and Saturday in western New York, an area prone to powerful winter storms. The historic Blizzard of 1977 killed as many as 29. Antwaine Parker told The Buffalo News that his mother, Carolyn Eubanks, perished at the home of strangers who took her in after her family tried to get help for the ailing woman.

Eubanks, 63, relied on an oxygen machine. With the power out in her home and emergency responders unable to answer calls amid the blizzard, Parker said, he and his stepbrother drove through the snow Saturday to rescue her themselves. She collapsed as

they led her to a car, he said. "She's like, 'I can't go no



further. I'm begging her, 'Mom, just stand up.' She fell in my arms and never spoke another word," Parker told the newspaper. The stepbrothers knocked on nearby doors, seeking someone who would help. They found David Purdy, who opened his door to two desperate strangers and helped them carry Eubanks inside and try in vain to revive her.

After they realized she was gone, Purdy and his fiancee sheltered her body until first responders showed up with plows the next day.

"I done it as respectful as I could," Purdy told The Buffalo and watched a forecast that calls for some rain later in the week. Officials in Erie County which encompasses Buffalo, said Tuesday they were concerned about the possibility of

The weather service said Wednesday that "any flooding is expected to be of the minor or nuisance variety."

While suburban roads and most major highways in the area reopened Tuesday, there was still a driving ban in Buffalo, and state and military police were assigned to enforce it. Erie County Executive Mark Poloncarz, a Democrat, said "too many people are ignoring the ban."

A Facebook group originally created in 2014, when Buffalo was buried under deep snow, has become a lifeline, seeking to help thousands seeking food, medicine, shelter and rescue in the latest storm. Currently managed by five women, the group swelled to at least 68,000 people as of Tuesday.

"We are seeing a lot of desperation," said Erin Aquilinia, founder of the original group, in an online interview

Nearly 400,000 people were affected, with over 81,000 still in shelters and nine others injured, the National Disaster Risk Reduction and Management Council said.

Sixteen of the 25 deaths were reported in Northern Mindanao region in the south, while 12 of the 26 missing are from the eastern Bicol region, the council

A shear line — the point where warm and cold air meet - triggered rains in parts of eastern, central and southern Philippines, the state weather bureau PAGASA said.

The weather disturbance disrupted Christmas celebration in affected provinces, with photos from the south-ern province of Misamis Occidental showing rescuers carrying an elderly woman on a plastic chair as they waded through a flooded street. Some residents in the province were seen hanging on to floaters as coast guard rescuers pulled them across chest-deep flood using a rope.

The disaster management council said 1,196 houses were damaged by the floods, while sections of 123 roads and 12 bridges were affected. Some areas remain without power or water supply.

China to start issuing new passports as virus curbs ease

The Chinese government says it will start issuing new passports as it dismantles anti-virus travel barriers, setting up a potential flood of millions of tourists out of China for next month's Lunar New Year holiday.

That raises the possibility of an influx of free-spending Chinese visitors to revenuestarved destinations in Asia and Europe in what usually is the country's busiest travel season. But it also presents a danger, as tourists might spread COVID-19 as infections surge in China.

China stopped issuing passports at the start of the COVID-19 pandemic in early 2020 as part of the world's strictest anti-virus controls and tried to block students, businesspeople and other travellers from going abroad. Tourist travel into China was shut down. Businesspeople and others who were allowed in were quarantined for up to one week.

Tuesday's announcement adds to abrupt changes that roll back a "zero-COVID" strategy that confined millions of families to their homes. It kept infection rates low but fueled

While telecom regulator Trai looks at service quality norms, the DoT's parley with telecom operators was more about identifying problem areas and seeking inputs on policy measures and operational interventions that can facilitate better service quali-

ty in the country.

In September this year, Communications Minister Ashwini Vaishnaw indicated that telecom service quality parameters could be made more stringent and tighter, possibly to the extent of 3-4

The minister had made it amply clear that the industry will have to improve telecom service quality "significantly" as the government too has done its bit by ushering major reforms in the sector.
