EC warns against urban voter apathy

Poll panel urges voters to come out in large numbers to exercise their franchise in the second phase of the Gujarat Assembly polls on Dec 5

Wary of the "urban apathy" that impacted the overall voter turnouts, be it in Shimla when Himachal Pradesh voted on November 12 or in Surat in the first phase of polling on December 1, the Election Commission (EC) on Saturday went public urging the voters of Gujarat to come out in large Gujarat to come out in large numbers during the second phase of polling for 93 seats on December 5, high-voltage cam-paigning for which ended on Saturday. As many as 833 can-didates are in the fray across 93 constituencies for the December 5 polls. Votes will be counted on December 8. Prominent candidates in the second phase of the

China increasing forays in Indian Ocean: Navy chief

'Four to six Chinese warships in region at any given time'



Depicting the highly-sensitive scenario in the Indian Ocean Region, Navy chief Admiral R Hari Kumar on Saturday said at any given time four to six Chinese warships are present in the region, indicating increasing forays by China. He, however, assured that the Indian Navy was keeping a close watch on the movement of these warships and would protect national interest.

While outlining the situation in the Indian Ocean Region and the Indo-Pacific, the Navy chief also said the Ukraine conflict has taught India to be self-reliant in Defence production. The nearly 10-month-old war has not impacted the Navy's procurements.

Giving a low down on the increasing Chinese visibility in the strategically important Indian Ocean, Admiral Kumar said there are a lot of Chinese ships in the region including

research vessels, warships and merchant ships. The Indian Navy is keeping a close watch, he said adding there are more than 60 other extra-regional forces also present in the 'vital

Elaborating upon the importance of the Indian Ocean, Kumar said large amount of trade transits through the sea lanes of the region besides energy supply of several nations. The Indian Navy keeps track of the ships and will not allow vessels inimical to the country's interest, the Navy chief said.

Informing that Chinese fishing vessels operate all over the world including the Indian Ocean Region, Admiral Kumar said, "our job is to track them through robust surveillance and not allow them to fish in India's exclusive economic Continued on Page 6

disputed Lapid's claims about the film directed by Vivek Agnihotri. Veteran actor Anupam Kher had acted in the film.

Both of them have slammed Lapid.

According to the news portal *The Wire*, breaking their silence, the three foreign members of the IFFI jury have now said they stand behind what Lapid said. On Saturday, fellow jury member Jinko Gotoh tweeted a statement expressing the support of all the foreign members of the jury for Lapid's stance on 'The Kashmir Files.'



Cooperative Bank

No major damage caused, say officials

massive fire broke out on A massive fire bloke on the 8th floor of UP Cooperative Bank's headquarters in Hazratganj on Saturday. The bank was in news following a cyber fraud in which a sum of Rs 146 crore was transferred to different accounts by hackers on October 15. The police have worked out the case and recovered the entire amount. Interestingly, the fire broke out on the same floor where the cyber fraud was committed by the hackers.

As per reports, Gajendra Pathak, who is incharge of allowing entry to safai workers to open the locks and clean the office, felt a foul smell from a room known as Brochures room on the 8th floor. Minutes later, he saw fumes emanating from the room.

The bank officials said they attempted to douse the flames by using fire extinguishers and informed the Fire department around 9:40 am. "The firemen reached around 10 am and successfully douses the flames. Some old brochures, which were of no use, were partially damaged. No major losses took place," an official said.

In the fraud case, a former staff, RS Dubey of Indira Nagar,



was accused of conspiring with the hackers. The police arrested the accused named in the case. The police had found that the company of one of the accused, Sukh Sagar Singh Chauhan of Gomti Nagar, had got Rs 74 crore in the digital transaction. The police got the lead following the interrogation of Dubey, who disclosed the

names of his aides as Umesh Kumar Giri, Gyan Dev Pal, Ravi Singh Verma and Satish Kumar. The cyber fraud had taken place on October 15 and Dubey had facilitated entry of the fraudsters using his familiarity with security guards. The police were yet to find the device which the hackers used to breach the bank's server.

Fire breaks out in UP Jail inmate falls sick, dies; kin create ruckus

A jail inmate fell sick all of a sudden and died during treatment at Balrampur Hospital in Wazirganj police station area on Saturday. His family members created a ruckus in the hospital, alleging that he was not provided proper medical care and that he was thrashed in jail.

As per reports, Mohammed Amir (40) of Daliganj near Mankameshwar Temple was named in a case registered under Negotiable Instrument (NI) Act and later sent to jail in Gosainganj. Around 10 am on Saturday, Amir developed health-related complications and was taken to the jail hospital from where he was referred to Balrampur Hospital. A police spokesman said Amir was admitted to the

hospital around 10:30 am on Saturday and he died around 1:05 pm. The hospital administration sent a memo to Wazirganj police. Thereafter, the police reached there and sent the body for autopsy. Amir's family members

assembled at the hospital and created a ruckus. They alleged that Amir was thrashed in jail and did not get proper medical care, which resulted in his death. They claimed that he had no health complications earlier. They said he was scheduled to be released from jail on December 29.

It surfaced that Amir had a money-related dispute with a man. "We were informed in the morning that Amir had fallen sick and he had been admitted to Balrampur Hospital," they said. Amir is survived by wife and two daughters.

HC judge, driver in road mishap

Lucknow (PNS): A sitting judge of the Allahabad High Court and his driver had a providential escape after a 14-wheel truck hit his car in BBD police station area on Friday night. His driver filed a case in this connection. As per reports, judge Surendra Singh's car was hit near Break Point dhaba in the area around 11:10 pm on Friday.

A police spokesman said a case for reckless driving was registered on the complaint of judge's driver Radhey Krishna Mishra of Prayagraj. He said the truck brushed past the judge's car whose front tyre was damaged. "The front portion of the car was also damaged and a case under the relevant sections of the IPC was registered. Efforts are underway to track down the errant driver," he said.

The police said the judge and his driver were safe. "We will arrest the truck driver soon," he added.

Providential escape for Allahabad | Man defrauded of ₹20L by realtor a flat in his project and took came to know from various

A realtor and his men were accused of defrauding a man of about Rs 20 lakh in the name of booking a flat at his project called Urban Woods in Sushant Golf City police station area.

The victim, Amitesh Pandey of Mohanlalganj, filed a case with the Vibhuti Khand police on Saturday. In his complaint, Amitesh, who is a banker, said realtor Shashank Gupta lured him into buying

Rs 19,34,000 from him for booking in 2016.

"I was not interested in investing in a flat but he lured me into doing so. In March 2018, he gave me a fake allotment letter even though the project was nonexistent back then. He later motivated me to adjust the money in other projects when I insisted him to register the flat in my name in

2020," he said. He further said that he

sources that the project was fake and he decided to take back his money.

"One of my relatives and I were held hostage at the office of the realtor in Vibhuti Khand. He threatened to frame us rape cases. He even thrashed and abused us," he alleged. He said an associate of the realtor impressed upon him by saying he was a close aide of an MLA and had a good rapport with officials at the CM's office.

BDC ex-member Levana Suites owners, manager get bail peppered with bullets by rivals

PNS LUCKNOW

A former member of BDC and presently a MGNRE-GA worker was peppered with bullets by his rivals in Kakori police station area on Saturday afternoon.

As per reports, Ram Jeewan Lodhi of Gurdeen Khera was attacked when he was returning home from the town area close to Chaudhary Mohalla Ward near Sharda Canal. Police recovered bullet shells and Lodhi's bike from the crime scene.

ADCP, West, CN Sinha said, "Ram Jeewan Lodhi was shot three times and he sustained injuries in his hands and head. He was rushed to Trauma Centre of KGMU where he was pronounced dead," he said.

The ADCP said Lodhi had an enmity with Shiva aka Shamsher, who is a former gram pradhan of the area. The family of the deceased has named Shiva and his men in a complaint. A case has been registered and manhunt has been launched for Shiva and his a week ago.

men. Shiva was not found at his house and it deepened the suspicion on him," Sinha said.

Eyewitnesses told the police that Lodhi was shot after a brief verbal spat with Shiva. "Shiva whipped out a pistol and fired at Lodhi," an eyewitness was quoted as saying by the police.

The attacker was accompanied by others who fled the scene taking advantage of the chaos which followed after the incident.

Meanwhile, a group of youths abducted their rival and freed him after thrashing him in Sarojini Nagar police Reports said the victim, Shahrukh of Baag No. 3, had gone to pick up his younger brother from a school in Shanti Nagar when his rivals reached the scene and abducted him. They took him to some place where they thrashed him before setting him free. He named Jeet, Manish and Manas in his complaint and said that he had a showdown with them

The Allahabad High Court has granted bail to the owners and manager of Levana Suites hotel here where four people were killed and many were injured in a fire on September 5 this year.

The Lucknow bench of the high court granted bail to Levana Suites owners Rahul Agrawal and Rohit Agrawal and manager Sagar Srivastava.

'There may have been some infraction of regulatory requirements to run a hotel but that would not amount that the accused persons had been negligent or they failed to take due care of their guests or they had knowledge of fire accident, which would result in death/injuries to the guests," Justice DK Singh

observed in the bail order.

Four people had died and several injured in a massive fire that broke out at the hotel in Hazratganj area of Lucknow on September 5 this year. The FIR in the matter was lodged at Hazratganj police station. The FIR had alleged that no arrangements for fire safety, emergency escape or entrance were made in the hotel and no arrangements were there for smoke to come out and also no such safety arrangement was there to counter such exigencies. It was also alleged in the FIR that windows of the hotel rooms were blocked with iron grills and thus, they could not be opened for the purpose of escaping by the occupants.

During the rescue operation, firemen faced immense

difficulty in cutting iron grills to enter the building. The FIR further alleged that gas cylinders were kept in the hotel premises in a very unsafe and reckless manner. It was further alleged that the owners and manager of the hotel had knowledge that such lapses and lack of arrangements would likely threaten life and safety of the people.

In the bail pleas, it was argued that the owners and manager of the hotel have been booked for the most serious offence of committing culpable homicide besides other offences but in fact, they had no knowledge that such an incident could ever occur and hence the offence cannot attract against them.

To this plea, the bench observed, "To attract the pro-

visions of Section 304 IPC (committing culpable homicide), there has to be knowledge of an accused that his act would likely cause death."

The state counsel and the victims' lawyers opposed the bail pleas arguing that noobjection certificates were obtained by bad means and the accused were aware that such an incident could happen on any day and hence they are not entitled for bail.

"Considering the aforesaid facts and circumstances of the case and also the fact that the charge sheet has already been filed and the accused persons have been in jail since the first week of September 2022, I am of the opinion that the accused persons are entitled to be enlarged on bail," the bench said.

The Power Employees' Joint Action Committee on Saturday announced to suspend the four-day work boycott following talks with Energy Minister AK Sharma.

The minister assured the power employees that their demand for removal of the chairman of UP Power Corporation Limited would be looked into. Convenor of the committee Shailendra Dube said the agitation had affected the power supply across the state and around three crore power consumers were affected by the agitation.

He said that over 25,000 engineers and power employees had participated in the agitation. The major demands of the power employees include rollback of the orders for privatisation of the transformer repair workshops and orders for the operation of power transmission sub-stations through outsourcing to private agencies. The employees are also demanding cancellation of the tender of Rs 25,000 crore for the purchase of smart

LSWA delegation meets Power employees excise minister to press demands

delegation of Liquor Sellers' Awelfare Association (LSWA) met the excise minister on Saturday to apprise the latter of their demand to increase the margin on sale of liquor to make up for their losses and renewal of their licences.

LSWA media incharge Devesh Jaiswal said the meeting was fruitful and satisfactory. Jaiswal said the demand to increase the margin on the sake of liquor was the need of the hour. "For the last ten years, quota and licence fee have nearly doubled but the margin on sale of IMFL has decreased from 18 per cent to 11 per cent while that on desi liquor from 14 per cent to 8 per cent. On the contrary, the expenses on running a shop (rent, salary of salesmen, cost of contract deed, installation of CCTV cameras, LMC fees, which increased by 500 per cent, food licence, freight charges, damage of goods and other counts) have increased by nearly three times," he pointed out.

Jaiswal said liquor sellers

were facing a lot of hardships in running their business and also facing losses due to increased expenses. He said the Excise department should allot a highstandard scanner as the PoS machines were not working properly. Jaiswal said the department should not increase the MRP of low-brand desi liquor, IMFL and beer because the revenue is high on such brands. "There is a need for 42.8 per cent of Tetra Pal of desi liquor availability in the city area of Lucknow," he said.

The delegation also demanded that the shop opening time be increased to 11 pm from 10 pm to prevent illegal sale. The delegation further demanded immunity for licence holders from police FIR for the illegal work of sellers. "The sellers undergo police verification and they should be taken to task if they commit a crime. Shop-owners usually take licences in the names of their family members. Police action should be taken only if a probe establishes the role of a licence holder in any illegal activity," the delegation said.

₹1,000 crore in Ayodhya

The Yogi Adityanath govern-I ment has approved projects worth about Rs 1,000 crore to provide direct road connectivity from various locations to the Ram temple being built in Avodhva.

The initiatives include land acquisition for road connectivity, rehabilitation of buildings and shop-owners and con-struction of buildings. With this, all the roads leading to Ram Janmabhoomi will be widened and beautified, creating a beautiful ambiance for pilgrims.

Keeping in mind the convenience of devotees, a 0.566km four-lane road is being built from Sugriva Fort to Shri Ram Janmabhoomi Mandir Marg, and it has been named Janmabhoomi Path.

In a high-level meeting, Chief Minister Yogi Adityanath gave his approval to the development project which will cost approximately Rs 83.33 crore, including land purchases and other projects.

In addition, Rs 3.90 crore and Rs 27.17 crore have been made available for the construction work. At present, 39 per cent of the work has been completed whereas the work of pipeline for sewer water supply by Jal Nigam is going at a rapid

Utility duct and RCC drain construction are also underway. From Shringar Haat to Shri Ram Janmabhoomi Mandir Marg, a four-lane stretch measuring 0.742 kilometres is also being construct-

The name of this route is Bhakti Path. For its expansion, an amount of Rs 62.79 crore has been approved for the purchase of land and other construction work and a sum of Rs 32.10 crore has been released.

Owners of 350 shops which were in the way of the construction have been given compensation. As many as 290

shops have been demolished for widening of the road to 13 metres, including 5.50-metre wide CC road.

A 12.940-km four-lane road from Sahadatganj to Naya Ghat Marg is being built and has been named Ram Path in order to facilitate access to the Ram Janmabhoomi temple.

An amount of Rs 797.69 crore has been approved for widening of this road. For purchase of land and other construction work, a sum of Rs 290 crore has been released. About 40,765 square metres of land is needed for Ram Path, against which 4,773 square metres of land has been acquired.

Yogi govt OKs projects worth BJP will come back to power: Yogi in Guj

Uttar Pradesh Chief Minister Yogi Adityanath said on Saturday that the Bharatiya Janata Party would come back to power in Gujarat with a thumping majority. He appealed to people to turn up at polling booths in large numbers to vote for the BJP in the final round of elections to be

held on Monday. On the last day of his marathon campaign in Gujarat, Yogi said that the doubleengine government alone could ensure development at the speed of a bullet train and welfare of people while respecting faith, and described the Congress and the Aam Aadmi Party as "barriers in the country's progress" and were incapable of providing security, prosperity & employment to people, and respecting faith.

Urging voters to reject the Congress and AAP, Yogi said: "The voters of Uttar Pradesh have already done it and now it's your turn. AAP could not even open its account whereas of the 403 seats in UP, Congress only got two. You need at least four people even for carrying a body to the cremation ground."

Yogi said that under Prime Minister Narendra Modi's leadership, 'Ek Bharat, Shresth Bharat' is emerging. "There is no terrorism, separatism and

naxalism in the country. A new model of secure India has been established. Bulldozer has set a new model. It is not only used in construction but also runs over criminals and terror-

ists," he said.

"Gujarat is a model state that has provided leadership to the country at every critical juncture right from the period of Lord Krishna to Dayanand Saraswati, Mahatma Ćandhi, Sardar Patel, Swami Narayan and now Prime Minister Narendra Modi under whose leadership, India's prestige at the global stage has increased

remarkably," he added.

"In this 'Amrit Kaal' of Indian independence, India has defeated the UK, which ruled the country for two centuries, to become the world's fifth largest economy. On December 1, India under PM Modi's leadership also formally took on the mantle to lead G20, a group of 20 most developed countries that control 80 per cent of the world's resources," he said.

He added: "Under PM Modi's leadership, a vaccine was developed during Covid in real quick time. Besides, PM

Modi provided free tests, treatment and vaccines in addition to giving free ration to 80 crore people.  $T^{\text{he Uttar Pradesh government}} \\ \text{is looking at the real estate sec-} \\$ tor as a real source of investment in its goal to make Uttar Pradesh a \$1-trillion economy. In the next five years, the real estate sector would get investments worth Rs 7.3 lakh crore, as per an estimate by the Yogi Adityanath govern-

Special focus is being laid on urban areas. Under this, 64 lakh homes HIG, MIG, LIG EWS categories will be constructed in urban areas close to small markets. The government will encourage private companies to invest in these houses.

Citing a survey report, Chief Minister Yogi Adityanath told

officials in a meeting held recently that in the year 2020-21, the contribution of real estate in Uttar Pradesh's Gross State Domestic Product (GSDP) is 14.4 per cent, which is equal to Rs 34 billion. About 20 lakh people are associated with this sector.

Yogi told the officials concerned that there is a need to pay attention to this because according to the report, this sector can be helpful in providing new opportunities for growth, development, and employment in the state.

It has been said in the report that at present, the population of the state is 23.09 crore, of which about 23.7 per cent of the population (almost 5.47 crore) lives in urban areas.

In the year 2027, the popula-

tion of the state is expected to be 24.47 crore, of which 35 per cent of the population (8.56 crore) would increase in urban areas. In this situation, over 3.09 crore people will increase in the urban areas of the state in the next five

> At present, there are 10.7 lakh houses in urban areas whereas in the next five years, 64 lakh houses will be required in accordance with the population. This is the reason that there will be a boom in the real estate sector, which will play an important role in making the state a \$1-trillion economy.

The construction of 64 lakh homes will cost Rs 7.3 lakh crore, according to the chief minister. The average cost of constructing a home is expected to be Rs 1,500 per sq ft.
Private real estate companies will contribute 65 per cent of the cost of construction of these houses while 35 per cent contribution will be from the authority under the government. Besides, 75,000 acres of land will be required to build these houses, of which 32,000 acres is currently available

with the government. In such a sit-

uation, the government will have

to make more arrangements for 43,000 acres of land. Yogi has divided it into four parts to promote the real estate sector in the state — Ghaziabad, Gautam Buddh Nagar, and Meerut of NCR in the western zone. There will be an increase in the

cent to the growth state value addition. With the arrival of new companies, the means of employment will increase, which will attract people towards it. CPI (ML) delegation meets family of Dalit youth who died due to police beating

delegation of the Communist Party A delegation of the Community of Dalit youth Pravesh (20), who died due to alleged police atrocities in the Bewana village of Ambedkar Nagar on Saturday.

The delegation consisting of five members also visited the crime scene and submitted its report to higher authorities in the party. The party will stage a demonstration at the Ambedkar Nagar district headquarters in protest against the incident. In the report, the delegation said a brawl took place between two groups in Bewana police station area on November 30 night. "Later, a local police team reached the scene and caught Pravesh who was standing at the opening of a lane and was not part of the brawl. A native of Songaon in Jamalpur in Ambedkarnagar, Pravesh had visited his sister's house on the fateful day," the deceased's sister was quoted as say-

ing by the delegation. The delegation further alleged that the policemen kicked Pravesh in the chest and private parts and pushed down his sister Kalwati and other fanily members when they rushed to his rescue. "Pravesh fell unconscious and was pronounced dead at the district hospi-

tal," the delegation members said. The incident evokes stiff protest by the villagers who demanded justice for the victim. Following public pressure, senior officers assured proper action

against the policemen in question.

"A case was registered against two policemen for murder and under sections for SC/ST Act but the accused are still on the lam. The autopsy report con-cluded that Pravesh died of police beating. The delegation also visited the house of the deceased to collect information regarding the incident and demanded immediate arrest of the errant policemen, monetary compensation to the family of the deceased and a government job to a member in his family. The delegation was led by senior CPI (ML) leader Ram Bharose.

Vocational training to help girls become self-reliant in UP

As part of its ongoing endeavour to help girls become self-reliant in the state, the Uttar Pradesh government, led by Chief Minister Yogi Adityanath, will provide vocational training to them in schools.

Director-General of School Education Vijay Kiran Anand said the training would commence in the upgraded Kasturba Balika Vidyalayas of the state. "Orders have been issued and these schools have been asked to connect 100 per cent girl students to this programme," he said.

Meetings with parents will be held to generate awareness about the value of vocational training at the community level with the cooperation of district inspectors of schools, principals, district coordinators of Skill Development Mission, district basic education officers and district coordinators of girl edu-

"To motivate and enrol more girls, the introduction of skill development schemes and its advantages should be discussed. Room and furniture should be compulsorily made available for training," Anand said.

He said a room within each hostel should

be converted into a training room and the girls be assigned trade-based training as per their interests during pre-counselling. It should be mandatory to report the attendance of girl students undergoing training on the Prerna por-

A warning has also been issued along with the directive that the district coordinators for girl education and wardens would face disciplinary action if different circumstances were discovered during physical verification or a surprise inspection.

Assistant Director of the Skill Development Mission Rajeev Yadav said a total of 54 Kasturba Balika Vidyalayas had been notified, and training would begin soon. The registration procedure has begun.

In addition to this, the Skill Development Mission runs numerous programmes across the state to give girls access to vocational edu-

In view of women's safety, a safety kit distribution programme is also going on. After 10 days of training, special kits will be provided to the girls by experts. Additionally, as part of the pilot project, vocational training has already begun in a few women's residential

'High BP becoming a major cause of health concern'

Noted nephrologist Dr Archana Bhadauria while addressing the technical session of IMA State Working Committee-Con 2022 on Saturday said currently high blood pressure was becoming a major cause of health concern and often it was the subtle reason for chronic kidney diseases as well. She said in common terms kidney diseases were of two kinds-- acute kidney disease and chronic kidney disease and thus it engendered the need for constant monitoring of kidney health. She said all kidney diseases were not irreversible and can be cured but timely.

Explaining chronic kidney disease she said diabetes was the most common cause of kidney disease. Both type 1 and type 2 diabetes. But also heart disease and obesity can contribute to the damage that causes kidneys to fail. Urinary tract issues and inflammation in different parts of the kidney can also lead to long-term functional decline. She said diabetes was the most common cause of kidney disease both type 1 and type 2 diabetes. She said but also heart disease and obesity can contribute

to the damage that caused kidneys to fail. She said urinary tract issues and inflammation in different parts of kidney can also lead to long-term functional decline. She said there were a few other conditions or circumstances that can cause kidney disease like glomerulonephritis which was a group of diseases that caused inflammation and damaged the kidney's filtering units and these disorders were the third most common type of kidney disease. She said another was polycystic kidney disease or PKD was a common inherited disease that causes large cysts to form in the kidneys and

damage the surrounding tissue. She said malformations that occurred as a baby developed in its mother's womb like narrowing may occur that prevented normal outflow of urine and caused urine to flow back up to the kidney which caused infections and may damage the kid-

Dr Bhadauria said another factor was autoimmune disease it happened when the body's defence system, the immune system, turned against the body and caused lupus nephritis that resulted in inflammation of small blood vessels that filtered wastes in kidney.

ADM-E and Dy DEO Ran Vijay Singh said officers related to election, including DEO and observers will conduct patrolling of polling booths on the day of special drive and added that in case any BLO is found absent legal action will be ascertained against him or her. The educational institutions/offices and other institutions where there are polling

booths will remain open on December 4, he said and appealed to voters who will complete 18 years on January 1, 2023, but are not voters, to be present at their respective polling booths and get their names registered in electoral rolls by filling in prescribed forms. The new voters can apply online to get their names enrolled in electoral rolls through voter helpline app and website of the election commission-https://nvsp.in and https://voter portal.eci.gov.in, he said. Meanwhile, DM Rajalingam chaired a meeting at his camp office on Friday evening regarding preparations for forthcoming urban body polls and took DDO to task for having no information about duty of employees and selecting training staff. He directed the additional municipal commissioner to chalk out route chart for sector zone plan regarding urban body election. The special drive should be launched to apprise the voters of their name and number in voters' lists and polling booths, the DM said and added sensitive polling booths should also be determined after getting all information. He directed all officers concerned to be in election mode and ensure all arrangements related to election at polling booths.

613 qualify physical test

The Prayagraj Development Authority (PDA) has been tasked with the beautification of the route leading to Akshayvat which will be equipped with facade lighting, greenery and tales related to the sacred tree on the walls. Pant, who along with DM and other senior officials visited the site on Friday, asked officials to develop themes based on Akshayavat and Patalpuri on route between Quila ghat and Akshayvat

ED seizes betel nuts worth ₹11.5 cr in raids

The Enforcement Directorate (ED) has searched 17 premises across Mumbai and Nagpur under Prevention of Money Laundering Act, covering office and residential premises of various persons involved in smuggling of betel nuts of Indonesian origin.

The smuggling of the Indonesian origin betel nuts was being carried out mostly via the Indo-Myanmar Border.

The ED initiated investigation on the basis of a CBI FIR registered in Nagpur on March 5 last year under Indian Penal Code Sections relating cheating, forgery and criminal conspiracy besides provisions of the Prevention of Corruption

As per the FIR, many Nagpur-based traders in connivance with various public servants, were indulging in smuggling of substandard Betel Nuts/Areca Nuts of Indonesian Origin and falsely claiming the same to be originating from member countries of South Asia Preferential Trading Agreement (SAPTA) and South Asia Free Trading Agreement (SAFTA) by using were made and transported



Fake Certificates of Origin, and by using bogus and undervalued bills/invoices. This caused evasion of Customs Duty and loss to the Government. Further, the Directorate of Revenue Intelligence had also investigated the illegal smuggling of betel nuts and issued eight Show Cause Notices.

"ED investigation has revealed that there is a well organized syndicate of suppliers of Indonesian Betel Nut, Commission Agents, Logistic providers, Transporters, Hawala Operators and Buyers were smuggling Indonesian Betel Nut into India via the Indo-Myanmar Border. Fabricated domestic invoices

smuggled betel nuts to Nagpur and Gondia districts of Maharashtra," the agency said in a statement.

During ED searches, unaccounted Betel Nut of 289.57 MTs valued at roughly ₹11.5 crore has been seized under PMLA at Nagpur. The godown owner could not supply the KYC (Know Your Customer) of the Traders who deposited the Betel Nut, and failed to furnish any supporting documenta-tion like Stock Register, Bills, Invoices, Quality Certificate and Transport documents among others.

The ED has seized Rs 16.5 lakh in cash and various incriminating documents and digital devices. Further investigation is going on, it added.

contemplating whether to go for indigenous aircraft carrier (IAC) II or prefer a repeat order for the IAC I, Chief of Naval Staff Admiral R Hari Kumar while setting a timeline of 2047 for making his force 'Atmanirbhar' (self-reliant).

Kumar said the proposed procurement of a fleet of Predator drones from the US is under process and that the Navy is on course for a major capability enhancement to deal with myriad security challenges.

The Chief also said an exercise is underway in the force to shed the colonial past as "we strongly support the view that we have to get away from this "Ghulami ki mansikta" (slave mentality).

On modernisation of the Navy, he said assurances have been given to the government that the force will become 'Atmanirbhar' (self reliant) by 2047 and several measures are being initiated to meet

"We are still working on what size it should be and what its capabilities should be. Right now we have put a hold on it because we have just commissioned INS Vikrant. We are quite happy with the ship. The way the ship performed in the trial," Admiral Kumar said when asked about the

The Navy has been making a strong push for having the IAC-II having a displacement of 65,000 tonnes which was estimated to cost close to Rs 50,000 with the

envisaged specifications. India's first indigenously-built aircraft carrier INS Vikrant (IAC I) was commissioned in September. The aircraft carrier, with a displacement of 40,000 tonnes, was built at a cost of around Rs 23,000 crore. The Navy Chief also said the Light Combat Aircraft (naval version) project will significantly help in developing the proposed next generation deck-based fighters. "This is helping us in developing

the next generation fighters to be operated from the deck which is something called the twin engine deck-based fighters," he said. "We are preparing the draft cabinet note for that. EC WARNS AGAINST **URBAN VOTER...**

The first phase of voting was held for 89 seats in Saurashtra, Kutch and south

Gujarat on December 1.
"Urban apathy continues unabated from Shimla to Surat. ECI appeals to voters of Gujarat to come out in large numbers during second phase to compensate for low voting in 1st phase," the ECI spokesperson tweeted.

In Gujarat, voter turnout in Surat, Rajkot and Jamnagar was lower than the overall 63.3 per cent in the first phase of Gujarat assembly elections, the poll panel said. The voting percentage in the first phase of election in Gujarat in 2017 was .79 per cent.

The urban assembly seat of Shimla in Himachal Pradesh recorded the lowest turnout in the state at 62.53 per cent, 13 percentage points less than the state average of 75.6 per cent. Though overall the voting ercentage increased marginally in Himachal Pradesh in 2022 compared to 2017 (74.17 percent), too many voters shied away from polling stations in urban centres in the State.

The Election Commission said the voting percentage increased in many constituencies in Gujarat in the first-phase polling but the overall turnout was diminished by the urban apathy to voting in key districts such as Surat, Rajkot and Jamnagar. Chief Election Commissioner Rajiv Kumar appealed to the voters of Gujarat to come out in large numbers during the second-phase polling on December 5 to make up for the low voting in the first phase. The possibility of surpassing the 2017 voting percentage now depends on their increased participation, he said, according to the Election Commission.

primarily be on ODIs and just like the T20Is, India's approach in the 50-over format needs a sea change.

Sometimes having a plethora of options isn't actually a good headache to have as it creates more confusion among the rank and file of the team.

When there are similar skill set options, the coach tries to give everyone equal opportunities but it results in not having a settled line-up and this is not an ideal situation when a marquee event is round the corner.

Currently, the Indian white ball squad is now going through that particular phase.

A few years back, Rohit Sharma and Shikhar Dhawan were automatic



picks as India's preferred ODI opening pair with hardly any questions asked or their spots being debated.

But Dhawan's slow approach in the Powerplay overs and the emergence of Gill as a potent 50-over opener is bound to throw up possibilities.

KL Rahul, during the last phase of Ravi Shastri's coaching stint played a few games in the middle-order but he

loves to bat at the top and has had a fair amount of success too.

Ironically, the numbers in the face of it will not give a clear indication as to who should be Rohit's opening partner for the series.

In the 19 ODI innings that Dhawan has opened for India in 2022, he had a poor strike-rate of 75.11. While between 2016-18, it used to be 101 and between

2019-21, it dipped but was still a steady 91. Rahul, who has five hundred and 10 fifties in 45 ODIs with a healthy strike-rate 85 plus and an impressive average of 45, looks a better candidate.

For the opening match though, in case the team management wants to give rest to a jet-lagged Dhawan, who has flown all the way from Down Under to join the team in Mirpur, Rahul will

Middle-Órder muddle

While Virat Kohli at No. 3 is an automatic choice, Shreyas Iyer as India's No. 4 is slowly settling down. Rishabh Pant after his heroics in the ODI series in England remains ahead of Ishan Kishan to start as No. 5 in the line-up.

Pant has copped a lot of flak for some of his cheap dismissals in T20s but despite some underwhelming shows in the recently concluded series, he remains the first choice keeper in 50 over format

Kishan, who prefers opening in T20 has got all his three half-centuries in ODIs batting at either No. 3 or 4.

We will narrow down our options closer to World Cup: Rohit

Ckipper Rohit Sharma doesn't Owant to clutter things by "thinking too far ahead" about the ODI World Cup and said he and head coach Rahul Dravid have a "fair idea" of how they would approach the showpiece to be held in India in October-November next year.

Asked if World Cup preparations start with the threematch ODI series against Bangladesh starting here on Sunday, Rohit made it clear that there is still time before his team can start thinking specifically about the marquee event.

He then gave a peek into his team's gruelling schedule during the past few months.



Memphis Depay and Daley Blind scored in the first half and Denzel Dumfries added a late goal as the Netherlands eliminated the United States from the World Cup with a 3-1 victory Saturday that advanced

the Dutch to the quarterfinals. Second-half substitute Haji Wright cut the U.S. Deficit to 2-1 in the 76th minute when Christian Pulisic's cross hit his trailing foot and popped over goalkeeper Andries Noppert and into the net. But Dumfries, who assisted on the first two goals, scored on a volley in the

Runners-up in 1974, 1978 and 2010, the Oranje extended their unbeaten streak to 19 games and face Argentina or Australia on Friday.

It was a disappointing end for a rebuilt U.S. Team hoping to advance past the round of 16 for the first time since 2002. Using the second-youngest squad in the tournament, the Americans achieved the bare minimum to consider the World Cup a success, beating Iran in their group-stage finale to reach the knock-

But just like in 2010 against



Belgium, the United States was eliminated in the round of 16.

The day before what was like- I ly his last World Cup game, Luis Suarez walked into the room, sat down and placed himself squarely in the spotlight again.

Then a Ghanaian journalist let it all out: Ghana wants to "retire you," he said to the Uruguay forward. You are "the devil himself." You need to apologize to my country for what you did. Quite the reaction to a soccer player, even if his deliberate handball more than a decade ago is still one of the most contentious moments in World Cup history.

Uruguay's 2-0 win over Ghana on Friday, which still



resulted in elimination for the Uruguayans, is expected to be Suarez's last World Cup game if he stays true to his pre-tournament pronouncement.

And if so, it ended the international career of one of soccer's most divisive characters, a player who is adored in Uruguay, who won titles at Ajax, Barcelona and Atletico Madrid, and who was at his height one of the best strikers in the world.

Suarez brought joy to his teams and fans, often after extended periods of gloom. With Suarez, Uruguay ended 20 years of World Cup underachievement — either failing to qualify or being eliminated in the group stage — to reach the semifinals in 2010.

He helped deliver Uruguay's first Copa America title in 16 years in 2011. He was instrumental in Atletico Madrid's first Spanish title in seven years in 2021. In doing so, Suarez also managed to regularly provoke emotions on the other side of the

"I thought our camel was better than Ronaldo and Messi," ioked Jassim al Kuwari, part of the family that owns Nazaa'a.

These events are held regularly throughout the Middle East, where the people have connected with camels for genera-

This is our culture. This is from long time ago, from our fathers and grandfathers," Al Kuwari said. "Today is a competition, a beauty competition.

We like these camels. We give them names. It's like a family." Visitors were greeted by a

Owners and their families sat in an air-conditioned luxury tent with red velvet chairs and a glass camel jingle "Welcome to the wall to watch the competition.

Competitors makes several passes in front of a stand of fans that cheer for their favorite. There's also a milking competition, with The main attraction were the prize going to the camel that Karak, a spiced tea with milk. the pure-bred female camels. produces the most milk.

Make no mistake, this a serious contest: A doctor is on staff to make sure the animals don't use fillers or Botox to make them more beautiful. Last December dozens of camels were disqualified from the King Abdulaziz Camel Festival in Saudi Arabia for cosmetic enhancements.

Then there's the money: The winner, runner-up and third place camels all receive trophies. Nazaa's owners earned 200,000 Qatari riyals (\$55,000). The camel that produces the most milk wins 15,000 riyal.

"I have been with camels and their contests since I was a child," camel owner Hamad al Greissi said. "Camels were there before planes and cars. They were called the ships of the desert. after modern vehicles, the camels became less popular, but they still hold a big place in our culture.

REVDI CULTURE IS HERE TO STAY

Despite so much debate and discussion of the revadi culture in the recent past, all political parties have gone all out of the way to offer sops to woo voters in Gujarat and Himachal Pradesh assembly polls, writes DIPAK UPRETI

hildhood stories like that of 'Kabuliwala' remind one of the street hawkers announcing their arrival and selling goodies like 'budia ke baal', peanuts, 'channa', 'gazak', and also ubiquitous sweet, 'revdis'.

The last selling item has recently taken a political colour with no less a person than Prime Minister Narendra Modi himself giving a condescending look at the humble "revdis" and decrying what he called "revdi culture" of freebies spawned by certain political parties and more specifically by the Aam Aadmi Party (AAP) of Arvind Kejriwal ruling Delhi and Punjab and currently making a high-pitch foray in PM's home state

'Revdies' themselves are popular sweat meat available even as 'prasad'. But now all political parties are showcasing 'Revdis' in their poll campaigns to distract the voters from their political rivals to their own decorative election campaign carts..

The 'freebies' or 'revdis', though, seen in the larger context, could also include tax cuts for corporate sectors, waving off of Nonperforming assets, and also sanctioning projects and schemes in the poll-bound states by the ruling parties.

They have been in vogue for long but received currency of late in the political dialogue which is increasingly turning bitter unlike the 'revdis', which have always been a good 'time pass' sweets for an average Indian to be taken without much fuss ...!

The debate raised is that freebies are a waste of tax payers' money which should be invested in such a way that it institutionalizes benefits and that too on a 'permanent basis' and is unlike offering a free laptop, cycle or a monthly allowance without any accountability to available finances or the budget.

In a welfare state, free health, education, and a minimum subsistence allowance to poor should not be viewed as 'freebies' but be welcomed as a step towards positive

For example, the 'Janaushadi kendras', under Central Scheme, offering allopathic medicines at less than half the market prices go a long way in relieving the pain of economically backward and middle class who are already facing the mercenary grind of an insurance-based healthcare system.

A free or highly subsidized health and education system catering to the economically poor section should be an obligation of the state and must not be considered 'bad

economics' and part of the "Ravadi culture" as has been made out by some of the advocates of 'globalization'.

The poll-time 'revdis' are, however, polished goods whose shine go away, once elections are over and at a time never delivered or fulfilled.

In circulation on the eve of poll season, all political parties rigorously decorate their election face 'with goods and items which could fetch them easy and enough votes to win. And like willy hawkers, political leaders announce them in their manifestos as if these could be the vehicles of transformation in a developing country like ours.

Despite the Prime Minister's disapproval of freebies, BJP's Gujarat manifesto is full of revdis and has also drawn sharp criticism from the Congress and AAP, for its "striking commonalities" with the sops, guarantees or 'revdis' promised by them.

The BJP manifesto titled "Agresar Gujarat Sankalp Patra 2022" pledges to provide free education to girls from kindergarten to postgraduation. This promise mirrors the Congress manifesto released on November 12.

The AAP too has promised free education to all children. At a rally at Mahidarpura in Surat's diamond market, the AAP candidate from Varachha, Alpesh Kathiriya, charged that the BJP manifesto was a "xerox copy" of the AAP guarantees.

Targeting the BJP, Gujarat AAP president Gopal Italia makes taunts , "When we announce our guarantees, the BJP calculates cost and tells us where will you get the money

The BJP manifesto promises to provide free medical treatment by doubling the cap of 'Pradhan Mantri Jan Aryogya Yojana' to ₹10 lakh from the existing ₹5 lakh.

The Congress has also promised a ₹10 lakh free medical health cover to all citizens. While the BJP has promised two free LPG cylinders annually for women under the 'Pradhan Mantri Ujjwala Yojana', Congress has

pledged subsidized cylinders at ₹500 per unit. Gujarat Congress spokesman Manish Doshi says, "The Congress manifesto announced well in advance forced the BJP to focus on education and health. Their promises

"In 2012, when we announced the 'Ghar nu Ghar scheme (promising houses to voters)' the BJP promised to build 50 lakh houses, " he

says.

'Revadis' distributed by political parties, in the game of winning elections, are more or

carry bags..! Congress has pledged to write off farmers' debt up to ₹3 lakh each in the state, while the figure promised in this regard by the AAP is ₹2 lakh. Both Congress and the AAP have promised electricity to farmers during the

daytime for irrigation purposes.
In its manifesto, BJP promises to host Olympic Games in the state by 2036 and provide 20 lakh jobs in the next five years.

As part of their poll pledges, both the Congress and the AAP have promised 300 units of free electricity for people, which the BJP has not done.

Giving an example of the first Solarpowered village in Modhera in Gujarat Prime Minister sought to counter rivals by claiming that it is time to "sell electricity" instead of receiving it free.

As against the BJP's promised 20 lakh new jobs in the next five years, Congress and the AAP have promised to fill 10 lakh vacancies in the state government's departments and PSUs.

Congress also pledged to regularise contractual government employees.

Both the Congress and the AAP have also promised to provide ₹3000 unemployment allowance to jobless youth and restoration of the Old Pension Scheme which the Congress has also promised in Himachal Pradesh that voted on November 12.

The party has also promised an unemployment allowance of ₹3,000 per month, ₹2,000 pension to 'divyangs', widows, senior citizens, and needy women, and waiver of loans of up to ₹3 lakh of all fishermen.

The AAP has also promised free water to farmers, ₹3,000 unemployment allowance, and a waiver of electricity bills

All three parties have promised assistance for cows and livestock and sought to milch cows for votes even though the emasculated bovines themselves are eating plastic in cities and towns of Indian streets.

While the BJP in its manifesto pledges to roll out "Pashu Aadhar cards" and subsidised cattle feed for calves, Congress has promised ₹5,000 for every family seeking to buy a cow. The AAP has promised ₹40 per day for the

maintenance of each cow in the state. Besides, the Congress has offered a ₹2,000 pension to 'divyangs', widows, senior citizens, and needy women, and a waiver of loans of up to ₹3 lakh for all fishermen.

The AAP has also promised free water to farmers, ₹3,000 unemployment allowance, and a waiver of electricity bills.

With an eye on tribal constituencies, the BJP manifesto promises to set up 25 residential schools for tribals. The AAP too has matched it by promising to build residential schools for tribals in all districts besides constructing houses for them.

The women voters are being increasingly enticed by the political parties with the 'revdi' offerings with Congress in Himachal Pradesh promising monthly ₹1500 to each woman above the age of 18. AAP leader Arvind Kejriwal has offered ₹1000 monthly 'financial assistance' to all women in Gujarat above 18 of age saying "it is not a freebie but people's money which is theirs "

Leave aside Gujarat and Himachal Pradesh elections, the humble Municipal Corporation of Delhi elections have attracted a rainbow of 'revdis' by AAP, Congress, and the BJP too.

The ruling BJP in the MCD has promised to provide free cycles to meritorious girl students of class V studying in MCD-run schools in Delhi and to set up 50 'Annapurna Rasoi' run by women in which citizens will get food at ₹5 !.

It is estimated that over 84 percent of Delhi government schools, mostly run by the AAP government, don't have Principles. This apart, teachers in the MCD-run government schools are missing their salaries and schools are grossly understaffed with a single teacher teaching many subjects and some primary schools don't have money to even employ a guard. Many government schools have been closed or on the verge of being closed even though DDA land is available with the MCD to open new government schools.

The 'revdi culture' could not be a substitute for real development lest there would not have been potholes, broken drainages, miserable hospitals, and schools without teachers. But when the political intent is to be in power and not the transformation of the 'basics', 'revdis' come in handy to outplay the voters as deceiving lollypops. They are superficially created to treat the symptoms of 'development' but rarely contribute to it and create undesired inequalities and nepotism.

It would be apt to quote the traditional idiom to describe the crafty mist created by the political class during the poll season: "andha baante revdi, apne apnon ko de", that is, a sightless person will distribute revdis only to his near and dear ones.





After a brief outburst of laughter, the party officials decided to award Verma the ticket in exchange for his donation of five jeeps and Rs 25,000 to five assembly candidates. In

order to compete against Dinesh Pratap Singh, the Raja of Kasmanda, who was running for Congress, the party needed a candidate from the Sitapur region. Additionally, it required financial and material resources. Nevertheless, the Jan Sangh did not validate Verma's claims about his riches. He was the owner of a relatively small flour mill, after all. Verma's jeep was seized, and he was given a light beating by irate party members. When the Jan Sangh began campaigning for him, using his last name frequently, Verma fled to Lucknow to hide. Even though the people desired a candidate

from among themselves rather than a "Raja," the Congress treated Verma as if he were irrelevant. With a margin of 3,377 votes, Verma was declared the victor.

The narrative is full of the components that Indian elections are made up of, including the criteria for receiving a ticket, the significance of caste and community, the ability of the voter to denigrate the powerful, and the use of astrological fore-

These are only a few of the many anecdotes told by Anil Maheshwari and Vipul Maheshwari in their book The Power of the Ballot: Trial and Triumph in the Elections, in which they tackle the massive topic of election in India.

The depiction of the tradition in Haryana of weighing candidates against coins is another example of utilising an anecdote to highlight the idiosyncrasies of Indian elections. By the 1980s, the chances of victo ry for every candidate, including unaffiliated candidates who had little chance of victory, were being compared to coins. A second contender was weighed against laddoos, which were also presented to the audience. An enraged rural population allegedly weighed a senior minister in the Bansi Lal government against a pile of



Hapless victims of borderless cyber terror

Globalisation accompanied by multiple waves of advanced information and communication technologies has made nation states and their citizens more prone to attacks by unknown enemies.

The cyber enemies are fast creating a world devoid of trust, creating a brand new vocabulary of conflict and chaos. James Adams, one of the founders of a cyber security firm called iDefense, had in 2001 warned that cyberspace is fast going to be a "new international battlefield".

Cyber warfare is a new reality.

A decade ago, then US Secretary of Defence Leon Panetta declared the dangers of a "Cyber Pearl Harbour". Further then US Homeland Security Secretary Janet Napolitano cautioned for a "Cyber 9/11". In 2015, James Clapper, the then Director of National Intelligence, stated that the US must get ready for a "Cyber Armageddon".

Since the 9/11 terror attack on the US, the most powerful nation has been exposed to external threats. No one, even the US intelligence and other top security agencies would have thought of a terror assault on the US.

But it happened that too at an unparallel magnitude, and terrorism received a new nomenclature called "global terrorism" and the fight against this scourge came to be known as "Global War on Terrorism". The massive global terror network starting from the dreaded al-Qaeda to the Islamic State has in fact redefined the contours of global terrorism.

Precisely, this phenomenon has grown like an industry accompanied by a large institutional mechanism all around the world. While these monstrous radicals are taking on humanity irrespective of region, religion and race, the devil of cyber terror has emboldened them. And frankly, the nation states have once again encountered an unidentified, borderless and all-encompassing catastrophic regime of terror.



In the light of the latest cyberattack on the e-services at the prestigious All India Institute of Medical Sciences (AIIMS), Delhi, in the last week of November, the possible threat of ransomware is surfacing again. With this horrendous strike, nearly three crore data storage of patients, including the VVIPs like the former Prime Ministers, Presidents, etc, are either lost, damaged or seriously com-

With immediate steps taken by the Intelligence Fusion and Strategic Operations of the Delhi Police, there is every chance that the perpetrators will be identified soon. At the moment, we do not have sufficient legal and security measures to prevent such malware attacks in India. Since the establishment of the Indian

Emergency Computer Response Team (CERT-In) in 2004, a national nodal agency, the collection, and analysis of data, and preventive measures to avert cyber security threats have become stronger than

The National Cyber

Security Coordinator under the National Security Council Secretariat coordinates with multiple institutions at national level on various cyber-security matters. Besides, the National Critical Information Infrastructure Protection Centre established in 2014 under the 70A of the Information Technology Act 2000 (amended in 2008) makes necessary arrangements to protect all institutions of national critical importance.

Again, the Cyber Swachhta Kendra (Botnet Cleaning and

Malware Analysis Centre) under the Ministry of Electronics and Information Technology (MEITY) is providing us adequate preventive mechanisms to stop such malicious viruses into our cyberspace. In fact it is part of Digital India Initiative of the Government of India that aims to create a secure cyber space by detecting botnet infections across the country. This centre also helps to notify, clean and secure systems for all end users to protect them from possible malware attacks.

But it is pertinent to know whether such mechanisms are enough to protect our national and regional critical infrastructures against hundreds of malwares released by various nefarious actors? If not what more can our Government do? At the moment, the national cyber security agencies and Internet is open to such attacks. all other civil-military organisations are certainly not sufficient to counter possible cyberattacks. It must be noted here that no nation, even the mighty US, is completely protected against such attacks. While global organisations like the Interpol and other top security and intelligence agencies can be the hope for countries like India, the US, China, Russia, the UK, the EU, etc, an immediate global-level cooperation and safe data sharing to fight cyber crime is the only way to minimise threats emerg-

ing from the cyberspace. Today, national governments are facing single most serious security threats not from air force, navy, or infantry divisions but from cyberspace. A simple computer or any digital device linked with the

Indeed, nation states are facing an existential threat not only from their real and perceived enemies but also from growing corporate conglomerates around the world. At this juncture, governments at all the four levels — global, national, regional and local — are grappling to safeguard their territorial boundaries from cyber enemies.

The current Ukraine war is a testing ground for cyber warfare. This conflict has provided extensive insights into the current domain of the digital war zone. Leaders like Putin are once again shaking people's confidence in national and international institutions, making them rather irrelevant for some time.

It's time to stop him and save democracy and basic

human rights of the people on both sides of the border of Russia. Putin's designs have no place in a civilised world like ours. His nasty cyber tactics have already brought immense loss to hapless Ukraine. The moot question is

whether we will be able to overcome the chaos in the near future? Experts say there is a very remote possibility to completely destroy the cyber enemies. No nation is safe today, not even those who launch cyberattacks. It is time to realise the fact that we are living in an open world, wherein there is no place to hide from enemies. All the nations are interdependent, and no one can claim to be fully protected from enemies, both physical and virtual.

It is high time we realised that cyberspace is not an isolated realm. It binds all of us together. We are creating our enemies. The irony is that these viruses are man-made. But we are unable to keep them under control. But we are still struggling to grasp the underlying reality.

For an emerging global power like India, we do not need to wait for another AIIMS like cyber attack chaos. Delhi must respond to the crisis effectively. Its security and intelligence agencies must stop any future attacks over Parliament, the Reserve Bank of India, All India Radio, Prime Minister's Office and all other critical infrastructures.

The magnitude and cyber threat is increasing at an unimaginable rate. But strategies to counter it are purely inadequate at the moment. Today biggest challenge is to remain isolated. It is beyond our control. Many security experts predict that cyber threats might push many countries into physical conflicts. Cyber enemies are creating distrust, pitting one against another and making us suspicious of each other.

It's not all Musk's act

Regardless of the diatribe around the Twitter-Musk saga, it's time to look at essential numbers and stop relating everything to Musk's takeover of Twitter. As per Sensor Tower's data, during the days Musk announced his plan to terminate the agreement to buy Twitter amid spambot and fake account debates, the mean average weekly advertising spending in the US had touched \$945,800. Come September, this dropped to \$944,200, when tensions were building up further over Twitter's deposition in the lawsuit filed in Delaware Court of Chancery. Despite the looming law, the deal seal was expected to be postponed for a while.

By October, before the deal went through, the mean dropped to \$877,200 and plunged to \$589,100 a week after Musk's takeover. Such figures beg further scrutiny.

Logging out As much as social media

users may criticise the entire Twitter takeover, the sheer number of installs on App Store and Google Play Store is testimony to the world's choice of Tweeting on the app. The 6.3 million worldwide installs through October 15-26 jumped to a staggering 7.6 million between October 27 and November 7, which is when the takeover saga started.



uring a counselling a person in distress, he claimed: "Sir, I am spiritual. I have done advanced course in Vipasana and learnt dynamic meditation of Osho. I wish to become a healer. Recently I tried to heal someone I liked. Driven by the belief that my healing touch will help him overcome his negatives, I associated with him for quite long. I expected from him to appreciate my efforts and join hands with me as a life partner. But I miserably failed. Its emotional carryover has become burdensome." Kindly guide."

True, you do carry seeds of spirituality as would linkage of lagna (individual identity), 5th house (merits carried over from the past), and 9th house (translation of merits into fruits) mean.
