# Hijab clash in Karnataka shuts schools, colleges

### Maintain peace, harmony, CM urges students

PNS BENGALURU/NEW DELHI

The hijab controversy in Karnataka took an ugly turn on Tuesday as pro and anti-hijab students clashed in several parts of the State. Chief Minister Basavaraj Bommai appealed to students to maintain peace and ordered the closure of schools and colleges for three days.

In a tweet, Chief Minister Basavaraj Bommai said, "I appeal to all the students teachers and management of schools and colleges as well as people of Karnataka to maintain peace and harmony. I have ordered the closure of all high schools and colleges for the next three days. All concerned are requested to cooperate."

As protests for and against the hijab intensified at colleges in different parts of Karnataka, State's Home Minister Araga Jnanendra also appealed for peace and said no one should give an opportunity to use the police force.

The Home Minister's warning came as tension pre-

vailed at some educational institutions in Udupi, Shivamogga, Bagalkote, and other parts, forcing the police and authorities to inter-

Meanwhile, the Karnataka High Court began hearing the petitions filed by five girls studying in a Government Preuniversity College in Udupi, questioning hijab restriction in college. The court appealed to the students to maintain peace and posted the matter for further hearing on Wednesday.

"You (students) are all educated, you have to think about

your future. After two years of Covid-19, this year classes have been conducted in a good way. This is the time for you to prepare for your exams that are coming up in a couple of months," the Home minister

Noting that religious forces behind such incidents have to be guelled and everyone should think about the country, the Minister in a video statement said, "We should all stand together as brothers, as the children of this country. Uniform is a sign of equality. Educational institutions are not the place for

showcase our costumes.' 'Everyone should maintain peace. Don't give an opportunity to use the police force. appeal to parents to guide their children and let's all work towards colleges functioning in a peaceful manner."

Protests erupted at the Mahatma Gandhi Memorial College in Udupi after a large group of students wearing saffron stoles and headgears raised slogans on the college campus as hijab-clad Muslim girls were staging a protest demanding justice, forcing the police and college authorities to intervene. Some colleges have declared holidays in the district.

A minor stone petting incident has been reported near a college in Bagalkote and a few students even tried to barge into the campus, whom police dispersed using mild force.

A similar incident was also reported at a college in the Shivamogga district, and police had to intervene to bring the tense situation under control.

According to sources, some students even tried to hoist the saffron flag at the college premises. Similar protests have been reported at colleges in Mandya, Vijayapura, and Gadag districts.

# Modi: Anti-Sikh pogrom, exodus of Kashmiri Pandits Cong's legacy

#### **Cong gripped by** ideology of urban Naxals, says PM; **Cong walks out**

PNS NEW DELHI

Prime Minister Narendra Modi on Tuesday questioned the legacy of the Congress rule in the country and pointed out that the legacy of the party included the massacre of Sikhs in 1984, the mass exodus of Kashmiri Pandits from Kashmir, and the Emergency in 1975. The Congress members walked out in protest during Modi's

Launching a scathing attack on the main Opposition party, the aggressive Prime Minister in his 90-minute speech in the Upper House also said the Congress was now gripped by the ideology of urban Naxals.

Participating in the debate on the motion of thanks to the President's address, Modi said if the Congress would not have been at the helm for so many years in the past, incidents like atrocities against Sikhs or exodus of the Pandits would not have taken place.

He also said Mahatma Gandhi was in favour of dis-



mantling the Congress after the country gained Independence. However, it did not happen due to dynastic politics practised by the party and talent was the first casualty, Modi charged. He also said dynastic politics was the biggest threat to democracy

Listing out the so-called failures of the Congress, Modi said the country saw institutionalised corruption, casteism and regionalism. He claimed that the Congress practised the policy of three systems, including first discredit, then destabilise and then dismiss.

He then read out how several State Governments were dismissed and President's Rule imposed during the Congress' rule. The President's Rule was imposed more than 100 times during the Congress rule spread over 50 odd years, the Prime Minister said. He also said 50 State Governments were also dismissed during that tenure.

When the Congress staged a walkout, Modi said one needs that the party was used to only preaching to others till

The Prime Minister rejected accusations of altering history and said he was only refreshing the memory of some whose histories began only 50 years ago and whose histories were confined to that of a particular family.

Referring to Jawaharlal Nehru, Modi said he was "concerned about his global image", refused to send the Army to help Ram Manohar Lohia led "satyagrahis" working for Goa's independence. The Congress, he added, delayed Goa's independence by 15 years until after Îndia attained freedom.

Modi also listed instances of past Congress Governments muzzling the freedom of expression and cited Lata Mangeshkar's musician brother Hridaynath Mangeshkar being sacked from All India Radio (AIR) for presenting poetry on Veer Savarkar. Lyricist Majrooh Sultanpuri, he added, was jailed for criticising Jawaharlal Nehru. Singer Kishore Kumar too had to suffer during the Emergency, the Prime Minister said.

Whenever someone within the Congress has spoken against a particular family, the results have been there for all to see, Modi said, naming the late Sitaram Kesri

Akhilesh further said that an urban employment guarantee law would be enacted on the lines of Mahatma Gandhi National Rural Employment Guarantee Scheme (MGN-REGS). The former chief minister said that there would be 33 per cent reservation for women in government jobs, including the UP Police.

The SP manifesto also promises free education for girls from primary class till post-graduation. Also, a 'Kanya Vidhya Dhan' scheme will be launched again under which girls clearing their class 12 exam will be provided with a one-time amount of Rs 36,000. It also pledges to provide a laptop to all students clearing their class 12 exams.

The SP chief further said. 'Samajwadi Pension' will be relaunched, under which elderly people, needy women and families below poverty line (BPL) would be provided Rs 18,000 every year. This will benefit nearly one crore fami-

that samajwadi canteens and 'kirana' (groceries) stores will be established where poor labourers, masons and destitute will get ration and other essen-

tials on concessional rates. These canteens will provide 'Samajwadi Thali' for Rs 10. The aim of this scheme is to end the hunger problem in the state. A helpline number for migrant labourers of the state - '1890 Mazdoor Power Line' -- will also be launched," he

Akhilesh also said that a compensation of Rs 25 lakh would be given to the kin of farmers who lost their lives during farmers' protests and a farmers' memorial would also e set up in the state.

In a unique announcement, the SP manifesto also promises one litre free petrol to all two-wheeler holders in the state every month.

Earlier in Agra on Sunday, the Samajwadi Party president had promised to set up a university named after former Prime Minister Atal Bihari Vajpayee at Bateshwar, whose ancestral village Bateshwar is in Agra district.

Akhilesh also promised to upgrade the Bateshwar Fair to international standard and further improve the condition of ghats and temples there.

He targeted the Bharatiya Janata Party for announcing a university after Atal Bihari Vajpayee in Lucknow, which he claimed had not been implemented till date.

# Bombay HC issues show-cause notice to Malik

Asks him why action should not be taken against him for breaching undetaking

The Bombay High Court on Tuesday issued a showcause notice to Maharashtra Minister and NCP's chief spokesperson Nawab Malik asking him to explain why should not an action be taken against him for breaching undertakings given to the court and for continuing to defame IRS officer Sameer Wankhede for "breaching" his undertakings to the court and continuing to make defamatory statements against IRS officer Sameer Wankhede.

Two months after Malik

filed an affidavit tending an 'unconditional apology" to the Bombay High Court for 'breaching' his undertaking to the court that he would refrain from making statements against Sameer's father Dhyandev Wankhede and his family members, a HC bench of Justices SJ Kathawalla and Milind Jadhav passed an order on a contempt petition filed by Dnyandeo Wankhede, alleging ongoing defamation.

Alluding to Malik's affidavit filed on December 10 wherein he had disputed the veracity of the press conference transcripts, the HC bench said

that the NCP minister should have produced the "correct statements" on record in that

'We are therefore not satisfied with the explanation given by Respondent No 1 (Nawab Malik)," the HC bench said, as it directed the High Court registry to issue the show-cause notice under Rules to Regulate Proceedings for Contempt under Article 215 of the Constitution of India and the Contempt of Court Act 1971. The notice is returnable on February 21.

It may be recalled that in an affidavit filed by him on

December 10,. 2021 in response to an explanation sought from him by the high court on December 7 as to why a contempt of court notice should not be issued against him for deliberately breaching his assurance to the court, Malik had tendered an "unconditional apology" t the same HC bench of Justices Kathawalla and Jadhav for

PM Modi on Monday while addressing the Bijnor rally virtually said that his helicopter couldn't leave due to weather conditions, so he thought of holding the rally

through video conferencing.

West Bengal Chief
Minister said, "History will never forgive those responsible for Hathras, Unnao incidents and bodies dumped in the Ganga in UP during COVID-

Afrom Delhi's RTR Hospital was shot at allegedly by unknown persons while the doctor was standing outside the

hospital building.

According to a senior police official, on Monday night, the doctor was standing outside the hospital building when unknown assailants came in a car and opened fire at him and fled from the spot.

"The incident took place at around 8 PM on Tuesday in Dwarka when Dr Hemant was standing outside near the Emergency department of the hospital when a group of assailants parked their car near the building. They got out and opened fire at him following which one of the bullets hit the jawline of the victim," said the senior police official.

The scheme provides comprehensive personal accident cover of Rs 50 lakh to 22.12 lakh healthcare providers, including community health workers and private health workers, who may have come in direct contact.

The Centre launched the PMGKP scheme on March 30, 2020, for health workers fighting Covid-19.

The scheme provides comprehensive personal accident cover of Rs 50 lakh to 22.12 lakh healthcare providers, including community health workers and private health workers, who may have come in direct contact with and were involved in the care of Covid-19 patients and may be at risk of being impacted by the dis-

plemented all doctors, nurses and other healthcare workers for doing exemplary work during the first, second and third wave of the pandemic.

# New cases continue to decline as India logs 67,597 cases in 24 hrs; death toll up

India is seeing a decline in new Covid-19 cases with 67,597 infections registered on Tuesday. Fatalities, however, have been over 1,000 in the past few days taking the death tally to 5,04,062 cases.

The total cases are reported at 4,23,39,611, while the active cases fell below 10 lakh after around 27 days, the Union Health Ministry said on Tuesday. The active Covid cases have declined to 9,94,891, comprising 2.35 per cent of the total infections. The national recovery rate improved to 96.46 per cent, the Ministry said.

There was a reduction of 1,14,047 cases in the active Covid-19 case count in a span of 24 hours, as per the data. The daily positivity rate was recorded at 5.02 per cent while the weekly positivity rate was recorded at 8.30 per cent, it said. The number of people who have recuperated from Covid surged to 4,08,40,658, while the case fatality rate was recorded at 1.19 per cent, the data showed.

The health ministry stressed that more than 70 per cent of the deaths occurred due to comorbidities.

In the meantime, the government said that more than 5 crore adolescents in the 15-18 age group have been administered the first dose of Covid-19 vaccine in the country while the cumulative Covid-19 vaccine doses administered in the country have exceeded 170.21 crore.

# 49 people convicted, 28 set free

#### 20 explosions shook city on July 26; 56 killed, 200 injured in serial blasts

here on Tuesday convicted 49 persons in the case related to the 2008 Ahmedabad serial blasts which had claimed 56 lives and left over 200 injured.

In his verdict, which came 13 years after the deadly blasts, special judge A R Patel acquitted 28 accused, giving them the benefit of doubt

As many as 20 explosions had ripped through the city on July 26, 2008. The hearing on the quantum of punishment for the convicts will start from Wednesday, the court said. Those who were held guilty included Safdar Nagori, Javed Ahmed and Atikur Rehman.

Among those acquitted were Mohammad Irfan, Nasir Ahmad and Shakeel Ahmed. The 49 were convicted under various sections of the Indian Penal Code, Unlawful Activities (Prevention) Act (UAPA), Explosive Substances Act and the Damage to Public Property Act. One accused was also convicted under the Arms Act.

The accused were convicted under IPC sections 302 (murder), 307 (attempt to murder), 121 (a) (conspiracy to wage war or attempt to wage war against the nation) and 124 (a) (sedition), and section 16(1)(a)(b) of

Ahmedabad: A special court the UAPA which concerns ter-

The convicts can attract a maximum punishment of death or imprisonment for life, and the prosecution will seek capital punishment for some of them, said special public prosecutor Amit Patel.

The prosecution argued before the court -- specially designated to conduct trial in the case -- that the blasts were an act of terrorism, he said, adding that as many as 547 charge sheets were filed and 1,163 witnesses examined.

"Twenty-eight other accused were acquitted by the court giving them the benefit of doubt. Details will be clear from the full judgement which we have not yet gone through,' the prosecutor said. Of 28 acquitted, all but six have one or more other cases pending against them or are already serving sentences in past cases including under the Maharashtra Control of Organized Crime Act and cases investigated by the NIA, Patel

Hence, only six out of 28 acquitted persons will be released from jail, he added. Further, the trial of four other accused who were arrested later has not started and the

prosecution has sought that they be tried jointly, Patel said.

Among those awaiting trial is Yasin Bhatkal, a leader of the terror organization Indian Mujahideen (IM). According to investigation agencies, the IM was involved in a string of bombings across the country including the 2008 Ahmedabad

Of 15 wanted accused, two died in police encounter in Azamgarh in Uttar Pradesh and one died in Kerala. A couple of accused are believed to be hiding in Pakistan.

Three of the acquitted accused were also booked for allegedly digging a tunnel under the Sabarmati jail here in a bid to escape which was foiled by the police in February 2013, Patel said.

The convicts are currently lodged in six jails across India, including 32 in Sabarmati Central Jail in Ahmedabad. Others are lodged in jails at Taloja (near Mumbai), Bengaluru, Jaipur, Gaya and Bhopal, officials said.

All 77 accused who were on trial were presented before

court via video conference on Tuesday. They will remain present in the same way during the hearing on quantum of sentence, prosecutor Patel said. P G Vaghela, one of the investigating officers, said phone calls analysis and human intelligence proved useful in cracking the case.

The trial against 77 accused ended in September 2021. When it began in December 2009, charges had been framed against 78 persons, but one of them turned approver and was granted pardon.

Twenty bombs went off in different areas of Ahmedabad city between 6:32 pm and 7:45 pm on July 26, 2008, killing 56 and injuring 246 others. As many as 29 live bombs were also found in Surat though none of them exploded. The trial was conducted after the court merged all 35 FIRs.

The Gujarat government had transferred the investigation to the Ahmedabad crime branch. Present Gujarat director general of police Ashish Bhatia, who was then joint commissioner of police, had supervised the probe.

A total of nine judges presided over the trial at different times, starting with Bela Trivedi in whose court charges were framed on February 15,

Justice Trivedi is now a Supreme Court judge. Special judge A R Patel who delivered the verdict had taken over the trial from June 14, 2017, prosecutor Patel said. Police had claimed that members of the IM, a radicalized faction of the banned Students Islamic

Movement of India (SIMI), were behind the blasts. IM planned the blasts as a revenge for the 2002 post-Godhra riots in Gujarat in which over a thousand persons, most of them from the Muslim community, had died, as per the investigators.

For survivors, the blasts left permanent physical as well as psychological scars. Yash Vyas was only 10 years old when he suffered severe burn injuries in the blast at a hospital ward in Asarva area.

"I am still suffering from partial hearing impairment because of the explosion. I spent nearly four months in the ICU while my father and elder brother Rohan, who was then 12 years old, died in the I miss them. My mother

and grandmother suffered a lot all these years and our struggle still continues," he said. His father Dushyant Vyas was a lab technician in a cancer medical facility located on the civil hospital campus.

Attacking BJP for the enactment of Citizenship Amendment Act Banerjee said, "they are asking for votes but they should ask for forgiveness for the CAA."The Trinamool Congress chief had on Monday left for Lucknow to address a virtual meeting in support of Samajwdi Party.

Raising the farmers' issue, the Bengal Chief Minister asked whether BJP had any repentance for the farmers' death during farm movement. "Have they asked for forgiveness for the farmers' deaths ... First let them ask for forgiveness for that before asking for votes."

Banerjee who was earlier invited by SP chief Akhilesh Yaday to campaign for his party in UP said that her party would have liked to contest against the BJP bur decided to refrain from doing so because "there is no point in allowing opposition votes to get divided."

To this Congress Lok Sabha leader and Bengal Pradesh Congress president Adhir Chowdhury questioned her "double standards" in Goa and UP."If she knows that division of votes will give BJP a better chance then why the TMC is contesting against the Congress in Goa," the Congress leader asked.

Meanwhile in an unrelated development the infighting continued both in the BJP and TMC over distribution of tickets for the upcoming elections to 108 civic boards if Bengal.

While hundreds of rebel TMC men continued to protest in a dozen of districts the disgruntled BJP workers too protested in Nadia, West Midnapore and other places.

Chennai: The Tamil Nadu Assembly on Tuesday adopted again, the anti-NÉET Bill, returned days ago to the Government by Governor RN Ravi and the ruling DMK and principal opposition AIADMK reaffirmed their opposition to the test based on the Dravidian ideology

Chief Minister M K Stalin labelled NEET a killer exam and said he believed that the Governor would forward without any delay the Bill re-adopted, now to the President for his

"It is the Constitutional duty of the Governor to forward it to the President. I think and expect the Governor to do that duty hereafter at least," he said.

The Bill was passed followed discussions that stretched to 3 hours and the test was vet again dismissed by Stalin as one that went against the principles of Constitution including social justice and equality.

# Kerala HC upholds Centre's ban on Malayalam news channel Media One

**KOCHI:** Justice N Nagaresh of the Kerala High Court on Tuesday upheld the order issued by the Ministry of Information and Broadcasting revoking the license of Media One, a Malavalam news channel owned by Madhyamam Broadcasting Ltd. The channel authorities and the Kerala Union of Working Journalists in a writ petition had sought the dismissal of the Centre's order revoking the license.

Though the order was issued last month, Justice Nagaresh had allowed the channel to continue broadcasting pending reply from the ministry. The judge had asked the ministry to submit in a sealed cover the reasons for

revoking the license of the channel. The Information and Broadcasting Ministry had told the court that the revoking of the license was based on inputs provided by the intelligence agencies to the Union Home Ministry. The Ministry of Home Affairs had passed on the input to the Information and Broadcasting Ministry which in turn revoked the channel's license.

The MIB in a sealed cover had submitted to the court the details provided by the MHA that led it to take the decision. Justice Nagaresh in his order on Tuesday said that a perusal of the intelligence information found that the ministry's denial of license to the company was in tune with the intelligence inputs. "Going through the files, I found that the Ministry has called for intelligence inputs. Based on the intelligence inputs, the committee of officers has found that security clearance should not be given . The Ministry has decided to accept the finding of the Committee of officers. There are inputs justifying the denial of security clearance to the channel. Therefore I am dismissing the writ petition," said the Judge.

Later, the channel authorities said in a release that it was closing down the transmission and would approach a Division Bench challenging the Single Bench order. **PNS**

# **Dole confusion**

The Govt's decision on maternity benefits for the second child, if girl, raises many doubts

ast week, the Union Government said that its maternity benefits programme involving a cash transfer of ₹5,000 to the mother at the birth of her first child will now be extended to cover the birth of the second child, provided that the second child is a girl. The official announcement on February 2 said that the benefits under the Pradhan Mantri Matru Vandana Yojana "for the second child may be provided only if the second child is the girl child to discourage pre-birth sex selection and promote the girl child". It is turning into a controversy with women's rights activists saying the proposal is discriminatory. Under the Yojana, cash of ₹5,000, along with a separate ₹1,000 for institutional delivery, will be given to the mother of the first child. The scheme, under the Ministry of Women and Child Development, aims to ensure a nutritional diet for pregnant mothers and partially compensate them for their wage loss. The objective is to solve the problem of undernourishment and temporary unemployment. Now the Government has to clarify several doubts arising out of the extension of cash benefits to a mother's second pregnancy where the child is a girl. The scheme was originally designed



for the mother to get nutritious food when she is pregnant so that the child is born healthy, too. By what logic can this objective apply to the gender of the second child? Here is a look at the trail of confusion the proposal leads to.

Illegal sex determination tests are even now surreptitiously sought to identify a female foetus. The prospect of a cash incentive for a girl can also be a reason for conducting the sex test. If the foetus is a girl, she will live because of the cash incentive. But what if it is a boy? The question puts orthodox patriarchal families in a quandary. It is a mat-

ter of deciding between having a son for patriarchal reasons and getting extra cash for having a girl. Where the second child is a male, there is no incentive left to try for a girl child in the third instance. But if the second child is a male, the mother is discriminated against as she is ineligible for the cash and neither she nor her child would benefit from nutritious food. The proposal does not also check population growth. For instance, in cases where the first two children are girls, some parents may keep trying for a male child irrespective of incentives. The other issue is, the proposal for extending the incentive to a girl child runs counter to the National Food Security Act, 2013. For, Chapter II of the Act clearly says, "Every pregnant woman and lactating mother shall be entitled to a meal, free of charge....to meet the nutritional standards... (and) maternity benefit of not less than ₹6,000.... It specifies neither the gender of the child nor the number of the pregnancy.

The AIMIM leader should be prudent in accepting Z-category security

here is an unusual kind of soft interaction going on these days between All India Majlis-e-Ittehadul Muslimeen (AIMIM) leader and Lok Sabha MP Asaduddin Owaisi and the BJP-led Union Government. ly and sounding concerned, Shah again requested "Owaisi ji to accept the security to address our concerns about his safety". Owaisi had outright rejected the Government's proposal to provide him Z-category security (with a bulletproof) car. Hours later, the AIMIM leader reiterated that he remained firm on not taking it. This time, quite heroically, he declared: "Owaisi will be safe once the Dalits, the downtrodden and the minorities of this country are safe. I don't like people with arms around me. I am a free bird, I want to live freely."

Interesting to observe, also, is the nonchalance

of Opposition leaders. Except SP chief Akhilesh Yadav and the Telangana Rashtra Samithi's KT Rama Rao, no Opposition leader of any weight has condemned the attack on Owaisi — not the Gandhis, not Mamata Banerjee, Jagan Mohan Reddy, Arvind Kejriwal or any other Chief Minister or party chief. That's despite the fact that the incident gives them a stick to beat the BJP with. Actually, they understand that this arrangement is sometimes a double-edged sword. While it undeniably ups the safety quotient for the protectee, it can also be used to keep a very close eye on him and suffocate him, in a sense. In the same vein, though obviously Owaisi might have been shaken by the February 3 incident, he is wily enough to understand the restrictions that accepting the Government's security would entail. The BJP-led Government has already been accused of illegally using the Israel-manufactured Pegasus spyware to snoop on a host of professionals including politicians, journalists, industrialists and even NGOs. In such a scenario, it's not unfathomable that it could use the official (security) apparatus to ferret out information, plans and strategies about Owaisi's outing in Uttar Pradesh.

# Leave the zeitgeist of Beating Retreat alone ASHOK K MEHTA



A few traditional ceremonies have an old-world charm associated with them. It's not advisable to tinker with these for enhanced visual appeal

obody will deny that the 1,000 dronesempowered son et lumiere was a resounding spectacle to showcase the nation's atma nirbharta programmes and technological triumphs. But its timing, coupling it with Beating Retreat, was terribly wrong and a breach of yet another military tradition. After the buglers had sound-

ed the retreat and the Tricolour brought down at sunset, it was time for the customary ceremony to conclude with the massed bands marching back over the hump fading into the skyline of Rashtrapati Bhavan followed by the President's cavalcade. Surprisingly, instead of North and South Blocks being illuminated thereafter as had been the practice since 1950, a scintillating drone show followed that lasted much longer than the 10 minutes advertised. No one will deny that its visual richness was stunning but darkness had set in, exposing the President, Prime Minister and other VIPs to risk. Beating Retreat got overshadowed, not complemented, by the ill-timed show and a legacy tradition violated. No one has ventured to point out that once the Retreat is played, it's time to shut shop for tomorrow, which will be heralded by sounding another bugle call: Reveille.

Beating Retreat is an English tradition signalling the end of combat for the day, bringing down the ensign, muzzling guns, putting swords back into sheaths and scabbards on bayonets. It was also used to call back patrols to the castles and, in the case of the Dutch, to stop serving beer. In Indian military units throughout the country, when Retreat is sounded at sunset, soldiers outside their barracks spring to attention, cease working and return to quarters. A soldier's day begins with reveille at sunrise with various bugle calls during the day signalling different events marking the soldier's routine.

For 70 years, Beating Retreat marked the sombre end to Republic Day celebrations. It was never followed by another event; in this case, a drone show-cumprojection mapping, which was a breach of tradition. Instead of

a 15-minute truncated soundand-light show at the end of Beating Retreat, a longer and more comprehensive drone display can be organised at the same venue next day. If coupling the visual spectacle with Beating Retreat passes away as Indianising the event, I have nothing to say. But for diehard veterans, it was an erosion of a traditional military custom symbolised by the flag, bugles and dusk announcing its end.

In the past, the organisers have tampered with songs and music in order to Indianise the ceremony. The Pipes and Drums bands are essentially tuned for Scottish musical scores and don't adapt easily to foreign renditions. Yet, İndian military maestros have succeeded in adapting them, especially to hill songs from the Himalayan region. The highly exaggerated swaying of bagpipers has gone a sway too far and requires the swagger to be moderated. The brass band is more amenable to playing Indian tunes but regrettably very few Indian marching tunes (except for Kadam kadam badhaye ja; Saare jahaan se achcha and Jai Bharati) are recognisable. The first and second tunes herald the arrival and departure of the bands over the hump. Our bands have excelled with dis-

plays by trumpets, drums and bugles and shown their rich repertoire. Once tablas and another time the sarod were attempted to synergise with marching music but they proved a big failure of fusion. The last Beating Retreat consisted for the first time of all 26 marching tunes being Indian though, except for two, none other was familiar. Doordarshan neither mentioned the name of songs nor displayed them on the scroll. The interminable debate over dropping the last foreign composition, Mahatma Gandhi's favourite hymn Abide with me, for Mere watan ke logon was necessary. The choice of the replacement song, no matter how moving, harks back to the humiliating defeat of 1962. Instead, Vaishnav jana to tene kahiye, another Mahatma Gandhi favourite, could have been chosen to eternalise Bapu's memory who is the leit motif of commemorations. The bands performed to perfection though the new Indian tunes will take time to become familiar. A first and aptly demonstrating jointness was the Navy, not the senior service Army, bringing down the Tricolor and wrapping it up. Next time, this ceremony can

gration underway of the armed forces.

TV channels must be forbidden from giving ball-byball commentary by military experts and their anchors stopped from competing with each other to show off their military vocabulary. This jarring intervention has gone on for too long. Doordarshan should orchestrate the Republic Day celebrations with competent professionals. The MoD should call up senior veterans as advisors for the military component of the celebrations. They could have forged a consensus over fusion of martyrs' flames, suitable national hero for the canopy and choice of gutsy marching music. Remember, Beating Retreat ceremony is essentially a musical tribute to India's martyrs. In 2003, the Delhi Government brought together Amjad Ali Khan and Ustad Bismillah Khan (Bharat Ratna) to remember the Unknown Soldier as part of Republic Day celebrations at a separate event. Indianising military traditions is a delicate process; handle with care.

#### **EVS MAY GET CHEAPER FROM APRIL**

Sir — The rising petrol and diesel prices have plagued citizens and the vehicles using these fuels also cause pollution. Therefore, the Union Government has now adopted a policy of promoting electric vehicles. According to the policy, these vehicles will be cheaper by about 30 per cent from April. The battery swapping policy has been announced in the Budget as per the policy announced by the Union Government on February 1. So, of course, the hassle of charging an electric battery is going to be less. The battery swapping policy will be implemented considering the space constraints for setting up charg-

ing stations in urban areas. Electric vehicle owners will be able to rent a battery from any authorised company with a certain amount as security deposit. This will save battery maintenance cost and charging time and benefit the private sector. About 30-40 per cent of an electric vehicle cost is spent on batteries only. Apart from this, maximum discounts will also be given to EV buyers. The Centre proposes to reduce GST on batteries and their services from 18 per cent to 5 per cent. Overall, these vehicles are expected to become cheaper so they can become an affordable alternative.

# **FIRST COLUMN ART IN THE TIME OF THE PANDEMIC**

There's the question: Have we entered a new era of artistic expression?

Inat does the pandemic mean for an artist in India today?'Survive, evolve, and thrive' has been the mantra of the last few years, and never has it been more evident than in the world of art. Given the expansive nature of the creative spectrum in India, the art industry has painstakingly tried to build and create an ecosystem that nurtured talent and inspiration. From galleries, studios, creators, curators, and the likes, recognition has always been the ultimate goal and an arduous task at that. The 'starving artist' was never just a moniker, but a written description of the economic uncertainty and challenging circumstances that come with being an artist. So when the pandemic arrived in all its disruptive glory - the art world was shaken and forced yet again to refocus and rebuild. In the face of adversity and these challenging times, grit and agility were the need of the



hour, and artists, as well as the art community, rose to the occasion. But in this new normal, what could artists look forward to? Going digital was no longer an option but a means of self-preservation. And while the beginning of this change seemed uncomfortable, what it did do was, introduce unique opportunities for the art community to interact, collaborate and create in newer, more engaging ways. Institutions, organizations, and gallerists have now turned to virtual galleries to spotlight new and upcoming talent, while artists use social media as a launchpad to present new collections. For artists that use performance as a form of expression, hybrid models that combines a physical stage with a virtual audience have helped in keeping the art alive and thriving. The digital debut of the critically acclaimed play Sea Wall by Simon Stephens, starring Jim Sarbh, proves just that. In fact, the digital revolution has broken down geographical boundaries and has given Indian artists the opportunity to present their work on a more global scale. The series of digital initiatives launched by the Serendipity Arts Foundation in 2020 are perfect examples of this shift and evolution. Furthermore, the pandemic has changed the narrative of expression and served almost as an inspiration to create for a lot of artists. Take, for example, Mumbai-based artist, Dhruvi Acharya who found solace in creating a series of watercolor on paper paintings that depicted the tremendous struggles of migrant workers, medics, and people in general, during the pandemic. In fact, this new normal even gave local artists an opportunity to showcase their skill and talent. Delhi's first street art gallery in the Lodhi Art District which was reserved and intended for international graffiti artists now adorns pandemic-themed murals created by local talent. Thus, raising the question, have we entered a new era of artistic expression?

With that said there are still a lot of development and preventive measures that need to be ushered in, in order to try and alleviate the impact of unforeseen events like COVID-19 on India's artists. India's creative economy continues to be significantly fragmented and while digital communities like the ArtX Company or C3 are working to bring some semblance of order, there needs to be an overall framework in place to support India's artistic community. The pandemic presented an almost dichotomous proposal to artists in India. It brought inconceivable havoc while also posing as a catalyst of incredible change and opportunity. On the one hand, artists had to face the loss of a sense of home, with galleries, studios, and theatres being shut down, but on the other, the digital realm opened up new possibilities, presented a gateway to a wider audience, and even in some instances 'inspired'.

Local needs generate curiosity among students. That needs to be sustained by Government efforts to result in scientific innovation

Tcience progresses not through our research institutions alone but through the success of innovations made by a layman without having any scientific knowledge. The best innovations come from our rural folk who live with nature. It is the need and necessity that generate curiosity in the minds of humans. This curiosity, in turn, triggers his response to tide over adverse situations. Our scientists who sit within the four walls of research institutions rarely follow nature's clues to identify a scientific problem. They usually depend on published research papers to locate a problem.

Most of them rarely accept anything that is not published in scientific journals or think out of the box. There will not be any precedence to do work in that area in such instances. That means there will not be any reference material to start the work. Science survives only through innovations; for that, our scientists should come out of the lab and see the problems that affect society. They have to work to find a solution

Students, especially school children, have good observation power, and they continually formulate questions in their minds. Often, they ask these questions, often treated as absurd questions, to their teachers. There are only very few teachers in our education system who entertains such nasty questions from students. It's these questions that awaken the pursuit of innovation among the students. To promote such innovations from our curious minds, the Department of Science & Technology (DST), Government of India has started the 'Innovation in Science Pursuit for Inspired Research' (INSPIRE) Awards - MANAK (Million Minds Augmenting National Aspirations and Knowledge).

DST is executing this awardthrough National Innovation Foundation - India (NIF), an autonomous body of DST, which aims to motivate students of classes 6 to 10. This award scheme aims to target one million original ideas/innovations rooted in science and societal applications to foster a culture of creativity and innovative thinking among school children. Under this scheme, schools can nominate the five best original ideas/innovations of students. The top 1,00,000 ideas received that can address societal needs through Science & Technology are shortlisted by NIE. The shortlisted students will get INSPIRE Award of INR 10,000.

It is always an inspiration to go through the paths taken by our young researchers. How have they identified a problem? How do they pursue the work despite difficulties? What are the challenges they faced? How their parents and teachers support them? All these can have bearer on the

next-generation innovators. These questions that crept into the mind of our young innovators are answered through the programme Vigyanveer. It is a popular science programme telecaston the

panels.

Another student M.Abhishek, from Telangana, made a machine that can be used to fill grains in sacks effort. This unique innovation saves the farmers' time and reduces the labour involved in loading the grain. Vandana Kumari, a student of Mahuakheda village of Etah, Uttar Pradesh, made a unique device to solve her father's troubles in plucking fruits from trees full of thorns.

Microscope holds a vital role in understanding fundamental biological concepts in science education. Even though children from citybred schools are fortunate to have the hands-on experience, many schools in rural regions of the country don't have many laboratory facilities. When Ananya Singh realized that many students don't have a facility like a microscope for their studies, she developed a lowcost microscope from waste plastic bottles. She named this as 'Plastoscope', which is low cost and can be easily carried in a school bag.

Managing a house is a tedious task for our homemakers. For helping his mother, Shailendra from Udaipur, Rajasthan, has developed an automatic device to help her mother clean the house.

Similarly, Dharmendra Yadav, a student living in the Seoni district of Madhya Pradesh, created a unique movable toilet after seeing the difficulties of his grandmother. Vibha, a student from Karnataka, developed a fantastic innovation that will reduce fuel consumption in the kitchen and reduce the cooking time. Navshri Thakur, a student of Hoshangabad, Madhya Pradesh, designed a unique machine to ease her mother's trouble in the kitchen. This machine can do many tasks in the kitchen together, and it does not even require electricity to run.

Manual scavenging is an inhuman attitude prevailing in our sociour community are cleaning the public toilets without any safety measures. Sulochana Kakodia, a student from a tribal-dominated area of Chhindwara in Madhya Pradesh named Gummach Khamaria, took the problem of manual toilet cleaning as her inspiration and made a machine that can clean the toilet without touching hands. Similarly, Ayush, a student from Bangalore, discovered a unique way to prevent accidents due to open manholes.

Many people are living with disabilities. To support such 'divyagyan,' students have developed innovative technologies. K Sreeja, a student of Godavarikhani, Telangana, has made such a unique cap and stick that can bring a new ray of hope to the lives of blind people. Mainuddin, living in the Gonda district of Uttar Pradesh, has developed a leg-controlled computer mouse that will make disabled people work with a computer. Similarly, Madhav Lavakare, a Delhi student, understands the pain of deaf people and invented smart glasses. With the help of Transcribe Glass, deaf people can easily understand what a person is saying in front of

Safety issues of women and older people are always a matter of concern. Siddhi Pandey, a student living in Dhamtari, Chhattisgarh, has created a device to solve the problem of molestation. This device will surprise the maniacs who harass women and bring them to the ground by giving them an electric shock. Parv Kapoor, a student living in Bareilly, Uttar Pradesh, saw his grandfather's troubles and significantly made a digital security alarm watch to help the elderly.

It is heartening to notice that our young minds have touched zen of our country encounters in their daily life. The vast area of their research shows that India indeed has big brains for the future. Their only satisfaction is that they have developed something for the society, something for the nation. This is evident from their smiling faces. The instincts create curiosity in these young people, and we need to carry forward these basic scientific instincts to build a self-reliant country.

Rahul Gandhi perhaps realizes this, which is why he has been talking of a difference between Hindutva

# **Macron tries to defuse Ukraine** crisis; no breakthrough so far

 $F^{\mathrm{rench\ President\ Emmanuel}}_{\mathrm{Macron\ brought\ his\ diplo-}}$ matic effort to defuse the crisis over Ukraine to its capital of Kyiv on Tuesday, a day after hours of talks with Russian President Vladimir Putin yielded no apparent breakthrough. Macron met with

Ukrainian President Volodymyr Zelenskyy as fears of a possible Russian invasion mount. Moscow has massed over 100,000 troops near Ukraine's borders, but insists it has no plans to attack.

The Kremlin wants guarantees from the West that NATO will not accept Ukraine and other former Soviet nations as members, that it halt weapon deployments there and roll back its forces from Eastern Europe — demands the U.S. and NATO reject as non-

Western leaders in recent weeks have engaged in multiple rounds of diplomacy in the hope of de-escalating the tensions and preventing an attack. High-level talks have taken place against the backdrop of military drills in Russia and Belarus. On Tuesday, Russia's Defense Ministry said six large landing ships were moving

from the Mediterranean to the Black Sea for exercises.Macron's talks with Putin on Monday

challenge NATO's core principles, like shutting the door to Ukraine or other countries that lasted more than five hours, and the French leader told reporters that they allowed him to ensure that "there's no degradation and no (further) escalation." He said he did not expect Putin to make any "gestures", saying his objective was to "prevent an escalation and open new perspectives. ... That objective is

Macron said Putin "set a collective trap" when he initiated the exchange of written documents with the U.S. Moscow submitted its demands to Washington in the form of draft agreements that were released to the public, and insisted on a written response, which was leaked to the press. cy, there was never a crisis that has been settled by exchanges of letters which are to be made public afterward," he said, adding that is why he decided to travel to Moscow for direct

Putin said after the meeting that the U.S. and NATO ignored Moscow's demands, but signaled his readiness to continue talking. NATO, U.S. and European leaders flatly reject the demands that they say

might seek membership; but they have offered to talk about other Russian security concerns in Europe.

Putin warned that Ukraine membership in NATO could trigger a war between Russia and the alliance should Kyiv move to retake the Crimean Peninsula, which Moscow annexed in 2014. In that case, he said, European countries would be drawn into a military conflict with Russia where "there will be no winners."

U.S. President Joe Biden has said that any prospect of Ukraine entering NATO "in the near term is not very likely," but he and other NATO member nations and NATO itself refuse to rule out Ukraine's entry into the alliance at a future date.Biden met in Washington on Monday with German Chancellor Olaf Scholz, who also will travel to Kyiv and Moscow on Feb. 14-15.

### **Biden threatens: No** gas pipeline if Russia invades Ukraine

n a flurry of diplomacy across Ltwo continents, President Joe Biden met with Germany's new leader Monday and vowed the crucial Nord Stream 2 Russia-to-Germany gas pipeline will be blocked if Russia further invades Ukraine.

Russia's Vladimir Putin retorted that the U.S. And its allies are the only ones talking invasion. Putin and French

Emmanuel Macron met for more than five hours in Moscow at the same time Biden and German Chancellor Olaf Scholz spoke at the White House in efforts to defuse the crisis before armed conflict breaks out. Russia has massed thousands of troops at the Ukraine border, adding military might almost daily.

The White House has expressed increasing alarm about the prospects of war, and Biden has been looking to solidify support among

European allies for economyjarring sanctions against Russia if it attacks."If Russia invades, that means tanks and troops crossing the border of Ukraine again, then there will be no longer a Nord Stream 2," Biden said. "We will bring an end to it." That would hurt Russia economically but also cause supply problems for Germany.

Construction of the ipeline has been completed, but it is not yet operating. "We are jointly ready, and all of NATO is ready," Biden said, referring to the powerful Western alliance, though Ukraine is not a member.

While Biden reiterated with certitude that the pipeline would not move forward, Scholz stressed the need to keep some ambiguity about sanctions in order to press Russia to de-escalate the crisis."It's necessary for Russia to understand that a lot more could happen than they've perhaps calculated with themselves,." Scholz said.

# Mauritius presses claim versus UK for Indian Ocean islands

A delegation from Mauritius is set to sail Tuesday to the Chagos Islands to press the country's claim for the strategically important Indian Ocean archipelago, which is also claimed by Britain and is home to an American military base.

It is the first time Mauritius has embarked upon an expedition to the islands without seeking the permission of the United Kingdom, Prime Minister Pravind Jugnauth said in a statement, adding it is a "concrete step" in "exercising its sovereignty and sovereign rights in relation to the Chagos Archipelago."

Those rights were strengthened in 2019 by a non-binding opinion from the International Criminal Court, which said that Britain had unlawfully carved up Mauritius, an archipelago nation whose main island is some 2,000 kilometers (1,200 miles) off the southeast coast of Africa.

The Chagos islands were a part of Mauritius until Britain separated them a few years before Mauritius became independent from British colonial rule in 1968.The United Nations General Assembly followed that opinion with a resolution two months later demanding that Britain end its "colonial administration" of the Chagos Islands, which

include U.S. military base on Diego Garcia, and return them to Mauritius. Even Pope Francis weighed in, saying that Britain should obey the U.N.

Thus far, however, Britain, which calls archipelago a British Indian Ocean Territory," has refused to abide by non-binding decisions. It has argued that Chagos archipelago has been under its sovereignty since 1814 and that its continued presence there is strategically important. Britain's Foreign Office did not immediately respond to requests for comment on current expedition. In his statement, Jugnauth recalled ICJ ruling and said that

"continued administration of the Chagos archipelago by the United Kingdom constituted a wrongful act." His office did not immediately respond to an email seeking further com-

Jugnauth has repeatedly said that ending British administration, however, would have no implications for the U.S. military base at Diego Garcia, which he has said Mauritius is committed to maintaining.

Britain sealed a deal in

1966 allowing U.S. to use Diego Garcia for defense purposes. The United States maintains a base there for aircraft and ships and has backed Britain in legal dispute with Mauritius.

Dmitry Polyansky, who chaired meeting, said many sanctions regimes interfere with plans for state-building and economic development, pointing to Central African Republic and Sudan and calling measures on Guinea Bissau "anachronistic." The Security Council needs

"to take greater heed of what authorities of states under sanctions think" and be more realistic in setting benchmarks to lift them to make sure they don't turn into "a mission impossible," he said. U.S. Ambassador Linda

Thomas-Greenfield countered that sanctions are "a potent tool" that "make it harder for terrorists to raise funds via international financial systems, and have slowed development of "certain capabilities" in North Korea's nuclear and ballistic missile programs. Sanctions also "constrain resources of processes, threaten UN peacekeepers, commit atrocities, and tance," she said.

### **White House: Top** scientist resigns over treatment of staff

**AP W**ASHINGTON

President Joe Biden's top science adviser Eric Lander resigned, hours after the White House confirmed that an internal investigation found credible evidence that he mistreated his staff, marking the first Cabinet-level departure of the Biden administration.

An internal review last year, prompted by a workplace complaint, found evidence that Lander, the director of the Office of Science and Technology Policy and science adviser to Biden, bullied staffers and treated them disrespectfully.
The White House rebuked

Lander over his interactions with his staff, but initially signaled Monday that he would be allowed to remain on the job, despite Biden's Inauguration Day assertion decency" from all who worked for his administration and would fire anyone who shows

disrespect to others "on the spot." But later Monday evening, press secretary Jen Psaki said Biden had accepted Lander's resignation with "gratitude for his work at OTSP on the pandemic, the Cancer Moonshot, climate change, and other key priorities."

Lander, in his resignation letter, said, "I am devastated that I caused hurt to past and present colleagues by the way in which I have spoken to them." I believe it is not possible to continue effectively in my role, and the work of this office is far too important to be hindered," he added.

The White House said Biden did not request Lander's resignation. Earlier Monday, Psaki said senior administration officials had met with Lander about his actions and management of the office, but indicated he would be allowed administration was following a "process" to handle workplace complaints.

### UN: 13 million people face severe hunger in Horn of Africa

AP KAMPALA, UGANDA

Drought conditions have left an estimated 13 million people facing severe hunger in the Horn of Africa, according to the United Nations World Food Program. People in a region includ-

ing Somalia, Ethiopia and Kenya face the driest conditions recorded since 1981, the agency reported Tuesday, calling for immediate assistance to forestall a major humanitarian Drought conditions are

affecting pastoral and farming communities across southern and south-eastern Ethiopia, south-eastern and northern Kenya, and south-central Somalia. Malnutrition rates are high in the region.

WFP said it needs \$327 needs of 4.5 million people over the next six months and help communities become more resilient to extreme climate

"Three consecutive failed rainy seasons have decimated crops and caused abnormally high livestock deaths," it said in a statement. "Shortages of water and pasture are forcing families from their homes and leading to increased conflict between communities."

# **China locks down** southern city as omicron surges

hina has ordered inhabitants of the southern city of Baise to stay home and suspended transportation links amid a surge in COVID-19 cases at least partly linked to the omicron variant. Classes have been sus-

pended, non-essential businesses closed and mass testing of residents ordered. Restaurants are only permitted to serve take-out. Traffic lights have been switched to red only to remind drivers to stay home. As of Tuesday, 135 cases

had been reported in the city at least two of them found to be omicron, health authorities said. The city has become the latest to be placed under lockdown in keeping with China's "zero-tolerance" approach to the pandemic. requires strict measures be applied even when only a small number of cases have been found.

A major concern is preventing outbreaks during the ongoing Beijing Winter Olympic Games. No new cases were reported in the Chinese capital on Tuesday.More than 30 athletes at the Beijing Olympics are in isolation facilities after testing positive for the coronavirus, organizers said

Tuesday. The average stay in isolation is seven days. Baise has an urban population of about 1.4 million, with another 3 million in the large surrounding rural area that abuts the Vietnamese border.

State media reported customs clearance at crossing points of Longbang and Pingmeng were delayed, causing further disruptions to cross-border trade that have already inflicted major losses on Vietnamese fruit farmers who rely on the Chinese market for much of their revenue.

The first cases in Baise were reported Saturday at the tail end of Lunar New Year holiday, when many Chinese travel vast distances to their hometowns. For third year running, the government asked people to remain in place to avoid a calls had only a slight effect on numbers of trips taken.

Despite occasional regional outbreak, China has largely brought pandemic under control through lockdowns, mass testing, case tracing, mask mandates and other strict measures. Almost 85% of population is fully vaccinated, according to Our World in Data, although questions have been raised about efficacy of Chinese vaccines, particularly against omicron strain.

# **Can't have a situation** where market is India but jobs are in China

**New Delhi:** Making it clear that relaxations will not be provided to US-based electric vehicles major Tesla unless it participates in manufacturing activities in India, Union Minister Krishan Pal Gurjar on Tuesday said there cannot be a situation where the market is India but jobs are cre-

The minister of state for heavy industries also told the Lok Sabha during Question Hour that the company is yet to apply for schemes as per the government's policy.

Last year, the Elon Musk-led company sought a reduction in import duties on electric vehicles (EVs) in India but the Ministry of Heavy Industries asked the firm to start manufacturing its iconic EVs in the country before any tax concessions can be considered.

Gurjar said the government has Production Linked Incentives for automobile and auto components as well as for manufacturing Advanced Chemistry Cell (ACC) battery. Both schemes are open for domestic as well as foreign entities.

Responding to a query on Tesla, the minister said "the company wants workers from

in Modi Government... Our Government's policv is that if india market is to be used, job opportunities will have to be given to Indians.'

The minister's reply came in response to a question by Congress member K Suresh on whether the government would invite Tesla to enter the Indian market and steps being taken to promote mass production of electric vehicles in the country.

"Want to ask the member if they want india's money to go to China? That company has not applied as per our policy. For that (company), doors of India are open, they can come apply as per policy, set up company, give jobs to our people, increase government revenue," the minister said. "Modiji ki sarkar mein ye nahi ho sakta ki rozgar Cheen ko aur market Bharat ki... Modiji sarkar ki neeti hai ki agar market Bharat ki hai, rozgar bhi Bharat ke logon ko milega.... (Under Modi government, it cannot happen that jobs are in China while market is India... The government's policy is that if the market is India, then peope in India should get jobs)," Gurjar said.

# Markets snap 3-day losing streak; RIL leads rebound

Mumbai: Snapping their threeday losing run, market bench-marks ticked higher after a seesaw session on Tuesday on fag-end buying in energy, metal and finance counters amid a firm trend in global markets.

Covering-up of short positions by bears also supported the late recovery in stocks, traders said.

After swinging between gains and losses, the 30-share BSE Sensex finally closed 187.39 points or 0.33 per cent higher at 57,808.58. Similarly, the broader NSE Nifty climbed 53.15 points or 0.31 per cent to 17,266.75

Tata Steel topped the Sensex gainers' chart with a jump of 3.10 per cent, followed by Bajaj Finance, Bajaj Finserv, Reliance Industries, Titan, Asian Paints and Axis Bank.

In contrast, PowerGrid, TCS, UltraTech Cement, Tech Mahindra, Kotak Bank, L&T and HDFC twins were among the losers, shedding as much as 1.66 per cent. Sensex constituents, 19 shares

closed higher while 11 were in the red.

"Indian equities were highly volatile today, swaying between gains and losses while managing to close on a positive note. Selling pressure from FIIs was countered by bargain hunting by domestic investors.

"European shares advanced over ECB President's comments stating that there are lower chances of a measurable tightening of monetary policy, which helped in comforting global investors," said Vinod Nair, Head of Research at Geojit Financial Services.

Meanwhile, the Reserve Bank's rate-setting panel began its three-day deliberations on Tuesday to decide the next monetary policy in the backdrop of Budget 2022-23, inflationary concerns and evolving geopolitical situation.

S Ranganathan, Head of Research at LKP Securities, said, "As policymakers face one of the fastest pace of price increases in the developed markets, global stock markets are facing a challenge in pricing the likely actions by central bankers."

#### Rupee weakens 5 paise to 74.74 a dollar

**Mumbai:** The rupee edged lower by 5 paise to close at 74.74 against the US dollar on Tuesday as stronger greenback, elevated crude oil prices and foreign fund ouflows weighed on forex market sentiment.

At the interbank foreign exchange, the rupee opened at 74.65 a dollar and later touched an intra-day high of 74.57 and a low of 74.80. The local unit finally ended the day at 74.74, down 5 paise from the previous close.

In the previous session on Friday, the rupee had settled at 74.69 against the greenback.

The forex market was closed on Monday as Maharashtra had declared February 7 as public holiday to mourn the demise of legendary singer Lata Mangeshkar.

### Domestic air passenger traffic falls 43 pc to 64 lakh in January: Icra

Mumbai: Domestic air passenger traffic plunged around 43 per cent month-on-month at 64 lakh in January 2022 as the third wave of the pandemic and the resultant restrictions by State Governments kept flyers away from air travel, Icra said on Tuesday.

The domestic passenger volume in December 2021 was recorded at 112 lakh.

The rating agency said it is expecting the recovery process to remain subdued during March quarter and that the jet fuel prices continue to be a drag on the sector. The passenger traffic declined 17 per cent last month over 77 lakh passengers transported by domestic airlines on local routes in January 2021, Icra said.

Also, airlines deployed 7 per cent lower capacity in January 2022, which saw 62,979 departures against 67,877 departures recorded in the corresponding month of 2021, it said, noting that on a sequential basis, the number of departures in January was lower 27 per cent due to emergence of new

The sequential recovery slumped in January 2022 with emergence of the new variant (Omicron) and related restrictions impacting the leisure travel segment along with existing subdued demand from the corporate traveller segment, said Suprio Banerjee, Vice President & Sector Head, Icra.

The same is also reflected as passenger traffic during April-January period of 2021-22 remained around 45 per cent lower than the period year earlier, he stated.

The emergence of the new COVID variant and reactionary air travel restrictions will keep the recovery prospects subdued for the domestic airlines sector in the current quar-

# CUCET to provide equitable opportunity

With DU and JNU confirmed to be a part of CUCET, admission to most of the central universities through a common entrance test seems to be a reality now. A common entrance for all the universities will put a rest to ever-increasing cut-offs (like DU) and may improve the chances of regional language aspirants as well as it is expected to be conducted in a minimum of 13 scheduled languages. The idea

at the undergraduate level is to shift the focus more on developing the critical thinking ability of the students rather than going for

rote learning. Universities Central Common Entrance Test (CUCET), advocated under the National Education Policy 2020 is not a new concept. It was first conducted for admission in 7 central universities for 1,500 seats in undergraduate, postgraduate & integrated courses in 2010. Till

the academic year 2021-22, 12 Central Universities like Assam University, University of Karnataka, University of Kerala, University of Haryana, to name a few, already took admissions through CUCET. The National Testing Agency (NTA) has been assigned the task to conduct the CUCET and as per the report, this may be conducted twice a year from the academic year

022-23 like the JEE entrance test. "UGC has directed all 45 centralized universities to take appro-

priate measures for the CUCET from the academic session 2022-2023, & efforts are ongoing at these academic institutions to implement the computer-based exam that is likely to happen in June. The exam is most likely to be divided into two segments- the first one focusing on the general aptitude of the students and the second one may be on the specific subject domain, for which the students are seeking admissions, says Mk Yadav, CMD, AI

India's top-order batter Smriti Mandhana has risen two places, to fifth, while captain Mithali Raj continues to hold on to her second position in the latest Women's ODI Player Rankings Batters

Mandhana, on 710 points, has displaced South Africa's Lizelle Lee (702) and England's Tammy Beaumont (696) in the ranking, which is led by Australia's Alyssa Healy (742 points).

Meanwhile, dominant perfor-

mances in the first two ODIs of the Women's Ashes have seen several Australian players climb the charts in ODI Player Rankings. Having dropped to the second spot after the series against India in September 2021, Australia all-rounder Ellyse Perry is back at the top of the



Women's ODI Player Rankings for All-rounders with 407 points. India's Deepti Sharma is fourth with 299

Perry was the 'Player of the Match' in the second ODI, first returning figures of 3/12 to reduce England to 129 all out, before scoring a 40 off 64 balls to take Australia close to victory. Perry also made huge gains in the bowlers' rankings, rising seven spots to break into the top-10 and occupying the No.9 spot.

There hasn't been much for England to cheer about in the ODI leg of the Ashes but Katherine Brunt's all-round brilliance in the first ODI, where she finished with 3/12 and scored 32 not out, sees her gain three spots to No.5 in the allrounders' rankings. Brunt also jumped a spot to No.6 in the bowlers'

Despite England ending up on the losing side in the first two ODIs, Sophie Ecclestone bowled economically and jumped to third with a career-best 717 rating points in the ODI Player Rankings for Bowlers, which has India's Jhulan Goswami in second spot.

Perry's teammate Beth Mooney too climbed the charts for batters, rising five places to occupy the third spot behind Mithali Raj after a Player-of-the-Match-winning 73 in the first ODI of the series.

Tahlia McGrath played a crucial role in Australia sealing the ODI series in the first two ODI, with 48 runs and five wickets. Her strong showing reflected across all three departments in the rankings, where she rose six spots to No.41 for batters, a massive 32 spots to No.52 to bowlers and 20 spots to No. 31 for

The recently-concluded ODI series between South Africa and West Indies also caused some movement in the latest ICC Rankings. West Indies, who were 1-0 down after the first two ODIs, won the final two matches to take the series 2-1.

Young all-rounder Sutherland led the way with 4/31 at Junction Oval as England were bowled out for a paltry 163, before contributions from all the top-four batters ensured Australia cruised home with more than 13 overs to spare. The win means Australia finished the multi-format series without a loss and England lost debutant Emma Lamb (0) and skipper Heather Knight (9) inside the first hour to slump to 19/2 in nine overs. The experienced duo of Tammy Beaumont (50) and Nat Sciver (46) combined to put on an 88-run stand but were extremely cautious in their approach. They couldn't find a single boundary between overs 18-30, and the pressure of scoring big eventually got to both the batters as they fell in a span of five overs. Thereafter, it all went downhill for the visitors. Attacking batter Danni Wyatt (9) was Sutherland's first victim and the wickets continued to fall in quick succession as England lost their last seven wickets for just 39 runs to be dismissed midway through their final over for 163.

While the England batters looked to avoid damage, Australia threw caution to the wind from the start, with openers Alyssa Healy and Rachael Haynes adding 47 runs in the powerplay. Freya Davies was the only England bowler who looked like taking a wicket and eventually did, breaking the strong opening stand for 74 by dismissing Healy (42).

Sophie Ecclestone made it two in two overs as she got rid of the other set batter, Haynes, for 31. After the slight setback, skipper Meg Lanning and Ellyse Perry ensured Australia got through to an easy win. Lanning played the aggressor, smashing seven fours and a six en
