# 'Dynasty kills democracy'

# PM: It does not allow new talent to flow into politics

PNS NEW DELHI

On the eve of the first phase of Uttar Pradesh (UP) Assembly elections, Prime Minister Narendra Modi on Wednesday slammed "family dynasties" and lashed out at the Samajwadi Party (SP) for "perpetuating family rule" in the State and asserted that the BJP will again triumph in UP.

In a televised interview to ANI, Prime Minister Modi said the BJP has changed "the old theory of ek baar aao ek baar jao" and through its work created "pro-incumbency" in whichever State it ruled. He claimed that the BJP will win in all five poll-bound States.

Hitting-out at dynasties in the country be it in "Punjab, Haryana, UP, Jharkhand, Tamil Nadu", the Prime Minister said "It did not allow new talent to flow into politics and posed the biggest danger to democracy

and is its biggest enemy."

Taking on the SP-RLD alliance led by Akhilesh Yadav and Jayant Chaudhary, the PM said the BJP had trounced the "two boys" in the last Assembly polls too."Do Ladkon wala khel



pale bhi dekha tha.. ", he announced saying "itna ahankar tha, Gujarat ke do gadhe kaha tha...", Modi said and went on to say that "janta ne sabak sikhaya jab bua bhi thi.. ", a reference to BSP leader Mayawati.

Modi went hammer and tong at the SP saying, "SP ka Samajwadi Puri Tarah parivarvad hain" and sought on the SP saying and sought of the SP sayi know whether socialists Ram Manohar Lohia, George Fernandes or Nitish Kumar had a "parivar."

He said 45 members of the family (Mulayam and Akhilesh Yadav) are in prominence in the SP and said he was told that all in the age group of 25 are contesting elections.

"Such parivarvad is dangerous to democracy ..there is no dynamics only dynasty", Modi said. "Beta kaisa bhi ho, adhyaksh ladka hi banega...", he said. He also pointed out dynasty rule in Jammu and Kashmir.

Asked about BJP too having family members in politics, Modi said in the BJP just a few people (from family) go to

politics but elsewhere "dynasty

Modi said for a larger part of the period since Independence the Congress ruled the country and set it on the destructive path that his party will not allow for a long

Asked since he is given credit for the poll victory, does he also take responsibility for defeats, Modi replied saying, The BJP has seen many defeats...we learn from every election.. each election is a new university...it is our educational field.

Modi heaped praise on UP CM Yogi Adityanath saying the SP is also wanting to take credit for his work in the State. He refuted that Central

Taking a jibe at Congress leader Rahul Gandhi over his criticism of the Government in Parliament, Modi on Wednesday said he cannot reply to a "person who does not listen and does not sit in the

On Rahul Gandhi's questions on unemployment and the India-China issue, Modi said, "I have given facts on every subject and spoken on every subject on the basis of facts. On some subjects, our External Affairs Ministry and Defence Ministry have given detailed answers and wherever it was necessary, I had also spoken. How do I reply to a person who does not listen, and does not sit in the House?"

Modi said his Government believes in dialogue and does not attack anyone.
"We don't attack anyone,

instead we believe in holding dialogue. At times, there are debates (vaad-vivaad), interruptions (toka-taki) (in Parliament), I welcome this and that is why I don't have any reason to be miffed (on these subjects)," Modi said.

In his first comment on Lakhimpur Kheri violence, Modi said the UP Government was working in a transparent manner and gave its consent for whatever committee Supreme Court wanted to form.
On Rahul Gandhi's

remarks that he didn't need a certificate for his great grand-father from anyone and the PM is scared of the Congress, Modi said, "I did not speak against anyone's father/grandfather. I said what a former PM had

said, it's the right of the nation (to know). They say we don't mention Nehru Ji. If we do, then also there's a problem. I don't understand this fear."

The PM said he believed in the mantra of Unity in Diversity and refuted the allegation that the BJP didn't

respect regional aspirations.
"We believe that for a country's progress, we have to address regional aspirations. I was a CM too and understood the States' aspirations. Earlier, leaders coming to India used to visit only Delhi, I took them to different States," the PM said.

Explaining further, the PM said, "We believe in unity in diversity. But some leaders followed the divide and rule policy. We identified over 100 aspirational districts in the country. Today, some of these districts have even crossed the national average in many parameters. This is a way to address regional aspirations.

# Western UP to choose its leaders today

### First phase of **Assembly polls to seal** fate of 623 hopefuls



Uttar Pradesh (UP) will see the first phase of polling for 568 seats in the Jat-dominated belt of Western UP on Thursday. The BJP has swept these seats in 2017, but this time around the Samajwadi Party (SP) hopes to stage a comeback due to its alliance with the Rashtriya Lok Dal (RLD).

As many as 623 candidates, including 73 women, are in the fray in the first phase of polling which will also decide the fate of nine Ministers in the Yogi Adityanath Government. The Election Commission

(EC) has made elaborate arrangements for the free, fair, and peaceful conduct of the first phase of the UP Assembly elections on Thursday.
The poll panel has also

made arrangements for ensuring compliance with Covid protocols. Thermal scanners, hand sanitisers, face masks, face shields, PPE kits have been made available at each polling station. Central paramilitary forces will be deployed at each polling station and central forces will also guard the strong room where the EVMs will be



Pradesh Assembly elections, in Noida, on Wednesday

stored after polling. UP Chief Electoral Officer (CEO) Ajay Shukla said here on Wednesday that in the first phase of elections, 2.28 crore people are eligible to vote, which includes 1.24 crore men, 1.04 crore women and 1,448 voters from the third gender. For the first phase of polling 26,027 polling stations and 10,853 polling booths have been set up. Due to Covid the number of voters at each polling booth has been restrict. polling booth has been restricted to 1,250. The EC has also directed the district returning officers to provide the facility of drinking water, toilets and

ramp at each polling station.
Polling for the 58 seats spread in 11 districts will be held between 7 am and 6 pm on Thursday. Of the 58 seats nine are reserved. The districts where the polling will be held

are Shamli, Hapur, Gautam Buddh Nagar, Muzaffarnagar, Meerut, Baghpat, Ghaziabad, Bulandshahr, Aligarh, Mathura

and Agra.

The CEO said besides the Election Photo Identity Card (EPIC) issued by the EC many other identity papers have been approved by the commission.  $I^{\mathrm{n}}$  a shocking revelation, the Government on Wednesday disclosed that 25,000 people committed suicide due to bankruptcy, indebtedness and unemployment between 2018 and 2020 in the country. The Home Ministry informed the Rajya Sabha that over 16,000 people committed suicide due to bankruptcy or indebtedness while 9,140 people ended their lives due to unemployment between 2018 and 2020.



The Minister of State for Home Nityanand Rai said 5,213 people committed suicide due to bankruptcy or indebtedness in 2020, while 5,908 died by their own hand in 2019

and 4,970 in 2018.

A total of 3,548 people committed suicide due to joblessness in 2020, while 2,851 killed themselves due to unemployment in 2019 and 2,741 ended their lives in 2018, he said replying to a written ques-



# **Kerala logs over 23 K Covid cases in 24 hrs**

Thiruvananthapuram: Daily Covid-19 cases in Kerala which saw a slight increase a day ago, again decreased on Wednesday with the State recording 23,253 fresh infections which raised the total caseload to 63,46,631.

The southern state had reported 29,471 Covid-19 cases on Tuesday.Kerala today also reported 854 deaths which raised the total fatalities in Kerala to 60,793, according to

a government release.

Of the deaths, 29 were reported in the last 24 hours, 198 were those which occurred in the last few days but were not recorded due to late receipt of documents and 627 were designated as Covid-19 deaths after receiving appeals based on the new guidelines of the Centre and the directions of the Supreme Court, the release said.With 47,882 more people recovering from the virus since Tuesday, the total recoveries crossed 60 lakh in the state to reach 60,26,884

As the number of recoveries were more than the new Covid-19 cases, the active cases in the state went down to 2,58,188, the release said. On Tuesday, the number of

active cases was 2.83.676.

As many as 84,919 samples were tested in the last 24 hours. Among the 14 districts, Ernakulam recorded the highest number of cases with 4,441,

# 'Hybrid immunity effective in aborting Omicron surge'

effective in preventing the spread of the Ômicron, a variant of coronavirus, according to the findings of the study conducted by a team led by a Kerala doctor.

"The impact caused by Omicron in India was less compared to the crisis created in countries such as the US and the UK. Hybrid immunity present in Indian population is the one of the main reasons for low death rate compared to other countries," said clinical immunologist and rheumatologist Dr Padmanabha Shenoy who headed the research.

Dr Sakir Ahmed of Kalinga Institute of Medical Sciences, Bhubaneswar, was coresearcher."Human body gains immunity through natural infection or vaccination.

The research included about 2,000 patients with autoimmune rheumatic diseases at the Centre for Arthritis & Rheumatism Excellence (CARE).It was found during the initial studies that hybrid immunity generated antibody levels 30 times higher than those who have received two doses of vaccines.

While 60 per cent patients who had received two vaccine doses were able to neutralise the original Wuhan strain of virus, 90 per cent of people with hybrid immunity could neutralise the original strain. Even in Delta variant also, the figures were almost similar.

# Daily Covid cases rise to over 7K in 24 hrs in Maha

 $T^{\text{he daily Covid-19 infections}}_{\text{rose by 1035 to touch a tally}}$ of 7,142 on Wednesday, even as the daily cases in Mumbai dropped marginally to 441.

A day after the State recorded 6,107 infections, the daily cases rose to 7,142 on Wednesday. With the fresh infections, the total number of Covid-19 cases in the state rose from 78,16,243 to 78,23,385

With 92 fresh deaths, the total number of deaths registered in the state since the outbreak of Covid-19 in the state in March 2020 went up from 1,43,155 to 143247.

Mumbai, where the daily infections have been dropping steadily for more than two weeks now, witnessed a small drop in the number of cases from 447 to 441.. With the latest cases, the total number of cases in Mumbai mounted from 10,52,176 to 10,52,617.

As 20,222 Covid-19 patients were discharged from the hospitals across the state after full recovery, the total number of people discharged from the hospitals since the second week of March 2020 increased from 75,72,069 toi 75.93.291. The recovery rate in the state rose from 96.89 per cent to 97.06 per cent

The number of "active cases" in the state dropped from 96,069 to 82,893. The fatality rate in the state stood static at 1.83 per cent.

The active cases in Pune dropped to 23603. The active cases in Mumbai dropped from 4783 on Tuesday to 4096 on Wednesday, while the active cases in the neighbouring Thane rose from 7192 on Tuesday to 4887 On Wednesday.

Nagpur accounted for 11374 active cases, followed by Ahmednagar (6034),

Nashik (4073) Aurangabad (3333)

Of the 7,59, 05,676 samples sent to various laboratories across the state so far, 78,23,385 have tested positive (10.31 per cent) for COVID-19 until Wednesday. Currently, 5,78,076 people are in home quarantine while 2,396 people are in institutional quarantine.

Meanwhile, no fresh Omicron case was recorded in Maharashtra on Wednesday, resulting in the total number of the new Covid-19 variant cases remaining static at 3,334. Till Wednesday evening, 7452 samples had been sent for genome sequencing, out of which, results of 7,014 patients have been received. 438 results are awaited.

## 70% of foreign prisoners in India under-trials: Data

PTI ■ NEW DELHI

Seven in every 10 prisoners of foreign-origin in Indian jails at the end of 2020 were undertrials, with nearly half of such inmates being from Bangladesh, according to data released by the government. The recently released annual 'Prison Statistics India 2020' of the National Crime Records Bureau (NCRB) shows there were 4,926 foreigners lodged in jails of the country in 2020, as against 5,203 in 2019 and 5,157

The number of Indian prison inmates in the country stood at 4.83 lakh by the end of 2020, stated the NCRB, which functions under the Union Ministry of Home

in 2018

"Among 4,926 prisoners of foreign nationality at the end of 2020, 4,135 were males and 791 were females. Among these foreign national prisoners, 23.1 per cent (1,140 inmates) were convicts, 70.4 per cent (3,467 inmates) were under-trials and 0.8 per cent (41 inmates) were detenues," the report showed."Among the foreign convicts, the highest number of foreign convicts

were from Bangladesh (46.4 per cent, 529 convicts) followed by Nepal (18.1 per cent, 206 convicts), Nigeria (8.2 per cent, 94 convicts) and Myanmar (7.3 per cent, 83 convicts) at the end of 2020," it noted.

According to the NCRB, West Bengal has reported the highest number of foreign convicts lodged in its jails at 466 (40.9 per cent) followed by Uttar Pradesh with 127 (11.1 per cent) and Delhi with 73 (6.4 per cent) at the end of 2020. "Among the foreign under-trials, the highest number was from Bangladesh (47 per cent, 1,630) followed by Nigeria (17.7 per cent, 615) and Nepal (13.4 per cent, 463)," the report showed. West Bengal has reported the highest number of foreign undertrials lodged in its jails at 1,295 (37.4 per cent), fóllowed by Delhi with 400 (11.5 per cent) and Maharashtra with 380 (11 per cent) at the end of 2020, it stated. The NCRB noted that the percentage share of foreign prisoners out of total prisoners has decreased from 1.1 per cent in 2019 to one per cent in 2020 (as on December 31 of each year).

### HC grants bail to woman accused of duping jeweller by impersonating as cousin of Brunei King

m granted\ bail\ to\ a\ woman}$ accused of duping a jeweller to the tune of over Rs two crore by impersonating the cousin of the King of Brunei who wanted to visit political leaders in India and gift them jew-

Justice Subramonium Prasad stated that although the petitioner woman -Nancy Gill -- was allegedly the mastermind behind the plan to cheat the complainant jeweller, she cannot be kept behind the bars endlessly.

The court noted that even after four years, the investi-gation was yet to be completed and directed that the petitioner be released on a personal bond of Rs one lakh with two sureties of the like amount. The court said, "the material on record discloses that the petitioner played a crucial role in the commission of the alleged offences" purintricate planning" which involved the petitioner purchasing another SIM to impersonate the cousin sister of the King of Brunei.

"This Court is of the opinion that the Petitioner cannot be kept endlessly behind bars. When the right to a speedy trial is a concomitant of Article 21 of the Constitution of India, it can be presumed that one of the facets would also be that the accused cannot be kept in cus-

tody indefinitely.

The Petitioner has already spent more than one-fourth of the maximum period of imprisonment in custody," the court said in its order passed on February 8. "There is weight in the submission of the learned Counsel of the Petitioner that even if she is convicted, the Petitioner would be subjected to imprisonment for a maximum of seven years, out of which she has already spent two years in custody. Even after four years, the investigation has not been completed," it added.

The Court directed that the petitioner be released on a personal bond of Rs one lakh with two sureties of the like amount.

The court clarified that if any instance of the petitioner threatening her family members or the complainant comes to light or if false cases are filed against the complainant or his family members by her or at her instance, the bail would stand cancelled forth-

The petitioner sought bail in the matter on the ground that no recovery was made from her and the complainant along with her (Gill's) husband has conspired to falsely implicate her in the case.

The complainant jeweller the petitioner, who was known him, told him about a big project and dishonestly represented that the Prime Minister of India had started a programme pursuant to which the King of Brunei was going to start 14 super-spe-

cialty hospitals in the country.

The complainant claimed that the petitioner stated that she met the cousin sister of the King of Brunei who wanted to visit political leaders in India and gift them jewellery. He stated that he was subsequently induced by the petitioner to accept an order worth more than one crore rupee without taking any advance while agreeing to give her a five per cent com-

After no payment was received by him for the jewellery, it was realized that the story involving the King of Brunei was concocted to dupe him, the complainant submitted. Consequently, an FIR was registered for the alleged commission of the offence of cheating under Section 420 of the Indian Penal Code.

## Herbal hookah permitted subject to Covid appropriate protocol, Delhi Govt tells HC

¬he Delhi Government The Delni Government Wednesday told the Delhi High Court that service of herbal hookah is permitted in bars subject to compliance with COVID-19 appropriate protocol and other relevant conditions.

Delhi government counsel Santosh Kumar Tripathi told Justice V Kameswar Rao that the case of the petitioner -- a restaurant-cum-bar owner challenging the ban on servicing herbal hookahs -- is covered by the order passed by the Delhi Disaster Management Authority on February 4 which has allowed bars and restaurants to operate at 50 per cent seating capacity.

The counsel stated that the petitioners have to give an undertaking to the court that they would strictly follow COVID-19 appropriate behaviour while serving herbal hookah in terms of the court's order passed in November last year. The judge stated that the order permitting the petition-er to serve herbal hookah shall be effective till the next date of

The petitioner M/S Punter House Cafe, represented by lawyer Anubhav Singh, argued that authorities interfering with the sale and service of herbal flavoured hookahs in restaurants was in violation of Articles 14 and 19(1)(g) of the Constitution of India.

The court also directed the Delhi government to file its counter affidavit to the petition which has challenged an August 3, 2020 order passed by the Health and Family Welfare Department banning the use of hookah, with or without tobacco, in public places on account

of the pandemic.
Tripathi said that smoking was prohibited in public places under the law and since restaurants and bars also qualify as public spaces, service of nookah was banned by the Delhi government. On November 11, while consider ing the order of the Health Department, the court had opined that COVID-19 restrictions cannot be permitted to continue at the cost of livelihood and allowed the sale and service of herbal hookahs.

The court had clarified that it was granting permission to service herbal hookah as an interim relief and it was subject to the then petitioners giving an undertaking to it that they would strictly follow COVID-19 appropriate behaviour while serving herbal hookah.The Delhi government, in its affidavit filed in that batch of petitions, had stated that the "very nature of the mechanism of hookah increases the risk of transmission of the virus" and COVID-19 infected smokers can spread the virus through floating of contaminated aerosol parti-

cles in the air.

Enforcement The Directorate (ED) has provisionally attached properties worth ₹1,621.93 crore under Prevention of Money Laundering Act (PMLA) in the case of coal block investigation against Jharkhand-based Corporate Ispat Alloys Ltd.

The provisionally attached properties consist of one biomass power plant, two captive thermal power plants, one ferro alloys plant and Direct Reduced Iron Plant and parcels of land situated at Durgapur, West Bengal and Saraikela, Jharkhand of the Nagpur-headquartered company, the ED said in a statement.

The ED had initiated money laundering investiga-



tion on the basis of an FIR dated January 6, 2016 registered by the Economic Offences Wing of CBI, New Delhi, for alleged commission of offences under the Indian Penal Code (IPC) and relevant provisions of the Prevention of Corruption Act against CIAL, promoters of the company and others for alleged criminal conspiracy, cheating and criminal misconduct by the accused

persons for obtaining coal

block, it said. "Investigation carried out under the provisions of PMLA revealed that the company fraudulently obtained the Chitarpur coal block through misrepresentation

Huge capital was later infused in CIAL in the form of equity shares so as to derive and obtain benefits/gains from

It said the shares were allotted at a huge premium. This entire infusion of capital ₹1,896 crore was done with an intention and in anticipation of undue benefits to be derived and obtained by CIAL in

"The proceeds derived from the issue of share capital were further invested in fixed assets and projected as untainted property and given colour of a genuine business investment, whereas, the entire process starting with the application for getting a coal block, to being awarded the Chitarpur coal block, to raising of funds on the strength of tainted property (allocation letter) was a consequence of criminal activities related to the scheduled offences," it added.

# PC Financial: ₹288 crore seizure by ED under FEMA

The Commissioner of Customs, Chennai, has confirmed the "full" seizure of ₹288 crore done by the Enforcement Directorate (ED) under FEMA against Chineseowned PC Financial Services Private Limited, a non-banking financial company (NBFC) by passing a speaking order.

The Commissioner of

Customs, Chennai, is the designated Competent Authority under Foreign Exchange Management Act (FEMA) for confirming seizures made by the ED in that zone.

The ED had seized Bank/Payment Gateway funds worth ₹ 288 crore belonging to PC Financial Services (PCFS) vide three separate seizure orders issued under the provisions of Foreign Exchange Management Act (FEMA). The orders were issued on August 26, September 30 and December 15 last year for amounts of₹106.93 crore, ₹

The ED is investigating a number of NBFCs and Fintech companies under PMLA for providing online instant microloans using mobile applications (Apps) and then extorting high rate of interest by misusing the personal data of the customers and threatening and abusing them through call cen-

During the course of money laundering investigation, the ED also initiated investigation under FEMA against PCFS that provides instant personal micro loans through its mobile application 'Cashbean' for suspicious foreign outward remittances.

"PCFS is ultimately beneficially owned by Chinese National Zhou Yahui. Investigation further revealed that the foreign parent companies of PCFS brought in FDI worth ₹173 crore for lending business and within a short span of time, made foreign out-

₹429.29 crore to Chinese-controlled foreign-related companies, in the name of payments for non-existent software services," the ED said in a state-

PCFS also showed high domestic expenditure of ₹941 crore. The ED has found that exorbitant payments were blindly allowed by the dummy Indian Directors of PCFS without any due diligence and on the instructions of the Country

Head Zhang Hong, who directly reported to Zhou Yahui residing in China, it said.

"PCFS had contravened FEMA provisions and equivalent assets were liable for seizure. Hence, seizure orders were issued. Further based on the ED investigation, Reserve Bank of India (RBI) and Income Tax Department have also initiated enquiry against the said NBFC. Further investigation is in progress," it

## NSUI leader writes to Rahul Gandhi seeking justice for party worker

Chhattisgarh NSUI president Neeraj Pandey has written to former Congress chief Rahul Gandhi raising doubts on the death of one of his workers, Deepak Gupta, who succumbed to the injuries he received in an attack on him and his friends on January 4, 2022.

In his letter, the NSUI state chief has alleged that "influential Congress leaders" could have planned the attack on party's student activist.

Pandey has termed the death mysterious and urged Rahul Gandhi to ensure justice for Deepak.

NSUI leaders have alleged that there have been differences between the district unit of party and the NSUI ever since Pandey was appointed the chief of NSUI state unit

According to letter, a NSUI program which was supposed to be addressed by Pandey in Surguja on November 14 last year was intercepted by district leaders and banners and posters put up to welcome the NSUI president was taken off. The program had to be conducted after adequate police presence, the letter read.

Pandey also mentioned how several of his workers were targeted, their homes attacked following that.

On January 4, Gupta along with his friends Viraj Dubey, Yudhvir Singh and Vikas Singh were attacked in which he suffered serious injuries which he later succumbed to in the hospital, the letter reads, adding an FIR was registered in the Ambikapur police station which led to arrest of a "minor".

It's the arrest of a minor in the case that has raised questions on the intention and working of police in the district, with Pandey writing to Rahul Gandhi that the cops want to let the real culprits get away by arresting a

Over the past few months, the differences within Chhattisgarh unit of the Congress had come out open due to rift between two top leaders of the party. The fight for supremacy even reached the national capital with both Chief Minister Bhupesh Baghel and his cabinet colleague TS Singh Deo camp MLAs flexing muscle in front of the party high command.

# Budget not for the poor, farm sector needs more attention: Opp

Opposition parties on Wednesday accused the Government of leaving out

the majority of the poor in its Budget 2022-23 and not doing enough for the farm sector that employs a large number of people in the country.

During the second day of the discussion in Ràjya Sabha on the Union Budget, Congress leader Kapil Sibal slammed the government for increasing excise duty on petrol and diesel, alleging its tax regime is worse than that of Mughal ruler Aurangzeb.

Taking part in the discussion BJP member Sushil Modi said jobs are not created by doling out freebies, cash transfer or through income support.

Lauding the Narendra Modi government for providing income support and helping people during COVID-19 pandemic, the BJP leader said employment can only be created through capital expenditure and giving impetus to the manufacturing

In four years, including 2023, India will be spending Rs 20 lakh crore in capital expenditure, he said, claiming it to be the biggest in the history of independent India.

Sibal said that in 2014, the price of petrol was Rs 71, and in January 2022, it

was Rs 95. "Central excise which we imple mented in 2014 was 9.2 percent per litre. You made it 27 percent. How much increase does it lead to? 203 percent. Diesel price was Rs 55. The excise on it was Rs 3.46. Today the price is Rs 86 and excise is Rs 21 on diesel and the increase is 530 percent," Sibal

During the discussion, Sibal made reference to 'Jizya'tax which was introduced by Ahmad Shah and later abolished by Akhbar. "Then Aurangzeb came. He again implemented it in 1617 and said that it will not be applicable to people who are deprived, unemployed. It will not be applicable to people who are able to poor people. It will not be applicable to those who protect us, army person-

This is what Aurangzeb said. This is worse than Aurangzeb. You have implemented it on everyone that too 530 percent and 203 percent," Sibal said.

The Congress MP said he was surprised to hear the prime minister talking about 'tukde tukde<sup>†</sup> in Parliament. "One who does 'tukde tukde" (dismembering) of culture, history, Constitution, brotherhood is the "leader of the tukde tukde gang," Sibal hit

CPI leader Binoy Viswam alleged that the Budget was a "failure" and only intend-



ed to benefit "big corporate houses such as Tata, Birla, Ambani and Adani".

TRS leader K R Suresh Reddy lamented the "cut" in food subsidies and the "meagre" sum allocated for research in agricul-

Referring to Prime Minister Narendra's Modi's allegation that the Congress governments in states were the reason for migrants walking back home during the pandemic, Viswam said, "Was it Congress party which did the lockdown?" He said though his party CPI has lots of criticism against the Congress party as it started the disastrous policies of the economy, it is BJP that is doing much more damage.

Nominated member Narendra Jadav termed the Union budget as "visionary" and

Birendra Prasad Baishya of AGP supported the budget terming it as a growth o-

BJD leader Amar Patnaik said, "In agriculture investment fund where spending was planned to be Rs one lakh crore in six years, the spending is Rs 6,627 crore in two years." He stressed that the focus on the rural economy is required.

DMK leader M Mohamed Abdulla

claimed the budget did not have any mention of the problem of inequality that the country is facing now.

# Major social media firms set up institutional structure, following guidelines: IT Min

reports as required under the statute, IT Minister Ashwini Vaishnaw said on Wednesday. Replying to a question in the Lok Sabha, Vaishnaw said to ensure that social media is safe and people can trust what is written on that, a very self-regulating regime, which was laid down in IT social media intermediary guidelines, was brought in last year.

All of them are also following the guidelines and publishing their monthly reports. The compliance has been good and whatever further steps are needed to make social media accountable, the government is open to those suggestions.

Baneriee on whether the government is thinking to bring any law restricting or pro-Almost all the social media companies hibiting or regulating and penalising the concept of meme which embarrasses a pergovernments try to increase accountability, increase regulations (of social media platforms) the question from civil society comes is whether we are taking away the freedom of expression.

"If we don't increase regulation, if we don't make the social media accountable then the safety and trust that citizens have on these media platforms that comes under a question mark. So it's a fine balance that we have to strike, we have to evolve and mold according to the changes,' Vaishnaw said. The new rules require large social media platforms to follow additional due diligence, including the appointment of chief compliance officer,

nodal contact person and resident grievance officer. They are also required to publish on their website their status on compliance with the new digital rules every month. Non-compliance with rules would result in these social media companies losing their intermediary status that provides them exemptions and certain immunity from liabilities for any third-party information and data hosted by them. In other words, they could be liable for criminal action in case of complaints.

# Govt seeks suggestions to draft new national cooperative policy

The Government has sought suggestions ▲ and inputs from various Central Ministries and institutions like NAFED and cooperative lender-NCDC as it drafts the new aimed to develop a cooperative based economy model focusing on achieving 'Make in India' mission.

"The new policy will address all developmental issues of cooperatives. Inputs / suggestions of the stakeholders including Central Government Ministries have been sought," Union Minister of Cooperation Amit Shah said in a written reply in Rajya Sabha on

The consultation with the stakeholders is being done to make cooperatives more transparent and efficient. Discussions are on relevant interventions viz. creation of a National database of Cooperatives, digitalisation of about 63,000 active Primary Agriculture Credit Societies (PACS), he

The Minister explained that there were two types of co-operative structures in the country i.e. State Cooperative Societies and Multi-State Cooperative Societies. (MSCS). The Cooperative Societies functioning in one State only are governed by the laws of the respective State Government while the cooperative societies functioning in more than one state are governed by the Central law, 'the Multi-State Co- operative Societies

"Any issues related to their administration are dealt with at respective levels. However, to give new dimensions and to further strengthen the cooperative sector in the country through policy and other intervenbeen created...," said the Minister.

The Government has been pinning hopes on the cooperatives to achieve its dream of 'atmanirbhar bharat.' The Government also plans to amend the MSCSA 2002 to establish a regulatory mechanism for MSCS and remove the loopholes in the existing act.

As per the National Cooperative Union of India (NCUI) data, as on 2018, there are 8.54 lakh cooperatives in the country. Some of the issues affecting accelerated and equitable growth of cooperatives, inter alia, are lack of effective governance, leadership and professional management in cooperative units, low level of technology adoption.

In fact, according to an official from the Ministry, complaints for non-repayment /misappropriation of deposits of investors against some of the MSCS in various states have been received. In case of delinquent societies against whom complaints are received, action for winding up process is underway in case of 77 societies under Section 86 of the Multi-State Cooperative Societies (MSCS) Act, 2002. Most of the erring cooperatives are from Rajasthan, Uttar Pradesh, Gujarat, Maharashtra, Delhi and Odisha, as per the government data.

The NIA had registered the case on February 3, 2018 pertaining to planting of three IEDs in and around the premises of Bodh Gaya temple complex. After investigation, chargesheet was filed against three accused on September 27, 2018 and a supplementary chargesheet was filed on January 28, 2019 against remaining six accused

# SC to consider listing for early hearing of plea seeking quick trial of cases against politicians

New Delhi: The Supreme Court on Wednesday agreed to consider listing for early hearing the PIL which has sought expeditious trial of criminal cases against lawmakers and speedy investigation by CBI and other

A bench headed by Chief Justice NV Ramana took note of the submissions of senior advocate and amicus curiae Vijay Hansaria that the plea needed to be listed for urgent hearing.

Hansaria said a fresh report, giving details of the pending cases against serving and former MPs, MLAs and MLCs, has been filed with the court and urgent, stringent steps are needed for expeditious disposal of the pending criminal cases. "We will see," said the bench which also comprised justices AS Bopanna and Hima Kohli. As per the recent report, a total of 4,984 cases are pending against

Members of Parliament and Members of Legislative Assembly/Council out of which 1,899 cases are more than five years old. The report stated that the total number of cases pending as of December 2018 was 4.110: and as of October 2020 it was 4,859 "Even after disposal of 2775 cases after December 4, 2018, the cases

against MPs/MLAs have increased from 4,122 to 4,984. This shows that more and more persons with criminal antecedents are occupying the seats in the Parliament and the State Legislative Assemblies. ### SC to consider hearing plea against continuation of Jharkhand DGP after retirement

New Delhi: The Supreme Court on Wednesday said it would consider listing for urgent hearing the pending contempt petition against the Jharkhand Government and Director General of Police (DGP) Neeraj Sinha alleging he has been occupying the post even after superannuation on January 31.

A bench headed by Chief Justice N V Ramana was told that the contempt plea, which was ordered to be listed in September last year, has not come up for hearing so far and, in the meanwhile, Sinha is continuing as Jharkhand DGP after his retirement.

The bench, also comprising Justices A S Bopanna and Hima Kohli, said the courts have been hearing "restricted matters" due to Covid and would consider the plea for early hearing. 'This matter was last listed on September

3 last year and it was ordered to be listed after two weeks then. It never got listed. It concerns the top post of the Director General of Police (DGP) of Jharkhand," lawyer Apoorv Khator

"This is not the priority item. We know that we are hearing the restricted matters. We will see," the bench said.

## Alliance Air Mumbai-Bhuj flight's engine cowl detaches during take-off; DGCA orders probe

**A**n Alliance Air ATR aircraft landed safe-ly at Bhuj from Mumbai after a part of the engine cowling fell down during take-off on Wednesday morning. The Directorate General of Civil Aviation (DGCA) has initiated an inquiry to fix responsibilities for lapses. The cowling was recovered alongside the runway after the flight took off. The four-yearold aircraft had around 70 passengers on

The incident happened on Wednesday morning and was brought to the notice of airport authorities by a Mumbai Air Traffic Controller (ATC). Subsequently, the Directorate General of Civil Aviation (DGCA) started an investigation into the incident. Meanwhile, officials said that Mumbai ATC informed the airport that Alliance Air ATR aircraft, operating flight 91-625 (Mumbai-Bhuj) took off without the left engine cowling (cover.

Visuals of the aircraft, which were shared on social media, showed an exposed engine of the flight as the cowling, the removable **PTI** outer part of the engine fell off on the run-

way.The aircraft, VT-RKJ took off from Mumbai airport at about 6.30 am. Later, the airline's engineering team reached the site and retrieved the engine cover from the runway. Flying without engine cowling may have an aerodynamic effect leading to marginal deterioration in the aircraft's performance, the Expressing regret at the unfortunate

incident, the airline in a statement said that during the operation of Alliance Air flight 9I-625 from Mumbai to Bhuj on February 9, the panel of the engine cowl was found on the runway post take off. "We have taken strict note of the incident and a thorough investigation has been initiated. The findings of the same shall be shared with the regulatory authorities and we shall ensure that all required corrective actions are put in place," the airline said.

It also said that "we are grateful that all passengers and crew onboard the flight safely landed and there was no damage to the aircraft due to this unfortunate incident." Alliance Air said, it follows laid down policies/ procedures as per the regulatory author-

# Rifleman from J&K among 7 killed in AP avalanche

**MOHIT KANDHARI** JAMMU

Rifleman Arun Katal, married barely three months ago in November 2021, was one among the seven Army personnel who made supreme sacrifice in the high altitude area of the Kameng Sector in Arunachal Pradesh on Sunday. The soldiers were on patrol duty when they were hit by an avalanche.

In his native village Jandore in Lakhanpur area of Kathua district his newly wedded wife spent the whole day tightly clinging on to their wedding pix. On the other hand inconsolable family members and close relatives assembled at their residence spent the long day eagerly waiting for the arrival of his mortal remains. Arun had joined his duty shortly after attending his marriage ceremony. He was commissioned in the Índian Army in 2015.

"Initially we were informed that the mortal remains would arrive on Wednesday but there was some delay due to technical reasons, now we are told the

dead bodies would reach here on Thursday", a close relative informed local media in Kathua. Along with Arun Katal two more soldiers from Jammu region sacrificed their lives.

They have been identified as Havaldar Jugal Kishore, son of Ram Pal, resident of Dager village in Kharha Wali block of Khour and Sepoy Vishal Sharma son of Babu Ram (Exserviceman), resident of village Chak Malal in Khour Sub Division of Jammu district.

Rifleman Arun's father, Praladh Singh himself an Army veteran was hopeful his son would survive. But on Wednesday he was informed about the recovery of dead bodies of all seven soldiers who were struck by an avalanche during a routine patrol duty at an high altitude area.

Ex Serviceman Om Prakash, father-in-law of Havaldar Jugal Kishore said, "I fail to understand why the soldiers were deputy on patrol duty when the high altitude area was witnessing heavy

snowfall". He appealed to the higher authorities in the Indian army to avoid risking lives of soldiers during inclement weather conditions. Havaldar Jugal Kishore leaves behind his ageing parents, a four year daughter and wife. His elder brother, Gautam Sharma, a former sarpanch in the area said, "his parents were offering prayers seeking well being of his younger brother but now it has been confirmed he has not survived. "How can I tell them their son is no longer alive. I cannot face his wife and four year old daughter". According to family members Jugal contacted his wife on Feb 5 for the last time. The family couldn't stay in touch with him after

that Alleging Charles Enforcement Directorate (ED) and other agencies were "continuously harassing" the vendors who provided service to his daughter's wedding held in November last year, Shiv Sena MP and spokesperson Sanjay Raut has charged the harassment suffered by the decorators and other vendors concerned as a "direct attack" on his right to speak freely in Rajya Sabha and outside the Upper House.

In a letter shot off to chairman of Rajya Sabha and vice president of India Venkaiah Naidu on Tuesday, Raut said: "my daughter gor married on 29th November 2021. The ED and other agency personnel are summoning, intimidating and threatening the decorators and other vendors of the wedding event so as to extract statements from them that they received Rs 50 lakh from me in

cash. On refusal by these people to partake in such an endeavour, the ED and other agencies are continuously harassing them".

Raut, who is the Shiv Sena Parliamentary Party leader, said that the ED and other agencies had so far "wrongly confined" 28 persons as part of the alleged witch-hunt being carried out against him. He said that the ED and other agencies had not only "confined" the 28 persons for hours together in its office, but had also gone to the extent of "threatening" these people that if they do not give a statement to the ED and other agencies, they would be arrest-ed. "The ED and other agency personnel who are tasked with the duty to protect revenue and secure proceeds of the crime are now reduced to puppets of their political masters. In fact,

the personnel from the ED and

other agencies even confessed

to the very people they are

summoning that they have been asked by their bosses to fix me," Raut wrote in his letter to Naidu.

Maintaining that he was not scared nor was he going to down (to the Government). "I will continue to speak the truth, both in the House and outside the House. However, the Government using agencies like the ED and other agencies to harass my family members, friends, relatives and even those people who are not concerned with me speaks volumes of the "decay in our system".

Raut said that as a Rajya Sabha member, he had the right as well the duty guaranteed by the Constitution to speak in the House. "As a citizen, I have the right to speak outside the House. I have the right to question the Government, its policies, decisions and right to dissent. I have the right to make alliances which will democratically fight what we all perceive to be against the state/national interest," he said.

Raut, whose Shiv Sena severed its links with the BJP and aligned with the Congress and NCP to form the MahaVikas Aghadi (MVA) government in Maharashtra in November 2019, said: "We have a right to have our own ideology which may necessarily in tandem with the political power in power at the Centre. However, that does not mean that our legislators, MPs, their family members, friends and acquaintances are threatened and harassed under the garb of conducting investigations and even arrested in cases of alleged money laundering".

"However, transactions which are decades old and have nothing to with the money laundering are taken to investigations with the oblique and ulterior motive of harassing and terrorising political opponents in the name of conducting investigation by ED and other central agencies," he said. Raut urged the vice President "not just take note of the abuse of power to perpetuate intimidation and harassment on members of the Rajya Sabha but also to speak up and take action". Raut signed off his letter with the famed poem penned

by the anti-Nazi German pastor Martin Niemoller who did not speak out against the Nazi rule at the right time and wrote confessional people as a token of poem that read thus: "First they came for the Communists, and I did not speak out-Because I was not a communist; Then they came for the trade unionists, and I did not speak out-Because I was not a trade unionist; Then they came for the Jews, and I did not speak out—Because I was not a Jew; Then they came for me—and there was no one left to speak for me".

# **Knotty scarf**

The Karnataka hijab case is complicated; it's a matter of several competing rights

he Karnataka hijab controversy case will take time to find a legal resolution. Being heard by a single Bench of the Karnataka High Court, it stands referred to a larger Bench because of the multiplicity and sensitivity of the issues involved. The High Court did not provide any interim relief to the petitioners — the Muslim girls asked not to attend classes in hijab — during the pendency of the case. The case is quite complicated. That is why it is important to get the sequence of issues right. Essentially, it is about the legality of a citizen's right to choose a religion of choice and the freedom to practice it. Several judgments uphold them. Then follows the right to privacy of the petitioners, that protects their decision to wear a hijab in class. The Kerala High Court had stated that the hijab is an essential religious practice in Islam. And finally comes the question of whether the State's interference in matters concerning essential religious practices is warranted. Four arguments exist here. One, whether a school or college management has the right to prescribe a uniform for all students without permitting any extra clothing or accessory that are essential religious practices. Secondly, since an earlier judgment of a High Court stated



that the hijab is an essential religious practice in Islam, should it not be allowed, with or without a uniform, especially when accessories that form an essential practice of other religions are worn over and above the uniform? The Sikh 'patka' is an example.

Thirdly, the Karnataka Government said in its order upholding the ban on the hijab by the college authorities that public order must be preserved. It needs to be determined how wearing a hijab, which is a private affair, is a threat to public order. Rather, the public order was disturbed when a group of students entered the college wearing saffron shawls to protest

some girls wearing the hijab. It needs to be clarified who threatened public order and how. Thus, the Government order itself becomes subject to legal scrutiny. Four, the case throws up the question of how to resolve a situation where two fundamental rights compete with each other. The reference is to the right of the college management to introduce a uniform and the right of the petitioner students to wear an item of additional clothing because it is an essential practice of their religion. There is a High Court order in another case that the individual interest (of the petitioner, in this case) must yield to the larger interest (of the management). The court needs to rule on which of the two — imparting education and maintaining public order — is the larger interest inside an educational institution. The immediate priority of the larger Bench which would now hear the case is to decide on the interim relief request of the petitioner girls so that they do not lose out on education more than they already have.



# Flighty course

The TN Government is playing with lives of the poor students by scrapping NEET

he farce being staged in Tamil Nadu over the National Eligibility cum Entrance Test (NEET) for admission to undergraduate medical courses basically is 'much ado about nothing'. The Bill adopted by the Tamil Nadu Assembly scrapping NEET was sent to Governor RN Ravi for approval. The Governor, after seeking legal counsel, sent it back to the Government stating that scrapping of NEET was against the interests of students, especially the rural and economically poor students. He also pointed out that the Supreme Court in the Christian Medical College Vellore Vs



of poor students. It is in this backdrop that one should see Tamil Nadu Government re-sending the Bill back to the Governor. Chief Minister MK Stalin knows well that the Governor would not sign the Bill and sit over it indefinitely. The NEET is a gift to the country by the Congress-led UPA regime in 2010 and the DMK was the second largest constituent of that Government. Though the then Chief Justice Altamas Kabir had pronounced the move as unconstitutional, a Constitution Bench unanimously ruled in favour of NEET, which was implemented by the Narendra Modi Government in 2016.

The Dravidian parties portrayed isolated cases of suicide by students who failed to make it to the MBBS courses as fallout of the NEET fiasco. But the fact that many poor and economically backward students could get admission to MBBS courses has been conveniently blacked out from public knowledge by these outfits. The media in Tamil Nadu, which make a killing through advertisements issued by these private medical colleges, sing paeans to the management and the State administration. "The Government must find a permanent solution to eliminate the menace of capitation fee and profiteering by private medical colleges. More than ₹20,000 crore is collected annually by these colleges by way of capitation fees. Formulating an all-India policy for medical admissions is the need of the hour. NEET will solve the problem to some extent," a pro-DMK newspaper had said in 2016. The Tamil Nadu Government's failure to bring in much-needed reforms in its school education syllabus is not being discussed by anyone who matters.

# A few reasons why Tollywood languishes PRAFULL GORADIA

ati-ul-Islam, a righthand man of Sheikh Mujibur Rahman and later the Finance Secretary of Bangladesh, first met Satyajit Ray to import some films for the benefit of Bangladeshis. The prices paid would astound today's generation. The maximum was for Apur Sansar — a handsome price of ₹25,000. In all, he purchased 12 films. This incident apart, the Bengal film industry, popularly called Tollywood, has not marketed its products as profitable as it might have. Or conversely perhaps, it has produced what is intellectually attractive but commercially not much viable.

Úncannily, Bengali men and women, in most segments of Bollywood, have played a role as big as any other community, including setting up studios. Bombay Talkies was founded by Devika Rani and her husband. Her role cannot be underestimated when one realises that Dilip Kumar aka Yusuf Khan was her exclusive find.

Bengalis sent nightingales, men and women of distinction, to the song and music world of Bombay, most notably Hemant Kumar, Manna Dey and the inimitable Kishore Kumar, not to forget Geeta Roy (later Geeta Dutt) and the veteran Juthica Roy, whose rendition of Ghoonghat ke pat khol re, tohe piyaa milenge resonates even today. We cannot also forget that the immortal KL Saigal was a product of New Theatres, founded by BN Sircar. So were Saigal's renditions Babul mora and Jab dil hi toot gaya, which still ring in our ears. Incidentally, Saigal had been singing Rabindra sangeet in Kolkata. The golden voice of *ghazals* in the Bombay film world, Talat Mehmood, also began his career in All India Radio, Calcutta, under the pen name of Tapan Kumar.

One could conclude, and not without justification, that Tollywood has had talent but little success. The directors and filmmakers that come to mind are many, but let us mention the iegendary Bimai Roy (who gave Kabuliwala and many other classics), Hrishikesh Mukherii,

Basu Bhattacharya and Shakti Samanta, among the prominent ones.

It is true that Tollywood has produced some Hindi and Urdu films such as Devdas, but the net cast by Bengali directors has been narrow and confined mainly to Bengali movies. By the same token, not many non-Bengalis got much space on the Tollywood screen. The reason is that unless one is a son of the soil, it is difficult to pick up spoken Bangla, which is first a melody and then a language. For example, one is pronounced 'Ayk' while 21 is 'ek'; 51 is 'ek anno' and 61 becomes 'ek sutti'. Not many who are not born in Bengal can cope with this variation of melody first and language later. Many of even those born on its soil are not conscious of this variation.

As a result, once Bollywood got going, Tollywood could not compete. Also, Tollywood selects subjects without any marketing strategy, and lacks a proper distribution network. The West Bengal Government is silent about promoting good cinema while other States pursue it seriously. Another reason may be that Tollywood did not traverse from the zaminaari ps Do Bigha Zameen, che to that of businesspeople and eventually to the respectable middle class. The

Bengali zamindar, once zamindari was over, continued to look down upon business as an OBC occupation; he descended straight into the middle class. The contempt for business persisted as before. Occupationally, the zamindar took refuge in either intellectualism or trade unionism.

When it came to films,

Tollywood's scriptwriters and directors produced 'pure' and intellectual films, without any masala being allowed to touch the kadhai, a la Satyajit Ray, Ritwick Ghatak and Mrinal Sen. Anyone who could deal in masala stuff and wanted to make money had to take a train from the erstwhile Bengal Nagpur Railway (BNR) to Bombay. It is not too late for

Tollywood to catch up. For this, the Kolkata film world needs to think anew, devise new strategies and join the race. The normal or run-ofthe-mill explanation of financial paucity would not come in the way. As American businessmen say, "Money follows a bright new idea with the confidence to manage it. Ideas and management do not follow money." To take an example of a film that was a simple idea, which was followed by plenty of finance, it was *Gandhi* by Sir Richard Attenborough. From

the most elderly and learned intellectuals to the youngest of schoolchildren, everyone could identify with the classic movie and enjoy it. Why did we have to wait for an English knight to produce a classic on an Indian giant?

Between the 19th and 20th centuries, India produced any number of giants. The saga of Netaji Subhas remains an epic, for instance. Gurudev Rabindranath Tagore was poetry and music personified, besides being India's first Nobel laureate for Literature, for Gitanjali. Bankim Chandra was an inspiration for heroes, for Tollywood or any other 'Wood' to produce movies on. Ramakrishna Paramahansa and Vivekananda are spiritu-

ality epitomised. Coming to themes, is there any shortage in West Bengal or any other part of India? Sandakphu, the Sunderbans with its Royal Bengal Tigers, the collieries and tea gardens are landmarks of the State. Kapurush deals with tea gardens, but not with tea-growing; they use these gardens as a stage for dubious romance.



# **FIRST COLUMN NORTH KOREA: THE** STING IN THE TAIL

The Pyongyang-Washington tiff interests nobody



hey want to have a deterrence system that is like a scorpion's tail," said Prof. Kim Dong Yup, a former South Korean naval commander. "North Korea's main purpose is not to attack but to defend themselves." They want a "diversified deterrent capability," and who could blame them? It's a welcome distraction from the daily warnings of an imminent Russian invasion of Ukraine, and even less likely to end in an actual war. North Korea test-fired seven different missiles in a month, US President Joe Biden retaliated with more sanctions against Kim Jong-un's hermit state, and everybody got their warhorses out for a brisk trot around the track. The reality, however, is that nobody in a position of authority is in the least excited by this little back-and-forth between Pyongyang and Washington. Pyongyang

hasn't tested any nuclear weapons since 2017, but it is believed to



have 50-60 warheads by now. Neither has it test-launched its intercontinental ballistic missiles (the ones that can reach anywhere in the United States) since then. The January tests were of 'hypersonic' missiles, 'intermediate-range' missiles, cruise missiles and similar hardware. Most of those missiles can probably carry nuclear warheads too, but only as far as South Korea or Japan, America's local allies. It's a formidable investment for a small, quite poor country (same population as Australia, but one-sixtieth the size) - but it's not that extravagant when you consider that all these nukes are intended to deter the United States. No American diplomat or military officer will admit publicly that North Korea's fear of an American nuclear attack is justified, but the more intelligent ones realise that the rules of nuclear deterrence are exactly the same for democratic superpowers and dwarf tyrannies. If your enemy has nuclear weapons, then to be safe you must have them too. From the perspective of Pyongyang, American nuclear weapons are a mortal threat, and nobody can persuade the North Korean regime that they would never be used against it unless it attacked first. Americans wouldn't forego nuclear weapons if China and Russia made such promises, nor would they take America's word for it. Too much is at stake to take a chance.

This is the universal dilemma of nuclear weapons. North Korea has just as much right to worry about it as the United States, and it will never give its own nukes up so long as the current confrontation in the Korean peninsula persists. (71 years and counting.) Any meetings or 'summits' between US and North Korean diplomats or leaders will be driven by North Korea's perpetual desire to end UN and US trade sanctions and/or America's futile quest to get Kim to agree to unilateral nuclear disarmament. Neither is going to happen, but there is no crisis either. The North Korean regime is vicious, but it is not crazy. A reasonably stable cold peace has prevailed in the peninsula since the end of the Korean War in 1953, guaranteed since the first North Korean nuclear test in 2006 by mutual nuclear deterrence between the US and North Korea. There's no urgent need to 'fix it' or 'shore it up' now. The United States cannot bring itself to publicly acknowledge this fact, but the Pentagon and the State Department privately accept that by now it is the long-established reality of the US-NK relationship. "They very much understand the significance of moving up the ladder on range," a senior Biden administration official said on Sunday, implicitly recognising that the North Koreans had not tested any new missiles capable of striking the American homeland. There really is a mutual understanding. They just can't talk about it.

# Pak's security policy is a flawed exercise

It is part of the focused effort to change the global perception of Pakistan as a 'national security State', obsessed with chasing an elusive parity with India

akistan recently released a public version of its National Security Policy (NSP) document. The document was authored by Moeed W Yusuf, previously Special Assistant to Prime Minister Imran Khan on National Security and Strategic Policy Planning, later re-designated as the National Security Adviser NSA). Drawing from his experience as former associate vice-president at the Asia Center at the United States Institute of Peace, Khan managed to provide a scholarly appeal to the document, with clever use of bombastic language that could impress amateur international audiences.

From Pakistan's strategic perspective, the document feeds into the ongoing efforts of the 'miltablishment' (military establishment) to reinvent itself as a 'changeagent' of a new narrative, based on the prioritisation of geo-economics as the key driver on national priorities, rather than the earlier paradigm based in pure geo-politics. Essentially, given the precarious economic situation facing Pakistan, and its fallen international standing after the Taliban victory in Afghanistan, the reality has dawned upon the miltablishment that it cannot be business as usual, of running with the hares and hunting with the hounds. Therefore, the NSP has to be seen as a part of the focused effort to change the international perception of Pakistan as a 'national security state', obsessed with chasing an elusive parity with India, and maintaining the dominance of

its military in every sphere, at any cost.

The document has incorporated all the right terms that would appeal to Western audiences. Sample some; "safety, security, dignity and prosperity of the people", "sustainable and inclusive economic growth", "preservation of diverse cultural heritage", "good Governance to strengthen the State-citizen contract", "ensure transparency and accountability", "strengthening the human security pillar of comprehensive national security", seeking a peaceful neighbourhood based on mutual co-existence, and so on. The repeated emphasis on enhancing trade, investment and connectivity is also given to make a mark in international business circles.

A finer reading of the document reveals that from India's point of view, the publication is nothing but a sophisticated exercise in insincerity. Almost all direct and indirect references to India have a negative connotation. Perhaps, the only saving grace in the entire document is the line and abroad, wishes to improve its relationship with India" (page 36, under "India"), and the restoration of Article 370 of the Indian Constitution by India is not mentioned as a pre-condition in the context of any bilateral proposition.

The document has other references to domestic security issues, which are nothing but clever attempts to paper over the serious problems that have not been acknowledged, let alone acted upon with due sincerity by Pakistan, despite overwhelming evidence to the contrary. The



any groups involved in terrorist activities on its soil" and "...with national resolve and dedication, Pakistan has fought one of the most successful wars against terrorism in the past two decades. Subsequently, under "Narcotics and Organised crime", it is claimed that "Pakistan has been declared a poppy-free country since 2001". The vacuity of this statement is belied by the fact that a majority of Afghanistan-origin opium, heroin and methamphetamine is trafficked through Pakistan, with the tacit support of state agencies, primarily the Inter-Services Intelligence. There is a major lacuna of the

document in the absence of any serious proposition concerning addressing the serious human rights situation in Afghanistan. There is also a subtle endeavour to underemphasize the burgeoning dependence upon China on vital matters of national interest. The publication has already come under sharp criticism by domestic critics within Pakistan, who have called it high on platitude and low on substance. Despite its claim of bringing in the factor of strategy", the publication does not make any commitment to reduce or rationalize the unsustainable Defence Budget of Pakistan, which remains largely out of public scrutiny.

The document adopts a slick presentation style, summarising the discussion of its six thematic sections in Policy Objectives, at the end of each relevant chapter. There is, however, no discussion on the "hows" of the vaunted objectives listed in enigmatic language. It is a major weakness of the document in absence of even broad allusion to the main components of the Policy Objectives described, the infirmities of the discussion will only become magnified in time.

The document has been given a time frame of four years by the authors. As a sincere exercise in selfdelusion, and a ploy for diverting the attention of the world from the real problems, which strike at the root of Pakistan's anachronistic existence, the document may become redundant in less than half its intended time frame, on an optimistic note. For India, it is another proof in evidence that the insincere miltablishment of Pakistan will use every trick in the book to buy time and attempt to encash on tactical peace to achieve its unflagging grand strategic objective of remaining the ultimate arbitrators of Pakistan's destiny.

The existing national security paradigm could provide neither state security nor human security to Pakistan. One wonders how a new concept of national security can emerge without critically drawing the right conclusions from past devastating military adventures. While keeping the failures of a moribund security paradigm under the carpet, the question must be asked, what is so new in the "first" on which so much self-praise is being showered?

It is being belatedly admitted that without ensuring economic security, "traditional security", i.e., defence, is not possible. The fact of the matter is that under the burden of traditional security, an impoverished economy has collapsed. And, consequently, traditional military security has also come under mounting pressure. The published NSP document provides only an

abstract analytical and disjointed framework, although it is reluctant to unambiguously draw a line between traditional security and human security.

What ought to be the contours of a meaningful paradigm shift? In simple and clear words, human security, as opposed to the security of the state, demands the security of people based on their fundamental rights. But, this basic feature of any qualitative change is mentioned casually and superficially, and that too in the last chapter of the document. Five chapters deal only with traditional security and other matters related to it, another chapter covers foreign policy and one chapter deals with economic security.

The emphasis is undoubtedly on defence. The document is overloaded with concerns over increasing asymmetry in conventional weapons with India. Redressal is sought in the growth of the economy as a necessary prerequisite. If the contradictions and demands of a dependent and fragile economy are fundamental, they have to be set right first. Then, logically, all aspects of traditional security must be subjected to economic imperatives, which warrant peaceful coexistence, mutually beneficial economic cooperation, and recalibration and resoprotracted and patient negotiations. Rather than taking a maximalist approach towards the most intractable "core" issues, it would require taking a path towards a peaceful settlement of disputes with all neighbours, promotion of mutually beneficial trade and investment across borders, and building economic synergies to strengthen economic interdependence.

Conclusively, Pakistan's NSP is a flawed exercise in futility.

Post-pandemic Railways at an interesting crossroad

## The pandemic presented a unique business opportunity to Indian Railways to concentrate on its two most profitable business segments

nformation about the working and the finances of the Indian Railways has become scarce in recent years. Discontinuance of a separate Railway Budget since 2017has taken the limelight away from the Railways. Now it features as a single paragraph in the Union Budget.

As a result, little is now publicly discussed about new projects, new trains, or demands for new lines or projects by different states or politicians. High-profile or controversial subjects like the High-Speed Corridors, the Train-18 project, or the Private train Operations schemedo find occasional mention in the press, but a holistic view of the actual health, direction or growth of the Indian Railways -the biggest employer in the



country, and arguably one of the biggest enterprises in the world -is no longer available to the country at large. Since 2017, the Ministry does not even have a full-time Railway Minister. Both Piyush Goyal (on taking over from Suresh Prabhu in September 2017) and the present incumbent Ashwini Vaishnav have been given charge of other important ministries along with Railways, further exacerbating matters.

Consequently, the specific impact of Covid on IR, has not been sufficiently evaluated in the public domain. In the absence of an objective assessment about the rebound - if any by the Railway sector, and in the run-up to the upcoming Budget presentation, an attempt was made to compile

sional data on IR's website for the 9-month period April-December 2021 with April-December 2019, two years back. This is considered the

The passenger segment, however, is a very differentstory. While total passengerscarried have reduced from 6278 million to 2300 million (- 63 per cent), revenue from passengers fell from ₹39,528cr. to ₹ 27.092cr.(-31.5%), for the 9-month comparison period. The biggest reduction is in the suburban passenger numbers, which explains why the loss in revenue is disproportionately less in relation to the drop in numbers. The improved freight performance may partially owe it to the reduced passenger operations, with more paths, more locomotives/crew available, and easier mobility possible. The pandemic's adverse effect on the trucking business, and ele-

vated fuel prices, may also have favoured rail freight. These are advantages IR would do well to capitalise on, and build on further. The gradual, partial opening-up of the two Dedicated Freight Corridors are also adding capacity (they moved about 6 billion NTKMs till recently - a significant, although still a miniscule part of IR's traffic). A sustained increase in freight, at a level higher than the GDP growth, as achieved in the last two years, will help win back much needed modal share of the major, non-coal commodities

The pandemic, and the phased recovery of the economy has presenteda unique business opportunity to Indian Railways in that they are able to concentrate on their two

most profitable business segments - Freight and long-distance, reserved passengers keeping the grossly subsidised and capacity guzzling suburban and short/medium distanceordinary passenger services to the bare minimum. The temporary suspension of many concessions on the passenger services would also have helped in adding to revenue, and in improving availability to fullfare paying passengers. All this offers clear clues to the Rail Ministry in long-term measures aimed at improving its revenues, profitability, and rewinning its importance and relevance. It is hoped that thiswindfall - which may be partially circumstantial, and not a positive act of the IR management - will not be allowed to wither away.

# Iran unveils new missile with reported region-wide range

Iran unveiled a new missile on Wednesday with a reported range that would allow it to reach both U.S. bases in the region as well as targets inside its archfoe Israel.

State TV reported that the missile uses solid fuel and has a range of 1,450 kilometers (900 miles). It is called the Khaibarbuster, a reference to a Jewish castle overrun by Muslim warriors in the early days of Islam.

The report said the missile has high accuracy, is manufactured completely domestically, and can defeat missile shield systems. The information has not been independently verified. Israel's closest point to Iran is some 1,000 kilometers (620

# Two killed in gunmen attack in south Nigeria

Lagos: As many as two people were killed when a group of gunmen attacked the convoy of businessman in south Nigeria's Edo state, police said on Wednesday.

Kontongs Bello, the police spokesperson in Edo, said that the victims were drivers attached to the chairman of a petroleum marketers association in the state, Abdul-Hamid Egele, who was abducted by the gunmen after the attack, Xinhua news agency reported.

The gunmen intercepted Egele's motorcade near the town of Jattu of the state on Monday evening, killing the

driver of the car Egele was using on the spot, and wounding a security guard and another driver of the motorcade, said

He said the second driver. who was driving Egele's back-up car, died later because of the serious bullet injuries he suffered during the attack.

The police spokesperson said the police had begun a rescue operation in the area. Armed attacks have been a primary security threat in the most populous African country, leading to deaths and kidnappings in recent months.

# UN: Terror groups enjoy greater freedom in Af than any time in recent history

Terror groups enjoy greater freedom in Afghanistan than at any time in recent history and there are no signs that the Taliban leadership has taken steps to limit the activities of foreign terrorists in the war-torn country, a report of the UN Secretary-General has

The report says the dreaded Islamic State terrorist group aims to position itself as the "chief rejectionist force" in Afghanistan, expands into neighbouring Central and South Asian countries and is viewed by the Taliban as its primary armed threat.

The '14th report of the Secretary-General on the threat posed by ISIS to international peace and security and the range of United Nations efforts in support of Member States in countering the threat' notes that the security landscape in Afghanistan changed dramatically on August 15, following a Taliban military campaign that took control in the country, including Kabul.

"There are no recent signs that the Taliban has taken steps to limit the activities of foreign terrorist fighters in the country. On the contrary, Member States are concerned that terrorist groups enjoy greater freedom in Afghanistan than at any time in recent history," the report said.

It, however, said that only a small number of foreign terrorist fighters are moving to Afghanistan.

The report said ISIS affiliate in Afghanistan, Islamic State in Iraq and the Levant-Khorasan, continues to be led by Sanaullah Ghafari, an Afghan national, who was designated by the ISIS and al-

Qaida Sanctions Committee of the UN Security Council in December last year. The US on Monday announced a reward of up to USD 10 million for information on Ghafari and those responsible for last year's militant attack on the Kabul international airport that killed at least 185 people. The US Department of Rewards for Justice (RFJ) issued notifications to this effect on Monday. "Rewards for Justice is offering a reward of up to USD 10 million for information on ISIS-K leader Shahab al-Muhajir, also known as Sanaullah Ghafari," it said. According to the UN report, ISIS-K is taking advantage of the turmoil in the country, including by recruiting fighters from the Eastern Turkistan Islamic Movement and the Turkistan Islamic Party, among other foreign terrorist groups. "It aims to position itself as the chief rejectionist force in Afghanistan and to expand into neighbouring Central and

The Member States in the South-East Asia region are also concerned about the "potential resurgence of a safe haven" in Afghanistan for international terrorist activity, as well as about social media messaging that "celebrates the Taliban victory", which could be used as a recruitment tool for violent extremism locally, the report

National authorities in the South-East Asia region are not reporting any immediate uptick in attempted travel to Afghanistan, but are alert to

this possibility. The report said that both Indonesia and the Philippines reported significant counter-terrorism gains, leading to an overall decline in terrorist activity and cautious optimism that the operational capability of several groups in the region may be significantly degraded. At the same time, the threat of attacks by lone actors or inspired by radicalised individuals remains

### Researchers on board for report on high-speed rail in Australia

 $A^{\text{team of researchers from}}_{\text{the University of New}}$ South Wales (UNSW) have come up with a new approach to making highspeed rail (HSR) cost-effective in Australia that involves factoring in the rise in land value among other "value uplifts".

The report released by UNSW's City Futures Research Centre on státions along HSR Australia's east coast, connecting the nation's three most populous cities Sydney, Melbourne and Brisbane would generate a potential 140 billion Australian dollars (about US\$100 billion) in land value, Xinhua news agency reported.

"There are a lot of opportunities around HSR for Australia to build stronger connectivity between cities and inject significant wealth and job opportunities into the regions," said Director of City Futures UNSW Research Centre and lead report author on Christopher Pettit.

In past, proposed HSR projects have been ruled out given Australia's relatively small population -- compared to countries like Japan, China and Germany, which have established HSR networks.

A report delivered to the Australian government in 2013 proposed HSR development on east coast would cost 130 billion Australian dollars (about \$93 billion).

Pettit said their proposal shows that this cost could be almost entirely offset by value added in areas such as dwelling value, population growth, creating jobs in regional areas of Australia and providing greater access to cities.

"If you were to capture a substantial proportion of this value uplift, it could pay for a huge amount of the HSR," he said. Past proposals have attracted no shortage of criticism.

Experts have rebuked idea as having a benefit-cost ratio that would barely break even, and huge emissions costs from construction of thousands of kilometers of rail lines. James Abbott, managing director at Abbott Advisory and reviewer of UNSW report, told Xinhua: "I think that you need to consider population we will have in 30 years versus pop-

ulation we have today.

# India is in discussion with **ASEAN** to start FTA review: Patel

India is in discussion with the 110-nation bloc ASEAN for initiating the review of the free-trade agreement in goods between the two regions to seek more market access for domestic products, Parliament was informed on Wednesday.

Minister of State for Commerce and Industry Anupriya Patel said the market access issues and trade barriers being faced in ASEAN (Association of Southeast Asian Nations) countries and China are being regularly taken up with individual countries bilateral through

engagements.
"The Government of India is in discussion with ASEAN countries for initiating the review of ASEAN-India trade in goods agreement to seek more market access for Indian products," she said in a written reply to the Lok Sabha.

that to increase exports includ-ing apparel exports, India is actively negotiating regional trade agreements (RTAs)/ FTAs with a number of countries including the UAE, Australia, Canada, Israel and

"Ongoing FTA negotiations will also provide more favourable market access to products exported from India,"

The Minister said that textile and apparel export growth has been facing adverse impact of the COVID-19 pandemic and higher import tariffs in key markets such as the European Union and the United Kingdom as compared to zero duty access in these countries to competing countries like Bangladesh and Cambodia.

Replying to a question on export dues, she said the government has released ₹56,027 crore in order to clear pending

exporters. This is for various schemes - Merchandise Exports from India Scheme (₹33,010 crore, Service Exports from India Scheme (₹ 10,002 crore), Rebate of State and Central Taxes and Levies ( ₹5,286 crore), Rebate of State Levies (₹330 crore), and Remission of Duties and Taxes on Exported Products (₹2,568 crore) and other legacy schemes like Target Plus Scheme, Focus Product

"It is estimated that such benefits would be disbursed to more than 45,000 exporters, out of which the majority would be in the micro, small and medium enterprises (MSME) category," Patel said. Clearance of dues under these schemes is dependent on meeting the eligibility criteria by the applicant exporter, whose applications are scrutinised for any deficiency.

# Govt open to 'some tinkering' in capital gains tax regime, says Revenue Secy

**New Delhi:** The Government is open to 'some tinkering' in the varied rates and holding period for computation of capital gains tax on shares, debt and immovable property, in a bid to make it simple, Revenue Secretary Tarun Bajaj said on Wednesday. In the current fiscal, the revenues from

capital gains tax is expected to jump 10-fold to about ₹80,000 crore.

Under the Income Tax Act, gains from sale of capital assets, both movable and immovable, are subject to 'capital gains tax'. The Act, however, excludes movable personal assets such as cars, apparels, furniture from this tax.

Bajaj said the current capital gains tax structure is "too complicated" in terms of varied rates and period of holding across the assets and hence needs a relook.

"We need to rework the capital gains structure for rates, holding periods. We would be open to some tinkering in it, the next time we get an opportunity," Bajaj said Asking the industry chamber to also

conduct a study on what are the prevailing rates of capital gains tax across the world, Bajaj said, the department has already studied the rates in other nations like India and the developed world.

"Number one is rate and number two is the period for which it is. I think it is too complicated... That we have created. For real estate, we have made it 24 months, for shares 12 months, for debt it is 36 months. We need to work on that," Bajaj said. Observing that when any such tinkering is brought

payers who would stand as gainers, while there would be a segment who would lose out compared to their present tax provision, the Secretary said, adding "that becomes the most difficult part".

Depending upon the period of holding an asset, the long-term or short-term capital gains tax is levied. The Act provides for separate rates of taxes for both categories of gains. The method of computation also differs for both the categories.

In general, when an asset is held for more than 36 months, it is termed as a longterm asset, otherwise short-term.

However, equity shares or units of equity oriented mutual funds held for more than 12 months are considered long-term, whereas house property has to be held for 24 months to be considered a long-term

Short-term capital gains are chargeable to tax at normal slab rates applicable to the taxpayer, except where such gain is arising from sale of equity shares in a company or units of equity oriented mutual fund or unit of a business trust (where STT has been paid), which is chargeable to tax at the rate of 15 per cent, while long-term capital gains in excess of ₹1 lakh is taxed at 10 per

Bajaj said in the current fiscal, the gov ernment is likely to collect good revenue from capital gains tax despite the fact that capital gains tax rates are much lower at 10 per cent and 15 per cent respectively for long-term and short-term. *PTI*

# Sebi puts in place framework for conversion of private listed InvITs

Wednesday came out with a framework for conversion of a private listed Infrastructure Investment Trust (InvÎT) into a public InvIT.

In addition, the regulator has issued guidelines for converting a private unlisted InvIT into a private listed one. În a circular, Sebi said a private listed InvIT may convert into a public InvIT on making a public issue of units through a fresh issue and/or an offer for sale.

A listed private InvIT has to comply with various requirements, including having at least 5 investors other than the sponsor(s), its related parties and its associates. Post issuance and listing of such units, the private listed InvIT will stand transformed and will be considered a public InvIT. Such an entity will be required to comply with all provisions of the InvIT rules prescribed for public InvITs. With regard to conditions for conversion, Sebi said a private listed InvIT will have to fulfill certain conditions, including obtaining approval from 75 per cent of the unit holders by value for such public issue of units. In addition, a private listed InvIT need to be compliant with all the applicable listing obligations and disclosure requirements since the date of its listing or preceding three years, whichever is less.

# won't defrost windshield fast enough

**Detroit:** Tesla is recalling nearly 27,000 vehicles in the US because the cabin heating systems may not defrost the windshield quickly enough, cutting visibility and increasing the risk of a crash.

The latest in a series of recent recalls covers certain 2021 and 2022 Models 3, S, and X, and some 2020 through 2022 Model Y vehicles. Tesla says it doesn't know of any crashes or injuries tied to the problem. Documents posted Wednesday say the electric vehicle maker will send out an online software update to fix the

US safety regulators say in the documents that a software error can cause a valve in the vehicles' heat pumps to open unintentionally, trapping refrigerant inside the evaporator. That can reduce defrosting performance.

The problem can deplete the refrigerant in some parts of the heat pump, causing the compressor to stop working as a fail-safe measure. That can cause loss of cabin heating, largely when it's minus 10 degrees Celsius (14 degrees Fahrenheit) or colder.

Tesla stores and service centers were to have been notified of the recall around Feb. 4. The recall is the 14th done by Tesla since January 2021, according to National Highway Traffic Safety Administration records.






# **Ashwell Prince quits as** Bangladesh batting coach: Report

Dhaka: Former South Africa batter Ashwell Prince has resigned as the batting coach of Bangladesh men's team, said a report by ESPNCricinfo. Prince's resignation means that he will not be part of the Bangladesh support staff in their home series against Afghanistan followed by the tour of South Africa in March.

"We have received his resignation letter on email a few minutes ago. He has cited family reasons for his decision," said Jalal Yunus, cricket operations chairman at the Bangladesh Cricket Board (BCB).

Prince was appointed to the post initially for a short-term deal since last year's tour of Zimbabwe before taking up a permanent role that was supposed to run until this year's Men's T20 World Cup in Australia in October-November. For taking the permanent role with Bangladesh, Prince had resigned as head coach of domestic side Western Province in South Africa.

The 44-year-old's resignation



comes a month after former Bangladesh head coach Jamie Siddons was brought on board as a batting consultant in December 2021. At that time, BCB President Nazmul Hassan had said it was 'not yet finalised in which area he will work in, whether it is the High Performance, Under-19s or the senior team'.

Under his tenure, Bangladesh had a difficult time with the bat, especially during the Men's T20 World Cup in the UAE and Oman. But Bangladesh

managed to script a surprise eight-wicket victory over New Zealand in the Bay Oval Test.

Prince is the second member from Bangladesh's coaching staff to move on from the side in the past few weeks after ex-bowling coach Ottis Gibson joined England County side Yorkshire as their head coach.

# New Zealand-Australia T20 cricket series nixed

### Mountaineer Arjun Vajpai sets sight on Mt. Annapurna and Mt. Dhaulagiri

Having already scaled six out of the 14 8000m summits successfully, India mountaineer Arjun Vaipai has now set his eyes on climbing Mt. Annapurna and Mt. Dhaulagiri. The 28-year-old was recently awarded by Guinness World Records for becoming the youngest person to climb two higher 8000ers (Mt. Everest in 2010 and summit Lhotse in May 2011). Vajpai now wants to become the first Indian to scale all the 14 8000m summits in the world and his first target is to climb Mt. Annapurna and Mt. Dhaulagiri, which will make him the first from the country to finish all the 8000m mountains of Nepal.

There are less than 40 people in the entire world who have ever climbed these 14 summits but no Indian has achieved the feat yet.

Vajpai has already scaled Mt. Everest, Mt. Lhotse, Mt. Makalu, Mt. Kangchenjunga, Mt. Manaslu, and Cho-Oyu, making several

mountaineering world records. "It is my dream to climb all 14

mountains above the 8000 meters and put India's flag flying high and become the only Indian to have achieved this feat. Right now my focus is on #Project8k and I am going to give my best in order to achieve this daunting task," he said in a release. In order to complete #Project8k, Vajpai has started a fundraiser on Ketto to crowd source funds to complete his expe-
