India rushes flights to Ukraine for nationals

20,000 students among stranded Indians to be brought back home

PNS NEW DELHI

With tension mounting in Ukraine, India may increase flights to bring back home its stranded citizens, including nearly 20,000 students. At present, very few flights connect India with Ukraine.

The ongoing tension between Ukraine and Russia and fear of military confrontation has led to a sharp increase in airfare and unavailability of seats. The Indian Embassy in Ukraine on Tuesday advised its students to leave the country due to "uncertainties." Also Indian citizens were urged to refrain from travelling to Ukraine for the time being.

Given the concerns of the parents, sources said here on Wednesday discussions were on with the civil aviation authorities and various airlines on ways to increase the number of flights between India and Ukraine.

They also said the Indian Embassy in Kyiv was monitoring the developments on a regular basis. "We are aware that many Indian students are presently in Ukraine and their families are anxious about their



wards, particularly about getting flights to India," sources said. Parents are demanding that their children should be airlifted and brought home as soon as possible.

The control rooms in the Embassy as well as in the Ministry of External Affairs are being set up to respond to queries of Indian nationals in Ukraine and their families in India," sources said.

Not just India, but several other nations have asked their citizens in Ukraine to return at the earliest. Some countries fear that a war in Eastern Europe could result in a massive refugee crisis.

Rajya Sabha member Priyanka Chaturvedi (Shiv called on the Government to facilitate the evacuation of Indians, especially students, from Ukraine.

"Indian students are facing difficulties in leaving the country following the Indian Government's advisory to return to India temporarily. Flights booked are being cancelled while many others are unable to afford tickets back

home as the air tickets prices

are soaring," she tweeted. The advisory by the Indian Embassy on Tuesday said, "In view of the uncertainties of the current situation in Ukraine. Indian nationals in Ukraine. particularly students whose stay is not essential, may consider leaving temporarily."

The advisory also urged Indians to keep the Embassy informed about the "status of their presence in Ukraine to enable the embassy to reach them when required".

India has so far refrained from commenting on the ongoing crisis and pushed for a peaceful resolution of the situation in Ukraine through sustained diplomatic efforts.

Rendering help to Indians in Ukraine wanting information and help can get in touch with the Ministry of External Affairs. It has set up a dedicated 24X7control room in India's Embassy in Ukraine. Continued on Page 2

Poll battle moves to Yadav belt, real test for Akhilesh

s the Uttar Pradesh Assembly elections enter the third phase, the battle of the ballot has moved to "the Yadavbelt". A total of 59 Assembly constituencies in 16 districts. spreading from Bundelkhand to the Avadh region will go to the polls on February 20. The hottest contest is at Karhal from where former Chief Minister Akhilesh Yadav is in the fray.

The third phase covers five districts from western UP: Firozabad, Mainpuri, Etah Kasgani Hathras; six districts of Avadh region: Kanpur, Kanpur Dehat Auraiya Kannauj, Etawa, Farrukhabad; and five districts from Bundelkhand region: Jhansi Jalaun Lalitpur Hamirpur Mahoba.

Akhilesh has entered the fray to act as a force multiplier in the third phase. Interestingly, in 2017, the BJP not only swept all the 19 seats of the Bundelkhand region but also managed to make a big dent in the Yadav stronghold which the Samajwadi Party swept in 2012.

From Chief Minister Yogi Adityanath to his deputy Keshav Prasad Maurya to Union Home Minister Amit Shah, top BJP leaders have been campaigning in the Yadav bastion from where Mulayam

Singh Yadav and two other members of the family have been MPs. SP chief Akhilesh will campaign in this region on Thursday and address election meetings at several places in the Karhal Assembly constituency, Mainpuri, Ferozabad, Tundla, Mainpuri and Etwah.

The SP won 37 out of the 59 seats in this region in the 2012 Assembly Elections. However, politics in this region took a new turn when the Yadav-dominated regions voted heavily for the BJP in 2017 elections. The BIP won 49 out of 59 seats while the SP only had to settle with 9. The Congress got one while the BSP drew a blank from here. The real test of Akhilesh,

Campaign win hearts, minds of voters peaks in TN for urban polls

parties in Tamil Nadu for the upcoming urban civic polls reached a fever pitch on Wednesday with the ruling DMK asserting that it has fulfilled most of its assurances made ahead of 2021 Assembly election while the main opposition AIADMK slammed it for not fulfilling promises.

DMK president M K Stalin in a virtual address for the February 19 local polls said a majority of assurances made by his party in the run up to the Assembly election have been fulfilled.

Seeking votes for his party and allies, the CM listed several fulfilled promises including slashing milk price by ₹3 per litre and fare free travel for women in town buses. Priority for the Tamil people in state government jobs (by making commencement of allotment Tamil compulsory, as the qualifying norm for state services) and appointment of trained people belonging to all castes as priests in temples were among the other implemented promises, he cited.

Stalin said his party-led regime is driven by the 'Dravidian model' which is 'social justice inclusive growth.'
True growth is all about enhancing the living standards of all the people of the State rather than only a section of them, he said. "That is Dravidian thought. Each and every scheme of ours is based on this." The lie repeated over a long period of time that the DMK is a party against Hindus has been broken into pieces,'

under a ₹1,000 crore fund for renovation of temples and retrieval of lands worth Rs 1,789 crore (180 acre) belonging to shrines.

For those who do politics based on religion, their blood pressure will only increase if they look at Tamil Nadu. They will have a sense of frustration that despite their efforts nothing happened to the unity of

He also reiterated his Government's commitment to do away with NEET in its application to Tamil Nadu. The CM also targeted the saffron party-led Centre for 'not providing' Rs 8,989 crore to Tamil Nadu towards pandemic relief from the disaster relief fund and 'delaying' release of Rs 16,725 crore GST due.

He ridiculed the Centre over the Union Budget 2022 saying tax has been slashed for diamond while there is no assistance for people affected by coronavirus. Several bigger issues in Tamil Nadu like the NEET that echoed during the last year's Assembly polls grabbed a large campaign space for the urban polls too rather than local civic issues.

In his campaign, AIADMK top leader and former Chief Minister K Palaniswami on Wednesday slammed the ruling DMK as a 'corporate' entity. "The DMK is not a political party, it is a corporate company," he said in his campaign at Krishnagiri district. Stalin had mocked at the AIADMK as a 'comedy drama company.' Listing DMK's Assembly election poll promises one after the other, Palaniswami asked the people if these were implemented, while a section of the gathering replied 'no.'

The DMK had promised ₹1,000 per month 'rights' assistance to women but 'did they give?' he asked. Similarly, the AIADMK leader went on to list other assurances like ₹100 subsidy every month for cooking gas cylinders and waiver of education loans taken by stu-

"Did they implement?" he asked repeatedly listing such promises. Stalin had given as many as 505 assurances ahead of the last year's Assembly election the AIADMK leader said and claimed that such

promises could not be fulfilled by him. People would hence not be benefitted by the DMK regime, he said. Since people would question the Chief Minister on such assurances, he is 'afraid' and thus could not meet the people face to face for polls, Palaniswami claimed. That was why Stalin chose the virtual campaign route for urban civic polls, the AIADMK leader alleged.

Palaniswami appealed to the people to support the AIADMK and said the urban civic polls should serve as a 'lesson' to the ruling DMK. He also targeted the DMK regime over 'substandard' commodities in the 'Pongal' festival hampers distributed to beneficiaries and again hit out at the DMK regime over NEET. "Only the

AIADMK is committed to the people's welfare.

Only our party nominees can address the people's problems and fulfill their aspirations. Please give an opportunity to AIADMK candidates to serve you." Meanwhile, a delegation of bishops of the Church of South India called on Stalin at the DMK headquarters here and extended their support to the candidates of ruling party

legendary singer Kishore Kumar, Bappi Lahiri ruled the hearts of filmgoers in the seventies, eighties and early nineties through his composi-tions from films like Disco Dancer, Naya Kadam, Aangan Ki Kali Hathkadi, Namak Halaal, Masterji, Dance Dance, Himmatwala, Justice Chaudhury, Tohfa, Maqsad, Commando, Naukar Biwi Ka, Adhikar and Sharaabi,

"I Am A Disco Dancer," "Jimmy Jimmy Jimmy Aaja", "Auva Auva Koi Yahan Nache,' "Ramba Ho" "Yaar Bina Chain Kahaan Re", "Raat Baki", Bambai Se Aaya Mera Dost, Naino Main Sapna, TaakiTaaki, "Chalte Chalte, Mere Ye Geet Yaad Rakhna Kabhi Alvida Na Kahna Kabhi Alvida Na Kahna", "Inteha Ho Gayee", "Pag Ghungroo Bandh" and 'Thodi Si Jo Pee Li" are still fondly remembered by the film buffs across the country.

Born musician parents Aparesh Lahiri and mother Bansuri sang Bengali and classical music on November 27th, 1952 at Jalpaiguri in West Bengal, took to music at an early age of three when he started playing tabla. A he grew up, he also learnt playing piano, guitar and saxophone and various types of percussion instru-

After making his Hindi film debut with the 1973 film Nanha Shikari, where his song "Tu Hi Mera Chanda" with Mukesh and Sushma Shrestha, Bappi Lahiri worked with Lata Mangeshkar in the Bengali film Daadu. He got a break in Hindi films through his music composition "Jalta Hai Jiya Mera," rendered by Kishore and Asha Bhosle in film Zakhmee (1975)

Bappi's career took off in a big way in 1976 with Kishore Kumar's title track in film"Chalte Chalte" and the Shailendra Singh-Lata Mangeshkar duet "Pyar Mein Kabhi Kabhi."

His song "Bambai Se Aaya Mera Dost" from the 1977 film Aap Ki Khatir became a party song, while another popular number "Maana Ho Tum tum behad haseen" sung by K J Yesudas in his baritone voice in Toote Khilone.

It was around this time, Bappi began to sing his own songs. He rendered four such numbers in Mithun Chakraborty's film "Suraksha".

Bappi, who introduced disco-electronic music to the Hindi film industry, created memorable disco numbers like 'I am A Disco Dancer Zindagi Mera Gaana "from film "Disco Dancer with Vijay Benedict, "Tu Mujhe Jaan Se Bhi Pyaara Hai" in Wardat with Uthup, "Hari Om Hari" in Pyaara Dushman, Uthup's "Ramba Ho" and Sharon Prabhakar's "Mere Jaise Haseena" in Armaan and Asha Bhosle's "Disco Station" in Haathkadi. Bappi went onto compose

songs like "Jhoom Jhoom Jhoom Baba" with Salma Agha in Kasam Paida Karne Wale Ki, Yaar Bina Chain Kahaan Re' with S. Janaki in Saaheb and Alisha Chinai's "Zoobi Zoobi" in Dance Dance. Meanwhile, popular filmmaker Prakash

His compositions in 1982 film Namak Halaal yielded the hits "Pag Ghungroo Bandh," 'Raat Baaki," "Thodi Si Jo Pee Li," "Aaj Rapat Jaaye" and 'Jawan-e-Jaaneman Haseen Dilruba with Asha Bhosle became chartbusters.

with Bappi's music.

At a time when renowned music directors Laxmikant-Pyarelal, R.D. Burman, Kalyanji-Anandji, Ravindra Jain, Khayyam Rajesh Roshan were in demand, Bappi established his own identity with disco (retro film) music. He inspired a new generation of DJs around the world. So much so that Charanjit Singh produced "Synthesising: Ten Ragas to a Disco Beat" later in 2007, British-Sri Lankan rapper M.I.A came up with "Jimmy," a cover of the track "Jimmy Jimmy Jimmy Aaja" from Disco

Earlier in 2002, Bappi made news for another reason. American producer DJ Quik and executive producer Dr. Dre had used a sample of his song "Thoda Resham Lagta Hai" in their song "Addictive" by singer Truth Hurts.

However, after 2000, Bappi cut down on his music work. He later took to politics and contesed the 2014 Lok Sabha polls on a BJP ticket from the Serampore constituency in West Bengal, but was defeated.

vast diversity of religious symbols in all sections of the society. Why is the government picking on Hijab alone and making this hostile discrimination? Aren't bangles religious symbols?" Kumar told the full bench of the High Court comprising Justice Ritu Raj Awasthi, Justice J M Khazi and Justice Krishna S Dixit.

Questioning why no other religious symbol was considered in the government order and only the Hijab, the senior counsel wondered whether that was done because of his petitioners' faith.

'This discrimination against Muslim girls is purely on the basis of religion and hence a hostile discrimination. which violates Article 15 of the Indian constitution. We are not heard but straightaway punished. This is draconian," he argued.Kumar told the court that the purpose of education is to promote plurality and not homogeneity. "Classrooms should be a

place for recognition and reflection of the diversity in society," contended. Regarding the ban on Hijabs, he said that according to rule 11 of the 1995 rules--government provisions related to the Education Department--the educational institutions should give notice to the students and parents about changing uni-

form at least a year in advance. Stating that a dress code is not mandatory for the pre-university colleges, Kumar said, "prescribing uniform in the government pre-university col-

lege is illegal. Even the guide-Education department in 2021-22 did not speak about uniform." "It is an emphatic statement by the department that principals cannot prescribe a uniform. Neither the pre-university board and the rules nor the Karnataka Education Act prescribe any uniform or prohibition of Hijab. Such being the case, under what authority are we kept out of the class," he

Be it Chandni Chowk Market, Sadar Bazaar, Khari Baoli, all these markets are mentioned in the master plan. These are called commercial markets.

"The conversion charge is applicable when a residential area has been converted into a commercial one. But there is no point in charging conversion fees in a Mughal Era market, which is already a commercial market," he added.



Review Covid curbs as cases declining: Centre

Stating that the coronavirus pandemic in India is showing a sustained declining trend since January 21, the Centre has asked States and Union Territories to review, amend or do away with additional restrictions after considering the trend of new cases and positivity rate in their regions.

In a letter to the Chief

Secretaries and Chief Administrators of all States and UTs recently, Union Health Secretary Rajesh Bhushan said the coronavirus pandemic in India is showing a sustained declining trend since January

The letter, however, stated that States/UTs must continue monitoring the trajectory of cases and the spread of infection on a daily basis. The health secretary also asked states to follow the five-fold strategy of test, track, treat, vaccination and adherence to Covid-appropriate behavior.

The average daily cases during last week were 50,476, and 27,409 new cases were reported in the last 24 hours. The daily case positivity rate declined to 3.63 per cent on



Tuesday.

In earlier months, in view of the high case trajectory, certain states had imposed additional restrictions at their borders and at airports, he

While effectively managing the public health challenge COVID-19, it is equally important that movement of people and economic activities should not be hampered by additional restrictions imposed at state-level points of entries, Bhushan said in the letter.

"Presently, as the case trajectory across the nation is showing a sustained downward trend, it will be useful if states/UTs review and amend/do away with the additional restrictions so imposed after considering the trend of new cases, active cases and positivity within the state and UT," he said.

With the changing epidemiology of the pandemic globally and in India, existing guidelines aimed at minimising the transmission and circulation of the virus have been reviewed and updated. The Union Ministry of Health accordingly revised its guidelines for international arrivals on February 10, he stated.

Bhushan underlined that states and UTs may also follow the broad five-fold strategy of Test Track-Treat-Vaccination and adherence to Covid-appropriate behaviour.

Vistara resuming certain services to pre-Covid levels

Vistara on Wednesday said it is gradually resuming certain services that were suspended temporarily due to the pandemic. The airline has gradually been resuming services that were halted temporarily due to the pandemic, it said adding that on the domestic network, the choice of non-vegetarian meals in economy class on all eligible flights is also made available from January 1 this year. The airline said it has also resumed serving tea and coffee on select routes and will progressively restart this service on all flights of 90 minutes duration and above.

The airline also re-introduced menu cards in business class, starting February 15, and will increase the choice of meals for its premium economy and business-class customers soon, it said. Also, hot beverages services including a range of teas and freshly brewed coffee have also resumed on the international routes, and from February 1, the airline has enhanced the choice of alcoholic beverages in all three cabin classes.

On short to medium haul routes, menu cards are back in the business class and the airline has already made the full bar available to all customers, the airline said, adding, Vistara will be resuming these on the long-haul routes along with increasing the meal options for customers. "While we are restoring our services progressively and systematically, we will also be introducing new enhancements at various customer touchpoints," said Deepak Rajawat, Chief Commercial Officer, Vistara.

Channi says don't let UP, Bihar ke bhaiya enter Punjab; BJP hits back

A head of Punjab polls on Sunday, the remarks of Chief Minister "don't let UP, Bihar ke bhaiya enter Punjab'" at a rally in Rupnagar has provoked BJP leaders to strike back at Congress general secretary Priyanka Gandhi Vadra who was seen clapping and laughing at the venue. Priyanka is also leading the Congress charge in UP and is apparently the party's CM

As the four-cornered campaign and contest among Congress, AAP, BSP-SAD, and BJP-Punjab Lok Congress of ex-Chief Minister Amarinder Singh is peaking-up, rival parties have upped their ante to woo voters in the state that would vote for 117 assembly seats on February 20 in a single-phase election.

BJP's IT chief Amit Malviya shared a clip from the rally where the Punjab CM could be seen speaking in derogatory terms against people of UP, Bihar and Delhi. Malviya launched an attack on Congress and alleged that their leaders were dividing people instead of developing the country.

Malviya took to his Twitter handle to share a video of Punjab CM Channi and Congress' general secretary and Uttar Pradesh-in-charge Privanka Gandhi, In the video, Channi could be seen taking the microphone from Priyanka to state that she is a daughter-in-law Continuing his words, CM Channi praised the people of Punjab and asked them to use their wisdom and then commented against the people of UP and Bihar. Meanwhile, Priyanka was seen laughing and clapping to the slogans being shouted by the Congress

SC asks Centre on one rank one pension

The Supreme Court on Wednesday sought clarifications from the Centre on the One Rank One Pension (OROP) scheme. The apex court was hearing a petition filed by ex-service men associations on the disparities in implementation of OROP and Modified Assured Career Progression (MACP).

Seeing the tables of salary and differences produced by the petitioners, the Bench observed displeasure.

"There is no statutory definition of OROP. It is a matter of art. The fact of the matter is there is no statute of OROP. When you have framed policy, you have given a particular definition. The fact you have not gone further, is it violative of Article? Your hyperbole on the policy presented a much rosier picture that what is actually given," observed Justice DY Chandrachud, give convincing answers posed by the Bench, comprising

The Bench also observed that "what appears is that MACP has become a barrier for the grant of OROP."

Justices Surya Kant and Vikram

Justice Kant also said that, "what they say is that by connecting OROP and MACP you have substantially reduced the beneficiaries. There is a classification created by MACP. For eg: one is getting 800 and other is getting 1200 because of MACP and after they retire, the person will get more pension. The principle of OROF gets defeated."

ED arrests president of B'luru-based co-operative bank

PNS NEW DELHI

The Entorcement Directorate (ED) on Enforcement Wednesday arrested K Ramakrishna, president of Sri Guru Raghavendra Sahakara Bank Niyamitha, on money laundering charges in connection with misappropriation of public deposits to the tune of over Rs 1,000 crore.

The PMLA probe revealed that officers and employees of the bank siphoned off the money deposited by the public with the bank. The Bank promised to give higher interest rates to the depositors which were not in line with the prevailing market rate, the ED said in a statement.

'The money deposited by depositors advanced/siphoned off to various persons including employees of the bank without obtain-The bank officers created fictitious loan accounts and transferred the money to these accounts which in turn was transferred to overdue loan accounts for evergreening purposes to show strong financial health of the Bank," it said.

Earlier, the ED had attached movable and immovable properties worth Rs 45 crore. The Principal City Civil and Sessions Judge, Bangalore has granted four-day custody of

Ramakrishna to the ED. In a separate case of money laundering, the PMLA Special Court, Mumbai ordered confiscation of properties worth Rs 300 crore held in Singapore in

a Ponzi scheme fraud case.

These assets were beneficially owned by Sayed Masood, Chairman and promoter of City Limouzines (Î) Ltd and his family members. After extensive overseas

investigations, the ED had attached the bank accounts of foreign companies of Masood located at Singapore having a balance of approx Rs 300 crore. In addition to overseas assets, ED had also attached domestic assets of Rs 129 crore in this case. The ED is investigating a case of money recorded against City Limouzines (I) Ltd., Masood, City group companies and others. Masood, key conspirator and beneficiary, in connivance with other directors of the City Group of companies, laundered the investors' money by routing it through various countries and investing in movable and immovable

Masood has opened many companies trusts/bank accounts abroad without any requisite statutory permission in violations of Îndian laws which served as special purpose vehicles to launder the proceeds of his criminal activity of cheating more than 70000 investors of

Rs 700 crore. In yet another case, the ED has filed a Supplementary Prosecution Complaint (chargesheet) against Sanjay Agarwal and three others in a case of smuggling of gold, to the tune of 2,717 Kg of gold worth Rs 650 crore for money laundering.

Vacancies in tribunals: SC rues 'knee jerk' actions, says bureaucracy taking it lightly

The Supreme Court on Wednesday rued the "knee jerk" actions in filling up vacant posts in Tribunals, saying the bureaucracy has been taking up the issue "lightly". The bench headed by Chief Justice N V Ramana, which has been proactively dealing with the issue of huge vacancies in various tribunals across the country, said that after a few appointments made initially, nothing substantial happened.

"We are getting (pleas for) extension of time for the members of the NCLT (National Company Law Tribunal) ... Some knee-jerk appointments took place and nothing happened after that. We do not know the fate of members and many are retiring. Bureaucracy is taking it (the issue) lightly," observed the bench which also comprised justices A S Bopanna and Hima Kohli.

Attorney General K K Venugopal, who has been assisting the bench in dealing with the vacancies-related matters, attempted to show the list of vacancies and the steps taken to fill them up. The bench said that it would hear the issue after

The top court has been asking the Centre to make appointments in tribunals that are facing a severe crunch of presiding officers as well as judicial and technical members. As per data made available in á hearing in August last year, around 250 posts are lying vacant in various key tribunals and Appellate Tribunals across the country.

Climate change could boost dengue cases

 $R^{\text{ising temperatures and}}_{\text{untimely rains linked to cli-}}$ mate change are likely to push dengue cases and fatalities in the country, health experts have warned. They have attributed this spurt to increased survival, reproduction and biting rate of the mosquitoes causing vector borne disease.

Data speaks. Last year, mortalities due to dengue were significantly high at 247 cases till November, when compared to 66 deaths in 2020, according to the government statistics tabled in Parliament last week.

In fact, last year in September, in a high-level meeting chaired by Cabinet Secretary Rajiv Gauba and attended by representatives of 11 affected states/UTs, the government had flagged the emerging challenge of serotype-II dengue which is associated with more cases and more complications than other The States reporting serotype -II dengue cases were Andhra Pradesh, Gujarat, Karnataka,

Kerala, MP, UP, Maharashtra, Odisha, Rajasthan, Tamil Nadu, and Telangana.

To develop a safe, affordable and effective treatment for the vector-borne disease within five years, the Transitional Health Science and Technology Institute (THSTI), an autonomous institute of the Department of Biotechnology on Wednesday joined hands with, DNDi Drugs for Neglected Diseases initiative India Foundation engaged in developing new treatments for neglected patients.

As per the partnership, preclinical studies of potential dengue treatments will be carried out besides testing the efficacy of several repurposed drug candidates and implement clinical trials of the most promising compounds to deliver an affordable and accessible treatment solution.

"There are no specific antiviral drugs to treat dengue infection, and limited use of vaccines. Despite research and development to identify treatment for dengue fever, we have



not yet achieved sufficient results. It is important that we join our efforts to tackle the disease which affect millions of people," said Dr Pramod Kumar Garg, Executive Director of THSTI.

"It is critical to find therapeutic solutions to this climate-sensitive disease that spreads at a rapid pace,' added Dr Kavita Singh, Director, DNDi South Asia.

An analysis of data available from 400 stations of the Meteorological Department (IMD) across the country indicates that in the last 50 years, the number of hot days has increased manifold. Scientists say that heat waves incidents are projected to increase eight times in the near future and will spike to alarmingly 30 times in 2071-

According to the ministry, the production during 2021-22 is higher by 25.35 million tonnes than the previous five years' (2016-17 to 2020-21) average production of foodgrains. Four persons have been arrested in the instant case so far," the NIA said in a statement. During the searches, incriminating materials and digital devices have been seized, it said.

10 Jaish overground workers held in J&K

SIA raids 10 locations in South, Central dists of Kashmir

A total number of ten (10) doverground workers (OGWs) allegedly working with pro-Pakistan terrorist outfit Jaish-e-Mohammad have been arrested by the State Investigation agency (SIA) during overnight raids across 10 different locations spread between south and central Kashmir districts of Kashmir Valley in the last 24 hours.

According to official sources these OGWs were part of terror modules who were taking instructions from JeM terrorist commanders.

Meanwhile, the Srinagar police has also tracked down the footprints of another terror network set up by the "The Resistance Front (TRF) to carry out terror strikes in and around Srinagar city

According to a police spokesman, "Basit Ahmed Dar of Redwani Kulgam and

Srinagar were using the net-work of overground workers in the valley for subversive activities. Maidanporal. The spokesman added, "These OGWs were also found to be involved in creating content of the threatening posters issued by TRF from time to time. Through these posters they aimed to threaten Govt employees, Police, Armed Forces, elected PRIs and nonlocal businessmen and to cause disaffection against the state". It was also found that they had recently provided logistic support to three terrorists namely Momin Gulbar, Arif Ahmed Hazar and one foreign terrorist by provided them shelter and also facilitated them in carSrinagar city.

According to spokesman of the State Investigation Agency, the terrorist handlers were using these OGW's for recruiting other young persons, arranging finances, transporting weapons in south and central Kashmir besides providing

other logistic support.

In the searches, besides arrests, cell phones, SIM cards, records to show use of banking channels and even a dummy pistol were seized. Among arrested persons, there is one at whose house four terrorists had been killed on 4th of April 2020.

According to the SIA pokesman, "the arrested members were mostly recruiting vulnerable school and college going students as a few of them are students themselves. They were in close connection with the regular terrorists of JESH outfit and had been under surveillance for quite some time. The spokesman added the digital records seized are being sent to FSL for evidence analysis and the arrested persons would be presented before the NIA court in Srinagar seeking permission for custodial questioning.

agree to resolve boundary disputes

New Delhi: Assam and Meghalaya have agreed to resolve their boundary disputes in six locations and are ready to find solutions to six other such areas soon. Meghalaya Chief Minister Conrad Sangma said on Wednesday.

Meghalaya was carved out of Assam as a separate state in 1972 and it had challenged the Assam Reorganisation Act, 1971, leading to disputes in 12 locations along the two states' 884.9-km-long border.Sangma said the two states were making efforts to resolve the disputes.

"Assam and Meghalaya have held discussions related to six locations and came to an understanding on them," he told reporters here.

Sangma, along with his Assam counterpart Himanta Biswa Sarma, had met Union Home Minister last month and apprised him about the outcome of their discussions.

Sangma said they have submitted a report to the central government and he was hopeful that the Centre will invite both the states soon.

"When we will come, we will certainly resolve the differences on these six locations. "Our effort is that we will

resolve the differences on the remaining six locations before the 75th anniversary of India's independence," he said.

Sources said Assam and Meghalaya governments came to a consensus on the villages and identified natural boundaries such as rivers and forests.

There are 36 villages in the six places, covering an area of 36.79 sq km where an agreement has been reached.

Three committees each were formed by the two states in August last year after two rounds of talks between Sarma and Sangma were held to resolve the vexed border dispute in a phased manner.

According to the joint final set of recommendations given by the committees, out of 36.79 sq km disputed area taken up for settlement in the first phase, Assam will be getting full control of 18.51 sq km area and Meghalaya of 18.28 sq km.

Out of the 12 points of disputes between Assam and Meghalaya, the six areas with relatively less critical differences were taken up in the first

Case against CM of Assam over lewd jibe at Rahul

Hyderabad: A case was registered against Assam Chief Minister Himanta Biswa Sarma here for his alleged remarks on Congress leader Rahul Gandhi, police said on Wednesday.

Based on a complaint filed by Telangana Pradesh Congress Committee (TPCC) President and party MP A Revanth Reddy, a FIR was registered at the Jubilee Hills Police Station, they said."A case was registered against the Assam CM under relevant IPC sections after taking legal opinion", a senior Police official told PTI.

Revanth Reddy in the complaint had accused Sarma, of making obscene speech against Rahul Gandhi (on February 11 at a public meeting in Uttarakhand) deliberately and in a pre-planned manner to garner political mileage and sought for registration of an FIR against the Assam CM. Sarma had slammed

Gandhi for demanding proof of the September 2016 surgical strike launched by the Indian Army against terrorist camps in PoK, and questioning the efficacy of the anti-Covid-19 vaccines, during a rally in pollbound Uttarakhand.

The Assam CM had sought to know whether the BJP had ever demanded proof of him

The remarks drew sharp criticism from the Congress

being the son of former Prime Minister Rajiv Gandhi.

Protest against killing of villager by forest guards in Assam's Morigaon

Morigaon: Locals and hundreds of student activists on Wednesday protested against the killing of a villager by forest guards for allegedly cutting trees inside the Sonaikuchi Reserve Forest in Morigaon district of Assam.

The protesters under the banners of All Tiwa Students' Union (ATSU), Karbi Students' Union (KSU), Karbi Students Association (KSA), Tiwa Yuva Chatra Parishad (TYCP), All Tiwa Women's Association (ATWA), Morigaon District Tribal Sangha and All Assam Tribal Youth League (AATYL) and All Assam Students' Union (AASU) staged a two-hour dharna.

After the demonstration near the Morigaon Deputy Commissioner Court, the protesters sent a memorandum to Chief Minister Himanta Biswa Sarma, seeking a judicial inquiry into the firing incident and also demanded the arrest of the forest beat officers of Jagiroad and Kuthori for their alleged role in the incident.One person, identified as Borsing Tiso, was killed on the spot and another, named Rajib Singnar, was injured in firing by forest guards when the duo was allegedly cutting trees inside the forest near Jagiroad in Morigaon district on Tuesday.

The protesters alleged that the firing was indiscriminate and should be treated as murder as the victims were allowed to enter the Sonaikuchi Reserve Forest by forest officers, but later the duo was shot at by some other officials.

The issue of Ukraine trying to secure a Nato entry is much more complicated than it seems

President says he is pulling back some troops from the Ukraine border but the Americans say they see no such movement. Earlier, there were reports that he had mobilised enough troops to launch an invasion. But it was subsequently said he had not taken that call. If this pattern has to make sense, it can mean only one thing. Putin will not launch an invasion unless there is a provocation. The worry for the Americans and Nato leadership is even a false incident could provoke him into action. Putin has made clear what he wants. He is strictly against Ukraine getting a Nato membership. An eastward expansion of Nato would bring the United States to Russian borders and encroach into Russia's sphere of power and influence. Putin wants Nato's military presence near Russian borders curtailed, as also neutralising Ukraine. US President Joe Biden, intent on forgetting the embarrassingly quick withdrawal from Afghanistan, wants to be the crusader by thwarting Russia and protecting Ukraine, but without having to wage a war for it. Does it then seem that both leaders have a strong motive to fight a war or merely magnify the threat of war?

President George W Bush forced Nato in 2008 to invite Ukraine, along with Georgia, to become members. There was no set date and Nato has never offered a formal invitation to join. Some Nato members were sceptical, considering Ukraine was farther to the east and much closer to Russia. Biden has been handling the Ukraine-Nato busi-

ness off and on for several years, since when he was a member of the American Senate Foreign Relations Committee. He is witness to all the deliberations that never officially led to a formal Nato invite to Ukraine. There are three conditions for a country to join Nato.

One, it should be democratic and honour the rule of law. Two, it should be able to contribute to the joint defence of Nato member-States. Three, all 30 Nato members should approve the application. There are enough reasons suggesting these conditions make it difficult for Ukraine to have an easy entry into Nato. On the other hand, Ukraine always dreams of joining Nato. The objective was enshrined in their Constitution in 2019. However, they could never shed themselves of Russian presence and pressure in their attempts to get closer to Nato. Former Presidents Viktor Yushchenko and Viktor Yanukovych did their best to gain entry into Nato. Yanukovych could not even manage to sign an agreement to be associated with the European Union. Even now, they have not given up their "dream" and are looking for "other arrangements" to allow them to "survive" the present crisis. They know Russia can defeat them in a war but it can gain more leverage by merely threatening to attack. It is a matter of what concessions Russia seeks and who is willing to concede them.

There's quite a bit of hostility between the Governments and Governors in three States

hree States in the Union are witnessing a spectacle of confrontation between the BJP-appointed Governors and the Governments concerned. The bad blood between Bengal Governor Jagdeep Dhankhar and Chief Minister Mamata Banerjee is now folklore. Along similar lines, the confrontation between Tamil Nadu Governor RN Ravi and Chief Minister MK Stalin is brewing on an hourly basis due to the former's refusal to toe the political line of the DMK Government. The Governor's refusal to sign the Bill scrapping NEET in the State made Stalin and the ruling party furious and they retaliat-

ed by ridiculing the State's top authority. In Kerala, Arif Mohammad Khan has questioned the Government's propriety of appointing party cadre as personal staff members of Ministers, paying them hefty salary and perks. The cadres who serve these Ministers for a minimum of two years are eligible for a monthly pension equivalent to Government staff's with more than three decades of service. The cat is out of the bag as there is deep desire among the party cadres to get on board as the personal staff of Ministers. Interestingly, all the three Governors were appointed by the BJP Government at the Centre while the three States are ruled by staunch critics and rivals of the Hindutva party.

Hence it is guite natural to have strained ties between the Governors and the non-BJP State Governments. Ravi is a retired IPS officer who did a commendable job while in service and even after retirement. Khan is quite unique in his approach to various issues. He shot to fame as a young Cabinet Minister in the Rajiv Gandhi Government when he put in his papers over the Centre moving a Constitution amendment Bill to derail the Supreme Court verdict in the Shah Bano case on maintenance allowance to divorced Muslim women. Khan, who took charge as the Governor in 2019, has become a popular First Citizen of the State within no time. He visited the houses of most of the young brides who had committed suicide/were murdered over dowry-related issues and made youngsters take the pledge that they would never accept dowry. He has warned the Kerala Government about the state of affairs in universities which have become centres offering employment to close relatives of Ministers, MLAs and party bigwigs despite not being qualified enough. Something is rotten in TN and Kerala as the elected Governments fume while people support these Governors.

SC as the guardian of our Constitution



Soft encroachment by the Govt in the ambit of Fundamental Rights can affect the Constitution's basic structure, which the apex courts guards against

he argument that our Constitution denotes a rational restriction on the Government to negate arbitrary despotism can't be reinforced enough. A Government that infringes upon the ideals of the Constitution loses its legitimacy. To overbridge such lacunae, and to preserve the basic privileges guaranteed to individuals as regards dignity and personality, the Constitution should be permeated with a dash of constitutionalism The role of media in com-

municating authentic, crucial and path-breaking information and playing the paramount role of monitoring and examining the Government's policies and legislative enactments is epochmaking. The ideals and principles of a democratically fashioned State mandate the supreme judicial authority in sustaining constitutional morality from being suppressed. The freedom of speech and expression is not just legal but a constitutional right which is enshrined as the foundational parameter and an essential pillar of a democratic Union. The arbitrary suppression of speech and expression is direct curtailment of the democratic principles enshrined in the Constitution. The Supreme Court has, however, prudently upheld the sanctity of freedom of speech and the exclusive rights of media in a few judicial pronouncements, and it has broadened the notion of Fundamental Rights against discretionary speculation. The Supreme Court has accentuated upon the Fundamental Rights while adjudicating upon Mohan Lal v Union of India and Vinod Dua v Union of India, respectively. The free speech and expression incorporate and encapsulate the inviolable principle of privacy as well.

In the judgment of Manohar Lal v Union of India, famously known as the Pegasus case, the judicial contention staunchly precludes arbitrary encroachment in the confines and purview of Fundamental Right of speech — rupting public order and har

lated that the Union Government cannot breach national security in order to evade reasonable accountability. The protection of credible journalistic sources is irrefutably covered under the ambit of privacy and surveillance of the sources/information is an absolute assault on the sanctity of the press and the democratic ideals. The judgment has directed the establishment of a technical committee to examine the legality of Pegasus intrusion and privacy breach.

In another path-breaking

judgment of Vinod Dua v Union of India, the journalistic voicing that could potentially lead to constructive criticism was intelligently bifurcated from the seditious and defamatory ambit. The contentions in the matter concerned revolved around the question whether the statements of the journalist in question were in any way seditious in nature as covered under Section 124-A of the Indian Penal Code, 1860, and incited agony and hatred among citizens. Furthermore, did the statements have the potential of disand the scope of privacy of an individual. The apex court pragmatically opinioned and articu-

The Supreme Court has referred to the landmark pronouncement of the Kedar Nath Singh case to uphold the speech and expression narrative and stated that for an act to be a seditious offence, the inclusion of a few attributes has to be examined, including the incitement of hatred against the authority concerned, and the disturbance of public order.

If journalistic opinions and voicing are not protected by the judicious authority and the 'sources' of journalists are under constant threat and surveillance, then the concept and idea of a democratic State will become obsolete. Such soft encroachment in the ambit of Fundamental Rights can easily affect the basic structure of the Constitution. Constitutionalism not only upholds the morality and principles of the Constitution but also gives and limits the power of Parliament and the Union Government. The Court. HIJAB ROW: MORE THAN WHAT MEETS THE EYE

Active involvement of CFI clearly points to this being a manufactured controversy

o view the Hijab brouhaha merely as a spontaneous, isolated altercation between a clutch of Muslim girls and the college authorities of a government run institution is to miss the wood for the trees. When carefully parsed, this confrontation appears to be an orchestrated controversy that is a part of a bigger gameplan with fundamentalist and political undertones. It is a subtle attempt by one community to hijack secularism of the nation by exploiting its fault lines.

On October 29 2021, some Muslim girl students who had participated in an ABVP organized protest against a sexual assault on a student came to the notice of the Campus Front of India (CFI), a student wing of the radical Popular Front of India. These particular students were counselled not to join ABVP-organized protests and advised to join the CFI instead; today some of these same students are at the forefront of



In November, a small group of Muslim students began alleging discrimination in the collge. The issue of wearing a hijab was also raised at this time. The college development committee met with the students and their parents in December to amicably resolve the issue. Six of 12 students relented but the remaining remained adamant and were refused entry into the classroom in late December when they came wearing hijabs.

Subsequently, a petition was filed in the Karnataka HC on behalf of these students. The CFI and the agitating students openly admit to be working together. There are reports that 4 twitter handles were created in October-November 2021 for posting updates on the issue as well as other CFI content. Also, parents of three of the protesting girls are active members of the SDPI -- the political wing of PFI.

The time line of the above noted events and the active involvement of the CFI in this matter clearly point to the possibility of this being a manufactured controversy with an all too well- known modus operandi-- first provoke and when the other side responds blame the other party and feign victimhood.

Over the last couple of years there has been a tendency to blow up issues, some genuine and some not, out of proportion by exploiting fault lines to stoke discontent in specific communities like students, religious minorities and farmers- all with the malicious intent of creating chaos and confusion to rock the stability of the nation and put the government

The Hijab controversy has all the crafty trappings of the same previous 'create anarchy' projects. Visuals on social media like the one depicting a lone Muslim girl confronting a swarm of saffron clad male students chanting 'Jai Shri Ram' are meant to evoke sympathy by playing up the gender card as was the Shaheen Bagh movement during the CAA protests. Reports are now emerging that the video maybe doctored and that the Muslim girl allegedly actually taunted the male students to provoke a response that could be filmed.

The instant organization of solidarity marches across the country supported by the Muslim clergy (in Ludhiana Imams of 80 mosques organized a Hijab march on Jan 12) are further evidence of a systematic coordinated effort to disrupt normalcy in the country. The Karnataka government did well to close down educational institutions and ban protests in their vicinity to prevent anti-social elements from exploiting

One needs to be careful in extending support to a cause whose motives are suspect. Agreed, protest is an inherent right in a democracy. But to resort to protest at the drop of a hat makes a mockery of this

Train 18/Vande Bharat must excel its ancestor



ICF did build a great train but was it world class? Not quite because it was sought to be completed in 18 months against the international 36-42 months

t is euphoric that Train 18, on the day of its unveiling and launch by the Prime Minister at Integral Coach fac-tory, Chennai (ICF) safely breached the 180 km/h speed barrier. Team ICF had delivered the first modern train entirely of Indian origin from concept to delivery at much less than half the cost of import. The way the country loved and celebrated this Make in India projectwas beyond imagination, considering it was just a train.

The first pair of the train are in successful servicewithout any break in it service, a feat not paralleled by even any imported rolling stock so far.

That the team was later hounded through the poisonous instrument of scoundrels, "give a dog a bad name and hang him", is a thing of the past with a change in the leadership of Indian Railways. The pride of shining success of the trainhas been restored to the team which built it,after it suffered crooked machinations, vilification of the train and witch-hunt of the team members. Although not everyone of the team has been revived but be that as it may, it is time

to look at the future dispassionately.

The PM has been fashioning it as a symbol of aspirational India, announcing on August 15th 2021 that 75 such trains would criss-cross the country in 75 weeks. IR has already unfolded a plan for 104 such trains, with equipment orderedfor 44 trains and procurement underway

ICF did build a great train but was it a world-class? Not quite. It wanted to, but there was a race against time as ICF was trying to do something in 18 months against the international norm of 36 to 42 months. Now is the time to look at it very closely to turn out the new avatar of the train which must be necessarily be an improvement over the first two.

What would be the recipe for the new

Let us first get the bizarre creation of a new specification asit was nothing but an exercise driven by jealousy, venality and insipidity. It attempts to enhance the acceleration of a train which was at the optimum already or improve the rideof a train which has a ride-comfort superior to existing coaches. These 'boil the ocean' modifications would neither cut down travel time nor improve travel experience but the die is cast; One can only hope that these complications, given that these changes have already set back the project by three

Otherwise, there are not many technical issues to be addressed but, even those there are, should be addressed strongly, like the improper ventilation of traction motors, unfriendly cable layout, disuse of Stepper in the Plug door etc. It is learnt that the Stepper in the Plug Door is being eliminated; that would be a defeatist way to solve a problem.

Train 23:Assuming we would have 104 rakes in five years from now, where would we deploy them?Shatabdis are clear candidates but that would mean only about 25 to 30 rakes. So, development of a Sleeper version is a must to replace conventional Rajdhani rakes. It was planned in 2018 as Train 19 project but later consigned to limbo

in 2019. ICF must start work on this train to be turned out by early 2023.

Train 25:Train 20 was planned as a future-ready train for speed range 160-200 km/h operation; such speeds may become a reality on IR although the prospects today appear bleakwith the works for 160 km/h fitness of infrastructure moving slowly. In any case, migration from 160 km/h to 200 km/h is not a complicated exercise. Train 20 project called for an Aluminiumbodied train set.To minimise expenditure on track and allied infrastructure, it should be provided with Pendolino type tilting mechanism too. It should be possible to move a project for, say, 500 coaches or 30 train sets, on the model made by ICF in 2018, which envisaged true partnership in design and manufacture, unlike IR's conventional ToTregime, with shed space being made available to the manufacturing partner at ICF. This model would equip ICF to be ready for design and manufacture

ly', a US survey reported. Nevertheless, sexual harassment is a reality for both men and women but 'women have more than twice the risk of becoming a victim of harassment'. The Australian Human



Rights Commission found that one in four women and one in six men have been subjected to workplace sexual harassment. In European Union countries, between 40 and 50 per cent of women experience unwanted sexual advances, physical contact or other forms of sexual harassment at work. In the United States, 38 per cent of women have been victims of different forms of harassment, 77 per cent being verbally abused while 51 per cent are

touched without permission, with international standards'. and 55 per cent of victims experienced retaliation after making a complaint. A survey by ABC and Washington Post said that '95 per cent of harassers go unpunished, and the perpetrators are often protected'. Across Asia, studies in Japan, Malaysia, the Philippines and South Korea accounted that about 30 to 40 per cent working women face offensive Now, the latest report of the

World Policy Centre, UCLA, said that more than one-third of the world's countries do not have any laws prohibiting sexual harassment at work, and nearly 235 million working women still remain unprotected. While, the ILO's report observed that 'even where laws exist, they are always compliant ullifies the objective of the law

China is still mulling over a such a legislation with no clearcut timeline for implementa-

India does have the PoSH act, 2013, as a legal antidote but its efficacy has been questioned with many women activists dubbing it 'weak in content, and is hardly an empowering instrument, which used only the broad framework of the SC laid down Visakha guidelines and judgement, and, departed in many ways, like by diluting the due process rights, reducing the employer's liability, and there by, allowing to manipulate or bypass the process altogether'. Further, the provision for punishing a woman, if her complaint and evidence found to be false or malicious, 'completely

commented many lawyers.

In case of women workers in the informal sector, who are 'more often forced to prioritise their income over their wellbeing', the 'act so far proved to be only a piece of paper'. The local committees (LCs), the redressal fora, exist only in 29 per cent of districts. In the organised sector, 'the employers, by and large, do not play any role in ensuring that the internal complaint committees (ICC) are equipped to deal with the procedures as per law, or have proper co-ordination with the personnel/disciplinary authorities and don't treat the issue as a policy matter and integrate it in service rules', said a Mumbai-based lawyer.

No wonder that a 2016 survey found that 'women victims generally shy away from

reporting to the management due to embarrassment, lack of confidence in the complaints mechanism, unawareness and stigma attached with sexual harassment'. An advisory firm which helps listed companies in PoSH act compliance, disclosed that the cases reported to the ICCs of 44 NIFTY companies reduced by 2.6 per cent in 2019-20. Russia: Pulled back more troops amid Ukraine standoff

R ussia said on Wednesday it was returning more troops and weapons to bases, yet another gesture apparently aimed at easing fears it is planning to invade Ukraine, even as the US said the threat of an attack remained.

Russia has massed about 150,000 troops east, north and south of Ukraine, sparking Western concerns it was planning an assault. There

have been no indications of a significant withdrawal of those forces, but this week has seen a handful of gestures from Moscow that offered hope that Europe might avoid war following weeks of escalating East-West tensions.

On Wednesday, the Russian Defence Ministry released a video showing a trainload of armoured vehicles moving across a bridge away from Crimea, the Black Sea peninsula that Russia annexed from Ukraine in 2014.

It said the movement was part of a return of forces to their permanent bases.

A day earlier, the ministry reported the start of a pullback of troops following military exercises near Ukraine. And Russian President Vladimir Putin signalled he wanted a diplomatic path out of the crisis, emphasising that he did not want war and would rely on

goal of keeping Ukraine from joining NATO.While the US and its allies continued to express skepsticism about Russia's intentions, the moves nonetheless changed the tenor amid the worst East-West security crisis since the Cold War.

Still, Putin did not commit to a full withdrawal, saying Russia's next moves in the standoff will depend on how the situation evolves. The Russian military hasn't given the number of troops or weapons being withdrawn and offered few other details. President Joe Biden

noted Tuesday that American officials had not verified Russia's claim."Indeed, our analysts indicate that they remain very much in a threatening position," Biden said in remarks at the White House. Still, he promised that the US would give diplomacy "every

British Defense Secretary Ben Wallace also said "it's too soon to tell" whether the pullback is genuine, noting that the Russians "haven't taken the foot of the gas.

"I think what we haven't seen is evidence of withdrawal that has been claimed by the Kremlin," he told Sky News. "In fact we've seen continued buildup of things like field hospitals and strategic weapons systems. Until we see a proper

Biden: US has not verified claim of Russia troop withdrawal

President Joe Biden on Tuesday said US has "not yet verified" Russia's claim that some of its forces have withdrawn from Ukraine border and said an invasion of Ukraine remains a distinct possibility. Biden made remarks at White House hours after Russia announced that some units participating in military exercises near Ukraine's borders would begin returning to their bases. Russian President Vladimir Putin earlier Tuesday said Russia was ready for talks with United States and NATO on military transparency, missile deployment limits and other security issues. But Biden continued to express skepticism about Russia's intentions. Biden warned again that if Russia invades Ukraine US "will rally world to oppose its aggression. Putin had said Tuesday he welcomed a security dialogue with West as his military reported pulling back some of its troops near Ukraine -signals that may indicate Kremlin has opted for a diplomatic path for now despite Western fears of an imminent Russian invasion of its neighbor.

US Ukrainian clergy, flocks show support amid Russia crisis

Yuriy Opoka prays his wife and young daughter will be safe in Ukraine as he closely follows massive buildup of Russian troops on country's borders and dire warnings that they could invade at any time. The 33-year-old journalist often calls his family from Philadelphia, where he's attending an English course, and recently joined others in city's Ukrainian community at a rally calling for peace back home. "My 5-year-old daughter asks my wife why Russians want to kill Ukrainians," Opoka said about his loved ones, who live in the western city of Lviv. "I'm frustrated and also worried about them."Religious leaders and members of Ukrainian diaspora in United States are growing increasingly concerned over threat of a dramatic escalation of nearly decade-old conflict and have stepped up efforts to show support for family members and their Eastern European homeland. That support ranges from offering spiritual succour during special praver services and maintaining charitable donations to orga nizing demonstrations.

NATO sees no sign Russia is pulling back troops near Ukraine

Russia said Wednesday it was returning more troops and weapons to bases, but NATO declared it saw no sign of a drawdown as fears that Moscow could invade Ukraine soon persisted. US Secretary of State Antony Blinken and External Affairs Minister S Jaishankar were part of Quad meeting on February "As Democratic and Republican co-chairs of Congressional Caucuses for Japan, Australia, and India, we take note of Quad Foreign Ministers' Meeting that took place in Melbourne, Australia," said a Joint Statement issued by Co-Chairs of Congressional Japan, Australia, and India Caucuses, and HFAC Asia Subcommittee on Monday. "As

staunch supporters of closer relations between United States and Japan, Australia, and India, we are pleased to see further development of this critical partnership through last week's ministerial meeting. We will continue to work in a bipartisan manner to assist in that development from Congress," it said.

By advancing cooperation on CÓVID-19 vaccination delivery, humanitarian assistance and disaster relief, the environment, maritime security, counterterrorism, cybersecurity, combating foreign disinformation campaigns and economic coercion as well as standards for critical and emerging technologies, the Quad is advancing a positive vision for future of Indo-Pacific rooted in shared values and supported by unique capabilities of member countries, the state-

It noted that last week's Quad meeting builds upon outcomes of in-person leaders' summit in September 2021.The lawmakers hoped that United States and Quad will continue to engage other countries and multilateral organisations throughout Indo-Pacific-including Association of Southeast Asian Nations which will continue to play a central role in American engagement with region

Protesters against US grant clash with riot police in Nepal

Protesters opposing a proposed US half-billion dollar grant for Nepal clashed with police outside Parliament on Wednesday, leaving injuries on both sides. The proposal was scheduled to be presented in Parliament for approval, but the debate was postponed because of disagreements among political parties. There has been growing opposition to the grant, mainly led by Communist parties. The money is meant to be used for the construction of power transmission lines and improvement of roads in the Himalayan nation, but the par-

ties allege it comes with conditions that are not acceptable. Two of the Communist parties are part of the coalition government. They claim the conditions in the grant agreement will prevail over Nepal's laws and strike at the country's sovereignty. They say it's part of Washington's Indo-Pacific strategy, which has military components that could bring American soldiers to Nepal.US officials have spoken to Nepalese leaders recently to assure that grant concerns only Nepal's development. A few hundred protesters managed to push through thick lines of riot police, who used bamboo batons and fired tear gas.

Pelosi in Jerusalem: US support for Israel is 'ironclad'

 $A^{\rm merican\ support\ for\ Israel}_{\rm remains\ "ironclad,"\ US}$ House Speaker Nancy Pelosi told members of Israel's parliament Wednesday, despite deep differences between the nations on Iran, peace with the Palestinians and other issues. Pelosi stuck to what the US and Israel have in common, particularly on their desires to rein in Iran's nuclear capabilities and find a path toward peace with the Palestinians. "The US remains ironclad, I keep using that word, in our support of Israel's security and its regional stability," Pelosi said with her

Mickey Levy, standing nearby. The face-to-face diplomacy came at a tense time in the nations' relationship as talks about a deal to rein in Iran's nuclear capabilities drag on in Vienna. US President Joe Biden campaigned on renewing and expanding the Iran nuclear deal after former President Donald Trump, with strong encouragement from then-Prime Minister Benjamin Netanyahu, withdrew the United States in 2018. Since then, the US has reimposed sanctions and Iran has stepped up its nuclear activities, amassing a stockpile of highly

enriched uranium that goes well beyond the bounds of the accord. Israel has said it will not be bound by any international agreement concerning Iran's nuclear program, and says it is prepared to take military action if needed to prevent Iran from obtaining nuclear arms. Iran insists its nuclear program is solely for peaceful purposes. Standing before a vibrant mural in the Knesset's Chagall Hall, Pelosi said Israel and US remain concerned about same threat from Iran and its proxies. We are together in fight against terrorism posed by Iran, both in region and also its nuclear development," she said.

EU summit aims to counter China, Russia influence in Africa

European Union leaders want to re-engage with African nations and counter the growing influence from China and Russia across the continent during a two-day summit in Brussels. The EU-African Union gathering starting Thursday was initially planned for 2020 but was postponed due to the coronavirus pandemic and agenda issues. It will be the first time EU and African Union leaders meet in that format since 2017. The aim for the EU is clear: to remain partner Africa's choice.European Commission president Ursula von der Leyen

travelled to Senegal last week to meet with President Macky Sall, who also chairs the African Union. She announced a 150-billion euro (\$170 billion) investment plan in Africa as part of the EU's so-called Global Gateway project, which is widely seen as an alternative to China's Belt and Road Initiative. China's programme aims to develop markets and new trade routes connecting China with the rest of the world by weaving a network of ports, bridges and power plants that will yield diplomatic clout and global power. The EU's project is expected to mobilise, in total, up to 300 billion euros (\$341 billion) in public and

private funds by 2027. "We will demonstrate that the European Union is Africa's most trusted partner," said Josep Borrell, the EU's top diplomat, ahead of the summit. "We will thereby also counter negative narratives and disinformation about what Europeans are and what Europeans are doing for, and with, the African people."In 2020, the EU was Africa's largest single trade partner, and China was its second largest. The EU said that its investment package for Africa is meant to bolster a green and digital transition, accelerate sustainable growth and job creation, and strengthen edu-

Chancellor Karl Nehammer announced the decision at a news conference in Vienna, stressing that the pandemic is not yet over but the situation allows Austria to open up step by step. Proof of a negative test will suffice for those things. From March 5, most restrictions will be dropped, with night clubs reopening and restrictions on opening hours for restaurants and bars ending. Nehammer said that a requirement to wear protective FFP2 masks will remain in place where it is necessary to protect the most vulnerable, including in public transport, essential shops and

Biden orders release of Trump White House logs to Congress

President Joe Biden is ordering the release of Trump White House visitor logs to the House committee investigating the riot of January 6, 2021, once more rejecting former President Donald Trump's claims of executive privilege. The committee has sought a trove of data from the National Archives, including presidential records that Trump had fought to keep private. The records being released to Congress are visitor logs showing appointment information for individuals who were allowed to enter the White House on the the day of the

insurrection.In a letter sent Monday to the National Archives, White House counsel Dana Remus said Biden had considered Trump's claim that because he was president at the time of the attack on the US Capitol, the records should remain private, but decided that it was "not in the best interest of the United States" to do so. She also noted that as a matter of policy, the Biden administration "voluntarily discloses such visitor logs on a monthly basis," as did the Obama administration, and that the majority of the entries over which Trump asserted the claim would be publicly released under current policy.

"We have filed another application on the manner the death penalty has been administered in (Singapore) and the various breaches on right to life and unequal treatment," Ravi wrote on Facebook. He said the new hearing was due on Thursday morning. The two men, who were arrested for smuggling drugs into the country, will be the first to be executed since November 2019 if their sentences are upheld.

Malaysian Pausi Jefridin and Singaporean Roslan Bakar were sentenced to death in 2010, two years after being arrested. Lawyers and rights activists say Pausi has an IQ of only 67 - a level that is internationally recognised as an intellectual disability - while Roslan has a borderline range of intellectual functioning.

In 2017, a lower court judge found that two "displayed competence and comprehension while carrying out the act they were sentenced according Transformative Justice

U.S. Defense Secretary Lloyd Austin and his counterparts also plan to weigh possibility of stationing troops longer-term in southeast Europe, possibly starting later this year. The troops would mirror presence of some 5,000 servicemembers that have been stationed in allies Estonia, Latvia, Lithuania and Poland on a rotating basis in recent years.The U.S. Has started to deploy 5,000 troops to Poland and Romania.

Britain is sending hundreds of soldiers to Poland and offering more warships and planes. Germany, the Netherlands and Norway are sending additional troops to Lithuania. Denmark and Spain are providing jets for air policing.

"The fact that we have deployed more NATO troops on ground, more naval assets, more aircraft, all of that sends a very clear message," NATO Secretary General Jens Stoltenberg said. "I think there is no room for any miscalculation in Moscow about our commitment to defending allies.

"The deployment has come in response to a formidable challenge. Over last four months, Russia is estimated to have amassed around 60% of its entire land forces and a significant portion of its air force to north and east of Ukraine, as well as in neighboring Belarus.

Indian Winter Olympics pioneer Shiva Keshavan has been inducted into the Olympians For Life hall of fame for his role in promoting the Winter Olympics, winter sports, luge and the spirit of Olympianism.

Keshavan is the first Indian winter-sport participant and second overall after boxer MC Mary Kom to be named Olympian For Life. Mary Kom was inducted in 2016 during the Rio Olympics.

Keshavan, the first Indian to represent the country in Winter Olympics and in luge in 1994, has participated in six Olympics, has won gold in the Asian Luge Cup and also held the Asian speed record.

He was on Tuesday among five Olympians who were inducted into the World Olympians Association's Olympians For Life hall of fame for the Beijing Winter Olympic Games in an online function.

The Olympians For Life programme was launched by the World Olympians Association in 2016 during the Rio de Janeiro Olympics. As per this programme, five persons that have participated in the Olympics have declared Olympians For Live during every Summer or Winter Olympics since 2016.

Apart from Keshavan, others that were named Olympians For Life for the Beijing 2022 Winter Olympics are Simidele Adeagbo of Nigeria who participated in the skeleton; Alain Calmat of France who participated in figure skating; Clara Hughes, a speed skater from Canada and Ben Sandford of New Zealand, who participated in

Keshavan is the first and only five-time Olympian to be included on the occasion of the Beijing 2022 Games.

Keshavan was inducted for his trailblazing achievements and initiatives in grassroots development programmes to grow winter sports within India.

'My experience as an Olympian gave me a great platform to help provide more opportunities for younger generations to get involved with sport. India cruise to six-wicket win over WI

urkyakumar Yadav played the finisher's role to perfection after skipper Rohit Sharma blazed away at the top as India secured a clinical six-wicket win over the West Indies in the first T20 International here on Wednesday.

At his favourite Eden Gardens, Rohit smashed a 19-ball 40 (6x3, 4x4) to give India the perfect foundation after his bowlers restricted the

visitors to 157 for seven.

In the company of Venkatesh Iyer (24 off 13), Surkyakumar then hit a brisk 34 in just 18 deliveries to help India chase down the target of 158 with seven balls to spare and take a 1-0 lead in the three-match

Roston Chase (2/14) bowled brilliantly in the middle overs and dismissed the two Indian openers -- Rohit and Ishan Kishan -- before the hosts also lost Virat Kohli and Rishabh Pant to leave them at 114/4

The most expensive IPL buy, Ishan Kishan, who was bought back by the Mumbai Indians for a staggering Rs 15.25 crore, made 35 in 42 balls before becoming Chase's second victim.

Kishan, who opened the batting with the skipper, struggled to get

going even as Rohit looked in full flow.

Former India skipper Virat Kohli also continued his lean patch and fell cheaply for a 13-ball 17, hit-ting straight to Kieron Pollard at

long-off boundary.
But Rohit's flying start meant that India remained on course before Suryakumar and Iyer produced the finishing act with an unbroken 48run partnership from 26 balls.

Suryakumar was brilliant all around the wicket and smashed one six and five fours in his unbeaten knock while Iyer, playing with an injured hand, too looked in great

Rohit went into the attacking mode from the second over when he smashed Romario Shepherd over deep square leg.

Odean Smith bore the brunt of

Rohit's excellent batting as the captain took him to the cleaners with a 6, 4, 6 off successive balls to collect 22 runs from the over.

The 50-partnership was up for India in just 4.3 overs but Rohit could not convert his start and was dismissed by Chase while trying to clear the deep midwicket fence.

For the Windies, Chase was impressive and also took the wicket of Ishan Kishan to finish with fantastic figures of 4-0-14-2.



Earlier, on a high after his hefty IPL buyout, wicketkeeper-batter Nicholas Pooran returned to form a with a brisk 61 as West Indies recovered from a mid-innings slump to post a fighting total.

The left-hander, who clinched a fat paycheck of Rs 10.75 crore from Sunrisers Hyderabad in the IPL mega auction, got back to rhythm in style, scoring his runs in 43 balls with five sixes and four boundaries.

The Windies No. 3, who endured an abysmal last IPL with 85 runs at a poor average of 7.72 and had scores of 18, 9 and 34 in the preceding three ODIs, made his intention clear by smashing Bhuvneshwar

Kumar for a big six early on.

The Indian spin duo of Yuzvendra Chahal and debutant legs-pinner Ravi Bishnoi derailed the Windies in the middle overs by taking three wickets in between them, unleashed their fury in the death by scoring 61 runs in the the last

A fit-again Kieron Pollard, who missed the last two matches in the ODI series, played a cameo (24 not out from 19 balls) with two fours and one six.

Jodhpur's googly man Bishnoi made his debut memorable as he returned tidy figures of 4-0-17-2, including the wickets of Roston Chase (4) and Rovman Powell (2) in a space of four balls to derail the Windies in the middle overs.

Bhuvneshwar got his swing going up front and dismissed Brandon King (4) in the first over after the batter had failed to negotiate his outswingers. Kyle Mayers and Pooran

steadied the innings before the wicketkeeper broke the shackles with a big six against Bhuvneshwar. Mayers also stepped it up

against the likes of Chahar and Harshal Patel as the Windies enjoyed a decent powerplay, reaching 44/1 in six overs. Rohit was quick to bring in
