# Murder of Bajrang Dal's Lalu gets 5 years RI in activist sparks violence

#### 2 held; Harsha's funeral procession stokes anger

PNS SHIVAMOGGA (KARNATAKA)/MUMBAI

A<sup>28</sup>-year-old Bajrang Dal activist, Harsha, was stabbed fatally in Shivamogga district on Sunday night triggering massive protest from right-wing activists. His funeral procession in Shivamogga turned violent that left a photo journalist and a police woman among three injured.

The police have arrested two persons in connection with the murder and said efforts were on to nab the rest of the suspects at the earliest.

Home Minister Araga Jnanendra said a four-five member group of assailants was suspected to be involved in the

killing.
Three persons were injured when miscreants pelted stones during the funeral procession of the deceased Harsha that took place amid tight security. Several vehicles were torched and damaged while there were reports of some shops also

being ransacked. Shivamogga, a town

around 250 km from Bengaluru, had recently seen disruption in some colleges over the hijab row

Police tried to bring the situation under control and made way for the funeral procession to move further and the final rites to take place.

Harsha, a resident of Seegehatti, was attacked by a group of unknown persons at Bharati Colony here on Sunday night, following which he was taken to McGann Hospital where he succumbed to his

# 5th fodder scam case

#### **RJD** chief to move **HC** against verdict

PNS RANCHI

The Special CBI court on Monday awarded five-year rigorous imprisonment and a fine of ₹60 lakh to former Bihar Chief Minister Lalu Prasad in a fodder scam case (RC 47 A/96). So far, Lalu has been convicted in five cases of fod-

The case pertains to the fraudulent withdrawal of ₹139.35 crore from Doranda treasury of Ranchi during

RJD supremo's lawyer Prabhat Kumar said Lalu would challenge the judgment at the Jharkhand High Court besides a bail petition will be filed on behalf of Lalu.

"We will challenge the judgment and a petition will be moved very soon. Lalu has spent three years and 19 days in this case hence he can get the bail," Kumar said.

However, the CBI sources disputed the claim and said Lalu had not spent much time

Reacting to the judgment, Lalu tweeted, "I've been fighting against injustice, inequality and dictatorial regimes and will continue to fight. Who can break the resolve of someone whose power is truth and who



Lalu's son and RJD leader Tejashwi Yadav said his father was convicted because he fought against the RSS and the BJP. "If Lalu would have shaken hands with the BJP then he would have been called Raja Harishchandra but today he is fighting against RSS-BJP hence he is facing imprisonment. We'll not get scared with this, he said

After he was pronounced guilty on February 15, Lalu was taken into custody. He is now admitted in Rajendra Institute of medical Science at Ranchi.

On Monday morning, the court premises were jampacked with lawyers, media ersons, and supporters of Lalu. Former RJD MLA from Bihar Bhola Yadav, former Ministers Shyam Rajak, Abdul Bari Siddiqui, and many others were present. They turned disappointed and soon left the court premises when the court pronounced the quantum of

punishment. The court proceedings started at 12 when the court

heard arguments of lawyers of convicts on the point of sentencing. Lalu's lawyers said he is very old and suffering from many diseases hence the court adopts a lenient view. Lalu is currently under treatment at RIMS under judicial custody.

Special CBI judge Sudhanshu Kumar Shashi also pronounced the quantum of punishment to 39 other convicts of this case. All sentences were pronounced through video conferencing. On February 15, the court

held Lalu and 74 other accused guilty, including former MLAs, former Secretary, former Commissioner of Income Tax the then AHD officials, veterinary doctors, proprietors, and other private persons. The court had acquitted 24 accused from all charges. The court sentenced 35

convicts to three years of rigorous imprisonment along with a fine. Regarding rest of the convicts, the court fixed February 21 to pronounce the judgment of the remaining 40 convicts.

These 40 convicts include Lalu, Dr Rabindra Kumar Rana (then MLA, Bihar Assembly), Beck Julius (Secretary, AHD) Mahendra Prasad (Treasury Officer, Doranda Treasury), Devendra Prasad Srivastva (Treasury Officer, Doranda

# **Cong continues stir in K'taka House**

#### Speaker objects to slogans against RSS

Bengaluru: Protests by the Congress, who are demanding the sacking of Rural Development and Panchayat Raj Minister KS Eshwarappa and that he be booked for sedition over a statement on the national flag, continued to rock the Assembly proceedings in Karnataka for the fourth consecutive day on Monday.

The Assembly also saw passage of four bills amidst the din, and Speaker Vishweshwar Hegde Kageri took strong exception to Congress members "unnecessarily" bringing in RSS' name during their protest in the well of the House.

The 'day-and-night' protests by the legislators inside the Assembly began on Thursday demanding Eshwarappa's dismissal.

Recently, Eshwarappa had claimed 'Bhagwa dhwaj' (saffron flag) may become the national flag some time in the future and the same may be hoisted on the Red Fort then.

He however had said the tricolour is the national flag now, and it should be respected by everyone.

As the House met for the day, Congress members trooped into the well of the House and started shouting slogans demanding action against Eshwarappa. Slogans like - "Down, down

BJP", "Suspend Eshwarappa", "Eshwarappa desha drohi (traitor)", "Down Down desha drohi BJP government", "Speaker give justice", "This government is RSS' puppet",
"We want constitution, not marred the proceedings.

Despite protest, Speaker Kageri took up the question hour with no Congress legislator taking part in it.

Then, amidst the din, the assembly also passed four bills The Karnataka Civil Services (Validation of Selection and Appointment of 2011 batch Gazetted Probationers) Bill, 2022; The Karnataka Stamp (Amendment) Bill, 2022; The Karnataka Stamp (Second Amendment) Bill, 2022; The Criminal Law Amendment Ordinance, 1944, (Karnataka Amendment) Bill, 2022 - without any discussions.

After the passage of bills, the Speaker asked former chief minister and Leader of Opposition Siddaramaiah to participate in the discussion on the motion of thanks to the Governor's address, and called

The Speaker said several attempts have been made by him for the smooth conduct of the proceedings of the house, by calling a meeting of the Leader of the House (CM Basavaraj Bommai) and Leader of Opposition, along with other senior leaders, but it has failed.

common in a democracy, but we are duty bound to conduct the proceedings of this House. If the government has not agreed to your demands, protest outside and cooperate to run the House. We have to discuss developmental issues, issues of the people here", he

JD(S) deputy leader Bandeppa Kashempur said his

to raise several key issues concerning the people of the state and farmers, and they should be given an opportunity.

Meanwhile, Congress members raised slogans taking the RSS' name, Speaker Kageri took strong exception to this. "I want to say to Congress members very strongly - unnecessarily, why are you bringing in the RSS' name. How is RSS responsible for this? Don't repeatedly bring RSS' name unnecessarily," he

"RSS is an organisation with a nationalist ideology, they are working towards uniting Hindus. You have to cooperate in their efforts. Don't bring RSS name, if you have political differences, set it right," Kageri added.

## Maha inches closer to end of Covid 3rd wave as cases reach below 1K mark

T N RAGHUNATHA MUMBAI

Maharashtra on Monday inched closer to what may be the end of the third wave of Covid-19, as the daily infections dropped below 1000 for the first time in nearly 22 months after the break-out of the State.A day after Maharashtra recorded 1,437 infections, the daily cases dropped to 806, while the daily cases came down in Mumbai from 167 to 96.

Available records show that within a few weeks of the break-out of the pandemic, Maharashtra had on April 23, 2020 recorded 778 daily infec-

With 806 fresh infections recorded on Monday, the total number of Covid-19 cases in the state rose from 78,58,431 to

With four fresh deaths, the total number of deaths registered in the state since the outbreak of Covid-19 in the state in March 2020 went up from

With the fresh 96 cases, the total number of cases in Mumbai mounted from 10,55,561 to 10,55,657. While the recovery rate stood static at 98 per cent, the overall growth rate of Copvid-19 cases in the metropolis for a period from February 14 and 20 dropped to

0.02 per cent. As 2,696 Covid-19 patients were discharged from the hospitals across the state after full recovery, the total number of people discharged from the hospitals since the second week of March 2020 increased from 76,94,439 to 76,97,135. The recovery rate in the state rose from 97.91 per cent to 97.94

The number of "active cases" in the state dropped from 16,422 to 14,525. The fatality rate in the state stood static at 1.82 per cent.

The active cases in Pune dropped from 4743 To 4418. The active cases in Mumbai dropped from 1511 to 1415, while the number of active cases in the neighbouring

Thane dropped from 1040 to 994. The active cases in Ahmednagar dropped from 1550 to 1464, while the number of active cases in Nagpur came down from 1530 to 1255.

Of the 7,72,69,104 samples sent to various laboratories across the state so far, 78,59,237 have tested positive (10.17 per cent) for Covid-19 until Monday.

Currently, 1,76,378 people are in home quarantine while 1,036 people are in institutional quarantine.

Meanwhile, 53 fresh Omicron cases were recorded in Maharashtra on Monday, resulting in the total number of the new Covid-19 variant cases going up to 4,509. Of these cases, 3,994 patients have been discharged after they tested negative in the RT-PCR tests.

Till Friday evening, 8904 samples had been sent for genome sequencing, out of which, results of 8,044 patients have been received, while the results of 860 samples are

### Will launch protests if Gui doesn't withdraw pending cases against quota agitators by March 23, says Hardik Patel

Ahmedabad: Patidar leader Hardik Patel on Monday said that state-wide agitations will be launched in Gujarat after March 23 if the ruling BJP Government fails to withdraw all the remaining criminal cases lodged against protesters during the 2015 Patidar agitation for reservation under OBC category.

Patidars form a significant vote bank in Gujarat where elections are due in December this year.

Addressing media persons, Patel, who is Gujarat Congress working president, said that he was raising the demand for the withdrawal of the remaining cases as a quota agitator and not

Playing down Hardik's threat to launch protests, Gujarat BJP spokesperson Rutvij Patel said Hardik and his party have lost their political base in Gujarat and they are doing such "stunts" only to grab the attention of the media.

As promised, nearly 140 cases against Patidar agitators were withdrawn when Anandiben Patel was the chief minister (till August 2016). Her successor Vijay Rupani had promised to take back the remaining cases but he did nothing. At present, nearly 200 cases involving nearly 4,000 youths, who are shown as accused, are pending," claimed Hardik.

He claimed that prominent Patidar leaders and MPs from the community made a representation before Bhupendra Patel after he became chief minister of Gujarat a few months back on this issue."Patidar youths are getting harassed due to the false cases lodged against them. Despite such representation from various quarters, the CM has not taken any decision yet," Hardik

A bench of Justices Ajay Rastogi and Abhay S Oka said this while setting aside the judgement of the Telangana High Court which had upheld the conviction of a woman public servant, who was working as a commercial tax officer at Secunderabad, for the alleged offences under the PC Act including under section 7.

The offence under section 7 of the PC Act relating to public servants taking bribe requires a demand of illegal gratification and the acceptance thereof. The proof of demand of bribe by a public servant and its acceptance by him is sine quo non for establishing the offence under section 7 of the PC Act," the bench said in its 17-page judge-

The top court delivered the verdict on the plea filed by the accused challenging the high court judgement.

The bench said that evidence of the complainant in the case about demand for bribe by

the appellant was "not at all reliable".

"Hence, we conclude that the demand made by the appellant has not been conclusively proved," the bench said, adding that the version of the complainant in his examination-inchief about the demand made by the appellant from time to time is "an improvement".

"Thus, this is a case where the demand of illegal gratification by the appellant was not proved by the prosecution. Thus, the demand which is sine quo non for establishing the offence under section 7 was not established," the apex court

While allowing the appeal, the bench said the conviction for the offences punishable under sections 7 and 13(1)(d) read with section 13(2) of the PC Act is set aside and the appellant is acquitted of the charges framed against her.

According to the prosecution, the appellant was working as a commercial tax officer at Secunderabad and the complainant was working at the relevant time as a supervisor of a co-operative society.

It was said that the complainant was doing the work of filing returns of commercial tax of the society.

### Allow shops to remain open till 10 pm in CP, says traders' association

In view of the improving COVID-19 situation in the

national capital, the New Delhi Traders Association (NDTA) has written to Delhi Lieutenant Governor Anil Baijal, requesting him to allow shops to remain open till 10 PM in Connaught Place. This is the second letter to

Baijal written by the NDTA, citing huge financial losses as a cause of concern for traders. "We request you to extend

the closing timings of shops in Delhi to 10 PM on the same line as that of restaurants.

In UP and Haryana, night curfew and all restrictions have been removed but in Delhi timings for closing shops is same at 8 pm, which is causing huge financial losses to shop owners," NDTA wrote to the LG. "Since Covid positivity rate in Delhi has reduced drastically and is continuously reducing every day, we once again request you to extend closing timing of shops from 8 PM to 10 PM on the same line as closing timing fixed for restaurants," it added.

The Delhi Disaster (DDMA), in its meeting on February 4, had extended the imposition of night curfew in the national capital but slashed its duration by an hour -from 11 PM to 5 AM.

Due to the night curfew, shops selling non-essential items are only allowed to operate till 8 PM. The DDMA had also allowed the reopening of schools for classes 9 to 12 from February 7 and for students of nursery to Class 8 from February 14.

Further, it permitted all government and private offices to function at 100 per cent capacity. Gyms were also allowed to reopen with certain restrictions. However, several restrictions like allowing only one weekly market in a munic ipal zone, no standing passengers in buses and Metro trains and a 50 per cent cap on seating capacity in restaurants, bars and cinemas remain, even though there has been a marked decline in COVID-19 cases in Delhi.

## KG and class-1 released in Capital by private schools

 ■ to entry-level classes nursery, KG and class-1 was released by the private schools in the national Capital on Monday. The schools had put out their first list on February 4 using the point-based criteria announced by them earlier.

The process for nursery admissions in over 1,800 schools in the national capital began on December 15 last year, bringing respite for anxious parents who have been waiting for the notification for over two months.

According to a senior official of Directorate of Education (DoE), the students who have been shortlisted in second list have to take admission between February 22 to 28. "All private unaided recog-

nised schools were directed that they shall develop and adopt criteria for admission which shall be fair, reasonable, well-defined, equitable, nondiscriminatory, unambiguous and transparent," he said. "The subsequent list for admission, March 31," he added. The DoE has also directed

that the number of seats at the entry-level shall not be less than the highest number of seats in entry-level classes during the last three academic years --2019-20, 2020-21 and 2021-22.

According to norms, all private unaided recognised schools admitting children in pre-school, pre-primary and class-l level shall reserve 25 per cent seats for EWS or DG category students and children with disability.

A monitoring committee has been constituted in each district under the chairmanship of Deputy Director (District) concerned regarding admis-

sion process. The deputy director has

been asked to ensure that each private school uploads criteria and its points on online module and further ensure that school shall not adopt those criteria which were abolished by department and upheld by the Delhi High Court.

#### Rape & murder: Partially decomposed body of 14-year-old girl found in a shop in Narela

There has been an improper and arbitrary exercise contrary to settled law by the high court which has granted bail without at all considering the heinous nature of the crime, it said. Seeking "stay of the impugned bail order", the plea narrated the sequence of evidence and said, "The act of deliberately crushing the peace-

#### 'Rogue antibodies in blood of Covid patients cause for concern

PNS NEW DELHI

Usually antibodies help check the pathogen, but the 'rogue' antibodies circulating in the blood of Covid-19 patients have the potential to cause cells to lose their resistance to clotting, according to a study conducted by a team from the University of Michigan. The researchers found

higher-than-expected levels of antiphospholipid autoantibodies, which can trigger blood clots in the arteries and veins of patients with autoimmune disorders, including lupus and antiphospholipid syndrome.

Antibodies typically help the body neutralise infections. Autoantibodies are antibodies produced by the immune system that mistakenly target and sometimes damage the body's own systems and organs.

In a 2020 study, the research group found that autoantibodies from patients with active COVID-19 infections caused "a striking amount of clotting" in mice.

For the new study published in Arthritis and Rheumatology, the team studied the blood samples of nearly 250 patients hospitalized for Covid-19.

The team found that the autoantibodies appear to stress the endothelial cells that make up the inner lining of blood vessels and, in doing so, cause the cells to lose their ability to prevent blood clots from form-

ing.
"This provides an even stronger connection between autoantibody formation and clotting in COVID-19," said Hui Shi, lead author and rheumatology research fellow at Michigan Medicine.

The researchers found higher-thanexpected levels of antiphospholipid autoantibodies, which can trigger blood clots in the arteries and veins of patients with autoimmune disorders, including

antiphospholipid

**syndrome** 

"When endothelial cells are activated, they cause healthy blood vessels to become 'sticky' attracting other cells to the vessel walls and becoming more prone to thrombosis. This can affect many of the body's essential organs," Shi added.

The researchers found that when they removed the antiphospholipid autoantibodies from COVID-19 blood samples, the endothelial cell activation that promotes clotting was lost.

While the link is strong, future studies must be done to find whether these autoantibodies are the precise cause of thrombosis that contributes to clotting and increased severity of COVID-19, said Jason Knight, Associate Professor of Rheumatology at Michigan Medicine.

"We must do more research to decide if it is beneficial to screen patients with severe COVID-19 for these autoantibodies to evaluate their risk of clotting and progressive respiratory failure," Knight said.

This may help to repurpose treatments used in traditional cases of antiphospholipid syndrome for Covid-19, he noted.

## **Divided Opposition?**

Several parties are gearing up to take on the BJP in 2024, but are they together in it?

omething is cooking up in the Opposition camp. Telangana Chief Minister K Chandrasekhar Rao's recent outburst against Prime Minister Narendra Modi, his travel to Mumbai, his hour-long luncheon meeting with his Maharashtra counterpart Uddhav Thackeray, his hobnobbing with NCP supremo Sharad Pawar; all these seem part of a well-thought-out plan. KCR never hid his ambition to play a bigger role in national politics, but he shied away from taking on Modi in such a brazen manner in the past. In fact, the Telangana Rashtriya Samiti (TSR) often came to the rescue of the NDA Government in the Rajya Sabha when the ruling alliance lacked a majority in the Upper House in the past. But KCR has finally shunned his hesitation and unleashed what many would call "below the belt" diatribes against the Prime minister, mocking his sartorial preferences, and calling him a "man on no substance". Taking his batter a notch higher, he didn't even receive the Prime Minister at the Hyderabad airport when Modi visited the State to inaugurate the statue of Sri Ramanujacharya . The message is loud and clear: KCR was out to play a national role and would vie with Mamata Banerjee to emerge as the glue to tie the Opposition together. The Bengal chief minister

recently held a telephonic talk with KCR, during which the two leaders discussed the need to convene a meeting of Chief Ministers of the Opposition-ruled States to oppose the Modi Government's alleged misuse of the Central agencies against BJP's political rivals. The rant against the alleged misuse of the Central

agencies is not new. The real purpose of such an enclave is to discuss the framework to bring together the Opposition to dislodge the Modi Government from office in 2024. The recent meeting of poll strategist Prashant Kishor with Bihar Chief minister Nitish Kumar also seems part of the same strategy. Of late,

the relation between the Janata Dal (U) and BJP has seen a sharp deterioration. The JD(U) has put up candidates against the BJP in both Uttar Pradesh and Manipur, and its leaders have been spewing venom against the saffron outfits' programmes and policies. Similarly, the BJP's Bihar leadership has been highly critical of Nitish Kumar's prohibition policy. Sources close to Nitish say that the Bihar CM might open up his cards after the outcome of the UP polls. Indeed, the results of the Assembly polls will greatly influence the move to cobble together the anti-BJP front. If the Congress managed to retain Punjab and win back Uttarakhand and Goa, it'll be difficult for the Opposition leaders to ignore the 'grand old party' out in the Opposition's scheme of things, though Mamata Banerjee has gone on record saying the Congress can go on its own way. Under the circumstances, the million-dollar question before the likes of Sharad Pawar, Mamata Banerjee or KCR is whether to walk hand in hand with Rahul Gandhi or let the Congress row its own boat.

## **Together**

Satraps are trying to dislodge the BJP but where is the glue to hold them together?

he song 'Happy Days Are Here Again' would possibly reverberate across the country if the efforts of three non-Congress and non-BJP Chief Ministers bear fruit and lead to the formation of a Third Front to take on the 'Hindutya' party in the 2024 Lok Sabha election. Mamata Banerjee, K Chandrasekhar Rao and MK Stalin, the Chief Ministers of West Bengal, Telangana and Tamil Nadu, respectively, are on a mission to constitute a viable alternative for the people in time for the next Lok Sabha election. The three States contribute 98 out of the 543 total seats in the



Lok Sabha and hence their bonding is a must for these leaders to reach the magic figure of 272. KCR was in Mumbai the other day, courting Maharashtra strongman Uddhav Thackeray and requesting him to join the proposed Third Front. Assuming that the three leaders succeed in forging a 'rainbow alliance' to take on the communalists, there are some guestions that remain unanswered. Who will be the prime ministerial candidate? The voters have the right to know who would be the chief executive of the country, lest they would be left with the ignominy of watching persons like Deva Gowda and IK Gujral addressing the countrymen.

While there is no doubt about the competence and leadership qualities of Mamata, whose popularity is on an upward swing even in the southern State of Kerala, the same cannot be said about KCR and Stalin. Mamata fought her way to the top through hard work and intelligence. Stalin is in the present position only because he happens to be the son of late M Karunanidhi, the founder leader of the DMK and the five-time CM of Tamil Nadu. The silence of these leaders about the role of the Congress is baffling. BJP's veteran leader LK Advani had said in 1996 that it would be impossible for any political grouping to form a Government without the Congress or the BJP. The same holds true even now because Congress is the only party with a pan-India presence and acceptability. Memories of 2004 offer a ray of hope. It was Sonia Gandhi who took the initiative and walked that extra mile to forge the UPA bandwagon which won the election much to the shock of pollsters who had forecast a cakewalk victory for the 'Shining India' party. Sonia is capable of repeating the feat. The nation awaits its future.

# The Ukraine crisis: Its impact on India DEEPAK SINHA



India has to tread a fine line in this imbroglio: Taking care of the welfare and evacuation of Indian students and the possibility of oil price hike

he face-off over Ukraine between Russia and the United States and its Nato allies has been dominating the headlines for a while now with tensions ratcheting up as we receive dire public warnings everyday of a Russian invasion any day now. Clearly, the possibility of Russian intervention there, and the consequent escalation of sanctions against them, is very real and concerning.

While Ukraine may be a developing country and the poorest in Europe, by no means is it a pushover. It is the second largest country there, behind Russia, by area, and in terms of population the eighth largest with its 42 million inhabitants. It has been independent since 1991, following the collapse of the Soviet Union, though it had been a part of the Russian Empire and the Soviet Union since the 18th century. If there is one lesson that Putin and the Russian military should have learnt from America's disastrous interventions in Iraq and Afghanistan is that invasions are relatively easy to accomplish, but keeping restive and hostile populations under control is a wholly different proposition.

In any event, Putin and his advisors must clearly remember the Soviet intervention in Afghanistan that ultimately led to its collapse. Surely not worth the risk of repetition? He has already achieved much more than what we did during Operation Parakram. The ongoing imbroglio has its genesis in the Western funded 'Euromaidan' protests of November 2013 against pro-Russian President Viktor Yanukovych that ultimately led to his resignation. Those protests were strongly opposed by the Russian-speaking inhabitants of eastern Ukraine and pro-Russian politicians in power in Crimea and the port city of Sevastopol initiated a referendum there that resulted in the region breaking away and signing a Treaty of Accession with the Russian Federation, facilitated by the Russian military. separately, the Donbas Region, which includes Donetsk and Luhansk Provinces in the East, became the focus of a separatist



Minsk Protocol. Clearly the Ukrainians and the Europeans are pawns in this version of the 'Great Game 2.0' between Russia and the US. Russia's motives appear to be aimed at stopping Ukraine from joining Nato, thereby ensuring a buffer. Putin also probably wishes to reinforce his reputation as a strong nationalist leader by regaining some of the earlier clout that Russia enjoyed in the halcyon days of the Soviet Union. On the other hand, a deeply fractured US is keen to buttress its own domination over its Nato allies that had been adversely affected during President Trump's tenure.

Some analysts have suggested that the Americans are keen to goad Russia into invading Ukraine so as to bog them down in an unwinnable conflict, while also adversely impacting growing cooperation between Russia and Germany on the energy front. A desperate attempt by President Biden, who over a

Whatever the motives of either side, tensions in Ukraine have only added to our problems. Not only does the Indian Government find itself having to worry about the welfare and evacuation of the 20,000-odd Indian students there, but also faces increasing possibility of oil price hike and its implications for our economy in the event of a shooting war. Moreover, the Government is treading a fine line as it balances its response without damaging its relationship with either of the protagonists, with both of whom it has close ties. Also any escalation in Ukraine will shift focus and allow China an opportunity to act even more aggressively against us, Taiwan and the QUAD; much like the manner in which it got away by attacking us in 1962 while the US and the Soviet Union were focused

Government an opportunity to focus on pursuing our own national interest to the full. Instead of our wishy-washy neutral stand, we must throw our full weight behind the side that we perceive will help us to effectively counter China's aggressive designs. Otherwise, as in the past, we will once again be on our own with only token assistance being offered. The brutal truth is morals and values count for little and national interest is paramount. As Iqbal Chand Malhotra points out in his latest book, Dark Secrets: Politics and Proxy Wars in Kashmir, it was our good friend the Soviet Union that prodded Mao Zedong into illegally occupying and constructing a highway in the Aksai Chin so as to secure its access to the uranium mines there. For that matter, the traitorous actions of the British in not just ensuring Partition but also in organising the division of J&K, including the mutiny at Skardu, so that they had a suitable base in Pakistan from where they could keep an eye on the actions of the Soviet Union as well as control the access to oil through the

### THE RISE AND DECLINE **OF SOCIOPATHY**

Sociopaths are born, not made

generally leave the psychohistory to Hari Seldon, but just this once I feel sufficiently motivated to venture into the field. The immediate spur for this departure is the spectacle - half-fascination, half-disgust - of Boris Johnson, Britain's part-time prime minister, gradually foundering in a sea of his own lies. But there are other examples, too.

There was Donald Trump just a year and a bit ago, trying to drag an entire country down with him and having some success in the enter-

There's Jair Bolsonaro, flailing around as he awaits almost inevitable defeat by 'Lula' in next October's Brazilian election.

There's Viktor Orban, astounded to face a united six-party opposition in Hungary's April elections.



And what they have in common is that they are all liars. Not shy, sly liars. Bold, in-your-face, shameless liars. They don't care if you really know the truth from personal experience. It doesn't bother them that you know they are lying. They will just say the lie again - and you might even believe them, because they say it with such conviction.

They are convincing because after a split-second when they privately decide that some lie will serve their purpose, they actually believe it themselves. They have other markers, too: they are usually male, they are always intelligent, they are almost always charming, and they generally get through several spouses and many children in a lifetime. They are, in a word, sociopaths.

Which takes me back to an interview I did with a sociologist in an American university many years ago. We had finished up, and I casually asked if he knew of any evolutionary circumstances that were changing human behaviour now. He paused for a moment, then said that he thought the sociopaths were multiplying. So, I unpacked my gear and resumed the interview. He began with the obvious statement that sociopathy is usually if not always a genetic property. Most sociopaths are born, not made. And he speculated on how they could have escaped being weeded out by natural selection back in the hunter-gatherer days, because those were small groups of people - thirty or forty adults - where everyhody knew everybody else

His answer was that small groups are not very vulnerable to a sociopath. Everybody has his number before he reaches reproductive age, so he can't be a super-spawner. Everybody checks his lies with everybody else, so he doesn't get away with much. And there are certain rare circumstances where it could be handy to have a sociopath around.

All went well until human beings started living in societies thousands or millions strong where the sociopaths become invisible. Nobody has their number, and there's an endless supply of strangers to deceive and exploit (and breed with). A mass society is a sociopath's garden of delights. Of course, their numbers are going up: my sociologist friend reckoned three per cent of males and rising. And of course, they are appearing in leadership positions because they can lie directly and convincingly to far more people. But here's the really interesting question: why are all these men now on their way out of power or already gone? That may be part of their sociopathy too, because they all leave trails of human wreckage behind them: cheated partners, abandoned lovers, betrayed followers. They can't help it; it's who they are.

So the good news may be that genuine sociopaths get found out in the end. The bad news, however, is that there's lots more of them out there, and they're breeding like flies.

# Rationalising the nation's direct taxes



The Government should rationalise direct taxes to address anomalies between PIT and corporate tax at one level and capital gains tax at another

wer since, the commencement of d its second term, Modi Government has showered benevolence on the corporate sector by giving relief in income tax but when it comes to personal income tax (PIT), it has notmatched the expectations.

On September 20, 2019, Finance Minister (FM) Nirmala Sitharaman had announced steep reduction in the rate of corporate tax for "new entities" incorporated from October 1, 2019 in the manufacturing sector and start production by March 31, 2023 from the existing 25 percent to 15 percent. Such companies won't have to pay minimum alternate tax (MAT).

Furthermore, the tax rate on existing companies was reduced from 30 per cent to 22 percent sans exemptions and deductions. These firms are also exempt from MAT. The small and medium enterprises (SMEs) with annual turnover of less than ₹400 crore were already enjoying a preferential tax rate of 25 percent against 30 percent payable by large firms. Following the cut to 22 percent (albeit for all 'existing' firms), the preferential treatment for SMEs is gone.

Meanwhile, the companies were given a choice to either continue with the old regime viz. tax at 30 percent with tax breaks or go for the new one. For those deciding to continue, MAT was reduced from extant 18.5 to 15 per cent.

In the Budget for 2020-21, Sitharaman extended the benefit of 15 percent rate to "new" power companies also. Besides, "cooperatives" were made eligible for the 22 percent rate sans exemptions and deductions. The FM also abolished dividend distribution tax or DDT. From April 1, 2020, dividend is taxed in the hands of shareholders.

In the 2022-23 budget, the government has extended the eligibility of 15 percent corporate tax to new (albeit manufacturing) entities which get incorporated before March 31, 2024 - against the existing threshold of March 31, 2023. It has reduced the surcharge on profits of cooperatives from existing 12 percent to percent besides reducing MAT from existing 18.5 percent to 15 percent.

Coming to PIT, prior to 2020-21, a person having an income of ₹2,50,001-₹ 5,00,000 per annum was required to pay tax of five percent, those earning more paid 20 percent tax whereas, someone having an income higher than ₹10,00,000 paid 30 percent. With these tax rates, individuals enjoyed a plethora of exemptions and deductions.

The 2020-21 budget, even while retaining 5 percent tax for annual income in the ₹2,50,001-₹5,00,000 range, on income higher than ₹5,00,000, it levied: 10 percent for ₹5,00,001-₹7,50,000; 15 percent for ₹7,50,001-₹10,00,000; 20 percent for ₹10,00,001-₹12,50,000; 25 percent for ₹12,50,001-₹15,00,000. For

percent tax continues.

On the face of it, with tax rates under different slabs being lower, it would appear the new PIT regime is better. But, considering that it comes without exemptions/deductions, the gain is illusory. For instance, under the old regime, a person having an annual income of ₹15,00,000 and availing tax breaks of ₹3,75,000 (Section 80C:1,50,000; Section 80D: 25,000; Section 24: 2,00,000), pays ₹1,56,000 as tax.

Against this, under the new regime, he will have to pay ₹1,95,000as the benefit of lower rates is more than offset bywithdrawal of exemptions and deductions. So, the 2020-21 budgetary changes have not made individuals any better. At the same time, rate in September, 2019, the extant PIT rates donot enthuse them.

tax rates, i.e., 20-25 percent are higher than the corporate tax.

The individuals could gain from abolition of DDT. This is because on their dividend income, against 20 percent paid prior to 2020-21, levy of tax on such income in their hands will entail payment at a lower rate for instance, 10 percent for those earningin ₹500,001-₹750,000 range. However, this is of little use as these earnershardly have any

surplus to invest in shares. Clearly, Modi - government has done much less for PIT payers. While, less tax on profits of firms is important for inducing them to increase investment, reducing PIT is no less crucial. In fact, in the contemporary context, when growth is hamstrung more by the demand constraint, the latter can be much more rewarding.

The FM should consider putting more money in the pockets of individuals by giving extra relief in PIT. This may be done by changing the tax structure to: 7.5percent tax on income in in ₹1500,000-₹2000,000 and 20 percent on above 2000,000 (there will notbe any tax breaks).

Under this package, a person earning ₹1500,000 will pay ₹104,000 as tax which is significantly lower than the payout of ₹156,000 under the old regime. Apart from giving a massive boost to the demand, this will also propel assesses shift en mass to the new dispensation.

On the corporate front, the legacy of exemptions/deductions exemptions/deductions.

needs to be completely erased. According to the revenue secretary, Tarun Bajaj, already,65 percent of the existing companies have switched over to the new regime of 22 percent sans exemptions/deductions. Hopefully, rest of the firms will also shift within an accelerated time frame.

Modi also needs to look into the extant regime for capital gains tax. The tax rate varies depending on the category of the underlying asset and the holding period. For instance, equity and equity mutual funds attract short-term capital gains tax (STCG) of 15 percent and long-term capital gains tax (LTCG) of 10 percent. ŠTCG on most bond investments is at the tax slab the investor comes under. LTCG is either 10 or 20 percent, depending on whether it is a list-ed or unlisted bond or a debt mutual fund. For real state, LTCG is at 20 percent.

Such a highly differentiated tax structure is prone to misuse, evasion and protracted litigation.Irrespective of the asset ₹5,00,001-₹10,00,000; 10 percent an individual deals in and the in the  $\sqrt[3]{10,00,000}$  -  $\sqrt[3]{1500,000,15}$  holding period, the capital gains to his income in the relevant year. ## Clear front-of-pack labels to safeguard health

#### Simple warnings on high levels of fat, salt and sugar in packaged foods can be a lifesaving solution

ven as India copes with the ongoing Covid-19 pandemic that has already strained our health system, with hospitals diverting resources and capacities to treat the infection, the non-communicable diseases (NCDs) are becoming an emergency we cannot afford to ignore. Results of the latest National Family Health Survey (NFHS-5) should come as an eye-opener for policymakers as well as consumers.

The Global Nutrition Report, 2021 says that around 12 million people died prematurely in 2018 due to risks linked to an imbalanced and unhealthy diet. These included NCDs like CVD (heart attack, stroke etc), cancer and diabetes. Diabetes remains one of the biggest and fastest-growing killers today. In India, the num-

ber of people with diabetes caused by obesity is expected to rise from 77 million in 2019 to 101 million in 2030

Not just children, obesity among women and men has also increased. The percentage of overweight women went up from 20.6 percent to 24 percent, while in men the number increased from 18.9 percent to 22.9 percent, according to the NFHS-5.

Obesity and NCDs are on the rise not only in metros or urban settings but also in rural areas where the food industry has made inroads through their well-oiled marketing strategy offering high fat, salt and sugar (HFSS) laden packaged food. This has left consumers and nation to suffer--both on the health and economy fronts. According to the World Health



Organisation (WHO), around 58 Lakh Indians die every year due to preventive NCDs.

Covid-induced restrictions like 'work from home', lockdowns, social distancing, and travel restrictions to arrest the spread of infection in many countries including India have just added to the health woes. Demand for ready-to-make, easily available packaged food has increased, while physical activity has comparatively slowed down for many.

However, what is a matter of concern is that these unhealthy options are put before the consumer when there are so many healthy choices like fresh fruits and vegetables and other nutritious food are available.

With the virus likely to stay here - since it is more than two years in existence since 2019 - it gives a second chance to the Government as a policymaker, community as well as a responsible individual to introspect what food is being offered on the platter to cut down the NCDs.

Three important and increasingly common policy strategies recommended by the WHO are: front-of-package labels (FOPL) on unhealthy foods and beverages, restrictions

children, and restricting the sales of these products in schools

Clearly, consumers need to be provided with clear information about the nutrition profile of the packaged food products and drinks while nudging the industry to reformulate their products for the better health of

the people. This could be possible by making mandatory 'easy to understand' warning labels on packaged food and beverages that would help consumers in making healthier choices and help curtail deaths from NCDs as has been in the case with the cigarettes which have clear

warning symbols. In fact, as per the global health body, the FOPL works best when it is made mandatoon marketing these foods to ry and applies to all packaged

products, the label is interpretative, simplistic and readily visible, guided by a strong nutrient profile model. The WHO says consumption has come down after warning labels were made compulsory.

Case in point is Chile. It has mandated "High-in" warning labels - considered the golden standard FOPL, restricted sale marketing to children, and banned in-school sales of packaged foods and beverages having HFSS-black octagon(s) with the words high-in sugar, sodium, saturated fat, and/or calories, whichever applies.

By making FOPL mandatory, Chile has already started reaping benefits with more of its citizens saying no to HFSS

According to various reports, the fast food industry is increasingly eyeing children as their potential future consumers - with kids seeing ads when they're as young as two years old. ## Biden, Putin agree to talk but fears of Ukraine war continue

The US and Russian presidents tentatively agreed to meet in a last-ditch effort to stave off a possible Russian invasion of Ukraine, even as sustained shelling continued on Monday in a conflict in eastern Ukraine that Western powers fear could provide the spark for a broader war.

If Russia invades, as the US warns Moscow has already decided to do, the meeting will be off. Still the prospect of a face-to-face summit resuscitated hopes that diplomacy could prevent a devastating conflict, which would result in massive casualties and huge economic damage in Europe, which is heavily dependent on Russian energy. Russia has massed an esti-

mated 150,000 troops on three sides of Ukraine - the biggest such buildup since Cold War. And Western officials have warned that Russian President Vladimir Putin is now merely looking for a pretext to invade the country, a western-looking democracy that has defied Moscow's attempts to pull it back into its orbit.

Moscow denies it has any plans to attack, but wants Western guarantees that NATO won't allow Ukraine and other former Soviet countries to join as members. It has also

demanded the alliance halt Dmitry Peskov told reporters weapons deployments to Monday that Putin and Biden Ukraine and roll back its forces from Eastern Europe demands flatly rejected by the

With the prospect of war looming, French President Emmanuel Macron scrambled to broker a meeting between US President Joe Biden and Putin. The language from Moscow and Washington was more cautious, but neither side denied a meeting is under discussion.US national security adviser Jake Sullivan said the administration has always been ready to talk to avert a war - but was also prepared to respond to any attack.

"So when President Macron asked President Biden yesterday if he was prepared in principle to meet with President Putin, if Russia did not invade, of course President Biden said yes," he told NBC's

### **Ukraine crisis tests China-Russia partnership**

Russia's military buildup Ralong its border with Ukraine is testing possibility of a Moscow-Beijing axis lining up against US and its allies. Russian leader Vladimir Putin's meeting with Chinese counterpart Xi Jinping in Beijing this month fed speculation that a new alliance could form between two great powers as they face off with US over a range of issues.

Russia and China have backed each other's positions on opposing a NATO expansion in former Soviet republics and buttressing China's claim to self-governing island of Taiwan. But relationship remains lopsided.

China's confident rise as an economic and political force contrasts with Russia's growing isolation and reversion to Cold War tactics of intimidation and bullying. China also remains opposed to actions that could damage its territorial ambitions, from South China Sea and Taiwan to Indian border. Here are some of the main factors driving, and blocking Russo-Chinese rela-

Where does China stand on the Ukraine crisis?

China has not criticised Russia over its moves against Ukraine, and has joined in verbal attacks on Washington and its allies. Addressing Munich Security Conference over weekend, Chinese Foreign Minister Wang Yi lashed out against the US, accusing "a certain power" of "stirring-up antagonism." However, in response to a question from conference Chairman Wolfgang Ischinger, Wang said the "sovereignty, independence and territorial integrity of any country should be respected and safeguarded, because this is a basic norm of international relations."

"Ukraine is no exception," Wang added. He also stated that major powers should act in defense of global peace and no country should "repeat past mistake of forging rival alliances."That chimes with China's longstanding opposition to military alliances and often invoked-but often breached in practice - policy of non-interference in other countries' internal affairs.

## US claims Russia has ordered final preparations for invasion

Russia on Sunday rescinded earlier pledges to pull tens of thousands of its troops back from Ukraine's northern border, a move that US leaders said put Russia another step closer to launching what they said was the planned invasion of Ukraine.

Residents of Ukraine's capital filled a gold-domed cathedral to pray for peace. Russia's action extends what it said were military exercises, originally set to end Sunday, that brought an estimated 30,000 Russian forces to Belarus, Ukraine's neighbour to the

They are among at least 150,000 Russian troops now deployed outside Ukraine's borders, along with tanks, warplanes, artillery and other war materiel.

The continued deployment of the Russian forces in Belarus raised concern that they could be used to sweep down on the Ukrainian capital, Kyiv, a city of about 3 million people less than a threehour drive away. In Kyiv, life outwardly continued as usual for some on a mild winter Sunday, with brunches and church services, ahead of what US President Joe Biden said late last week was an already decided-upon Russian attack.

Katerina Spanchak, who fled a region of eastern Ukraine when it was taken over by Russian-allied separatists, was among worshippers crowded into the capital's St. Michael's monastery, smoky with the candles burned by the faithful, to pray that Ukraine be spared. 'We all love life, and we are

all united by our love of life," Spanchak said, pausing to compose herself. "We should appreciate it every day. That's why I think ever

thing will be fine.""Our joint prayers will help to elude this tragedy, which is advancing," said another worshipper, who identified himself only by his first name, Oleh. A US official said Sunday

that Biden's assertion that Putin has made the decision to roll Russian forces into Ukraine was based on intelligence that Russian front-line commanders have been given orders to begin final preparations for an attack. The official spoke on the condition of anonymity to describe the sensitive intelligence. Russia held nuclear drills Saturday as well as the conventional exercises in Belarus, and has ongoing naval drills off the coast in the Black

#### Officers' trial in Floyd killing enters possible final week

The trial of three former Minneapolis police officers charged with violating George Floyd's civil rights heads into what may be its final week Monday, with third officer yet to take his turn on stand. Thomas Lane is expected to testify as his attorney presents his case, the last to do so in the nearly month-long proceeding before federal trial moves to closing arguments and then to the jury. Lane, Tou Thao and J. Alexander Kueng are charged in federal court with violating Floyd's constitutional rights when Derek Chauvin pressed his knee into Floyd's neck for 9 1/2 minutes as the 46-year-old Black man was handcuffed, facedown on the street and pleading for air before going silent. Kueng knelt on Floyd's back, Lane held his legs and Thao kept bystanders back.

#### Israeli PM: Iran nuke deal will create more violent Middle East

**AP** JERUSALEM

Israel's prime minister on Sunday criticized an emerging deal over Iran's nuclear program, saying it would be weaker than a previous agreement and would create a "more violent, more volatile Middle East."

World powers have been negotiating in Vienna in a bid to revive the 2015 nuclear deal, which was left in tatters after the Trump administration, goaded by Israel, withdrew.

The original deal granted Iran relief from crippling economic sanctions in exchange for curbs on its nuclear program. Israel vehemently opposed that accord and has urged negotiators to take a hard line against Iran in the current round of talks. In a speech to Jewish American leaders Sunday, Israeli Prime Minister Naftali Bennett warned that Iran has used interim period to march ahead with its enrichment of uranium to levels approaching weapons grade.

He also noted the 10-year limits on enrichment and other key aspects of Iran's nuclear program in the original deal are set to be lifted in 2025 - just two and a half years from now. That "leaves Iran with a fast track to military-grade enrichment, Bennett told the Conference of Presidents of Major American Jewish Organisations.

"The pilots sacrificed themselves, they could (have) used ejection system, but they refused to do it."The pilots headed for pitch "to keep people safe," Yousefi said in report.

But things escalated when Emmilee Risling was charged with arson for igniting a fire in a cemetery. Her family hoped the case would force her into mental health and addiction services. Instead, she was released over

the pleas of loved ones and a tribal police chief. The 33year-old college graduate - an accomplished traditional dancer with ancestry from three area tribes - was last seen soon after, walking across a bridge near a place marked End of Road, a far corner of the Yurok Reservation where the rutted pavement dissolves into thick woods. Her disappearance is one of five instances in the past 18 months where Indigenous women have gone missing or been killed in this isolated expanse of Pacific

Francisco and Oregon, a region where the Yurok, Hupa, Karuk, Tolowa and Wiyot people have coexisted for millennia. Two other women died from what authorities say were overdoses despite relatives' questions about severe bruises. The crisis has spurred the Yurok Tribe to issue an emergency declaration and brought increased urgency to efforts to build California's first database of such cases and regain sovereignty over key services.

Tracking deep losses in other Asian bourses, the BSE Sensex dived around 700 points in the opening session but staged a recovery to briefly trade in the positive zone as market jitters were calmed by hopes of talks between the US and Russia over the Ukraine

However, it wilted under selling pressure in the afternoon session to settle at 57,683.59, down 149.38 points or 0.26 per cent. Similarly, the broader NSE Nifty slipped 69.65 points or 0.40 per cent to close at 17,206.65.

Of the 30 Sensex constituents, 21 shares ended in the red, with Sun Pharma, TCS, ITC, Tech Mahindra, UltraTech Cement and Titan dropping up



In contrast, Wipro, Infosys PowerGrid, ICICI Bank, HDFC Bank and Maruti were among the major gainers, spurting as much as 1.45 per cent.

"Domestic indices started weak, taking cues from negative global peers but in between recouped most of its losses on reports of likely meeting between Biden and Putin over the Ukraine issue. However, the market could not stretch the direction and turned negative as uncertainty in the global markets continued.

"Investors stood on the sidelines, impacting volumes. The market is expected to be volatile due to the upcoming Fed meeting and state election results," said Vinod Nair, Head of Research at Geojit Financial

Ajit Mishra, VP - Research, Religare Broking Ltd, said markets are in wait and watch mode in line with global peers and closely monitoring the



# shareholder for bancassurance gain

PTI ■ NEW DELHI

IPO-bound Life Insurance Corporation (LIC) on Monday said it would like to retain some stake in IDBI Bank so that the insurer continues to reap the benefits of the bancassurance channel.

IDBI Bank became a subsidiary of LIC with effect from January 21, 2019, following the acquisition of an additional 8,27,590,885 equity shares.

On December 19, 2020, IDBI Bank was reclassified as an associate company due to the reduction of LIC shareholding to 49.24 per cent following the issuance of additional equity shares by the bank under a Qualified Institutional Placement (QIP).

The government, which is the minority shareholder in IDBI Bank with a 45.48 per cent stake, has already expressed its intent to exit by selling the stake.

'Ğoing forward, we would like to have some stake in IDBI Bank. The whole idea of us picking up stake in the bank was strategic in nature and that has not gone away at all," LIC Chairman M R Kumar said during a media interaction.

strongest contributor for the bancassurance channel, he said, adding that this was something that would help LIC to grow that particular



channel in the post-IPO scenario. Bancassurance is an arrange-

ment between a bank and an insurance company allowing the latter to sell its products to the bank's customers and others through the branch network.

"I, as LIC Chairperson, would like to see that the relationship continuing in the future as well," he said.

On how much LIC would like to retain out of 49.24 per cent stake in IDBI Bank at present, Kumar said as of now there was no sense of the Department of Investment and Public Asset Management (DIPAM) to kick off that excercise.

"Since it was a strategic partner-

ship to begin with, we might stick on to some stake in order that we continue our relationship on bancassurance and other areas which are a winwin-win for both LIC and IDBI Bank," he said.

Elaborating on bancassurance channel, Kumar said LIC has distribution tie up with 58,000 branches of different banks. There is still a lot of scope and headroom for growth on that front, he added.

About new products, he said LIC was working on several participating (par) and non-participating (nonpar) policies that would be launched going forward.

LIC filed the Draft Red Herring Prospectus (DRHP) for the Initial Public Offering (IPO) this month. The government expects to mobilise about Rs 63,000 crore from the proposed Offer for Sale (OFS) to meet the lower disinvestment target of Rs 78,000 crore for the current financial year.

The insurer had infused Rs 4,743 crore in IDBI Bank on October 23, 2019 using policyholders' funds while the bank further raised Rs 1,435.1 crore on December 19, 2020 by way of a QIP.

## How much screen time is too much?



ndoubtedly, there has been an unprecedented jump in the screen time that we have all engaged in ever since the pandemic has broken out. In an era of lockdowns and homestays, however intermittent and episodic, not only have we remained confined indoors for longer durations, the way we function as a society has undergone a sea change. Whether it is for educational purposes, or for entertainment and leisure or for work, a fullfledged digital lifestyle has increasingly come to define us. Indeed, as part of this lifestyle change, work-from-home has become a more permanent feature of our everyday routine.

Work-from-home has an eye health cost

But do we realize that the increased adoption of work-fromhome routine has a cost element involved in terms of our eye health. As we spend more and more time on digital screens including laptops, mobile phones, tablets, e-readers and even television, our eyes have an disproportionately increased exposure time to these screens fraught with considerable adverse consequences.

Characterised by a range of symptoms

The increased screen time and the resultant eye problems can be gauged through a range of symptoms. These could be in the form of eve strain, or headaches, or blurred vision or double vision, or dry eyes or even neck and shoulder pain. Sometimes, it can even lead to disturbance in sleep patterns and difficulties in concentration apart from mental health conditions.

Computer Vision Syndrome,
Reducing or the big eye problem Because of excessive screen time,

we can face a number of problems in the screen our eyes with Computer Vision time is the Syndrome or Digital Eye Strain being one prominent example. We need to st step that realize that the nature of den one has to our eyes changes as compared to when we regularly read a printed page or **consider** write in the physical mode. Apart from the movement of our eyes, the

focusing and refocusing on a computer or other digital screens requires additional efforts on the part of the eye muscles and the vision system. If we consider the glare, the contrast and the flicker of the screen, it becomes even more strenuous and uncomfortable for our eyes attempting to work on the screens. Also, while we are engrossed with our screens, we tend to blink less which leads to dry eyes with related consequences. People touching forty particularly have to exert more since their natural lenses become less

Those wearing eyewear also have problems

While people with unaddressed or under-addressed vision issues will have more problems for obvious reasons, those wearing some eyewear such as eyeglasses and lenses also need to be equally careful. Screen use, particularly at home, is often associated with improper posture and improper home lighting. The viewer is often forced to bend his head, not just aggravating discomfort to eyes but also causing back and neck pain.

#### Prevention

Of course, reducing or right-sizing the screen time is the first step that one has to consider. Second, placing the computer or other screen in sufficiently lit space must become a priority. Third, adequate distance preferably at an arm's length and at appropriate viewing angle between the individual and the screen must be maintained. Fourth, glasses and lenses filtering blue rays and with UV protection should be taken recourse to. And fifth and very importantly, one must observe the 20-20-20 rule meaning that every 20 minutes, a person using a screen should look about 20 feet away for at least twenty seconds. This would give the eyes much-needed rest on a regular basis.

Therefore, while work-from-home and the consequent increased screen time has many advantages, there are downsides too with respect to our eye health. A study reports that nearly 23 per cent of the Indian population had suffered some level of weakening eyesight during the pandemic-driven increased homestays. As such, while we can't do away with our screens completely, we must exercise caution. Moderation is the keyword here.

Yoga practice in conjunction with naturopathy treatment and psychiatric therapy may be beneficial, says DR H P BHARATHI

From school or job performance to physical health issues, an eating disorder may create severe disruptions in a person's life. Yoga is a mind-body activity that is recognised for its inherent healing effects and awareness. Yoga and naturopathy may be a valuable aid in the rehabilitation process, and consistent yoga practice in conjunction with naturopathy treatment and psychiatric therapy may be beneficial. Obviously, smart food choices

can benefit the body in different ways but when someone becomes too much obsessed with restrictions, problems arise. When the behaviour of a person gets too disruptive owing to such restrictions, work relationships which ultimately leads to psychological disorders.

Also, it has been observed that people with orthorexia often tend to avoid social invitations and interactions, fearing that they would have to compromise on their healthy eating habits. Regular yoga practice may aid in the restoration of mental, emotional and physical strength that is damaged due to binge eating disorders.

Stressful mental patterns that sustain eating disorders may frequently dissipate slowly with a design that first opens the body via stretching and then completes with relaxation. During or after a yoga practice, we may be able to release feelings that have been burdening us for years.

Yoga, meditation and breathwork both lessen the body's physiological stress response by lowering sympathetic nervous system activation and boosting activity in the part of the brain responsible for confidence, emotion management,

and mental flexibility, according to Surprisingly, research on yoga's therapeutic benefits has shown that the ability to bear modest amounts of stress, such as learning to remain in an unpleasant pose, is linked to overall happiness and quality of life. Once a person learns to remain in an unpleasant pose, they are more capable of being with uncomfortable feelings when they arise instead of binge

eating.
Naturopathy helps in healing eating disorders

Naturopathic physicians treat patients focusing on their physical, lifestyle, environmental, mental, and emotional wellness. Naturopathy doctors who follow these concepts always concentrate

on addressing the underlying cause of a patient's ailment. Depression, anxiety, trauma, or another factor may play a role in eating disorders. This may also need collabora-

tion with a psychologist due to the serious nature of binge eating disorder. The naturopathy method entails examining the body's longterm changes: What nutrients have been deficient for a long time? What impact does the eating disorder have on mental performance? What impact does it have on a patient's behaviour? What organs or blood components, such as the stomach, heart, kidneys, and so on, have been impaired as a result of the binge eating disorder? It also entails assessing what deepseated issues and hurdles the patient may need assistance in overcoming the eating disorder in order to be cured.

healthy food habits, naturopathy also involves alternative healing therapies like acupuncture, relaxation therapy, botanical medicine and others. Acupuncture may aid in the treatment of eating disorders by addressing linked health issues, lowering stress, and speeding the healing of afflicted bodily systems. The botanical medicine approach tries to replenish the patient's organ systems, which are often damaged as a result of the binge eating problem. And relaxation therapy involves massage therapy, which seeks to lower stress hormones, raise positive chemical levels (norepinephrine and dopamine), and reduce body dissatisfaction.

The pandemic has unpredictably changed consumer behaviour from shopping and entertainment to healthcare needs. 

ndia is one of the world's fastestgrowing alcobev and spirits marcets. Various factors have contributed to the growth, including a large middle-class population with increasing spending power, growing urbanisation, changing preferences towards quality products, and the subsequent waning cultural taboos. However, the COVID-19 lock-

down, which began in late March 2020, had a significant toll in all areas, and the alcobev and spirit industry was no exception. Some states tried to adjust to the shifting dynamics of the distribution system, and the approach turned out to be relatively fruitful. A few states began home delivery to reduce crowds and facilitate social distance during the lockdown. However, consumption started picking up pace after lockdowns were eased, and people thronged out-lets to embrace the packs of tinge of

picking up pace; however, the behavioural change of the drinkers persisted. In fact, some studies have hinted at an increase in intake.

An element of many people's social lives, the industry noticed an intriguing shift in consumer behaviour, as they were eager to experiment with their tipple while at home. It's fascinating to watch how they experiment with beverages they may not have had previously, such as artisan whiskey, craft rum, and craft gin. The change in preference towards premium is also an alteration from the health aspect, as consumers became conscious about quality and did not bat an eyelid before shelling out extra to savor the premium tastes.

Impact of social media and OTT also cannot be negated as it is bringing in the exposure to international trends, which kicks in the mentality of aping behaviour of mature markets. The recent research reports point toward the psychological behaviour of the internet generation as they want to portray themselves on social media platforms as the acceptors of experimental consumption.

Another pattern that emerged after the pandemic is the increased inclination to go premium. The shift

occurred because people saved money by not going to bars/restaurants; people could afford to go a notch up in liquor selection with the same amount. Consumers are looking to create an experience out of their drinking time and are hunting for quality. In the future, there will be more private gatherings and more opportunities to experiment with DIYs, which usually leads to fascinating consumer behaviour adjust-Looking at the increased con-

sumption, we took the opportunity to step in as a responsible corporate body to promote a judicious drinking habit that should not affect personal lives. An increased focus on awareness campaigns is required, and we carried out numerous camps to educate people.

The pandemic has necessitated the focus on health aspects, and that is where the people's increased inclination towards quality has to be weighed in. The alcobev industry is catching up fast to reach pre-COVID sales and is also aware of the responsibilities at the same time. We need to take these forward to create a society that can always raise a toast to

ll Satyajit Ray lovers can come and gaze at his book covers at the India International Centre Gallery and partake of the celebration of *Ray@100 years* which has gathered steam in many places in the country. This set of book covers — at the exhibition *Ray Between the Covers* — unravels his enchantment for design and his love for the alphabet as well as the human figure in all its moods.

For Ray, a book's cover was more than that. It was a living metaphor of its contents. His design influences range from Western art to Santiniketan, to the grace of calligraphy as well as the Japanese wash technique. Historians state that his work changed the face of the 1940s Bengali publishing industry.

#### VINTAGE LIST OF 1940S AND 50S

Of course, for those of us who remember his best covers, it's best to recall and reminisce because these covers are rare vignettes of his captivating contours and compositional brilliance. Unforgettable is that vintage list, beginning from Premendra Mitra's collection of poems, Ferari Fouj (The Lost Army, 1948), Leela Majumdar's short story collection, *Din Dupure* (Midday, 1948),
Achintya Kumar Sengupta's novel, İndrani (1949), Bishnu Dey's collection of poems, Naam Rekhechi Komal Gandhar (I have Named her Komal Gandhar, 1953), Parampurush Sri Sri Ramkrishna (Sri Sri Ramakrishna, the Supreme



Jibanananda Das's Bonolata
Sen (1952) Achintya Kumar


Since these covers don't feature in this suite of covers, one must hunt for the delectable figure and contrasting calligraphic charisma.

Professor Shanku has a Western tinge to the contouring. Indeed, for Ray, the cover of a book was like a hieroglyph just waiting to be deciphered; in his cover of *Badshahi Sangiti*, we see the cityscape with street and the human face as a teaser revealing just enough to stoke interest in the contents and fire our curiosity.

Ray had started in 1943 as a junior visualiser at an advertising firm, D J Keymer and Co, where Dilip Kumar Gupta (popularly known as DK) was an assistant manager. DK went on to start a publishing venture, called Signet Press, the same year, which revolutionised the



look of the Bengali book. Ray joined him as a principal artist, a job that allowed free rein to his creativity.

Gangtoke Gondogol is a masterpiece. It is a reflection of Ray's love for visual dynamics; we can sense the love Ray had for the aesthetic as well as an adaptive appreciation of form to content.

Scholars have noted that

stylistically Ray was like a chameleon who adapted his design according to the needs of a particular book. This approach was a marked departure from the repetitive, and often superficial, decorative style prevalent in the Bengali publishing industry at that time. His liberal use of references from Western and Eastern art to provide a subtext to his creations is seen in the manner in which he creates spatial divisions between alphabets and textural inferences. While Western influences had seeped into his sensibility even as an



adolescent, Ray's exposure to Indian art came much later, only when he went to Santiniketan as a student at Kala Bhavan in 1940: Nandalal Bose and Benode Behari Mukherjee, his teachers, opened up a new world before him.



#### I OVE FOR SCRIPT

His understanding of using the outline printed in reverse, within a black block, and combining it with the author's name written by hand, with the title at the top creates masterpieces in the anatomy of design. When he uses the lexicon of grammarian script you can sense his understanding of subtle spacing as well as alignment of horizontal and vertical design frames. While this collection could have included some of his utterly feminine fabular tales this does well to bring in the spirit of celebration and the eternal chord that existed between the earthiness of both humans and nature in all of his escapades with the art of creating book covers as well as telling stories.

We can walk away remembering his words: "Somehow I feel that an ordinary person — the man in the street if you like — is a more challenging subject for exploration than people in the heroic mould. It is the half shades, the hardly audible notes that I want to capture and explore."

# Boundlessness of built environment

The evolution of design, as a whole, is the result of cultural boundaries to guard political power, professional responsibilities and privileges, says NIKITA BAJAJ PATHAK

The term built environment touches all aspects encompassing the buildings we live in, generally described as manmade or modified structures that provide people with living, working, and recreational spaces. As architects, we aim to achieve an integrated, environmentally conscious approach to building designs. The fraternity in the industry has been consistently discussing how to meet the climate targets, reduce heat island effects and limit the impact of the built environment over the past few years. The built environment dictates how societies develop while expressing their cultural infrastructure while also negotiating the abstract world of policies, council guidelines, building codes, and laws. All this coming together creates visible structures that allow for comfortable living, business activities, and transport networks.

As architects, we appreciate that the inhabited urban built environment is made of boundaries, demanding how we look at spatial data representing the architectural and material characteristics. Architectural boundaries are a determinant for the spatial subdivisions of the built environment. The sequence of boundaries is designed to better appreciate how abstract spatial data refers to the empirical social reality of the material presence of the built environment to its inhabiting society. The types of boundary lines create a built scheme with analytic units that are at once ideational and empirical.

The evolution of design, as a whole, is the result of cultural boundaries to guard political power, professional responsibilities, and privileges. But one must also understand the performance attributes associated with the design of buildings and design professionals. There is a need for better communication and negotiation among the stakeholders and financial institutions through policies and regulatory agents to user groups. This is done by simply finding different positions and priorities while still respecting the view-



point of all parties involved. Encouraging the architecture fraternity to integrate sustainability thinking within their projects will require assurances that assessment methods be transparent in use while being complementary to other tools and processes. With this approach, architectural and design boundaries can be conveniently created with the help of non-sustainable materials for the betterment of the built environment.

The success with the current generation of the built environment method lies in the perceived simplicity in declaring an industry's expectation of what constitutes a built environment and its construction. While architecture is governed by various boundaries of rules and regulations, it also comes with its own set of ambiguous and limitless opportunities to explore the realm of design. The solution to complex design involves a wide range of influence and time frames requiring the ability to appreciate the inter-relationships between a broad range of conflicting requirements. The principal task of

architecture does not only concern the production of objects, but it also helps in creating suitable spatial dimensions at various locations. It offers an interplay between spatial features of constructive elements involved with the perception of user experience. The boundless architecture further comprehends architectural situations from the perspective of experience and not of design. The key consideration of design is the way in which people experience the buildings created for them, be it governed by boundaries or the freedom of boundlessness

While the terms 'roof', 'base', and 'wall' do appear to be quantitative and physically accountable along with being bordered, the individual concepts do not primarily refer to constructive contexts while representing an aesthetic doctrine of building shapes. Design is not just limited to locating terms within the history of architecture, nor are concepts generalised within a broad socio-cultural context. Concrete architecture and built environment, at the end of the day, concentrate on the situative contents of the respective term in connection with concrete structural-spa-(The author is an

# INDIA TOPS T20 RANKINGS

India claimed the top spot in the ICC men's T20 International Team Rankings on Monday, riding on their 3-0 series sweep over the West Indies at home.

Rohit Sharma's men eased to a 17-run victory over the West Indies in the third and final T20 of the series on Sunday in Kolkata an emphatic 3-0 clean

The triumph helped India catapult England at the top of the T20 team rankings, with the side now matching the top rating of 269. India last attained the number one spot back in 2016, a reign that lasted a little over two months.

While England and India both have the same

tional matches in the current rankings period (269), India has a total of 10,484 points, 10 more than

England's 10,474. According to a statement issued by the ICC, Pakistan (rating of 266), New Zealand (255) and South Africa (253) complete the top five list, while current world champions

Australia (249) remain in

victory over Sri Lanka.

West Indies (235) are placed seventh, followed by Afghanistan (232), Sri (231)Bangladesh (231).

Prior to the recentlyconcluded contests against the West Indies, India had whitewashed New Zealand 3-0 at home in November last year.

## We're clear about WT20 team combo: Dravid

 $F_{\text{can be tricky}}^{\text{inding the perfect combination}}$ formula, but India head coach Rahul Dravid says he and skipper Rohit Sharma are pretty clear about the team for the T20 World Cup in Australia in less than eight months'

The former captain, who took over from Ravi Shastri after India's group stage exit in last year's T20 World Cup in UAE, will have his first big challenge in Australia. Dravid said he and Rohit understand what should be the team combination for the

"I think we have got a fair idea between Rohit and myself and the selectors and the management," Dravid said after their 17-run win over the West Indies in the third T20I that ensured a 3-0 clean sweep here on Sunday. "I don't think there's a set formula to it. But we're pretty clear about the balance and the combination (for the T20 World Cup)...We are just structuring a little bit of the team around it and also balancing individual workloads as well.

We have got a pretty fair idea of the kind of skills we're looking for in Australia, with the kind of guys who are in running. Not everything is set in stone but we want to give every-

one a fair chance to stake their claim for those spots," he added.

The T20I series against West Indies was India's first in a packed calendar in the build-up to the World Cup and they next take on Sri Lanka in an identical three-match rubber in four days' time.

In the absence of some Team India regulars like opener KL Rahul, and pacers Jasprit Bumrah and Mohammed Shami, India gave opportunities to youngsters such as Ishan Kishan, Ruturaj Gaikwad and Avesh Khan to stake their claim in the World Cup-bound squad.

With Virat Kohli and Rishabh Pant being given a 10-day bio-bub-ble rest, India also tried out Shreyas Iyer, while Kishan doubled up as the wicketkeeper in the third and final T20I. Dravid said the whole process was about having the backups ready.

"In the times that we live in, it's never easy... I don't think there's a time-frame when you can actually say that okay, now this is the team you want to freeze on.

'You don't want to cast your net too wide. We don't also want to restrict ourselves to just 15 players. We want to give players opportunities, ensure that by the time we get to the World Cup, some of our guys have played at least 10-15-20 games," Dravid explained.

"It gives Rohit a chance to play them, bowl them in positions that he wants to, but he also has to be balanced with the fact that we need to have a few back-ups of people in case of an injury," he added.

## Dravid not hurt by Saha's comments | WI should not feel disgraced: Pollard

India's head coach Rahul Dravid Lis not "hurt" by Wriddhiman Saha revealing the "difficult" conversation that the two had about his future as he firmly believes that the veteran keeper-batter "deserved the honesty and clarity' which was provided to him. Saha, whose India career has

come to a halt, recently told the media that Dravid asked him to consider retirement during a private conversation after the South Africa series last month. Dravid said his intention

behind talking to Saha was to ensure he has a clear picture of where he stands and he does not "I'm actually not hurt at all. I

have deep respect for Wriddhi and his achievements and his contribution to Indian cricket. My conversation came from that place. I think he deserved honesty and clarity," Dravid replied at the end of the T20



series against the West Indies which India won 3-0 on Sunday.

The 37-year-old, who has played 40 Tests for India, was dropped from the squad ahead of the upcoming home series against Sri Lanka. He subsequently pulled out of the ongoing Ranji Trophy as

Dravid said he will continue having such conversations with players whether they like the discussion or not.

"It's about conversations I constantly have with players. I don't expect players to always agree with everything I say about

They might have been handed a 0-3 clean sweep in the T20I series but West Indies skipper Kieron Pollard said his team shouldn't feel disgraced as the scoreline is not an indication of the fight put up by them during the three-match rubber against India. Suryakumar Yadav came up with

an explosive 65 and was backed up by a spirited bowling effort by the seamers as West Indies fell short by 17 runs in their chase of 185 in the final T20I here on Sunday. Yes we lost 3-0 but the guys put

their hands up and gave a good account of themselves. I don't think we should be disgraced by what has taken place," Pollard said in the postmatch virtual media interaction "We are not happy losing, let me

put that on record. It's not like that at all. We are trying to win cricket games." West Indies had their best chance to level the series in the sec



ond T20I with Royman Powell and Nicholas Pooran slamming explosive fifties in a 100-run partnership. But India fought back with

Bhuvneshwar Kumar bowling a tight penultimate over as West Indies fell short by just eight runs.

"It just goes to show the fine line

in International cricket between winning and losing, and the margins for error -- when you are bowling or batting," Pollard said. Executing in the backend is

something we need to work on. From a bowling perspective, for the first 15 overs of this game, we had India right where we wanted them to be. "Right through the series, it was

just a matter of finishing off the games in the back-end. From a batting perspective, 157, 180 (178) and 170 (167) we did fairly decently."

WI, a work in progress The biggest positive for the West Indies have been the return to form of wicketkeeper-batter Nicholas Pooran who slammed three halfcenturies on the trot to be the top-run getter of the series with 184 runs at an average of 61.33.

## Desperate India aim to end losing streak in NZ tour

the first ODI, it was the bowlers and fielders who failed to keep things under control in the last two matches as the New Zealand side successfully chased down big totals. With the World Cup looming,

Mithali Raj's team will have to iron out the flaws in the next two ODIs and the return of star opener Smriti Mandhana and pacer Meghna Singh will bolster the team as it looks to get some momentum ahead of the big-ticket

In the bowling department, veteran pacer Jhulan Goswami was the only bright spot in the 3rd ODI as she rocked the top-order with three wickets but she lacked support as New Zealand recovered from 171 for 6 to

chase down 280 with five balls to spare. With Meghna back, India will look to field a strong and settled pace attack in the remaining two ODIs after experimenting with Pooja Vastrakar, Simran Bahadur and Renuka Singh.

Among spinners, Deepti Sharma has shone bright with seven scalps, including a four-wicket haul in the second ODI, but the likes of Poonam Yadav and Rajeshwari Gayakwad will have to put up more consistent shows.

India's batting has looked good with Sabbhineni Meghana grabbing the opportunity with both hands, hitting 49 and 61 in the last two ODIs in Mandhana's absence. Shafali Verma also returned to form with a 57-ball 51 in the third game.

With Mandhana back, it will be interesting to see the combination that skipper Mithali fields in the next two



ODIs, especially with Harmanpreet Kaur struggling to get runs in the mid-

New Zealand, on the other hand, have been working like a well-oiled machine. The hosts are high on confidence after chasing two big scores but one area they would like to improve is bowling in the final two games.

Amelia Kerr (219) and Suzie Bates (127) have been their best batters with each hitting a hundred in the first two

## Djoker starts his season in Dubai

Novak Djokovic's season, derailed in January when he was deported from Australia, finally starts on Monday in Dubai with the world number one insisting players in the locker room have been positive and welcoming" on his return.

Djokovic missed the chance to win a 10th Australian Open, and 21st Grand Slam, due to the cancellation of his visa in Melbourne and eventual deportation as a result of not being vaccinated.

He returns to the tour this

week in the Emirates, where he will be competing for the first time since the Davis Cup Finals in Madrid last December.

Dubai organisers have dubbed the first day of the ATP event 'Magnificent Monday' and a couple of other marquee entrants, Marin Cilic and Andy Murray, will also be in action



But all eyes will be on Djokovic who last played in Serbia's Davis Cup semi-final defeat by Croatia.

Djokovic, who saw Rafael Nadal win in Australia to claim a 21st major, is able to play in Dubai as a coronavirus vaccine is not a requirement to enter the United Arab Emirates.

The Serbian is a five-time

winner in Dubai and he finally starts his season with a point to prove and his number one ranking under threat.

Even if he wins in Dubai, Djokovic could lose the top spot, which he has held since February 2020, to Daniil Medvedev, who is in action this week almost 15,000km away in Acapulco.

### R Praggnanandhaa stuns World No 1 Magnus Carlsen

 $m{r}$ oung Indian Grandmaster R Y Praggnanandhaa stunned world No 1 Magnus Carlsen in the eighth round of the Airthings Masters, an online rapid chess tournament.

Praggnanandhaa won with black pieces in 39 moves in a Tarrasch variation game early on Monday to halt Carlsen's run of three straight wins.

The Indian GM lies in joint 12th spot after eight rounds with eight points. His spectacular win over Carlsen comes after a moderate run in the earlier rounds, which included a solitary victory over Lev Aronian, two draws and four defeats.

He drew against Anish Giri and Quang Liem Le and lost to Eric Hansen, Ding Liren, Jan-Kryzstof Duda and Shakhriyar Mamedyarov.

Russia's Ian Nepomniachtchi, who lost the world championship match a few months ago to the Norwegian world No 1 Carlsen, is on top of the standings with 19 points followed by Ding Liren and Hansen



(both on 15 points).

In the Airthings Masters, a 16player online rapid tournament, a player gets three points for a win and one for a draw in the preliminary rounds. Seven more rounds remain in the preliminary phase.

Lille side sitting in mid-table **A**in Ligue 1 head to London to face Chelsea this week hoping to play the role of "party poopers" against the reigning European champions, their coach Jocelyn Gourvennec said.

Recent Club World Cup winners Chelsea are heavy favourites to beat Lille in their Champions League last-16 tie as Thomas Tuchel's side look to retain the title they won by beating Manchester City in last season's final.

Lille already exceeded expectations just by reaching the last 16 of Europe's elite club competition for the first time since 2006/07 and, as they make the short trip to the other side of the English Channel for the first leg, their aim is to keep the tie alive for the return. "We are competitors so we will not be going there just to be Chelsea's sparring partners, that's for sure," Gourvennec said.

The side from France's far north caused a major upset by winning the French title last season ahead of star-studded Paris Saint-Germain and they then topped their Champions League section above Austrian champions Salzburg, Sevilla and Wolfsburg.
