Hindu saint Ramanujacharya "This statue of Ramanujacharyaji is a symbol of his knowledge, detachment, and ideals," he observed.





## Talks fruitful, employees call off stir

Finally, the talks between the State government and the employees have been fruitful. The sevenhour marathon negotiations have become successful with both the government and the employees arriving at a consensus on most of the contentious issues.

Continuing their talks for the second consecutive day on Saturday, the Ministers' committee and the Employees' unions hammered out a consensus, thus ending the impasse. In a joint press conference late on Saturday night, along with employees' union leaders, Advisor to AP Government (Public affairs) Sajjala Ramakrishna Reddy said that the

The cumulative Covid-19 count in Andhra Pradesh crossed 23 lakh on Saturday, with the last one-lakh cases coming in 11 days.

Simultaneously, the gross recoveries also went past the 22 lakh mark. But the declining trend continued as the state registered 3,396 fresh cases in 24 hours ending 9 am on Saturday.

The latest bulletin said 13,005 infected persons got cured and nine more succumbed in the state.

The number of active cases dropped by 9,618 to 78,746, the bulletin said.

The coronavirus caseload now stood at 23,00,765. While the total recoveries increased to 22,07,364, the overall toll touched 14,655.

East Godavari district reported the highest of 516 fresh cases and Srikakulam the lowest of 46 in 24 hours.

Vizianagaram logged 56 while the remaining 10 districts added between 100 and 500 new cases each.

Anantapuramu, SPS Nellore and Prakasam districts reported two fresh fatalities each.

Chittoor, Guntur and Kurnool had one Covid-19 death each in a day.



## Punjab elections: 1,304 candidates left in the fray

A total of 1,304 candidates are left in the fray in the highstakes February 20 Punjab assembly polls.

As many as 341 candidates withdrew their nomination papers on Friday which was the last date for the exercise, said Punjab's Chief Electoral Officer S Karuna Raiu.

Raju said 2,266 candidates had filed their nomination papers for the 117 assembly constituencies of the state. During the scrutiny, 1,645

nomination papers were found valid, he further said. The highest number of 19 candidates are contesting from Sahnewal and Patiala assembly constituencies.

Five candidates, the least number, were contesting from Dinanagar constituency. Among prominent candidates who are contesting the state assembly polls are Chief



Social Welfare hostels in Krishna district are all set to give corporate institutes a run for their money. With modernisation works of 138 hostels nearing completion under the 'Nadu-Nedu' programme, students hailing from underprivileged and weaker sections can hope for comfortable accommodation with all modern facilities.

As per the instructions of District Collector J Nivas, the renovation of the hostels has been taken up under the 'Marpu' programme and the works are going on at a fast pace. Officials of the Panchayat

Raj department have estimated that the works of each of the hostel to cost Rs 10 lakh to Rs 15 lakh. In all, 178 welfare hostels are present in the district. Out of them, 138 are being run out of the government-owned buildings which will get a total facelift soon. The works for the pilot project are underway at Penamaluru and Kaikaluru in the district. The renovated pilot project hostel in Penamaluru will be inaugurated by the minister in 10 days.

After the inauguration of the pilot project, an action plan has been prepared to begin the works for all the 138 hostels in the district and to complete the same in 138 days. As part of it, engineers of Panchayat Raj, RWS, Housing and other departments will





ensure that works are completed soon without compromising on quality.







## Centre orders 5 cr doses of Corbevax

The Centre has placed a purchase order with Biological E for five crore doses of Covid vaccine Corbevax each costing Rs 145 excluding taxes, official sources said on Saturday.

The government is yet to decide on which segment of beneficiaries this new vaccine would be administered.

However, according to sources, discussions are underway in technical groups and in the Health Ministry's immunisation division about expanding the scope of the precaution doses which are currently being given to healthcare and frontline workers, and comorbid senior cit-

izens. The HLL Lifecare Limited, a public sector undertaking, has issued the supply order of Corbevax to Biological E in January-end on behalf of the

Union Health Ministry. According to the order, the Hyderabad-based company is



expected to provide the supplies in February.

"The cost implication of five crore dosed of Corbevax at the rate of Rs 145 per dose plus GST as applicable come to Rs 725 plus GST as applicable.

"In this regard, it is also stated that Rs 1,500 crore has been released as advance vide sanction order dated June 2, 2021, to HLL Lifecare Limited for from Biological E Limited," the order stated.



Under Section 7 of IBC, a financial creditor may move NCLT for initiation of CIRP over default of Rs 1 crore and above.

## Budget 2023 more directional with longterm growth: Goyal

## BharatPe's other founder backs CEO

A day after Ashneer Grover, the embattled co-founder of BharatPe sought removal of CEO Suhail Sameer from the Board, the fintech startup's other founder Shashvat Nakrani has thrown his weight behind the chief executive, saying the official continues to enjoy his confidence.

In a move that is expected to complicate Grover's pursuit to oust Sameer as both the founders need to consent jointly to remove the CEO, Nakrani asserted that he himself has not given any consent or demand for such removal and that the CEO continues to enjoy his support.

Legal experts contend that the ČEO cannot be removed from the board on the sole demand of Ashneer Grover and any such removal can only be done jointly by both the cofounders. Lawyers also confirmed that if the CEO is a nominee of both founders, then one founder's unilateral withdrawal is not valid under the law. When contacted, Nakrani

confirmed that he has not given any consent or demand for removal of Suhail Sameer from the Board.

"I have neither given my consent, nor sought the removal of Suhail Sameer from the Board of BharatPe. News reports suggesting this are incorrect", Nakrani said.



## COPING WITH STRESS

If stress was supposed to be helpful to our survival, why did it become detrimental to our lives? questions PAYAL ANAND. An edited excerpt:

nce, in an organizational behaviour class, I asked my students, 'What is that one thing that makes you similar to others sitting in the class?' Their answer, 'The fact that we all are stressed out and depressed,' cracked me up. While it really sounded funny, in reality, it isn't.

For one of my research projects, I particularly wanted to dig a little deeper and understand if managing stress is really a pervasive issue for young working professionals. I asked around 450 working professionals 'What bothers you most at work?' After analysing the responses, there were five major trends observed as a result of word cloud analysis. The dissolution of work-life boundaries and its consequent strain was one of the major observations that came out consistently. The next couple of trends that stood out were the building up of frustration and physical and psychological exhaustion. The overall feeling of gloominess and loneliness were the last two that completed the top five trends. Frankly, these trends do not baffle me. They all have been in the heavily discussed topics in psychology. However, if you notice, the com-mon denominator for all the abovementioned issues is stress. Work may become stressful for us if we perceive too many challenges, demands and threats in the environment that we are not able to deal.

Imagine a casual day when your boss asked you to make an impromptu presentation in front of the board members. Or you heard bad news from the client you were not prepared for. Do you feel sudden rush in your body in such unexpected situations? Your breathing becomes heavier, face becomes pale and/or you feel sudden weakness in gut or legs. Do you suddenly become more attentive and your eyes get dilated? All of us do. This is a natural response of our body when we see a life-threatening situation. This is our bodily response of fight or flight, also known as acute stress response. Either we fight, in other words, approach the situation, or we flee, that is, avoid the situation. Both are different from each other and are separate constructs. Fight or flight can be con-sidered as a bodily coping mechanism with threats, a response to something that is terrifying, either mentally or physically. There is an evolutionary explanation behind this phenomenon. Our ancestors used to be surrounded by various sorts of threats including attack from huge animals. It was matath As their entire life was surrounded by dangerous species, to survive better, they developed the fight or flight coping mechanism. This instinct is very much intact in us even now. Through this mechanism, once our brain senses a life-threaten-



ing situation, it prepares to cope with it. 'Stress', in this regard, acts as a signal to the brain, which then releases a stress hormone, whose objective is to create an alarm in us. Thanks to our ancestors, we have a mechanism to prepare ourselves physically and biologically when encountered with stressors. Either it prepared their body to stay and deal with a threat (i.e., fight) or to run away to safety (i.e., flight). The way stress was defined tradi-

The way stress was defined traditionally is in stark contrast with its modern definition. The old definitions explicitly indicated the positive connotation that was attached with stress at that point. It is intriguing to know that stress was a biological phenomenon against a physical or mental threat that was created to work in our favour (to alarm us of dangers), instead of working against us. The modern definition of stress, however, speaks volumes about the current interpretation of the phenomenon. The contemporary scholars define it as 'a feeling of emotional strain and pressure'. Shocking, isn't it? Modern lives have distorted our understanding of events and processes that once



were considered as a gift to humankind. In fact, the definition of 'life-threatening situations' has changed totally. Nowadays, disagreement with peers, argument with the boss, fear of missing out, fear of rejection, exclusion or unknown stresses us out, including many other things. In fact, we have created a gamut of 'modern' issues that stress us out.

Many years ago, we started off on a note that stress is positive and helpful for our survival. However, as kids growing up, we never heard people telling us that stress is positive. We commonly hear people saying, 'Stress is extremely bad for our emotional, mental and physical health,' 'Stress can be severely detrimental to life,' and 'Don't stress yourself over things.' No doubt stress has become one of the most common reasons for psychosomatic illnesses in the current times. High stress levels lead to cardiovascular diseases, lifestyle disorders (such as hypothyroidism), sexual illnesses, strokes and what not. If stress was supposed to be helpful to our survival, why did it become detrimental to our lives?

Note that over the years, our body has evolved to respond in a certain way (fight or flight) every time it encounters danger. Whether it is an attack from an animal or nomophobia, what we define as 'dangerous' or 'stressful' for ourselves is completely upon us. Our body will react accordingly. It is saddening that, in current times, not getting the 'best employee of the year' award is comparable to hunting for food and saving ourselves from man-eaters. So, who is to be blamed? It goes without saying, we have not quite understood the importance of acute stress in our lives. Unfortunately, we have not fully accepted that those heated arguments with clients/boss/colleagues or that two hours extra work that we did the other day for free are part and parcel of life. These events, by no means, are and should become a source of stress events should

Dealing with a bad situation can be overwhelming and one gets confused. Making goals and dealing with things one by one can be a practical and realistic way of dealing with a crisis. Setting goals and thinking of ways to achieve them can be transitional and can take you from not knowing to achieving new things

• Develop your problem solving skill: Study shows that people who are able to come up with solutions to a problem are better able to cope with problems than those who cannot. Whenever you encounter a new challenge, make a quick list of possible ways to deal with it. Experiment with different strategies and focus on developing a logical way to walk through common problems. If you practice problem solving skill on a regular basis, you will be better prepared to cope with serious challenges. Take action: Simply waiting for

a crisis to go away on its own only prolongs its existence. Thinking too much and plan-

ning on the safe side may not help either. By going through all the tips that I have mentioned above, just make an action plan and take action because action will give you result and over thinking won't. Rather all His acts begin with "Jai Shriram".

Let us get an idea about how powerful the word Rama is from Shri Ramacharitamanasa, written by Tulsidasa. In the famous dialogue between Narada and Lord Ramachandra, Narada requests the Lord to empower Rama name such that it can benefit the chanter immensely. The Lord consented, and we see evidence of chanters of the name Rama benefiting greatly in multiple ways. It is not surprising that Rama naam is glorified even in a person's last journey with the chanting of "Rama nama satya hai". Mother Ahilya caught attention of Lord Ramachandra by incessantly chanting Rama. The Lord delivered her from the curse she was under, because of which she had turned into stone.

The word Rama is a primal sound like Om, and we are aware of unimaginable benefits of chanting Om. The name Rama is similarly beneficial if chanted regularly. Calling the Lord's name gets His attention immediately,



because He is near us only. How God responds depends upon Him. In The Gita, Lord Krishna has specifically mentioned, "God is outside and inside of all living entities. He is situated far away and He is nearby also. (13.15) This is how God hears our prayers also. Such chanting of God's names is very useful because this activity makes us noble. (7.18), whatever may be our desires, we can be distressed, seekers of wealth, inquisitive or wise. (7.16)" Those who chant Rama regularly and with attention/devotion can youch for the fact that one's wishes are responded to in an appropriate manner, because God never ignores our taking His shelter, which chanting His name is.

Peace begins to descend on the practitioner, one can sense that he is not getting agitated/worried to the extent he was prone to earlier. Chanting of Rama *nama* effectively blocks out neg-

ative thoughts, if done with attention. Yes, this will take time, because it is not easy to be rid of negative thoughts, but it will happen as chanting of Rama name begins to purify the chanter's existence. Additionally, one will begin to feel assured. God's presence, who is omnipresent, does wonders to the consciousness as one continues chanting His name. One begins to feel assured.

In the cosmic design, there are only two duties/responsibilities for us souls. They are doing our material and spiritual duties. And the easiest and most effective to do spiritual duties is to chant Rama. Go out/do your material duties and return to chanting Rama. Soon you will be able to get used to it and may even one day get it synchronised with your breath.

## **Unlearning from crisis: Tiny fraction of GDP for health**

health crisis was marching toward the peak, Finance Minister Nirmala Sitharaman in her 100 minutes long Budget speech mentioned the word 'health" at least 34 times. In the Economic Survey 2020-21, an Takes Centre Stage, finally!" was devoted to health. This chapter was full of figures, though criticised later for superfluous correlation and better performance of outlier States, and it seems like the government accepts the importance of public spending on healthcare on out-of-pocket expenditures (OOPE), poverty, and public health.

In the Budget documents, clubbing the related heads and some finance commission grants, the rhetoric of 137 per cent increase in health expenditure was streamed under the title "Health and Well-Being" budget. #### Conclusion

There is an urgent need to democratise the political parties which are the very heart and soul of a democratic regime. Political parties often are accused of partisan functioning during ticket distribution; a charge that can't be shrugged off if the internal working of the party gets a democratic set-up. Also, it has been noted that various posts in the party are held by powerful and influential people who often convince the party leadership to do away with formal internal elections. This leads to favouritism, corruption and in many cases shifting of member between parties. Corruption is caused by overcentralisation since "the more remotely power is exercised from the people, the greater is the distance between authority and accountability." These are implications of the fact that provisions related to intraparty democracy are most of the time ignored and put on the shelf.

### Pentagon: Deadly Afghan airport attack was not preventable

The military investigation into the deadly attack during the Afghanistan evacuation has concluded that a suicide bomber, carrying 20 pounds of explosives packed with ball bearings, acted alone, and that the deaths of more than 170 Afghans and 13 U.S. service members were not preventable. The blast at Abbey Gate outside the Kabul airport on Aug. 26 killed 11 U.S. Marines, a sailor and a soldier, who were screening the thousands of Afghans frantically trying to get onto one of the crowded flights leaving the country after the Taliban takeover. The Islamic State group claimed responsibility for the attack. At the Pentagon on Friday, military officials laid out a detailed and graphic minute-by-minute account of the bombing. The bottom line, they said, was that those who died had wounds that were "so catastrophic" that they couldn't be overcome. And they said that earlier thoughts that it was a complex attack involving gunfire turned out to be unfounded. "A single, explosive device killed at least 170 Afghan civilians and 13 U.S. servicemembers by explosively directing ball bearings through a packed crowd and into our men and women at Abbey gate," said Gen. Frank McKenzie, head of U.S. Central Command

# **'GAY code for Gaya airport inappropriate'**



Parliamentary panel on Friday said the use of 'GAY' code for Gaya airport is inappropriate for the holy city and asked the government to make all efforts to change the code.

The Committee on Public Undertakings, in its first report tabled in Parliament in January 2021, had recommended changing the code of Gaya airport from 'GAY' and also suggested an alternate code name like 'YAG'.

According to the civil aviation ministry, IATA has essed its inability to change the code without a "justifiable reason primarily concerning air safety" The International Air Transport Association (IATA) assigns the code for airports. > A<sup>s</sup> soon as a Uyghur athlete helped light the Olympic flame at the Beijing Olympics, the debate began: Was it a defiant signal from Chinese leaders, or proof that protests around the world were having impact? The selection of Dinigeer Yilamujiang for the supreme honor of being a final Olympic torchbearer at the ceremony that opened the Winter Games in Beijing on Friday night was a huge surprise. What it meant - because Olympic gestures like this always have meaning - wasn't clear. U.Sbased human rights lawyer Rayhan Asat — whose brother Ekpar Asat is among more than 1 million Uyghurs that China has imprisoned - was at first aghast. The pictures of Yilamujiang, a 20-year-old cross-country skier, holding the torch with Zhao Jiwen, a skier from China's dominant Han majority - both of them all smiles - reminded Asat of the half-Jewish fencer, Helene Mayer, who competed for Germany at the 1936 Summer Olympics that Adolf Hitler hosted in Berlin. "I did feel like history is repeating itself," Asat said in a phone interview. "This is like a new low. That is how I felt, initially." But on reflection, Asat saw crumbs of encouragement. China has steadfastly rejected international criticism of its crackdown on Uyghurs, treatment that the US government and others have said is tantamount to genocide. China's hosting of the Games has made many exiled Uyghurs feel that their voices aren't heard. But the selection of a relatively unknown athlete to light the flame couldn't be a coincidence.

At the core of the Ukraine crisis is a puzzle: Why would Russian President Vladimir Putin push Europe to the brink of war to demand the West not do something that it has no plan to do anyway? Russia says NATO, the

American-led alliance that has on its hands the biggest European crisis in decades, must never offer membership to Ukraine, which gained independence as the Soviet Union broke apar about 30 years ago. Ukraine has long aspired to join NATO, but the alliance is not about to offer an invitation, due in part to Ukraine's official corruption, shortcomings in its defense establishment, and its lack of control over its international borders.
