Delhi, Maha head for Covid crisis

4,099 fresh cases in Delhi, 12,160 in Maha; India's daily spike reaches 33,750

PNS NEW DELHI/MUMBAI

The Covid-19 is marching relentlessly across the country with each day total case count registering new high and the situation turning for the worse in States like Delhi and Maharashtra. On Monday, Delhi registered 4,099 fresh cases of Covid-19 and one death in the past 24 hours. The positivity rate has increased to 6.5 per cent from 4.59 per cent recorded Sunday.

On the other hand, Maharashtra recorded 12,160 Covid-19 cases, taking the total number of cases from 66,99,868 cases to 67,12,028 cases. Similarly, the State recorded 68 Omicron cases, taking the total number of Covid-19 variant cases from 510 cases to 578 cases

While 33,750 Covid-19 infections were reported from across the country during the last 24 hours on Monday, the Omicron tally breached 1,700 marks of which 639 people have recovered. According to an estimate, cases of the virus nearly tripled in the week ending Sunday as compared with the previous seven days, registering an unprecedented rise of 181 per cent rise during the period. Covid-cases on Monday were 22 per cent higher than Sunday, while 123 died due to the virus in a day.

The variant of concern has spread to 23 States.

Maharashtra topped the Omicron list with 510 cases fol-lowed by Delhi (351) Kerala (156), Gujarat (136), Tamil Nadu (121) and Rajasthan (120). Bihar also reported the highest weekly percentage increase, with cases going from 85 in the December 20-26 week to 1,073, a 12-fold rise although the absolute numbers

times the previous week's tally of 3,550. Jharkhand numbers also leaped by nearly nine times to 2,879, from 326. Other States where this week's cases were at least five times higher than the preceding one included Gujarat (4,410 cases), Uttar Pradesh (1,617), Rajasthan (1,403), Chhattisgarh (1,133) and Haryana (2,285).

In a worrying development for India, China is building a bridge across the Pangong Tso (lake) in eastern Ladakh for rapid deployment of its troops on both the banks of the lake. The two-year-old stand-off

between India and China started from Pangong lake when the Chinese troops blocked an Indian patrol leading to exchange of blows. Situation later turned seri-

ous with the Chinese troops transgressed the Line of Actual Control (LAC) at several points leading to a bloody clash in the Galwan valley in 2020. Twenty Indian Army per-

Over 37 lakh teenagers from 15-18 yrs get first Covid jabs

Vax drive for children begins; 39.88L register on CoWIN till Monday

PNS NEW DELHI

Over 37 lakh teenagers between 15 and 18 received their first Covid shots, Covaxin, on the first day of the pecial vaccination drive for children launched across the country from Monday morning, amid clear signs of the beginning of a fresh Covid-19 the highly transmissible Omicron variant.

Most of the schools and other educational institutions are being used as inoculation centres for those between 15-18 years. The Government has advised States to make separate Covid vaccination centres (CVCs) for children and adults to avoid mixing of vaccines.

Those born in 2007 and before are eligible for the vaccine. As per the data available on CoWIN portal, more than 39.88 lakh beneficiaries, aged 15 to 18 years, registered themselves on the website till

Monday afternoon. Around 7.5 crore children of this age bracket will be vaccinated across the nation under

the drive. Earlier, Union Health Minister Mansukh Mandaviya had tweeted, "Great to see that our young friends all over the country are uploading their

this age bracket to get vaccinated at the earliest and further strengthen the world's largest vaccination drive Mandaviya had visited the

vaccination centre at Ram Manohar Lohia hospital in the national Capital and enquired about the process.

As of now, only Bharat Biotech's indigenously-made Covaxin will be available for vaccinating this age bracket. According to the Union Health

Ministry, all States and Union Territories will get additional doses of vaccines for administering to this population category.
On December 25, Prime

Minister Narendra Modi announced that vaccination for the 15-18-year age group will begin from January 3. Meanwhile, the administration of the third dose of vac-

cine for health workers, frontline workers, and vulnerable senior citizens will begin from

66 people on Mumbai-Goa cruise ship test Covid +ve

s many as 66 of the over As many as oo of the 2,000 people on board the Cordelia cruise ship, which came to Goa from Mumbai, have tested positive for Covid-19, State Health Minister Vishwajit Rane said on Monday. The cruise liner, where the NCB busted a highprofile rave party in October last year, was carrying hordes of New Year revellers.

A medical team in PPE kits came on board to conduct RT-PCR tests of the passengers and crew members, and the sample testing process continued till Monday afternoon. The testing of those on board the vessel was necessitated after a crew member was found infected with the coronavirus on Sunday, an official said. Officials had instructed that no one should disem-



bark from the ship till the result of the RT-PCR tests was declared. The liner is anchored close to Mormugao Port Trust (MPT) cruise terminal.

On Monday afternoon, Rane tweeted, "Out of 2000 samples tested from Cordelia cruise ship, 66 passengers tested positive for #COVID19. Respective collectors and MPT staff have been informed. The

authorities will decide whether to allow disembarking of pas-

sengers from the ship."

The ship, operated by a private firm, had arrived at Mormugao Port Trust in Goa on Sunday. A day ago, Goa had reported 388 new Covid-19 cases, taking the infection tally to 1,81,570, while one death raised the toll to 3,523, as per official data

Ensure all voters get both Covid doses: EC to poll-bound States

Polling staff must get second dose on priority, eligible for precaution dose: EC

PNS NEW DELHI

A fter assessing the Covid-19 situation in the five pollbound States, the Election Commission (EC) has asked them to accelerate the vaccination drive to ensure that all eligible citizens in their respective States are fully inoculated at the earliest. The EC has also asked to ensure that the personnel to be deployed on election duty are "double vaccinated".

The poll panel reportedly expressed concern about the low percentage of first dose vaccination in Manipur. According to sources, in a

recent letter to the chief secretaries of Uttar Pradesh, Uttarakhand, Goa, Manipur, and Punjab, the EC reminded them that polling personnel come under the category of frontline workers and are eligible for the "precaution dose"

of the Covid vaccines.

The commission has said the polling personnel to be deployed in these States should be fully vaccinated and those eligible for the second dose of the vaccines should be administered the jabs on a priority basis, the sources cited the letter.

Taliban shut down women's baths in **Afghan province**

As the Islamic Emirate of Afghanistan is taking root

Those who proclaim themselves accidental Hindus are not Hindus: CM to Gandhian family

In a veiled attack on the Gandhi family for practicing 'divisive politics', Chief Minister Yogi Adityanath said that those who proclaimed themselves 'accidental Hindus', cannot call themselves Hindus and sought to know why the family goes out and claims allegiance to Hinduism during elections.

"Unhe chunaav me hi 'mandir' aur Amethi ki yaad aati hai," he said.

Addressing a public rally in Amethi, a bastion of the Gandhi family in Uttar Pradesh till 2019, the chief minister remarked, "Those who have always adopted divisive politics, who have disintegration and division in their genes, whose ancestors used to say that we are accidental Hindus, cannot now call themselves Hindus."

Yogi laid the foundation stone for a government medical college worth Rs 293 crore and also inaugurated a 500-bed district-level referral hospital built at a cost of Rs 86.42 crore in Amethi. Union Minister Smriti Irani was also present on the occasion.

Taking a jibe at Congress leader Rahul Gandhi, Yogi said, "He does not even know how to sit in a temple and knows nothing about Hinduism or Hindutva. During the elections in Gujarat, the former MP of Amethi went to a temple and sat there in the position to offer namaz. The priest had to interrupt and guide him how to sit

Accusing the previous Samajwadi Party government of bringing anti-communal law and playing with the faith of Hindus, the chief minister said,

"By bringing anti-communal law in the country, they wanted to imprison the Hindus of this country and wanted to play with their faith. But as the elections inch closer, they have the audacity to go out and pose as staunch Hindus."

Yogi further said, "We are not hiding anything and we don't have any hesitation. When I was not the chief minister, then too I used to say this which I am reiterating, that everyone should proudly say that they are Hindus. In their lust for power and the politics of appeasement they were always eager to destroy Ram Setu. Sometimes, they used to instigate riots in the name of

communalism." Targeting the Congress brass, the chief minister said, "They remember Amethi in the elections only. When the people of this district gave them a chance to serve, they did nothing. The Congress big gun's apathy led to his defeat in the Lok Sabha election in Amethi. But now as the elections are approaching, they have taken out time to visit the district again. They are undertaking political tourism."

Launching a scathing attack on the Congress 'bhaibehen' duo, Yogi said, "During the COVID-19 pandemic, when we were working to save the lives of the common man, the brother-sister duo provided fake registration numbers of buses to ferry stranded workers into UP from Rajasthan, These numbers turned out to be of scooters. Not a single leader or president of Samajwadi Party, Congress or Bahujan Samaj Party came forward to help the public during

as elections come, these people come here. They will disappear for four and a half years after the elections and will not be seen again."

Slamming the Samajwadi Party chief for crying over the recent IT/GST raids, the chief minister said, "Today we are getting houses built for the poor. In the previous government, the funds were used to go to the pockets of 'babua'. "Yes, the chargesheet has been filed," the senior prosecution officer SP Yadav told media persons waiting outside court. The police said during the investigation they had found that Ashish was present at the spot when the violence occurred. The report said the name of one of Ashish's relatives, Shukla, has also been added in the chargesheet. Shukla has been accused of destroying evidence in the case.

The SIT of the Uttar

Pradesh Police that is probing the violence case had earlier said the incident was a 'planned conspiracy' with 'intent to kill'. On December 14, the SIT had submitted an application in the court to invoke four more criminal charges against the accused, including murder. The SIT requested the local court to drop three charges under IPC sections 279 (rash driving on a public way), 338 (causing grievous injury by act endangering life) and 304a (causing death by negligence) against the accused. The probe team then slapped Sections 307 (attempt to murder), 326 (voluntarily causing grievous hurt by dangerous weapons or means) and 34 (Act done by several persons in furtherance of common intention) of the IPC against the accused booked

in the killing of four farmers and a journalist. The case relates to the killing of eight people, including four farmers, during a protest in Lakhimpur Kheri district against the Centre's three farm laws on October 3. Violence had erupted when farmers were protesting the visit of Uttar Pradesh Deputy Maurya. Four agitating farmers were run over by a vehicle,

belonged to Ashish. The Supreme Court had reconstituted the SIT and added new members, IPS officers SB Shiradkar, Preetinder Singh and Padmaja Chauhan, along with retired judge of Punjab and Haryana High Court Rakesh Kumar Jain, to probe

As 1748 patients were discharged from the hospitals across the State after full recovery, the total number of people discharged from the hospitals since the second week of March last year increased from 65,12,610 cases to 65,14,358 cases The recovery rate in the State dropped from 97.21 per cent to 97.05 per cent.

The number of "active cases" in the State increased from 42,024 cases to 52,422 cases. The fatality rate in the State dropped from 2.11 per cent to 2.1 per cent.

Mumbai accounted for a maximum of 37,274 cases, while there were 6309 active cases in Thane. There were 3808 active cases in Pune, followed by Palghar (1080), Raigad (980), Nashik (691),, Ahmednagar (346), Nagpur (406) and Satara (336).

Of the 6,93,70,095 +samples sent to various laboratories across the State so far, 67,12,028 have tested positive (9.68 per cent) for COVID-19 until Monday.

Currently, 3,32,610 people are in-home quarantine while 1,096 people are in institutional quaran-

Meanwhile, the State recorded 68 cases of Omicron, taking the total number of new Covid-19 variant cases to 578 cases. Of the new Omicron cases reported on Monday, 34 have been reported by the National Institute of Virology (NIV) while 34 cases were report ed by National Chemical Laboratory (NCL).

Of the 68 omicron cases reported in the state on Sunday, Mumbai accounted for a maximum of 40 cases, followed by Pune Municipal Corporation (14), Nagpur (4) Pune rural, and Panvel- 3 each, Kolhapur, Navi Mumbai, Raigad and Satara-

In a related development, the authorities said the total number of passengers who arrived at Mumbai, Pune and Nagpur airports since December 1 was 2,23,630 (32,705 from At-risk countries and rest 1,90,925 are from other countries), while passengers whose RT-PC tests have been done are 51,735 (32,705 are from high-risk countries and 19030 are from other countries). Similarly, RT-PCR positive and samples sent for genomic sequencing was 490(302 are from at-risk countries and 188 are from other countries).

Ensure all voters get both Covid doses: EC to ...

To assess the preparedness of election-bound States, an EC team headed by Chief Election Commissioner Sushil Chandra and election commissioners Rajiv Kumar and Anup Chandra Pandey recently visited Punjab, Uttar Pradesh, Uttarakhand, Manipur, and Goa and held deliberations with all stakeholders.

Several health experts have advised the Government to postpone the Assembly elections. Allahabad High Court has also urged the poll body to postpone the elections and ban rallies and public gatherings amid the Omicron scare.

After meeting with all stakeholders in Uttar Pradesh, the EC stated that all parties in Uttar Pradesh want the Assembly elections to be held as per schedule. "All the political parties, without any difference of opinion, said that elections should be conducted on time while following Covid protocol," the EC said. While the tenure of the Uttar Pradesh Legislative

Assembly ends in May, the terms of the Legislative Assemblies of Goa, Manipur and Punjab end on different dates in March.In a letter to the States and Union Territories, Union Health Secretary Rajesh Bhushan said the personnel to be deployed on election duty in the poll-bound States will be included in the category of frontline workers.

The EC, along with Bhushan, assessed the Covid situation in the five States on December 27 and asked the Government to expedite the vaccination programme in these States. It had noted that the percentage of those who have received the first dose of the vaccines was still less in Uttar Pradesh, Punjab and Manipur, while it was nearing 100 per cent in Uttarakhand and Goa.

The government's air quality forecast agency SAFAR said the AQI will continue to remain very poor on Tuesday.

"High winds and intermittent rains are likely during January 5 to January 8 that are expected to improve AQI significantly to 'lower end of very poor' through strong dispersion and wet deposition. Mixing layer height continues to be about 1 km," it said.

An AQI between zero and 50 is considered "good", 51 and 100 "satisfactory", 101 and 200 "moderate", 201 and 300 "poor", 301 and 400 "very poor", and 401 and 500 "severe"

The maximum temperature in Delhi on



Monday was recorded at 21.5 degrees Celsius, two notches above the season's average. The minimum temperature settled at 5.4 degrees Celsius, two notches below the season's average. Humidity levels oscillated between 97 per

cent and 43 per cent. The weather office has forecast partly cloudy sky with shallow fog for Tuesday morning. The maximum and minimum temperatures are likely to hover around 22 and 7 degrees Celsius,

On Sunday, the minimum temperature of Delhi was recorded at 5 degrees Celsius, two notches below normal, while the maximum temperature was 20.4 degrees Celsius, a notch above the season's average.

Covid-19: DDMA likely to consider more restrictions in today's meeting

New Delhi: Amid rising coronavirus cases in the national capital, the Delhi Disaster Management Authority (DDMA) is expected to consider more restrictions — to arrest the spread of the infection — in its meeting scheduled on Tuesday, official sources said.

Delhi added 4,099 new COVID-19 cases with positivity rate jumping to 6.46 percent in the past 24 hours, as per the city government's health bulletin on Monday. The DDMA in its last

meeting on December 29 had decided that Covid-related restrictions imposed in Delhi under the 'yellow alert' would continue in view of a low number of hospitalisations.

However, as per Graded Response Action Plan (GRAP), Delhi has reached the stage of Level 4 (red alert) restrictions that stipulates the closure of most activities and total curfew. The 'red alert', as per GRAP,

comes into force after positivity rate stays above 5 percent for two consecutive days. "In the last DDMA meet-

ing, it was decided to review the emerging situation and consider if further restrictions as per GRAP were required. The meeting on Tuesday will discuss if anything more was needed to be done to check the spread of Omicron," an official source said on Monday. Delhi Health Minister Satyendar Jain on Monday said CÓVID cases were rising fast but the situation was under control because people were not getting seriously ill

Speaking during the ongoing session of Assembly, the minister said none of the Omicron-infected patients in Delhi's hospitals have so far required oxygen. He said there was no need to panic and appealed for following social distancing and wearing face

to require hospitalisation.

'Student' who duped 100 fliers at IGI airport in last 5 yrs arrested

The Delhi Police has arrested a man for allegedly cheating passengers at the National Capital's Indira Gandhi International (IGI) airport by posing as a student of a reputed university and then taking money from them for his travel conveyance on the pretext that he missed his flight.

The accused has been identified as Modela Venkata Dinesh Kumar, a native of Guntur district in Andhara Pradesh. Police said that he has cheated more than 100 passengers so far in the last four to five years.

Police said that on December 19, 2021, complainant, who is a resident of PG Mens Hostel Maulana Azad Medical College, travelled from Baroda to Delhi IGI Airport T-3, near the belt, where the accused approached him and stated that he is a student of a reputed university.

his ID card of the said university and requested that he had come from Chandigarh and had missed his connecting flight to Vishakhapatnam. He induced him and showed him that a flight ticket to

the DCP.

6,500 with him. Later, he convinced the victim to pay the difference as he promised to return the money once he reached his destination. The victim then paid Rs. 9,250 by Google pay in his account, the complainant

When the accused did not return his money despite demanding several times, he approached police and a case was registered in the matter,

'On December 30, on the basis of CCTV footage, an alleged suspected person was apprehended from IGI Airport T-2 when he was trying to cheat other passenger," said

Interrogation revealed that the accused used to visit different airports for cheating passengers. He used to introduce himself as a student of a reputed university and cheated passengers on the pretext of missing his flight. Once he was able to convince the passenger, he used to get the ticket money transferred into his bank account and would cheat the passengers, said the

It also came to light that five more FIR's have already been registered against the accused and on Twitter also, there were many complaints against him, police said.

Cops seek information from Twitter, GitHub over auctioning of Muslim women on Bulli Bai app

The Delhi Police has written to Twitter seeking information about the first account handler on its platform who reported about the 'Bulli Bai' app, which had offensive contents being written about women of a particular community. Police said they have also sought information from Github platform to share details about the developer of "Bulli Bhai" application, as a part of ongoing investigation.

Earlier, the National Commission for Women had also National written to the Delhi Police to expedite its action in the case involving 'Bulli Bai', a dodgy app that has listed Muslim women for auction, to ensure that such crime does not

According to a senior police official, they have also asked Twitter to removed or block any offensive content shared through the alleged "Bulli Bhai" app on its platform.
"As part of the ongoing probe

into the matter, we have written to Twitter seeking information about the account handle who had first tweeted about the "Bulli Bhai" app. This is to know how the concerned person came across the alleged application who had offensive contents being written about woman of a particular community," he said.

The police said they have also approached Github platform to share details about the developer of the "Bulli Bhai" application available on its platform to know the intention behind creation of such an application and whereabouts.

The development comes after the Delhi Police on Saturday night registered an FIR against unknown persons for allegedly uploading a doctored picture of a woman journalist on a website. The journalist had lodged an online complaint and she shared the copy of the complaint on Twitter.

The case was registered at the Cyber Police station of the southeast district on Saturday night, the police A senior police officer had said

the case has been registered under sections 509 (word, gesture or act intended to insult the modesty of a woman) and 354 A (sexual harassment and punishment for harassment) of the Indian Penal Code on the complaint of the journalist alleging that she is being targeted by an unidentified group of people on "Bulli Bai" portal.

Netizens and women rights groups have expressed outrage over the matter. Hundreds of Muslim women were listed for "auction" on 'Bulli Bai' app with photographs sourced without permission. It has happened for the second time in less than a year. The app appeared to be a clone of Sulli Deals which triggered a row last year. According to the complaint,

the woman, who works with an online news portal, sought immediate registration of an FIR and investigation against an unknown set of people who are "seeking to harass and insult Muslim women" on social

"I was shocked to find out this morning that a website/portal called bullibai.github.io (since deleted) had a doctored picture of me in an improper, unacceptable and clearly lewd context. This needs immediate action, as the same is clearly designed to harass me and other similarly situated independent women and journalists," the woman said in the complaint.

"I enclose snapshots of the said tweet directed at me herein as well as of other tweets. The term 'Bulli Bai' itself seems disrespectful and the content of this website/portal (bullibai.github.io) is clearly aimed at insulting Muslim women as the derogatory term 'Bulli' is used exclusively for Muslim women and the entire website seems to have been designed with the intent of embarrassing and insulting Muslim

Plea seeks rehabilitation of African elephant kept at Delhi zoo

HC asks authorities to respond

New Delhi: A plea filed in the Delhi High Court on Monday sought the release and rehabilitation of an African elephant gifted to India by the Zimbabwean government and kept chained at the National Zoological Park here for 16 years now. A bench of Chief Justice D N Patel and Justice Jyoti Singh issued notices and sought responses of the Centre, Delhi government, National Zoological Park, Central Zoo Authority (CZA) and the Animal Welfare Board of India (AWBI) on the petition and listed the matter for further hearing on March 9.

The court also directed the authorities to consider a representation preferred by the petitioner in this regard in November last vear.

The plea filed by 16-yearold Nikita Dhawan, founder of Youth For Animals (YFA), said the lone African elephant named 'Shankar' is a victim of cruelty and viciousness at the hands of caretakers at the zoo, and his present condition is nothing less than illegal impris-

India in early stages of 3rd wave: Experts

Several experts have asserted that the rapid spike in daily Covid-19 cases, as well as the spread of Omicron (India has logged at least 1,700 Omicron cases till Monday), indicates that the country is in the early stages of a third wave. A rising R-value is a further indicator of the same.

Professor Mahindra Agarwal, scientist from IIT Kanpur, has predicted that the third wave will come in India in January and end by April. In March, the country will report 1.8 lakh cases daily, he

However, amid the gloomy Professor prediction, Mahindra, however, said that only 1 in 10 will need hospitalization. Two lakh beds will be needed in the middle of March that the third wave of the pandemic will end by April, he asserted.

The scientist warned that rallies during elections can prove to be a super spreader for Corona infection, as it is not easy to follow the Covid guidelines in such gatherings. Prof Agarwal said that as a large number of people reach the election rallies without following the guidelines, the risk of infection increases to a great

In such a situation, there is a need to be careful. If there are rallies, the transition can pick up ahead of time. According to Prof Agarwal, who bases his predictions of the epidemic on the basis of his mathematical model, the third wave will come in India in January and in March, 1.8 lakh cases can



"It will be a matter of relief that only 1 in 10 will need a hospital. Two lakh beds will be needed in the middle of March," he said.

He further said that 80 per cent of the population in Africa and India is below 45 years of age. Natural immunity is up to per cent in both countries. In both countries the delta variant has been due to mutants. Like South Africa, India too is less likely to have a major impact, he claimed.

According to research conducted by the Institute of Mathematical Sciences in Chennai, the R-value of all major cities has crossed 1 including Delhi, Mumbai and Kolkata. As of December 21, the R-value of the entire country stood at 1.22.

According to the researchers, led by Sitabhra Sinha, an R-Value higher than 1 is a cause for concern as it indicates a high speed of virus transmission, meaning that the virus is spreading quickly.

According to top virologist Shaahid Jameel, the third wave of the pandemic has already begun. "Both numbers, as well as test positivity rate, have started going up in several places, especially in larger cities," Jameel told Outlook in a previous interview.

However, Jameel, as well as other experts, believe that the third wave may not be as severe as the second, Delta-driven

SC asks Centre to decide on woman's extradition from Af jail



PNS NEW DELHI

The Supreme Court on Monday directed the Centre to decide the representation of a Kerala-based man seeking direction for extradition and repatriation of his daughter and minor granddaughter, who are at present detained in Afghanistan's Pule-Charkhi jail.

A bench comprising justices L Nageswara Rao and B R Gavai directed the Centre to decide the representation made by V J Sebastian Francis within eight weeks.

In his petition, Francis, a resident of Kerala's Ernakulam district, said his daughter has been booked in India in a case by the National Investigation Agency (NIA) under the Unlawful Activities (Prevention) Act (UAPA) and for other offences. He said that the allegation is that his son-in-law along with his daughter and other accused persons had hatched a conspiracy to propagate terrorist

organisation ISIS in waging

war against Asiatic nations.

Francis said after reaching Afghanistan his son-in-law got involved in a war and was killed, and his daughter and granddaughter, who were not actively involved in the fight, had to surrender before Afghan forces on November 15, 2019, along with several other women.

Francis said that the first detenue (daughter) and the second detenue (granddaughter) with an intention to join the Islamic organisation in Afghanistan exited India on July 30, 2016. The Interpol also issued a Red Corner notice on March 22, 2017, in the name of the first detenue, the plea said.

He said during an interview conducted by a news portal, his daughter had repented her decision to join the ISIS and wanted to return to India and face fair trial before courts here.

The India Meteorological Department (IMD)'s probability forecast for the minimum temperatures indicates normal to above normal minimum temperatures are most likely over many parts of northwest India, northeast India and adjoining areas of east India in January . "Below normal to normal minimum temperatures are most likely over many areas of the north peninsula and some parts of central India", it said.

The IMD said the probability forecast for the maximum temperatures indicates that below normal maximum temperatures are likely over most parts of the central and peninsular India. Above normal temperatures are likely over some parts of northwest & north India and most parts of northeast India. The rainfall during January, February and March (JFM) 2022 averaged over North India consisting of seven meteorological subdivisions (East Uttar Pradesh, West Uttar

Pradesh, Uttarakhand, Haryana, Chandigarh & Delhi Punjab, Himachal Pradesh, Jammu Kashmir & Ladakh) is most likely to be normal (86 to 114% of Long Period Average

According to the IMD, due to back to back western disturbances, widespread rainfall or snowfall is likely in Jammu and Kashmir, Himachal Pradesh, and Uttarakhand this week. Isolated hailstorms are also likely in the region. Moreover, western distur-

bances have a dual impact on winter cold across northern plains. They attract moist winds from the North Indian Ocean and limits northwesterly cold winds from central Ásia. As a result, minimum or nighttime temperatures rise. However, as the clouds envelop the region, the morning sun fails to warm the region, leading to a fall in daytime tem-

IMD in its forecast for JFM, said January rainfall averaged over North India is most likely to be above normal



ing January based on the data of 1961-2010 is about 48.5 mm. monthly rainfall for the 2022 January averaged over the North India is most likely to be above normal (>124 % of Long Period Average (LPA)). Currently, moderate La

Niña conditions are prevailing over equatorial Pacific region. The latest Monsoon Mission Climate Forecast System (MMCFS) forecast is indicating that these La Niña conditions are likely to persist dur-

Adding to the woes of the people, the number of cases Omicron detected in the State rose to 181 by Monday evening. Despite the increase in the number of Covid-19 and Omicron cases, Kerala Government Medical Officers Association (KGMOA) continued its State-wide agitation for the 27th successive day on Monday against the indifference of the Government to their demands for appointing temporary hands and restoration of the allowances slashed in 2020.

With both the Government of Kerala and the KGMOA refusing to make any concessions in their stances, the

agitation by the doctors would enter 28th day on Tuesday. The doctors gave advance information to the State Government that there would not be any let up in their agitation or demands. The demonstration on Tuesday is expected to see a massive turn out of doctors in front of the State Secratariat, the permanent venue for all agitations against the government.

The NITI Aayog's ranking of Kerala as the State with the best medical infrastructure has dampened as the agitation by the doctors is getting stronger the day. Dr Cini Priyadarshini, State treasurer of Indian Medical Association who is also the District Medical Superintendent, told The Pioneer that there was a severe shortage of doctors and health professionals in the State. "We are short of 700 doctors. The number of doctors and nursing staff who fall prey to Covid-19 has gone up and this has to be addressed immediately.

Over forming alliance with Cong to fight BIP together

All is not well in the ties between the CPI(M) and its poor cousins the CPI in Kerala. The simmering differences in the approach of the parties visà-vis the Indian National Congress came out in the open as Binoy Viswam, widely seen as the next general secretary of the CPI declaring at Kochi on Sunday that "a viable national alliance against the Fascist RSS and its political arm the BJP could be formed only in company of the Congress".

Viswam, a member of Rajya Sabha, was addressing the memorial meeting in honour of P T Thomas, the veteran Congress leader convened at Kochi by the Kerala Pradesh Congress Committee. "An alliance of the Left and the Regional parties would not be

able to dethrone the RSS and the BJP from power in New Delhi. We should have the Congress playing a significant role in that alliance. Barring Kerala, the CPI and the CPI(M) have electoral alliance with the Congrtess in rest of the country," said Viswam, who is seen as the intellectual face of the

Pinarayi Vijayan, chief minister of Kerala, who is the CPI(M) strongman, has made it clear time and again during his party's district level meetings held in connection with the triennial State Convention that the Congress was a spent force. The CPI(M) is for an alliance of Left-led regional alliance at the national level," Vijayan said in all the meetings where he was the key note speaker.

The CPI(M)'s expectations suffered a jolt on Monday as Kanam Rajendran, CPI's Kerala secretary, who usually toes the line of Pinarayi Vijayan, said on Monday that Congress could not be kept away from an alternative to the RSS and the BJP. "The CPI and the CPI(M) are not strong enough to

replace the Congress though the latter has become weaker in some States. This is what Viswam said in his speech. The Left is strong in Kerala but in rest of the country, though we are opposing the RSS and the BJP, we require the cooperation of the Congress," Rajendran told media on Monday.

It may be worth remembering that the CPI was an ally of the Congress from 1969 to 1980 and had vehemently opposed the dictatorial line of the CPI(M). C Achutha Menon of the CPI was anointed as the chief minister of Kerala in 1969 with the help of the Congress and he remained in that position till 1977. In 1979, P K Vasudevan Nair of the CPI was sworn in Kerala Chief Minister with the support of the Congress. "The CPI(M) was in political wilderness from 1969 to 1980 and the party could taste power only after the CPI came out of the alliance with the Congress in support of the former," I S Kundoor, the cultural and literary face of the CPI till recent-

ly, told The Pioneer.

Schools shut for Classes I-IX till Jan 31 in Mumbai

Maha records over 12K Covid cases, tally crosses 67L-mark

mid the surge in the ACovid-19 and Omicron cases, the authorities announced on Monday that schools for standard 1 to 9 would remain closed in Mumbai and neighbouring Thane till January 31.

With no let up in the spread of the pandemic, Maharashtra on Monday recorded 12,160 Covid-19 cases, taking the total number of cases from 66,99,868 cases to 67,12,028 cases. Similarly, the state recorded 68 Omicron cases, taking the total number of Covid-19 variant cases from 510 cases to 578 cases.

Mumbai Municipal Commissioner I S Chahal and Thane district collector Rajesh Narvekar made separate announcements about the closure of all schools in Mumbai and Thane for standard 1 to 9

from January 4, 2022 to January 31, even as Mumbai recorded 8082 Covid-19 cases and 40 Omicron cases while Thane registered 2084 Covid-19 cases and went blank on the Omicron front. However, the classes for standard 10 and 12 would continue.

As 1748 patients were discharged from the hospitals across the state after full recovery, the total number of people discharged from the hospitals since the second week of March last year increased from 65,12,610 cases to 65,14,358 cases. The recovery rate in the state dropped from 97.21 per cent to 97.05 per cent.

The number of "active cases" in the state increased 42,024 cases to 52,422 cases. The fatality rate in the state dropped from 2.11 per cent to 2.1 per cent.

Mumbai accounted for a maximum of 37,274 cases,

while there were 6309 active cases in Thane. There were 3808 active cases in Pune, followed by Palghar (1080), Raigad (980), Nashik (691), Ahmednagar (346), Nagpur (406) and Satara (336).

Of the 6,93,70,095 +samples sent to various laboratories across the state so far, 67,12,028 have tested positive (9.68 per cent) for COVID-19 until Monday.Currently, 3,32,610 people are in home quarantine while 1,096 people are in institutional quarantine.

Meanwhile, the State recorded 68cases of Omicron, taking the total number of new Covid-19 variant cases to 578 cases. Of the new Omicron cases reported on Monday, 34 have been reported by the National Institute of Virology (NIV) while 34 cases were reported by National Chemical Laboratory (NCL),

Of the 68 omicron cases

reported in the state on Sunday, Mumbai accounted for a maximum of 40 cases, followed Pune Municipal Corporation (14), Nagpur (4) Pune rural and Panvel - 3 each, Kolhapur, Navi Mumbai, Raigad and satrara- 1 each.

After work from home, the anytime-anywhere work trend is popular, especially in Tier-2 cities

borderless workforce that can work anytime and from anywhere: That is the emerging trend of work in India, says a top human resource consultancy company. It Offers evidence in the form of rising salary levels in Tier-2 cities. Ahmedabad leads the pack, with Chandigarh, Bhubaneswar, Kochi, Jaipur, Nagpur, Lucknow, Indore and Coimbatore joining the growing list of non-metro cities that are becoming favourite hiring centres. The salaries in the junior, mid and high levels are no longer disproportionately lower than in Tier-1 cities. The consultancy firm's report says that work is beginning to search for talent and as uncertainty over the COVID-19 pandemic continues, work from home could shift to work from anywhere in 2022. Employers, now used to nonmanufacturing departments functioning online, prefer either of two things: One, find employees who are comfortable working from their homes in other cities and towns. Jobs for a range of services are available, including in manufacturing, sales, customer service, technology, finance and operations.

In the process, not only are they attracting talent from within and outside, they are also attractive as they flaunt lifestyle aspects similar to metropolitan cities. For the employers, hiring from Tier-2 cities makes sense because the overheads are low. Rents and routine expenses are much lower than in metro

cities. The personnel are comfortable and can be retained better. The companies will have a better distributed resource base for their business. For employees, life is glitzy thanks to retail chains and malls, eateries and specialty restaurants, salons and gadget stores that crowd the smaller cities. That is not all. Commutes are shorter, reasonable rents get you larger living spaces — and working spaces — there is little or no pollution, less congestion and parking problems, and there is a chance that you live close to your family. The pandemic has changed the working culture globally. Work from home has given way to hybrid work forms like half-time work and remote work, which will become popular in India as well. Bottle battle

Politics is brewing over the reopening of liquor vends across Delhi under the new excise rules

he BJP in the Capital has opened another front against the AAP, which recently routed it in the Chandigarh municipal election and which appears to be resurgent in most of the five States going to elections soon. The Arvind Kejriwal-led AAP is already gaining mind space and airtime in the politically significant Uttar Pradesh, besides Uttarakhand, Punjab and Goa. In all these States, it has promised a host of sops, including free electricity in the range of 300 units per household and other benefits to womenfolk. Now, the BJP is leaning heavily on the same women power to counter the AAP Government's new excise policy. On Monday, it organised dhar-



nas and 'chakka jam' protests at 15 locations against the new excise rules. The new policy ended the Government's involvement in liquor selling business, a redistribution of liquor stores across the city and upfront collection of excise revenue. Under the policy, implemented in the city from November 17, 2021, 849 premium liquor vends are being opened across the city. The Delhi BJP's grouse is that the Government is opening liquor shops "illegally", with the outlets being opened near residential and religious places. The BJP's posters, placards and banners have mushroomed 'thanking' Kejriwal for 'gift-

ing' at least one liquor outlet in each municipal ward.

For his part, Delhi Deputy Chief Minister Manish Sisodia claims that the BJP was rattled as the new policy aims to curb the sale of illegal liquor, which the BJP's State unit indulged in, adding that this "theft" was worth ₹3,500 crore. Earlier, the stores were distributed unequally (some wards had none while some others had 9-10); now each ward will have an average of three stores. People can now walk into these spacious, well lit and air-conditioned vends and choose their brand. The new policy per se can't be faulted since it ultimately boils down to the consumer's choice. Having a liquor vend in the neighbourhood would ensure against 'brand pushing' (where one wants to buy a particular beverage brand but the person at the paan-stained dingy window forces him to buy another one because (a) the brand of choice is not available, or, (b) the manufacturer and distributors of less popular brand names pay a hefty commission to these Government-owned shop salespersons to forcedly boost their sales) as also against consumption of cheap or unsafe liquor.

Why Taiwan is an eyesore for China



China's apprehension would be that a successful democracy anywhere in its neighbourhood is a threat to its own system based on dictatorship

in Taiwan lately circle around the subject of democracy. The reason may well be the close proximity of this island nation to China, which claims its ownership. The intention might be to differentiate itself sharply from the communist dictatorship of the main-land; a subtle but obvious way of rejecting Beijing's claims. In any case, in his heart of hearts, President Xi Jinping would know that his country had lost Taiwan a long time ago. Although the Chinese were aware of the existence of Taiwan and its native aboriginal population, Chinese settlement of the island did not begin until the 17th century. The Portuguese first visited the island in 1590, naming it Ilha Formosa (Beautiful Island), but were unprepared to settle there. By 1626, the Dutch and the Spanish had established fortified commercial settlements along the island's western coast. The Manchus began settling the island's eastern shores in 1796. In 1895, Taiwan was ceded to Japan following the Chinese-Japanese War.

Under the Japanese, Taiwan became a major supplier of rice and sugar to Japan. In the 1930s, Japan's Taiwan policy turned to the development of industry based on cheap hydroelectric power. Following World War II, Taiwan was ceded to China, then governed by the Nationalists (1945). Following the Communist victory on the mainland in 1949, the Nationalist Government and its supporters, led by Gen Chiang Kai-shek, fled to Taiwan. In 1945, the Nationalist Government and the United States signed a mutual defence treaty. Taiwan has since then received military and economic support from the US.

Taiwan has, ever since the Communist takeover of China by Vlao Zedong, been an eyesore for Beijing. This is understandable; President Abraham Lincoln Taiwan has not only become a (1860-65), one of the greathighly developed economy with est democrats in the history

a sophisticated industrial and manufacturing base, particularly software and electronics, its close ties with the financial world of the West and the success of its democracy are a challenge to China's world view. A democratic system is

widely accepted as ideal; where it is not being practised, it is because of obstructive vested interests, like those of potential autocracies or oligarchies. Or, the people's profile is such that they are unable to organise a democratic system. The supreme demand of a democracy is the continual existence of at least a few leaders sacramentally wedded to rules that mandate that when one's time is up as President or Prime Minister, one gets up and leaves. Through modern history, the Anglo-Saxons are one people who have displayed this sacramental quality.

It began with King John of England, who signed the Magna Carta (the Great Charter) in 1215 at Runnymede (in Surrey). Since the sowing of this seed, democracy in the world has grown to become the rule of the people, by the people and for the people, as famously articulated by American

This is not to say that other countries or societies do not have leaders who play by rules. France and Germany are equally civilised but had allowed themselves to slip out of the lap of democracy. In an endeavour to push out the monarchical autocracy of Louis XVI that had lasted several years, France landed in the grip of Napoleon Bonaparte and his vaulting ambitions. It took a century and more for France to adopt a true and proper democratic Constitution in 1905.

Germany adopted a democratic Constitution in 1918, which fell apart with the advent of Adolf Hitler and his Nazi regime. Fortunately, twothirds of the country returned to democracy soon after World War II, with Konrad Adenauer as the Chancellor. The other one-third had to endure a communist dictatorship under Herren Walter Ulbricht and Erich Honaker until communism and the Eastern Bloc fell in 1989.

Sweden is a constitutional monarchy, but only since 1921. Before that, it was like any other monarchy. About the only democracies in Asia are Japan and India. Otherwise, traditionally, democracy was an Anglo-Saxon monopoly.

Political parties that run a democratic system are broadly of two types. One type would be those with a virtually unchanging ideology, while the other would have a view that encompasses the entire nation. The programmes or manifestos, however, would alter with the wind. The latter type is the Anglo-Saxon countries, with one exception. The British Labour Party remained fairly unchanged until Prime Minister Tony Blair innovated "New Labour" in 1994, and ruled

The non-ideological movements have the advantage of adjusting their manifestos every election and, therefore, do not get out of date. On the other hand, ideological organisations like the communist parties or the BJP can bend to the changing wind to some extent, but cannot violate their basic principles. When times change radically, they face the danger of expiring, as happened to the communist parties the world over. However, ideologies are excellent for binding parties and their members together.


THE TRANSFORMATION **OF UTTAR PRADESH**

Perceptions about UP have now changed and the State is completely transformed

ttar Pradesh is in the news as the ruling BJP is not only showcasing its achievements but the cultural agenda is also being asserted. The grand opening of the Kashi corridor was part of the core ideological commitment of BJP. Development and governance are the main themes of the poll campaign which is supported by the iconic images of the Prime Minister and Chief Minister. Even his baiters agree that Chief Minister Yogi Adityanath has provided a secure atmosphere in the state and ended the mafia raj. Perception about UP has changed now and the state is completely transformed. Overall improvement in infrastructure facilities, control over crime and taming of the bureaucracy has resulted in improvement in ease of business. TheGSDP (current price) of the state has also grown over seven percent over a period of four years from 2017 to 2021 and this is despite the Covid-19 impact. When



Yogi claims about increasing the network of roads and power availability, they are not hollow claims but backed by statistics. The length of national highways has increased from 8,483 km in 2017 to 11,831 km in 2021 recording an increase of 40 percent. Power availability has increased from 10,570 crore units in 2017 to 12,338 crore units in 2021, an increase of 17 percent. Traditionally UP has been a backward and populous state and therefore change in social indicators becomes an important benchmark for performance assessment. The annual social expenditure has increased 1.5 times within four years after Yogi came to power.UP has scored 60 against overall the national average of 66 in the SDG India index published this year by Niti Ayog. Recently Niti Ayog released a report on health ranking of the states and UP has not fared well. However, it is worthwhile to highlight that UP comes at the top when incremental performance (i.e., current round versus previous round) is assessed. An overall performance is the sum total of efforts and performances by all the governments while incremental performance shows the performance of the current regime. Chief ministers of other states were busy giving advertisements during the second wave and their presence was limited to video conferencing while Yogi led from the front in a populous state like UP. UP's 'test-trace-treat' model to fight the pandemic was lauded all across the country andthe CM was praised for his efforts. UP's economy is primarily agriculturebased and farmer's agitation was at the centre-stage in this year. UP has registered net value added growth at CAGR of 7.9 percent (at current prices) over a four-year period in agriculture and allied sectors.Initiatives like farm loan waiver in 2017, increase in MSP of farm produces, clearing sugarcane dues, completion of irrigation schemes etc. has contributed towards agriculture sector growth. Ground reports suggest that the farmers' agitation had a limited effect in certain pockets of the State. BJP is showcasing development. Governance, nationalism and cultural Hindutya while the opposition is busy wasting its time in a puerile discussion over Hindu versus Hindutva. Intellectuals who always mocked cultural nationalism and portrayed it against development citing that both are mutually exclusive are speechless now. Road to Delhi goes via UP and it seems like a lost battle for opposition.

The tale behind putting off key power reforms



DBT and de-licensing of electricity distribution hold the key to extricate the sector from morass and make power available to consumers at affordable rates

n the draft Electricity (Amendment) Bill, 2021, there were four provi-sions—direct benefit transfer (DBT), de-licensing of the electricity distribution business, creation of the Electricity Contract Enforcement Authority (ECEA) for adjudication of contract disputes, and a single choice committee for appointment of chairman and members of state and central tariff regulators. Reportedly, the Central Government has dropped all four.
While the third and fourth proposals

are procedure-oriented aimed at ensuring effective enforcement of contracts, the first two are revolutionary reforms. If implemented in letter and spirit, they have the potential to drastically improve the Indian power landscape.

Before we get to analyze as to what they can deliver and how and why these have been dropped from the bill, it is necessary to take stock of what is ailing the sector.

For nearly two decades, four problems have been haunting the Indian power sector namely, inadequate availability and frequent disruption in supply; financially stressed power distribution companies (PDCs); increasing dues of independent power producers (IPPs) and high cost of electricity supplied to industries and businesses. The Government triedto address them but has not succeeded in making any dent.Meanwhile, the problems have assumed menacing dimensions.

Let us look at some harsh facts to gauge their intensity. As of March 31, 2021, discoms had piled up a mammoth debt of over ₹450,000 crore. This was despite a bailout package coordinated by the Union Governmentunder UDAY (Újwal Discom Assurance Yojana) in November 2015 (under it, their outstanding debt of ₹400,000 crore was extinguished). They also owe a staggering ₹100,000 crore to power producers - IPPs and other generators in the public sector such as NTPC - despite a ₹130,000 crore lifeline given last year under Atmanirbhar Bharat Abhiyan

In most states, electricity is supplied to industries and businesses at more than Rs 10 per unit. As for the availability, the entire network remains vulnerable due to huge receivables of IPPs/PSU generators from discoms. However, for intervention of the Centre by way of arranging funds- for instance, during 2020/21, Power Finance Corporation (PFC) and Rural Electrification Corporation (REC) were roped in to give ₹130,000 crore loan to discoms --to enable them clear dues to IPPs/PSUs, disruption in power supply

A sizeable chunk of electricity is supplied to households and farmers at a fraction of the cost of purchase and distribution or even free (in some states, subsidy accounts for 30-40 per cent of discoms' revenue). Such supplies are made possible

As a result, on units sold to the beneficiaries of subsidized power, discoms incur huge under-recovery. This is aggravated by power theft that happens under the patronage of political brass. Inflated tariff allowed to producers under a cost-plus formula increases the under-recovery.

In a bid to offset this under-recovery, and under instruction from their masters (read: the State government), discoms charge high tariffs on supplies to industries. Considering that the former are sole suppliers of power, the latter have no option but to pay. Despite this cross-subsidization, overall, discoms incur huge loss.

The genesis of the problem lies in an uncompromising stance (albeit populist) of all parties irrespective of their political affiliation to give cheap/free electricity to farmers and poor households (this class matter in elections) and use discoms to achieve it. Even now, in the run-up to elections in 5 states, they are competing with each other to offer free power including waiver of unpaid bills.

Successive governments have made no credible effort to address this endemic problem. All that they have done is to give to discoms the so-called financial restructuring package (FRP) - a fancy nomenclature for condoning their debt. In fact, four FRPs (2002/ 2012/ 2015/2020) have been given in the last over two decades involving

drain of hundreds of thousand crore from the central and state exchequer. The way forward is to delink

subsidy to preferred consumers from the electricity supplier, namely the discoms. The State Government should pay subsidy directly to the beneficiary using the direct benefit transfer (DBT) mechanism on lines similar to DBT of LPG subsidy (this was done during January 2015 - June 2020), even as discoms are free to fix tariff taking into account the cost of purchase, wheeling and distribution. Concurrently, private firms should be allowed in the distribution business to give competition to discoms and ensure that consumers are not

taken for a ride. At present, almost the entire infrastructure for transmission, wheeling and last-mile delivery of power is owned and controlled by discoms. To ensure that there is a level playing field, this infrastructure should to be stripped from the discoms and vested in an independent entity. All suppliers should have access to it on 'common carrier' principle in a transparent and nondiscriminatory manner.

There is also dire need for unshackling discomsfrom state control by converting them into autonomous entities. Preferably, they should be made 'corporate enterprises' and allowed to operatelike any private firm. This will enable them independently glide their operations - including tariff setting and negotiations for purchase of electricity- in a professional manner.

These steps will reduce cost of purchase, increase realization from sale of electricity and help eliminate theft. All three outcomes will combine to turn discoms into

profit making entities. Moreover, being under no obligation to supply power to farmers/households at subsidized rates (or free), there won't be any under-recovery hence no reason to charge more from industries and businesses thereby making power affordable/competitive.

In short, these twin reforms — DBT and de-licensing of electricity distribution — hold the key to extricate the sector from the current morass and lay the foundation for ensuring the viability of power producers and distributors on one hand and making this most crucial infrastructure input available to consumers at affordable/competitive rates on the other. Their inclusion in the Electricity (Amendment) Bill, 2021 would have been the first major step forward in realizing this goal.

Dropping from the draft now shows that the Government is no longer interested in pursuing them. It also shows that none of the states are willing to let the 'goose that lays golden eggs' (read: discoms they use for garnering votes)go out of their hand. However, what prevents states from giving the money directly to farmers or households and still win election? There is a big difference.

Unlike the present dispensation of routing subsidy through discoms wherein, the State government can afford to take things leisurely - not making upfront payment, not paying in full and delaying payment under DBT, they cannot enjoy any of these luxuries. Hence, they staunchly oppose DBT.Allowing the private sector in electricity distribution business also does not suit them as this has the potential of exterminating discoms.

For now, power reforms are a distant dream.

Mixopathy: Integrative medicine as a life-cycle approach

The practice of an integrative approach requires an understanding and recognition of the strengths of each system of medicine

hile the Covid-19 pandemic has challenged the healthcare system by exposing its gaps, it has also provided an opportunity to design resilient health systems. One way of strengthening the health system is by pooling available resources from different systems of medicine for foundational tasks. For example, against the requirement of one doctor per 1000 population as per WHO norms, the allopathic doctors to population ratio is only 0.76 (assuming 80 per cent availability of 12.68 lakh registered allopathic doctors), which can be complemented by 0.48 Ayush practitioners per 1000 population (assuming 80 per cent availability of registered 7,99,879 Ayush practitioners) taking

the recommended norm. Incidentally, Ayush manpower was utilized by various States/UTs for different identified roles in mitigation of Covid-19; Ayush infrastructure was utilized as Covid Care Centre, Covid Health Centre, and Vaccination Centre, etc. Further, corresponding to the Indian Council of Medical Research (ICMR) for modern medicine, research councils exist for each system of traditional medicine. There is a scope for synergy and pooling of expertise of modern medicine and Ayush in research as well.

The National Health Policy, 2017 advocates for improving the health status through concerted policy



action in all sectors. The policy commits Government support in research and integrative practices.

The WHO Global Report on Traditional and Complementary Medicine 2019 reiterates the need for integrating the best of Traditional and Complimentary Medicine (CAM) and that of Conventional medicine to tackle the unique health challenges posed in the 21st century.

The WHO defines Integrated Health Care as "a

approach between a variety of Western medical, traditional and indigenous, and CAM licensed health care providers. The scope of integrative care cum medicine is very broad and it envisages patient-centric, comprehensive care.

Integrative health recognizes that the modern system and Ayush systems have their own strengths and limitations in a way that they can complement each other. Strengths of the Modern system of medicine include emergency management, anaesthesia and surgical management, anti-microbial therapy, management of communicable diseases, etc.

In contrast, Ayush systems have strengths in Health (Swasthvritta), dietetics in prevention and health pro-

collaborative, team care (Ahara-Vidhi), daily and seasonal regimen (Dincharya and Ritucharya), advocacy for moral conduct (Sadvritta) and yoga which contributes to attaining a state of good health. AYUSH systems aim to provide person-centric care, emphasize eliminating the underlying cause of the disease, a whole of person approach encompassing body and mind.

These systems have a special role in geriatric care, disorders of the intestines, skin, neurological and musculoskeletal systems, autoimmune diseases, reproductive health, mental health, noncommunicable chronic diseases, and rehabilitation. In terms of lifespan, and at the cost of over-generalization, Preventive and Promotive traditional medicine is useful

motion, managing chronic diseases, and home-based care.

Modern medicine can better manage emergencies (as stroke, heart attacks), accidents, infections, childhood conditions, and those requiring surgical procedures. The practice of an integrative approach requires an understanding and recognition of the strengths of each system of medicine, which has to be incorporated in their respective curricula. Integration of these systems through cross-referrals will provide scope for holistic and

comprehensive care. Some misinformed people label integrative medicine as "mixopathy". There is a need for the professions and the consumers to distinguish between the two. It is important to understand that this

integration can be an important move in preserving, protecting, and rejuvenating health along with effective and safe management of conditions. Practitioners with education, training, and license to practice alone can and should practice each system. Integration aims to bring together the best practices of each system without losing their identity. In contrast, "mixopathy" is an illegal and unethical practice of different medicine systems by unqualified practitioners. A system of integrative

medicine in India can avoid the ballooning of healthcare expenditure, provision of comprehensive healthcare through a continuum of care, and help realize the SDG-3 of Universal Health Care.

Booster 88% effectiveness against Omicron: UK studies | Pak ready to host SAARC

Athird dose of COVID-19 vaccine can provide up to 88 per cent protection against hospitalisation from infection by the Omicron variant of coronavirus, according to early results from studies conducted in the UK.

The findings compiled in a report by the UK Health Security Agency (UKSHA) show significantly higher protection provided by third vaccine dose against the highly mutated variant first identified in Botswana and South Africa in November, compared to two doses.

Eric Topol, professor of molecular medicine, and director of Scripps Research Translational Institute in the US noted that vaccine effectiveness drops to 52 per cent against Omicron around six months after taking the second shot of a COVID-19 vaccine.

However, a booster dose substantially increases immunity and lowers odds of being hospitalised with COVID-19 infection."That's a big boost of protection for 3rd dose vaccine vs hospitalisation from Omicron infection.

Vaccine effectiveness increased from 52 per cent (due to 2-dose waning after 6 months) to 88 per cent after 3rd dose," Topol tweeted on Sunday. "It's pretty impressive that vac-

Both studies found a substantial reduction in risk of hospitalisation for Omicron cases after three doses of vaccine compared to those who are unvaccinated. Despite estimated reduction in hospitalisation risk and preserved vaccine effectiveness against hospitalisation, the study authors noted that there may still be large numbers of admissions to hospital. The emergency departments with Omicron was approximately one-third of that for Delta. The report shows that vaccine effectiveness against symptomatic disease continues to be lower for Omicron than for Delta with waning by 10 weeks after dose 3rd. Prime Minister Morrison upbeat amid Australia virus surge

AP SYDNEY

Australian Prime Minister Scott Morrison on Monday said his country's health system can cope with the new wave of coronavirus infections as Victoria state reported a record number of new cases and hospitalizations surged in New South Wales.

Morrison spoke in two television interviews before Monday's figures were released. Victoria reported 8,577 new cases, a record for the state which eclipsed the previous peak of 7,442 on New Year's

New South Wales, Australia's most populous state, saw a slight decline in case numbers from a record 22,577 on Saturday to 20,794 on Monday. But the number of people in hospitals rose to 1,204 from 1,066 the day before. There were 95 people in intensive care, a rise of 12 on he previous day.

Speaking with the Seven Network, Prime Minister Morrison said Australia's health ystem is well equipped to deal with the surge in case numbers caused by the spread of the

tant that with the rising case numbers, we see that the severeness of this illness is already being shown to be around 75 percent less than what we saw with delta," Morrison said.

"Rising case numbers is part of the omicron period, it's part of the new phase of the pandemic we're in." That doesn't mean to say it can't put pressure on the hospital system.

It can and that's why we're working very closely with the (state) premiers and chief ministers to make sure those resources are there," Morrison

Morrison said the federal government would take steps to ensure hospitals had the resources they need to cope with rising admissions. His government last week changed the definition of "close contact" to ensure health workers who might have been exposed to an active case do not have to isolate and can return to work.

"We're looking to make further changes on that this week to get more staff back into our hospitals and deal with the need," Morrison told 9 News.

Summit, India can join virtually: FM Qureshi

Pakistan Foreign Minister Shah Mahmood Qureshi said on Monday that his country was ready to host the 19th SÁARC Summit and India can join it virtually if the leadership in New Delhi is not willing to visit Islamabad.

Addressing a press conference to highlight the achieve-ments of the Ministry of Foreign Affairs in 2021, Qureshi accused India of making SAARC dysfunctional through its stubbornness by refusing to come to Islamabad for the Summit meeting.

"I reiterate the invitation for the 19th SAARC summit. If India is not ready to come to Islamabad, it can join virtually... but it should not stop others from attending the moot,"

SAARC - a regional grouping comprising Afghanistan, Bangladesh, comprising Bhutan, India, the Maldives, Nepal, Pakistan and Sri Lanka - has not been very effective since 2016 and its biennial summits have not taken place since the last one in Kathmandu in 2014.

The 2016 SAARC Summit was originally planned to be held in Islamabad on November 15-19, 2016. But after a terror attack on an Indian Army camp in Uri in Jammu and Kashmir on September 18 that year, India expressed its inability to participate in the summit due to

"prevailing circumstances". The summit was called off after Bangladesh, Bhutan and Afghanistan also declined to participate in the Islamabad meet. Noting that there was no change in relations with India in 2021, Qureshi cited the alleged dominance of "Hindutva thinking" in India for sabotaging the prospects of good ties between the two countries. "Unfortunately, ties with India in 2021 were frozen. In our view, the potential of regional cooperation has been hit by aggressive Hindutva behaviour in recent years," he

He said Pakistan wanted peaceful ties with all its neighbours, including India, but the responsibility for improving the relations was on India.

Qureshi said peace with India was not possible without resolving the Kashmir issue. The bilateral relations deteriorated after India withdrew the special powers of Jammu and Kashmir and bifurcated the state into two union territories in August, 2019.

India has told Pakistan that it desires normal neighbourly relations with Islamabad in an environment free of terror, hostility and violence.

Qureshi dwelt at length on Pakistan's ties with the rest of the world and concluded by saying that political, economic and diplomatic relations improved last year with the entire world, including the US, Russia and China. Qureshi specially men-

tioned that the ties with Bangladesh were improving and Prime Minister Imran Khan has interacted with his Bangladeshi counterpart Sheikh Hasina. He said Khan invited Hasina to visit Pakistan who also invited him to visit Bangladesh.

To a question on the reported 'Cold War' between China and the United States, he said Pakistan's policy was clear and Islamabad will not become "part of any camp". Responding to another question on removal of fencing by the Taliban forces on the border, he said Pakistan carried out the fencing work and was aware of the latest incidents (of its removal) while adding that "Afghanistan is our friend and British PM: Health service under strain. but no new measures

British Prime Minister Boris
Johnson warned on Monday that country's health system will remain under strain for weeks amid current surge in coronavirus infections, but suggested there would be no tightening of measures soon to slow spread.

The highly transmissible omicron variant has sent Britain's daily new caseload soaring over Christmas and the New Year, with 137,583 infections and 73 deaths reported for England and Wales only on Sunday, with numbers for Scotland and Northern Ireland to be announced after the holiday weekend.

"I think we've got to recognize that the pressure on our NHS, on our hospitals, is going to be considerable in course the next couple of weeks, and maybe more," Johnson said during a visit to a vaccination center in Aylesbury, 85 kilometers (53 miles) northwest of

Johnson was speaking after The Sunday Times newspaper reported that a group of hospitals in eastern county of Lincolnshire had declared a "critical incident" due to "extreme and unprecedented" staff shortages. Chris Hopson, chief executive of NHS Providers, which represents health trusts that run hospitals around the country, told BBC: We're seeing increasing staff absences, and that's coming on top of a very significant amount of wider pressure."

And Matthew Taylor, chief executive Confederation that represents 1.5 million health workers, said much of health service is in "a state of crisis" that's exacerbated by a high demand for services and staff absences. 'Some hospitals are making urgent calls to exhausted staff to give up rest days and leave to enable them to sustain core

Biden vows US to act decisively if Russia invades Ukraine

AP WILMINGTON, DEL

Dresident Joe Biden conferred on Sunday with Ukraine's leader over the Russian troop buildup near its and allies will act "decisively" if Russia further invades the

Eastern European nation. Biden and President Volodymyr Zelenskyy's call came as the U.S. and Western allies prepared for a series of diplomatic meetings to try to de-escalate a crisis that Moscow said could rupture ties with Washington.

"President Biden made clear that United States and its allies and partners will respond decisively if Russia further invades Úkraine," White House press secretary Jen Psaki said in a statement following the call.

Psaki added that Biden underscored his commitment to principle of "nothing about you without you," the tenet that it won't negotiate policy that impacts Europe without its allies' input. Biden has spoken of hitting Russia with economy-jarring sanctions if it moves on Ukraine's territory, but he said last month that US military action is not on table. The Kremlin has demanded that any further expansion of

NATO exclude Ukraine and other former Soviet countries. The Russians have also demanded that the military alliance remove offensive weaponry from countries in

The White House has dismissed Russia's demands on NATO as a non-starter. A key principle of the NATO alliance is that membership is open to any qualifying country. And no outsider has membership veto power. While there's little prospect that Ukraine would be invited into the alliance anytime soon, the U.S. and its allies won't rule it out.

Zelenskyy said in a Twitter posting after Sunday's call that 'keeping peace in Europe, preventing further escalation, reforms, deoligarchization were discussed.

"We appreciate the unwavering support," Zelenskyy said. The United States has made little progress in efforts to persuade Russian President Vladimir Putin to ease tensions, Senior U.S. and Russian officials are scheduled to meet Jan. 9-10 in Geneva to discuss the situation. Those talks are to be followed by meetings at the NATO-Russia Council, and at the Organization for Security and Cooperation in Europe. Biden spoke with Putin for nearly an hour on Thursday. He told reporters next day that he warned Putin that his economy would pay a "heavy price" if Russia, which has massed some 100,000 troops near border, made further moves against Ukraine."I'm not going to negotiate here in public, but we made it clear that he cannot — I emphasize cannot - move on Ukraine," Biden said Friday. Biden said he told Putin it was important for the Russians to take steps before those meetings toward easingcrisis. Putin's foreign affairs advis-

er, in describing presidents' conversation this past week, said Biden's pursuit of sanctions "could lead to a complete rupture of relations between our countries and Russia-West rela tions will be severely damaged. US intelligence findings indicate Russia has made preparations for a potential invasion in early 2022

President Bolsonaro hospitalized in Sao Paulo

Brazilian President Jair Bolsonaro was taken to a Sao Paulo hospital for tests ing abdominal discomfort, the government said. Bolsonaro is doing well and further information will be provided later in a medical bulletin, a government statement published by the Globo media outlet said.

Bolsonaro returned to financial capital during night from a New Year break on coast and was immediately taken to Hospital Vila Nova Star, according to Globo.

Globo quoted Bolsonaro's doctor, Antônio Luiz Macedo, as saying Bolsonaro had stomach pains. Macedo operated on Bolsonaro after he was stabbed at a political rally in 2018.

Globo said that Macedo was on holiday in Bahamas and was waiting for a flight back to Brazil to see Bolsonaro, who reportedly had no public appearances scheduled on Monday. Since his stabbing during 2018 presidential election, Bolsonaro has undergone stomach several times.

Sudan's PM announces resignation amid political deadlock

Prime Minister Abdalla Hamdok announced his resignation Sunday amid political deadlock and widespread prodemocracy protests following the country's fragile transition to democratic rule.

Hamdok, a former U.N. official seen as the civilian face of Sudan's transitional government, had been reinstated as prime minister in November as part of an agreement with the military following the October coup. In that time he had failed to name a Cabinet and his resignation throws Sudan into political uncertainty amid uphill security and economic challenges.

In a televised national address Sunday, Hamdok called for a dialogue to agree on a "national charter" and to "draw a roadmap" to complete the transition to democracy in accordance with the 2019 constitutional document governing the transitional period. "I decided to return the responsibility and declare my resignation as prime minister," he said, adding that his stepping down would allow a chance for

another person to lead the nation and complete its transition to a "civilian, democratic country." He did not name a successor. The prime minister said his efforts to bridge the widening gap putes among the political forces nave failed.

He warned that the ongoing political stalemate since the military takeover could become a full-blown crisis and damage the country's already battered economy.

"I tried as much as I possibly could to prevent our country from sliding into a disaster. Now, our nation is going through a dangerous turning point that could threaten its survival unless it is urgently

rectified," he said. The October coup had upended Sudan's plans to move to democracy after a popular uprising forced the military's overthrow of longtime autocrat Omar al-Bashir and his Islamist government in April 2019. Four months after al-Bashir's ouster, the generals and the protesters reached a powersharing deal to rule the country through elections in 2023.

Exports up 37 pc to record USD 37.29 bn in Dec; trade deficit widens to USD 22 bn

New Delhi: The country's exports in December 2021 surged 37 per cent on an annual basis to USD 37.29 billion, the highest-ever monthly figure, on the back of healthy performance by sectors like engineering, textiles and chemicals, even as the trade deficit widened to USD 21.99 billion.

Imports in December too rose by 38 per cent to USD 59.27 billion on account of an increase in oil imports, which soared 65.17 per cent to USD 15.9 billion, government data showed on Monday. Gold imports expanded by 4.5 per cent to USD 4.69 billion. Exports in December 2020 stood at USD 27.22 billion, while imports aggregated to USD 42.93 billion. Trade deficit was at USD 15.72 Cumulatively, during April-December 2021-22 exports rose by 48.85 per cent to USD 299.74 billion.

Imports during the period increased by 69.27 per cent to USD 443.71 billion, leaving a trade deficit of USD 143.97 bil-In December 2021,

exports of engineering goods grew by 37.27 per cent to USD 9.7 billion, followed by petroleum products (140 per cent to USD 5.6 billion), gems and jewellery (15.8 per cent to USD 2.98 billion), chemicals (26 per cent to USD 2.64 billion) and ready made garments of all textiles (22 per cent to USD 1.46 billion).

Addressing a press conference, Commerce Minister Piyush Goyal said India's merchandise exports will cross USD

400 billion this fiscal.
"With USD 300 billion in the first nine months of 2021-22 we are on track to achieve our target...This growth is satisfying and we must aspire for more, Goyal said.

He added that the third wave of COVID-19 is impacting developed economies like the US, Europe and the Middle East, and problems related to shipping lines can be expected.
"We don't immediately see

any supply disruptions or in the supply chains because by and large the world has seen that the effects of this wave are relativeworld has not restricted any movements as yet.

'We've also not seen instances of lockdowns being announced in any major country," Goyal said, adding that the only problem could be temporary in the form of some shipping staff getting infected with COVID-19, causing short-term disruptions. "Most cases are asymptomatic and recover very quickly. Hopefully supply lines and supply activity will contin-

ue in full steam," he said. Commenting on the numbers, Federation of Indian Export Organisations (FIEO) President A Sakthivel said looking at the current trend, India will achieve the USD 400 billion merchan-

dise exports target for the fiscal. Goyal also said the country is well on track to go up to USD 230 billion or upwards in services exports this fiscal, which will also be an all-time

"We have seen a USD 179 billion services exports in first nine months," he said.

Eyes are precious, keep a watch



 \P yes are the window to the world, allowing us to see the many wonders around us and enjoy life. But often, we take them and their function for granted-people, in general, tend to disregard their eye health and the problems associated with it. Eye diseases are on the rise around the world, including in India. According to the World Health Organization (WHO), at least 2.2 billion people worldwide have near or distance vision impairment. The WHO also states that visual impairment could have been avoided in at least one billion of these cases if the patient had received proper diagnosis and treatment.

Due to a hectic lifestyle, cases of vision loss are on the rise in India. According to a large scale study, which included data from 14.5 lakh patients, the number of cases of dry eye disease increased to 21,000 in 2019. It states that India is on the verge of a dry eye disease epidemic. By 2030, it will affect approximately 40 per cent of the urban population.

Although the findings are concerning, they are unsurprising given that several international studies have concluded that Indians are at a high risk of diabetes and glaucoma-related vision problems, including total blindness. To keep the numbers from rising, it is critical that public education on eye health issues be prioritized at all levels. Moreover, eye disorders worsen as people get older. Occurrences which seem simple to us such as unaddressed blurred vision, an unattended eye injury, can lead to irreversible vision loss. But, on a positive note, simple and timely interventions can help address the issues in no time and restore one's vision. In this context, large public awareness initiatives for early detection and treatment are critical.

Physical and social impact of eye diseases

Blindness and vision impairment have a significant impact on an individual's quality of life. It also affects their educational and employment opportunities. This burden can be greatly mon eye diseases, allowing them to seek timely eye care. For this, one of the initiatives we can take is to create information and education regarding eye diseases which can be integrated into the school curriculum. At the University level, students in public health can be encouraged to organize eye care awareness camps for the public. This will also aid in better understanding of the problem and decision making for eye care in the future. To fortify our efforts in generating public awareness on quality eye care, we can initiate Knowledge Attitude and Practise Studies on blindness, create IECs around them and have a strong dissemination plan. NGOs like Orbis are already working to support its partners across India to ensure that quality eye care is delivered to the community and, more importantly, to the children of the

Preventing eye diseases through public health policy Preventable blindness is a critical component of our public

health policy. In order to address the country's untreated eye conditions, the WHO and the International Agency for the Prevention of Blindness (IAPB) collaborated with the Indian government to develop VISION 2020: Right to Sight-INDIA. It was founded in 2004 as a parallel NGO confederation to the international body. It aids in the development of state-level plans and programmes, which are led by the state government with extensive input from local and international NGOs. With the active participation of the Government of India, it also organizes World Sight Day, Eye Donation Fortnight, and other events. The Way Forward

We are aware of prevalent eye diseases, but we become short-sighted when it comes to critical information that can aid in early detection and treatment. Glaucoma, diabetic eye disease, agerelated macular degeneration (AMD), refractive errors, low vision, all require urgent public education. Children, middle-aged individuals caring for elderly parents, and older persons are some specific groups that could be targeted for educational activities to raise awareness on eye health, simple signs and symptoms of eye disorders and actions to take once they identify the symptoms to receive swift treatment and best results. Increased patient understanding of common eye diseases and treatments may lead to a greater appreciation of the value of routine eye exams in the early detection and treatment of many eye problems.



IT IS A LUNG CASE

Hospitals are seeing a significant rise in the number of patients suffering from a lung infection. Few subsets of COVID patients gradually develop the infection leading to pneumonia. SUPRIYA RAMESH speaks with experts to bring a report

nce again, the world is petrified as Omicron cases are on rise and sooner than soon we all might again be put behind the doors. Amidst the pandemic, which certainly doesn't seem to bid goodbye to us and has already caused pandemic-fatigue, there is pneumonia, another lung disease which is increasing its count all over the

Termed as an infection of one or both of the lungs, air sacs that are present inside tend to get filled with fluid or pus. It primarily affects infants and people above the age of 65, the severity of disease is more. Age is not the only factor that decides the seriousness of the disease infection and person's overall health also matter. Bacterial, viral, and fungal infections can all cause pneumonia. However, viruses and bacteria are some of the commonest causes. Some viruses also infect the respiratory tract and can lead to pneumonia. Viral pneumonia may be mild and can go away on its own like a

Mild signs and symptoms often are similar to those of a cold or flu, but they last longer and the symptoms vary for newborn, young adults and in older people. "Signs and symptoms may include chest pain when you breathe or cough, cough, which may produce phlegm, fatigue, fever, sweating and shaking chills, lower than normal body temperature (in adults older than age 65 and people with weak immune systems), nausea, vomiting or diarrhoea, shortness of breath," says Dr I J Kalra, MBBS, MD — Medicine, General Physician at Dr Kalra's Medical & Dental Centre in Hari Nagar and Paschim Vihar, New

Pneumonia's symptoms are almost similar to the coronavirus and there has also been a term coined for the condition patient faces post-COVID. "Pneumonia is a lung infection in general terms, and few subsets of COVID patients gradually get lung infection leading to pneumonia, in medical terms we refer to the condition as COVID Pneumonia," Dr Akshay Budhraja, Sleep Medicine, Aakash Healthcare

According to Dr Vidya Nair, Senior Consultant, Respiratory & Sleep Medicine, QRG Super Speciality Hospital, pneumonia management includes oral or IV antibiotics based on the severity of infection which is ascertained by the doctor. Most community acquired pneumonia with no additional patient risk factors need only monotherapy (single antibiotics), which needs to be given for five to seven days. Elderly patients, patients who have chronic comorbidities, or who have respiratory distress, may need dual antibiotic cover, oxygen

support and management of sepsis. "In case the patient is having

spasm (airway spasm) we give nebulization to the patient; along with that other supportive care like nutritional part, medicines for fever (antipyretic), antibiotics for vomiting, and other as per the symptoms," says Dr Davinder Kundra, Consultant — Pulmonology, HCMCT Manipal Hospital, Dwarka.

There has been a surge in cases due to the changes in weather and rising air pollution. "In our hospital, there is a significant rise in the number of patients suffering from a lung infection, including COVID. There is a 200 per cent increase in lung infection cases. However, most of them are having bacterial or other pneumonia, not COVID. Therefore, there is a three fold increase in lung three weeks. The catalyst behind this is changing weather and air quality," Dr Budhraja explains.

More than 60 per cent cases are from rural areas and there could be more than just one reason. What could be the possible reasons? Other than poor hygiene, improper sanitisation, less ventilation, no access to proper healthcare facilities and unavailability of vaccination, TB is the reason behind most pneumonia cases in rural areas. "Patients who come from rural areas, keep coughing for two to three weeks and it is only after X-ray and other medical examinations we get to know it is Tuberculosis," Dr Budhraja tells us.

Although pneumococcal vaccination is strongly recommended to prevent serious life threatening invasive bacterial pneumonia especially in people with comorbidities and age greater than 50 years, it doesn't prevent the disease completely. As the illness is related to lungs,

smokers might be at high risk. Dr K Shanmugham, Assistant Chief Medical Officer, Jindal Naturecure Institute, tells us that evidence from several studies confirms that smoking is significantly associated with the development of bacterial and viral pneumonia.

Exposure to tobacco smoke suppresses the activation of innate immune responses to bacterial infection; the front-line defence mechanism considered important in susceptibility to pneumonia. Cigarette risk factor for pneumococcal pneumonia in patients with chronic obstructive pulmonary disease (COPD), but even without COPD, smoking remains a major risk fac-

One with less severe infection can resort to home remedies. Herbal teas like peppermint, eucalyptus, turmeric, ginger and fenugreek tea can soothe a scratchy throat efficiently. They also deal with upper respiratory tract infections and break down mucus. Gargling with salt water helps get rid of the mucus sitting in the throat causing a ticklish feeling. Moringa, commonly known as 'drumstick', is a tropical plant with many nutritional and medical benefits.



The story is a fine attack on religious dogmatism in a patriarchal society, and was telecasted live on December 31, 2021, through online medium for students.



Worse, Mohammed Siraj hobbled off with what looked like a hamstring strain and if it's bad news, then India would be left with four bowlers.

However, a lot of blame should go to India's batters as some like Pujara didn't show intent to score while others like Rahane seemed completely short of confidence



It prompted the legendary Sunil Gavaskar to say it as it is on air, "I think the next innings will be their last chance."

Having given up hopes to play for England, Duanne Olivier (3/67 in 17 overs), playing his first game for South Africa in three years, dismissed Pujara (3 off 33 balls) and Rahane (0) off successive deliveries to make it difficult for the

Marco Jansen (4/31 in 17 overs), with his giant frame, created awkward lengths for every Indian batter while Kagiso Rabada (3/64 in 17.1 overs),

despite not being at his best, got wickets when it mattered.

In his first game as captain, Rahul concentrated hard as he played 133 deliveries. He was peppered with short balls. He would sway to some and duck the others while pulling the ones that he could

At the start, Mayank Agarwal (26) looked fluent in the first hour with five boundaries before Jansen pitched one in the spot from where it wasn't on drivable length as it climbed on. The opener went for a drive only to edge that to wicketkeeper Kyle Verreynne.

Rahul, on his part, survived strong caught behind and leg before appeals which were negated by debutant umpire Allahudien Palekar, someone who impressed on debut. But what would disappoint

Pujara and Rahane most is that on a day when they should have taken more responsibility in Kohli's absence, they couldn't even inject a sense of positivity in India's approach.

Bumrah appointed vice-captain for second Test, Iyer misses out due to stomach bug

▼ndia's leading pacer Jasprit **L**Bumrah was on Monday appointed vice-captain for the second Test against South Africa after KL Rahul was elevated as skipper in the absence of injured Virat Kohli.

Besides regular captain Kohli, who is missing the crucial match owing to upper back spasm, middle-order batter Shreyas Iyer was also ruled out of the game due to a stomach bug, the BCCI said in a statement. "The All-India Senior Selection Committee has named Jasprit Bumrah as vice-captain for the 2nd Test," the Board statement read, adding, "Team India batsman Shreyas Iyer was also ruled out of selection for the 2nd Test owing to a stomach bug."

Iyer made a magnificent start to his Test career, scoring a hundred and a half-century on debut in the home series against New Zealand towards the end of last year.

Bumrah had been appointed vice-captain for the limited overs series against the Proteas starting January 19, a move that was widely seen as an acknowledgement for his all-format consistency over the years.

Regarding Kohli, the BCCI said the superstar batter "had a spasm on his upper back this



morning"

"He won't feature in the second Test against South Africa at The Wanderers. The BCCI medical team will be monitoring him during the course of this Test match."

Kohli, who has been battling a prolonged lean patch with the willow, will thus not be able to complete his landmark 100th Test in the seriesfinale at Cape Town.

aptain Mominul Haque scored 88 to lead Bangladesh to a 73-run, first-innings lead over New Zealand in the first cricket test Monday, in one of its best-ever performances away from home.

Mominul shared a 158-run partnership with wicketkeeper Liton Das, who made 86, steering Bangladesh to 401-6 at stumps on the first innings of 328.

Bangladesh has seldom been so commanding in New Zealand, where it has never won a match in any format, or anywhere outside the sub-

It began the day 175-2 with Mahmudul Hasan Joy 70 not out after a 104-run partnership on the second day with Najmul Hossain Shanto (64). Joy was out early for 78 and Mominul and Liton Das then combined in a partnership which occupied the next 52 overs and saw the tourists attain a first-innings lead 20 minutes after tea.

Trent Boult dismissed both Mominul and Liton Das within four overs of each other in the final session to slightly diminish the tourists' commanding possession. But the day belonged to Bangladesh and for the second day in a row they finished with the upper hand.

"The boys really got stuck in," Bangladesh batting coach Ashwell Prince said. "We had a good day yesterday but

good day and the guys did exactly that. There will be two or three guys

we had to follow it up with another

disappointed that they didn't go on and get three figures. But all in all we had some good partnerships and it was a very good day."

The partnership between Mominul and Liton Das was critical for Bangladesh who, despite their outstanding performance on the second Zealand's last five wickets for 70 runs and lost only two wickets in two sessions, still had to consolidate their

They lost Joy quickly to a tired shot. He followed a ball from Neil Wagner wide of off stump and struck the ball directly to Henry Nicholls at backward point. Had they lost another wicket quickly at that point, all of the hard work of the second day might have been lost.

The I-League was on Monday suspended for at least The 1-League was on Iviolities stage characteristics for six weeks by the All India Football Federation (AIFF) after a fresh COVID-19 outbreak hit the participating teams inside the bio-bubble here.

It has been learnt that the total number of COVID-19 cases now stands at 45 after the latest round of tests which prompted the AIFF to suspend the league for six weeks. "The League Committee, abiding consensus of all

participating clubs as per the suggestion of Dr Harsh Mahajan (member of AIFF Sports Medical Committee) ratified the decision to postpone the ongoing Hero I-League 2021-22 for at least 6 weeks," the AIFF said in a release. The I-League Committee, chaired by senior AIFF vice-president Subrata Dutta, will have a review meeting after four weeks to take stock of the situation and decide the future course of action. The health protocols of the bio-bubble will contin-

ue till January 7, as all teams will be tested again on Wednesday. The teams can travel back to their respective destinations once they are tested negative.

Players and officials, who have tested positive in the team hotels and have already been isolated, will be treated and quarantined in Kolkata as per the health parameters laid down. They will be allowed to leave the biobubble after they test negative.

The fresh round of COVID-19 cases has thrown the I-League into jeopardy. With COVID-19 cases surging throughout the country, including in Kolkata and its suburbs where the I-League is being held, it will be a tough task ahead for the organisers to resume it. Getafe ends Madrid's unbeaten streak; virus-hit Barça wins

fter watching Real Madrid Alose its first match in three months, Carlo Ancelotti had one simple message for his players: The holidays are over.

Madrid's run of 15 consecutive games without a loss in all competitions came to an end Sunday when it slumped to a 1-0 defeat at modest Getafe in the Spanish league after a nearly two-week winter break.

League leaders Madrid fell behind early when Getafe striker Enes Unal stole the ball from defender Éder Militão near the goal and beat Thibaut Courtois. Luka Modric's shot off the woodwork in the first half was as close as Madrid got to an equalizer.

Even though Madrid remained in control of the league — with an eight-point lead over second-place Sevilla

Ancelotti chastised his team for its attitude.

"We can't get carried away this loss," Ancelotti said.

"We are still leaders and are excited about what is to come... A player who normally stands out for his defensive play gifted them their goal. It seems we didn't finish the year well. We were lacking focus, lacking commitment. This must be a wake-up call. My team looked like it was still on holidays."

While Madrid had got back several players — with the important exception of forward Vinícius Júnior, who had been out due to COVID-19 — Barcelona earned a 1-0 win at Mallorca with a team badly hit by the coronavirus. The absence of 10 first-

team players gave the rarely used Luuk de Jong the chance to finally show his worth as a striker since he joined



Barcelona on loan at the end of the summer transfer market as a bargain replacement for Antoine Griezmann
