# Corona's incursion unabated, cases grow 55%

### Maharashtra, Delhi, Bengal, Kerala, TN, K'taka account for nearly 80,000 cases

PNS NEW DELHI/MUMBAI

India on Thursday registered a steep surge in Covid cases which crossed 90,000-mark, a significant rise from the previous day's 58,097 infections in a span of 24 hours while Omicron tally reached 2,630 — the most in Maharashtra with 797 cases, followed by Delhi with 465 cases

Several States have announced restrictions like night curfew as Covid cases continue to race across the metros as well as small cities.

Just six States — Maharashtra, Delhi, West Bengal, Kerala, Tamil Nadu and Karnataka — accounted for nearly 80,000 cases on Thursday. This means, when India reports its number on Friday, it would easily cross 1.2

Maharashtra added 36,265 new cases (Mumbai 21,081) to India's massive spike, followed by West Bengal and New Delhi. While Bengal registered 14,021 cases, Delhi logged 15,097 new cases in a day.

Gujarat recorded 4,213 new cases of coronavirus on Thursday, taking its tally to 8,44,856, while one patient succumbed to the infection in the State, the Health

Department said. In south, Karnataka reported 5,031 fresh Covid-19 cases, 1 death in the last 24 hours. Kerala recorded 4,649 new Covid-19 cases on Thursday after testing 68,325 samples, taking its Test Positivity Rate (TPR) to 6.80 per cent. Tamil Nadu reported 4,862 Covid-19 cases. Chennai topped the list with 2,481 cases.

Alarmed at the spike, the Centre has asked States to ensure setting up of district, sub-district control rooms for Covid management with adequate staff, doctors, infrastructure, monitoring of beds availability, making outbound calls to patients in home isola-

The aim is to ensure ease of access to services like ambulance transportation and hospital beds, said an official from the Union Health Ministry.
"All States and UTs must

ensure that the daily status report of the home isolated persons are collated by the control rooms at the district and subdistrict levels in accordance with the new guidelines," said the Ministry in a letter dated on January 1, 2022.

In continuation of that letter, the Ministry on Thursday asked the States and UTs to ensure adequate staff and medical doctors at the control rooms in view of a rise in the case. The Ministry has asked the district administration to allot the dedicated ambulances for each control room.

# Delhi crosses 15,000 cases a day mark, positivity 15.34%

Delhi on Thursday registered 15,097 fresh Covid-19 cases and six deaths in the last 24 hours, 41 per cent jump over the previous day count. According to the Delhi health bulletin, the positivity rate jumped to 15.34 per cent.

On Wednesday, 10,665 cases were reported and on Tuesday 5,481 cases, according to official figures.

The huge spike in fresh cases over the past several days here is being recorded amid a significant jump in cases of the new Omicron variant of the virus. The death toll due to the coronavirus infection in Delhi has now risen to 25,127.

The number of cumulative cases on Thursday stood at 14,89,463. Over 14.32 lakh patients have recovered from the infection

During the height of the

second wave of the pandemic, 28,395 cases, the highest-ever single-day tally here, and 277 deaths were recorded in Delhi on April 20 last year, according to official figures.

Nine Covid-19 deaths were reported here in December last year, and seven in November, according to official data. Delhi had recorded four Covid-19 deaths in October and five in September.

# 125 fliers from Italy test +ve on arrival in Amritsar

As many as 125 passengers for almost 80 per cent of those traveling from Italy to India on the non-scheduled charter flight (YU-661) tested positive for the coronavirus on arrival at Amritsar airport on

The flight, operated by a Portuguese company, EuroAtlantic Airways, landed at Amritsar's Sir Guru Ram Dass Ji International Airport around 1.30 pm on Thursday with 179 passengers.

This comes amid heightened testing at all airports across the country. India earlier identified several European countries, including Italy, "at risk" in the wake of the outbreak of Omicron.

Taking to Twitter, the Amritsar airport authorities stated that they have taken all necessary actions to stop the spread of Covid-19. "In today's flight 125 passengers tested positive, and are being attended by State health officials. Rest 35 tested negative, and have been advised self-monitoring and would be under supervision," the airport noted.

VK Seth, the airport director at Amritsar, said as many as 125 passengers tested positive out of the 179, who were flying in a chartered flight from

Milan. Of them, 19 were either children or infants so they were exempt from on-arrival RT-PCR testing. Officials said the passen-

gers who have been tested Covid positive has been sent to institutional quarantine in their respective districts.

Chaotic visuals from the Amritsar airport showed a large number of passengers waiting to leave and in some videos, passengers were seen arguing with the authorities. After the test reports came in, a number of the passengers were not satisfied with the results and created a hue and cry at the terminal building. The passengers who tested positive for Covid-19 were reluctant for admission in the isolation ward of any of the city hospitals and were pressing upon the authorities to let

# Now a candidate can spend ₹95L for LS and ₹40L for Assembly elections

Pollowing the recommendations of the Election Commission, the Ministry of Law and Justice on Thursday revised the maximum expenditure limit from ₹28 lakh to ₹40 lakh for a candidate in Assembly polls and ₹70 lakh to ₹95 lakh for Lok Sabha polls.

For Puducherry, Tripura, Sikkim, Nagaland, Mizoram, Meghalaya, Goa and Arunachal Pradesh, the maximum expenditure limit for Assembly elections has been revised from ₹20 lakh to ₹28 lakh and from ₹54 lakh to ₹75 lakh for Lok Sabha elections. The expenditure limit is the amount an election candidate can legally spend for his

# **Lakhimpur lynching case**

Three BJP workers were lynched in Kheri violence

fter submitting charge-Asheets against 14 accused, including Union Minister's son Ashish Mishra, the special investigation team (SIT) on Thursday summoned 12 farmers in connection with the alleged lynching of three Bharatiya Janata Party workers during the violence in Lakhimpur Kheri that took place on October 3 last year.

Most of these farmers had earlier stated that they were present at the spot but were not involved in the attack. They were, at that time, charged under bailable sections such as 'rioting' and 'voluntarily causing hurt' and were let off by the SIT officials under Section 41 of the Criminal Procedure Code.

Seven farmers have been arrested in the case so far and the SIT is looking for more sus-

A SIT member said, "We have issued summons to record statements of the farmers who were present on the spot and were part of the mob. A few of them appeared before us earlier but none were arrested."

Advocate Harjeet Singh, who is representing the farmers, said, "A few farmers were earlier summoned for questioning under lenient sections as they were part of the mob but were not involved in the violence. The farmers who received the summons now are the ones who are witnesses in the case of the murder of farmers. We are waiting for the SIT to find the two other accused in the convoy who managed to escape.'

Four farmers and a journalist were allegedly mowed down by the convoy of Union Minister Ajay Misra Teni`s son Ashish Misra. Angry farmers had then in retaliation allegedly killed three BJP workers and torched two SUVs that were part of the convoy.

Cross FIRs were registered in the case and the SIT submitted a charge-sheet in which 14 people, including Ashish, who are in jail for the death of the farmers, have been named. Seven farmers have been arrested in the lynching case. The investigation in the latter case is ongoing.

# SIT summons 12 kisan in | Tweet on CM's wife sparks row in Maha

Objectionable tweet calls Rashmi Thackeray 'Marathi Rabri Devi'

An "objectionable" tweet describing Maharashtra Chief Minister Uddhav Thackeray's wife Rashmi Thackeray as "Marathi Rabri Devi" sparked a controversy on Thursday, with the Mumbai police calling a BJP social media functionary for questioning over the tweet.

In a development that saw the ruling MVA leaders hit out at the BJP for the controversial tweet put out by its social media functionary Jiten Gajaria, the the Cyber Cell of the Crime Branch-CID of Mumbai Police called Gajaria for questioning over his description of Rashmi Thackeray as"Marathi

In his tweet put out along

with photograph of Rashmi Thackeray, Gajaria has likened her to Bihar's former chief minister Rabri Devi, who had taken over the reins of the northern state after her husband and RJD chief Lalu Prasad Yadav resigned in the wake of his involvement in the fodder scam.

Through his tweet, Gajaria has indirectly referred to the health issues faced by chief minister Uddhav Thackeray, who is recouping from a cervical spine surgery that he underwent at HN Reliance Hospital here on November 12. Uddhav's health issues should be seen in the context of the fact that the winter session of the Maharashtra Legislature – for the first time in the history of the State Legislature -came to be convened in Mumbai instead of Nagpur in view of the chief minister's delicate condition and the fact that the doctors attending on him have advised him to go out of

Confirming that his client and party colleague Gajaria had been called for questioning, Mumbai BJP secretary and Advocate Vivekananda Gupta said: "Gajaria has been called for questioning by the police. He has not been arrested. Nor has any FIR been registered against my client".

Shiv Sena leader and current Maharashtra Legislative Council chairperson Dr Neelam Gorhe condemned the tweet saying that "it was objectionable". "Wecan not tolerate this kind of insults," she said. BJP's state women's wing

vice president and activist Chitra Wagh disapproved tweet by saying: "I am not supporting it". A couple of day ago Shiv Sena leader and minister Abdul Sattar, had said that Rashmi Thackeray, if made chief minister, was capable of running the Maha Vikas Aghadi government in the state. State BJP president Chandrakant Patil had said Uddhav's wife Rashmi Thackeray or son Aaditya Thackeray, who is state tourism, environment and protocol minister, should be made the chief minister of the state in view of the heath condition of the chief minister.

It may be recalled that on March 1, 2020 Rashmi Thackeray had replaced Uddhav as the editor of the Shiv Sena's official mouthpiece "Saamana", a Marathi daily newspaper,

The change in guard in "Saamana" set-up was expected as Uddhav had quit as the editor of the party's official mouth-piece after taking over as the chief minister of Maharashtra in November

Uddhav Thackeray had taken over as the Editor of Saamana" after the death of Shiv Sena chief and his father Bal Thackeray on November 18, 2012. After having been its editor for eight years, Uddhav resigned as the editor of Saamana, before taking the oath as the chief minister on November 28, 2019. So much so that Uddhav's name had disappeared from the print line of the newspaper.

In a public notice issued in the newspaper by publisher of "Saamana" Madhukar Bhagwat under the Regulations of Newspapers on Sunday, Rashmi Thackeray was named as the Editor of the Sena's official mouth-piece.

'Saamana' began its publication on January 23, 1988, with late Thackeray as its founding editor. 'Dopahar Ka Saamana', a Hindi afternoon edition of "Saamana" was launched by the Shiv Sena on February 23, 1993.

"One of the core responsibilities of the control rooms shall be to collate the daily status report of all patients under home isolation in their jurisdiction and submit the same to the district administration," reads the letter.

The control rooms will be responsible to make calls to the patients under home isolation for regular monitoring of the status report.

Along with enabling the infrastructure to provide unintended connectivity, the control rooms will remain functional round the clock to provide support to the patients. The control rooms need to ensure a mechanism for the allotment of beds.

Data has shown that the average daily rise of Covid this time is almost 21 per cent faster than during the second wave in March-April.

The bridge will now reduce a 150 km loop from Khurnak to the south banks through Rudok, sources said. The bridge will reduce the route from Khurnak to Rudok to 40-50 km instead of 170 km, they said. China has two-thirds of the 135 km Pangong

Tso and India has the remaining part. The region has seen stand-offs in the past few years with Chinese aggressive patrolling on foot and by boats.

Besides the bridge, the Chinese army has also built a road leading to the bridge for quicker deployment of troops and weapons, sources

The region saw a prolonged face-off between the Indian and Chinese troops from September 2020 till February 2021. Following prolonged military and diplomatic level talks, the two sides disengaged from the southern banks of the Pangong

Despite the stand-offs and talks, China ramped up its infrastructure development, including roads, bridges and helipads besides military garrisons near the Pangong lake and other flashpoints in the last few months. At present, more than 50,000 troops each from both sides are deployed in Eastern Ladakh.

A total of 98,434 tests — 80,051 RT-PCR tests and 18,383 rapid antigen tests - were conducted a day ago, the bulletin said.

Health Minister Satyendar Jain said, "Patients infected with Omicron can be treated at home. People should not panic and go to the hospital only if the symptoms are severe." Jain also said lockdown will not be imposed in the national Capital.

He said as per the new guidelines if the SPO2 level is above 93 per cent, there is no need to go to the hospital. He said no one has died as a result of the new Omicron variant and no Omicron patient has yet required oxygen or ventilator support. He urged Delhi residents not to visit the hospital unless they were in immediate need. "There are enough beds in Delhi's hospitals, so there is no need to panic. If the symptoms are minor, there is no need to go to the hospital. Only go to the hospital if your symptoms are severe," he said.

According to the new guidelines of the Health Ministry, patients with mild symptoms and asymptomatic patients do not need to go to the hospital. Asymptomatic patients can be treated at home.

# Police nab 'mastermind' engineering student

The Intelligence Fusion and Strategic Operations (IFSO) unit of Delhi Police has arrested a 21-year-old engineering student believed to be the "mastermind" and creator of the "Bulli Bai" app from Jorhat in Assam on Thursday. Police said that he was brought to the national Capital where he confessed to his role.

The accused identified as Niraj Bishnoi is the fourth person to be arrested for their alleged involvement in the app that has listed hundreds of Muslim women for "auction". The other three, nabbed by Mumbai Police, include a 19year-old woman from . Uttarakhand, also alleged to be a prime accused in the case.

Bishnoi, a resident of Jorhat who studies in Bhopal, is the creator of the "Bulli Bai" app on the platform GitHub as well as the main Twitter account holder of "Bulli Bai", police said.

(DCP), ISFO, Bishnoi is the mastermind and the person who had created this application on Github.

'He has confessed about the creation of the application... forensic remnants of the creation have been found in his laptop. He was arrested early Thursday morning from Jorhat," the DCP said, adding that IFSO worked out the case using technical analysis, IPDR (Internet Protocol Detail Records) and other gateways.

Bishnoi is a second year B Tech student at the Vellore Institute of Technology in the Madhya Pradesh capital, the

Of the four people arrested, three are 21 years old, two are studying engineering and one is aspiring to, and two are from Uttarakhand.

old Mayank Rawal, also from Uttarakhand, and Bengaluru-based Vishal Kumar Jha, a second-year engineering student like Bishnoi and aged 21 too.

According to a senior Mumbai Police officer, Singh is a prime accused who had created the Twitter handle of the Police Mumbai Commissioner Hemant Nagrale told reporters on Wednesday that some more people are likely to be involved in the matter.

Hundreds of Muslim women were listed for "auction" on the "Bulli Bai" mobile application with photographs sourced without permission and doctored. The app appeared to be a clone of "Sulli Deals" which triggered a similar row last year.

# HC upholds murder charge for death by firing in barat procession

New Delhi: The Delhi High Court has upheld the charge of murder framed against a man who fired a bullet from his pistol during a barat procession which resulted in the death of an onlooker standing on a nearby roof.

Justice Rajnish Bhatnagar dismissed the petitioner's challenge to the framing of charge under Section 302 of the Indian Penal Code and said that the murder case was based on the material on record and the deceased person's father's statement who claimed to have seen the accused firing after wiping out his pistol, one of which hit his son.

The judge said that the question of motive and intention would be seen during the course of the trial and clarified that at the present stage, only a prima facie view is to be taken to arrive at the conclusion that the commission of the offence is a probable consequence.

'While deciding the question of framing of charge in a criminal case, the court is not to apply exactly the standard and test which it finally applies for determining the guilt otherwise. What is required to be seen is whether there is strong suspicion which may lead to the court to think that there is ground for presuming that the accused has committed an offence," the court said in its recent order.

"In the present case, the perusal of the impugned order dated 09.01.2020 showed that the Ld. ASJ (additional session judge) has framed the charge on the basis of the material as placed on record by the prosecution and the statement of the eye witness who is the father of the deceased who has stated in his statement that it was the petitioner/revisionist who after wiping out his pistol started firing and fired one gun-

shot towards his son," it added. As per the complaint filed in the case, one bullet had hit the deceased on the right side of his chest as he watched the wedding procession from the rooftop. He thereafter fell down and was taken to the hospital, it was stated.

The prosecution defended the murder charge against the petitioner and informed that the pistol used for firing was an un-licensed weapon. It stated that whatever defence the petitioner wanted to take could be taken by him during the course of the trial.

# Delhi Govt extends application deadline for nursery admissions in private schools

New Delhi: The Delhi Government has extended the application deadline for nursery admissions in private schools by two weeks in view of the prevailing Covid situa-tion, Deputy Chief Minister Manish Sisodia said on Thursday.

The process of nursery admissions in nearly 1,800 private schools across the national capital began from December 15, and the application window was scheduled to close on January 7. "Keeping in view the pre-vailing Covid conditions, the

# Maha, TN, UP, Raj, Guj, **Delhi Covid hotspots**

Maharashtra, Tamil Nadu, Gujarat, Rajasthan, Karnataka, Delhi, Uttar Pradesh and Andhra Pradesh—which are currently seeing a significant surge in coronavirus infections—are the hotspots for the prevalent Covid-19 pandemic in India, according to a study by the researchers from the Indian Institute of Technology (IIT)

Mandi. Pointing out that as international migration is a significant factor in these States, the researchers advised that the Government should carefully monitor travel to and from these states in future cases of pandemic outbreaks.

They also called for strict precautionary measures in districts near large bodies of water before the monsoon season begins as water bodies have a strong influence on a region's microclimate in terms of temperature and humidity, contributing significantly to regional climate change, and subsequently rise in cases.

Science, was performed on 640 districts from April 1 to December 25, 2020.

For the study, results of which were released on Thursday, the team found common patterns between the Spanish Flu (1918-1919), H1N1 (2014-2015), Swine Flu (2009- 2010), and Covid-19 (2019-2021) outbreaks and Covid-19.

They also found that "There has been a striking similarity in the focal point and route of transmission of different epidemics in India, such as Spanish flu, H1N1, Swine flu Covid-19. Mostly all the pandemics have started and found their epicentres in the northern, western, and southern parts of India," said Dr. Sarita Azad, Associate Professor, School of Basic Science, IIT Mandi, in a state-

Furthermore, researchers examined the temperature variations across districts that are close to large bodies of water to understand the spread of Covid-19 in these

maximum temperatures in these districts are about 3 and 5 degrees Celsius lower than neighbourhoods in July, which is attributed to the lake effect. The cooler climate conditions may have contributed to the increase in cases in districts that are close to water bodies.

"We also found that districts with direct access to large water bodies had a sudden increase in cases during monsoon (as high as 800 per cent) compared to the preceding season. Hence, strict precautionary measures should be imposed in these districts before the beginning of monsoon season during an outbreak, Azad added.

In addition, the researchers estimated R0 values for these districts until August 31, last year, and the results indicated that their R0 values are much higher than those of the primary hotspot states.

In epidemiology, the basic reproduction number, commonly known as R0, quantifies the disease spread and finds the expected number of cases directly generated by one case in a population.

# Omicron variant less severe than Delta: US study

Giving a cause for optimism to the people rattled by the Covid-19 fueled by Omicron variant, White House chief medical adviser Dr Anthony Fauci has said that a growing body of data indicates that the Covid omicron variant is less severe than the Delta strain.

However, he cautioned that hospitals could still face stress through the unprecedented number of new infections sweeping across the U.S. His comments come amid an exponential rise in Covid cases in India on Thursday when the infections breached the 90,000

mark with the majority of States reporting huge spikes in the cases.

The doctor cautioned against complacency, urging the public to follow public health guidance by getting vaccinated, boosted and wearing a mask.

'Multiple sources of now-preliminary data indicate a decrease in severity with omicron," Fauci told the public during a Covid update from the White House response team, according to reports. "However, we really do need more definitive assessment of severity with longer-term follow up here and in different countries."

Fauci cited a study from Ontario, Canada, that found the risk of hospi-

talization or death was 65% lower among people infected with omicron compared with individuals who

The risk of admission to an intensive care unit or death from omicron was 83% lower, according to the study.

He also pointed to a study from South Africa that found about 5% of infections during the omicron wave resulted in hospital admission, compared with 14% during delta. Patients admitted to the hospital during the omi-cron wave were 73% less likely to have severe disease compared with the delta wave, according to the data.

Fauci also said the lung infection

from omicron appears less severe than previous variants, citing recent animal studies of mice and hamsters.

"It was shown that the virus proliferates very well in the upper airway and bronchi, but actually very poorly in the lungs," Fauci said. While this does not definitively prove omicron is more mild, it is consistent with the variant transmitting very quickly but causing less severe lung infections," he said.

Fauci warned that even if omicron proves less severe, the variant is spreading so quickly that it could still produce a large number of patients who do require hospital care, straining the nation's health-care system.

# EC reviews Covid situation in poll-bound States

In a separate meeting, the poll panel also discussed the law and order situation in the five states - Uttar Pradesh, Uttarakhand, Goa, Punjab and Manipur - with Union Home Secretary Ajay Kumar Bhalla ahead of the announcement of the poll dates



in the next few days. Besides Health Secretary

Rajesh Bhushan, the meeting to assess the Covid situation was also attended by AIIMS director Randeep Guleria and

ICMR's Balram Bhargava, sources aware of the interactions said. Bhushan and other health experts briefed the poll body on the present situation. This is the second time that when Bhushan briefed the top officials of the EC on the emerging Covid situation in the country and poll-bound states in particular.

According to sources, the EC is preparing to tighten Covid-19 guidelines for the upcoming assembly elections including bringing in stronger accountability.

In the separate meeting,

The Chief Election Commissioner's statement came as a clear indication that there will be no postponement of the elections in the poll-bound states.

# CBI registers 4 separate cases in bank fraud of ₹940 crore

The CBI has registered four separate cases related to bank fraud of around Rs 940 crore and conducted searches in each case.

One of these cases was registered on complaint from Bank of India against Electrotherm (India) Ltd and others including its directors, unknown public servants and unknown others on the allegations of causing loss of Rs 631.97 crore to Bank of India in the matter of various credit facilities, the CBI said in a

statement. It was further alleged that during the period 2012 to 2016, the directors of the borrower company were enjoying fund based and non-fund based credit facilities from Bank of India.

The Forensic Audit of the company (conducted by the bank) revealed that the company was allegedly involved in diversion / siphoning off funds through its subsidiary / associate companies which were having common directors, it said. The company was also allegedly involved in transactions with suspicious dealers involved in issuing false bills without actual delivery of goods.

It was also alleged that the company started facing liquidity problems and failed to pay the dues to the bank. Subsequently the account was classified as Non Performing Assets (NPA) with outstanding amount of Rs 631.97 crore, thereby, causing loss to the Bank of India.

# 4 J&K ex-CMs to lose **Special Security Group**

Farooq, Azad to still avail of NSG: Omar, Mehbooba to continue with Z+ security in J&K

Srinagar/New Delhi: Four former Chief Ministers of Jammu and Kashmir, including Farooq Abdullah and Ghulam Nabi Azad, are likely to lose their Special Security Group (SSG) protection as the Union Territory's administration has decided to 'rightsize' the elite unit established in 2000, officials said on Thursday.

The move comes a little over 19 months after the Centre had issued a gazette notification - Jammu and Kashmir Reorganisation (Adaptation of State Laws) Order, 2020 -- on March 31, 2020, amending the Special Security Group Act of the erstwhile Jammu and Kashmir Government by omitting a clause that provided former chief ministers and their families with SSG security.

Officials said the decision was taken by the Security Committee, a group that oversees the threat perception of important leaders in Jammu and Kashmir.

The officials said the SSG will be 'rightsized' by reducing the number of the elite force to the 'bare minimum'. It will be headed by an officer below the rank of Superintendent of Police as against Director, who is of the rank of Inspector General of Police and above.

However, the officials feel there was a re-think over the downsizing of the SSG as some experts within the police force feel that this may hamper the preparedness of the elite unit.

The SSG will now be entrusted with the security of serving Chief Ministers and their immediate family mem-

The decision will entail the withdrawal of the security cover of Farooq Abdullah, Ghulam Nabi Azad and two other former chief ministers Omar Abdullah and Mehbooba Mufti at a time when a number of terror incidents have taken place in Srinagar.

# Catch-22 situation for Kerala CPI(M) over tie with Cong

Despite the CPI(M) leaders in Kerala making critical statements about the Indian National Congress and eulogise the regional parties, seasoned political commentators in the State are of the view that there would be a marked change in the former's attitude to the Grand Old Party in the coming months.

The CPI(M)'s Kerala secretary, Kodiyeri Balakrishnan, who is the de facto general secretary of the party is on record stating that the INC has lost its relevance and the regional parties would play a crucial role with the Left forces in dethroning the "communal and Fascist" BJP and Sangh Parivar in the 2024 Lok Sabha election.

"Though the national leadership of the CPI(M) has expressed its stance that only a combination of Lefts, the INC and regional parties would be Marxists are caught in a Catch-22 situation in Kerala," said P Sujathan, veteran scribe and columnist.

He pointed out that the Congress was the main rival of the CPI(M) in Kerala unlike the rest of the country where both are on the same sides of the fence. "The question faced by the CPI(M) leaders in the State is how to convince the cadre who are moulded in an anti-Congress platform," said Sujathan. He said as the CPI has made it known that no viable alliance would be possible against the Hindu parties without the inclusion of the Congress, the CPI(M) is likely to make amendments in its triennial congregation, the Party Congress, which meets in Kannur shortly.

It is in the Party Congress the leaders of the CPI(M) come out with its stance on all global, national and state level issues. Other Left parties like the RSP and the Forward Blocks are for a strong united front that include the INC against the "communal" BJP, pointed out Hari Kartha, former chief editor of Janmabhumi, the Sangh

Parivar mouthpiece. "We should understand ground realities. Indian National Congress is the only pan-India party which is consistent in its stance on secularfederalism and Constitutional institutions. We should forge a national alliance with the Congress in the forefront," Kanam Rajendra, general secretary of the CPI's Kerala unit told The Pioneer.

The CPI's mouthpiece Janayugam in its editorial on Tuesday reiterated that no viable alliance would be possible against the Fascist forces without including the Congress in the initiative. "The Congress has its own stance on economic issues. But the present situation needs a collective to safeguard secularism, democracy and freedom of speech. That could be regained only by aligning with the Congress," opined the editorial.

Meanwhile Cherian Philip, after a brief stay in the CPI(M) asked the CPÍ to dump the Marxists and forge an alliance with the Congress. "That's the need of the hour. The CPI was in alliance with the Congress for decades and there is nothing new in such a relation," said Philip, a close confidante of Oommen Chandi, former chief minister.

There is a discernible change among the CPI(M) cadre vis-a-vis the INC. The rallies held across the State as part of the district conventions reverberated with slogans against the BJP and its Hindu policies while the cadre were silent about the Congress. Deshabhimani, the mouthpiece of the CPI(M) too has toned down the criticism and opposition against Congress leaders. "It looks more like a friendly match and I feel there exists a strong possibility of the parties coming together for a common

cause," said Kartha. Sujathan reminded that the CPI(M)-Congress alliance functioned effectively at the Centre during 2004 to 2009 though the former withdrew from the friendship following India's decision to sign the Nuclear Energy Pact with the US.

# A new low

Rabble-rousing politics can debase democratic values, and the proof is Capitol's 'insurrection'

n January 6 last year, thousands of Americans formed a mob and forced their way into the US Capitol in Washington. The joint session of Congress was at that time trying to formalise the victory of President-elect Joe Biden. The rioters assaulted police officers and vandalised property as the complex went into lockdown. The march to Congress, called an "insurrection", followed provocative speeches by outgoing President Donald Trump who refused to accept his defeat. Trump told his supporters, "You do not concede when there is theft involved", and asked them to go to the Capitol but did not join them. Trump escaped impeachment by a whisker but the question is asked even today: If this is a court of law, did Trump cross the line? The violent attack was the culmination of a series of incendiary exhortations that marked Trump's presidency. It also fundamentally changed Congress and raised concerns about the resilience of American democracy. Democracy is perhaps the scapegoat for the real ills that plague the United States — extreme economic inequality, brittle race relations, trigger-happy gun policies, issues of social exclusion and, of course, the tussle



for power between the elected administration and the mammoth industrial complex. Trump ensured the transformation of the Republican Party into a forthright right-wing association harbouring extreme views about inclusivist politics. If the Democrats were unprepared for the extent he could go to in riling up the public, traditional leaders among the Republicans were equally flustered at one individual sweeping the rug of complacency from under their feet.

Yet, when Trump stirred controversy, it was attributed to the democratic right to freedom of speech. Just like taking the Fifth Amendment to avoid telling

the truth or using self-defence as an excuse for buying a gun is seen as evidence of a thriving American democracy. And yet, when Trump acted divisively when the vote went against him, and when January 6 happened, Americans did not know how to respond. It was the kind of unrest they had till then read about in papers or saw on TV happening in far-off lands; it was now happening right in the middle of Washington. January 6 is evidence that rabble-rousing politics can debase democratic values but was still insufficient to derail democracy completely. Opinion polls screamed that people's belief in democracy was waning, but their politicians were meanwhile trying to respect that "ideal". The "insurrection" had led to a call for setting up a military quick reaction force but the people's representatives vetoed it. Surprisingly, it was a Republican duo, a Senator and a US Representative, who issued a statement insisting the Capitol Complex must remain the "responsibility of federal civilian law enforcement", and adding: "We cannot and should not militarise the security of the Capitol Complex." That should answer the cynics even though the American people are still in two minds whether the "insurrection" was an attempt to undermine democracy or the result of dangerous partisan politics



# **Kudos, Congress**

The party has shown respect for human life by deciding to put off big campaign rallies in UP

he 'grand old party' has finally started showing some spark after staying moribund for a long, long time. A couple of sprightly decisions within a matter of hours, after lying inert for years altogether, point to this rejuvenation in the core of the Congress: One, the party has decided to put on hold public rallies and political functions in Uttar Pradesh in view of the deepening health scare in the country. Two, party president Sonia Gandhi spoke to Punjab Chief Minister Charanjit Singh Channi regarding Prime Minister Narendra Modi's security breach and sternly told him to fix accountability and take suitable action. But first things first. Owing to the



sudden spurt in Coronavirus cases (mainly its Omicron variant) across the country, the Congress has decided to put on the backburner all major campaign rallies; the decision is said to have been taken by senior All India Congress Committee (AICC) leaders in consultation with the UP PCC brass "in view of public safety". It indeed is a matter of record that the COVID-19 situation in the country is worsening by the day and major political rallies — which draw crowds of thousands — have the potential of turning into super-spreader events, especially in view of the anticipated third COVID wave

To reach out to voters, however, the Congress has sought permission from the Election Commission for door-to-door campaigns and small gatherings. The Samajwadi Party, too, followed suit. However, the BJP, AAP and BSP are yet to announce their stand officially though they have cancelled a few rallies. For his part, UP Chief Minister Yogi Adityanath on Thursday cancelled a Government function in Gautam Buddh Nagar district. But the same doesn't hold true for the BJP's star campaigner, Modi, who recently addressed a massive rally in Manipur and was cut short by circumstances beyond his control from attending another huge rally in Punjab's Ferozepur on Wednesday. It's indeed a matter of shame that the horrifying memories of the second wave — huge political rallies turning into super-spreaders; lack of oxygen cylinders and hospital beds; crematoria struggling to cope with incoming dead bodies; and bodies floating in the Ganga — have not deterred parties from operating as businesslike as usual. In this context, the Congress certainly deserves a loud 'cheer' for taking the lead in respecting the value of human life over its share in ballot boxes.

# Cricketers need to up their game a lot PRAFULL GORADIA



The current competitive phase of the game shows that there is a dearth of all-rounders as well as of ambidextrous bowlers who can swing a match

s I watched the second day of the second Test against South Africa, I found that the fast bowlers had not been able to take a wicket for quite a few hours. Yet none of them tried to bowl, for a change, with his left arm. Or a leg cutter, like Fazal Mahmood of Pakistan used to successfully bowl in his day. Or even try a different type of slow delivery as Gary Sobers of the West Indies used to try when his opening spell was over. He was otherwise an opening pacer.

In the current competitive phase of cricket, why are there so few all-rounders? One of the few rays escaping through the clouds is of all-rounders, while there is sunshine of specialists. A right-handed batter can be a left-arm bowler. Why cannot a left-arm bowler, slow, medium or fast, bowl with his right arm? The brain or the technology of bowling is the same. The bowler is left-arm opener but he won't try his other arm when his left fails to take a single wicket. The answer might be that he was not trained to bowl with both arms. True, but why cannot a young player of 22 make up by getting trained at this not-old age? Is it his fear of diluting his expertise with his left arm? Or is it just a plain mindset? Jaspreet Bumrah appears to have experimented with some batting lately. So probably has Mohammed Shami, although a little too late. To say that India is a large

country is an understatement, and particularly so, when said in the context of cricket. Australia, Sri Lanka and the West Indies are tiny by comparison. Yet each of them fields a Test team of 11 players; no more, no less. No nation fields, say, two or three teams. The same is the case with the 50over one-dayer and the Twenty-20. In all, no country fields more than a total of 33 players on any single day. Sri Lanka, with 25 million people, and India, with 1,400 million, are weighed on the same scale. nised international cricket. One also knows that Indian players or their training academies do little to make youngsters more competi-

For those young boys and girls who are ambidextrous, there are clearly five talents they could conceptually cultivate. This is batting and bowling with both hands and arms. Fielding is the fifth ability. Here, too, why not learn to throw with both hands, which would make for a maximum of six faculties? If one goes by the example of Gary Sobers, there is the choice of fast bowling as well as slow-medium. This should be the simplest option.

This plea for all-rounders or versatile players is not merely for players and their training academies, but also for India. The boom in cricket began first with the introduction of one-dayers and, a few decades later, the advent of the Twenty-20 matches. Another great boost has been the innovation of the Indian Premier League (IPL), which

What we can apprehend is that in the absence of a continually expanding scope for players, they may at some future date consider emigrating to smaller countries. Suppose a small country like New Zealand runs short of talented cricketers, it might tempt a few Indian players to migrate. I suppose there is nothing wrong with such a development. But I find it unwelcome if it is a result of our failure to foresee the future. Something inexplicable

needs to be mentioned here; which is that certain tournaments attract crowds, while others just do not. Take the Ranji Trophy, named after the distinguished batter Jam Kanjitsinnji, wno innovated the behind-the-wicket stroke as a deliberate scoring attempt. Especially the leg-

played until Ranji showed in England, mainly in the County Cricket tournaments, how to play these shots. Even the off-side cuts were not very common; the frequent scoring style was in front of the wicket, whether on the leg or the off side. Yet Ranji Trophy matches in India do not draw crowds. They never have, although playing for one's State should arouse enthusiasm.

rance took over the European Union (EU) presidency this week for a period of six months. This development can have significant impact on QUAD and AUKUS, whose member-countries are actively seekinga dominant voice vis-a-vis China in the Indo-Pacific belt. This will also be a significant force in France's own bilateral engagements with each of the global powers and through multilateral bodies such as EU. France has a slightly altered sense of the Indo-Pacific stretching from East of Africa to the US west coast whereas for many in the QUAD group Indo Pacific is an extension the of Pacific Ocean. India, though part of QUAD, is more aligned with France's version of the Indo Pacific, which puts India in the center of the Indo-Pacific sphere of influence. France is currently facing an embarrassment in its bilateral and multilateral relationship with the US, the UK and Australia, after the down south country formed a military alliance for procur-



ing sophisticated nuclear capability submarines patrolling the Indian ocean. This is a lost economic opportunity for France who earlier was the preferred partner for Australia to provide weaponry. This has also led to France withdrawing its diplomats from Washington in nearly 250 years and souring of relationship between the US and EU on whole bunch of multilateral issues. France and India have robust bilateral defense and security relations and have sharedinterestin global and multilateral platforms on whole bunch of issues. In the last two months of 2021, India and France have had several high-level bilateral meetings, including one between Prime Minister Narendra Modi and President Emmanuel Macron on the sidelines of G20. France has a significant presence in India's defence equipment sector, the latest being the induction of nuclear capable Rafale fighter jets into India's front end strike capabilities. In December, French armed forces minister Florence Parly had reiterated onstrengtheningindustrial cooperation and co-manufacturing ofdefenceequipment. This is a perfect fit into India's visionof self-reliance on strategic equipment production (Atmanirbhar Bharat) and France's desire to expand its economic partnership with key allies such as India in the Indo-Pacific. It is the centrality of placing India in the Indo-Pacific strategy which could be of great benefit in the next six months. Last month, the French president defined the way forward for the European Union in the Indo-Pacific with a focus on promoting multilateralism, cooperationand informationsharing onsecurity, cyber space and emerging technologies. This also includes the emerging situation in Afghanistan, and stability in Indian Ocean Rim countries where China has suddenly started to make aggressive overtures. he Chinese foreign minister Wang Yi has been on a whirlwind tour to Comoros, Kenya, Eritrea, Maldives and Sri Lanka in the Indian Ocean Region. Countering China's push for greater say in the Indianocean region is a shared interest of Indiaand France and to a large extent of the entire EU. India and EU havenot had lucrative trade relationsfor nearly a decade now, and in a post-Covid world looking to build resilient supply chains, having a rim of allies for shared prosperityis a priority. Many experts point out that India may restart engagement on BTIA (Bilateral trade and investment agreement) with EU. There could be a challenge for getting the undivided attention of the French president on many of these multilateral matters on the EU platform, as he faces a stiff challenge for re-election back home. That aside. the strategic partnership should be utilized to its full potential to drive the shared vision for a free and fair Indo-Pacific region.

# Social justice forays into medical education



Healthcare is a matter of national importance, a key to Swasth Bharat, and the resident doctors are crucial for the entire healthcare system

he matter of introducing 27 percent reservations for the Other Backward Classes (OBCs) and the Economically Weaker Sections (EWSs) in medical education both at Under Graduate (UG) and Post Graduate (PG) levels is at crucial stage of hearing before the Supreme Court. The medical students and the entire nation are waiting with bated breath for the judgement of the apex court as it is a matter of vital importance involving and intertwining social justice and quality medical education.

A group of resident doctors has challenged before the Supreme Court the government notification providing the impugned reservations. On July 29, 2021, the Union government had issued a notification introducing the above two new reservations for undergraduate and postgraduate medical and dental courses beginning from the current academic year 2021-22. The notification reserves 27 per cent seats for the OBC and 10 percent seats for the EWS under All India Quota (AIQ). The NEET-UG examination for admission to the MBBS course is conducted by the National Testing Agency, Ministry of Education while the National Board of Examination (NBE), Ministry of Health and Family Welfare conducts the NEET-PG examination for medical and dental courses in the country.

The NEET-PG exam was supposed to be held in the month of January 2021 but was postponed to April 2021 and, in the meanwhile, owing to the evolving Covid-19 situation, the exam was further postponed to September 2021. The exam results came out in October. The counselling was to start from the end of October itself but it could not start as the notification was challenged in the Supreme Court by some doctors and the matter is sub-judice. The petitioners also challenged the reasonableness of the annual income ceiling of?. 8 lakhfixed to determine EWS status. Another important aspect is the fate of those candidates who have secured higher ranking in the order of merit but would be deprived of admission due to these two new reservations unless additional seats are created for them.

Although the resident doctors have called off the strike on the personal intervention of the Union Health Minister, the problem of inordinate delay in admissions and the inevitable denial of admission to meritorious students continues to be cause of serious concern and worry. The problem needs speedy and amicable resolution in view of the looming threat of yet another but far contagious wave of the pandemic and the possible enormous swell in patients. The resident doctors were protesting since November 27 against the multi-ple postponements of the NEET-PG 2021 counselling and the resultant delay in admission of the fresh batch of doctors in medical colleges.

The All-India Quota (AIQ) scheme was introduced in 1986 under the Supreme

this additional 10 per cent EWS reservation without affecting the seats of the unreserved category.

On a petition, the Madras High Court ruled in July 2020 that the OBCs were entitled to reservations in the AIQ seats and directed the Union Government to implement the same from the academic year 2021. The Union Government decided to provide 27 per cent reservation for OBCs and 10 per cent reservation for EWS in the AIQ seats for all the UG and PG courses from the current academic year 2021-22. Given the enormous delay in holding NEET-PG-21 counselling, the government could have taken a decision to implement these reservations from the academic year 2022-23. But no popular government can afford dithering and prevaricating on a highly emotive and inflammable issue of social justice, more so when elections are round the corner. The clarion call of social justice is seen as a potentially powerful tool to secure political power. There were times when the politics of Mandal and Kamandal were at loggerheads but today a blend of both is perceived as sure recipe for electoral triumph. The report of Mandal Commission was pulled out of hibernation all of a sudden by then Prime Minister VP Singh as a counter-measure to save his government. PV Narasimha Rao, short of overburdened and the simultaneous bariiamentary majority, introduced 10 percent reservation for the EWS apart from 27 percent reservations for the OBCs. The notification was challenged, and the Supreme Court in the famous Indra Sawhney vs Union of India, 1992, upheld 27 percent quota for the OBCs but struck down 10 percent reservation for the EWS. However, with the passage of the 103rd Constitution Amendment, the reservation for the EWS has been constitutionally guaranteed, albeit


some institutions of national excellence and pioneering research in matters of national and strategic importance have been kept beyond the ambit of reservations.

The resident doctors want NEET-PG-21 Counselling to start without further loss of time, which has been delayed unconscionably and inordinately for multiple reasons. The academic session 2022-23 is only a few months away and given the severe constraints of infrastructure and faculty, approximately 90,000 PG students cannot be catered to by the system meant for 45,000 students per academic year. To overcome the shortage of teachers, the Medical Council of India (now Medical Commission under the new Act) increased the professor-teacher ratio from 1:2 to 1:3 from the academic session 2018-19. Court's direction to provide for domicile-free merit-based opportunities to students from any state aspiring to study in a good medical college in any of the states. The AIQ consists of 15 per cent of the total available UG seats and 50 per cent of the total available PG seats in government medical colleges. Prior to 2007, there was no reservation in the AIQ scheme. In 2007, the Supreme Court introduced 15 per cent reservation for the Scheduled Castes (SCs) and a 7.5 per cent quota for the Scheduled Tribes (STs) in the AIQ scheme. When the Central Institutions (Reservation in Admission) Act came into force in 2007, it provided for the first time 27 per cent reservation to the OBCs. It was implemented by all the central medical educational institutions but not applied to the AIQ seats of the state medical and dental colleges. # China: No more 'Mr Nice Guy'

### The limited free speech and tolerance of dissent that prevailed for 20 years under Xi Jinping's predecessors have been systematically eroded

ore than 200 Hong Kong police raided and shut down one of the last pro-democracy news websites in Hong Kong recently, in the latest sign that the Beijing regime will no longer tolerate dissent of any kind. It was total overkill - a couple of cops with a court order would have sufficed - but they were 'sending a message' to other

'malcontents'. Chief Secretary for Administration John Lee defended the police operation (which also arrested current and former editors and board members in their homes) in fluent Orwellian Newspeak: "Anybody who attempts to use media work as a tool to pursue their political purpose contravenes the law. They are the evil elements that damage

press freedom." It's not just Hong Kong: all of China is closing down. The limited free speech and toler-

ance of dissent that prevailed for twenty years under President Xi Jinping's predecessors, Jiang Zemin and Hu Jintao, have been systematically eroded, and Xi is now effectively president-for-life.

He even encourages a personality cult, something the Party had managed to avoid since the catastrophe of Chairman Mao Zedong. And there's no velvet glove on the iron hand any more: uppity ethnic groups like the Tibetans and Uyghurs are just overwhelmed by imported majorities of Han Chinese, and those who complain get sent to con-

centration camps



warrior' diplomats berate the foreign countries they are stationed in for any criticism of China, and the crushing of Hong Kong's liberties signals the abandonment of any notion of seducing Taiwan into unification under the banner of 'one country, two systems'. When the time comes, it will be annexed by

But the question is: why now? Xi's personality is authoritarian, to be sure, but It's the same abroad. 'Wolf that is pretty standard among

the 'princelings' who grew up as part of the second and third generation Communist aristocracy. Yet for decades they supported term limits on the leadership because that protected them from being victimised by another Mao fig-

If they now accept Xi's elevation to supreme and perpetual power, it cannot just be because they are afraid of him. He's only one man. There also has to be some sense among others in the Party's leadership that it will need a tough autocrat to ride out the coming storms and preserve its rule. So, what storms might

those be? It has been evident for years that Beijing was cooking the books and overstating China's economic growth rate.

It was obvious from previous examples where industrialising countries enjoyed high growth rates by exploiting cheap labour flooding into the cities from the countryside that this was a once-only bonus. The 10 per cent growth never lasts more than one generation; then it falls back to the 'normal' 2-3 per cent. Recent examples are Japan (1955-85) and South Korea (1960-90)

Like it or not, China has had its 30 years of high-speed growth (1985-2015), and behind a facade of lies its real growth rate has already been falling for at least half a decade. In the last few quarters, indeed, China's Gross Domestic Product has grown at half the

rate of the American GDP. That is partly due to a

surge in US production while the economy recovers from the Covid lockdowns, but the published Chinese growth rates have been fictions for at least the past five years. Realistic estimates, 'reverseengineered' from electricity consumption and other proxies, have been more like 3-4 per cent, and growth is destined to fall further.

The Chinese birth rate has collapsed: each new age cohort entering the workforce will be much smaller than the one before, which will hit demand very hard. Moreover, the debt incurred by reckless over-investment in housing, roads and other infrastructure, just to keep the employment and growth statistics up, is already a major burden on the

Two implications of this are long-term threats to Communist rule in China. The Party's promise to overtake the US economy and make China the world's dominant power will probably never come to pass, nor will its promise to raise Chinese living standards to a developedworld level. (Current GDP per capita is only \$9,000.)

If the Communist Party can't deliver on those two promises, what gives it the right to monopolise political power in China? It's certainly not delivering on its old promise of equality either.

No wonder Xi Jinping is battening down the hatches politically, and no wonder the nomenklatura (to use the old Soviet word) are going along with it. Stagnation awaits.

# **Computer model predicts Omicron to** increase transmission, immune escape

Mutations in Omicron can strengthen the affinity of the coronavirus variant for the human cells, which could increase its infectivity and evasion of antibodies, according to researchers.

The scientists from Boston College in the US developed a computer model that can predict mutations in the SARS-CoV-2 virus, and provide insights into future variants of concern before they emerge.

The team used the model to develop an initial set of predictions about the role of mutations on infectivity and immune response evasion of Omicron and other SARS-CoV-2 variants with human

"We find that Omicron has not reached its full potential to bind human host cells," said Babak Momeni, Assistant Professor at Boston College.

"We identify mutations that can strengthen the virus affinity for the human cell, which could increase infectivity and evasion of antibodies," said Momeni, lead researcher on the project.

The Omicron variant of the coronavirus is suspected to be the most infectious yet by binding to human receptors better than the Delta variant.

The yet-to-be peerreviewed research posted on the preprint repository bioRxiv found that Omicron may have the potential to continue to evolve even stronger binding to increase transmission and infectivity.

The spike protein of the coronavirus binds to a receptor on the host cells, called ACE2, which allows the virus to enter the cells and infect it.

Binding is the first step for infection, and several mutations in previous variants of concern have been shown to be important for increasing the spike's binding to human

"We use a fully quantum mechanical model to theoretically assess how different mutations in the spike can contribute to its increased, or decreased, binding strength to human ACE2," said Momeni.

"The modelling shows that Omicron binds to receptor proteins stronger than the Delta variant," he said.

The model predicts what mutations allow better binding to host receptors and better evasion of antibodies, the researchers said.Such mutations can potentially lead to a future variant of concern, they

"Having this knowledge from our model would help with readiness for detecting and preventing, as well as treating, emerging and future variants," Momeni added. He, however, cautioned that increased infectivity is only one impor-

aspect in variants of concern. It is also important to monitor the severity of symptoms and the ability of the variant to evade antibodies and vaccines, the researcher said.

The study found that Omicron's spike proteins bind better than the Delta variant to the human ACE2 receptor.

However, not all muta-

tions in the spike protein's targeting system -- known as a receptor binding domain -are beneficial for binding.

This suggests factors other than binding may also be involved in determining how the variant evolves.

One possible explanation is that the variant has acquired mutations to evade host antibodies, Momeni said. Such mutations can be detrimental to its binding to the host receptor and were followed by additional compensatory mutations to recover, or even improve, its receptor binding.

# US urges COVID boosters starting at age 12 to fight omicron

The U.S. is urging that everyone 12 and older get a COVID-19 booster as soon as they're eligible, to help fight back the hugely contagious omicron mutant that's ripping through the country.

Boosters already were encouraged for all Americans 16 and older, but Wednesday the Centers for Disease Control and Prevention endorsed an extra Pfizer shot for younger teens — those 12 to 15 — and strengthened its recommendation that 16- and 17-year-

It is critical that we protect our children and teens from COVID-19 infection and the complications of severe disease," Dr. Rochelle Walensky, the CDC's director, said in a statement Wednesday night. 'This booster dose will

provide optimized protection against COVID-19 and the Omicron variant. I encourage all parents to keep their children up to date with CDC's COVID-19 vaccine recommendations," she said. Vaccines still offer strong protection against serious illness from any type of COVID-19, including omicron — what experts say is their most important benefit. But the newest mutant can slip past a layer of the vacprotection to cause milder infections. Studies show a booster dose at least temporarily revs up virus-fighting antibodies to levels that offer best chance at avoiding symptomatic infection, even from omicron. Earlier Wednesday, the CDC's independent scientific advisers wrestled with

whether a booster should be an

option for younger teens, who tend not to get as sick from COVID-19 as adults, or more strongly recommended.

Giving teens a booster for a temporary jump in protection against infections is like playing whack-a-mole, cautioned CDC adviser Dr. Sarah Long of Drexel University. But she said extra shot was worth it to help push back the omicron mutant and shield kids from missed school and other problems that come with even a very mild case of COVID-19. More important, if a child with a mild infection spreads it to a more vulnerable parent or grandparent who then dies, the impact "is absolutely crushing," said panelist Dr. Camille Kotton of Massachusetts General Hospital.

"Let's whack this one down," agreed Dr. Jamie Loehr of Cayuga Family Medicine in Ithaca, New York. The vaccine made by Pfizer and its partner BioNTech is only option for American children of any age The CDC says about 13.5 million children ages 12 to 17 slightly more than half of that age group — have received two Pfizer shots. Boosters were opened to 16- and 17-year-olds last month.

Wednesday's decision means about 5 million of younger teens who had their last shot in spring are eligible for a booster right away. New U.S. guidelines say anyone who received two Pfizer vaccinations and is eligible for a booster can get it five months after their last shot, rather than six months previously recom-

### **China lashes** out at America over support for Lithuania

China lashed out at United States on Thursday over its support for European nation of Lithuania in its feud with Beijing over relations with Taiwan. Foreign Ministry spokesperson Wang Wenbin said Washington was using Baltic state to "use Taiwan to contain China."

The US side has defended Lithuania's erroneous act of creating 'one China, one Taiwan, and attempted to put together a small clique condoning Taiwan independence forces," Wang said at a daily briefing. His remarks came after top US and German diplomats on Wednesday said Chinese pressure against Lithuania was unwarranted.

Lithuania broke with diplomatic custom last year by letting Taiwanese office in Vilnius bear the name Taiwan, instead of Chinese Taipei, which most other countries use to avoid

offending Beijing. China considers Taiwan part of its territory with no right to diplomatic recognition, and Lithuania's move infuriated Beijing, which withdrew its ambassador to Vilnius and expelled Lithuanian ambassador to Beijing. Lithuania has since closed its embassy in Beijing. Constant Chinese pressure has reduced number of Taiwan's formal diplomatic allies to just 14, although it has robust informal relations with U.S., Germany and most other major nations.

Lithuania, a country of 2.8 million people, is a member of European Union and NATO and a close U.S. ally. Wang also blasted Taiwan's move to create a \$200 million investment fund for Lithuania to offset China's economic reprisals as "dollar diplomacy," adding that "soliciting foreign support to Taiwan independence will only lead to

# Australia, Japan sign defense pact as China concerns loom

The leaders of Japan and Australia signed a "landmark" defense agreement Thursday that allows closer cooperation between their militaries and stands as a rebuke to China's growing assertiveness in the Indo-Pacific region.

Australian Prime Minister Scott Morrison and Japanese Prime Minister Fumio Kishida met in a virtual summit to sign the Reciprocal Access Agreement, the first such defense pact signed by Japan with any country other than the United States.

The agreement follows more than a year of talks between Japan and Australia aimed at breaking down legal barriers to allow the troops of one country to enter the other for training and other purpos-

**Dozens of** protesters, 12 police dead in Kazakhstan stir

AP MOSCOW

ecurity forces killed dozens of protesters and 12 police died during extraordinarily violent demonstrations in Kazakhstan that saw government buildings stormed and said ablaze, authorities said Thursday. One police officer was found beheaded in escalating unrest that poses a growing challenge to authoritarian rule in the Central Asian

nation. Despite the severe response by authorities, protesters took the streets again in the country's largest city, Almaty, a day after breaking into the presidential residence and the mayor's office there. Police were out in force again, including in the capital of Nur-Sultan, which was reportedly quiet, and Russian troops were on their way.

Russia's Sputnik news service reported that shots were fired as police surrounded one group of about 200 protesters in the city. So far, 2,000 people have been arrested, the Interior Ministry said.

In the unrest on Wednesday, "dozens of attack-ers were liquidated," police spokeswoman Saltanat Azirbek told state news channel Khabar-24, using a term common to describe the killing of people thought to be extremists by law enforcement. Twelve police officers were killed in the unrest and 353 injured, according to city officials cited by the channel.

Tens of thousands of people, some reportedly carrying clubs and shields, have taken to the streets in recent days in the worst protests the country has seen since gaining independence from the Soviet Union three decades ago. Although the demonstrations began over a near-doubling of prices for a type of vehicle fuel.

BEIJING: China has recommitted itself to completing its orbiting space station by end of year and says it is planning more than 40 launches for 2022, putting it roughly level with United States. ant has since spread around the world, causing record daily cases in the United States and parts of Europe. French Prime Minister Jean Castex said Thursday that omicron is now estimated to represent 70% to 80% of all infections in France.

France, which has one of Europe's most-vaccinated populations, reported more than 332,000 new virus cases on Wednesday. The number set a European record for the highest single-day national count of confirmed cases.

# HC junks Swamy's plea seeking to set aside Air India disinvestment process

The Delhi High Court on Thursday dismissed BJP leader Subramanian Swamy's plea seeking to set aside the Air India disinvestment process on the allegation that the methodology adopted by the government in the valuation of the national carrier was "arbitrary, illegal and against public interest". The order was passed by a bench of Chief Justice D N Patel and Justice Jyoti Singh.

Swamy has sought to set aside and revoke any action or decision or grant of any further approvals, permissions or permits by authorities with respect to the Air India disinvestment process. On January 4, the court heard the arguments put forward by Swamy, Solicitor General Tushar Mehta and senior advocate Harish Salve, who appeared in the matter on behalf of Talace Private Limited, and had reserved the order.

Swamy also sought a CBI investigation into the role and functioning of authorities and the submission of a detailed report before the court. Reacting to the Judgment, Swamy later said that he will approach Supreme Court after studying the Delhi High Court's order.

### FinMin releases 10th installment of revenue deficit grant to States

New Delhi: The Finance Ministry on Thursday released monthly revenue deficit grant to 17 States totalling ₹ 9,871 So far, an amount of ₹98,710 crore has been released to 17 states as post devolution revenue deficit grant in the current financial year.

'The Department of Expenditure today released monthly Post Devolution Revenue Deficit (PDRD) grant of ₹9,871 crore to 17 states. This was the 10th instalment of the PDRD grant released to the states," the ministry said in a statement.

States which received this grant are Andhra Pradesh Assam, Haryana, Himachal Pradesh, Karnataka, Kerala, Manipur, Meghalaya, Mizoram, Nagaland, Punjab, Rajasthan, Sikkim, Tamil Nadu, Tripura, Uttarakhand and West Bengal. The grants are released as per the recommendations of the 15th Finance Commission in monthly installments to meet the gap in revenue accounts of states post devolution. The Commission has recommended this grant to 17 states during 2021-22.

The eligibility of states to receive this grant and the quantum of grant was decided by the Commission based on the gap between assessment of revenue and expenditure of the state after taking into account the assessed devo-

# DPIIT to come out with revised FDI policy to facilitate LIC disinvestment: Secv

New Delhi: The commerce and industry ministry is making changes in the foreign direct investment (FDI) policy to facilitate disinvestment of the country's largest insurer LIC, after taking views from the finance ministry, a top government official said on Thursday. Anurag Jain, secretary in

the Department for Promotion of Industry and Internal Trade (DPIIT), said the current policy related to the sector will not facilitate the disinvestment process of LIC and, hence, needs to be revised. "We are working on fur-

ther simplification of the FDI policy. A very important point for further simplification is required urgently as we have to do the LIC disinvestment. So, we would be coming out with a revised FDI policy which will facilitate LIC disinvestment," he told reporters here.

The matter is being discussed with the Department of Financial Services and Department of Investment and Public Asset Management (DIPAM). 'We have had two rounds of discussions at my level and now, we have (DPIIT, DFS and DIPAM) come on the same page. So, we are in the process of drafting

those changes in the FDI policy. We will go to the Cabinet (for approval), " he said. According to the current FDI policy, 74 per cent foreign investment is permitted under the automatic route in the insurance sector. However, these rules do not apply to the Life Insurance Corporation of India (LIC), which is administered through a separate LIC

As per Sebi rules, both FPI and FDI are permitted under public offer. However, sources said that since the LIC Act has no provision for foreign investments, there is a need to align the proposed LIC IPO with Sebi norms regarding foreign investor participation.

The Cabinet had in July last year approved the initial public offering (IPO) of LIC and the stake sale is being planned in the current March quarter. Further, talking about the

long-pending e-commerce policy, the secretary said the DPIIT is in the final stages of "giving touches" to the e-commerce policy and the national retail trade policy. The e-commerce policy "is

finalised at my level and we have circulated that to other departments. Now we will have a higher level discussion... We will have discussions with departments on that and then we will finalise it ... A lot of work has been done", he said. He added that FDI is allowed

# A CONTEMPORARY FOOD JOURNEY

Saimi Sattar samples the new menu at the Farzi Cafe and discovers old favourites with a twist

odern Indian cuisine, as a food genre has been having Lits moment in the sun for quite some time. From fine dining, it has now graduated to a bistro format. And Zorawar Kalra's Farzi Cafe was one of the first ones off the block which attempted to bring a more contemporary version of the country's food and make it a preferred choice for a generation that was equally at home digging into a pizza as a makki ki roti sarson da saag. So the aim here is to create an amalgamation of traditional global cuisine, with Indian influences, contemporary presentations, culinary styles and ambience.

The bistro has recently introduced a new menu that takes you on a culinary journey of traditional cuisine from different parts of the country in a contemporary version. So, you could dig into a Sweet potato chat with foam chutney and wafer on top or have a Mutton galouti kebab wrapped in a blanched sheermal (yes, you read that right).

So, we headed to the Connaught Place outlet of the restaurant to find out what the fuss was all about. The place, done primarily in wood with warm lights, had an inviting hue. We settled down strategically in a place that was not likely to see too many foot-falls and glanced around apprecia-tively at a set-up that was clearly for live performances loaded as it was with musical instruments. But that

was the ambience.
Coming to the food, the *amuse*bouche arrived with enough drama to catch our attention. A thick nitrogen fog poured out from a basin and when it cleared a bit, it revealed two small vessels containing Mishti doi sphere with strawberry reduction. Eaten in one slurp, the taste was tantalising enough to almost make me ask for a second round but we decided to let Chef Jagdeep Rana take charge of the meal rather than being swayed by

The chef suggested that we try a few starters and since these have become my second-favourite part of the meal, after dessert, I was more than willing. While we waited for the food, we sipped on to our mocktails, Farzi OK and Litchi panna desire. Despite the first being a signature drink, it was the latter that found favour among both of us. But soon enough, plates in dif-

ferent shapes and sizes bearing food made their way to the table. The Sweet potato chaat, chutnev foam and crisp wafer replicated the street side delight where the chutney foam and the wafer added a contemporary twist. The Jaitooni paneer tikka, keeper's raita was succulent but what made it truly stand out was that none of the flavours was overpowering. The blend







was not smothered by that of the spices. The Rock prawns. thecha, pepper and peanuts used the coarsey pounded Maharashtrian condiment with green chillies and garlic in a presentation that looked absolutely modern. Biting in, the familiar flavour of thecha kicked in and we realised that it could go as well with the prawns as bhakri (millet flatbread).

We moved on to something more hearty and a Mutton galouti, sheermal cannelloni was waiting for us. While the *galouti* was tender, just the way it should be, for some-



write a thesis on the finer nuances of sheermal variants served in Lucknow, Kanpur and what masquerades as one in Delhi, the cannelloni did not quite make the cut – more cannelloni than sheermal. It was a watered-down version of the much-loved bread. The Chicken candy, gondhoraj sauce with a dip that was reminiscent of butter chicken gravy was really filling and we could hardly finish even one. The hint of lemon, so popular in Bengali cooking added a whiff of freshness to the dish.

Moving to the main course, we

ajwaini lacha paratha which was spectacular. The balance of flavour and the mushrooms cooked to perfection ensured that we wiped the bowl clean. The Prawn Alleppey curry, steam rice was equally flavoursome. A little tart flavour which was offset by the slightly sweet taste of the coconut perfectly complemented the prawns.

The Yuzu malai, pistachio crumb was a fitting finale to the meal. The creamy texture tickled the taste buds while the citrusy flavour gave it a fresh blast.

We returned with our tummies

Albert Camus, one of my favourite philosophers, had once said, "In the depth of winter I finally learned that there was in me an invincible summer."

That could, in brief, summarise my visit to the Hungarian Wine festival at The Claridges this winter. During the cold wind, when everyone donned woolen coats and boots, with glasses of wine to warm their insides, it was an evening to be remembered. I found a summer within myself that day.

As I entered the premises, the aroma of the wine tingled the senses. It was fresh and fascinating.

People have often talked about the four S's in wine-tasting swirl, sniff, sip and spit, and, forgive me, I've never been able to abide by it, especially the last part!

The fine collection of wine at the Claridges garden, from Tokaj, Somlo Villan and Szekszard Hungary, was arranged in a circular placement of a buffet-styled

The white wine's peculiar taste complemented the cheese and the charcuterie, which comprised the Milano salami, Parma ham, Chicken mortadella, and so on, along with some condiments. The selection of cheese was extravagant - from edam, emmental to gruyere and smoked scarmoza.

I tried the Chicken mortadella slices, with focaccia bread, which tasted very similar to salami — the right balance between lightness and taste. It was pleasant. Riesling, paired with the cold meat and cheese, made for a heavenly combination. The ham, however, was moist and sweet and salty at the same time, not so much to my taste.

As I moved ahead, happy with the appetisers, to the second menu, an enthusiastic white guy was pointing to a map and explaining which wine had come from which part of Hungary. I stood there, engrossed in the conversation for a while. "The sweet wine you're drinking," he paused to point at a man with a glass of Barta, "is from Hegyalja, one of the seven larger wine regions of Hungary," he said.

The red wine was light bodied, which went well with the grills, sea food and meat. I went with the Tundertane, blended with merlot and kekfrankos. T'was fruity in taste. Along with it, I'd picked up the

spicy but loaded with flavour. It had a mature taste on the tongue. I sensed red currents in the wine, some cherry, and perhaps, cranberry. Overall, it was easy wine.

Talking with Chef Vivek Rana about the experience, he shared, "Wine-tasting is all about savour-ing the taste. You close your eyes and listen to your senses. Listen to what they are telling you."

"Today's journey is well-planned. Why cheese or charcuterie goes along with white wine is because the fat on the charcuterie is cut down by the acidity in the white wine or Riesling. Similarly, the light bodied wine is balanced with grill fish and grill lamb, whereas, the full bodied wine marry well

sweet wine for the dessert," he explained.

Sure enough, finally, the heavy bodied wine, Rhapsody, of the thrid menu was rich and had a more complex flavour, which augmented the taste of food in the main course. Tarty and slightly sour, the drink would trickle down the throat and create a chill-effect. I chose roasted fish with barbeque sauce, which made for a great companion. The tannin in the wine compensated with the richness of the red meat. The end of the journey held the

best surprise. The dessert wine was sweet and gelled amazingly with the warm Chocolate and walnut brownie or just as much with the Apple In a conversation with Andras

Laszlo Kiraly, the ambassador of Hungary, he expressed, "We want people to have a great evening because they deserve it. After all the suffering and neglect, it is time for the people of Delhi to have a relaxing evening."

### WHAT YOU NEED

- Spring onions: 1 tsp
- Chopped red chillies: ½ tsp Sliced/
- quartered mushrooms: 1
- Pitted Chilean
- cherries: 1 cup
- Olive oil Salt and pepper to taste
- Coriander powder: ½ tsp Cumin

If Aiden Markram and Keegan Petersen gave him good support on the third day, Rassie Van der Dussen (40), with an 82-run stand, ensured victory on a rain-soaked fourth day marking an inauspicious start to India captaincy for KL Rahul, who is supposed to be groomed for future leadership.

Elgar had soaked in all the pressure and hostility in the third evening, which had literally blunted the Indian attack and Mohammed Siraj's injury in a tricky chase became a huge factor.

The Proteas skipper had taken a couple of blows on the head, a few on the chest, another few on the knuckle, one on the shoulder, all of which were like badges of honour for a batter who conforms more with "Shivanarine Chanderpaul School of Batsmanship" rather than Brian Lara's.

# Novak Djokovic denied entry to Australia, has visa cancelled

**AP** ■ BRISBANE (AUS)

Novak Djokovic's chance to play for a 10th Australian Open title was thrown into limbo Thursday when the country denied him entry and cancelled his visa because he failed to meet the requirements for an exemption to COVID-19 vaccination rules.

The top-ranked Djokovic announced on social media Tuesday and landed in Australia late Wednesday after receiving a medical exemption from the Victoria state government that would shield him from the strict vaccination regulations in place for this year's first major tennis tournament.

But border authorities did not accept the exemption. The Australian Border Force issued a statement saying Djokovic failed to meet entry requirements.

"The rule is very clear," Prime Minister Scott Morrison told a news conference Thursday. "You need to

have a medical exemption. He didn't have a valid medical exemption. We make the call at the border, and that's where it's enforced."

Health Minister Greg Hunt said the visa cancellation followed a review of Djokovic's medical exemption by border officials who looked "at the integrity and the evidence behind it."

He said Djokovic was free to appeal the decision, "but if a visa is cancelled, somebody will have to leave the country."

The president of Djokovic's native Serbia's blasted the "harassment" of the star, who was detained overnight at Melbourne Tullamarine Airport. The 20-time major winner had to wait more than eight hours at the airport to find out if he would be allowed into

egal action. Morrison confirmed the cancellation in a Twitter post: "Rules are rules, especially when it comes to our borders. No one is above these rules. Among those who were appointed in France 2019 are referees Casey Reibelt and Kate Jacewicz of Australia, China's Qin Liang and Japan's Yoshimi Yamashita and



assistant referees Fang Yan of China, Makoto Bozono and Naomi Teshirogi of Japan and Kim Kyoung-min and Lee Seulgi of Korea Republic.

Kim will be among the most experienced match officials as she is poised for her sixth straight appearance in the AFC Women's Asian Cup followed by her compatriot Lee in what will be her fourth appointment in the tournament.

The trio of Yamashita, Bozono and Teshirogi, who made history as the first allfemale referee team to take charge of a men's club competition in the AFC Cup in 2019, will also play their part in the Asian

Cup.

This contingent of match officials includes three Indians - Ranjita Devi Tekcham (Referee), Fernandes Uvena (Assistant Referee) and Rebello Maria Piedade (Technical Instructor).

Meanwhile, Video Assistant Referee (VAR) will makes its debut in the tournament from the quarter-finals as well as potential play-off matches.

"An additional six video match officials will be appointed to the tournament, with the system being used across two venues in Navi Mumbai and Pune," the statement

It also stated that the AFC has organised various workshops and trainings including VAR courses to ensure the highest standards of refereeing are maintained

# NIS Patiala reports 4 Covid positive cases

The third wave of the COVID-19 pandemic has **1** struck the National Institute of Sports (NIS), Patiala with the elite centre on Thursday reporting four positive cases inside its campus.

The positive cases were confirmed following 170 RT-PCR tests conducted among athletes and coaches residing inside the campus. The cases include three junior athletes and one coach. "RT-PCR tests for 170 athletes and coaches were conducted in NSNIS Patiala on Tuesday as part of SAI COVID SOP. Results have revealed that three junior athletes and one coach are COVID positive," the Sports Authority of India (SAI) said in a statement. "All four are symptomatic and have been isolated as per SOP." "There are no positive cases among national campers and their training is continuing unhindered inside a bio-bubble." A SAI official also said that the elite athletes are in a completely different bio-bubble and have no link with the junior athletes or the outside world. The official revealed that besides athletes, NIS Patiala also reported some positive cases among a few students of its academic courses, but they leave outside the campus and has no connection with its campers.

# Chelsea gifted goals by Spurs to gain 2-0 cup semifinal lead

With Tottenham's defenders giving away easy goals, Chelsea could restore tranquility while easing

There were no Chelsea players around Tottenham duo Japhet Tanganga and Ben Davies as they combined comically to gift the hosts a second goal. Tanganga's attempt at a headed clearance came off the shoulder of Davies and past their own goalkeeper, Hugo Lloris.

"We try to improve the personality, try to make less mistakes during the game," Conte said.

"Don't lose stupid balls. This is part of a process and I repeat — I want to be very clear - in these games that we played since I was in charge, if you analyze the games, we



struggle."
There's still a second leg to turn it around next Wednesday back on Tottenham's home field. But the trip to west London on Wednesday, two months into Conte's reign, reinforced the need to rebuild a team that is without a title since the 2008 League Cup.

"This type of game can show us the difference, the gap," Conte said. "We struggled a lot and they showed to be much stronger than us.

For sure, we are disappointed." Collecting trophies — as Conte did in the Premier League and FA Cup — is familiar territory for reigning European champion

Chelsea. So is the occasional off-field distraction.

Lukaku's outburst in an interview aired last week, where he said he was unhappy with how he's being used by Tuchel, led to the club's record signing being dropped for Sunday's Premier League draw against Liverpool.

Restored to the team after apologizing, the Belgium striker had a quiet first half with few touches until having a chance to head in a third before the break. In the second half, he managed a tame shot at Lloris. Most significantly, there was no sense of any dissent against him from Chelsea's own fans.
