Lull before Covid storm: Experts

Country sees 1.79 lakh fresh Covid cases, 146 deaths; likely to witness massive spike

PNS ■ NEW DELHI

 $F^{\text{or the first time since the}}_{\text{third Covid-19 wave hit the}}$ country, the number of daily cases has shown a decline in several States such as Maharashtra, Delhi, Karnataka, West Bengal and Gujarat among others. However, experts feel that cases will again spike on Tuesday as Monday's report was the outcome of lowest testing on week-

The country recorded 1,79,723 new coronavirus cases on Monday, raising the tally to 3.57 crore. This included 4,033 cases of Omicron variant reported across 27 States and Union Territories.

The country reported 146 deaths linked to the virus. The steep rise in the past week was primarily due to the case surge in urban centres such as Mumbai, Delhi, Kolkata, Bengaluru, and Chennai.

On Monday, Delhi saw a dip reporting 19,166 cases during the last 24 hours. The national Capital reported 22,751 cases in the last 24 hours. The positivity rate in Delhi stood at 25 per cent, the highest since May 5. The city also reported 17 deaths. There are currently 65,806

active Covid patients in the Capital, the highest since May 15. As many as 44,028 patients are in home-isolation and the recovery rate stands at 94.20 per cent. Around 14,076 patients were discharged in the past 24 hours.

Mumbai saw a dip in coro-navirus cases for the third day running recording 13,648 cases on Monday. This is around 30 per cent lower than Sunday's count. But the positivity rate stood at a very high at 23 per cent. Mumbai on Monday reported 13,648 new Covid-19 cases, around 30 per cent or 5,826 less cases than the previous day count. The city's tally of infections now stands at 9,28,220 and the death toll at

Maharashtra on Monday reported 33,470 new Covid-19 cases, which is nearly 11,000 lower than the previous day

West Bengal recorded around 19,286 cases on Monday, lower than Sunday's number of 24,000 plus cases. The State saw 8,187 recoveries and 16 deaths.

Karnatala case count also came down slightly from 12,000 plus cases on Sunday to 11,698 new cases and 4 deaths in the last 24 hours. Karnataka Chief Minister M Basavaraj Bommai also tested positive for Covid-19 "with mild symptoms". But daily cases increased slightly in Tamil Nadu from 12,000 plus on Sunday to 13,990 new cases, 2,547 recoveries, and 11 deaths, in the last 24 hours. Active cases stood at

Gujarat reports 6,097 new Covid cases and 2 deaths in 24

Concerned at the rising cases, Union Health Minister Dr Mansukh Mandaviya in a meeting with health ministers of five States and one UT asked them not to drop their guard. "Let there be no lapses in our preparedness as we battle this surge of the pandemic. Holistic synergy between Centre and States is most vital for seamless and effective pandemic management," he said.

Covid 'precaution shots' start for priority groups

Battling a spike in Covid pushed by the Omicron variant of the coronavirus, India on Monday kicked off the drive to give late booster doses called "precaution shots" of the Covid-19 vaccine to priority groups. Health and frontline workers and citizens above 60 years old with comorbidities are currently eligible to take the jab.

There is no need for a new registration on CoWIN platform for those eligible for the precautionary or the third dose

of the Covid-19 vaccine. The portal has sent over one crore reminder messages to the beneficiaries to get the precaution dose, said a senior official from the Union Health Ministry.

Notably, the precaution dose can only be taken after 39 weeks (from the date of administration of 2nd dose).

The Ministry has recommended that the precaution dose for healthcare workers, frontline workers, and senior citizens with co-morbidities will be the same as given pre-

SC to form panel to probe Modi's security breach

Court stays enquiries by two different panels set up by Centre, Punjab

PNS NEW DELHI

A mid bickering between the Centre and the Punjab Government, the Supreme Court on Monday said it would set up a panel headed by its former judge to probe the security breach during Prime Minister Narendra Modi's visit. The top court also stayed the parallel inquiries by the committees set up by the Centre and the State Government into the lapses.

"We are thinking on these lines... One retired Supreme Court judge will head the committee and the members would be DGP (Director-General of Police) of Chandigarh, the Inspector-General of the NIA (National Investigation Agency), the Registrar-General of the Punjab and Haryana High Court and one more person from Punjab...And he can be Additional DGP (Security)," Chief Justice of India (CJI) NV Ramana observed, hinting at the broad parameters of the proposed order which will be oassed later.

Stressing that the apex

court was not "undermining the importance of the security of the Prime Minister" and was dealing with it with "all seriousness", a Bench headed by the CJI said that the separate enquiries by panels set up by the Centre and the State Government will be stayed. The Bench, comprising

Justices Surya Kant and Hima Kohli, took note of the submissions of Solicitor-General Tushar Mehta about the time frame within which the courtappointed panel should give the report and said it would keep this aspect in mind. The SC was hearing the

olea of an organisation, Lawyers Voice represented by senior lawyer Maninder Singh, seeking a thorough investigation into the breach in Modi's security to ensure there was no repeat of such an incident.

The Delhi Disaster Management Authority (DDMA) on Monday announced that restaurants and bars would remain closed for dine-in services but "take away" services would continue in the national Capital.

Lieutenantchaired by Governor Anil Baijal, it was decided that a lockdown would not be imposed in the city.

According to the minutes of the meeting, ways to strictly enforce existing restrictions to check rising cases of Covid -19 and the latest variant Omicron in the Capital were discussed.

ed at 25 per cent.

The Delhi Government has also said that the Covid-19 health infrastructure is robust in the city, with a total bed strength in city Government, MCD, private and Centre-run hospitals being 16,380 (Covid oxygenated) and 3,619 (ICU beds) till Ianuary 10 this year.

The city Government also escalation plan to deal with any contingency due to the third Covid wave. In the first stage, the city will be ready with 28,645 (Covid oxygenated beds) and 8,041 (ICU beds) in all private, State Government, and Central

NIA chargesheets four **Bangladeshis**, 1 Indian **JMB** operative in case linked to ultra's arrest

The National Investigation Agency (NIA) has chargesheeted four Bangladeshis and one Indian operative of Bangladesh-based Jamat-ul-Mujahideen Bangladesh (JMB) in connection with a case related to the arrest of a JMB terrorist in Kolkata.

The five chargesheeted accused Bangladeshi nationals are Najiur Rahman Pavel, alias Joseph, Mikail Khan alias Sekh Sabir, Rabiul Islam, alias Rabiul Isalm, Md Abdul Mannan Bachu, alias Mannan, and Indian national Lalu Sen alias Rahul

The case was originally registered as FIR No. 11/2021 dated July 10, 2021 at STF Police Station, Kolkata, in connection with hatching of criminal conspiracy by three Bangladeshi nationals who had illegally entered India along with their associates of JMB/AQIS, to recruit, motivate young Muslim youth in order to establish "Caliphate" and for the furtherance of terrorist activities in India and Bangladesh.

Suu Kyi sentenced to 4 more yrs in jail

Acourt in Myanmar sentenced ousted leader Aung San Suu Kyi to four more years in prison on Monday after finding her guilty of illegally importing and possessing walkie-talkies and violating coronavirus restrictions, a legal official said.

Suu Kyi was convicted last month on two other charges and given a four-year prison sentence, which was then halved by the head of the military-installed government. The cases are among about a dozen

brought against the 76-year-old Nobel Peace Prize laureate since the army seized power last February, ousting her elected government and arresting top members of her party. If found guilty of all the charges, she could

be sentenced to more than 100 years in prison. Suu Kyi's supporters and independent analysts say the charges against her are contrived to legitimize the military's seizure of power.

Monday's verdict in the court in the cap ital, Naypyitaw, was conveyed by a legal official who insisted on anonymity for fear of being punished by the authorities, who have restricted the release of information about Suu Kyi's trials. Continued on Page 2

Amid spike, Bombay HC asks East Pak immigrant to **HC** principal bench to work for 3 hrs/day

Will only hear urgent matter till January 28

Mumbai: Amid the surge in COVID-19 infections in the city, the principal bench of the Bombay High Court will operate only three hours on all working days beginning Tuesday and hear urgent matters till January 28, it was informed on Monday.

The new timing will be effective from January 11, a communication issued to lawyers by the Bombay Bar Council stated on Monday evening.

The HC will hear only urgent matters during this period, the HC Registrar said in a notice. "A meeting was convened with the administrative committee of the Bombay High Court today," the communication said.

"In view of the exponential rise in COVID-19 positive cases, it was decided that effective from tomorrow, viz 11.1.22 till 28.1.22, the principal bench of the Bombay High Court will operate for 3 hours from 12 noon to 3.00 pm (without lunch break) and take up urgent mat-

The NIA had re-registered the case on August 6 and took up the investigation.

They had received funds from Bangladesh through the hawala channel and also fraudulently obtained Indian identity documents including Aadhaar cards, Electoral Photo Identity Cards, PAN cards and Passports to evade detection and to conceal their illegal activities from the law enforcement agencies, it added.

BMC must ensure citizens are safe from Omicron: HC

Mumbai: The Bombay High Court on Monday said the Brihanmumbai Municipal Corporation (BMC) must not leave any stone unturned in ensuring people of the metropolis remained safe from the rapidly rising number of cases caused by the new Omicron variant of COVID-19.

A bench of Chief Justice Dipankar Datta and Justice MS Karnik directed the BMC to implement precautionary measures as well as guidelines issued by the Maharashtra government to manage Covid-related healthcare resources.

The Foreigners' Tribunal-II of the district had in May 2017 declared Paul a foreigner who came to India illegally from Bangladesh on or after March 25, 1971.

The High Court in its order said that Paul was about two years old when he entered India with his father Boloram and grandfather Chintaharan Paul on September 30, 1964 from the then East Pakistan, which became Bangladesh on March

"...They were given refugee status by the Government of

India as (is) clearly evident from the certificate issued by the Government of West Bengal to the members of the minority community in East Pakistan desiring to stay in

India," the order said. asked him to apply for citizen-ship under the Citizenship According to the petition-er, his grandfather had entered through West Bengal but thereafter settled in Assam and his name appeared in the voters' list of the state in 1966. He died

> The Tribunal also noted that the petitioner had studied upto class five in Gandhi Colony Madhyamik Vidyalaya in Kolkata and after attaining his majority was engaged in jewellery business at Jadavpur area of that city.

> ... It is on record that the petitioner came to Patharkandi, . Karimganj, Assam, only in the year 1984 and settled there and started his jewellery business," said the High Court judgement on December 14, 2021.

> The judges said that considering the evidence on record, there is no doubt that the petitioner had entered India in 1964 and thereafter stayed in Calcutta (now Kolkata) till

and settled in the state.

"The question which naturally will arise is, what will be the status of the petitioner, who had entered India in the year 1964 from East Pakistan and continued to stay in India? Is he to be declared a foreigner?" they wondered.

The two-judge bench expressed its inability to declare Paul as an Indian citizen as claimed by him as he was not born in this country but in East Pakistan, now Bangladesh, and entered India in 1964.

As to whether a person who enters India in 1964 from East Pakistan can be considered to be an Indian or not, there is no provision under the Citizenship Act, 1955 except for Sections 6A(2), the judges said.

'Under Section 6A(2) of the Citizenship Act, 1955, a person entering India before 01.01.1966 can be deemed to be a citizen provided he enters Assam from the specified territory (East Pakistan) and he has been ordinarily residing in Assam after the date of entry, bench

Assam on or before March 25, 1971 can get the benefit of citizenship if they register them-selves before the competent authority. Those who entered the state after the date will be

declared as foreigners.

The High Court said that as the petitioner did not enter Assam but West Bengal and also as he has not been a resident of Assam after his date of entry in 1964, he cannot get the benefit of deemed citizenship under Section 6A(2) of the Citizenship Act, 1955.

"Under such circumstances, the question which arises is, whether the petitioner will be declared a foreigner, in which event, he will be liable to be deported also," it

The bench then pointed to the Citizenship (Amendment) Act, 2019 (CAA), which said any person belonging to Hindu, Sikh, Buddhist, Jain, Parsi or Christian community from Afghanistan, Bangladesh or Pakistan, who entered India on or before December 31, 2014 shall not be treated as an ille-According to the Assam gal migrant.

Also, the senior citizens with co-morbidities will not be required to produce a doctor's certificate or prescription at the time of administration of the precaution dose.

The details of the administration of the precaution dose will be suitably reflected in the vaccination certificates. An estimated 1.05 crore healthcare and 1.9 crore frontline workers. and 2.75 crore comorbid people in the 60 plus age group are going to be administered the precaution dose of Covid-19

Meanwhile, the ICMR has said that contacts of confirmed Covid cases do not need to get tested unless identified as "high risk" based on age or comorbidities. The ICMR Advisory on Purposive Testing Strategy for Covid-19 said individuals undertaking inter-State domestic travels also do not need to get tested.It said testing can be undertaken either through RT-PCR, TrueNat, CBNAAT, CRISPR, RT-LAMP, Rapid Molecular Testing Systems or through Rapid Antigen Test (RAT). A positive point-of-care test [home or self-test/RAT] and molecular test is to be considered confirmatory, without any repeat testing, the advisory by the ICMR said. The ICMR advisory comes in view of sharp transmission of the virus in the community across the States which are reporting spurt in cases. Notably, the test positivity rate crossed the 10 per cent mark in the country. That is, every 100 tests now yield 10 positive cases.

Between January 4 and 8, Mumbai recorded more than 86,000 cases, a 150 per cent increase in infections compared to the week before. Delhi recorded about 68,000 new cases, a 350 percent rise. Bengaluru registered close to 24,000 cases, a 400 per cent increase. In the same period, Chennai saw 17,247 infections, a 350 per cent increase compared to the past week. With nearly 45,000 new infections, Maharashtra's active cases breach 2 lakh-mark.

Andhra Pradesh reported 1,257 COVID-19 infections and two deaths in the 24 hours ending Sunday morning. The single-day tally crossed 1,000 for the first time in 101 days since highest in the past 180 days. The number of active cases tripled in just five days from 1,848 on January 5 to 4,774 on Sunday.

The number of active cases in Bihar until January 8 was 12,311, with over 7,000 in Patna district. More than 350 doctors and medical staff in the state have tested positive, most of whom were from Nalanda Medical College and Hospital. In addition, some staff of a private airline working at the Patna airport was

In Gujarat, the case count increased by 6,275, while 1,263 patients recovered. As a result, active cases neared the 28,000 mark, of which 26 patients were on ventilator support.

unheard," the State's law officer said, urging that an independent committee be set up as he apprehended that the State officials would not get a fair hearing before the Centre's panel. "The committee's inquiries were put on hold. "Asking them to reply within 24 hours, after our order...It is not expected of you," the Bench said. "To say it is not expected of you', is a bit harsh under

With the spike of Covid-19 cases in the national Capital, around 1,000 police personnel have tested positive for Covid-19 since January 1st, 2022. Police said that those tested positive for the virus are home quarantined and recovering well.

The strength of the Delhi Police force is over 80,000.Recently, following the rise in Covid-19 cases across the city, the Delhi Police Commissioner Rakesh Asthana had issued a Standard Operating Procedure (SOPs) for preventing spread of coronavirus amongst police personnel. Since police personnel are frontline workers performing their duties amidst the public, it is imperative they take adequate precautions to protect themselves from exposure to

According to the SOPs mentioned in the order dated January 5, all police personnel should wear face-masks, maintain social distancing and practice proper hand hygiene while performing their duties. All police personnel and eligible family members who have



not been vaccinated, may be motivated to complete the vaccination process.

Those who have not been vaccinated due to medical reasons may be encouraged to seek medical opinion again for vaccination" the order said. All police personnel may be motivated to take precaution dose of Covid vaccine and install and use of Aarogya Setu App mandatorily.

Self monitoring practice to be adopted by police personnel and any kind of illness may be reported without fail, to daily health monitor-

The force was asked to go contact less and do their enquires through Video Conferencing and if a visitor came without a face mask, a face mask should be provided to him or her, the order

Around 46 inmates and staffs in national Capital's three jail complexes, Rohini, Tihar and Mandoli Prisons have tested positive for Covid-19

According to data shared by jail authorities till Sunday, 46 inmates were tested positive.
"Out of them, a maximum of 29 inmates

were from Tihar and the remaining 17 were from Mandoli jail. Staffs in Prison Complexes of Tihar, Rohinu and Mandoli have also been tested positive for Covid-19," said a senior prison official.

Overall till Sunday, 43 prison staffs were tested positive for Covid-19. Out of them 25 are from Tihar, 12 from Rohinu and six from Mandoli jail complex.

"All the infected inmates as well as staffs have been under isolation and are recovering," said the senior prison official.

As part of steps taken against the spread of the viral disease in Tihar, Mandoli and Rohini jail complexes, dispensaries in Delhi jails turned Covid care centres, oxygen plant in Tihar to start working soon, officials said.

"Many medical isolation cells have been set up for inmates showing slight symptoms of Covid-19. Those who test positive but are asymptomatic will be kept in separate isolation cells within the same jail," he said.

The 120-bed hospital in Tihar and the 48bed facility in Mandoli have been converted into Covid Health Centres with the round-the-clock presence of doctors, 50 oxygen concentrators and over 100 cylinders and essential medicines to treat patients.

The jail administration said they have formed four committees for the inmate and staff who test Covid positive.

"Each of these panels has been divided into four jurisdictions with each comprising four members, including jail staff and officers, tasked with looking after them if they need further help and guidance. All the new inmates will have to undergo quarantine for 10 days and mandatorily undergo the rapid-antigen test," said the official

Social distancing among staff and inmates is followed to the extent possible. Inmates are mostly restricted to within their wards and an educational and awareness programme about following Covid norms are carried out regularly, officials said. The total number of prisoners in all the three jails of Delhi Prisons as of January was 18,528. Tihar has a maximum of 12,669 inmates, Mandoli 4,018 and Rohini 1,841.

The inoculation status of inmates of Delhi Prisons as of December 31 was, 22,620 have been administered the vaccine of which 15,452 got the first dose and 7,168 got the second shot.

Health Min urged to allow 200 guests as wedding business takes a hit

"Please allow us to have weddings with a capacity of 200 Pax as our wedding venues are very large and can accommodate very large gatherings in a controlled and monitorable environment. Or allow us gatherings following the 4 sq ft/per person for-

Delhi Govt has no power to formulate doorstep food delivery scheme: Ration dealers tell HC

New Delhi: The Delhi government's scheme for doorstep delivery of ration cannot be sustained in law in the absence of approval from the Lieutenant Delhi High Court was told on

The Delhi Sarkari Ration Dealers Sangh (DSRDS), which has challenged the AAP government's Mukhymantri Ghar Ghar Ration Yojna, said before a bench headed by Justice Vipin Sanghi that the scheme fell foul of the law, including the National Food Security Act (NFSA). "The state government

does not have the power to make any such scheme without the concurrence of the L-G (Delhi lieutenant governor) and the central government," the DSRDS argued. It also said that any notifi-

cation pertaining to the food security law has to be mandatorily published under the signature of the L-G. On being asked if fair price shops (FPS) were ready to supply door-to-door, lawyer V Shrivastav, appearing for the petitioner, replied, "We are ready but the central government has to say yes because it is their food

The DSRDS is an association that represents FPS own-The court, which has reserved its verdict on the challenge to the scheme, also asked the Delhi government as

to how its doorstep delivery scheme was an improvement on the existing FPS model and how did it allege the present system has corruption.

whole community of FPS owners by the same brush. You are saying that they're all corrupt. What the L-G has told you is you're only basically replacing one set of persons by another. Are you suggesting that those accepting your tender are coming from an outer planet?" it

Senior advocate Abhishek Manu Singhvi, appearing for the Delhi government, said that in the new system, a contractor would lose the tender in case of misconduct, and contended that the court was not examining whether the new regime would ensure 100 per cent sanitisation.

He informed that the implementation of the scheme would be monitored by stateowned corporations, and the city government was entitled to change the system to make it "significantly better" and minimise malpractices.

FPS owners were found to be in a system which has leakages, the advocate said.

Singhvi said that the scheme was approved by the council of ministers and the law does not empower the L-G to keep referring back to the council any difference of opinion for re-con-

SC lawyers get threat calls over PM security lapse case

New Delhi: Several Supreme Court lawyers alleged on Monday that they received calls threatening judges over the case involving the security breach that left Prime Minister Narendra Modi stuck on a flyover in Punjab for 20 minutes last week.

A police complaint has been filed by lawyer Deepak Prakash over what he says were "terrifying calls" that could lead to riots. The caller threatened "extremely adverse reactions affecting national securi-ty and integrity", he alleged.

The calls were made

allegedly by a pro-Khalistan organisation Sikhs for Justice (SFJ). Many lawyers say they received an automated call at 10.40 am on Monday. The caller allegedly claimed that the SFJ group was responsible for the blockade by protesting farmers on PM Modi's route when he was travelling by road from Bathinda to Ferozepur on Wednesday. After waiting for 20 minutes for the road to clear up, the Prime Minister turned back and cancelled all his programmes..

The caller allegedly warned that the judges who heard the case "must not help PM Modi" punish Sikh farmers. They also referred to the 1984 anti-Sikh riot and accused the Supreme Court of silence on the death of Sikh farmers over the past year, during protests against three now-cancelled farm laws.

"All advocates have been receiving such threatening calls since morning, which indicate that they want to bring hatred, contempt and hostility to disrupt the government and public peace and tranquillity if the Supreme Court hears the PM security breach case," Deepak Prakash's complaint to the police said. Nikhil Jain, the treasurer of

a Supreme Court lawyers' body, said he had received a call from the number +447418365564. Vishnu Shankar Jain, a

lawyer for the Uttar Pradesh government, said he had received the calls twice. "Today,

many Supreme Court lawyers including me have received calls from a number from UK. The call specifically asked Supreme Court Judges to refrain from hearing the petition on the blockade of PM Modi's cavalcade," Mr Jain said. "This matter requires consideration. It is a very serious issue and I think the highest authority must take it up as

well," he said. Nishant Katneshwarkar, a Supreme Court lawyer who once represented the Maharashtra government, also confirmed receiving the call. He said, "In the morning I received two calls from a number in the UK. Most of the Supreme Court lawyers have received such calls

TMC's Rajya Sabha MP Derek O'Brien has written to the chairman of the Parliamentary Standing Committee on Home Affairs seeking a meeting of the panel to discuss the issue of "hijacking and manipulating" social media trends using 'Tek Fog' app which he said is a "threat" to national security and privacy of citizens.

A recent media report alleged that people associated with the ruling BJP's IT cell were purportedly using the app to take control of inactive WhatsApp accounts, send messages to frequently contacted numbers, and "hijack" trending topics on social media plat-forms. This is the second letter the TMC MP has written to Congress leader and panel head Anand Sharma for a meeting.
In his letter on Monday,

O'Brien said that the exposé shows that the Tek Fog app gives cyber troops the ability to hijack WhatsApp accounts of private citizens by sending them spyware disguised as a media file. It then remotely

accesses inactive accounts in their contact list and uses the inactive number to send targeted messages to all their contacts.

"All of the hijacked number's contacts are synced to a database on cloud, ripe for picking as future targets of disinformation and harassment... It is also pointed out that this hacking technique was formerly used by the Pegasus spyware, before the NSO Group developed an even more sophisticated zero-click hijacking method," he said.

He said that the application can automate the sending of WhatsApp messages across networks of groups, flooding the social media space with

misinformation and fake news, misleading individual citizens, and manipulating political nar-"Use of such manipulative

technology is a danger to national security and democratic rights of free speech and unfettered media, and a threat to individual citizens' privacy and safety. SFI student activist stabbed to death amid college union polls

Dheeraj, a computer science student and SFI leader in Government Engineering College, Idukki, was stabbed to death on Monday by a gang belonging to the rival KSU.

The murder occurred amidst college union election in which the CPI(M) controlled SFI and the rival KSU, the students wing of the Indian National Congress were engaged in tough fight. Though campus politics has been banned by the Kerala High Court, the government or the political parties have not taken any action to implement the verdict.

Nikhil Pylee, a Congress leader has been arrested by the Idukki Police in connection with the murder. SFI have declared a statewide agitation

on Tuesday including boycotting of classes.

College Principals and political observers are unanimous in their view that elections in campuses should not be held based on political leaning. "One has to doubt the intention of the Kerala Government not to shut down schools and colleges despite the upsurge in Covid-19 cases. On Monday, the State diagnosed 5,797 new cases and the Test Positivity Rate stood 12.6 per cent. The CPI(M) -led Kerala Government wants to establish its total control over educational institutions and universities. There is no justification for the government's decision to keep the colleges and universities opened despite the hike in Covid-19 cases," said Hari Kartha, former chief editor, Janmabhumi.

Chief Minister Pinarayi Vijayan condemned the murder of Dheeraj. "The murder of Dheeraj is reprehensible. The

government has asked the police to put their foot firmly and suppress all kinds of vio-lence. We will not allow the campuses to become killing fields," said Vijayan in his social media posti.Kodiyeri Balakrishnan, CPI(M) secretary, blamed KPCC president K Sudhakaran for the murder. "It is after he was appointed as the KPCC chief that political murders shot up in the State," Balakrishnan told reporters at the State capital.

Meanwhile, activists of the DYFI (youth wing of the CPI-M) have waylaid Sudhakaran at Malappuram where he had gone to address a camp of party workers. A KSU leader pointed out that the SFI activists themselves complained that the police refused to shift Dheeraj to the hospital despite their pleas. "There were internal issues in the SFI itself and last Friday saw they clashing among themselves," said a KSU functionary.

Michael Lobo resigns as **Goa Minister,** quits **BJP**

MLA Michael Lobo on Monday resigned from the Pramod Sawant-led Cabinet and also as member of the Legislative Assembly, ahead of the state polls scheduled next month.

The Goa BJP unit later said Lobo's move will not have any impact on the party's prospects in the state Assembly elections, to be held on February 14.

Lobo, who represented the Calangute Assembly constituency and held charge of the state port and waste management departments, submitted his resignation to the chief minister's office and the Goa Assembly's Speaker. likely to join the Congress, according to sources.

Asked whether he will join the Congress, Lobo said he is in talks with other political parties. He claimed that people were unhappy with the ruling BJP in the coastal state.

The voters told me that the BJP is no more a party of the common people," he said, while claiming that the grass-root level workers were feeling ignored by the party. However, Goa BJP presi-

Maha reeling under Covid 3rd wave: State Health Min

'33K Covid cases including 31 Omicron infections reported in State' T N RAGHUNATHA MUMBAI

Maharashtra Health Minister Rajesh Tope said here on Monday that the State had begun to reel under the third Covid-19 wave, even as 33,470 Covid-19 daily infections and 31 Omicron cases were reported from various parts of the state.

Talking to media persons here, Tope said that the state had begun to come under the grip of the Covid-19 wave and it was difficult to predict as to how long it would continue. But it was certain that the state

would reel under the third wave for the whole of January. 'The third Covid-19 wave

started. We do not know when the third wave will peak. The number of cases has gone up 44,388. The number of cases is increasing now. During the second wave, we used to record 65,000 cases every day. It is difficult to predict what would be the number of daily cases when the third wave peaks in the state. Experts are predicting that the third wave may peak by the end of this month," Tope said. Meanwhile, the daily Covid-

19 cases dropped from 44,388 on Sunday to 33,470 on Monday, taking the total number of cases recorded 69,20,044 to 69,53,514 cases. As many as 8 Covid-19 deaths were reported from various parts of the state.

Meanwhile, the State recorded 31 cases of Omicron, taking the total number of new Covid-19 variant cases to 1247 cases. All the 31 cases were reported by the National

Chemical Laboratory. As 26,671 Ćovid-19 patients were discharged from

Proud moment

INS Vikrant begins third phase of trials amid hopes of significantly improving the situation

mid the pandemic despair, pictures of INS Vikrant, India's first indigenous aircraft carrier, striding the high seas as she begins the third phase of trials, is just what the doctor ordered to revive the spirit. It will go through complex manoeuvres in various conditions. It has already established its credentials about propulsion and basic navigational operations as well as machinery and flight trials. Subject to successful completion of the trials, it will be commissioned by this August. Till now, INS Vikramaditya is the country's only operational aircraft carrier. That improves the situation a lot for the Indian Navy because even if one goes for maintenance work, the other will be functional. Vikrant's commissioning comes at the right time when India feels its maritime operational capabilities have to increase because of the growing Chinese naval presence in the Indian Ocean Region (IOR). The carrier also gives a boost to domestic manufacturing while reducing costs and increasing the navy's capacity to acquire more vessels than ever before. The navy is currently locally building around 50 warships, including survey vessels, frigates, diesel-electric submarines and nuclear-



powered ballistic missile submarines. In terms of the navy's long-term capabilities, however, Vikrant's commissioning revives afresh the military debate: Does India need a third aircraft carrier? The navy wants the third carrier. China is on the verge of commissioning its third carrier while a fourth one is on the drawing board. The force development programmes of India and China revolve around carriers.

The navy has plans for a third IAC Vikrant-class carrier but former Chief of Defence Staff, the late General Bipin Rawat, had said last year that India should prioritise submarines over a third carrier. The

navy's acquisition programme has to be based on its assessment of growing risk in the Indian Ocean Region. It requires maritime assets to tailor its sea control or sea denial policies. Submarines are an effective tool for the latter. However, the navy has its logic that favours carriers. It is simply that shore-based naval operations are limited by range. The IOR practically covers a vast expanse, the entire Indian Ocean, from the Strait of Hormuz to Reunion Island, from East Africa to Australia, and from Lombok Strait to Malacca Strait. Strike aircraft operating from the mainland cannot effectively cover the vast region entirely. That is where the aircraft carriers come into play. Two, carrier groups coupled with nuclear submarines are required to maintain 24x7 operational readiness given the increasing Chinese entry into the IOR. China is developing maritime outposts in the region, commissioning long-range vessels to protect its sea lanes of communication and launching joint exercises with Pakistan. Three, given the evolving geopolitics of IOR, safeguarding maritime interests will mean developing Carrier Battle Groups to project power and be able to have room for manoeuvre in the vast IOR area of operations. Aircraft carriers become central, even inevitable, in such a situation.



New threat

Compounding matters, a new strain combining Delta and Omicron has been found in Cyprus

here seem to be no happy tidings on the Coronavirus front, in fact all developments point to the contrary. Even as the nation recorded a single-day surge of 1.6 lakh new cases and Prime Minister Narendra Modi held a meeting to review the situation on Sunday, there were reports that Uttar Pradesh, West Bengal, Karnataka, Tamil Nadu and Kerala were leading the pack though Maharashtra received some respite. Meanwhile, ICMR chief Balram Bhargava said COVID antiviral drug, Molnupiravir, has major safety concerns and has not been included in the national protocol for treatment of Coronavirus, adding that the World Health Organisation (WHO) and the UK



have not included it for treatment. However, as if the existing mutations weren't enough headache for the Governments and peoples the world over, a professor of biological sciences in Cyprus has now claimed that a new strain of SARS-CoV-2 that combines the features of Delta and Omicron has been found in his country. Leondios Kostrikis, of the University of Cyprus and head of the Laboratory of Biotechnology and Molecular Virology, was quoted as saying: "There currently are Omicron and Delta co-infections and we found this strain to be a combination of these two. The discovery has been named Deltacron."

However, to the optimist, the outlook isn't all bleak. There is a ray of sunshine in the words of top US-based Israeli scientist Afshine Emrani, MD. His take, while at no point advocating the lowering of safety precautions, is that Omicron is literally the 'vaccine' pharma companies across the world could not make. "It is attenuated. Almost no hospitalisations. No critical patients. No oxygenation. No intubation. Everyone will be exposed and will get it. Mass herd immunity. Totally replaces Delta. Within 8-12 weeks, the world will be 'vaccinated'. Why the panic? It could've been a lot worse. Show gratitude to nature for finally eliminating a manmade, lab-leaked nasty virus! We are blessed," he tweeted recently. He went so far as to make a case against the restrictions imposed by the US Government in the wake of Omicron, saying: "Our Government's reaction will be more harmful than the virus itself." It is true that nobody can pierce through the heart of future and, therefore, fingers crossed! The earthlings have truly become sick of the pernicious virus and its sundry variants. May what Emrani says come true, and quickly!

A third term for Pak Army chief?



The proclivity of Pak Generals to overstay their tenures in office, vis-à-vis the professional transition in the Indian Army, is a study in contrasts

he British Indian Army was the common progenitor of the Armed Forces of independent India and Pakistan before its decommissioning in 1947. Inherited structures, ethos and templates ensured a common operating framework between the forces. Both forces had British Commanders-in-Chief manning the post-Independence transition till a native officer was appointed, Field Marshal KM Cariappa OBE in 1949, and Field Marshal Muhammad Ayub Khan in 1951, respectively. Both armies changed its leadership nomenclature to Chief of Army Staff (COAS), as first tenured by General Maharaja Rajendra Singhji Jadeja in 1955, and by General Tikka Khan in 1972. Irrespective of nomenclatures, military chiefs in Pakistan started assuming a larger ambition than what was mandated in the Constitution, and the rot had started with its first chief and later Field Marshal Ayub Khan (promoted himself to Field Marshal

The proclivity of Pakistani Generals to overstay their mandated tenures in office, vis-à-vis the smooth and professional transition in the Indian Army, is a study in contrasts. Since Independence, combining the posts of Commanders-in-Chief and Chief of Army Staffs for both militaries, there have been 28 incumbents to date in India, and exactly half in Pakistan put simply, many in Pakistan chose to extend their stay and some even decided to také over the country as Chief Martial Law Administrators, Chief Executives and Presidents! This usurpation and perpetuation of power by Pakistani Generals is not a practice of the past, but a continuing trend, with three of the last four COAS extending their tenures, including the serving Pakistani COAS, Gen Oamar Baiwa, Prior to him, Gen Pervez Kayani and Gen Pervez Musharraf had done the same, while the ostensibly odd honourable exception, Gen Raheel Sharif Janjua, may not have extended his term in kawaipindi GHQ, but is currently the Commander-in-Chief of another 'non-threatening' the Islamic Counter-Terrorism Coalition, a 41-nation alliance of



Muslim nations based out of Saudi Arabia. Personal preferences and

misplaced perceptions of 'loyalty amongst the ruling politicians, instead of seniority or professional competence, have played a predominant role in selection of most chiefs in Pakistan, and this corrosion had started with the selection of the first chief, Gen Ayub Khan. Wrongly believed to be 'loyal' and least ambitious, Pakistan's then Defence Secretary (later President) Iskandar Mirza had prevailed upon Prime Minister Liaquat Ali Khan to appoint the juniormost Maj Ĝen Ayub Khan (who was not even in the list of four senior officers, nominated for the first native Commander-in-Chief). Soon, in a pattern that would get virtually institutionalised, the out-of-turn selected Generals would invariably turn on their political mentors and, in this case, Ayub Khan deposed Iskandar Mirza to exile. Later, another ostensibly 'loyal', pli-ant and non-threatening Mohajir (émigré from India) Gen Zia-ul-Haq, who too superseded seven senior Lt Gens, sent his political godfather ie, PM Zulfiqar Ali Bhutto, to the gallows. In a repeat of the misiaid assumption of yet Mohajir (in Punjabi-Pathan dominated Army), PM Nawaz

Sharif was to appoint Gen Pervez Musharraf, who too had superseded two senior officers to become the COAS only to then bump off Nawaz Sharif in a coup d'état.

Nawaz had a particularly unlucky record in inheriting or 'handpicking' all six chiefs, who tenured along him. His first choice in 1993 of Gen Waheed Kakar was instrumental in forcing Nawaz to resign. In his second coming as PM, Nawaz forced Gen Jehangir Karamat into premature retirement. The third was his famously rocky equation with Gen Musharraf. In his third tenure as PM, Nawaz saw Gen Pervez Kayani unilaterally extending his tenure, and his next 'handpicked' Gen Raheel Sharif too became his own man by giving sleepless nights of possibly extending term, which he finally didn't. Interestingly, the current COAS, Qamar Bajwa, was the last of Nawaz's choices (after superseding three others), who too ultimately allowed Nawaz to get disqualified from contesting and is credibly believed to have thrown his institutional weight in getting Imran Khan's PTI elected.

Now, having secured a three-year extension from the P11 Government, it is time for for completion in November.

The Pakistani Army has had multiple fissures with Imran's Government in recent times, including appointment to the sensitive post of DG ISI. Trial balloons of the augury were the pointed questions of extending Gen Bajwa's term for the third time to both, Imran Khan and Army spokesperson, DG ISPR, recently. In the Pakistani game of thrones, the timing of this loaded question is neither coincidental nor innocent. Adding invariable spice to the risqué question of 'extension' were straight-faced queries of a possible 'deal' with the Opposition PML-N. Both Imran and the DG ISPR denied any knowledge or concern, but the murky Pakistani history and evolving dynamics would suggest otherwise. The Pakistani military has always tactically counterbal-anced parties without any ideological or personal affiliations and, as the one-time beneficiary of that institutional preference, Imran would know better than to feel comfortable now. Triggered chorus for Gen Bajwa's third term has started, so have unsubtle pressures — eyes are

Space transport becoming an industrial-scale operation like road transport was back then



t will be a bumper year for big space launches to the Moon, Mars, and asteroids, including many manned flights, but the real shocker is the number of satellites and spaceships being launched by private companies. Never mind Elon Musk's twelve-thousand-small-satellite Starlink programme, which is already becoming a traffic hazard after only 1,892 satellites have been launched, sixty at a time. (The Chinese have lodged a complaint.) There are 39 other companies in eleven different countries whose vehicles are scheduled to make their maiden flights this year. There's 'Blue Whale 1' from Perigee Aerospace in South Korea, 'Agnibaan' from AgniKul Cosmos in India, and 'RFA One' from Rocket Factory Augsburg in Germany. Not to mention 'Hyperbola-2' from i-Space in China, 'Eris' from Gilmour Space Technologies in Australia, and 'Terran 1' from Relativity Space in the United States. It's like 1910, when there were hundreds of start-up car manufacturers in the world. Space transport is becoming



an industrial-scale operation now like road transport was then, and everybody with an alternative approach that might fly is piling in. For example, 'Blue Whale 1' is a two-stage, two-tonne rocket that can put a 50kg. satellite into a 500-km-high Sun-synchronous orbit. Perigee plans to launch up to forty Blue Whale 1 rockets a year from an Australian site at \$2 million each. Agnibaan's special feature is that its rocket engine is 3D-printed at the company's site in Chennai. It can deliver a 100-kg. payload to a 700 km. orbit, and the launches will be made from Alaska since India still has limited space at its own commercial launch sites. And on, and on... But the four really heavy lifters are all American, and all are attempting first flights this year. Blue Origin' is designed to deliver 45 tonnes to LEO, but only the first stage is reusable. 'Vulcan-Centaur', mostly for military use, lifts 27 tonnes into LEO and 12 tonnes to a lunar transfer orbit. Space Launch System (SLS), descended from the rocket that carried the Space Shuttle into orbit, is NASA's own new heavy lifter.

It will ultimately be able to deliver 95 tonnes to LEO and 27 tonnes to a lunar transfer orbit. The star of the show, without a doubt, is Elon Musk's Starship, whose first flight is still tentatively scheduled for this month. It may well crash and burn - most of his maiden flights do - but that's the way he works, and he has planned at least a dozen more launches this year. If there are bugs in the newly celebrated marriage of the super-heavy launch vehicle and the passenger- and cargo-carrying Starship proper, he'll weed them out in the end. This is a real spaceship: room for a hundred people or a thousand cubic metres of cargo space. Both parts are reusable, and the Starship can refuel in orbit. It will land on the Moon, and eventually on Mars. It will be, as Musk said, "a generalized transport mechanism for the greater solar system." All of these advances will be overshadowed by the various space spectaculars coming up this year: the unfolding of the James Webb telescope, NASA's 'Artemis' mission orbiting the Moon, the joint Russian- European ExoMars mission, Indian, Russian, Japanese and South Korean soft landings on the Moon. But the real news is that after marking time for fifty years, we are actually getting off the planet at last. Cargo to orbit is now affordable (if you're rich or corporate), and both Earth orbit and the surface of the Moon will begin to accumulate a human population. A thousand people in fifteen years? Mars will take a little longer, probably, but we're

FDI in retail: The conundrum persists



The way forward is to legitimise Foreign Direct Investment in Indian online retail along with 100 per cent FDI in offline retail without any riders

n 2020, the Department of Consumer Affairs, in the Ministry of Consumer Affairs, Food and Public Distribution issued the Consumer Protection (ecommerce) Rules, under Section 101of the Consumer Protection Act, 2019. The rules require all e-commerce entities that are not established in India, but intending to operate here to register with the Department for Promotion of Industry and Internal Tradein the Commerce Ministry, bar affiliated entities from selling on e-commerce platforms and restricting 'flash sales, and disallow seller from using the name or brand associated with that of marketplace e-commerce entity for promotion

Within a year, the government proposed amendments through the Consumer Protection (e-commerce) (Amendment) Rules, 2021. These amendments include restricting business-to-business or B2B sales (business conducted between one business entity and another, such as transaction between a marketplace firm and the seller) in e-commerce, a provision to prevent 'abuse of dominant position' by e-commerce firms, and a fallback liability clause (it makes e-commerce firms liable in case a seller on their platform fails to deliver goods or servicesthat causes loss to the cus-

The amendments are a response to the complaint lodged by the Confederation of All India Traders and other associations regarding violation of the Foreign Direct Investment policy by global e-commerce players, Amazon and Walmart-owned-Flipkart, etc. For close to five years, these bodies havebeen registering protestwiththe concerned authorities, viz., Reserve Bank of India, Enforcement Directorate, Ministry of Commerce and Industriesbesides the judiciary regardingthe 'unfair'and 'discriminatory treatment meted out to tradersbyforeign majors on their market-place. These petitions have failed to make an impact. Here are some facts:

In a PIL filed by the Retailers Association of India in early 2018 alleging violation of FDI norms in e-commerce, ED had informed the Delhi High Court on October 31, 2018, that it was investigating violation of the Foreign Exchange Management Act against Amazon, et al but the proceedings are stuck due to the lackadaisical attitude of agencies and the

The All-India Online Vendors Association had petitioned the Competition Commission of India alleging abuse of market dominance against Flipkart India Private Limited (it is into wholesale trading/distribution) and ecommerce marketplace Flipkart Internet Private Limited. But, CCI saw nothing wrong in this practice; it wondered 'how come any one player in the market command any dominant position.

Even as the National Company Law Appellate Tribunal (NCLAT) quashed the CCI ruling and ordered a probe, nothing

As for submissions beforethe Union Government, all that we see is either Union Minister for Commerce and Industry Piyush Goyal reprimanding Amazon chief Jeff Bezos (February, 2020)or the DPIIT (the department under his ministry dealing with FDI) issuing directions to the RBI and ED to take action against the errant e-commerce firms (December, 2020). Now, we have Rules issued bythe DoCA aimed at reining in e-commerce firms (paradoxically, these have been opposed bynone other than DPIIT).

Will these Rules help achieve the objective? Was there anything wrong with the extant Rules?

As per the guidelines issued in early 2016, 100 per cent FDI is allowed under the marketplace model. The marketplace is a platform where vendors sell their products to consumers even as its owner merely acts as a facilitator by providing services such as booking orders, raising invoices, arranging delivery, accepting payments, etc. No inventory can be held or direct selling undertaken.

Two conditions are prescribed: The entity cannot permit more than 25 per cent of total sales on the marketplace from one vendor or its group companies. Two, it cannot directly or indirectly influence the sale price. Sans any mention as to

who the vendor is, a firm linked to marketplace either its subsidiary or a Joint Venturewith an Indian company is eligible. As for the second condition, it is not easy to establish that marketplace owner has manipulated the sale price.

Thus, these norms permitted e-commerce majors as direct sellers albeit through their subsidiary/JV.A clarification issued on December 26, 2018, said: "The owner of the marketplace or its subsidiary or its JV with an Indian company can't have ownership of the seller." Moreover, "a seller on the platform can't source more than 25% of its inventory from a firm connected with the latter".

The owner could get around both; first, by having less than 50 per cent shareholding in the seller firm and argue, he or she has no control (albeit majority) over the latter and second, by its wholesale arm restricting supplies to the seller within 25 per cent threshold. It is therefore not surprising that the e-commerce majors continue to hold sway over the marketplace run by them. For instance, only three dozen firms out of 400,000 sellers on Amazon platform account for 67 per cent of sales on it.

Now, look at the proposed rules (2020) and amendments (2021). The thrust of both sets is to establish a 'disconnect' between the seller and the marketplace. Whether, it is barring affiliated entities from selling on e-commerce platform or restricting transaction between a marketplace firm and the seller or preventing 'abuse of dominant position' by e-commerce firms or disallowing seller from using the name or brand associated with that of marketplace entity for promoting sale of their of having to regulate the sector.

goods, all point towards this overarching goal.

Juxtapose these rules with what is already there in the 2016 guidelines and the clarification issued on December 26, 2018. Both are at cross-purposes. While the former wants a total disconnect (the owner of the marketplace or its subsidiary can't have even 1% shareholding of the seller on the platform; besides, the seller can't source any supplies from a firm linked to the marketplace), the latter allows an e-commerce major to be a direct seller albeit indirectly. This throws up a

serious dilemma.

If the ModiGovernment goes ahead with the new rules, it will tantamount to overturning the 2016 and 2018 guidelines. It will be viewed as retrospective change of policy and send a wrong signal to foreign investors. On the other hand, if the existing policy dispensation continues, this will tantamount to the Government backtracking on its commitment to small traders.

Government needs effective communications strategy

The Government's performance depends upon proper communication of its policies and schemes but little or no effort is made in this direction

was the chief guest in a seminar of the medium and small industries sector (MSME) at Lucknow recently and surprised to find that the biggest problem appeared to be a huge communication gap between the government and the entrepreneurs. Most MSME members are not aware of the government schemes available for them and are unable to take advantage of them. That is why the objectives of the

schemes are not fully realized. MSME is a key sector. Nearly 60 million MSME units in the country employ about 110 million people and contribute 30 percent of GDP and 48 percent of exports. At the seminar, I found that most industrialists spoke about the problem of getting credit for



the sector, marketingtheir products, and technological innovation. Later, when the various schemes were outlined and explained to them, they were surprised to find that they could run their industry much better by using the incentives offered by the government. It was then decided that

awareness meetings need to be held in various industrial areas, districts and academic institutions and that the government should take the initiative so that intended beneficiaries are sensitized properly. Strangely though, the entire performance of the government depends upon proper communication of its policies and schemesbut little or no effort is made in this



environment, health, and education. There is thus a need for a communication strategy at the level of the Union and Governments.

I was closely associated during my tenure as an IAS officer with the information department of UP. The department issued advertisements to the mediato highlight government's achievements. The vital schemes are mentioned but details are not given. Merely issuing an advertisedirection. It is true for other ment does not make people

schemes. During my tenure as District Magistrate, we had an information officer whose job wasto make people aware of the government schemes and projects. He was expected to use local folk artists and theatre to popularized government schemes and make them reach the citizens in a simple and entertaining manner. This used to be quite effective but over time these innovative tools of communication are not being

The quickest way to reach the millions is through the use of social media. Increasingly the government and its officers are using Twitter, Facebook, Youtube and Whatsapp messaging to communicate their ideas and schemes. Normally

aware of the benefits of the information department but somehow it is spent on expensive advertisements. We need to evaluate whether this budget is being utilized effectively and are the people being made aware of government schemes and policies.

One-way communication does not always give the right results. For communication to be effective, there is need for feedback. Fortunately, technology has made this a simple matter. I recall as Chief Secretary, I wanted to know whether the beneficiaries of various schemes are genuine and have got the desired benefit. In the past, the only way of knowing was to physically verify things. Technology now makes it possible to do 100 percent verification and in no

contact the listed beneficiaries on their cell phones to find out whether they had received assistance under various government schemes. We also gave them details of schemes over the phone and took their feedback and suggestions. This worked really well and I would like to use this template for future use of technology-based communication.

In rural areas radio is an excellent mode of communication. Television also plays a useful role. However, there is no substitute for old-fashioned face-to-face interaction. I remember as a District officer I use to visit villages and hold meetings explaining to the villagers about government schemes and how they could avail the benefits. semination of information and communication with the citizens. Apart from print media, television, field visits and use of folk art, the strategy is to go digital. Singapore says 30% Covid-19 deaths in 2021 were fully vaccinated

 $F_{\text{accounted for 30 per cent of Singapore's total COVID-19}}^{\text{ully vaccinated individuals}}$ related deaths last year, Health Minister Ong Ye Kung said in Parliament on Monday.

The minister said that Singapore last year registered 802 deaths due to the coronavirus, out of which 247 were fully vaccinated people. Most of the vaccinated individuals, who died from COVID-19 related complications, had received non-mRNA vaccines, according to crude incidence rates of deaths provided by Ong.
Ong provided the crude

incidence rates based on type of vaccination: 11 deaths per 100,000 for those vaccinated with Sinovac, 7.8 per 100,000 for Sinopharm, 6.2 per 100,000 for Pfizer-BioNTech and 1 per 100,000 for Moderna.

"Be mindful, we are calculating this based on quite a small sample of 247 deaths... These rates are only indicative since they do not account for other factors which can affect mortality such as the age and timing of vaccination," Channel News Asia quoted Ong as saying in the House.

The remaining 555 people who died from COVID-19 last year were not fully vaccinated. Although the unvaccinated represents a "small proporthose deaths accounted for 70 per cent of the total COVID-19

deaths last year, Ong said.
The Ministry of Health (MOH) has managed to vaccinate "well over 90 per cent" of every eligible age group over the past months, he said."We are especially happy to see that amongst seniors aged 60 to 69, and 70 and above, 96 per cent and 95 per cent have been fully vaccinated respectively," the minister said.

As for those aged 12 to 19 years old, 95 per cent are fully vaccinated, said the minister, while response has been "good" and operations have been "smooth" for vaccinations among younger children aged

"At this time, only the Pfizer-BioNTech/Comirnaty vaccine is authorised for use in ages below 18 years. We will continue to monitor closely the availability of other vaccines, including non-mRNA vaccines that are approved for use in children," Ong assured the

Singapore's booster programme is "gathering pace", with about 46 per cent of the population having received their boosters (third injection), said Ong.% "We have recently brought some 900,000 individuals aged 18 to 29 into the booster programme, of whom

700,000 are already eligible to receive their boosters today," he

The MOH has also set a validity period for full vaccination status of 270 days, to send "a strong signal to our population".

However, it is "still too early to tell" whether there is a need for further booster shots, he said. Israel is the only country that has authorised a fourth

non-immunocompromised individuals. Meanwhile, the current COVID-19 safe measures will only be tightened as a "last resort" when Singapore's healthcare system is under heavy strain, Ong

"It is the (multi-ministry task force's) hope that we can ride through the Omicron wave with the current safe management measures. "If we have to tighten the restrictions, it will be as a last resort when our healthcare system is under severe pressure," he said, in response to questions on whether stricter rules will be put in place.

Philippines reports 3rd day of record virus cases

Manila: The Philippines on Monday reported a record high number of new COVID-19 cases for third day, logging 33,169 infections. The positivity rate, or percentage of tested people whose results came out positive, also soared to 46 per cent, another record high since pandemic started two years ago. Monday's tally brings Philippines' total infection count nearer to 3 million mark at 2,998,530. The death toll stood at 52,293 with 145 new deaths recorded.Officials said they are assuming that local transmission of highly contagious omicron variant is driving the current spike in cases. Some experts have called for increased restrictions as cases surge and hospital operations are being hobbled by number of infected health workers. But officials said on Monday that there is still no need to raise alert to fourth level of five-step alert system.The capital region Metro Manila and several provinces and cities are under under Alert Level 3 until January 15.

Chinese port city reports 41 virus cases, amid mass testing

uthorities in the Chinese Acity of Tianjin on Monday reported 41 CÓVID-19 infections out of 3.4 million residents tested since the discovery of two local omicron cases. Officials say they plan to test all of the 14 million inhabitants of the large port city that lies near the capital of Beijing.

City officials said that 41 people had tested positive as of 6 p.M. Local time, according to state broadcaster CCTV. Of those 31 had COVID-19 symptoms and 10 did not.

The outbreak, while small, has raised concerns because it is the first one in China linked to omicron and comes as nearby Beijing is set to host the Winter Olympics in less than a month. The port city is also an industrial hub with industrial Volkswagen and Airbus factories.Tianjin has locked down affected parts of the city, but so far not ordered a total lockdown. It has closed some subway stops, the zoo, museums and libraries. The citywide

testing was being carried out in two phases on Sunday and Monday. The measures, in response to a relatively small number of cases compared to other countries, shows how far China is going to shut down outbreaks as it pursues a zero COVID-19 strategy.

The restrictions have only tightened ahead of the Olympics, which China and the International Olympic Committee seem determined to pull off despite the spread of the omicron variant globally. China has locked down

two other cities battling delta outbreaks, the historic ancient capital of Xi'an in Shaanxi province and the smaller city of Yuzhou in neighboring Henan province. The number of new cases in Xi'an, home to famed Terracotta Warriors statues in a former emperor's tomb, fell to just 15 on Sunday, but the city of 13 million people remained locked down. Officials said that sections of the city could be opened up when they meet certain conditions including no new cases in past 14 days.

Singapore expects Omicron wave to be several times larger' than Delta: Minister

Singapore can expect an infection wave due to Omicron "several times larger" than the one caused by Delta, Health Minister Ong Ye Kung said in Parliament on Monday as he cited the latest variant's higher transmissi-

Responding to a query from a Member of Parliament, the minister said that cases are likely to double every two to three days.Singapore can expect an infection wave "several times larger" than the one caused by Delta, said Ong, citing the Omicron variant's higher transmissibility.

"If Delta infections reached a sustained incidence of about 3,000 cases a day, Omicron could perhaps reach 10,000 to 15,000 cases a day, or more. "So once cases start to rise steeply, within a couple of weeks, we may see 3,000 Omicron cases a day," the minister said. Ong also pointed to global studies that have shown that the Omicron vari-

ant causes less severe illness than Delta, with fewer cases being admitted to hospital or requiring emergency care."This has also been borne out by our own experience. In Singapore, we have recorded 4,322 Omicron infections so far, including 308 seniors aged 60 and above.

"Eight needed oxygen supplementation and all of them have been taken off oxygen after a short few days. None required ICU care as yet," he said.

If these infections had instead been caused by Delta, authorities would expect 50 to 60 patients needing oxygen supplementation, ICU care or to die, he said.But Ong cautioned that Singapore must be careful in interpreting these observations, as "it is early days and the circumstances of each country are different". Meanwhile, the current COVID-19 safe measures will only be tightened as a "last resort" when Singapore's healthcare system is under heavy strain, Ong said.

Beijing accuses US of inciting Lithuania over Taiwan

 $B^{\text{eijing on Monday accused}}_{\text{Washington of inciting}}$ Lithuania to "contain China" in a feud over status of self-ruled Taiwan after US officials expressed support for European Union-member country in face of Chinese economic pressure. Lithuania is latest flashpoint in China's campaign to pressure companies and foreign governments to adopt its positions on Taiwan, Tibet and other sensitive issues.

"The United States has instigated Lithuanian authorities to undermine one-China principle'," said a foreign ministry spokesman, Wang Wenbin. "It has supported, aided and abetted them in going further down wrong path to achieve its political calculations to contain American and Lithuanian officials say China has blocked imports from northern European country since Taiwanese government was allowed to open a trade office there under name Taiwan. US, Russia meet for talks amid tensions over Ukraine

Senior US and Russian officials formally launched special talks on strategic stability on Monday as part of a flurry of diplomatic activity in Europe this week aimed at defusing tensions over a Russian military buildup on the border with Ukraine, though no major breakthrough was immediately in sight. Russian Deputy Foreign

Minister Sergei Ryabkov and his delegation arrived under Swiss police escort at the US diplomatic mission for face-toface talks with Wendy Sherman, the US deputy secretary of state, and her team.

The meeting is part of 'Strategic Security Dialogue" talks launched by Presidents Joe Biden and Vladimir Putin during a June summit in the Swiss city. After an informal working dinner on Sunday, Ryabkov predicted "difficult" talks in Geneva that are to be followed by a NATO-Russia meeting in Brussels on

Wednesday and a meeting of the multilateral Organisation for Security and Cooperation in Europe in Vienna on Thursday. Moscow has sought to wrest a string of concessions from the US and its Western allies, including guarantees that NATO will no longer expand eastward into former Soviet states like Ukraine, along whose border Russia has amassed an estimated 100,000 troops in steps that have raised concerns about a possible deeper military intervention there.

State Department spokesman Ned Price said that during Sunday's dinner Sherman "stressed the United States' commitment to the international principles of sovereignty, territorial integrity and the freedom of sovereign nations to choose their own alliances", a reference to Ukraine and its aspirations of joining NATO. Many analysts say any such accession would be years away at best. Sherman "affirmed that the United States would welcome genuine progress through diplomacy", Price said in a statement. The US has played down hopes of significant progress this week and said some demands - like a possible halt to NATO expansion - go against countries' sovereign rights to set up their own security arrangements, and are thus non-negotiable.

But US officials have expressed openness to other ideas, like curtailing possible future deployments of offensive missiles in Úkraine and putting limits on American and NATO military exercises in Eastern Europe - if Russia is willing to back off on Ukraine. US Secretary of State

Antony Blinken said bluntly Sunday that he doesn't expect any breakthroughs in coming week. Instead, he said a more likely positive outcome would be an agreement to de-escalate tensions in short term and return to talks at an appropriate time in future. But US will have to see a de-escalation for there to be actual progress. "It's very hard to see that happen-

ing when there's an ongoing escalation, when Russia has a gun to head of Ukraine with 100,000 troops near its borders, possibility of doubling that on very short order," Blinken said on ABC's "This Week".The United States, which has emphasised that Ukraine's government and those of other European countries need to be included in discussions, plans to discuss some bilateral issues in Geneva "but will not discuss European security without our European allies and partners", Price said Sunday.

Amid Russian military buildup, concerns have risen about a broader Russian military incursion in Ukraine - and United States and its Western allies have vowed "severe costs" for Russia if it happens. Putin's government has laid out a list of demands, such as seeking guarantees that the NATO military alliance won't seek to expand any further eastward to countries like Ukraine or Georgia, which are former Soviet republics.

9 children among 19 killed in one of worst fires in New York

In one of the worst fire accidents in the recent history of New York City, 19 people, including nine children, were killed in an apartment building where a massive blaze broke out due to a malfunctioning electric space heater.

The New York City Fire Department said that approximately 200 of its members were operating on the scene at the 19-storey building in the Bronx where the fire started around 11 AM on Sunday.

The incident comes days after an apartment fire in Philadelphia killed 12, with eight children among the dead. New York City Mayor Eric Adams termed it a "tragedy beyond measure".

"We've lost 19 of our neighbours today... Join me in praying for those we lost, especially the 9 innocent young lives said in a tweet on Sunday. Over 30 people were seriously injured in the incident. Adams said that the building housed a largely Muslim population, with many immigrants from Africa's Gambia.

"This is a horrific, horrific, painful moment for the City of New York. The impact of this fire is going to really bring a level of pain and despair to our city... This is going to be one of the worst fires we have witnessed during modern times," Adams said at a news conference.

Governor of New York state Kathy Hochul said the city is "in shock". "It's impossible to go into that room where scores of families who are in such grief, who are in pain, to see it in a mother's eyes as I held her, who lost her entire family.

It's hard to fathom what they're going through," Hochul said as she joined Adams to provide an update on the apartment fire in the Bronx. The Governor said that she will establish a victims' compensation fund for the individuals affected by the fire and to help them find new housing and for

Airlines offer domestic fliers free date change amid curbs

The Tata-Singapore Airlines-backed Vistara is also providing one complimentary 'date change' for all domestic flights. The complimentary date change is permitted on all domestic flight routings issued for travel up to March 31, 2022. "We are observing a decline medical emergencies.

Mumbai: Domestic air passenger traffic remained 44 per cent lower in the April-December 2021 against the corresponding period of FY20, but saw a jump of 52 per cent year-on-year to 111 lakh in December 2021, according to rating

The total domestic passenger traf-fic had stood at 73 lakh in December 2020, according to a report by the rating

It also said that the emergence of new coronavirus variant and reactionary restrictions impacting air travel remain near term-challenges for the airline industry. On a sequential basis, the growth in December was recorded at 5-6 per cent over November 2021 during which Indian carriers had flown 105 lakh passengers, ICRA said in a statement on Monday. Besides, the average daily departures stood at around 2,800, notably higher compared with around 2,065 in December 2020 and around 2,700 in November 2021, it said.

At the same time, the average number of passengers per flight during December 2021 was largely flat at 129 as compared to 130 in November, ICRA said. Sensex zooms 651 pts; Nifty recaptures 18,000-level ahead of Q3 results season

Mumbai: The BSE Sensex shot up over 650 points to surge past the 60,000-level while the NSE Nifty settled above 18,000 on Monday as participants showed keen interest in IT and financial shares ahead of the Q3 earnings season.

Rising for the second straight session, the 30-share BSE benchmark hit the day's high of 60,427.36, before ending at 60,395.63, higher by 650.98 points or 1.09 per cent.

Likewise, the broader NSE Nifty climbed 190.60 points or 1.07 per cent to settle at 18,003.30. On the Sensex chart, Titan, Maruti, SBI, L&T, SBI, HDFC and Kotak Bank emerged as prominent gainers, advancing as much as 3.29 per cent.

In contrast, Wipro, Nestle India, Asian Paints and PowerGrid were among the major laggards, shedding up to 2.47 per cent.

Market breadth was positive, with 20 of the 30 Sensex counters posting gains.

Analysts said the Q3 corporate results announcements starting this week from the IT majors and HDFC Bank are likely to set the trend for the crucial tech and banking segments.

"Amid weak global mar-

Sebi puts in place framework for operationalising gold exchange

New Delhi: Capital markets regulator Sebi on Monday came out with a framework for operationalising the gold exchange, wherein the yellow metal will be traded in the form of electronic gold receipts

The stock exchange desirous of trading in EGRs may apply to Sebi for approval of trading in the new segment, the regulator said in a circular.

The bourses can launch contracts with different denomination for trading or conversion of EGR into gold. Under the new framework, the entire transaction has been divided into three tranches-- creation of EGR; trading of EGR on stock exchange and conversion of EGR into physical gold.

A common interface will be developed by depositories, which will be made accessible to all the entities -- vault managers, depositories, stock exchanges and clearing corporations.

The new framework will come into force with immediate effect, the Securities and Exchange Board of India (Sebi) said. This comes after the government, through a notification on December 24, declared "electronic gold receipts" as 'securities' under the Securities Contracts (Regulation) Act 1956.

Separately, the regulator through a notification on December 31, notified rules for vault managers paving the way for operationalising gold exchange.

As per the Sebi circular, supply of the physical gold, to be converted into EGR, will be the fresh deposit of gold, coming into the vaults, either through imports or through stock exchange accredited domestic refiner-

The existing deposit of gold lying in the vaults, which meets the criteria and has never been out of the sion into EGR.

Vault managers will have to ensure that 'gold' to be converted into EGR meets the criteria.

The gold which complies either with LBMA Good Delivery Standard or with the India Good Delivery Standard, or any other standard specified by Sebi, will be eligible under this framework.

To lower the costs associated with withdrawal of gold from the vaults, EGRs have been made "fungible" and "interoperability between vault managers" have been allowed. To increase the reach of gold exchange, all exist-

ing branches of vault managers may be allowed as 'collection and/or withdrawal center', which meets the safety standards, as specified by Sebi.

Mumbai: The third wave will push the recovery in multiplexes by up to five months as Governments resort to the temporary closure of movie halls to contain the spread of the COVID wave, a domestic rating agency said on Monday. full revenue recovery of the multiplexes will be pushed back to the second half of the next fiscal as against the first quarter earlier, Crisil Ratings said.

NCLAT rejects petitions against Ola in alleged predatory pricing matter

New Delhi: The National Company Law Appellate Tribunal (NCLAT) has rejected petitions filed by ride sharing players Meru and Fast Track Call Cab against Ola alleging predatory pricing ways and anti-competitive practices in Bengaluru market.

The appeals were filed by the entities against ANI Technologies, which run the app-based taxi service under the brand name Ola. alleged that Ola indulged in abuse of dominant position and entered into anti-competitive agreements with drivers in the Bengaluru mar-

The appellate tribunal has upheld the order passed by the Competition Commission of India (CCI), which in July 2017 had rejected the allegations of abuse of dominant position against Ola. The watchdog's decision followed a detailed probe by its investigation arm Director General The petitions by the two entities had challenged CCÎ's order. While rejecting the petitions, NCLAT also said that Ola was not

"Moreover, since Ola is not in dominant position the question of abuse of dominant position through predatory pricing also does not get attracted. In sum, we do not think the orders of the Commission dated 19.7.2017 require any interference. Both the appeals are, therefore, dismissed," the appellate tribunal said in an order on January 7



Take the much needed vitamin

The primary source of Vitamin D is exposure to sunlight, particularly ultraviolet B (UVB) rays, says DR SHELLY SINGH

D is quite common across the country. In 2013, it was estimated that approximately 40 per cent of the Indian population suffered from Vitamin D deficiency. Currently, it has risen to as much as 77 per cent, in both rural and urban areas. This deficiency is particularly prevalent in adults of the 18-30 years age group. Women belonging to the lower social demographic are also more prone to Vitamin D deficiency. The primary source of

Vitamin D is exposure to the sun. However, there are many factors that prevent the majority of the population to get sufficient sun exposure. Modernisation has meant that most people spend the bulk of their time indoors. Moreover, some of the cultural practices like wearing a burqa limit exposure to the sun. The application of sunscreens and increased skin pigmentation limits the production of

Vitamin D by the skin. A high

→ he deficiency of Vitamin level of air pollution is also a contributing factor as it prevents UVB ray transmission. Dietary habits are also

responsible for the vast vitamin D deficiency. Poor dietary habits contribute to a lower intake of Vitamin D as well as calcium. Furthermore, most food rich in Vitamin D is derived from animal sources. Considering the fact that

a majority of people in India follow a vegetarian diet, people usually don't get sufficient Vitamin D from dietary sources. Even the food products that are widely consumed across the country such as dairy products do not have sufficient proportions of Vitamin D. Fibre-rich food products contain phosphates and phytates, which play a role in depleting Vitamin D stores.

Medical factors like underlying conditions or certain medications can also cause Vitamin D deficiency. Certain health conditions like celiac disease, cystic fibrosis, inflammatory bowel disease,

chronic liver disease and gastric bypass can cause malabsorption of Vitamin D. Medications

Carbamazepine, Clotrimazole, Nifedipine etc., can cause activate Vitamin D degeneration. Vitamin D deficiency is also commonly seen in women with multiple pregnancies and successive pregnancies in a short time span.


Now&Me to your rescue

LIVING WITH THE PAST

MADHULIKA LIDDLE tells Khushbu Kirti that Delhi, in her new novel, The Garden of Heaven, is a beautiful and diverse garden with its share of thorns, snakes in the grass, and the occasional poisonous plant

he first Indian to win the Commonwealth Broadcasting Association's Short Story Competition in 2003, Madhulika Liddle is known for her deeply researched and engaging works. Afterall, the 17th century Mughal detective Muzaffar Jang is, indeed, her brainchild.

Being born in Delhi, Liddle has embarked on a new journey to enravel the secrets from the pages of history of the city of love.

Her freshly published work by the Speaking Tiger Books, The Garden of *Heaven*, is the first one in the saga of The Delhi Quartet. Beginning shortly before the invasion of Mohammad Ghuri, and extending till just after Partition; the saga will span 800 years of Delhi's history. And you guessed it, the first 200 years of that stretch are being covered in The Garden of

In a rather interesting conversation, Liddle talks about her works, and shares her thoughts on history, the city and the city's history. Read on for excerpts from an exclusive interview:

♦Congratulations on your recent release, The Garden of Heaven. Please give us an overview of the

♦What inspired you to begin this saga? Thank you! The Garden of Heaven

is a historical novel, the first in a fourbook series called The Delhi Quartet. The entire saga will span 800 years of Delhi's history, as seen through the lives of a group of interconnected families. The first novel covers the period from 1188 CE, just before Mohammad Ghuri defeated Prithviraj Chauhan and established the Delhi Sultanate; to 1398 CE, when Taimur sacked Delhi.

A somewhat similar, but much more ambitious book, Edward Rutherfurd's Sarum, inspired me to write this series. Sarum is about ordinary people living their lives against the backdrop of several thousand years of history (from the Ice Age to 1984) in and around England's Salisbury, which was earlier known as Sarum.

♦What is the significance of the title - 'The Garden of Heaven'?

The Garden of Heaven is the name the stone carver, Madhav, gives to the exquisite stone frieze he carves in his later years, a frieze depicting a garden. I also meant the 'garden of heaven' to be a metaphor for Delhi itself, a beautiful and diverse garden, but (like any real garden), with its share of thorns, of snakes in the grass, and the occasional poisonous plant...

❖A lot of people's lives are intertwined, their stories running in parallel lines in the book. Thus, making it deeply layered.

What is the objective

behind the same? I wanted to write a historical novel which focussed not on the important people, the larger-than-life historical figures of that era, but the everyday people: I wanted to explore how they might have felt, even as history was being made during their own lifetimes. I also wanted to show how people come together, how one family divides and separates, or how two disparate families come together: these are themes that interest me, and placing them in a historical setting helped me give it a new dimension: to explore how people cope with hardship, with circumstances outside their control.

Important people like Razia Sultan, Amir Khusro, Ibrahim Lodhi, Mohammad Ghori, Prithviraj Chauhan, and so on, exist and their personal endeavours are conveyed beautifully. How close to reality is the story? Can this qualify for a historical fiction? Mostly, the episodes and incidents

regarding the real personalities in this book are based on fact (or, as in the case of Hazrat Nizamuddin Auliya, on folklore). Razia's tussles to gain and then retain her throne; Ghiyasuddin Tughlaq's attempts suppress Nizamuddin; Taimur's invasion, and so on: these are all factual. It is mostly only in

their interactions with the fictitious characters (Madhav, Jayshree, Girdhar, et al) that a fictitious episode in the lives of these historical characters is introduced. So yes, I would call The Garden of

Heaven historical fiction. ♦It is said that Dilli was destroyed and

built seven times. Do vou wish to encompass this journey in your books? There is some debate on whether

times, or more — some historians believe there could be up to ten cities of Delhi, perhaps even up to fifteen. Enumerating all of these (or even just seven) in the course of four novels might lead to a too bulky set of books, so I am restricting myself to just telling the story in its broad outlines. At times, the destruction of the city (or rather, the falling away of one area and the coming to power of another) does become highlighted; at other times, the shift in power is rather less dramatic, and one city fades gently away, too gently for anything other than an oblique reference.

This is the first of the four of Delhi Quartet. What is your vision for the forthcoming books?

As in The Garden of Heaven, the other three books will also follow a similar pattern: ordinary people living in Delhi, their lives at times touched by the history being made in Delhi. Some important real-life historical personalities will appear now and then, but otherwise, the focus will be largely on the fictitious characters. Each book will cover, as did The Garden of Heaven, approximately 150-200 years of history.

Have you studied history since your novels are so well-researched. Would you be a historian, if not a writer?

I've always been interested in history, especially since my sister, Swapna Liddle, is a historian — her studying history inspired me too, to regard history with a lot more affection than most Indians seem to have for the subject.

If I hadn't been a writer, I would probably have been one of the many professions I've followed in my career: hospitality manager, advertising executive, editor, instructional designer... for me, the interest in history came a little late in life, after I'd decided (as I thought) what career I was going to adopt. By then, it was too late to start studying history in earnest. So my interest in history remains (and will remain) a love, not a profession.

Historicity and meaning. What, in your opinion, is the antinomy between history and truth?

I think history and truth are not quite synonymous, simply because - like science — history too is a discipline which draws conclusions from available evidence, coming up with logical theories to interpret that evidence. For example, old chronicles, artefacts, archaeological evidence, and so on, can help historians build up a picture of what might have happened in the past. While artefacts and archaeological evidence may be more irrefutable proof, chronicles can be biased, thus, distorting the truth. And, as Delhi was destroyed and built seven in the case of science, until further evi-

dences come to light, one history, one accepted truth, may prevail. Newly-discovered evidence may however change that truth.

History, therefore, to me is perceived truth; believed truth. Some aspects of it might be factual, some may be reliably so, and others may be so till further evidence proves either way.

What do you think of the Education Ministry's move of wiping out the Mughal dynasty from the history syllabus of prominent universities?

Are we depriving our future generation of historical truth?

I think that's a very short-sighted, bigoted move. Wiping out mentions of the Mughal dynasty (or any other, for that matter) or trying, in other ways, to distort historical fact to suit one's own agenda serves nothing other than to propagate a falsehood.

What will this lead to? A generation (many generations?) of Indians who are learning something nobody else in the world knows as history? A falsehood, too, which is completely unsupported by evidence of any sort? My take is that history cannot be changed; we have what we have. The past is done, and nothing we do now can change it. So what is wrong with living with that past? Good or bad, all of India's history is our history. To try and sanitise it is juvenile.

♦I truly believe we need more female authors to write stories of women, since they were either wiped out from the pages of history or their truths misconstrued by male voices.

Care to weigh in?

I agree. Women have, for too long, been largely erased from the 'commonly known histories' — that's how I would describe it, since there are historians I know who have done research into women in history, and have come up with fascinating instances of women going far beyond what anybody can imagine in a patriarchal society like ours. The great queens of Odisha, for instance, or the padishah begums during the time of the Mughals: women with far greater agency than is now remembered by the common

♦How do you like to portray your female characters? For Shagufta seems to be one bold woman in the face of

I like to portray my female characters as a blend: not all strong-willed, not all flawless; human. Some are more feisty than others, some are far more conforming and meek than most, but I like to have at least one female character who stands up for herself, and is emotionally mature and intelligent.

Australian judge says Djokovic can stay but saga not over

ovak Djokovic won a court battle Monday to stav in Australia to contest the Australian Open after his exemption from strict coronavirus vaccination rules was questioned, but the drama might not be finished, with the government threatening to cancel his visa a second time and deport him.

Hours later, the tennis star hit the court and was training, his brother told reporters. Djokovic himself tweeted that he was still planning to compete.

Federal Circuit Court Judge Anthony Kelly reinstated the Djokovic's visa, which was revoked after his arrival last week because officials said he didn't meet the criteria for an exemption to a rule that all non-citizens be fully vaccinated.

Djokovic's lawyers say that since he recently recovered from COVID-19, he didn't need to be inoculated under Australia's rules.

The judge ruled the No. 1 player had not been given enough time to speak to his lawyers before the decision was made and ordered the government to release him within 30 minutes from a Melbourne quarantine hotel where he has spent the last

Christopher Tran told the judge that the immigration minister "will con-



sider whether to exercise a personal power of cancellation.

That would mean that the ninetime Australian Open winner and defending champion could again face deportation and could miss the tournament, which starts on January 17. It could also bar him from the country for three years.

The back and forth has gripped

But government lawyer the world and caused a furor in Australia, where many initially decried the news that Djokovic, who

has been a vocal skeptic of vaccines, had received an exemption to strict

rules to compete in Melbourne. Many felt the star, who court documents say is not innoculated against COVID-19, was being given special treatment since Australians who aren't vaccinated face tough travel and quarantine restrictions.

But when border police then blocked him on arrival, others cried foul, saying he was being scapegoated by an Australian government facing criticism for its recent handling of the pandemic.

Speaking with television network Prva in Belgrade, Serbia, the tennis star's brother, Djordje Djokovic, described the judge's ruling as a "great defeat for Australian authorities.

"This is definitely politics, all this was politics," he added.

He said at one point Monday that the family was hearing that his brother might still be detained, though he gave no details. Later, he confirmed that the tennis player was not in detention.

"Novak is free. He was at the tennis court moments ago. He is training," he said.

The star himself tweeted out a photo of him standing on a court at the arena where the tournament is

The Ahmedabad franchise

The CVC-owned Ahmedabad franchise will be appointing senior India all-rounder Hardik Pandya as captain for its maiden season in the Indian Premier League, for which it has got the all-clear from the BCCI.

One of the world's leading venture capitalists, who bought the Ahmedabad IPL team for INR 5625 crore, the owners had to wait longer for the BCCI to give them the Letter of Intent as legal vetting was required.

The delay in getting the green light was due to CVC's investments in betting firms in Europe and although they have no such operations in India where betting is illegal, the country's cricket board wanted to be sure about the legal ramifications before giving them the go-ahead.

"Yes, Ähmedabad franchise has received their Letter of Intent.

However, they have been doing their back-room work for some time as it's a huge process. As far as we know, Hardik has been zeroed in on as the captain of the franchise," a senior IPL source told PTI on the condition of anonymity.

Latham, Boult star as NZ dominates 2nd test

Tom Latham scored 252, Devon Conway banked another century and Ross Taylor likely played his last test innings as New Zealand declared at 521-6 on Monday before bowling out Bangladesh for 126 on the second day of the second cricket test.

Trent Boult took 5-43, including his 300th test wicket to join Richard partner Tim Southee among New Zealanders who have taken 300 wickets in tests. The milestone came in

Boult's 75th test at an average of 27.35, along with his ninth five-wicket hauls in tests. "It definitely means a lot," Boult said. "I suppose as a team we're not about the milestones but it definitely means a lot to join an exclusive club. tough to get a membership."

Latham declared New Zealand's first innings halfway through the middle session on day two at Christchurch, and Boult and Southee order to leave the tourists' 11-4 in the seventh over — challenging their test

Yasir Ali showed fortitude to post a maiden test half century and was out for 55 just before stumps. Latham took two catches at sec-

Arsenal out of FA Cup, Liverpool and Tottenham avoid upsets

Third-round exits in the FA Cup I don't come along very often for Arsenal. Unless, that is, Nottingham Forest is the opponent.

Failing to transfer its improved Premier League form to the world's oldest knockout competition, Arsenal was beaten 1-0 by second-tier Forest on Sunday in the second big shock of the third round — the stage where top-flight clubs enter the draw. It's only the second time in 26 seasons that Arsenal has fallen at the first hurdle. Forest was responsible for the other occasion, too, in 2018.

"We were not good enough," Arsenal manager Mikel Arteta said, "and we have to apologize for it." Tottenham and Liverpool avoided the same fate as



Arsenal, launching comebacks after falling behind at home to third-tier opponents. Tottenham beat Morecambe
