NYT report triggers fresh controversy on Pegasus

Centre duped SC, hijacked democracy, says Cong; VK Singh snubs 'Supari Media' PNS NEW DELHI

 $P_{\text{a}}^{\text{egasus scandal erupted into}}_{\text{a fresh controversy on}}$ Saturday after the *New York Times* published a report claiming India bought the Pegasus spyware from Israel as part of a defence deal in 2017.

Latching on to the report, the Congress on Saturday launched an all-out attack on the Government, accusing it of deceiving Parliament, duping the Supreme Court, hijacking democracy, and indulging in

The party, which had ear-lier attacked the Modi Government over the Pegasus row and even stalled Parliament, said it intended to raise the issue again in the Budget Session starting next week and will demand accountability from Prime Minister Narendra Modi and the BJP Government on the

floor of Parliament. Former Congress president Rahul Gandhi accused the Government of treason by "tapping" phones

Opposition leaders, Armed forces, and the judiciary using the Pegasus spyware. "The Modi Government bought Pegasus to spy on our primary democratic institutions, politicians, and public. knowingly "deceive" it. The shadow of the Pegasus issue looms large again over the 2022 Budget Session as the entire Monsoon Session of 2021 was washed out over the

issue after the Opposition had jointly stalled the proceedings.

According to a report in

The New York Times, the Israeli spyware Pegasus and a missile system were the "centerpieces" of a roughly USD 2-billion deal of sophisticated weapons and intelligence gear between India and Israel in 2017.

Addressing a Press conference here, Congress general secretary and chief spokesperson Randeep Surjewala alleged the Modi Government "deceived" Parliament as well as "duped" the Supreme Court.

He said the BJP machinery engaged in a massive strategy to also "dupe" the people of the country and it is now clear that the BJP Government-led by Modi "purchased the illegal and unconstitutional" spyware from Israel and used it against Opposition leaders, the judicial the media and its own functionaries.

They committed an act of treason ahead of the 2019 Lok Sabha elections, he alleged. "It is now very clear that Parliament was deceived by the Modi Government, the Supreme Court was also duped and the people of India were lied to by the Modi Government and its Ministers,"

'Party responsible for killing of hundreds of Hindus in **Muzaffarnagar riots**'

Training his guns on the Samajwadi Party, Uttar Pradesh Chief Minister Yogi Adityanath said on Saturday it was responsible for the killing of hundreds of Hindus in the Muzaffarnagar riots.

Asking the people to beware of the politics of appeasement, he said voting for the SP alliance would be an insult to the innocent killed in

"The SP people have no right to be in power as they only harassed women and farmers and failed to ensure security for them," the Chief Minister said while interacting with the public in Baghpat district on Saturday.

He said, "More than 60 Hindus were killed and over 1,500 Hindus were put behind the bars during the Muzaffarnagar riots... This is the identity of SP. Their cap is stained with the blood of innocent Ram bhakts. Yogi remarked that SP

never had development-oriented thinking. "For them, development only meant construction of boundary walls of graveyards, not development of infrastructure like airports,

highways, medical colleges and houses for the poor."

He squarely blamed the previous ŜP Government for patronising mafias, goons and terrorists looting money of poor and instigating riots in UP. "This time these people have made goons and criminals and those with Talibani mindset their candidates. The Kairana candidate of the SP still threatens people. 'Lagta hai inki garmi abhi gayi nahi," he comnented.

Appealing for public sup-port for the Bharatiya Janata Party candidate in Baraut, Yogi said the period from 2012 to 2017 was a "period of darkness" for Uttar Pradesh

Yogi also addressed the

issue of women's safety and said, "How was the situation before 2017 in Western Uttar Pradesh? Women safety was in danger, so much so that girls could not go to schools and Mulayam Singhji would say: boys make mistakes. Their sympathy is not with women and youth. Today it is a pleasure for someone to look at their sisters and daughters." While interacting with the

public in Chhaprauli, Yogi said the SP used to establish factories of firearms, while the BJP Government was getting a defence manufacturing corridor built in the State.

"Earlier, there were instances of attacks on Kanwar yatras. Now, I used to send helishower flower petals on Kanwar vatras and stern action against anyone harassing any innocent participant of Kanwar

yatras," he pointed out. Mocking at SP's election announcements like free electricity, Yogi said when their Government failed to provide electricity, how was it to be expected that they would give electricity for free. There was no electricity during the previous regime, he said.
"We have given electricity

for 24 hours and now the electricity rate of farmers has been reduced by half. Also, today no one dares to steal even the pump sets of farmers," he added.

He took a swipe at the SP and the BSP for issuing tickets to criminals, saying, "There is a competition between the SP and the BSP to give tickets to the biggest criminal. If these criminals become MLA, they will produce guns, not flowers and there is only one way to treat them, and it is by the bull-

Referring to the works of the double-engine Government, Yogi said it takes courage to work. "Those people who used to surrender in front of mafias and criminals, such people cannot run the state and they can only take care of the family. They are harmful for the state and its people," he said.

WHO: Covid risk still high, no country out of woods yet

India cautioned against dropping guard after report of decline in cases

Days after the Union Health Ministry claimed that certain States in the country had reported early sign of Covid cases plateauing, the World Health Organisation(WHO) cautioned India not to drop the guard since the risk of Covid-19 remained high and no country, irrespective of their current transmission scenario, is "out of the woods" yet.

"By becoming endemic doesn't mean that the virus will not be a cause of concern," said Dr Poonam Khetrapal Singh Regional Director, WHO South-East Asia Region, on Saturday. She advised that authorities should concentrate on reducing transmission and implementing situation-specific measures

A decline in Covid cases and positivity rate have been especially observed in Maharashtra, Uttar Pradesh, Delhi, Odisha, Haryana, and West Bengal.

Asked if the pandemic is entering in endemic stages, Singh said, "Currently, we are still in the midst of the pandemic and the focus should be to curtail the virus spread and save lives". Compared to the Covid-19's Delta variant, she said Omicron is able to more rapidly infect the tissues of the upper respiratory tract rather than the lungs, which may also help the spread of this variant.

"There appears to be a lower risk of severe disease and death following Omicron infection as compared to other variants. However, due to the very high numbers of cases, many countries have seen a significant increase in the incidence of hospitalization, putting pressure on healthcare systems," she said.


Data suggests that infection with Omicron may be associated with a lower risk of hospitalization compared to infection with Delta, Singh said, but noted that the severity of illness increases with age and in the presence of underlying medical conditions and among people who are not vaccinated.

She stressed on the need to rapidly accelerate efforts to vaccinate all at-risk populations in all countries.

"There is growing evidence on vaccine effectiveness for Omicron, but we still have a lot to learn. So far, we think that vaccines are less effective against Omicron infection and symptomatic disease compared to Delta. Having a booster shot seems to increase protection," she said.

Singh said the emergence of Omicron means that the protective behaviours remain critical such as keeping a safe distance from others, avoiding crowds, wearing a well-fitted mask covering mouth and nose, cleaning hands regularly, keeping indoor spaces well ventilated, and covering coughs and sneezes.

City sees 4,483 new Covid-19 cases, 28 deaths


New Delhi: Delhi on Saturday reported 4,483 fresh Covid-19 cases, a positivity rate of 7.41 per cent and 28 deaths, according to data shared by the city

health department.
With this, the national capital's case count ihas increased to 18,23,815 and the death toll to 25,797, the latest health bulletin stated. The number of Covid-19 tests conducted a day ago was 60,532, it said.

On Friday, Delhi recorded 4,044 cases with a positivity rate of 8.60 per cent and 25 deaths. The day before, on Thursday, it recorded 4,291 cases with a positivity rate of 9.56 per cent and 34 deaths.

On Wednesday, it had logged 7,498 cases with a positivity rate of 10.59 per cent and 29 deaths.

The number of daily cases in Delhi has been on the decline after the record high of 28,867 on January 13. The city had recorded a positivity rate of 30.6 per cent on January 14,

Covid cases decline in city, but containment zone count still over 40K

New Delhi: The number of Covid-19 cases reported in Delhi has reduced significantly in the last one week from over 11,000 cases logged on January 22, but the containment zones count remains over 40,000, according to official data.

A containment zone is created by authorities to check the spread of infection if at least three cases of coronavirus are recorded in a household or in a neighbourhood. The surge in Covid cases in Delhi during the third wave of the pandemic are due to the Omicron variant of the virus which is highly transmissible.

Many families in a large number of neighbourhoods had tested positive, but medical experts have said that since the infection had happened at the same time, the recovery too will be quicker for the community as a whole, and there is less chance of more spread of infection as people are largely home isolated with a very little number of patients needing hospitalisation this time.

According to official data shared by the Delhi health department, the number of

containment zones in the city stood at 41,095 on Friday, a fall from 42,388 on Thursday.

The number of containment zones on January 22 was 43,457 when 11,486 Covid cases were recorded. The number of cases have dropped in the last one week, with over 4,000 cases logged on Friday.

However, the number of containment zones are still in the range of over 40,000.

If a household or a neighbourhood is put under a containment zone category, then movement of people in and out of that region is restricted. District officials had earlier said

that emphasis was being laid on mirco containment to arrest the spread of the infection. While home isolation protocols have undergone a change in the recent past, the containment

zone regulations still remain the

same, authorities said. Sources in the district administration authorities in Delhi said the policy to manage containment zones is still the same, meaning, a zone can be put in a de-containment zone only after a 14-day period, to check the spread of infection.

Gym owners take out protest march, demand fitness centres be allowed to reopen

New Delhi: Hundreds of gym owners on Saturday took out a protest march to Chief Minister Arvind Kejriwal's residence here to oppose the DDMA's decision to keep fitness centres closed even as the number of Covid cases have come down in the city.

Demanding that gyms and spas be allowed to reopen, and raising slogans against the government, demonstrators started their march from the Chandgi Ram Akhara to Flagstaff Road in the Civil

They, however, were stopped by police a few metres away from the chief minister's residence. Though the Delhi Disaster Management (DDMA) on Authority Thursday lifted the weekend curfew and also allowed restaurants, bars and cinema halls to operate with 50 per cent capacity, gyms and schools in the city are still shut.

Restrictions had come into force under a 'yellow alert' issued by the authority in December last year when the Covid positivity rate had crossed 0.5 per cent in the national capital.

"We took out the protest march to make the government

and the Delhi lieutenant governor (L-G) hear the plight of gym owners and others engaged in this business," said Chirag Sethi, the president of the Delhi Gym Association (DGA), under which the agitation was organised.

"The fitness industry has already suffered a lot due to the Covid pandemic in the last two years and not allowing our establishments to reopen will prove to be a death warrant for our businesses," he told

He said that Covid cases in the city have come down drastically and other business establishments such as multiplexes, restaurants and bars have been allowed to open. Then why are fitness centres not being permitted to function, Sethi asked "This is a genuine demand.

The government and the DDMA should consider it in its next meeting as soon as possible," Sethi said. Later in a statement, he claimed that fitness centres are open in neighbouring states but no surge in cases of the Omicron variant of the coronavirus is being seen because of gyms. "No case of Covid transmission has been seen in any gym all over the world," Sethi said.

"Do we want the people of Delhi to stay unhealthy, unfit and obese? If gyms are not opened soon then thousands of gym owners and their families will come on the road to protest against this," he warned in the City records max temp at 22.4 deg C New Delhi: The national

552 liquor shops opened in Capital till Jan 28 under new excise policy

New Delhi: As many as 552 liquor shops, out of 849 permitted vends, have been opened till January 28 under the Delhi Government's new excise policy, official sources said. The policy was implemented on

November 17 last year. An updated list of all the functional liquor vends has also been uploaded on the excise department's

Under the new excise policy, the liquor business in the city was completely handed over to private players wherein they can open 849 spacious and swanky vends in 32 zones having an area of at least 500 square

Such outlets will also allow walk-in facility to consumers where they can choose the alcohol brand of their choice as they do at shopping

The Delhi BJP, which is in power in the three civic bodies -North, East and South - had been opposing the policy by alleging that iquor shops have been opened in violation of norms.

Municipalities have also launched a crackdown on liquor shops, which said were set up

According to civic authorities, till

January first week, the three civic bodies have sealed nearly 25 shops and issued notices against around 130 such establishments.

"Our crackdown against illegal liquor shops continues. Yesterday, we issued notices against several liquor shops for unauthorised construction and violation of building norms," SDMC standing committee chairman B K Oberoi told PTI.

The Delhi government had moved out of retail business of liquor under the new policy through privatisation of all 849 liquor vends, more than half of which were run by its four agencies earlier.

SDMC asks officials not to answer Assembly panel's questions

The decision of the South Delhi Municipal Corporation (SDMC) asking its officials "not to answer" questions of the Delhi Assembly's privilege committee set a stage of confrontation between the Aam Aadmi Party (AAP) and the South Corporation ahead of municipal polls scheduled later this year.

AAP Chief Spokesperson and MLA Saurabh Bhardwaj termed the proposal contempt of the historical institution of Delhi Vidhan Sabha. Talking about the issue, he said that an AAP MLA had asked in the Vidhan Sabha whether the BJP pays the MCD for all the advertisements it has put up in Delhi and the MCD

Commissioner replied saying he has no information on it.
"Today the MCD is being dri-

ven into doom because the BJP puts up hoardings for free and prevents the MCD from earning from them. One hoarding is supposed to generate 1-1.15 lakh in revenue per month but the BJP is looting the MCD of 2,680 crores every year," he

Bhardwaj said, "Whenever someone heads out of their homes in Delhi, they come across a sea of advertisements of the BJP and its leaders. Be it the hoardings, the public conveniences, the street furniture, or even a loosely hanging pole, we'd see all of it has been hijacked by the BJP. This is not an

exaggeration but a fact. Everyone knows how many political ads of the BJP have been put up all over

However, Delhi BJP Spokesperson Praveen Shankar Kapoor said that South DMC's decision to not to reply to Delhi Assembly's queries is logically correct as Arvind Kejriwal Government is not implementing the 4th and 5th Delhi Finance Commission recommendations on funds for MCDs.

The Kejriwal government has refused to release funds after acceptance in Delhi Assembly, so how does it expect MCDs to reply to that Assembly's queries, he said. HC refuses to quash FIR for stalking, sexual harassment in spite of settlement between parties

New Delhi: The Delhi High Court has refused to quash an FIR against a man accused of stalking, sexual harassment and circulating morphed pictures of a girl in spite of a settlement between the parties, saving that the offences are not personal in nature but affected assault on the girl's fundamental right to live with dig-

Justice Mukta Gupta noted that the circulation of the girl's morphed photographs on an online platform resulted in several people asking for "illegal favours" from her on payment of money and that the FIR cannot be quashed merely on the ground that the petitioner is now showing repen-

The judge said that considering the nature of the allegations, it was not a fit case for quashing the FIR on the basis of a compromise.

"Considering the fact that the petitioner not only used to stop, harass, stalk and threaten the complainant but also circulated her morphed photographs on V-Chat, resulting in number of people visiting her place asking about illegal favours from her on payment of money, the alleged offences committed her leaving the coaching cenby the petitioner against the complainant cannot be said to be a personal dispute not affecting the society at all," the court said in its recent order.

The nature of offence committed by the petitioner her mother spoke to the petiagainst the complainant cannot tioner's parents who assured ground that the petitioner now shows repentance as the offence committed is a serious assault on the fundamental right to live with dignity of the complainant," it added.

The FIR in the present case was filed for the alleged commission of offences under sections 354A (sexual harassment)/354D (stalking) /341 (wrongful restraint)/506 (criminal intimidation)/507 (criminal intimidation by anonymous communication)/509 (Word, gesture or act intended to insult the modesty of a woman) of the Indian Penal

This has forced the homeless to spend the nights on the streets bearing the harsh weather, it

nearby rain baseras (night shelters)," said Sunil Kumar Aledia, founder of

He suggested government departments like the Women and Child Development Department and Social Welfare Department should work in coordination with the DUSIB to ensure the welfare of the homeless people. Delhi based Wishes and Blessings is another NGO active in providing winter essentials to the underprivileged.

The NGO distributes winter relief items to the homeless in three states -- Delhi/NCR, Jharkhand and West Bengal – and launched the eighth phase of its annual Winter Relief Project on December 20 last

In the last seven years, it has reached out to more than 20,000 homeless and underprivileged people and provided them with shawls blankets, jackets/sweaters, gloves and mufflers, socks and food. PTI

ISI to step up attacks on forces in J&K: Intel

Holds meet with terror groups after terrorist violence cases drop in J&K

RAKESH K SINGH NEW DELHI

Fin terrorist violence in Jammu and Kashmir, Pakistan's Inter-Services Intelligence (ISI) held a meeting earlier this month with the commanders of terror groups like Lashkare-Tayabba, Jaish-e-Mohammad, Al Badr and Hizbul Mujahideen in PoK and decided to step up attacks on security forces and political workers in the Valley, according to intelligence inputs.

The meeting was held at Malakpaiyan, Muzaffarabad, Pakistan-Occupied Kashmir earlier this month by one Major Yaqoob of ISI with the terror

his dissatisfaction with the tanzeem commanders over the decline in terrorist activities in the Kashmir Valley.Major Yakoob directed the commanders to make arrangements for suitable terrorist attacks in the Valley, according to an Intelligence report generated from Srinagar.

Movement of local Hizbul Mujahideen terrorist Rayees Ahmad of Joibal Veer in Anantnag and two unidentified terrorists have been observed in village Nubuk Nanil under Mattan police station in Anantnag has been reported by the agencies. Ahmad along with other two terrorists frequently visit Nubuk Nanil and are apparently planning to shift their location to an apple orchard in nearby villages. They are also in the process of recruitment of local youth from the district, officials said, quoting from the chatter picked up

This group, they said, is planning to attack security forces and political workers in between Bijbehera and Anantnag.

During the last two-three years, the security forces have neutralized a number of terrorist commanders during operations and the Pakistanbacked groups are finding it difficult to find suitable replacements. Additionally, the recruit-

ment of cadres has also taken a beating owing to a variety of factors including a crackdown on funding channels like NGOs and trade-based financing of terrorism in the Valley. The National Investigation Agency the Enforcement Directorate have undertaken a number of probes to choke terrorist financing and money laundering respectively, leading to constricted funds flow to the terror outfits, officials added.

EC bans exit polls for State polls till March 7

The Election Commission on Saturday banned all exit polls pertaining to the upcoming Assembly elections scheduled in five States — Uttar Pradesh, Goa, Uttarakhand, Punjab and Manipur - till March 7. Anyone violating the order will be punished with a two-year jail or fine or both. "Now, therefore, in exercise

of the powers under sub Section (1) of Section 126A of the RP Act 1951, the Election Commission having regard to the provisions of sub Section(2) of the said Section hereby notifies the period between 7 AM on 10 February 2022 and 6.30 PM on 7 March as the period during which conducting any exit poll and publishing or publicising by means of the print or electronic media or disner whatsoever, the result of any exit poll in connection with the aforesaid General Election shall be prohibited," the EC said in a notification on Saturday.

The poll body further said that it is clarified that under Section 126 (1) (b) of the RP Act 1951 displaying any election matter including results of any opinion poll or any other poll survey, in any electronic media, would be prohibited during the period of 48 hours ending with the hours fixed for conclusion polls in the respective polling areas in connection with General Election.

wenty-five innovation hubs I set up across the country through the National Mission on Interdisciplinary Cyber-Physical Systems (NM-ICPS) are churning out best technologies in various sectors, including the health sector to do their bit in tackling challenges thrown by Covid-19 pandemic.

For instance, ARTPARK at IISc Bangalore has developed an AI-driven platform that helps Chest X-ray interpretation of images sent over WhatsApp brought early intervention through rapid screening of Covid-19, aiding doctors who have no access to X-ray machines. Similarly, a team of scientists from IIT Bombay has developed a tapestry method for screening Covid-19 under Remedial Action, Knowledge Skimming, and Holistic Analysis of Covid-19 (RAK-SHAK), an effort supported by the Technology Innovation Hub (TIH) at IIT Jodhpur.

According to an official from the Union Ministry of Science and Technology, the ARTPARK has a solution called XraySetu which is quick and easy to use and can work with low-resolution images sent via mobiles, facilitating detection in rural areas. "Using machine learning algorithms, it generates a patient report showing suspicious abnormal regions in the lungs and detects if the person is likely positive for Covid, pneumonia, or other lung

eprosy is now completely Lcurable and can be rendered non-contagious by administering first dose of Multi-Drug-Therapy (MDT). However, India continues to be the home of around 57 per cent of the global population of people with leprosy — mainly because of stigma and discrimination against the sector.

There are at least 97 legislations at the Centre and States levels that have various clauses that allow continuation of discrimination against leprosy affected persons in the country. With such legal discrimination,

Stigma, neglect various other welfare and medical measures taken by the Government are not yielding desired results, say experts.

Taking serious note of Commission (NHRC) in an advisory to the States sought immediate removal of such legal provisions.

Of 97 legislation in the country, at least 21 are central laws while rest are implemented by the States like Andhra Pradesh, Delhi, Madhya Pradesh, Telangana, Tamil Nadu, Goa, Odisha, Punjab, Karnataka, Madhya Pradesh, Meghalaya, Bihar, Rajasthan, Uttar Pradesh, Haryana, Maharashtra, Assam, Gujarat,

West Bengal and Kerala. The clauses openly discriminate and restrict people

with leprosy from taking certain professions or contest municipality polls or enter public places.

Caused by the bacteria these legal discrepancies, the Mycobacterium leprae, leprosy al nervous system causing skin lesions, numbness, and other deformities. Latest data from the National Leprosy Eradication Programme (NLÉP) reveals that a total of 65,147 new leprosy cases were detected during 2020-21 in India.

On the eve of the World Leprosy Day, Alice Cruz, the UN Special Rapporteur on the elimination of discrimination against persons affected by leprosy and their family members took strong umbrage at the discriminatory laws, which she said whether actively enforced or not, motivates, authorizes and normalizes substantive violations, especially against women.

'The mere existence of laws allowing for divorce on the grounds of leprosy have a devastating impact on women, hinand justice," the UN expert said.

"By formalizing harmful stereotypes as lawful labels and normalizing humiliation and violence as authorized practices, such laws significantly compromise livelihoods, exclude people affected by leprosy from political and civic participation, and augment the State's negligence towards this marginalized group," she fur-

ther added. NHRC chief justice (retd) Arun Kumar Mishra in the advisory issued by the Commission also suggested the Centre to consider enacting a law to provide for substitution of "derogatory terms" used to describe persons affected by leprosy. The advisory called upon authorities to ensure that no person or any of his family against and denied all or any of the right to healthcare, employment, education and land rights.

For the betterment of lives, the NHRC urged authorities to start special programmes to provide vocational training, employment and unemployment benefits, health insurance among others.

The NHRC members also felt that besides several problems notwithstanding, the COVID-19 pandemic further worsened the condition of leprosy-affected persons, particularly with regard to their food and livelihood.

The state government told the division bench presided by Chief Justice Prakash Shrivastava that it was willing to reopen schools and colleges, but a call would be taken once the COVID-19 situation is properly analysed.

Hearing of the petitions, filed by a teacher, a student and a lawyer, were adjourned till February 14, when the state will be informing the court on its plan to reopen the educational institutions

The petitioners, claiming that long closure of the institutes was affecting education of students, prayed for a direction to the state government on reopening of schools colleges and universities for physical classes. Schools and colleges in Bengal

have largely remained shut since March 16 2020 due to the COVID-19 pandemic. Institutes had briefly opened in November last year only to close down again as number of infections started soaring across the

Self-governed social, religious trusts can't be subjected to overarching State control, says SC

New Delhi: Self-governed social and religious trusts cannot be subjected to "overarching state control" as it would undermine the principle of autonomy and democratic decision-making and would reduce the fundamental right of freedom of association "an empty husk", the Supreme Court

The verdict dealing with the right of the state instrumentalities over the affairs of registered social and religious trusts came on an appeal of Parsi Zoroastrian Anjuman, Mhow, which was denied the nod by the Registrar of the society to sell its five properties in Madhya Pradesh despite following the due procedures.

'The impugned judgment and the decision of the Registrar are hereby set aside," a bench comprising justices U U Lalit, R Ravindra Bhat, and Bela M Trivedi said and permitted the Parsi trust to implement its decision to sell its five properties after fresh valuation of each of the properties. Justice Bhat, writing the judgement, acknowledged the state's power to monitor the affairs of registered social and religious trusts to ensure that their properties are not frittered away, but said it cannot control the decision-making process of self-governed societies.

Omicron drives US deaths higher than in fall's delta wave

Omicron, the highly contagious coronavirus variant sweeping across the country, is driving the daily American death toll higher than during last fall's delta wave, with deaths likely to keep rising for days or even weeks.

The seven-day rolling average for daily new Covid-19 deaths in the US has been climbing since mid-November, reaching 2,267 on Thursday and surpassing a September peak of 2,100 when delta was the dominant variant.

Now omicron is estimated to account for nearly all the virus circulating in the nation. And even though it causes less severe disease for most people, the fact that it is more transmissible means more people are falling ill and dying.

"Omicron will push us over a million deaths," said Andrew Noymer, a public health professor at the University of California, Irvine. "That will cause a lot of There will be a lot of soul searching. discussion about what we could have done differently, how many of the deaths were preventable."

Omicron symptoms are often milder, and some infected people show no symptoms, researchers agree. But like the flu, it can be deadly, especially for people who are older, have other health problems or who are unvaccinated.

"Importantly, milder' does not mean mild," Centers for Disease Control and Prevention Director Dr. Rochelle Walensky said this week during a White House brief-

Singapore reports more infectious BA.2 'growth advantage' Omicron variant

Singapore has recently reported 198 cases of Covid-19 traced to the BA.2 Omicron sub-lineage, which appears to be more infectious than the more common BA.1, but hospitals are coping well in spite of the current wave infecting thousands of people daily, according to reports.

A total of 150 BA.2 cases

were imported infections and the remaining 48 were local cases since January 25, 2022, the TODAY newspaper reported.

Investigations into the characteristics of BA.2, including immune escape properties and virulence, should be prioritised independently (and comparatively) to BA.1, said the World Health Organisation (WHO).

The BA.2 Omicron sublineage differs from BA.1 in some of the mutations, including in the spike protein, the WHO wrote on its website. The BA.2 sub-lineage has been detected in more than 50 countries, most notably in Denmark and the UK as of

Meanwhile, Singapore reported 5,554 new COVID-19 cases, including 282 imported infections, and three deaths as of noon on

Singapore has so far recorded 338,625 cases since the start of the pandemic.

Omicron sub-lineage BA.2 has substantial over original, UK finds

The BA.2 sub-lineage of the Omicron variant of Covid-19, which is classed as a variant under investigation in the UK, spreads much faster than the original BA.1 strain but it also seems to show higher vaccine protection, health authorities said.

The UK Health Security Agency (UKHSA) said that BA.2 has an increased growth rate compared to BA.1 in all regions of England where there are enough cases to assess it. As of January 24, 1,072 genomically confirmed cases of BA.2 have been identified in England and all assessments remain preliminary whilst case numbers are relatively low.

"While growth rates can be overestimated in early analyses of a new variant, the apparent growth advantage is currently substantial," the UKHSA said.

The experts said their analysis from routine contact tracing data indicates that transmission is likely to be higher among contacts of BA.2 cases in households at around 13.4 per cent than those for contacts of other Omicron cases at 10.3 per cent in the period between December 27, 2021, to January 11, 2022.

A linked preliminary assessment did not find evidence of a difference in vaccine effectiveness against symptomatic disease for BA.2 compared to BA.1.

Third Covid wave looms in Indonesia as omicron spreads

AP JAKARTA

Indonesia is bracing for a third wave of Covid-19 infections as the highly transmissible omicron variant drives a surge in new cases, health authorities and experts said Saturday.

The country reported 9,905 new infections and seven deaths on Friday in the latest 24-hour period. It was the highest daily caseload since August last year when the country was struggling to contain a delta-driven wave.

Indonesia had recovered from last year's spike in cases and deaths that was among the worst in the region, and daily infections had fallen to about 200 by December. But cases are rising again just weeks after the country reported its first local omicron case.

Health Minister Budi Gunadi Sadikin said the next few months will be critical because omicron is spreading rapidly and massively.

Its upsurge will be extremely fast ... We will see a sharp rise in the near future," he told a news conference Friday, adding that the current wave would likely peak at the end of February or in early March.

The government has prepared mitigation measures to

deal with a potential surge, including dedicating more hospital beds for COVID-19 patients, ensuring adequate tracing and testing measures.

Singapore:Singapore is facing an epidemic of scams with victims having lost more than USD 712 million in the last five-and-a-half years as fake love on the internet remains one the most lucrative online cheating formats since 2011, according to a media report on Saturday.

Authorities have acknowledged difficulties in tackling the problem, pointing out that many of the perpetrators are based overseas, and once the money is transferred, its recovery is difficult, The Straits Times reported.

In the last five-and-a-half vears, victims have lost 965 mil-USD 712 million), it said.

The police, meanwhile, have had some success with their Anti-Scam Centre saying that of the 7,400 scams involving losses of over 201.7 million dollars (USD 148 million) last year, it was able to recover 66



The Talent Tech Outlook 2022 study is an analysis of inputs from 100 plus C-suite and human capital leaders across four continents, done by SCIKEY through surveys, social media inputs, interviews and panel discussions. study further revealed that 64 per cent employees said they are more productive working from home and feel less stressed.

The new normal for HR shifted from engaging face to face to engaging with remote employees whom they meet only virtually most of the time, it stated. More than 80 per cent of the HR managers admitted that hiring employees for full-time office presence is getting more dif-Working ficult, the study said. from home is no longer a choice but a new normal that every tech talent expects from their employer and the employers not willing to adapt will face challenges in hiring good talent and retaining those already



employed, it observed.

The tech workforce has found new love with remote working, giving them freedom and productivity that requires HR to be more trusting, it said adding that unengaged or underutilised employees will find alternatives faster and exit faster than pre-pandemic times.

"It is interesting to observe how the fast-evolving 'Future of Work' is getting past the world of conventional HR and transforming into an ecosystem that now involves people beyond the confines of company payroll and office boundaries. Welcome to the world of remote work, the gig economy, and the power of the crowd that is waiting to be explored before it explodes," SCIKEY founder and CEO Karunjit Kumar Dhir said.

Technology is already moving swiftly to change the way companies engage with their employees and get a deeper, more meaningful engagement to everyone's advantage, he

Meanwhile, the study found

that only 18 per cent of tech hiring managers are looking at using psy chological assessment as a part of the hiring process in 2022, down from 68 per cent in 2019. is the new normal the offices too will become more occasional meeting places and alternate workplaces, the

More than 67 per cent of companies admit that hiring talent with office-only working conditions has become increasingly difficult, it said.

However, two years of remote working has given a sense of new flexibility that benefits both employers and employees, it added.

The study said more than 70 per cent of HR and Tech managers admitted that giving on the spot or quick awards for a job well done is more important to retain a workforce that is scattered and needs that 'little' motivation regularly.

Over 36 per cent of the respondents have already initiated quick rewards as their model to engage and retain their talented workforce, it added.

RBI 'behind the curve' criticism: Deputy Governor Patra says approach has served us well

Mumbai: Addressing criticism of the RBI being "behind the curve" by continuing with the accommodative monetary policy stance longer than other countries, Deputy Governor Michael Patra on Friday said that so far, "the approach has served us well".

India is placed "much bet-ter" to deal with future waves of the pandemic as compared to being affected the worst in the first wave after the nationwide lockdown, he said, expressing concerns on inflation being elevated due to crude prices.

It can be noted that the RBI has been criticised in some quarters for being 'behind the curve' by holding on to its GDP growth-enhancing accommodative stance even as the pressures on its core objective of inflation become evident and at a time when many of its peers have shifted to tightening of rates. Those making such calls have been suggesting that the central bank shift its policy stance to neutral.

The US Fed has indicated that it will be switching over to hiking rates to tame the record high inflation, which is already leading to nervousness in the capital markets the world over. The comments asserting the RBI's efficacy also come just days away from the Union Budget to be presented on February 1.

"Yes, there has been criticism that RBI has fallen behind the curve but only time will tell whether or not India got it right. So far, the approach has served us well and has helped in charting a course for ourselves into the future with a difference to the rest of the world, Patra said, delivering the 18th C D Deshmukh Memorial Lecture organised by Council for Social Development.

Patra said the slew of over 100 measures taken by the central bank since the onset of the pandemic, which included conventional ones like rate cuts and also unconventional ones, have contributed significantly in engineering a turn-

around in the Indian economy.

Conceding that the impact of the measures is still unravelling, Patra said, "the overall state of the economy and of financial markets which is what these measures sought to address - provides some evidence of the efficacy or otherwise of the RBI's pandemic response." Patra said even before the start of the pandemic, the economy was already in a "cyclical downturn" with growth decelerating to a decadal low, which had forced Monetary Committee to turn accommodative in February 2019 itself and added that the central bank had already cut its key rates by a cumulative 1.35 per

cent by February 2020.

The GDP contracted by 24.2 per cent in the first quarter of FY21, which was among the deepest in the world, and the experience of the global financial crisis in 2008, where central banks led the fight, made the RBI swing into action, he said, adding that over 100 measures were taken to address stress at the system level and also in specific sec-"I would not hazard the audacity of anticipating the judgment of history, but today, India is much better placed to deal with future waves of the pandemic relative to the first wave," Patra said, pointing out that the GDP is set to grow by 9.2 per cent in FY22 after a 7.3 per cent contraction in FY21 courtesy the exports

In remarks that come at a time when oil prices touched a seven-year high of USD 90 a barrel, Patra termed inflation as being "elevated" on commodity prices, including crude oil, but admitted that it has come off the highs seen during the pandemic.

Restoration of livelihoods and the revival of MSMEs is a formidable task that lies ahead, an optimistic Patra said.

Patra also pointed out that Governor Shaktikanta Das' 13 statements during the pandemic were the leit motif around which RBI's policy response was shaped and also termed them as instrument of policy in light of the central bank utilising its conventional options.

The RBI shuns the glare of the limelight but is ever ready to act, he said, adding that the central bank will learn the lessons from the pandemic and emerge more stronger and resilient to pursue the mandate of price stability while keeping in mind the objective of growth, Patra said.

sh Barty recovered from 5-1 down in the second set to win the Australian Open final 6-3, 7-6 (2) over Danielle Collins on Saturday, ending a 44-year drought for Australian women at their home Grand Ślam tournament.

Barty was the first Australian woman into the singles final here since Wendy Turnbull in 1980 and is now the first Australian champion since Chris O'Neil in 1978.

The top-ranked Barty now has major titles on three surfaces, adding the hard court at Melbourne Park to her win on grass at Wimbledon last year and on clay at the French Open in 2019.

This is just a dream come true for me," the 25-yearold Barty said.

"I'm just so proud to be an Aussie."

Evonne Goolagong Cawley, a tennis icon with seven Grand Slam titles and a trailblazer for Indigenous athletes from Australia, was a surprise guest to present the champion's trophy to Barty, who is part of a new gener ation of Indigenous stars.

O'Neil was involved in the night, too, after carrying the trophy into the stadium for the pre-match ceremo-

"I'm an incredibly fortunate and lucky girl to have so much love in my corner," Barty said, thanking her coach and support team, her family, the organizers and the crowd. Barty hadn't dropped a set and had only conceded one service game through six matches, against American Amanda Anisimova in the fourth round.

The 28-year-old Collins was the fourth American to take on Barty in four consecutive rounds. Barty had beaten Anisimova, Jessica Pegula and 2017 U.S. Open runner-up Madison Keys in straight sets.
Collins had spent more than four hours longer on

court than Barty in her previous six matches, having to come back from a set and break down to beat Danish teenager Clara Tauson in the third round and rally from a set down to beat Elise Mertens in the fourth.

Barty took the first set after saving a break point in Garros.

Not to be outdone, Collins hit back quickly with her high-intensity game, breaking Barty's serve in the second and sixth games to take a 5-1 lead.

Collins twice served for the set and

twice was within two points of leveling the match and taking her first Grand Slam final to a deciding set. But Barty launched a comeback, picking up the energy from an almost full house in Rod Laver Arena, despite government restrictions on ticket sales in the COVID-19 pandemic. She won five of the next six games to force a tiebreaker and then took control by racing to a 4-0 lead. "As an Aussie, the most important

part of this tournament is being able to share it with so many people Barty said.

"This crowd is one of the most fun I've ever played in

You relaxed me, forced me to play my best tennis."

Barty congratulated Collins and told her she "absolutely" belonged in the Top 10, adding: "I know you'll be fighting for many of these in future." The run to the final was the best at a Grand Slam so far for Collins, who reached the semifinals in Australia in 2019 and the quarterfinals at Roland

for the third wicket, Pakistan were always behind in their chase and eventually crumbled to 157 all out with the wickets shared among the Australian bowlers.


Pakistan won the toss and elected to field, but soon regretted that decision as Kellaway and Wylie (71) put on 86 for the first wicket.



It is a well-known fact that CO2 is contributing to global warming. But there are other greenhouse gases like methane that also influence climate change. The present speed at which the change is happening is disruptive. SHALINI SAKSENA speaks with climatologist PROFESSOR MURARI LAL who says that solution lies in newage technology

study published by researchers at Duke University has thrown some alarming figures. It says that India has lost 259 billion hours of labour annually between 2001 and 2020 due to global warming. The loss of labour hours due to humid heat has cost India ₹46 lakh crore which is equivalent to almost seven per cent of the nation's gross domestic product

Carbon dioxide, a by-product of fossil fuel combustion, is the principal greenhouse gas contributing to global warming. However, climate change is also influenced by greenhouse gases, including methane, nitrous oxide, and other industrial-process gases.

One is told that methane is 24 times more potent greenhouse gas than carbon dioxide with important implications for climate change. "Although methane has a much shorter atmospheric lifetime than carbon dioxide (CO2) — around 12 years, compared with centuries for CO2 — it absorbs much more energy while in the atmosphere. The methane gas (CH4) accounts for 18 per cent of greenhouse gases, is responsible for more than a quarter of global warming which comes majorly from landfills, agriculture, and the energy industry. Thus, while methane tends to receive less attention than CO2 until now, reducing methane emissions will be critical for avoiding the worst effects of climate change," Professor Murari Lal, a climatologist

Besides the Glasgow Declaration and the parties' individual Nationally-Determined Commitments (NDCs) to limit emissions in COP 26 (as agreed under the Paris Agreement), more than 100 countries signed a first-of-its-kind pledge to cut emissions of methane by 30 per cent by 2030, in combating climate change. The signatories represent 70 per cent of the global economy, including six of the world's top 10 methane polluters. Reducing methane emissions from oil and gas operations is among the most cost-effective and impactful actions that governments can take to achieve global climate goals.

The importance of this breakthrough in COP 26 can't be overlooked and yet it sounds too good to be true. A major concern is that several methane polluting nations — including Turkmenistan and Russia — haven't signed the pledge. Similarly, the commitment is voluntary and lacks enforcement mechanisms, as is the Paris Agreement. Therefore, its success will depend on countries holding themselves (and each other) accountable. Unfortunately, the world has a bad track record when it comes to this," Lal opines

Unlike CO2, methane only lasts for 12 years in the atmosphere. Methane, that has a higher global warming potential, traps heat in the atmosphere 80 times more effectively than CO2; therefore even a tiny amount of it in the atmosphere can have huge effects on the climate. Reducing methane emissions in the atmosphere will pay off very quickly for the planet and for human health. Also, up to half of human-generated methane emissions can be cut at low or even negative cost using existing technology.

The world's wetlands contribute about three-quarters (75 per cent) of the enduring natural sources of methane. Agriculture and livestock on the other hand is the largest anthropogenic source of methane emissions, accounting for around a quarter of the total, followed by the energy sector, which includes and biofuels. The oil and gas sector emitted around 70 metric tonne of methane (approximately 2.1 Gt CO2-eq) in 2020 — over five per cent of global energy-related greenhouse gas

"The present speed of warming of our planet is much faster than what we have experienced historically, and climate change at that speed is disruptive. It is not just a matter of getting warmer; traditional growing seasons and weather patterns will change, disrupting our established ways of life, including how we produce our food. It is in this context that perhaps reducing methane emissions is one of the most cost-effective strategies to rapidly reduce the rate of warming and contribute significantly to global efforts to limit temperature rise to 1.5° C. The UN has called for a 45 per cent reduction in methane emissions below a 2030 business-as-usual baseline, an aggressive cut that would avoid nearly 0.3° C of global warming by the 2040s, while improving human health and agricultural yields through reduced ground level ozone," Lal says.

Wetlands remain a major area of concern with respect to climate change. Recent studies suggest that high rates of anaerobic (no oxygen) methane oxidation in freshwater wetlands can substantially reduce atmospheric emissions of methane. Methane, primarily from agriculture and livestock, contributes 16 per cent of all anthropogenic greenhouse gas emissions. Waste management, energy use (which includes coal, oil, natural gas and biofuel), and biomass burning also contribute to CH4 emissions.

Methane routinely leaks out from oil and gas wells, pipelines, and processing facilities into the atmosphere, exacerbating climate change. Methane is also emitted by natural sources like natural wetlands. Past estimates have suggested that about 2.5 per cent of human-induced climate warming can be attributed to rice farming.

"Rice production is estimated to be responsible for 10 per cent to 12 per cent of total methane global emissions, mainly due to its anaerobic decomposition during its production processes. The flooded rice fields in waterlogged soil is a perfect breeding ground for methanogens, the microbes that produce methane gas," Lal tells you

Approximately 20 per cent of India's anthropogenic methane emissions come from enteric fermentation, manure management, coal mines, municipal solid waste, natural gas, and oil systems. Wetland rice fields have been identified as one of the major sources of methane emission in India.

"Methane emission from wetland rice cultivation is expected to increase due to the likely intensification of rice cultivation in the coming decades. Alternate wetting and drying irrigation can effectively reduce CH4 emissions and total water use. Improved high yielding rice varieties together with efficient cultivation techniques will also significantly contribute to the curtailment of the methane emission fluxes," Lal says

China is responsible for the most emisıltural pr by India, Brazil and the US during the past 20 years. Together, these top four agricultural emitters were responsible for 37 per cent of global agricultural production emissions. China and India's agricultural production emissions have increased by 16 per cent and 14 per cent, respectively since 2000. However, in terms of per capita agricultural emissions, the top three countries are Australia, Argentina and Brazil.

"In order to keep warming to 1.5° C, the limit scientists assert is necessary for prevent-

ing some of the worst impacts of climate change, significant changes in technology, policies and farming practices would be necessary to reduce agricultural production emissions (mainly nitrous oxide from synthetic nitrogen fertilizer use and production, and carbon dioxide, both from energy used to produce fertilizer and other chemicals, and from generating electricity for farm use) by 40 per cent between 2016 and 2050 and increase carbon removal from the atmosphere with vast amounts of reforestation," he explains.

He tells you that majority of agricultural

production emissions come from raising live-"Globally, more than 70 billion animals are raised annually for human consumption. The

biggest single source is methane from cow burps and manure. Enteric fermentation (fermenting acetate and H2-CO2 in soils into methane and carbon dioxide) — a natural digestive process that occurs in ruminant animals such as cattle, sheep and goats accounts for about 40 per cent of agricultural production emissions in the past 20 years (primarily methane, mostly from cattle digesting from manure management)," he says.

In India, major contribution to methane emission by livestock during the past few decades has from buffalo, followed by cattle, swine, goat, sheep and other species. Buffalo shared about half (50.8 per cent) and cattle 39.6 per cent of the total manure methane

Interestingly, only marginal changes in head count of these livestock have taken place in India during the past one and a half decade. Methane emissions in future from dairy and other categories of livestock populations could be reduced substantially through proper dairy herd management (and diet management e.g., feeding garlic plants to live stocks) without compromising animal production.

The natural gas demand is expected to grow worldwide in the coming decades in contrasts to coal and oil, which would drop globally by almost 60 per cent and 30 per cent respectively by 2040. Fossil fuel operations currently generate nearly one-third of all methane emissions from human activity. Action on methane is therefore one of the most effective steps the energy sector can take to mitigate climate change.

Quantitatively, the energy sector is responsible for around 25 per cent to 30 per cent of the total anthropogenic methane emissions which includes emissions from coal, oil, natural gas and biofuels. In the oil and natural gas industry, methane is released during upstream production when natural gas is flared or vented. Methane is also released in small leaks, called fugitive emissions, from faulty valves and drilling equipment (unintentional releases) used in drilling and production.

One of the biggest hurdles to effective regulation of methane from the energy sectorincluding oil, natural gas, coal and bioenergy is the extent of uncertainty — about the magnitude of emissions, emissions sources and variability including lack of reliable data on

According to IEA estimates, the methane emissions from the oil and gas sector will need to fall to around 20 metric tonne per year by 2030 — a drop of more than 70 per cent from levels in 2020. It is recognised now that methane leaks are not an inevitable part of today's oil and gas business. They can be reduced cost-effectively — and this has to happen if the world is to address climate change.

Considering average natural gas prices from 2017-2021, almost 45 per cent of current methane emissions from oil and gas operations could be avoided with measures that would have no net cost. Policy makers have at their disposal well-established policy tools that

have already been demonstrated in multiple contexts to drive these emissions reductions. for instance Leak Detection and Repair (LDAR) requirements, staple technology standards and a ban on non-emergency flaring and

Unfortunately, the methane releases and leaks in the oil and natural gas industry are often intermittent and easy to miss. In local but they are not very effective.

Drone and airplane surveys are time-consuming and costly, and most of the world is inaccessible by air.

The solution lies in powerful new imaging technology. "A methane-hunting satellite can sniff out the emissions and track them to their sources. Various satellites with multiple sensors in operation today can provide estimates of the atmospheric concentration of methane across geographic areas," Lal says.

For example, the satellite Sentinel 5P (Precursor), part of the European Space Agency (ESA) Copernicus programme, provides readings of methane concentration across areas of 5 km by 7.5 km, covering the whole world on average every four days. The satellite GHGSat covers a much smaller area each day but can provide data at a very fine spatial resolution (around 50 m by 50 m).

"The coverage and accuracy of these readings is only going to improve, especially with the envisaged launches of the Environmental Defense Fund's MethaneSat, ESA's Sentinel 5 and additional satellites from GHGSat. Targeting emitters on a global scale from space in the coming years would be an important new tool for routine sustained monitoring of greenhouse gases for developing regulations and guiding enforcement to combat climate change," Lal tells you.

We have never been more in need of urgent action than now to combat climate change. There has been a shift in the scientific community's awareness of the scale and speed of needed action. There is not much time left to avoid setting the world on a dangerous, potentially catastrophic trajectory.

'For the climate crisis to be resolved, the world must first reduce greenhouse gas emissions significantly and then achieve net-zero emissions by the middle of the century or earlier. Methane leaks from abandoned oil and gas wells must be prevented and coal mines must be cleaned up. The challenge presented by methane emissions from oil and gas in tackling the major leaks promptly would also require key oil companies to pursue and maintain high operational standards, and policy makers to put in place well-designed technical support and policy regulations. A smart national action plan would be needed that would require polluters to pay for their methane emissions — and offer oil and gas companies help in cleaning up their act. Since methane is a valuable product in the oil and gas industry and can often be sold if it is captured, this revenue can help offset some of the costs of deploying the measures needed to prevent the emissions and leaks," Lal says.





• According to the Hindu scriptures, the civilisation is divided time wise into four Yugas. The Vedas state that the first Yuga, the Satya, was the purest and the holiest of the Yugas. Slowly and steadily, degeneration began creeping in the other Yugas. Kalyug is said to be the last and the most degenerate of the four Yugas. It has been predicted, that in the end of the Kalyug, the world will be destroyed, and the previous cycle of the Yugas will be repeated.

• Hindu mythology states that the first Yuga or the Satya Yug, spanned a period of 1,72,8000 years. It was the age of truth enlightenment, virtue, and reason. It was the golden age. Because of the ideal state of mind and body, the normal height of a person was approximately 31 feet and people lived for hundreds and thou-

sands of years. • Next comes the *Treta Yug*, second of the Yugas. By the end of the Satya Yug and the beginning of the Treta Yug, the purity of the Satya Yug had begun diminishing somewhat. According to the ancient scripts the Treta Yug was of 1,296,000 human years. Tamas and Rajas Gunas had now begun mixing with the purity of thoughts and deeds. A human being's physiology and life span too had become shorter.

• The third Yug was the Dwapar Yug. It is said that in the Dwapar Yug, the good and the evil had become equal to each other. Thirst for power had reared its ugly head as amply personified in the Mahabharat. Dwapar Yug is said to have lasted 864,000 years and the average life

span shortened to about 1,000 years. • The last age of the Yug cycle is the Kali Yug. It is the shortest Yug and will last for 432,000 human years. Approximately 5,000 years have passed of the *Kali Yug*. Corruptions of all kinds will be prevalent in this *Yug*. There will be little, or no conscience left. Human beings will be at the lowest both in terms of physicality and intellect. The average life span will be from 100 to 120 years and the average height will be between 5 to 6 feet. It has also been predicted that in the last stages of the Kalyug, man's life span will be around 20 years.

I am clubbing mythology and epics together here. Many scientists now agree that many modern-day weapons can be traced back to the ancient times when celestial weapons were used by Bhagwan Ram or by the characters of Mahabharat. I have described some of these divine weapons in my trilogy of the war between demons and human beings too. One such instance was when the protagonist of the book 'The Demons of Jaitraya,' used the Narayan astra to destroy the demons. BAPU: A HINDU PATRIOT

Making of a Hindu Patriot: Background of Gandhiji's Hind Swaraj by JK Bajaj & MD Srinivas, is based mostly on Gandhi's own correspondences & conversations, writes KUMAR CHELLAPPAN


early eight decades after his assassination, Mohandas Karamchand Gandhi, known as Bapu or Mahatma remains an enigma. Hundreds of books have been written about this man who took the world by storm during and after his life. Gandhi continues to be read, written, discussed and debated hotly by the world with the same passion or even more than while he was alive. The year 2024 marks the 155th anniversary of the Mahatma and the nation has set many targets and agendas to be realised to coincide with the occasion. Is there anybody anywhere in the world who could wield this kind of influence and love even after 75 years of his demise? It could be Gandhi's simplicity that had made him so dear to all.

The movie *Gandhi* directed by Richard Attenborough is ideal to understand the man. What comes to mind is the scene in which Gandhi holds a serious discussion at Sabarmati Ashram with Sardar Patel, Nehru and hopefully Jinnah about the Britishs proposal to divide India. The mood and tone of the scene are solemn, serious and sedate. All were discussing about the future of India. A tiny girl enters the scene with a baby sheep and complains to Gandhi about the injury suffered by it. "Gentlemen, if you excuse me..." said the Father of the Nation as he walked out to attend to the injury of the pet. This was Gandhi.

Cut to 1992. Immediately after the

demolition of the disputed structure at Ram Janmabhumi, the nation witnessed a furore. The then Union Government in its bid to douse the flames of communal riots asked all State Governments to hold peace meetings in all districts. I was working as a programme officer in the FM station of All India Radio, Kochi and was deputed to cover many such peace meetings. The speeches delivered by the politicians were to be recorded and aired as radio reports every evening. The only negative side of these meetings were the blunders coming out of the politicians! Many of them strongly believed that Mahatma Gandhi was closely related to Indira Gandhi! Two ministers claimed that the Ram Rajya about which Gandhi had dreamt was not that of Lord Ram but another Ram who was a Dalit contemporary of the Father of the Nation!

Another controversy that is going the rounds these days is that a politician commenting that he would not accept the Mahatma as the Father of the Nation. Gandhi was never after any names or titles. It was he who suggested that Dadabhoy



Naoroji should be honoured with this title. So much so that even his assassin Nathuram Godse got immortality with his essay "*Why I assassinated Gandhi*" which was published in 1968 following the Bombay High Court's lifting the ban order. Persons who are yet to understand the apostle of peace had the audacity to describe the Maoists as "Gandhians with AK-47".

There is a Malayalam drama by name "Supreme Court" authored and directed by late N N Pillai in the early 1970s in which the latter tells that Godse was far better than the present day followers of Gandhi. "Godse murdered Mahatma only once. But Mahatma's so called followers are murdering him daily, every minute," said Pillai, the acharya of Malayalam theatre.

Though there are many books on Gandhi, the one which remained engraved in the mind was *The Life of Mahatma Gandhi* by Louis Fischer. Fischer had no personal or political agenda to push and the work is considered as a straightforward biography of the Mahatma. Though there are many studies on Gandhian philosophy held by hundreds of scholars and volumes have been written about this branch of "science" none of them could make any impact in our

minds as Gandhiji himself had explained in his words his life and mission. What the scholars did hitherto was to selectively analyse and put words into the mouth of Gandhi and this ended up in our politicians pontificating from podiums that his Ram was different from Lord Ram of Ramayana.


The gross injustice did by Gandhi *Bhakts* was to replace the term Harijan (people of God) with the word Dalit, a boorish term which the Mahatma had never uttered in his life. Acharya M K Kunhol, Kerala's lone and true Gandhian, says that the removal of the word Harijan was the biggest crime perpetrated by the self-styled followers of Gandhi.

Well, this Gandhi Jayanti coincided with the publication of "Making of a Hindu Patriot: Background of Gandhiji's Hind Swaraj", a pathbreaking work spread across 1,043 pages and authored by J K Bajaj and M D Srinivas of Centre for Policy Studies. The philosophy of Mahatma Gandhi has been rebooted, revived, retold and re-energised by these two theoretical physicists. The work took them through the Collected Works of Mahatma Gandhi (CWMG-literally speaking an ocean of knowledge) in its entirety and the vintage Gandhian philos-

ophy has been presented by the authors without any prejudice. A serious reading of this book would make Godse turn in his graveyard and he is likely to plead with the judge who sentenced him to death for another death sentence. Godse for sure had fired at the wrong person!

In a situation straight taken out from courtrooms, Bajaj and Srinivas present before us what Mahatma Gandhi wrote and spoke about various issues in his non-violent fight against the colonial masters, the British imperialists. The authors present the Mahatama's original words which were culled from his own writings and speeches without giving any interpretation.

Bajaj and Srinivas tell us how Gandhi got converted himself into a true Hindu, a Hindu Patriot, by exploring and undertaking an expedition into Hinduism. Why he chose the mission was because of friends from Christianity and Islam who exerted pressure on him to get converted to their religions. Gandhi undertook a serious study into Christianity and Islam along with that of Hinduism. It took Gandhi to a great truth and also to the answer which he was asking himself; what is a Hindu and who is a Hindu? What are his responsibilities and



what the world expects from a Hindu. Gandhi ji studied about India's civilisation and the modern Western civilisation. What he understood was that the Indian and western civilisations represented two distinctly different ways of being which were difficult if not impossible to reconcile.

The CWMG explains in his own words what Satyagraha stands for. For the first time in history, these two scientists bring out the meaning of Satyagraha to the people of India. In Gandhi's own words, Satyagraha is a religious instrument. "It is a struggle carried out with God as witness to preserve the sacred dignity of the religious person. It is not an agitation to win concessions or rights. Self suffering is what makes Indian civilisation different from Western civilisation. The heart of Indian civilisation is religion while that of Western civilisation is irreligion", Gandhiji writes while recounting his South African days. This translation of Satyagraha as visualised by Mahatma Gandhi is certain to put the rationalists and atheists on the defensive as they usually resort to this kind of demonstration to extract concessions from those in power. Equally interesting is the startling disclosure about Hind Swaraj. Gandhiji says that religious duty and patriotic duty are one and the same. "Hind Swaraj is nothing but religious patriotism. My love for India is derived from my religion. Hind Swaraj is

based on *Dharma*," explain the authors quoting from what Gandhi*ji* has said in his original work in Gujarati.

Gandhi also said that he does not want the Britishers to leave India. "The ideal solution of the conflict between the British rulers and the Indian subjects is that the relationship between the ruler and the ruled be anchored in Dharma. Hind Swaraj does not ask the English to leave India but to remain and rule in accordance with Dharma. If they were to agree to rule in such a manner it would be for the good of all. So doing, we shall benefit each other and the world. But that will happen only when the root of our relationship is sunk in a religious soil", he writes in Hind Swaraj 3:97. To drive home his Bharateeyata, the Mahatma reminiscences his formative years. "I grew up reading Ramayana and Bhagavad Gita. My life was moulded by the stories in Ramayana, slokas in Bhagavad Gita and the teachers who taught me the same. The youth and children of those days have made it a routine habit and life style to read Ramayana and Bhagavad Gita," he has written.

What made the Mahatma sad was the kind of work being done by evangelists and missionaries in the country. He says he was taken aback by the kind of language used by the evangelists and missionaries against Hinduism. "Christian missionaries used to stand in a corner near the high school ad hold forth, pouring abuse on Hindus and gods. I could not endure this.." says Mahatma Gandhi in "Glimpses of Religion". But then why did he not openly question this attitude of the proselytisers? It is the under hand methods and illegal means employed by the missionaries and evangelists that form the root cause of the tension between the religions. "I am a Hindu and I am tolerant. Only a Hindu can be tolerant and he alone will be able to co-exist with believers in other religions," he said.

The uniqueness of "Making of a Hindu Patriot" is that Bajaj and Srinivas, while analysing threadbare what the Mahatma has written, substantiate the same with documentary evidences which are nothing other than the latter's own words. Only Mahatma Gandhi could repudiate what Bajaj and Srinivas have written. The authors drive home an important lesson: Never try to analyse Mahatma Gandhi with ulterior motives or agendas. These two scholars earn full marks in their effort to portray the real Mahatma. Let this work be read widely and discussed. That is the biggest tribute we can offer to the Father of the Nation who had said that his life was his message.

Advertising in feminist discourse

Stereotyping & objectification of women in the media narrative is a universal truth, that need to be addressed, questioned & reversed, writes JAISHRI JETHWANEY in her new book. An edited excerpt:

he 1970s saw the rise of trade unionism and advocacy movements for civil liberties, especially after the clamping of emergency by Mrs. Indira Gandhi in 1975. Further, in 1974 a document was prepared on the Status of Women by the official Status of Women Commission, titled 'Towards Equality.' It focused attention on the fact that, despite many progressive social legislations and constitutional guarantees, women's status in India had indeed not improved much, especially in many areas like political, economic and social spheres. This document has been the basis for many legislations and development programs focusing on gender as well as creation of women's organizations and working groups — as discussed later. The United Nations declared 1975 as the International Year for women and 8 March as the International Day for

The last 70+ years of independence has seen many organizations springing up that have espoused the cause of women, both in the cities and at grassroots level. Domestic violence, alcoholism, female feticide, sexual harassment of women at work place, skewed and unjust family laws, reproductive rights, legislative reforms are some of the issues spearheaded by civil society organizations and NGOs. On the academic front, many universities in the 1970s set up Women Studies' centres.

A pioneer in Women's studies, Dr. Vina Mazumdar was the first one in the independent India to combine activism with scholarly research in women's studies.

Vina Mazumdar [1994] argues that women became a point of engagement in politics as well as research and academia during the colonial rule with an objective to justify both social reform or to give a backbone for India's cultural pride. She writes that this however, became redundant in post-independent India, as the need for justification was no longer necessary. This may have in some way led to the side-lining of women's issue and with that the increase in gender disparity between men and women. This gap was highlighted in the investigation by the



Committee on the Status of Women in India and the subsequent report 'Towards Equality' 1975. With this, a new agenda was set to change the status of women and for that research on women's issue was one area, which received the impetus. A new program for Women's Studies, initiated by the ICSSR began which, over the years has seen a lot of seminal work in this arena. This went along with several other processes of bringing about change and empowerment as the larger women's movement also went along. Critics however, feel that in the beginning, there was a lot of academia — civil society interface, which over the years, has eroded.

Many UN organizations like the UNICEF, UNFPO and UNESCO have also entered the policy dialogue with the government based on milestones articulated in the UN Sustainable Development Goals (SGDs) of which India is a signature.

EQUAL RIGHTS AND OPPORTUNITIES GUARANTEED BY CONSTITUTION OF INDIA


The Constitution of India provides equal status and opportunities to women along with men. The Indian women received equal political rights for which their western counterparts had to fight a long battle.

WOMEN-CENTRIC LAWSSince the country's independence in

1947, many laws have been passed to address the issues of equal opportunities for women at work place and home to address issues of sexual harassment at work place, domestic violence, dowry, and female infanticide, and feticide, property rights among others. Discrimination, however, is so well entrenched in the patriarchal mind-set of the society coupled with ignorance and centuries of subjugation that both the urban and the rural women

endure (particularly the latter as they suffer in larger measure in every possible way) when it comes to equality. Women, especially in the rural arena are raped and wronged to settle caste rivalries. Young women choosing to wed out of caste and religion often become victims of honour killing. Who they can marry, what they would wear, how they would behave are sometime issues discussed in the illegal Khap panchayats, while the state administration is often seen as a mute spectator.

The passing of the two acts viz. Sexual Harassment of Women at Workplace (Prohibition), 2013, and the Indecent Portrayal of Women in Media (Prohibition), 1986, together with many other acts including against those against domestic violence, dowry, and sex determination as well as the setting up of the National Commission for Women (NCW) at the centre and other state level commissions are pointers to the efforts by myri-



ad women rights organizations in influencing policy and also various governments in addressing women issues.

Having said that, there is no gain saying that there are laws in place but it is the implementation, which is more often lax. Social transformation accompanied with implementation of laws shall be the key to address women related issues in India. The feminist literature and movements bear testimony to the fact that feminism is very much home grown and organic in India and not a copy of the West as generally alleged. The feminist movement is not against men but about fighting the power structures that are so well embedded in the familial, social, political and economic spheres.

Burkina Faso military can't win war against jehadi

 B^{urkina} Faso, a West African country, has fallen into the hands of the country's military. Its armed forces have ousted democratically President Roch Marc Christian Kabore who was in power since 2015. The main reason behind the military takeover seems for now is to crush the growing tide of Islamic fundamentalist forces as the Kabore failed to tackle the menace. The mutinous soldiers quietly stormed his house and took him to safe custody. Meanwhile, Captain Sidore Kader Ouderaogo, the spokesperson of the military, who addressed the media immediately after the coup, said that the military has dissolved the Government and the National Assembly and suspended the Constitution.

Why the Army has taken such a drastic and immediate step? For long, both the Army and the people have been complaining about the inaction of Kabore against the rising militancy of al-Qaeda and Islamic State (ISIS) in the country. And the deposed President was not adequately supporting the security forces in the fight against fast-engulfing insurgency of the jehadi.

How serious was the threat posed by the Islamic militancy in the country? Indeed, the chaos sparked by the Islamic jehadi is spreading in this poor nation, similar to what is happening in many other African nations. And the Government of Kabore has been facing growing public criticism for a long time for failing to stem the roots of militants' insurgency. These terror groups have brought a large swathe of lands under their control by displacing about 1.4 million people over the years.

The statement released by the Army came from an organisation called the Patriotic Movement for Safeguard and Restoration or MPSR. Precisely, the MPSR is an almost unheard identity that claims to represent almost all factions of the Army that desperately wanted to put an end to the reign of Kabore.

The military leader behind the quiet coup in Burkina Faso, Lieutenant Colonel Paul-Henri Sandaogo Damiba, once started his career as a part of the prestigious presidential guard of former President Blaise Compaore, who ruled the had to quit as massive popular uprising came up against him all around the country. Damiba studied in France at a military academy and had a master's in criminal sciences from there. Interestingly, he had been in

the forefront in the country's fight against Islamic militancy in the past. He also opposed a military coup in 2015 that lasted for nearly a week. The 41-year-old officer penned down a book on Islamic militancy in 2021 called "West African Armies and Terrorism: Uncertain Responses?" It is Damiba who could now save the country from slipping into an abyss. Ironically, the chaos in Burkina Faso did not all emerge in the country itself. Its roots lie in neighbouring Mali, a long terror-infested nation that has witnessed the evil designs of major Islamic groups of western Africa.

Islamic militancy has been on the rise in Burkina Faso since 2015. Nearly 2,000 lives have been lost in terror attack since then. In fact, schools are getting closed in several parts country till 2014. Compaore of the country as terror attacks and networks have become rampant. In June 2021, the terrorists had taken the lives of 100 people in the northern village of Solhan. And this time, a relatively calm atmosphere terrorists have crossed over to Burkina Faso from neigh-

bouring Mali. This Solhan saga prompted the Opposition forces to demand the immediate resignation of Kabore. He then had to immediately reshuffle the Government and appointed himself as the Defence Minister of the country. But by November 2021, another ghastly attack on the Inata military base ramped up the cry against the Government all over the country. During this attack, more than 50 security men were killed. The worst part of the tragedy was that these soldiers were sending requests for food and more ammunitions two weeks before the attack which never reached them. This being another setback for Kabore, he immediately sacked the Government by appointing a new Prime Minister and Defence Minister ahead of national reconciliation dialogue with the Opposition.

How the trouble started in Burkina Faso? Despite West Africa's security and political volatility, Burkina Faso enjoyed for some years in the past. But this fragile stability did not last

for long time. It all came to a halt when a popular uprising suddenly brought down the regime of long-time former President Compaore in 2014. Again, a military coup in 2015 left the country's military widely divided about the future of the nation. And in the same year, Kabore was elected on a promise to unify the country.

Clearly, the trouble began in Burkina Faso with the coming of Campaore to power in the year 1987. He took power in that year through a coup and managed the first four elections till 2010. But in the same year, his election victory was widely contested. Also people and Opposition parties came out to protest his attempt to amend the country's Constitution and extend his rule. Finally, he had to quit in 2014 and took refuge in Ivory Coast. And then, his former Prime Minister and national assembly President Kampore took over in

November 2015. From 2015 onwards, capital city Ouagadougou and most parts of the north of the country encountered constant kidnappings and attacks mounted by various terror groups either affiliated to al-Qaeda or the ISIS. On January 15, 2016, the jihadists attacked the posh Splendid Hotel and a restaurant killing nearly 30 people, mostly westerners. This sudden strike of the Islamists shocked the Western Governments, particularly the year-old Government of Kampore. Further, this indicated the vulnerability of the security system at the very heart of the country. By 2017, the former colonial power France backed G5 forces began its cross border joint operations in three West African nations — Mali, Burkina Faso and Niger.

However, with all these multi-national operations, the jihadists did not relent their targeted attacks. This time, the terror outfits mounted their assault on French forces and its embassy in the capital, killing 8 soldiers and injuring about 85 civilians in the beginning of the year 2018. The Government of Kampore couldn't be of much help against the massive forces the terrorists. But

Ouagadougou simply clamped a national emergency in various provinces by the end of the 2018. And the worst descended in Burkina Faso in 2019. Terror-related incidents have become a regular affair across the country, almost pushing the country into the brink of a massive civil war like scenario.

A helpless Kampore, by

putting all the blames on the Armed Forces, simply sacked the head of the Army and brought a new government to the capital. This time by the end of 2019, Burkina Faso saw a massive attack by the armed fighters over an army base near Mali border, called Arbinda that led to the death of more than 42 people. In the midst of the crisis, Kampore got re-elected to the presidency in November 2020, but voters could not cast their ballot because of the wide-ranging threats from the radical groups. And Kampore's second term witnessed chaos across Burkina Faso.

Meanwhile, the UN, the West African bloc known as the Economic Community of

West African States (ECOW-AS) and the African Union condemned the sudden power grab by the Burkina Faso military. Currently, the whereabouts of Kabore, who won the second term in office in 2020 is not known. Many of the antigovernment protesters who directly supported military takeover say that the ECOW-AS does not care about their country and the international community is simply condemning terrorist violence in Burkina Faso.

UN Secretary General Antonio Guterres said in a statement that he strongly condemns any attempted takeover of government by the force of arms, calling it a coup. He also said that the coup leaders must lay down their arms and ensure the safety of the President and the protection of the country's institutions. Both the ECOW-AS and the African Union held the soldiers responsible for safety of Kabore. The US said it is deeply concerned about the developments in Burkina Faso and urged a swift return to civilian rule. JosepBorrell, the European Union's High Representative, said the bloc was very worried about the evolution of the situation in Burkina Faso. French President Emmanuel Macron condemned the coup and said that he planned to hold talks on the matter with regional leaders. Till 1960, Burkina Faso was a French colony when it got

independence. Interestingly, the Chinese Foreign Ministry also reacted to the political developments in Burkina Faso and called for all parties in the country to peacefully resolve differences via dialogue and safeguard nation-

Combating terrorism during pandemic

hogged the limelight, terror organisations from across the border have unleashed a wave of terror in Kashmir to attract attention from the media to upturn the diminishing morale of the mercenaries.

Seen in this perspective are the recent sinister designs of the terror forces in Pulwama and Shopian districts of the Valley. In the past few days, the insurgency has resulted in the martyrdom of five Army soldiers and three CRPF men in the Valley.

This highlights the continued challenges the Government faces on this terror front despite exigencies of its war on Covid-19, which has come as a hindrance in the resolve to fight terror.

There is an urgent need for creating a long route of cominternational mechanism to deal with monster head on. And within the country, India should have in place a multilayered security apparatus to promptly deal

India needs to be quite agile and very prompt in case of a surprise challenge. Hence, cooperation in building communication capability and management of security arrangements to deal with any kind of threat is the main weapon in the combat

Although India has boosted cooperation in this direction, the catch here is how to generate prudence to anticipate any possible threat from insur-

There is strong need for a quick mechanism to facilitate cooperation between the security and defence establishment among the nations of the world. It should chalk out strategies how to deal with the worst scenario in which biological and chemical weapons fall into the hands of new breed of terrorists.

International cooperation in terms of forming strict laws and regulations to prevent the possession of biological and chemical weapons can provide a strategic management in dealing with the worst form of terrorism. Cooperation between the Government and the media can ensure quality assurance and positive outlook in patching the differences and defeating terrorism. India has already in place

a mechanism that gathers sufficient data about the area within which the event is unfolding. There has been a hidden strategy to whip up religious sentiments that has helped certain terrorist organisations create and reinforce their base to indulge in proxy war with States across the globe. New fear psychosis induced by terrorists is more pernicious since it involves local populace in creating disturbance through stone pelting and shouting anti-India slo-

Besides, the rampant use of

explosive devices in public places has become an impor-

tant part of their tactics. À combating strategy has to be a combination of various tactics such as eliciting prior knowledge about the possible terrorist attack, learning secretive mission of the intruders and creating cognitive dissonance through relentless application of latest information on changing strategies with feedback from those deployed and constant interactive communication with various branches dealing with

law and order maintenance on daily basis. Therefore, there is an urgent need for integrated programmes and services which support both Army and local police making them more efficient with present circumstances of dealing with the worst form of propaganda

Many efforts have been made by a number of nations to control State-sponsored terrorism, such as through eco-

battery operated improvised nomic sanctions, but so far they have not reached a consensus either at the national or glob-

al level. During the last two decades, increasing drug smuggling and the unholy nexus between drug smugglers and terrorists have posed a serious problem to the internal Statesecurity networks and compelled various nations to organise themselves and wage a relentless war against such a

But mere implementation of vigorous drug laws cannot become effective unless the judicial procedure is modified for ensuring speedy trials. The continuing uncertainties with regard to terrorism have encouraged various countries to launch psychological warfare against terrorism.

The London Economic Summit Conference, organised by NATO States and Japan a few years ago, proved to be another landmark for the eradication of terrorism. It was discussed in detail to attack at the root of terrorism.

Creation of general awareness and organisation of public support against terrorist

acts could be of immense use. While it is desirable to allow police and the Armed forces to employ better informed judgement about local problems, there is, of course, a danger that this attempt of the Government could dilute the benefits to those deemed deserving and, thus, any possibility of peace

and negotiation. Rapid international transportation and use of sophisticated weapons have helped the expansion of terrorist networks globally. Besides, the new suicide squads have left the entire security apparatus shocked.

As religiously-motivated attacks increase globally, the concept that one man's terrorist can be another man's freedom fighter must be done away with.

The local populace should cooperate with the law enforcement machinery even at the cost of personal misery while prompt and strict decisions should be undertaken by various nations for controlling terrorists psychologically.

In a changing environment, the security apparatus and police need to diversify activities by bringing together technical and professional expertise based on many decades of experience in maintaining internal security.

In this regard, the most crucial aspect is to develop the capability to anticipate security needs.

The web of myriad challenges entangled into challenges posed by the paradoxes of globalisation has finally brought about a paradigm shift at the global level wherein there has been a confused struggle searching for religious and ideological interlinkages against the stark realities of




