DELHI LIFTS WEEKEND CURFEW, REOPENS RESTAURANTS

ew Delhi lifted a weekend curfew and allowed restaurants and marketplaces to reopen on Friday, following a sharp drop in new infections of Covid. Under new orders, however, the city will remain under night time curfew, and schools will be closed, Delhi's lieutenant governor said. Restaurants, bars and cinemas will be allowed to operate with up to 50% capacity and the number of people at weddings will be restricted to 200. The number of new cases in Delhi fell to 4,291 on Jan. 27 from a peak of 28.867 on Jan. 13. More than 85% of Covid beds across the city's hospitals were unoccupied, government data showed.

BJP FACES REBELLION IN 4 GOA SEATS, INCLUDING PANAJI, AHEAD OF POLLS

he ruling BJP has managed to contain dissent in most areas in the run up to the Goa Assembly polls scheduled for February 14, but four seats, including the prestigious Panaji constituency, continue to be a cause for worry. In Panaji, Utpal Parrikar, the son of former chief minister and BJP's tallest leader from Goa so far late Manohar Parrikar, is up as an Independent against the ruling party's Atanasio Monserratte, who had guit the Congress in 2019. Utpal Parrikar has claimed his heart continues to be with the BJP but he was contesting to ensure a "wrong person" does not get elected.

Are lenders aboveboard in l'affaire Karvy?

□ Banks fail in their duty of due deligence

Going by the revelations till date in the Karvy scam, it is now obvious that major banks and fintech companies that gave massive loans to the company either failed to do due diligence in checking the validity of the documents, shares and collaterals submitted to them; or, worse still, connived with the promoters of the company.

When an individual obtains mortgage loans or pledges shares for loans, banks take possession of the original title deeds, after creating a charge and transferring the

property rights to itself in association with the person obtaining the loan, pending clearance of the loan amount. In any case, certified records from the registration department are scrutinized thoroughly before sanction of the loan simply because no person can sell anything that he does not own in the first place.

The investigators have gone after Karvy promoters without looking sufficiently into the questionable role evidently played by the lending banks and fintech firms.

Companies that divert and siphon off public funds for investment in realty through shell firms are foredoomed, if one goes by what has happened now to Karvy group of companies and what had resulted in the downfall of once IT major Satyam Computers some years back.

Parallels are being drawn between the collapse of once celebrated Hyderabad-based stock broking firm Karvy group and that of Satyam Computers, also based in Hyderabad, in 2009. In both the cases, the companies had resorted to diversion of funds mainly to invest them heavily in real estate.

The collapse of Hyderabad real estate market as a consequence of the 2008 global economic meltdown eventually resulted in the fall of

Those symptomatic nearly 100 times than reported Covid +ve

Telangana State is witnessing a strange trend. While the ongoing Fever survey has identified nearly 3.45 lakh people with Covid-19like symptoms, the official media bulletin claims that only 3,877 people tested positive as of Friday. Health Minister Harish Rao

said that the first round of Fever

survey in the state had been completed in nearly 28-29 districts. The second round of the survey is set to begin. The Fever surveys were conducted in 77,33,427 households in the state and 3,45,951 kits provid-

ed. Harish said: "Everyone should come forward and take part in the Fever survey. Fever survey has reduced the spread of Covid-19. The state government is sufficiently equipped with testing kits



and home isolation kits. We are prepared with 1 crore kits to ensure there is no shortage".

Telangana on Friday registered 3,877 Covid-19 infections, including 1,189 positive cases under GHMC. The number of active Covid-19 positive infections in Telangana as on Friday surged to 40,414, with nearly 36,500 of them in areas within GHMC.

'NeoCov': Scientists warn of new kind of Covid from bats

A type of coronavirus, NeoCov, that spreads among bats in South Africa may pose a threat to humans in future if it mutates further, according to a study by Chinese researchers.

The yet-to-be peerreviewed study recently posted on the preprint repository BioRxiv, shows that NeoCov is closely related to the Middle East respiratory syndrome (MERS), a viral disease first identified in Saudi Arabia in 2012.

Coronaviruses are a large fam-



ily of viruses that can cause diseases ranging from the common

cold to Severe Acute Respiratory Syndrome (SARS).

Academy of Sciences and Wuhan University noted that NeoCov is found in a population of bats in South Africa and to date spreads exclusively among these animals.

In its current form, NeoCov does not infect humans but further mutations may make it potentially harmful, the researchers noted.

"In this study, we unexpectedly found that NeoCoV and its close relative, PDF-2180-CoV, can efficiently use some types of bat Angiotensin-converting enzyme 2 (ACE2) and, less favourably, human ACE2 for entry," the authors of the study noted.

Center hails TS fever survey as 'good strategy'

Center to formulate policy to replicate fever survey 3.45 lakh show Covid-like symptoms

Union Health Minister Mansukh Mandaviya has lauded the Fever survey launched by the Telangana government as part of its efforts to contain the spread of coronavirus. The Union Health Minister hailed it as a "good strategy" of the state government. He said that steps would be taken to formulate a similar policy for replicating it in all the states

on Friday held a video conference on the situation with regard to Covid-19 in the states. It was attended by the Health Ministers and senior officials from Telangana, Andhra Pradesh, Karnataka, Kerala, Tamil Nadu, Lakshadweep Island, Andaman and Nicobar and Puducherry



TS Health Minister Harish The Union Health Minister Rao briefed the Union Minister on the situation relating to coronavirus in the state, the state government's preparedness, Fever survey, vaccination and related matters.

So far, 77,33,427 households in the state have been surveyed for fever and 3,45,951 kits been provided. Harish Rao explained

that during the second wave, the Telangana Fever Survey was started for the first time in the country and it yielded good

According to Harish, a total of 21,150 teams are participating in the Fever survey, with three members each from the health, panchayat or municipal divisions going to each house to check people's health. Those

state. He said that oxygen facility had been provided to more than 27,000 beds in the state.

Harish Rao requested that booster dose be given to all those aged above 60 years, including those with comorbidities. He suggested the duration of the two doses be reduced as well as the interval between the second dose and the precaution dose from 9 months to 6 months. Every citizen aged over 18 years should be considered for booster dose. Harish urged the Center to release the pending second phase funds due to the State under Emergency COVID Response Plan -2. He requested upgrading of Pediatric ICUS, apart from allocation of human resources and supply of humidifiers required to bring the Center-supplied ventilators into use.

Telangana procured 70 lakh tonnes of paddy, bagged third slot: Kamalakar

Telangana has come third in the country by procuring 70 lakh tonnes of paddy during the Kharif/Vanakalam season exceeding the target set by the Centre, said the Minister for Civil Supplies, Gangula Kamalakar.

Of the total quantity of paddy procured across the country, Telangana's procure-ment is the third highest, and it exceeded by 1.31 lakh tonnes the target set by the Centre, he said in a statement.

This is despite problems like the Covid-19 pandemic, the Minister said.

As per the instructions of Chief Minister Chandrasekhar Rao, the Civil Supplies Corporation procured

44 per cent more than what was procured in the last Kharif season by procuring 21.21 lakh tonnes of extra paddy. He said every paddy grain brought to the centres was procured.

The State set up 6,872 purchase centres and procured paddy worth Rs 13,690 crore from 12.78 lakh farmers. The money for the paddy is being transferred since the last two days into the bank accounts of farmers and it will be over in a week, he said.

Explaining the proactive measures taken by the TRS government, Kamalakar said that they had kept ready around five crore gunny bags more than last time and except problems regarding the higher percentage of moisture in the paddy due to unseasonal rains, overall the paddy procurement was completed smoothly. Even now, paddy is being brought to purchase centres and it is being accepted, he said.

The high yields of paddy and procurement became possible because of Rythu Bandhu, Rythu Bhima, 24-hour free power supply, Kaleshwaram Lift Irrigation Project and other schemes, he

India's drug regulator has given permission to Bharat Biotech to conduct phase-3 clinical trial for its intranasal Covid vaccine as booster dose on participants who have been previously inoculated with SARS-CoV 2 vaccines.

India is yet to approve the use of intranasal COVID-19 vaccine BBV154 developed by the Hyderabad-based com-Drugs Controller General

of India (DCGI) on January

27 gave the nod to Bharat Biotech to conduct phase-3 randomised multi-centric clinical study to evaluate immunogenecity and safety of its intranasal vaccine as booster dose on participants who have been previously vaccinated with COVID-19 vaccines approved under new drugs under New Drugs & Clinical Trials Rules, 2019.

According to official sources, the trial would be conducted at five sites, including AIIMS Delhi.

In December, Bharat Biotech had sought permission from DCGI to conduct phase-3 study for its intranasal COVID-19 vaccine as a booster dose to participants previously vaccinated with SARS-CoV-2 vaccines. Separately, the DCGI on Thursday also gave permission

3 clinical trial to compare the

immunogenecity and safety of

BBV-154 (intranasal) with

Covaxin. This trial has been

In August, the nasal vaccine had received the regulator's nod for conducting phase 2 clinical trials. BBV154 is an intranasal

Hyd tops list of states in utilising groundwater

PNS HYDERABAD

Hyderabad topped the list in utilising ground water to a large extent followed by Rajanna Sircilla and Jangaon districts in 2019-20, according to ground water resource estimations carried out jointly by the State Groundwater Department and Central Ground Water Board.

Apart from Hyderabad, Rajanna Sircilla and Jangaon districts, Ranga Reddy, Mahabubnagar Nizamabad were in the list of high use of ground water in the state. Nine other districts - Jagitial, Warangal Rural and Urban, Nagarkurnool, Medchal-Malkajgiri, Sangareddy, Vikarabad, Kamareddy and Siddpet were in the moderate use of



groundwater while the remaining districts were in the category of low use of groundwater.As much as 97

per cent of groundwater was consumed in Hyderabad while 79 per cent and 78 per cent of groundwater in

Rajanna Sircilla and Janagaon, respectively. Seventy-four per cent of groundwater was consumed in Ranga Reddy while 72 per cent in Mahabubnagar and 70 per cent in Nizamabad.Groundwater resources estimation of the State as on March 2020 were carried out based on the GEC-2015 methodology. As major part of the State was underlain by hard rocks, watershed was taken as assessment unit for the entire State.

As per resource estimation for 2019-20, the total annual extractable groundwater resources are 15128 million cubic meter (mcm) (command area:6705 and noncommand area:8423), which is 22 per cent more in comparison to 2017 resources (12367mcm).

1,755 Covid +ve women delivered at Gandhi till date

Achampet incident an aberration, say health officials

Notwithstanding public outrage over the recent refusal by Achampet Government hospital doctors to perform delivery of a Covid positive pregnant woman, it is heartening to note that doctors at Gandhi Medical Hospital here have conducted as many as 1,755 deliveries of Covid positive pregnant women till date.

In all, 1,623 deliveries were conducted at Gandhi Hospital during the first wave and the second wave combined. Since January 1 this year, a total of 132 deliveries of Covid19 positive pregnant women were conducted at the hospital.

Last week, a COVID posi-

tive woman from Maharashtra delivered a child at the Government Hospital in Nirmal. Another pregnant



woman with Covid infection gave birth at Mother and Child Health Centre in Jangaon.

On the denial of admission to the pregnant Covid positive woman at Achampet CHC, senior officials in Health Department reasoned: "It is unfortunate that this incident happened. The Superintendent and the duty doctor in Achampet, Nagarkurnool, were suspended. We have con-

ducted thousands of deliveries. In Gandhi itself, we did 1,755 and such one of incident gets highlighted. It demoralises our doctors who risk their lives while conducting deliveries".

The official said that it was safe for both mother and child to get the deliveries done at government hospitals. Even in district hospitals deliveries were being done. In the Kothagudem district hospital itself 117 deliveries were conducted during three waves; likewise, there were 20 deliveries this month at Khammam District Hospital.

ties, the assets of the top 10 parties were worth Rs 2028.715 crore or 95.27 per cent of the total declared by them all combined. In the FY 2019-20, among the regional parties, the highest assets were declared by the Samajwadi Party at Rs 563.47 crore (26.46 per cent), followed by the TRS at Rs 301.47 crore and the AIADMK at Rs 267.61 crore.

Fixed Deposits/FDR constituted the largest share of Rs 1,639.51 crore (76.99 per cent) of the total assets declared by regional parties in the FY 2019-20. Missing classes

There is still no clarity from any quarter on whether it's okay to reopen schools

ne would have expected the Indian SARS-CoV-2 Genomics Consortium (Insacog) or the National COVID Task Force or the entire body of epidemiologists and virologists to at least now come up with a view on the reopening of schools. Unfortunately, their view eludes us. Schools remained closed for all of 2020 and most of 2021. They began to reopen in several States at the end of the second wave but closed down again when Omicron surfaced. Scientists predict that the current wave is subsiding fast, but they do not want to tell us if it is okay for children to return to school. Restrictions are being lifted but no State Government is willing to bell the 'school reopening' cat. Is there something we do not know but ought to know? Or is it that nobody wants to take the risk because nobody can say with confidence that the reopening will increase, or not increase, the risk of infection? The children and their parents are owed an explanation. For over 600 days, students have missed school, been kept away from classroom studies and subjected to forced home isolation and, for no fault of theirs, they are becoming victims of mental distress. We hear the usual from the scientists that children have a strong immune system that prevents them from catch-

ing infection easily. On the contrary, months of sitting isolated at home without exercise or physical activity may have dented their immunity.

There is no data on how children faced infection and no surveys on whether strict precautions in schools can ward off infection till they are vaccinated. To a large extent, the hesitation of the Government in reopening schools is justified because children are the only segment of the population without a vaccine. Those over 15 are getting their first dose now. Vaccines for children above two years of age will have to wait for a while longer, probably till early summer when

five vaccines will be available to them — Cadila Healthcare's ZyCoV-D, Bharat Biotech's Covaxin, the Serum Institute's Covovax, Biological E's RBD and Johnson & Johnson's 26COV.2S vaccine. In the meanwhile, there should have been a national assessment of the fall in education reception, or knowledge absorption and in the standards among children, if any. The shortcomings of the online method of teaching are already in the public sphere. Students from poor families are suffering from not being able to afford digital devices or lacking electricity to run them. Parents are beginning to ask why education is not an "essential" service like economic activity is. They find it surprising that bars are the first to reopen, but not schools. They say it is naïve to suppose children are not exposed to the virus when adults in the family go out regularly for work. It is time for rationality, not emotions, to decide on the reopening of schools. There is no scientific reason to keep them closed, anyway.

Hindus as punching bags for centuries?



There are several mentions in historical recordings and scholarly papers to show that pre-Islamic religious edifices were razed to build mosques

here is no doubt that Hindus have had the image of being soft and, therefore, a useful punching bag. It was overdue for a firm stand to be taken as was rightly done by TS Tirumurti, the Indian permanent representative to the United Nations, very recently. Swami Vivekananda was palpably aware of the Hindu image having been tarnished and there being a Hindu phobia. Accorded a tumultuous welcome upon his return after making a great name for himself and his faith overseas, Swamiji gave a frank explanation for why there was Hindu phobia.

Sir Sankaran Nair, a member of the Viceroy's Council, in his book called Gandhi and Anarchy (published by Tagore & Company; Madras, 1922), wrote: "For sheer brutality on women, do not remember anything in history to match the Malabar rebellion. It broke out about the 20th of August (1921). Even by the 6th of September, the results were dreadful." Gandhiji's comment which he wrote in Young India of September 29, 1921: "We have forgotten the divine out of dying for our faiths without retaliation... The Hindus must have the courage and the faith to feel that they can protect their religion in spite of such fanatical eruptions." He warned the Government against excessive repression of the Moplahs. The ending of the revolt was a matter not only of urgency, but of simple human-"Be the Moplahs ever so bad, they deserve to be treated as human beings.

So great is the sanctity of the spot that its panegyrists do not hesitate to declare that a single day spent in Mathura is more meritorious than a lifetime passed in Benares. All this celebrity is due to the fact of it being the birthplace of lord Krishna.


Brajbhoomi. He was so overwhelmed by the vandalism that visited the area repeatedly that he wrote feelingly, although his home was in far-away England. To quote: 'Thanks to Muhammadan intolerance, there is not a single building of any antiquity either in the city itself or its environs. Its most famous temple, which was dedicated to Kesava Deva (Krishna), was destroyed in 1669, the 11th year of the reign of the iconoclast Aurangzeb. The mosque (*idgah*) erected on its ruins is a building of little architectural value.

Today, Balkrishna is worshipped in a little room which appears like a servant quarter adjoining the back of the idgah. Pathos can be experienced by any visitor, whether a devotee or otherwise. The mischief with *masjids* extends from Somnath in the west to Adina mosque on the Bangladesh border in the east. The Adina mosque is sit-uated on National Hiighway No.34 near Gaur. On the nants of Hindu deities are visible. One stone slab displays Ganesh by the side of his consort. Inside the mosque, the stone work is equally convincing that the original building was a temple. There

has obviously been done a fair amount of work on this place of worship. Memoirs of Gaur and Pandua by M Abid Ali Khan, subsequently revised by HP Stapleton, prove this.

A more recent work of scholarship is entitled Mosque Architecture of Pre-Mughal Bengal by Dr Syed Mahmudul Hasan. Evidently, local legend as to who built the Adina mosque and why, appears to be incorrect. According to scholars, it was established by Sultan Sikandar Shah between 1366 and 1374 AD. There is a difference of opinion, especially between JH Ravenshaw and other scholars as to whether Gaur, the famous capital of medieval Bengal, was older or whether Hazrat Pandua, where Adina is located, flourished earlier. The significance of the controversy is about how much rubble from pre-Islamic edifices could have been used. Dr Hasan is impartial enough to quote various scholars at length, although he betrays wall outside, distinct rem- some unhappiness at the allegation about the use of Hindu materials.



SOVEREIGN BOND MOVE IS A WELCOME IDEA

Foreign capital inflow will ease down the bond yield to some extent

nion budget 2022 is few days away and there are speculations around inclusion of India's sovereign bond in the global bond index. Sometime back RBI governor said that the process is on and it should happen in few months. Historically, India has remained averse to the foreign ownership in the country's debt. This policy choice was largely driven by our experience related to balance of payment situation in 1990s. Government opened up the corporate sector for foreign capital (via FDI/FIlroute) and even FPI limit in corporate bond was kept high but RBI continued to keep a conservative stand on sovereign bonds. Things have changed now and our foreign exchange reserve is enough to withstand the short-termvolatility caused by sudden capital outflow. The Covid pandemic has curtailed revenue generation on one hand while public spending has increased on the other. The Government has resorted to borrowing as other non-tax receipts (like disinvestment proceedsor asset



monetisation schemes) are lagging behind the target. The GOI 10-year bond yield has touched two years high of 6.54 percent in January 2022. Economic growth is still under the shadows of pandemic and therefore government borrowing is unlikely to come down drastically. When economy revives and credit demand picks up, banks would not be showing the same appetite for the Government papers and it appears that yields are not going to ease in near term. A higher yield means more outflow on account of interest payment and thereby leaving less amount with government for infrastructure and asset creation.

Foreign capital inflow will ease down the bond yield to some extent. However, this inflow will cause appreciation of INR and it will be detrimental to the exporters. This exchange rate movement can be managed by the RBI with its market intervention policies. Despite of various concessions and incentives given by government, private investment is not picking up and government has to come forward for almost all major infrastructure projects. Domestic borrowing directly impacts the liquidity which has direct impact on demand/consumption and inflation. In our case, external borrowing should be used for growth purpose only and foreign capital should not be tapped just to finance the fiscal deficit. Country's risk perception determines the demand of the government papers by the buyers. Credit Default Swap spread isgenerally used to gauge the risk perception on the securities issued by the borrower. India's five-year sovereign CDS spread has consistently fallen (after reaching its peak in March' 20 due to Covid-related uncertainty) which means that credit perception has improved. India's sovereign credit rating has remained stable and downgrading by Moody's in June 2020 from Baa2 to Baa3 had invited severe criticism. Attractive yields on Indian bonds are remunerative to the foreign investors even if exchange rate risk is factored in and therefore demand of these securities is not a question which policy makers should worry about. There are certain areas which needs to be clarified by the RBI and finance ministry before this policy shift sees the light of the day. Though there is an overall ceiling of six percent and two percent of outstanding loans for central Government and state development loans respectively, operational process should be smooth. Taxation aspect (both interest receipt at periodic interval and capital gain) is important as any relaxation to the foreign investors would be detrimental to the domestic investors. A concession to the foreign investors while taxing the transaction in the hands of domestic investors would go against the principles of equity. This structural shift shows change of mindset and it is a welcome step but will needto be monitored cautiously post implementation.

Can Modi-Capt duo help BJP in Punjab?



Several Assembly polls have shown that Modi alone cannot be the face of BJP; it needs that extra zing, that extra person or an issue, to ride home

The Enforcement Directorate's raids on the house and business premises of the relatives of Punjab chief minister Charanjit Singh Channi follows a set pattern being followed by the central agencies for a while now in poll-bound states.

"This will generate a lot of smoke, this smoke will remain visible for a while but it will have little or no adverse political consequences for those who have been targeted," a leader in Punjab quipped on the timing of the raids when elections have been announced and the electoral process has begun.

Those who are knee-deep into politics say that the ED or Income Tax raids or any raid by a central agency hardly benefits the BJP in the elections as the fire is extinguished by those affected by the raid the very next day by playing the victim card to the hilt. The smoke too clears in the next 3-4 days after the agencies give an account of the recoveries and the dust it generates settles down in a week.

So, BJP in Punjab will have to rely solely on the charisma of Prime Minister Narendra Modi and the political guile of two-time chief minister Amarinder Singh, having a combined tenure of nine and a

half years in the top job of the state.

As we all know by now, Modi has a great influence when it comes to something like presidential type elections where he hardly has any political rivals and easily towers over others. It happened in 2014 and 2019 where the election was clearly Modi versus the rest. Obviously the combined "rest" was no match to Modi and the results hardly had any element of surprise. Not much has changed even in 2022 on this front.

However, at the same time, the Assembly elections in several states clearly showed that Modi alone cannot be the face of BJP and it has to get that extra zing, that extra person or an issue to ride home. Even in the home state of the Prime Minister, Gujarat, Congress did reasonably well despite the fact that Modi and Home Minister Amit Shah hailed from the same state. There were a string of losses in states all over the country, suggesting that local and regional leaders held on their own in their home turfs.

In Chandigarh Municipal Corporation elections, Modi was the only face of the BJP in the polls and the party could not win a majority despite ruling the civic body for five years. It's a different matter that through political machinations, it managed to get its "minority" Mayor elected, though the Aam Aadmi Party had two seats more than the BJP in the House.

So in Punjab, it is unlikely that Modi will have a big influence in the voting process and outcome, whatever his supporters say. The only rally he was supposed to address before the polls were announced, in Ferozepur, had to be canceled after the much-publicized security

The two parties complemented each other well-SAD, claiming to put across Sikh point of view while BJP the Hindu point of view in a state which was badly affected by militancy in the 1980s and early 1990s.

The now repealed three agricultural laws changed the political dynamics of the state and no one either from the BJP or the SAD could envisage the consequences it would have on state politics before the bills were conceptualized and eventually passed. As Sikh farmers from the state gathered at Delhi borders in one of the most visible non-violent protests in decades, opposition to the farm laws became a sort of mass movement in Punjab which a party could neglect only at its peril. SAD with its partner BJP and withdrew its minister Harsimrat Kaur Badal from the Modi Cabinet.

Even when BJP was in alliance with SAD, particularly, during the ten years of its rule (2007 to 20017), there were demands within BJP to test electoral waters independently. This chorus grew louder since 2014 when Modi emerged as a towering leader and BJP won several state elections and changed the political dynamics of the country. So, in 2022 it will be the first time in decades that BJP would be the big brother in the alliance with Congress turncoat and PLC chief rest of the country as well.

Amarinder Singh and would contest 65 odd seats. If BJP manages a decent show and the definition of a decent outing would vary from one leader to the other, a new alignment could emerge in Punjab. But given the fact that BJP has been unable to grow in rural Punjab due to multiple factors, it looks like a long haul for the saffron party at present.

Many in the SAD believe that Amarinder Singh's PLC is only a one election wonder and they have little or no differences with BJP, more so when the reason for their differences-Farm Acts-no longer exists. Solid waste management policy still suffers from niggles

Primary segregation is key to effective solid waste management, specifically recycling and composting

Solid Waste Management Rules, 2016 brought in by the Ministry of Environment, Forests and Climate Change (MoEFCC) and monitored by the Central Pollution Control Board (CPCB) are having limited success. Authorities right from the Ministry of Urban Development, CPCB, State pollution Control made

Boards, Municipalities, and Gram Panchayats have been accountable. Implementation is mainly by municipal authorities and gram panchayats as per rules. Segregation at source is the mainstay of the Rules as has been amply demonstrated by municipalities like Indore, making citizens and institutions responsible for primary segregation.

The ministries of of Urban Development and Rural

Development are the main monitoring agencies at the national level.

Ministry of Chemicals and Fertilizers, according to clause 7, has to ensure market development assistance and promotion of city compost with chemical fertilizers in the ratio of 3:4, but the ministry has done nothing to assist the municipalities and gram panchayats, where compost is being produced.

Similarly, the Ministry of Agriculture, as per clause 8, had to set up labs for checking the quality and propagation of compost on farmland, but it has done little. Central Pollution Control Board (CPCB) hardly monitors State Pollution Control Boards for implementation. Even Delhi is not segregating waste as per rules right under the nose of



2016, Clause 15 makes local authorities responsible for solid waste management. Except for municipalities like Indore, Ambikapur and a few others, no municipality is following the rules. Cities like Noida are finally working on different types of waste and segregation at doorsteps but implementation is insufficient even though City managers like Salil Yadav worked hard to implement and succeeded partially. He has been trans-CPCB. According to SWM Rules ferred to Greater Noida

Authority (GNIDA) to implement in the planned township of Greater Noida.

GNIDA was fined Rs 2 crore by National Green Tribunal in 2019 for not properly implementing SWM 2016 rules. Since then, it has taken action for empanelment of private agencies for bulk waste generators (apartments) and has empaneled more than 17 agencies in category 2 of

its notification. Sources said three attempts were made by GNIDA to empanel vendors for colonies but due to unfavourable conditions such as unwillingness to pay or pay very little, harassment of sanitary workers and collectors, the attitude of residents, foiled the initiative.

A look at the implementation of apartments and colonies

Industrial Development like Jalvayu Vihar, AWHO, Gurjinder Vihar, Jaypee Greens, La Residentia, NHPC Employee colony, Greenwoods Society, Ansal Golf Links, Gaur City 1 & 2 throws up interesting facts.

Jaypee installed a composter machine in July 2021, in accordance with the SWM rules of GNIDA and Central Government, but the machine had not worked properly due to its vendor's inadequacies. 



CCI Secretary Jay Shah on Friday said that the postponed Ranji Trophy will be held in two phases starting next month, clearing the decks for India's premier domestic competition to resume after being cancelled last season.

It is expected that the 38-team tournament will begin in the second week of February and the first phase will continue for about a month.

The tournament, which was not held last year due to the COVID-19 pandemic, was scheduled to begin on January 13 but was postponed owing to a third wave of infections across the country.

The Board has decided to conduct the Ranji Trophy this season in two phases. In the first phase, we plan to complete all matches of the league stage while the knockouts will be held in June," Shah said in a

"My team is working closely to mitigate any kind of health risk caused by the pandemic, while at the same time ensuring a highly competitive red-ball cricket contest."

Shah said that the BCCI understands the significance of Ranji

Trophy.
"Ranji Trophy is our most prestigious domestic competition, which has been providing Indian Cricket
