# Aditi Singh in BJP's 3rd list of 85 for UP polls

Asim Arun gets ticket from Kannauj, Nitin Aggarwal from Hardoi

The BJP on Friday fielded Aditi Singh and Rakesh Singh, who left the Congress to join it, and Asim Arun, who recently quit the IPS, in the Uttar Pradesh assembly polls as it released a list of 85 more candidates.

Both Aditi Singh and Rakesh Singh are sitting MLAs from constituencies falling under Congress president Sonia Gandhi's Rae Bareli parliamentary seat. They have

liamentary seat. They have been fielded from their current seats of Rae Bareli and Harchandpur, respectively.

The list also includes incumbent MLA Hariom Yadav, a relative of Samajwadi Party patriarch Mulayam Singh Yadav. Hariom Yadav quit the opposition party recently and joined the BJP.

Yadav has been fielded from his current seat Sirsaganj, while Arun, a Dalit, will contest from Kannauj, a reserved

In the last assembly election in 2017, out of the five assembly seats in Rae Bareli, the Congress and the BJP had won from two constituencies each while one had gone to the

Samajwadi Party.

The five assembly seats of Rae Bareli — Bachrawan (SC), Harchandpur, Sareni, Unchahar and Rae Bareli — will vote in the fourth phase, while Salon (SC) will vote in the fifth phase on February 27.

The BJP also announced its candidates for assembly constituencies in Lakhimpur Kheri

In Lakhimpur Kheri dis-trict, the BJP has repeated Shashank Verma (from Nighasan), Arvind Giri (from

Gola Gokrannath), Manju Gola Gokrannath), Manju Tyagi (from Srinagar), Yogesh Verma (from Lakhimpur Kheri), Saurabh Singh Sonu (from Kasta-SC), Lokendra Pratap Singh (from Mohammadi) and Harvindar Romi Sahni (from Palia).

Lakhimpur Kheri has been in the news recently after four protesting farmers were run over by vehicles. Four others, including a journalist and two BJP workers, were also killed in the violence in October last

## Amar Jawan Jyoti merger stirs row; India Gate to get Bose's statue

Rahul raps Govt for moving flame to War Memorial

PNS NEW DELHI

A mar Jawan Jyoti on Friday was merged with the eter-nal flame at the newly con-structed National War Memorial (NWM) here. Some veterans and political leaders, including Rahul Gandhi, however, criticised the move and said it was an insult to the fallen soldiers.

In a short military ceremony, the flame at the Amar Jawan Jyoti at the India Gate was taken and merged with the War Memorial about 400 metres away in the afternoon. Chief of Integrated Defence Staff Marshal BR Krishna presided over the ceremony that included a parade and

Prime Minister Narendra Modi, meanwhile, announced that a statue of Netaji Subhas Chandra Bose will be installed at India Gate as a symbol of India's indebtedness to him. This announcement came ahead of Bose's 125th birth anniversary.

Until the installation is completed, a hologram of Netaji will be projected at the site of the statue, the Prime Minister said. "I will unveil the

hologram statue on 23rd January, Netaji's birth anniversary," he tweeted.

"At a time when the entire nation is marking the 125th

birth anniversary of Netaji Subhas Chandra Bose, I am glad to share that his grand statue, made of granite, will be installed at India Gate," Modi tweeted on Friday. "This would be a symbol of India's indebtedness to him."

The statue will be installed under the grand canopy near which the Amar Jawan Jyothi flickers. The canopy, which was built along with the rest of the grand monument in the 1930s by Sir Edwin Lutyens, once housed a statue of the former king of England George V. The statue was later moved to Coronation Park in Central Delhi in the mid-1960s.

The National War Memorial, built in 2019, will now be the single point for military ceremonies and tributes to fallen soldiers.

At the same time, she said the Congress would be open to a post-poll alliance if the need arose. Rahul on his part chose to attack the BJP alleging that those preaching Hindutva are spreading

# 703 die, 3.5L infected in a day as corona marches on

## rate soars to 43%

PNS NEW DELHI

India on Friday recorded 3,47,254 new cases of Covid-19, including 9,692 cases of the new Omicron variant, while 703 fatalities were reported in the last 24 hours. The active cases have increased to 20,18,825, the highest in 235 days, the Union Health Ministry data showed. The active cases comprise 5.23 per cent of the total infections.

The Test Positivity Rate surged to 43.76 per cent in Kerala, paining a gloomy picture about the Covid-19 situation in the State which recorded 41, 668 fresh cases during the last 24 hours on Friday. The samples tested on Friday stood at 95,218.

By far this is the highest positivity rate recorded by any State in India ever since Covid-19 spread in the country. Positivity rate is the percentage of people who test positive of those overall who have been

## Domestic fliers can't carry more than one hand baggage

Domestic air passengers will no longer be allowed to carry more than one hand baggage. In a bid to reduce congestion at airports, the Central Industrial Security Force (CISF) has asked the Bureau of Civil Aviation Security (BCAS) to strictly implement the rule which mandates that only one handbag is allowed per pas-

senger.
The CISF has said flyers with more than one cabin handbag are choking the security check-in counters at airports as well as causing delays, congestion and inconvenience to passengers. CISF guards all



rules allow passengers to carry one hand baggage, the existing rules permit a passenger to carry one laptop bag, one ladies' handbag, and one blanket, gift item purchased from duty-free shop, umbrella, and a reasonable amount of reading material on board an aircraft.

In a letter to Director General, BCAS, the CISF's IG/Airport Sector Vijay Prakash pointed out that it has been seen that passenger on

average carries two to three handbags to the screening point. This has led to increased clearance time as well as delays, congestion in PESC points, and inconvenience to passengers. "As per BCAS AVSEC Circular Nos. 06/2000 & Lt12000, no passenger should be permitted to carry more than one handbag other than those items already listed in the cirrule' meticulously on the ground to ease the congestion

items already listed in the circular including lady's bag," the CISF said, adding, "All airlines and airport operators may be instructed to take steps to implement 'One Hand Bag and other security concerns.

## blocked for anti-India canards PNS NEW DELHI

Acting on intelligence inputs, the Government has blocked 35 YouTube channels, two Twitter accounts, two Instagram accounts, two websites, and a Facebook account for spreading anti-India pro-paganda and spreading fake news in a "coordinated man-ner" on the Internet from Pakistan.

Talking to the media, Apurva Chandra, secretary Union Information and Broadcasting Ministry, said these YouTube accounts had a total subscriber base of over 1.20 crore, and their videos had over 130 crore views. The Government last month had



blocked 20 YouTube channels and two websites for spreading anti-India fake and divisive news and other content.

According to Chandra, the 35 YouTube accounts blocked by the Ministry were all operating from Pakistan and were identified to be part of four coordinated disinformation networks. These include Faisal Tarar Speaks, Apni Dunya TV, Haqeekat ki Dunia, Shahzad Abbas, Mera Pakistan with

Shahab, Khabar with Ahmed, HR tv, Sabee Kazmi, Such tv network, Saqib Speaks, and Salman Haider Officials.

The Apni Duniya Network operates 14 YouTube channels, and Talha Films Network operates 13 YouTube channels. A set of four channels and a set of two other channels were also found to be acting in synchronisation with each other.

The channels were used to post divisive content in a coordinated manner on topics like Kashmir, Indian Army, minority communities in India, Ram Mandir, General Bipin Rawat, etc. One of the groups identified on YouTube was "Naya Pakistan".

## SIT files more chargesheets against 7 in Kheri violence

Lucknow (PNS): The Special Investigation Team (ŜIT) probing the Lakhimpur Kheri case, on Friday, filed four more chargesheets against seven accused over the death of a driver and two Bharatiya Janata Party workers during the violence in Tikunia.

The SIT investigator filed the 500-page chargesheet on Friday in the court of chief judicial magistrate in connection with an FIR lodged by BJP worker Sumit Jaiswal.

All the seven are accused of lynching three people in the Lakhimpur Kheri violence case after four farmers and a journalist were allegedly mowed down by a speeding vehicle. They are currently lodged in a

The Lakhimpur Kheri case pertains to the violence that erupted in Lakhimpur Kheri district on October 3 last year. Eight people, including four farmers, two BJP workers, a driver and a local journalist, were killed in the incident. Union minister Ajay Misra Teni's son Ashish Misra is the prime accused in the case and has been lodged in jail since his arrest on October 9. Two FIRs were lodged in

connection with the incident. The first FIR, number 219/2021, was lodged by farmer Jagjeet Singh in connection with the deaths of farmers and a journalist in which he implicated Ashish Mishra alias Monu, the son of the Union minister, and 15 to 20 others. The second FIR, number 220/221, was lodged by BJP worker Sumit Jaiswal in connection with the death of two party workers and a driver, in which he implicated unidentified assailants. Sumit Jaiswal is

On October 3, 2021, eight people were killed in Lakhimpur Kheri during violence that erupted when farmers were protesting against Uttar Pradesh Deputy Chief Minister Keshav Prasad Maurya's visit to the area. A vehicle allegedly linked to Ajay and Ashish Misra ran over some farmers, killing five. An angry mob burnt several vehicles and killed three people, taking the toll to eight.

The farmers' bodies claimed that besides a journalist, four farmers, identified as Nakshatra Singh (55), Daljeet (20) and Gurvendra Singh (18), died as vehicles mowed the protesters down on the Tikunia-Banbirpur road. Three other deaths were reported from the BJP's camp.

On Thursday, 2,41,457 samples were tested out of which 16,142 were found positive. The overall positivity rate in the state is 1.97 per cent while the recovery rate is 93.8 per cent. The government is making all efforts to ensure that the maximum number of eligible persons in the state are fully immunised against the novel coronavirus before the assembly polls and on the directives of the chief minister, screening and testing has been intensified

The establishment of Covid Help Desks in all the offices and industrial units has been made mandatory. The chief minister has also issued

## 2,290 test positive, 17,495 active cases in the city

## Election process set rolling for 2nd phase

The Election Commission of India (ECI) set the election process rolling for the second phase of Uttar Pradesh assembly polls on Friday with issuance of notification for 55 assembly constituencies in nine districts of Rohilkhand and west UP region.

Friday was also the last date for filing nominations for the first phase of polls to 58 assembly constituencies in 11 districts of western UP.

Ten nominations were filed for the second phase of polling on the first day on

UP Chief Electoral Officer (CEO) Ajay Kumar Shukla said here on Friday that notification for the second phase polls was issued at 11am on Friday. He said nominations in these 55 assembly constituencies had commenced, strictly following the Covid norms and guidelines issued by the

Shukla said this time, the candidates could also submit their nomination papers online. Only two persons along with the candidate would be allowed during filing of nomination physically, he added.

He said that Friday was also the last date for filing nomination papers for the first phase polls.

As many as 815 candidates have filed their nominations in the first phase.

The state will witness a keen tussle of ballots in the seven-phase elections covering 403 assembly constituencies with polling to be held between February 10 and March 7 and announcement of result on

In the second phase polling to be held on February 14, filing of nominations commenced from January 21, the last date for filing nominations is January 28, scrutiny on January 29 and last date for withdrawal is January 31.

Altogether 55 assembly constituencies will go to polls in the second phase covering nine districts of Saharanpur, Bijnor, Amroha, Sambhal, Moradabad, Rampur, Bareilly, Budaun and Shahjahanpur.

In the second phase, 2,01,42,441 voters will cast their votes in around 17,000 polling booths.

In the 2017 elections, Bharatiya Janata

Party had won 40 seats of these 55 assembly seats while Samajwadi Party won 13 and Bahujan Samaj Party won 2 seats.

815 nominations filed for first phase of assembly polls

It may be noted that Uttar Pradesh has administered 24.4 crore doses till now, which include 14.9 crore first doses, 9.37 crore second doses and 6.9 lakh precautionary doses. Till January 20, the state has achieved 63.06 per cent coverage of the sec-

"We are aiming to complete 75 per cent coverage of the second dose but it all depends on the first dose administered. If the first dose is administered late we cannot administer the second dose in case of Covishield. Hence if the first dose is administered in the month of January 2022 or December 2021, the person will not be eligible for the second dose if the person has had a shot of Covishield," he

Officials said that the Election Commission of India had given directions that a voter guide shall be provided to every elector's household ahead of elections, giving them information about the date and time of polls, contact details of the BLOs, important websites, helpline numbers, documents required for identification at the polling station besides other important information including the Do's and Don'ts for voters at the polling station. The voter guide also contains important information like Covid guidelines. An official said that as per the directions of the Election Commission of India for identification at polling station, voters shall present the EPIC or any of the identification documents approved by the ECI along with the voter information slips such as the Aadhaar card, MNREGA job card, passbooks with photograph issued by bank, post office, nealth insurance smart card issued under the scheme of the Labour Ministry, driving licence, PAN card, smart card issued by RGI under NPR, Indian passport, pension document with photograph, service identity cards with photograph issued to employees by Central, state governments, PSUs, pub-

All the hand-made crafts are disappearing from villages which need to be protected," he said.

# owner commit suicide

Lucknow (PNS): In a shocking incident, a couple, after being cheated by a plot owner, committed suicide.

Reports said that Sunil, a resident of Majra Kesaripur of village Mazhigaon in Hardoi, used to sell tea in Bramhrauli under Kakori police station in Lucknow. Sunil's uncle, Shree Krishna, said that his nephew lived with his wife Sonika, four-year-old daughter Sakshi and four-month-old son Yuvraj.

Sunil had made a deal to buy a plot in Bramhrauli with his savings and only Rs 30,000 was left to be paid but the plot owner sold the plot to someone

On Makar Sankranti, Sonika had gone to her maternal home in Kesaripur village in Sitapur with her children. Sunil told Sonika on Thursday evening how the plot owner had cheated him after which she hanged herself in a room. On Friday morning, Sunil also committed suicide by hanging himself near the plot.

## Varanasi achieves 100 per cent target in administering first dose of vaccine

n a remarkable achievement, Ithe Varanasi district has achieved the 100 per cent target to administer the first dose of Covid vaccine while approximately 65 per cent got a second shot of vaccine. More than 50 lakh beneficiaries have been vaccinated in a year.

A total of 28,348 beneficiaries got a second shot of the vaccine on Thursday and with this, 64.6 per cent beneficiaries were administered the second dose by a day earlier, the Chief Medical Officer Dr Sandeep Chaudhary informed adding, the district has also achieved the feat to administer the vaccines to 50 lakh beneficiaries in a year as a total of 50,96,707 people including 26,71,064 men and 24,12,542 women

The DM has emphasised that the 100 per cent vaccination target of adolescents aged from 15 to 17 years is also to be achieved at the earliest and to achieve this, everyone should make their best level effort.

According to the District Immunisation Officer Dr VS Rai, a total of 596 sessions were held at various vaccination centres of the district on Thursday and a total of 43,176 beneficiaries were vaccinated including 1,692 precautionary

This was informed by Soil Scientist of CSA, Dr SK Biswas while conducting a survey in the surrounding areas. He said the fog coupled with rains has led to late blight which was affecting the potato crop and this will lead to not only losses of farmers but it will also lead

coming times. He said the team was advocating that the farmers use a right amalgal of Matco, Equation Pro and Radomil fungicide by mixing one ml mixture in one litre of water and spar on the crops immediately. He said the farmas it will rot leading to finan-

He said late blight was caused by the fungus called phytophthora infestans which was the most important deadliest disease of potato that can result into crop failures in a short period if appropriate control measures were not adopted. He said losses in potato yield can go as high as 80 per cent in this epidemic year. He added that when plants become infected, lesions (round or irregularly shaped areas that range in colour from dark green to purplish black and resemble frost injury)

and stems. He said a whitish growth of spore-producing structures may appear at the margin of the lesions on the underleaf surfaces. He said potato tubers developed rot up to 15 mm (0.6 inch) deep. He said secondary fungi and bacteria often invaded potato tubers and produced rotting that resulted in great losses during storage, transit, and mar-

of concern was that phytophthora survived in stored tubers, dump piles, field plants, both sexual oospores and asexual sporangia were dispersed by the wind to nearby plants, in which infection may occur within a few hours. He said at temperatures below 15 degree sporangia germinated by producing zoospores (asexual spores with flagella) that encyst and later form a germ tube under certain temperature and humidity conditions. He said above that temperature most sporangia produce a germ tube

directly. He said the disease can be

cation of fungicide, though epidemics can occur rapidly once crops were infected. He added that the oospores had thickened walls and were able to persist in the soil for several seasons, the disease can be difficult to eradicate. He suggested measures for controlling and preventing blights which typically involved the destruction of the infected plant parts, use of disease-free seed or stock and resistant crop rotation, pruning and spacing of plants for better air circulation. He said apart from this by controlling pests that carry the fungus from plant to plant and to avoid overhead watering and working among wet plants and, where needed, the application of fungicide or

#### SIT starts probe into Kanpur anti-Sikh riots PIONEER NEWS SERVICE ■ KANPUR

The Special Investigation Team (SIT) probing the 1984 anti-Sikh riots of Kanpur has started investigation into two more cases. These include one related to the murder of a man and his two sons in Naubasta after seeking details of documents, witnesses and accused involved in it. These two cases were reported from the Naubasta and Nazirabad police station areas of the city.

It may be recalled that the
SIT, set up to re-investigate the
riots in the city in the aftermath of the assassination of former Prime Minister Indira Gandhi, has so far identified 89 accused

in the 13 cases. Of these 89 accused, 70 are alive and remaining 19 have died. In the 11 cases, the SIT has already handed over the list of the accused to the government while the investigations in

two more cases (Nos 12 and 13)

are still underway. "The rioters had killed a man and his two sons in case No. 12 reported from Naubasta police station area. The SIT has gathered all the evidence in this regard. More than a dozen accused have been identified. The verification process is in progress," sources in the SIT said and added, "Similarly, in case No. 13, two persons of the Sikh community were killed by

the mob.' SIT DIG Balendu Bhushan Singh said, "So far, the investigation of 11 cases has been completed. The investigation of case Nos. 12 and 13 is already underway." All the documents relating to these cases like names of witnesses, plaintiffs and accused had been recov-ered. In case No.12 registered as 498/84 in the general diary of Naubasta police station by Vijender Kaur, her husband Gurmendra Singh, father-inlaw Nagina Singh and brotherin-law were murdered, while in case No. 13 registered as 315/84 in the GD of Nazirabad police station, one Gurcharan Singh and Amlok Singh were killed by the rioters, DIG Singh said. It may be recalled that

nearly 127 people were murdered in the city in the aftermath of Indira Gandhi's assassination in 1984.

## Masks not for children below 5 years: Revised guidelines

**NEW DELHI** 

In what should come as a huge relief for both parents and children, wearing of masks is not recommended for children aged 5 years or below according to the revised Covid-19 guidelines issued by the Union Health Ministry. Those aged 6-11 years may wear it depending on the ability of the child to use a mask safely and appropriately under direct supervision of parents.

Ensuring that the kid masks up properly has been of much concern to parents while masking up didn't go too well with children who felt suffo-

Comprehensive Guidelines for Management of COVID-19 in Children and Adolescents (below 18 years)', those aged 12 and above should wear a mask under the same conditions as adults, the guidelines said.

It also said that use of antivirals or monoclonal antibodies is not recommended for those less than 18 years of age, irrespective of severity of Covid infection, and if steroids are used, they should be tapered over 10 to 14 days, subject to clinical improvement.

The guidelines were reviewed by a group of experts in view of the current surge that

The available data from other countries suggests that the disease caused by the Omicron variant is less severe. However, there is a need for a careful watch, as the current wave evolves, the ministry said.

Under the Arms (Amendment) Rules, 2022, the arms manufacturers, however, will have to submit online every month details of the firearms manufactured. sold or transferred or consumed for the month.

The manufacturer who has been issued licence in Form VII under these rules shall be permitted to have enhanced annual production of firearms or ammunition or caliber wise revision of his licensed capacity by giving intimation to the licensing authority and also to the State Government concerned within ninety days from the end of the financial year and for which no further endorsement on the licence as to capacity shall be required," the MHA notifi-

The Constitution will consume the 100 crore Hindus of this country. Those who believe in this Constitution will be killed. Those who believe in this system, in these politicians, in the Supreme Court, and in the Army will all die the death of a dog.

## Ventura case: ED attaches assets worth ₹2 crore

The Enforcement Directorate (ED) has attached assets worth Rs 2.37 crore of Jeevendra Poddar and Shipra Singh under Prevention of Money Laundering Act (PMLA) in the offence of money laundering initiated against Ameet Savant and others. The attached assets are in the form of a flat in Goa, Office Space in Gera Imperium Grand in Goa and BMW cars among others.

The ED had initiated money laundering investigation on the basis of FIRs dated August 21, 2019 and December 12, 2019 registered by Goa Police under various sections of IPC and Goa Protection of Interest of Depositors (In Financial Establishments) Act, 1999 against Ameet Savant, Ieevendra Poddar, Shipra Singh, and others for duping of investors to the tune of approximately Rs 21.38 crore by promising fixed returns of 2 to 5 percent per month.

Investigation by ED Authorized Representative (AP) of Ventura Securities Ltd. had collected money to the tune of Rs 21.38 crore from the complainants between 2015 and 2019. Instead of depositing the same in the demat accounts of investors maintained with Ventura Securities Ltd., had misappropriated the same by depositing in the accounts of his own similarly named proprietorship firm, VENTURA, the agency said in a statement.

Savant had further laundered the money received from complainants gambling/speculation in the securities market and lost money to the tune of Rs 9.86 crore approximately between 2016 and 2018, it further said.

Further, Savant had transferred Proceeds of Crime (POC) to the tune of Rs 5.45 crore in the bank accounts of Jeevendra Poddar and Shipra Singh as commission/brokerage for sourcing clients for him, it added.

The West Bengal State Commission noted the bank should have accepted its mistake, by crediting the cheque amount to the account of Sunil Maity, who had the account at the same branch.

The top court noted: "There was no way that the appellant would have known that the second respondent namely Sunil Maity had an account in the same branch. No sane person would deposit cash or cheque meant to be



deposited in his account in an account number belonging to another person with similar

It pointed out that the National Commission exceeded its revisional jurisdiction by calling for the report from the bank and made it the basis to conclude that the two fora below had erred in not undertaking the requisite in-depth appraisal of the case.

The top court said the report that tries to absolve the bank of its liability is based on surmises and conjectures, as it holds that bank has every reason to believe that wrong account number was intentionally inserted by the petitioner himself for reasons best known to him or on account of negligence by him by not keeping the passbook in proper custody. "The suppositions are contradictory as well as incredulous and fanciful," said the

The National Commission, allowing a revision petition by the bank, said the complainant can move the competent civil court under the law.

The petitioner submitted before the top court that he did not know Sunil Maity, the second respondent, and would not have known his account number unless it was given by a bank officer.

## The medium

To teach in English or in mother tongue? A multilingual approach is the answer

The Telangana Government has decided to introduce English as a medium of instruction in Government schools from the next academic year. The State language, Telugu, will be parallelly available as the other medium of instruction. On the face of it, there is a readymade explanation for the change. More and more parents of children in Government schools of Telangana feel the kids, when they reach the college level, fail to catch up with the standards of English-medium students. Secondly, private schools, hitherto limited to the urban centres with their English-medium education, have of late mushroomed across rural Telangana offering education in the English medium. That has led to a near-exodus from Telugu-medium Government schools, many of which have either closed down or merged with bigger schools, or relocated for want of students. The Government in any case runs a few residential schools with English medium and thinks offering English medium across the State would not be much of an issue. The problem the Government faces is finding teachers who can teach in English. They are scarce. The majority of the teachers is proficient in Telugu. The Government has to re-train these teachers — a tough task



— and encourage prospective teachers to take up B Ed courses in English. But by and large, not many eyebrows are being raised as the English medium creeps into the Government school system in Telangana where 'going to America' is a popular cry and Telugu-medium students shell out big money to enrol in private English-language courses.

The issue, however, points to a disturbing fact. Even after 75 years of Independence, we are stuck with basic stuff, like what should be the medium of education in our schools. We are still debating whether children should be taught in English or their mother tongue. We

are also not sure whether mother tongue constitutes languages or dialects, too. For instance, millions speak Bhojpuri but it is considered a dialect of Hindi. Only last year, a Minister in Bihar mooted the idea of making the "mother tongue of the region" the medium of teaching. It just shows India never had an exhaustive debate on the subject. Linguists backing cognitive education insist that children learn skills in their mother tongue, a language they grow up with. The aspirational, social-empowering, rights-based argument favours English because it is the language that works in the world. Thus, the medium of instruction carries the baggage of ideology and elitism in the world's largest multi-lingual federation that is India. In contrast to parents' eagerness for their children to be taught in English, the Centre's National Education Policy (NEP) largely prefers the mother tongue. The answer is a bilingual or, preferably, a multilingual approach. Technology makes it possible. In a country where most children live their lives in two or three languages, multilingual teaching methods provide a level playing field for diverse linguistic and cultural backgrounds while reconciling the desires of both parents and the NEP.



As Kerala grapples with rising COVID cases, its 'immaculate health care' balloon has burst

s the number of daily COVID-19 cases soared to 46,487 on Thursday, Kerala's boast of being a role model for health care came crashing down like a pack of cards. The death toll in the State till Thursday stood at 51,501. Kerala has not been free from the pandemic's onslaught since India's first COVID-19 case was diagnosed in the State in early 2020. However, the State administration-sponsored media blitzkrieg portrayed an "all is well" image. Chief Minister Pinarayi Vijayan, who is currently recuperating in a US hospital, had addressed the media daily to tell the



briefings, which were telecast by all satellite news channels, were used by Vijayan to campaign for the 2021 Assembly election. He claimed that Kerala was receiving global acclaim for its health care system and other countries were emulating its example. But after the LDF retained power following the 2021 Assembly election, he discontinued the practice of addressing the media daily; the opportunist in Vijayan the politician chose to ignore people as the next major election is due only in 2024.

When the cases of COVID-19 surged, the Government turned to blaming people for the trans-

mission of the virus. The truth, however, is that no worthwhile efforts were made to study the pattern in the spread of the disease. The State Government continued to tom-tom and live by its past laurels, when some agencies had praised the Kerala model of health care. The health department was complacent throughout this period, and manipulated figures failed to cover up the administration's malpractices. A 600-bed COVID hospital at Kasaragod, built by the Tatas and handed over to the Government in early 2021, is yet to become fully operational. The Government doctors were on a path of agitation for the last one year, demanding restoration of allowances which were cancelled citing financial crunch. The much-touted Kerala model was virtually a red herring spawned by friendly media. EMS Namboodiripad and C Achutha Menon, the Communist Chief Ministers of the State, used to fly to Romania and East Germany for medical treatment while Vijayan and his consciencekeeper Kodiyeri Balakrishnan prefer the "imperialist" US as their medical caretaker. It's time for the Comrades to see the writing on the wall, isn't it already?

# Afghan women's rights are still far



The Taliban's recent announcements fail to inspire confidence and don't go far enough to impress the international community

wo news items, published in newspapers on January 20, 2022, merit attention. The first by *AFP*, carried in the Delhi edition of a leading daily, is about Acting Afghan Prime Minister Mohammad Hassan Akhund's appeal on January 19 to Muslim countries "to take the lead and recognise us officially". He was speaking at a conference to address Afghanistan's massive economic problems. The second, by PTI, featured in the Delhi edition of *The Pioneer*. It cited Chinese Foreign Ministry spokesman Xiao Lijian as saying at a media briefing on January 18 that he hoped that the Afghan side would respond further to the international community's expectations that it would "establish an open and inclusive political architecture, adopt moderate and prudent domestic and foreign poli-cies, firmly combat all sorts of terrorist forces" and be "on friendly terms with other countries, especially its neighbours and integrate into [the] international family at an early date".

The statement, made following a mention of the Taliban seeking China's help to get global diplomatic recognition, clearly indicated that the world did not think that they had established an "inclusive" Government or that their policies towards women would not be a repeat of the horribly repressive ones that marked their earlier stint in power from 1996 to 2001. And this, when they had promised that women would enjoy all the rights to education and work available under Sharia law. In fact, the UN and its bod-

ies have, on several occasions, asked the Taliban to implement their promises and made critical observations about their actions. Its secretary-general, Antonio Guterres, told reporters on October 7 last year, "I am particularly alarmed to see promises made to Afghan women and girls by the Taliban being broken." He idded, "I strongly appeal to the Taliban to keep their promises to women and girls and fulfil their obligations under international human rights and humanitarian law." Speaking at the Human Rights Council, an inter-govern-

mental body within the UN system responsible for promoting and safeguarding human rights, Michelle Bachelet, United Nations High Commissioner for Human Rights, said on September 13, 2021, "My office has received credible allegations of reprisal killings of a number of former ANSF (Afghan National Security Forces) personnel, and reports of officials, who worked for previous administrations, and their family members being arbitrarily detained.... In some cases, the officials were released and, in others, they were found dead." Bachelet also highlighted "deeply troubling information" about Taliban raids on offices of some advocacy

The UN bodies have acted. On September 17, the Security Council unanimously adopted a resolution asking the Taliban to establish an inclusive Government that has "the full, equal and meaningful participation of women" and upholds human rights. The Human Rights Council adopted a resolution on October to have, from March 2022, a special rapporteur, supported by UN experts, on the ground to monitor the human rights situation in Afghanistan.

that the Taliban are reacting. Abdul Baqi Haqqani, Minister for Higher Education, announced at a press conference in Kabul on January 12 that the Government would soon reopen public universities for male and female students. He also announced that these students would be segregated and cited Afghanistan's economic crisis and the lack of separated classes for male and female students, as reasons for the delay.

Earlier, in a decree on December 3 in the name of the Acting PM, the Taliban had stated that a "woman is not a property, but a noble and free human being; no one can give her to anyone in exchange for peace...or to end animosity". Both women and men, it had added, "should be equal" and that "no one can force women to marry by coercion or pressure". The decree also enabled a widow to re-marry 17 weeks after her husband's death against the longstanding Afghan tribal custom of her leadership has reportedly ordered Afghan courts to treat women fairly, especially in cases of widows seeking inheritance as next of kin. The announcement also cites the

Taliban as saying they had asked their Ministers to spread awareness about women's rights across the population.

Significantly, the first announcement does not mention the precise date when public universities will reopen. Nor does it mention women's right to work. The third sura of the Koran (ayats 193 and 194) forbids the wasting of anyone's — whether a man or woman's — labour. The fourth sura (ayats 36 and 37) says, "To the men a share of what they have earned,/ and to the women a share of what they have earned..." (translation from The Koran Interpreted by Arthur J Arberry). The second announcement says nothing about women's right to education and work, which are crucial issues with the international community. Also, the rights the decree announces regarding marriage have all been enshrined in Islamic jurisprudence since the time of Prophet Mohammad. Clearly, neither announcement means marrying one of her husband's much and is unlikely to brothers or relatives after his impress the international comdeath. ## **QUICK COMMERCE: A NEW RETAIL MANTRA**

Essentially large warehouses, dark stores enable fast delivery of goods in localities

wise person can create 'The Advantage of Adversity'. And you can very much learn this from retail marketers at this crucial juncture. Coping with the crucial situations of COVID-19, retail marketing is scaling newer heights. Business climate for retail marketing is getting conducive as there is a win-win situation for both the marketers and the clients. Today, retail industries are resorting to varied strategies to meet up consumers' demands. Moreover, the modus operandi of delivering the goods and services is becoming digitalized and even fast-paced. Consequently, understanding and innovating the retail has become a new business mantra. So much so Amazon, Flipkart, Ola, Uber, Zepto, Blinkit, Swiggy, Dunzo, Bigbasket and other business units are surprisingly found to be engaged with quick commerce companies. Owing to fasten the business, dark stores have been founded in the local area for treading

Quick commerce websites are used to provide an online platform for various trading in the country. However, this business method helps the online shoppers to make safe purchases for their stores. Such a business model wants to be the biggest kirana store in the urban colony. It should be expressed that a dark store hits a frequency of more than 200 orders per day. The unit economics depends on the fact that there is a mixture of perishable and non-perishable in transaction. Tellingly, quick commerce remains a new and evolving business management with the effective inclusion of information technology. Many e-commerce companies are turning to social media channels such as Facebook and Instagram to showcase their vast array of products. Customization is the key of this trade. It will facilitate speed and efficiency. Quick commerce addresses are meaningful. The customers can use their mobile devices for shopping. However, quick commerce can invite online fraudulent activities. Credit card frauds are persistent in online businesses. It is apparent that quick commerce or electronic commerce is above all a commercial transaction over the Internet. It is a space mainly to watch out for logistics and e-commerce players. The expectations are likely to settle in at a sweet spot of thirty minutes' delivery or so. According to industry players, ten minutes' delivery model will see rationalization over time. # Cinema ticket pricing vs bloated film costs

wo controversial Government Orders issued by the Andhra Pradesh Government related to entertainment and culture have created a lot of heat. The first Go issued in April 2021 was aimed at regulating film industry. The second one was recently issued banning a popular and message-oriented stage play 'Chintamani.' Both the issues could have been dealt with skilful ly had the Government consulted the stakeholders before taking the decisions.
The Government of YS Jagan Mohan

Reddy which has been dabbling in controversies of all kinds has added two more, involving the film industry and stage plays.

About 170 of the 950-odd theatres in Andhra Pradesh have been closed since the GO was issued. The exhibitors say they lost hugely due to Covid during 2021 when the theatres were completely shut. They were reopened with 50 per cent occupancy on July 31, 2021. Even before that, the State Government issued GO 35 fixing slabs for tickets in cinema halls in municipal corporations, municipalities, nagar panchayats and village panchayats under economy, deluxe and premium classes for multiplex, AC theatres and non-

Filmmaker Ram Gopal Varma met AP Information, public relations and cine-matography minister Perni matography Venkataramaiah (Nani) and told him that the Government has no business to intervene in this issue. It is for the exhibitors and audience to decide the price of tickets. Pawan Kalyan, film hero-cum-politician (president of Jan Sena which has alliance with the BJP) was rather aggressive in his criticism. He said since the Government has no money, it is indulging in online ticketing and fixing ticket prices. Minister Nani asked the actor why would the government which has no money would reduce the ticket price instead of increasing. Senior actor, Pawan Kalyan's elder brother and former union minister Chiranjeevi tried to break the ice when he travelled to Amaravati to meet Jagan Mohan Reddy over lunch on last Thursday. Some news channels and newspaper said Chiranjeevi was offered a Rajya Sabha seat by the YSRCP chief which was promptly and curtly denied by the mega star. He said the problem would be resolved soon.

What is the problem? Is it peculiar to Tollywood? So, it appears. The problems in the industry started with stardom. At least six stars today charge a fee of ₹45 crore each for a movie. Heroines also are paid in crores, though their remuneration is nowhere near the actors'. Directors donot take all the remuneration by cheque or cash but ask for share in the revenue area wise. Together they eat away threefourth of the budget.




## Will Russia play the 'Cuban card'?


#### But Russia stopped being Communist 30 years ago

fter a week of intense discussions about 'security' between Russia and the NATO countries, this is the week when the Western allies will send their written replies to Russian President Vladimir Putin. Various pundits, some of whom have actually been to Russia, warn us that there will be 'War in Europe' if Putin's demands are not met.

(You there, at the back. Stop giggling! This is no laughing matter! Peace is hanging by a thread!)

Historians keen for a moment in the limelight are being wheeled out to draw parallels with past diplomatic disasters like the Munich conference of 1938 (appeasement of Hitler) and Yalta in 1945 (carving up Europe and giving Stalin the eastern half in 1945).





Wow! A dagger - no, two daggers - pointed at the heart of America (although they'll have to work on the length of the Venezuelan dagger, since it's 2,000 km. from Caracas to Miami). If that does not force the

Americans to give in, what will? I'm sorry. That's enough sarcasm. It's just that all this prancing around and mugging for the camera gets tiresome. This is a minor diplomatic spat that has been deliberately inflated far beyond its merit, and it is

being taken much too seriously. Let's start with Russia play-



Maduro's regime in Venezuela also has aspirations in that direction - but Russia, in case you've Ryabkov's intention was forgotten, stopped being

Communist thirty years ago. Putin's regime in Moscow is nationalist-populist, and Cuba has absolutely no motive to host Russian troops and risk triggering a confrontation with the United States. In any case

Russian troops in Cuba would pose no military threat to the United States. What are they going to do? Invade Florida?

obviously to do a "How would you like it if...?" on American diplomats. How would like it if there were Russian troops '90 miles from Florida' (as people used to say during the Cuban crisis of 1962), and not NATO troops 450 km. from Moscow

(which is where they are now). The grown-up American answer to that would be "Who cares?" In real life, there are a number of troglodytes in the US

Congress who would work themselves up into a lather about Russian troops in Cuba - but since the Cubans would not agree to it in the first place, it's really quite irrelevant.

Well, then, what about the alleged historical precedents: Munich and Yalta? They were both about granting a 'sphere of influence' in Europe to a great power (Germany in 1938, the Soviet Union in 1945) that could easily enforce its wishes on the

Russia is effectively demanding a comparable sphere of influence in its old 'satellite' countries, which would not be allowed to have friendly foreign troops on

their soil even though they are NATO members, but it's a complete non-starter. Russia lacks the military capacity to enforce its rill on the ground.

So will there be 'War in Europe, as the feverish headlines suggest? Not in the sense they imply: massive armoured forces rolling across whole countries, with the threat of nuclear war looming in the background. But there might be some shooting on or just inside Ukraine's border

ith Russia Of course, there's already a little bit of shooting along that border, in the Russian-backed breakaway provinces of Donetsk and Luhansk. As Pentagon spokesman John Kirby said on Friday, Putin may now be plan-

ning to cause a little more. Kirby warned that Russia "has pre-positioned a group of

operatives to conduct what we call a false-flag operation, an operation designed to look like an attack on them or on Russianspeaking people in Ukraine, as an excuse to go in." He may be right - and he may be wrong. The satellites can see their location, but not their intentions.

Something has got into Putin, and he's seeking concessions that he should know he cannot extract, with threats that he cannot enforce. It is possible that he could

he would try to conquer all or even half of Ukraine. It is almost inconceivable

## 3 accused denied bail; court says their acts defamed womanhood

Mumbai: A court in Mumbai January 4. denied bail to three students arrested in the Bulli Bai app case by stating that the trio had committed serious acts of "defaming womanhood" and, therefore, in the larger interest of society the personal liberty of the accused can be curtailed.

The Bulli Bai app had made public the details of several Muslim women in a bid to malign them, allowing users to participate in their 'auction'.

Vishal Kumar Jha, Shweta Singh and Mayak Rawat were denied bail by Bandra Metropolitan Court Magistrate Komalsing Raj on January 20, but a detailed cop of the order was made available on Friday.

While Singh and Rawat were arrested by the Mumbai police's cyber cell from Uttarakhand on January 5, Jha was nabbed from Bengaluru on

"No doubt accused persons are students of tender age and they have fundamental right to life and liberty, but those rights are subject to reasonable restrictions. They were arrested for collection of evidence relating to non-bailable offence and, hence, their arrest is not in violation of any law," the magistrate said in the order.

They were found to have committed serious acts defaming womanhood. The larger interest of society is at stake. Therefore, their personal liberty can be said to be curtailed following due process of law," the magistrate said.

The court also noted there was "some ill-intention" on part of the creator and followers of the app as well as persons propagating and disseminating information about women of a

particular religion. Stating that, prima facie, the involvement in of the accused is noticed, the court said, "The disputed fact is only in respect of exact role played by them. It is contended on behalf of the applicants that they are just followers and dis-seminated the information containing its link. Even if it is presumed they are just followers/subscribers of the application, at this stage it cannot be said they are innocent."

The court further said records showed their "active involvement" in propagating and disseminating the information/data relating to the women.

## **Covid-19 cases continue to rise in Kerala, over 41K logged in 24 hrs**

Though Kerala's Department I of Health brought down the number of samples tested on Friday to 95,218, the Covid-19 cases continued to remain unabated in the State. A total of 41, 668 persons were diagnosed with the pandemic during the last 24 hours and the Test Positivity Rate surged to 43.76 per cent. A total of 51, 607 persons succumbed to the pandemic in the State till Friday evening, according to a release issued by Veena George, minister of health.

A Public Interest Litigation

filed in the High Court on Thursday had pointed out the restrictions were compromised possibly to facilitate CPI(M) district meetings. It has been argued by the petitioner that the Chairperson of the Disaster Management Authority can only amend his orders on certain new circumstances for the

The Kasaragod district meeting of the CPI(M) was underway at Kasaragod in violation of all safety protocols when the High Court delivered its interim order. "What is so special about the political party meetings? The number of persons who could attend the Republic Day itself has been restricted to 50," said the Division Bench. Taken aback by the High

Court order, the State leadership of the CPI(M) decided to hold the Thrissur district committee meeting which began on Friday. 
## **Curbs imposed amid** case surge in Valley

Srinagar: Authorities on Friday afternoon imposed restrictions on the non-essential movement of people across Kashmir as a 64-hour lockdown began in the union territory in view of an exponential rise in the number of coronavirus cases since the beginning of the new year, officials said.

Police vehicles fitted with public address systems announced the restrictions at several places across the valley in the afternoon after the government ordered complete restriction on non-essential movement during from 2 pm on Friday till 6 am on Monday in the entire Jammu and Kashmir, the officials said.

Shops and other business establishments in the city and elsewhere in the valley – which had opened this morning – were forced by police to shut in view of the restrictions, they



The police closed the markets and asked people to return to their homes. After the movement of people early in the morning, the police erected barricades at several places in the city here and other areas of the valley and the movement of public was restricted, the officials said.

They said only employees and emergency cases were allowed to move and all other non-essential movement was restricted.

The district authorities appealed to the people to cooperate with the administration and curtail their movement in view of the rising cases. PTI

## China raps US missile sanctions as hypocrisy

hina on Friday criticised Washington for imposing sanctions on Chinese companies the US says exported missile technology, and accused the United States of hypocrisy for selling nuclearcapable cruise missiles.

The United States announced penalties on three companies it said were engaged in unspecified "missile technology proliferation activities.'

It said they were barred from U.S. Markets and from obtaining technology that can be used to make weapons.

"This is a typical hegemonic action. China strongly deplores and firmly opposes it," said Foreign Ministry spokesperson Zhao Lijian. China urges the United States to immediately correct its mistakes, revoke the relevant sanctions and stop suppressing Chinese enterprises and smearing China.

"China accounted for about 5 per cent of global weapons exports in 2016-20, according to the Stockholm International Peace Research Institute.

The United States was the top global exporter, accounting for 37 per cent of the total in 2016-20.

Cruise missiles and longrange ballistic missiles are regarded as among China's

## America sanctions Ukrainian officials alleged to help Russia

**AP** ■ WASHINGTON

The US Treasury Department levied new sanctions on Thursday against four Ukrainian officials, including two current members of parliament who administration officials say are part of a Russian influence effort to set the pretext for further invasion of Ukraine.

The sanctions name parliamentarians Taras Kozak and Oleh Voloshyn and two former government officials. According to Treasury, all four have been intimately involved in disinformation efforts by Russia's federal security service, known as

The new sanctions were announced less than 24 hours after President Joe Biden said he thinks Moscow will newly invade Ukraine. He warned Russian President Vladimir Putin that his country would pay a "dear price" in lives lost and a possible restrictions in access to the global banking system if it does.

Biden faced criticism from Republicans and Ukrainian officials that he invited a limited Russian invasion by suggesting in comments to reporters on Wednesday that US Would react with a measured response if there was only a "minor incursion" of Ukrainian territory. ## **Vaccines to Africa must have** good shelf lives, says expert

At least 2.8 million doses of Covid-19 vaccines donated to African countries have expired, the Africa Centers for Disease Control said Thursday, citing short shelf lives as the major reason.

Donors of vaccines to the continent should send them with a realistic shelf life of about "three months to six months" before their expiration, Africa CDC director John Nkengasong told an online briefing. More African nations are now refusing to accept donations of vaccines that have only one or two months before their expiration, he said.

Although the number of expired doses is only about 0.5% of the total number donated to Africa, Nkengasong said he is unhappy to see any become invalid."Any dose of vaccine that expired pains me because that is a life that can potentially be Nkengasong said.

Just over 10 per cent of Africa's population of 1.3 billion people are fully vaccinated, he said. The continent's 54 countries have confirmed 10.4 million COVID-19 cases and 235,000 deaths. The continent's omicron wave appears to be receding, with new confirmed cases down by 20 per cent from the previous week and deaths dropping by 8 per cent, the World Health Organization's Africa office announced Thursday. "The deep inequity that left Africa at the back of the queue for vaccines must not be repeated with life-saving treatments." In 2022, more testing is needed to fight the pandemic, said Harley Feldbaum of the Global Fund. "We need to bring testing and treatment together in a much more rapid

## Family of four, believed to be Indians, frozen to death along US-Canada border; man charged with human smuggling

**▼**n a heartbreaking tragedy, a **I** family of four, including a baby, all believed to be Indians, has died from exposure to cold weather on the Canadian side of the border with the US in an apparent human smuggling operation, according to media reports.

Manitoba Royal Canadian Mounted Police (RCMP) on Thursday said that the bodies of four people - two adults, a teen and an infant-were found on the Canadian side of the U.S./Canada border near Emerson on Wednesday.

US officials say the dead are believed to be a family from have been attempting to cross into the US, according to media reports.

Commissioner Jane MacLatchy concerns the group's attemptshared the discovery with reporters in a news conference on Thursday."What I am about to share is going to be difficult for many people to hear," she said, calling it "an absolute and heartbreaking tragedy".

"At this very early stage of the investigation, it appears that they all died due to exposure to the cold weather," MacLatchy said, adding RCMP believe the four people are connected to the group that was apprehended on the U.S. Side of the border. ## Step back from Ukraine or be ready for massive consequences, UK Govt warns Russia

The UK government on ☐ Friday warned Russia of "massive consequences" if it did not step back from Ukraine, noting that it is working with partners like India to counter such growing threats to democracy and build a global network of liberty.

UK Foreign Secretary Liz Truss used a speech at the Lowry Institute think tank here to urge Russian President Vladimir Putin to desist from an invasion on its border with Ukraine, where tensions have been building up in the past few weeks.

She went on to call out Russia and China working together against forces of democracy as they get "emboldened" in a way never seen since the Cold War era.

"Russia and China are working together more and more, as they strive to set the standards in technologies like artificial intelligence, assert their dominance over the Western Pacific through joint military exercises and in space through closer ties," Truss said.
"China and Russia have

spotted an ideological vacuum and they're rushing to fill it. They are emboldened in a way we haven't seen since the Cold War. As freedom-loving democracies we must rise up to face down these threats. As well as NATO we are working with partners like Australia, India, Japan, Indonesia and Israel to build a global network of libsaid In her direct appeal to Putin, she noted: "The Kremlin hasn't learned the lessons of history. They dream of recreating the Soviet Union, or a kind of 'Greater Russia' carving up territory based on ethnicity, and language.

"We know what lies down that path, and the terrible toll in lives lost and human suffering it brings. That's why we urge President Putin to desist and step back from Ukraine before he makes a massive strategic mistake.

Truss warned of sanctions if such an invasion were to take place in Ukraine, where the UK has announced a new package of training, support and defensive weapons to boost defensive capabilities.

"Last week, at the NATO-Russia Council we sent a clear message to Moscow that any further incursion into Ukrain would bring massive consequences, including through coordinated sanctions hitting the financial sector, and individuals," Truss said. "We're also pushing for

alternatives in energy supply, so that nations are less reliant on Russia for their gas. We need everyone to step up.

Together with our allies, we will continue to stand with Ukraine and urge Russia to deescalate. What happens in Eastern Europe matters for the world," she added.Russia denies it is planning an invasion but has moved around 100,000 troops near its border with Ukraine. The North Atlantic Treaty Organisation (NATO) members, which includes the UK. US and several former Soviet Union states, agree on working together against such hand, has made a series of demands to the West, including not allowing Ukraine to

# SNAKES SOS: GOA'S WILDEST

In their new show, wildlife activists BENHAIL ANTAO and LOUISE REMEDIOS embark on a quest to conserve the species and simultaneously bust myths around them by educating the audience that these reptiles are not the danger lurking in the dark. By KHUSHBU KIRTI

Antao and Louise Remedios, in their new show, Snakes SOS: Goa's Wildest, were seen rescuing wild snake species and other undomesticated animals in Goa.

The 10-part adventure series is bringing in a spirit of adventure, thrill and adoration for wild animals. The power couple will face and rescue some of the wildest snake species in the most unusual of situations. It showcases the duo in action and giving an up-close and personal experience of their techniques in rescuing the varied snake species and other undomesticated animals through the city of Goa. It is understanding snake psychology 101, if you may.

Read on for excerpts from a candid interview with the adrenaline junkies and wildlife rescuers about insiders from their new series:

□National Geographic has introduced an Indian avatar of the show, Snakes in the City. How is it going to be different or how are you Indianising it?

extremely different shows. I think Goa's Wildest is an independent show and has everything unique about it. Right from the snakes they are Indian species and behave differently — to the places where they're rescued from. It's more about the snakes in this programme and more about the people who are encountering the snakes.

I mean, snakes are a problem everywhere. And the way people respond, the culture shown promotes repulsion or aversion. The message that we give through this programme is subtle — I want people to watch this and find between the lines. It's pretty clear where we stand when it comes to snakes and, the term, conservation. You know, snakes are not that danger lurking in the dark anymore. Snakes never were the danger lurking in the dark. The ideology of the show is pretty different.

#### **□**What is the aim of the show?

LR: So, first, we want to educate you about the kinds of snakes that are in Goa because this show has been shot there specifically. And a lot of these snakes are also present in different parts of India. People assume we're either dealing with an anaconda or a rattlesnake or Black Mamba. No, you don't get those. It's cool that people are watching these programmes, but they are not aware of the many varieties of venomous, non-venomous and different kinds of snakes that exist here. We want to create awareness.

Besides that, we want people to understand that snakes are like any other animal. You don't look at them like you look at a dog or a cat, right? There's a lot of myth and mystery. In India, mythology, which is associated with a snake, makes people more intrigued and more scared of them. People are unable to distinguish between mythology and fact. So, we're trying to bust these myths. There are so many more questions associated with our mythology when it comes to snakes, which we will be answering in the show. You'll find that message in every

which is a conservation technique of very ethical snake-rescue, to try and impart empathy into people. Because when you can put yourself into another animal's shoe, and understand where they come from, you will then feel empathy towards them, you will then understand them, and you will start to admire

We want you to understand the difference between fear and danger. We're trying to conserve the ecosystem, too. If you want to conserve any kind of habitat, you need to protect the animals in them.

**□**You've mentioned that there are so many myths around the species. I wanted to know, what are some myths and misconceptions around

BA: Yeah, that's super interesting. What most people know happens to be myths, like, for example, a very, very common myth is that a snake takes revenge. I've had people calling me up, like, you know, at three in the morning and saying, 'I



need help. When I enquire why they say they can't sleep because they rode over a snake in the daytime and are scared it's going to come and take revenge. So, it's no longer any rescue call, it's more of a counselling call (everyone laughs).

LR: So, what happens is that there are possibilities that these snakes, during mating season, release certain kinds of pheromones and perhaps you know, another snake tracks that and comes looking for the dead snake. These are territorial animals, if they see an open territory, they might come. Also, if it's a female's hormones that Indianising it?

We also want to set people on BA: Snakes in the City, or, for the right trend, which will be there a very small chance that a male will sense that and follow Howe snake is definitely not interested in you (chuckles). It can also be a coincidence.

**BA:** Funny how when people are given a choice, they will defer to the most supernatural explanation for it and the most expensive one. I heard of people who go around catching snakes and charging a huge sum of money. They feed people with all these myths, that snakes fly and coil around your neck, or that snakes dance to music.

□Wait, snakes don't dance to music? I mean that's what the snake charmer (sapera) does,

LR: Haha, see! Okay, so, first of all, the snake needs to enjoy the music, right? So, when we enjoy it, we are not scared of it. The fact is that when a cobra spreads its hood, it signifies that it's scared. The hood is a form of defence. So, it is definitely not enjoying and second, most snakes do not have external ears and cannot hear audible music! They can hear very low-frequency



sound vibrations.

Now, why does it shake or give the impression that it's dancing? It's because it is scared of that flute. It is following the movement of the

hand of the snake charmer. Most of the time, the snake charmer will have a long needle with them to poke the snake so they're scared of them and their hands. It looks to us

like they're dancing, they're not.

**BA:** And they claim that there is a diamond in the head. I mean, that's not possible. There is no stone or precious stone. If that would've been the case, we would have been multimillionaire (giggles).

A lot of times they pluck out the teeth of these snakes. What happens is that there can be a lot of bacterial infections and the snake can die from that. So the charmers pluck out the teeth just in case they come too close to the snake. They stitch the mouth sometimes. It is extremely sad.

□ I always thought that snakes knew how to protect themselves. If somebody does something like this, don't they bite?

BA: Oh, yeah, they do bite. Even snake charmers get bitten all the time. I mean, there are snake charmers that die of snake bites and sometimes they pull out the snakes' fang but don't notice there is anoth-

er fang and they've died of it. LR: But usually a snake gets very exhausted. If you provoke the snake, initially it will try to stay away from you, you provoke it a little more, it is going to give you a warning, provoke it still further it is going to bite you with a fake bite. It doesn't want to waste its venom on you. And then you really provoke, it's going to severely bite you. When you do it repeatedly, the snake gets scared, almost traumatised and tired. They have no energy to even strike most of the time.

**BA:** Also, it's not that every time they strike you, there's going to be venom, they can control how much venom goes in or doesn't go. Because that venom is a very important resource. And to produce venom, it takes a lot of energy for develop venom back.

Look, the snake doesn't want to bite you because it knows even if it does bite you with a full dose of venom, you can still kill it before you die. Right? It will still give you maybe like a fake strike, like a warning to leave it alone.

BA&LR: We live in Goa. We love Goa (both laugh).

**□**You are a power couple who are luxurious wedding planners in the day and deadly wildlife res-cuers at night. How did this dynamic transpire?

**BA:** I can talk for myself. But we have been passionate about rescuing wildlife and spreading awareness. I've been doing this for the last 19 years now, spreading the message of conservation.

Over a period of time, I did engineering, I worked in a company, we joined event management, then we got married and started our own event management company. So, all these happened along the way. But snake rescue has been the backbone. I mean, it's always been there. We never monetised it. But it's always been a passion.

LR: So, when my mom asked me about Ben, when we were dating, and what he does, I told them. My father was like, really? My mom surprised me. She said, 'you know, baby, I always thought you'll marry someone like this. You've always been one wild child. Now we're hashtag Goa's wildest (chortles).

I could handle the situation differently. There was no internet or books that could teach me the procedure. I've had my fair share of bites and stuff like that. Snakes don't appreciate that they are being rescued because they don't know they're being rescued. So, experimenting and not resorting to violence was how I learnt and I want to make others aware of the same.

## **NCAA** adopts new policy for transgender athletes

The NCAA has adopted a sport-by-■ sport approach for transgender athletes, bringing the organization in line with the U.S. And International Olympic Committees.

Under the new guidelines, approved by the NCAA Board of Governors on Wednesday, transgender participation for each sport will be determined by the policy for the sport's national governing body, subject to review and recommendation by an NCAA committee to the Board of Governors.

When there is no national governing body, that sport's international federation policy would be in place. If there is no international federation policy, previously established IOC policy criteria would take over.

"Approximately 80% of U.S. Olympians are either current or former college athletes," NCAA President Mark Emmert said in a release. "This policy alignment provides consistency and further strengthens the relationship between college sports and the U.S. Olympics." The NCAA policy is effective immediately, beginning with the 2022 winter championships.

NCAA rules on transgender athletes returned to the forefront when Penn swimmer Lia Thomas started smashing records this year. She was on the men's team her first three years, but she is competing for the women this season after transitioning. The Board of Governors is suggesting NCAA divisions allow for additional eligibility if a transgender student-athlete loses eligibility based on the policy change.

In his previous stint, Stephan secured Rennes' first trophy in 48 years and led the

Skipper Yash Dhull, his deputy Shaik Rasheed, and Aaradhya Yadav, all of who tested positive in the Rapid Antigen Tests (RAT), have been confirmed positive in the latest RT-PCR reports along with Manav Parakh, who had tested negative in RAT.

(Adelaide Oval on November 2). The Men in Blue's last Super 12 match is scheduled for November 6 against the winners of Group B at the MCG. The Super 12s -- round two of the tournament, with two groups - will begin on October 22 with hosts and defending champions Australia playing New Zealand at the SCG on October 22 in a re-match of last year's men's T20

World Cup final.
The Black Caps will also face England at The Gabba on November 1 in a re-match of their epic semi-final encounter at the 2021 event. In Super 12s, Australia are in Group 1 with world number one England, New Zealand, Afghanistan plus the

winner of Group A and the runner-up in Group B from the first round. The semi-finals will

be played at the SCG and Ađeláide Oval on November 9 and 10, respectively. It will be the first time the Adelaide Oval will host a World Cup semi-final. The MCG will host

the final, which will be contested under lights on November 13.

In the first round, 2014 champions Sri Lanka and Namibia will play the opening match at Kardinia Park, Geelong on October 16. They'll be joined by two qualifiers in Group A.

Two-time champions West Indies will also start in the first round, joined in Group B.
