On the eve of Republic Day, the Centre bestowed the Padma Vibhushan award, India's second-highest civilian award, on the country's first Ghief of Defence staff, late General Bipin Rawat, and for-mer Uttar Pradesh Chief Minister late Kalyan Singh. The other two Padma Vibhushan awardees are noted musician Prabha Atre and Gita Press Chairman Radheshyam

Khemka (posthumously).

Among the 17 Padma
Bhushan awardees, two political leaders from the Congress and the CPI(M) — Ghulam Nabi Azad and former West Bengal Chief Minister Buddhadeb Bhattacharjee figured in the prestigious award list. However, Buddhadeb refused to accept the award. The Ministry of Home Affairs (MHA) on Tuesday came out with a list of 128 distinguished personalities from different fields for Padma Awards.

The list comprises four Padma Vibhushan, 17 Padma Bhushan, and 107 Padma Shri Awards. Out of 128 awardees, 34 are women and the list includes 10 persons from the



category Foreigners/NRI/PIO/OCI and 13 posthumous awardees. Padma Awards are conferred in three categories: Padma Vibhushan, Padma Bhushan and Padma Shri. Rawat hails from Uttarakhand and Kalyan from Uttar Pradesh, the two States which are headed for Assembly polls. The political significance of the Centre's decision to handpick Azad for giving the Padma award is not lost. Azad comes from Jammu & Kashmir, a Union territory, where the Centre is trying its best to win over the masses through the political process. Azad has been of late sidelined in the Congress and has also been in the news for repeatedly praising PM Narendra Modi.

Singh, 57, is a prominent

Singh, 57, is a prominent leader and a member of royalty from the Eastern UP. He has been a three-time Congress MLA from Padrauna and a Member of Parliament from Kushinagar.

He joined the BJP shortly after writing a brief letter of resignation to the Congress president Sonia Gandhi.
Singh's exit from the party

Singh's exit from the party has come as a massive blow to the grand old party in the run-up to Uttar Pradesh Assembly elections. The Congress leadership was apparently caught by surprise because it named Singh as the "star campaigner' only a few days ago." days ago.

A section of the party leaders feels that Singh's exit was good riddance because he had been hobnobbing with the BJP for the last one year to topple the Congress-JMM Jharkhand Government. RPN, known within the Congress circle, was Congress general secretary in charge for the Jharkhand for the last three years.



Singh, a key Kurmi OBC leader from eastern UP, is the second big exit for the Congress in the State after Jitin Prasada, who is now a Minister in the Yogi Adityanath-led BJP

Government in UP.

Addressing the media after joining the party here at the BJP headquarters in the presence of BJP UP in-charge Dharmendra Pradhan, UP party president Swatantra Dev Singh, UP Deputy-Chief Ministers Keshav Prasad Maurya and Dr Dinesh Sharma, and Jyotiraditya Scindia, Singh lauded Prime Minister Narendra Modi who, Government in UP. Minister Narendra Modi who, he said, is being "appreciated roundly for linking the ancient

Indian civilisation and cul-

ture with the 21st century'

Singh is also seen as BJP's Assembly candidate against OBC leader Swami Prasad Maurya who recently left the BJP to join the SP.

Criticising the Congress, his erstwhile party, Singh said, "I spent 32 years in one political party (Congress). But that party has not remained the same as it was before when I joined it. I will work as a karyakarta' towards fulfilling PM Modi's dreams for India, said Singh. He also praised the double-

engine Government and the change in the law and order situation in UP.

SC issues notices to Centre, EC on guidelines on 'freebies' in polls

PNS NEW DELHI

The Supreme Court on Tuesday issued notice to the Centre and the Election Commission on framing of guidelines on "freebies" promised by political parties

promised by political parties before elections.

Observing that it was a "serious issue", and "freebie budget" was going beyond the regular Budget, the court sought a response from the poll body and the Union Government in four weeks.

The Chief Justice of India

The Chief Justice of India said that the Supreme Court, in a different issue, had directed the poll body to frame guidelines on the matter but the poll held just one body meeting whose outcome is unknown.

"Within the limited scope, we had directed the Election Commission to frame guide-lines. But subsequently, they conducted only one meeting after our directions. They sought views from political parties and thereafter I do not know what happened," NV Ramana, the Chief Justice of India, said.

A bench of CJI Ramana, Justice AS Bopanna and Justice Hima Kohli was hearing a plea filed by lawyer and BJP leader Ashwini Upadhyay saying public funds were being misused by all political parties, pushing States deeper into debt.



Channi 'Thor', Rahul 'Hulk' take on 'aliens' in Punjab

With the political parties fighting the ballot-battle in the virtual arena amidst restrictions on physical road-shows and rallies for February 20 Punjab polls, Punjab Congress has come up with a latest campaign video - inspired by 2018's Hollywood superhero movie "Avengers" - featuring Chief Minister Charanjit Singh Channi as the mighty god of thunder "Thor" and Rahul Gandhi as "Bruce Banner".

Through the 34 seconds video, the Congress has virtually declared war against its rival political parties. Sharing



it on its social media handles. the party captioned, "We will do whatever it takes to redeem our beloved State from the clutches of evil forces working against the interest of Punjab and its people". In the video, Channi can be seen as "Thor" carrying the Stormbreaker, Rahul Gandhi as "Bruce Banner" wearing the Hulkbuster, Punjab Congress president Navjot Singh Sidhu as Captain America, and senior party leader Sunil Kumar Jakhar as "Groot".

The video, which starts with Hulk-Rahul Gandhi announcing "Koi na bachna tussi" (you can no longer be saved) in a warning to the opponents, also portrays Channi in the lead role - in an indication to be the party's choice of CM candidate. Continued on Page 11

Notification issued for 3rd phase polls

PNS LUCKNOW

The Election Commission of India issued the notification for the third phase of UP assembly elections on Tuesday.

The third phase polls will cover 59 assembly constituencies spread across 16 districts of Bundelkhand and polling will be held on February 20.

UP Chief Electoral Officer Ajay Kumar Shukla said in Lucknow that notification for the third phase was issued at 11 am on Tuesday. Shukla said that more than 2.15 crore voters com-

prising 1.16 crore males, 99.62 lakh females and 1,096 of the third gender would exercise their right to franchise in the third phase.

The chief electoral officer said that candidates could

submit their online application through Suvidha web portal and submit the copy of application form to returning officer.

No candidate will be allowed to take out a procession at the time of nomination in view of COVID-19 pandemic. The last date for the third phase nominations is February 1, scrutiny of nominations will be done on February 2 and the last date for withdrawal is

A total of 59 assembly constituencies will go to polls in the third phase in 16 districts namely Kasganj, Hathras, Firozabad, Etah, Mainpuri, Farrukhabad, Kannauj, Etawah, Auraiya, Kanpur Dehat, Kanpur Nagar, Jalaun, Hamirpur, Mahoba, Jhansi and Lalitpur.

The assembly constituencies going to polls in the third phase are Hathras (SC), Sadabad, Sikandararau, Tundla (SC), Jasrana, Firozabad, Shikohabad, Sirsaganj, Kasganj, Amopur, Patiali, Aliganj, Etah, Marhara, Jalesar (SC), Mainpuri, Bhogaon, Kishni (SC), Karhal, Kayamganj (SC), Amritpur, Farrukhabad, Bhojpur, Chhibramau, Tirwa, Kannauj (SC), Jaswantnagar, Etawah, Bharthana (SC), Bidhuna, Dibiyapur, Auraiya (SC), Rasulabad (SC), Akbarpur-Rania, Sikandra, Bhognipur, Bilhaur (SC), Bithoor, Kalyanpur, Govindnagar, Sisamau, Arya Nagar, Kidwai Nagar, Kanpur Cantomhen, Maharajpur, Ghatampur (SC), Madhaugarh, Kalpi, Orai (SC), Babina, Jhansi Nagar, Mauranipur (SC), Garoutha, Lalitpur, Mehrauni (SC), Hamirpur, Rath (SC), Mahoba and Charkhari.

In the 2017 assembly elections, the Bharatiya Janata Party had swept the polls by winning 50 of these 59 assembly seats while the Samajwadi Party had won seven and Bahujan Samaj Party and Congress one each.

With the electoral competition intensifying between the Bharatiya Janata Party and Samajwadi Party, the non-Yadav Other Backward Classes has emerged as a distinct voting class in Uttar Pradesh. The battle for non-Yadav OBC vote bank has ensured that in the coming year this voting bloc will be a significant player in electoral politics of UP.

The BJP in 2014 and 2019 Lok Sabha elections and 2017 UP assembly elections drew rich political dividends as it forged a new social coalition of non-Yadav OBCs, non-Jatav Dalit communities and upper castes. The BJP has been stung by a spate of resignations, including by three non-Yadav OBC ministers Swami Prasad Maurya, Dara Singh Chauhan and Dharam Singh Saini.

The three ministers of the Yogi Adityanath council of ministers along with a couple of other non-Yadav OBC MLAs of BJP also joined the SP. This development has placed the Akhilesh Yadav-led SP, a serious contender for the throne in Lucknow in a good position.

The SP, keen to shed its Muslim-Yadav tag, has increased the representation of non-Yadav OBCs in the ticket distribution for the

Though the BJP was able to draw political dividends from this vote bank in 2014 for the first time, the foundation for this vote bank was laid by BJP Chief Minister Rajnath Singh in 2001. On June 28, 2001, then Chief Minister

Rajnath Singh had constituted a social justice committee headed by then cabinet minister Hukum Singh to devise an equitable policy for distribution of reservations. The committee recommended quota within quota for the non-Yadav OBCs. The total quota for OBCs is 27 per cent.

Both Samajwadi Party and Bahujan

Samaj Party had then vehemently opposed

the idea. The committee recommended that

dominant OBC castes like Yadavs, Kurmi and Lodh be slotted in the first category and assigned five per cent reservation. Eight castes, Sonar, Jat, Kurmi, Giri, Gurjar, Gosain, Lodh and Kamboj, were declared more backward and allotted nine per cent reservation, whereas 70 castes, including Kushwaha, Kashyap, Nishad, Koeri, Teli Saini, etc were classified as most backward and given 14 per cent reservation. The BIP, however, failed to reap any political dividend in 2002 UP assembly elections and the party finished third in the polls. Mayawati headed the next BSP-BJP coalition government and it scrapped the report.

The electoral contest in UP has remained triangular for the last two decades, with the BJP, the BSP and the SP being the principal power contenders.

These political parties enjoy strong support among the upper castes, scheduled castes and Yadav-Muslim communities, respectively. Voters who comprise a strong social support base of political parties are identified as partisan voters. Such voters play an indispensable role in the surge and decline of political parties, but they do not decide victory in elections

This is decided by the less partisan voters who do not remain aligned with any political party. In UP, such voters are the non-Yadav OBCs. Till the 2012 UP assembly elections, non-Yadav OBCs decided electoral outcomes heavily due to their alignment largely with the SP and BSP and a small section with the BJP.

The BJP in UP has worked hard to mobilise the non-Yadav OBC voters since 2014 Lok Sabha elections and reaped rich political dividends. In fact BJP has built a coalition of upper castes, non-Yadav OBCs, and non-Jatav SCs in the state. This new social coalition has broken all previous records and the BJP has not only been able to win the highest number of seats, but also increase its vote share. In the upcoming assembly election, it appears that a serious attempt has been made by the SP to dent this

Battle on for non-Yadav Bodies of missing minors found buried in field in Gorakhpur

Gorakhpur was again rocked by a sensational double-murder after the bodies of two minors who went missing 18 days back were recovered from a field on the fringes of Nauvari Palipa village in Jhangha area on Tuesday.

The hands of both victims were tied and there were injury marks on the head. The bodies were later sent for post-mortem examination.

As per reports, Ganesh Jaiswal (17) and Akash Jaiswal (16) of Nauvari Palipa village of Jhangha area had left home late in the evening of January 7 and later went missing since then. Their family members first assumed that both had gone to work in a factory in Gorakhpur industrial area. But after searching, when they failed to trace them, the new market police outpost in-charge Abhay Pandey was informed about their disappearance and a probe was initiated.

On Tuesday, some stray animals dug up a pit in a field exposing the buried bodies. Some passers-by noticed the concealed body parts and informed the Jhangha police station.

Later, Superintendent of Police (North) Manoj Awasthi and Circle

Officer of Chaurichaura, Akhilanand Upadhyay, reached the spot along with a forensic team. The police dug up the ground and retrieved the bod-

The hands of both victims were tied with a rope and there were injury marks on their heads.

The family members said that on the night of January 7, four of the victims' friends had come home. They first came to Ganesh's house and took him along and then came to Akash and also took him along with them. Since then Ganesh and Akash were not seen.

The police have now started searching for their friends. Both Ganesh and Akash's father are farmers. Ganesh was a student of Class 11, while Akash was the breadwinner of his family. Meanwhile, one person was brutally beaten to death over a political dispute in Hardoi.

Lucknow (PNS): A team of UP Special Task Force nabbed an accused named in the murder of history-sheeter Ajit Singh in Vibhuti Khand police station area in Gomti Nagar on Tuesday.

The accused, Vipul Singh aka Vipin Kumar Singh of Jaunpur district, was carrying a cash reward of Rs 50,000. The STF was handed over the case of Ajit Singh's murder on January 8 after Lucknow police failed in its efforts. Police said Vipul had driven injured Rajesh Tomar to Sultanpur for treatment. Tomar had allegedly opened fire at Ajit Singh who fired back at him in retaliation.

D demand ban on opinion polls

Lucknow (PNS): Rashtriya Lok Dal has demanded a ban on opinion polls being aired on different news channels with an immediate effect.

In the statement, RLD national secretary Anil Dubey said he had handed over a memorandum of demand to the chief election officer.

He said the announcement of UP assembly election was made on January 8 and nomination for the

second phase of election was underway despite this some news channels were airing opinion polls related to the election and this way they were affecting the transparency and objectivity of the polls.

Dubey said the news channels were creating confusion among the voters by their opinion polls and this was a clear violation of the model code of conduct.

"The opinion polls shown by the news channels are presenting uneth-ical things and violating the model code of conduct. This may influence the voting trend and the very aim of ensuring free and fair elections will be defeated," he said.

The RLD leader said the Election Commission of India should immediately ban opinion polls to ensure free and fair polls.

and protecting their party's goons and mafia, etc., pushed UP to jungle raj. They are guilty of troubling the public, but their rhetoric continues."




state, which was increasing continuously and causing frustration to people. The society and the state were lagging behind

Medical experts warn of new Omicron variant

m edical}$ experts have warned of a new variant of Omicron in the country which they say is more infectious than the current Omicron variant.

Officials from the Health department, however, say that an unnecessary hue and cry is being raised over the new variant because the number of coronavirus positive cases in Uttar Pradesh is already on the decline.

Piyalli Bhatacharya from Sanjay Gandhi Post-Graduate Institute of Medical Sciences said that the new variant of omicron (BA2) was gradually replacing the classical BA1 as per reports from across the country

"The new sub-lineage (BA.2) does not carry the spike 1 he new sub-lineage (BA.2) does not carry the spike 69/70del deletion and thus is not detectable by SGTF (S-gene target failure). Experts say that there could be more infections and that it will spread rapidly and also it may end abruptly," she said, adding that there were reports that BA.2 was already replacing the original Omicron variant in India "What is still not known is whether re-infection occurs if previously infected by BA1 and re-infected by BA.2 and what is also not known is the effect of vaccination on

and what is also not known is the effect of vaccination on this variant. The protection is proper mask and vaccinati on though there is no benefit of curfew and lockdown," she

State Covid Surveillance Officer Vikasendu Aggarwal said that he found no significance in the issue because the COVID-19 cases in Uttar Pradesh were really going down. Aggarwal said that he had no specific data on the new Omicron 2 vari-

ant but infections were definitely going down in UP. When asked if the COVID-19 figures were an actual projection of the infection, he said that if the numbers were going up it would reflect in the figures and there was no way one could change it.

"Across the state in the 75 districts there are so many labs which are carrying out tests and they are independently reporting the cases," he said.

He admitted that there may be many who may not have taken the test but the crucial thing was that the positivity rate was coming down.

"UPs positivity rate is 6.5 per cent which was earlier 7.8 per cent. This is important even if you consider that some patients are not getting themselves tested," he said.

When asked if UP had crossed the peak, he said that it

was difficult as yet to say anything.

Meanwhile, Organised Medical Academic Guild secretary general Ishwar Gilada also said that there was unnecessary buzz about the new variant of Omicron and the only thing which was important was to know that all the sub-lineages of Omicron were not fatal and were less viru-

He said that the Omicron variant of novel coronavirus had three sub-lineages namely BA.1, BA.2 and BA.3. He said that people had a wrong perception that the new variant BA,2 had emerged now since it was already prevailing.

"In European and Asian countries only BA.2 seems dominant. In a recent round of genomic sequencing in India, 88 per cent of the total COVID-19 positive samples had Omicron and almost 80 per cent had BÂ.2. BA.1 may be around 5-6 per cent and BA.3 is extremely low. The BA.2 sub-lineage patients have high viral load and so are highly infectious. Sgene drop test which is used as a proxy marker to detect Omicron variant has lit of false negativity with BA.2 sub-variant," he said. Apart from these two differences, there was nothing specific about the sub-lineages as regards to the outcome, he added.


As many as 1,854 people tested positive for novel coronavirus infection in the city while 3,103 COVID-19 patients recovered during the last 24 hours.

Drop in new Covid cases in UP

Uttar Pradesh showed a dip in new COVID-19 cases for the fourth day in a row on Tuesday as 11,583 people tested positive for coronavirus infection in the last 24 hours while 18,875 patients recovered in the corresponding period.

Additional Chief Secretary (Information) Navneet Sehgal said in Lucknow on Tuesday that at present there were 86,563 active cases in the state out of which 84,141 were undergoing treatment at home.

During a meeting of Team 9 officials in Lucknow on Tuesday, Chief Minister Yogi Adityanath directed officials to administer the first dose of Covid vaccine to cent per cent of the eligible population and the second dose to at least 75 per cent of the eligible citizens by January 31.

Over 98.14 per cent of the people above the age of 18 years have received the first dose of Covid vaccine, while over 66 per cent have received both doses of the vaccine. About 58.71 per cent ado-

lescents in the age group of 15-17 years have received the vaccine cover and more than 65 per cent of the eligible people the target till January 31.

Monday. He was unmarried.

Childhood obesity contributes to risk of numerous health problems

Noted Yoga expert, Dr Shalini Vaidya and head of Sadhak Anshit Ýoga Institute, while addressing a webinar on 'Childhood Obesity' said childhood obesity contributed to the risk of numerous health problems. She said study carried out by the Institute showed that in obese students the cognitive functions were significantly weakened. She said significant impairments in their cognitive functions, especially attention, retention, intelligence, and cognitive flexibility, were observed. She she said thus it was necessary that the school adolescents were involved in physical activities to reduce body weight in order to have cognitive functions within normal range.

She said obesity in childhood and adolescents was a serious community concern and the magnitude of the problem was progressively affecting low, middle and high-income sections mainly the urban population. She said the obese children were likely to stay obese into their adolescence and later part of their life. She said school age was a period of strenuous growth because of a greater amount of activity and the development of physical and cognitive functions, required a balanced nutrition.

She added that from the approach of neuropsychology, ample nourishment with physical activity was compelling for healthy brain growth, optimal

learning, and scholastic performance She said the major change in lifestyle of families with eating habits and increasing hours of inactivity because of video games, social media, and computer had played a noteworthy role in enhancing obesity in school-going children who are overweight. She said as a result childhood obesity led health-associated risks at adulthood.

She said thus yoga asanas need to be taught to school children which will help burn calories, tone muscles, boost metabolism and also prevent the child from emotional eating. She said yoga brought about mindfulness that will help child maintain a disciplined lifestyle and make healthy lifestyle choices. She said yoga will not only boost metabolism but it will also help the child steer clear of emotional eating and overeating and thus they need to practice these asanas. Dr . Vaidyta said Vinyasa Flow was a series of yoga poses that one needed to move through quickly and the sequence increased the heart rate, tones the body and brought along mindfulness. She said similarly Surya Namaskar or sun salutation had many benefits from boost-

ing metabolism to toning body

Virabhadrasana or the warrior

She said in this pose, one needed to use upper body and core muscles simultaneously, making it especially great to strengthen the core muscles.

She said next was Halasana or plough pose which toned the muscles of butts and strengthened the shoulders. She siad it stretched out the hamstrings and the muscles of the abdomen. She said apart from concentrating on the core, this asana also toned the muscles of the thighs and arms.

She advised parents to ensure they put their children under the tutelage of yoga trainers to ensure they grow in healthy manner.

Pandey while addressing the students said at every stage of women's life, nutrition and regular exercise were the cornerstones of good health and optimal energy. She said the onus rested on the parents to ensure they provide healthy diet to their daughters which included fruits, vegetables, whole grains, low-fat dairy products and lean sources of protein. She advised that parents need to encouraging girls to be more physically active while reducing high-calorie foods can help balance the energy equation and by starting early, they set a pattern of healthy eating that will carry them through their life.

She said girls also need health care more and access the health care system due to their reproductive and sexual health needs, they also have more hronic non-reproductive health issues such as cardiovascular disease, cancer, mental illness, diabetes and osteoporosis. She said hygiene especially menstrual hygiene was a hygienic practice during menstruation which can prevent girls from the infection in reproductive and urinary tract. She said hygiene-related practices of women during menstruation were of considerable importance, as it may increase vulnerability to Reproductive Tract Infections (RTI's).



MLA's son among 7 killed in car accident

Wardha: Seven MBBS students, including the son of an MLA, were killed in Wardha district of Maharashtra in the wee hours of Tuesday when the car they were travelling in fell off a bridge, police said.

The incident occurred around 1.30 AM near Selsura village in Wardha district, 77 km away from Nagpur, in east Maharashtra. An official said that all seven

students died on the spot. One of the seven students, Avishkar Rahangdale, was the son of Tirora BJP MLA Vijay Rahangdale. He was a first-year MBBS student of the Jawaharlal Nehru Medical College at Sawangi (Meghe) in Wardha. "One of the deceased students was a medical intern. Of the rest six, two each were studying in the final year, third year and first year," he said. Other six deceased are identified as Niraj Chauhan, who hailed from Daudpur in Gorakhpur, Pratyush Singh, Shubham Jaiswal from Chandauli (Uttar Pradesh), Vivek Nandan and Pawan Shakti (both from Gaya in Bihar), and Niteesh Kumar Singh from Belapur in Odisha. both his hands and legs were chained. "The record was created to make children to draw inspiration from it and I am happy," he said. Kadekar had earlier entered

the India Book of Records by swimming 1.4 km in 73.7 minutes by chaining his legs in the 'Padmasana' posture at Padukere at the senior level. *PTI*

Gangadhar Kadekar, who entered the **Arabian Sea from Padukere beach** shore in Udupi at 7.50 am on Monday, completed his swim by 1.25 pm

on January 24, 2021. He also created a record by swimming with his 41 students at St Mary's Island on February 14, 2021.

Kadekar, who took to swimming at the age of 50, founded the Jai Durga swimming club in Udupi and has been providing training to youths for the last two years. Life before death

The vaccination drive in terror-hit regions hasn't run into any problem, which is a good sign

n June 8 last year, Weyan, a tiny hamlet in Kashmir's Bandipora district, became India's first village to vaccinate its entire adult population against COVID-19. In a few days, Jammu and Kashmir will become India's second State, after Himachal Pradesh, to vaccinate all those over 18. The achievements are noteworthy considering health workers had to brave inaccessible terrain, non-existent communication facilities, terrible weather and terrorism to complete the process of giving the first dose of the vaccine to all. The State's vaccination drive carried on in the face of frequent incidents of cross-border terrorism in one of the most hostile international border areas of the world. The drive stayed on course despite a wave of killings throughout October 2021 when terrorists targeted non-Kashmiris, members of minority communities and did not spare even daily wage labourers. The surge in violence left 33 dead. However, the health workers were welcomed wherever they went, especially in areas known for separatist sentiments. The presence of security forces accompanying the teams caused no reservation among the locals, who overcame their wariness to receive the doses. The possibility of some separatist elements or sympathisers surreptitiously getting a free dose

by the State cannot be ruled out. For once, the fear of terror paled before the fear of the unseen virus. That brings us to the moot issue: Do anti-State elements, whether terrorists, militants, insurgents, Naxalites or Maoists have a right to COVID-19 vaccines?

Under international humanitarian law, in situations of conflict. the wounded and sick are entitled to medical care. During the pandemic that we currently face. such care can include a vaccine. The State, which alone can acquire the vaccine, arranges for it to reach across the country. It will respect its human rights duties towards the population living in the conflict areas. The

resistance groups have the primary responsibility for the wellbeing of those living in their area of influence. Whether in J&K that witnesses terror attacks, the 'Red Corridor' districts in central India that brave Maoist attacks, or the deep interiors of some States in the Northeast which have a brush with insurgency, the issue must have cropped up when security agencies were preparing for the vaccination drive. In Maharashtra, Telangana, Chhattisgarh and Odisha, there were reports of the virus infecting Maoist cadres deep inside forests. Many may have succumbed for lack of medical care. The lockdowns or movement restrictions prevented couriers and sympathisers from reaching medicine or oxygen cylinders to them. What we do know is that the vaccination drives were never disturbed. In the Northeast, too, the drives never met with harm. The insurgents, like the Maoists, must have realised the danger of the virus spreading in their areas. The States did offer anti-COVID treatment and vaccine doses to those who surrendered. It is not known how many acceded to the call. Parliament must debate the issue and give shape to a protocol for the future.

Happy R-Day

But it's time for agencies to work professionally and to let the suffocating security cover go

s India celebrates its 73rd Republic Day today, there is a multi-layered security ring enveloping the Capital. Of course, the pandemic is a hindrance to the grandioslity of celebrations for a couple of years now. But, that apart, is there really a need to insulate the normal, common Indians from their national celebration? Why shouldn't they be allowed to be part of the joy, pride and festivities as those who claim to be the top layer among equals, that too in the name of protecting the latter? And from whom; one's own countrymen? Of course one remembers what happened at the Red Fort this day last year. But one also distinctly remembers that when former US President Bill Clinton



visited India towards the turn of last century, there was minimal inconvenience caused by the Secret Service people. They would diligently check all equipment besides mandatorily body-checking all incoming persons but they would never be overly intrusive. Why can't our security agencies be as professional? The only reason, it appears, is that they are still unsure of their own abilities; therefore, they'd rather issue advisories banning all sorts of items to a VVIP venue.

There is no denying that any untoward incident on such a momentous occasion would come as a major embarrassment for the Government and the security

establishment but another way of looking at it is, as some politicians have said in the past, women shouldn't venture out of their homes late at night because rapists are on the prowl. Well, rather than advising a well-meaning, perhaps late-working, woman to stay indoors, shouldn't the police rather focus on increasing its presence on the streets and aim for crime prevention rather than trying to solve it after their laxity has allowed it to be executed? Delhi Police Commissioner Rakesh Asthana has informed that more than 27,000 personnel of the force have been deployed for security duty and anti-terror measures have also been intensified. Delhi Police is also getting assistance from 65 companies of the Central Armed Police Force (CAPF). Anti-terror measures are intensified comprising of the checking of hotels, vehicles, blockades of several locations, among others. All of this is good, but the moot point is: Don't victimise innocent citizens. May hope and peace always be in the country! Happy Republic Day.

The eternal flame can't be partial to our soldiers ASHOK K MEHT



The 'othering' of Indian soldiers in colonial times was the biggest disservice to the collective memory of the armed forces; it must be rectified now

n his book Surrender at Dacca: Birth of a Nation, Lt Gen JFR Jacob utilised one page to state: "The rifle and helmet that forms the centrepiece of the Amar Jawan War Memorial at India Gate once belonged to a soldier unknown to history who died on the battlefield on the outskirts of Jessore. There is no inscription on this monument." Then he recalls the legendary inscription at Kohima which, he says, is "appropriate for our jawans who laid down their lives in the rice paddies of Bangladesh: Let us not forget

India Gate and, under its

canopy, the statue of the Unknown Soldier of 1971 war called the Amar Jawan Jyoti have become enduring symbols of nation's gratitude to the armed forces. Inside the India Gate arch are etched names of some Indian soldiers who fought in World War I and Third Afghan war not the complete lineup of Indians who fought colonial wars of pre-Independence India. The National War Memorial that came up in 2019 recorded the names of all martyrs in wars, and internal stability operations after Independence. The 'othering' of soldiers in colonial times was the biggest disservice to the collective memory of the armed forces. The discrimination between British Indian Army and the Indian Army should have been challenged by Service Chiefs when Governments would ignore commemoration of battles fought by Indian troops abroad. Even now, the NWM has no place for the 'others' as India Gate was never an inclusive salute as it excluded those who fell in pre-Independence wars.

Thousands are buried across Europe, Middle East, SE Asia and N Africa. India's contribution to the Great Wars and other campaigns was outstanding. Field Marshal Claude Auchinleck said that Britain would not have won the wars without Indian Army's ontribution. Even Prime Minister Winston Churchill praised the unsurpassed bravery of Indian troops. Of the 1.4mn Indians in World War I, 74,000 were killed and 64,350 wounded. About 2,200 decorations were won by Indian soldiers. In World War II, 2.5mn took part; 87,000 were killed with 34,354 wounded. Including 18 Victoria Crosses, 4,000 decorations were awarded.

According to an Army source, the fusion of two flames and shifting the India Gate flame to NWM does not mean that the four urns surrounding the Unknown Soldier will be extinguished. One will continue to glow eternally, celebrating India's only military victory in 1,000 years. But there will be one NWM, not two. That still leaves several questions. Will one of the four urns continue to burn; will the tri-service guard remain under India Gate; will the statue of the Unknown Soldier be ultimately shifted to NWM? And who will occupy the vacated space. When the NWM was inaugurated, Government said the sanctity of the eternal flame will be maintained at India Gate. We are not sure. Last Sunday, the hologram of Netaji Subhas Chandra Bose was installed in the empty canopy near India Gate which once contained King George V's statue. Once his granite statue is sculpted, he will become the top contender for the space under India Gate. Prime Minister Modi

said: "The heroes whose mem-

Almost 90 per cent of military traditions and regimental ethos, ethics and values are drawn from pre-Independence period, including Beating Retreat, colour presentations, gallantry awards and battle honours. Nearly 80 per cent of our regiments were raised 150-200 years ago. Almost everything in the military is carry-over of British relics and traditions; we must accept it unhesitatingly. Regiments still celebrate battle honours and gallantry awards that were won in the Great Wars. But we are still arguing about renaming Aurangzeb Roads and railway stations. Britain ruled for more than a century and created an empire that stretched from Belize to Hong Kong, surpassing the conquest of even the Mongols.

Today, Britain's tiny miliv has lost none of its sheen though its empire is gone. The entire British Army has dwindled to smaller than our 43 Gorkha battalions. Still, the glory lingers on and will never extinguish due to

embedded traditions. India has a lot to learn from its military history. India this year will surpass Britain's GDP to become the fourth biggest economy. The process of Indianisation has been extremely slow and in the wrong areas.

Beating Retreat is a very solemn ceremony. Introducing Indian instruments and theatrics ill- fit this grand and somber ritual. Dropping the hymn Abide With Me with lyrics composed in the aftermath of India's humiliating defeat in 1962 is not an enthusing end to the ceremony.

In erasing the past, the Government is committing the mistake of compartmentalising military history; then and now, theirs and ours. The merging of flames and transferring it to NWM is 'othering' the sacrifices of the pre-Independence era soldiers. Their valour must not only be acknowledged but a suitable memorial be added to the NWM by the next Republic Day to honour them. (The writer, a retired

BUDGET FOR EQUITABLE ECONOMY

Sir - Never before has a Budget demanded greater insight, acumen and earnest pragmatism. This one must go far beyond juggling the ledger and marquee headings to invite kudos from the Dalal Street. It ought to be all about restoring lost employment in the middle, lower middle classes and daily wagers, besides creating fresh avenues. This economy was already on jobless growth for four years. From a pandemic peak in unemployment of near 14 per cent, we are at 7.9 per cent in December 2021. Compare this with 2017-2018, at 4.7 per cent. Between 2019-20 and December 2021, the manufacturing sector lost 9.8 million jobs, services sector

But most worrisome should be the drop in salaried jobs, which points to an unstable economy starved of investment. Without new investments, India will not be able to generate the kind of employment it needs. Rising interest rates and a depreciating currency make it worse. The Budget needs to focus on these issues. These sectors are in dire straits; earlier due to demonetisation, now pulverised by COVID. One of the key objectives of this year's Budget ought to be on employment returning to the class that needs to reclaim its lost purchasing power.

ADULT MARRIAGE ISN'T THE GOVT'S BUSINESS

How will increasing the marriageable age empower women or make them self-reliant?

he Government is considering to change the eligibility of Indian girls getting married from 18 to 21. The intent of the Bill isto "make them self-reliant and to enable them to take decisions themselves". An amendment seeks to define a child as a male or female who has not completed 21 years of age. How will increasing the marriageable age empower women or make them self-reliant? Gender equality per se is achieved with 21 becoming the marriageable age o men and women. But this stipulation for men itself is totally arbitrary and to make gender equality, men's marriageable age should have been brought down to 18. Parity does not mean taking away the right or privilege from one group. When the government wants to decide the minimum age for marriage, strangely it claims that it is going to empower girls to decide on their own. As per Indian Majority Act, 1875 18 is the age for attaining majority. But, as per the same Act, a child appoint-



ed with a guardian by the court attains majority after completion of 21 years. Through Indian Majority (Amendment) Act 1999, Section 3 has been replaced with the following: "Age of majority of persons domiciled in India. — (1) every person domiciled in India shall attain the age of majority on his completing the age of eighteen years and not before." So, whoever completes the age of 18 years the person is a major and cannot be treated as a child. Hence the proposed amendment with the nomenclature Prohibition of 'child' marriage act is a misnomer. Our law permits 18-year-olds, without representation by a guardian, to enter into any contract, own properties, pursue jobs, drive heavy vehicles in most states, and vote in elections. But the government wants to prescribe an age limit for marriage that too by branding the persons attaining majority as children. While introducing the Constitution (Sixty first Amendment) Act, 1988, the government stated as follows: 'The present-day youth are literate and enlightened and the lowering of the voting age would provide to the unrepresented youth of the country an opportunity to give vent to their feelings and help them become a part of the political process. The present-day youth are very much politically conscious. It is, therefore, proposed to reduce the voting age from 21 years to 18 years.' Is it not ridiculous to suddenly change the gear and say that girls of 18 years cannot decide on their own and hence should not marry? UNICEF, also known as the United Nations Children's Fund, is a

United Nations agency responsible for providing humanitarian and developmental aid to children worldwide. Even UNICEF regards only the marriage of a minor (a person below the adult age) as child marriage and a violation of rights. It is a different matter that most of the girls and boys are not getting married even after they are eligible as per the Prohibition of Child Marriage Act, 2006. As per a survey conducted with a sample of 10,005 respondents by YouGov-Mint-CPR Millennial Survey, one in four young adults in India do not want to marry. As norms and values around marriage and family life change, the Indian youth too are being influenced by recent trends. Compared to a decade ago, youth are now marrying later in life. This has been again brought out by Lokniti-CSDS Youth Studies in 2016 and 2007 which show the proportion of married youth decreased by eight percentage points from 55 per cent in 2007 to 47 per cent in 2016. The government must drop this amendment bill which is retrograde.

The US is in the grip of inflation

The American policy makers are diverting attention from the real cause of inflation — excessive expansion of money supply

lthough inflation is a common phenomenon in most countries of the world including India, many past generations of Americans have never suffered the brunt of inflation. But in the last one year, the rate of inflation in America has reached around seven percent, and that has started affecting the lives of ordinary Americans. Ruling Democrats are fearing the consequences of the same in the 2022 mid-term elections. On the one hand, Covid-19, which has destroyed the jobs of 22 million Americans, has also caused a 30 percent drop in annual production, while on the other, Americans are facing further hardships due to rising inflation.

The question is, how America was saved from inflation in the past, and how it will come out of the grip of current. Inflation has been registered in almost every item of daily needs — eight percent increase in the price of eggs, 58 percent in the price of petrol, 14 percent increase in the prices of other groceries.

Some American economists believe that due to US Government's bailout packages to revive the economy from the effects of COVID-19, there was an unprecedented increase in demand in the country. However, due to supply disruptions, the prices of goods are increasing fast. Economists believe that due to rising inflation, wage rates are also increasing, which may lead to a spiral effect on inflation. Experts believe that the pent-up demand of the Covid-19 period is also retuning back now.

During the pandemic period many people with permanent income also could not spend their incomes fully. Now, with return of normalcy, they are spending more on tourism, fuel, food items, restaurants, entertainment, etc. It is believed that as supply conditions improve, it will be possible to control inflation. But there is almost a consensus that there is no immediate relief

US policy makers are trying to blame this record inflation on supply chain problems and shortage of raw materials, but most economists are citing the rising money supply as the main reason. It is true that the sudden spurt in consumer demand after the temporary relief from COVID-19 has led to a shortage of goods, but this is not the main reason for inflation in America.

Many policy makers in the US are saying that due to the shortage of goods, sellers have started raising prices. Therefore, inflation can also be curbed by price controls. But we must understand that one of the disadvantages of price control is that it reduces the incentive of producers to produce more. There is an apprehension that due to this (price control), the consumers may face shortage of goods.

75% ICU Covid survivors grapple with health problems

At least 75 per cent of the Covid-19 survivors, who were treated in the Intensive Care Unit (ICU), experience physical, mental and/or cognitive problems one-year post ICU, according to a large-scale MONITOR-IC study published in the journal JAMA.

The study was led by Radboud university medical center, in which the health status of ICU survivors is monitored with questionnaires up to five years after ICU admis-

The study regarding longterm health problems was conducted among 246 Covid-19 patients (176 men/70 women) who were treated in the intensive care unit (ICU) in the Netherlands. Their mean age was 61 years. Using questionnaires, they were asked how they were doing one-year post ICU. Worldwide, this is the first scientific research regarding long-term problems among Covid-19 ICU survivors. Patients in this study were admitted to the ICU during the first Covid-19 surge between March and July 2020.

Majority of patients experience health problems oneyear post ICU. This study shows that three quarters of the Covid-19 ICU survivors experience problems one-year post ICU. These are primarily physical problems, whereby half of the patients experience feelings of fatigue. Other physical problems are e.g. a reduced condition, pain, muscle weakness and shortness of breath.

Also, mental symptoms are common; one in five Covid-19 ings of anxiety or post-traumatic stress. Furthermore, one in six have cognitive problems such as memory or attention problems. These various problems negatively affect former

ICU patients' daily lives. Over half of them indicate that they have work-related problems because of the health problems: they reduced their working hours; they are still on sick leave or have even given up their job.

Yet another study has said that about 50 per cent of people infected with Covid-19 during the first wave of infections in 2020 may have longterm and even permanent changes to their sense of smell. Scientists at the Karolinska

Institute in Stockholm found this after they ran comprehensive tests on 100 individuals who caught Covid in the first wave of infections in 2020.

 $T_{ ext{Supreme}}^{ ext{he Centre}}$ on Tuesday told the Supreme Court that Foreign Contribution Regulation Act (FCRA) registrations of 11,594 NGOs, which applied within the cut-off date, have already been extended. Taking note of Solicitor General Tushar Mehta's submission, a bench headed by Justice A M Khanwilkar refused to pass an interim direction that FCRA registrations of all organisations that were valid as continued until further orders.

The bench, also comprising Justices Dinesh Maheshwari and CT Ravikumar, said the petitioners are free to make representation to the concerned authorities which may be considered on its merits in accordance with law. The FCRA registration is mandatory for any association and NGO to receive foreign funding. Mehta told the top court that 11,594 NGOs had applied within the cut-off date and their registrations have been extended for the time being.

The apex court, which is seized of a plea filed by a US-based NGO seeking quashing of the Centre's alleged decision by which 5,789 entities lost their FCRA registration, was dealing with arguments regarding interim relief in the matter.

While referring to Mehta's submission, the top court said that in light of the stand taken by the authorities. it doesn't intend to pass such interim direction as prayed. The bench said the petition would be listed after the

judgement is pronounced on a batch of pleas, including those which have raised issues concerning the Foreign Contribution Regulation (Amendment) Act, 2020.

Senior advocate Sanjay Hegde, appearing for the US based NGO said they have the information which is available in public domain as per which there are around 6,000 NGOs whose registrations have not been extended for whatever reasons.

The bench told Hegde that the citor General has si those who have applied, there registration has been extended. "If those 6,000 NGOs have chosen not to apply for registration, that means they do not want to continue in the present regime," the bench observed.

There were 22,762 FCRA-registered organisations till December 31, 2021. On January 1, the number came down to 16,829. These are considered "live" organisations. The officials had said the FCRA licences of 18,778 organisations were expiring between September 29, 2020 and December 31, 2021. Out of them, as many as 12,989 organisations have applied for renewal of the FCRA licence between September 30, 2020 and December 31, 2021. Since 5,789 organisations did not apply for the renewal of the FCRA licence, they were deemed to have ceased to be registered organisations, an official had said. In addition to them, renewal application of 179 organisations were also rejected by the Home Ministry due to different rea-

As home isolation cases up, Mandaviya tells States, UTs to bolster teleconsultations

On Tuesday, Union Health Minister Mansukh Mandaviya asked states to adopt the hub and spoke model and open additional teleconsultation centres.

"This will enable beneficiaries to access advice from experts stationed at district hubs, " it said. He said the government's e-Sanieevani telemedicine system has provided services to more than 2.6 crore beneficiaries where people can seek medical advice an interaction with health ministers, senior bureaucrats and administrators of nine states and union

These were Jammu and Kashmir, Himachal Pradesh, Punjab, Chandigarh, Uttarakhand, Haryana, Delhi, Ladakh and Uttar Pradesh, according to a statement from the health ministry. Mandivya also urged the health ministers and state authorities to plug the existing gaps by efficiently utilizing the amount sanctioned for various infra

On the importance of teleconsultation services, Mandaviya urged them "This will prove to be a game-changer and will be of immense value and importance for the hard-to-reach and far-flung areas, and especially in the northern regions in the current winter season," he highlighted.

He advised the states and union territories to ensure that those in home isolation are efficiently monitored in line with the national guidelines. This will ensure that the vulnerable categories of active cases in home isolation get the required medical help in a timely manner, the statement said. The virtual meeting was held to review public health preparedness for containment and management of Covid and the progress of the national Covid 9 vaccination campaign.

Soon after Singh announced his resignation from the party, Jharkhand Barkagaon MLA Amba Prasad alleged that Singh had since several months been attempting to dislodge the Congress-JMM coalition government and that there were reports about him being in touch with BJP leaders.

"The party leadership had been cautioned on several occasions about his anti-party activities. Every true member of Congress is happy with him (RPN) going to BJP," Amba Prasad tweeted.

RPN posted his resignation

letter addressed to Congress president Sonia Gandhi, Today, at a time, we are celebrating the formation of our great Republic, I begin a new chapter in my political journey. Jai Hind."

Kunwar Ratanjit Pratap Narain Singh, popularly known as Raja Saheb of Padrauna, was former Minister of State in the Ministry of Home Affairs in Congress-led UPA govern-

Jyotiraditya Scindia's exit was among the triggers for a big churn in the party that led to 23 leaders writing to Sonia Gandhi asking for "visible and full-time" leadership and collective decision-making.

Scindia, Prasada, and Singh, all Doon school pals, were Rahul Gandhi aides and were in the Council of Ministers of the Manmohan Singh Congress led UPA governments.

As the media was abuzz with RPN switching over to BJP, Congress spokesperson Supriya Shrinath at a Press conference quoted Priyanka Gandhi as saying that the "battle which Congress party is fighting can be fought only with bravery" and "cowards can't fight it".

Law Minister slams 'elements' trying to 'discredit' EC

Vice President M Venkaiah Naidu on Tuesday called for increasing the voter turnout to at least 75 per cent in the next Lok Sabha elections while Union Minister for Law and Justice, Kiren Rijiju said "elements" trying to discredit the Election Commission (EC) were actually trying to discredit the democratic process of the country. The minister also said the courts have a right to make observations on the Commission but the judges will also have to think about the language being used.

In his message at an event on the occasion of the 12th National Voters Day, Naidu said as a nation we must think and arrive at a consensus to have simultaneous elections to all the three tiers of federal set up and move towards better governance by focusing on allround development of our peo-

ple. Naidu was the chief guest at the event but could not attend the function as he is in home isolation in Hyderabad after testing positive for COVID-19.

The event was also attended by Chief Election Commissioner Sushil Chandra and Election Commissioners Rajiv Kumar and Anup Chandra Pandey and representatives of recognised political parties, including Trinamool Congress, BSP, BJP, CPI, Congress and National People's Party.

Naidu's message was read out in Hindi and English. The vice president said the country has come a long way from the first general elections of 1952 when only 44.87 per cent of the eligible voters turned up to vote. In the last general elections in 2019, 67.40 per cent or more than two-third of the eligible voters exercised their franchise, he noted.

Rijiju said, people who want to challenge democracy have found a way of doing so by challenging the poll panel. The minister said the way EC has handled challenges from time to time, there is little scope to criticise it. He, however, did not name the "elements" he was referring to. In a democracy, people are free to criticise the EC, but the criticism should be based on logic, he said, adding that the language used should

be within civic norms. "If the courts says on EC, it can. Courts have a right. But the judges will have to think about what language they are using. Under what circumstances EC is working has to be

understood," he said. Referring to the recent passage of a bill on electoral reforms, the minister said due to "ruckus" in the House he felt "handicapped" as he could not explain in detail the reforms being ushered in.

Govt imposes curbs on export of human hair

Amid a sharp rise in instances of hair smuggling to China that has squeezed raw material supplies for Indian exporters of hair products, the government on Tuesday put restrictions on the export of human hair.

Earlier, hair exports were allowed without any restriction. As per the new norms, now an exporter would have to seek permission or licence from the Directorate General of Foreign Trade, Ministry of Commerce to ship hair outside India.

Last year, the Directorate of Revenue Intelligence busted a scam involving Chinese nationals in exporting human hairs from Bengaluru to China via Myanmar. Bangladesh has now emerged as the new transit hub for human hair smugglers. While high quality locks go for

Rs. 15,000 per kg, the lower quality human hair 'waste' starts at a comparatively measly Rs. 4 per kg. În a notification, the Director General of Foreign Trade (DGFT) Santosh Kumar Sarangi on Tuesday said, the export policy of human hair, unworked, whether or not washed or scoured; waste of human hair or any other form of raw human hair...Has been put under restricted category, with immediate effect.

The hair export market in India is worth Rs 6,000-8000 crore — 5 percent of the hair comes from donations at temples and rest through collection of comb waste across villages. China, Hong Kong, Brazil and Italy are among the top five markets for India, when it comes to human hair exports.

It is used for making wigs, false beards, eyebrows, extensions and also in extraction of a protein used in the baking

industry. It's used to make calligraphy brushes, wig making, cloth making, soy sauce, suit linings, and furniture. It's enlisted to clean up oil spills. It's even a part of the bagel-making process at Dunkin' Donuts. A large chunk of the hair

exported comes from the ritual of hair tonsuring at the famous Venkateswara Temple in Andhra Pradesh where thousands of devotees offer their hair to Lord Venkateshwara every day. It is estimated that over a ton of hair is collected at the temple on a daily basis.

Welcoming the move member of Human Hair and Hair Products Manufacturers and Exporters Association of India Sunil Eamani said that it was their long-pending demand. "Now with this restriction, only genuine exporters will be able to export the product," he said.



ith global vaccination efforts and tackling new variant waves, the world is learning to live with the COVID-19 pandemic. This has arguably been the greatest challenge humanity has faced since World War-II, and just like WWII, this pandemic will fundamentally alter aspects of our lives. From the possibility of permanent remote work to a radical shift to the service-based, online nature of businesses, we are facing unfathomable and unpredictable changes to how we live, work, eat and travel. Businesses will, and already have, shut down, new industries will arrive and thrive, old and established jobs will disappear, jobs that were once thought to be niche will suddenly show an exponential rise. It is very hard for anyone to predict what changes will be witnessed over the next few years.

Therefore, this is, perhaps, a very good time to invest in skills for the future. What makes the current climate special are two factors. First is that COVÎD-19 led to restructuring of the economy and demand for previously popular industries may be suppressed for a long time. Second, while the economic recovery has begun, it may take a while before it is nearly complete. Therefore, now is a good time to invest in skills that are likely to be in demand when the market is hot.

This is particularly relevant for students deciding what to study at university. such as Google, Amazon, Facebook and Microsoft recruit economists every year with large salaries. It is harder to think of a career path that can offer as diverse opportunities as economics. There are many universities that have

one, economics as a discipline borrows heavily from diverse fields ranging from philosophy and mathematics to psychology and history. Therefore, a student will be exposed to a wide range of topics, which will be good for both their professional and personal development.

Second, a good command of the basics of economics is a tremendously valuable skill in analysing complex, real-world problems, and is therefore extremely valuable in the labour market. This is why studying economics can lead to some of the highest-paid jobs - starting salaries in the UK for someone with a masters in economics are often upwards of £60,000 - £75,000.

Also, most students are concerned about the safety aspect, and economics is perhaps safer than any other discipline. In the 1970s, there was buzz around engineering, in the 1990s it was programming, in the 2000s it was finance, and now it's big data and machine learning. 

Ukraine urges calm, saying Russian invasion not imminent

Ukraine's leaders sought to reassure nation that a feared invasion from neighbouring Russia was not imminent, even as they acknowledged threat is real and prepared to accept a shipment of American military equipment Tuesday to shore up their defences.

Russia has denied it is planning an assault, but it has massed an estimated 100,000 troops near Ukraine in recent weeks, leading United States and its NATO allies to rush to prepare for a possible war.

Several rounds of high stakes diplomacy have failed to yield any breakthroughs, and this week tensions escalated further. NATO said it was bolstering its deterrence in Baltic Sea region, and US ordered 8,500 troops on higher alert to potentially deploy to Europe as part of an alliance "response force" if necessary.

The State Department has ordered families of all American personnel at US Embassy in that movement of Russian troops near Ukraine's border "is not news."

Kyiv to leave country, and it said that nonessential embassy staff could leave.

Britain said it, too, was

withdrawing some diplomats and dependents from its embassy. In Ukraine, however, authorities have sought to project calm. Ukrainian President Volodymyr Zelenskyy said late Monday that situation was "under control" and that there is "no reason to panic". Defence Minister Oleksii Reznikov said that, as of Monday, that Russia's armed forces had not formed what he called battle groups, which would have indicated that tomorrow they would launch an offensive.""There are risky scenarios. They're possible and probable in future," Reznikov told Ukraine's ICTV channel on Monday. "But as of today...Such a threat doesn't

On Nuclear talks, Iran says 'ready' as US asserts 'direct meeting'

Iran for the first time Monday said it was open to direct nuclear negotiations with the United States, which declared itself ready to hold talks "urgently" -- in a possible turning point in efforts to salvage the 2015 nuclear accord.

Tehran has been engaged since last year in talks with the five other world powers still part of the agreement, which offered sanctions relief in exchange for curbs on its nuclear program.

After unilaterally with-drawing in 2018 under then-president Donald Trump, Washington has been taking part indirectly in the Vienna negotiations, which seek to bring the United States back into the nuclear accord and ensure Iran returns to its commitments.

But Washington has said on multiple occasions it would prefer to hold direct talks, and on Monday Iran's foreign minister said his country would consider doing so if it

proved the key to a "good agreement" to salvage the floundering deal.

"If during the negotiation process we get to a point that reaching a good agreement with solid guarantees requires a level of talks with the US, we will not ignore that in our work schedule," said Foreign Minister Hossein Amir-Abdollahian.

A US State Department spokesperson reiterated after the Iranian comments that the United States is "prepared to meet directly."

"We have long held the position that it would be more productive to engage with Iran directly, on both JCPOA negotiations and other issues," the spokesperson said, referring to the nuclear deal, known formally as the Joint Comprehensive Plan of Action.

"Given the pace of Iran's nuclear advances, we are almost out of time to reach an understanding on mutual return to full implementation of the JCPOA," the official added.

US child abuse report: Deaths of Black children up in pandemic

The latest national child welfare report shows an increase in the number of Black children who died, even though fewer abuse-related fatalities were investigated in the yearlong period that included the first several months of the pandemic

The findings were released in the 2020 Child Maltreatment Report, issued Friday by the U.S. Department of Health and Human Services.

The report covers data from October 2019 to September 2020 and only partially reflects how COVID-19 disrupted the work of child welfare. "Disparities that were present before the pandemic were intensified, and COVID-19 exposed gaps in our human services delivery system," Aysha E. Schomburg, of the department's Children's Bureau, said in a statement.

The report noted an overall 10per cent drop in the number of child protective services cases handled by states in the early days of the pandemic. That's a troubling trend that the Associated Press first reported

last year with an analysis of state child welfare data.

The federal data confirm a drop by hundreds of thousands in documented cases of child abuse reports, investigations, substantiated allegations and support for at-risk families. But experts say that's not necessarily good news - children were out of the public eye during the pandemic, and some cases likely weren't reported until they became more severe, if at all.

The numbers on fatalities in particular are concerning, because such cases are notoriously underreported, said Amy Harfeld, of the Children's Advocacy Institute. Social workers often investigate a child's death only if the family had already been involved with a child welfare agency.

"The numbers that we know of are not reflective of the numbers that are experienced," Harfeld said.

Federal officials highlighted a 4per cent decrease in child abuse and neglect-related deaths, though the data also show a roughly 17per cent increase in the number of Black children who died when compared with the previous year's report.

Pakistan slips further on Corruption Perceptions Index, ranks 140 out of 180 countries: Transparency report

Pakistan has dropped 16 spots on the global Corruption Perceptions Index for 2021 and is ranked 140th out of 180 countries, Transparency International said in a report

on Tuesday, in a major blow to Prime Minister Imran Khan's government which came to power on the promise of introducing a clean governance system.

The report released by the Berlin-based non-profit organisation formed to combat global corruption said that corruption levels remain at a standstill worldwide, with 86 per cent of countries making little to no progress in the last 10 years.

In its 2021 edition, the Corruption Perceptions Index (CPI) ranks 180 countries and territories by their perceived levels of public sector corruption on a scale of zero (highly corrupt) to 100 (very clean), drawing on 13 expert assessments and surveys of business executives.

In 2020, Pakistan's CPI was 31 and it was ranked 124 out of 180 countries. According to Transparency International, the country's corruption score has now deteriorated to 28 while it is ranked 140 out of the total 180 countries on the index. Comparatively, India's score stands at 40 and is ranked 85, while Bangladesh's CPI is 26 and stands at 147th position. Explaining the causes of low score of Pakistan, the report said the absence of the "rule of law" and "state capture" were the main reasons. The report comes at a time when Prime Minister Khan is under pressure to improve the performance of his government which came to power in 2018 on the promise of introducing a clean governance system.

His advisor on accountability, Shehzad Akbar, stepped down on Monday amidst reports of his poor performance to bring the corrupt elements under the law.

To add to Khan's woes, Justice (retd) Nasira Iqbal, Vice-Chair of Transparency International Pakistan, said that the ranking of Pakistan under the PTI government has gradually come down.

UK PM Johnson hit with new row as Scotland Yard opens 'partygate' probe

Britain's embattled Prime Minister Boris Johnson is on Tuesday facing fresh allegations in ongoing "partygate" scandal as details emerged of a surprise 56th birthday cake "party", organised for him at peak of first COVID lockdown in June 2020.

The scandal continues to spiral out ahead of an internal Cabinet Office inquiry report, expected this week, as Scotland Yard confirmed that Metropolitan Police will investigate potential lockdown breaches

related to alleged parties at Boris Johnson's office-residence at 10 Downing Street, as well as other government offices in London.

"As a result firstly of information provided by Cabinet Office inquiry team and secondly by officers own assessment, I can confirm that Met is now investigating a number of events that took place at Downing Street and Whitehall in last two years,"Met Police Commissioner Dame Cressida Dick told London Assembly Police and Crime Committee at Mayor of London's office.

"I should stress that we are now investigating does not mean fixed penalty notices will necessarily be issued in every instance and to every person involved.

We will not be giving a running commentary on our current investigations but I can assure you we will give updates at significant points," she said.

Earlier, Downing Street said Johnson, who turned 56 on June 19, 2020, was present at an event "for less than 10 minutes" as his staff "gathered briefly" to wish him a happy birthday.

Soldiers declare military junta in control in Burkina Faso


More than a dozen mutinous soldiers declared Monday on state television that a military junta had seized control of Burkina Faso after detaining the democratically elected president following a day of gunbattles in the capital of the West African country.

The military coup in a nation that was once a bastion of stability was the third of its kind in the region in the last 18 months, creating upheaval in some of the countries hardest hit by Islamic extremist attacks.

Capt. Sidsore Kaber Ouedraogo said the Patriotic Movement for Safeguarding and Restoration "has decided to assume its responsibilities before history." The soldiers put an end to President Roch Marc Christian Kabore's presidency because of the deteriorating security situation and the president's inability to manage the crisis, he said.

It was not immediately known where Kabore was, and the junta spokesman said only that the coup had taken place "without any physical violence against those arrested, who are being held in a safe place, with respect for their dignity."

epublic Day honours the date on which the Constitution of India came into effect on January 26, 1950. The date was chosen because it was on this day in 1930 when the Declaration of Indian Independence (Purna Swaraj) was proclaimed by the Indian National Congress as opposed to the Dominion status offered by the British Regime.

While India gained independence from the British Raj in 1947, it wasn't until January 26, 1950, that the Indian Constitution came into effect, and India became a sovereign state, declaring it a republic. A committee was created a few days later, on August 29, 1947, to draft a permanent constitution for independent India. Dr BR Ambedkar was made chairman of the committee.

On November 4, 1947, the committee drafted the constitution and

When the President arrives, the PBG commander asks the unit to give the National Salute, which is followed by the playing of the Indian National Anthem, Jana Gana Mana, by the

- Between 1950 and 1954, the Republic Day parade was held at Irwin Stadium (now National Stadium), Kingsway, Red Fort, and Ramlila grounds.
- Republic Day celebrations have been held at Rajpath since 1955. Rajpath was once known as the Kingsway, in honour of India's then emperor, George V. The road was renamed Rajpath after independence, which also means King's Way in Hindi.
- Every year, the leader of a particular nation is invited to be the chief guest for the Republic Day parade. President Sukarno of Indonesia was the first to attend India's Republic Day celebrations
- as chief guest in 1950.
 The parade starts after the arrival of the President of India. The President's cavalier bodyguards salute the National Flag first. The National Anthem is played, followed by a 21-gun salute. The firing is, however, not done using 21 canons. It is done with seven canons of the Indian army known as '25-Ponders' that fire three rounds each.
- Each member of the army who takes part in the march must go through four layers of investigation. Aside from that, their arms are extensively inspected to ensure they are not carrying live bullets.
