

Franco Mulakkal, 57, was the first Catholic bishop in India to go on trial for rape on the complaint of a nun. After a trial of more than 100 days, the additional sessions court pronounced a single line verdict saying it had found him not guilty of the charges. He was seen exiting the court in Kottayam with a smile after the verdict. In 2018, the nun from the Missionaries of Jesus congregation had accused Bishop Franco of repeatedly raping her between 2014 and 2016.

AP's revenue up by 9 pc, deficit rises to 803.72 pc

PNS VIJAYAWADA

Andhra Pradesh's own tax revenue was Rs 16,372.97 crore higher in the first eight months of the 2021-22 financial year, as compared to the corresponding period in 2020-21, but the State's revenue deficit zoomed to a worrisome 803.72 per cent by the end of November, the Comptroller and Auditor General (CAĜ) has stated.

Overall, there has been an 8.82 per cent increase in the state's revenue receipts between April and November 2021, touching a sum of Rs 88,618.58 crore, but still, the government borrowed Rs 49,570.31 crore, a jump of 133.87 per cent than the budgeted estimate of Rs 37.029.79 crore. 37,029.79 crore.

The latest figures of the state's accounts released by CAG showed a revenue expenditure of Rs



1,28,805 crore, including Rs 13,779 crore as interest payment on loans.

In the form of welfare schemes, the state spent Rs 61,746.91 crore in the first eight months of this

financial year, leaving little for budgeted development schemes.

AP's total borrowings and liabilities have now touched a staggering Rs 6,35,265.63 crore, as per the

At the end of the first half of the current financial year, the state's revenue deficit was 662.80 per cent and the fiscal deficit was 107.79 per cent. They have now shot up to 803.62 and 133.87 per cent respectively, according to the CAG's latest numbers.

Though the State targeted to spend Rs 30,571.53 crore during the year on capital works, only Rs 8,804.71 crore (28.80 per cent) has actually been spent in the first eight months, indicating low infrastructure development

The State has received significant grants from the Centre amounting to Rs 23,273.33 crore between April and November, a jump of more than Rs 5,000 crore compared

Least temperature rise projected for AP by 2030 **SNV SUDHIR** VIJAYAWADA

Andhra Pradesh is one of the five states in the country that is projected to witness the least temperature rise by the year 2030 compared to the 1860-1900 period.

According to a climate study done by the Forest Survey of India (FSI), Andhra Pradesh may witness 1.06 degrees Celsius of temperature rise by 2030 whereas all India mean temperature is projected to increase by 1.52°C to 1.64°C compared to 1860-1900 period under moderate Green House Gases (GHG) scenario. The above projections are based on Representative Concentration Pathways (RCPs) 4.5



Greenhouse gases (GHGs) are the key drivers of climate change. How emissions may grow in the future is represented by Representative Concentration Pathways (RCPs). There are four RCP scenarios: RCP 2.6, RCP 4.5, RCP 6.0, and RCP 8.5. Among these, RCP 8.5 is the high emission scenario, while RCP 6.0 and RCP

The revenue earnings front is certainly looking good, with enhanced tax revenue showing up. At the same time, it is perplexing that the revenue deficit is mounting to unimaginable and unmanageable levels, a senior official of a revenueearning department observed.

The official pointed out that the revenue deficit normally comes down after the first few months in a financial year but in AP's case it has only been scaling up in an abnormal fashion. A lot of course correction is inevitable to keep this trend in check. Else, it will be nothing but doom ahead, he

Attributing the current financial situation in the state to "gross fiscal indiscipline", former finance minister

Yanamala Ramakrishnudu said the government led by Chief Minister Jagan Mohan Reddy violated all constitutional and Fiscal Responsibility and Budget Management (FRBM)

The Centre stipulated that

64 per cent of the borrowings should be spent on capital works but the Jagan government has only been indulging in unbridled revenue expenditure. Fiscal deficit has crossed 13 per cent of the Gross State Domestic Product (GSDP). The unmindful acts of the government have pushed AP into a serious economic crisis. Ramakrishnudu, who is now the Leader of Opposition in the Legislative Council, said.

He pointed out that government expenditure was not in line with the approved budgetary allocations. This government has been showing utter disdain for legislative propriety. All budgetary rules are being flouted with impunity. It is high time that the Centre intervenes and conducts a high-level review of AP's financial management,

the senior TDP leader said. Finance Minister Buggana Rajendranath, however, blamed the peaking revenue deficit on the "legacy" left behind by the state's bifurcation in 2014. From a revenue surplus state, we have been pushed into a revenue deficit because of legacy issues. The economic upheaval caused by COVID-19 has only compounded the crisis, Rajendranath claimed.

We are now trying to ensure a sustainable economic revival, despite the hardships, the Finance Minister added.

According to the statement, since June-July last year, Rode has figured prominently in operationalising a series of terror modules through his network in Punjab and abroad.

A large number of militant hardware, including RDX, tiffin IEDs, associated explosive material for assembling IEDs, hand grenades and firearms, as also narcotics have been pushed in by him from across the international border, mainly via drones and using his network of cross-border smugglers, the police said.

On Monday, police had said they had solved a case involving a recent grenade blast outside the gate of the Army cantonment in Pathankot by busting a major terror module backed by the ISYF with the arrest of six of its operatives.

The ISYF is believed to have the backing of Pakistan's intel-



By the year 2085 the temperature rise is projected to increase by 2.501 degrees

Since FSI does not have based climate change projections, the task was outsourced to an expert team led by Dr. Rajiv Chaturvedi of the BITS Pilani Goa campus. The observed change in the temperature and rainfall during the period 1951-2019 has been downscaled to the 10km x 10km resolution.

According to the FSI's study, the mean annual temperature in India has increased by 0.72°C (as per Meteorological Department) over the period 1901 to 2019. However, the temperature rise has been especially rapid in the last



Mango farmers' hopes turn sour

The mango crop is in a big crisis in the upcoming season in the State as thrip (Nalla Thamara in Telugu) is attacking mango blooms. Normally, the mango blooms appear during Sankranthi and the tender mangoes are witnessed in early February. However, this year in the majority of the areas, there are no mango blooms due to thrift attacks.

The north Andhra districts including Srikakulam, Vizinagaram Visakhapatnam are famous in both the Telugu States for the Palakamanu variety which gets ready for harvest early. The size and taste of the fruit is also very

good. This variety is also

famous for preparing pickles as

they last an entire year. However, this year, no blooms are there in the lion's share of the trees in the three districts. Due to the severe cold conditions and dense fog, the mango crop was badly affected. As there are no flowers, the



farmers are in deep worry. Not only Palakamanu, the other varieties including Suvarnarekha are also badly affected by Nalla Thamara.

The north Andhra region is sharing a huge quantum of mango exports across the world and also rules the domestic markets. However, with the adverse climate conditions, the farmers are losing their hopes as the contractors are not coming forward to buy the trees. Because of CÓVID-19 restrictions, mango exports came down in 2020 and 2021. Usually, mango traders inspect the fields during December/January and assess the expected crop from

the trees and offer good amounts to the farmers. As there is no flowering even now, the traders think that this vear there would not be much

return from the crop.
"The mango crop completely depends on the rainy and winter season conditions. The untimely rains, cold and fog conditions will decide the fate of the mango crops. After the third week of January, there will be big changes in the climate conditions which may help the mango crop. According to our calculations, the green mangoes will be ready for harvest in the first week of April. The king of fruits will lead the market dur-

ing May and June," said Joint Director, AP Horticulture, P. Hanumantha Rao.

Meanwhile, the US has relaxed its restriction to import Indian mangoes this year. Due to COVID-19, the US government had stopped the import of Indian mangoes. However, this year an expert team is coming to India to check the qual-

ity and quantum of the fruit.
"The horticulture officers will give several suggestions including watering, cleaning and continuous spraying to prevent the various viruses. However, the practices have become very costly and the returns are not matching the expenditure. Not only Suvarnarekha

AP records 4,528 fresh Covid cases

Preparing festival delicacies at home passe Families even in rural areas depend on food shops during festivals

Preparing special meals at home is part of any festival. However, the tradition of preparing food at home for the Sankranti festival has totally vanished even in rural areas these days. Most of the people buy food from sweet shops. Surprisingly, even the traditional tamarind rice is also brought from sweet shops nowadays during festivals.

The three-day harvest festival Sankranti, which is the first festival of the year, is celebrated in one's native villages. The three days -- Bhogi, Sankranti and Kanuma -- are celebrated in a traditional way by the entire family members together. Homemade food plays a key role during the festival as the women in the family are engaged in preparing a variety of food items and sweets right from Bhogi to Kanuma. However, the sheen has been lost during the festival celebrations for the past few years. The special food items

include Bobbatlu, Bellam Gavvalu, Ariselu, Kajjikayalu, Sunnundalu, Pulihora, Sweet Pongal, Perugu Garelu, Vada, Nuvvu Undalu, Badam Halwa, Rava Kesari, Pongal, Laddu, Paravannam, Payasam,

Boorelu to name a few. The

majority of these meals include

rice flour and jaggery, both of which are fresh and easily accessible during the harvest season. The younger generations hardly know the names of these dishes.

During the olden days, the preparations for the festival began as early as January 1with

the purchase of various items used in the preparation of food, running to the flour mill to provision shops etc. But the whole exercise was made easy by a few home food sweet shops that were established a

decade back. G Amrutha, a retired teacher

from Machilipatnam, says that her two children are working in Hyderabad and Bengaluru in software companies. "Preparing traditional food is a tedious job and for the past few years, I have been ordering food from home food shops and they supply fresh home-made food a day before the festival. Without exertion at this age, all the food items are at the doorstep. Home food shops have made the festival preparations very easy for the past few years," she said and added that she was not sure if the service would be available this time around owing to COVID restrictions.

An engineer working in an MNC in Chennai, B Premesh Kumar, said that he did his schooling in a residential school and later joined a residential college. "Most of the time I was away from home and hardly knew these homemade foods or cooking stuff. During the festivals, we buy everything from the shops. There is no need to trouble the parents at old age," he said.



Media reports claiming under-reporting of Covid deaths ill-informed, baseless & misleading: Govt

The Health Ministry has refuted media reports alleging a "significant undercount" of COVID-19 deaths in the first two waves in India, saying these are fallacious, illinformed and mischievous in

The Government of India has a very comprehensive definition to classify Covid deaths, based on globally acceptable categorisation, it said.

In a statement, the ministry refuted some media reports alleging a "significant under-count" of the actual number of people who have died in India due to COVID-19 in the first two waves and that the final toll may be "substantially greater" crossing the figures of about three million.

"It is clarified that such media reports are fallacious and ill-informed. They are not based on facts and are mischievous in nature. India has a very robust system of birth and death reporting which is based on a statute and is carried out regularly from the gram panchayat level to the district level and state level," the statement said.

The ministry said the whole exercise is carried out under the overall oversight of the Registrar General of India

"Moreover, the Government

of India has a very comprehensive definition to classify Covid deaths, based on globally acceptable categorisation. All deaths are being independently reported by states, and are being compiled centrally. The backlog in COVID-19 mortality data being submitted by the states at different times are being reconciled in the data of Govt of India on a regular basis," it said.

A large number of states have regularly reconciled their death numbers and have reported arrear deaths in a broadly transparent manner. Therefore, to project that deaths have been underreported is without basis and

without justification, it added. The ministry clarified that there is an "extreme difference" in Covid case load and linked mortality between Indian

"Any assumptions putting all states in one envelope would mean mapping skewed data of outliers together with states reporting lowest mortality which is bound to stretch the median towards higher and wrong results," the ministry

The government is procuring many more buses including e-buses, he said.

It takes 2-3 years for new buses to come due to tender process and other formalities, it cannot happen overnight. When our government was formed, there was much shortage of buses as no new buses were purchased for many years.

Blind faith among pilgrims 'masks' Covid safety norms

Blind faith of the thousands of pilgrims thronging the city's Babu-Ghat (Steps leading to the river Ganges named after its builder Baboo Raj Chandra) en-route to Sagar Island for the Gangasagar Mela, saw many of them discarding Covid safety protocol, turning virus containment a tough proposition for the state administration.

Many pilgrims said that taking a dip in the Hooghly river here in the shadow of the Babu-Ghat's Doric-Greek pavilion with massive Cornithian pillars, would kill the coronavirus while several others blindly claimed that no virus would be able to touch them because they are on a holy pilgrimage.

A sadhu, Sanyasi Sukanta Giri from Haridwar's Shambhu Panchayati Atal Akhara, who was seen without a mask said that though he has got both the vaccine shots (a must-to be allowed to proceed to Gangasagar) "chanting the 'Gangasnan' (Ganges bathing) and 'Mahamrtyunjaya' (conquest over death) mantras"

would help keep him safe from the pandemic.

"Î don't want to talk about it. There is no coronavirus at the moment and even if there is any it will not be able to infect me because I am doubly vaccinated and I chant the `Mahamrityunjaya mantra (prayer) everyday," Sukanta Giri told PTI.

"Hum to mast hai. Coronavirus hum ko chu nahi

payega. Hum bindass hai. Hum Gangasnan ke liye aye hai. Corona kuch nahi kar payega humara (I am a fearless person and coronavirus will not be able to do anything to me because I have come here for the holy dip in Gangasagar)," HC Budhiraja, a resident of Ahmedabad, who has come with his old parents, Harshvardhan Budhiraja and Poonam, told this reporter.

Rajendra Pal of Rajasthan's Ajmér added that he firmly believed taking a dip in sea water at Sagar will "kill any form of bacteria or virus and ward off sins"

"Hum to bhagyashali hai ke hum Gangasagar mein dubki lagane ko aa paye hai. Coronavirus bol ke kuch nahi hain, aur Gangasagar mein nahaney se sab bacteria, virus mar jata hai. Gangasagar ke pani

mein sab paap, virus khatam hota hai. (I am lucky to have come here for the holy dip. If you get a chance to take the holy dip, all coronavirus and bacteria along with your sins will be washed away)," Pal said.

Many of sadhus and the pil-

grims were also reluctant to take the RT-PCR tests which have been made mandatory by the Calcutta High Court to go to the Sagar Island for the annual congregation, a senior official of

the health department said. "It's like a test of our patience. They are reluctant and giving us funny excuses not to undertake the RT-PCR tests or vaccines. We have to literally fight with them to collect the swabs. At times we are taking help from policemen to explain that unless they are

tested, they will not be able to

proceed from this point Babughat)," the doctor said.

Senior police officers of Kolkata Police also echoed similar difficulties while managing the pilgrims at Babughat where several tens of thousands of pilgrims are passing through.



Stepping up

The Govt and the SC are on same page on the need to bring about criminal law reforms

or the last few days, the Delhi High Court is hearing petitions seeking to criminalise marital rape. During the hearings, the Centre has informed the court that it proposes a comprehensive revamp of the criminal law. This is an echo of the Union Home Minister on Tuesday seeking views from the Chief Justice of India, Members of Parliament and Chief Ministers on forging a "people-centric legal structure". The Home Minister said the same once before, way back in 2016, when he sought similar views on changes to the Indian Penal Code, Code of Criminal Procedure, Arms Act, and so forth. The same year, the Supreme Court too asked the Centre to reform police laws as well. Better late than never, as they say. Several sections of these laws and many other statutes like the sedition law are of colonial vintage and are antiquated. They are still used, most in their breach, and should go at once. The one that decriminalises marital rape is another one that is so obviously not 'people-centric' and yet exists in the statute books. The Home Ministry is bound to get numerous suggestions on reformation and change. But it is for the Ministry to identify the provisions that require a revision. Some would say the reforms



amendments to date, 37 of them coming after Independence. The CrPC has amended 18 times between 1974 and 2014. Social progress and technology upgradation mean these laws need to be modernised to keep pace with the times. New types of punishments, with restorative and reformative justice in mind, need to be introduced into the Indian

system. Principled sentencing is the need of the hour on the procedural side to ensure that different sentences for crimes of similar nature do not have major variations. The Government has to explain how it wants to give the reforms a 'people-centric' push. For, in democratic parlance, it means having suitable procedures in place to quickly identify the reasons for victimisation and reforming laws to uphold the rights of victims of crime. The extant laws of Macaulay's time are tuned to serve the interests of the Crown. They need to be oriented towards people — once the victims of colonial rule who, after Independence, became the victims of colonial laws. They need to enjoy the benefits of victim protection schemes and victim participation in criminal trials, compensation and restitution schemes for victims. Victim advocacy and human rights are the thrust points. But that will not amount to much without the fundamental tightening of the mental resolve to tackle crime: One, political non-interference in the roles of crime investigation agencies; two, a change in the attitude of the police towards complainants; and, three, no external pressures on the police.

The recent resignations have dented the BJP's efforts at consolidating the Hindu vote, which helped it win in 2014, 2017 and 2019. The formula was built around the BJP's strategy of social engineering, a concept perpetuated by former general secretary and ideologue K Govindacharya, but it appears to be wearing off now. Needless to say, the recent developments are quite comforting to the Opposition camp, and the satraps would likely enter the humdinger of the electoral battlefield with renewed zest and vigour. Meanwhile, the saffron party would need a lot more than its social engineering formula and development slogans to keep its ship stable and on course. Unfortunately, what most people overlook is that while it is relatively simple to start a fire, the conflagration leaves none unscathed. Those fanning the flames of religious bigotry would do well to heed ist ideologies as well, both religious and ethnic. In our Samuel Taylor Coleridge's wise words that "in politics, what begins in fear usually ends in failure".

SEARCHING FOR ANTIDOTE TO COMMUNAL HATE

Hate speeches against any religion serve to imbalance public order and peace



India woke up to the new year with shocking revelations regarding the "Bulli Bai"app targeting minority women in a derogatory and humiliating manner. The app had misused photographs of a number of Muslim women, including students, prominent personalities, journalists, and social workers. Protests were lodged all over the country. With pressure from human rights and women groups, the Bulli Bai app was blocked by Github. A couple of owners of the Bulli Bai App have now been arrested by the CERT-IN (Indian Computer Emergency Response Team) and currently in police custody. The 'Sulli Deals' App, which was launched last year, had listed Muslim women for 'auction' with photographs sourced without permission and doctored. Its mastermind has also been arrested now. Will these arrests stop this kind of humiliating intent against certain religions, sects, communities, castes, or groups? Certainly not, because these are not one-time or stand-alone crimes. These are the



result of organized and sustained hate campaigns poisoning the minds of Indians, especially youth, against minority communities. For last some years, the social media has been extensively used to create platforms and material by these perpetrators of hate. As per Statista Research Department, most hate crimes during 2015-2019 were targeted at Dalits, followed by Muslims. There have been several reports of Muslims not being allowed to pray in certain places in North India and Christians being targeted on suspicion of being involved in religious conversions. Human rights groups which monitor atrocities against Christians in India have documented the violence by Hindutva groups from all states and released a fact-finding report titled 'Christians under attack in India'. The report released by the Association of Protection Civil Rights, United Christian Forum and United Against Hate at a press conference in Delhi in October 2021 says over 300 such instances were reported from across 21 states, particularly in North India, in nine months of 2021.

The farmers who protested for almost a year were repeatedly labelled as 'Khalistanis' and hate messages against them were doing the rounds on all social media platforms. Various forms of provocative incidences against minorities have been on the rise in the last few years. We keep hearing about the incidences of 'love jihad', 'ghar wapsi' and other newly coined terms to target certain communities. The Supreme Court has agreed to take up a PIL seeking probe into alleged hate speeches at two separate events at Haridwar and Delhi in December 2021. There are messages and videos circulating on social media regarding the atrocities committed on Hindus by Mughals (Muslims) during the Middle Ages. The voices for making India a 'Hindu Rashtra' are getting louder by the day. The hate speeches and hateful actions against any religion can only serve to imbalance the public order and peace in society. Educated young people are debating religion and hate rather than constructive issues for nation building. Do we have a solution? The harrowing trend of communal hatred is likely to meet with retaliation by those targeted in due course leading to destruction of the very fabric of multi-cultural Indian society. As Mahatma Gandhi said "an eye for an eye will only make the whole world blind ".The Constitution of India enshrined and ensured equality and respect for all Indians. Hate campaigns against any religion, community or sect need to be condemned in the strongest words and strict legal action should be taken against the perpetrators. Politicians, religious and community leaders, and people from all walks of life should come together to oppose hate campaigns. School curricula should have mandatory content on communal harmony so that future generations learn to value of compassionand brotherhood.

Mahatma Gandhi an ecological economist?



Gandhi's ideas could not be more relevant than today when India is witnessing jobless growth and facing the worst unemployment crisis

ndia was earlier known for its flourishing trade in spices and textiles, along with precious metal and stone.

AfterIndependence, India inherited an economy that was one of the poorest in the world with no industrial base and mostlydevastated land deprived of forest and fertility. The Britishleft a poor base for the already developed handicraftsuniver-sally acclaimed for their quality and craftsmanship.

In Mahatma Gandhi's view,industrial civilisation fostered by British rule was the main cause of India's social, ecological and economic distress. He believed that India's salvation lay in the restoration of its ancient civilisation where economic

progress and moral progress intertwined.
Gandhi knew that "India lives in her seven lakh villages" thereforethe economic and social revival of these villages is a pre-condition for reconstruction of India. He wanted to make the villages self-sufficient and build a rural economy which is not solely based on agriculture and allied activities but also has strong rural industries thereby generating employment for the villagers.

Gandhi once said, "If the village perishes, India will perish too". He imagined his ideal village will consist of cottages made from locally sourced materials with sufficient light, ventilation, proper sanitation and produce its own grains, vegetables, fruits, and Khadi. It will have wells, places of worship, a common meeting place, a common grazing field, a co-operative dairy, primary and secondary schools where vocational training will be imparted and panchayats for settling disputes.

Gandhi was against the concentration of power and the system that makes the individual subservient to the machine and material. He wanted a development process which is harmonious, poverty free, nonviolent, based on cooperation and ethics. Therefore, he proposed an ecological model centered on limitation of wants in contrast to the modern civilization that promotes material welfare and individual profits. He was sure that too much emphasis onmaterialism could lead to violence, unhappiness and a culture of oppression, exploitation, and dominance.

Gandhi's concept of sustainable development is rooted in a holistic approach which emphasizes the development of an individual and society as a whole in connection with nature. By preaching "simple living," Gandhi sought to curb both human greed and mindless exploitation of natural resources. He said, one should know the difference between 'need' and 'want' and taking more than required to fulfil our need, in a way is theft from other species, humans and the future.

Gandhi often said,"The earth provides enough to satisfy every man's needs, but not every man's greed".

He warned against the perils of massive industrialization and unsustainable patterns of consumption in the west. He

It is evident that the current paradigm of developmentis causing serious environmental problems whichis neither ecologically nor socially sustainable. It is leading the planet into a vortex of inequality, widening the rift between rich and poor, and proved inadequate to address the issues of the millions living in poverty.

Gandhi was well aware of the pitfalls of such developmentas well as the consequences of unequal distribution of wealth between different classes. The World Inequality Report 2022 ranked India as the most unequal country in the world. The top 10 per cent and top one per cent hold 57 per cent and 22 per cent of the total national income,respectively,while the bottom half's share has come down to 13 per cent and they barely have anything. Thomas Piketty asserts in his influential book, Capital in the Twenty-First Century, that inequality is rapidly intensifying and global cooperation is desirable to prevent the wealthy from simply shifting assets into other jurisdictions.He proposed, an extremely high income-tax rates on upper-income taxpayers along with a global wealth tax. Economic progress devoid of moral elements will deepen divisions and increase dissensions

among people. With growing population, the increase in food demand has considerably altered land-use practices whichhas led toagricultural intensification at the expense of forests and grazing lands. Increased use of chemicals and fertilizers are causing pollution, soil and ground water contamination, loss of biodiversity and killthebeneficial organisms whichincreases fertilitv.Gandhi believed in sustainable agriculture and advised the use of bio-manures and bio-pesticides to improve soil fertility. Today, the experts in the healthcare are emphasizing the importance of chemical-free crops because excessive amounts of chemicals in plants are causing health related problems in humans as it affects kidneys,

lungs, may also cause cancer and congenital abnormalities like malnourished children, etc.

Gandhi's understanding of the ecological crisis was far ahead of his time and anticipated many of our greatest challenges of today. Knowing that afforestation can be an effective step to combat future water crisis, he urged people to plant trees. He also proposed, water harvesting for irrigational purposes to prevent droughts and

Climate change has once again shed light on Gandhi's philosophy of self-sufficiency and sustainable development and made the world realize the importance of practicing a lifestyle that has minimal environmental impact. These principles remain the driving force behind all the UN's climate agreements, environmental conservation treaties, and sustainable developtreaties, and sustainable development goals. Many of his ideas foreshadow the holistic thinking behind the "Agenda 2030: Transforming Our World" for Sustainable Development. The central idea of Agenda 2030 is captured by the tagline "Leave No One Behind" The plan aims to achieve Behind." The plan aims to achieve prosperity for people and the planet and calls for "transformative" change, which includes changing the way we live, produce, and consume.

Thus, the current climate crisis and the need to find sustainable means has brought a long-suppressed and quintessentially Galbraith's unanswered question to the fore — "How much should a country consume?" — along with Gandhian corollary — "How much should a person consume?". They have become fundamental questionsfor the 21st century and will dominate the intellectual and political debates.

Poisonous tobacco products must be made unaffordable

The sale of 'sin products' needs to be limited and kept out of reach of the maximum number of citizens, especially teenagers

obacco consumption is a menace that is worse than the current Covid019 pandemic and causes innumerable fatalities. Both Finance Ministry and GST Council appear to have overlooked the causes of this malady despite representations by civil society organizations, Members of Parliament, the medical fraternity, state representatives, Ministers and citizens.

There have been no major tobacco tax increases after the GST council placed tobacco products in the 28 per cent bracket in 2017. The option of tax increase on tobacco products gives the government a golden opportunity to raise badly required finances. Remember, lower taxes increase the affordability of

tobacco consumers, especially teenagers and children. The Union Government has the option of hiking the excise duty and NCCD in the annual budget while the GST Council can increase the cess. This will ensure India has optimal tobacco taxation as mandated by WHO.

A submission Parliament mentioned that a small excise duty hike ensured tax collection of Rs 4962 crores. This proves the point that raising excise duty and calamity duty substantially in the coming budget can fetch a handsome revenue.

The costs imposed on our society and our economy, both direct as well as indirect, have been huge. India has over 27 crore tobacco users today and the consumption of tobacco nearly one-fifth of the stu-



kills more than 13 lakh Indians annually. At a global level, eight million deaths are reported people every year. Overseven million deaths are due to direct use of tobacco while the rest are caused by passive smokers exposed to the poisonous smoke. As per the data of GYTS (Global Youth Tobacco Survey) in 2019,

form of the tobacco product (smoking, smokeless, and any other form) in their life. Clearly, consumption of tobacco isnot just about one's health at the individual level, but a societal problem we face nationally.

Tobacco taxes and, therefore, the prices have to be increased regularly, so as to significantly reduce the affordability over a period of time. This was the practice in the pre-GST era with additional options of the states adding VAT. Tobacco taxes and prices have not been increased enough over time to reduce the affordability of these products resulting in more numbers of consumers getting addicted. A long, four-year gap of no tax increase has tobacco companies share prices eases (CVDs) - nearly 4,49,844

dents aged 13-15 have used any soaring on the one hand, and on the other, we see rampant consumption leading to more deaths and spread of dreaded diseases. The tobacco industry may have its reason to look the other way, but the government has no such option.

The annual economic cost from all tobacco products is estimated to be Rs 177.341 crores in 2017-18 amounting to more than one per cent of India's GDP. This will continue to grow in the post-Covid era and the next GATS report will surely point out the alarming rise of casualties. In a country like India, an estimated 1.3 million deaths are accounted for by tobacco abuse. As per WHO data, the most common way tobacco kills isthrough cardiovascular dis-

deaths such deaths occurred in India as of 2018. The high prevalence of non-communicable diseases due to tobacco use is posing a huge challenge to the country's response to Covid-19 management, amplifying India's health burden in

such difficult times. It is time that the Finance Ministry launches a multipronged attack for the social cause of tobacco control by increasing taxes on tobacco products both in the annual budget and also in the GST council to wipe out the gap of the last four years. Doing this social good will not raise any eyebrows and citizens will welcome it for reasons of public

Optimism and confidence are ruling high amongst Indian businesses as a significant percentage of industry leaders are positive about India's economic growth and expansion, despite the surge in COVID cases, says a survey.

According to the pre-budget survey by Deloitte Touche Tohmatsu India LLP (DTTILLP), that collated a total of 163 responses from 10 industries, more than 75 per cent respondents were positive about India's economic growth and expansion.

The survey further noted that about 91 per cent respondents (compared with 58 per cent last year) believe that the 'Atmanirbhar Bharat' initiative, coupled with monetary policy actions by the Reserve Bank of India (RBI) did contribute to bringing the economy back on track

"They (industry leaders) expect the Union Budget FY 2022-23 to build on to this momentum," DTTILLP said in

Finance Minister Nirmala Sitharaman is scheduled to present the Union Budget in Parliament on February 1.

Further, about 55 per cent business leaders "believe that



providing extra tax incentives to long-term investors" for infrastructure investment can help promote growth in the

Adding to this, 45 per cent respondents believe that the budget should focus on announcing incentives for increased R&D spending. This would be beneficial for sectors such as life sciences, automobile, capital goods, technology, and telecommunication.

Enhancing export competitiveness, putting in place competitive import tariffs, and reducing administrative inefficiencies are some other expectations that industry leaders conveyed through the Deloitte



what's brewing?

Madhulika Liddle tells **The Pioneer** that Delhi, in her new novel, The Garden of Heaven, is a beautiful and diverse garden with its share of thorns, snakes in the grass, and the occasional poisonous plant

he first Indian to win the Commonwealth Broadcasting Association's Short Story Competition in 2003, Madhulika Liddle is known for her deeply researched and engaging works. Afterall, the 17th century Mughal detective Muzaffar Jang is, indeed, her brainchild. Being born in Delhi, Liddle has embarked on a new journey to unravel the secrets from the pages of history of the city of love. Her freshly published work by the Speaking Tiger Books, The Garden of Heaven, is the first one in the saga of The Delhi Quartet. Beginning shortly before the invasion of Mohammad Ghuri, and extending till just after Partition; the saga will span 800 years of Delhi's history. And you guessed it, the first 200 years of that stretch are being covered in The Garden of Heaven. In a rather interesting conversation, Liddle talks about her

works, and shares her thoughts on history, the city and the city's history. Read on for excerpts from an exclusive inter-

What inspired you to begin this saga?

The Garden of Heaven is a historical novel, the first in a four-book series called *The Delhi Quartet*. The entire saga will span 800 years of Delhi's history, as seen through the lives of a group of interconnected families. The first novel covers the period from 1188 CE, just before Mohammad Ghuri defeated Prithviraj Chauhan and established the Delhi Sultanate: to 1398 CE, when Taimur sacked Delhi. A somewhat similar, but much more ambitious book. Edward Rutherfurd's Sarum, inspired me to write this series. Sarum is about ordinary people living their lives against the backdrop of several thousand years of history (from the Ice Age to 1984) in and around England's Salisbury, which was earlier known as Sarum.

What is the significance of the title - The **Garden of Heaven?**

The Garden of Heaven is the name the stone carver, Madhav, gives to the exquisite stone frieze he carves in his later years, a frieze depicting a garden. I also meant the 'garden of heaven' to be a metaphor for Delhi itself, a beautiful and diverse garden, but (like any real garden), with its share of thorns, of snakes in the grass, and the occasional poisonous plant...

A lot of people's lives are intertwined, their stories running in parallel lines in the book. Thus, making it deeply lay-

What is the objective behind the same?

I wanted to write a historical novel which focussed not on the important people, the larger-than-life historical figures of that era, but the everyday people: I wanted to explore how they might have felt, even as history was being made during their own lifetimes. I also wanted to show how people come together, how one family divides and separates, or how two disparate families come together: these are themes that interest me, and placing them in a historical setting helped me give it a new dimension: to explore how people cope with hardship, with circumstances outside their control.

Important people like Razia Sultan, Amir Khusro, Ibrahim Lodhi, Mohammad Ghori, Prithviraj Chauhan, and so on, exist and their personal endeavours are conveyed beautifully. How close to reality is the story? Can this qualify for a historical fiction?

Mostly, the episodes and incidents regarding the real personalities in this book are based on fact (or, as in the case of Hazrat Nizamuddin Auliya, on folklore). Razia's tussles to gain and then retain her throne; Ghiyasuddin Tughlaq's attempts to suppress Nizamuddin; Taimur's invasion, and

so on: these are all factual. It is mostly only in their interactions with the fictitious characters (Madhav, Jayshree, Girdhar, et al) that a fictitious episode in the lives of these historical characters is introduced.

So yes, I would call The Garden of Heaven historical fiction.

It is said that Dilli was destroyed and built seven times. Do you wish to encompass this journey in your books?

There is some debate on whether Delhi was destroyed and built seven times, or more — some historians believe there could be up to ten cities of Delhi, perhaps even up to fifteen. Enumerating all of these (or even just seven) in the course of four novels might lead to a too bulky set of books, so I am restricting myself to just telling the story in its broad outlines. At times, the destruction of the city (or rather, the falling away of one area and the coming to power of another) does become highlighted; at other times, the shift in power is rather less dramatic, and one city fades gently away, too gently for anything other than an oblique refer-

This is the first of the four of Delhi Quartet. What is your vision for the forthcoming books?

As in The Garden of Heaven, the other three books will also follow a similar pattern: ordinary people living in Delhi, their lives at times touched by the history being made in Delhi. Some important real-life historical personalities will appear now and then, but otherwise, the focus will be largely on the fictitious characters. Each book will cover, as did The Garden of Heaven, approximately 150-200 years of history.

Have you studied history since your novels are so well-researched. Would you be a historian, if not a writer?

I've always been interested in history, especially since my sister, Swapna Liddle, is a historian — her studying history inspired me too, to regard history with a lot more affection than most Indians seem to have for the subject. If I hadn't been a writer, I would probably have been one of the many professions I've followed in my career: hospitality manager, advertising executive, editor, instructional designer... for me, the interest in history came a little late in life, after I'd decided (as I thought) what career I was going to adopt. By then, it was too late to start studying

history in earnest. So my interest in history remains (and will remain) a love, not a profession.

Historicity and meaning. What, in your opinion, is the antinomy between history and truth?

I think history and truth are not quite synonymous, simply because — like science — history too is a discipline which draws conclusions from available evidence, coming up with logical theories to interpret that evidence. For example, old chronicles, artefacts, archaeological evidence, and so on, can help historians build up a picture of what might have happened in the past. While artefacts and archaeological evidence may be more irrefutable proof, chronicles can be biased, thus, distorting the truth. And, as in the case of science, until further evidences come to light, one history, one accepted truth, may prevail. Newly-discovered evidence may however change that truth. History, therefore, to me is perceived truth; believed truth. Some aspects of it might be factual, some may be reliably so, and others may be so till further evidence proves either

What do you think of the Education Ministry's move of wiping out the Mughal dynasty from the history syllabus of prominent universities? Are we depriving our future generation of historical truth?

I think that's a very short-sighted, bigoted move. Wiping out mentions of the Mughal dynasty (or any other, for that matter) or trying, in other ways, to distort historical fact to suit one's own agenda serves nothing other than to propa-

gate a falsehood.
What will this lead to? A generation (many generations?) of Indians who are learning something nobody else in the world knows as history? A falsehood, too, which is completely unsupported by evidence of any sort? My take is that history cannot be changed; we have what we have. The past is done, and nothing we do now can change it. So what is wrong with living with that past? Good or bad, all of India's history is our history. To try and sanitise it is


I truly believe we need more female authors to write stories of women, since they were either wiped out from the pages of history or their truths misconstrued by male

Care to weigh in?

I agree. Women have, for too long, been largely erased from the 'commonly known histories' — that's how I would describe it, since there are historians I know who have done research into women in history, and have come up with fascinating instances of women going far beyond what anybody can imagine in a patriarchal society like ours. The great queens of Odisha, for instance, or the padishah begums during the time of the Mughals: women with far greater agency than is now remembered by the common populace.

How do you like to portray your female characters? For Shagufta seems to be one bold woman in the face of atrocity.

I like to portray my female characters as a blend: not all strongwilled, not all flawless; human. Some are more feisty than others, some are far more conforming and meek than most, but I like to have at least one female character who stands up for herself, and is emotionally mature and intelligent.



Of small towns, big dreams and greater achievements

the sleepy towns of Bhilai and Bokaro, Arundhati Bhattacharva never imagined that one

day she would go on to chair India's largest bank. It was by sheer chance that she came to know of the bank probationary officers' entrance examination through a friend. She applied, was selected and went on to chart out a glorious banking career spanning four decades.

Indomitable — A Working Woman's Notes on Life, Work and Leadership (Harper Business) is the story of Bhattacharya's life as a banker and the challenges she faced in a maledominated bastion. She takes the reader through her growing up years and early education in the 1960s, getting to Kolkata for her college education and then into the State Bank of India (SBI), where she started her career.

The life of a woman banker with a family in a frequently transferable job isn't easy. In Bhattacharva's life, too, there were breaking points when she almost thought of quitting her career to balance her personal aspirations with her family's needs. But she didn't give up. Instead, she faced her challenges with humour and positivity and took up every assignment as a new chapter in learning and adapting.
In her role as the chair-

man of SBI, she steered the bank through some of its worst phases. She inspired confidence in the banking sector when the NPA crisis led to a significant public trust deficit. Under her leadership, SBI metamorphosed into a customercentric and digitally advanced bank while playing a pivotal role in national development. Some of her human resources initiatives included industryfirst practises that were appreciated and later adopted by other banks.

Candid, lucid and humble, *Indomitable* is the story that will galvanise you to embrace challenges, break barriers, push forward and

achieve greater heights.
"From a very young age I listened to many older people talking about migrating to the Western world as it was defined as 'the land of your dreams'. First it was the UK then the US and Canada and thereafter Australia and Singapore. I often wondered why India couldn't become the land of one's dreams. But I was told in India things don't work unless you know people. That capital was scarce and that the multiple barriers to living out your dreams didn't allow for anything other than a mundane existence to people coming from small towns with no backers or backgrounds.

"Did that mean people like me couldn't dream? This book is written to prove that India can be the land of our dreams and it is our ability to reach out with the right attitude and the right ideas that will get us there. 



Learn the importance of emergency medicine

ime is of essence in the management of a stroke. A stroke can be the result of a blockage in one of the blood vessels in the brain or the sudden rupture of a blood vessel. The former can result in impaired blood supply to the brain, while the latter can cause bleeding in the brain tissues. In both cases, the flow of oxygen to the brain is hampered, which can lead to the death of the brain cells within min-

Dr B.Srinivasan, Consultant — Emergency Medicine, Accident and Emergency Care, Manipal Hospitals, shares with The Pioneer emergency steps to take in the event of a stroke.

Symptoms that help in recognising stroke:

The warning signs of onset of a stroke can be seen on the victim's face, arms, and in the speech. Remember, time is of essence — do not waste even a second:

- F-Face: If an individual experiences numbness or droop on one side of the face, it is the first warning sign of a stroke
- A-Arms: Another warning symptom is when a person experiences numbness or weakness in both arms
- S- Speech: Following either of the earlier two warning signals, the person could begin experiencing speech
- impediment T-Time: Do not waste time. Call



for emergency services immediately. Getting the person to a hospital and under the care of medical experts could make all the difference between

- life and death. • Remember this acronym — FAST when dealing with stroke victims.
 Among other symptoms experi-
- enced by stroke victims are blurred vision, dim vision, loss of vision, especially in one eye, headache, loss of balance, loss of consciousness, and loss of bowel control.

What to do during a heart attack

If the person has persistent chest pain or discomfort in breathing, experiences palpitations, or sweating, he

might be in the throes of a heart attack

- (cardiovascular arrest). In such a case: • Convince the victim to stop all activity and help him/her to rest comfortably. If he/she has a known cause of heart disease and if the doctor has
- prescribed medication like aspirin or sorbitrate, you can give it to the person • Shift the patient to a hospital as
- soon as possible • In case the patient stops breathing or his/her heart stops beating, administer cardiopulmonary resuscitation.

Emergency steps to take in the event of a stroke

• A stroke patient will face a sudden onset of weakness in one or more parts of the body, along with slurred

speech, facial asymmetry, and/or facial droop. In such an emergency, proper medical care has to be provided within 4 hours of the onset of symptoms. So, make sure to:

• Shift the patient to a hospital as soon as possible

• Get a CT scan done of the brain. If there is a clot in the brain, the person would need urgent medical attention to help dissolve the clot.

The golden hour

The Golden Hour is a crucial period for a victim of stroke or accident. Every moment counts in such a situation. Speedy action should be taken to reach the patient into the hands of medical experts. Following are the rules to be followed in such a situation:

- Assess the victim 1 minute • Resuscitate and stabilise the vic-
- tim 5 minutes • Immobilise and transport the
- patient to a nearby hospital 4 min-
- Treatment of the victim 50

minutes According to the guidance of the American Stroke Association (ASA), the symptoms of stroke can lead to disability if clot-busting drugs are not administered within 4.5 hours. However, sometimes mechanical clot removals are performed up to 24 hours

On a comeback trail, Prannoy, who had reached the quarterfinals at the last world championships, dominated the proceedings initially to secure a 6-2 lead. He got his acts together in time to turn the tables at 12-10 and then zoomed from 15-14 to pocket the opening game.

The pace was high in the first game as both of us tried to up the pace but I made errors at 13-13 and it cost me the game," Sen said.

Sen, however, roared back into the contest in the second game as he ran up a huge 12-5 lead and didn't look back from that point, as Prannoy crumbled. A reliable source in the federation has confirmed to PTI that a letter has been sent to the Asian Boxing Confederation as well as the tournament's organising committee confirming India's withdrawal.

The event was scheduled to be held from January 20 to 30. The Asian event was originally slated to be held from December 7 to 17 last year but was postponed because of the pan-

Indian boxing has been hit by a COVID crisis of its own. The men's senior national camp in Patiala has reported 26 cases, including 20 boxers.

Boxers born in 1999, 2000, 2001 and

2002 are eligible to compete in the event that is being held for the first time in the conti-

The competition was to be held in 12 women's and 13 men's weight categories.

The Indian men's squad featured the likes of Asian youth bronzemedallist Mohammed Etash Khan (63.5kg) and reigning national champion Rohit Mor (60kg) among others.

The women's squad featured the likes of world youth champion Arundhati Chaudhary (71kg) and champion international medallist Jaismine (63kg). Chaudhary had recently made the headlines by taking the Boxing Federation of India to court for not holding trials in her weight category for the world championships in Turkey.

Visa revoked again, Djokovic faces deportation

No v a k Djokovic faces deportation again after the Australian revoked his visa for a second

time, the latest twist in the ongoing saga over whether the No 1-ranked tennis player will be allowed to compete in the Australian Open despite being unvaccinated for COVID-19. Immigration Minister Alex Hawke

said Friday he used his ministerial discretion to cancel the 34-yearold Serb's visa on public interest grounds just three days before play begins at the Australian Open, where Djokovic has won a record nine of his 20 Grand Slam titles.

Djokovic's lawyers were expected to appeal at the Federal Circuit and Family Court, which they already suche landed at a Melbourne airport.

A hearing was scheduled for Friday night. Deportation from Australia can lead to a three-year ban on returning to the country, although that may be waived, depending on the

Hawke said he cancelled the visa on "health and good order grounds, on the basis that it was in the public interest to do so."

His statement added that Prime Minister Scott Morrison's government "is firmly committed to protecting Australia's borders, particularly in relation to the COVID-19 pandem-Morrison himself welcomed Djokovic's

pending deportation. The whole episode has touched a nerve in Australia, and particularly in Victoria state, where locals went through hundreds of days of lockdowns during the worst of the pandemic and there is a vaccination rate among adults of more than 90%.

Australia is currently facing a massive surge in virus cases driven by the highly transmissible omicron variant. On Friday, the nation reported 130,000 new cases, including nearly 35,000 in Victoria state.

Although many infected people aren't getting as sick as they did in previous outbreaks, the surge is still putting severe strain on the health system, with more than 4,400 people hospitalized. It's also causing disruptions to workplaces and supply chains.

This pandemic has been incredibly difficult for every Australian but we have stuck together and saved lives and livelihoods. ... cessfully did last week on procedural Australians have made many sacrifices during

this pandemic, and they rightly expect the result of those sacrifices to be protected," Morrison said in a statement.

"This is what the Minister is doing in taking this action today."

Everyone at the Australian Open — including players, their support teams and spectators is required to be vaccinated for the illness caused by the coronavirus. Djokovic is not inoculated and had sought a medical exemption on the grounds that he had COVID-19 in

That exemption was approved by the Victoria state government and Tennis Australia, parently allowing him to obtain a visa to travel. But the Australian Border Force rejected the exemption and canceled his visa when he landed in Melbourne on January 5.

Djokovic spent four nights in an immigra-tion detention hotel before a judge on Monday overturned that decision. That ruling allowed Djokovic to move freely around Australia and he has been practicing at Melbourne Park daily to prepare to play in a tournament he has won each of the past three years.

He had a practice session originally scheduled for mid-afternoon Friday at Rod Laver Arena, the tournament's main stadium, but pushed that to the morning and was finished several hours before Hawke's decision was announced in the early evening.

An Australian Open spokeswoman said tournament organizers did not have any immediate comment on the latest development in Djokovic's situation, which has overshadowed all other story lines heading into the year's first

Imran Khan to visit China for Beijing Winter Olympics

Prime Minister Imran Khan will Phe travelling to Beijing next month to attend the opening ceremony of Winter Olympics, bolster the all-weather bilateral ties and seek more investments in various projects under the ambitious CPEC, the Foreign Office said here on Thursday.

The Beijing Winter Olympics will be held from February 4 to 20, followed by the Paralympics Winter Games from March 4-13, amid a diplomatic boycott by several Western countries, including the US and the UK over concerns of China's alleged human rights

"The premier will be embarking on a three-day visit to Beijing of the Chinese leadership," Foreign Office Spokesperson Asim Iftikhar said during his weekly news brief-

Khan will also have an interaction with the Chinese leadership to further strengthen Pakistan-China all-weather strategic cooperative partnership and to exchange views on regional and

international issues, Iftikhar said. Khan's visit is considered significant because several western and European countries have announced a diplomatic boycott of

Tensions have risen between China and several Western counfrom February 3 on the invitation tries over a number of issues.


