Minister for Medical and Family Welfare Ma Subramanian said the health department expects to administer 'precautionary booster dose to 10 lakh people by end of the month.

2ND CHARGESHEET IN LAKHIMPUR CASE. FARMERS NAMED FOR KILLING BJP MEN

second chargesheet has been filed in the Lakhimpur Kheri Case where an SUV -- allegedly driven by the son of a Union Minister -- ploughed into a crowd of protesters last year. While the first chargesheet named Ashish Mishra, son of Union Minister Ajay Mishra, over four farmers and a journalist who got run over, the second one involves the violence that followed, in which two BJP workers and the driver of the SUV were beaten to death. Seven farmers were arrested by the police during their investigations in this case, but it is not clear year if all of them have been charged with murder.

AP Cabinet okays new PRC

The threats from the employees notwithstanding, the State Cabinet that met on Friday had approved the 11th PRC, increasing the government employees' retirement age to 62 years among others.

The new PRC revised the pay scales of the government employees with modified HRA slabs and did away with the City Compensatory Allowance (CCA) which turned into a bone of contention between the government and the employees who have announced an action plan of their proposed agitation including work strike from February 7.

The State Cabinet had given a green signal for reserving 10 percent of the land in Jagananna Smart Townships for government employees, 5 percent land for pensioners, and offer 20 percent rebate for government employees.



Act to be amended to facilitate TTD special invitees

VIJAYAWADA: The State Cabinet on Friday gave its nod for the ordinance with amendments to the Endowments Act 1987, regarding the appointment of TTD special invitees. It may be recalled that the State government's move to appoint 52 special invitees to the TTD board that runs the worldrenowned temple of Lord Venkateswara had turned controversial. The high court in September last year had struck down the GOs related to the appointment of the TTD's jumbo board while passing the orders in a batch of PILs filed by BJP and TDP leaders, contending the appointments as in violation of the of the provisions of The Andhra Pradesh Charitable and Hindu Religious I and Endowments Act, 1987.

Government employees have decided to go on an indefinite strike from February 7 and would serve the strike notice to the government on January 24. Various unions of the government employees that have decided to get onto a single platform on Friday announced that they are forming 'PRC Sadhana Samithi'. A 12member steering committee to lead the agitation has also been decided to be formed.

On Friday, after a marathon of meetings, representatives of the Samithi met Chief Secretary, Sameer Sharma, and outlined their three main, important and immediate demands and also sought time on January 24 to serve strike notice. The Samithi representatives handed over a memorandum to the Chief Secretary and said every government employee is opposing the new PRC as it will incur a huge loss to the employees. They made it clear that with the new PRC their salaries will be

"We have decided to step up the stir and all the unions have joined hands and came onto a single platform. Our first demand is that the government should withdraw the G Os of the revised pay scales, second demand is to implement recommendations of Asuhitsoh Mishra and the third demand is to revise the newly revised pay scales. The ward and village secretariat employees should be given new pay scales," said AP Secretariat Employees Association president K Venkata Rami Reddy after the meeting with the chief secretary.

AP to rope in **IndiGo for** resuming flights from Kadapa

Andhra Pradesh government on Friday decided to enter into an agreement with Inter-Globe Aviation Limited (IndiGo) for resuming flight services from the Kadapa airport in the Chief Minister's native district.

The State Cabinet, which met here under the chairmanship of Chief Minister Y S Jagan Mohan Reddy, approved a proposal to cancel the existing Selected Airline Operator Agreement with Turbo Megha Airways (Trujet) and enter into a new pact with IndiGo, official sources said.

The Cabinet approved an expenditure of Rs 20 crore to support IndiGo operations from Kadapa and also to meet the state's 20 per cent share under the Regional Connectivity Scheme-UDAN for other airports like Kurnool.



Rs 1,392.33-cr NABARD loan for 3 med colleges

NABARD has sanctioned a loan of Rs 1392.23 crore under its Rural Infrastructure Development Fund (RIDF) for establishment of three new medical colleges-cum-hospiand East Godavari districts, and five multi-specialty hospitals in Srikakulam, Vizianagaram, East Godavari, West Godavari and Prakasam districts. These infrastructure projects would improve the healthcare facilities in the State and also provide timely healthcare in remote tribal areas of

The medical colleges-cum-hospitals will be having facilities for major operation theatre, clinical OPDs, dialysis, burn ward, casualty ward, specialized clinical cum surgical ward, oxygen plant, etc. besides providing quality infrastructure for improved medical

The Multi-speciality hospitals will have consultation rooms, Aayush clinic, treatment procedure room, dialysis ward, diagnostic labs, OT complex, OPD, General/Pediatrics/orthopedic wards, etc.

Regional Office, Chief General Manager, Sudhir Kumar Jannawar, said, the bank has been actively partnering with government in improving the health and education infrastructure in the state.

NABARD has so far sanctioned Rs 3092 Crs to school projects being implemented under the Government of AP's flagship Nadu-Nedu programme. The support will enable the creation of additional classrooms, providing toilets and drinking water facilities in 25648 schools. NABARD has also supported the State Government in the establishment of Anganwadi Centres and Integrated Agri-Aqua labs, he said.

Even as its third unit is getting ready to be commissioned, the YS Jagan Mohan Reddy government, due to mounting operational costs, had decided to handover the operation and maintenance (O&M) of APGENCO run Sri Damodaram Sanjeevaiah Thermal Power Station at Krishnapatnam in Nellore district to outsiders- others through

It effectively means that any private player or Central PSUs having experience in the power sector may participate in the bidding to take up O & M of the Krishnapatnam thermal power plant.

A decision in this regard has been taken by the state cabinet that had met here on Friday. The German state-owned development bank KfW and Power Finance Corporation Ltd (PFC) had financed this super-



critical power station.

While initially in stage 1 two units of 800mw each have been operationalized in 2015 and 2016 in phases, construction of the third unit of another 800 mw has just been completed and ready to launch the commercial operation.

"While the power generation cost at Krishnapatnam power plant has been Rs 3.14 per unit, its only Rs 2.34 per unit in the nearby thermal power plants in the same region. The operational costs have been heavy and unviable.

The Cabinet had decided to hand over the operations and maintenance of the Krishnapatnam thermal power plant for 25 years to outsiders through bidding. The further procedure will be taken up," said I & PR minister Perni minister Venkataramaiah (Nani) after the cabinet meeting.

Is it social media or anti-social media? Let us be fair and clear

Sways a boon to the common man. It has opened new vistas for the common people who, through their hand-held devices, can now express their voice freely. One should welcome such a development and the social media platforms. But at the same time one should collectively oppose the deliberate misuse use of social media.

There are certain social media platforms that are hurting human relations. They are creating more dangers and fears than those posed by the Covid-19 pandemic. Under the guise of social media journalism, people are expressing shocking opinions, remarks, and observations without any regulation, restrictions or sometimes even basic decency. Is this kind of social media journalism superior to

expression? Are these socalled social media channels spinning out stories on news and other issues above basic morals, ethics and principles of journalism? One has to ponder this.

Information pollution is increasing by leaps and bounds with the advent and proliferation of social media platforms, which are beyond print and electronic media boundaries. People are in a situation where they are not been able to distinguish truth from fiction. Many social media sites are creating fake thumbnails for better ratings and spreading fake news, lies and baseless reports. If one observes closely the social media platforms, one would realise how fast they are spreading hatred and dangerous trends.

treasured right and it carries a very great responsibility too. Journalism should be practiced in line with constitutional obligations so that it does not adversely impact citizens' respect and sentiments. Our Constitution has provided certain rights even to those who are accused. In this backdrop, it is undemocratic to utilise the social media platform for vested interests and individual likes and dislikes, whims and fancies.

Freedom of speech should be utilised with utmost com-

mitment and dedication. There is no separate freedom of the press in our Constitution. The freedom of expression as enshrined in the Constitution under Article 19 (1) is applicable to freedom of the press also. It also applies to journalists. To run a newspaper there are several conditions. One should abide by the guidelines of the Press Act while publishing a report.

For launching a newspaper, one has to meet 16 conditions imposed by the



Registrar for Newspapers in India (RNI). One has to obtain permission from the police and submit bank account details; permission from the district collector etc., among other requirements. The Press Council of India was formed to ensure that newspapers follow guidelines and Code of social media platforms do not have such regulations presently. They have the option of self-regulation.

Under these circumstances, the so-called democratic-minded people should act with more responsibility. Everyone should follow selfregulation and utilise freedom of expression for the public good and act like responsible citizens.

In a democracy, people will have varied opinions. But this does not mean that people should be allowed to spew venom against those who are differing with them on certain issues. This is gross irresponsible behav-

Unless intellectuals, genuine journalists wake up and take remedial measures, people will lose faith in journalism. And that will be a death atmosphere and journalism, and it would lead to political dictatorship.

The Supreme Court had recently expressed its anger at the fake news campaign in social media. If someone is intentionally or for vested interests spreading hate campaign, it is not only harmful to the individuals targeted but to entire society. Netizens should understand this danger and be alert.

There is a dire need to punish severely those spreading lies, fake news and hatred through social media platforms. In several countries around the world, social media platforms and OTTs are controlled by the respective governments. Those violating norms are fined and sent to jail. In countries like Germany, Australia, the punishments are severe. China

and WhatsApp. There are restrictions on social media platform in Russia and

Freedom of speech is great. The Government should ensure that this is not being misused or abused. So, proper measures should be taken. Every citizen should exercise caution and be alert about the misuse of freedom on social media platforms. The guidelines and restrictions of the Press Act would be extended to the social media too, along with the mainstream media.
Against this backdrop, the
Press laws, Acts, RNI, and
The Press Council should
review their laws and prepare guidelines. All those misusing those laws should be legally punished.

High drama as TDP leaders try to barge into K Convention hall

The police had a tough time controlling the TDP leaders and activists who tried to barge into K Convention hall owned by Minister Kodali Sri Venkateswara Rao (Nani) on Friday. The FFC members, accompanied by a large number of party workers, started the journey, but were stopped by the police at Pamarru. After a discussion with the police, only 10 vehicles continued the journey to Gudivada.

The TDP leaders and supporters first reached the party office in Gudivada, and from there they tried to go to K Convention hall despite the police denying permission. However, discussions were held





between the TDP leaders and the police and the cops took the TDP leaders into custody to prevent any untoward incidents. In the meantime, some miscreants broke the window pane of Bonda Uma's car leading to a tense situation. The TDP leaders alleged that YSRCP supporters damaged the car.

Speaking to media persons, Bonda Uma alleged that Minister Nani organised gambling in his own convention hall. The minister brought casino culture to Gudivada in the name of 'NTR to YSR' and also organised anti-social activities. If the minister tries to evade investigation by saying that he



was undergoing Covid treatment in Hyderabad, we will move legally to take action against the minister. The minister is now caught red-handed and should be expelled," demanded Bonda Uma.

Surprise checks on Covid testing labs

During the checks, they found that three labs were charging more than Rs 350 prescribed by the State government for tests as per GO

Checks were conducted at Kamineni Hospital, Apollo Laboratory, Remedies Laboratory, ABC Diagnostic Center, iRIS Laboratory, Omicron Diagnostic Center, and Sai Balaji Diagnostic Center. The team found that Kamineni Hospital, Omicron Diagnostic Center and Sai Balaji Diagnostic Center were charging Rs 499.

The three labs have charged more amounts from 471 persons, that is a total of Rs 80,000, and they were asked to refund the amounts to the customers. No action was taken against them. The inspection team warned of severe action against collecting additional amounts from the patients for Covid tests.

He said wounds were clearly visible on the body of the deceased and added that he could have

been murdered.

He said the police should verify the CCTV footage at the residence of his first wife and mobile data should be collected to get information in the case.

on withdrawing the weekend curfew, lifting the odd-even rule for opening of shops and allowing private offices to operate at 50 per cent capacity. "Experts had warned that Delhi can record one lakh cases daily during this wave but that danger has been averted. We will take a call on lifting of more restrictions within three-four days," the minister told reporters here.

Delhi has passed the peak of the ongoing wave of the pan-demic, Jain said. He said that after recording around 28,000 Covid infections last week, Delhi is now reporting a sharp decline in the number of daily cases and the positivity rate.

To teach in English or in mother tongue? A multilingual approach is the answer

he Telangana Government has decided to introduce English as a medium of instruction in Government schools from the next academic year. The State language, Telugu, will be parallelly available as the other medium of instruction. On the face of it, there is a readymade explanation for the change. More and more parents of children in Government schools of Telangana feel the kids, when they reach the college level, fail to catch up with the standards of English-medium students. Secondly, private schools, hitherto limited to the urban centres with their English-medium education, have of late mushroomed across rural Telangana offering education in the English medium. That has led to a near-exodus from Telugu-medium Government schools, many of which have either closed down or merged with bigger schools, or relocated for want of students. The Government in any case runs a few residential schools with English medium and thinks offering English medium across the State would not be much of an issue. The problem the Government faces is finding teachers who can teach in English. They are scarce. The majority of the teachers is proficient in Telugu. The Government has to re-train these teachers — a tough task



— and encourage prospective teachers to take up B Ed courses in English. But by and large, not many eyebrows are being raised as the English medium creeps into the Government school system in Telangana where 'going to America' is a popular cry and Telugu-medium students shell out big money to enrol in private English-language courses.

The issue, however, points to a disturbing fact. Even after 75 years of Independence, we are stuck with basic stuff. like what should be the medium of education in our schools. We are still debating whether children should be taught in English or their mother tongue. We

are also not sure whether mother tongue constitutes languages or dialects, too. For instance, millions speak Bhojpuri but it is considered a dialect of Hindi. Only last year, a Minister in Bihar mooted the idea of making the "mother tongue of the region" the medium of teaching. It just shows India never had an exhaustive debate on the subject. Linguists backing cognitive education insist that children learn skills in their mother tongue, a language they grow up with. The aspirational, social-empowering, rights-based argument favours English because it is the language that works in the world. Thus, the medium of instruction carries the baggage of ideology and elitism in the world's largest multi-lingual federation that is India. In contrast to parents' eagerness for their children to be taught in English, the Centre's National Education Policy (NEP) largely prefers the mother tongue. The answer is a bilingual or, preferably, a multilingual approach. Technology makes it possible. In a country where most children live their lives in two or three languages, multilingual teaching methods provide a level playing field for diverse linguistic and cultural backgrounds while reconciling the desires of both parents and the NEP.



As Kerala grapples with rising COVID cases, its 'immaculate health care' balloon has burst

s the number of daily COVID-19 cases soared to 46,487 on Thursday, Kerala's boast of being a role model for health care came crashing down like a pack of cards. The death toll in the State till Thursday stood at 51,501. Kerala has not been free from the pandemic's onslaught since India's first COVID-19 case was diagnosed in the State in early 2020. However, the State administration-sponsored media blitzkrieg portrayed an "all is well" image. Chief Minister Pinarayi Vijayan, who is currently recuperating in a US hospital, had addressed the media daily to tell the



briefings, which were telecast by all satellite news channels, were used by Vijayan to campaign for the 2021 Assembly election. He claimed that Kerala was receiving global acclaim for its health care system and other countries were emulating its example. But after the LDF retained power following the 2021 Assembly election, he discontinued the practice of addressing the media daily; the opportunist in Vijayan the politician chose to ignore people as the next major election is due only in 2024.

When the cases of COVID-19 surged, the Government turned to blaming people for the trans-

mission of the virus. The truth, however, is that no worthwhile efforts were made to study the pattern in the spread of the disease. The State Government continued to tom-tom and live by its past laurels, when some agencies had praised the Kerala model of health care. The health department was complacent throughout this period, and manipulated figures failed to cover up the administration's malpractices. A 600-bed COVID hospital at Kasaragod, built by the Tatas and handed over to the Government in early 2021, is yet to become fully operational. The Government doctors were on a path of agitation for the last one year, demanding restoration of allowances which were cancelled citing financial crunch. The much-touted Kerala model was virtually a red herring spawned by friendly media. EMS Namboodiripad and C Achutha Menon, the Communist Chief Ministers of the State, used to fly to Romania and East Germany for medical treatment while Vijayan and his consciencekeeper Kodiyeri Balakrishnan prefer the "imperialist" US as their medical caretaker. It's time for the Comrades to see the writing on the wall, isn't it already?

Afghan women's rights are still far




The Taliban's recent announcements fail to inspire confidence and don't go far enough to impress the international community

wo news items, published in newspapers on January 20, 2022, merit attention. The first by *AFP*, carried in the Delhi edition of a leading daily, is about Acting Afghan Prime Minister Mohammad Hassan Akhund's appeal on January 19 to Muslim countries "to take the lead and recognise us officially". He was speaking at a conference to address Afghanistan's massive economic problems. The second, by PTI, featured in the Delhi edition of *The Pioneer*. It cited Chinese Foreign Ministry spokesman Xiao Lijian as saying at a media briefing on January 18 that he hoped that the Afghan side would respond further to the international community's expectations that it would "establish an open and inclusive political architecture, adopt moderate and prudent domestic and foreign policies, firmly combat all sorts of terrorist forces" and be "on friendly terms with other countries, especially its neighbours and integrate into [the] international family at an early date".

The statement, made following a mention of the Taliban seeking China's help to get global diplomatic recognition, clearly indicated that the world did not think that they had established an "inclusive" Government or that their policies towards women would not be a repeat of the horribly repressive ones that marked their earlier stint in power from 1996 to 2001. And this, when they had promised that women would enjoy all the rights to education and work available under Sharia law. In fact, the UN and its bod-

ies have, on several occasions, asked the Taliban to implement their promises and made critical observations about their actions. Its secretary-general, Antonio Guterres, told reporters on October 7 last year, "I am particularly alarmed to see promises made to Afghan women and girls by the Taliban being broken." He added, "I strongly appeal to the Taliban to keep their promises to women and girls and fulfil their obligations under international human rights and humanitarian law." Speaking at the Human Rights Council, an inter-govern-



The UN bodies have acted. On September 17, the Security Council unanimously adopted a resolution asking the Taliban to establish an inclusive Government that has "the full, equal and meaningful participation of women" and upholds human rights. The Human Rights Council adopted a resolution on October to have, from March 2022, a special rapporteur, supported by UN experts, on the ground to monitor the human rights situation in Afghanistan. There are some indications

that the Taliban are reacting. Abdul Baqi Haqqani, Minister for Higher Education, announced at a press conference in Kabul on January 12 that the Government would soon reopen public universities for male and female students. He also announced that these students would be segregated and cited Afghanistan's economic crisis and the lack of separated classes for male and female students, as reasons for

the delay. Earlier, in a decree on December 3 in the name of the Acting PM, the Taliban had stated that a "woman is not a property, but a noble and free human being; no one can give her to anyone in exchange for peace...or to end animosity". Both women and men, it had added, "should be equal" and that "no one can force women to marry by coercion or pressure". The decree also enabled a widow to re-marry 17 weeks after her husband's death against the longstanding Afghan tribal custom of her leadership has reportedly ordered Afghan courts to treat women fairly, especially in cases of widows seeking inheritance as next of kin. The announcement also cites the

Taliban as saying they had asked their Ministers to spread awareness about women's rights across the population.

Significantly, the first announcement does not mention the precise date when public universities will reopen. Nor does it mention women's right to work. The third sura of the Koran (ayats 193 and 194) forbids the wasting of anyone's — whether a man or woman's — labour. The fourth sura (ayats 36 and 37) says, "To the men a share of what they have earned,/ and to the women a share of what they have earned..." (translation from The Koran Interpreted by Arthur J Arberry). The second announcement says nothing about women's right to education and work, which are crucial issues with the international community. Also, the rights the decree announces regarding marriage have all been enshrined in Islamic jurisprudence since the time of Prophet Mohammad. Clearly, neither announcement means marrying one of her husband's much and is unlikely to brothers or relatives after his impress the international comdeath Further the Taliban munity sufficiently for the purse strings to be loosened generously or recognition to be forthcoming soon.

QUICK COMMERCE: A NEW RETAIL MANTRA

Essentially large warehouses, dark stores enable fast delivery of goods in localities

wise person can create 'The Advantage of Adversity'. And you can very much learn this from retail marketers at this crucial juncture. Coping with the crucial situations of COVID-19, retail marketing is scaling newer heights. Business climate for retail marketing is getting conducive as there is a win-win situation for both the marketers and the clients. Today, retail industries are resorting to varied strategies to meet up consumers' demands. Moreover, the modus operandi of delivering the goods and services is becoming digitalized and even fast-paced. Consequently, understanding and innovating the retail has become a new business mantra. So much so Amazon, Flipkart, Ola, Uber, Zepto, Blinkit, Swiggy, Dunzo, Bigbasket and other business units are surprisingly found to be engaged with quick commerce companies. Owing to fasten the business, dark stores have been founded in the local area for treading



purposes. Essentially, dark stores are large warehouses that are the central points of retail distribution. They cater exclusively to local needs through online shopping. Quick commerce is indeed the next generation of ecommerce. It is an international business process that caters to the wishes of the consumers to bring instant delivery of goods. It provides instant support to the modern communities which are in dire need. Groceries. stationaries hygiene products etc., are coming under the ambit of quick commerce activities. Quick commerce websites are used to provide an online platform for various trading in the country. However, this business method helps the online shoppers to make safe purchases for their stores. Such a business model wants to be the biggest kirana store in the urban colony. It should be expressed that a dark store hits a frequency of more than 200 orders per day. The unit economics depends on the fact that there is a mixture of perishable and non-perishable in transaction. Tellingly, guick commerce remains a new and evolving business management with the effective inclusion of information technology. Many e-commerce companies are turning to social media channels such as Facebook and Instagram to showcase their vast array of products. Customization is the key of this trade. It will facilitate speed and efficiency. Quick commerce addresses are meaningful. The customers can use their mobile devices for shopping. However, quick commerce can invite online fraudulent activities. Credit card frauds are persistent in online businesses. It is apparent that quick commerce or electronic commerce is above all a commercial transaction over the Internet. It is a space mainly to watch out for logistics and e-commerce players. The expectations are likely to settle in at a sweet spot of thirty minutes' delivery or so. According to industry players, ten minutes' delivery model will see rationalization over time. Cinema ticket pricing vs bloated film costs

wo controversial Government Orders issued by the Andhra Pradesh Government related to entertainment and culture have created a lot of heat. The first Go issued in April 2021 was aimed at regulating film industry. The second one was recently issued banning a popular and message-oriented stage play 'Chintamani,' Both the issues could have been dealt with skilfully had the Government consulted the stakeholders before taking the decisions. The Government of YS Jagan Mohan

Reddy which has been dabbling in controversies of all kinds has added two more, involving the film industry and stage plays.

About 170 of the 950-odd theatres in Andhra Pradesh have been closed since the GO was issued. The exhibitors say they lost hugely due to Covid during 2021 when the theatres were completely shut. They were reopened with 50 per cent occupancy on July 31, 2021. Even before that, the State Government issued GO 35 fixing slabs for tickets in cinema halls in municipal corporations, municipalities, nagar panchayats and village panchayats under economy, deluxe and premium classes for multiplex, AC theatres and non-

Filmmaker Ram Gopal Varma met AP Information, public relations and cine-matography minister Perni Venkataramaiah (Nani) and told him that the Government has no business to intervene in this issue. It is for the exhibitors and audience to decide the price of tickets. Pawan Kalyan, film hero-cum-politician (president of Jan Sena which has alliance with the BJP) was rather aggressive in his criticism. He said since the Government has no money, it is indulging in online ticketing and fixing ticket prices. Minister Nani asked the actor why would the government which has no money would reduce the ticket price instead of increasing. Senior actor, Pawan Kalyan's elder brother and former union minister Chiranjeevi tried to break the ice when he travelled to Amaravati to meet Jagan Mohan Reddy over lunch on last Thursday. Some news channels and newspaper said Chiranjeevi was offered a Rajya Sabha seat by the YSRCP chief which was promptly and curtly denied by the mega star. He said the problem would be resolved soon.

What is the problem? Is it peculiar to Tollywood? So, it appears. The problems in the industry started with stardom. At least six stars today charge a fee of ₹45 crore each for a movie. Heroines also are paid in crores, though their remuneration is nowhere near the actors'. Directors donot take all the remuneration by cheque or cash but ask for share in the revenue area wise. Together they eat away threefourth of the budget.

Persons working in 24 crafts in films get a pittance. The presence of Chiranjeevi, Prabhas, Mahesh, Pawan Kalyan, NTR (Jr) and Ram Charan Teja makes the budget


Will Russia play the 'Cuban card'?


But Russia stopped being Communist 30 years ago

fter a week of intense discussions about 'security' Abetween Russia and the NATO countries, this is the week when the Western allies will send their written replies to Russian President Vladimir Putin. Various pundits, some of whom have actually been to Russia, warn us that there will be 'War in Europe' if Putin's demands are not met.

(You there, at the back. Stop giggling! This is no laughing matter! Peace is hanging by a thread!)

Historians keen for a moment in the limelight are being wheeled out to draw parallels with past diplomatic disasters like the Munich conference of 1938 (appeasement of Hitler) and Yalta in 1945 (carving up Europe and giving Stalin the eastern half in 1945).





Wow! A dagger - no, two daggers - pointed at the heart of America (although they'll have to work on the length of the Venezuelan dagger, since it's 2,000 km. from Caracas to Miami). If that does not force the Americans to give in, what will?

I'm sorry. That's enough sarcasm. It's just that all this prancing around and mugging for the camera gets tiresome. This is a minor diplomatic spat that has been deliberately inflated far beyond its merit, and it is being taken much too seriously.

alleged historical precedents: Munich and Yalta? They were both about granting a 'sphere of influence' in Europe to a great power (Germany in 1938, the Soviet Union in 1945) that could easily enforce its wishes on the

Russia is effectively demanding a comparable sphere of influence in its old 'satellite' countries, which would not be allowed to have friendly foreign troops on their soil even though they are NATO members, but it's a complete non-starter. Russia lacks the military capacity to enforce its will on the ground.

So will there be 'War in Europe, as the feverish headlines suggest? Not in the sense they imply: massive armoured forces rolling across whole countries, with the threat of nuclear war looming in the background. But there might be some shooting on or just inside Ukraine's border





Over 2,250 startups added in 2021, raised US \$ 24.1 bn

More than 2,250 startups were added in the year 2021, over 600 more than what was added in the previous year, a report by Nasscom and Zinnov said on Friday.

The study titled 'Indian Tech Start-up Ecosystem: Year of The Titans' said with rising investor confidence, startups leveraging deep-tech, and tapping unexplored talent pool, the Indian tech startup base continues to witness steady

As per the report, startups raised USD 24.1 billion in 2021, a two-fold increase over pre-COVID levels.

In comparison to 2020, there was a 3X increase in number of high-value deals (deals more than USD 100 million), demonstrating investor confidence with a pool of active angel investors of more than 2,400 and a readiness to take significant risks, it said.

While the US remains the

investment in startups, worldwide involvement is also growing. About 50 per cent of the deals had at least one Indiadomiciled investor, it added.

The report said the startup ecosystem saw a 2X gain in cumulative valuation from 2020 to 2021, with an estimate of USD 320-330 billion, demonstrating the sector's development and recovery throughout the pandemic.

B2B spending in India expected to grow 10.3% in 2022: Report

PNS ■ NEW DELHI

The total business-to-business spending in India is expected to rise by 10.3 per cent in 2022 with the spend of the country's businesses growing three times faster than the expectations from its comparable peers in other countries in the third quarter of last year, according to a study.

The total business-to-business (B2B) spend for India rose 9.4 per cent in Q3 2021 on a year-on-year basis, as per the India Business Spend Indicator (IBSI) report by American Express, India and Invest India in partnership with the Centre for Business and Economic Research (CEBR).

Stating that the India spending is on the rise across nine key B2B categories, the report said, "it is expected to rise by 10.3 per cent in 2022."

The study, which interviewed 500 financial decision makers in India on how their business spending habits are changing, found bullishness and greater confidence with 74 per cent of businesses expecting to spend more on technol-

ogy and 72 per cent planning to make more capital investments in 2022

Manoj Adlakha, SVP and CEO, American Express Banking Corp, India said, "India saw the highest B2B spending growth compared to expectations of six other major economies. This year, the total B2B spend for India is expected to rise by 10.3 per cent compared to 2021.'

This, he said, "Shows that the Indian economy is very much in its bounce-back phase from the economic difficulties caused by the pandemic crisis."

The survey also reveals that some of the trends that have emerged or accelerated during the pandemic such as payments automation and new approaches to manage the supply chain are likely to stay,

Adlakha added. The trend includes benefits of digital payments, which 59 per cent of B2B sellers considered to be the speed of payment and ability to track spends, while 83 per cent of eligible respondents said that the government's 'Make in India' campaign has helped

Squid Game will get a second season

he popular Korean survival drama Squid Game will be getting a Season 2, co-CEO and chief content officer Ted Sarandos has confirmed. On Netflix's fourth quarter 2021 earnings interview, Sarandos was asked whether there would be a second season of the violent South Korean survival drama, which has scored as the company's No. 1 most-viewed TV series, reports variety.com.

"Absolutely," Sarandos replied.
"The Squid Game universe has just begun." He put 'Squid Game' in the category of Netflix's burgeoning bouquet of entertainment franchises that the company sees as having growth potential outside the core streaming service, with live experiences, games and merchandise. Sarandos called out *Bridgerton*, the second most-viewed Netflix original TV show, with the Season 2 set

In Season 1, 456 cash-strapped contestants are invited by a mysterious organisation to compete in a series of children's games with deadly consequences. Netflix paid \$21.4 million for the



Venkatesh Iyer (22 off 33 balls and 5-0-28-0) is still a work in progress and his fast-tracking in the limited overs set-up is less of pragmatism and more desperation to find a fresh version of injury-plagued Hardik Pandya.

Iyer might develop into a good cricketer but he is a far from finished product and may be some time away from being a success at the international level in all conditions.

As of now, he is not a natural No.6, who can be a finisher like Pandya was in his best days before injury.

Had Pant not played the role of an enforcer to perfection, even a target of 288 wouldn't have been possible. And this was after it seemed India would score close to 315 when he was having a steady stand of 115 with his skipper.

But there dismissals in quick succession saw Proteas make a comeback on a Boland Park strip where stroke-making wasn't an easy proposition for a new batter.

National Cricket Academy Head VVS Laxman had lauded the players for the way they responded to the situation ahead of the Ireland game.



Some of the international features from the Oscar shortlist are also eligible for best picture, in addition to the best international feature category, such as Japan's much-awarded *Drive Mv* Car, Italy's The Hand of God, Iran's A Hero and Norway's The Worst Person in the World. Directed by Priyadarshan, Marakkar is one of the most expensive films in the history of Malayalam cinema. It narrates the epic tale of Kunjali Marakkar IV, a Malabar sea lord and his epic battles against the Portuguese. The movie had won three National Awards Best Feature Film, Best Special Effects and Best Costume Design.
