Thackeray camp's strength reduced to 15 as another MLA shifts loyalty

The Shiv Sena hit an all-time low in its 56-year-old history on Monday as its rebel leader and Maharashtra's Chief Minister Eknath Shinde not only won convincingly on the floor of the Maharashtra Assembly but he also began systematically to dismantle the very edifice of the Uddhav Thackeray-led parent party Sena and usurp the legacy of late Bal Thackeray

Hours before Shinde won the confidence vote on the floor of the Assembly, Speaker Rahul Narwekar had reinstated Shinde as the Shiv Sena Legislature Party leader in place of Ajay Chaudhary who had replaced the rebel Sena leader earlier, removing all technical glitches for the new Chief Minister seeking a trust vote in the Assembly

In a confidence vote held nearly a fortnight after Shinde rebelled against his party president and then Chief Minister Uddhav Thackeray, as many as 164 MLAs voted for the motion of confidence brought in by the



Maharashtra Chief Minister Eknath Shinde and Deputy Chief Minister Devendra Fadnavis, along with MLAs, after a special session of the Assembly at Vidhan Bhavan in Mumbai on Monday

new Chief Minister, while 99 voted against it.

As many as 21 MLAs including Congress' two former Ministers Ashok Chavan and Wadettiwar — were absent during the trust vote, while three MLAs refrained from voting in a 287-member Assembly (the strength of the

288-member Assembly has come down to 287, following the death of a Shiv Sena MLA).

Coming as they did a day after the rebel Sena faction led by Shinde had virtually taken over the party's legislature party office at Vidhan Bhavan by sealing the office, Monday's developments established that

the new Chief Minister is going about in a clinical manner to dismantle the parent party Shiv

Sena layer by layer.

The Uddhav-led Shiv Sena suffered one more jolt on Monday as yet another Shiv Sena MLA Santosh Bangar joined the Shinde-led camp.

service charge **Section of industry** slam guidelines by **Central Consumer**

Hotels and restaurants can no longer impose service charge on customers. Amid rising consumer complaints, the Central Consumer Protection Authority (CCPA) on Monday issued guidelines for "preventing unfair trade practices and violation of consumer rights due to levying of service charge in hotels and restaurants."

"No hotels or restaurants shall add service charge automatically or by default in the bill No hotel or restaurant can force a consumer to pay service charges. They have to clearly inform the consumer that service charge is voluntary, optional and at consumer's discretion," the guidelines said.

Meanwhile, several restaurant and bar owners in Delhi on Monday opposed the CCPA guidelines barring them from levying service charges automatically or by default on food bills, saying it is "completely illegal and baseless".

Restaurant owners asserted that service charge was not levied discreetly as it is mentioned on the menu and the bill as well.

Further, service charge cannot be collected by adding it along with the food bill and levying GST on the total If any consumer finds that

a hotel or restaurant is levying service charge in violation of the guidelines, s/he can request the concerned establishment to remove it from the bill amount.

The consumers can also lodge a complaint on the National Consumer Helpline (NCH), which works as an alternate dispute redressal mechanism at the pre-litigation level, by calling 1915 or through the NCH mobile app. *Continued on Page 2*

In a first in Army, docs place auditory brainstem implant

Perform 12-hr-long rare surgery to cure deafness in 4-year-old child

Army doctors have performed a rare surgery lasting more than 12 hours to cure profound deafness of a four-year-old daughter of a serving soldier. She has become the first child in the armed forces or any Government organisation to receive an Auditory Brainstem Implant (ABI).

Giving details of the complex medical procedure, Army officials said on Monday the surgery was performed at the Army Hospital Research and

Referral here. Explaining the significance of the operation, they said most childhood deafness rosurgeons, neuro anesthetists wherein the defect is in the



cochlea is addressed with a

cochlear implant. However, this child had no cochlea or the auditory nerves at birth, thus the only option to rehabilitate her was to surgically place an ABI at the seat of hearing within the brain.

The cutting edge technology of auditory brainstem implantation is still at its nascent stages across the world.

The team of ear, nose and throat (ENT) surgeons, neu-

and audiologists completed this surgery in around 12 The device will be switched

on six weeks post surgery. This will be followed by intense rehabilitation. With that, the child will gain auditory awareness and hopefully develop

This will help the child in integration with mainstream schooling thereby becoming a productive member of society in years to follow, they said.

This face mask can kill coronavirus

Researchers have developed a new N95 face mask that can not only reduce Covid-19 spread but also kill the SARS-CoV-2 virus upon contact with it. The mask can potentially be worn longer, causing less plastic waste as it does not need to be replaced as frequently, the researchers said.

"We think the work is a first step toward longer-lasting, self-sterilising personal protective equipment, such as the

tective equipment, such as the N95 respirator," said Edmund Palermo, from Rensselaer Polytechnic Institute in the

"It may help reduce transmission of airborne pathogens in general," Palermo said.

In research recently published in the journal Applied ACS Materials and Interfaces, the team successfully grafted broad-spectrum antimicrobial polymers onto the polypropy-lene filters used in N95 face

"The active filtration layers in N95 masks are very sensitive to chemical modification. It can make them perbial quaternary ammonium



form worse in terms of filtration, so they essentially no longer perform like N95s. They are made out of polypropylene, which is difficult to chemically modify.
"Another challenge is that

you don't want to disrupt the very fine network of fibres in these masks, which might make them more difficult to breathe through," Zha added.

The team, including researchers from Massachusetts Institute of Technology (MIT) used only UV light and acetone in their process, which are widely available, to make it easy in the US, attached antimicro-

polymers to the fibre surfaces of nonwoven polypropylene fabrics using ultraviolet (UV)initiated grafting. The process that we

developed uses a really simple chemistry to create this nonleaching polymer coating that can kill viruses and bacteria by essentially breaking open their outer layer," said Zha. "It's very straightforward and a potentially scalable method," Zha noted. The team

solution is straightforward, they said. The user could wear an unaltered N95 mask along with another polypropylene layer with the antimicrobial polymer on top according to polymer on top, according to the researchers.

In the future, manufacturers could make a mask with the antimicrobial polymer incorporated into the top layer, they said. "Hopefully, we are on the other side of the Covid pandemic. But this kind of technology will be increasingly important," said Zha.

The threat of diseases caused by airborne microbes is not going away. It's about time that we improved the performance and sustainability of the materials that we use to protect ourselves," Zha added.

Ajit Pawar elected Leader of Opp in Maha Assembly

Tn a role reversal that came Lafter the change in the Government in Maharashtra. senior NCP leader and former deputy Chief Minister Ajit Pawar was on Monday was elected as the new Leader of Opposition (LoP) of the Maharashtra Legislative Assembly.

The NCP has got the LoP's post as a natural consequence, as the Sharad Pawar-led now has the largest number of MLAs (53) as against the Congress' strength of 44 MLAs and Shiv Sena's reduced strength of 15 MLAs in the in 288-member State Assembly. The Sena earlier had a strength

Earlier, in the NCP's Legislature party meeting, State party president and state legis-



lature party leader Jayant Patil proposed the name of Pawar for the post of the LoP. The party later proposed Pawar's name in the House and was elected to the post.

A six-time MLA, one time MP and a commerce graduate Ajitdada - as Ajit Pawar is popularly known in the state political circles - is the nephew of NCP President Sharad Pawar. Ajitdada is the cousin of Baramati MP Supriya Sule, and Rohit R. Pawar, an MLA from Karjat-Jamkhed con-

62-year-old Maharashtra where there have been nine deputy chief ministers so far, Ajit dada – interestingly enough --had in the past held the DCM's post record four times—from November 2010 to September 2012, December 2012 to September. 2014, from November 23-28, 2019 and from December 2019 to June 2022. He was the deputy chief minister in the Maha Vikas Aghadi (MVA) government headed by Chief Minister Uddhav Thackeray.

Ajitdada has long been aspiring to be the chief minister of Maharashtra, a desire he has never hidden.

An aggressive and no-nonsense leader, Ajitdada began his political career under the guidance of his uncle Sharad Pawar by engaging himself in sugar

1982. He was elected to Lok Sabha from Baramati constituency for the first time in 1991, but vacated his LS seat immediately there for his uncle Sharad Pawar who had then become the Defence Minister in the Narasimha Rao government. He was subsequently elected to the State Assembly

from Baramati constituency. Ajitdada was subsequently elected to the State Assembly from Baramati in 1995, 1999, 2004, 2009, 2014 and 2019. He has worked in different governments in the past.

Speaking in the House after assuming the LoP, Ajitdada urged the Speaker togive adequate time to the Opposition to raise issues in the House. "I will assure you that no bill would be passed without healthy discussions," the

Manipur landslide: 4 more bodies retrieved, death toll mounts to 46

The death toll in the landslide that struck a railway construction camp at Tupul in Manipur's Noney district rose to 46 on

Monday as four more bodies were retrieved from under the debris on the fifth day of the search and rescue operations, officials said.

The bodies were yet to be identified, even as 20 people, including three army personnel and 17 civilians, were accounted missing till Sunday, they The bodies are becoming

increasingly difficult to identify as they are decomposing rapidly, they said.

Personnel of the 107



Territorial Army and civilians involved in the construction of the 110-km Jiribam-Imphal railway line lost their lives in the worst natural disaster to have struck the northeastern state in recent times.

A massive landslide hit the railway construction site on Wednesday night. The debris blocked the Ijei river below, creating a reservoir that threatens to inundate the low-lying areas. At present, work is underway to clear the debris to let the water flow out.

Lakhs of fish die in Najafgarh drain upstream

huge number of fish have Amysteriously died in the upstream stretch of the Najafgarh drain along the Delhi-Haryana border in the last few days, prompting the Delhi Government to rush teams to the area to probe the incident.

Residents in the nearby Jhuljhuli village say fish in a pond in their village, around 150 meters from the drain, have also died. The incident came to light

on Saturday when a team of the forest and wildlife department was conducting a survey for tree plantation in the area. The number of dead fish

could be in lakhs. It could be due to the release of an exces-

sive amount of pollutants in the drain," a forest department official said on condition of anonymity.

The fish have died only in a five-kilometre upstream stretch of the drain between Rawta village in Delhi and Dhansa dam in Haryana. The banks of the drain are littered with dead, rotten fish and the stench has filled the area, a spot inspection by PTI revealed. No such incident has been

reported at Najafgarh Jheel, the second largest water body in Delhi-NCR after the Praveen Kumar, a resi-

dent of Jhuljhuli, said they have never seen something of this sort in the past.

"A massive number of fish

have died. All the fish in the demand (BOD) refers to the pond (in the village) have died too. It's been happening for the last three to four days, he said, pointing at the dead fish in the water body. We saw snakes scurrying

out of the water and entering houses. We do not know what led to it. It's a mystery, Kumar, who works with the Delhi Police, said. A senior official of the

Delhi Pollution Control Committee (DPCC) told PTI that a team collected water samples from the drain on Sunday morning. Tests are being conducted

to ascertain biological oxygen demand and dissolved oxygen levels and a report will be available in four to five days.

Biochemical oxygen

AAP, BJP trade charges over city's waterlogging woes

Ruling party says flooding result of MCD not cleaning drains, BJP holds PWD responsible

STAFF REPORTER ■ NEW DELHI

The AAP and the BJP on Monday traded barbs over the issue of waterlogging in the national Capital in the Delhi Assembly, with the ruling party saying the problem was a result of the Municipal Corporation Delhi (MCD) not cleaning drains and the latter holding the Public Works Department (PWD) responsible.

During the discussion on the first day of the Delhi Assembly session, Deputy Chief Minister Manish Sisodia said people are facing problems due to waterlogging in the city and the issue should not be politicised. The BJP rules the MCD the PWD is a Delhi Government agency.

He said nearly 2,000 km of the city drains come under the iurisdiction of the PWD and the remaining are maintained by the MCD and other agencies. "There is confusion among people over the jurisdiction of agencies. We cannot justify the PWD and the MCD in this House. It's a crime if any agency claims to have desilted a drain without actually having done it. If I come to know that PWD drain, action will be taken against the guilty,'

He also said that a "very poor system" has come up in MCD due to the unification of three municipal corporations. "Earlier, there used to be a director of local bodies of the Delhi Government but now, after making some new rules, they (unified MCD) have abolished that arrangement. Later, they said that Assembly cannot ask questions (on issues pertaining to MCD)," he added.

Countering the AAP, BJP MLA Jitendra Mahajan said the PWD is to be blamed for waterlogging in Delhi as it is responsible for maintaining all the big nullahs but does not clean them."The MCD has managed to clean smaller drains despite adverse financial conditions. There is corruption in desilting of drains (byPWD). A joint committee should be set up to ensure proper desilting of drains and there should be no politics over it," he said. BJP legislator Abhay Verma said,

"Why are only PWD roads waterlogged? The rainwater from smaller drains flows into bigger drains managed by the PWD that are clogged. As a result, the water spills over onto roads and underpasses.'

CCTVs installed to check waterlogging

 $T^{\text{he Delhi government has}}_{\text{installed CCTV cameras}}$ for constant monitoring of criticial waterlogging areas in the national capital. The Public Works Department (PWD) has identified 147 waterloggingprone areas, including seven critical locations from where report heavy flooding is reported every rainy season.

According to officials, there will be round-the-clock monitoring of the critical waterlogging points as the CCTV feed will be sent to the PWD control room and necessary instructions will be issued to lation of pumps and digging of the staff on the ground to tackle the situation.

These seven critical locations are -- IP State Ring Road near the WHO building, the underpasses at Minto Bridge, Pul Prahladpur, Zakhira, Okhla, Azadpur and the Jahangirpuri metro station

In view of the India Meteorological Department's (IMD) "orange" alert for heavy rains on Wednesday, authorities said elaborate arrangements such as constant monitoring of critical locations, strengthening of drains, instal-

recharge pits have been made to ensure that there is no waterlogging on the city roads.

An official claimed that except for Pul Prahladpur, no waterlogging was reported from the six other locations on June 30, when the city witnessed the first monsoon showers of the season.

LG seeks suggestions to make city self-sufficient in drinking water **STAFF REPORTER** ■ NEW

Delhi Lieutenant-Governor Vinai Kumar Saxena on Monday invited suggestions from the public to make the national Capital self-sufficient in meeting drinking water demand. "Instead of blaming others, let us together make the Capital self-sufficient by conserving water and augmenting our groundwater. Your suggestions & participation only will help us achieve this," the L-G tweeted.

The Lieutenant Governor said Delhi's water demands are unsustainable and there is a shortage of around 280 million gallons a day (MGD) of drinking water in the city. The capital depends on neighboring states for raw water: It gets 675 MGD of water from Haryana through two canals -- CarrierLined Channel (368 MGD) and Delhi Sub-Branch (177) and the Yamuna (65 MGD). Besides, 253 MGD of water is received from Uttar Pradesh through the Upper Ganga Canal, and the rest is drawn from ranney wells and tube wells installed across the city.

The Delhi Jal Board supplies 990 MGD of water to city residents. Delhi faced a severe water shortage this summer season with Haryana releasing less water in the Yamuna and the two canals.

Academy for Public Order to train RPF in crowd control

Hit by huge losses due to mob fury during violent agitations, including the recent protests against the Centre's Agnipath scheme for recruitment in armed forces, the railways has approached Meerutbased Rapid Action Force (RAF) Academy for Public Order (RAPO) to train the Railway Protection Force in crowd control, public order management and mob psy-

This is the first time that the Railway Protection Force (RPF), which is responsible for protecting railway property, will be trained to control

Officials said the responsibility has fallen on the force which has had to deal with large protesting crowds on several occasions over the last year. The training for the first batch of 182 personnel began at the academy on Monday, officials said. "At RAPO, we have trained state police and BSF jawans deployed for the United Nations mission, and we train



personnel after we receive a request from their organisations. We received a request from the railways and have started training their men. We primarily focus on training personnel on how to maintain public order and the use of non-lethal weapons. We discuss global and domestic case studies and also analyse mob psychology," said RAPO

Deputy Inspector General (DIG) Akhilesh Kumar Singh.

RAPO is an institute under the Ministry of Home Affairs and is the only riot control and public order management institute in the country. During the training focus is given on how to manage a mob in railway premises and prevent damage, he said. In recent years, the national transporter has suf-

fered huge losses during the Citizenship Amendment Act (CAA) protests, farmers protests, protests by students against anomalies in railway recruitment board exams. Barely a month ago, trains were set on fire in protest against the Centre's Agnipath scheme. During the schedule of the course, the personnel will be trained in crowd control,

freedom of speech and expres sion. He also pledged that he will work for the repeal of the sedition law. "To ensure a better future for all Indians, the Rashtrapati must work conscientiously. I pledge that, upon being elected as President,

I'll serve as an impartial custodian of the Constitution; not a rubber stamp for the government. I urge the BJP's candidate to make the same pledge," Sinha wrote on Twitter.
Posting the pledge to the

people of the country, he said, hereby affirm that India needs a Rashtrapati who serves as the impartial custodian of the Constitution and not a Rashtrapati. Will the BJP's candidate make the same pledge?"

Alleging that the ruling dispensation has unleashed "a poisonous communal propaganda to divide India's multireligious society", Sinha said, "I promise to all Indians that if elected as President, I shall uphold India's plural nature and the Constitution. I urge the BJP's candidate to make the same pledge." The Presidential polls are scheduled for July 18.

Understanding(MOU) has been signed between the Defence Innovation Organisation (DIO) and the Naval Innovation and Indigenisation Organisation (NIIO) to work on a collaborative project named SPRINT(Supporting Pole-Vaulting in Research and Development through iDEX,

NIIO and TDAC), navy officials said here on Monday. The Navy in conjunction with the DIO will unveil the problem statements for Indian Industries as part of iDEX(SPRINT) during the NIIO Seminar 'Swavlamban 2022' scheduled on July 18-19 at Dr. Ambedkar International Centre, New Delhi. The purpose of the

Seminar is to engage the Indian Industry and Academia towards achieving 'Self-reliance in Defence Sector.' Giving details about the NIIO, they said the Defence Acquisition Policy (DAP 2020) envisages creation of 'Innovation and Indigenisation Organisations (IIOs)' within Service Headquarters. Accordingly, the NIIO was launched on August 13, 2020 by Defence Minister Rajnath Singh. The NIIO is a three tiered mechanism headed by Vice Chief of Naval Staff. At apex level, the Naval Technology Acceleration Council (NTAC) has been constituted to bring together twin aspects of innovation and indigenisation and accelerate induction of disruptive combat technology into Navy so as to enhance war fighting capabil-

The NTAC meets every six months and gives apex level directives. It consists of ex-officio members as well as nominated members of technical expertise and standing, both from within Navy and civilians, scientists and industry.

'Unethical Shinde Govt won't win hearts and it will fall'

Bengal Chief Minister Mamata Banerjee on Monday presaged an early fall of the newly-formed Eknath Shinde Government in Maharashtra saying the BJP and the Shinde faction of Shiv Sena might have won by fabricating an "unethical and undemocratic" Government but they would fail to win the people's heart leading to their

Speaking at a media house conclave Banerjee said "this (Shinde) Government will not continue ... It's an unethical undemocratic government. They might have won the confidence vote, but they did not win the heart of the people of Maharashtra."

Alleging that the rebel Sena MLAs were given "money and other things by the BJP in Assam," where they were hosted in a five star hotel after they rebelled against Uddhav Thackerey, the Bengal Chief Minister said the BJP-led "unethical" alliances "can bulldoze democracy by misusing your power, but the people of this country will bulldoze you (them) using democratic means."

She said in the coming elections



(2024) elections would take place not to elect someone but to reject the BJP.

Apparently taking Home Minister Amit Shah head on for accusing her of running a dynastic government which would be uprooted by the BJP, Banerjee offered the example of Bangladesh Prime Minister Sk Hasina wondering who other than her could have been a better option to rule Bangladesh after Sk Mujibur

"What is this dynasty that they (read BJP) are talking about? After Sheikh Mujibur Rahman's death, Sheikh Handbasin took over the reins of Bangladesh. Who else could have done that," she said justifying the rise of her nephew Abhishek Banerjee the two-time Trinamool Congress

MP and party national general secretary. "What is the harm (in his being her successor)" she asked saying it was on the younger generations to take take charge after the older generations.

In an apparent reference to Shah she wondered how his son could become the BCCI secretary. "When someone becomes the top boss no one talks of dynastic politics but when rises up by working in the grassroots people start talking about dynastic culture."

On post post-poll violence in Bengal the Chief Minister said that there was no post poll violence in the State adding whatever violence that had taken place in the State was during when the administration was in the hands of the Election Commission of India.

She said "21 people died when ECI was administering the state ... but no one goes to Tripura when there is violence there .. how many persons went to Hathras in UP,"

BJP marches on

As the saffron juggernaut rolls on, the Oppn must do better than just making speeches

enior BJP leader Amit Shah's claim that the next 30-40 years will be the era of the saffron party should not be dismissed or downplayed by opponents as pure hyperbole or an assertion suggesting complacency. The BJP juggernaut under Prime Minister Narendra Modi and Shah seems unstoppable; indeed it is gaining momentum. This is extremely disconcerting for the Opposition and a large section of the intellectual class; for them, it's a nightmare come true. There have been highs (too numerous to be mentioned) and lows (eg, West Bengal last year) in the BJP's journey; but its rise has been secular — no pun intended. Some political and thought leaders may even try to see complacency in Shah's statement, though there



is none. He is not among those who like to rest on their laurels; for him, laurels are never enough; there is always need for more. Winning a State is not enough; the number of BJP's MLAs and MPs from the State should rise further; and after every rise, the Modi-Shah duo look for another rise. They fight for not just the 543 Lok Sabha seats, but also every Rajya Sabha seat, every State, even municipalities. The duo has excised complacency from the BJP genes. It is a new BJP, not that of Atal Bihari Vajpayee and LK Advani. This is not to say that the Vajpayee-Advani BJP was lethargic and laidback; quite the contrary, it has always been extremely

active, vocal and enthusiastic

Even in the late 1980s, when the saffron party was reduced to two seats in the Lok Sabha, there was no let-up in its activity; its leaders continued to make their presence felt even though the Congress had over 400 members in the Lok Sabha. Whatever else the BJP's opponents say about it, they can't fault it for being slack or slothful. Under Modi and Shah, the saffron party has been further galvanised. Not many parties show the kind of energy, purpose and drive when out of power that the BJP does; and the Congress, which can boast of all-India presence, is certainly not that party. It bounced back to power in 1980 because the Janata Party fell under the weight of its own contradictions. Ditto with another experiment, involving Janata Dal, which was repeated a decade later. In 2004 too, the 'grand old party' came to power not because its leaders sweated it out on streets to win a landslide against the BJP — in fact, it got just seven seats more than the BJP's — but because the saffron party's messaging was awful and it could not get the RSS' support during campaigning. Against this backdrop, Shah's claim doesn't seem improbable. If the GOP and other Opposition parties want to oust the BJP, they must do more than making fiery speeches and viral tweets. They must come up with something that is politically feasible and electorally possible. They have to stir out of their complacency.



Clear & present danger

Five types of extreme weather events are linked to human-induced climate change

If any further proof of the omnipresent climate change conditions playing havoc with our planet's ecology and nature was needed, here it is! For some time, the science of attribution has led to major advances in linking the impacts of extreme weather and human-caused climate change, but large gaps in published research still obscure the full extent of damage from climate change. A new report published last week in the first issue of *Environmental Research: Climate*, a new academic journal, quoted researchers from the University of Oxford, Imperial College London and the Victoria University of Wellington reviewing the impacts of five different types of extreme weather events and to what degree these damaging events could be attributed to human-induced climate change. To do this, they combined information from the latest Intergovernmental Panel



tion studies — where weather observations and climate models are used to determine the role that climate change played in specific weather events. They found that for some extreme weather events, such as heat waves, the link with climate change is clear and unequivocal across the world, and that the extent of the impacts is likely being underestimated by insurers, economists and Governments across the globe.

For others, such as tropical cyclones, the study shows that important differences exist between regions and the role that climate change plays in each event is more variable than for heat waves. There is an urgent need for more data from lower- and middle-income

countries, where the impacts of climate change are more strongly felt. Research on these impacts is hampered when national weather data is not publicly available — examples include South Africa and India. A case in point would be the ongoing southwest monsoon. While it has staged a smart recovery and the Indian Meteorological Department has predicted enhanced rainfall alert in Konkan, Goa, Gujarat and Odisha, several States still have not been able to cover the shortfall due to a weak start in rains. These are largely concentrated in the central, north-western parts of the country, and Bihar and Jharkhand in east India, besides parts of Tamil Nadu and Kerala, the last named being usually the first State in the Indian subcontinent to welcome the southwest monsoon. It's time to wake up to this very real danger which affects everybody. Everybody!

Legal panacea for ills of sex workers



Even after the Supreme Court judgment uphold the dignity of sex workers, a lot more needs to be done on the ground to ensure they really lead a dignified life

he Supreme Court recently upheld 'sex work' as a profession and issued a slew of directions to uphold the dignity of sex workers. However, the term 'sex worker' quoted in the landmark judgment as well as used otherwise appears to be impolite and offensive. Being one of the oldest professions, there are hundreds of names globally associated with the 'disgraced' professionals, to mention a few: courtesan, tawaif, drab, hooker, hustler, moll, tart, kasbi, randi, kunchni, paatar, patariya, beswa, vaishya, kaveri and ganika.

Not branding them as 'sex workers' or 'prostitutes', I would prefer to call them with some ighter term such as 'Bobby' or at the most 'tawaif' for the simple reason that if you intend to give dignity to a profession, you need to begin that expression with a suitable title or nomenclature, not only to redefine the nature of job but to remove the prevalent 'scarlet letter'.

The landmark judgment, besides being historic, was necessary because India is no stranger to sex work. It is a historically prevalent profession, albeit under unsafe conditions. Leonard William King, in the Code of Hammurabi, says, in 1780 BC, out of 282 Hammurabi codes, six codes (178, 179, 180, 187, 192, 193) mentioned the rights of a prostitute or her children. In 1075 BC, the Code of Assura distinguished prostitutes from other women by prescribing a dress code. Sarah B Pomeroy in Ancient Greece — A Political, Social and Cultural History (1999) mentions: "Hetaira a 'female companion'was the term normaly used for courtesans by classi-

WC Firebaugh, who translated Petronius Arbiter's work, The Satyricon, referred therein Roman Regulation of 80 BC, which states: Rent from a brothel was legitimate source of income... In ancient India, there was the

practice of rich people asking for 'Nagar vadhu' (bride of the town) to sing and dance. The State courtesans were described as 'Vaishali ki nagar vadhu'. Amrapali was one such example. Writing about 19th century Awadh (Lucknow), Adrian McNeil of Macquarie University observed that courtesans had royal patronage and were "well provided for". There were many examples in Lucknow where tawaifs left their profession and married respectable persons. However, a man in love with a prostitute had to shell out a hefty amount to the owner of the brothel for the release of his beloved.

Over the years, people have debated whether this profession should be legally sanctified. In India, nearly three million tawaifs, with an overwhelming majority in the age group of 15-35 years, are operating. The demand for minors increases year on year and such demand is highest among older clients. To address these nightmarish phenomena, the Supreme Court took a lead in regulating and humanising sex work in the case of Budhadev Karmaskar Vs The State of West Bengal & Others dated May 19, 2022. In July 2012, the court while appointing a broad-based committee had formulated three questions:

bilitation of sex workers who wish to leave the work; and conditions conducive for sex workers who wish to continue, with dignity. The order dated May 19, 2022, adds: "After conducting a detailed discussion with all the concerned stakeholders, the panel submitted a comprehensive report on the terms of reference. When the matter was listed in 2016, this court was informed that the recommendations made by the panel were considered by the Government of India and a draft legislation was published incorporating the panel's recommendations. Thereafter, periodically adjournments were taken by the Union of India on the ground that a Bill is on the anvil. As the legislation has not been made to date even though the recommendations have to be implemented, we were exercising our powers conferred under Article 142 of the Constitution. In the catena of decisions of this court, this power has been recognised and exercised if need be, by issuing necessary directions to fill the vacuum till such time the legislature steps in to cover the gap or the executive discharges its role." This matter has been listed for July 27, 2022.

The exercise started after the judgment dated August 2, 2011, headed by Justice Markandey Katju, initiating its order dated February 14, 2011. By that order, the court dismissed the appeal of the appellant, who was convicted for murdering a sex worker in a red light area in Kolkata. The court suo moto converted the

case into PIL in order to

address the problems of sex

workers. In its order of February 14, 2011, the court observed: This is a case of brutal murder of a sex worker. Sex workers are also human beings and no one has the right to assault or murder them. A person becomes a prostitute not because she enjoys it but because of poverty. Society must have sympathy towards sex workers. They are also entitled to a life of dignity in view of Article 21 of the Constitution." However, despite the court's best intentions, there are many gaps to be addressed for which the Immoral Traffic (Prevention) Act, 1956, needs complete overhauling in a time-bound manner. Also, the order is silent on the issues of call girls and hetero-male prostitution (gigolos). Such issues have not been discussed in the juagment.

"In this world, there are two types of living beings, possessing either divine or demonic qualities. (16.6) Each person will have either the preponderance of divine or demonic qualities. Some of the divine qualities are purity of heart, charity, austerity, truthfulness, not given to anger, peacefulness, uncomplaining, modesty, hygienic and non-violent. (16.1-3) Demonic qualities are deceitful behaviour, arrogance, sense of being doer, anger, cruelty and ignorance. (16.4)

So, there will be people with dominant bad qualities. They cannot be avoided. Then, what should we do? Reform the bad ones. This is not possible, because everyone has individual nature based on qualities. One will only change when one wants to. This is the reality of life, and complaining gets us nowhere. How do you manage? Firstly, accept that there will be bad people one has to deal with. This is the reality of this world, which is an impermanent place of miseries. Lord Krishna has made this very clear in the Geeta, when He stated, "The contact between senses and their objects are givers of cold, heat, pleasures, and misery. What will give relief is not to get agitated or complain about them when sufferings do come, but use superior intelligence to do something about them. (2.56) What is this intelligence? Stable trading worse than horse-trading



A handful of party leaders cannot be allowed to trump the wishes of people and remove MPs, MLAs from the Houses

dhe recent political drama in Maharashtra brought the antidefection law into focus. Some analysts want it to be made more effective or stronger. The truth, however, is that this is one of the most illiberal pieces of legislation ever enacted; and it has done immense harm to democracy.

The votaries of the anti-defection law say that there should be an end to what is derogatorily called Aaya Ram-Gaya Ram politics. How can a Member of Parliament (MP) or of legislative assembly (MLA) vote against the party on whose ticket he or she won the election? Isn't it a betrayal of the party that had reposed its trust in him or

Yes, it is, and the party has all the rights to deal with the disobedient lawmaker; it can expel them. But it has no right to expel them from the Lok Sabha or the Vidhan Sabha, for it was the people who sent them there, not the party. The mandate of the people cannot be nullified by the whims and fancies of party bosses, however high and mighty they might be. The legislators enter the legislature because people, not the top party leaders, want them there. A handful of party leaders and managers cannot be allowed to ride roughshod over the wishes

The supporters of the anti-defection law say that horse-trading is an abomination, and it should be stopped. The much bigger and far uglier abomination, however, is stable trading. This is what we have seen after the enactment of the law.

To put it in other words, horse-trading is far less bad than stable trading. If your MP or MLA doesn't represent you properly in the legislature, you can question them, but if they have to follow the party whip on important issues, you can't blame them because blame presupposes free will, which they are deprived of by top party leaders.

The anti-defection law is evil because, by disempowering MPs and MLAs, it has killed the very idea of representation in a parliamentary democracy. An illustration will make it evident: A major issue, say, extreme water pollution plagues your area. People in your locality campaign for a corrective measure; they tell the MLA about the problem; and they promise to help you. In the legislative assembly, the issue is brought up, but the MLA is forced—'whipped'—to vote against the corrective measure.

When you confront the MLA, they tell you that they were bound to obey the whip; they couldn't vote for you because that would have breached party discipline. What kind of representativeness is this in which your elected representative can't take your problems to the government which, by the way, exists because of the support of elected representatives like yours?

Technically, in the parliamentary form of democracy, the executive is responsible to the executive; in practice, though, it is the other way around. MPs and MLAs have to obey the dictates of their respective party

democracy How did we reach here? The original sin was the 52nd amendment to the Constitution in 1985, the anti-defection law in common parlance; it made MPs and of MLAs the slaves of party bosses. The Statement of Objects and Reasons of the Fifty-second Constitution Amendment Bill, 1985 read: "The evil of political defections has been

not combated, it is likely to undermine the very foundations of our democracy and the principles which sustain it." The new legislation, ostensibly enacted to end "legislative anar-

chism," provided that a lawmaker would cease to be a member of the legislature: if he resigns from the party on whose ticket he was elected; if he votes, or abstains from voting, in the House "contrary to any direction" issued by the political party to which he belongs; or if he has been expelled from such political party "in accordance with the procedure established by the Constitution, rules or regulations" of such party.

The author of the law, the then

law minister Asoke Sen, claimed that it would "cleanse the political life of this country of the dirt accumulated over the years." Corruption in politics will end with this law.

One need not be a political analyst to know that venality and unscrupulousness have increased since the law was enacted. The remedy has proved to be infinitely worse than the malady. Indeed it engendered another malady the enslavement of elected representatives.

It is interesting to notice that the Opposition at that time resisted the Bill. L.K. Advani of the Bharatiya Janata Party (BJP) was prophetic in his lamentation that this would "muffle dissent forever in a party like the Congress(I)..."

It is another matter that when his party was in office in 2003, and he was deputy prime minister, the BJP-led government decided to make the law even more stringent. The 1985 law recognized a "split" in a party if at least one-third of members of the legislature party decided to form or join another political party. The BJP-led government, however, introduced the 91st amendment to the Constitution in 2003, making the requirement for split or merger stiffer: since then, at least two-thirds of members of a legislature party need to leave the party. Evidently, Ádvani & Co forgot the 'muffle dissent' rhetoric.

Hypocrisy, however, is not the monopoly of the BJP. Speaking at the Kerala Literature Festival in Kozhikode, Kerala, on February 5, 2017, Congress MP and former Union minister Shashi Tharoor said the anti-defection law negatively impacted democracy as it diminished the voting power of people's representatives. "The anti-defection law has a negative impact on democracy. A people's representative does not have the right to vote according to his conscience. He has to vote on what his party says," PTI quoted him in its report.

Kapil Sibal, a senior leader who recently quit Congress, also wants tne anti-detection law to go. Alas, it didn't occur to him when held the law portfolio.

The same old story: introduce illiberal laws when in power, and slam such legislation when in the Opposition. Meanwhile, liberty gasps for breath in politics—as else-

Single use plastic ban success is suspect without options

Single use plastic ban has come in force, but lack of viable alternatives suggests that past lessons aren't learnt

Single use plastic ban has come into force in India from July 1. In its commitment towards global climate goals, the government has implemented its notification banning identified 19 single use plastic (SUP) items. The violation of the ban is expected to invite penalties and jail terms as well under the Environment (Protection) Act 1986. Single use plastic items are those that are used once and discarded. They have high littering potential and high degree of nonbiodegradability. The government has issued immediate directions to all States to curb supply of the banned finished goods and prohibit the petrochemical industries from supplying raw materials such as polystyrene used in producing



The blanket ban on the 19 SUP items is a welcome move that promises to deliver relief to the environment and wildlife. The styrofoam cups, plates and plastic spoons and forks have long been an eyesore all around our cities, parks, beaches, railway tracks and even wildlife sanctuaries. In fact, the landfills across India are replete with SUPs that will not biodegrade even in the next 400 years. India generates 3.5 million tonnes of plastic waste a year, which is 3 kg of per capita plastic waste per year. During 2020-21, India generated 41,26,997 tonnes of plastic waste. Considering these staggering figures, it is apt for the government to launch the initiative. But is India ready, and more importantly, will the ban work this time?

Restrictions on SUPs have been attempted in India as long back as 1999 when the sale of polythene bags was prohibited. Since then a plethora of national and state level laws have been enacted and implemented. However, the last 22 years are a testament to the fact that we still have plastic cutlery and many other SUP items freely available in the market. Till date, the centre had encouraged the states to phase out the SUPs but the states' efforts were largely ineffective and SUPs thrived as always. The cause of the earlier SUP futile ban is always attributed to lax enforcement which took place in fits and starts. The current ban seeks to address this loophole and may to a large extent resolve the ineffective enforcement issue. But the real



cause for failure of the SUP ban in the past has not been lax enforcement alone. The lack of sustainable alternatives to SUPs has been the major cause for the ban to remain ineffective and before long one could see resurgence of the SUP items in daily life.

The government seems to have put its weight behind enforcement of the SUP ban raw materials either. The gov-

notification and its rules and paid less attention to the impact and viable alternatives for the industry and the people. Consequently, there's a serious gap on ways and means of replacement of the single use plastic, which stands prohibited in a large part of the country, barring a few days of relaxations given at some of the places. An unrealistic time frame given for phasing out these single use plastic products means that the industrial houses in the country have been unable to research and develop practical and affordable solutions for the single use plastics. As a result, there is a dearth of manufacturing capacities of the alternatives to the single use plastics and no set supply chains are available for their

ernment could have opted instead to stagger the ban and used the time to develop a parallel line of eco-friendly products that would seamlessly have taken over the SUP slots. This would not only make the ban more successful but would have also saved the employment of scores of people engaged in production of SUPs and the capital of industries that has been invested into the production machinery.

India needs to move towards a complete plastic free future and this cannot be possible in a short time. The government cannot and must not directly or indirectly support the plastic industry, while it bans SUPs as this will tantamount to taking two steps forward and one step backward. The Indian plastic industry towards adopting alternative materials on one hand and incremental staggered ban on plastic items must be applied in every quarter on the other hand to discourage the production and use of plastic items. In this balanced manner the government can actually phase out plastic from daily life. Some exceptional uses can be allowed such as for medical and defence purposes. For a better environment,

the people will fervently hope for the latest ban on SUPs to succeed. But there are lessons from the past failures, which must not be repeated. The government should enforce the ban effectively, while also making available the affordable alternatives to the shopkeepers and the consumers.

No fuel, no cash: Lanka keeps schools closed

Sri Lanka's opposition Janatha Vimukthi Peramuna (JVP) on Monday urged the government to share the details of an alleged bomb threat as outlined in a reported communique between the police chief and the defence ministry secretary ahead of the Black Tiger day marked by the LTTE

JVP leader Anura Kumara Dissanayake told reporters that Police chief CD Wickremaratna had addressed Defence Ministry Secretary Kamal Gunaratne by a letter dated June 27 and alerted him to the alleged threat.

Dissanayake claimed that an unidentified foreign intelligence service was to carry out an explosion in either the north and east regions or in the south to mark the Black Tiger day on either July 5 or 6. He, however, did not name the foreign agency.

Accordingly, all employees of foreign establishments located in Jaffna and VIPs have been advised to stay indoors on the two days, according to the information provided by the police chief to the defence ministry secretary in the said

Dissanayake urged the government to provide full details as to how the information came to be gathered or if this was an attempt by the government to curb the raging public protests against it over the current economic and fuel cri-

He said it was too early to speculate on the motive for the shooting, which happened in the late afternoon at Field's, one of the biggest shopping malls in Scandinavia, located on the outskirts of the Danish capital.

"We have several dead and several injured," Thomassen said, though he gave no specific casualty count. He said the suspect was an "ethnic Dane," a phrase typically used to mean someone is white.

A 101-year-old man who was convicted last week as an accessory to murder for serving as a guard at a Nazi concentration camp during World War II has appealed, a Ğerman court said Monday. The man, whom local

media have identified as Josef S., was convicted last Tuesday of more than 3,500 counts of accessory to murder and sentenced to five years in prison.

He had denied working as an SS guard at the Sachsenhausen camp and aiding and abetting the murder of thousands of prisoners. But the Neuruppin state court concluded that he did in fact work at the camp on the outskirts of Berlin between 1942 and 1945 as an enlisted member of the Nazi Party's paramilitary wing.

British military authorities are trying to find out who hacked the army's social media accounts over the weekend, flooding them with cryptocurrency videos and posts related to collectible electronic art.

The investigation was launched after authorized content on the army's YouTube account was replaced with a video feed promoting cryptocurrencies that included images of billionaire Elon Musk. The Army's Twitter account retweeted a number of posts about non-fungible tokens, unique digital images that can be bought and sold but

have no physical counterpart.

"Apologies for the temporary interruption to our feed, the army said in a tweet posted after the Twitter account was restored on Sunday. "We will conduct a full investigation and learn from this incident. Thanks for following us, and normal service will now resume.

The Ministry of Defense said late Sunday that both breaches had been "resolved."

While internet users were unable to access the Army's YouTube site on Monday, a spokesperson said the site was down for standard maintenance. The Twitter feed was operating normally.

Japan spots Chinese, Russian warships near disputed islands

AP ■ TOKYO

▼apan protested to Beijing after spotting Chinese and Russian warships just outside its territorial waters around the disputed East China Sea islands on Monday.

Japan's Defense Ministry said a Chinese frigate sailed inside the "contiguous zone," just outside Japanese territorial waters around Senkaku Islands, which Beijing also claims and calls the Diaoyu, for several minutes Monday morning.

The Chinese warship's presence was confirmed about 40 minutes after a Russian frigate had entered the waters for more than an hour, the ministry said. It was not immediately clear

Chinese-Russian military activity in the area. Japanese defense officials mentioned a possibility that the ships may have been there to avoid a typhoon. Deputy Chief Cabinet

Secretary Seiji Kihara said Japan lodged a protest expressing 'grave concern" to Beijing over the incident. "The Senkaku islands are an inherent part of Japan's territory historically and under international law. 'The government will deal

with the matter calmly but firmly to protect the Japanese land, territorial waters and air space, Kihara said. There was no violation of the territorial waters, he

In Beijing, China justified the frigate's entry and criticized what was behind the latest Tokyo's protest. Chinese Foreign

Ministry spokesperson Zhao Lijian said the islands are Chinese territory. The activities of Chinese

vessels in waters nearby are lawful and justified," he said at a regular news conference. "Japan has no right to make such irresponsible remarks. Japan sees China's increas-

ingly assertive military activity in the East and South China seas as threat to regional stability. Toyo is especially sensitive to Chinese activities near the disputed islands.

Kihara said that Monday's incursion into the contiguous zone, which is between the territorial sea and the wider exclusive economic zone, by the Chinese warship was a fourth such event since June 2016.

Govt committed to 6.4% fiscal deficit target for 22-23: Sources

ndia's macroeconomic fundamentals are strong to deal with global challenges and the central government is committed to sticking to the fiscal deficit target of 6.4 per cent of the GDP for the current fiscal, official sources said on Monday. The government is taking steps to deal with the spiralling crude oil prices in the international market, the sources said.

India meets nearly 85 per cent of its oil demand through imports and a weaker rupee makes imports costlier.

Commodity prices, including of crude oil, are ruling high due to the ongoing Russia-Ukraine war and have led to inflationary pressures across countries, including India.

The government is committed to adhering to the fiscal consolidation path and the Budget this year has pegged the fiscal deficit at 6.4 per cent of the GDP, sources said, adding that steps are being taken to address the situation arising out of rising crude oil prices.

While acknowledging that there are strong global head-winds, the sources said the country's macroeconomic fundamentals are strong enough to deal with challenges



Sources said that the current account deficit (CAD) is expected to be high as crude oil prices are high.

For the past several years, sources said, India had low CAD but this year there is headwind on that front. However, the macroeconomic situation and forex reserve are better than in the past.

On the rupee depreciation, sources said the dollar is appreciating vis-a-vis all other currencies and appreciation vis-a-vis rupee has been the least among the peers.

There is no comfortable level for the rupee in mind but market forces would decide the stable value, sources said, adding that monetary authority does intervene in the forex market to smoothen out sharp

Asked about the government's recent measures to impose taxes on fuel and gold, sources said the government is taking a part of the windfall profit from unexpectedly high

imposed a Rs 23,250 per tonne tax levied on crude oil produced domestically.

Highest 28% GST on luxury, sin goods to continue: Revenue Secy

PTI NEW DELHI

The Government intends to **L** continue with the top GST slab of 28 per cent for luxury and sin goods, but is open to discuss narrowing down the three slabs of 5, 12 and 18 per cent into two, Revenue Secretary Tarun Bajaj said on Monday.

Addressing the industry leaders, Bajaj said the rate rationalisation exercise of the GST Council is a result of introspection of GST, five years after its rollout, and the policymakers do not have a "fetish" to raise the tax rates to the revenueneutral level of 15.5 per cent.

On the industry demand for bringing petroleum products under GST net, he said part of their revenues, both the Centre and states have some apprehension. "We will have to wait for some time.'

"Of the 5, 12, 18 and 28 per cent, we would have to confinue with 28 per cent because in a developing economy, in an economy with so much of income disparity, there would be some luxury and sin items that would and should attract a higher rate of taxation.

But, whether on 5, 12 and (per cent), we can bring down to 2 rates to start with and then see how the country grows and whether there is a capacity to bring it to one rate or not is something to be seen. It is a very difficult challenge," Bajaj said at an Assocham event. Under the GST, a four-rate

structure that exempts or imposes a low rate of tax of 5 per cent on essential items and a top rate of 28 per cent on cars is levied. The other slabs of tax are 12 and 18 per cent. Besides, there is a special 3

per cent rate for gold, jewellery and precious stones and 1.5 per cent on cut and polished diamonds.



Italy's Jannik Sinner stunned Spanish teenager Carlos Alcaraz to reach the Wimbledon quarter-finals for the first time.

The 20-year-old triumphed 6-1, 6-4, 6-7 (8/10), 6-3 to become the youngest man in the last-eight since Nick Kyrgios in 2014.

Sinner had never won a grass court match until this year's Wimbledon.

But now he goes on to face defending champion Novak Djokovic for a spot in the semi-finals.

The 10th-seeded Italian needed six match points to seal the deal while 19-year-old Alcaraz was left to regret failing to convert six break points in the fourth set.

"Carlos is a very tough opponent and a nice person. It's always a huge pleasure to play him," said Sinner after making the quarter-finals of a Grand Slam for the third time.

Sinner swept through the first two sets and appeared on course for a routine win until Alcaraz played a thrilling third set tie-break.

The Spaniard saw three set points come and go before having to save two match points, the second of which came courtesy of wanted to be a trailblazer for "I wish I could really give
