# **Emergency in Lanka as Prez flees to Maldives**

Rajapaksa, who had promised to resign, appointed PM Ranil as acting President hours later; thousands of protesters defy emergency

**S**ri Lanka declared a state of emergency on Wednesday as angry protesters stormed the Prime Minister's office in Colombo, hours after President Gotabaya Rajapksa fled to the Maldives on a military jet, amid the country's worst economic crisis in decades

Rajapaksa, the 73-year-old leader who had promised to resign on Wednesday, appointed Prime Minister Ranil Wickremesinghe as the acting President hours after he fled the country, escalating the political crisis and triggering a fresh wave

Announcing that Rajapaksa has appointed Wickremesinghe to act to perform his functions Speaker Mahinda Yapa Abeywardena said he has informed him over the telephone that he will resign today as promised. The Speaker also said the vote for the new President will take place on July 20. In a special televised statement, Wickremesinghe declared a nationwide emergency and imposed a curfew in the city and surrounding areas. "We must surrounding areas. end this fascist threat to democracy. We can't allow the destruction of state property. The President's Office, the President's Secretariat and the Prime Minister's official residence must be returned to proper cus-

'Those who are in my office want to stop me from discharging my responsibilities as acting President. We can't let them tear up our Constitution. We can't allow fascists to take

over. Some mainstream politicians, too, seem to be supporting these extremists. That is why I declared a nationwide emergency and a curfew," Wickremesinghe said.

He said he has instructed the security forces to enforce the emergency and curfew to bring the situation to normalcy, adding that a committee comprising the heads of armed forces has been given the responsibility of doing so with zero political intervention.

However, the development enraged anti-Government protesters, who wanted both the President and Prime Minister to quit over mishandling the economy. Thousands of protesters waving Lankan flags defied the emergency and surrounded the building of the PM Office. The police fired tear gas on protesters who broke through a barricade and stormed the Prime Minister's office, calling for his resignation.

Wickremesinghe said he was alarmed by the inputs received by the Intelligence services.

"Despite the President leaving, and measures taken to elect a new President, some groups in the struggle have organised to take over the Prime Minister's Office, and surround the Air Force Commander's residence for providing an Air Force plane for the President to fly to the Maldives. They had also decided to surround the Navy Commander's residence and Army Commander's residence. These groups tried to obtain control of the country," he added. Sri Lanka's state owned television channel Rupavahini briefly suspended

its telecast on Wednesday as protesters stormed the building. Also, a second state television channel went off the air, less than an hour after Rupavahini suspended its operations.

Earlier, a statement from the Sri Lanka Air Force said that Rajapaksa left the country along with his wife and two security officers on a military jet and added that it was done with approval from the Ministry of

#### **Govt of Maldives faces flak for helping Gotabaya**

MALE: Sri Lankan President Gotabaya Rajapaksa's escape to the Maldives was negotiated by the Maldivian Majlis (Parliament) Speaker and for-mer President Mohamed Nasheed, sources in the Maldives Capital Male said. The Maldivian Government's argument is that Rajapaksa is still the President of Sri Lanka,

and that he hasn't resigned or

handed over his powers to a successor. Therefore, if he wanted to travel to the Maldives, it could not have been denied, sources said.

The Maldives Government has not yet officially commented on his presence in the island nation. However, the Maldives National Party (MNP) leader and former Maldives Foreign Minister

Dunya Maumoon said it was very disappointing that the Maldivian Government did not care about the sentiments of the Sri Lankan people.

'My party will move a motion in parliament seeking the Government's explanation in the matter," Maumoon, the daughter of former Maldives president Maumoon Abdul Gayoom, told *PTI*.

### Oppn asks PM Ranil to quit ahead of Prez's resignation

Sri Lanka's Opposition leaders have asked Prime Minister Ranil Wickremesinghe to quit ahead of the resignation of President Gotabaya Rajapaksa who has promised to step down on Wednesday, according to a media report. President Rajapaksa is likely to leave for Singapore later on Wednesday, the Daily Mirror reported, citing sources in the Maldives.

He is likely to send his resignation letter only after reaching his final destination on Wednesday evening, Sri Lanka's The Morning news portal reported, citing highly placed Government sources.

The Tamil National Alliance (TNA) MP MA Sumanthiran said on Wednesday that the decision was taken at an all-party meeting which was attended by leaders excluding those from the Government, News 1st channel reported. He said two unanimous decisions were taken at the meeting, and one was for Wickremesinghe to resign immediately, while the other was for the Speaker to sack the

Whip Lakshman Kiriella from the Samagi Jana Balavegaya said the Commanders of the threearmed forces were also present at the meeting. "The Prime Minister was

avoiding the party leaders," he said. The Commanders informed that the protesters were near the gates of Parliament, and wanted permission to repel them by using force, he said. "We said we cannot agree to such a request," he said, adding that at the last party leaders meeting the call was for the President and the Prime Minister to resign.

The leaders have asked the

Speaker to sack Wickremesinghe to take up the post of Acting President, and thereafter Parliament is prepared to work with him. Wickremesinghe on Wednesday asked Speaker Mahinda Yapa Abeywardena to nominate a Prime Minister who is acceptable to both the gov-

ernment and the Opposition. In a statement, the Prime Minister's Office said that Wickremesinghe held a meeting with the Members of the Cabinet at his office. All the Ministers were of the opinion that as soon as there is an agreement to form an all-party Government, they will hand over the responsibilities to that Government.

### Chinese firm charged with ₹4,389 cr duty fraud

### show cause notice to mobile major Oppo India

The Directorate of Revenue Intelligence (DRI) has issued a show cause notice to Chinese mobile company, Oppo India, demanding Customs duty amounting to ₹4,389 crore.

The notice also proposes relevant penalties on Oppo India, its employees and Oppo China, under the provisions of the Customs Act, 1962. The DRI detected Customs duty evasion of around ₹4,389 crore during an investigation against Oppo



Mobiles India Private Limited, a subsidiary subsidiary company of Guangdong Oppo Mobile Telecommunications Corporation Ltd., China.

Oppo India is engaged in the business of manufacturing, assembling, wholesale trading, distribution of mobile handsets and accessories across India. Oppo India deals in various brands of mobile phones, including Oppo, OnePlus and Realme.
"During the investigation, the

DRI conducted searches at the

agement employees, which led to the recovery of incriminating evidence indicating willful misdeclaration in the description of certain items imported by Oppo India for use in the manufacture of mobile phones," said an official statement issued by the

Union Finance Ministry. This mis-declaration resulted in wrongful advantage of ineligible duty exemption benefits by Öppo India amounting to ₹2,981

### 'Udaipur killers were in touch with Pakis, 300 radicals in India'

Apreliminary probe into the Udaipur beheading case has revealed that the two prime accused - Riyaz Akhtari and Ghouse Mohammad — were in communication with 18 Pakistani mobile numbers and as many as 300 suspected "rad-

icals" across 25 States in India. Out of these 300 people with whom the two prime suspects were in touch, nearly 250 are from Maharashtra alone and the remaining are from Gujarat, Kerala, West Bengal and Bihar,

sources said. The agencies are scanning the bank accounts of these 300 suspects for any dubious transactions. Also, initial findings suggest the 300 suspects could be

part of the sleeper cells of Pakistani terrorist group Dawat-e-Islami and awaiting instructions for inimica

actions, they said. Some of these 300 suspects were in touch with the Pakistani mobile phone numbers with which the two prime accused in the Udaipur beheading case were also communicating.

These initial findings have also been corroborated with the analysis of the call detail records of the seven arrested accused in the Udaipur case.

Sources said the two prime accused in the beheading case were curious to know about the quantum of punishment they would face and if death penalty was inevitable.

### Free Covid booster jabs for 18-59 age group from July 15

oncerned that less than one Oper cent of the target population of 77 crore in the 18-59 age group has been given the pre-caution Covid jab, the Centre has decided to launch a 75-day drive from July 15 to provide the segment free booster doses at all its vaccination centres in India.

The drive, aimed at boosting the uptake of Covid booster doses, will be held as part of the Government's 'Azadi Ka Amrit' Mahotsav to celebrate the 75th anniversary of India's Independence, Union Health Minister Mansukh Mandiviya

"Less than one per cent of the target population of 77 crore in the 18-59 age group has been given the precaution dose.



However, around 26 per cent of the estimated 16 crore eligible population aged 60 and above as well as healthcare and frontline

workers have got the jab.
"A majority of the Indian population got their second dose over nine months ago. Studies at ICMR and global research institutions have suggested that antibody levels wane around six months after the primary vaccination with both doses... Giving a booster increases the immune response," an official from the Union Health Ministry said.

### No blanket ban on demolitions: SC

Omnibus order impossible as law must be followed, court tells

Ulama-i-Hind

The Supreme Court on Wednesday refused to pass a blanket order restraining authorities from carrying out demolition exercises if there is an illegal construction and the corporation or the council is authorised to take action.

The top court was hearing pleas filed by the Muslim body Jamiat Ulama-i-Hind seeking directions to the Uttar Pradesh (UP) Government and other States to ensure that no further demolition of properties of alleged accused in recent cases of



violence is carried out.

'What omnibus directions can we issue? Nobody can dispute that the rule of law has to be followed. But can we pass an omnibus order?

"If we pass such an omnibus order, will we not prevent the authorities from taking action in accordance with law," a Bench of Justices BR Gavai and PS Narasimha said

Claiming that the issue was 'extraordinarily serious", senior advocate Dushyant Dave, who appeared for the Jamiat Ulamai-Hind, referred to a newspaper report which said that the house of a murder accused was demolished in Assam.

"We don't want this culture. Lordships will have to decide for once and all. They have to act in accordance with the law. They cannot take advantage of municipal laws and demolish houses of someone who is merely accused

This country cannot permit this. We are a society governed by the rule of law which is the basic structure of the Constitution. It should be finally heard and disposed of," Dave said while seeking an interim stay

direction on the demolitions. Alleging that there was discrimination in carrying out such

exercises, Dave submitted there is no material to show that other unauthorised houses of other communities were acted against similarly. Senior advocate CU Singh, also appearing for one of the petitioners, said despite the status quo order in Delhi's Jahangirpuri, the same modus operandi was followed in city after city.

Solicitor-General Tushar Mehta said he has some objections with the locus of the petitioners. "Replies have been filed by authorities that the procedure was followed and notices were issued. The demolition process started much before alleged riots. Merely because you take part in riots does not give you immuni-ty from illegal constructions being demolished.

"Affected persons have already taken their remedy before various high courts. Let us not create a sensationalising hype unnecessarily," Mehta said. He opposed Dave's submission. and said all communities are Indian. "We cannot have community-based PILs," he said.

senior customs official. However, Manjit had slipped out of the airport by then. "Jaswinder Kaur was also an active participant in the smuggling plan and helped remove and destroy the tags of both the trolley bags containing 45 guns having an approximate value of ₹22.5 lakh," said the senior cus-

toms official. "Both of them have confessed to their previous involvement in smuggling 25 pieces of assorted guns from Turkey with an approximate value of ₹12.5 lakh," said the customs official

"The two trolley bags along with the recovered guns were seized and the couple was placed under arrest under Section 104 of the Customs Act," the official added. Officials said the couple is

suspected to be smuggling these guns to supply to criminals in India.

The agencies are probing how the couple cleared security check with so many guns while leaving Vietnam.

### **SC** lays down principles for courts in search, seizure matters under I-T law

In a significant verdict, the Supreme Court on Wednesday laid down principles for high courts in matters of search and seizure under Income Tax rules, and said formation of opinion and reasons to believe recorded by revenue department is not a judicial or quasi-judicial function, but administrative in character.

A bench of Justices Hemant Gupta and V Ramasubramanian set aside the Gujarat High Court order quashing the warrant of authorization of search and seizure dated August 7, 2018 issued by Principal Director of Income Tax (investigation).

"We find that the High Court was not justified in setting aside the authorization of search dated August 7, 2018. Consequently, the appeal is allowed and the order passed by the High Court is set aside. As a consequence thereof, the Revenue would be at liberty to proceed against the assessee in accordance with law," the apex

The High Court had passed the order on a plea of an Ahmedabad-based business-

man who invested money in a recreation company in Goa and on whose premises search and seizure were conducted by the revenue department.

The bench said in light of earlier judgments, the sufficiency or inadequacy of reasons to believe recorded cannot be gone into while considering the validity of an act of authorization to conduct search and

"The belief recorded alone is justiciable, but only while keeping in view the Wednesbury Principle of Reasonableness. Such reasonableness is not a power to act as an appellate authority over the reasons to believe recorded," it said.

The bench said it would like to elaborate the principles in exercising the writ jurisdiction in the matter of search and seizure under Section 132 of the Income Tax Act.

"The formation of opinion and the reasons to believe recorded is not a judicial or quasi-judicial function, but administrative in character," it said, adding that the information must be in possession of the authorised official on the basis of the material and that

the formation of opinion must be honest and bona fide and cannot be merely pretence.

It said consideration of any extraneous or irrelevant material would vitiate the belief/satisfaction.

"The authority must have information in its possession on the basis of which a reasonable belief can be founded that the person concerned has omitted or failed to produce books of accounts or other documents for production of which summons or notice had been issued, or such person will not produce such books of accounts or other documents even if summons or notice is issued to him," the bench said.

It said there should be reasonable belief that such a person is in possession of any money, bullion, jewellery or other valuable article which represents either wholly or partly income or property, which has not been or would not be disclosed.

"Such reasons may have to be placed before the High Court in the event of a challenge to formation of the belief of the competent authority in which event the Court would

In other words, the Court will examine whether the reasons recorded are actuated by mala fides or on a mere pretence and that no extraneous or irrelevant material has been considered," it said.

### Cong asks Centre to withdraw new forest conservation rules

Urges NCST to take note of violation of Forest Rights Act 2006

The Congress has urged the National Commission for Scheduled Tribes to take note of the alleged "violation" of the Forest Rights Act 2006 and ask the Centre to withdraw the new forest conservation rules in public interest.

The party alleged that the new forest conservation rules will lead to disempowerment, dispossession, and displacement of STs and other traditional forest dwellers (OTFDs), and fuel conflict in tribal areas.

In a letter to the National Commission for Scheduled Tribes (NCST) chairperson, Harsh Chouhan, AICC national coordinator SC, ST, OBC and minority departments K Raju said the Ministry of Environment Forest and Climate Change (MoEFCC)

has notified the new Forest (Conservation) Rules, 2022 on June 29, and alleged that these rules have been notified without holding any public consultation with stakeholders.

Congress general secretary Jairam Ramesh, who has criticised the Centre's move of bringing in the new rules, shared Raju's letter to the NCST on Twitter and slammed the rules as "anti-Adivasi". The FC Rules 2022 replace the earlier 2003 Forest Conservation Rules and its amendments in 2004, 2014 and 2017, Raju noted in his letter. The FC Rules 2022 completely "undermine and

violate" the Forest Rights Act

2006 by diluting the legal

"The NCST is urged to take note of the violation of FRA and constitutional and statutory rights of STs due to the notification of FC Rules 2022 and issue directions to the Central Government and the MOEFCC to withdraw the Rules in public interest," he said

### Cholera claims 5 lives in Maha as State records 2nd Zika case

The Cholera claimed five lives in four villages of Amravati district in eastern Maharashtra, even as the state health authorities on Wednesday confirmed the second case of the Vector-borne Zika Virus in Maharashtra.

In its daily medical bulletin, the State Public Health department said that there was an outbreak of cholera in two taluks of Amravati district since July 7. "There is an outbreak in three villages --Dongri, Koylari and Ghana -- in Chikhaldara block and Naya management and treatment, village in Amaravati block. and health awareness are Until now, 181 patients have been diagnosed and 5 of them have died".

Of those who succumbed cholera, two were women, while three others were men. The three of the deceased were in the age group 24 to 40 years, while two were over 70

Following the outbreak, medical teams are working round the clock in outbreak affected villages and efforts for prevention and control in terms of water quality monitoring, patient surveillance, underway.

"The state has lately been affected by heavy rainfall. Against this background, epidemiological surveillance is being carried out on war footing," the medical bulletin said.

Cholera is an acute diarrhoeal infection caused by ingestion of food or water contaminated with the bacterium Vibrio cholerae.

A state-level squad is currently in Amravati district to investigate the outbreak and provide appropriate guidance. Additional Health Secretary

(Public Health) reviewed the outbreak situation in detail and necessary instructions have been given regarding the outbreak control to the District Collector and Chief Executive

Officer of Amaravati district

administration.

Meanwhile, the second Zika case has been reported in Maharashtra. As per the latest report from the Pune-based National Institute of Virology (NIV), a 7-year-old girl in the Ashramshala at Jhai in Talasari taluka of Palghar district was found to be infected with Zika

patient was found in Pune in from 80,07,648 to 80,10,223 July 2021.

In a related development, 2,575 fresh cases of Covid-19 were reported from different parts of Maharashtra on Wednesday, even as the pandemic claimed 10 lives in the

With 2,575 fresh cases, the daily Covid-19 cases rose from 2435 to 2,575, taking the total number of cases in the state

Similarly with ten fresh Covid-19 deaths reported during the day, the total number of deaths registered in the state since the outbreak of Covid-19 in the state in March 2020 rose from 1,47,991 to 1,48,001.

Of the total 4,255 fresh cases reported in the state, Mumbai accounted for 383 positive cases, taking the total number of cases reported in the metropolis since outbreak of the pandemic in March 2020 to 11, 19,833. The metropolis recorded one Covid-19 deaths taking the total number of deaths in the metropolis from 19,625. The authorities pegged the overall growth rate of Covid-19 cases during the period from July 6 to July 12 at 0.041 per cent.

As 3,219 Covid-19 patients were discharged from the hospitals across the state after full recovery, the total number of people discharged from the hospitals since the second week of March 2020 increased from 78,42,090 to 78,45,300. The recovery rate in the state rose from 97.93 per cent to 97.94 per cent.

Rajapaksa, who enjoys immunity from prosecution while he is president, fled the country before resigning to avoid the possibility of arrest by the new government.

On Saturday after thousands of protesters stormed his official residence, blaming him for the unprecedented economic crisis that has brought the country to its knees,

Rajapaksa announced that he will step down on Wednesday .Thirteen people accompanied Rajapaksa to the Maldives. They arrived in an AN32 aircraft, according to TV news channels. Meanwhile, former president

Maithripala Sirisena warned that a power-hungry group is gradually destroying the country, saying the President and the Acting President have no mandate at all, and one must think twice before executing their directives.

In a statement, Sirisena said

that it is the responsibility of the in Galle Face Green chanting armed forces to protect the people who are engaged in the struggle.

"An MP with one seat is appointed as PM. Now the same person is appointed as acting President. This is the Rajapaksa style of democracy. What a farce. What a tragedy, Leader of the Opposition Sajith Premadasa tweeted.

Also on Wednesday, the Indian High Commission in Sri Lanka categorically denied "baseless and speculative" media reports that it facilitated the escape of Rajapaksa to the Maldives.

"It is reiterated that India will continue to support the people of Sri Lanka as they seek to realize their aspirations for prosperity and progress through democratic means and values, established democratic institutions and constitutional framework," the India mission tweeted. As the news of Rajapaksa's departure spread, an enthusiastic crowd gathered the popular phrase Aragalayata Jayawewa, or "Victory to the struggle" in Sinhalese and "Go home Gota".

Citing sources, BBC also reported that Rajapaksa's younger brother and former finance minister Basil Rajapaksa has also left the

On Monday night, both Rajapaksa and his brother Basil were turned back at the Colombo airport as they attempted to leave the country amid mounting anger against the powerful family for mishandling the island's worst economic crisis.

Sri Lanka, a country of 22 million people, is under the grip of an unprecedented economic turmoil, the worst in seven decades, leaving millions struggling to buy food, medicine, fuel and other essentials. Last week, Prime Minister

Wickremesinghe said Sri Lanka is now a bankrupt country.

# Air quality panel revamps plan to check air pollution

The Commission for Air Quality Management (CAQM) in National Capital Region and Adjoining Areas has completely revamped the emergency-level Graded Response Action Plan (GRAP) to reduce episodic smog events across the national Capital. The plan has now been linked to the Air Quality Index (AQI) or eight pollutants including PM 2.5, PM 10, and gases such as Ozone (O3), Sulphur Dioxide SO2) and Nitrogen Dioxide (NO2). The review is part of a policy formulated by CAQM to abate the menace of

air pollution in Delhi-NCR. As per the policy of the commission for the GRAP, measures under the 'very poor', 'severe' and 'severe plus' categories will be enforced at least three days in advance. Agencies earlier waited until PM 2.5 or PM 10 concentration touched a particular threshold. Under the 'severe plus' category, agencies waited for PM 2.5 and PM 10 concentrations to stay above 300 and 500 micrograms per cubic metre for 48 hours or

"If AQI is in 'Severe' category (401-450), there will be ban on C&D activities in national capital, except emergent and essential projects (like railways, metros, airports, ISBTs, national security, defence related and projects of national importance) and nonpolluting, non-dust generating activities such as plumbing works, interior decoration, electrical works and carpentry related works," stated the GRAP policy.

GRAP policy also stated that in severe category AQI, brick kilns, hot mix plants, stone crushers not operating on clean fuels like PNG and biomass-based fuels will be shut

"There will be ban on mining and associated activities in NCR and the state governments in NCR, GNCTD may impose restrictions on BS III petrol and BS IV diesel LMVs -wheeled vehicles)," the policy further added.

"In severe plus category (above 450), there will ban on the entry of trucks including



Delhi registered traffic into Delhi, except trucks carrying essential commodities, providing essential services and CNG or electric trucks," the

"İf AQI reaches severe plus category, the state governments will decide on allowing 50 per cent staff strength to work from home (WFH) in public, municipal and private offices. The State governments may consider additional emergency

measures like closure of schools, colleges, educational institutions, plying of vehicles on odd-even basis etc," the policy added.

The GRAP for the National

Capital Region (NCR) has now been classified under four different stages of adverse air quality in Delhi: Stage I - 'Poor' (AQI 201-300); Stage II - 'Very Poor' (AQI 301-400); Stage III 'Severe' (AQI 401-450); and Stage IV - 'Severe+' (AQI

The measures to be followed in the "emergency" sit-uation or Stage IV include a ban on the entry of trucks into Delhi, and on the plying of Delhi-registered diesel-run medium goods vehicles and heavy goods vehicles (HGVs) in the national capital except those engaged in essential commodities.

The use of four-wheeler diesel light motor vehicles, except for BS-VI vehicles and vehicles engaged in essential services, will also be banned in Delhi and the bordering districts of NCR. GRAP is a set of anti-air pollution measures followed in Delhi and its vicinity according to the severity of the situation.

Earlier, authorities would wait until PM 2.5 or PM 10 concentration touched a particular threshold. CAQM formulates extensive action plan to check pollution from vehicles

s vehicles are the second-A highest contributors to particulate pollution in the country, the Commission for Air Quality Management has come up with an extensive action plan for abetment of air pollution from vehicles and the transport sector in the National Capital Region (NCR) and the adjoining states.

Ensuring 100 per cent compliance with valid pollution-under-control (PUC) certificates, formulating norms for monitoring on-road vehicles with remote-sensing devices for advanced emissions surveillance and phasing out over-aged vehicles are some of the key factors that have been included in the policy to curb air pollution.

For on-road emissions inspection and monitoring, the policy mentions that effective fleet screening still remains a daunting challenge and that more advanced inspection and monitoring systems are needed to be introduced.

It further states that all commercial vehicles require annual roadworthiness and fitness tests under the Central Motor Vehicle Rules (CMVR).

CMVR tests are carried out manually in the absence of adequate testing facilities in most parts of the NCR and there is a need to set up more fullyautomated, high-capacity centralised testing centres for the region, it said.

The policy also includes plans to introduce remotesensing facilities to measure exhaust emissions remotely.

Further, the action plan includes phasing out old vehicles and scrappage of end-of-life vehicles. ### Traders upset with MCD's licence, registration fees decision

Traders across North and East Delhi on Wednesday expressed resentment over the Municipal Corporation of Delhi (MCD) decision to rationalise licence and registration fees by bringing the rates on par with markets in southern parts

Arguing that markets in south Delhi are more developed as compared to those in north and east Delhi that lack even basic facilities such as toilets and potable water, they demanded that the fees hike should be rolled back.

The MCD on Tuesday revised the rates for getting health trade licence for running various establishments, such as banquet halls and eating hous-

Nitin Gupta, President of Kamla Nagar Traders Association, said it is "unjust" to impose the health trade licence fee of south Delhi areas in north and east Delhi.

"As per the Master Plan, the conversion charge and parking development charge paid by traders to the MCD was to be market but the civic body did not do it and now they have raised taxes and licence fee and imposed it on traders.

This is completely unjust," Gupta said.

The public health department of the MCD has revised the rates of one-time registration fee and annual license fee for 94 categories of health

Under the new policy, a one-time registration fee for health trade license for banquet halls with a capacity of up to 250 seats has been fixed at Rs fee of Rs 15,000.

The registration and license fees for health trade of banquet halls with capacity more than 250 seats have been from Delhiites. fixed at Rs 20,000 and Rs

"The MCD should first 25,000, respectively. Prior to this arrangement, traders in north Delhi had to pay only Rs 1,000 for health trade license.

The traders said that after the revision in the license fee, if people want to open a 'dhaba (eatery)' in north Delhi areas, they will have to shell out Rs 6,000 for license while earlier it was only Rs 500.

Similarly, the per annum health trade license fee for a three- and five-star hotel in north Delhi will now be Rs 1 lakh and Rs 5 lakh, respectively. Earlier, it was Rs 500 for both the categories.

The accused, Shubham Jain, who owns a garage and deals in spare parts of vintage luxury cars, had taken a red BMW from Chandigarh's Ajay Parihat for repair. Police said that the red BMW was registered in the name of Ravi Kumar, who is Parihat's elder brother.

According to Benita Jaiker, the Deputy Commissioner of Police (DCP), South district that during interrogation, Jain told police that on the intervening night of July 9 and 10,



he along with his elder brother Vaibhav Jain and a friend had gone to Nehru Place in the BMW car. While returning from Nehru Place at about 2.30 AM on July 10, he hit a person near the plastic pots Market on Lajpat Rai Road but to very high speed. Later, he stopped the car near Blue Bells School for a moment but due to fear, he fled from the spot, the DCP said. The deceased, Ranjan Kumar, 46, a resident of Savitri Nagar in Malviya Nagar, worked as a cashier at a pub in East of Kailash, police said. The speeding car hit Kumar

from the front while he was walking on the road, and threw him on the pavement, police said. They said they received information about the hit-andrun incident at 5.09 AM at Greater Kailash Police Station. Kumar was lying uncon-

### Anand Vihar RRTS station to be built 8 meters below ground

m he\ Anand\ Vihar\ RRTS\ station\ will\ be\ an\ engineering}$ marvel as it will be constructed eight meters below the ground. This will be the only station in the Delhi-Ghaziabad-Meerut RRTS (Regional Rapid Transit System) corridor to be constructed one level underground.

"A typical underground station is constructed two level below the ground. Initially Anand Vihar Station was planned to be constructed 15 meters underground, however in doing so, it came in the way of the construction of the RRTS corridor," the National Capital Region Transport Corporation (NCRTC) said in a statement.

According to the statement, this station is being constructed by top-down method, first the ground level will be constructed and then the underground level. Four tunnels are also being constructed for the to and fro movement on both the sides of the station.

The construction of this station is a complex task from the point of view of civil engineering. However it is being made possible via new technologies, strategic planning, and innovative methods.

It would also ensure passenger convenience, for the elderly, handicapped and children as they wouldn't have to climb much to catch the RRTS trains, he added.

The station is close to var-



ious transport infrastructures such as Foot Over Bridge, Metro (blue and pink line), ISBT (Interstate Bus Stand), (Delhi Transport

#### Plan to shift deer from Delhi Golf Club to Asola Bhatti put on hold

The Delhi forest department's plan to shift a herd of Sambar deer from the elite Delhi Golf Club (DGC) to their new home in the Capital's Asola Bhatti Sanctuary has been put on hold till the con-struction of the sanctuary's boundary wall completed. Department, requesting them to shift the deer to the Asola Sanctuary, which is witnessing an increase in wildlife population. In winter months, when food is scarce, they start eating the grass, which increases the maintenance cost, according to DGC officials.

'The sanctuary's boundary wall is fragmented on the Haryana side. The concern is that the deer may get hurt or killed on the roads passing through or abutting the sanctuary," a senior forest official

### CUET aspirants complain about lack of time to prepare

#### As exams dates approach

The stress has increased manifold among students ever since the admit cards for the CUET-2022 were issued, with the aspirants complaining about a lack of time to prepare for the examination and no knowledge about their examination centres.

The debut edition of the CUET-UG will be conducted from July 15 to August 10. The "city intimation slips" were issued to the students on

"On Monday, only our admit cards came. Many of us have been given three days to prepare for the most important examination of our life," said Himanshu (16), a Common University Entrance Test (CUET) aspirant.

Moreover, there is no clarity as regards the examination centre as the "city intimation slip" only mentions the city's name, not that of the centre.

"It is written on the website that the examination city can also be changed in case of a large number of students. There is a lot of uncertainty,

Himanshu said.

Students say they are not satisfied with the date-sheet as the papers are either falling on the same day or in the first few days of the examination.

They feel it provides an "unfair" advantage to others as they will get ample time to prepare and also an idea about the pattern of the examination. A few aspirants have got all their examinations on the same day. According to National Testing Agency (NTA) officials,

students should not get worried as they have been issued the "city intimation slips" for the examination centre.

"Advance intimation slips

for the examination city to all candidates with the date of the examination and the city of the examination are being issued. The City Intimation Slip for each candidate has information relating to the subjects, language and medium offered in Slot 1 and Slot 2 as well as the date and the city allotted," a

senior NTA official said.
"The admit card of the first phase, showing the details of the examination centre, have been available for download from 6 pm on July 12," he added.

The CUET is a centralised common entrance test for admission to undergraduate

programmers in over 90 universities across the country, including the Delhi University. Due to a large number of

subjects, a unique date-sheet for every individual candidate has been created. The unique combination method is "quite confusing" and "convoluted" for the stu-

dents. The lack of guidance is being equally felt by the students and their parents. "It is quite confusing and convoluted. We are among the educated class and our children used to look up to us for guidance. Now, we have no idea

about the examination. We are

equally clueless," said Jyoti,

whose daughter is scheduled to appear in the CUET in August. For Ramya Shukla (18), the

lack of guidance is adding additional pressure on her. She said a major problem is that the syllabus is not just what they have studied in Classes 11 and 12 but contains "extra" elements too.

"I have not taken any coaching. I am employing the hit-and-run method. I have no idea what questions will come in the examination. The only relief is that my examination is in August. But I feel bad for my friends, many of whom have an examination in the first few days," she said.

### **Ex-VP Ansari leaked info to Pak scribe: BJP**

Addressing a Press conference, Bhatia cited the Pakistani journalist's purported comments that he had visited India on Ansari's invitations and also met him. If Congress leaders Sonia and Rahul Gandhi

Union I&B Minister Anurag Thakur said the Cabinet also granted central status to The Railway University in Gujarat's Vadodara and it has been renamed as Gati Shakti Vishwavidyalaya.

To be built by the Ministry of Railways, the project will link two states and three religious places and will be completed by 2026-27. The proposed rail line will traverse through the Sirohi district of Rajasthan and Sabarkantha, Banaskantha and Mahesana districts of Gujarat. Ambaji is one of the 51 'Shakti Peeths' which attract millions of devotees from Gujarat as well as other parts of the country and abroad every year.

Mount Abu is the headquarters of the Brahma Kumari community and is frequented by its followers from around the world. # K'taka rain fury: 32 dead, 34 injured, 300 evacuated

₹500 crore to be disbursed for restoration work, says CM

s rains continue to wreak Ahavoc in different parts of Karnataka, Chief Minister Basavaraj Bommai on Wednesday said 32 people have lost their lives so far, and Rs 500 crore will be released immediately to restore the basic infrastructure that got damaged.

The CM is on a visit to rain and landslide-affected Kodagu, Dakshina Kannada and Udupi districts since Tuesday, and will be travelling to Uttara Kannada, Belagavi and other northern districts next week.

"Across the state, so far 32 people have lost their lives, five people are missing, 34 are injured, more than 300 people have been evacuated and saved, 14 relief camps have been set up, four NDRF and SDRF



teams each are working to rescue people," Bommai said.

Speaking to reporters after holding a review meeting with senior ministers and deputy commissioners of coastal districts in Udupi, he said a sum of Rs 500 crore would be immediately released to take up repair and restoration of roads, bridges, power lines and other infrastructure works in the flood-hit areas based on the report received from all the districts on the extent of losses suf-

The Chief Minister said he s getting reports on estimates for damage from all districts, following which the state will request the Centre for relief.

Rains have increased this year in July, resulting in flood-like situation in coastal region, he said, adding, "Earlier there were some rains in May and June, in June it was average rainfall, but all of a sudden there was large-scale rainfall in the last 10 days, which has been above normal in coastal and

several parts of Malnad and coastal Karnataka causing flood-like situation, also there have been several incidents of landslide and sea erosion.

Rivers in the region have swelled, several dams have reached the brim and there is severe waterlogging in agri-culture fields and low-lying areas causing damage to crops and properties. Similar is the situation in adjoining districts of Shivamogga, Chikkamagaluru and Hassan.

Rains and increase in water level in rivers and dams is a cause of worry in a few northern districts of Belagavi, Vijayanagara and Yadgir. Water is being let out

through 15 crest gates at Yadgir's Basava Sagara dam into Krishna river. The reservoir is receiving an inflow of about one lakh cusecs. People living along the riverside have been asked to vacate to safer

reaching its capacity and increasing water flow in the river, there are threats of some of the monuments at the heritage site of Hampi like Purandara Mantapa getting inundated, sources said.

The state government is providing immediate relief of Rs 10,000 to those whose houses have been damaged, Bommai said, adding that dam-age to houses has been categorised as A, B and C according to the extent of damage, and Rs 5 lakh is being provided as compensation for completely destroyed houses, Rs 3 lakh for partially damaged houses and Rs 50,000 for houses with less damage.

As for crop losses, the NDRF has fixed input subsidy of Rs 6,800 per hectare for dry land crops, however the state government is paying Rs 13,600. Similarly, this year too Rs 13,600 would be paid, he said, and added that for wetland crops Rs 25,000 would be input subsidy of Rs 13,500 fixed by the Union govern-

For horticulture crops, the Union government is providing input subsidy of Rs 18,000, while the state government is giving Rs 28,000 to help the farmers, Bommai said.

A solatium of Rs 4 lakh is being paid by the Centre to the families of those killed in natural calamities like floods, but the state government has raised it to Rs 5 lakh, the Chief Minister said.

Speaking about damages caused in Udupi, Dakshina Kannada and Uttara Kannada, he said among the dead, eight people are from the three districts, where crop loss is to the tune of 355 hectare, and 1,062 houses have been damaged. Also, a total of 2,187 km of

### ICMR releases new standard treatment guidelines for 54 common conditions

In view of growing new scientific evidence and surging healthcare costs, the Indian Council of Medical Research (ICMR) has released a set of new standard treatment guidelines for 54 common conditions across 11 specialities to help physicians at all levels with focus on affordable quality health care.

The volume III of the 'Standard Treatment Workflows' seeks to address problems associated with irrational use of medicines, over and under diagnosis and poor referral practices, among others. Dr Vinod K Paul, Member (Health), NITI Aayog, released the book ICMR Standard Treatment Workflows -Volume III pertaining to 54 conditions under 11 specialities and also a mobile app on

Tuesday, an ICMR statement said on Wednesday. Specialties as dermatology, endocrinology, gastroenterology, general surgery, sickle cell disease, neonatology, oncology, ophthalmology, orthopaedics, female infertility, paediatric surgery had been covered in the book. Prof (Dr) Balram Bhargava, Secretary, DHR, and Director General, ICMR, said, 'The burden of delivering healthcare at the periphery predominantly rests on primary care physicians who have been doing a phenomenal job. The Standard Treatment Workflows will help these physicians to remain updated and will provide broad guidance on how to manage common conditions'

Paul said the use of Standard Treatment Workflows (STWs) needs to be examined in an operational research mode and at various levels of



the public healthcare system. A robust dissemination strategy, including international dissemination, involving various stakeholders needs to be planned, he added. ICMR released volume I with 53 conditions in 2019 and volume II with 18 conditions exclusively focused on tuberculosis in March this year.

Dr Lokesh Sharma, senior scientist at ICMR, said, "Developing STW is a mission mode project of ICMR for

common and serious diseases encountered by the treating physicians at all levels of healthcare systems with an aim to guide them for management and encourage rational use of drugs, diagnostics and other healthcare services.

"It is expected that these resource stratified treatment workflows would be useful to doctors working at primary, secondary as well as tertiary levels and help in optimal utilisation of resources," he said.

#### 7 cops suspended after 2 criminals escape from their custody in UP

#### National flag dumped with garbage: Police begin probe so do Navy, Coast Guard

The Navy and the Coast Guard on Wednesday launched a probe into an incident wherein the national flag and the flags of the Coast Guard were found dumped along with garbage on the outskirts of Ernakulam in Kerala.

The police have already registered a case and launched an investigation into the matter by constituting a special Defence sources told PTI

that even the Navy and Coast Guard have initiated parallel investigations into the incident and at the same time they are also cooperating with the police probe.

A top officer of Kochi city police said an ex-military personnel passing through that area had reported the incident and immediately they had

rushed to the spot, gave a salute to the Indian flag and removed it as well as the flags of the Coast Guard from an open piece of land close to Irumpanam crematorium in Ernakulam on Tuesday. The special squad has

begun to investigate what has happened and as part of that, information has been sought from the Cochin Naval Base and the Coast Guard, the officer said. He said it is hoped that the flags were dumped there in such an insulting manner by someone from outside the naval base or the Coast Guard.

The defence sources said it is suspected that the agencies which were awarded contracts to collect scrap from outside the "material organisations" (or store depots) of the Navy and Coast Guard were probably responsible for what had happened.

### India ranked low in gender parity: WEF report

der parity, despite an improvement of five places since last year on better performance in areas of economic participation and opportunity. On the health and survival subindex too, India ranked the lowest at 146th place and figured among the five countries with gender gaps larger than 5% - the other four being Qatar, Pakistan, Azerbaijan and China, as per the annual Gender Gap Report 2022 of the World Economic Forum (WEF) released on Wednesday in Geneva.

However, good news is that India was ranked the top globally in terms of gender parity for primary education enrolment and tertiary education enrolment and at the eighth place for the position of head of state.

Iceland retained its place as the world's most gender-equal country, followed by Finland, Norway, New Zealand and Sweden, Only 11 countries are sweden, Very Laboratory of the most significant is strength of the country of the count Afghanistan, Pakistan, Congo, Iran and Chad being the worst-

The WEF warned that the cost of living crisis is expected to hit women hardest globally with a widening gender gap in the labour force and it will take another 132 years (compared to 136 in 2021) to close the gender gap.

The report further said

that COVID-19 has set gender parity back by a generation and a weak recovery was making it worse globally. On India, the WEF said its

gender gap score recorded its seventh-highest level in the last 16 years, but it continues to rank among the worst performers on various parameters.

"With a female population of approximately 662 million, India's level of attainment weighs heavily on regional

Hours earlier the Governor attacked the State Government and asked the State civil society to "break silence and highlight worrisome governance scenario of extreme appeasement, communalised patronage, Mafia Syndicate Extortion in the state as this would help to enhance of democratic values and human rights protec-

He also said that "many statements were made" regarding development, investment was reflected on the ground.

Elsewhere the TMC leaders like Idris Ali hit the Governor back saying he was a "communal person." Bengal Speaker Biman Banerjee said Raj Bhavan was being reduced to a place of drama.

### **Needed: deregulation**

Deregulation, and not price control, is the way ahead to bring down prices and boost industry

The index of industrial production (IIP) numbers for May and retail inflation data for June released by the Government on Tuesday give a mixed picture of the economy. While there is a rebound in factory output, underpinned by capacity addition, 7.01 per cent inflation (slightly lower than 7.04 in April) is well beyond the Reserve Bank of India's tolerance band of 4-6 per cent. The IIP grew by 19.6 per cent in May, against 27.6 per cent in May last year. But these high numbers have to be viewed keeping in mind the massive decline (34.7 per cent) in May 2020 because of the COVID-induced lockdown. In absolute terms, the IIP stood at 135.4 in May 2019, whereas in May 2022 it was 137.7, the base year being 2011-12 with IIP 100; which means that industrial production is just 1.7 per cent above the pre-COVID level.



Manufacturing, which has almost 77 per cent weight in the IIP, grew by 20.6 per cent in May as compared to 32.1 per cent in May 2021. Capital goods, indicating rising capital expenditure, zoomed 54 per cent in May, against 74.9 per cent in 2021. In the first two months of this fiscal, capital grew by an impressive 31.1 per cent as compared to 232.5 per cent in the same period 2021-22. By any reckoning, this is good news.

The same, however, can't be said about the Consumer Price Index (CPI), released by the National Statistical Office (NSO) of the Ministry of Statistics & Programme Implementation. The price data are collected from selected 1,114 urban markets and

1,181 villages. The Consumer Food Price Index (CFPI) declined from 7.97 per cent in May to 7.75 per cent in June, but still food inflation is very high. Reacting to the persistently high CPI, Finance Minister Nirmala Sitharaman promised continued monitoring of prices. "We will have to be mindful and watchful of the price movement," she said. "I will keep monitoring (prices) item by item for anything that goes haywire. This pointed attack on inflation will need to continue." While her concern is admirable, she — indeed the entire Government — should not let monitoring relapse into any manner of price controls, for it is a well-known fact that price controls are a remedy worse than the malady of inflation. India and other countries have experienced the horrors of price controls in the past, especially in the pre-liberalisation era. They invariably result in shortages, blackmarketing and corruption. The problem, however, is that our political class, even after more than three decades of economic reforms, is yet to imbibe the ethic of open economy; so, the temptation to adopt statist measures is always there. The powers that be would be well-advised to opt for deregulation instead; this will not just help bring down prices but also boost industry. This will also help improve the ease of doing business which Prime Minister Narendra Modi is so keen on.



### At a crossroads

The row over the National Emblem 'replica' atop new Parliament building was best avoided

here is something about the new Parliament building that keeps it in the news for all the wrong reasons. Right from the beginning, questions were raised about the rationale behind starting it during the trying times of COVID and spending a fortune when the money was needed to provide beds and medical oxygen. Now the first glimpse of its Ashokan emblem has raised a storm. On Sunday, the Prime Minister unveiled Sunil Deore's creation — the replica of Ashokan emblem at Sarnath with four lions symbolising the State and its might looking in four directions. The unveiling of the statue opened Pandora's box. Asaduddin Owaisi said the replica should have been unveiled by Speaker Om Birla and not the PM as Parliament and all its paraphernalia is in the Speaker's domain. Then other Opposition



tion; if it was okay for the PM to unveil the statue in the first place. However, it is not such a big deal for which so much fuss should be created; after all, the PM is the representative of people and so his actions can be deemed people's wish.

Another controversy about the emblem replica is more visible and even disturbing. The lions in the statue look furious and aggressive. They aren't reassuring but menacing and do not make a comforting sight. Even 'Satyamev Jayate' is also not inscribed on the replica. Several leaders pointed to it, some even posted pictures of the Sarnath emblem with replica showing the stark difference.

In his defence Sunil Deore, the co-sculptor, said the two looked different due to the angle, height and size of the emblem and there was hardly any difference between the two. Well, everyone is entitled to his or her opinion but, for us, the 'emblem replica' should have been an exact replica. It is not. You just can't take creative liberties with national symbols. How about an oval chakra in the flag or adding a few lines to the National Anthem? This is not done, and shouldn't be. Ram V Sutar did a great job in creating the Mahatma Gandhi statue in Parliament and Sardar Patel Statue in Gujarat. Sunil and those who commissioned the replica could have taken a cue from him. Let's hope they are more mindful next time.

# AYUSH – The way to a healthy life



Most diseases today are the result of poor lifestyle and bad living conditions. This is where the alternative system of medicine comes into picture

ccording to the World Health Organisation (WHO), nearly 1.7 million deaths take place in India due to heart diseases every year. India is number two in the list of most diabetic nations with more than 77 million diabetics. Approximately 5.8 million Indians die of diabetes, cancer, stroke, heart and lung diseases every year. In other words, one out of four Indians is at the risk of dying from a Non-Communicable Disease (NCD) before the age of 70. In India, nearly 4 crore people go under the poverty line every year by spending on health care from their own pockets. The gravity of the situation can be realised from the fact that the poorest 10 per cent of the population relies on selling assets or on borrowing, entailing intergenerational consequences on the family's ability to access basic goods and affecting longterm economic prospects.

Not many people are aware that most of these diseases are the result of poor lifestyle and bad living conditions. Simple routine practices like a healthy diet, regular physical activity, avoiding tobacco and alcohol and incorporating healthy habits like yoga can bring about a drastic change and help improve one's health. This is where the alternative system of medicine comes into picture. This proven effective system, which has been in place for a long time, is relatively affordable. It will be an effective measure to promote these systems in rural areas where people mostly practice them and are ready to adapt them. Common masses could be easily provided affordable and alternative treatment options by eliminating misconceptions, creating awareness, setting up infrastructure and appointing expert practitioners.

To propagate this alternative system of medicine, the Ministry of Ayurveda, Yoga and Naturopathy, Unani, Siddha and Homoeopathy (AYUSH) was formed on November 9, 2014, for the development of education and research in these areas. The products of the body (mala, Ministry's objective is to upgrade the educational standards of total body matrix comprises

Indian systems of medicines and homoeopathy colleges, strengthen existing research institutions and ensure timebound research programme on identified diseases for which these systems have an effective treatment; to draw up schemes for promotion, cultivation and regeneration of medicinal plants used in these systems and to evolve pharmacopeial standards for Indian systems of medicines and homoeopathy drugs.

It is important to understand the relevance of this system in some detail. AYUSH is an acronym for five traditional medicinal systems. The Ministry promotes other indigenous and natural systems of medicines such as SOWA-RIGPA, Naturopathy etc. The Ministry follows the strategy of promoting these systems of medicines in such a way that they can coexist with allopathy and improve the healthcare framework. According to ayurveda, life is conceived as the union of body, senses, mind and soul. The living man is a conglomeration of three humours (Vata, Pitta & Kapha), seven basic tissues (Rasa, Mansa, Meda, Asthi, Majja & Shukra) and the wast mutra and sweda). Thus, the

"Sowa-Rigpa" is one of the oldest, living and well-documented medical traditions popular in the world. The term means "knowledge of healing" and is popular in the trans-Himalayan region of Jammu & Kashmir, Ladakh, Himachal Pradesh, West Bengal (Darjeeling), Sikkim and Arunachal Pradesh.

Sir – With reference to the news regarding PM Narendra Modi unveiling the bronze National Emblem atop the new Parliament building, I would say the National Emblem is an adaptation of the Lion Capital atop the Ashoka Pillar of Sarnath, and is combined with the national motto Satyameva Jayate. Its usage is governed by the State Emblem of India (Regulation of Use) Rules, 2007. Forming an integral part of the emblem is the motto inscribed below the abacus in Devanagari script, Satyameva Jayate, but in photographs published in newspapers, the National Emblem that will crown India's new Parliament is seen without this motto.

Earlier, directions were sent to Government agencies because they weren't displaying the State emblem properly. There is a State Emblem of India (Prohibition of Improper Use) Act of 2005 and consequent 2007 rules. But it is not understood as to why the State emblem 'Satyameva Jayate' is vanishing both literally and symbolically. I recall when I pointed this to a very senior police officer about the missing motto below the State Emblem; it was instantly not only replaced but appreciated. #### THE FALLACY OF **SUCCESS**

In this essay, the writer highlights the silly glorification of success and wealth



**GK CHESTERTON** 

here has appeared in our time a particular class of books and articles which I sincerely and solemnly think may be called the silliest ever known among men. They are much more wild than the wildest romances of chivalry and much more dull than the dullest religious tract. Moreover, the romances of chivalry were at least about chivalry, the religious tracts are about religion. But these things are about nothing, they are about what is called Success. On every bookstall, in every magazine, you may find works telling people how to succeed. They are books showing men how to succeed in everything, they are written by men who cannot even succeed in writing books. To begin with, of course, there is no such thing as Success. Or, if you like to put it so, there is nothing that is not successful.

That a thing is successful merely means that it is; a millionaire is successful in being a millionaire and a donkey in being a donkey. Any live man has succeeded in living, any dead man may have succeeded in committing suicide. But, passing over the bad logic and bad philosophy in the phrase, we may take it, as these writers do, in the ordinary sense of success in obtaining money or worldly position. These writers profess to tell the ordinary man how he may succeed in his trade or speculation—how, if he is a builder, he may succeed as a builder; how, if he is a stockbroker, he may succeed as a stockbroker. They profess to show him how, if he is a grocer, he may become a spotting yachtsman; how, if he is a tenth-rate journalist, he may become a peer; and how, if he is a German Jew, he may become an Anglo-Saxon. This is a definite



and business-like proposal, and I really think that the people who buy these books (if any people do buy them) have a moral, if not a legal, right to ask for their money back. Nobody would dare to publish a book about electricity which literally told one nothing about electricity, no one would dare to publish an article on botany which showed that the writer did not know which end of a plant grew in the earth. Yet our modern world is full of books about Success and successful people which literally contain no kind of idea, and scarcely any kind of verbal sense.

It is perfectly obvious that in any decent occupation (such as bricklaying or writing books) there are only two ways (in any special sense) of succeeding. One is by doing very good work, the other is by cheating. Both are much too simple to require any literary explanation. If you are in for the high jump, either jump higher than anyone else, or manage somehow to pretend that you have done so. If you want to succeed at whist, either be a good whistplayer, or play with marked cards. You may want a book about jumping, you may want a book about whist, you may want a book about cheating at whist. But you cannot want a book about Success. Especially you cannot want a book about Success such as those which you can now find scattered by the hundred about the book market. You may want to jump or to play cards, but you do not want to read wandering statements to the effect that jumping is jumping, or that games are won by winners...

# Going organic Indian, not Sri Lankan, way



The abrupt ban on imports of fertilisers ahead of summer crop sowing plunged Sri Lanka into deep agrarian crisis

few days ahead of the beginning of the Yala planting season, Sri Lanka announced a complete ban on imports of chemical fertilizers in April 2021. The farmers were ready with the sowing season as the Monsoon set its course in the island nation for the Yala crops, same as Kharif sowing season in India. This planting season is the mainstay of the Sri Lankan economy, as paddy is the staple food of the island nation. The Sri Lankan government was convinced that the organic farm produce would fetch premium prices in the international market and make Sri Lanka richer in quick time.

The Sri Lankan government took the country into the arms of chaos by embarking on policy adventures with least regards to the scientific inputs. Agriculture is not a domain for casino players to set bets with borrowed foreign money. But the Sri Lankan government was fully policyblinded, as the Chinese hot money flowed in the pockets of the ruling elites in Colombo, and Beijing pursued its debttrap policy in India's neighbourhood. The ban on imports of chemical fertilizers was sudden. It came as a jolt to the farming community. That was despite the agricultural scientists publicly expressing their reservations.

Sri Lanka is essentially a plantation economy. The island nation was self-sufficient in rice production. Agriculture accounted for 8.26 per cent in the Gross Domestic Product (GDP) of Sri Lanka in 2020. Sri Lanka takes pride in the Kandyan Home garden System, banking on the traditional agricultural practices, which is said to have helped in protecting biodiversity and also the environment. The Chenna cultivation system works with the rotation of the crops and the agro-forestry has also been a key feature of Sri Lankan agriculture. Such practices which enjoyed popular support for the traditional agricultural practices must have made the Sri Lankan government to take the organic bet in April 2021. By November, Sri Lanka began real-

izing that the worst case scenarios projected by the agricultural scientists started proving right. Tea productions, the mainstay of Sri Lanka and the key earner of foreign currency reserves, crashed by over 40 per cent. The productions of the Yala crops took a big hit, crashing by almost 40 per cent. The prices of the foodgrains began soaring. Panic set in, and the government realized that mistakes have been committed. But it was too late in the day when the Sri Lankan government partially lifted the ban on imports of chemical fertil-

The foreign currency reserves were already dwindling following the 2019 Easter terror attacks and the subsequent outbreak of the Covid-19, which dried up the remittances sent by the expatriates. The cunning traders began hoarding the food-

financial system of Sri Lanka, which eventually defaulted on its over USD 55 billion. The Galle Face protest began gathering strength about three months back, almost the same time when Russia invaded Ukraine, which plunged the world into a full scale inflation trap. While Russia and Ukraine are granaries of the world, being big wheat producers, the ongoing war triggered the food crisis in many countries. The crude oil prices dried the foreign currency reserves of the importing countries, including Sri Lanka. Time had run out for the Sri Lankan government to do any repair, as the people stood miles in queues to fetch cooking gas, petrol and diesel, rations, and so on. In the end, the April, 2021 decision of the Sri Lankan government to ban import of the chemical fertilizers proved to be the last straw on

grains, and the food inflation just

flew into the sky, setting off a chain reaction to stage the collapse of the

the camel's back. Organic farming is an abiding objective of the progressive farmers. But the fact is also true that a shift to organic farming after decades of chemical fertilizersbased agriculture cannot be abruj Incidentally, Sri Lanka and India worked almost at similar times for the Green Revolution in the 1960s. Doubling of the foodgrains production and their subsequent scaling up later were entirely based on the use of chemical fertilizers and better quality seeds. Like India, Sri Lanka too became self-sufficient in most of the foodgrains requirements. There emerged significant comfort levels about food security in Sri Lanka, which may have set

up the government there to go for the organic gamble. It, however, remains a fact


among the agricultural scientific community that a shift to organic farming cannot be swift and sudden, for soil needs to be restored to its health first before productions of the grains could match the levels seen during the use of the chemical fertilizers. This tests patience, and requires government support to the farming community, as has been done by the Central government in India. Sikkim is the only organic state in India, but the state government with the support of the Centre put in place a robust support system for the farmers to compensate for the losses of the productions and incentivize them to persist with the use of the organic manures, while at the same time providing a pan-India marketing support system to help the cultivators fetch the premium prices for their produces.

The Indian experiment to promote organic farming has been scientific and gradual. Organic Research and Training Institute hand-holds the farming community in the adoption of organic farming. The Central government through a siew of schemes support the promotion of the use of bio-fertilizers and organic fertilizers through laboratories, while at the same time the Soil Health Cards, taken up by the government on a big scale, have empowered the farmers to make the right choices. As part of the National Programme for Promotion of Organic Products, India exported 59908 MT of produces in the Cereal & Millets category worth USD 76 million in 2020-21. On the

other hand India's export of organic food products rose by 51 per cent USD 1040 million in 2020-21. India is exporting organic food products to 58 countries, while there continues to be robust demand in the global market. The Covid-19 pandemic made no impact on the exports of the Indian organic food producers. That was made possible on account of the end-to-end support system, from cultivation to processing to marketing, with incentives assured by the government for each stakeholder.

Besides, India embarked on scientific ways to reduce the consumption of the chemical fertilizers, with the Soil Health Cards helping the farmers to make informed decisions on right use of urea. Also, the introduction of the neem-coated urea has been a game changer. Additionally, the innovation with the nano-fertilizer has empowered the farmers to make the best and optimum use of the chemical inputs. Incidentally, the ceiling on the production of the neem-coated urea has been enhanced from the earlier 20 per cent to 35 per cent.

The Indian way of promoting organic farming is well-tested and assured by the government, which should act as an exemplar for any country if it decides to make a shift in the farming practices. Restoring the health of the soil is at the core of the efforts of the government to promote organic farming. There cannot be any short-cut. The farmers, the government agencies, and the scientific community have to toil hard for sustainable agriculture, and there cannot be any short-cut to reach the goal.

### BJP sets eyes on record Prez poll win; 2024 agenda on card

### The BJP wants Opposition presidential candidate Yashwant Sinha to bite the dust to set narrative for 2024 and beyond

A fter 1969, the Presidential election is being much talked about even though the outcome is no secret. The BJP's election management for a big victory margin, higher than

2017, has made politics unusually out of the ordinary. The fad for a super number of votes is unparalleled in an election that has little relevance than going past the halfway mark. There may be much more to it than meets the eyes. There may be a new order in the pipeline. Nobody spells that out but it can be for a variety of reasons. The 1969 was different -VV Giri against Sanjeeva Reddy. That was an intra-Congress affair that finally led to decimation of the syndicate and installed Indira

Gandhi as the new leader in



the party.
The opposition is also los-

ing its credibility for not raising the issue of inflation and a lot more. Congress is busy with its first family and a pseudo presidential battle. Together or individually, none of them even bring out a protest rally.

Prime Minister Narendra Modi is himself leading the party in creating a sort of record by having the maximum number of votes for the ruling alliance's presidential nominee Droupadi Murmu. It is troubling the opposition parties the most and many leaders, including West Bengal Chief Minister Mamata Banerjee, are feeling cornered by an astute BJP leadership. Modi's love-hate relationship with the opposition nominee

Yashwant Sinha is known.

Having fallen out of his favour, it's no wonder that the strategies in the BJP are being made to make Sinha bite the dust. In the process, the entire Opposition is finding itself in an uncanny situation and uncertain future.

The sudden turn in Maharashtra politics with 55 Shiv Sena MLAs joining a government with the BJP is planned to make the state politics interesting. The way the Eknath Shinde group forced Shiv Sena chief Uddhav Thakre to vote for Murmu speaks volumes. Shiv Sena has a total vote value of 25893 in the Presidential election.

Wherever the opposition parties are not cohesive, it is getting a shock and finds their ranks tilting towards Murmu. In UP, Samajwadi Party ranks party hosted by Andhra

Pragatisheel Murmu. Samajwadi Party (Lohia) chief Shivpal Singh Yadav has announced that he would vote for Murmu. Om Prakash Rajbhar attended the dinner of Murmu and Uttar Pradesh Chief Minister Adityanath, but the next morning he said he would vote for the candidate being supported by Akhilesh Yadav. Mayawati's BSP is supporting Murmu.

UP may spring some surprises. Jansatta Dal Loktantrik founder Raghuraj Pratap Singh alias 'Raja Bhaiya' extended his support to Murmu, saying his two MLAs will vote for the

NDA candidate. Murmu met 31 YSR Congress Party MPs and 151 MLAs and later joined a tea

appear mysteriously favouring Pradesh Chief Minister Jagan Mohan Reddy, who assured support for the NDA candidate in the Presidential election. The opposition Telugu Desam Party with 4 MPs and 23 MLAs has announced to support the NDA nominee. The lone MLA of Jana Sena who is virtually now in YSRCP has also announced to back Murmu. In effect, all votes from Andhra Pradesh will go to Murmu.

Almost similar is the situation in Odisha. Chief Minister Naveen Patnaik's BJD and BJP are voting for her. There is little doubt about Bihar either despite some reservations of Chief Minister Nitish Kumar. Jharkhand CM Hemant Soren who had initially thrown his phalanx with Sinha almost overnight not only was won

over by BJP but even told Sinha not to visit his home state for campaigning.

Rajasthan has seen cross voting during the Rajya Sabha polls. Now BJP is trying to dent the Congress votes with appeal to the scheduled caste and scheduled tribe MLAs to vote for tribal Murmu. The BJP backed Subhash Chandra lost the RS poll recently from

Rajasthan. Surprises remain in West Bengal. While Mamata Banerjee, worried about Santhal votes, blames the BJP for not telling about Murmu's candidature, her missive to Yashwant Sinha not to visit the state for campaigning speaks volume. She has not yet said

how she would vote. Delhi Chief Minister Arvind Kejriwal still holds the

AAP card close to his chest. Though it is certain that Murmu is getting the majority votes, the BJP poll managers are targeting for more than 75 percent votes.

The total value of votes is 10,86, 431, with a total of 776 MPs and 4033 MLAs constituting the electoral college. The BJP commands 48 percent votes and the NDA has over seven lakh votes.

The BJP is aiming to surpass votes polled by the incumbent President Ram Nath Kovind over Meira Kumar in 2017. Kovind had won with more than 65 percent votes. The BJP has taken the Presidential election as a test case for the 2024 polls. It will show its might for the onenation-one-party to carry on a number of unfulfilled tasks.

# **Ukraine: Heavy Russian shelling** kills 5 civilians, wounds 18

Renewed Russian artillery barrages across Ukraine killed at least five civilians and wounded another 18 in the past day, the office of Ukraine's president reported on Wednesday as Moscow attempted to expand and consolidate its gains in the country's east.

Most of the deaths occurred in Donetsk province, which is part of a region where pro-Russia separatists have fought for eight years and the Kremlin is intent on capturing. The city of Bakhmut faced particularly heavy shelling as the current focus of Russia's offensive, Donetsk administrative chief Pavlo Kyrylenko

In adjacent Luhansk province, which Russian and separatist forces have all but conquered, Ukrainian soldiers battled to retain control of two outlying villages amid the shelling, Gov. Serhiy Haidai

Luhansk and Donetsk together make up Ukraine's Donbas region, a mostly Russian-speaking region of steel factories, mines and other



industries vital to the economy. The Russians are "deliber-

ately turning Donbas into ashes, and there will be just no people left on the territories captured," Haidai said.

Russian artillery also rained down in northeast Ukraine, where a regional governor, Oleg Syniehubov, accused Russian forces of trying to "terrorize civilians" in Kharkiv, the country's second-

With Russia's sights set on

the east, the Ukrainian military has tried to reclaim captured city's in the south. The Ukrainian military claimed Tuesday to have used missiles to destroy a Russian ammunition depot in occupied Nova Kakhovka, a city east of the

Black Sea port of Kherson. The precision of the depot strike suggested Ukrainian forces had employed US-supplied multiple-launch High Mobility Artillery Rocket Systems, or HIMARS, a type of weapon for which the government in Kyiv repeatedly appealed.

Russia's Tass news agency said the reported blast occurred when a mineral fertilizer storage facility exploded. Some of the ingredients in fertilizer can be used for ammunition.

Meanwhile, Ukrainian and Russian officials are expected to meet face-to-face Wednesday for the first time in months.

Military delegations from the two countries and Turkey

plan to hold talks in Istanbul on a potential deal to get grain out of Ukraine's blockaded and mined ports.

United Nations representatives also were involved in the talks. Ukraine is one of the world's largest exporters of wheat, corn and sunflower oil, but Russia's invasion halted shipments, endangering food supplies in many developing countries and contributing to higher global prices.

In other developments: The leader of a Moscow-backed separatist government in eastern Ukraine's Donetsk province said foreign fighters convicted of terrorism and trying to overturn constitutional order for working with Ukrainian troops have appealed their death sentences.

face a firing squad.

### 'Ukraine needs assurances to resume grain exports'

The Ukrainian foreign minister says grain exports from his country's ports won't resume without security guarantees for ship owners, cargo owners and Ukraine as an independent nation.

Military officials from Russia and Ukraine were set to hold their governments' first face-to-face talks in months Wednesday. They planned to meet in Istanbul to discuss a United Nations plan for getting blocked Ukrainian grain to world markets through the Black Sea.

Speaking to The Associated Press ahead of the talks, Ukrainian Foreign Minister Dmytro Kuleba said any agreement needs to ensure Russia "will respect these corridors, they will not sneak into the harbor and attack ports or that they will not attack ports from the air with their missiles."

Kuleba also told the AP on Tuesday that Ukraine's military is "planning and preparing for full liberation" of Russianoccupied cities and towns near the country's Black Sea coast. Dozens of people have died in four days of gang battles in a violent neighbourhood of Haiti's capital, the latest eruption of bloodshed in a wave of increasing violence sweeping the country, local officials said

Jean Hislain Frederick, deputy mayor in Cite Soleil district of Port-au-Prince, said that the fighting erupted Friday in a clash between members of two rival gangs and that at least 50 people had died and more than 50 were wounded.

The violence began just a day after the first anniversary of the assassination of President Jovenel Moïse. Since Moïse was killed, violence has soared in Haiti as gangs battle over territory, and the government has struggled to crack down.

Vatican names 3 women to office that vets bishop nominations



**AP** ■ ROME

**D**ope Francis on Wednesday named three women to serve as members of the Vatican office that vets bishop nominations, in another first for women to have a say in Catholic Church governance.

The Dicastery for Bishops oversees the work of most of the church's 5,300 bishops, who run dioceses around the world. The dicastery's members, who include cardinals, bishops and now women, meet periodically to evaluate proposed new bishops whose names are forwarded by Vatican ambassadors. The ambassadors usually come up with three candidates for each opening after consulting with local church members.

The pope still makes the final call and can bypass candidates proposed by his ambassadors and then vetted by the dicastery. But the addition of women into the consultation process is nevertheless significant and a response to calls to break up the all-male clerical hierarchy of the Holy See and demands that women have a greater say in church decision-making.

The new members are Sister Raffaella Petrini. who already holds a high-ranking Vatican position as the secretary general of the Vatican City State, which runs the Vatican Museums and other administrative parts of the territory.

Also named was Sister Yvonne Reungoat, former superior general of the Daughters of Mary the Helper, a religious order also known as the Salesian Sisters; as well as a laywoman, Maria Lia Zervino, president of a Catholic women's umbrella group, the World Union of Female Catholic

### SKorea spy agency searched amid squabbling over NKorea cases

South Korean prosecutors raided the country's main spy agency Wednesday as part of investigations into two past North Korea-related incidents that drew criticism that the previous liberal government human rights to improve ties with Pyongyang.

New conservative President Yoon Suk Yeol, who took office in May, has accused his liberal predecessor Moon Jae-in of being "submissive" to North Korea and has moved to resolve persistent suspicions about the handling of the two cases. His push has triggered a backlash

Prosecutors and other investigators searched the NIS main headquarters near Seoul, including documents, computer files and other materials related to the two cases, the Seoul Central District elaborating.

The cases include North Korea's fatal shooting of a South Korean fisheries official near the Koreas' western sea boundary in 2020, and South Korea's deportation of two North Korean fishermen despite their wishes to resettle in South Korea in 2019.

### Spain's running of the bulls: 6 hurt, no gorings in Pamplona

Six people were treated for injuries but initial reports said there were no gorings in the seventh running of the bulls at Spain's San Fermín festival on Wednesday.

There were many hairy moments in the 2minute dash through the cobblestone streets of Pamplona. Shortly into the race, one bull twice head-butted a runner before tossing him to the ground where he was trampled by other beasts and frantic runners.

In the bull ring, at the end of the run, another runner who had fallen and tried to get to his feet was surprised by a charging bull who butted

Four people in all have been gored, none seriously, during the festival's seven runs bull-runs so far this year. The festival ends Thursday.

In the 8 am runs, hundreds of runners, mostly men, test their mettle to run like mad ahead and alongside six fighting bulls and their guiding steer as they charge along an 875-meter (956-yard) route through Pamplona to the city's bullring, where later in the day the bulls are killed by professional bullfighters.

Tens of thousands of visitors attend the Pamplona festival, which was immortalised in Ernest Hemingway's 1926 novel "The Sun Also Rises." The festival is also popular for its 24-hour partying, street events, and the city's

#### US, allies aim to cap Russian oil prices to hinder invasion

With thousands of sanctions already imposed on Russia to flatten its economy, the U.S. And its allies are working on new measures to starve the Russian war machine while also stopping the price of oil crush the global economy.

The Kremlin's main pillar of financial revenue - oil - has kept the Russian economy afloat despite export bans, sanctions and the freezing of central bank assets. European allies of the U.S. Plan to follow the Biden administration and take steps to stop their use of Russian oil by the end of this year, a move that some economists say could cause the supply of oil worldwide to drop and push prices as high as \$200 a barrel.

That risk has the U.S. And its allies seeking to establish a buyer's cartel to control the price of Russian oil. Group of Seven leaders have tentative-

agreed to back a cap on the price of Russian oil. Simply speaking, participating countries would agree to purchase the oil at lower-than-market price. High energy costs are already straining

economies and threatening fissures among the countries opposing Russian President Vladimir Putin for the invasion of Ukraine in February.

President Joe Biden has seen his public approval slip to levels that hurt Democrats' chances in the midterm elections, while leaders in the United Kingdom, Germany and Italy are coping with the economic devastation caused by trying to move away from Russian natural gas and petroleum.

The idea behind the cap is to lower gas prices for consumers and help bring the war in Ukraine to a halt. Treasury Secretary Janet Yellen is currently touring Indo-Pacific countries to lobby for the proposal.

Mexican President Andres Manuel López Obrador agreed to spend \$1.5 billion to improve "smart" border technology during meetings Tuesday with President Joe Biden — a move the White House says shows neighborly cooperation succeeding where Trump administration vows to wall off the border and have Mexico pay for it could not.

Harris also proposed requesting that the U.S. Congress triple funding for fisheries assistance to \$60 million a year and appoint the first U.S. Envoy to the forum.

# SENSEX, NIFTY FALL FOR 3RD DAY

### On selling in oil, banking & IT shares



enchmark equity indices Sensex and Bifty reversed their early gains to close lower on Wednesday due to selling in oil & gas, banking and IT stocks amid weak trends in European markets.

The 30-share BSE Sensex declined by 372.46 points or 0.69 per cent to close at 53,514.15, extending its falling streak to a third day.

The index opened higher and touched the day's high of 54,211.22 amid gains in Asian markets. However, it failed to hold onto its gains and dropped over 750 points to touch a low of 53,455.26 as European markets opened lower.

The broader NSE Nifty declined 91.65 points or 0.57 per cent to settle below the 16,000 level at 15,966.65.

In the three sessions to Wednesday, Sensex dropped by 967 points or 1.7 per cent while Nifty fell by 254 points.

"Strong domestic macro numbers and a fall in crude prices lifted Indian indices to open in positive territory while the gains were restrained by Europe's negative mar-

"Global markets were in a bear grip ahead of the release of the US inflation data...," said Vinod Nair, Head of Research at Geojit Financial Services.

Among the Sensex constituents, IndusInd Bank fell the most by 3.42 per cent. Bharti Airtel fell 2.87 per cent, HDFC by 2.65 per cent, HDFC Bank by 2.44 per cent and Reliance Industries 1.77 per cent.

TCS declined by 1.49 per cent while HCL Technologies fell 1.11 per cent. Titan, ICICI Bank, Bajaj Finserv, Tech Mahindra

and Wipro also dropped.

Analysts said gains in FMCG and pharma shares helped cut losses in the indices.

Hindustan Unilever rose by 1.97 per cent, Asian Paints by 1.7 per cent, and Sun Pharma by 1.09 per cent. Kotak Mahindra Bank, NTPC and Nestle also advanced.

Meanwhile, the broader markets outperformed the benchmark and ended on a flat note. The BSE midcap gauge advanced 0.32 per cent and smallcap index ended up by 0.04 per cent.

### Indian staffing industry adds 12.6 L informal employees in FY22: Report

The staffing industry added 12.6 lakh informal workers in 2021-22, driven by demand in industries like fastmoving consumer goods, ecommerce and manufactur-

ing, according to a report. In 2020-21, the informal workforce or flexi staff demand grew at a modest 3.6 per cent, according to the Indian Staffing Federation (ISF) annual report.

It said FMCG, e-commerce, manufacturing, health-care, retail, logistics, banking and energy drove demand for general flexi staffing or informal workers.

ISF is the apex body representing the manpower outsourcing industry in India.

Digital adoption across sectors drove the demand for new employees. This indicates that in FY23, fintech, IT- Infra, IT/ITeS are promising impact sectors that are expected to continue with the staffing demand, it added.

The report said that in FY22, ISF member-companies collectively added 2.27 lakh for-

mal workforce and provided employment to 12.6 lakh flexi

Women's participation in the flexi workforce continued at 27 per cent in FY22, the same as in the previous financial year, said the report.

The majority of job opportunities for flexi staff moved from outdoor sales to essential delivery services, it showed. Most of the flexi workers were in 25-30 years age-bracket, comprising 40 per cent of the workforce.

Interestingly, the report found that there is a growth in the participation of the 31-45 years age bracket in the flexi working population, which saw over 10 per cent growth compared with other formats

of employment. "FY2022 has been exceptional for the flexi staffing industry. The sharp comeback of workforce demand, growing to 21.9 per cent(12.6 lakh), is a clear indication that both employers and employees are working to put the impact of the pandemic in the past and are looking forward to building the future," ISF president Lohit Bhatia said.

Even as the inflationary fears and geopolitical tensions loom large, the early indicators for FY23 and the industry's preparations for the festive season show that hiring is expected to remain elevated over the next three quarters, he added.

According to ISF Executive Director Suchita Dutta, compared with other forms of employment, there has been 10 per cent growth in demand for flexi work.

"The participation of 27 per cent women in the workforce remained stable over the last two financial years, continuing to contribute to the workforce in spite of the three Covid waves.

"Year after year, flexi working continues to positively impact the lives of Indian citizens and their families, and provides livelihood and stability in the post pandemic era. It is also great to witness that around 15 per cent flexi workforce gets absorbed as permanent workforce," she added.

India's palm oil imports rise to 5.90 L tonnes in June: SEA

### Cigarette sales set to rise 5-6% to surpass pre-Covid level this fiscal: Report



**PTI** ■ MUMBAI

Domestic cigarette manufacturers are on course to record higher volume growth than the pre-pandemic levels at 5-6 per cent this fiscal, despite smuggled in cigarettes chipping away a good volume, a report said on Wednesday.

Rating agency Crisil said it expects the volume to go past 93 billion sticks this year on the back of increased outdoor mobility after ebbing of the pandemic restrictions and a stable tax regime.

Cigarette volume has been on the upward spiral since FY18 when it was 85 billion sticks, which rose to 91 billion sticks in FY19. The sales volume declined marginally to 90 billion sticks in FY20 before plunging to 77 billion sticks next year due to the pandemic. In FY22, the volume went up again to hit 88 billion sticks. The volume is projected to

touch 93 billion sticks this year, according to the report.

It said though gross margins will moderate on rising input cost, credit profiles of manufacturers will stay robust owing to higher volumes, healthy operating margins and strong balance sheets. Rising demand on the back

of the near end of pandemic curbs and the stable prices will light up cigarette sales by 5-6 per cent on year during this fiscal year, helping the industry surpass pre-pandemic lev-

Volume is expected to touch 93 billion sticks, the

agency said, adding, for the organised cigarette industry, volume will be 3 per cent higher than in FY20.

The report sees the rising

input cost shaving off gross margins by 100-150 basis points for manufacturers. Prices of tobacco and packaging paper, which together account for 50-60 per cent of total cost, have been rising and will rise further this fiscal.

According to Anand Kulkarni, a director with the agency, cigarette sales volume run rate has exceeded prepandemic levels in the fourth quarter of last fiscal as the impact of the third wave turned out to be modest. Increasing occupancy at workplaces, nearnormal retail and recreation mobility and a stable tax regime over the past two years augur well for demand.

Cigarette sales volume saw a 14 per cent decline in fiscal 2021 due to the mobility curb. But in FY22, the volume bounced back with a surge of 14 per cent as mobility returned to near-normal levels.

Between FY13 and FY17, excise duty on cigarettes rose annually at 15.7 per cent.

In fiscal 2018, the industry saw a further 20 per cent hike in taxes as a result of the increase in excise duty and transition to the GST regime. Another growth enabler

is the continuing stable taxation, which also has sizeable bearing on demand. Since fiscal 2013, such levies, including excise duty and Goods and Services Tax (GST), have increased significantly, leading to progressive migration from duty-paid cigarettes to other lightly taxed/tax-evaded tobacco products such as illegal cigarettes and bidis.

However, profitability is likely to decline marginally as prices of tobacco and packag-

### India on track to add 27k circuit km power transmission lines by 2024: Official

India is poised to add 27,000 circuit kilometres of interstate power transmission networks by 2024 as it has already added 6,500 circuit kilometres or almost one-fourth of the target. The power transmission network expansion has been planned keeping in mind the ultimate goal of having 500 GW of non-fossil fuel based electricity generation capacity in the county.

"We have planned to add 27,000 circuit km of inter-state transmission network in the country, mainly focussing on evacuation of renewable energy in the country by December 2024. We have already completed 6,500 circuit km lines so far," a senior power ministry official said. The official exuded confidence that India is on track to meet the target of adding 27,000 circuit kilometres as one-fourth of that is completed well within schedule.

The official also informed that 10,000 circuit kilometres lines are already under construction while 10,500 circuit kilometres are at various stages of bidding or tendering.

The inter-state transmission link plays an important role in power generation capacity addition. Solar projects are set up within a time frame of 15 to 18 month, whereas more time is required to set up the inter-state transmission link.

Experts are of the view that transmission link to evacuate power from projects especially renewables should be set up much before the generation capacity is added. The official said, "We need to build transmission line well in advance so that the generation capacities are not stranded.

In order to facilitate faster development of power infrastructure in the country, 1,500 inter-state transmission lines are mapped on PM GatiShakti portal, covering 2 lakh circuit kilometres across the country.

Earlier this month, power ministry had said that all Inter-State Transmission System (ISTS) lines have been mapped on the portal of the PM GatiShakti National Master Plan (NMP), which was launched in October, 2021 to push infrastructure development in the country.

For two-time Olympic medallist P V Sindhu and man-in-form HS Prannoy, it was also a good day in office as the two also progressed to the second round with facile wins.

Sindhu looked in complete control as she prevailed 21-15, 21-11 over Belgium world No. 36 Lianne Tan to set up a clash with Vietnam's Thuy Linh Nguyen.

Prannoy, who had reached the semifinals at Malaysia Masters last week, saw off Thailand's Sitthikom Thammasin 21-13, 21-16 and will next meet third seeded Chou Tien Chen, whom he had beaten at Malaysia Open recently.



London Olympics Bronze medal-Saina Nehwal also avenged her India Open loss to compatriot Malvika Bansod with a 21-18, 21-14 win to make it to the second round.

Manjunath, who had reached the finals of Orleans Masters Super 100 in April this year, came out all guns blazing as he dominated the opening game after taking an early 6-2 lead. He kept Srikanth at bay to comfortably seal the opening game.

Srikanth, however, turned the tables after the change of ends as he enjoyed a 11-8 cushion at the break and kept extending his lead to come back

The decider turned into a rollercoaster ride with the two slugging it out but it was Manjunath, who showed better control as he ensured a slender onepoint advantage at the breather.

Srikanth managed to take a 16-15 lead at one stage but Manjunath didn't let the opportunity slip and reeled off the last three points from 18-18 to notch up one of the biggest win of his nascent international career.

Manjunath, 24, has been in fine fettle as he reached his maiden Super-100 final at Orleans Masters in France last April. He had claimed four All-India ranking titles, including the Senior Ranking Badminton tournament in December last year.

Earlier in the year, he had contracted COVID-19 and had to withdraw from India Open Super 500 in January. He, however, made it to the Indian team for the Badminton Asia Team Championships in Malaysia after a semifinal finish at Syed Modi International and quarterfinals at Odisha Super 100.

#### **French enquiry blames** organisers for CL fiasco

An enquiry by the French Senate into crowd chaos at this year's Champions League final in Paris concluded that organisers were to blame, not supporters, undermining claims by the police and Interior Minister Gerald Darmanin.

A fact-finding mission led by two senators was set up after the Liverpool-Real Madrid game on May 28 which was marred by a delayed kick-off, crushes, teargas and street crime.

The investigation concluded that the problems were caused by a "string of dysfunctions" including a lack of preparation by French authorities and poorly executed security arrangements.

"These dysfunctions were at every level, not only during the implementation but also during preparations in advance," the co-chair of the enquiry Laurent Lafon told

reporters at a press conference. The final report contradicted repeated statements from Darmanin that Liverpool fans were mostly responsible, with the minister claiming that up to 40,000 of them travelled to the stadium either with no tickets or with fake ones.

"The first statements (by the minister) do not match up with reality," François-Noel Buffet, a fellow co-chair of the

investigation, told reporters. The conclusions of the minister on the evening and the day after were not the right ones," Lafon added. "It was a biased conclusion, imprecise."

Many Liverpool supporters struggled to travel to the stadium because of a transport strike, then found themselves in bottlenecks and crushes at

the stadium entry gates. Faced with the build up of frustrated fans around the Stade de France, police fired tear gas to move the crowd back, affecting many children as well as disabled fans in

After the game, visitors were preyed on by local gangs as they made their way to local transport connections, with many reporting pickpocketing, muggings and threats as the police looked on.

### Wasn't thinking about break from ODI, says Shami

Ceasoned India pacer Mohammad Shami said he wasn't thinking about his long lay off from ODI cricket and approached his comeback game with a clear mind as he is well-versed with the whiteball behaviour.

The first ODI against England on Monday was Shami's first appearance in the format after almost a gap of two years. He last played in India's 51-run loss to Australia in November 2020.

"It wasn't a small break but of three years," Shami, who claimed 3 for 31 at the Oval on Tuesday, said during a chat with bowling coach Paras Mhambrey on BCCI.Tv.

"Nothing was going on in my head regarding the gap. I've become very comfortable with the team. We travel together and have been playing together for like a decade now.

"Everyone knows their job and after playing so much of cricket, if you come with a question mark in your mind, then I believe it's not good."

It was also a milestone match for Shami who became the fastest Indian and third fastest bowler overall to take 150 scalps in ODI cricket.

"It's extremely important to come with a clear mind as you already know what you need to do, where you need to pitch the ball, the variations in white-ball and everyone knows these basics.

But you need to be courageous from heart and if you are that, then you can get set in any format at any given moment."

While Shami claimed three wickets, fellow pacer Jasprit Bumrah finished with a career-best 6 for 19 to blow away hosts England in the first

"As soon as we started, the ball was stopping and seaming, it became important for us to pick our areas and keep line and length in control. "We played our best per-

formance (in first ODI); like, the way a series has to be started, it set an example." Shami said the key was to

keep things simple and put pressure on the batters from both ends. "The only thing to be kept in mind was if the area will be

great on a pitch where it swings and seams, you bowl with great pace from both ends and makes life difficult for (batting teams) on a wicket like

"We kept things simple, got to fetch wickets quickly and result is there for all to see."

ustralia is likely to get the competition Apoints from a cancelled three-game limited-overs international series after South Africa withdrew because of a crammed schedule and the launch of its domestic T20 competition.

Cricket Australia on Wednesday said the scheduled ODIs in January in Hobart, Sydney and Perth against South Africa had been scrapped and dates and venues for

other international matches were revised. The ODI series was to be part of the International Cricket Council's Super League which determines direct qualifi-

cation for the 50-over World Cup in 2023. "Given these games will not be played before the qualification cut-off date in May, (South Africa) has agreed that Australia will be awarded the competition points pending ICC approval," Cricket Australia said in a statement.

Cricket South Africa is set to launch at new domestic T20 league in January and wanted its leading players available for the tournament.

Australia will host South Africa in a three-test series starting in Brisbane on December 17 and scheduled to end in

December 17 and scheduled to end in Sydney on January 8.

Before then, Australia will host Zimbabwe, New Zealand, West Indies and England in white-ball series from late August ahead of the T20 World Cup from October 16-November 13. The Australians will then play England in a three-game ODI series and West Indies in a two-Test series in Perth and Adelaide.
