My achievement is the success of all the poor in the country, says India's 1st tribal Prez in her swearing-in address

Breaking several glass ceilings, Droupadi Murmu on Monday took oath as the 15th President of India at the Central Hall of Parliament. Chief Justice of India NV Ramana administered the oath of office to Murmu in Hindi.

The first tribal and the youngest, 64, to hold the highest Constitutional post, Murmu stepped into the historic Rashrapati Bhawan on a balmy day followed by a spectacular ceremony which included President's guards escorting her motorcade to and from the Raisina hills.

"This is not only my achievement. It is the achievement of all the poor in the country. The poor can dare to dream now," said Murmu in her first address to a packed Central Hall which reverberated with thumping of desks by Prime Minister Narendra Modi, his Cabinet colleagues, Congress leader Sonia Gandhi, and the members of the two

## RS seat, Guv post for ₹100 cr! Racket busted

#### 4 held for luring people into trap, 5th assaults CBI team and flees

The CBI on Monday said it has busted a multi-State job racket that falsely promised governorship and Rajya Sabha seats for ₹100 crore and even appointment as Chairman in different Government-run organisations under Central Government Ministries and departments against huge pay-

Prime accused Kamlakar Prem Kumar Bandgar, resident of Latur (Maharashtra), impersonated as a CBI officer posted at the agency's head-quarters here to impress upon the clients.

The agency has arrested Bandgar along with three other accused — Mahendra Pal Arora (resident of Delhi) Abhishek Boora (resident of Ghaziabad) and Ravindra Vitthal Naik (permanent resident of Mumbai/Belgaum). Fifth accused Mohammed Aijaz Khan, a resident of Delhi, is vet to be arrested.

The agency had conducted searches at seven locations in Delhi, Uttar Pradesh, Maharashtra and Karnataka recently in connection with the case, officials said.

Searches were conducted at seven locations, including at Pradesh, Delhi, Uttar Maharashtra and Karnataka, which led to the recovery of incriminating material, includ ing WhatsApp conversations, and other evidence," the agency

They conspired with "the sole ulterior motive of cheating private persons by falsely assuring them of arrangement of seats in the Rajya Sabha, appointment as Governor, appointment as chairman of different Government-run organisations under Central departments against huge pecuniary consideration," the FIR alleged. discussed with Bandgar how the latter's purported connections with high-ranking offi-cials playing "pivotal roles" in appointments could be exploited to get the work done.

Action follows Speaker's warning to members against displaying placards

The Congress hit back at the Speaker and termed his action as "a blot on democracy". The party accused the Government of trying to "intimidate" it for raising people's issues and said it would not be cowed down.

The suspended MPs are: Manickam Tagore, TN Prathapan, Jothimani and Ramya Haridas.

Before naming the four MPs, Speaker Om Birla told the protesting members — from the Congress, the TMC and the DMK — that those who continue to shout slogans and display placards will have to do it outside the House after 3 pm. When the disruption continued, Birla named the four

Congress MPs. After the Chair named the Congress MPs for disrupting the House, Parliamentary Affair Minister Pralhad Josh then moved a resolution to suspend them for the rest of the session. Joshi said that these MPs have shown "utter disregard" for the authority of the

Chair and a "serious note of their misconduct" have been taken by the House.

Flanked by the suspended MPs outside the Ĥouse, Congress' deputy leader in the Lok Sabha Gaurav Gogoi said, "The Government is trying to intimidate us by suspending our MPs. What was their fault? They were trying to raise the issues which matter to

people. Asserting that the Congress will not be cowed down like this, he said, "The MPs were holding placards raising the issues of rising prices of gas cylinder, imposition of the GST on items such as flour and buttermilk. We moved an adjournment motion demanding a discussion on these issues, but no discussion was held." Continued on Page 2

second in this sea floor lake New Delhi: One of the most bizarre discoveries made by a team of scientists from the University of Miami is of a brine pool that can immediately kill anything that swims into it. The team made their dis-

covery using a remotely operated underwater vehicle at a depth of 1,770m, discovering the brine pool during the last five minutes of a 10-hour dive at the bottom of the Red Sea. A brine pool is a depres-

sion in the sea floor which is filled with highly concentrated saltwater which is roughly three to eight times saltier than the surrounding ocean. Brine pools are sometimes called sea floor "lakes" because

the dense brine does not easily mix with overlying seawater creating a distinct interface between water masses.

## **Gurugram Police launches E-Beat system to prevent crime**

Haryana Chief Minister Manohar Lal Khattar on Monday launched the 'Smart E-Beat' system at the office of the Commissioner of Police, Gurugram and flagged off 119 motorcycle riders of the police connected with this system.

With this initiative, the police claimed to improve patrolling, detecting crime, monitoring the police personnel on the beat, improving police-public relations and finding out their real-time location.

According to the police, this is a GIS-based system, with the introduction of this

system police riders monitoring will be done more effec-

Under this system, it would cover all the 33 police station areas in Gurugram and 119 motorcycle riders will be deployed each motorcycle rider will have two policemen and 714 policemen will perform duty in three shifts a day.

The police said, they have identified 2056 sensitive locations or points in the city, which mainly include ATMs, petrol pumps, residences of senior citizens, schools, colleges, religious places, crimeaffected areas etc which will be

covered by these riders. These beat points would be

visited twice every 24 hours by the police riders debuted on the

This system will be integrated with Emergency Response Sport System in future so that apart from ERV, this rider can also reach for help on calls received on phone number-112.

Police Gurugram Commissioner Kala Ramachandran said that earlier it was implemented as a pilot project in East Gurugram and the Manesar area.

"This month this e-beat system has been expanded and it has been implemented in South Gurugram and West Gurugram also. Under this

new system, every rider has to download the e-beat app on his mobile phone. Those riders mark their attendance by punching on this app by going to the area where their duty has been imposed. The responsibility of identifying and checking sensitive places is given to these riders," she said.

The Commissioner also informed that the data of antisocial elements and stolen vehicles has also been mentioned in this app so that these riders will help find the stolen vehicles.

"This system will work as a secure, digital, smart and realtime patrolling solution. This is a next-generation patrolling application app on which the

### **UP Govt trying to save some** big fish: Maya on transfer row

Even as the controversy around the recent transfers in the Health department and PWD in Uttar Pradesh refuses to die down, Bahujan Samaj Party (BSP) chief Mayawati launched a veiled attack on the Yogi Adityanath-led state government claiming that attempts were being made to save "some big fish involved in the game."

She was addressing a meeting of the BSP office-bearers from Gujarat, Maharashtra, Karnataka, Tamil Nadu and Kerala.

In a press note issued by the BSP chief on her Twitter handle on Monday, she alleged that people in the state were being harassed due to corruption at every level.

"People are now witnessing how the game of corruption is being played in transfers and postings, which has become an industry. The state government has been exposed by

some of the ministers but efforts are on to save some "big fish of this game"," she alleged.

Maywati further targeted the government, claiming that communal and religious issues were raised regularly to disturb communal harmony and that a distorted picture of development was being presented through costly government advertisements.

"The BJP government in the state is a victim of internal strife and casteist disturbances. For how long will development continue to be affected by casteism, communalism, corruption and tussle among leaders? Such is the condition of their development claim that the new Bundelkhand Expressway collapsed in just four days," she said.

The former UP CM said that the way the GST tax had been imposed on essential items of daily use was a glaring proof of the anti-poor policy of the government.
"Barring a handful of

wealthy people, the income of most of the people of the country has declined. People are bearing the brunt of inflation. The price of INR is falling at a record level in the international market and the Central government should take some steps," Mayawati said.

The transfer of doctors in Uttar Pradesh sparked a row after which Deputy Chief Minister Brajesh Pathak had written a letter to the additional chief secretary regarding the implementation of the transfer policy in the department.

Asked about the suspension at a press conference at the AICC headquarters here, party spokesperson Shaktisinh Gohil said there is a tradition in Parliament that suspension is done only in exceptional and rarest of the rare circumstances there is no other option but suspension of that member.

"When Sukh Ram ji was our Minister, the BJP had not allowed Parliament to function for 17 days alleging corruption against him. Sukh Ram

ji had resigned and we had also allowed debate. There was no suspension," Gohil said.

"It is a tradition of the Lok Sabha and the Rajva Sabha that the member comes to the well of the House, it gets adjourned, there is a dialogue, a middle path is found and work goes on. Suspension is not the way and in the past, suspension has not happened in this manner," he

He said that when the BJP was in Opposition it had done the same thing repeatedly, and is a tactic of the Opposition which is in public interest and running of the House is the job of the party in power.

### VK Saxena seeks report within 15 days from Naresh Kumar

A fter receiving a complaint alleging cartelisation and the involvement of blacklisted firms in liquor retail, Lieutenant-Governor Vinai Kumar Saxena has directed Chief Secretary Naresh Kumar to probe "brazen and blatant corruption" by the Delhi Government in awarding Retail Zonal Licences under the revamped Excise Policy 2022. The Lieutenant-Governor has sought a detailed report within the next 15 days.

This comes after a complaint filed by an organisation of jurists, lawyers and civil society members, the sources said while refusing to divulge the name of the organisation to "protect them from intimidation and harassment".

The AAP Government has welcomed the Lieutenant-Governor's decision to probe the matter saying, "We welcome any enquiry or investigation into the matter. We know there's no truth to the claims.

The Delhi Government will continue working for the welfare of the public unhindered." The complaint brought out irregularities in auction to the entities related to the Balaji Group of Companies, manufacturer and distributor of liquor. "Clause 4.1.1 and 4.1.2 of the New Delhi Excise Policy

2021-22 clearly states that no licences for three zones by the entity shall be allotted more than two zones.

However, in complete violation of these clauses, two entities of Balaji Group of Companies, namely, M/s Pixie Enterprises Pvt. Ltd. and M/s Magunta Agro Farms Pvt. Ltd. were awarded Zonal Retail Licences for Zone 32 and Zones 4 and 23 respectively," it

"Further, these clauses also prohibit bidding by the entity which has any manufacturing facilities, directly or through any sister or related concern. But while the Balaji Group of Companies was allotted

The complaint said, the second violation is auction to the entities of Indospirit Group-Manufacturer and Distributor of Liquor in which Khao Gali Restaurant Pvt. Ltd., the winning bidder of Zone 2, is owned by the father of Geetika Mahendru, who is the blacklisted promoter of Indospirit Group of Companies. A part of the

furnished by the Khao Gali Restaurant Pvt. Ltd. has been provided by Indospirit Group while the other part of the EMD has been provided by Zainab Trading Pvt. Ltd. which is a related party of Pixie Enterprises Pvt. Ltd. and Magunta Agro Farms Pvt. Ltd.

# double-decker flyover in city

Deputy CM also checks installation of 500 flag poles for hoisting Tricolours across Capital

Delhi Deputy Chief Minister Manish Sisodia on Monday reviewed the works related to the installation of 115 feet high flag poles that would be needed to hoist the Tricolour at 500 places in the national Capital, and for the double-decker flyover being built between Yamuna Vihar and Bhajanpura in the Maujpur-Majlis Park Metro corridor.

He also reviewed CCTV camera installation across the city and the free Wi-Fi project in the Expenditure Finance Committee (EFC) meeting on Monday. At the meeting, the Delhi Government approved a project for a double-decker flyover between Yamuna Vihar and Bhaianpura.

This unique 1.4 kilometer flyover is being built on the upper deck of the Metro line. Crores of rupees are also being saved due to this unique model of the flyover. Currently, 50 per cent of the work of this flyover has been

The pillars of the Capital's first double-decker viaduct with a Public Works Department (PWD) flyover below and tracks of Delhi Metro' upcoming Majlis Park-Maujpur corridor on the upper deck have started taking shape. It is being constructed between Bhajanpura and Yamuna Vihar

The 12.5 km corridor is an extension of the Pink Line (Majlis Park Shiv Vihar) being constructed as part of the Phase-IV project by Delhi Metro. "This upcoming project is an engineering marvel and shows the way for better utilisation of spaces with higher population for public transport and traffic management.

After the completion of this project, the people of the surrounding areas will not have to deal with long traffic jams and their precious time will also be saved," the Government said in a statement. On the occasion of the

Independence Day, the Kejriwal Government plans to install 115 feet tall Tricolours at 500 spots across Delhi. Till now 497 mast poles have been installed and other places will be covered before August 15.

Sisodia also reviewed the second phase of the installation of 35,000 more CCTV cameras in the city. At the meeting Sisodia directed the PWD officials to ensure the installation of CCTV cameras on all the roads under its jurisdiction, which is 1,400 kms, by December 2022.

The Deputy Chief Minister said that installation of CCTV cameras on PWD roads will strengthen road safety as well as help in their regular maintenance. He directed the setting up of an Integrated Control Center for monitoring these cameras, from where the feed of all these cameras can be received and used towards improving the roads.

Also the Government has set up Wi-Fi hotspots at 11,034 places in Delhi as part of its plan to provide free Wi-Fi to the people.

Officials said that under this important project lakhs of people are availing free internet connection every day. The maintenance work of these Wi-Fi hotspots is also taken up regularly, the officials said. A live monitoring module has also been made for this.

'All the heads of schools of govt/govt aided/pvt unaided recognized schools of DoE (Directorate of Education) are requested to submit the ATR (action taken report)...To their respective deputy director of education (DDE)-district till

In a bid to reduce pollution, India has banned 19 SUP items, including earbuds, plastic sticks for balloons, flags, candy sticks, ice-cream sticks, polystyrene (thermocol), plates, cups, glasses, forks, spoons, knives, straws, trays, wrapping or packaging films around sweets boxes, invitation cards, cigarette pack-ets, plastic or PVC banners of less than 100 microns and stir-

Plastic bags of thickness less than 75 microns are also prohibited under the Plastic Waste Management Rules. Their thickness will have to be increased to 120 microns from December 31 this year.

"Today, at the swearingin ceremony of the Hon'ble President, Shri Mallikarjun Kharge, Leader of Opposition in the Rajya Sabha was made to sit in a seat not commensurate with the position he holds," the opposition leaders said in their letter. "We are writing to express our shock and protest at this

a very senior leader violating the warrant of precedence and not in accordance with protocol courtesies due to him," the leaders said. Kharge was seated in the front row but at the extreme left corner of the Central Hall during the swearing in ceremony. BJP chief JP Nadda and Maharashtra Deputy Chief Minister Devendra Fadnavis had more prominent seats, the Congress alleged, calling it "deliberate insult by the Home Ministry".

Rebutting the charge, Union Minister of Parliamentary Affairs Pralhad Joshi said, "According to the protocol set by the Union Home Ministry, the seat is given in the third row." However, at the farewell function, he was offered a seat in the first row instead of the third.

Joshi also said Kharge was provided with a seat in the first row on Monday. When he still complained that it was on the corner, the staff offered to move him to the centre, but he refused. The Trinamool Congress is furious at the Enforcement Directorate for mentioning Chief Minister Mamata Banerjee's name in the arrest memo of her senior Cabinet colleague and TMC secretary general Partha Chatterjee.

The ED arrest memo referred to four calls made by Chatterjee between 2 am and 9 am on Sunday during when he was being grilled by the investigators. According to sources the ED officials asked him whether he wanted to contact any friend or relative — as per the CrPC — to which he tried to call up the Chief Minister in the dead of night.



Even Chatterjee later said that he had tried to contact Banerjee but all his calls were went unanswered.

The Opposition parties immediately wondered why Chatterjee who had a married daughter would not call her up and instead make phone calls to the Chief Minister.

According to the arrest memo he made his first call after his arrest at around 1.55 am ... then he called up at 2.33 am. Then again he called up at 3.37 am and subsequently again tried to contact her at 9.35 am.

"He called her but she didn't take his call," the ED document place before the court said. Reacting sharply to the "ED's mischievous ploys to malign the Chief Minister" TMČ spokesperson Kunal Ghosh said "there was no need to refer about it ... it has been

motive ... Partha Chatterjee was simply induced to call the Chief Minister."

However, another senior minister Firhad Hakim said "normally the agencies take away your phone ... then how Partha Chatterjee could call up the Chief Minister ... this is mischiorous propaganda" mischievous propaganda."

Meanwhile, in another development the ED on Monday told the court that it could be a Rs 120 crore scam and that they had recovered three diaries from the residence of Arpita which could yield a number of information.

The ED sources also said that Arpita had worked in Tamil movies during which she had established contacts with six heroines in those movies. All those actresses could be questioned by the agencies sources said adding a lot of scam money could have gone into Tamil and Odiya movies through these actresses.

The ED sources also said that they had stumbled upon properties, resorts, bungalows tourist spots Shantiniketan,, Kolkata and other places.

SC notice to Centre on plea to conduct delimitation exercise in four North Eastern States

Hrishikesh Roy issued notices to the Ministry of Home Affairs, Ministry of Law and Justice, Chief Election Commissioner, and others on the plea filed by the Delimitation Demand Committee.

The plea has also sought directions to constitute a Delimitation Commission in terms of the provision under the Delimitation Act, 2002 and Section 8A of the Representation of Peoples (Amendment) Act, 1956.

The petition contended that the delimitation exercise has not been carried out for the last 51 years in the States of Assam, Arunachal Pradesh, Manipur, and Nagaland.

## 8 killed, 20 injured in mishap on Purvanchal Expressway

As many as eight people were killed and nearly 20 others injured when a Delhibound double-decker bus rammed into a stationary double-decker bus on Purvanchal Expressway in Barabanki on Monday morning.

## **Putin's unending war**

The strikes on the port city of Odessa have smashed the UN-brokered deal aimed at easing global food shortages

krainian President Volodymyr Zelenskyy has rightly called the strikes on the port city of Odessa on Saturday an act of barbarism. The missile strikes smashed the UN-brokered deal that was intended to ease global food shortages by recommencing grain exports from the Black Sea region. Typically, the Kremlin has indulged in prevarication, claiming that the target was military infrastructure. United Nations Secretary General Antonio Guterres looks further diminished. As it is, the world body has lost its raison d'etre. When Russian President Vladimir Putin launched the unwanted, brutal needless war against the hapless Ukrainians, Guterres made a fervent but feeble appeal to Putin, "President Putin, in the name of humanity, bring your troops back to Russia". Just like the cornered Hindi film heroine begs a rapacious Prem Chopra or Ranjeet, "Bhagwan ke liye mujhe chhod do!" And now this. After Russia, Ukraine, and intermediary Turkey signed the deal, the UN Secretary General had said the deal



offered a "beacon of hope". The hope has been dashed—withing 24 hours of the signing of the deal. As a CNN report said, "Sadly for Guterres and all those counting on the much-needed food, his months of diplomatic slog—including visits to Moscow and Kyiv to nail the deal—ultimately illuminated the limitations of trusting Russia." For Putin's Russia has increasingly been behaving like a rogue state, indulging in chicanery, acting on it, and threatening and attacking neighbours. On few moral and rational grounds Putin's

belligerence can be justified. He accused Ukraine of

genocide, but provided no evidence of mass murders.

He said that he wanted to shield people from bullying; he claimed that he stood for the "demilitarisation and de-Nazification" of Ukraine. But Zelenskyy is a Jew. "How could I be a Nazi?" he asked incredulously. And it's not that anti-Semitism is rampant in Ukraine, and Zelenskyy is just a token President, signifying nothing. The very fact that the Ukrainians elected a Jew as their President underlines the almost complete absence of anti-Semitism in the Eastern European nation. There is no country in the world, other than Israel, whose head of the state is a Jew; in fact, it is hard to find any such nation which ever had a Jewish head of the state or government. Yet, intoxicated with power and irredentism, Putin started the war—and is showing no intent of ending it. Reacting to the Odessa strikes, Ukrainian Member of Parliament Oleksiy Goncharenko said that Russia is "showing they want to continue to threaten the world's food security." US Secretary of State Antony Blinken's reaction also expressed dismay, "The attack cast serious doubt on the credibility of Russia's commitment." UK Foreign Minister Liz Truss, who is among the top two contenders for the post of the prime minister, said, "It shows not a word [Putin] says can be trusted." But the problem is that his man is in-charge of a deadly nuclear arsenal. The world has become a dangerous place.

Last Friday saw B S Yediyurappa, the BJP's Karnataka strongman and a former CM, announcing his retirement from electoral politics though he made it clear that he would be around for some more time. Nothing is surprising in the decision of the veteran politi-

But what surprised many was Yediyurappa's decision to anoint his second son B Y Vijayendra as the candidate from Shikaripur for the assembly election scheduled in 2023. This is dynasty politics at its worst as Yediyurappa is not a monarch to decide the names of candidates.

Even in Ramayana, the great epic on which the BJP swears, King Dasaratha has consulted his peers before announcing the name of Lord Rama as his heir. Yediyurappa is no Dasaratha while Vijayendra is no Rama. And Vijaayendra is an unknown entity in Karnataka but for his father. One should not forget the adage that charity begins at home and one should practice what one preaches.

he newly notified Forest (Conservation) Rules will protect 'Forest Rights' and interests of forest dwellers, a 2019 analysis had shown that the Forest Advisory Committee approved 193 of the 240 proposals for diversion of forest land without dwelling too long on 'consent'. 
Sir — The quality of water in the river Ganga is becoming worse and polluted

### **FLUX AND CONSTANCY OF HUMAN NATURE**

Excerpts from Life of Reason by philosopher George Santayana (1863-1952)

rogress, far from consisting in change, depends on retentiveness. When change is absolute there remains no being to improve and no direction is set for possible improvement: and when experience is not retained, as among savages, infancy is perpetual. Those who cannot remember the past are condemned to repeat it. In the first stage of life the mind is frivolous and easily distracted; it misses progress by failing in consecutiveness and persistence. This is the condition of children and barbarians, in whom instinct has learned nothing from experience. In a second stage men are docile to events, plastic to new habits and suggestions, yet able to graft them on original instincts, which they thus bring to fuller satisfaction. This is the plane of manhood and true progress. Last comes a stage when retentiveness is exhausted and all that happens is at once forgotten; a vain, because impractical, repetition of the past takes the place of plasticity and fertile re-adaptation. In a moving world re-adaptation is the price of longevity. The hard shell, far from protecting the vital principle, condemns it to die down slowly and be gradually chilled; immortality in such a case must have been secured earlier, by giving birth to a generation plastic to the contemporary world and able to retain its lessons. Thus old age is as forgetful as youth, and more incorrigible; it displays the same inattentiveness to conditions; its memory becomes self-repeating and degenerates into an instinctive reaction, like a bird's chirp.



Not all re-adaptation, however, is progress, for ideal identity must not be lost. The Latin language did not progress when it passed into Italian. It died. Its amiable heirs may console us for its departure, but do not remove the fact that their parent is extinct. So every individual, nation, and religion has its limit of adaptation; so long as the increment it receives is digestible, so long as the organization already attained is extended and elaborated without being surrendered, growth goes on; but when the foundation itself shifts, when what is gained at the periphery is lost at the centre, the flux appears again and progress is not real. Thus a succession of generations or languages or religions constitutes no progress unless some ideal present at the beginning is transmitted to the end and reaches a better expression there; without this stability at the core no common standard exists and all comparison of value with value must be external and arbitrary. Retentiveness, we must repeat, is the condition of progress.

The variation human nature is open to is not, then, variation in any direction. There are transformations that would destroy it. So long as it endures it must retain all that constitutes it now, all that it has so far gathered and worked into its substance. The genealogy of progress is like that of man, who can never repudiate a single ancestor. It starts, so to speak, from a single point, free as yet to take any direction. When once, however, evolution has taken a single step, say in the direction of vertebrates, that step cannot be retraced without extinction of the species. Such extinction may take place while progress in other lines is continued. All that preceded the forking of the dead and the living branch will be as well represented and as legitimately continued by the surviving radiates as it could have been by the vertebrates that are no more; but the vertebrate ideal is lost forever, and no more progress is possible along that line.

The future of moral evolution is accordingly infinite, but its character is more and more determined at every step...

# Let free market discover the price!



Deficiency price payment may be way forward as agri market forces are better placed to judge the value of agir products

ddressing a conference on 'Getting Agricultural Markets Right' (July 6, 2022), Ramesh Chand, who is a Member of the Niti Aayog, proposed the adoption of defi-ciency price payment system (DPPS) as an alternative to the existing dispensation of procurement of crops from the farm-

ers at minimum support prices (MSPs).

What is the problem with the MSP-based regime? How will DPPS help in alleviating it? Under the existing system, agencies of the government like the Food Corporation of India (FCI) buy agri-produces such as wheat, rice/paddy, coarse cereals, from farmers at the MSP and distribute at a subsidized price of ₹1/2/3 per kg through a network of fair price shops, known as the public distribution system (PDS), to meet the needs of India's poor.

The excess of MSP plus handling, stor-

age and distribution cost (HSD) over ₹1/2/3 per kg is paid as subsidy. Based on the recommendation of the Commission for Agricultural Costs and Prices (CACP), the government fixes MSP of 22-23 crops grown in both Kharif and Rabi seasons. However, purchases by the FCI and other state agencies are restricted primarily to rice and wheat. The other important crops are pulses and oilseeds – these are procured by the National Agricultural Cooperative Marketing Federation of India Ltd (NAFED).

The overarching objective of this dispensation is to ensure 'food security' of over 800 million people by actually making grains available to them at 'affordable' price. That this is done under a law enacted by the Parliament viz. the National Food Security Act (NFSA), 2013 shows the importance attached to it. Giving an attractive price to the farmer for her crop was another but this complement the main objective.

The MSP regime was introduced in the 1960s vide an executive order for encouraging farmers in the 'Green Revolution' region in Punjab, Haryana and western Uttar Pradesh for higher production of rice and wheat. While the intent in those days was to address food shortage, today the country has a food surplus.

Despite this fundamental change, the Government continues with the MSP regime but with a big difference. Whereas, earlier the State agencies used to procure only the quantity required for the PDS plus a 'strategic buffer', now there is a total disconnect.

Today, the Government runs an openended procurement scheme whereby the agencies buy the highest possible quantities at ever-increasing MSP. The ruling establishment is driven by a sense that in elections, it will be judged on the basis of 'how much it is purchasing from the farmers' and 'the quantum of hike in MSP allowed during its term. The drive is pursued with missionary zeal not even caring to assess whether the food thus pro-

The system has given rise to a myriad of problems viz. build up of stock far in excess of the agencies capacity to store; monumental wastages inefficiencies and high cost; large scale diversion and misuse; unsustainable increase in subsidy and added risk of violating India's commitment under the WTO. This is when only 6 per cent of the farmers get MSP benefit covering a select few crops, even as the agencies procure 30 per cent of wheat and rice production.

cured is needed or not.

There is clamor for extending coverage to all the 22-23 crops and 'all' farmers who have surplus produce to sell. If these demands are granted and that too 'guaranteed by law' (as sought by farmers during their year-long protest), this will be a sure invitation to economic disaster and financial bankruptcy of the Central Government.

Under the DPPS, the Government merely compensates farmers for the difference between the MSP for select crops and the price realized from selling in the mandi (a commonly used phrase for the 'local market'). Unlike the existing system wherein the State agencies actually purchase farmers' produce at the MSP, under the prosystem, they need not.

While Madhya Pradesh had experimented with the DPPS on select crops earlier, Harvana is in the process of rolling it out for a few commodities. Ramesh Chand wants the Centre to consider going for pan-India rollout.

Considering that the Government will continue to purchase agri-produce to meet the requirements of the PDS, to that extent, the DPPS will have no relevance. It will substitute only the

quantity that the agencies are currently buying in excess of what is required for the PDS or items such as pulses and oilseeds, they (for instance, NAFED) purchase as

price support to the farmers.

To the extent of substitution of these purchases by deficiency price payments, the Government will save money as it doesn't have to incur handling and carrying cost (H&CC), besides avoiding the loss from selling grains in the open market under OMSS (Open Market Sale Scheme) at a price lower than the MSP. For instance, if for a kg of wheat MSP is ₹20 H&CC Rs 10 and the agency sells for ₹15, then the savings would be ₹15 [10 + (20 - 15)].

Having decided in principle to make deficiency price payment, the Government will have to give it to all farmers and cover all crops unlike the existing system wherein MSP support is available 'only to those from whom it buys'. The higher expenditure due to substantially expanded coverage under DPPS will more than offset the savings due to non-purchase. The net result: even under the proposed system, ballooning subsidy outgo can't be avoided.

Under the existing regime, MSP is calculated using an All-India average cost of cultivation (plus 50 percent of the cost towards profit) even as the cost incurred by individual farmers could vary depending on the location. This results in fortuitous gains for farmers whose actual cost is less than the average and

to arrive at the deficiency amount payable, the anomaly will remain. It could be addressed by calculating location specific MSP and comparing the same with the corresponding mandi price. This poses a huge challenge in terms of data collection, analysis and implementation.

Whether it is MSP-based regime or DPPS-, both are openended, susceptible to ever increasing subsidy burden and vulnerable to violation under the

What is the way forward? It is impossible to have a viable state support system which takes care of all farmers and all crops. It should be left entirely to the market forces. PM Modi should create an eco-system in which farmers have multiple options to sell (this will require resurrection of the three Central farm laws) and fetch a remunerative price. If need be, the Government can give direct income support to poor farmers. The assistance given under PM Kisan Samman Nidhi (currently, it covers all farmers) may be restricted to them only with enhanced allocation.

This system will be free from maladies afflicting MPS/DPPS and india won't be questioned at the WTO either. As for the food security objective, Government can purchase from the market quantity required for the PDS besides 'strategic buffer'. Ideally, it may give subsidies directly to the beneficiary and let the latter buy her needs from the market. For instance, for a kg of wheat, it can transfer ₹28 to her account so that she can pay the full price of ₹30, spending ₹2

## BJP narrative for 2024 to be 'dynasty-free Bharat'

### The theme would be that while the BJP is devoted to the nation, dynasty-run parties are 'devoted to families'

ynastic politics is perhaps the antithesis of democracy. Critics say it is amongst many political evils in the Indian democratic setup where most parties, including the Congress, are being run like family enterprises. The paradox is that many regional satraps have emerged in the past 75 years and co-exist in a democracy. More are emerging.

National parties are at the forefront of the phenomenon across all states. Except for a handful like the communist parties, only seven or eight of the fifty relevant parties in

India are free from dynastic rule.



Foundation day of Bharatiya Janata Party recently, Prime Minister Narendra Modi observed, "There are still two kinds of politics going on in this

country. One is the politics of family devotion (dynasts), and the other (like BJP) is committed to patriotism." While 'Congress-free' Bharat and 'corruption-free' India were prominent BJP slogans in the last two Lok Sabha elections, the narrative for the 2024 campaign would be 'dynasty-free Bharat.'

The theme would be that while the BJP was devoted to the nation, parties were "devoted to families." The narrative covers regional parties also, most of which are family-oriented.

The BJP has now realised that the real threat comes from the family-ruled regional parties in several states. After sidelining the Congress dynasty, the BJP has identified eight prominent families that dominate state politics nationwide; the BJP intends to decimate them polit-

ically, failing which it joins them as an ally. Telangana, Meghalaya, Nagaland, Tripura, Karnataka, Chhattisgarh, Madhya Pradesh, Mizoram, and Rajasthan will hold Assembly elections in 2023. Therefore, eliminating the provincial czars would be Modi's next big project.

The question is whether it is possible to eliminate the dynasts as visualised by the BJP? It is indeed ambitious.From Kashmir to Kanyakumari, there are many dynastic families like the Abdullahs. Tall leaders among them mesmerised their electorate. The Muftis in Kashmir, the Badals and Captain Amerindra Singh in Punjab, the Rajes and Pilots in Rajasthan and Madhya Pradesh,

and the Yadays in Uttar Pradesh

and Bihar are such dynasts.

Naveen Patnaik in Odisha, the Gowdas and Bommais in Karnataka, the Gogois in Assam, the Karunanidhis in Tamil Nadu, the Raos and the Reddys in Telangana and Andhra Pradesh, the Sorens in Iharkhand, and the Chautalas and Hoodas in Haryana are notable.

The southern states are currently under the sway of regional satraps—Telangana Samithi's K. Chandrashekar Rao, YS Jagan Mohan Reddy in Andhra Pradesh, MK Stalin in Tamil Nadu, and Pinarayi Vijayan in Kerala. The BJP aims to weaken all four of them as their next project.

The party currently has just four MLAs in Tamil Nadu (riding piggyback on the

Pradesh or Kerala. Telangana has three MLAs, which it has won on its own steam. Therefore, the first step would be to weaken them. There are 120 seats in the five states in the South. Despite all its efforts, the BJP could not find a hold in southern states except in Karnataka.

Now comes the question as to why do these dynastic leaders sway people? Family-oriented parties choose their kith and kin to succeed because they feel they are more an asset than a liability. They find it easy to install and train them to take over when they die. Besides, they see them as more an asset than a lia-

Secondly, family candidates are more likely to get elected than new candidates. Thirdly, AIADMK) and none in Andhra some regional czars have

realised that establishing family rule gives them loyalty and confidence. A party like the DMK is also reconciled to dealing with the Karunanidhi dynasty.

On the other hand, the BJP and many others think that dynastic politics is not good in a democracy as it enables only those leaders who have strong connections with the family. New fiefdoms boasting of family rule have

emerged all over India. It discourages new talents from coming forward. But the BJP is not alien to dynastic politics. Critics point out that this does not seem to apply to dynasts such as Jyotiraditya Scindia, Piyush Goyal, Dharmendra Pradhan, Anurag Thakur, and Kiren Rijiju—all Cabinet ministers in the Modi

Russia appears to have reversed itself after the country's top diplomat said Moscow's overarching goal is to topple the government of Ukrainian President Volodymyr Zelenskyy as Russian artillery barrages and air strikes continue to pummel cities across Ukraine.

The remark from Russian Foreign Minister Sergey Lavrov comes amid Ukraine's efforts to resume grain exports from its Black Sea ports, something that would help ease global food shortages, under a new deal tested by a Russian strike on Odesa over the weekend.

Speaking to envoys at an Arab League summit in Cairo late Sunday, Lavrov said Moscow is determined to help Ukrainians "liberate themselves from the burden of this absolutely unacceptable regime.' Lavrov accused Kiev and "its Western

allies" of spouting propaganda intended to ensure that Ukraine "becomes the eternal enemy of Russia. "Russian and Ukrainian people

would continue to live together, we will certainly help Ukrainian people to get rid of the regime, which is absolutely antipeople and anti-historical," he said. Lavrov's remarks contrasted sharply

with the Kremlin's line early in the war, when Russian officials repeatedly emphasised that they weren't seeking to overthrow Zelenskyy's government. Lavrov argued that Russia was

ready to negotiate a deal to end hostilities in March when Kyiv changed tack and declared its intention to rout Russia on the battlefield, adding that the West has encouraged Ukraine to keep fight-

"The West insists that Ukraine must not start negotiations until Russia is defeated on the battlefield," Lavrov said. It was not yet clear when grain ship-



ments would resume following Russia and Ukraine signing identical agreements with the United Nations and Turkey on Friday in Istanbul.

The deals are aimed at clearing the way for the shipment of millions of tons of desperately needed Ukrainian grain, as well as the export of Russian grain and The Kremlin insisted Monday that

the attack on the port of Odesa over the weekend targeted military assets and would not affect grain shipping.

Kremlin spokesman Dmitry Peskov told reporters that the strike had to do exclusively with the military infrastruc-

ture."
"This is in no way related to the infrastructure involved in fulfilling the agreements and exporting grain. So this can't and shouldn't affect the start of the ship-

The Kremlin spokesman also said that Moscow has no interest in halting all gas supplies to Europe and that recent restrictions on the flow of Russian gas to European countries "are simply the consequences of restrictions the Europeans have imposed, and the Europeans themselves are suffering from these restric-

ment process in any way," Peskov said.

"Russia is a responsible gas supplier, and no matter what anyone says, the European Commission, in European capitals, in the U.S., Russia has been and continues to be a country that to a large extent guarantees Europe's energy security," Peskov said.

Meanwhile, Ukraine's presidential office said Monday that at least two civilians were killed and another 10 were

In the eastern Donetsk region, the focus of the Russian offensive, Russian artillery struck Avdiivka, Kramatorsk and Kostiantynivka. An airstrike on Bakhmut damaged at least five houses.

"The Russians are using the scorched earth tactics across the entire Donbas, they fire from the ground and from the air to wipe off entire cities," Donetsk Gov. Pavlo Kyrylenko said in televised remarks.

The Russians also struck the Kharkiv region. In the city of Chuhuiv, a Russian strike ruined the building of a local club and rescue workers removed several people from under the debris.

Kharkiv Gov. Oleh Sinyehubov denounced the attack as "senseless barbarity," saying that "it looks like a deadly lottery when no one knows where the next strike will come and the entire region is dangerous for living.'

In the Dnipro region, a 10-year-old girl was wounded by shelling, and a 7-year-old child was wounded in the ussian shelling of the Mykolaiv region.

In other developments, Russia's top domestic security agency said Monday it has thwarted an attempt by the Ukrainian military intelligence to entice Russian military pilots to surrender their combat jets to Úkraine.

The Federal Security Service (FSB), the KGB's successor agency, said Monday that Ukrainians offered Russian pilots cash and European Union citizenship to persuade them to hijack their warplanes. In a video released by the FSB, a man purported to be a Ukrainian intelligence officer, is offering to pay a prospective defector pilot USD 2 million if he would surrender his plane during combat mission over Ukraine.

Russian state television claimed that Western spy agencies assisted the Ukrainians in the effort. The Russian claims couldn't be independently verified.

## Young Ukrainians use techno parties to rebuild villages

In a village in northern Ukraine that was devastated by Russian occupation only months ago, a techno party is in full swing. In a bombed-out building, more than 200 young people have found a novel way to help rebuild their country.

The daytime "clean-up rave" in Yahidne was organised by young Ukrainians who have been using dance parties as a way to contribute to recovery efforts in the country's north, which has suffered major damage from Russian bombard-

Shovels in hand, the volunteers tackle the remnants of a village cultural centre that was destroyed in March by a Russian rocket strike, tossing piles of debris onto a tractor's loader. A DJ, his turntables mounted on a stack of ammunition boxes, spins techno and house dance music as the volunteers work. Some even take a break from their labour to

'Volunteering is my

lifestyle now," said Tania Burianova, an organiser with the Repair Together initiative. "I like electronic music and I used to party. But now it's wartime and we want to help, and we're doing it with music.

Ukraine's vibrant club scene was brought to an abrupt halt with the Russian invasion on February 24. Now, with a nighttime curfew in effect in Kyiv, the capital, and the threat of more Russian rocket attacks ever present, adherents of Ukraine's party culture have sought to combine the fun and freedom of a music festival with rebuilding the country they love. Burianova said the clean-up raves bring together those who had lost their nightclub community during the war, helping them regain a sense of normalcy and fun while contributing to the recovery of damaged towns.

"We miss (parties) and we want to come back to normal life, but our normal life now is volunteering," Burianova, 26,

told The Associated Press. The damaged cultural centre sits on the edge of Yahidne, where nearly all of the just over 300 people in the village were confined to a basement for weeks by Russian forces during the occupation of the northern Chernihiv province.

Local resident Nina, 68 said she spent those awful weeks in the basement before the Russian troops withdrew, and that 11 people died there as a result of the poor conditions. She was grateful to see young people coming together to help the village recover.

"They already repaired our windows, doors and entrances," Nina said of the volunteers. We couldn't do it ourselves with our salaries or pensions. I'm thankful that they helped

Most of the volunteers were in their 20s and 30s and came from Kyiv, about two hours' drive away. But others have come from the western city of Lviv and also nearby Chernihiv, while some foreign volunteers arrived from Portugal, the United States, Germany and elsewhere.



IN will be staged in Britain, organisers announced Monday, after concluding it is too risky to hold the muchbeloved pop extravaganza in the designated host country, Ukraine.

The U.K. Said the 2023 event would be a celebration of Ukrainian culture and creativity.

Ukraine won the right to host the glitzy pan-continental music competition when its entry, the folk-rap ensemble Kalush Orchestra, won this year's contest in May. Britain's Sam Ryder came in second.

The European Broadcasting Union, which runs Eurovision, said it had concluded that "regrettably, next year's event could not be held in Ukraine for safety and security reasons." It said Britain's BBC had agreed to broadcast the show on behalf of Ukrainian broadcaster UA:PBC.

"The 2023 Eurovision Song Contest of Ukraine," said Mykola Chernotytskyi, head of the managing board of UA:PBC. "We are grateful to our BBC partners for showing solidarity with us.

The fate of the 2023 contest had featured in talks between Ukrainian President Volodymyr Zelenskyy and British Prime Minister Boris Johnson.

Johnson said the two had agreed that "wherever Eurovision 2023 is held, it must celebrate the country and people of Ukraine." "As we are now hosts, the U.K. Will honor that pledge directly - and put on a fantastic contest on behalf of our Ukrainian friends," Johnson said.

Ukraine has won the contest twice and hosted Eurovision in 2005 and 2017. The competition has been held in Britain eight times, most recently in 1998, the year after the U.K. Last won.

### 'The money is gone': Evacuated Ukrainians forced to return

Her mother found her dying on the bench beneath the pear tree where she'd enjoyed the afternoon. By the time her father arrived, she was gone.

Anna Protsenko was killed two days after returning home. The 35-year-old had done what authorities wanted: She evacuated eastern Ukraine's Donetsk region as Russian forces move closer. But starting a new life elsewhere had been uncomfortable and expensive.

Like Protsenko, tens of thousands of people have returned to rural or industrial communities close to the region's front line at considerable risk because they can't afford to live in safer places.

Protsenko had tried it for two months, then came home to take a job in the small city of Pokrovsk. On Monday. friends and family caressed her face and wept before her casket was hammered shut beside her grave.

"We cannot win. They don't hire us elsewhere and you still have to pay rent," said a friend and neighbor, Anastasia Rusanova. There's nowhere to go, she said, but here in Donetsk, "everything is ours."

The Pokrovsk mayor's office estimated that 70% of those who evacuated have come home. In the larger city of Kramatorsk, an hour's drive closer to the front line, officials said the population had dropped to about 50,000 from the normal 220,000 in the weeks following Russia's invasion but has since risen to 68,000.

It's frustrating for Ukrainian authorities as some civilians remain in the path of war, but residents of the Donetsk region are frustrated, too. Some described feeling unwelcome as Russian speakers among Ukrainian speakers in some parts of the country.

But more often, lack of money was the problem. In Kramatorsk, some people in line waiting for boxes of humanitarian aid said they

were too poor to evacuate at all. Donetsk and its economy have The missile's impact flung been dragged down by conflict since 2014, when Russianing Ukraine's government.

"Who will take care of us?' asked Karina Smulska, who returned to Pokrovsk a month after evacuating. Now, at age 18, she is her family's main money-earner as a waitress.

Volunteers have been driving around the Donetsk region for months since Russia's invasion helping vulnerable people evacuate, but such efforts can end quietly in

In a dank home in the village of Malotaranivka on the outskirts of Kramatorsk, speckled twists of flypaper hung from the living room ceiling. Pieces of cloth were stuffed into window cracks to keep out the

Tamara Markova, 82, and her son Mykola Riaskov said they spent only five days as evacuees in the central city of Dnipro this month before deciding to take their chances back home.

"We would have been separated," Markova said.

The temporary shelter where they stayed said she would be moved to a nursing home and her son, his left side immobilised after a stroke, would go to a home for the disabled. They found that unacceptable. In their hurry to leave, they left his wheelchair behind. It was too big to take on the bus.

Now they make do. If the air raid siren sounds, Markova goes to shelter with neighbours "until the bombing stops." Humanitarian aid is delivered once a month. Markova calls it good enough. When winter comes, the neighbours will cover their windows with plastic film for basic insulation and clean the fireplace of soot. Maybe they'll have gas for heat, maybe not.

"It was much easier under the Soviet Union," she said of their lack of support from the state, but she was even unhappier with President Putin and what his soldiers are doing to the communities around her.

## Zimbabwe debuts gold coins as legal tender to stem inflation

Harare: Zimbabwe has launched gold coins to be sold to the public in a bid to tame runaway inflation that has further eroded the country's unstable currency.

The unprecedented move was announced on Monday by the country's central bank, the Reserve Bank of Zimbabwe, to boost confidence in the local currency. Trust in Zimbabwe's currency is low after people saw their savings wiped out by hyperinflation in 2008 which reached 5 billion, according to the IMF.

With strong memories of that disastrous inflation, many Zimbabweans today prefer to scramble on the illegal market for scarce US dollars to keep at home as savings or for daily

Faith in Zimbabwe's currency is already so low that many retailers don't accept it. The central bank disbursed 2,000 coins to commercial banks on Monday.

The first batch of the coins was minted outside the country but eventually they will be produced locally, according to the governor of the Reserve Bank of Zimbabwe, John Mangudya.

The coins can be used for purchases in shops, depending on whether the shop has enough change, he said.

The government is trying to moderate the very high demand for the US dollar because this high demand is



not being matched by supply, said Zimbabwean economist Prosper Chitambara.

The expectation is that ... There will also be moderation in terms of the depreciation of the local currency, which should have some kind of stabilising effect in terms of pricing of goods," he said.

Any individual or company can buy the coins from authorised outlets such as banks, according to an announcement by the country's central bank.

People can buy the gold coins from authorized agents such as banks using the local currency or foreign currencies and purchasers can choose to keep the coins at a bank or take them home. Foreigners can only buy the coins in foreign currency, said the central bank.

Called Mosi-oa-Tunya, which in the local Tonga language refers to Victoria Falls, the coins" will have liquid asset status, that is, it will be capable of being easily converted to cash, and will be tradable local-

tral bank. People holding the coins can only trade them for cash after 180 days from the date of buying, the bank said.

### Myanmar executes NLD lawmaker, 3 other political opponents

Government announced Monday it had carried out its first executions in nearly 50 years, hanging a former National League for Democracy lawmaker, a democracy activist and two men accused of violence after the country's takeover by the military last year.

The executions, detailed in the state-run Mirror Daily newspaper, were carried out despite worldwide pleas for clemency for the four political prisoners, including from United Nations experts and Cambodia, which holds the rotating chairmanship of the Association of Southeast Asian

The four were executed"in accordance with legal procedures" for directing and orga-nizing violent and inhuman accomplice acts of terrorist killings," the newspaper reported. It did not say when the executions were carried out.

Aung Myo Min, human rights minister for the National Unity Government, a shadow civilian administration established outside Myanmar after the military seized power in February 2021, rejected the allegations the men were involved in violence.

Among those executed was Phyo Zeya Thaw, a former lawmaker from ousted leader Aung San Suu Kyi's party, also known as Maung Kyaw, who was convicted in January by a closed military court of offenses involving explosives, bombings and financing terrorism.

His wife, Thazin Nyunt Aung, told the AP she had not been informed his execution had been carried out."I am still trying to confirm it myself," she said.

The 41-year-old had been arrested last November based on information from people detained for shooting security personnel, state media said at the time. He was also accused of being a key figure in a network that carried out what the military described as terrorist attacks in Yangon, the country's biggest city. ## Taiwan holds drills amid Pelosi visit concern, China tension

**Beijing:** Taiwan's capital staged air raid drills Monday and its military mobilised for routine defence exercises, coinciding with concerns over a forceful Chinese response to a possible visit to the island by US Speaker of the House Nancy Pelosi.

While there was no direct link between China's renewed threats and Taiwan's defensive moves, they underscore the possibility of a renewed crisis in the Taiwan Strait, considered a potential hotspot for conflict that could envelop the entire

Air raid sirens were sounded in the capital Taipei and the military was holding its annual multi-day Han Kuang drills, including joint air and sea exercises and the mobilization of tanks and troops.

In Taipei, police directed people to shelters when a siren went off shortly after lunchtime. Streets emptied and shops closed.

'In recent years, Chinese military planes have frequently harassed Taiwan, and the war between Russia and Ukraine broke out in February this year," Taipei Mayor Ko Wen-je told reporters, referencing concerns that a similar conflict could break out in East Asia."All these things make us understand the importance of being vigilant in times of peace and we need to be prepared if there

#### Chinese astronauts enter lab module in orbit for first time after it docks with space station

Beijing: Three Chinese astronauts aboard the country's space station, currently under construction, successfully entered the lab module in orbit for the first time on Monday, a day after the space laboratory was launched, according to the China Manned Space Agency.

China launched its space laboratory called Wentian on Sunday, sending the country's largest-ever spacecraft into Earth's orbit to become part of the space station named Tiangong which is currently under construction. The Wentian module docked with the front port of the space

station in the early hours of Monday after it entered the planned It is the first time that China's two 20-tonne-level spacecraft

## Pope lands in Canada, set for apologies to Indigenous groups

Edmonton: Pope Francis began a historic visit to Canada on Sunday to apologize to Indigenous peoples for abuses by missionaries at residential schools, a key step in the Catholic Church's efforts to reconcile with Native communities and help them heal from generations of trauma. Francis kissed the hand of a res-

idential school survivor as he was greeted at the Edmonton, Alberta, airport by Indigenous representatives, Canadian Prime Minister Justin Trudeau and Mary Simon, an Inuk who is Canada's first Indigenous governor general. The gesture set the tone of what

Francis has said is a"penitential pilgrimage" to atone for the role of Catholic missionaries in the forced assimilation of generations of Native children - a visit that has stirred mixed emotions across Canada as survivors and their families cope with the trauma of their losses and receive a longsought papal apology Francis had no official events

scheduled Sunday, giving him time to rest before his meeting Monday with survivors near the site of a former residential school in Maskwacis, where he is expected to pray at a cemetery

The simple welcome ceremony took place in airport hangar, where Indigenous drums and chanting broke the silence. ## WhatsApp privacy probe must go on, CCI urges HC

### 'As policy hasn't been withdrawn'

New Delhi: Competition Commission of India (CCI) Monday told the Delhi High Court that WhatsApp's updated privacy policy of 2021 has not been withdrawn and its probe concerning the policy should be allowed to proceed.

The CCI also said the scope of its inquiry has no overlap with the issue of an alleged infringement of user privacy pending before the Supreme Court.

The submissions were made by CCI before a bench headed by Chief Justice Satish Chandra Sharma on appeals by WhatsApp LLC and Facebook Inc against a single-judge order dismissing their challenge to the probe ordered by the CCI into the instant messaging platform's updated privacy policy.

The bench, also comprising Justice Subramonium Prasad, reserved an order on the appeals after hearing the concerned parties. January last year, CCI on its

own had decided to look into WhatsApp's updated privacy policy based on news reports regarding the same. WhatsApp and Facebook



had subsequently challenged before the single judge CCI's March 2021 order directing a probe against them, saying that the issue concerning its new policy was already pending consideration before the high court and the Supreme

The single judge on April 22 last year had, however, refused to interdict the investigation directed by the CCI.

Additional Solicitor

(ASG) Venkataraman, appearing for CCI, argued that the CCI probe into the privacy policy-- which is "still in place and function--- should not be deferred any further to await the decision of the Supreme Court, especially in the absence of any stay on the single judge order, and asserted that the messaging platform was still issuing a "pop up" seeking the consent of users who are yet to accept the updated policy.

"Judicial process cannot be used to thwart investigation .... automatically obviate competition law concerns. There is no overlap in facts. We should be allowed to investigate. There is

no overlap in law," he argued
The ASG said that the infraction on the competition law front may still be happening as there are users who have opted for the policy update and "for non-withdrawal period", the policy has to be "examined."

ASG Balbir Singh, also appearing for CCI, defended the initiation of a probagainst

the initiation of a probe against Facebook as well in connection with WhatsApp's privacy polcy, saying that the former is the holding company of the messaging platform and it can potentially exploit the data being shared".

ASG Venkataraman contended that the outcome of the Supreme Court proceedings would have no bearing on the proceedings under competition law which concerns the abuse of dominant position by a market player.

He also said that unless there is a lack of jurisdiction or malafides or arbitrariness, the CCI probe cannot be stalled.

Counsel Tejas Karia, appearing for WhatsApp, said that the "status quo" was being maintained for users who have not opted for the policy update and the CCI probe should be deferred in view of the validity of the privacy policy being tested before the Supreme (Pendency of privacy issue Court and the high court. PTI

### Sensex, Nifty snap 6-day winning streak on profit booking in energy, auto shares

Mumbai: Benchmark indices Sensex and Nifty snapped their six-day winning run to close lower by over a half per cent after profit booking in oil & gas, automobile and telecom stocks on Monday.

The 30-share BSE Sensex fell 306.01 points or 0.55 per cent to settle at 55,766.22 dragged down by index heavy-weight Reliance Industries.

During the day, the barometer declined 535.15 points or 0.95 per cent to 55,537.08

Investors traded with caution ahead of the Federal Reserve meet on Wednesday," Shrikant Chouhan, Head of Equity Research (Retail), Kotak Securities Ltd, said.

Among the Sensex con-uents, Mahindra & stituents, Mahindra fell the most by 3.80 per cent. Reliance Industries declined 3.31 per cent after the company's June quarter earnings failed to cheer investors.

PACL, also known as Pearl Group, had raised money from the public in the name of agriculture and real estate busi-

According to the Securities and Exchange Board of India (Sebi), PACL collected more than ₹60,000 crore through illegal collective investment schemes (CIS) over a period of

A committee, headed by former Chief Justice of India R M Lodha, is overseeing the process of disposing of properties to refund investors after verifying their genuineness. It has already initiated the process of refund in phases. The panel was set up by Sebi in 2016 following a Supreme Court order.

The fresh advisory came after the committee noticed that an authority letter purportedly issued on behalf of nodal officer cum secretary of the committee, authorizing one Harvinder Singh Bhangoo to sell the properties of PACL in Karnataka is in circulation.

It has been clarified that the committee has not authorised any individual or entity much less Bhangoo, to sell the properties of PACL Ltd



as falsely asserted in the foregoing authority letter, or at all, according to a statement issued on Sebi's website.

It, further, said that any attempt by individuals or entities to illegally and unauthorisedly take possession of the properties of PACL will invite strict action.

In view of this, the panel has cautioned the public at large against "buying and/or dealing with the properties of PACL or properties wherein PACL Ltd or any of its associates/subsidiaries have any interest/right, directly or indirectly.

In December 2015, Sebi had ordered attachment of all assets of PACL and its nine promoters and directors for their failure to refund the money due to investors.

Sebi had asked PACL, as also its promoters and directors, to refund the money in an order dated August 22, 2014.

The defaulters were directed to wind up the schemes and refund money to the investors within three months from the date of the order.

"It is great, I cannot complain!" said Duplantis, whose new mark bettered by 1cm his previous best set when winning Gold at the World Indoor Championships in

"The goal was to come out and to win this Gold. I just did it," said

Jamaica's Britany Anderson and Olympic champion Jasmine Camacho-Quinn of Puerto Rico.

"I believe in my abilities but I was not expecting a world record

at these championships."

American Athing Mu lived up to her hype by adding the world 800m title to her Olympic crown.

Mu, still only 20 years of age, was forced to dig deep to hold off British rival Keeley Hodgkinson in

"Today with a lot of grief, I want to tell everyone about the continuous harassment going on with me. The coaches who helped me win an Olympic medal are always being side-lined which has severely impacted my training schedule," Lovlina wrote in her twitter post.

"One of the coaches is Sandhya Gurungji, who is a Dronacharya awardee. I had to plead with folded hands to get my coaches included in the contingent. I am feeling mentally harassed because of this ordeal," she posted.

"Right now, my coach Sandhya Gurung is standing outside the CWG village and not being allowed to enter. Just eight days before the start of my event, my training schedule has been hampered. My other coach has been sent back to India," she said.

The 27-year-old right-handed batter rued not scoring a hundred.

"Last time also it was a good catch (to dismiss him). Obviously, I can't say I threw away my wicket but I should have converted into hundreds. But I feel good to contribute to the

"It's really fortunate to get to fifty (back to back) but I should have converted into hundred because I had got a good start. You said,

don't get these kind of starts again and again in international cricket and converting as many fifties to hundred is very beneficial. I thought today was a great chance to do that."

Iyer has been batting at number three in his last few matches and he said he is enjoying his new role.

"It is one of the best positions to bat at. You go in at a tough situation. If the wickets fall, you go early and you have to see off the new ball and then build the innings.

"And also, if the opening partnership is very good and you have to carry it on and build onto that from where they left. It is a fun position to bat at and I really enjoyed." He credited his strong form to the extra

hard work he has been putting in recently. "The result I am getting is because of the

hard work I am doing. I am doing some extra hard work recently because wickets and conditions are changing and there are back to back matches so I have to keep fit and try to control the controllables.'

There were some tense moments during the 312-run chase when India needed six runs off three balls.

Talking about those moments, Iyer said, "It was fun to be honest. Rahul (Dravid) sir was getting very tensed, he was passing messages. But the players were very calm and composed during pressure situations.

## **SL** on top in 2nd Pak Test

Spinner Ramesh Mendis took three wickets to put Sri Lanka in command of the second Test on Monday despite a fighting 62 by Pakistan batsman Agha Salman.

Tourists Pakistan, who lead the two-match series 1-0, ended day two on 191-7, still trailing Sri Lanka by 187 in their first innings in Salman resisted the bowl-

ing attack with his maiden Test fifty but fell to Prabath Jayasuriya's left-arm spin in the final moments of play before stumps was called.

Jayasuriya got Salman caught at slip with a drifter coming into the right-handed batsman. Salman, who made his

debut in the previous match, put on 46 runs with Yasir Shah, batting on 13, to lift Pakistan from 145-6. Pakistan suffered from a

lack of partnerships after losing first-match hero Abdullah Shafique for a duck and skipper Babar Azam for 16 on either side of the lunch break. Jayasuriya, who took 21

wickets in his first two Tests, bowled Azam on a turning delivery that got the edge of the dangerman's bat to crash onto the stumps.

Imam-ul-Haq attempted to rebuild the innings with Mohammad Rizwan but



Dhananjaya de Silva broke through with his off-spin to send back Imam on 32.

De Silva is standing in as captain in place of Dimuth Karunaratne, who did not take the field in the Pakistan innings because of back pain.

Rizwan hit a few boundaries to counterattack but Ramesh trapped him lbw for 24 and a review failed to save the wicketkeeper-bats-

## De Kock warns multi-format cricketers could be on way out

Quinton de Kock believes it will become increasingly difficult for leading cricketers to play all three main formats, although he remains confident about the

future for ODIs. The South Africa wicketkeeper-batsman, who made a fine unbeaten 92 before the third ODI against England at Headingley on Sunday was washed out, ended his Test career late last year, shortly before becoming a father for the first

Questions regarding a congested global schedule were raised again after the ODI retirement of England all-rounder Ben Stokes following the first match of this series at the 2019 World Cup final star's Chester-le-Street home

De Kock, speaking after Sunday's rain in Leeds meant a three-game contest ended in a 1-1 draw, told reporters: "It's going to start being tough for players three formats is a lot and it looks like more games are happening over the calendar.

"Players need to make decisions individually and if they feel they can do it (play Tests, ODIs and T20Is), I am happy for them," the 29-year-old added

"But guys need to take decisions into their own hands. For me, I am happy where I am." De Kock though stressed

curtailing a 54-match Test career had yet to have the desired effect. Although he had two months off after returning from paternity leave to play in South Africa's

white-ball matches against India

in January ahead of the series against Bangladesh, he has been on the go playing cricket ever

De Kock featured for the Lucknow Super Giants in the Indian Premier League before the tour of England, which also includes several further T20Is.

He will then remain in England to play in the Hundred before heading to the Caribbean Premier League prior to another white-ball series in India which precedes the T20 World Cup in Australia.

"It (retiring from Tests) hasn't freed up my calendar — at least not this year," said De Kock.

"I've been roped in to play a couple of leagues but that's my n consequence.

"I am happy to do it. It's still a sacrifice but I'm slowly getting



to an age where I need to think about where I want to be in my career.

South Africa have never won a 50-over World Cup — something they will try to put right in India next year — with De Kock insisting: "The (ODI) game is doing well for itself with the way players are going about it and from a batting and bowling competitiveness.

"There's a future for it and a lot of us still want to win 50-over World Cups." De Kock was just shy of what would have been his 18th ODI century, with the opener 92 not out off 76 balls, including 13 fours, when rain eventually ended play with South Africa

159-2 off 27.4 overs. "I think obviously it's nice going out there and scoring runs for the guys," he said.

England captain Jos Buttler was left frustrated by a gruelling schedule, as much as the bad weather. The 50-over world champi-

ons are currently nine games into a hectic period of 12 white-ball fixtures in 24 days, with just a solitary training day in that time.

Buttler, who recently suc-

ceeded Eoin Morgan as England's limited-overs captain following the 2019 World Cup-winning skipper's international retirement, said: "It's tough.

"To get the highest standard

of cricket possible, you need to prepare properly. Hopefully that's something we can look at going forward. He added: "That's been a

frustration to be truthfully honest — it would be nice to have that time to do the work.'
