19 MPs suspended India slams invite to nations to CPEC projects in PoK from RS for week

Decision to deepen Govt-Opp face-off; call taken with heavy heart: BJP

In a major development that Lould lead to complete washout of the Monsoon Session, 19 Opposition Rajya Sabha members, including seven from the TMC and six from the DMK, were suspended on Tuesday from attending the sitting of the Rajya Sabha till Friday for disrupting the proceedings of the House.

This was the highest number of MPs suspended in one go. Earlier, 12 Opposition members were suspended in November last year after some of them had climbed on the table and flung papers towards the Chair.

The BJP said the decision to suspend the MPs was taken with a "heavy heart" as the penalised members repeatedly ignored Deputy Chairman Harvansh's appeals to let the Upper House of Parliament

Four Congress Lok Sabha MPs — Manickam Tagore, TN Prathapan, Jothimani and Ramya Haridas — were suspended on Monday for disrupting proceedings, deepening the standoff between the Opposition and

The Opposition MPs, who stalled the proceedings since the start of the Monsoon Session of Parliament last Monday over price rise and the levy of the GST on daily essentials, entered the Well of the House shouting slogans.

The protesting MPs were raising slogans in various languages, including English, Hindi, Tamil and other regional languages. "Modi ji jawab do"; "GST wapas lo", "Gujarat CM resign *karo*" were some of the slogans being raised by the Opposition members.

Deputy Chairman Harivansh repeatedly asked Chairman the protesting MPs to return to their seats but when they refused, he asked the treasury benches to move a motion for their suspension.

Minister of State for Parliamentary Affairs V Muraleedharan moved a motion to suspend 10 MPs for the remainder of the week for their "misconduct" by showing "utter disregard to the House and authority of the Chair".

But when Harivansh put the motion to vote, he read out the names of 19 members. The motion was passes by a voice

When some Opposition

MPs demanded a division of votes, the Chair said he would do so if the members returned to their seats and the House was brought to order.

With the MPs refusing to budge, he said it seems they are not interested in the division and declared that the motion has been adopted

The suspended MPs refused to leave, squatting on the floor of the House, leading to three adjournments — first for 15 minutes by Harivansh then for an hour and finally, for the day by Bhubaneswar Kalita who was in the Chair.

Invitation by China, Pak infringes on India's sovereignty, territorial integrity, says New Delhi

India on Tuesday strongly opposed China and Pakistan inviting other countries to participate in their economic corridor passing through Pakistan Occupied Kashmir (POK) and termed it as "illegitimate and

In a sharply worded response on the China-Pakistan Economic Corridor (CPEC), Ministry of External Affairs Spokesperson Arindam Bagchi said, "We have seen reports on encouraging a proposed participation of third countries in so-called CPEC projects. Any such actions by any party directly infringe on India's sovereignty and territorial integrity.

"India firmly and consis-

tently opposes projects in the so-called CPEC, which are in Indian territory that has been illegally occupied by Pakistan. Such activities are inherently illegal, illegitimate and unacceptable, and will be treated accordingly by India."

New Delhi has all along

opposed projects in the CPEC falling in India's territory illegally occupied by Pakistan.

The latest reaction by India came after a July 21 meeting of the CPEC Joint Working Group (JWG) on International Cooperation and Coordination where Pakistan and China decided to welcome interested third countries to join the flag-ship CPEC initiative.



The CPEC was launched in 2013 to improve Pakistan's road, rail and energy transportation infrastructure, pesides connecting its deep-sea port of Gwadar with China's Xinjiang province.
The CPEC is part of

China's ambitious Belt and Road Initiative (BRI). During the virtual meeting

co-chaired by Pakistan's foreign secretary Sohail Mahmood and China's Assistant Foreign Minister Wu Jianghao, both the countries sought the participation of "interested third par ties" in mutually beneficial cooperation opened up by the economic corridor.

China and Pakistan described the economic corridor as "an open and inclusive platform", and "welcomed interested third parties to benefit from avenues for mutually beneficial cooperation opened up by CPEC," according to a statement issued by Pakistan's Foreign Office.

The meeting reviewed the implementation of the CPEC and its "expansion to jointly priority areas" agreed Mahmood emphasised the centrality of the "time-tested Pakistan-China all-weather strategic cooperative partnership" in Islamabad's foreign policy and said the "vitality and dynamism of the CPEC reflect ed the deep-seated mutual goodwill that lay at the heart of the bilateral relationship".

The two sides said the CPEC's development has reached a "new point, with increasing emphasis on highquality development of industry, agriculture, IT, and science and technology", and has also "broken new ground in strengthening international and regional connectivity, especially in the context of its extension to Afghanistan".

The CPEC was launched as a flagship venture under Chinese President Xi Jinping's Belt and Road Initiative.

 $I^{\rm n}$ an effort to provide modern weapons and protection gear to the frontline troops, the Defence Ministry on Tuesday approved procurement proposals worth ₹28,732 crore for rifles, bulletproof jackets and

With tension persisting at the Line of Actual Control (LAC) in Ladakh for the last two years, the Defence Acquisition Council (DAC) gave the go ahead for buying four lakh automatic rifles for the soldiers deployed all along the 4,000-km long border stretching from Ladakh in the west to Arunachal Pradesh in the east. The troops guarding the 750-km long Line of Control (LoC) will also be equipped with these rifles.

The DAC chaired by

Defence Minister Rajnath Singh here also gave the go ahead for procurement of armed drones. The DAC is the apex body to approve projected requirements of the armed

Officials said the main focus of the procurements was on self-reliance and most of the weapons will come under Buy (Indian IDDM) and Buy (Indian) categories giving a further boost to "atmanirb-

Considering the demand of enhanced protection against the threat of enemy snipers to Indian troops deployed along the LoC in Jammu & Kashmir, and in close combat operations in counter-terrorism scenario, the DAC gave the nod for bulletproof jackets with Indian Standard BIS VI level of protection.

To combat the current

complex paradigm of conventional and hybrid warfare and counter-terrorism at the LAC and other borders, including the LoC, the DAC approved the induction of four lakh close quarter battle carbines.

This is set to provide a major impetus to the small arms manufacturing industry in India and enhance atmanirbharta in small arms, they

As regards unmanned aerial vehicles (UAV), they said in the recent conflicts across the world, drone technology proved to be a force multipli-

er in military operations. Accordingly, to augment the Indian Army's capability in modern warfare, the DAC gave the nod for procurement of Autonomous Surveillance and Armed Drone Swarms under Buy (Indian-IDDM) category.

Low turnout for Covid booster worries Centre

The tepid response to the precaution doses of the Covid-19 vaccine among the targeted beneficiaries has become a cause of serious concern for the Centre, which extended the umbrella of the booster jab to all adults more than four months ago. Only 11 per cent of the nearly 69 crore eligible beneficiaries aged 18 years and above took the precaution dose of the Covid-19 vaccine till July 25.

The officials feel that complacency and waning of coronavirus fear were the factors behind the lack of interest for the booster shot.



Underlining the need for the precaution dose, officials pointed out that studies conducted by the Indian Council of Medical Research (ICMR) and other international research institutions have suggested that antibody level goes down after around six months after both doses and giving a booster increases the immune

Meghalaya BJP leader accused of running brothel held in UP

Meghalaya BJP vice president Bernard N Marak, who is accused of running a sex racket at his farmhouse in the northeastern State, was arrested in Uttar Pradesh on Tuesday, senior police officials said.

Marak, a former militant leader, had gone absconding following a police raid — which started Friday night and ran till Saturday morning — at the farmhouse at Tura in Meghalaya's West Garo Hills district. Police said they arrested 73 people from the farmhouse and rescued six minors — four boys and two girls.

He said at the United Nations Organisation Stabilisation Mission in the Democratic Republic of the Congo (MONUSCO) base in Butembo Tuesday, violent attackers snatched weapons from Congolese police and fired upon the UN uniformed personnel."Sadly, one military Peacekeeper and two UN police personnel were killed and another was injured. electorate at the cost of the exchequer to stay in power and must be avoided to preserve democratic principles and practices," it said.

The petition has also sought a direction to the EC to insert an additional condition in the relevant paragraphs of the Election Symbols (Reservation and Allotment) Order 1968, which deals with conditions for recognition as a state party, that a "political party shall not promise/distribute irrational freebies from the public fund before the election".

The petitioner has urged the apex court to declare that the promise or distribution of private goods or services, which are not for public purposes from public funds, before the elections, violates several articles of the Constitution, including Article 14 (equality before

L-G Saxena orders suspension of six MCD officials for corruption

Delhi's Lieutenant-Governor Vinai Kumar Saxena ordered the suspension of six officials of the BJP-run Municipal Corporation of Delhi (MCD) for "gross negli-gence", "abusing official posi-tion" and receiving "illegal gratification".

The Lieutenant-Governor also gave sanction to the (CBI) to prosecute a Sub-Registrar for allegedly regularising unauthorised constructions in Karol Bagh.

Top sources said that the MCD Commissioner, on the directions of the L-G, has suspended the six officials, which includes Superintendent Engineer Yadav, Administrative Officer, Manish Kumar, Deputy Controller of Accounts Anju Bhutani, South Zone Inspector Vijay Kumar, Junior Engineer (Narela) Sankhya Mishra and Assistant Engineer (Narela) Sriniwas

The sources also said complaints of corruption against officials of the MCD, the Government and the Delhi Development Authority are being decided singularly on merit. They said Sriniwas and Mishra have been suspended for failing to prevent an unauthorised warehouse from com-

ing up.

"The District Magistrate (central) and Principal Secretary (revenue), in their separate reports, had recommended the prosecution sanction to CBI to investigate the wrongdoings of Raj Pal," the source said.

'Adhere to Centre's guidelines on management of monkeypox'

International travellers arriving in Delhi with monkeypox symptoms such as high fever and back pain will be sent to the Lok Nayak Hospital from the airport. Meanwhile, one of the contacts of the monkeypoxinfected resident of Delhi has complained of body ache and is being monitored to check for any other symptoms, sources said on Tuesday. Sources said that the Delhi

Government has asked district authorities and officials concerned to adhere to the Centre's guidelines on management of the infection, which also state that referral arrangements from airport/port to identified link hospital need to be established or strengthened.

The sources said that those travellers having symptoms like high fever, back pain and joint pain at the IGI Airport will be sent to the isolation ward at LNJP Hospital, which has a special 20-member team to deal with such patients.

The samples of suspected patients will be sent to the National Institute of Virology, Pune, while the district administration will quarantine the family members and carry out contact tracing of such suspected patients, they said.

Meanwhile, the first patient

of monkeypox in the national Capital is currently recovering in the isolation ward of the Lok Nayak Hospital. His vitals are stable but his lesions will take at least a week to recover. Sources said there are 14 primary contacts of the patient. Four of his family members are in isolation at their west Delhi residence and have not shown any symptoms till now.
One of his friends, who

came in contact with him, has said he was experiencing body ache and is self-monitoring himself. He has not shown any other symptoms till now, they said.

BJP wants to bring Gui Model of illegal liquor business in Delhi: AAP

Policy 2021-22 of the Arvind Kejriwal-led city Government, which has asserted that there was no truth in the claim.

Addressing a press conference, AAP chief spokesperson Saurabh Bharadwaj said, There are few people who want that the business of spurious liquor continue and thrive in Delhi as well. Since 2021 when the Delhi government brought the new excise policy, these people have been perturbed." They (BJP) say the num-

ber of liquor shops have gone up to 850 to 1,000 in Delhi from the previous 250 after the new excise policy was brought in," the AAP spokesperson said, adding, "the BJP is spreading lies". 'Chronic hepatitis affects around 170 mn Indians' STAFF REPORTER

NEW DELHI

head of World Hepatitis Ahead of world Terminal Day, a leading gastroenterologist Dr Kunal Das said on Tuesday that chronic hepatitis affects around 170 million Indians or approximately 15 per cent of the Indian population of 130 crore. Talking on the subject, Das said the liver is the second-largest organ of the body and weighs around 1.5 kg. It is referred to as the laboratory and factory of the body as it has many enzymes that are vital for the functioning of the body.

"The most common causes of chronic hepatitis are Viral Hepatitis - Hepatitis B and Hepatitis C, Alcoholic Hepatitis and Fatty liver also known as Non-Alcoholic Steatohepatitis (NASH). Viral hepatitis is a big health problem in India as approximately 40 million are



infected with Hepatitis B and 6-12 million with Hepatitis C, said Dr Das, who is Head of Department, Gastro and Liver Department, Yashoda Hospital, in Ghaziabad.

Dr Das said it is estimated that 16-32 per cent of general population in India (nearly 120 million) has Non-alcoholic fatty liver disease (NAFLD) and among them nearly 31 per cent are diagnosed with NASH. The most common causes of fatty liver



diabetes, hypothyroid and hyperlipidemia. He further mentioned the complications of chronic hepatitis include water in the belly, vomiting of blood, hepatic coma, liver cancer, jaundice due to liver failure etc. Elaborating further Dr Das said the best strategy against Chronic Hepatitis is to "nip the devil in the bud" by prevention. Media must confine itself to honest journalism, not use influence to expand business: CJI Ramana

New Delhi: Media must confine itself to honest journalism and not use it as a tool to expand its influence and business interests, said Chief Justice of India (CJI) NV Ramana on Tuesday. Ramana said a media house with "other business interests" becomes vulnerable to external pressures and often business interests prevail over the spirit of independent journalism which compromises democracy.

Asserting that independent journalism is the "backbone of democracy", the CJI -a former journalist— also urged the stakeholders to introspect why the standards here are not considered good enough for international recognition and laurel in the field of journalism.

He was speaking at launch of Gulab Chand Kothari's book titled 'The Gita Vijnana Upanishad'. Lok Sabha Speaker Om Birla presided over event. Last week, the CJI had raised similar concerns and said "agenda driven debates" and "kangaroo courts" being run by media are detrimental to health of democracy.



andemonium is the new normal for our Parliament—not very new actually, for this has been going on for guite a while. Entire sessions were lost to it in the past. The words that occur frequently in news reports on parliament proceedings are din, commotion, shouting, sloganeering, etc. So, the recent spurt of barring parliamentarians from attending didn't come as a surprise; even those who attend rarely make speeches that illuminate the nation. On Monday, four Lok Sabha members from the Congress were suspended for the entire monsoon session ending August 12. The next day, a record 19 Rajya Sabha members from Opposition parties were suspended for this week. LS members were protesting with placards inside the House over inflation. They ignored Speaker Om Birla's warning not to display placards inside the House, leading to their suspension. Commerce & Industry Minister Piyush Goyal rightly slammed the Opposition



leaders for disturbing the proceedings on Tuesday. "The [RS] Chairman has decided to suspend a few members of Opposition parties. We have repeatedly stated that we are ready for discussion on any issue including price rise and have agreed to their demand for a discussion on the issue... [But] they are continuously disturbing the proceedings of the House," Goyal, who is the Leader of the House in the Rajya Sabha, told reporters. Birla also made a similar point on Monday: "If you want to show placards, do it outside the house. I am ready for discussions..." It is an inexplicable situation: the Narendra Modi Government is open to the idea of a discussion on inflation; the LS Speaker also allows that; but the Opposition, which

could have exposed the inadequacies of economic policy, runs away from debate and discussion. And what does it do? Shouting, screaming, placard displaying—essentially grabbing photo-ops from the issue of price rise, transmogrifying political dialogue into an unedifying spectacle, an event. And these are the folks who accuse the government of having reduced governance into event management! Quoting government sources, PTI reported in August last year, "Rocked by protests from Opposition parties on Pegasus snooping and other issues since the start of the Monsoon session, Parliament has only functioned for 18 hours out of the scheduled time of 107 hours, resulting in a loss of more than Rs 133 crore of taxpayers' money." It is not the money lost because of continuous tumult in Parliament that is the issue; the real issue is the Opposition's abdication of its duty to act as a check on executive authority. Instead of subjecting various ministries and departments to scrutiny and highlighting the failings in policies and decisions, Opposition leaders seem to be more interested in having their pictures printed in newspapers or shown on news channels. They may think that they are doing a great job, but in reality they are just helping the government, which gets a free pass because of the Opposition's theatrics.

Admit Medical Students

Medical students who returned from Ukraine and china are distressed as they can't get admission in their own country

he future of thousands of children studying medicine in Ukraine and China hangs in balance. When Russia attacked Ukraine these children had no choice but to return home. Though they made it to the home country in the middle of their studies thanks to operation Ganga are now in a quandary as they can neither go back to their college to complete their studies nor join Indian universities as they would not allow them admissions.

When they were evacuated they were promised that they would be able to continue their studies in Indian universities but after months of waiting, they are still waiting for admission.

After trying all channels they have not received any assurance from anybody regarding their future studies. They cannot return for obvious reasons and cannot study at

home. Most of them were pursuing medical science which requires a certain amount of practical training. After exhausting all channels these desperate students sat on a 5-day hunger strike in Delhi.

> They have made a poignant appeal to Prime Minister Narendra Modi to consider their request for admission to any Indian university. Even last month these students had sat on a dharna in n Jantar Mantar but to no avail, More than 40,000 students studying in Ukraine and China had to abandon their medical courses mid-way due to pandemics and war. While China has agreed to take back students on a caseby-case basis the future of students who were in

Ukraine is uncertain. The war is still going on in Ukraine and even if it stopped it is very

unlikely that the college they were studying in would resume its normal functioning. In this situation, the government should be considerate enough to give them some respite by admitting them to the university as a special case. The biggest stumbling block in admitting these students has been the National Medical Commission which has ruled out transfer or accommodation to any foreign medical students in any Indian medical institute or university since there are no such provisions in the Indian Medical Council

Act 1956 and the National Medical Commission Act, 2019 These children have already gone through a lot of trauma and if they are denied education in their own country their life would be ruined. Rules must be amended to accommodate these children. Definitely, some special arrangements can be made by which these students could complete this course and pursue their careers.

Eastern Europe bats for Ukraine



The Russian invasion of Ukraine has not gone down well with the erstwhile Soviet Bloc which is now drifting towards NATO

or the last three weeks, I have been traveling in former Czechoslovakia (the Czech Republic and Slovakia now) and areas south including Hungary and Serbia. What stands out is that except for Serbia which has maintained strong ties with Russia and China, other countries in Europe especially those from the former Soviet Bloc have become united in their wholesome support for Ukraine which has strengthened Nato and united European Union.

Scorching summer temperatures make climate change hazards inevitable. But for now, all eyes are on Ukraine as its flag and mostly women and children have found space in some of these anti-migrant countries. Take Praha (Prague) in the Czech Republic with a population of 1 mn. It has taken 400,000 Ukrainian refugees but none from Afghanistan and Syria. To its credit and unlike many other countries, it brought along 150 Afghans (and families) who were helping its military contingent there after Kabul was overpowered by the Taliban last year. İt is unspoken anti-Muslim

and the reason why it is free of any form of terrorism. Entry for anyone with an Islamic name, even from friendly countries like India, is not easy. One of the grandest crown jewels of Europe it hosts more tourists than its residents. Public transport of high excellence is free for all including tourists above 60. Bratislava, the capital of Slovakia, is an hour by train from Vienna which runs to the minute.What is noticeable is Soviet/Russian influence in Hungary, Bulgaria, Poland, former Czechoslovakia, and other countries which were part of the Soviet Union and Warsaw Pact. Their economies are not as developed as west Europe but the EU and the democratic spirit and values, they say, will certainly help their rise. Bulgaria is the poorest, struggling to weed out corruption and lethargy. It is the only country that bal-Their Soviet connection makes ances its relations effectively



for India's legacy Russian military equipment still in its inventory. Russia has made India

highly dependent on not just equipment and armaments but also spare parts, maintenance, and equipment upgrades. Although these countries are gradually converting from Russian to Nato standard equipment, they still have a high number of Russian weapons. They have taken hold of blueprints of Soviet equipment and continued to manufacture the ammunition and accessories that India is importing. Indian military delegations visit these countries to test and examine spares and maintenance equipment at the source for quality and reliability. Slowly we are weaning away from Russian equipment in favor of western, especially the US, Israeli and European armament.

Serbia was the heart and glue of former Yugoslavia. It is a very special country in this region. Under its dynamic leader Tito, it initiated and navigated the nonaligned movement along with India, Egypt, Indonesia, and otners

with Russia and China alongside the EU. It has applied for EU membership but not Nato and probably will not join it though it cooperates with the Nato Advanced Office in Beograd. It retains its strategic autonomy. For the first time, China has supplied arms to a European country, Serbia - its latest air defense system. In many respects, Serbia and India play the same Swing Game with differing degrees of success.

Besides their preoccupation with COVID and climate change, the war in Ukraine dominates the mind-game, especially among former Soviet republics. On 24 February it was Ukraine. Will Czech be next? Or Hungary? People worry. The longevity of the war in Ukraine is a big uncertainty in Europe. Even if Putin decides to unilaterally end hostilities, Ukraine and its backers including the militaryindustrial complex are thriving may not. Ukraine has received more weapons than it has the personnel to employ them. Former Warsaw Pact countries have donated mostly their older Soviet weapons. Not all are supporters of Okraine wnich has had problems with Poland, Hungary, and Bulgaria.

During his recent visits to Czech Republic and Slovakia S Jaishankar was unable to convince his listeners in Bratislava and Praha, why India had not voted against Russia over its invasion of Ukraine. People I met there said they had hoped that at least on one of the six times countries voted in the UN, India would vote at least once against Russia- at the UN Human Rights Council on humanitarian issues. They said while India has convinced itself of its choices, others are not convinced that it has followed the correct path. It appears India has not been able to make its case on Ukraine. 



Economy should focus on migrant workers

Is Nehru family above Constitution?



The first family mobilised its cadres and leaders to protest outside the ED office during interrogation of Sonia Gandhi

he entire politics of the Congress party, which has been in power for more than five decades, has been confined to the Nehru family, which has treated themselves as a monarchy, above the law and the Constitution of democratic India. This disregard for the country's constitution was in full display again when Congress stalwarts Rahul Gandhi and Sonia Gandhi were back-to-back summoned by the Enforcement Directorate for interrogation in the National Herald case.

In both cases, the 'first family' of the Congress mobilised its cadres, Members of Parliament, MLAs, and party office bearers to protest outside the office of the ED during the interrogation. The protest continued despite the imposition of Section 144. The Congress leaders left no stone unturned in portraying themselves as the trustees of the Nehru family.

Six and a half years ago, on December 19, 2015, when Sonia Gandhi and Rahul Gandhi were to appear before the Patiala House Court in Delhi in the same case, they staged a march from the Congress

Party office to the court.

Not surprisingly, people are asking why, despite being in the Opposition, the Congress never showed so much solidarity for the problems of people? The protests against the so-called persecution of the Condhis because are not never the of the Gandhis, however, are not new. The foundation was laid 47 years ago-on June 12, 1975, to be precise-when the Allahabad High Court scrapped the then prime minister Indira Gandhi's election from Rae Bareli for the misuse of state machinery. After the court barred her from contesting elections for six years, the family puppets coined the slogan 'Indira is India and India is Indira.

Whenever any action is taken against the Nehru family, the Congress makes fun of the process of law. Take the case of October 23, 1977, when Indira Gandhi was arrested over corruption charges. Or when she was arrested on December 19, 1978, and sent to the Tihar Jail on charges of breach of privilege and contempt of the House. Or when her son Sanjay Gandhi was sent to the Tihar Jail by the Supreme Court in 1979 on charges of forced sterilisation, interference in government work, the Maruti company controversy, and burning of the prints of the film KissaKursiKa during the Emergenc and pressurising the witnesses of the trial. In all these cases, the entire Congress took to the streets in defence of the accused Nehru family.

The questions to be asked are: When other senior Congress ministers and leaders are arrested, why doesn't the party stage any protest? Why is it only with the Nehru family?

The Congress Party and its leaders forget how, as Gujarat chief minister, Narendra Modi cooperated with the investigating agencies when he appeared



In situations like these, the basic difference between Modi and the Nehru family has to be understood. At that time, Modi, while addressing the media before going to the interrogation, had reiterated, "The Constitution of India, the law of India is supreme. As a citizen and chief minister, I am bound by the Constitution of India, by the law of India. No person can be above the law.'

tne other hand, Rahul Gandhi, before his interrogation, was planning with his party colleagues as to how to remain in the limelight by protesting violently in the name of Satyagraha.

Amit Shah was arrested in 2010 while serving as the home minister of Gujarat, and was called for interrogation several times by Central Bureau of Investigation. Even after getting bail from the Supreme Court, he was not allowed to go to Gujarat

because of pressure from the Congress government. Former Union minister and BharatiyaJanata Party national president MurliManohar Joshi, former Madhya Pradesh chief minister Uma Bharti, and Vishwa Hindu Parishad leader Ashok Singhal were also called for interrogation by the special CBI court on several occasions. In all these cases, neither the BJP questioned

the CBI over questioning nor did it organise protests and demonstrawould not take any breaks durtions against the Congress government. Everyone fully cooperated with the administration in their respective investigations. By compromising with criminals and the corrupt, the Congress also brought them up under its umbrella. For example, after the

arrest of Indira Gandhi on December 20, 1978, Bhola Nath Pandey and Devendra Pandey, flying from Lucknow to Delhi at 5:45 pm, hijacked the Indian Airlines plane Boeing 737 with 132 passengers in it and made a landing in Varanasi. They demanded her release and the withdrawal of all the cases against her and her son Sanjay Gandhi..

After coming to power, the Congress withdrew all the cases against these two devoted followers who worshiped the Nehru family, and gave tickets to both of them as their reward, making them MLA and MP; this was deplorable politics by any reck-

Monkeypox is no pandemic, not as deadly as Covid

But there will be much worse pandemics coming down the road in the future, and the world needs to be better prepared

onkeypox is very unpleasant and it spreads very fast, but it's not a real killer: 16,000 cases in 75 countries in just a couple of months is impressive, but there have been only five deaths.

Yet the World Health Organisation (WHO) has just declared monkeypox a global health emergency, which is a big deal. The only other infectious diseases in that category are Covid-19, which has already killed 6.4 million people, and polio (which is trying to make a comeback). Targeting monkeypox seems disproportionate, but there's a

reason. "Covid-19 is broadly viewed as being a 'once in a lifetime' or 'once in a century pandemic. Modeling work

based on historical data shows that this is not necessarily the case," reported the epidemiological start-up Metabiota last year. That's because "the frequency of 'spill-over' infectious diseases like Covid is steadily increasing.'

It's increasing because quick-killer pandemic diseases only started thriving in human societies when we began living together in large numbers. Lethal viruses and bacteria probably always 'spilled over' into human populations from time to time, but if they infected little hunter-gatherer groups of 50 or 100 people they just died out along with the victims.

The natural home of those diseases were birds and animals that lived in big flocks and herds: lots of potential victims to sustain the transmission. But

when human beings started living in big civilisations and domesticated some of those animals, the pandemic diseases happily transferred across and thrived amongst us too. For most of the history of

civilisation, successful transfers didn't happen all that often: big new killer pandemics only came along every five hundred years or so. However, now that there are eight billion people and millions criss-cross the planet every day, the disease vectors have more opportunities to spread and they move much faster.

At the moment, according to Metabiota's calculations, it's even odds that we will have another new pandemic on the scale of Covid-19 in the next 25 years. More precisely, they estimate the probability of anoth-

Covid to be between 2.5-3.3 per cent each year. It could even arrive next year.

Monkeypox is not that disease. Despite its rapid spread to so many countries, it is transmitted mainly between men who have sex with men. There is an existing, fully effective vaccine for it (the same one that eradicated smallpox, which no longer exists in the wild). And hardly anybody dies from it.

So WHO Director-General TedrosAdhanomGhebreyesus had some explaining to do when he broke a stalemate at his 'emergency committee' and decreed that monkeypox is a global emergency.

He explained that it was to speed up research on "the new modes of transmission that and he may come under seri-

er global pandemic as deadly as have allowed it to spread", and to press countries to use vaccines and other measures to limit the numbers infected. These are all sensible things to do, but they really don't justify declaring a global health

emergency. What he carefully avoided saying is that he really intends it as a reminder of our peril and a spur to action. The whole pandemic response system needs an exercise that incorpo rates all the lessons learned from our stumbling response to Covid, and monkeypox pro-

vides an excuse to do it. Ghebreyesus is manipulating the system in a wellmeant attempt to persuade the world to build better systems for containing dangerous emergent diseases in general,

ous fire for doing so.

But you can see his point, because we haven't learned enough from our harrowing experience with Covid. The vaccines were developed faster than in any previous pandemic, and two-thirds of the world's population has been fully vaccinated in about sixteen months, but the rate of immunity in the poorest countries is

abysmal. That leaves reservoirs of high infection that serve as breeding grounds for new variants of the virus, some of which may be able to evade the vaccines. This is an issue of distribution and organisation, not a medical issue, and doing it on a smaller scale for monkeypox could improve the system for the next time something truly dangerous appears.

The same goes for the initial phases of detection and containment, which were badly bungled with Covid. There will be much worse pandemics coming down the road in the future-WILL BE, not 'may be'and the world needs to be better prepared.

Just spending one-hundredth of what the world spent on fighting Covid to improve global readiness for dealing with the next pandemic-building local vaccine production facilities, regional labs with good analytical capabilities, and stronger reporting networks-could spare us another two years of the misery and loss we had with this pandemic.

If that's Ghebreyesus's real goal with this monkeypox business, it's all right with me.

Ukraine pushes to try war crimes as fighting rages



he appeal of Ukraine's first war crimes conviction was adjourned on Monday, as prosecutors keep pushing to hold Russia legally accountable for atrocities even as fighting rages in the south and east of the country.

Thin and subdued, Vadim Shishimarin, a 21-year-old captured Russian soldier who pleaded guilty to killing a civilian and was sentenced in May by a Ukrainian court to life in prison, sat in a glass box in the courtroom as he faced news cameras. The hearing was postponed until July 29 due to his lawyer's ill health.

Around Ukraine's capital region, where Russian forces pulled out four months ago, much of the work of documenting crime scenes and interviewing witnesses has been done. Now a more difficult phase in the search for accountability is underway: Finding those

"While conducting searches in the previously occupied region, we regularly find documents, passports and lists with names of participants of the units, with their complete data, including sites face war crimes trials so far in Ukraine,

of birth and dates of births," Andrii Nebytov, head of the Kyiv regional police, told The Associated Press.

"All of this information is being transferred to the relevant law enforcement. The investigators are working with the victims, trying to identify the people who committed crimes against them.

Shishimarin's case is unusual in that Ukrainian authorities quickly found evidence to link him with the shooting of a 62-year-old man in the northeastern Sumy region on Feb. 28. That's not the case for most war crimes cases now under investigation.

Ukrainian prosecutors have registered over 20,100 potential war crimes, and police in the Kyiv region have exhumed more than 1,300 bodies.

But as of July, prosecutors in Ukraine have only been able to identify 127 suspects, according to the prosecutor general's office. Fifteen of them are currently in Ukraine as prisoners of war while the rest remain at large. Those suspects include three accused of sexual violence and 64 accused of willful killing or illtreatment of civilians.

Shishimarin is one of 10 people to

in cases involving indiscriminate shelling, willful killing, sexual violence, robbery, ill-treatment of civilians and attacks on civilian objects. Six have been convicted, according to the prosecutor general's

The speed of justice in Ukraine has been unusual. War crimes prosecutions are rarely conducted during an ongoing

Ukraine's top prosecutors have long argued for speedy trials — in part to meet a seething public hunger for justice even as they work to maintain judicial standards that will satisfy domestic watchdogs and allies in the U.S. And

The prosecutor general behind this effort, Iryna Venediktova, was dismissed last week along with the former chief of Ukraine's SBU security service, Ivan Bakanov, for reportedly not doing enough to tackle "collaborators and traitors" in their departments. Her replacement is expected to be announced shortly.

Even as the hunt for war crimes perpetrators intensifies, the daunting work of documenting atrocities continues.

Victims of chaos and carnage in the early weeks of war in Ukraine were buried dug up for forensic examination. Kyiv regional police have exhumed 1,346 bodies, but more than 300 people are still

missing, according to Nebytov.

"Concerning the exhumations, I am sure that we are far from finishing it," he said in an interview Thursday. "This week we found a man who was executed with his hands tied behind his back and a hat over his head. The expert says that during the execution the man was on his

More than half of the victims police have found so far were shot dead; 38 of them were children. Kyiv police have found 13 mass graves in the region.

Nebytov said he has documented a litany of horrors: babies shot dead as their families tried to escape in civilian convoys, a man kidnapped as he gathered wood to make a fire and executed, civilians taken in for interrogation by Russian forces whose bodies were found with hands and eyes bound with tape, shot in the knees and shot in the head.

'With the intelligence at my disposal, I can say that there's no specific military strategy in sight. It is not a military strategy but rather terror," he said. "It is a concentration of evil, violence and cru-

Ruslan Kravchenko, chief regional prosecutor in Bucha, which lies just north of Ukraine's capital, told AP that he has sent over 2.000 cases to Ukraine's security services for further investigation and that new cases continue to come in every day — now, mostly for property damage.

Bucha, once a desirable, leafy town

outside Kyiv, has become a symbol of the carnage of the war started by Russia in February. Kravchenko said of the 327 murder victims in Bucha his office has documented, just three were soldiers and one was a police officer.

"I have never seen so many bodies," said Kravchenko, who worked in Crimea, which Russia annexed in 2014, and the Donbas, where Russia-backed separatists have been fighting the Ukrainian government since 2014, before moving onto Bucha. "I can see only one pattern: Where Russians saw civilians, they shot

the city of Kherson have been liberated forever," Kirill Stremousov was quoted as saying by Russian state news agency RIA Novosti. The developments came as Ukraine appeared to be preparing a counteroffensive in

Russia previously attacked Odesa's port at the weekend. The British military said Tuesday there was no indication that a Úkrainian warship and a stockpile of anti-ship missiles

British Defence The Ministry said Russia sees Ukraine's use of anti-ship missiles as "a key threat" that is limiting its Black Sea Fleet.

This has significantly undermined the overall invasion plan, as Russia cannot realistically attempt an amphibious assault to seize Odesa," the military said.

"Russia will continue to prioritise efforts to degrade and destroy Ukraine's anti-ship capability."

first head-on BBC television debate clash on Monday night was less than decisive, betting odds aggregator Oddschecker sees Truss pulling ahead in the race to succeed Boris Johnson as British Prime Minister with a 75 per cent chance of winning compared to Sunak's 25 per cent. The odds in favour of a Truss victory have risen sharply

Meanwhile, a YouGov survey of 507 Tory members, who will be among the estimated 180,000 to vote for the final winner, also favoured the Foreign Secretary. Sri Lanka's former president Gotabaya Rajapaksa is not in hiding and is expected to return to the country from Singapore, Cabinet spokesman Bandula Gunawardena said on Tuesday.

Indonesia's leader invites Chinese counterpart to G20 summit

Indonesian President Joko Widodo on Tuesday formally invited Xi Jinping to the Group of 20 summit in Bali this fall, although it's unclear whether the Chinese leader would attend in person.

The invitation came during a meeting between the two in Beijing, where they discussed issues ranging from trade to maritime cooperation.

"President Xi expressed his thanks and wished complete success for the summit," China's state broadcaster CCTV said, without giving further details. The summit is to be held on the Indonesian resort island on Nov. 15-16.

Xi has not left China since 2019 because of the COVID-19 outbreak, choosing instead to attend major events via video. It is also unclear whether he will attend the Asia-Pacific Economic Cooperation forum in Bangkok shortly after the G-20 summit. The G-20 is considered a valued grouping for China because it includes not only the rich Western countries but also the voices of major middle-income nations such as China, India and Brazil. State Councilor Yang Jiechi

and Foreign Minister Wang Yi have acted as Xi's proxies over the recent years, even while China's foreign and economic policies, including its tacit support for Russia in the Ukraine conflict, have put its relations with the US, Europe

Myanmar executions of 4 spur global outrage

International outrage over Myanmar's execution of four political prisoners intensified Tuesday with grassroots protests and strong condemnation from world governments, as well as fears the hangings could derail nascent attempts to bring an end to the violence and unrest that has beset the Southeast Asian nation since the military seized power last year.

Myanmar's military-led government that seized power from elected leader Aung San Suu Kyi in February 2021 has been accused of thousands of extrajudicial killings since then, but the hangings announced Monday were the country's first official executions in

"We feel that this is a crime against humanity," said Malaysian Foreign Minister Saifuddin Abdullah, speaking at the side of the United Nations' Special Envoy on Myanmar Noeleen Heyzer at a press conference in Kuala Lumpur. He said the executions

would be a focus of the upcoming meetings of the Association of Southeast Asian Nations foreign ministers, which begin in Cambodia in a week.

Myanmar is a member of the influential ASEAN group, which has been trying to implement a five-point consensus it reached on Myanmar last year calling for dialogue among all concerned parties.

Indiana abortion debate draws protest crowds

Thousands of people arguing the ■ abortion issue surrounded the Indiana Statehouse and filled its corridors Monday as state lawmakers began consideration of a Republican proposal to ban nearly all abortions in the state and Vice President Kamala Harris denounced the effort during a meeting with Democratic legislators. Harris said during a trip to Indianapolis that the abortion ban proposal reflects a health care crisis in the country. Despite the bill's abortion ban language, anti-abortion activists lined up before a legislative committee to argue that the bill wasn't strict enough and lacked enforcement teeth.

Indiana is one of the first Republican-run state legislatures to debate tighter abortion laws following the US Supreme Court decision last Supreme Court ruling is expected to lead to abortion bans in roughly half

"Maybe some people need to actually learn how a woman's body works," Harris said Monday, eliciting murmurs and laughs from the Democratic legislators. "The parameters that are being proposed mean that for the vast majority of women, by the time she realizes she is pregnant, she will effectively be prohibited from having access to reproductive health care that will allow her to choose what happens to her body. Confrontations erupted periodi-

cally between anti-abortion and abortion-rights demonstrators around the Indiana Statehouse. The framework for the Social Stock Exchange (SSE) has been developed on the basis of the recommendations of a working group and technical group constituted by the

The social stock exchange is a novel concept in India and such a bourse is meant to serve the private and nonprofit sectors by channelling greater capital to them. The idea of SSE was first floated by Finance Minister Nirmala Sitharaman in her Budget Speech 2019-20.

Under the new rules, SSE will be a separate segment of the existing stock exchanges, according to the three separate notifications issued by the Securities and Exchange Board of India (Sebi) on Monday.

Social enterprises (SEs) eligible to participate in the SSE will be entities -- non-profit organisations (NPOs) and forprofit social enterprises -- havtheir primary goal. Also, such an intent should be demonstrated through its focus on eligible social objectives for the underserved or less privileged populations or regions. PTI



Russia eyes 2024 Paris Olympics despite sports ban

With two years to go until the Paris Olympics open, Russia is making plans for its athletes to live and compete in the French capital even though many remain barred from upcoming qualification events because of the war in Ukraine.

Russian Olympic Committee president Stanislav Pozdnyakov wrote on the Telegram messaging app Tuesday that the country was working to get its athletes access to qualification events

and already making plans for the Olympic village in 2024. Most Olympic sports have suspended athletes from Russia and Belarus since the invasion of Ukraine began in February, following a recommendation from the International Olympic Committee. However, the IOC has not suspended the Russian Olympic Committee, the body which enters Russian teams for the Games.

"In exactly two years, the Olympic Games start in Paris. Despite all of the cir-

cumstances, the Russian Olympic Committee is a fullfledged participant in the Olympic movement,' Pozdnyakov wrote.

"We are continuing our systematic preparations for the Games and are also carrying out work to ensure qualifying opportunities and equal presence of our athletes in the Olympic village and at the venues, their participation in events during the Games."

Qualifying for some

Olympic sports has already begun, but others won't start until next year. If sports federations lift bans on Russian athletes competing in international events such as Olympic qualifiers, that could lead to boycotts by Ukraine.

The International Judo Federation has allowed Russia's team to keep competing as neutral athletes without their flag or anthem. In response, Ukraine refused to participate when Olympic judo qualifying began last month, in particular because it said that 11 of 24 athletes on the Russian team at the event were members of the

conduct the course. Two ISSF instructors, Ahmed Sief El Din Daoud of Egypt for Pistol and Natalya Zhukova of Russia for Rifle are currently in India to conduct the course. They are closely working with the likes of Samaresh Jung and Manoj Kumar.

BCCI set to bid for 2025 Women's WC hosting rights

India in all likelihood will host the Women's 50-over World Cup in 2025 as the BCCI is set to bid for the mega event.

If India wins the bid, the ICC flagship event will return to the country after more than a

The last time a women's 50over World Cup was held in India was back in 2013 when Australian emerged champions after beating the West Indies by 114 runs in the final in Mumbai

The ICC's Annual Conference is being held in Birmingham and it has been learnt that the bids for the four big women's ICC events for the next cycle will be accepted during the meet.

India will be favourites to host the 2025 edition of the global ODI event.

"Bids are being accepted for four women's events. The prominent amongst them are 2024 and 2026 ICC T20 World Cup and the 2025 edition of the ODI World Cup," an ICC Board

member said. The last big mega women's global cricket event held in India was the 2016 World T20 but that was primarily because ICC used to organise both men's and women's event simultane-

However, the system has changed with popularity of women's game increasing exponentially and ICC has segregated the events to procure the proper value for women's game with separate broadcast deal and exclusive coverage.

The 50 over Women's

World Cup however has been a stand-alone event since its inception in 1973, two years before the men's mega event started in England in 1975.

India have hosted the event thrice -- in 1978, 1997 and Those in the know of things

starting the Women's IPL from next season, I think they wouldn't like to hold any other marquee T20 women's event right away. Hence the decision to bid for the 2025 World Cup seems logical," the source said.

In the 2025 Women's World Cup, the hosts and five top nations from ICC Women's Championship (IWC) 2022-2025 will get direct entry into the tournament.

The remaining two teams will be identified through a global Qualifier comprising six teams. Out of six teams in the Qualifier, four will be from the IWC (rankings after top five teams) and the other two will be selected according to the ICC

Report finds Cricket Scotland 'institutionally racist' | Karunaratne, De Silva take SL's

An independent review into allegations of racism at Cricket Scotland has found the governance and leadership practices of the organisation to be "institutionally racist".

The report, which was described as a "wake up call for Scottish sport", found 448 examples of institutional racism.

A review was commissioned by sportscotland, the national funding body, last year after Scotland's all-time leading wicket-taker Majid Haq and former teammate Qasim Sheikh id they had suffered racist

As part of the review, an anonymous survey was carried out, with 62 percent of those who responded saying they had experienced, witnessed or had received reports of incidents of racism, inequalities or discrim-

Allegations include racial abuse, use of inappropriate language, favouritism towards white children from public schools and a lack of a transparent selection process.

The investigation, carried out by consultancy firm Plan4Sport, found Cricket Scotland failed in 29 out of 31 indicators of institutional



As a result of the findings, the governing body has been placed into special measures until at least October 2023, with sportscotland effectively taking control of the organisa-tion. "Governance and leadership practices of Cricket Scotland have been institutionally racist," said Louise Tideswell, managing director of Plan4Sport.

"The reality is that the leadership of the organisation failed to see the problems and, in failing to do so, enabled a culture of racially aggravated microaggressions to develop.

On Sunday, the board of Cricket Scotland resigned en

Interim chief executive Gordon Arthur said: "The racism and discrimination that has taken place in the sport that we all love should never have been allowed to happen, or to go unchallenged for so long.

"I would like to again issue a heartfelt apology to all those who have been the victims of racism and discrimination in Scottish cricket." Among the recommendations of the review are for the new board to be comprised of no more than a

60-40 gender ratio either way and a minimum of 25 percent of members should come from black, south-east Asian, or other mixed or multiple ethnic groups. The chief executive of sportscotland, Stewart Harris, described the findings as "deeply concerning and in some cases shocking".

"Today should also act as a wake-up call for all of Scottish sport," he added.

"Racism is a societal problem and it is no longer good enough to simply be non-racist, Scottish sport must now be actively anti-racist."
