As rebel camp swells, Sena seeks to disqualify 12 MLAs

mid the political crisis aris-Aing out of a massive rebellion within the ruling Shiv Sena deepening on Thursday and more MLAs joining the rebel camp, the Shiv Sena has moved a petition before the Deputy Speaker to take action against 12 MLAs.

Rebel Eknath Shinde's camp has claimed it enjoys the support of 42 MLAs, but NCP chief Sharad Pawar has said the MVA Government will survive and the situation will change dramatically when the rebel MLAs return to Mumbai.

The newly-appointed Shiv Sena legislature party leader Ajay Choudhari met the acting Speaker Narhari Zhirwal on Thursday and urged him to take action against the 12 rebel MLAs for violating party dis-

'National party' has assured all help: Shinde

Shiv Sena leader Eknath Shinde, whose rebellion against the party has pushed the three-party Maha Vikas Aghadi (MVA) government to the brink of collapse, said a "national party" has termed their revolt as "historic" and assured to provide all help to

A video of Shinde addressislators at a Guwahati hotel was released by his office here. The video also showed the legislators unanimously authorising Shinde to take further decision on their behalf as their group leader.

In the video, Shinde is seen as saying, "Our worries and happiness are the same We are united and victory will be ours. There is a national party, a 'mahashakti'...You know they vanquished Pakistan. That party has said that we have taken a historic decision and

assured to provide all help."
A statement issued by Shinde's office said the decision to authorise him to take decision on their behalf was taken

unanimously.

Sena leader Arvind Sawant said a whip was issued to MLAs and since they didn't obey and gave prior notice, our party has brought this to the notice of the Vidhan Bhavan. "Twelve names are there in the petition submitted to Maharashtra Assembly Deputy Speaker. Membership of Eknath Shinde, Balaji Kinikar, Lata Sonawane, and Bharat Gogawle among 12 others should be cancelled. We have asked the Deputy Speaker to take action against these 12."

Reacting to the Shiv Sena's move seeking disqualification of 12 MLAs in his camp, rebel leader Eknath Shinde said: 'The whip which you are cit-

ing for disqualification is for Assembly work and not meetings. We are the real Shiv Sainiks following the principles of Balasaheb.

Meanwhile, a day after Uddhav Thackeray offered to quit both as the Chief Minister and party chief if the rebel party MLAs were to meet him personally and ask him to put in his papers and moved out CM's official residence, Shinde — in a show of strength released a group photograph of 42 MLAs supporting him taken Government, NCP chief Sharad Pawar — who is the

The video that the Eknath Shinde camp circulated in the media showed the rebel MLAs sitting together and raising slogans like "Shinde Saab Tum Aage Badho, Hum Tumhare Saath Hain?

On a day when Uddhav Thackeray appeared reconciled to the prospect of the fall of his Government, NCP chief

Aghadi (MVA) Government expressed optimism that the MVA dispensation would survive the current crisis facing the Shiv Sena. "Let the MLAs come back from Guwahati. The situation will change drastically. The MVA Government will survive the floor test in the

State Assembly," Pawar said. Reiterating his party's support to Uddhav Thackeray, Pawar said it was the responsibility of all the three conand Congress — to "save" the Uddhav Thackeray Government.

Without taking the name of the BJP, Pawar slammed the BJP for the manner it fuelled rebellion within the Shiv Sena. "Everyone knows how the rebel Shiv Sena MLAs were taken to Gujarat and then to Assam. We don't have to take the names of all those assisting them. The Assam Government is helping them. I don't need to take any names further," he said.

The rebel MLAs will have to come back to Mumbai and face the Assembly, he said, adding that BJP leaders "from Gujarat and Assam will not be coming here to guide them."

Pawar also refuted allegations by rebel Shiv Sena MLAs that they faced difficulties in getting funds for their constituencies as the Finance Ministry, which is controlled by NCP's Ajit Pawar, discriminated against them, and the Sena has given up its Hindutva

ideology. "All these are excuses, some of these MLAs are facing a probe by Central agencies," he said. The NCP chief also said that the rebels will have to face consequences, recalling that when Chhagan Bhujbal defected from the Shiv Sena to join the Congress in the 1990s, all his supporters except one lost the Assembly election.

Let's meet halfway, China urges India

Beijing says interests outweigh differences. proposes four-point process to boost ties

Even as face-offs persist at the border in Ladakh for the last two years, China has urged India to meet "halfway", saying common interests outweigh differences between the two countries. China also called for enhancing mutual trust rather than remain "suspicious of each other."

This message was conveyed by Chinese Foreign Minister Wang Yi to India's ambassador Pradeep Kumar Rawat on Wednesday in Beijing. The Chinese minister also proposed a four-point process to improve ties between the two countries.

The Indian envoy emphasised the "criticality of maintenance of peace and tranquility in the border areas" to realise the full potential of the consensus between the top leaders of the two sides on the importance of Sino-India ties for Asia and the world. "Bilateral and multilateral

issues of interest to both sides were touched upon during the conversation" between Rawat and Wang, the Indian embassy other heads of states of the BRICS combine on Thursday.



on Thursday.

"Wang Yi conveyed that at the highest level of leadership of the two countries, there is consensus on the importance of bilateral relations for Asia and the world," the release said.

"Wang Yi said the border issue is important and we should stay committed to peacefully addressing it through consultation and coordination," it said.

The meeting between Wang Yi and Rawat came ahead of the virtual meeting of Prime Minister Narendra Modi with President Xi Jingping and

the first Chinese minister to visit India this March since the stand-offs erupted at the Line of Actual Control (LAC) in Eastern Ladakh in May 2020 leading to major flare up. He held talks with External Affairs Minister S Jaishankar to find ways for early disengagement of troops from the friction

China biggest security threat: Australia PIONEER NEWS SERVICE

ustralia on Thursday said Australia on Thankel, China is the "biggest security anxiety" as it is seeking to shape the world in a way that slammed China for its 'appalling behaviour" towards Indian soldiers two years ago in the Galwan valley in Ladakh.

Twenty Indian Army personnel, including the commanding officer, were killed in a bloody brawl with the Chinese troops on June 15, 2020. These remarks by visiting Australian Deputy Prime Minister and Defence Minister Richard Marles here came against the backdrop of China flexing its muscles in the Indo-Pacific, the South China Sea and the ongoing tension at the border in Ladakh.

Sounding this note of caution, Marles said India too has similar security concerns and that Australia stands in solidarity with New Delhi over its

border row with China. He also expressed concern over growing defence and security cooperation between China and Russia, suggesting that it back, Marles said his country could have implications for stands in solidarity with India the region. The visiting digniin respect of that incident. tary made these observations during an interaction with journalists.

Canberra are strongly committed to expand defence and security ties as his country sees India as "completely cen tral" to its world view.

Marles said New Delhi and

"For Australia, China is our largest trading partner and so is for India. For Australia, China is our largest security concern, that is also the same for India," he said.

India and Australia are working closely together not only to build our relationship economically but also in the context of defence so that together we are engaging more deeply to enhance the defence

and security of both our nations, Marles said.

In an apparent reference to the Galwan Valley clashes in eastern Ladakh over two years Twenty Indian Army personnel, including the commanding officer, were killed in a bloody brawl with the Chinese troops on June 15, 2020. More than 40 Chinese soldiers were also killed in the clash.

China is seeking to "shape the world around it in a way that we have not seen before' and that has resulted in "more assertive Chinese behaviour". especially in the last couple of years, Marles said

"We've seen it in respect of the Line of Actual Control (LAC)... the incident that occurred a couple of years ago, where there was an appalling behaviour towards Indian soldiers, and we stand in solidarity with India in respect of that

China's growing assertiveness in the South China Sea is aimed at deterring Australia's activities to protect the rulesbased order in that region, including the freedom of navsaid. Greater cooperation between Australia and India in the face of such Chinese assertiveness is "absolutely

'It is really important that we live in a world where there is a rules-based order, where disputes between countries are resolved as per a set of rules and in a peaceful way," Marles said. On the Ukraine crisis, Marles said, "What we are seeing in UKraine is having an impact on global food supply

and that is a real concern. He said a large country was seeking to overpower a smaller neighbor and this principle was there too in the Indo-

Delhi Covid number doubles, cases spike to 15K in country

With Delhi and Maharashtra recording sharp surge in Covid cases, the total caseload is likely to cross 15,000 mark on Thursday against 13,000 reported a day

As per the Government data, Delhi on Thursday reported 1,934 new Covid cases, almost double from the day before. The national Capital's active cases tally was recorded at 5,755, while the test positivity rate (TPR) was recorded at 8.10 per cent. Maharashtra reported 5,218 new cases of Covid-19, a jump of almost 60 per cent from the day before when the State had reported 3,260 infections.

Mumbai had also recorded a jump of 50 per cent in fresh infections, as the metropolitan on Thursday recorded 2,479 new cases. On Wednesday, the financial Capital had recorded 1,648 cases.

ED allows Sonia to appear in July end

The Enforcement Directorate (ED) has accepted Congress president Sonia Gandhi's plea to defer her questioning in connection with a money laundering case linked to the National Herald newspaper. The ED has now asked her to record her statement with the agency sometime in late July.

She was issued a second summons for June 23 by the agency but the 75-year-old Congress leader could not keep the date as she is recuperating from post-Covid implications. She has been strictly advised to rest at home following her hospitalisation on account of Covid and lung infection.

The ED has advanced her questioning in the case for week of July, sources said.

about four weeks and asked her to depose sometime in the last The move comes following a plea from Sonia, communicated on Wednesday to the ED, a few weeks in the wake of medical advice to take rest.

Sonia was first issued the notice for an appearance on June 8 but after she reported positive for Covid-19, the summons for June 23 was issued. The Congress president was on Monday discharged from a private Delhi hospital where she was admitted for treatment of Covid-19.

She was admitted to the hospital on June 12, days after she tested positive for Covid-19 on June 2. Her son and Congress MP

Rahul Gandhi has been questioned by the agency in the same case for about 54 hours over five days.

The probe relates to alleged financial irregularities in the Congress-promoted Young Indian Private Limited, which owns the National Herald newspaper. The move to question the Gandhis was initiated after the ED recently registered a fresh case under Prevention of Money Laundering Act

A case under sections 354(D) (stalking) and 509 (word, gesture or act intended to insult modesty of woman) of the Indian Penal Code was registered at Ambedkar Nagar police station on Wednesday following the complaint by the woman," said Benita Mary Jaiker, the Deputy Commissioner of Police (DCP), South district adding that further investigation is underway.

BODY OF WOMAN FOUND IN MOHAN NAGAR

New Delhi: The body of a 25-year-old woman with strangulation marks was found in west Delhi's Mohan Garden area on Thursday. The body was discovered by a local person who then informed police about it. Police said that the body was found in Bhagwati garden area of Mohan Garden police station. Prima facie, it appears to be a case of murder since the woman's body had strangulation marks.

1 DEAD, 6 RESCUED FROM ROHINI FIRE

New Delhi: A person died while at least six people were rescued after a fire broke out at a building at Pooth Kalan in Rohini area on Thursday evening. According to Atul Garg, the director of Delhi Fire Service (DFS) the fire department received information about the fire in the building, comprising ground and two floors, in Sector 5, Pooth Kalan, at 4.55 PM following which 10 fire tenders are at the spot and the blaze has been brought under control.

10-YR-OLD BOY SUFFOCATES BY ACCIDENT

New Delhi: A 10-year-old boy suffocated to death in a skipping rope accident while trying to enact a stunt he had watched in a video. The incident took place in northeast Delhi's Kartar Nagar area around 7 pm on Wednesday when he was at home with his mother. Police the boy used to watch a lot of videos of stunts and on Wednesday evening, while he was skipping inside a room, he tried to perform one such stunt but the skipping rope became wrapped around his neck and suffocated

EMPLOYEE OF MCG FACING CORRUPTION CHARGES

Gurugram: An outsourced employee of the Municipal Corporation of Gurugram (MCG) is facing corruption charges for committing fraud during the registry of MCG shops under the Haryana government's Mukhyamantree Shaharee Nikaay Svaamitv Yojana, also known as the chief minister's Urban Body Ownership Scheme. Under the scheme, "any tenant, who has continuously rented or leased a shop from the MCG for a minimum period of 20 years, as on December 31, 2020, is eligible to purchase the building or shop space at a discounted collector rate". It has been revealed that MCG employee Sunil Kumar has taken Rs 15 lakh on the registry per shop of the MCG.

2 ARRESTED FOR CHEATING

New Delhi: Delhi Police has arrested two men for allegedly cheating passengers on false assurances of confirming their train tickets and fleeing with their valuables in the national Capital. The accused have been identified as Ravi Kumar Mehto (38), a resident of Loni, Ghaziabad in Uttar Pradesh, and Kamlesh Kumar (22), a resident of Shakurpur.

Transporters urge Govt to find other means to curb pollution

The transporters in the The transporters in the national Capital on Thursday urged the Delhi Government to look for alternate means to curb air pollution stating that the move to ban the entry of medium and heavy goods vehicles in the city from November to February will lead to losses for

The Delhi government has issued an order banning the entry of medium and heavy goods vehicles in the capital from November to February to curb vehicular pollution.

However, trucks carrying essential items will be allowed to enter Delhi.

According to an official, entry of such vehicles will be banned from November 1, 2022 to February 28, 2023. Vehicular pollution leads to

deterioration of air quality during the winter months, the official added.

Bhim Wadhwa, ex-president of the All India Motor Transport Congress said bureaucrats frame policies without thinking about the general public or the stakeholders. How will such things solve the problem of pollution? The government had earlier also put similar measures in place but have they given any results?

"The government should share data of pollution levels on the days the ban was in place on earlier occasions and when there was no ban. The government had put up smog towers to curb air pollution. But have there been any results?" he asked.

Rajendra Kapoor of the Delhi Goods Transport Organisation concurred with Wadhwa and said Delhi's reputation as a retail hub will be badly hit due to the ban.

Truckers and traders will find alternative markets for buying goods and sending them with Delhi being shut for them. This will hurt Delhi's reputation as a retail hub. The businesses of petrol pumps will be severely affected. This ban will hit the transporters in a much more severe way than the Covid pandemic," he said.

Kapoor urged Delhi LG Vinai Kumar Saxena, Chief Minister Arvind Kejriwal and Transport Minister Kailash Gahlot to reconsider the decision of enforcing this ban.

"Please consider alternate ways to curb pollution by holding meetings with experts. If this comes into effect, it will affect transporters in a severe way and it will be difficult for them to recover from the

India rushes team to Kabul to monitor humanitarian assistance

India on Thursday rushed a team to Kabul to "closely monitor efforts" for the effective delivery of humanitarian assistance to the people of Afghanistan. This move came in the backdrop of more than 1,000 people dying in the earthquake there on Wednesday. The government did not

spell out the objective of sending a "technical team" to its embassy there which is closed since August last year after the Taliban took control of the country. A statement from the ministry of external affairs here on Thursday said "in order to closely monitor and coordinate the efforts of various stakeholders for the effective delivery of humanitarian assistance and in continuation of our engagement with the Afghan people, an Indian technical team has reached Kabul and has been deployed in our Embassy there.'

Recently, another Indian team visited Kabul to oversee the delivery operations of our humanitarian assistance to Afghanistan and met with senior members of the Taliban. During the visit, an assessment of the security situation was also carried out.

The Taliban has urged India to reopen its embassy in Kabul and assured of all security and assistance. It also appreciated the Indian aid in terms of the commitment to supplying wheat and medicines to the strife-torn country. Several consignments have already reached Afghanistan through the land route passing through Pakistan.

The ministry statement referred to the recent visit to Kabul by an Indian team led by joint secretary JP Singh, the external affairs ministry in charge of Afghanistan, to oversee the delivery of humanitarian assistance and to hold meetings with senior Taliban members.

"Our longstanding links with Afghan society and our development partnership, including humanitarian assistance for the people of Afghanistan, will continue to guide our approach going forward," the statement said.

An Indian team was to travel from New Delhi to Kabul on June 18. The visit was called off following a terror attack on Gurdwara Karte Parwan in the Afghan capital.

Afghanistan ambassador to India Farid Mamundzay appreciated the support extended by India. "Appreciate the solidarity and support of India at this difficult time. The humanitarian situation in Afghanistan was already going from worse to worst - and with the occurrence of natural disasters like the recent earthquake make life unbearable many Afghans,"

Kids as young as 3 also suffer from long Covid

hildren as young as three-years-old also suffer from long Covid that can last at least two months, according to a study published in The Lancet Child & Adolescent Health. The most commonly reported symptoms among these children were mood swings, rashes and stomach aches. In one of the largest studies, researchers from Copenhagen University Hospital, Denmark analysed data from a survey of 11,000 children aged 0-14 with a positive Covid-19 test result between January 2020 and July 2021.

The data were then matched by age and sex to over 33,000 children who had never tested positive for Covid.

Among 4 to 11-year-olds the most commonly reported symptoms were mood swings, trouble remembering or concentrating, rashes, and among 12 to 14-year-olds it was fatigue, mood swings and trouble remembering or concentrating.

The results of the study found children

diagnosed with Covid-19 in all age groups to be more likely to experience at least one symptom for two months or longer than the con-

In the 0 to 3-year age group 40 per cent of children diagnosed with Covid-19 (478 of 1,194 children) experienced symptoms for longer than two months, compared to 27 per cent of controls (1,049 of 3,855 children).

For the 4 to 11-year age group, the ratio was 38 per cent of cases (1,912 of 5,023 children) compared to 34 per cent of controls (6,189 of 18,372 children), and for the 12 to 14-year age group, 46 per cent of cases (1,313 of 2,857 children) compared to 41 per cent of controls (4,454 of 10,789 children) experienced longlasting symptoms.

'Our findings align with previous studies long Covid in adolescents showing that, although the chances of children experiencing long Covid is low, especially compared to control groups, it must be recognised and treated seriously," said Professor Selina Kikkenborg Berg from the hospital.

Mandaviya, who chaired a meeting with key experts and officials amid an upsurge of Covid-19 cases in some States, stressed the need to focus on districts reporting high case positivity and undertake adequate testing (with higher protive surveillance to assess and control the spread of the infection in a timely manner, the Ministry said in a statement.



43.75% voter turnout in Rajinder Nagar bypoll

The Rajinder Nagar Assembly constituency recorded a 43.75 per cent voter turnout till 6 P.M. in the bypolls on Thursday. This is significantly less than the figures recorded in the 2020 polls, when the voter turnout in Rajinder Nagar was 58.27 per cent. The bypoll to the Rajinder Nagar seat is largely being seen as a battle between a confident AAP and a spirited BJP.

According to the Election Commission (EC), the final voter turnout at the close of polling on Thursday stood at 43.75 per cent. Also, 24 Covidpositive voters turned up to cast their votes. "From 7 A.M. to 6 P.M., a total 100 senior citizens including 658 women voters were provided pick and drop facilities to cast their votes.

Delhi Chief Election Officer (CEO) Ranbir Singh said efforts have been made to

to the polling booths. Availability of water and the poor condition of roads were issues reigning on the minds of voters who turned up to vote.

The bypoll were necessitated after former AAP MLA from the area, Raghav Chadha, was elected to the Rajya Sabha from Punjab. While AAP fielded its MCD in-charge Durgesh Pathak from the constituency, he is up against former BJP councillor Rajesh Bhatia. The Congress has also put forth former councillor Prem Lata.

There are over 1.64 lakh voters in the constituency. Of these, 92,221 are male, 72,473 are female and 4 are categorised as 'third gender'. There are 1,899 voters between the ages of 18-19 who are eligible to vote for the first time in the constituency.

The candidates since morning were seen at the polling booths. Rajya Sabha Vidya Bhawan GSSS, New Rajinder Nagar polling booth.

The BJP candidate, Rajesh Bhatia along with his wife and parents also voted around 8 A.M. at Salwan Girls School voting centre. BJP MP Gautam Gambhir and his wife also cast their vote.

Prem Lata, the Congress candidate from the seat cast her vote at 1 P.M. along with her whole family at number 173 voting centre.

The poll body has registered 13 cases against the AAP, nine against the BJP and one against the Congress for violation of the MCC. According to officers, 47,180 defacements have been removed by the MCD. "We have also penalised vehicles that were displaying posters and banners in an inauthorised manner."

A total of 188 people have been fined - 123 against AAP, 49 against BJP and 16 against MP Raghav Chadha also came others. As a preventive action,

Action was taken against 8,708 people under Delhi Police Act, while 36 people were arrested and 1,850 litres of liquor worth Rs 5.65 lakh was seized under the Excise Act.

A total 36 FIRs lodged and 36 arrests made so far, the CEO said. The enforcement agencies have seized 280 licenced arms under the Arms Act and lodged five FIRs. It has also seized five illegal arms and arrested five people.

'4 suspended babus used to transfer evacuee properties to private entities'

has reached near two thousand 'mark' in covid cases in last The single-day figures were over 108 per cent higher than the previous day's figures. On February 4, the capital had

logged 2,272 cases and 20

deaths with a positivity rate of 3.85 per cent. The national capital, however, did not see any fresh death with the toll currently standing at 26,242. Three lives were lost to the virus a day ago. Delhi's active case count not stood at 5,755, while the overall infection tally rose to 19,27,394.

According to the state health bulletin, there are now 309 containment zones in Delhi and the 332 calls have been received on covid helpline number in last 24 hours.

On Tuesday, the city reported 1,383 fresh coronavirus cases with one death. However, the positivity rate

dipped to 7.22 per cent, three 20 deaths while the positivity per cent down as compared to Monday's 10.09 per cent. With the new COVID 19 cases, the total tally of active cases in Delhi climbed up to 5,595.

The capital on Monday reported 1060 fresh coronavirus cases with six deaths, while the positivity rate stood at 10.09 per cent.

with three deaths, while the positivity rate stood at 8.41 per cent, according to the data released by the city health department. Delhi on Saturday report-

HDFC staffer among three arrested for cheating hundreds of account holders

Culprits used to cheat clients by re-issuing SIM cards on fake IDs using bank data

Three men, including an employee of a HDFC bank, were arrested from Delhi's Rohini for allegedly cheating hundreds of bank account holders by re-issuing SIM cards on fake IDs, using stolen customer data from the bank.

The accused, identified as Sunny Kumar Singh (27), Kapil (28) and Pavin Ramesh (21), were arrested on June 20, while another member Rakesh is absconding. Police said that manhunt has been initiated to nab the remaining accused.

According to Sagar Singh

Commissioner of Police (DCP), north district, they have also recovered 12 SIM cards, five mobile phones, eight debit cards and two fake Aadhaar cards from the accused, and also identified three bank accounts involved in

Two fake bank accounts which were used to transfer money were also identified and are being scrutinized. Sunny, who works at the credit card sales department of a bank in Rohini, collected details of mobile numbers, email, addresses and ID proofs linked to the bank accounts," said the DCP.

Meanwhile, Kapil, Pavin and Rakesh made fake ID proofs with these details and reissued SIM cards of the phone numbers linked with the accounts. Police team which had been working for two

weeks finally zeroed in on the location of accused persons at Jain Nagar in Rohini," said the DCP. "An HDFC account holder in his complaint filed in May alleged that he received a message regarding reissuing of his SIM card and password change of his gmail ID. Later, he found that his

7. Further, the FSL authorities handed over DNA profiles of three unknown dead bodies on the evening of June 7.

According to Sameer Sharma, the Deputy Commissioner of Police (DCP), Outer district, on Wednesday, four DNA profiles were received regarding which we will hand over the bodies to concern.

"There are five bodies in Sanjay Gandhi hospital out of which the post-mortem of four Soni Kumari, Monika, Parveen and Ranju Devi -- will be conducted on Thursday. Two DNA reports are pending from forensic science labora-

tory (FSL)," said the DCP. On May 14 (next day of the incident), eight bodies were identified by the family members and handed over to them. The FSL reports of seven were

correctly matched with the samples of family members.

However, the same of one Ranju Devi could not match. On Wednesday, the FSL report was received which showed that out of five bodies, there is one of Ranju," said the DCP.

On Thursday, it is being handed over to the family, police said. Santosh Kumar, the husband of Ranju, identified her body through her turtleshaped ring and two bangles -- the only items that remained unburnt on her charred body.

CONGRESS DARES ED TO PROBE ADANI GROUP

Why is ED sitting over allegations that Modi was pushing its case for a project in Lanka: Gourav Vallabh

fter senior Congress leader Rahul Gandhi's five-day grilling by the Enforcement Directorate (ED), the Congress on Thursday asked when the probe agency would question the Adani Group over allegations that Prime Minister Narendra Modi was pushing its case for a project in Sri Lanka. The party accused the ED of taking "enforced directives" from the Modi Government.

The Sri Lanka issue was reported in a section of the media, but has been denied by the Lankan Government as well as the Adani Group. At an AICC press conference, Congress spokesperson Gourav Vallabh cited reports of the chairperson of the Stateowned Ceylon Electricity Board (CEB) in Sri Lanka making claims before a parliamentary panel that the Indian Prime Minister had allegedly "pressurised" Sri Lankan President Gotabaya Rajapaksa to award a wind power project to the Adani Group.

"What was his compulsion? Why are ED and other agencies sleeping on this information?" the Congress leader asked.

"Is this not a case of corruption worth investigating? Which bureaucrats or Ministers is the ED



planning to call for an investigation? Has the ED ever called anyone from the Adani Group, or is it planning to call to investigate these serious allegations? What credibility does an agency like the ED have... (it) is on a political witch-hunt but failing on its duty of investigating severe allegations

and crimes," he said. CEB Chairperson MMC Ferdinando, who claimed before a parliamentary panel that Modi allegedly influenced Gotabaya Rajapaksa to award a wind power project to the Adani Group in the island nation, resigned a day after retracting his statement.

During a hearing of the Committee On Public Enterprises (COPE), Ferdinando had said Rajapaksa summoned him after a meeting in November last year and told him that the wind power project must be awarded to Adani Group's Gautam Adani as Modi had urged that it be so. Rajapaksa

had categorically denied Ferdinando's statement before

the parliamentary panel.

The Adani Group earlier issued a statement on the controversy. "Our intent in investing in Sri Lanka is to address the needs of a valued neighbour. As a responsible corporate, we see this as a necessary part of the part-nership that our two nations have always shared," it said

During the press conference, Vallabh also spoke on Rahul Gandhi's questioning by the ED over the last few days and said it was a clear case of maligning his reputation and a "mere political

He alleged that all central agencies have been reduced to pawns in the hands of the Government. "All these agencies have been queuing up to collect their blindfolds only to make a mockery of themselves," Vallabh said, adding that the BJP Government's claims have been exposed in the last eight years and it has all been about "antics and substance".

"A once-reputed agency such as the ED can no longer be called the Enforcement Directorate... (it) is busy taking 'Enforced Directives' from the Modi Government," he alleged.



Unitech assets worth ₹257 crore attached provisionally, says ED

The Enforcement Directorate (ED) on Thursday said it has provisionally attached movable and immovable assets worth ₹257 crore in Gurugram, Goa, Chennai and other places in a money laundering case against Unitech Limited.

The total proceeds of crime detected by the ED in the case is ₹6,452 crore.

"The provisionally attached properties include residential/commercial units, land parcels, demand drafts, equity shares and bank account balances. The properties are owned by CIG (Chandra Investment Group) Realty Fund and Authentic Group. Two Separate Provisional attachment orders were issued for attaching these assets, the ED said in a statement.

The ED had registered a money laundering case against Unitech Group on June 6, 2018 following a directive of the Supreme Court.

The money laundering case was registered on the basis of FIRs registered by Economic

Offences Wing (EOW), Delhi houses, homebuyers' funds to Police and Saket police station here under various sections of the Indian Penal Code (IPC) and relevant provisions of the Prevention of Corruption Act.

For purchasing these properties, homebuyers' funds of Rs 244 crore were illegally diverted by the Unitech promoters to CIG Realty Fund.

The diverted funds were used to purchase land-owning companies of Unitech Group, the agency said.

Aurum Asset Management Private Limited was one of the companies controlled by the

Chandra family, the promoters of the Unitech Group, which was used to manage the affairs of CIG Realty Fund. This company was also used by Chandras' to siphon-off the investors' funds from the accounts of CIG Realty Fund, it said.

"The misappropriated funds were used to finance the illegal activities of Chandras such as bribing certain Tihar Jail officials and other personal expenses of Ajay Chandra and Sanjay Chandra," it said.

Uddhav's precarious position in Maharashtra may be a setback but doesn't mean the end of the road

aharashtra Chief Minister Uddhav Thackeray's departure from his official residence 'Varsha' on Wednesday night to his family's hold over the may seem to be a decline, if not the end, of his family's hold over the huilt It was quite emotional, with a large numparty that his father, Bal Thackeray, built. It was quite emotional, with a large number of Shiv Sainiks showing solidarity with him. As emotional as his (farewell?) speech: "Will quit as Chief Minister and leave official residence if even one of the disgruntled MLAs says he doesn't want me as Chief Minister." His speech was on Facebook, as he has been infected with the Coronavirus. He made three main points that need to be highlighted. One, he presented himself as an atypi-



cal politician; he is not among those for whom power is to be grabbed at any cost: "I have kept letter of my resignation as Chief Minister ready, willing to resign this very moment." Two, his party is still with him: "Getting calls from MLAs who have gone with Eknath Shinde; they are claiming that they were forcibly taken away." And, finally, he has reiterated his adherence to Hindu nationalism: "Shiv Sena can't be separated from Hindutva." His followers and sympathisers will agree with him, but others may like to raise a few questions. The Shiv Sena fought and won the 2019 Assembly election in alliance with the Bharatiya Janata Party,

with the BJP's Devendra Fadnavis as the chief ministerial candidate. Then why did Shiv Sena ditch the BJP, the only other Hindutva force in the country, for the parties that are inherently anti-Hindutva?

Further, are Shiv Sena legislators calves and cubs that could be forcibly taken away to a State hundreds of miles away? And if that is the case, Thackeray cannot be absolved of the blame of having given tickets to so many weaklings, for he also happens to be the supreme leader of the party. One can still sympathise with a leader who has been abandoned by his followers, but his competence in running the party and Government leaves a lot to be desired. He obviously failed to gauge the intensity of resentment in his own party, as is evident from the fact that two out of three of his MLAs were with Shinde. The exodus continues. On Thursday morning, three more Sena MLAs — Deepak Kesakar, Mangesh Kudalkar and Sada Sarvankar — flew to Assam where the rebels are camping. So, is the party over for Uddhav, indeed for the Thackeray family? If that is the case, it may imply that a political party has been able to shrug off the shackles of the family that birthed it. It would, however, be premature to reach the conclusion that the Thackeray family's political career has ended; it is down but it may not be out. Like Chirag Paswan, who lost control over the LJP but claims to be the inheritor of Ram Vilas Paswan's legacy. Let's wait and watch.

Vendetta?

The UP Govt's action of bulldozing illegal houses in the State has raised a lot of heat and dust

The Yogi Adityanath-led Uttar Pradesh Government has been brazening out the allegations of 'bulldozer politics', which is basically a euphemism for targeting those people who have been speaking out against the ruling BJP Government. The issue snowballed into a major controversy after the properties of certain people accused of participating in violent protests against remarks by two former Bharatiya Janata Party (BJP) leaders on Prophet Muhammad were demolished to allegedly punish them for raising their voice against the establishment. In fact, the issue has reached even the Supreme Court, where the State Government submitted that "no property in the State was demolished to punish" people. Though the State has clarified that bulldozers were pressed into service to raze illegal constructions in accordance with municipal laws and after providing due opportunity to the violators, it is too much of a coincidence that the action came about soon after protests broke out in Kanpur and

Prayagraj in the first fortnight of June against now-suspended BJP spokesperson Nupur Sharma and expelled party leader Naveen Jindal for their remarks against Prophet Muhammad. Subsequently, the UP Government demolished three properties in these cities.

The Government took the stand that these demolitions "had no relation to the riots", and that the actions were taken as part of the ongoing demolition drive against encroachment and illegal construction. Though it sounds like the first plausible excuse that the State Government took the stringent steps in accordance with statutes, the two applications filed by Muslim body Jamiat Ulama-i-Hind asked for restrictions on the State Government on further action. However, the Government's

contention was that the organisation "deliberately obfuscated the true facts to paint a nefarious picture of alleged mala fide on the part of the administration". Referring to the two properties partly demolished in Kanpur, the Government claimed that proceedings were initiated under municipal law long before the riots in June — in one case, in August 2020 and, in another, in February 2020. The violators are said to have even admitted to the illegality of the buildings and moved applications for compounding the acts by payment of appropriate charges. INDIA AT BRICS AND G7: TOUGH BALANCING ACT

Navigating through China's assertiveness, Putin's Ukraine war

ndia's diplomatic and foreign policy calendar has been swinging between a diverse bunch of power blocks. India had a tough challenge to attend the 14th BRICS summit held virtually under the chairmanship of Chinese President Xi Jinping.

It was a tough call, given India's frosty relationship with China over the border tensions and sharing a platform (virtually) with Russian President Vladimir Putin, now considered a global outlaw. The BRICS summit was themed on Global Development; it's actually a message China wants to send across, placing itself at the centre of economic prosperity for the globe. This position has traditionally been claimed by the US and its Western allies.

It is interesting to note how the Chinese communist party's foreign policy propaganda newspaper, the Global Times, reported on the significance of the BRICS summit. In one of its recent reports, it mentioned the most novel proposition of this summit, BRICS expansion. The presence of Putin and several new invitees is also open to various interpretations. The Ukraine crisis has seen fissures emerge in the G20; and adding new members to BRICS could make it an alternative minus US



This could also mean an expanded BRICS overtaking G7 earlier than imagined. In some of the other paragraphs the report lays emphasis on the "Global South cooperation," the presence of India in both the USled Quad framework and BRICS, India's exit from the China-led Regional Comprehensive Economic Partnership (RCEP), while accepting to be a founding member of US-led Indo Pacific Economic Framework (IPEF).

While China's foreign policy department officially stuck to "high-quality partnership amongst BRICS, usher in new era for global development," as the core agenda, its allied arms such as the newspaper report mentioned above was setting the real agenda for the summit

India moves away from the BRICs summit to another important multilateral, the Commonwealth Summit which is taking place in Rwanda's capital Kigali over the weekend. Leaders of 54 countries from Asia, Africa, South America, and Europe participate in the commonwealth summit which most often has been described as a club of erstwhile UK colonies, discussing their internal affairs, rather than coming out with a significant outcome-driven agenda for world affairs.

However, this diverse group of nations also represents the conflu ence of developing and the developed world, the former rulers meeting the former colonies, to indulge in some creative solutions for existing and emerging problems. It is a different matter that much of the commonwealth nations except the larger and more prosperous ones have been denied access to vaccines and therapeutic remedies to counter the Covid pandemic by the powerful nations. India will be represented at the summit by External Affairs Minister S Jaishankar.

However, one of the most eyeball-grabbing meetings will be the G7 in Schloss Elamau, against the backdrop of the Bavarian Alps in Germany next week. India has been invited for this meeting as a guest and will be represented by Prime Minister Narendra Modi in person. This is the fourth consecutive time India has been invited for this prestigious global policy leaders meeting.

The G7, which is a group of most prosperous nations of the world which are some of the largest donors to international bodies, together make the most influential voice for global policy directions. This year, the G7 presidency has been taken over by Germany, which will push for some coordinated policy actions on the ongoing war in Ukraine, its impact on food inflation, particularly in the developing nations, the climate crisis, the Covid pandemic, and its impact.

COVID crisis led to distress employment

There is an urgent need to generate more decent and productive employment for the increasing labour force in the country

he National Statistical Office (NSO) released the Periodic Labour Force Survey (PLFS), 2020-21 report on June 14. At a first glance, the annual survey report shows an improvement in the employment situation with rise in employment and decline in the unemployment rate during the pandemic years compared to the previous years (PLFS survey years correspond to the agriculture year July

This is quite unexpected, keeping in mind the severe economic disruption after the Covid-19 pandemic. The survey results differ from several other reports, which suggest that the employment situation in the country has worsened after the pandemic. This survey report has evoked heightened interest in the findings. It calls for further investigation as to whether these results are survey anomalies or indicate the changing employment situation in the country.

This article attempts to interpret the findings from the last three annual PLFS (2018-19, 2020-21 and 2020-21) reports, and try to understand the impact of Covid-19 pandemic by analysing some key labour market indicators.

The labour force participation rate as per usual status (reference period of last 365 days preceding the survey), which is the sum of those working and those available for work or unemployed, reported highest in the four years at 41.6 per cent in 2020-21. The worker population ratio (WPR) has increased from 35.3 per cent in 2018-19 to 39.8 per cent in 2020-21, which is the percentage of employed persons in the population.

On the other hand, the unemployment rate which is the percentage of unemployed in the labour force has eased from 5.8 per cent in 2018-19 to 4.2 per cent in 2020-21. The rural-urban division shows that the rise in WPR is in rural areas, which is almost 2.5 times higher than urban areas. It is well documented that the impact of Covid-19 in the rural economy was far less than urban, which is also reflected from the survey results.

A lot of people, particularly migrants engaged in the informal sector, lost their employment during the pandemic at the urban destinations. With no means of employment in urban areas, a large number of them have returned to their native places in rural areas, where they, along with their family members especially women, are engaged in locally available activities such as agriculture and related work for survival.

The survey results further reveal that the rise in WPR is largely credited to female than male, where WPR of the former has increased by 2.54 times more than the latter. This phenomenon is more pronounced in rural areas, where the female WPR has increased almost 3.2 times more (19.0 per cent to 27.1 per cent) than their urban counterparts (15 per cent to 17 per cent) during the pandemic years.

So, the rise in employment during the

The industrial structure provides broad employment trends, where the employment in agriculture in developing countries like India is considered as subsistence and less productive, while employment in non-farm industrial and services is regarded as more productive. It is well documented that as the country progresses, the people move away from the less productive agriculture sector in rural areas to more productive nonfarm industrial and services sectors

However, the industrial distribution of employment in India shows a reversal of the decades-long decline in agriculture share in recent years with more and more people moving into the farm sector in rural areas. The share of employment in agriculture has increased by 3 percentage points from 57.8 per cent in 2018-19 to 60.8 per cent in 2020-21.
This trend indicates that peo-

ple are finding it difficult to get employment in non-farm sectors, and they are compelled to engage in subsistence farm activities due to the lack of other employment avenues. In rural areas, almost three-fourth (75.4 per cent) of the females are engaged in farm activities compared to around half of the male (53.8 per cent).

Thus, the rise in employment in rural areas has a huge implication on women's work, which is also reflected from increasing female's WPR. This reveals that the rise in share of employment in agriculture reflected the impact of economic slowdown and the pandemic.

The reverse migration from cities to rural areas would have only increased the pressure on the farm sector to absorb the workers, especially females, leading to the distress

employment. The status of employment broadly indicates the quality of employment, where a regular salary is considered better quality of work than self-employed and casual labour. Regularity of work and social security benefits are associated with regular salaries, while social security provisions are generally not available for self-employed and casual labourer.

The PLFS survey reports show that the share self-employed has increased from 52.1 per cent in 2018-19 to 55.6 per cent in 2019-20, while the share of regular salaried (23.8 per cent to 21.1 per cent) and casual labour (24.1 per cent to 23.3 per cent) has declined during the last three years. This phenomenon is more pronounced in rural areas, where the share of the self-employed has increased relatively more (3.3 percentage points) than urban areas .7 percentage points).

However, the increase in share of the self-employed in rural areas is largely attributed to the rise in unpaid helpers in household enterprises (4.6 percentage points), while the share of own account workers and employer category has declined (-1.4 percentage points).

This indicates that the jump in female WPR in rural areas is contributed most by the increase in employment of helpers or unpaid family workers in household enterprises. A recent Niti Aayog report highlighted that the rise in 'disguised employment' or unpaid family workers is a more serious issue than unemployment in India. The decline in the share of regular salaried workers is another serious

concern, reflecting the worsening employment conditions with rise in low quality employment in recent pandemic years.

The above analysis reveals that the increase in employment in pandemic years is distress-driven and not necessarily any improvement in the overall employment in the country. This is shown in the report as an increase in terms of labour force participation rate, the worker-population ratio, and decline in the unemployment rate. It is also important to note that the share of employment in agriculture and allied activities, and especially employment of rural women, has gone up in recent years, which is mostly of distress type not productive or decent employment.

Further, the report also reveals that employment in the informal sector has increased during the pandemic years from 68.4 per cent to 71.4 per cent in 2020-21. Workers in the informal sector are for the most part not covered by any social security benefits and also not covered by the national labour laws and regulations. Such workers are most affected by any economic shocks such as the economic downturn after Covid-19.

In sum, the PLFS survey report (2020-21) indicates generation of new employment in the country during the pandemic years, but most of the new jobs are of distress or informal type, especially for females in rural areas.

In this context, there is an urgent need to generate or provide more decent and productive employment for the increasing labour force in the country, which is must to meet the SDG goal 8 targets of 'decent or productive employment for all' by 2030.

India emerges as leader at WTO ministerial meet

India defended its right to extend subsidies to Indian fishermen, with contentious clauses removed

or the first time in a decade, members of the World Trade Organisation (WTO), a 164-nation body, have finalised a historic deal at the 12th Ministerial Conference (MC12). The four-day MC12 was extended by two days as trade ministers negotiated through the night at WTO headquarters, next to Lake Geneva, and negotiations continued till June 18 morning. India was at the centre of WTC negotiations at the MC12.

India has agreed to the proposal of no export restrictions on the World Food Programme. But internal food security concerns will take precedence. There is no work programme on agriculture, which could be considered as a good outcome for India as our agri-subsidy will not face any further scrutiny.

On the trade-related intellectual property rights (TRIPS) waiver, an agreement could be reached only on vaccines. The official said negotiations for diagnostics and therapeutics would start in six months as demanded by developed coun-

This means India's demand to include diagnostics and therapeutics in the agreement did not find favour with developed countries. In October 2020, India, South Africa, and 63 cosponsors had made the TRIPS waiver proposal to help middleand low-income nations get access to Covid-19 vaccines and drugs. However, the discussions reached a deadlock in the TRIPS Council, the body responsible for monitoring the operation of the agreement. The draft agree-

ment fell short of the original

proposal and includes only vac-

India had called for a TRIPS waiver for vaccines, therapeutics, and diagnostics to fight Covid-19 and future pandemics. India had held it was too late in the day if only vaccines were included because the pandemic had run its initial course. On a moratorium on customs duty on ecommerce transactions, countries agreed to extend it by another two years

India put forth aggressive draft texts in all pillars of WTO negotiations rather than being reactive, as in the past. India brought the members together to a unanimous agreement on fisheries, health, and the future of WTO reforms, digital technology, food, and environment. India's principled stand at the WTO strengthened the voice of the poor and the vulnerable globally.

An agreement at Geneva makes it the first trade deal since the 2013 Bali Ministerial, where members signed the WTO's first trade deal on a peace clause on public stockholding for food security purposes and a trade facilitation agreement. The consensus-driven, rule-making process at the multilateral trade organisation means even one member could thwart a deal at the last moment. After negotiations spilled over to the sixth day, 164 countries of the World Trade Organisation finally sealed a package deal in the wee hours on 18 June in Geneva with India leading the course.

In a first major agreement in nine years, the deal includes six major issues of importance for developing countries including

food security, balanced outcome fisheries subsidies, response to pandemic, and patents waiver on Covid-19

The deal that tested Commerce & Industry Minister Piyush Goyal's negotiation skills saw several trade-offs between developed and developing countries during the two nights of marathon talks, going well past

the June 16 afternoon deadline. There is a good outcome on the issues that were long pending," Goyal said, adding that India completely protected the interests of fishermen and farmers. "All in all, it is a good package. Today there is no issue on which we have to be concerned, whether it is related to agriculture such as MSP [minimum support price], reinforcing the

relevance of the public stock-

holding programme towards fulfilling the national food safety programme or PM Garib Kalyan Scheme, TRIPS waiver, e-commerce moratorium, response to Covid and fisheries," Goyal said after the deal.

India defended its right to extend subsidies to Indian fishermen, with contentious clauses removed from the text at the last minute. In turn, India agreed to an 18-month extension of the moratorium on customs duty on electronic imports that it argues favours rich nations. However, subsides on overfishing, deepsea fishing; and illegal, unreported and unregulated (IUU) fishing has been addressed through the proposed pact.

"On India's insistence, sovereign sights on EEZ [exclusive economic zones] have been firmly established. It is really a

big achievement," said Goyal, adding that principal stakeholders who have benefited from these "historic decisions" taken by the 12th Ministerial Conference of the WTO are fishermen, farmers, food security, multilateralism, and trade and business, particularly digital economy and MSMEs. Through the joint efforts of

all WTO members, the MC12 has made breakthroughs on a number of key issues, demonstrating that the multilateral trading system can play a key role in addressing global challenges, she said.

Goyal said India today batted on the front foot rather than being fearful on various issues, be it environment, startups, MSMEs or gender equality. This was a result of the confidence of 'New India.'

RUSSIANS FOCUS FIREPOWER TO SEIZE 2 VILLAGES IN EAST UKRAINE

¬he Russian military expanded its grab of territory in eastern Ukraine on Thursday, capturing two villages and vying for control of a key highway in an offensive that could cut supply lines and encircle some frontline Ukrainian forces, British and Ukrainian military chiefs said.

Britain's defense ministry said that Ukrainian forces had withdrawn from some areas near the city of Lysychansk, the latest major battlefield in Russian President Vladimir Putin's war against Ukraine, to avoid the possibility of being encircled as Russians sent in reinforcements and concentrated their firepower in the

Ukraine's General Staff said Russian forces took control of the villages of Loskutivka and Rai-Oleksandrivka, and were trying to capture Syrotyne outside Sievierodonetsk

For weeks, Russian forces have pummeled Sievierodonetsk, the administrative center of the Luhansk region, with artillery and air raids, and fought the Ukrainian army house-to-house. Ukrainian forces remain holed up at the Azot chemical plant on the city's edge, where about 500 civilians were also sheltering.

The Russians were also pressing their offensive on Lysychansk, which is located on a steep river bank facing Sievierodonetsk.

The U.K. Ministry of Defense noted in its intelligence assessment Thursday that Russian forces have likely advanced more than five kilometers (three miles) towards the southern approaches of Lysychansk since Sunday.

"Some Ukrainian units have withdrawn, probably to avoid being encircled," the statement

Bulgarian government crisis Thursday threat-Aened to tarnish a European Union summit that was intended to bolster the EU membership hopes of Balkan countries and to show Western resolve in the face of Russia's war in Ukraine.

"It's not good to see that 26 other countries sit still in a scary show

Truck driver dies after waiting for 5 days in queue at fuel station

A63-year-old truck driver has died in Sri Lanka after standing for five days in a queue at a filling station in the country's Western Province, the 10th death reported due to prolonged waiting for fuel procurement in the debt-ridden island nation grappling with the worst economic crisis since its independence, according to a media report on Thursday.

The man was found dead inside his vehicle after waiting in the queue at the filling station in Anguruwatota, police

The death toll in queues now stands at 10 and all the victims have been men aged between 43 and 84 years. Majority of the deaths reported in queues have been due to

cardiac arrests, the Daily Mirror newspaper reported.

A week ago, a 53-year-old man died while waiting in a queue for several hours at a fuel station in Panadura in Colombo.

The man was reported to have died of a heart attack while waiting in the queue in his three-wheeler.

Sri Lanka, home to around 22 million, is currently facing its worst economic crisis in more than 70 years.

Sri Lanka's economy is experiencing extreme fuel shortages, soaring food prices and a lack of medicines.

The current shortages were made worse by the government's inability to get the stateowned Bank of Ceylon to open Letters of Credit for fuel

Trains cancelled in UK as unions stage 2nd 24-hour walkout

m illions}$ of people in Britain faced disruption Thursday as railway staff staged their second national walkout this week.

The 24-hour strike by 40,000 cleaners, signalers, maintenance workers and station staff canceled about four-fifths of passenger services across the country. A third walkout is planned for Saturday as part of Britain's

biggest and most disruptive railway strike in 30 years. Train stations were largely deserted Thursday. Highways also were less busy than expected, and many people appeared to heed advice to avoid travel. Internet provider Virgin Media O2 said its data suggested "millions more people" than usual were working from home.

The strike is a headache for those who can't work from home, as well as for patients with medical appointments, students heading for end-of-year exams and music lovers making their way to the Glastonbury Festival, which runs through Sunday on a farm in southwest England. The dispute centers on pay, working conditions and job security as Britain's train companies aim to cut costs and staffing after two years in which emergency government funding kept them afloat.

The strike pits the Rail, Maritime and Transport Union against 13 privately owned train-operating companies and the government-owned National Rail. Talks between union representatives and employers ended in deadlock Wednesday. The union accused Britain's Conservative government of scuttling the negotiations. States to push for continuing GST compensation beyond June

Centre to cite tight revenue position

PTI ■ NEW DELHI

The GST Council at its meeting next week is likely to be a stormy affair with Opposition-ruled States aggressively pushing for continuation of compensation for revenue loss, while Centre will defend such a move citing a tight revenue position.

To meet the shortfall in the GST compensation fund, the Centre has borrowed and released to states ₹1.1 lakh crore in 2020-21 and ₹1.59 lakh crore in 2021-22 as back-toback loans to meet a part of the shortfall in cess collection. In addition, the Centre has

also been releasing regular GST compensation from fund to meet shortfall. "Last year, out of the compensation cess collection, the Centre has repaid ₹7,500 crore towards interest cost for borrowing and ₹14,000 crore is to be paid this fiscal.



From next fiscal, the repayment of principal amount will start, had said regime of paying compensation to states for revenue which will continue till March 2026," an official said. The 47th meeting of GST Council, chaired by Union Finance Minister and comprising state Finance Ministers, in Chandigarh scheduled on June 28-29 is likely to see discussion veer around compensation mechanism and revenue posi-

tion of the Centre and states. As per estimates, some northeastern states do not require GST compensation. After 45th GST Council meeting in Lucknow, Union Finance Minister Nirmala Sitharaman pensation to states for revenue shortfall, resulting from subsuming their taxes, such as VAT in uniform national tax GST will end in June next year.

However, the compensation cess levied on luxury and demerit goods, will continue to be collected till March 2026 to repay the borrowings that were done in 2020-21 and 2021-22 to compensate states for GST revenue loss. Goods and Services Tax (GST) was introduced in country with effect on July 1, 2017, and states were assured of compensation for loss of any revenue arising on account of

'Govt can meet fiscal deficit target if rising oil prices don't force more excise cuts on fuels'

The Centre can meet the fiscal deficit target of 6.4 per cent for 2022-23 if there are no excise duty cuts to lower high oil prices and additional spending on subsidies, a German brokerage said on Thursday.

Meeting the budgeted target will be possible if there is no further cut on excise duties, Deutsche Bank's chief economist Kaushik Das said.

The note said that the recent cuts in excise duties, coupled with the higher spending on fertiliser, food and fuel subsidies have led to "upside risks" on the fiscal deficit target. "...Our analysis of the fiscal arithmetic at this juncture suggests that the central government can still potentially hold the FY23 fiscal deficit

close to the target of 6.4 per cent of GDP, assuming no further excise duty cuts or/and additional spending on subsidies over and above what has already been announced," it However, it will be a "dif-

ferent story" if crude oil prices rise to over USD 150 per barrel during the course of the year, it said, hinting that the fiscal deficit can expand beyond the targeted levels otherwise. The brokerage said its

house view is for the fiscal deficit number to come at 6.5 per cent of GDP.

Clarity on whether the fiscal target can be met or not, and if market borrowing needs to be increased from the present target of Rs 14.31 lakh crore will become clearer only in the second half of the fiscal,

FY23 fiscal deficit could be otentially higher by Rs 1.5 akh crore or 7 per cent of GDP, when calculated using the lower nominal GDP base provided in budget (which assumes only 11.1 per cent growth), but fiscal deficit works out to 6.54 per cent, when using a larger nominal GDP base, based on a realistic 17-18 per cent YoY (Year-on-Year) growth assumption, it said.

New Delhi: Bank unions on Thursday deferred their proposed June 27 strike as Indian Banks' Association (IBA) agreed to initiate negotiation talks on their demands.

The United Forum of Bank Union (UFBU), an umbrella body of nine bank unions, including All India Bank Officers' Confederation (AIBOC), All India Bank Employees Association (AIBEA) and National Organisation of Bank Workers (NŎBW) had threaten to go on to pension and demand for fivedays-a-week work.

As per agreement with IBA, the negotiation talks on various pending issues would begin on July 1, AIBEA general secretary C H Venkatachalam said after a meeting held under chairmanship of Chief Labour Commissioner.

Other demands included an updation and revision of pension for all pensioners and doing away with national pension scheme and restoring old pension scheme for all bank

RBI proposes norms for outsourcing of IT services by banks, NBFCs

Thursday proposed norms for the outsourcing of IT services to ring-fence banks and other regulated entities from financial, operational and reputational risks.

Regulated entities (REs) will not require prior approval from the central bank for the outsourcing of IT and ITenabled services, according to RBI's draft Master Direction on Outsourcing of Information

The underlying principle of these Directions is that the RE should ensure that outsourcing arrangements neither diminish its ability to fulfil its obligations to customers nor impede effective supervision by the supervising authority," said the draft, on which the RBI has invited comments from stakeholders

Banks, payment banks, cooperative banks, credit information companies, NBFCs and other regulated entities, would be required to put in place a comprehensive

icy. "Outsourcing of any activity of the RE shall not diminish its obligations as also of its Board and senior management, who shall be ultimately responsible for the outsourced

"RE shall take steps to ensure that the service provider employs the same high standard of care in performing the services as would have been employed by the RE if the same activity was not outsourced, the draft said.

of the board and senior management, besides norms pertaining to the usage of cloud computing services and outsourcing of the Security Operations Center (SOC).

The RBI has also proposed that the REs should set up a robust grievance redressal mechanism, "which in no way shall be compromised on account of outsourcing", meaning responsibility for redressal of customers' grievances related to outsourced services would rest with them.

As per the draft, a risk

management framework for the outsourcing of IT services should comprehensively deal with the processes and responsibilities for the identification, measurement, mitigation/ management and reporting of risks associated with out-

Entities regulated by the RBI should also require their service providers to develop and establish a robust framework for documenting, maintaining and testing Business Continuity Plan Plan (DRP).

Also, a RE could outsource any IT activity/IT-enabled service within its business group/ conglomerate, provided that such an arrangement is backed by the Board-approved policy and appropriate service level arrangements/ agreements with its group entities are in place,

the draft said. It has also proposed additional requirements for crossoutsourcing.In

February this year, the RBI had proposed to issue a guideline on outsourcing.

Govt-appointed committee on EVs fire cases to submit report this month

An expert committee set up by the road transport ministry to investigate cases of electric two-wheelers catching fire and suggest remedial measures is likely to submit its report this month, a senior government official said on Friday. Indian economy to grow by 7-7.8 pc in FY23 despite global headwinds: Experts

The Indian economy can **■** grow by 7-7.8 per cent this fiscal on the back of better agriculture production and a revitalised rural economy amid global headwinds mainly due to the ongoing Russia-Ukraine war, eminent economists said.

Eminent economist and BR Ambedkar School of Economics (BASE) Vice-Chancellor NR Bhanumurthy said at present Indian economy is facing multiple headwinds largely from external sources. Noting that global infla-

tionary pressures and the Russia-Ukraine war have brought in risks to the economy, which is otherwise strong with all the domestic macro fundamentals being well managed, he said unlike advanced economies, India's Covid stimulus measures, especially the fiscal policy interventions, are less inflationary and rather growth-enhancing.

With better agricultural production and revitalised rural economy India should touch 7 per cent growth in the current year despite global headwinds," Bhanumurthy told

PTI. Echoing similar views, eminent economist and Institute for Studies in Industrial Development (ISID) director Nagesh Kumar said the high-frequency indicators point to a robust growth momentum carrying through 2022-23 with a real GDP growth somewhere between 7-7.8 per cent.

French economist Guy Sorman said India could be severely impacted by the high cost of energy and fertiliser imports. "However, because India is still, largely an agri-cultural economy, the social impact of slower growth will be tempered by city workers going back to their village.

"This could increase agricultural production and grain exports," Sorman added.The World Bank has cut India's economic growth forecast for the current fiscal to 7.5 per cent as rising inflation, supply chain disruptions, and geopolitical tensions taper recovery. India's economy grew 8.7

per cent in the last fiscal (2021-

22) against a 6.6 per cent con-

domestic fuel prices and rise in global fuel and other commodity prices appears to have led to a sudden spurt in CPI inflation," he said, adding that recent policy measures, such as reduction in fuel taxes and hike in policy interest rates, should smoothen inflation and inflation expectations in the coming quarters. Kumar noted that the glob-

al headwinds of rising commodity prices do pose down-side risks for the Indian economic outlook as the CPI levels are elevated. "Yet, I do not think that India is heading towards

BIS issues performance standards for electric vehicle batteries

¬he Bureau of Indian ■ Standards (BIS) has come out with performance standards for electric vehicle batteries in order to ensure the safety of consumers, a senior consumer affairs ministry official said on Thursday.

BIS, the national standards-setting body that functions under the consumer affairs ministry, has published the "performance standards for electronic vehicle batteries", the official said.

The standard "IS 17855: 2022" has been formulated for lithium-ion traction battery packs and systems of electrically-propelled road vehicles and it has been harmonized with ISO 12405-4: 2018, the official added.

According to the official, the new EV batteries' standard incorporates the test procedure for the basic characteristic of performance, reliability and electrical functionality for the battery packs and system for either high power or high

energy application. This standard is formulated considering real-life scenarios for an electric vehicle such as vehicle in parking (battery is not used for an extended period of time), the battery system is being shipped (stored), operating battery at low and high temperature etc., accordingly various tests are incorporated in this standard.

Electric vehicles operate on an electric motor and rechargeable batteries. Over the past decade, electric vehicles have grown in terms of visibility and availability in the market. Most electric vehicles use lithium-ion batteries because of their high power-toweight ratio.

Considering the safety aspect of batteries for electronic vehicles, the BIS is in the process of publishing two more standards related to batteries for various passenger and goods carrying vehicles (L, M and N categories), the official

Williams won the seventh and most recent of her seven Wimbledon singles titles in 2016.

Serena, who became a mother in 2017, has plummeted to 1,204th in the WTA rankings due to her period out of action. Earlier Wednesday, Petra

Kvitova battled into the Eastbourne women's singles quarter-finals as the former Wimbledon champion fought back to beat Britain's Katie Boulter 5-7, 6-0, 7-5.

Sarfaraz's 134 propels Mumbai to 374, MP finish day 2 at 123/1

S arfaraz Khan completed his transformation from Mumbai cricket's resident 'enfant terrible' to 'Man Friday' with a superb hundred that kept his side ahead against Madhya Pradesh in the Ranji Trophy final, here on Thursday.

Courtesy Sarfaraz's fourth hundred of the season - 134 off 243 balls - the 41time champions managed a fighting 374 in their first innings after beginning the day at 248 for five.

But Madhya Pradesh won't be too unhappy as they finished the second day at 123 for one with Yash Dubey (44 batting) and Shubham Sharma (41 batting) adding 76 runs for the unbroken second wicket.

The day belonged to none other than Sarfaraz, who has now scored an astounding 937 runs in Ranji Trophy in just six games and could make it 1000 for the season if Mumbai bat again in this

His innings had 13 boundaries and two huge sixes - one over square leg off left-arm spinner Kumar Kartikeya and one down the ground off off-spinner Saransh Jain.



But what stood out was how he managed the innings after Shams Mulani was trapped leg before by Gourav Yadav (4/106) in the opening over of the sec-

His batting with the tail showed his new-found maturity, which is proving to be a boon for Mumbai cricket. He chose loose deliveries for boundary, forcing MP captain Aditya Shrivastava to open the

The manner in which Sarfaraz has turned a corner since the 2019-20 season (928 runs back then) is phenomenal as he had disciplinary issues early in his career, which also forced him to leave Mumbai for a season. With father Naushad Khan, who also

doubles up as his coach, making him play 400 balls (nearly 67 overs including nets and knocking) a day at practice, Sarfaraz 2.0 is a battle-hardened man, the 'khadoos street fighter' that any captain would want to go to a war with.

Once he reached his fifty, he touched the lion's crest on his jersey, gesturing 'Don't worry, I am going nowhere'.

His batting isn't as pleasing to the eye as Prithvi Shaw's but highly effective. His score those runs on a track that is largely two-paced and in overcast conditions with the ball doing a fair bit.
