Heads roll over EVMs' shifting

EC removes 3 from election duty in UP, suspends Varanasi ADM

RAJESH KUMAR NEW DELHI

On the eve of the counting of votes, the Election Commission on Wednesday removed three officials from election duty in Uttar Pradesh and suspended Varanasi Additional District Magistrate Nalini Kant Singh for negligence in electronic voting machines (EVM) transportation and initiated disciplinary actions against them.

The commission has deputed Chief Electoral Officer of Delhi to Meerut and Chief Electoral Officer of Bihar to Varanasi as special observers to oversee counting arrangements amid complaints from Opposition parties about alleged irregularities in Uttar Pradesh Assembly polls after an official of Varanasi publicly admitted to lapses.

"ECI has taken action against any type of breach of protocol. ECI has suspended ADM Varanasi," senior Deputy Election Commissioner Chandra Bhushan Kumar said.

Disciplinary action has been initiated against the Varanasi ADM. The Varanasi ADM has also been barred from going to the counting spot. Additional District Magistrate (Finance and

Meanwhile, Additional Election Officer VK Singh was removed from the election process in Bareilly after ballot boxes and other election items were found inside a garbage collection bin of the local municipality in the Baheri area.

In Sonbhadra district, where ballot slips were recovered from a box inside the vehicle of the additional district magistrate, Ghorawal returning officer Ramesh Kumar was removed from election work. The commission has ordered disciplinary proceedings against them. The Varanasi DM said all EVMs were checked late at night in the presence of election observers

This comes a day after Samajwadi Party (SP) chief Akhilesh Yadav accused the ruling BJP of "stealing" votes and claimed that his party workers intercepted a truck carrying EVMs in Varanasi.

He also claimed that vehicles transporting ballots were intercepted in at least three districts. On Wednesday, taking to Twitter, the party put out a video of the official admitting there were "lapses"

Last group of stranded Indians evacuated

India has managed to bring Lout most of its nationals, including students from wartorn country, as the last big group of about 700 Indian students were evacuated from the northeastern Ukrainian city of Sumy by a special train from Poltava. They are likely to board a flight to India from Poland on Thursday.

With this evacuation, India rescued more than 18,000 of its citizens via nearly 80 special flights as part of "Operation Ganga" starting February 22. Union Minister Piyush Goyal said on Wednesday "Operation Ganga" was the result of the "whole Government approach" of the Prime Minister.

He also charged the Congress and other Opposition parties of reaching "a new low in politics" by seeing the Government efforts from the prism of "publicity"

Informing that the last batch of Indian students have safely moved away from Sumy and proceeded to the Poland border on their way back home, he complimented the PM for taking "strong measures" to evacuate Indian nationals from Ukraine.

2008 SERIAL BLAST CASE HC notices to 38 for death sentence confirmation

Ahmedabad: The Gujarat High Court on Wednesday issued notices to 38 convicts in the 2008 Ahmedabad serial bomb blast case to confirm their death sentence before it gets executed, under the provisions of the Code of Criminal Procedure (CrPC).

The division bench of Justices Sonia Gokani and Mauna M Bhatt issued notices to all 38 convicts who were sentenced to death by a special court on February 18.

A special court had sentenced 38 convicts to death and sentenced 11 others to life imprisonment for the blasts, in which 59 people were killed and over 200 injured.

The state government had moved a criminal confirmation case in the High Court under the CrPC for convicts who received death sentence.

On the eve of the counting of votes, the Election Commission announced the removal of three officials, including the nodal officer for EVMs in Varnasi after a mass EVMs in Varanasi, after a massive controversy erupted over Samajwadi Party's allegation that electronic voting machines were being shifted in an unauthorised manner.

The poll panel also deputed Delhi's Chief Electoral Officer as a special officer in Meerut and the Bihar CEO in Varanasi, Prime Minister Narendra Modi's parliamentary seat, to supervise the counting of votes.

It is a high-stakes election in Uttar Pradesh for the BJP and the Modi government as the state sends the highest number of 80 MPs to Lok Sabha and the party's performance is expected to have a bearing on the next general election slated for 2024.

Several exit polls have forecast a clear majority for the BJP in Uttar Pradesh and for the Aam Aadmi Party in Punjab, while predicting a hung assembly in Goa and a tight race between the BIP and the Congress in Uttarakhand. Except for Punjab, all other states were under the BJP.

As the post-poll scenario could throw up surprises due to multi-cornered contests, the parties have dispatched senior leaders to the states and were also wooing other parties to ensure that they get the better of their rival claimant in case outside support is needed to

form a government. The Congress has sent Karnataka Congress chief D K Sivakumar as special observer to Goa and party general secretary Mukul Wasnik and Chhattisgarh Health Minister T S Singh Deo besides Vincent Pala to Manipur. The party had lost the race for government formation in the two states in 2017 despite emerging as the single largest party.Goa Congress chief Girish Chodankar told reporters that AAP leaders were "already in talks with Congress leaders".

Ali, who spoke to PTI from Poltava, said it is a nearly-12-hour train journey to Lviv, from where the students will be taken to Poland via buses. Lviv is located about 50 km from the Poland border.

After crossing the frontier, the students will be flown out on evacuation flights from Poland. "The students left Sumy at around 9:30 am. First, they reached Poltava, which is 170 km away and then they boarded a train to Lviv," Ali said.

"From Lviv, they will be taken to Poland in buses and then they are expected to board a flight for India on Thursday,"

A bench of Justices L Nageswara Rao and BR Gavai directed the convict, whose death penalty was commuted into life term in 2014, to report to a local police station near Chennai in the first week of every month and ordered that the additional conditions for release would be decided by a local court there.

"There is no dispute regarding the fact that the applicant has undergone the sentence of 32 years. We are informed by the counsel for the applicant that he was released on parole thrice earlier and there was no complaint about his conduct during his release," the bench said in

It also took note of the submission that the convict is on parole at present as well, and there

The bench considered the fact that Perarivalan has acquired educational qualifications and has been suffering ill health during incarceration. "Taking into account the fact that the applicant has already spent more than 30 years in prison, we are of the considered view that he is entitled to be released on bail in spite of the vehement opposition of the ASG (additional solicitor general, who appeared for the Centre), subject to the final disposal of the SLPs (special leave petitions) here," the court said.

The bench said the pleas have to be heard finally in view of the stand taken by the Centre

that the State Government did not have the power to entertain the mercy petition under Article 161 (power of the Governor to grant remission) of the Constitution in view of the fact that the convict has already taken the benefit of remission earlier when his death penalty was commuted to life imprisonment.

The top court has been hearing pleas, including the one in which Perarivalan sought suspension of his life sentence in the case till the

2020, had told the apex court that the Tamil Nadu Governor has to take a call on grant of remission to Perarivalan. Later, the Governor referred the mercy plea to the President of India saying he did not have the power to decide

The mercy plea has been pending since then and the apex court said that till the time the legal issue over the power to grant remission is decided, it would grant the bail to the convict.

EC has knelt before Centre, says Kejriwal

The State Election (SEC) on Wednesday deferred the announcement for conducting elections for the three municipal corporations after it received a communication from the Centre in this regard. The move came in for criticism from Opposition parties, including Delhi Chief Minister Arvind Kejriwal.

There are 104 wards each in the North and the South Delhi Municipal Corporations. The East Delhi Municipal Corporation has 64 wards.

Addressing the media SEC of Delhi, SK Srivastava said: "I received some communication from the Central Government at 4.30 PM, so I can't announce the dates right now. We were about to announce them but now it will take another fiveseven days to announce the dates." "The Government perhaps desires reorganisation of the MCDs. May be they could re-unify the three corporations. So we have to think over it, and then announce the poll dates. We will examine their advice. If the three MCDs are unified, then we will have to decide accordingly. We are taking legal opinion on the issue," he added.



The SEC's announcement drew a sharp reaction from Opposition parties. Reacting to the development, Arvind Kejriwal questioned the SEC, saying that the decision was taken under pressure.

"Can the Central Govt "direct" any EC to delay/cancel any elections? Under which provision? Are these "directions" binding on the EC? Why is the EC buckling under pressure?" Kejriwal tweeted.

Addressing the media, Delhi Deputy Chief Minister Manish Sisodia alleged that the term of the Houses of the civic bodies in Delhi is ending, and there was a pre-announced press conference where the dates were to be announced. Now, under pressure from the BJP at the Centre, the dates have been withheld. Sisodia charged that never since Independence, has an "election commission acted in this manner". "It (election body) has bent, and knelt down before the BJP at the Centre, after getting

23 year-old Uzbek nation-Aal, who was suffering from both kidneys failure, was saved at Delhi's Aakash Healthcare Super Speciality Hospital when her mother's kidney was transplanted to her in a complicated and rare procedure.

According to officials, the patient, Mokhichekhrakhon Sultonova, who recently became a mother, kidneys failed due to hypotension (low blood pressure), resulting in tubular necrosis, a kidney disorder involving damage to the tubule cells of the kidneys. "Patient's mother Mavjuda

Khalilova, had contacted the Aakash Hospital via email after her daughter's condition deteriorated in their home country.

She made the decision to donate her kidney to her daughter since she was unable to nurse and care of her child but most importantly she was gradually losing her life," said the official.

FIR filed against Bihar cricket association prez on rape bid accusation

"The victim pushed the accused and came out of the room. She called her brother and narrated the whole incident, following which he called the accused person who apologised for his act and said that it will never happen in future. He also assured the complainant that he will clear the bills of the complainant's company," the FIR stated.

Later, he called the woman and his brother at the hotel to talk about the payment. On hotel room. He asked complainant's

brother to take a bag from the room to the hotel reception. When her brother went out of the room, he allegedly touched her inappropriately, the FIR further stated. The woman resisted his act

and told her brother about the incident, it said, adding that the case has been registered under sections 354, 376 and 511 of the Indian Penal Code (IPC) on Monday.

Corporation (NLMC) will be

WHO centre for traditional medicine to be set up in Gujarat's Jamnagar

The Union Cabinet on Wednesday approved the establishment of a WHO Global Centre for Traditional Medicine (WHO GCTM) in Gujarat's Jamnagar by signing a host country agreement, the first and only global outposted centre for traditional med-icine across the globe. The WHO GCTM will be

established under the Ministry of AYUSH. The agreement would help position AYUSH systems across the globe and provide leadership on global health matters pertaining to traditional medicine, an offi-

WHO GCTM will ensure quality, safety, efficacy, acces-

sibility and rational use of traditional medicine besides developing norms, standards, and guidelines in relevant technical areas, tools and ethodologies, for collecting data, undertaking analytics, and assess impact.
The Cabinet was apprised

of a Memorandum of Understanding (MoU) signed between the Indian Council of Medical Research (ICMR) and D e u t s c h e Forschungsgemeinschaft, Germany in December 2021.

The objectives of the MoU are to enhance cooperation in the field of medical sciences/health research in areas including toxicology, neglected (Tropical) disease, rare diseases and any other areas of mutual interest. It was also

apprised of a MoU between ICMR and the Oxford University, the UK in November 2021 for capacity building for Indian scientists and researchers, collection of data compliant with interna-tional standards and regulatory requirements, development of India towards becoming a regional hub for capacity development using its own funds and following the principles of equity and sover-

The cabinet also approved a MoU signed between ICMR and the National Institute of Allergy and Infectious Diseases (NIAID), National Institute of Health of Department of Health and Human Services, US, in September 2021.

ED attaches immovable, movable properties in KSBL money laundering case

 $T^{\text{he Enforcement Directorate}}_{\text{(ED) has provisionally attached immovable and mov-}}$ able properties in the form of lands, buildings and share hold-ings worth Rs 1,984 crore under the Prevention of Money Laundering Act (PMLA) in a money laundering investigation against Karvy Stock Broking Ltd (KSBL) and its Chairman Comannder Parathasarathy and

The ED had initiated money laundering investigation on the basis of FIRs filed by the CCS Police Station, Hyderabad Police, on the complaints of lending banks who complained that the Karvy Group had availed large amounts of loans by illegally pledging their clients' shares worth about Rs 2,800 crore. Subsequently, these loans turned into non-performing assets (NPA) after the release of the client's securities as per the orders of NSE and SEBI.

The KSBL was one of the leading stock brokers in the country with millions of clients. The scam came to light after a limited purpose inspection of KSBL conducted by NSE in 2019 revealed that KSBL had not revealed a Depository Participant DP Account and credited the funds raised by pledging of client securities to six of its own bank accounts ("Stock Broker-own Account") instead of the "Stock Broker-Client Account", the ED said in a state-

The ED has collected the audit conducted by NSE and the orders passed by SEBI and ROC against KSBL and the forensic audit reports of BDO India LLP.

On September 22, 2021, the ED had conducted searches at nine locations and subsequently, Parathasarathy, CMD of Karvy Group, and G Hari Krishna, CFO, were brought on production warrant and produced before ED PMLA Special Court. They were arrested under PMLA on January 20 this year.

They are presently in judicial custody. Parathasarathy has been totally evasive and noncooperative during the investigation and while admitting a few wrong doings by KSBL, has been shifting the entire blame on the CEO, CFO and other senior management.

In a separate case, the ED has provisionally attached movable and 376 immovable properties worth more than Rs 268 crore in Akshaya Gold Farms & Ponzi scam case.

The attached properties are in the name of AGFVIL and sister concerns, its directors, relatives of directors and their

Meanwhile, the ED has arrested 11 key accused persons involved in Chennai Port Trust-Term Deposit fraud case worth over Rs 45 crore in relation to money laundering case. In this case, the ED had initiated a money laundering investigation on the basis of FIR registered by the CBI, ACB, Chennai.

Labourers listed under ASI's Kota and Delhi circles were also shown as working in Lucknow.

Similar bogus bills were also reimbursed on the basis of bogus bills submitted for maintenance of lawns in cites like Kushinagar, Agra, Kanpur, among others by the private

contractor Kuldeep Singh. The complaint, now a part of the FIR, gave specific details about archaeological sites in Uttar Pradesh like the iconic Taj Mahal and The Residency

in Lucknow. The Residency, also called as the British Residency and Residency Complex, is a group of several buildings in a common precinct in Lucknow. It served as the residence for the British Resident General who

was a representative in the court of the Nawab. The complaint further alleged that similar fraud was also perpetrated in Agra's Sikandara, Ram Bagh and Fatehpur Sikri.

was allegedly aided by Horticulture Assistant at The Residency Vineet Agrawal, Deputy Superintending Horticulturist posted at ASI's Agra Division-I which covers most of Uttar Pradesh, P K Choudhary; and retired officer Raj Kumar.

AK Antony hangs up boots after 52-year-long illustrious career in electoral politics

Veteran Congress leader and former Union minister AK Antony has informed the Congress leadership that he will not seek re-election to his Rajya Sabha seat and move back to his home state of Kerala after his tenure comes to an end in April. The announcement marks the end of Antony's nearly 52-year-long illustrious career in electoral politics which includes three terms each as Union minister and chief minister of Kerala. Elections to three Rajya Sabha seats in Kerala are due on 31

"The time has come now for me to end my journey in electoral politics and my parliamentary career. I will leave Delhi in April and return to live in Thiruvananthapuram," Antony said.

Antony thanked Congress president Sonia Gandhi for the opportunities given to him to represent the party in Rajya Sabha. The 81 year old leader said that he was thinking of quitting politics for a while and had also informed Sonia Gandhi about it a few months ago. "After thinking about par-I informed Sonia ji a couple of months ago about my decision not to seek another Rajya Sabha term. During my visit to Kerala last month, I told the PCC president and other colleagues about the same," Antony said at a press conference in Kerala. Earlier, the Election

Commission announced the dates for elections to three Rajya Sabha seats in Kerala which are currently occupied by Antony, CPI(M)'s K Somaprasad and MV Shreyams

Minister's political career began in Kerala during the 1970s and he earned the reputation of being one of the Congress' most honest and upright leaders, earning him the moniker 'St Antony of Congress'. He was known to be one of Sonia Gandhi's most trusted lieutenants, and also had good terms with former Prime Ministers Indira Gandhi and Rajiv Gandhi.

Antony first became MLA the Kerala Legislative Assembly in 1970, after graduating from his student politics days, and went on to serve the first of his three terms as the state's chief minister at the age of 37 in 1977. Apart from his five terms as MLA, he has also served as the chief of the Congress' Kerala unit for 10 years. He served as Union minister for three terms including the longest stint by any defence minister in the country- from 2006 to 2014. He has also been a Rajya Sabha MP for five terms.

After the split within the Congress party in 1978, he quit as chief minister of the Congress (U) faction that led the coalition government in

The decision was a protest Indira Gandhi in the 1978 bypoll. Antony had also asked Indira Gandhi to withdraw the Emergency earlier. After quitting as chief minister, Antony launched his own Congress faction called Congress (A), which later joined the Congress with Indira Gandhi attending the merger ceremony in Kochi.

Thereafter, Antony was made AICC general secretary in 1984 and has been a longtime member of the Congress Working Committee (CWC).

ASKS TWO TO 'SIT TOGETHER' TO SORT **OUT DIFFERENCES**

DISMISSES **PETITIONS CHALLENGING** ASSEMBLY SPEAKER **ELECTION RULES**

Averring that the "ram-belings" between the Maharashtra Governor and Chief Minister "do not take the State forward", the Bombay High Court on Wednesday observed that it was "unfortunate" that the two highest functionaries of the State "do not trust each other" and asked them to "sit together" and "sort out" the differences between

Expressing its displeasure over the strained relations between the Governor Bhagat Singh Koshyari and chief minister Uddhav Thackeray, a HC bench of Chief Justice Dipankar Datta and Justice MS Karnik indicated that the state was suffering because both the Governor and the chief minister were not on the

"The unfortunate part is that the two highest functionaries (Governor and Chief Minister) do not trust each other. You both please sit together and sort this out between yourselves. Erase all these differences. Your ramblings do not take the State forward. There is always the other side of the coin. We all read. The governor and CM are not on the same page.... Who is suffering?" CJ Datta noted.

Taking serious exception to the Governor's failure to implement its order of August 12, 2021 "to accept or return" the State Cabinet's recommendation to nominate 12 members to the State Legislative Council, the HC bench lamented: "We are also a Constitutional Court, how have we been treated? We had passed an order on the 12 MLCs case. Today we are on March 22. Eight months have passed and still nothing has happened".

The Chief Minister is the head of the executive. He has to run the state. We cannot say either of them is wrong. Has democracy died because the MLCs, an issue graver than the present? Our democracy is not as fickle/ brittle," the Bench

The HC bench made these observations while dismissing two public interest litigation (PILs) petitions filed by Opposition BJP MLA Girish Mahajan and citizen Janak Vyas challenging rules for election of speaker and deputy speaker of Maharashtra Assembly.

The two PILs had contested the State notification altering Rules 6 (election of speaker) and 7 (selection of deputy speaker) of the MLA Rules, claiming it is arbitrary and in

other things stated that the state government by way of the amendment to Rules nos 6 and 7 had removed the procedure of secret ballot and replaced it with voice vote, restricted the power of the Governor to notify the date of the election and the same had been transferred to the Chief Minister (which gives absolute power to the Chief Minister of State by holding elections) and replaced 'election' of the deputy speaker for 'selection'.

Refusing to accept petitioners' plea seeking an order declaring the amendment as "unconstitutional and illegal" on the ground – as stated by petitioner Girish Mahajan's lawyer Mahesh Jethmalani that when amendments were made, Mahajan was serving his suspension period, Chief Justice Datta noted: "Say these rules are made in your absence, which affect the public at large. Can you come back and say that decision should be reversed. Can that be done? Can you seek reversal? No, it cannot be done!"

rejecting While Jethmalani's contention that the public at large were affected by the amendment, CJ Datta observed: "The public is least concerned with the election of speaker and deputy speaker. Just ask in this very courtroom who is the Lok Sabha speaker. How many will be able to reply? Until and unless this deals with the public at large, this cannot be entertained in a public interest litigation," CJ Datta remarked.

On his part, Jethmalani and Advocate Subhash Jha, appearing for the second petitioner Janak Vyas, told the HC bench that the Chief Minister could not ask the Governor at all to fix a date for the speaker election. He went on to argue that the purpose of the Court was to ensure that everyone remained within their boundaries and followed good governance.

However, the HC bench did not accept the arguments made by the petitioners' lawyers. "The rules do not say anywhere the Chief Minister is unilaterally taking a decision to appoint speaker and deputy speaker. He is only taking a decision on the date of election," the HC bench noted, while dismissing the two petitions.

answerable to the Court in view of Article 361 of the Constitution and no direction can issue to the Governor; hence, the petitioner has not ioined the Secretary of the Governor as a party despite liberty granted by an earlier order of this Court".

"Before parting, this Court expresses hope and trust that things will be set right at an early date. If indeed, during the pendency of this writ petition, the Governor has acted on the advice of the Council of Ministers, in whatever way it was thought appropriate by him, that would take care of the petitioner's concern completey. The Public Interest Litigation is, accordingly, disposed of with no orders as to costs," the HC bench had said.

In its earlier observation in the judgement, the HC bench averred: "This Court, therefore, concludes the judgment by making a public law declaration that the obligation, which the Constitution vests on the Governor to either accept or return the recommendations as made by the Council of Ministers forming part of advice, has to be discharged within a reasonable time.

"Eight months, in fact, seems to be beyond reasonable time. This Court, having regard to the gravity of the issue involved and the necessity to fill up the vacant seats of members expeditiously as well as to subserve the aims set by the Constitution, would consider it eminently desirable if the obligation, in the present case, is duly discharged without undue

In its remarks preceding its conclusion, the HC bench had made some pertinent observations when it said: "The recommendations made by the Council of Ministers have become eight months old by the time this Court commenced hearing of this petition. If the saying that everything happens for a reason is to be believed, this Court ought to assume that there was/were genuine reason(s) for the Governor not to convey his decision earlier, whatever be the nature thereof"

Power play

The US ban on Russian oil import has set alarm bells ringing among EU nations

he United States has caused a global oil slick of economic fortunes by banning oil imports from Russia. The action, though not really severe, has only helped the already rising crude prices spiral further. Significantly, President Joe Biden stopped short of imposing a full sanction on the Russian energy sector. He is aware the European Union members import nearly half their annual consumption from Russia. As a result, the EU, though highly critical of Russia for invading Ukraine, is unwilling to ban Russian oil imports. For, such a decision would spike the rate of inflation, ending in a high fiscal deficit. The US thinks the moral pressure the ban has created would be sufficient to make Russia realise worse could be in store for it if it continues to be on collision course with the international community. Russia is already feeling the pinch. Its daily supplies to the US till recently were worth \$1billion. With Russian oil, gas and coal banned, all trade and investments by American companies have also come to a halt. This is enough to drive oil prices up even as Russia finds itself saddled with unsold oil it will have to quickly unload on any willing country at heavy discounts to cut



down its losses as much as it can. There is a matter of self-interest in this apparently anti-Russian decision of the US. The Americans stopped importing Russian oil since January as tempers rose over Ukraine. Everything now depends on how long the "war" goes on.

Ukraine's announcement that Nato's membership is no longer a priority may lead to de-escalation if that is Russia's only objective for attacking Ukraine. If President Vladimir Putin insists on demilitarisation of the country and a change of regime as well, the crisis will take a turn for the

worse. It could be that in such a situation, even the EU may review its decision to continue Russian oil imports. The US can unleash the second part of the current ban it has not enforced so far. It can decree that nobody will buy Russian oil and the US would stop engaging with any country that does. That is a severe sanction and can cripple Russia's oil sector. It could also put countries dependent on Russian oil in a quandary. Meanwhile, President Biden is facing a growing internal demand for promoting US-sourced liquefied natural gas as an alternative to Russian gas in Europe. The Americans have been sending a number of tankers to Europe to supplement the latter's gas supplies. Europe is paying dearly for the consignment. American oil companies feel that if the war lingers on, the Europeans may be inclined to enter into a long-term contract with the US for oil and gas supplies. If oil and gas are geo-political assets, then the US, instead of Russia, could hold the baton in Europe if the war does not end soon.

The Opposition needs to throw up a worthy alternative to the BJP in the next LS polls

n an overt attempt to rally the non-NDA parties against the BJP ahead of the 2024 parliamentary elections, West Bengal Chief Minister Mamata Banerjee has again sounded the bugle for the Opposition parties to unite. Ridiculing the strength of the saffron outfit in Parliament and most of the State Assemblies, she asserted that the BJP was in power at the Centre only because people didn't see a viable alternative to it, not because it was worthy of leading them, and that it would be ousted the day the Opposition cobbled up a strong enough recourse. To achieve this end,



she advocated coming together of her party, the TMC, along with other like-minded groups in the Opposition camp. She actually does have a point. As per the Constitution, the main role of the Opposition in Indian democracy is to question the Government of the day and hold it accountable to the public. This also helps fix the ruling party's mistakes or oversight. The Opposition must ensure that the Government does not take any steps which might have a negative effect on our nation. Its role in the legislature is basically to check the excesses of the ruling or dominant party, but not to be totally antagonistic.

In fact, as recently as on November 26, 2021, President Ram Nath Kovind had underlined that the "Opposition is, in fact, the most important element of democracy". Be it the AAP or other satraps in States across India, it is vital to have a vibrant Opposition. But sadly, they practically stand no chance in the face of the brute majority the BJP-led NDA enjoys in Parliament. For all practical purposes, the Opposition benches are lying vacant or their members are in a state of suspended animation. Of late, however, Mamata, Telangana Chief Minister K Chandrashekar Rao and their Tamil Nadu counterpart MK Stalin are trying their best to create ripples in Parliament and take the formidable BJP to task over issues of regional and national importance. At the national level, the Congress is in a moribund state but if it performs well in the just-concluded Assembly polls, the necessity to carry it along will become all the more imperative. These leaders need to draw more politicians with a good pan-India image into their fold; also, they should speak in one voice. Any infighting well before the final push may sound the death knell for Opposition unity and its ambition.




New Delhi hopes that Moscow will help it resolve ongoing problems with Beijing; it doesn't realise that Russia is just a vassal State of the Chinese

Russian attempts to brutally subjugate Ukraine, even going so far as to threaten the world with nuclear Armageddon. Clearly, leaders from the US, its European allies, the Russian Federation and Ukraine have badly miscalculated and put the world in grave danger. Probably, a rapid regime change and the rather fanciful wish to assimilate Ukraine into Mother Russia was what Putin hoped to accomplish. Things have obviously not gone according to plan as his Generals completely miscalculated Ukrainian resistance. While he may still succeed, any new regime will likely last as long as it has Russian military support to back it up. This seems uncertain, given that the ability of the Russian military to control a restive population over time seems extremely doubtful. Putin may, therefore, have to be satisfied with the capture of sufficient territory in the Donbas region that would provide a land corridor connecting Russia to Crimea.

Even this will not be acceptable to the Ukrainians and Putin is likely to have a serious insurgency on his hands, which his conscript Army will find increasingly difficult to control. As economic costs and instability in the region mount, one can deduce that, in all likelihood, things will end badly for Putin himself, that is if he manages to last out till the next presidential elections due in 2024.

There is no gainsaying that geopolitical machinations on the part of the US and the West to push Nato eastwards have given Putin the excuse to act like he has, supposedly in the interest of national security. However, his actions appear to have been pre-mediated as in the days leading up to his unprovoked offensive, diplomacy was paying dividends and Russia was gaining substantial traction within the international community. Thus, despite winning the diplomatic war, Putin decided to forcibly occupy Ukraine and launched a no-holds-barred assault that has led to a humanitarian cri-



world, whatever be the reason, national leaders can ill afford to resort to the use of force to satisfy their egos and personal ambitions, given the ramifications their actions have worldwide. As events unfold in this pointless and bloody war, it is not just the people of Ukraine and Russia who are paying a heavy price. It is damaging and destroying livelihoods, hopes and aspirations of families as far away as Chalageri village in Karnataka's Haveri district, home to 21-yearold student Naveen, who was killed in Russian shelling in Kharkiv. The ambivalence displayed by the Indian Government in condemning Russian aggression and supporting the Ukrainian position is indeed difficult to understand. The immediate result of its actions has been that our 20,000-odd students were placed in harm's way and have had to face the brunt of Ukrainian anger.

INDIA'S PRUDENT DIPLOMACY IN WAR

India's diplomatic stand is influenced by NAM and Panchsheel

mid the on-going Russian-Ukraine crisis, India's diplomatic strategies have once again come under the scanner and many pundits feel India should take a side (either Russia's or Ukraine's) in order to prevent the war from accelerating. But India has displayed a strong diplomatic character by choosing not to take sides in a situation involving the US-led NATO and Russia. Indian Prime Minister's telephonic talk with the Russian President and India's External Affairs minister's talk with the Russian foreign minister have both highlighted the effort of India to stop the war by taking the path of diplomatic negotiations and dialogues on one hand and a lasting solution for this problem on the other. India's neutral stand is mainly because all the key protagonists in the crisis are India's close allies. Hence, India's unaligned and diplomatic efforts. India and the US have good bilateral ties and have come together on sever-



al issues including the pandemic, climatic issues, trade and investment, and cyber security and emerging technological advancements. The USA has also been critical of China's hostile behaviour on India's territory and terror attacks from Pakistan. The USA has been consistently supporting India in the latter's emergence as a global power. Both countries have tried to ensure peace in the Indo-Pacific region. In this scenario, where Ukraine wants to be a member of NATO, if India votes in favour of Russia, it might affect its bilateral relations with USA. Although Ukraine is not a NATO member, it is still considered a partner country and that is why the US, Britain, Germany, Netherlands, and Polandhave sent military help to Ukraine. This shows that a possible support to Russia might hamper India's relations with the NATO countries, including USA.

Despite a divergent geo-political and strategic drift in India-Russia relationship with Russia embracing China and Pakistan, both being India's diplomatic foes, the age-old India-Russia relationship still continues to remain strong. This is evident when we take into consideration that the first in-person Russian bilateral meeting since the onset of the pandemic was withIndia. Moreover, Russia has been a significant supplier of military equipment. India is also procuring the S-400 Triumf Missile from Russia, despite strong US opposition. A deal worth over Rs. 5000 crore for the manufacture of Russian AK203 assault rifles is also in the pipeline. There are also hints of a new ten-year defence pact between the two countries. Speaking of economic relations, India-Russia annual trade is also worth about \$10 billion. India's support to Ukraine may not hamper Indian-Russian ties but might mean Russia developing stronger ties with China and Pakistan. That can be a real-time threat to India's national security. Moreover, speaking of India and Ukraine relationship, history has shown us that Ukraine has seldom supported India. Ukraine has been consistently taking anti-Indian position in the United Nations, be it in terms of voting against India in UNSC after 1998 nuclear tests, voting for UN intervention in Kashmir after abrogation of Article 370 or in terms of selling military equipment to Pakistan to use against India. So, in this regard as well, India's diplomatic stand in terms in abstaining support in favour of Ukraine is quite justified. India's diplomatic stand is influenced by the non-aligned movement and the Panchsheel framework ofmutual non-aggression and non-interference. Hence, India has always been a supporter of diplomatic settlement of disputes rather than military aggressions. India wants de-escalation of the crisis, but onlythrough arbitration or conciliation. Thus, considering all the angles to this crisis, India is adopting the strategy to solve this dispute keeping in mind that any country's national interest is above the overall global interest.

India-Aus CECA and the dairy saga



The rise in disposable income and preference for high-protein diets have created a consumer base for such niche dairy products

The India visit of the Australian trade minister in February 2022 has expedited the early harvest trade deal between both countries. An interim agreement which is expected in about a month's time would be a major leap towards the signing of a Comprehensive Economic Cooperation Agreement (CECA) between India and Australia later this year.

In 2020, India was Australia's seventhlargest trading partner and sixth largest export destination. The two-way goods and services trade between the countries was worth \$24.4 billion. While India's export basket to Australia majorly comprises petroleum products, medicines, polished diamonds, gold jewelry and apparel, Australian exports to India include coal, liquefied natural gas (LNG), alumina and gold. There is a huge demand for Australian premium alcoholic beverages and wines, health supplements, cold-pressed juices and trans-fatfree products in India.

The trade ministers of India and Australia stated in a joint press meet that the sensitivities of both countries will be 'accommodated and respected'. It is likely that Australia will not seek market access for dairy, beef and wheat which are sensitive sectors for India. Earlier this year, the Commerce Ministry of India had indicated that the interim agreement would focus on labour-oriented sectors like textiles, pharmaceuticals, footwear, leather products and agricultural products, and ruled out the inclusion of dairy and agriculture items.

This statement underpins India's commitment to protecting its agriculture and dairy sectors, which was one of the reasons for its exit from the Regional Comprehensive Economic Partnership (RCEP) negotiations, back in 2019. Indian dairy farmers, cooperative societies, and trade unions have taken a strong stance against the opening of sensitive sectors such as dairy and agriculture to the

The Indian dairy industry is the largest globally with milk production of 198.4 million tonnes in 2019-20. It provides livelihood to a large number of people and is dominated by milk cooperatives and small and medium-size dairy farmers, who face challenges towards achieving economies of scale in their operations. prise in most rural households. Instead, it is well integrated with the farming system. Dairy not only supplements the agricultural incomes of farmers, but also provides a regular income and helps them overcome financial crisis during the off-

season and thus, a valuable asset. Approximately 35 percent of the dairy sector is organised in India with more and more private companies investing in developing an efficient milk procurement network, and marketing liquid milk and value-added products. The

National Dairy Development Board projects a demand for milk and milk products at a pan-India level to reach 266.5 million metric tonnes in 2030

Out of the total milk produced in India, 48 percent is consumed in the rural areas and the rest is marketable surplus for consumers. Despite being the largest producer, India's share in the global milk trade is small. India exports dairy products to the United Arab Emirates, Bangladesh, the United States of America, Bhutan and Singapore. Skimmed milk powder accounts for 30 percent of total dairy exports. Butter, butter oil, cheese, ghee and buttermilk also form a part of the export basket. India imports (as well as exports) buttermilk, curdled milk, cream and kephir from Australia. Milk non-concentrated, cheese of all kinds, milk and cream powder are also among the dairy products imported from Australia in 2020.

ports around 70 million rural households, which consist of mostly small and marginal farmers. The milk cooperatives, dairy farmers, and trade unions have opposed Free Trade Agreements with milk surplus economies such as Australia and New Zealand. Assuming that a lowering of tariffs may lead to dumping of cheap imported products and resultant disruption of the domestic dairy spokespersons have taken a stringent position against the opening of this sector.

The majority of large dairy importing nations across the world have applied various tariff and nontariff measures to protect imports. The European Union, for instance, has not granted export clearance to Indian dairy plants under the pretext of veterinary control, levels of antibiotic and pesticide residues, etc. Even Australia permits only retorted products to be imported. While countries like the EU and USA give massive export subsidies to their dairy farmers, in India, no such support is provided to dairy farmers, making them uncompetitive in global trade.

The government has assured the dairy farmers that it will protect their interests. At the same time, the possibility of giving greater market access, by reducing tariffs or other import restrictions, to select agriculture and dairy duced nor consumed in great quantities domestically, has been kept open. This is a sensible step, considering the growing domestic demand and consumer preference for premium, high value processed products. Furthermore, this can also be seen as a window for structural reforms to make the sector more competitive.

These reforms, particularly in supply chain management, are icant cha crucial and should comprise of India.

enhancing the quality of cattle feed, procuring quality milk, instituting rigorous quality controls, and cold chain management to increase shelf life. All with huge investment opportunities.

As per the projections on dairy demand in India, it is evident that production needs to be increased to meet the domestic demand. There is also need for investment in educating and training dairy farmers, and providing better infrastructure for the collection, transportation, and processing of milk to augment milk productivity and improve the quality of processed milk. Foreign investment, including that in agriculture and dairy services, can be sought for cold chain establishment, distribution and marketing.

It is also important to remember that foreign dairy players in the country prefer partnerships with local entities and avoid backward integration of direct procurement gration could have benefitted our dairy farmers a lot. Another step could be to move forward and lower tariffs on dairy products not produced in India or those having high domestic demand. The gender war in South Korea election

Political parties try to win young men back with carefully modulated anti-feminist dog whistles

ender is not the only issue in this election in South Korea, but it's the hot-button topic. It's not clear if there was ever a successful sexual revolution in the country, but the counter-revolution is definitely doing well. The 'F-word' (feminism) is being used a lot by both major parties, and not in a good way.

The conservative People Power Party (PPP), unsurprisingly, deplores the activism of young feminists. Presidential candidate Yoon Suk-yeol claims that "gender discrimination no longer exists", and blames feminism for South Korea's very low birth rate: "Some say feminism has been politicised to make it emotionally hard for

men and women to date." What's surprising is that the liberal Democratic Party's

candidate, Lee Jae-myung, sort of agrees. He's a bit shamefaced about it, but he has expressed his "distaste" for feminism and recently shared a post online that said the "madness" of feminism had to be stopped.

This is a long way from the politics of outgoing President Moon Jae-in, who is also a member of the Democratic Party. When Moon took office five years ago, he declared himself the country's first 'feminist president', raised the minimum wage and cut the maximum work-week from 68 to 52 hours.

Lee is not necessarily more conservative than Moon (he's promising a universal minimum wage), but on the gender issue he has had to retreat. Most of Korean politics is far behind, and even among



unchanged - the south-east and older people vote conservative, the south-west and younger people vote liberal, etc. but on this one issue there has been an anti-feminist land-

In by-elections last April for the mayors of South Korea's biggest cities, a staggering 72.5 per cent of young men in their 20s in Seoul voted for the PPP. The second city, Busan, was not

Their calculation is as simple as it is ugly. Young women who normally vote for the Democrats have nowhere else to go politically: there's no other liberal-inclined party with a chance of winning office. So, they can take the female vote for granted, and try to win the young men back with carefully modulated anti-feminist

dog-whistles. But what has happened to the young men? South Korea is still a strongly patriarchal society, but the young of both sexes were much more open to changing all that than the older generations - young women

more so than young men, for obvious reasons, but there was certainly not the yawning gap between the sexes that has opened up today.

Perhaps part of the reason was the country's first woman president, Park Geun-hye, who was impeached in 2017, found guilty on corruption charges, and sentenced to 25 years in prison. That wasn't misogyny she really did disgrace her

There is also a general shortage of suitable jobs for the generation now coming out of the universities and colleges, 70 per cent of whom have a postsecondary qualification. The Ministry of Gender Equality's activities gave young men who didn't get good jobs a reason to

And above all, the feminist movement itself took a wrong turn in about 2015. Radical online feminist sites adopted a strategy called 'mirroring', in which they took the worst kind of derogatory anti-female abuse and reshaped it as antimale abuse, e.g. 'hannamchoong' (male pest) for a man and 'gisaengchoong' (parasite)

What the radical campaign did, however, was to give misogynists, and the patriarchy in general, enough ammunition to wage a ruthless and largely successful antifeminist, even anti-female campaign in the media. That's why 75 per cent of urban young men vote for the PPP, and why many Korean feminists now call themselves 'equalists' instead.

Russia-Ukraine war: Shelling, evacuation continue

Efforts are ongoing to coordinate safe routes of escape for Ukrainian civilians out of besieged cities as the Russian invasion rounds out its second week. In the time since Russian forces swept into the country, some 2 million people have fled Ukraine, nearly half of them children with most people fleeing to neighboring Poland. Russian troops have captured swaths of territory in the south, but have faced fierce Ukrainian resistance in other regions.

Ukrainian officials say pregnant women, women with children and others will be able to leave the city of Sumy on Wednesday through a humanitarian corridor Russia and Ukraine agreed to. Some 5,000 civilians, including many foreign students, were able to flee the city on Tuesday in buses

Life has become increasingly desperate in cities cut from electricity and facing food and medicine shortages. In the port city of Mariupol, which has been without water, heat, sanitary systems and phone service for several days, bodies laid uncollected in the

Ukrainian President Volodymyr Zelenskyy vowed that his country would fight Russia's invasion in its cities, fields and riverbanks.

Civilian evacuations are expected Wednesday during a 12-hour-long window from the northeastern border city of Sumy to the city of Poltava. Nearly two dozen buses carrying aid to the city will pick up people seeking to flee, Ukrainian officials say.

A senior Ukrainian official says 5,000 people, including 1,700 foreign students were

Ukrainian officials say they will not accept Moscow's offer to establish safe corridors for civilians to head toward Russia, saying they will only agree to the safe exits leading west-

Other evacuation efforts stalled or were thwarted by Russian shelling on Tuesday. The planned evacuation of civilians from Mariupol failed because Russian troops fired on a Ukrainian convoy carrying humanitarian cargo to the city on Tuesday, according to Ukraine's deputy prime minister. Russia insists it is ready to provide humanitarian corridors for civilians to leave five Ukrainian cities. The two sides blame one another for previous failed attempts.

Russian and Ukrainian foreign ministers are meeting in

Biden to ask Congress for \$2.6B to promote gender equity

President Joe Biden has said that he will ask Congress for USD 2.6 billion for foreign aid programs that promote gender equality worldwide, more than double the size of last year's

Biden announced his intentions on International Women's Day, which recognizes the social, economic, cultural and political achievements of women around the

Biden created the firstever White House Gender Policy Council on International Women's Day last year to help promote gender equity throughout the administra-

He said everyone deserves to live up to their "God-given" potential, regardless of gender, and that societies perform better when women and girls are allowed to prosper.

"Ensuring that every woman and girl has that chance isn't just the right thing to do -- it's also a strategic imperative that advances the prosperity, stability, and security of our nation and the world," the president said in a written

statement

The White House also livestreamed International Women's Day event Tuesday to discuss the announcement, featuring Secretary of State Antony Blinken from Europe, acting budget director Shalanda Young, US Agency for International Development Administrator Samantha Power and Jen Klein, director of the Gender Policy Council.

They were joined by young women leaders from Ukraine, Brazil, Zambia, Burma, Jordan and the United States.

Jill Biden marked International Women's Day with a video tribute to women. She said during an appearance Tuesday in Arizona that the women of Ukraine and Russia were in her

"I'm thinking about the women in Ukraine fighting to keep their country safe, and those holding their children, you know, holding them close as they flee to safety. And we've all seen the pictures," she said in Tucson.

"You're mothers and you can see what they're going through, and your hearts go out to each and every one of them. And I'm thinking of the brave women of Russia who have risked their safety to speak out against the invasion.

"Women have never been silent. But women have been silenced, with violence, with discrimination, and with isolation, and it's work and care that is never done," the first Biden's USD 2.6 billion

Republicans accused Biden of moving too slowly to help Ukraine and NATO nations assisting it, and to impose sanctions against Russia and its president, Vladimir Putin. They've also used the crisis to amplify their years-long drive to ease drilling restrictions on federal lands and to oppose Democrats' attempts to curb carbon-heavy fuels that worsen climate change. Democrats said time was needed to bring along European allies that rely heavily on Russian energy sources. They also countered that plenty of drilling is available on nonfederal lands. A bipartisan push to ban Russian oil imports had grown perhaps unstoppable before Biden announced Tuesday that he would do that on his own.

China sends aid to Ukraine, nixes sanctions

hina says it is sending Chumanitarian aid including food and daily necessities worth 5 million yuan (USD 791,000) to Ukraine while continuing to oppose sanctions against Russia over its invasion.

Foreign spokesperson Zhao Lijian told reporters an initial batch was sent to the Ukrainian Red Cross on Wednesday with more to follow "as soon as possible.

China has largely backed Russia in the conflict and Zhao reiterated Beijing's opposition to biting economic sanctions against Moscow.

Zhao told reporters at a daily briefing that "wielding the stick of sanctions at every turn will never bring peace and security but cause serious difficulties to the economies and livelihoods of the countries concerned."

He said China and Russia will "continue to carry out normal trade cooperation, including oil and gas trade, in the spirit of mutual respect, equality and mutual benefit." China has sought to blame

the U.S. For instigating the conflict, citing what it calls Washington's failure to adequately consider Russia's "legitimate" security concerns in the face of NATO expansion.

Zelenskyy: Ukraine 'will not give up'

Ukrainian President Volodymyr Zelenskyy President evoked British wartime leader Winston Churchill as he told the UK Parliament that his country would fight Russia's invasion to the end in Ukraine's cities, fields and riverbanks.

Zelenskyy told British lawmakers "we will not give up and we will not lose," in a speech that evoked Churchill's stirring "never surrender" speech during the darkest days of World War II.

Speaking by video from Ukraine to a packed House of



Commons chamber, Zelenskyy urged Britain to increase sanctions on Russia and to recognize Russia as "a terrorist coun-

Tuesday's address was the first time a foreign leader was allowed to speak in the House of Commons. Screens and simultaneous translation headsets were set up in the House of Commons so lawmakers could hear him.

After finally crossing the Hungarian border by train along with hundreds of other Ukrainian refugees, the 10year-old Maslovska said she had begun to worry about her friends in Kharkiv after the messages she sent to them on Viber went unanswered.

"I really miss them because I can't contact them, they just read my messages and that's all. I really worry, because I don't know where they are," she said in clear English from inside the train station at the border town of Zahony.

Annamaria, who was raised alone by her mother, is one of more than 1 million children who have fled Ukraine in the less than two weeks since Russia first invaded the coun-

That means that children represent around half of the more than 2 million people that have fled the war, an exodus that the UN refugee agency has called the fastest-growing refugee crisis in Europe since World War II.

Most of those fleeing the war have entered countries on Ukraine's western border, like Hungary, Poland, Slovakia, Romania and Moldova.

The majority have gone into Poland, where 1.33 million refugees have crossed according to the Polish Border Guard

India ranks 2nd for global investment

ndia is the second-largest global venture capital investment hub for digital shopping companies, growing by a whopping 175 per cent from USD 8 billion in 2020 to USD 22 billion in 2021, according to an official analysis released here on Wednesday.

On a global scale, India came in second to the US last year, which attracted USD 51 billion in investment, followed by China at third with USD 14 billion and the UK at fourth with USD 7 billion.

Within India, Bengaluru comes out on top globally with USD 14 billion worth of Venture Capital (VC) investments in digital shopping in 2021, followed by Gurugram at No. 7 with USD 4 billion and Mumbai at No. 10 with USD 3 billion.

Bengaluru almost tripled its investments from USD 5 billion in 2020 to take the top spot, ahead of other leading cities in the world - New York City (second), San Francisco (third), London (fourth) and Berlin (fifth)

According to the London & Partners analysis of Dealroom.Co investment data, increasing demand for online purchases during a series of lockdowns across the world during the COVID-19 pandemic led to global investors showing a strong merce companies.

"Today's data shows that

the UK and India are two of the world's leading hubs for digital shopping companies with high levels of global investment and unicorns," said Hemin Bharucha, Country Director, India at London & Partners - the Mayor of London's international trade and investment

"It's fantastic to see Bengaluru emerge a global leader for digital shopping investment last year. This surely creates several opportunities for collaboration with an already strong market in

'As Europe's largest hub digital shopping investment, there has never been a better time for India's strong pool of fast-growing e-commerce companies to choose London as the destination to scale their business outside of their home market," he said.

The data also shows that Bengaluru ranked number 5 among cities with the potential for future unicorns, just behind London. Three of the 15 global

cities with the highest count of current unicorns are in India - Bengaluru at No. 6 with 19 unicorns in 2021 (up from three in 2020, Gurugram at No. 7 with 13 unicorns (up from 3 in 2020) and Mumbai at No. 14 with 7 unicorns.

London is the leading European hub for digital shopping investment, with a record tal shopping companies based

in the capital in 2021.

rounds into London-based digital shopping companies in 2021 included: USD 180 million series H funding round for online food delivery service, Deliveroo; USD 150 million raised by online used car marketplace, Carzam; and USD 55 million raised by online dog-food delivery service, Butternut Box.

"London has always been a city with a distinct creative style that comes from the grassroots and the street," said Julia Hawkins, partner at venture capital firm LocalGlobe.

The huge growth in ecommerce has pushed many consumers into communities where they can find their tribe. Combining London's creative flair with e-commerce and embedded fintech can create new opportunities for start-ups in London that the rest of the world will look to,' she said. Overall, global venture capital investment into digital shopping more than doubled in 2021 following a significant consumer shift to ecommerce platforms during the pandemic.

The total global VC investment for 2021 stood at a record USD 140 billion, up from USD 68 billion in 2020.

'Jail for doing biz' report: DPIIT Secy says bulk of trouble due to labour laws, States need to act

Abulk of the laws still making it difficult for businesses to operate is on the labour front, and State Governments will have to adopt the simplified labour codes passed by Parliament to make it easier for enterprises to thrive, a top Union Government offi-cial said on Wednesday. Reacting to a think-tank's

report of there being 26,000 laws where a breach can land an entrepreneur in jail, Department for Promotion of Industry and Internal Trade secretary Anurag Jain said the Government found out that 70 per cent of those relate to

"On studying it with the same group of people (the think tank), we found that almost 70 per cent relate to labour laws and as far as Parliament is concerned, they have enacted four Labour

And they have really simplified those laws," Jain said, speaking at an event organised by IVCA, a lobby group representing the venture investing

industry. "Now, the next step which is required is state govern-ments adopting the notifica-

tions and thereafter a formal notification will be done. So, we expect that to happen a few months down the line," Jain added. The bureaucrat said we

need to work together with the state governments, to ensure that they come on board quickly and the requisite notifications are issued to make it easier for businesses to operate. He also urged IVCA to initiate policy advocacy efforts in the same

In a report released last month, think-tank Observer Research Foundation backed by

Ambani's Reliance Industries said that among the 69,233 unique compliances that regulate doing business in India, 26,134 clauses have imprisonment clauses as a penalty which means non-compliance with two of five compliances can send an entrepreneur to jail.

Jain said in the last one year, the government has reduced 25,000 cumbersome compliances but was quick to add that it is cognizant of more work to be done on the same.

"Recently, there was an article about 'jailed for doing business'....27,000 laws where a per son can be jailed for doing business. We had a close look at it. We are very open that if somebody brings it out to our notice, we need to engage and see how to improve our systems," he

Jain also said that the government is separately working on ease of doing business 2.0

facilitate entrepreneurship.

Meanwhile, Jain said industry players in IVCA can deploy the mandatory 2 per cent corporate social responsibility (CSR) funding towards honing startups focused on sustainability goals or from the sectors identified as sunrise ones.

He also said that the growing number of Indian unicorns can each adopt one of the 100 districts identified for its backwardness as 'aspirational districts' and take efforts towards making entrepreneurship flourish at such places which are faraway from big cities like Bengaluru and Mumbai which are associated with business.

Jain said he is confident that good quality entrepreneurial talent exists in the smaller towns and cities of the country, and urged the industry to play its part to tap the same. He cited the case of cricket to illustrate the point, and said that the IPL

tournament helped deepen the talent discovery and now the Indian team consists of players from different parts beyond what used to be the established base.

The official said startups also need to seize the opportunities which will come the private sector's way with the newly announced Gati Shakti scheme, stressing that there is a scope for innovation in the project.

He said the startup ecosys tem is key for the India at 2047 development agenda because of its ability to solve problems and also as a centre of wealth cre-

Acknowledging that startups existed even before 2016, when the present Narendra Modi government launched a programme aimed at such enterprises, Jain said that they had not seen such a push from the policy front as it happened after the Startup India pro-

people of India. Nd everyone who loves the game. With much sadness but without regret, I say this with a heavy heart: I am retiring from the Indian domestic (first class and all formats) cricket," the Kerala-born pacer

"For the next generation of cricketers..I have chosen to end my first class cricket career. This decision is mine alone, and although I know this will not bring me happiness, it is the right and honorable action to take at this time in my life. I ve cherished every moment," he added.

Having made his international debut in an ODI against Sri Lanka at Nagpur on October 25, 2006, Sreesanth went on to win the inaugural T20 World Cup in 2007 and also the coveted ODI World Cup in 2011 under Mahendra Singh Dhoni's cap-

ICC Women's WC: West Indies beat defending champions England

The West Indies edged past defending champions England by seven runs in a thrilling leaguestage encounter of the ICC women's World Cup here on Wednesday, leaving the tournament favourites in a spot of bother.

Batting first, the West Indies women, despite an impressive opening stand of 81 between veterans Deandra Dottin (31 off 64 balls) and Hayley Matthews (45 off 58 balls), managed a mediocre 225 for 6 in 50 overs after opting to bat in their second league match.

Keeper-batter Shemaine Campbell (66 off 80 balls) and Chedan Nation (49 off 74 balls) were the stars of the show as they added 123 runs for the fifth wicket to steer

In reply, England nearly pulled through, courtesy a 61-run stand between Sophie Ecclestone (33 no) and Kate Cross (27) for the ninth wicket before being all-out for 218 in 47.4 overs. This was the West Indies' women's first ever World Cup

win over England. 'It's a nice feeling. Nerve-wrack-

ing for me though. When we checked the stats at this ground, we found that we were about 10 under par. We knew we had to bowl well and field well, West Indies captain Stefanie Taylor said in the postmatch presentation. West Indies have now won

both their games and are placed second on points table while England, with back-to-back defeats, including the opening round game against Australia, are placed sixth among eight teams.

'They batted outstandingly at the start and came hard at us. We came back well with the ball, but just struggled to break that partnership (Campbelle-Nation). Also gave a few too many in the last few overs. Obviously there is frustration,' said England skipper Heather Knight.
'Happy with the attacking intent

shown from our batters but we need to be more clinical in execution at crunch times, she added.

It was a steady start by the Caribbean women as Dottin and Matthews safely negotiated the first 20 overs before a collapse saw them slump to 81 for three from 81 for no loss and subsequently 98 for 4 just

When England batted, their innings never had the momentum as they were 72 for four at one stage and then 156 for 8 at the end of the 36th over before Ecclestone and Cross nearly carried them home with their highly effective partnership. It came down to the last three overs and it looked like the duo were going to get the job done as England required just nine runs for victory and still had two wickets in hand.

But Cross was run out at the non-striker's end when backing up too far and Anya Shrubsole was bowled by spinner Anisa Mohammed (2/24) three balls later to set off jubilant celebrations for the triumphant West Indies side.

Pacer Shamilia Connell (3/38) was the most successful Windies bowler among the eight used by skipper Stephanie Taylor.

practice. Saliva application was barred by the ICC in view of the COVID-19 pandemic and MCC said its research found that applying saliva had no impact on the ball's movement. "When cricket resumed following the onset of Covid-19, playing conditions were written in most forms of the game stating that applying saliva to the ball was no longer permitted. "MCC's research found that this had little or no impact on the amount of swing the bowlers were getting. Players were using sweat to polish the ball, and this was equal-

ly effective," it said. "The new Laws will not permit the use of saliva on the ball, which also removes any grey areas of fielders eating sugary

sweets to alter their saliva to apply to the ball. Using saliva will be treated the same way as any other unfair methods of changing the condition of the ball," it asserted. The changes in the code, which first came into existence in 2017, were suggested by MCC Laws sub-committee "which were subsequently approved at the Club's Main Committee meeting last week."
