Hijab ban in classroom | Cong cracks whip on PCC chiefs valid, rules K'taka HC

HC reasons: It is not essential part of Islam; verdict challenged in SC

PNS NEW DELHI

Muslim girl students cannot wear hijab (headscarf) inside classrooms. The Karnataka High Court on Tuesday upheld the ban on hijab in educational institutions in the State by dismissing pleas of Muslim girls. The court said hijab is not part of the essential religious practice in the Islamic faith.

The HC order drew criticism from senior Muslim leaders like Mehbooba Mufti (PDP), Omar Abdullah (National Conference), and AIMIM leader and Lok Sabha member Asaduddin Owaisi. The Muslim girls who had opposed the Government order against wearing hijab in classrooms rejected the judgment.

Within hours of the HC order, a Muslim student filed a plea in the Supreme Court challenging the HC verdict.

A three-judge full bench of the High Court said the prescription of school uniform is only a reasonable restriction, constitutionally permissible which the students cannot

Muslim students' body Campus Front of India (CFI) protested against the "anti-constitutional order" and vowed to take all efforts to protect constitutional and individual rights.

Chief Justice Ritu Raj Awasthi-led bench said, "We are of the considered opinion that wearing of hijab by Muslim women does not form part of essential religious practice in the Islamic faith." The CJ read

out portions from the order. The other two judges in the panel were Justice Krishna S Dixit and Justice IM Khazi.

The bench also maintained that the Government has power to issue the impugned order dated February 5, 2022, and no case is made out for its invalidation.

By the said order, the Karnataka Government had banned wearing clothes that disturb equality, integrity, and public order in schools and col

leges, which the Muslim girls had challenged in the HC

The bench also rejected the plea to initiate a disciplinary enquiry against the college, its principal and a teacher. "In the above circumstances, all these writ petitions being devoid of merits are liable to be dis-missed. In view of the dismissal of the petition, all the pending applications pale into insignificance and are accordingly disposed of," said the HC.

Congress on Tuesday Ccracked the whip on its chief of State units where the party had a dismal perfor-mance in the just-concluded Accombly elections under the Assembly elections under the leadership of Rahul Gandhi and Priyanka Gandhi.

"Congress president Sonia Gandhi has asked the PCC presidents of Uttar Pradesh, . Uttarakhand, Punjab, Goa and Manipur to put in their resignations in order to facilitate reorganisation of PCCs, Congress general secretary Randeep Singh Surjewala said on a day when dissensions within the party came in public after senior leader and former Union Minister Kapil Sibal asked the Gandhis to quit and pave way for others to run party affairs.

The move also came two days after a meeting of the Congress Working Committee (CWC) to discuss the party's performance and in which Sonia, Rahul and Priyanka had offered to relinquish their posts but were asked by certain members to continue. The CWC then authorised Sonia to make comprehensive changes in the party structure at the State and national levels.

AICC sources said that process for the overhaul of the organisational structure has begun and during the next meetings of the CWC and the proposed chintan shivr in Jaipur there could be announcements to advance the organisation elections presently scheduled for September 2022.



Sonia has been the interim chief since 2019 after Rahul quit the post in the wake of poor Lok Sabha performance

Assembly elections. Among those who have been asked to tender their resignation to Sonia is Navjot Singh Sidhu. Appointed the Punjab Congress chief in July by Rahul and Priyanka, Sidhu was singularly responsible for the ouster of the then Punjab CM Captain Amarinder Singh Sidhu also locked horns with Charanjit Singh Channi Captain's successor and Congress Chief Ministerial face in Punjab elections. As a result of this infighting, the Congress was reduced to 18 seats in the

Punjab Assembly polls. The Congress was unable to unseat the BJP in Uttarakhand and won only 19 out of 70 seats where it had a very formidable chance along with Goa. The elections were fought under the leadership of Uttarakhand PCC chief Ganesh Godiyal and former Chief Minister Harish Rawat.

Blame game on in Punjab Cong

Timing of Capt's ouster cause of rout, say leaders MONIKA MALIK ■ CHANDIGARH

After the fatal performance, the post-mortem! Days after the Congress party virtually faced political annihilation in Punjab, its leaders on Tuesday carried out a detailed dissection of the debacle, slinging the mud of humiliation at each other and blaming, among other things, timing of Capt Amarinder Singh's ouster from the Chief Minister's post. Former Chief Minister

Charanjit Singh Channi, State Congress chief Navjot Singh Sidhu, and senior leader Sunil Jakhar too took the direct hit for singing different tunes as a part of the same choir. At the same time,

Congress president Sonia Gandhi has asked Sidhu to submit his resignation to facilitate the reorganisation of the State party unit.

Congress in Punjab could secure just 18 seats, with the Aam Áadmi Party sweeping the Assembly polls with a thumping majority of 92 seats in the 117-member House.

As the Congress State leadership met on Tuesday to discuss the "reasons" for the poll

debacle, the party leaders lashed out at the top three leaders — Channi, Sidhu and Jakhar — for openly speaking against one another in the run-up to polls. Demands for ousting Channi, removing Sidhu as PPCC chief, fixing accountability were raised during the meeting of contesting candidates called by the State party affairs in-charge Harish Choudhary at Punjab Congress Bhawan on Tuesday to introspect on the party's drubbing.

"This was expected. Many leaders want to replace Sidhu as they believe that he did not work the way a party president should have during the elections. He was continuously questioning his own party's government, he was pointing fingers at the Chief Minister... and there is no doubt that the Congress has to face defeat because of that," a senior party leader, who was part of the manthan, told The Pioneer while reacting to Sonia's decision to seek Sidhu's resignation.

Sources in the party maintained that after the poll defeat, Choudhary himself was in favour to remove Sidhu as the State party chief. Besides, party's Ludhiana MP Ravneet Singh Bittu and even Channi are believed to have called for replacing Sidhu with new party

 $U^{kraine\ universities\ discouraged\ stranded\ Indian}$ students from leaving the wartorn nation and showed reluctance to offer them online courses, External Affairs Minister S Jaishankar said in Parliament on Tuesday.

Elaborating upon the fallout of the ongoing war for India, Jaishankar said it has major economic implications and the same can be seen in the rising prices of energy and commodities.

Giving details of Operation Ganga to bring back the stranded Indians from Ukraine after the Russian offensive began on February 24, Jaishankar said India managed to evacuate 22,500 of its citi-

"Despite our efforts, however, a large majority of students elected to continue stayreluctance to leave the educational institutions and affect the studies. Some universities actively discouraged and showed reluctance to offer online courses. Many of them received conflicting advice regarding safety," Jaishankar

He said in the period leading to February 24, the political signals were confusing as well. "Public urgings not to be taken by alarmism and reports of force withdrawal created a confusing picture. The net result was that about 18,000 Indian nationals were caught in the midst of conflict when it started," Jaishankar said.

The Minister said students did what they thought is right under the circumstance. He said India prepared in advance zens, including students, from of the actual conflict situation.

Narrating the time-lines, Jaishankar said the Indian embassy in Ukraine had started a registration drive for India ing in Ukraine. We must nationals in January, and as a understand the predicament in result, 20,000 Indian nationals registered with the Indian

embassy. The Minister said 4,000 students left Ukraine through direct and indirect flights. India also rescued 147 foreign nationals of 18 countries, including Nepal and Bangladesh from Ukraine, he informed both Houses.

PM lauds Kashmir Files for revealing 'ugly truth'





SC restores MediaOne's licence

Allocate more budget for clean air prog: Parl panel tells green Ministry

A parliamentary panel has pulled up the Union Environment ministry for "non-cooperative" and "unresponsive" behaviour of its officials towards public representatives and asked it to work towards greater budgetary allo-

cation to fight air pollution.

The Parliamentary
Standing Committee on
Science and Technology, Environment, Forests and Climate Change, in its 363rd report - 'Demands for Grants (2022-23) of the Ministry of Environment', directed the ministry to sensitise authorities to accord due courtesy to public representatives and make available the information

sought by them. The Committee yet again expresses its deep concern on the issue of non-cooperative and unresponsive behaviour of the officials dealing with environmental matters towards the public representatives."The



Pollution'," it said. Recognising importance of plastic waste management and elimination of single-use plastics, the panel asked the ministry to run awareness programs on a regular basis as single-use plastics are a bio-hazard which not only impact wildlife and ecosystems but also pollute the environment.

The Committee recommends ministry to run awareness programmes on regular basis, to educate people about ill-effects of single-use plastics and encourage them to use other sources as a replacement to plastic products in day to day usage."The Committee also norms and regulations to discourage use of single-use plastics and also lay down clear allocation of roles and responsibilities," it said.

On issue of man-animal conflicts, the panel recommended proactive steps by ministry of environment, noting that incidents were on rise and still remain an area of concern. "As such, there is an urgent need to minimize instances of man-animal conflict that was resulting in both human and animal killings.

panel recommends that ministry should take proactive steps to sustainably manage and minimise man-animal conflict in a balanced manner, whereby wildlife habitat is improved," it said. The Committee urged ministry to evolve a mechanism for uniform compensation, early settlement of compensation and rehabilitation of victims of man-animal conflict

No embassy can be part of negotiations

The Delhi High Court on Tuesday refused to direct the involvement of the Central Government in the payment of 'blood money' in connection with the death sentence awarded to a Kerala woman in a murder case in Yemen and said that no embassy can be part of negotiations to pay blood

Justice Yashwant Varma, who was hearing a petition by an organisation seeking Centre's intervention to save the life of the Indian citizen-- Nimisha Priya, said the court cannot ask the government of India to countenance such a payment and requested the authorities to facilitate the appropriate legal action against the conviction of the woman.

The petitioner, 'Save Nimisha Priya International Action Council', sought a direction to the Centre to "facilitate

diplomatic interventions as well as negotiations with the family of victim on behalf of Nimisha Priya to save her life by paying blood money in accordance with the law of the land in a time bound manner". Blood money refers to the compensation paid by an offender or his kin to the family of the victim.

to pay 'blood money', says Delhi HC

'No embassy can be part of negotiations to pay blood money. You can do it personally, privately," the court stated.

"In so far as the first relief is concerned, the court cannot command the union to be a party to the negotiations which the family of the convict proposes to initiate," it opined. Lawyer Subhash Chandran KR, appearing for the petitioner said that the petitioner will pay the blood money and negotiate with the tribe of the victim but the assistance of the government was needed in view of the present social and political situation in Yemen. The court stated

that it can, at best and in law, call upon the Centre to facilitate the petitioner in pursuing the judicial remedy under the laws of Yemen. Central government lawyer Anurag Ahluwalia said that bearing in mind that the convict is an Indian national, the authorities shall take all proactive steps to institute an appeal before the next appellate forum in accordance with

the prevalent law and the concerned consular shall extend all cooperation and facilitate the travel of the petitioner to Yemen. "Accordingly, concerned Ministry is requested to duly pursue the remedy against the order of conviction as affirmed by court of appeal," the court

The court further requested the Ministry of External Affairs to communicate to concerned consulate to facilitate travel of the petitioner as well as to provide help of interpretators if so required. The petition said

Nimisha Priya was an Indian nurse working in Yemen and she was convicted in 2020 for the murder of the Yemini national. It said Priya was accused of murdering Talal Abdo Mahdi who died in July 2017 after she injected him with sedatives to get her passport that was in his possession. It said she injected him with sedatives so that she could take her passport from him while he was unconscious. However, he died of an overdose.

The plea alleged that Mahdi had forged documents to show that he was married to her and that she was allegedly abused and tortured by Mahdi. Though she appealed against death penalty, it was rejected, it said, adding that another chance of appeal before Supreme Court there still exists but Priya is unlikely to be spared and therefore, her only hope to come out of death sentence is if victim's family accepts blood money.

Probe Delhi riots as per law, sans influence: HC

The Delhi High Court on Tuesday asked the Delhi Police as to why it has not filed a charge sheet in the case concerning the death of a 23year-old man who was forced to sing the national anthem during the 2020 northeast Delhi riots and asked it to conduct its investigation without influence as per the law.

Justice Chandra Dhari Singh, who was hearing a petition by the deceased's mother seeking a speedy and proper investigation, said that the case was to be taken seriously and asked the investigating agency to "take into account" the "suggestions" by the petitioner in her plea.

The incident relates to a

could be seen allegedly being beaten by policemen while being made to sing the national anthem and chant 'Vande Mataram'. Kismatun, the mother of the deceased man, has sought an SIT probe into the death of her son, who along with four other Muslim men, was seen in the video.

The woman has claimed that the police illegally detained her son and denied him critical medical attention due to which he succumbed to the injuries on February 26, 2020. The DCP concerned told

the court that the case involves "technical evidence" and that the investigation has "zeroed down a head constable making the video" and not assaulting the victim and that no stone was being left unturned in the probe. The judge, who remarked that there was "no

ground to disbelieve" one of the highest officers in the police machinery, was further informed by Delhi police lawyer Amit Prasad that while they have "identified some people, confirmation was needed from all angles".

The court was informed that the agency will take eight more weeks to complete the probe. The court clarified that it was not interfering with the manner of investigation and added, "The son of a mother has died. I'm not commenting on how and when (but) it has to be taken very seriously" and dealt with as per the crim-

Delhi police said that the statements of the witnesses have been recorded and one of the surviving persons, who was with the deceased, has not alleged any "violence" and

that the investigating agency was awaiting the outcome of certain other technical tests. Lawyer Vrinda Grover

appearing for the petitioner, stated that no arrest was made in the case and the police earlier made a false statement concerning the status of CCTVs in the concerned police station and that the investigating agency was not probing the "second scene of the crime" i.e the police station and sought permission to file a response to the police status report.

The court asked the petitioner to raise objections after the charge sheet is filed and asked her to "have some faith in the investigating agency" and observed that there was "no reason to disbelieve" their stand by invoking the writ jurisdiction. The matter would be heard next in May.

The meeting was also joined by the concerned department officials and over 30 such locations were revisited and reviewed in the meet-

"We aim to take effective steps well in time before the monsoon season is upon us. There has been much progress in the areas where waterlogging in the past has been of concern and these will again be reinspected. Projects involving various government and private institutions are all being monitored and suitable remedial actions are being taken to curb waterlogging woes on Gurugram roads," said Rajpal. Some of the crucial areas of

waterlogging situation across Officer (CEO), GMDA, Sudhir arrangement of NH-48 near Mini Secretariat, Hero Honda Chowk, Golf Course Road, Sheetla Mata Road among others. Suitable action plans were proposed and a time-frame for completion was set before the onset of the monsoons.

To curb waterlogging issue Umang Bhardwaj Chowk, NHAI has been assigned to look into the matter on priority by creating the master drain first, ahead of the upgradation and widening of the roads which is underway on this stretch.

"Keeping in view of the past events of waterlogging in underpasses in the city, prior arrangements are being made to address the issue and mock drills will also be done in the month of May," added Rajpal.

Aday after an under-construction building collapsed in Kashmere Gate area, the Aam Aadmi Party (AAP) alleged that the incident happened due to "negligence" and "conspiracy" of the BJP and the building mafia. AAP senior leader and MCD in-charge Durgesh Pathak said that the party will file FIRs against BJP Councilors, the Mayor and the BJP state president and demand the strictest punish-

Accusing the BJP leaders, Pathak said that the civic body was well aware of the threat as AAP MLA Prahlad Singh Sawhney complained several times to the MCD but the BJP leaders did not act upon it. "BJP leaders fraudulently got the map of a 180 sq yard building approved under the SARAL scheme by showing it to be of 80 sq yards. SARAL scheme applies only to buildings up to 100 sq yards in area," he said.

Leader of Opposition in North MCD Vikas Goel said, "I am certain that once this matter is investigated the links of the builder with the BJP leaders will be exposed."Pathak said that AAP MLA Sawhney wrote a letter to the Commissioner, the Mayor and all authorities concerned, stating that the project was in violation of MCD's rules and regulations and is completely illegal. "Sawhney wrote two more letters dated 8th and 9th February respectively.

Through these letters and communication channels, he shared all the details of the illegalities of the construction project. He even wrote a letter to the L-G on 9th February informing him about the illegitimate construction that can pose a threat to lives of people working and living in the area. But no action was taken in this regard," he added.

Two men held for murdering gas godown guard

Delhi Police has arrested two persons for allegedly killing the security guard of a gas godown in order to rob money from the warehouse in northeast Delhi's Shastri Park area. The accused have been identified as Manish Kumar Mandal (19) and Vishal Singh (20), both residents of Bihar.

Police were informed around 9 am on Monday that a man was found dead at site number 2 of GS Enterprises, a gas agency. When police reached the spot, they found the security guard was lying in a pool of blood, in a cabin adjacent to the gas godown, police said. The deceased was identified as Ganesh Lal Kori (50), a resident of UP. His mobile phone was also found missing,

police said. They checked the CCTV footage and found three suspected persons near the guard room around 9:30 pm on Sunday. One of them was noticed entering it with a rod in his hand, a senior police officer said. He was identified as

Manish who earlier used to work as a labourer there. Manish's brother Virender still works at the godown as a dri-

On early Tuesday, a raid was conducted and two persons were nabbed from Tripathi Enclave, Suleman Nagar, Kirari, Deputy Commissioner of Police (northeast) Sanjay Kumar Sain said. During interrogation, they revealed that their third associate is a juvenile. The accused are drug addicts and were facing a financial crunch.

The primary focus was immunisation of children with comorbidities but due to the unavailability of data of such children, we have decided to open immunization for all the

years, said Dr Arora.

As regards the importance of the Siliguri corridor where the Army conducted the drill ten days back, they said it is a stretch of land bordering Nepal, Bhutan and Bangladesh. It connects the Northeast region with the rest of India and is considered crucial from the military perspective.

Modi, Kishida likely to discuss China's aggression at LAC

China's aggressive posturing in the Indo-Pacific region and continuing stand-offs at the Line of Actual Control (LAC) in Eastern Ladakh are likely figure prominently in the talks between Prime Minister Narendra Modi and Japanese Prime Minister Fumio Kishida here on Saturday. The two leaders are also likely to review the situation arising due to the Ukraine crisis.

The Japanese prime minister will visit New Delhi for a day and will leave for Cambodia the next day, sources said here on Tuesday. Besides security related issues, the two leaders will also explore ways to further enhance their ties in the field of trade and commerce and more bullet train projects besides the Mumbai-Ahmedabad corridor, they said.

The 17-billion dollar project was inaugurated in 2017 by former Japanese PM Shinzo Abe and Modi. The project is largely funded by loans from International Cooperation Agency (JICA).

The annual summit between the two leaders was put off several times since 2019 due to various reasons. The upcoming event comes at a time when this year marks the 70th anniversary of the establishment of India-Japan bilateral ties. The two leaders will also discuss the upcoming QUAD summit in Tokyo.

India and Japan have forged a "Special Strategic and Global Partnership," and started annual summit level talks in 2005. The talks are held alternately between the two countries each year. The last in-person, 13th

annual summit was held in 2018 when Prime Minister

Modi visited Japan. Abe's visit for the 14th annual summit was cancelled at the last minute as he was due to visit Guwahati when protests against the Citizenship Amendment Act broke out in 2019. The covid pandemic forced postponement of summit in 2020. The two Prime Ministers held telephonic talks in September 2020.

Modi then met Abe's successor Yoshihide Suga for a summit on the sideline of the first in-person meeting of the heads of states of Quad nations in Washington last year hosted

'Chair of Excellence' to be set up in first CDS' memory

A'Chair of Excellence' in memory of India's first Chief of Defence Staff (CDS)General Bipin Rawat will be set up at the United Services Service Institution(USI), a leading military think tank.

The announcement in this regard by Army Chief General M M Naravane here on Tuesday came a day ahead of the 65th birthday of General Rawat. He was killed in a helicopter crash near Coonoor in Tamil Nadu on December 8 along with his wife Madhulika and 12 armed forces personnel.

The 'General Bipin Rawat memorial Chair of Excellence' will focus on the field of jointness and integration among the armed forces.

"Late General Bipin Rawat who served as India's first CDS as well as the 27th Chief of Indian Army was an outstanding professional and was in the midst of steering one of the most radical transfor-mations of the Indian military," the Army said.

The Chair of Excellence is a befitting tribute to the astute leadership and professionalism of the General," it said in a statement. Naravane said General Rawat was passionate about strategic thoughts and invested considerable time and energy in the activities of various think tanks.

"And, therefore, his 65th birthday provided an opportune moment to reinforce the services' bond with their intellectual institutions. The Chair will be open to veterans of three services and civilians having expertise in the field of national security," Naravane said.

The topic for this year's research has been chosen as jointness and integration in the context of land warfare in

SC to set up Bench to hear | ED attaches assets of 2 Gujarati bizmen for selling fake shots

PNS NEW DELHI

Enforcement Directorate (ED) has attached over Rs 21.5 crore in five separate cases of money laundering across the country, including assets worth Rs 1.04 crore of two Gujarat-based businessmen, who allegedly sold "fake" Remdesivir injections packaged in the style of a reputed brand during the second wave of the Covid pandemic last year.

Kaushal Mahendra Bhai Vora and Punit Gunvantlal Shah manufactured fake injections of the antiviral drug at a farmhouse-cum-manufacturing facility in Surat and sold them in Madhya Pradesh and some other states, the agency

'The said fake Remdesivir injections were being manufactured by mixing glucose and salt in the deceptively similar bottles having similar stickers to that of branded original injections. Empty bottles of the same size and similar

appearance, huge quantities of glucose and salt, huge packing material, fake stickers and other raw materials in huge quantities were seized during the raids conducted at the farmhouse-cum-manufacturing facility at Surat by the Morbi Police, Gujarat," the ED said in a statement.

"The accused sold fake Remdesivir injections to various vendors who further sold the same to needy retail customers at exorbitant prices. In some cases, the injections were directly sold to retail customers who were identified by the accused persons through social media platforms during the peak of the second wave of COVID-19," it said.

Huge number of fake Remdesivir injections were purchased and injected to various patients at "exorbitant prices" by a hospital based in Madhya Pradesh, the ED probe found.

The anti-viral drug was part of the clinical management of coronavirus patients.

Of the attached assets, Rs 89.20 lakh cash was found in possession of Vora, who "masterminded" the entire conspiracy of manufacturing fake Remdesivir injections and Rs 11.50 lakh cash and Rs 3.92 lakh worth deposits in bank were found in possession of Shah, the co-conspirator in the production and supply of

the fake injections. In a separate case, Rs 1.5 crore of former Odisha BJD MLA Anam Naik was attached by the ED under the antimoney laundering law while it attached 15 immovable properties worth more than Rs 13.51 crore in Servomax India Private Limited bank fraud worth Rs

The ED also attached assets worth Rs 3.94 crore in a case registered against Nalini Prusty, an Odisha Financial Service officer, Bijava Ketan Sahoo, an OAS officer (her husband) and others for "assets disproportionate to their known source

₹1,000 monthly EPFO pension grossly inadequate: House panel

PNS NEW DELHI

Parliamentary panel on Armanientary Puriimum monthly pension of Rs 1,000 for subscribers of the pension scheme run by retirement fund body Employees' Provident Fund Organisation (EPFO) is "grossly inadequate" and it is imperative for the labour ministry to pursue a proposal for raising the amount.

"...Rs 1000 per month pension which was fixed eight vears back appears to be grossly inadequate now", the Parliamentary Standing Committee on Labour said in its 30th report on Demand for Grants , tabled in Parliament on Tuesday,

The panel said it becomes imperative on the part of the Ministry of Labour and Employment to pursue the matter with the Ministry of Finance for obtaining adequate budgetary support as recommended by the High-Empowered Monitoring

Committee, besides impressing upon the EPFO (Employees Provident Fund Organisation) to make an actuarial assessment of all its pension schemes so that the monthly member pension is enhanced to a reasonable extent.

The panel noted that in 2018, the ministry constituted High-Émpowered Monitoring Committee for complete evaluation and review of the Employees Pension Scheme, 1995. That committee in its report had inter-alia recommended that minimum monthly pension payable to the member/widow/widower pensioner may be raised to at least Rs 2,000, provided annual budgetary provision for the same is made, it stated.

However, it also noted that the Ministry of Finance has not agreed to any such enhancement in minimum pension beyond Rs 1,000 per month. The parliamentary panel found that the issue has been discussed in detail by several committees which have come

to the conclusion that unless the actuarial assessment of surplus/deficit of EPFO's pension schemes is made, revision of the monthly pension cannot

It also said difficulties are being faced by EPFO members for e-nomination, especially by those who retired before 2015, as well as in the functioning of the Online Transfer Claim Portal (OTCP). While taking note of the appreciable efforts made by the EPFO to maximise use of information and technology tools in line with Digital India initiative, the panel suggested that the retirement fund body should strive further to usher in systemic improvements to address the problems faced in e-nomina-

The pane further noted that out of the target of 71.80 lakh beneficiaries by March 31, 2022 under the Atmanirbhar Bharat Rojgar Yojana (ABRY), a total of 47.06 lakh employees have benefited as on February

IMD predicts heat wave in parts of India

The IMD predicted severe heatwave conditions in Mumbai on Tuesday and Wednesday. The situation is expected to improve by Thursday, it added. At the same time, the temperature in Delhi will also increase between 36 and 37 degree Celsius by March 18.

The IMD said that the maximum temperatures were above normal by 3-6°C at most places over Punjab and Uttarakhand; at many places over Jammu-Kashmir-Ladakh-Gilgit-Baltistan-Muzaffarabad at a few places over Himachal Pradesh, West Rajasthan and Saurashtra & Kutch; at isolated places over East Rajasthan and Gujarat Region.

Myopia an emerging health issue in schoolchildren

Myopia (near-sightedness) is already an emerging public health problem in both urban and rural school going adolescents in India. With the Covid-19 induced impact of digital screen time being feared to cause its progression., Ophthalmologists from the Dr RP Centre of AIIMS, Delhi, are mulling a study in this regard to frame corrective

Dr JS Titiyal, Chief of RP Centre, AIIMS, Delhi, said there have been complaints of Myopia progression among children. "But we do not have exact data for India. The results could be alarming. We are working on a strategy to assess the extent of the pro-

gression stage," he told The

It is important to study the habits that increase Myopia among children who have been left to rely on digital devices to continue with their

education. Uncorrected Myopia can result in an increased number of blindness, and the risk of retinal detachments, glaucoma and age-related macular degeneration while an increase in Myopia could lead to many not having access to services for prescriptions, thereby increasing amblyopia.

Doctors point out that among the risks to eye health associated with the use of digital devices are unstable binocular vision (using both eyes adequately to create a single

visual image), eye strain, uncorrected refractive error and dry eyes.

Health experts advise that kids should spend time outdoors, especially in early childhood, as it can slow the progression of nearsightedness.

According to a review paper, published in the Journal of School Health and led by Anglia Ruskin University (ARU), various research studies showed a consistent picture of increased digital screen time for children and adoles-

cents across the countries. The review also reported that "children and adolescents often use several devices at once, for example to browse social media on their phone while watching content on another device. Switching strain on the eye by 22 per cent, as this entails switching distances between different devices, forcing the eyes to adjust. The WHO has also raised alarm that the prevalence of

between devices increases the

myopia is increasing at an alarming rate; 1.89 billion people in the world have myopia. According to a study published in the PloS One journal by Indian doctors in 2020

there is an increasing trend of myopia in India over the last four decades. It showed "crude prevalence of myopia over the last four decades is 7.5 per cent in the 5-15-year age group, being 8.5 per cent and 6.1 per cent in urban and rural school going children respectively."

HC rejects Malik's interim bail plea

Says Maha Minister's arrest was in order, ED complied with PMLA provisions

PNS MUMBAI

The Bombay High Court on Tuesday rejected the interim bail application of Maharashtra Minister and senior NCP leader Nawab Malik in a money laundering case, after holding that the Enforcement Directorate (ED) had duly followed the requirement under section 19 the Prevention of Money Laundering Act (PMLA), in effecting Malik's arrest.

Rejecting Malik's contention that his arrest was illegal and his plea for interim bail, a HC bench of Justices SM Modak and PM Varale noted: "In the present case, there is no dispute on the factual aspect that custody order is passed by the competent Court of jurisdiction i.e., the Special Court and secondly, merely because the order is against the

Petitioner it cannot be termed as patently illegal or suffers from non application of mind. In our opinion, this twin test is duly applied in the present

The HC bench also noted that "... we find merit in the submission of learned Additional Solicitor General (ASG) that the requirement of Section 19 (of PMLA) is duly

"At this stage, we are not impressed by the arguments of learned Senior Advocate Shri Desai that there is no act attributable to the Petitioner so as to attract the provisions of the PMLA, 2002," the Judges noted.

Holding that the investigation initiated by the ED was at an initial stage, the bHC bench observed that the court was not expected to assess evidence and record any finding in respect of material collected by the probe agency. "So we deem it proper to peruse them (the papers) once the Petitioner will argue the Petition to the fullest extent," the Judges noted.

Malik was arrested by the ED officials on February 23 in connection with the purchase of a huge plot of plot of land at "a throw-away price" from two



alleged henchmen of Karachibased Dawood Ibrahim.

The ED's contention is that Malik and his family had purchased 2.80 acre plot of land from the "front men" of Dawood Ibrahim's sister Haseena Parker -- Mohammad Salim Patel -- and 1993 blasts accused Badshah Khan at a throw away price in 2005.

In the backdrop of the ED's contention, the HC bench noted: "When we have perused the un-amended provisions of Section 3 we may find that process or activity connected with proceeds of crime" is one of ingredient. It's a wider term. Its constitutional validity is not challenged before us. So prima facie we feel that the said contention cannot be accepted at this stage".

"There is an FIR registered by NIA dated 03.02.2022 and on that basis there is ECIR registered on 14.02.2022. There are also previous FIRs and on that basis separate ECIR in the year 2017 and 2019 were registered. Now the Enforcement agency has merged them and combined investigation is undertaken... Considering all the above referred grounds, we are not inclined to allow the prayers in the said applications. Resultantly, Interim Applications are rejected," the

HC bench ruled. After being in the custody of ED for 12 days, Malik is currently in the Judicial custody till March 21 in the money laundering case.

BJP looking for new UP Speaker after poll victory

The Bharatiya Janata Party, after its second consecutive victory in UP Assembly elections, has initiated the process for the election of the Assembly Speaker. Speaker of the 17th UP Assembly, Hriday Narayan Dikshit, had not contested the Assembly election as he had turned 75 years. The BJP is looking for his successor in the new Assembly.

"The exercise to elect the new speaker will be conducted after the swearing-in ceremony of the chief minister and the cabinet. The names of Suresh Khanna, Satish Mahana and Ramapati Shastri are doing rounds as prospective names for the position," a senior BJP leader said. These leaders are seniormost in terms of legislative experience among all BJP MLAs in the state, he added.

A nine-time MLA from Shahjahanpur, Khanna (68) has served as a minister in the governments of Yogi Adityanath, Kalyan Singh, Rajnath Singh and Ram Prakash Gupta. He was also a minister of state in the Bahujan Samaj Party-Bharatiya Janata Party coalition government headed by Mayawati in 2002. In the earlier Yogi Adityanath-led government,

Khanna was minister for parlia mentary affairs, medical education and finance.

Mahana is another senior BJP MLA who is being considered for the post of assembly speaker. In his tenure as a legislator, Mahana contested from Kanpur Cantonment constituency for the first five terms and then from Maharajpur constituency for the remaining terms. The 61-year-old leader also owns a business.

Like Khanna, Mahana has also been a minister of state in the governments led by Kalyan Singh, Rajnath Singh, Ram Prakash Gupta, Mayawati and cabinet minister in the Yogi Adityanath government.

The third name that is being considered is Ramapati Shastri, 72, who is the newly elected MLA from Mankapur (SC) seat in Gonda district. The agriculturist-turned-politician has served as a cabinet minister in the governments of Kalyan Singh, Rajnath Singh and Yogi Adityanath. He is a six-term

"As he belongs to the Scheduled Caste community, Shastri's name is under consideration. His appointment as the assembly speaker will send out a strong message to the Dalits," a party leader observed.

The Mahan Dal president attacked SP leader Swami Prasad Maurya who lost the Assembly election from Fazilnagar constituency in Deoria district.

Questioning the entry of Swami Prasad Maurya in the Samajwadi Party ahead of the UP Assembly elections, the Mahan Dal leader said, "Swami Prasad Maurya's entry in the Samajwadi Party was a conspiracy by the Bharatiya Janata Party. Maurya was drafted in the Samajwadi Party at the behest of the BJP with a clear political design.

Swami Prasad Maurya was labour minister in the Yogi Adityanath government and had joined the Samajwadi Party in January.

"With the entry of Swami Prasad Maurya a sense of com-placency gripped the Samajwadi Party. The SP became confident that it would now get the majority of votes of the Other Backward Classes (OBCs). The SP leadership should have realised that no particular leader commands the votes, it is the political party which has the vote bank," the Mahan Dal president said.

He charged that due to the influence of Swami Prasad Maurya, the full potential of Mahan Dal was not used during the elections.

The overconfidence of Swami Prasad Maurya proved to be a disaster for the Samajwadi Party as he led Akhilesh Yadav to be complacent about closely contested UP assembly elections," the Mahan Dal president said, and added, "Swami Prasad Maurya has lost the confidence of the people and he could not even win the election but he is in the habit of making tall claims."

"Mahan Dal was not given due importance in seat distribution among the allies of the Samajwadi Party. Mahan Dal was given only two seats while more seats were given to Rashtriya Lok Dal and Apna Dal (Kamerawadi). If the Samajwadi Party fails to honour the allies and does not give due importance to us then the Mahan Dal will be constrained to explore other options," said Mahan Dal president Keshav

Pitted in a direct contest with the BJP, the SP increased its seat tally and its vote share by 11 per cent but fell way short of the half-way mark of 202 in the UP assembly. In 2017, when the SP fought the polls in alliance with the Congress, it had won 47 seats, with a vote share of 21.28 per cent. This time, it has won 111 seats with a vote share of 32 per cent.

After losing the 2017 assembly election and the setback in the 2019 Lok Sabha polls, Akhilesh Yadav decided against alliance with former partners Congress and Bahujan Samaj Party. For 2022 assembly elections, Akhilesh made more strategic alliances, with small caste-based parties, thus forging cohesive, calculated vote banks. These included Om Prakash Rajbhar's Suheldev Bhartiya Samaj Party (SBSP), Mahan Dal led by Keshav Dev Maurya, Janwadi Party (Socialist) led by Sanjay Singh Chauhan, Apna Dal-Kamerawadi led by Union Minister Anupriya Patel's mother Krishna Patel, and most importantly the RLD in western.

Priyanka asks leaders to file UP debacle reasons report

ongress general secretary Cand UP in-charge Priyanka Gandhi Vadra has summoned senior leaders from Uttar Pradesh with a review report on the reasons for the defeat of the party in the UP Assembly elections.

Meanwhile, Congress supremo Sonia Gandhi has asked the presidents of the **Pradesh Congress Committees** of Uttar Pradesh, Uttarakhand, Punjab, Goa and Manipur to put in their resignations to facilitate reorganisation of PCCs, Congress leader Randeep Singh Surjewala said in a tweet on Tuesday.

Now UPCC chief Ajay Kumar Lallu has to resign.

In the review meeting held at the Congress headquarters here on Monday, the candidates enumerated the reasons for their defeat. Only two Congress MLAs, including the party's leader in state assembly, Aradhana Mishra 'Mona', have won the election.

Vadra on Tuesday evening also held discussions with the leaders on the reasons behind the party's debacle in New Delhi.

Earlier, party national secretaries Tauqir Alam, Pradeep Narwal, Rajesh Tiwari, Bajirao Khade and Satyanarayan Patel and UPCC president Ajay Kumar Lallu held a meeting with the candidates and officebearers and inquired about the reasons for the defeat.

Many candidates complained of non-support of the organisation and no help by local leaders. Most of the candidates attributed the election to direct fight between the two parties as the reason for the defeat of the Congress candidates as well as those of Bahujan Samaj Party.

At the same time, the candidates were also asked which people helped them and how many did good work. Many candidates also shared their experiences in writing.

They also highlighted the

high command's failure to build cadres and to keep the leaders with a significant voter base in their areas in the party

Sources in the party said that before the elections, organisational leaders had assured that at least 10-member committees were formed at every booth before the election but many candidates got less than 1,000 votes in assemblies having about 400 booths.

"We were told that 10 youth committees were formed at the booth level in every constituency. There are about 400 booths in every assembly segment. But a candidate getting 1,200-1,500 votes means that even those 10 members that party claimed were party workers did not vote for the party nominees,' said a party candidate, and added, "Not even women got votes."

Days after one of its unarmed supersonic missile crashed into Pakistan, India on Tuesday asserted its missile system was reliable and the safety procedures were of the highest order.

Giving this assurance in Parliament, Defence Minister Rajnath Singh expressed "regret" over the incident. Noting that the accidental firing was taken seriously by the Government, Rajnath also informed both Houses that a high level probe was ordered to find out the cause.

A review of standard operating procedures was also initiated, he said. In his statement in the Rajya Sabha, the Minister said, "I would like to brief this august House about an incident that took place on March 9,

This incident relates to

tine maintenance and inspection, a missile was accidentally released at around 7 pm."

The Minister said it was later learnt that the missile had landed inside the territory of Pakistan. "While this incident is regretted, we are relieved that nobody was hurt due to the accident. I would like to inform the august House that Government has taken serious note of the incident," he said.

Pointing out that Government has ordered a high-level inquiry to determine the exact cause of the accident, the Minister said a review of the Standard Operating Procedures for operations, maintenance and inspections was being conducted. "We attach highest priority to safety and security of

weapon systems. If any shortcoming is found, the same would be



"I can assure the House that the missile system is very reliable and safe. Moreover, our safety pro-

cedures and protocols are of the highest order and are reviewed from time to time. Our Armed Forces are well-trained and disciplined and are well experienced in handling such systems," he said. A missile launched from a base in Sirsa crashed more than 140 km inside Pakistan in an area called Mian Channu.

Clear as mud

The Karnataka and Kerala HC rulings on hijab are at variance; now the SC needs to clarify

The Supreme Court of India has to intervene in the Karnataka hijab case for the simple reason that we now have two judgments, of the Karnataka High Court on Tuesday and the Kerala High Court of 2016, that differ on whether the hijab is an essential Islamic practice. The Karnataka judgment says it is not. It banks, apart from various Islamic sources, on the work of jurist Abdullah Yusuf Ali who states that "...for Muslim women generally, no screen or hijab (purdah) is mentioned, but only a veil to cover the bosom, and modesty in dress". The Kerala High Court banks on the "analysis of the Quranic injunctions and the Hadiths" to conclude that "it is a farz to cover the head and wear the long-sleeved dress except (the) face part and exposing the body otherwise is forbidden (haram).... When farz is violated by an action opposite to farz, that action becomes forbidden (haram)". The girls of the educational institution in Udipi, who are not able to attend their classes because they refuse to remove their hijabs in classes and fear that they may miss out on their examinations due shortly, will not be wrong if they cannot decide which judgment to follow. The Karnataka High Court agrees that while the Quran does not mandate

the wearing of hijab for Muslim women, "there is sufficient intrinsic material within the scripture itself to support the view that wearing hijab has been only recommendatory, if at all it is".

Recommendatory does not amount to being mandatory surely, but it also does not prohibit the use of the hijab. It only means it leaves it to the discretion of the user. Also, the court says "this apparel at the most is a means to gain access to public places and not a religious end in itself. It was a measure of women's enablement and a figurative constraint". Then where is the problem? The point being

made here is how we end up splitting hairs and cross the realm of reasonableness if the essential practices doctrine is rigidly followed where matters of religion happen to conjoin matters of personal choice and freedom. The Karnataka High Court also says the hijab cannot be part of the uniform code because a uniform instils a sense of discipline. Interestingly, on Tuesday, the same day as the judgment, news reports say Sikhs can carry a small 'kirpan' with them to high-security installations like airports. Sikh students wear headgear and unshorn hair in schools, the colour of the headgear often matching their uniforms. Religious symbols are allowed to be worn in several uniformed services where discipline is mandatory. The hijab case, therefore, needs a clarification from the Supreme Court so that the essential practices doctrine is not misconstrued to be regulating diversity in the name of discipline and uniformity and deny individual choices and freedoms in cases which do not pose any danger to society to invite restrictions.

Ugly truth

Every creative expression has the right to live, and to get discussed. Don't muzzle it

he ongoing controversy over Vivek Agnihotri's *The Kashmir Files* is highly uncalled for; it's against basic civility. We are witnessing a strange phenomenon in a country that claims to be democratic, secular and pluralistic. Goons affiliated to certain political and religious outfits are threatening cinema hall proprietors and management to screen, or to take off, the movie based on the suffering of Kashmiri Pandits who were forced to flee their native State as part of ethnic cleansing in January 1990. Their slaughter and unending trauma in the name of religion are open secrets; now



they are forced to live as refugees in their own motherland. Their houses, land and business establishments were taken over by extremists while the State Government facilitated such a takeover by bringing in legislation suited to the oppressors, like the Roshni Act. It is natural for any person with artistic and literary talents to compose poems, stories and novels based on the 'Great Exodus'. That's how Agnihotri made a movie without any big stars or famous technicians. The end result, according to people who have watched it, is a great work which would remain etched in their hearts for decades.

But this is not the first time a movie is politicised because of its content. We saw right-wing activists demonstrating across the country when Deepa Mehta released her trilogy, Fire, Earth and Water, because these apparently projected Indian society in poor light. In fact, movies, dramas, novels, stories and poems are mirrors that reflect the true image of their society and no purpose will be served by blacking out the truth. Way back in the 1980s, when Doordarshan telecast Tamas, a TV serial based on Bhisham Sahni's novel of the same name, Hindu fundamentalist outfits protested in front of all Doordarshan Kendras across the country. Did it help our country in any way? The truth, however unpalatable, must be told as it helps us understand the real history. If the stories behind the destruction of Ram Temple at Ayodhya and Kashi Vishwanath Temple remained deficient in light, we would only be cheating ourselves. But how can today's Islamic community be held responsible for the despicable acts of its forefathers? Similar scenarios were witnessed around Kamal Haasan-starrer Vishwaroopam and Sanjay Leela Bhansali's magnum opus Padmaavat. All forms of creativity, whether written, verbal or visual, are and ought to be above caste, community, religion or region.

Ukraine validates our NPT mistrust BHOPINDER SINGH



The hopeless Ukrainian situation corroborates the Indian perspective of securing its sovereign and strategic interests, and not falling for the NPT trap

nvaluable lessons have emerged from the Ukraine crisis — one is the validation of India's age-old appre-hension of the Nuclear Non-Proliferation Treaty (NPT). Promoted with the supposed objectives of preventing the misuse of nuclear weapons and fostering complete nuclear disarmament, India despite its avowed pacifist moorings, has historically and consistently opposed the treaty. While wholeheartedly supporting the cause of a nuclear weapon-free world, Delhi never believed that NPT was the formulation to achieve the same. India has maintained that the treaty was structurally discriminatory as it perpetuated the hegemony of the 'haves' (exclusive club of pre-1967 'nuclear weapon States' ie, the US, Russia, United Kingdom, France and China), without obligating them to liquidate their own dangerous stockpile. The exclusivity of nuclear deterrence with the so-called 'nonnuclear weapon States' (as per NPT definition) by debarring others from acquiring a similar and equal nuclear deterrence with its implied retaliatory or mutually destructive portents, is unfair entitlement.

Not only have the NPT nuclear weapon States' not destroyed their stockpile, their belligerence and intimidatory expansionism on the 'have-not' nations has been disconcerting. From unsubstantiated case of the WMDs (Weapons of Mass Destruction) in Iraq, reneging of Iran N-treaty despite IAEA's confirmation of full compliances, China's blatant territorial expansionism, to now Russia's free run in Ukraine — the privileged five beneficiaries of NPT have hardly demonstrated reassuring and responsible behaviour. Even on Article 1 of the NPT that mandates 'nuclear weapon States' to not transfer Nweapons or knowhow, China's assistance to Pakistani, North Korean and Iranian nuclear programmes is a proven fact that shreds all pretences of NP1 — territorial — expansionist suppositions. For India, mem- endeavours. Despite being ories of the 1962 Chinese routinely chided as an outlier aggression (followed by Chinese from the prism of NPT, India's



nuclear test in 1964), or the intimidating sailing of the US 7th fleet flotilla in 1971, were staring concerns of regional and strategic threats that warranted hedging its own options, deterrences and asserting its sovereign freedom of action. India demonstrated its N-capability with 'Smiling Buddha' in 1974 (albeit calling it 'peaceful nuclear explosion').

Nonetheless, this opposition to signing the NPT has put India in an unlikely set of non-signatories (each for different reasons) with Israel, North Korea, Pakistan and South Sudan. However, unlike many NPT signatories and especially of the 'haves', India's responsible behaviour towards non-proliferation speaks for itself. Delhi remained committed to any non-discriminatory treaty that truly entailed fair play and guaranteed security amongst all, without privilege to some. India has a policy of credible minimum deterrence based on 'no-first-use' and 'non-use' of nuclear weapons against non-nuclear weapon States. Unlike China, Russia or the US, it has undertaken no

In 1991, when Ukraine broke from the USSR construct, it had one-third of the entire Soviet nuclear arsenal and means of production notionally, third largest nuclear stockpile (1,700 warheads) in the world. It could have practically persisted with its nuclear deterrence status given the inheritance and availability of the wherewithal, but it traded the same for financial compensation and ostensible security assurances from three of the five 'nuclear weapon States' as per NPT (Russia, US and United Kingdom) under the Budapest Memorandum. It was a move made in good faith on the word of the 'haves'. The memorandum had explicitly noted, among many guarantees, "to respect the independence and sovereignty and the existing borders of Ukraine" as also "reaffirm their obligation to refrain from the threat or use of force against the territorial integrity or political independence of Okraine . It had further captured "to refrain from economic coercion designed to subordinate" and, above all,

to provide assistance to Ukraine, as a non-nuclear weapon State party to the treaty on the non-proliferation of nuclear weapons, if Ukraine should become a victim of aggression or an object of a threat of aggression". Today, as Russia unconcernedly violates Ukraine's territorial integrity, and the US and UK (as principal components of Nato) leave Ukraine high and dry -the assurances of Budapest Memorandum sound so hollow.

Despite the 2014 annexation of Crimea, Ukraine had cavalierly persisted with reaffirming its 1994 decision towards NPT. Calls by odd Ukrainian parliamentarians and security strategists to arm themselves, too, went unheeded. Instead, Vladimir Putin had brazenly invoked N-weapons in defending Crimea, just like he has again dangerously posited the language of nuclear weapons today. In 2019, Secretary of the Ukrainian National Security and Defence Council admitted "nuclear disarmament was a historic mistake" and that "guarantees given to us are not even worth the paper they are written on". It was a classic case of fatally late realisation.

Ensuing drama of the hopeless Ukrainian situation validates the Indian perspective of securing its sovereign and strategic interests, and not falling for the NPT trap. As Kyiv desperately beseeches Delhi to intervene, memories of Ukraine condemning India's nuclear re-testing 'Operation Shakti') in 1998 is a conveniently forgotten footnote. India has consistently charted its own security considerations beyond the NPT imperatives, which have delivered far more responsible outcomes than those of most NPT signatories.

It was a tribal woman and the incident took place at a tribal festival in Alirajpur, Madhya Pradesh, last Friday. There have been 15 arrests till now but the point of concern is that no complaint has been filed by the woman. Police Superintendent Manoj Singh said that if it was not for the incident's video, they would have never known about it.

There are two key issues here: The response of the onlookers, and the response of the woman. The 'spectators' rush to the spot as if it were an interesting street show to be recorded. This shows how normal such incidents are for them. Two, the victim didn't come out to file a complaint. So either she isn't aware of her rights, or she is ashamed of the mishap and society's reaction. It shows us people's outlook towards women in Madhya Pradesh, especially tribal women. It again underlines the need for civic education among tribals and rural people. They need to be made aware of the laws; education can change their mindset.

INDIA IN A CHURN OVER ECONOMY, LEADERSHIP

The Opposition challenge in upcoming Assembly elections must not be Utopian

•he assembly elections have elements of surprise, feelings of relief, introspection for the opposition, diminution of smaller parties and a question whether 2024 Lok Sabha would be a cakewalk for the BJP or counter a new challenge. The path to 2024 can possibly be replicated through sound economic progress, less of privatisation, stable rupee and emancipation that can boost the pride of individual voters - a new order. The BJP and allies reclaim UP with reduced mandate; unexpectedly trounce Congress in Uttarakhand though its chief minister Pushkar Singh Dhami loses; and retain Manipur and Goa. The Congress loses the remaining glory. The Samajwadi Party may not have been that powerful in dislodging BJP but certainly has broken barriers to cut down BJP numbers. Aam Aadmi Party springs the greatest surprise by winning Punjab by a whopping margin. The polit-



ical tsunami of its leader Arvind Kejriwal started with Chandigarh UT's local body. In Punjab, AAP demolishes all traditional political powers. It is likely to emerge as a major contender in the ensuing Municipal Corporation of Delhi elections. The move for reunifying three MCDs into one is credited to the rise of AAP. His rise is a challenge to the entire privileged political class. It complicates comprehension of the electoral mood. The electorate have gone through a period of turbulence, difficulties, social tension on account of three farmers' bills, Citizenship Amendment Act 2019, demonetisation, GST, marginalization of SMEs, an acute pandemic that sent at least over 12 crore people trekking back to their homes and bodies of the Covid dead in the Ganga river. It follows a severe stagflationary situation, with food, edible oil and commodity prices reaching new highs. The Samajwadi Party's performance denotes the simmering anger but Akhilesh Yadav has to come out of his caste cloak to look at new realities in a changing Indian society. His caste engineering did not work wonders.

The difficult economic pangs are forgiven but not forgotten by the soothing new MY (Modi-Yogi) touch. Or are the people merely satisfied by the food and cash doles and free benefits? Difficult questions but the electorate, possibly believing that a BJP dispensation can perform better, threw their lot with it. That the contest was too close is testified by an array of seats being won or lost by low margins. The BJP leader's sharp assault on SP's 'love' for minorities could not prevent 35 Muslims from getting elected to the UP assembly. It is also being claimed that the poorest among the minorities may have supported the BJP thanks to benefits of government houses, gas cylinders and free food. Not only in UP but other states as well. RSS-BJP understands that Yogi Adityanath's 80: 20 formula has paid dividend again despite Samajwadi Party's touted bonhomie with kisans. Jats and minorities in western UP. Parties like the BSP must be worried with vote share plunging to 12 percent. It means that BSP leader Mayawati is no more the force to lead her Dalit vote bank, particularly Jatavs, despite Amit Shah exchanging niceties with her. Evidently, a new Dalit politics is surfacing. It changes the scenario for BJP too in its march to 2024 elections. If SP acts with vigour, forges effective national alliances with TMC of Mamata Banerjee, NCP of Sharad Pawar, Shiv Sena, TRS, the residual Left and may be also the Congress, a resistance can be put up. The impending Gujarat and Himachal polls would set the tone. If such alliances remain utopian, like the Goa experiment of Mamata Banerjee, the BJP may remain comfortable.But an emerging Keiriwal can create a national alternative as voters can break away from identity silos. Punjab is a lesson.

Achieving SDGs via Great Indian Kitchen



Because of the asymmetry in the household-level power dynamics, women have hardly been the decision-makers for even choosing the cooking fuel for their kitchens

he Great Indian Kitchen, a recent Malayalam film, very aptly depicts the inadequately addressed oppression of women in our kitchens. Women have traditionally been expected to remain confined to their socially prescribed household roles. A particular sequence of the film shows a very poignant reality. A newlywed woman starts her life in the adopted household. From the first day itself, family members savour the delicacies cooked by her. However, no one cares about the issues that she has to face day in day out. For instance, a drain is blocked in her kitchen, leading to a foul smell and an extremely unhygienic situa-tion which makes her vomit the moment she enters the kitchen. While she raises this immediately with her husband and subsequently keeps reminding him, he keeps forgetting it, and very conveniently so. And why wouldn't he? For him, the blocked drain changes nothing. He continues to get his lunch-pack in time, his clothes are pressed before he emerges from his show-

Others in the family are also not helpful. The aged father-in-law touchessambhar only if it is prepared n an earthen pot on a traditional 'chulha'. It doesn't occur to him that the well-educated bride has to spend a large part of her day in a smoky

In traditional Indian households, decisions, important or otherwise, are normally taken not by those who face their consequence. Because of this asymmetry in this household-levelpower dynamics, women have hardly been the decision-makersfor even choosing the cooking fuel for their kitchens. Programmes like Pradhan Mantri Ujjwala Yojana (PMUY) and Direct Benefit Transfer attack at the root of this asymmetry. The connection is only given to women from poor families and the subsidy amount is credited to their bank accounts

Since PMUY's launch in May 2016, 9 crore connections have been given under the scheme. The scheme has made a definitive contribution in improvingIndia's performance on Sustainable Development Goals-SDG3 (Good Health and Wellbeing) and SDG 5 (gender equality)and specially SDG 7, which aims to ensure access to affordable, reliable, sustainable, and modern energy for all. The contribution of Ujjwala Yojana may be seen in the



In its new phase launched recently, Ujjwala 2.0 focuses on migrants, an important category of women who were relatively left out of government entitlements. Most of these migrants are engaged in unorganised sectorsand earn their livelihoods doing odd jobs. Women working as domestic help constitute a significant share out of these migrants. Time is precious for them, the more time they save from doing their household chores, the more they can earn. Let's discuss the story of one such woman.

Reeta (name changed), had migrated to Punjab with her husthere as a labourer. When things didn't work out well with her husband, she came back to Lucknow, her maternal home and started working as a domestic help in several houses. She had heard about Ujjwala from many, but never applied for it. She thought since she does not have any local address proof, she will not be able to get an Ujjwala connection. Reeta has an AADHAR card and a bank account both registered in Punjab. Her

another bank and so she believed that her bank account was no longer working. She has no document as an address proof.

She had been trying unsuccessfully for a few months to get her AADHAR address updated and to get her bank account transferred. Given most of her mornings and afternoons were spent in working, she was not able to find time to pursue the updation of her key documents systematically.

However, things changed swiftfor her after the launch of Ujjwala 2.0. She got an Ujjwala 2.0 connection under the migrant category. She just had to submita copy of her Punjab AADHAR card and a simple self-declaration for her current address. Ujjwala 2.0 solves theaddress-proof problem for millions of migrants like Reeta. The documentary requirement for migrant minimum. They can simply submit a copy of their Aadhaar card for identity and a simple self-declaration as proof of address and declaration of family.

Similarly, Ranjeeta (name changed) who lives in Navi Mumbai and like Reeta, works as domestic help, got an Ujjwala 2.0 connection. She has an AADHAR card of West Bengal. Her husband had left her and she now lives with her two young daughters. She opted for two 5 Kg cylinders connection as the upfront cash expense each month is lower in this option. Gradually Rising patronage of the 5 Kg connection is a testimony to its popularity because of its convenience.

With women like Reeta and Ranjeeta part of the clean cooking ecosystem now, India is on track to achieve the targets under SDG 7.1, i.e., universal access to affordable, reliable and modern energy services. Of the 99 lakh connections given across the country under Ujjwala 2.0, more than 2.5 lakh connections have been availed by migrants and as word-of-mouth spreads about this innovative and citizen-centric policy tweak, more migrants are expected to onboard Ujjwala 2.0.

Ujjwala 2.0 has greatly simplified the application form and applicants can apply online as well.
Additionally, all beneficiaries are
being provided free stoves and first onboarding and make ita smooth and hassle-free experience. Considering the tremendous response to the scheme, the government has recently extended the scheme for the release of another 60 lac connections which will lead to a totalof 9.6 croreUjjwala beneficiaries.

Programmes like Ujiwala are relatively small in their financial outlays but epochal in the transformation they bring into the lives of ordinary citizens.

Russian offensive edges deeper into Kyiv, more talks planned

The Russian offensive in ■ Ukraine edged closer to central Kyiv on Tuesday even as the two countries kept open a narrow diplomatic channel with more planned talks.

Shortly before dawn, large explosions thundered across Kyiv. A series of Russian strikes hit a residential neighborhood in the capital, igniting a huge fire and a frantic rescue effort in a 15-story apartment building. At least one person was killed and others remain trapped inside.

Shockwaves from an explosion also damaged the entry to a downtown subway station that has been used as a bomb shelter. City authorities tweeted an image of the blown-out facade, saying trains would no longer stop at

When Russia launched the war nearly three weeks ago, fear of an imminent invasion gripped the Ukrainian capital, as residents slept night after night in subway stations or crammed onto trains to flee. But as the Russian offensive bogged down, Kyiv saw a relative lull. Fighting has intensified on the outskirts in recent days, and sporadic air raid sirens ring out around the cap-

There was a rare glimmer of hope in the encircled port city of Mariupol after a convoy of 160 civilian cars left along a designated humanitarian route, the city council reported. Over the past 10 days or so, the lethal siege has pulverized homes and other buildings and left people desperate for food, water, heat and medi-

The latest negotiations between Russia and Ukraine, held by video Monday, were the fourth round involving

two countries and the first in a week. The talks ended without a breakthrough after several hours, with an aide to President Ukrainian Volodymyr Zelenskyy saying the negotiators took "a technical pause" and planned to meet again Tuesday.

The two sides had expressed some optimism in the past few days. Mykhailo Podolyak, the aide to Zelenskyy, tweeted that the negotiators would discuss peace, cease-fire, immediate withdrawal of troops & camp; security guarantees." Previous discussions, held in person in Belarus, produced no lasting humanitarian routes or agreements to end the fighting.

Zelenskyy is seeking to extend martial law until April 24 and to require men ages 18 to 60 to stay in the country to fight. Zelenskyy submitted the extension in a bill to parliament, which is expected to vote on it this week.

In Washington, White House press secretary Jen Psaki said that while the Biden administration supports Ukraine's participation in the talks with Russia, Russian President Vladimir Putin would have to show signs of de-escalating in order to demonstrate good faith.

US National security adviser Jake Sullivan warned China against helping Russia during a meeting in Rome with a senior Chinese diplo-

Two administration officials, speaking on condition of anonymity to discuss sensitive information, said China had signaled to Moscow that it would be willing to provide both military support in Ukraine and financial backing to help stave off effects of

Monday. The Kremlin has denied asking China for military equipment to use in

Kremlin spokesman Dmitry Peskov said Russia was able to continue the operation itself and it was "unfolding in accordance with the plan and will be completed on time and in full." In Kyiv, the early morning explosions were artillery strikes, the Ukrainian military said. They hit the Svyatoshynskyi district of western Kyiv, adjacent to the suburb of Irpin that has seen some of the worst battles of the war.

Flames shot out of the apartment building as fire-fighters climbed ladders to rescue people. Smoke choked the air. A firefighter at the scene confirmed one person had died and that several had been rescued, but others remained inside as rescuers tried to reach them.Damage from unspecified ammunition prompted a fire in a 10story apartment block in the Podílsky district of Kyiv, north of the government quarter. One person was hospitalized, the state emergency agency reported.

Russian forces also stepped up strikes overnight on the northwest suburbs of Irpin, Hostomel and Bucha, said the head of the Kyiv region, Oleksiy Kuleba.

"Many streets (in those areas) have been turned into a mush of steel and concrete. People have been hiding for weeks in basements, and are afraid to go out even for evacuations," Kuleba said on Ukrainian television.

Ukraine TV tower attack death toll rises to 19

Local authorities say the number of people killed in a Russian rocket attack on a TV tower in western Ukraine has risen to 19.

The Rivne regional government posted on its Facebook page Tuesday that 19 people were killed and nine were injured in the strike on the TV tower in Antopol, a village outside the city of Rivne.

More than 3 million people have fled Ukraine **AP** ■ GENEVA

The International Organisation for Migration International says more than 3 million people have fled Ukraine since Russian invaded last month. The new milestone also indicated that some 157,000 third-country nationals - people who aren't Ukrainian - were part of the outflow in what UN officials have called the largest refugee crisis in Europe since World War II.IOM spokesman Paul Dillon said at a UN news briefing in Geneva on Tuesday that the totals were compiled from figures provided by national authorities. The UN refugee agency UNHCR, which provides a more detailed count than the IOM though based on similar data, has reported that more than 1.8 million of the

The European Union has announced that the 27-nation bloc has approved a new set of sanctions to punish Moscow for its invasion of Ukraine.

France, which holds the EU presidency, said the bloc "in consultation with our international partners, has approved a fourth package of sanctions targeting individuals and entities involved in the aggression against Ukraine, as well as several sectors of the Russian economy."

The French presidency said in a late Monday statement that the bloc also approved a declaration to the World Trade Organization "on suspending the application of the most-favourednation clause for Russia and suspending the examination of Belarus' application for accession to the WTO. "If Russia is suspended, its companies would no longer receive special treatment throughout the bloc. The announcements were in line with what leaders had announced at the Versailles summit last Friday, that a stringent package of sanctions would be upcoming if Russia continued its invasion of Ukraine. The exact details of the latest package of sanctions will only be known upon publication in the EU's official journal.

Since the war started last month, the EU has adopted tough measures targeting Russian President Vladimir Putin, Russia's financial system and its high-maintenance oligarchs. Last week, the bloc's nations agreed to slap further sanctions on 160 individuals and added new restrictions on the

export of maritime navigation and radio communication technology.

They also decided to exclude three Belarusian banks from SWIFT, the dominant system for global financial transactions. Altogether, EU restrictive measures now apply to a total of 862 individuals and 53 entities. In a statement published after the summit, EÛ Commission President Ursula von der Leyen said the fourth package of sanctions will further isolate Russia "and drain the resources it uses to finance this barbaric war." She said the EU will work in lockstep with Group of Seven countries to ramp up the pressure against Moscow. Efforts to agree on an oil boycott against Russia are complicated, because some EU countries, including Germany and Italy, are much more dependent than others on Russian energy.

"We have no indication as you also heard from our Indian partners that this incident was anything other than an accident," State Department spokesperson Ned Price told reporters at his daily news conference on Monday.

"We refer you of course to the Indian Ministry of Defense for any follow up. They issued a statement on March 9th to explain precisely what had happened. We don't have a comment beyond that," Price said in response to a question.

Iran returns passport of detained UK charity worker

AP ■ LONDON

Iranian authorities have returned the passport of a UK woman who has been detained in the country for almost six years, raising hopes of progress in negotiations toward her release.

Charity worker Nazanin Zaghari-Ratcliffe remains at her parents' home in Tehran, said Tulip Siddiq, her local lawmaker in the UK. "I also understand that there is a British negotiating team in Tehran right now," Siddiq said on Twitter. "I will keep posting updates as I get them.

Zaghari-Ratcliffe, who has dual UK-Iranian citizenship, served five years in prison after being taken into custody at Tehran's airport in April 2016. She was later convicted of plotting the overthrow of Iran's government, a charge that she, her supporters and rights groups deny. She has been held under house arrest and unable to leave the country since her release. Zaghari-Ratcliffe's local lawyer, Hojjat Kermani, also told The Associated Press she had received her British passport.

Witness: Army attacks in eastern Myanmar worst in decades

AP BANGKOK

While Russia's war in Ukraine dom-inates global attention, Myanmar's military is targeting civilians in air and ground attacks on a scale unmatched in the country since World War II, according to a longtime relief worker who spent almost three months in a combat zone in the Southeast Asian nation.

David Eubank, director of the Free Burma Rangers, a humanitarian relief organization, told The Associated Press that the military's jets and helicopters stage frequent attacks in the areas of eastern Myanmar where he and his volunteers operate, bringing medical and food aid to civilians caught in conflict.

Ground forces are also firing artillery indiscriminately, he said - causing thousands to flee their homes.

Video shot by his group's members includes rare images of repeated air strikes by Myanmar military aircraft in Kayah State - also known as Karenni State - causing a number of civilian deaths.

An analyst for New York-based Human Rights Watch said the air attacks constitute "war crimes."

Myanmar's military seized power last year, overthrowing the democratically elected government of Aung San Suu Kyi. After security forces cracked down violently on large, peaceful street demonstrations opposing the takeover, thousands of ordinary people formed militia

Take call to decriminalise Legal **Metrology Act: Goyal to States**

PNS NEW DELHI

In a bid to stop harassment of small shopkeepers, the Union Consumer Affairs Minister Piyush Goyal on Tuesday directed his department's officials as well as states to convene a meeting next week on the issues pertaining to the certain provisions of decriminalize the Legal Metrology Act. The minister pointed out that in 2018-19, the cases of first offence were 89,724 and the second offence only 11. "In 2019-20, the first offence cases were 92,000 while second offence only two while in 2020-21 the first offence cases offence zero," "I fail to understand that after the first offence, which is compoundable, how the number of cases for second offence, which can actually put you behind bars,

which is criminal, comes down drastically. You can understand the meaning of this what could have happened between the first and the second offence," Goyal said while addressing the "Fair Digital Finance" on the occasion of the World Consumer Rights Day, organised by his

Recalling his own harassment 35 years ago when he started out as a young entrepreneur, Goyal listed out the number of cases registered under three different sections of the Legal Metrology Act and pointed out the vast difference between the number of cases under first and second offences. Citing data of the last three years, Goyal said broad-51,000-54,000 cases were filed as first offence under Section 33, about 20,000-22,000 cases filed under Section 36 (1) and 8,000-10,000 cases

filed under Section 25. "This is all first offence which is compoundable. I fail to understand after the first offence is filed how the number of second offence falls. The second offence can put you behind bar as it is criminal," he said.

The Legal Metrology Act 2009 enforces standards related to weights and measures. In its present form, the law prescribe imprisonment, in addition to fine, for second or subsequent offence. "I personally would like to flag off a couple of concerns...Because I do believe that it's important. I do believe it's important that what Kumar (Consumer Affairs Secretary) said about decriminalisation should also be understood by all of us," he said.

The Minister also blamed the state government and the consumer organisations for opposing reforms.

No power crisis in India, generation capacity greater than peak demand: Power Min

India is not facing any power crisis as the installed electricity generation capacity stood at 395.6 gigawatts (GW) against the peak demand of 203 GW recorded in 2021-22, Parliament was informed on

"There is no power crisis in the country. As on February 28, 2022, the installed generation capacity is around 395.6 GW, which is sufficient to meet the demand of electricity in the country. The peak demand experienced during the current year was only 203 GW," said Power Minister R K Singh in a written reply to the Rajya Sabha.

Irregularities found in appointment of chief strategic adviser at NSE: Govt

The Government on Tuesday I said irregularities in the appointment of chief strategic adviser in the NSE during the tenure of a former MD&CEO were observed and the appointment was made without following due process.

The Securities Exchange Board of India (Sebi) has informed that an ex-MD&CEO of NSE, had sought guidance from a 'siddha purusha/yogi', Minister of State for Finance Pankaj Chaudhry said in a written reply to the Rajya Sabha.

During the course of investigation by Sebi, it was found that certain emails on various matters were exchanged by that MD&CEO with the yogi, he said. "Sebi has informed that irregularities were observed in the appointment of the chief strategic advisor (CSA), during the tenure of that ex-MD&CEO of NSE. This

appointment was made without windfall profits. appointment," Chaudhry

Accordingly, Sebi imposed monetary penalty and other restrictions on that ex-MD&CEO and the then CSA for violation of provisions of Sebi Act, 1992 and SCRA, 1956/Securities Contracts

(Regulation) Act. The matter relates to former NSE CEO Chitra Ramkrishna and Group Operating Officer Anand Subramanian, who are currently under the custody of the CBI, as the agency is probing them in the co-location scam.

In the co-location facility offered by NSE, brokers could place their servers within the stock exchange premises giving them faster access to the mar-

It is alleged that some brokers in connivance with insiders abused the algorithm and the co-location facility to make

that Ramkrishna was appointed as Joint MD of NSE in 2009 and remained in the position till March 31, 2013, with the power of DMD. She was elevated as MD and CEO on April 1, 2013, and left the bourse in 2016.

Earlier on February 11, the capital markets regulator levied a fine of Rs 3 crore on Ramkrishna, among others for violating securities contract rules in appointment of Anand Subramanian as group operating officer and advisor to MD.

It also levied fine of Rs 2 crore each on the NSE, former CEO Ravi Narain and

"Our new tariffs will further isolate the Russian economy from global trade, ensuring it does not benefit from the rules-based international system it does not respect," said UK Chancellor Rishi Sunak.

"These tariffs build on the UK's existing work to starve Russia's access to international finance, sanction Putin's cronies and exert maximum economic pressure on his regime," he said. The UK has published an



Such an all-encompassing education system needs to ensure access to quality education to all knowledge seekers at their doorstep and at an affordable cost for creating a large pool of effective learners endowed with domain knowledge, soft and hard skills and the ability to communicate across cultures, time and space. The student community, especially in India, is a heterogeneous group with a great diversity of needs and requires a variety of formats of learning, pace, style choices of learning, and other associated forms of flexibility.

Information and Communication Technology (ICT) can help us a great deal in this regard as it is fast emerging as an enabler for bringing innovative disruptions in higher education and is creating new narratives of learning. Technological advancement in the modern world is so fast and relevant that higher education institutions (HEIs) that are unable to make use of technological disruptions in higher education to equip themselves to embrace the changes happening in the teaching and learning processes will lose their relevance.

Digitalisation of higher education is a crucial factor in this context as it helps create responsive administration, multidisciplinary curriculum, appropriate pedagogies (experiential learning) and real-time performance evaluation in commensuration with learning outcomes, effective communication, inter-connectedness, seamless availability of e-learning resources even in remotest rural areas, innovations and entrepreneurship, and collaboration and outreach. Moreover, digitalisation will help those learners who cannot be in the classroom and those who are differently-

Digitalisation in Indian higher education began with the production of quality e-contents and courseware by Electronic and Multimedia Resource Centres (EMRC) under Consortium for Educational Communication and their dissemination through 24x7 Vyas higher Education TV channel and thirty-two SWAYAMPRABHA DTH channels. This digitalisation process has been accelerated during the last decade by the Ministry of Education through several initiatives related to access to online courses, quality digital academic content, academic research, and institutional administrative practices.

For online courses and access to online content, Massive Open

All these efforts have made a solid foundation necessary for creating an ecosystem of digitalisation in higher education. These initiatives will also be of immense use to the proposed digital university that is expected to be established on the University 4.0 model.

The digitalisation of higher education witnessed a steep rise during the COVID-19 pandemic, compelling HEIs to resort to online teaching using LMS. It is evident now that higher education will witness an extensive use of digital-

isation in course design, practicedriven teaching, research, assessment, and all other aspects of teaching and learning to create a next-generation learning environ-

For the learners, digitalisation powered flexibility, adaptability, and personalisation make learning a joyful enterprise, in both online and traditional classroom learning. Through technology-enabled flipped classes, virtual reality sessions, virtual labs, digital models and simulations, gamification, e-documents, e-text and reference books, online assignments, apprenticeships and vast and open educational resources, students can have engaging learning experiences.

To facilitate the impending transition, HEIs need to use appropriate technology for building a credible ecosystem that improves learning outcomes and provides personalisation. This can be accomplished by using ICT, embracing hybrid learning models, building industry associations and developing 21st-century life skills and competencies. The HEIs continuously need to upgrade their curricula, course contents, pedagogy, evaluation, integrate problem-solving research with academics, conduct research in the digital environment with peers across the globe and adapt modular models. HEIs also need to turn to learner-centric approaches revolving around soft and domain- specific skills crucial for enhancing learners' employability. They need to embrace hybrid learning models comprising offline,

online, on-labs, onsite platforms and include industry, skill-hubs and unorganised learning centres in rural India by building industryacademia collaboration and out-Implementation of National

Education Policy-2020 cannot be thought of without the digitalisation of higher education. Capacity building of faculty members in digitalisation technologies must be carried out for empowering them to embrace the advancement that the teaching-learning process is witnessing. However, funding will be a great barrier to the effective digitalisation of higher education since large-scale investments in hardware, software and in providing high bandwidth internet connectivity in remote and rural areas is needed to create a robust digital architecture required for an all-encompassing, all-inclusive and flexible learning ecosystem. Overcoming these roadblocks should be paramount for the long-term success of the ongoing process of the digitalisation of higher education. This success will ensure that the screen savvy tendency of gen-next is harnessed in the right earnest and that their dwindling memory span is also enhanced. Educational planners and leaders need to appreciate this and take responsibility for the digitalisation of their respective institutions. Those HEIs not becoming part and parcel of this process and thus not keeping themselves digitally ready will, in fact, be doing a great disservice to the learning system of the nation.

Empathy & innovation: Way to post-pandemic education

¬he bells are ringing again, laughter echoes in the halls and classrooms, the swings have come back to life-it is so good to see children back where they belong-amidst their friends and teachers. A pall of gloom has been lifted from the dull, lifeless classrooms. There is a buzz of activity—the tiny tots entering their schools for the first time physically-intimidated by the sudden socialising, unable to sit in class or follow basic instructions. The middle-schoolers, bursting with energy and curiosity, glad to be out of confinement. The high schoolers are partly lackadaisical due to the prolonged lockdown, partly stressed due to the imminent board exams.

The onus lies on the educators now. We need to reflect, understand our learners, re-connect with them and adapt to this change. We have to keep aside our personal challenges of resuming work and adopt new patterns and new techniques to bond with our students. School is not merely a classroom restricted to teaching and assessment. It is a second home where they learn basic interpersonal skills of caring, sharing, learning together and class-conduct. Think of the toddler who has stepped into a real classroom for the first time, met his teacher whom he has hitherto only seen on screen. Every minute in the school is a novel experience for him-unfamiliar and somewhat scary. I recently met the mother of one such 6-yr old.

She shared how the child was very excited to come to school on the first day, but was reluctant on the next day. He had done his maths-if he stayed at home, he could play or lie down after one hour of online classes but coming to school involved the arduous task of getting ready, sitting in class, paying attention and mingling with other bewildered toddlers like him. He decided it was easier to stay at home. To follow a routine, be a part of a team, obey orders, conduct himself as expected were all too intimidating for him.

These are going to be our challenges in the coming months. The teaching fraternity will need to muster up all their patience and perseverance,

innovate and engage their learners in

diverse ways.

The adolescent students will have to be handled with delicacy too. Prepubescent mentality, lack of exposure to opposite sex, lack of physical activity, too much screen time, over-dependency on gadgets and virtual well-being will have to be assessed and borne in mind while helping them adjust well in lassrooms again.

Teachers will need to be more flexible while teaching and assessing. We will have to re-invest ourselves to adopt active learning techniques. The thrust needs to be in getting the children ready for school-and sustaining it. If all teachers are empowered to engage children in active learning, they will certainly look forward to coming back. With a clear understanding of keeping the happiness quotient high in our classrooms, we should be able to address this challenge appropriately.
