## **Chinese Min to visit India amid LAC row**

#### First visit in 2 yrs since face-off in eastern Ladakh

PNS ■ NEW DELHI

In a major development amid ongoing tension at the border in Ladakh, China's Foreign Minister Wang Yi is likely to visit New Delhi later this month. This will be the first visit by any Chinese Minister since the face-off began between the armies of the two countries at the Line of Actual Control (LAC) nearly two years

Wang Yi is likely to hold talks on March 24 or 25 with his Indian counterpart S Jaishankar.

At present, more than 50,000 troops each of India and China are facing each other at some friction points at the LAC in eastern Ladakh. Both sides have held a series of diplomatic and military level talks since the stand-off began in May 2020 leading to a bloody brawl in June.

Twenty Indian soldiers, including the commanding officer, were killed. Nearly 40 Chinese soldiers reportedly died in the clash. Beijing is yet to confirm the exact number of

Against this backdrop, the



Chinese Minister's visit is an indication of a thaw in the tension between the two countries, sources said here on Wednesday

While the situation at the LAC will obviously top the agenda, the two countries may also hold parleys on Quad. China has all along protested against this grouping compris-ing India, the US, Japan, and Australia to ensure peace and stability in the strategically important Indo-Pacific region, they said. The two Ministers may also take stock of the situation arising from the ongo-

ing Ukraine conflict. The proposal for Wang Yi's visit came from China, sources said, adding he will

arrive here after a visit to Nepal. He is also likely to tour Pakistan, Bangladesh, and Bhutan, it was learned.

Elaborating upon the significance of the visit, sources said, so far both sides are engaged in parleys at the diplomatic and military levels. The 15th round of Corps Commanders of the two armies was held on March 11.

The two countries agreed to continue the process of dialogue to find ways for early disengagement of troops from the friction points in Eastern Ladakh. Jaishankar and Wang Yi had met in person in September 2020 and September 2021.

Sources said the feelings of the Wednesday meeting is likely to be conveyed by Azad to Congress president Sonia Gandhi. Rahul Gandhi and Priyanka Gandhi are also expected to be present at the meeting.

The meeting between Azad and Gandhis would be of great importance amid the dissatisfaction of G-23 leaders about the work style of senior Congress leaders, especially the Gandhis.

Sources said Azad will present the final proposal of G-23 members before the party's high command. The G-23 will decide its future course of action after the meeting between Azad and Sonia Gandhi.

Late Wednesday night after a marathon four hours meeting, the dissident leaders issued a joint statement saying, "We believe that the only way for-ward is for the Congress to

adopt the model of collective and inclusive leadership and decision making at all levels. In order to oppose the BJP, it is necessary to strengthen the

Congress party.
We urge the Congress party to initiate dialogue with other like-minded forces to create a platform to pave the way for credible alternatives for

The meeting was earlier scheduled over dinner at Sibal's residence but later Azad hosted it at his place because of Sibal's strong criticism of the Gandhis and his advice to them to make way for other

Sources said the venue was also changed because in the last meeting of the dissidents held at Sibal's residence, some Congressmen resorted to

stone-pelting.
Besides the G-23 leaders, others like Mani Shankar Aiyar, PJ Kurein joined the meeting to work out a future strategy and dissect what went wrong leading to the grand old party's poll debacle in the just-concluded Assembly polls.

Others present were Manish Tewari, Shashi Tharoor and Sandeep Dikshit, Preneet Kaur (Lok Sabha member from Patiala and wife of sacked Congress leader and former Chief Minister Amardiner Singh), and former Haryana Speaker Kuldeep Sharma.

### Govt misusing FB, Twitter to shape narrative: Sonia

Congress president Sonia Gandhi on Wednesday alleged a reported "nexus between big companies, social media and the Government" and accused social media giants of "spreading venom and dis-information" to "hack democ-

Speaking in the Lok Sabha during Zero Hour submission, the Congress leader said "global social media companies are not providing level playing field to all political parties" and quoted American publication Wall Street Journal to drive home her point that the "ruling party was being favoured" by the social media.

"There is a rising danger of social media being abused to hack our democracy. Global companies like Facebook and Twitter are used increasingly to shape political narratives by leaders, parties, and their proxies," said the Opposition leader.

### Former Defence Secretary charged in Agusta copter scam

PNS NEW DELHI

The CBI has filed a supplementary charge sheet in the ₹3,600-crore AgustaWestland against former Defence Secretary Shashi Kant Sharma and four Indian Air Force personnel. Sharma later also served as Comptroller and Auditor General of India. He is probably the first CAG to have been charge-sheeted in a bribery case.

The agency filed the charge-sheet before a special court in Delhi after getting the sanction from the Government to prosecute Sharma, who was the Defence Secretary between 2011 and 2013 before serving as the CAG from 2013-2017.

Sharma also served as Joint Secretary (Air) in the Defence Ministry between 2003 and 2007. He is alleged to have been instrumental, along with other accused IAF officials, in reducing the requirement of service operational ceiling of the heli-



copters to accommodate AgustaWestland which was otherwise ineligible to particpate in the tendering process. Besides this, he also allegedly allowed testing of a different model of AgustaWestland helicopter on foreign soil, sources

Besides Sharma, the CBI has named then Air Vice Marshal Jasbir Singh Panesar (now retired), deputy chief test pilot SA Kunte, the then Wing Commander Thomas Mathew and Group Captain N Santosh, officials said. Kunte and Santosh retired as air com-

### Maha Govt refuses to make | Air travel may **'The Kashmir Files' tax-free**

DY CM AJIT PAWAR SAYS IF THE BJP-LED CENTRE SO DESIRES. IT CAN GO AHEAD, MAKE FILM GST-FREE

Amid the decision by various BJP-ruled states, including Gujarat, Uttar Pradesh and Madhya Pradesh, to make Vivek Agnihotridirected controversial film taxfree, the Maharashtra government on Wednesday refused to grant tax exemption to "The Kashmir Files", a film based on mass killings and the exodus of Kashmiri Pandits in the

Making a statement in the State Assembly, Maharashtra Deputy chief minister Ajit Pawar - who also holds the state Finance portfolio-said that the state government had no plans to follow the suit of the BJP-ruled states and grant tax exemption to the film "The Kashmir Files". "If the Union

grant tax exemption to "The Kashmir Files". If the Centre does it, it will apply to the entire country," he said.

Pawar's statement came a day after the BJP MLAs raised slogans in the State Assembly demanding tax exemption for "The Kashmir Files". BJP MLA

Nitesh Rane had initially demanded tax exemption for the film. Subsequently, other BJP leaders submitted a memorandum to the Maharashtra government.

Alluding to the BJP's demand for making "The Kashmir Files" tax-free, Pawar said: "You will remember that in the past we had granted tax exemption to films like Mission Mangal, Tanaji, Super 30 and Panipat.. If you look at the tax exemption, there are two components – 50 per cent of CGST and another 50 per cent of SGST. Since Prime Minister Narendra Modi spoke in glowing terms about "The Kashmir Files", it is in fitness of things that he announces tax exemp-

ernment takes a decision, it is only SGST and it applies only our state. If the Centre grants CGST exemption on the film, it will apply to the entire country. Why can't he take such a decision for the entire country?," Pawar asked.

Starring Anupam Kher, Darshan Kumar, Mithun Chakraborty and Pallavi Joshi, The Kashmir Files has become a sensation at the box office. The film has already been declared tax-free in the BJPruled states like Gujarat, Madhya Pradesh, Uttar Pradesh, Karnataka and Haryana and Bihar.

Given that Maharashtra is ruled by the Maha Vikas Aghadi (MVA) - comprising the Shiv Sena, NCP and Congress, it is quite unlikely that the MVA government will ever grant tax exemption to The Kashmir Files", which is being seen by the Opposition as more of a propaganda film for the BJP in the run-up elections in Gujarat to be held later

## get costlier as ATF price rises

Air travel is expected to get costlier in the coming days as oil marketing companies on Wednesday raised the aviation turbine fuel (ATF) prices 18 per cent to record Rs 1,10,666.26 per kilolitre, all time high levels for the second time in March after international oil price surged to a multi-year high .

The increase - sixth straight this year - led to prices soaring past the Rs 1-lakh-per-kilolitre mark for the first time ever. Fuel retailers revise jet fuel

prices on a fortnightly basis. At present, fuel based expenses account for over 30 percent of the overall operating cost of an airline. Aviation turbine fuel (ATF) - the fuel that helps aeroplanes fly - was hiked by 17,135.63 per kl, or 18.3 per cent, to Rs 110,666.29 per kl in the national capital, according to a price notification by statefuel retailers.

International oil prices had climbed to a 14-year high of near USD 140 per barrel last week on fears of supply disruption following Russia's invasion of Ukraine.

Rates have since mellowed to around USD 100 per barrel. In Mumbai, ATF price soared to Rs 109,119.83 a kl and it costs Rs 114,979.70 in Kolkata. Jet fuel is priced at Rs 114,133.73 per kl in Chennai. Jet fuel, which makes up for almost 40 per cent of the running cost of an airline, has this year surged to new highs. The previous peak of Rs 71,028.26 per kl was recorded in August 2008, when international crude oil prices touched USD 147 per barrel. Brent crude oil on Wednesday was trading just above USD 100 per barrel.

ATF prices have increased every fortnight since the start of 2022. In six hikes beginning January 1, ATF prices have been increased by Rs 36,643.88 kl or almost 50 per cent.

### **CBI** arrests Jamia Prof, 2 others for graft

The CBI on Wednesday arrested a Professor of Department of Engineering, Jamia Millia Islamia University and two others of a private company based at Okhla area here in a bribery of ₹1 lakh.

A case was registered against the accused on allegations that the said Professor Md. Khalid Moin, in conspiracy with representatives of different private builders, architect and middleman, was indulging in different activities for issuing structural stability certificates for projects after taking bribes. The CBI laid a trap and caught the Professor and two others while accepting and giving the bribe of `1 lakh, the agency said in a statement, adding, searches are being conducted at the premises of the accused persons. The arrested accused will be produced before the designated Court at Delhi.Besides Professor Md Khalid Moin, Prakhar Pawar and Abid Khan of Vyom Architect, Okhla Phase-3.

ED attaches assets worth ₹2.30 cr under PMLA

The Enforcement Directorate (ED) has pro-Enforcement visionally attached movable and immovable assets worth Rs 2.30 crore under the Prevention of Money Laundering Act (PMLA) in a fraud case involving cheating the Institute of Engineers (India).

The ED initiated money laundering investigation on the basis of an FIR dated November 2, 2020 registered by Kolkata Police under various sections of the Indian Penal Code (IPC) against bank manager Samrat Paul and others for cheating the Institution of Engineers India.Paul, the then Bank Manager of Allahabad Bank, Bowbazar Branch and others who had allegedly cheated the Institute by getting funds over Rs 35 crore, transferred from the account of the Institution in the name of creating fixed deposits and then submitting fake/forged Fixed Deposit Receipts.

While the first meeting was on the sidelines of the Shanghai Cooperation Organisation (SCO) meeting in Moscow, the second meeting took place in Dushanbe. The two leaders discussed the roadmap for reducing tension and speedy disengagement of troops from the stand-off sites. Ever since the LAC standoff began, the top leadership of India and China have participated in several virtual meetings of groupings such as the SCO and BRICS comprising Brazil, Russia, India, China, and South Africa. However, there were rare oneon-one or bilateral meetings between India and China in the last two years. The talks at various levels have seen the withdrawal of troops from the north and east banks of the Pangong Tso (lake) in Ladakh in February last year.

### SC upholds Govt's.....

The SC disposed of a plea filed by the ex-servicemen association seeking implementation of the OROP as recommended by the Bhagat Singh Koshyari Committee with an automatic annual revision, instead of the current policy of periodic review once in five years.

In the operating part of the verdict, Justice Chandrachud said that all pensioners who hold the same rank may not form a homogenous class while taking into account the Assured Career Progression and Modified Assured Career Progression. There is no legal mandate that pensioners who hold the same rank must be given the same pension as they do not constitute a homogenous class, the top court said.

The verdict came on a plea

filed by the Indian Ex-servicemen 'Movement (IESM) through advocate Balaji Srinivasan against the Centre's formula of OROP. In South Delhi's Greater Kailash 1, not a single beneficiary had visited the Pahariwala Gurdwara vaccination centre till noon where empty chairs were seen lined up as frontline workers chit-chatted among themselves.

A dingy corner near the parking area of the Pahariwala Gurdwara served as the vaccination site for the young ben-

A similar reaction was echoed by an official at the Kautilya Government school vaccination centre where a child had arrived for the inoculation but had to be sent back as more beneficiaries were not present there. Several Covid Vaccination Centres across the 11 districts in Delhi have been identified for the inoculation

Despite its name mentioned in the list of centres, no vaccination camp was present at the SDMC School in Malviya Nagar. "There used to be a vaccine camp but it was shifted as the physical classes at the

not enough classes," said an official. Meanwhile, at a centre in East Delhi's Dilshad Garden, several beneficiaries were administrated the vaccines on day one. The CVC in-charge there said about 13 students had come for the vaccination till afternoon and most of them study in the same school.

Delhi on Tuesday reported 131 fresh Covid-19 cases and two deaths, while the positivity rate stood at 0.42 per cent, according to data shared by the city health department.

The Centre on Tuesday had released guidelines for Covid-19 vaccination of children between 12-14 years, and said only Corbevax vaccine would be used for the beneficiaries of this age group.

Two doses of Biological E's intramuscular vaccine Corbevax would be administered to the beneficiaries in the 12-14 years age group at an interval of 28 days, the guidelines said.

According to the Centre's guidelines, vaccination of 12-14 years would be conducted through dedicated inoculation sessions to avoid their unintended vaccination with any other Covid-19 vaccines.

### **6,587 kids get Covid vax first** dose in G'gram

A Covid vaccination camp has been started in Gurugram on the occasion of National Immunization Day on Wednesday for children in the age group of 12 to 14 years. The camps were started by the Deputy Commissioner, Gurugram Nishant Kumar Yadav, from the Government Girls Senior Secondary School, Jacobpura.

Yadav while boosting the morale of the students said: 'This vaccine is being administered to increase your immunity so that you can face the global epidemic like Corona with strength."

Civil Surgeon Dr Virender Yadav, who was also present informed that under this campaign, about 85,000 children in the age group of 12 to 14 years in the district would be vaccinated with the Covid-19 jab and on Wednesday around 6,587 children were administered the first dose. He said only children in this age group would be vaccinated with the Corbevax vaccine. Apart from online registration, beneficiaries can also get vaccinated by visiting the vaccination centre

"Under the campaign, 82 immunization centres have been set up in the district comprising schools and health centres, while instructions have been given at all the centres to vaccinate the child only after checking the age-related documents," the Civil Surgeon

The case relates to rioting, causing injuries to police personnel and gunshot injury sustained by one Rohit Shukla by an armed North East Delhi.The status report stated that "the accused has been keeping illegal arm and ammunition and has no remorse for his illegal act. His daring

act of firing at a policeman and the public shows that if released on bail, he can repeat such a criminal act.

It further said there are police and public witnesses who have identified him and from the criminal family history background and desperatenature of the accused, it can be evidently inferred that the witnesses can be adversely influenced by him.

The report said the statement of the eyewitnesses and seized CCTV footage establishes that Pathan was leading the mob and indulged in the act of rioting on February 24, 2020, during which he fired at the complainant and public from his

### HC allows reopening of Nizamuddin Markaz during Shab-e-Barat

The Delhi High Court on Wednesday allowed reopening of three floors of Nizamuddin Markaz, where the Tablighi Jamaat congregation was held in March 2020 amid the Covid-19 pandemic and has remained shut since then, to enable devotees to offer prayers during Shab-e-

Justice Manoj Kumar Ohri removed the restriction of putting a limit of 100 people at one floor and said it has been agreed that the management of the mosque will ensure that Covid-19 protocols and social distancing will be followed while allowing devotees to enter the mosque to offer namaz While Delhi Police had

imposed various conditions to be followed during the reopening of the markaz on the occasion of Shab-e-Barat, several of them were modified during the court hearing with mutual agreement between the police,

the Delhi Waqf Board and the management committee of the mosque. The court noted that the ground floor and three other floors of the mosque building will be opened at 12 PM one day prior to Shab-e-Barat, which is on March 18, and will be closed the next day at 4 PM.

The court, which was hearing an application by the Delhi Waqf Board seeking to open the mosque in view of Shab-e-Barat and Ramzan in March and April, listed the matter for March 31 to decide on the issue of reopening the mosque during Ramzan which will begin from April 2.

Regarding the condition imposed by the police that foreign citizens and OCI card holders will not be allowed inside the markaz premises and if some devotee of foreign origin or OCI card holder intends to offer namaz at Masjid Bangley Wali, his identity details along with ID proof will be taken by the management and submitted to the

SHO, the management said it a notice will put on the display board at the entry gate specifying this restriction. While the police, through advocate Rajat Nair, initially said no Tablighi activities will be permitted during the reopening period, it was later agreed between the parties that opening of the mosque will be restricted only for offering prayers.

Operation and Maintenance (O&M) centre: All concessionaires are required to establish an O&M centre at toll plaza or at any other location along project highway, the land for which will be acquired by the concessionaire.

This centre shall house the

main control room, storage space for equipment, parking space for crane and other big vehicles, and a general garage.

The guidelines also state

that all vehicles deployed by the concessionaire for emergency services shall be equipped with a GPS based Vehicle Tracking System so that it can be integrated with the 112 Emergency Response System.

The District Road Safety Committee, Gurugram dis-cussed all aforementioned provisions in detail. According to the Centre's guidelines, vaccination of 12-14 years would be conducted through dedicated inoculation sessions to avoid their unintended vaccination with any other COVID-19 vaccines.

## 1.5L road fatalities a year in India, highest globally

Expressing concern over deaths due to road accidents, the government on Monday said India records the highest number of fatalities in the world numbering 1.5 lakh every year. Plans are afoot to make roads safe by removing black spots on national and state highways, Road Transport Minister Nitin Gadkari said in the Rajya Sabha.

Elders also flagged the issue of rising number of cancer cases in India and called for effective and speedy measures to check this issue. A demand was also made for removal of GST on cancer medicines.

Fielding questions on the issue of accidents, Gadkari said, "This is a very unfortunate subject. As many people do not die in war or Covid. Every year 1.5 lakh people die, we are the highest in the world. We have to work on it." Gadkari also said it was unfortunate that 65 per cent of those dying every year were in the 18-45 age group.

He informed the house the government will soon implement a Rs 7,500-crore scheme with the help of the World Bank to address the problem and reduce accident-prone and black spots on national and state highways.

Asserting that the government is sensitive to the issue, he said "We have urged the World Bank to implement this programme across the country. We will soon get cabinet approval on this scheme."

The minister pitched for creating awareness, observance of rules, and improving road engineering and automobile engineering.

He sought the support of

people including NGOs and educational institutions for creating awareness about road accidents.

He said states such as Meghalaya and Arunachal Pradesh have helped reduce road accidents by around 50 per cent, while in places like Dadra and Nagar Haveli and Nagaland accidents have increased by 47 and 40 per cent respectively. Elders expressed concern over the rising cases of cancer in the country and suggested various measures, including regular check-up camps in rural areas and mandatory warning on processed meat packets, to

tackle the disease.

Raising the issue during Zero Hour, Mahesh Poddar(BJP) demanded that cancer warning should be made mandatory on packets of processed meat in line with tobacco products.

He said the International Agency for Research on Cancer (IARC) of the World Health Organisation (WHO) had announced in 2015 that consumption of processed meat and red meat may cause cancer. Poddar also said the country could witness as high as

16 lakh cases annually by 2025. He suggested that in line with tobacco products, the government should make cancer warning mandatory on processed meat packets as well.

Rewati Raman Singh(SP) too expressed concern over the rising cases of cancer, saying about 1,400-1,600 people are losing their lives due to the disease everyday.

Congress member L Hanumanthaiah demanded that a special grant should be given to Kidwai Memorial Institute of Oncology in Bengaluru to establish of a full-fledged proton therapy facility.

He said the institute needs Rs 550 crore to set up the facility, and it is only seeking Rs 230 crore under special grant from the central government. Chairman M Venkaiah Naidu said the MPs can contribute to the institute.

Vandana Chavan(NCP) expressed concern over instances of misinformation during health crisis situations, and demanded that the government should develop a credible platform that provides "fast, accurate, authentic information" that is easily understandable

### 2 rape accused gunned down by Assam Police

¬wo persons, prime accused I in the rapes of two girls of whom one has died, were gunned down by Assam Police in separate incidents while allegedly trying to escape from custody, a senior officer said on Wednesday

Both the accused were arrested on Tuesday, and they were being taken to their respective crime scenes in Guwahati and a tea garden in Udalguri for further investigation when both attempted to flee custody after midnight, Special Director General of Police G P Singh told reporters here. In the first incident in Guwahati, the accused allegedly attacked the police personnel who then opened fire at him. The accused was taken to the Gauhati Medical College Hospital (GMCH), where he

was declared brought dead. **GMCH** Superintendent Abhijit Sharma said he was brought to the hospital around 1 am with four bullet injuries

"He had no heart beat when he was brought here. We have kept his body in the morgue and will hand it over to his family after conducting post-mortem examination, Sharma said.

Police said that two women personnel were also injured in the attack by the accused, but they were out of danger.

The accused, who was absconding since the mother of the girl filed a complaint with the police on March 8, was arrested on Tuesday from Dampur area in Kamrup district. The 15-year-old girl was allegedly gang-raped at a hotel in Guwahati by five men, two of whom had assaulted her on an earlier occasion too, police As per the complaint

lodged by the minor's mother, two of the five culprits, who had first sexually assaulted the girl on February 16 and videographed it, allegedly threatened

the matter to anyone.

On February 19, however, the accused, promising to delete the video, met the girl again in another hotel, and along with others forced themselves on her.

A search operation is underway to nab the other accused, police added.

In the other incident, the accused had allegedly raped and killed as circle trans and killed trans and kill

### Govt: Nearly 1.44 L illegal foreigners identified on basis of Assam Accord till Jan 31

Nearly 1.44 lakh illegal for-eigners have been identified in Assam till January 31 this year, on the basis of the Assam Accord inked in 1985, and the authorities have deported around 30,000 of them, the state government informed the Legislative Assembly on Wednesday.

The definitions of 'Asomiya janagan' (Assamese people), 'khilonjia' (indigenous) and 'adi basinda' (original inhabitants), as mentioned in the Accord, are yet to be determined, it said. Assam Accord Implementation Minister Atul Bora, in reply to a question by AGP legislator Ramendra Narayan Kalita, said 1,44,077 illegal foreigners have been identified in the state till January 31, 2022, on the basis of the Assam Accord.

Out of them, 30,014 have been deported to their country of origin, the minister said.

According to the Assam Accord, signed on August 15,

1985, all foreigners who came to Assam on or after March 25, 1971, and stayed illegally would be detected and steps would be taken to deport them.

On the progress of fencing along the India-Bangladesh border in Assam, the minister said 98.35 per cent of work has been completed.

The fencing work on a 4.35 km stretch in Karimganj sector has not been completed due to issues raised by Border Guard Bangladesh (BGB) and discussions are on to resolve the matter, he added.

Assam shares a 263 km border with Bangladesh. Bora also said the State

### 3 LeT ultras who killed Sarpanch shot dead

Ahead of the two-day long Visit of the Union Home Minister Amit Shah, starting from March 18, a joint team of security forces gunned down three Lashkar-e-Tayyeba (LeT) terrorists involved in the recent killing of Sarpanch Sameer Ahmad Bhat in Srinagar on Wednesday.

While the security forces were laying cordon around the suspected cluster of houses in the Nowgam area the terrorists opened fire on the secuirty forces around 2.05 a.m. The terrorists were hiding in a three storey house A solider of the Indian army was also injured in the continuous exchange of firing and grenade lobbing by the terrorists. According to official

sources, the first terrorist was neutrlaised around 8.30 a.m and the remaining two were neutralised around 9.15 a.m on Wednesday. According to a police spokesman, the slain terrorists have been identified as Adil Nabi Teli resident of Chandhara, Galchibal Pampore, Shakir Ahmad Tantray resident of Ronipora Shopian and Yasir Ahmad Wagay resident of Kujer Frisal,

killed terrorists were affiliated with proscribed terror outfit 2021. They were part of groups involved in several terror crime cases including attack on Police/SF and civilian atrocities. Police said these three terrorists were also planning to attack security forces on the National

### Not so equal

The issue of essential religious practice must veer towards gender equality, personal choice

hy is it that the responsibility of a cohesive Indian society always falls on the delicate shoulders of women? And why should the judiciary intervene every time to restore or protect their rights and iterate that they be treated equal to men? Are women and girls now the proverbial guinea pigs to decide on contentious religious issues as well? Can they wonder aloud if patriarchal, societal and religious rules supersede constitutional guarantees about women's equality, freedoms and choices? The Supreme Court is besieged with applications to review the latest judgment of the Karnataka High Court that said hijab is not an essential religious practice of the Islamic faith. The apex court faces a dilemma while taking up these petitions. It has many petitions filed against its 2018 order allowing women and girls of menstruating age to enter Kerala's Sabarimala temple. They are pending a larger constitutional Bench examining questions related to essential religious practices. The court apprehended that cases involving determination of essential religious practice in other religions may object to the apex court's reasoning in the 2018 order and order a referral. Sounds entirely logical except that in the meantime, women and children of menstruating age are unable to enter the Ayyappa temple and perform

duties as devotees just like Muslim girls are unable to enter classes wearing hijabs. Perhaps the Supreme Court may first examine the question of essential religious practice before it takes up the hijab review petitions.

The Karnataka and Kerala HC judgments differing on hijab being an essential religious practice demand its attention. Two, in the context of Sabarimala, a question arises why a ban on entry of menstruating women should be essential religious practice when it is the demand of only the Hindu community. A basic counterquestion is whether the right of a Hindu devotee for unrestricted temple entry and prayer is an essential religious

practice in Hinduism (which, constitutionally, is also a legal right of choice). There cannot be a greater example of essential religious practice. Hinduism is not organised by a book. Over the centuries, various factors, including caste, patriarchy and divisions among Hindu communities, influenced practices that are today considered "ancient" traditions. How can essential religious practice be determined if the time and date of the origin of Hinduism and written traditions are unknown? Also, Hinduism is the only major religion that worships Shakti, god in female form. Gender equality could therefore be argued to also have spiritual, or religious, sanction, apart from being a constitutional necessity. The right to religious freedom, like any other constitutional freedom, without exception, means an equal entitlement of all people. Should courts deal with essential religious practice when relations between a devotee and god are constitutionally deemed personal and by choice? With essential religious practice hardly a fool-proof mechanism to determine religious issues, the Constitution should be allowed to prevail as proof of "positive secularism".

### Hard row to hoe

The AAP may have won a landslide in Punjab but the road ahead is tricky

inally, the AAP successfully installed its first Government in a full-fledged State outside Delhi when its leader Bhagwant Mann on Wednesday took the oaths of office and secrecy as the Punjab Chief Minister. After the ceremony, held at the ancestral village of Bhagat Singh, Mann made his priorities clear when he quoted the legendary freedom fighter: "Ishq karna sabka paidaishi haque hai; Kyun na iss baar watan ki sarzameen ko mehboob bana liya jaye." So far, so good. The verdict in the Punjab Assembly election has been unprecedented; in fact, the State



has never witnessed a landslide like this. But winning by a landslide does not mean a smooth ride ahead for the nascent party, with mostly inexperienced leaders pitted against past masters of State politics. It's not going to be easy, what with the Congress, BSP, the SAD, BJP and Capt Amarinder Singh's newly-launched party, the Punjab Lok Congress — with decades of experience of ruling Punjab among them — likely to be snapping at the heels of the newbie. The party must now come good on its promises of better public services, good-quality schools and hospitals, end of bribery and cor-

ruption, creating job opportunities and a drugs-free State.

All these pledges had remained the party's constant campaign theme on the lines of Delhi where the AAP has won two consecutive terms. However, the truth is that with Punjab's financial crisis set to worsen and the debt likely to touch ₹252,880 crore by this fiscal, the incoming Government is likely to face a tough task fulfilling its poll promises of investment in health and education, besides near-free supply of regular power and water to 35 lakh households. Banking largely on freebies to woo the electorate, the party had promised ₹1,000 a month to all adult women. But the State's coffers betray a disappointing scenario. The ever-increasing salary and pension burden and rising debt and interest leave little scope for development. The total outstanding debt of Punjab as on March 31 is projected at ₹252,880 crore, which is 42 per cent of the GSDP for 2020-21, and the outstanding debt is likely to be ₹273,703 crore in 2021-22, which is 45 per cent of the GSDP. In this light, it is critical for the AAP to fulfil its pre-poll assurances; else it can forget about foraying into any other State. As they say, higher the expectation, greater the disappointment!

## A fresh idea on majority-minority PRAFULL GORADIA

rif Mohammad Khan, currently the Kerala Governor, has given a Lfulsome interview to the media which should be a useful guide to many of our citizens. The former Union Minister, once a leading Congressman, says anyone who wins an election and comes to power can be called as being in majority and anyone who loses and remains on the opposite side is in the minority. He is opposed to the appointment of minority commissions; he prefers human rights panels to cater to the needs of those marginalised or perceiving their fundamental human rights under threat. Viewed from the lens of the fundamental requirement of any country that prides itself on being democratic and secular, the Kerala Governor's logic is irrefutable.

That should bring us to why the label of minority and minority-ism came into being, and the subsequent politics around it. MA Jinnah, the founder of Pakistan, agitated for Partition on the plea that Muslims are a nation and not a minority. He argued for his entire nation to emigrate to what some Muslim League leaders called the "New Medina". When he found that not many had migrated, he told the Pakistan Constituent Assembly on August 11, 1947: "You are free to go to your temples, mosques or to any other place of worship in this State of Pakistan. You may belong to any religion or caste or creed — that has nothing to do with the business of the State." However, Jinnah was perhaps too old and sick to enforce the implementation of what he had spoken in August 1947 in the highest Assembly of his new country. As a result, today India has more Muslims than Pakistan!

However, neither Hindus nor Muslims can behave as a separate nation inhabiting the same country. Two nations, aka Jinnah, cannot coexist in one country. Yet some people continue to behave as if they belong to a separate nation. For the country, the consequences of such recalcitrance are a drag on its progress while, for individuals, it is a drag on their future. They and their progeny

would indefinitely remain poor and backward; the only beneficiaries could be those who mediate between the poor individuals and God Almighty.

What a piece of news published earlier this week, following a survey, says is welcome. According to the survey, at least eight per cent of the votes cast in the recent Uttar Pradesh elections were reportedly by Muslims in favour of the BJP. Furthermore, it reported that six of the seats won by the BJP were due to the All India Majlis-e-Ittehadul Muslimeen (AIMIM) cutting into the community's votes that might otherwise have gone to the Samajwadi Party. AIMIM, a political party based out of Hyderabad, polled nearly 19,000 votes in Firozpur and 2,190 in Sultanpur in the UP Assembly elections. The other constituencies where AIMIM polled notable votes were Bijnor, Nakur, Kursi and Shahganj where the party had put up its candidates.

If indeed a change of outlook is taking place in UP, it is particularly welcome. Qaid-6 Azam Jinnah had ebulliently described the Aligarh Muslim University (AMŪ) as "the

arsenal of Pakistan". Many of its students spent months canvassing for the Muslim League in Punjab in the 1945-46 election, which ultimately led to the creation of Pakistan. When local Punjabis enquired of the campaigners as to what they (meaning the UP Muslims) had to gain from Partition, the latter replied that their campaign was to "win a New Medina" and to "reinstall a new Khalifa" (Caliph)! From an idealistic point of view, one would indeed grieve at such a mentality, although it is human to err. But it is folly to persist with an error.

Former President Dr Zakir Hussain once gave sound advice to his Indian coreligionists along with 13 other leaders; he had begun his counsel as long ago as 1951: "Our misguided brothers in Pakistan do not realise that if Muslims in Pakistan can wage a war against Hindus in Kashmir, why should not Hindus sooner or later retaliate against Muslims in India?" Another piece of him and his advice given by not welcome in Pakistan, how can we in all fairness

expect Muslims to be welcomed in India? Such a policy must inevitably, as the past has already shown, result in the uprooting of Muslims in this country and their migration to Pakistan, whereas it became clear last year, they are no longer welcome lest their influx should destroy Pakistan's economy."

Predictably, the BJP's

emphatic victory in four Assemblies, particularly in UP, has set off yet another round of secular wailing and the by-now-familiar predictions about the impending doom for secularism, democracy, liberalism and what not. Here again, the Kerala Governor's worldview, that the idea of a majority-minority divide entrenched in societies today has been sown for the very purpose of creating discontent and hatred, offers the sagest outlook and way ahead. Such binaries derail India's progress. One is a child of India, no matter what the vectors defining us are.

#### **CUT EXCISE ON FUEL PRICES**

Sir — One of the important benchmarks for crude oil prices, the Brent Crude, currently at \$110 a barrel from as high as \$139 earlier indicates a declining trend. It must be a sign of relief for the Government, considering that fuel prices have remained unchanged since November 4, 2021. ### **CREATING 'ARTPRENEURS' IN INDIA**

Supporting rural talent, entrepreneurship and education

n a country like India whose culture is as diverse and varied as the people who make up its population, art is an invaluable part of its social currency. Passed down from generation to generation, India's folk art is the secret ingredient that forms the epicenter of the country's rich heritage and serves as a looking glass into bygone eras. Whether it's the delicate art of Dhokra which dates back to the Mohenjadaro civilization, the intricate silver and gold zari work in Varanasi's Banarasi Sarees, or the 2000-year-old technique of block printing - each form tells a very distinct tale of history, created with a skill that is ancestral and almost genetic. But over the years as India has industrialized with technology breeding the era of hyper-consumerism, local art and artists have felt the struggle to balance the precarious act of sustaining tradition and making a living. With everything from fast fashion to fast art, decades of



skill and exquisite craftsmanship have taken a backseat, overshadowed by machine-made products created with the sole purpose to satiate immediate wants that are instigated by what's trending. Further aggravating the scenario is the growing insurgence of globalization with foreign influences stealing the limelight from local talent. And while it may seem that India's illustrious legacy of distinctive rural art forms could have soon been left for the archives - initiatives like Make in India, the National Handicraft Development Programme, and many such programs like this have put the focus back on local creations and production. Addressing inherent challenges that range from insufficient funds, a lack of a proper institutional framework to low penetration of technology needs to be highlighted, with efforts first beginning through heightened awareness. Given the vast nature of this network, the need for national and even international exposure is critical to the survival of rural art. And to some extent progress has been made with savvy netizens as well as social media leading the charge with trends like #VocalForLocal. In fact, initiatives like AD Design Show's 'Power to the Karigar' - which highlighted artisans like Ramzubhai Kumbhar who from his humble village in Ahmedabad is keeping the 8,000-year-old tradition of Kutch pottery alive - brings these almost forgotten art forms back into the spotlight. Technology too presents unique opportunities for rural art to gain a global platform. With eCommerce leading the charge, artisans now have the opportunity to present their creations to a wider audience from the comfort of their own hometowns. This of course is not possible without creating an infrastructure that enables them to access these connections. Deeper internet penetration and access, as well as basic training and upskilling, could lead to a future of budding 'artpreneurs' in every pocket of the country. Inciting foundational and sustainable change requires the creation of a multitude of business opportunities, as well as financial support to these communities. This is where institutional level or even on a privatized level, skill developments programs play a vital role. It's the age-old adage of 'teach a man to fish'. While most of these artisans operate in an almost seasonal and informal work environment if grassroot level business training is provided these local artists have a chance to gradually build a career of their own and generate a steady source of income. A key takeaway from these initiatives and observations is that to nurture India's thriving rural art scene, mobilization on an individual, institutional and private level needs to become a core priority. This community, which is an integral part of India's social construct, must be empowered with the necessary tools and exposure to seize control of their trade's future as well as their own.

## Deconstructing the Purvanchal vote

ttar Pradesh, the biggest state of the country, has several regions. The geographical, demographic and even political natures of these regions are different as they are closer to their adjoining states. Purvanchal (eastern UP) is one of the six regions, biggest one, by and large, close to Bihar and various border districts have 'roti-beti' relations with the adjoining State. Like Bihar, it is also one of the most backward regions where religion and caste factors always have a play in elections. Even in the latest assembly elections in UP, the domination of these factors were clearly visible.

The impact of Bihar's famous MY (Muslim-Yadav) factor, which played a crucial role in all recent polls, was also seen in UP, helping the Samajwadi Party (SP) emerge as a big challenge to the ruling BJP, which has changed all poll equations since 2014 with the emergence of Prime Minister Narendra Modi. It was an election in which Upper Castes enthusiastically supported Modi and a sizable part of non-Yadav OBCs shifted to the BJP as it played its social engineering card effectively under the leadership of Amit Shah.

Though SP's MY got a good support from unhappy people of different sections, it could not match the rival camp because of another MY combination --of Chief Minister Yogi Adityanath with his clean image, speedy development works and his religious card and the charisma of Modi. The caste-community-based MY failed to match the reach of Modi-Yogi who not only adopted aggressive campaigning but also succeeded in mobilising their supporters to vote. A slight decline in polling percentage despite resentment in a section helped the ruling party not only keep an upper hand but also increase its polling percentage. Various social welfare schemes of the central and state Governments had provided maximum benefits to the poor, resulting in a sharp shift of a sizable vote-bank of Bahujan Samaj Party (BSP) to the ruling camp. This new addition of votes has imbalanced all the poll strategies and expectations of the SP camp.

Besides, by the time the opposition identified the the real battlefield, it was too late. Its aggressiveness in the last two phases when Purvanchal went to the poll could not make any change as the BJP ing any time to the rivals to take an advantage from the agitation of farmers and incidents of Lakhimpur and others. In most of the places, despite spending their huge energy, the rivals failed to encash on such tragic incidents, whether it was Umbha (Sonbhadra) or Gorakhpur in this region where the BJP made a clean sweep winning all four and nine seats of these districts, respectively.

UP has six main regions and out of these Purvanchal is the biggest one with 102 assembly seats followed by Awadh

The Bhojpurispeaking Purvanchal has mainly two belts of Varanasi and Gorakhpur with 61 and 41 assembly seats of three divisions each, comprising 10 and seven districts respectively. As present political bases of Modi and Yogi are there, thedeparture of the Om Praksh Rajbhar-led SuheldevBharatiya Samaj Party (SBSP) from the NDA prior to parliamentary elections in 2019 and entry into the SP camp prior to this assembly polls did not make any decisive change, though its impact were clearly seen in some districts with sizable population of Rajbhars (a subcaste of OBC). BJP tried to boost UP Minister Anil Rajbhar but he did not have time to go outside of his own constituency (Shivpur in Varanasi) where he was contesting against Arvind Rajbhar, son of SPSP chief.

In Ghazipur, BJP lost all seven seats, though in 2017, NDA won five seats with two of its then won just the seat of Harraiya, losing all other four whereas five years ago, NDA bagged all five seats. It also managed to avoid going blank in Mau where in 2017, the party had bagged three out of four seats. Former minister Dara Singh Chauhan, contesting this time as SP candidate, won his seat despite changing it, from Madhuban to Ghosi.

In comparison to Gorakhpur, the BJP received an invisible challenge in Varanasi region as it lost all 10 seats in Azamgarh and fared poorly in Ballia and Jaunpur. In Ballia, both of its ministers, Anand Swaroop Shukla (Bairia) Upendra Tiwari (Phaphamau), faced defeat while yet another minister Sangeeta

Balwant (Ghazipur Sadar) met the

same fate.

In Ghazipur, three female candidates of BJP won in 2017 but this time, they all were defeated. The other two were Alka Rai (lost to SP's Sibghatullah Ansari, brother of alleged mafia don Mukhtar Ansari, in Mohammadabad) and Sunita Singh (lost to former minister OP Singh of SP in Zamania). Not only Sibghatullah but also Mukhtar's son Abbas Ansari (Mau) won. Mukhtar's elder brother Afjal is an MP

Despite the missing charisma of Modi-Yogi in many districts, the NDA made a clean sweep in Varanasi, Mirzapur, Sonbhadra, Deoria, Gorakhpur and Kushinagar districts clinching all seven seats, respectively. It maintained its tally in Chandauli, Bhadohi and Maharajganj winning three, two and four seats out of four, three and five constituencies respectively.

The BJP has received a shock in the Varanasi region where it was second largest party after SP, claiming 23 against 26 of SP out of 61 seats. Even NDA was second with 29 against 31 of SP camp whereas in 2017, NDA had won 41 (BJP 34) while SP bagged 12. However, in Gorakhpur region the picture was different as the NDA won 34 seats (BJP 30) out of 41 while SP camp six (five SP itself). In the entire region, NDA won 63 seats (BJP 53) out of 102 while SP camp 37 including 31 by SP. Besides, the region also saw the sole win of BSP (from Rasra in Ballia) and one out of two by Indian National Congress (INC) from Pharenda (Maharajganj).

Among six divisions of Purvanchal, the poorest performance of NDA was in Azamgarh claiming just three out of 21 (zero in Azamgarh, one in Mau and two in Ballia) whereas in 2017, it had claimed nine (one, three and five respectively). In Basti, NDA just opened its account in Basti and won three out of five in Siddharth Nagar. Its best shows were in Vindhyachal division (maintaining last tally of 11 out of 12, losing just Bhadohi seat to SP) and Gorakhpur (winning 27 out of 28 including all seats of Gorakhpur, Deoria and just one to INC in Maharajganj. However, a mixed result of NDA was seen in Varanasi, winning all the eight seats in Varanasi, retaining three out of four in Chandauli, claiming four in Jaunpur (five in 2017) and facing defeats in all seven seats in Ghazipur. Overall, the NDA won 15 seats out of 28 in the division whereas five years ago, it had claimed 21 seats. The SP camp increased its tally from six to 13.

## Zelenskyy takes centre stage in Congress, pleads for help

krainian President Volodymyr Zelenskyy is addressing the US Congress, the actor-turnedwartime leader's latest video speech as he uses the West's great legislative bodies as a global stage to orchestrate support against Russia's crushing

Lawmakers rose and gave him a standing ovation when Zelenskyy appeared on the large video screen.

Zelenskyy's livestreamed appearance on Wednesday into the US Capitol is part of his very public strategy, in which he has invoked Winston Churchill, Hamlet and the power of world opinion in his fight to stop

Nearing the three-week mark in an ever-escalating war, Zelenskyy has used his campaign to implore allied leaders to "close the sky" to prevent the Russian airstrikes that are devastating his country. It has also put Zelenskyy at odds with President Joe Biden, whose administration has stopped short of providing a no-fly zone or the transfer of military jets from neighbouring Poland as the US seeks to avoid a direct confrontation with Russia.

Instead, Biden will deliver his own address following Zelenskyy's speech, in which he is expected to announce an additional \$800 million in security assistance to Ukraine, according to a White House official. That would bring the total announced in the last week alone to \$1 billion. It includes money for anti-armor and air-defense weapons, according to the official, who was not authorized to comment publicly and spoke on the condition of anonymity.

According to a statement issued by FICCI, Choudhary emphasised on the need to connect farming with new tech-

nology.

He said farmers need better seeds, lower cost of production, storage facilities and market access.

Choudhary highlighted various steps taken by the government for the growth of agriculture sector like increase in the ministry's budget, neemcoated urea, nano fertiliser and the launch of e-NAM portal, among others.

Further, he said 10,000 FPOs are being formed countrywide to aid farmer groups seeds, lower cost of production, storage facilities and market access"

jointly undertake several postproduction activities.

4,000 FPOs are already set up," he said adding "every block will have one FPO."

Arjun Ram Meghwal, Minister of State, Parliamentary Affairs & Culture, said weather and market access are two vital areas that need special attention of every stakeholder.

R G Agarwal, Chair of the FICCI Committee on Crop Protection and Chairman, Dhanuka Group, said the biggest challenge before the country is rising population and reducing land availability for farming.

Agarwal also spoke about the increasing importance of pesticides and other plant protection equipment in farming and the need for genuine biostimulants. He alluded to sevthe country harming farmers. Talking about the need for

plant protection, P K Chakrabarty, Member, ASRB, Ministry of Agriculture and Former ADG (PP), ICAR, said 20-40 per cent of production is lost due to improper or no plant protection.

He said this amounts to Rs 90,000 to Rs 100,000 crore in value terms. "If we avoid this loss, we will save an amount almost equal to our agriculture budget," he said.

Chakrabarty also stated that India is the fifth largest seed market globally on the back of 49 crop research institutes of ICAR, 45 all-India coordinated projects, 77 state agriculture universities and a robust partnership with the pri-

A K Singh, Deputy Director General (Horticultural Science), DARE - Indian Council of Agricultural Research, underscored various tech-led initiatives that the government has taken in reaching out to farmers.

He said that more than five crore farmers are registered on the mKisan portal and they receive regular updates, and Kisan call centres address 20,000 calls every day.

able energy and abundantly available biomass. He noted that the introduction and adoption of technology to tap into the green hydrogen's potential will play a key role in securing a clean and affordable energy future for India.

Toyota Kirloskar Motor (TKM), along with the International Center for Automotive Technology (ICAT), is conducting a pilot project to study and evaluate the world's most advanced FCEV Toyota Mirai, which runs on hydrogen, on Indian roads and climatic conditions.

### 347 FDI proposals received from countries sharing land border with India; 66 approved

New Delhi: As many as 347 foreign direct investment (FDI) proposals, worth about Rs 75,951 crore, have been received by the government from countries sharing land border with India since April 18, 2020, Parliament was informed on Wednesday.

Out of 347, 66 proposals have so far been granted approval by the government and 193 cases have been rejected or closed or withdrawn, Minister of State for Commerce and Industry Som Parkash said in a written reply to the Lok

"Since 18th April, 2020, 347 FDI proposals have been received by the government from countries sharing land border with India or where the beneficial owner of an investment into India is situated in or is a citizen of any such country...The value of investments proposed in the aforementioned proposals received by the government is approximately Rs 75,951 crore," he said.

In April 2020, the government had made its prior approval mandatory for foreign investments from countries that share land border with India to curb opportunistic takeovers of domestic firms following the COVID-19 pan-

Countries which share land border with India are China, Bangladesh, Pakistan, Bhutan, Nepal, Myanmar and Afghanistan. As per that decision, FDI proposals from these countries need government approval for investments in India in any sector.

The 66 approved proposals are from sectors including automobile (7), chemicals (5), computer software and hardware (3), pharma (4), education (1), electronics (8), food processing (2), information and broadcasting (1), machine tools (1), petroleum and natural gas (1), power (1), services sector

The total value of investments of these 66 proposals aggregated to Rs 13,624.88

In another reply, Parkash said a decision has been taken to develop a platform for data exchange among all modes of operators. Accordingly, Unified Logistics Interface Platform

(ULIP) has been designed by National Industrial Corridor Development Corporation Ltd (NICDC), under the guidance of NITI Aayog.
"So far, the platform has

been integrated with 24 systems of six ministries including Ministry of Ports, Shipping and Waterways, of Railways, Ministry of Road Transport and Highways, Ministry of Civil Aviation, Directorate General Foreign Trade and Central Board of Indirect Taxes (CBIC) through 78 application programming (APĬs)," he added.


