



CM: Phone call made from PMO to defer MCD polls

In a scathing revelation, Delhi Chief Minister Arvind Kejriwal on Thursday alleged that a phone call was made from the Prime Minister's Office to State Election Commissioner asking him to defer the municipal corporation elections. Speaking in the Delhi

Assembly, Kejriwal said "This would not have happened anywhere in the world that a PM is getting an election deferred by directly calling and sending a letter to the election commission. The BJP doesn't want elections. BJP leaders broke all

the records of loot in the MCD," Kejriwal's remarks came after the Delhi SEC had earlier this month deferred the announcement of election schedule for the civic bodies after it received a communication Lieutenant Governor Anil Baijal, saying the Centre plans to bring a Bill in the Budget session of Parliament to unify the three municipal corporations of

The Union Cabinet on Tuesday gave its nod to a Bill to merge the three municipal corporations in Delhi. The Bill regarding the unification of civic bodies in Delhi is likely to

be tabled in the ongoing Budget session of Parliament.

The AAP national convener also sought to know why the BJP did not reunify all the three municipal corporations in the last seven years. "Were you (BJP) sleeping for seven years? The State Election Commission (SEC) was scheduled to declare the dates of MCD elections on March 9 at 5 pm, but a phone call from the PMO was made to the commissioner and a letter was sent just an hour before the announcement to cancel the polls," he claimed.

Addressing the House, the chief minister alleged that the BJP hated Babasaheb Ambedkar because he gave the Constitution and democracy. He dared the BJP to fight MCD elections timely and win. "The biggest party of the world (BJP) got scared by the smallest party of the world (AAP)," Kejriwal said. According to sources, there may be some reorganisation of wards in Delhi which might delay elections.

BJP leaders call AAP MLAs 'tukde tukde gang' BJP, RSS opposing installation of Tiranga, alleges Somnath

The second day of Delhi Assembly began on stormy note with an MLA of the ruling party Somnath Bharti alleged that the BJP and the RSS were opposing the instal-lation of a high-mast tricolour in his constituency while the BJP leaders called AAP MLAs part of the "tukde tukde gang".

Following the heated exchange of words, Speaker Ram Niwas Goel directed that BJP MLAs Vijender Gupta and Jitendra Mahajan be marshalled out of the House.

Deputy Chief Minister Manish Sisodia lashed out at the BJP, saying that it is opposing the installation of Tiranga in Delhi and dared them to stop the AAP Government from doing it. "Every single AAP worker and leader will lay their lives but will not allow the BJP to disrespect the national flag. Did Bhagat Singh-Sukhdev-Rajguru sacrifice their lives for us to see this day

around disregarding the Tiranga," he asked? "The Delhi Government decided to celebrate the 75th year of Indian Independence by installing 500 massive Tirangas all over the

Our motive behind the project was to instill a feeling of Deshbhakti in each and every citizen the moment they step out of their house. If any BJP Councillor has the audacity to say that the tricolor cannot be installed at a site because a certain group hoists their own flag then there just cannot be a bigger traitor than one who has no regard for the national

flag," he said. AAP MLA Somnath Bharti said "We have all heard from many sources that the people belonging to the BJP hold no attachment to our beloved Tiranga in any form or manner. Their leaders made absolutely no contributions in our fight to attain freedom, in liberating the Tiranga whatsoever. However,

where BJP conveniently goes an incident from my constituency has been brought to my notice recently, which has left me stunned and disconcerted."We had taken permission from the South MCD in order to install one of the Tirangas in the Maharaja Sursaini Park in my constituency.

As soon as we arrived at the site, some people arrived and objected to us installing the national flag. When I asked the reason behind their objection, they stated that they use the park to set up their Shakhas, and hence only their flag can be hoisted at the park," he added.

Responding to the allegation, Delhi BJP Spokesperson Praveen Shankar Kapoor has said that it is regrettable that MLA Somnath Bharti and other AAP leaders are playing 'dirty" politics in the name of hoisting tricolor. Bharti wanted to hoist the flag in one corner of the park while local residents requested him to hoist it in the centre of the park.

Learner's driving licences validity extended till May 31

Department has extend-Transport ed the validity of learner's driving licences expiring on March 31 by two months till May 31, 2022.

Delhi's Transport Minister Kailash Gahlot announced the development and said it is the final opportunity for people to get their learner's licenses renewed.

"Those Learner's License whose validity is going to expire by March 31 has been extended for a period of 2 months i.E., up to May 31. Pls note that this is the last and final opportunity," Gahlot said in a tweet.

He also attached a picture of the order issued by his department in this connection. The order issued by the Transport Department on Thursday said that the validity of driving learner's licenses has been extended from time to time because driving skill test and new appoint-

pended in pursuance of Delhi Management Authority (DDMA) guidelines to contain COVID-19 spread.

"It has come to notice that several learner's license holders, which were declared valid between February 1, 2020 and March 31, 2022 due to extended validity on account of pandemic situation, have not yet got the skill test appointments and there are many more applicants than the available driving skill test slots.

Therefore, the validity of those learner's license issued by this department whose validity going to expire by March 31, 2022, is further extended as a final opportunity for a period of two months i.e., upto May 31, 2022," the order issued by the department said.

The order further said that last extension for validity of driving learner's license was given up to March 31, 2022 in January this year.

Chinese Foreign Min arrives in India, to talk with Jaishankar, Doval

 \mathbf{I} ndia and China will make all efforts to end the two-yearold stalemate at the border in Ladakh during the talks between External Affairs Minister S Jaishankar and his Chinese counterpart Wang Yi here on Friday. Wang Yi is also likely to meet National Security Adviser (NSA) Ajit Doval.

The two leaders are also expected to discuss ways for the speedy return of Indian students to China. There are more than 15,000 Indian students studying in various universities there and forced to return home after the outbreak of the corona pandemic more than two years back, sources said here on Thursday.

Yi arrived in India on Thursday evening. He flew into New Delhi from Kabul and is the first Chinese Minister to come to India since trouble erupted between forces of the two nations in May 2020 resulting in a bloody brawl later in the Galwan valley.

Moreover, hé comes a day



after India criticised him for his remarks on Jammu and Kashmir. New Delhi rejected the "uncalled reference" to Jammu and Kashmir in his speech in a function in Pakistan.

Wang had made a reference to Kashmir in his opening speech at the Organisation of Islamic Cooperation in Pakistan. "On Kashmir, we have heard again today the calls of many of our Islamic friends. And China shares the same hope," he had said.

As regards talks on the situation on the Line of Actual Control (LAC), the two leaders will review the progress made so far during 15 rounds of military-level talks besides several rounds of parleys at the diplomatic level.

Wang and Jaishankar met twice after the incident — in Moscow in September 2020 and Dushanbe in September

Abstains from voting on resolution moved by Russia on crisis at UN

Maintaining a neutral stand, India abstained from vot-ing in the United Nations Security Council (UNSC) on a resolution moved by Russia on the humanitarian crisis in Ukraine. Twelve other countries, including the US, too abstained from voting on it late on Wednesday.

India had earlier abstained from voting in the UNSC and in the United Nations General Assembly (UNGA) on resolutions on Russia's invasion of

The draft resolution by Russia on Wednesday was co-sponsored by Syria, North Korea and Belarus. It failed to get adopted in the Council as it did not get the required nine "yes" votes to pass. Russia and China voted in favour of the resolution, but no countries voted against it.

Russia, a permanent member having veto power, had called for a vote in the 15nation Security Council on its draft resolution that "demands that civilians, including humanitarian personnel and persons in vulnerable situations, including women and children are fully protected, calls for negotiated ceasefire for enabling safe, rapid, voluntary and unhindered evacuation of civilians, and underscores the need for the parties concerned to agree on humanitarian paus-

es to this end."

The resolution called upon

all parties concerned to allow safe and unhindered passage to destinations outside of Ukraine, including to foreign nationals without discrimination, and facilitate safe and unhindered access of humanitarian assistance to those in need in and around Ukraine, taking into account the particular needs of women, girls, men and boys, older persons and persons with disabilities.

While other Council members made statements after the vote on the resolution, India not make statement.

US Ambassador to the UN Linda Thomas-Greenfield tweeted that "in a unified protest vote", 13 members of the Security Council abstained from Russia's farcical resolution deflecting blame for the humanitarian crisis it has created in Ukraine.

In the Explanation of Vote, Thomas-Greenfield said it really is "unconscionable" that Russia would have the audacity to put forward a resolution asking the international community to solve a humanitarian crisis that Russia alone cre-

Dermitting the Centre to Pconduct an inquiry into fake claims for ex-gratia meant for family members of those who have lost their lives due to Covid-19, the Supreme Court on Thursday directed the Government to verify 5 per cent of claims in four States -Maharashtra, Kerala, Gujarat and Andhra Pradesh — where the gap between number of claims and recorded deaths was wide.

A bench of Justices M R Shah and B V Nagarathna said, "Nobody can be permitted to avail the compensation by making a false claim or submitting the false certificate. We permit the National Disaster Management Authority/Union of India, through the Ministry of Health and Family Welfare, to carry out the random scrutiny," the bench said.

If it is found that anybody has made a fake claim, the same shall be considered under Section 52 of the Disaster Management Act, 2005 and liable to be punished accordingly, the bench said.

Giving this assurance in the Rajya Sabha in the backdrop of ongoing conflict in Ukraine, External Affairs Minister S

Jaishankar also said New Delhi favours dialogue to end the war. Prime Minister Narendra Modi held three rounds of talks with Russian President Vladimir Putin and Ukraine President in this regard, he said. Modi was present in the house when Jaishankar gave this information. Elaborating upon the country's foreign policy, he said India's position on Ukraine is based on six principles. Firstly, India calls for an immediate cessation of violence and hostilities. India stands for peace.

NIA conducts

The National Investigation Agency (NIA) on Thursday conducted searches at multiple locations in Gujarat and Maharashtra in the espionage case of Andhra Pradesh.

The case relates to involvement of Pakistani agents in espionage activities in India. Investigation revealed that they had conspired with other accused persons based in Gujarat for gathering sensitive information for conducting terror acts in India, the NIA said in a statement here.

The NIA conducted the searches at four locations in Gujarat and Maharashtra. The case was initially registered as FIR No. 1/2020 dated January 10, 2020 at Police Station Counter Intelligence Cell, Andhra Pradesh, Vijayawada and was later re-registered by NIA on December 23 last year.

"Indian SIM cards were fraudulently procured and one time passwords (OTPs) were received through their Indian

WhatsApp by Pakistan-based handlers which was then used to establish contact with defence personnel to elicit sensitive information related to vital installations," it said.

The searches were conducted in Godhra, Gujarat and Buldana, Maharashtra at the premises of suspects. During the searches, digital devices, suspicious SIM cards and incriminating documents have been the case is continuing, it said.

In a separate case, the NIA filed a supplementary chargesheet against an accused Shahid Kasam Sumra of Kutch, Gujarat, in NIA Special Court, Ahmedabad in a drugs smuggling case. The case was initially registered by Anti-Terrorism Squad (ATS)/Gujarat on August 12, 2018 pertaining to a criminal conspiracy hatched by accused based in Dubai and Pakistan for smuggling and distribution of 500 kg of illegal narcotic drugs (heroin) from Pakistan to Gujarat by sea route,

LRUs' import banned to boost self reliance in defence production

PNS NEW DELHI

Custaining its drive to achieve Self-reliance in defence production, the Government on Thursday banned import of 107 strategically important Line replacement Units (LRUs) and sub-systems. Earlier, the Government had banned import of nearly 2,800 sub systems covering all the three Services.

In the latest order, the items can only be procured from the Indian industry, especially Defence Public Sector Undertakings(DPSU), officials said here. The sub systems cover the entire gamut of weaponry including helicopters, tanks, guns, ships and submarines, radars, drones and electronic warfare systems.

Indigenisation of these items will be taken up by the DPSUs under 'Make' category. 'Make' Category aims to achieve self-reliance by involving greater participation of Indian industry. Projects involving design and develop-

ment of equipment, systems, major platforms or upgrades thereof by the industry can be taken up under this category.

The DPSUs will offer these identified LRUs and Sub-systems for industry led design and development. This will be a great opportunity for the Indian industry to get integrated in the supply chains of manufacturing major defence platforms. The indigenous development of these systems projects will bolster economy and reduce the import dependence of DPSUs. In addition, it will help harness the design capabilities of domestic defence industry and position India as a design leader in these technologies.

'Second-hand smoking killing 1.2 million'

 $S^{\text{econdhand smoke (SHS) in}}_{\text{the country is not only con-}}$ suming nearly 1.2 million lives, particularly women and children but also resulting in a loss of Rs 568 billion, being spent as healthcare costs annually, accounting for 8 per cent of total annual health care expenditures in the country.

This is on top of the staggering Rs 1773.4 billion in annual economic burden from tobacco use, according to a first-of-its-kind study by the Indian researchers and published in the Journal of Nicotine and Tobacco Research.

In fact, the Rs 568 billion represents only one part of the total economic costs of SHS exposure, said the study as it painted a grim picture of the toll the SHS was taking on the individuals who were silently affected by the smoker's habit.

All those people who do not smoke breathe in SHS and they take in nicotine and toxic chemicals the same way smokers do. The more the exposure, the higher the levels of these harmful chemicals in the body.

"The monetary burden does not include the additional indirect economic costs due to lost productivity, morbidity, and mortality caused by illness and early deaths arising from SHS exposure, that would further increase the final figure," warned the team of authors led by Dr Rijo M john, an economist and researcher from the Rajagiri College of Social Sciences.

The study has quantified the tremendous economic burden of SHS exposure in India, using public data sources and a prevalence-based attributable risk approach to quantify the healthcare cost of continued exposure to SHS among non-smokers aged 15 and

"In fact, increasing tobacco taxes is one of the most effective ways to reduce smoking, yet India has not had any significant tax increase on any tobacco products for the past four years. The current tobacco tax collected in India from all tobacco products combined is less than the Rs 567 billion in health care costs caused by exposure to SHS," Dr John

ED asks TMC MP Abhishek to appear again

The Enforcement Directorate (ED) has issued a fresh summons to Trinamool Congress MP Abhishek Banerjee, asking him to appear before it for questioning on March 29 in a money-laundering case linked to a coal scam of West Bengal. The TMC national gener-

al secretary and nephew of West Bengal Chief Minister Mamata Banerjee was questioned by the agency for about eight hours on Monday. This was the second time he was questioned by the ED in the case. He was first grilled in September last year and his role and links with other accused in the case are being investigated.

The last ED summons against Banerjee and his wife Rujira was issued after the Delhi High Court, on March 11, dismissed a plea moved by the couple, challenging the notices asking them to appear before the agency in Delhi instead of Kolkata. The ED lodged the money laundering case on the basis of a November 2020 FIR.

SC transfers probe against **Param Bir Singh to CBI**

In a big relief to former Mumbai Police Commissioner Param Bir Singh, the Supreme Court on Thursday transferred probe on all cases against him to CBI, registered by Maharashtra Police. A very murky affair is going on amid echelons of power on who should investigate the matter, a bench of Justices S K Kaul and M M Sundresh said, while transferring the probe to the central investigative agency.

"The exigencies in the advancement of principles of justice require the investigation to be transferred to CBI. We are not saying appellant (Singh) is a whistle-blower or anyone involved in this case is washed with milk," the bench noted. The bench also refused to revoke the suspension of Singh and said all future FIRs, too, will be transferred to CBI. The apex court said a thorough

the faith of people in the state police.

"We are unable to accept the contention that an FIR is registered by those who had complaints against the petitioner. We are of the view that state itself should have allowed CBI to carry the investigation. We are of the prima facie view that there is some concerted effort which needs the investigation by CBI. What is the truth, who is at fault how does such scenario come to prevail is something which investigation must get into. CBI must hold an impartial inquiry into all these aspects," the court said.

The bench, however, noted it was not commenting on the merits of the allegations as it does not want the investigation to be influ-

"We do not want the investigation to be influenced by the observation of this court. The High Court (Bombay) has treated this as thus we set aside the HC verdict.

We allow the appeal and direct the probe into 5 FIRs and three PEs be transferred to CBI with all records. Such transfer to be completed within one week and all officials to extend full cooperation to CBI to try arrive at the truth," the bench said.

It also comes in the backdrop of Sonia Gandhi meeting some of the lead-

ers of the G-23 grouping, which has been critical of the party leadership and have been demanding an organisational overhaul for a long time.

Sonia Gandhi has so far held consultations and deliberations with some of the G23 leaders including Ghulam Nabi Azad, Anand Sharma, Manish Tewari and Vivek

Ever since the poll results were announced on March 10, several party leaders, other than the G23, have been expressing their concerns for the fate of the grand old party and what has to be done for revival and issues were taken just two days later at the Sonia chaired Congress Working Committee meeting during which she offered to resign from the post. The party in its CWC had already scheduled September 2022 for the election of a new party president the process of which will begin in June towards complete organizational overhaul.

AICC sources said after Saturday's meeting another round of CWC will be scheduled in a weeks time which will be followed by a Chintan Shivir either in Jaipur in Rajasthan or Raipur in Chhattisgarh, the only two State where Congress is in power on its own.

Western officials fear such a step would lead to direct conflict between NATO and Russia, which Biden described as a potential World War III. However, in brief opening remarks as the NATO summit began, Secretary-General Jens Stoltenberg said the alliance must boost its defences and "respond to a new security reality in Europe".

"We gather at a critical time for our security," he told the leaders seated at a large round table. "We are united in condemning the Kremlin's unprovoked aggression and in our support for Ukraine's sovereignty and territorial integrity." Stoltenberg said the alliance is "determined to continue to impose costs on Russia to bring about the end of this brutal war."

Over the course of Thursday, the European diplomatic capital is hosting the NATO summit, a gathering of the Group of Seven industrialized nations and a summit of the European Union. Biden will attend all three meetings and hold a news conference afterward.

Missing education

The Taliban's inhuman order doesn't allow senior Afghan girls to attend school

It is so much easier for an Afghan girl to die of hunger or sexual exploitation than attend school. The Taliban, true to their colour, have reneged on their promise to allow girls to continue with secondary and high school education. Thousands of girls who were ready to attend grade six or above on the first day of the new school year were shocked this week when told to stay home instead. It was a typical Taliban decree. "What is our crime? That we are girls?" There is nobody to hear them wail. Girls still manage to go to school till the sixth grade, though. The Taliban have not indicated when the higher classes will be open for girls. The general assumption is that the Taliban were under pressure from the rural Afghan tribes which are the backbone of the Taliban movement. These tribes provide armed fighters for the organisation. The tribals are extremely conservative, patriarchal and believe women and girls have no duties outside of their homes. One can only speculate what happens now. Will the Taliban shut the doors for senior girl students? Or will they be asked to come to school in regressive attire, covering their bodies except for their eyes? The girls are willing to even wear 'burgas'; that is

how eager they are to attend school. But the Taliban may also insist that girls should be taught only by women teachers, well aware they are scarce.

The international community had warned the Taliban last year that the recognition of their Government would depend on, among other things, women being free to return to jobs and girls to school. The latest Taliban order is inhuman and against all norms of civil society. The international community has to do more than issue statements of protest. The world must realise the true extent of gender inequality in Afghanistan. We all know

the facts; we rarely act on them. Over half of the country's girls do not attend schools because their parents or communities force them to stay home. The legal age for marriage is 16 but most girls are married off when they enter their teens. That is the primary reason why they cannot be in school. Most girls in their early teens are sexually exploited or harassed. In a country where sons are preferred, many girls die of hunger in the rural areas where development and food are a trickle. In conservative Afghanistan, they simply do not have schools for girls. After the Taliban Government was removed from power in 2001, girls began to attend schools and adopted western ideas of education and employment. However, that was largely limited to the urban and suburban areas. The return of the Taliban ended that practice. The world cannot expect girls to fight the orthodox cultural norms on their own. They do not mind their tears so long as the world pays more than in helping them go to school.

'he legal maxim 'Audi Alteram Partem' is a universally accepted doctrine in judicial parlance in all civil societies. Why 'Wahabi' Pak kills Shia Muslims



Shias are totally against Wahabi terrorism but its strain from centuries past forces its followers to obey the violent re-interpretation of true Islam

he hardcore terrorist group (un-)Islamic State's affiliate in the region, known as (un-)Islamic State in Khorasan (ISIS-K) and headquartered in Afghanistan, claimed responsibility for the devastating attack on a mosque/Imambargah in Kucha Risaldar, a predominantly Shia Muslim neighbourhood in Peshawar. The ISIS-K terrorists on March 4, 2022, attacked a crowded Shia congregation with a powerful suicide bomb in Qissa Khwani Bazar in 'Wahabi' Pakistan, when the victims were offering Friday prayers. The death toll was an instant 68, while around 300 were critically injured.

Éarlier, on August 19, 2021, Pakistani terrorists by ripping a powerful bomb in a Moharram procession had killed three Shias and wounded over 50 people in Bahawalnagar of Pakistan. On October 8 the same year, (un)-Islamic State (Daesh) terrorists struck at a mosque packed with Shia worshippers during a Friday prayer in northern Afghanistan. The United Nations mission in Afghanistan said in a tweet: "Initial information indicates more than 100 Shia Muslims killed and injured in a suicide blast inside the mosque." (In June 2015, then British PM David Cameron told BBC and other media houses: "I wish you would stop calling it ISIS (Islamic State of Iraq and Syria; now only IS) because it is not an Islamic State. It is a poisonous death cult that is seducing youth to fight for it." ISIS terrorists again on

October 16, 2021, in a deadly suicide attack on a Shia mosque in southern Afghanistan, killed 63 people and wounded scores more. After the October 8 attack, the IS-K thugs said in a statement that Shias will be targeted in their homes and strongholds by its network, whenever possible. Al-Naba, the IS group's weekly, had published this warning on October 17, reported Khaama Press. Earlier, the ISIS beasts on May 12, 2020, attacked maternity hospital in the Dashte-e-Barche area of Kabul, his gang of thugs to silence the killing 13 people including two opposing voices. Islam prohibits violence and promotes peace and justice. The Quran says: "Prophet Mohammad was sent to the world as a mercy to mankind (21:107)." It categorically states: "Allah abhors any disturbance of peace (2:205)." When there is no permission of violence in Islam, why is there worldwide terrorism in its name? The answer to this crucial question is that 50 years after the death of Prophet Mohammad in 632 AD, the true faith of Islam was hijacked by self-proclaimed caliphs to use the religion as a platform for establishing their empire with the support of the growing influence of Islam in Arabia. As a result, the true religion started getting defaced by virulent political power wielders through the might of the sword.

This devastating process mainly began by the immoral and hardcore terrorist Yazidibn-Muawia who, after subscribing to Islam outwardly with the criminal intention to capture political power, proclaimed himself as "false caliph of Islam" and leader of the "faithful" by terrorising and killing Muslims through

of Caliphate was Hazrat Imam Husain, the grandson of the Prophet, whose rightful succession was usurped by Muawia. He demanded allegiance from Hazrat Imam Husain to acknowledge him as leader of the faithful. Imam Husain refused to pledge allegiance to the criminal/murderer as the caliph. Muawia then assassinated Hazrat Imam Husain and 72 of his family members and companions mercilessly in the desert of Karbala (Iraq) in 680 AD. Muawia defaced the true teachings of religion and pseudo-Islam emerged. This was the beginning of terrorism in the cloak of Islam.

However, the current scenario of terrorism is the revival of Muawia's model of terrorism in the form of Wahabi/Salafi ideology, an offshoot of the Sunni Muslim sect. Wahabism can best be explained through the words of British historian Charles Allen, who in his book God's Terrorists — The Wahabi Cult and the Hidden *Roots of Modern Jihad*, writes: "Wahabi is the guiding ideology behind modern Islamist terrorism. In the late 18th century, a violently intolerant reinterpretation of Islam took root in the Arabian desert. Its followers became known after their founder (Sheikh Muhammad Najdi ibn Abdal-Wahab) as Wahabis." Wahabi ideology is enshrined in Kitab-al Tawhid (book of unity), which prescribes forceful conversion of Muslims and others to his Wahabi ideology wherein he manifestly says: "Follow my ideology, else get ready to be killed."

His ideology was strongly opposed by Muslim masses, especially the Shia Muslims. However, when the opposition mounted against his ideology, Najdi was shrewd enough to find a patron in Muhammadibn-Saud, a Bedouin tribal chief. Ibn Saud belonged to the Zionist tribe of Anza Ben Wael. Islam is not the original religion of Saudi Arab rulers. Sheikh Najdi, too, belonging to Zionist ancestry, not only made an alliance with Ibn Saud but also got his daughter married to Ibn Saud's son Abd-Al-Aziz Ibn Saud. Thereafter, the faith was of Sheikh Najdi and the sword was of Ibn Saud. A dynastic Government was established as a result of this partnership, which is still continuing in the name of Saudi Arabia.

Again the question arises as to why Wahabi terrorists kill Shia Muslims? The answer is that Shia Muslims are totalagainst Wahabi terrorism.

CUET IS A WELCOME STEP

Sir - Recently, the UGC and the Government have decided that only the marks of the Common University Entrance Test (CUET) will be considered for admission to the undergraduate courses in colleges under Central universities, which is really a welcome step. It will prove to be a milestone in increasing the quality of higher education. During the pandemic, there were several possibilities of discrepancies in the process of admission to colleges on the basis of marks obtained in Class XII, based on the different methods and procedures of evaluation used by different education boards. This effort to eliminate them through the CUET is a commendable step.

No student should have an objection to this. Through this entrance test, all students will get equal rights of admission, and the admission process will be completely transparent. If part of the Class XII marks percentage is included in the merit list on the basis of CUET, it will also maintain the usefulness of the class marks. But this percentage should not exceed 20. India has to keep working on its relationship with other partners amid changing geopolitics

ndia concluded a high-level meeting with two QUAD partners last fortnight. Japanese Prime Minister Fumio Kishida was in Delhi a few days back and Australia's Scott Morrison had high-level virtual meetings. India and Australia also decided to elevate their bilateral relationship to an annual summit, where both Prime Ministerswill exchange visits to supervise the progress in the relationship. After Japan and Russia, the Australian annual bilateral summit is the third India has in its bouquet of developing closer relations with like-minded partners. It is worthwhile mentioning that Japan and Australia form the foundational pillars of the QUAD framework and are geographically located in the Indo Pacific, where the next theatre of supremacy is playing out. India has done well to highlight to both QUAD partners its priorities in the Indo-Pacific. An aggressiveChina, gobbling up or creating new military bases in the Indo-



Pacific, threatening sovereign rights of nations such as Taiwan and encroaching in India's territory and neighbourhood besides militarily monitoring the sea routes, with least concern for globally accepted rulesbased world order, are shared regional concerns for India, Japan and Australia. Australia knows it has to depend on regional allies and partners if it wants to take on China in its backyard. Its defence alliance with Japan also known as the Reciprocal Access Agreement (RAA) assumes significance in this context. Australia has also recently entered into a military alliance with the US and the UKwhich provides it access to nuclearcapable submarines. There are many lessons for Indian policy makers in India to learn. First, the US-centricity of the regional order is shrinking fast. Japan, which has traditionally relied on the US for its security needs, is willing to pick up the gauntlet and lead in the region. A signal has been sent to smaller economies in the region that Japan will stand up against Chinese aggression and establish a rules-based regional order. as an empowered independent player. Similarly, Australia with its bitter experiences with China has quickly gone ahead to forge new trade and securitypacts with major partners in Europe, the US, the UK, India and Southeast Asia. China, meanwhile, has announced a "no barriers" friendship with Russia. As the world order reshapes, post-Ukraine crisis, and a hardening of stances by NATO, the situation for Russiaappears unfavourable. The bite of western sanctions, together with frosty diplomatic and strategic relationships on world platforms, will make Russia more dependent on China. This could also mean India landing in embarrassingpositions when the Russia question comes up. India at this stage will have to calculate its security interests to suit its strategic and economic goalposts. Except for severe dependence on Russia formilitaryequipment, India doesnot have any significant ties with Russia. Over four decades of close bonding between Russia and India, where each side chose not to step into each other's sensitive spots on international fora, may be a ghost of the Cold war once the entire fallout of the Ukraine invasion playsout. India will have to carefully calibrate its place in the changing geopolitics and choose its partners. India and US have a strategic partnership for nearly a decade now. However, India's unwillingness to take a hard stance on Russia publicly could make several lawmakers in the US questionthe foundations of the relationship. The world, despite ideological differences, cannot ignore the US and its strategic importance as a large superpower. India has to keep working on its relationship with the USfor a free,open, transparent, rules-based order in the Indo-Pacific. Separate bilateral agreements with QUAD partners such as Australia and Japan would also help.

Self-reliance must in global payments



After the Russian example, we should not be subject to the whims of other countries in payments. For this, it is necessary to achieve self-reliance

rime Minister Narendra Modi has recently said that self-reliance is the best-suited strategy to deal with situations arising out of the Russia-Ukraine war. With regard to the ongoing war between Russia and Ukraine, some people believe that if this war goes on like this and Ukraine's friends, such as the United States of America and European countries join this war, then this war may head towards the World War III. But apart from this concern, there are many other concerns in India and the rest of the world. Given these apprehensions, Prime Minister Narendra Modi has called for selfreliance as a strategy.

It is noteworthy that Russia is the third-largest producer of crude oil of the world; and if supply of crude oil is blocked by way of sanctions, the prices of crude oil in the world may increase further. Currently, amidst fluctuating oil prices, Russia has offered to supply oil to India at 25 percent discount. India has also accepted this proposal and import of crude oil has already started. But the road to importing oil from Russia is not easy. Though the US has said for the time being that this import of crude oil by India, doesn't violate sanctions, the issue of payments continues to be an area of concern. In this context we need to ensure that nothing comes in way of cheaper import of oil by India, to keep away oil price inflation in the country.

The US and European countries

have blocked Russian banks from the international payment gateway, SWIFT, used in global financial transactions. Finding a solution to this problem, India and Russia have decided that they will settle their transactions in Rupees and Rubbles, that is, India will not only buy oil 25 percent cheaper, but payment for that oil will be made in rupees.

The question is, what will be the impact of blocking of SWIFT on India and the world? With the blockade of SWIFT, India and the world will have to create alternative payment systems. Payment can also be made through China's payment system called the Cross Border Interbank Payment System (CIPS). However, India and Russia have decided to exchange in Rupee-Rouble. On the other hand, Indian banks can do business with Russia by registering with CIPS uses the RMB as currency, it would be good for India to create an alternative payment system which is based on Indian Rupee.

One of the options for India is to integrate its UPI payment system with Russia's MIR system to make payments easier. Russian banks can open their accounts with the Reserve Bank of India and where Russian banks can keep deposits of Indian rupees. foreign exchange reserves. India has already started diversifying its foreign exchange reserves and today we are keeping our reserves in many other currencies including gold, dollars, euros etc.

Since the world's trade is dominated by dollars and dollars are kept only in American banks, because the sovereign currency of any country can be kept only in the banks of that country. For instance, euros can be kept in European banks, dollars in American banks, yuan in Chinese banks and Indian rupees in Indian banks only. Nostro account is opened for mutual transactions, owned by residents of another country. It would be useful for India that India should have its own payment system which is based on Rupee.

Countries on which economic sanctions have been imposed, finding it difficult to sell their goods, are ready to sell goods cheaper than the market to India. Due to the war, oil prices in the omy including defence goods, international market have electronics, telecom, chemicals, only Russia but also Iran is ready to sell oil at cheaper prices and on our terms (in exchange for payment in rupees). For imports from such countries, we can make payments in our currency under the barter system. But we have trade deficit with many countries,

so barter is not always practical. For a more viable payment system, we can create linkage between our payment system (UPI) and payment systems of dif-

ferent countries, and can circumvent SWIFT system under the influence of USA and European countries. For example, India can establish self-reliance in international payments by establishing a linkage with the payment systems of other countries including Russia's Mir payment system and China's payment system.

Not only this, nowadays the trend of digital currency has also increased. However, due to the huge fluctuation in the value of private cryptocurrencies, it would not be advisable to use them for payments. India has recently decided to launch its own digital currency through our central bank, that is, the Reserve Bank of India. This is called Central Bank Digital Currency (CBDC). Experts believe that international payments can also be possible through use of this digital currency.

Today, when India is moving forward towards the goal of selfreliance in all spheres of the econto international payments, we should not be subject to the whims of countries like the US and Europe in payments also.For this it is necessary to achieve selfreliance in international payments as well. This we will have to achieve by any means. Whatever the process, whether barter or linking of different payment systems or use of digital currency, we will have to achieve self-reliance in payments.

fter independence, due to inadequate irrigation infrastructure, there was consistent shortage of food grain that used to aggravate in drought years. In the 1960s, green revolution was pursued. In 1965, Food Corporation of India (FCI) was incorporated for storing buffer stocks. To incentivise higher production, in 1965-66, Minimum Support Price (MSP) was introduced. As a result, India became surplus inwheat and rice production. Thereafter, open market prices couldnot keep pace with other industrial products. Food grain exports were highly restricted. Russian war in Ukraine marks 1 month with no end in sight

Russia's war in Ukraine since February 24 has killed thousands of people, reduced entire cities to rubble and forced millions to flee their homes

The largest military conflict in Europe since World War II has also upset the international security order and sent dangerous ripples through the global economy.

A look at pivotal moments

THE ROAD TO WAR

A buildup of Russian troops near Ukraine in early 2021 raised fears of an offen-

Moscow withdrew some of the forces in April, paving the way for a June summit between President Joe Biden and Russian President Vladimir Putin. Their meeting, however, failed to meaningfully ease Russia-US tensions.

A renewed buildup of Russian troops along Ukrainian borders began in late October and reached an estimated 150,000 troops by the year's end.

From the beginning of the troop surge, Moscow denied any plans to attack Ukraine, calling such Western concerns part of a campaign to discredit Russia

At the same time, it urged the US and its allies to keep Ukraine from joining NATÔ

from Eastern Europe, demands the West rejected as non-

Putin on February 21 this year abruptly upped the ante, recognising the independence of pro-Russia rebel regions in eastern Ukraine.

Insurgents have been fighting Ukrainian forces there since 2014, when Ukraine's Moscow-friendly president was driven from office by mass protests and Russia responded by annexing the Crimean

INVASION BEGINS

In a televised address on February 24, Putin announced the launch of a "special military operation" intended to demilitarise Ukraine and uproot alleged "neo-Nazi nationalists".

As he spoke, the Russian military unleashed a series of air raids and missile strikes on Ukraine's military facilities and key infrastructure.

Russian troops rolled into Ukraine from Crimea in the south, all along the eastern border and from Moscow's ally Belarus, which borders Ukraine from the north.

Putin argued that Russia had no choice but to act after Washington and its allies ignored its demand for security guarantees. Western leaders dismissed the claims as a false pretext for the attack.

The Russian military advanced on the Ukrainian



US to welcome up to 1L refugees from Ukraine

capital Kyiv, located just 75 kilometres south of the border with Belarus, closed in on Ukraine's second-largest city of Kharkiv in the east and pushed along the Sea of Azov and Black Sea coasts in the south.

While Russia claimed it was only targeting military facilities, air raids and artillery strikes hit residential areas, schools and hospitals across Ukraine.The assault turned particularly deadly in March, with a Russian rocket hitting the regional administration building in Kharkiv on March

1, killing 24 people. On March 9, a Russian airstrike devastated a maternity hospital in the besieged port of Mariupol, killing at least three and injuring 17.

A Russian bomb on March 16 flattened a historic theatre in Mariupol, even after Ukrainians had scrawled the word "children" in huge white letters on the pavement next to it to indicate that civilians were sheltering inside.

Officials said hundreds of people who were hiding in the basement survived.

N Council defeats Russia resolution on Ukraine

he UN Security Council on I Wednesday overwhelmingly defeated a Russian resolution that acknowledged Ukraine's growing humanitarian needs -- but didn't mention the Russian invasion that caused the escalating crisis which has left millions of Ukrainians in desperate need of food, water and

To be adopted, Russia needed a minimum of nine "yes" votes in the 15-member Security Council and no veto by one of the four other permanent members - the U.S., Britain, France and China.

But Russia got support only

from its ally China, with the 13 other council members abstaining, reflecting Moscow's failure to get widespread backing for its war in Ukraine, which marks its onemonth anniversary Thursday.

The Russian defeat came on the same day the General Assembly started considering a resolution drafted by Ukraine and two dozen other countries and co-sponsored by nearly 100 nations which clearly states that Russia's aggression is responsible for the growing humanitarian emergency.

The assembly was also to consider a rival South African resolution that doesn't mention Russia and is similar to Moscow's defeat

ed council resolution. Action on those resolutions was delayed until Thursday because of the huge number of speakers.

Russia's U.N. Ambassador, Vassily Nebenzia, told the council before the vote that its resolution "is not politicized," just like other Security Council humanitarian resolutions, and he categorically rejected a U.S. Claim that his country had no right to submit such a resolution. U.S. Ambassador Linda

Thomas-Greenfield countered that Russia was "attempting to use this council to provide cover for its bru-"It really is tal actions." unconscionable that Russia would

have the audacity to put forward a resolution asking the international community to solve a humanitarian crisis that Russia alone created," she said.

"Russia does not care about the deteriorating humanitarian conditions. ... If they cared, they would stop fighting. Russia is the aggressor, the attacker, the invader, the sole party in Ukraine engaged in a campaign of brutality against the people of Ukraine, and they want us to pass a resolution that does not acknowledge their culpability.'

Nebenzia took the floor again after the vote saying it exposed all countries "for whom politicisation of the humanitarian dossier" is more important than helping to get aid to Ukrainians. If diplomats go on to lament the lack of a ceasefire and provisions for evacuations, "we will remind you that they were before you, but you refused to vote in favor of them for political reasons," he said.

Chinese Ambassador Zhang Jun, explaining his country's vote in favor of the Russian resolution, said council members should focus on humanitarian issues, "transcend the political differences" and try to reach consensus and "respond to the humanitarian crisis in a positive, pragmatic and constructive manner

Biden, Western allies open 1st of 3 summits on Russian war

US President Joe Biden and world leaders opened a trio of emergency summits on Thursday with a sober warning from NATO Secretary-General Jens Stoltenberg that the alliance must boost its defences to counter Russia's invasion of Ukraine and "respond to a new security reality in Europe."

Stoltenberg commented as he called to order a NATO summit focused on increasing pressure on Russian President Vladimir Putin over the assault on Ukraine while tending to the economic and security fallout spreading across Europe and the world.
"We gather at a critical time for our

security," Stolenberg said, addressing the leaders seated at a large round table. We are united in condemning the Kremlin's unprovoked aggression and in our support for Ukraine's sovereignty and territorial integrity." He said the alliance is "determined

to continue to impose costs on Russia to bring about the end of this brutal

Over the course of Thursday, the European diplomatic capital is hosting the emergency NATO summit, a gathering of the Group of Seven industrialized nations and a summit of the European Union. Biden will attend all three meetings and hold a news conference afterward.

The schedule left Brussels interlaced with multiple police checkpoints and road closures to help motorcades crisscross the city as the leaders go from one meeting to the next.

Biden arrived late Wednesday with the hopes of nudging allies to enact new sanctions on Russia, which has seen its economy crippled by several weeks of bans, boycotts and penalties.

While the West has been largely unified in confronting Russia after it invaded Ukraine, there's wide acknowledgement that unity will be tested as the costs of war chip at the global economy. The bolstering of forces along NATO's eastern flank, almost certainly for at least the next five to 10 years if Russia is to be effectively dissuaded, will also put pressure on national

Ukraine refugees' hopes of return waning

s Russia launched its war in Aukraine last month, exhausted and frightened refugees arrived in neighboring countries. They carried whatever they could grab in a hurry. Many cried. They still do.
The United Nations says

that more than 3.6 million people have fled Ukraine since the war started exactly one month ago Thursday in what is the biggest movement of people in Europe since World War II. Unprepared, most refugees believed they would soon be back home. That hope is waning now."At the beginning, we thought that this would end pretty soon," Olha Homienko, a 50-year-old woman from Kharkiv said. "First of all, nobody could believe Russia would attack us, and we thought that it would end quickly." Now, Homienko said, "as we can see, there is nothing to look forward to." Homienko's hometown of Kharkiv is among several Ukrainian cities and towns that have been encircled and shelled heavily by the Russians.

Ukraine to press world for more support

Ukrainian President Volodymr Zelenskyy called on people worldwide to gather in public Thursday to show support for his embattled country as US President Joe Biden and other world leaders met for talks focused on pressuring Russia to end the invasion that is entering its second month.

"Come to your squares, your streets. Make yourselves visible and heard," Zelenskyy said in English during an emotional video address late Wednesday that was recorded in the dark near the presidential offices in Kyiv. "Say that people matter. Freedom matters. Peace matters. Ukraine matters?

"This is a month now," Zelenskyy said Thursday in an address to Sweden's parliament, the latest of many to whom the Ukrainian leader has pleaded for help. "We have not seen a destruction of this scale since World War II."

After a month of fighting, Western analysts say Ukrainian forces need stocking up again with the weapons that have helped them slow and repel Russian advances. Both sides claimed Thursday to have inflicted more blows. Ukraine's navy said it sank a ship that had been used to resupply the Russian campaign with armored vehicles. Russia claimed to have taken a town, Izyum, in eastern Ukraine after heavy fight-

Islamic extremist rebel group, claimed responsibility for the attack. The 15 people killed were "mostly civilians" and the attack wounded "an unspecific number" of people, police officer Ahmed Hassan told AP by phone.

"I was at a walking distance to the polling station when a suicide bomber rushed towards the member of parliament Amina and embraced her and

Dhaqane Hassan said. "Shots were fired in the air by the soldiers who seemed shocked, but unfortunately she instantly died at the scene. Abdi, the legislator killed

at a polling station, was in Beledweyne campaigning for re-election in a vote expected to take place this week. "Somalia has lost a promis-

ing giant leader, an activist, a fearless advocate who finally paid the ultimate price for seeking justice for Ikram Tahlil," said lawmaker Abdirizak Mohamed, speaking of a female intelligence officer whose killing Abdi had been

trying to investigate.

Searchers find wing, engine parts from China Eastern crash

Pumps were being used to drain a water pond as an off-and-on light rain hampered the search effort for a second straight day. More than 300 searchers

were taking part, said Huang Shangwu, a deputy chief in the Guangxi Fire and Rescue Department.

Sensex, Nifty decline for 2nd day as banking, auto stocks retreat

Mumbai: Benchmark stock indices Sensex and Nifty closed lower in highly volatile trade on Thursday due to selling in banking, auto and FMCG stocks amid a weak trend in global equity markets.

Extending losses for a second day, the 30-share BSE Sensex ended down by 89.14 points or 0.15 per cent at 57,595.68. During the day, it touched a low of 57,138.51 and a high of 57,827.99.

The broader NSE Niftv dipped 22.90 points or 0.13 per cent to settle at 17,222.75 as 27 of its components declined and 22 advanced.

"The market now lacks direction and is moving up or down on a daily basis responding to news regarding crude price, FPI flows and speculation on what the Fed might do in the coming policy meets," said VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services.

'Sensex and Nifty ended a volatile session with losses amid heightening volatility due to surge in global crude oil prices and prospects of the US Fed raising interest rate," Mohit Nigam, Head - PMS, Hem Securities, said.

From the 30-share pack, Kotak Mahindra Bank fell the most by 3.09 per cent, followed by Titan which declined 2.63

HDFC Bank dropped 2.23 per cent, ICICI Bank by 1.94 per cent, and HDFC by 1.5 per cent. Mahindra & Mahindra fell by 1.31 per cent and Maruti

Suzuki India by 1.17 per cent. IndusInd Bank, Hindustan Unilever Limited, Nestle, Axis Bank and State Bank of India were also among the losers.

In contrast, Dr Reddy's Laboratories rose the most by 4.9 per cent, UltraTech Cement 1.77 per cent, and Tech

'All eyes are on the outcome of the NATO summit as it could provide the direction to the lingering Russia-Ukraine tension. Indications are in the

favour of further consolidation in the index however the prevailing underperformance from the banking pack is denting sentiment," Mishra said.

US President Joe Biden and world leaders opened the first in a trio of summits in Brussels focused on pressuring Russia to end its war in Ukraine.

In the broader market, the BSE midcap index gained 0.34 per cent, while smallcap gauge went higher by 0.16 per cent.

Rupee rises 6 paise to 76.33 against US dollar

Mumbai: The rupee appreciated 6 paise to close at 76.33 against the US dollar in a restricted trade on Thursday, as investors assess the global economic impact of the Russia-Ukraine conflict amid elevated global crude oil prices to find a decisive direction.

A weak trend in domestic equities and strengthening US dollar in the overseas market capped the gains in the domestic unit, forex traders

At the interbank forex market, the local unit opened slightly up at 76.37 against the greenback. During the session, it moved in a tight range of 76.24 and 76.41.

The rupee finally settled at 76.33, a rise of 6 paise over its previous close.

IOC, BPCL, HPCL lost USD 2.25 bn over fuel price freeze: Moody's

New Delhi: India's top fuel retailers IOC, BPCL and HPCL ue to average around USD 111 a barrel, the three rated entities have together lost around USD 2.25 billion (Rs 19,000 crore) in revenue between November and March by keeping petrol and diesel prices unchanged despite a sharp rise in crude oil prices, Moody's Investors said Service Thursday.

Petrol and diesel prices remained unchanged between November 4, 2021, and March 21 despite prices of crude oil (raw material for producing fuel) averaging around USD 111 per barrel in the first three weeks of March compared to around USD 82 in early

State-owned Indian Oil Corporation (IOC), Bharat Petroleum Corporation and Petroleum Hindustan Corporation (HPCL) on March 22 and 23 raised petrol and diesel prices by 80 paise per litre each but paused the increase on Thursday.

"Based on current market prices, the oil marketing companies are currently incurring a revenue loss of around USD 25 (over Rs 1,900) per barrel and USD 24 per barrel on sale of petrol and diesel, respectively," Moody's said in a report. If crude oil prices contin-

IOC, BPCL and HPCL - will incur a combined daily loss of around USD 65-70 million on the sale of petrol and diesel unless fuel prices are increased to cover the rising crude oil prices, it said. "Based on our estimates of

average sales volume between November and first three weeks of March, the state-owned refining and marketing companies together have lost around USD 2.25 billion in revenue on petrol and diesel sales, Moody's said.

This equates to around 20 per cent of the combined FY2021 EBITDA for the three

The rating agency estimated that IOC's revenue loss to be around USD 1-1.1 billion while that of BPCL and HPCL to be about USD 550-650 million over the same period

This loss in revenue will add to the short term borrowings, funded with working capital lines, of the refiners until such time that crude oil prices stay at elevated levels. Over time, the companies might be able to make up for some of these losses if oil prices come down," it added.

Fuel prices rise due to hike in int'l mkt: Puri

Petroleum Minister Hardeep Singh Puri on Thursday sought to defend the Government over the steep rise in the fuel prices saying it is due to the increase in its prices in the international market. On another issue, the Ministry of Minority Affairsinformed the Lok Sabha that the government was waiting for Saudi Arabia's signal for 'Haj' to happen this year.

On the matter of price rise Congress MP Sashi Tharoor pointed out to the government that it has not reduced tax on oil to bring down the fuel

Puri assured that efforts are being made to make fuel available to people at "affordable prices".

Replying to a question in Lok Sabha, the minister said the prices of LNG in the international market has gone up by "more than 37 per cent" if compared from April 2021 to February 2022, because of "an unsettled condition and military action in one part of the world following the Covid cri-

"Whereas, our increase at

the bunk has been only five per cent," he told the House during Question Hour.

As for the LPG price, which is based on Saudi CP (Contract Price), the hike has been 37 percent in the last six

months alone, he said. "So, I just want to place these facts before the members and this august House, so that they understand what the international situation today is," he

The government is making "every effort to make sure that the consumer at the point of consumption gets fuel at an affordable price", he sought to

10 wrestlers barred from national trials, Geeta Phogat out with injury

Cending out a stern message Sthat indiscipline will not be tolerated, the Wrestling Federation of India has barred 10 women wrestlers, including U-23 World Championship Bronze medallist Nisha Dahiya and a few youngsters, from competing in the trials for the

upcoming Asia Championship.
The barred wrestlers either did not report for the national camp in Lucknow or left after just two days, making excuses. The camp began on February 9.

The Asian Championship is scheduled to be held in Mongolia from April 19-24 and the trials for women wrestlers are scheduled for Friday at the SAI Centre in Lucknow.

The wrestlers in question, including Nisha, who competes in 65kg category, requested to be let off but the WFI did not budge. Nisha was in the news recently when the report of her murder in Haryana emerged, which turned out to be fake.

Other wrestlers who have been kicked out of the national camp are Honey Kumari (50kg), Ankush (53kg), Anju (55kg), Raman (55kg), Geeta (59kg), Bhateri (65kg), Priyanka (65kg), Naina (68kg) and Pooja (76kg).

Bhateri, Anju and Honey also sought permission from the WFI to compete in trials but the federation put its foot down. The celebrated Geeta Phogat, who recently made a

comeback during the National Championship in Gonda, has reported an injury. Missing out on this opportunity is a huge loss for Anju,

who is coming up nicely and opening up an option in the cat-egory of star wrestler Vinesh Since Sonam Malik is still unfit and Bhateri and Priyanka

are barred from trials, the road has become easier for struggling Sakshi Malik to book her slot in the Indian team in 65kg. "We will ask for an explana-

tion from the wrestlers why are they not taking national camp seriously. Missing out on a chance to compete in a tournament like Asian Championship will certainly teach them a lesson," WFİ President Brij Bhushan Sharan Singh told PTÍ on the sidelines of the men's trials at the IG stadium here.

"Our second line is pretty strong, so we can take these tough steps to ensure discipline at the national camp. We don't want to hurt chances of good wrestlers but they need to understand that they can't take things for granted," he added.
The federation believes that

more than the wrestlers, their personal coaches are responsi-ble for the mess.





Ravindra Jadeja.

"Dhoni will continue to represent Chennai Super Kings this season and beyond," the franchise added.

Dhoni, 40, who had announced his international retirement on August 15, 2020, had led CSK to their fourth title last season.
