MLAs exchange blows Criminal Identification Bill in Bengal Assembly

Demand for discussion on Birbhum carnage stirs row, 5 BJP MLAs suspended for ruckus

SAUGAR SENGUPTA KOLKATA

War of words degenerated into fisticuffs inside the Bengal Assembly with the Trinamool Congress and BJP legislators on Monday exchanging blows over the Birbhum burning and mass murder case that left eight people dead last week. Another woman who sustained 65 per cent burn succumbed to her injuries on Monday morning taking the official toll of the dead to nine

A number of MLAs from both sides reported injuries in the scuffle in the Assembly. But TMC legislator Asit Majumdar had to be hospitalised with broken nose allegedly given to him by Opposition leader Suvendu Adhikari

The incident started when Adhikari demanded discussion over the Rampurhat violence and Speaker Biman Benerjee turned the request. Soon slogan-shouting BJP MLAs assembled near the Speaker's chair demanding Chief Minister Mamata Banerjee's statement in the House. The treasury bench too jumped into the melee



Even as the two sides jostled — with the marshalls trying to separate them — blows started raining and Majumdar, an MLA from Hooghly district, suffered a blow on his nose. His spectacles broke and he was rushed to hospital and was admitted to the woodburn ward of the state-of-the-art SSKM Hospital.

"Being a senior man, I was requesting the two sides to calm down when Adhikari hit me and broke my glass and nose," Majumdar told the media with his nose bleeding.

However, Adhikari who

along with other senior leaders took out a massive rally of the BJP supports in North Kolkata said he was only trying to pacify to the two sides and had in fact escorted his party men out of the House.

He alleged Government pushed in policemen in civil dress and made them manhandle us ... Had I not taken my MLAs out we would have been badly injured considering the past record of the TMC leaders and their party men.

BJP MLA Manoj Tigga later complained that he had been beaten up by the TMC

Later, the Speaker suspended Adhikari and four other BJP MLAs, including Manoj Tigga, Shankar Ghosh, Narahari Mahato, and Dipak Mahato for "misconduct".

Opp slams it as unconstitutional

The Government on Monday introduced in the Lok Sabha the Criminal Procedure (Identification) Bill which seeks to amend an Act dating back to 1920, providing legal sanction to the police to take physical and biological samples of convicts, people arrested for heinous crime and for offences committed against women and children.

The Opposition parties alleged that it violates fundamental rights as well as human rights of individuals.

Another Bill to amend the list relating to Scheduled Castes and Scheduled Tribes of Uttar Pradesh which seeks to shift certain Scheduled Castes to Scheduled tribes categories was passed in the Lok Sabha.

The Bill has sought for the inclusion of Gond, Dhuria, Nayak, Ojha, Pathari and Rajgond communities living in the districts of Sant Kabir Nagar, Kushinagar, Chandauli and Sant Ravidas Nagar in the list of Scheduled Tribes in the

Union Minister of State Ajay Mishra 'Teni' introduced the Criminal Procedure (Identification) Bill, rejecting the apprehensions voiced by the Opposition members and affirmed that the move was



He pointed out that the existing law Identification of Prisoners Act dated back to 1920 and allowed taking only finger print and foot print impressions of a limited category of convicted

The Bill seeks to cover, "Any person, who has been, (a) convicted of an offence punishable under any law for the time being in force; or (b) ordered to give security for his good behaviour or maintaining peace under section 117 of the Code of Criminal Procedure, 1973 for a proceeding under Section 107 or Section 108 or Section 109 or Section 110 of the said Code; or (c) arrested in connection with an offence punishable under any law for the time being in force or detained under any preventive

detention law, shall, if so required, allow his measurement to be taken by a police officer or a prison officer in such manner as may be prescribed by the Central Government or the State Government: Provided that any person arrested for an offence committed under any law for the time being in force (except for an offence committed against a woman or a child or for any offence punishable with imprisonment for a period not less than seven years) may not be obliged to allow taking of his biological samples under the provisions of this section".

At the same time, the Shiromani Akali Dal, which had already opposed the move a day before as a "violation of the spirit of Punjab Reorganisation Act", on Monday requested Mann to call an all-party meeting to approach the Centre to stop its efforts to make Chandigarh a permanent UT.

Shah, during his Chandigarh visit on Sunday, had announced that the UT Administration's employees will now come under the Central Civil Services rules. Currently, Chandigarh employees are working under the Punjab Service Rules.

Though the decision is expected to bring big gains to the UT employees, like enhancement in their retirement age, and two-year childees, among others, the move BJP-led Central Government for the dictatorial and anti-Punjab decision to take over Punjab's claims

Society fees leave high-rise residents high & dry

Thousands of residents living in high-rise apartments across Delhi and NCR have claimed they are being fleeced by realtors and caretakers of societies in the name of maintenance cost.

"Earlier, I was paying a rent of ₹7,000 in Delhi but after investing my life's savings here, I am paying ₹4,000 as maintenance charges, including fixed meter, diesel generator and inflated bill for electricity usage every month. As I have to pay a whopping ₹22,000 per month as EMI for my flat, I am left with nothing. And I was better off in my rented accommodation," said Ekansh Desaur, a resident of Stellar One society in Noida Extension.

Hardship faced by Ekansh is just the tip of the iceberg as residents of almost all the skyscrapers have similar problems to narrate.

The Pioneer visited many of the societies to speak with

Another resident of the Amrapali Princely Estate, Dudani, said, "Maintenance of three bedroom-hall flat is around ₹2,100 per month but if you fail to pay this on the due date, the maintenance department starts knocking on your doors, pestering you with calls and might even threaten you. They say they will cut the electricity of your flat. They even charge late fee on per day basis. This is sheer harassment and should be stopped." He said service of the society is very bad. "If there is any

problem of water or electricity in the flat, we have to call the maintenance department again and again, but they show up according convenience. Sometimes we have to

manage our time according to the maintenance department as they tell us we can only visit at this time or your work will be done afterwards," he said. A resident of Gardenia Glory, Noida sector 46, who did

not wish to be named, said they

live in a three bedroom-hall fla

and their maintenance amount of the flat is ₹4,100 per month. The facilities provided by the society are disgrace, as guards of the society are old and lazy. And according to the need of residents, there is shortage in housekeeping staff. If we call the maintenance department for any work like plumbing, etc, they make us wait for hours, sometimes for days and after that they try to make extra money by lying about the work and telling that this thing is not working, I will get you a new one it will cost this much extra which you have to pay.

India to see high-profile visits

Amid Ukraine crisis UK Foreign Secy. Russian Foreign Min to come to New Delhi

As war is continuing in Ukraine, India will see a series of high-profile visits in the next few days starting with British Foreign Secretary Elizabeth Truss and then Russian foreign minister Sergei Lavrov. It will be the first visit by a senior Russian minister to New Delhi since war began in late February.

India, so far, has abstained from voting against Russia in the United Nations Security Council and the United Nations General Assembly(UNGA)on the issue. Israel Prime Minister Naftali Bennett has tested positive for corona days ahead of a scheduled visit to India to mark the 30th anniversary of diplomatic relations. His scheduled visit is from April three to day tour to hold talks with Prime Minister Narendra Modi. The visiting dignitary will also visit Varanasi.

The two leaders will review the current status of their long standing historical ties and explore ways to further enhance co-operation in the fields of power generation, connectivity, people to people contact and trade. The British Foreign Secretary will visit India on Thursday and is likely discuss the ramifications of the Ukraine conflict with her Indian counterpart S Jaishankar.

Announcing the visit, the Ministry of External Affairs (MEA)on Monday said Truss will hold consultations with Jaishankar on bilateral, regional and global issues of mutual

Last few weeks have seen a flurry of visits to India of several Western leaders, including the foreign ministers of Austria, Greece and US Under Secretary of State for Political Affairs."The visit will also serve to further

various sectors such as trade and investment, science, technology and innovation, defence and security, climate cooperation, education and digital communications," the ministry said in a statement in reference to UK minister's visit.

She will also participate in the inaugural edition of the India-UK Strategic Futures Forum, a track 1.5 Dialogue between the two countries. The relationship was elevated to a Comprehensive Strategic Partnership in May last year during the virtual summit between Prime Minister Narendra Modi and his British counterpart Boris Johnson.

In the summit, the two sides adopted a 10-yearroadmap to expand ties in the key areas of trade and economy, defence and security, climate change and people-to-people connections, among others. This will be the second visit of the UK Foreign Secretary to India since the virtual summit. Her visit will also provide an opportunity to assess the progress on the 'Roadmap 2030'. Russian visit Delhi later this week sources said. Lavrov is likely to focus on strategic issues resulting from the war, as well as specific discussions on purchasing Russian oil, payment mechanisms and sanctions against Russian banks with Jaishankar.

The two sides are also likely to review any possible impact on the unhindered supply of weapons systems. They include the ₹50,000 crore S-400 missile system and production of AK -203 assault rifles in India. This deal is worth over Rs 7,000 crores.

The government indicated in Parliament last week that it is considering offers of discounted Process 2.1. counted Russian oil and a special inter-ministerial group headed by the Finance Ministry is looking into the payments issues for Indian importers and exporters that arise fromwar and Western sanctions. Mexican Foreign Minister Ebrard will be in Delhi mid-week as well, while Israeli Defence Minister Benny Gantz will arrive ahead of Israel Prime Minister Bennet's visit next Sunday.

19-year-old DU student injured after rock slab falls on her foot

SpiceJet flight collides with pole at IGIA

lightning pole in the apron area of the airport. The flight was headed to Jammu from IGI airport at 9.30 am before its right wing hit the pole, damaging the aileron - a hinged part on the trailing end of the wing that helps steer the plane. The aircraft had to return to the bay.

In a statement, a SpiceJet spokesperson said, "On March 28, 2022, SpiceJet flight SG 160 was scheduled to operate between Delhi and Jammu. "During push back, the right wing trailing edge came in close contact with a pole, causing damage to aileron. A replacement aircraft has been arranged to operate the flight,"

NSE case: Delhi court allows CBI to collect handwriting samples of ex-CEO

Ayush Ministry hailed for innovative measures

Parliamentary panel has Alauded the Union Ayush Ministry for initiating a string of innovative measures including emphasis on integration of traditional alternative medicines in the National Health Mission (NHM) and establishing the system with growing numbers of people reposing their faith in its efficacy.

'The Committee appreciates that the National Health Policy (NHP) 2017 had strongly advocated mainstreaming the potential of AYUSH within a pluralistic system of Integrative healthcare and reemphasizing the need for integrating AYUSH in the National Health Mission, research and education," said the panel headed by Rajya Sabha MP Ram Gopal Yadav. However, the panel in its

report submitted in Parliament recently, felt that given that the percentage of budgetary estimate with respect to GDP has been gradually increasing with 0.009 percentage in 2016-17 to 0.015 per cent in 2022-23, realization of the vision of Ayush sector contributing to 7.7 per cent of GDP by 2047 seems to be a distant dream. Hence, the Ministry should

systematically move ahead for strengthening the Ayush system through a series of measures that need to be undertaken....must be adequately funded and schemes meticulously executed so as to realize the full potential of Ayush Systems, said the panel. The importance of Ayush Systems, particularly in Covid times, is highly appreciated with rising popularity of these systems and their increasing 8 acceptability as an economical and effective system of medicine, the panel added Talking about the targets

under the National AYUSH Mission (NAM), the panel said that the mechanism envisages better access to AYUSH services through increase in number of AYUSH Hospitals and Dispensaries, ensure availability of AYUSH drugs and trained manpower. The parliamentary committee also took note of the fact that as per the NAM, there is a paradigm shift in the recent past in the approach from disease management towards achieving wellness.

The AYUSH systems advocate holistic wellness approach aiming at prevention of diseases and promotion of health wellbeing. Government has kept target to upgrade 12,500 Health and

Wellness Centres (HWCs) through States/UTs in Centrally Sponsored Scheme mode and under the broad umbrella of National AYUSH Mission (NAM) in a phased manner by 2023-24 with a financial outlay of ₹3399.35 crore.

The Committee has been given to understand that the Ministry had projected a demand of ₹800.00 crore for NAM and it is heartening to see that it has been allocated the same amount in BE 2022-23. The Committee is pleased to note that demand for enhanced funds was due to demand of States/UTs for strengthening Ayush health facilities in their respective States/UTs.

Stating that the 36 States/UTs, a total of 487 Ayush Co-located facilities are at District Hospitals level, 2811 at CHCs level and 7452 at PHCs level, the panel noted that, "Maximum number of AYUSH co-located facilities are in Odisha and Uttar Pradesh. It is also noted that Arunachal Pradesh, Assam and Kerala have NIL Ayush Co-located facilities at all the three levels of District Hospitals, CHCs and PHCs. Bihar has AYUSH colocated facilities only at District Hospitals level while Gujarat has co-located facilities only at

PHCs level.

The RAN was set up to provide financial assistance to patients, living below the poverty line and who are suffering from major life-threatening diseases, to receive medical treatment at any of the super speciality hospitals or institutes or other Government

the MPs wrote to Modi, seeking an urgent meeting with him about saving the lives of several young patients, diagnosed with life-threatening rare disease conditions, classified under Group 3(a) in the National Policy for Rare 'We would like to seek a

meeting with you urgently to discuss the life threatening risks that many of the young patients, primarily children, are facing and the impending loss of lives due to the lack of immediate support for their treatment," the letter read.

The MPs noted that despite

several pleas to extend the Umbrella Scheme of RAN as a special, one-time provision for treatment of these patients before March 31, 2022, these patients and their caregivers have been left with no option but to wait for the inevitable. The members expressed

concern that the non-utilisation of the budgetary allocation under RAN before March 31, 2022, would not only lead to a fund lapse, but also deprive many of these eligible patients from seeking life-saving treatment to their conditions, for which the Drugs Controller General of India (DCGI) The group includes Congress MPs Vandana Chavan and Fauzia Khan and RJD MP Manoj Kumar Jha, among others.

Hindus as minorities: SC gives **Centre 4-week time on PIL**

'Hindus in minority in 10 States'

The Supreme Court on Monday granted four weeks to the Centre to respond to a plea, which has sought directions for framing of guidelines for identification of minorities at the State level, contending that Hindus are in minority in 10 States. A bench of justices S K Kaul and M M

Sundresh posted the matter for hearing on May 10 and asked the Union of India to place its stand on record on a plea filed by advocate Ashwini Kumar Upadhyay.

At the outset, Solicitor General Tushar Mehta sought two weeks time, saying that he had not gone through the affidavit filed by the Ministry of Minority Affairs.

The ministry in the affidavit has told the top court that state governments can declare any religious or linguistic community, including Hindus, as minority within the said state.

Responding to the solicitor general's submission, the bench said, "The reply appears to be seen in the newspapers.

The ministry has also submitted that matters concerning whether followers of Hinduism, Judaism and Bahaism can establish and administer educational institutions of their choice in the said states and those related to their identification as minority within the state may be considered at the state level.

Upadhyay had challenged the validity of section 2(f) of the National Commission for Minority Education Institution Act, 2004, alleging that it gives unbridled power to the Centre and termed it "manifestly arbitrary, irrational, and offending".

Section 2(f) of the Act empowers the Centre to identify and notify minority communities in India.

The plea, filed through advocate Ashwani Kumar Dubey, said that denial of benefits to the "real" minorities and "arbitrary and unreasonable" disbursements under schemes meant for them to the absolute majority infringes upon their fundamental right.

"In alternative, direct and declare that followers of Judaism, Bahaism and Hinduism, who are minorities in Ladakh, Mizoram, Lakshadweep, Kashmir, Nagaland, Meghalaya, Arunachal Pradesh, Punjab and Manipur, can establish and administer educational institutions of their choice in spirit of the TMA Pai

Ruling," the plea said. The apex court in the TMA Pai Foundation case had held that the state is well within its rights to introduce a regulatory regime in the national interest to provide minority educational institutions with well-qualified teachers in order for them to achieve excellence in education.

Quoting Article 30 of the Constitution, the plea said that minorities whether based on religion or language shall have the right to establish-administer educational institutions of their choice. The petition said that denial of minority rights to actual religious and linguistic minorities is a violation of the rights of minority enshrined under Articles 14 and 21 (no person shall be deprived of his life or personal liberty except according to procedure established by law) of the Constitution.The apex court had earlier allowed a plea seeking transfer of cases from several high courts to it against the Centre's notification to declare five communities -- Muslims, Christians, Sikhs, Buddhists, and Parsis -- as minorities and tagged the matter with the main petition.

Shastri took oath as pro tem speaker on Saturday.



Nexus between babus, dealers in J-K illegal arms licence case: ED

The Entorcement Directorate on Monday said it has seized "incriminating" documents that allegedly indicate transactions between weapon dealers and bureaucrats in issuance of illegal arms licences in Jammu and Kashmir between 2012-16.
The agency, which is prob-

ing the case under the antimoney laundering law, said it had launched raids against some IAS and Kashmir Administrative Service (KAS) officers, junior government officials and arms dealers on March 24 across the Union territory.

Searches have been conducted at 11 locations, including residential premises of Indian Administrative Service (IAS) officer Rajeev Ranjan (former DC, Kupwara), KAS officers Itrat Hussain (former DC, Kupwara) and Ravinder Kumar Bhatt (former ADC, Kupwara), and former judicial clerks at arms section in DC office, Kupwara Tariq Ather and Gajan Singh, the Enforcement Directorate (ED) said in a statement.

The residential premises of six arms dealers of lammu and Kashmir, including Amarnath Bhargava (Varun Armoury), his brother Mukesh Bhargava (Bhargava Gun House), Surjeet Singh (Deshmesh Armoury), Mohinder Kotwal (Mohinder Kotwal Arms & Ammunition), Manohar Singh (Swaran Arms & Ammunition), and Devi Dayal Khajuria (Khajuria Arms) were also searched, it said.Cash worth Rs 1.58 crore, 1.76 kg gold valued at about Rs 92.30 lakh and "digital exhibits" have been seized.

Mukhtar taken from Banda jail for court hearing

Amidst apprehension of threat to the life of donturned-politico Mukhtar Ansari expressed by his family members, the incarcerated don was brought for appearance at the MP/MLA court in Lucknow and later sent back to Banda jail on Monday. Ansari was taken out of

Banda jail in an ambulance early Monday morning and was brought to Lucknow by road for hearing in the court.

MLA, Abbas Bin Mukhtar Ansari, said that he feared that his father might be harmed in "I do not understand why

he is being shifted without prior information. We came to know that preparations for shifting my father to a Lucknow court started late Sunday night," he said.

Interestingly, the Vajra vehicle attached with Ansari's security fleet also developed some technical snag soon after leaving Banda district iail.

The escorting personnel somehow got it repaired but finally left the vehicle and proceeded to Lucknow in another vehicle. Meanwhile, in another sig-

nificant development, the Barabanki police registered a case against former Bahujan Samaj Party MLA and jailed don Mukhtar Ansari under the Gangsters Act on Sunday. As per details received, 12

other aides of Ansari were also



booked by the police in connection with a case related to the use of an ambulance to the Punjab jail.

Circle Officer (City) in Barabanki, Aatish Kumar, confirmed that investigations were underway in the case.

The police have named 12 ersons from Mau, Ghazipur, Lucknow and Prayagraj for registering an ambulance against a false address and for using it to ferry Ansari to and from Punjab jail.

All the accused in this case have been arrested.

The ambulance (UP 41 AT 7171) was registered on forged paperwork and was used to transport Mukhtar Ansari from a Ropar prison to a Mohali court.

The UP police probed the case in March 2021 and found that the vehicle was registered in Barabanki. Further investigation

revealed that the vehicle was registered in the name of Shyam Sanjeevani Hospital and Research Center owner Dr Alka Rai. It surfaced that Ansari's

colleagues Rajnath Yadav and Mujahid went to Dr Rai to get

her signature on forged papers Even the fitness test had not been done since 2017.

The police also claimed that the ambulance was used to

carry firearms by Ansari's gang.
A charge-sheet was filed against all of them under sections 419 (cheating by personation), 420 (forgery), 471 (fraudulently or dishonestly using documents as genuine), 467 (forgery of valuable security), and 468 (forgery for the purpose of cheating) of the Indian Penal Code as well as Amendment Act.

Subsequently, Dr Alka Rai, Dr Sheshnath Rai, Rajnath Yadav, Anand Yadav of village Sarwan, Surendra Sharma, Mohd Shahid, Firoz Qureshi, Afroz alias Chunnu, Zafar alias Chanda, Salim, Mohd Suhaib Mujahid and Mohd Jafri alias Shahid were accused in the case along with Ansari. A native of Yusufpur in

Mohammadabad (Ghazipur) Mukhtar Ansari is a former MLA from Mau and is facing more than 50 criminal charges across the country. The ex-MLA has spent

time in prisons in Ropar, Ghazipur, Mau, Agra and Lucknow on charges of extor-

His gang is listed in Uttar Pradesh's records as IS (interstate) gang 191 and his assets have been seized under Section 14A of the Gangsters Act and Activities Anti-Social (Prevention) Act. Ansari, his family and his cronies have lost properties worth Rs 390 crore as a result of recent actions initiated by UP Police.

Maha Mins booked for brandishing **swords**

An FIR was registered on Monday against against Maharashtra Education Minister Varsha Gaikwad, Textiles Minister Aslam Shaikh, and others for allegedly brandishing swords at a function in suburban Bandra, a Mumbai Police official said.

'Investment migration' is attracting rich Indians to citizenship in advanced economies

high net-worth individual is no longer a prisoner of geography. Thousands of Indian millionaires left India seeking citizenship abroad since 2019 and many more are making inquiries about migration programmes as we speak. A 2022 World Migration Report released by the United Nations Department of Economic and Social Affairs says lakhs of Indians who went abroad in recent years have either renounced their Indian citizenship or are trying not to return home. The migration slowed down during the COVID-19 pandemic but is picking up pace once again. Three distinct patterns distinguished Indian migration till recently. Most students going abroad to study would try to find a job and settle down there. Unskilled or semi-skilled workers would migrate to the Gulf countries, preferring to stay there and repatriate dollars home. Professionals, of the Information Technology variety, spearheaded the brain drain in the last decade. It is the turn of high net-worth individuals now. They migrate for reasons over and above quality of life and money-making. Today, rich Indians migrate for a combination of reasons that is bundled into the concept of investment migration. These programmes give them the opportunity to increase the sovereign equity of the countries they prefer to



migrate to. The rich Indian brings in money as investment and adds to the foreign country's public finances without adding to the country's debt. In turn, the country gives the rich Indian citizenship, a standard of life and the opportunity to diversify his or her investments. It is a win-win situation for both.

The rich Indians look for another criterion as well: The "power of the passport". It is the latest factor to influence social inequality because it favours only the rich. The power of the passport is determined by the number of countries it has visa-free access to. A Singaporean passport gives such access to 192 des-

tinations, Germany and South Korea 190 each and Spain, 189. The Portuguese passport allows one access to the Schengen States. Prosperous Indians prefer shifting to countries which have a combination of investment migration as well as the widest visafree mobility options. If you have money to invest abroad, even if you come from a lowermiddle or lower income country, you automatically score high points for migration and you do not suffer the ignominy of being deemed a high-risk person in terms of security, asylum and overstay. The not-so-rich applicants do not enjoy this privilege. Geo-politics and geo-economics are bringing the first world closer as far as freer movement of the affluent is concerned. Rich people from a handful of countries with faster economic growth potential, like India, are adding to this highly mobile neo-nobility. Several advanced economies already recognise the benefits of having investment programmes that trade incoming wealth legacies for residence, citizenship and mobility for the incoming investors. For a country like India, this means a drain of both human resource and capital wealth.

Takeaways from Birbhum killings



It appears that India is a half-sovereign State; the concept was innovated by a German jurist on international law in the 18th century

he gruesome killings at Rampurhat in Birbhum district can be seen as another link in the chain of half-sovereignty that has reigned in our country for long. The US Declaration of Independence in 1770 was the first document to enunciate sovereignty as an essential element of the new State. The French Constitution of 1791 stated: "Sovereignty is one, indivisible, unalienable and, imprescriptibly, it belongs to the nation; no group can attribute sovereignty to itself nor can an individual arrogate it to himself." The concept was first thought of by Jean Bodin of 16th century France to signal the progress from feudalism to nationalism.

Birbhum is not the only district affected by violence. The Government recently stated that there still are 40 districts affected by Maoism; in 2005, it stood at over 200 districts. On Independence Day that year, the Maoists had killed Andhra MLA C Narsi Reddy. Only two weeks earlier, seven persons were butchered in Bastar district of Chhattisgarh, again by Maoists. Leave alone civilians, even police could not enter sub-divisional towns in the affected areas.

What is happening in West Bengal is not accidental as it has been the policy of the Congress, the Left Front and Trinamool Congress to encourage infiltration, and thus expand their vote bank. Had it not been so, how would these parties explain their support to the IMDT Act in Assam and being unhappy at its having been struck down as ultra vires by the Supreme Court? UKRAINE: LESSONS FOR TAIWAN AND CHINA

Xi is unsure what sanctions China might face if it invades Taiwan

Imost a month in, China is still being extremely coy about its attitude towards the Russian invasion of Ukraine. The regime is acutely aware that there are many parallels between the Russian-Ukrainian relationship and the Chinese-Taiwanese one, and that the Russian attempt to conquer Ukraine is failing, or at least stalled. It's only recently that Russia's President Vladimir Putin began denying that Ukraine is a real nation, but that has been Beijing's position with regard to Taiwan from the start. For 73 years, ever since the Nationalist regime lost the Chinese civil war in 1949 and retreated to Taiwan, it has been the risk of a war with the United States that has deterred the victorious Chinese Communists from invading the island and finishing the job. But that threat may be a paper tiger, for there is no actual alliance between Taiwan and the United States. Like Ukraine,



Taiwan gets many expressions of sympathy and support from Washington, and even fairly advanced weapons (although Taiwan has to pay for them), but it does not have a promise that the US Navy will stop a Chinese attack across the Strait of Taiwan, or indeed that the United States would use force in any way to defend Taiwan. While the chaotic US withdrawal from Afghanistan was still underway last August, US President Joe Biden, seeking to reassure various friends and allies, said "We made a sacred commitment...that if anyone were to invade or take action against our NATO allies, we would respond. Same with Japan, same with South Korea, same with - Taiwan." That cheered many people in Taiwan - but later in the same day a senior American official, speaking 'not for attribution', said that "US policy has not changed." The United States didn't even bother with ambiguity in the case of Ukraine, making it clear from the start that it would not offer any military resistance to a Russian conquest of Ukraine. This is perfectly sensible when your potential adversary has nuclear weapons - but China does too, so the lesson for Beijing is that the US won't really fight for Taiwan either. That is certainly the conclusion that President Tsai Ing-wen's government in Taipei will draw from recent events, so she will be shopping urgently for state-of-the-art weapons to defend Taiwan with. Given the current mood in the US Congress, she will probably be able to get them. Yet it's unlikely that Xi Jinping's advisers will be urging him to seize this moment to attack Taiwan, because what he sees in Russia is a brother autocrat, Vladimir Putin, who took a similar gamble and is facing a humiliating defeat. Putin's miscalculation has been so monumental that he may even lose power over it. There are two elements in Putin's catastrophe that Xi will suspect might also apply to any attempt by him to seize Taiwan by force. The first is just that his inexperienced armed forces, ordered to carry out an amphibious invasion of Taiwan, one of the most complex military operations in the book, may prove to be, like the Russians, simply not up to the task. The other thing Xi can't be sure of is what kind of sanctions China might face if it invaded Taiwan. Nobody knows, including the players themselves, but China is hugely exposed to any interruption of international trade, and domestic circumstances are not propitious either. There would certainly be a surge of patriotic enthusiasm if Xi ordered the invasion of Taiwan this year, but he should wait a bit and watch what happens to another dictator who launched a stupid, unwinnable war and got his whole country cancelled.

Time to revisit the three farm laws

When farmers get dozens of options to sell, plain common sense says that they are bound to get a good deal in every respect, including a good selling price

hile, staying the implementa-tion of the three contentious farm laws, the Supreme Court (SC) had set up a Committee to recommend the way forward. The committee submitted its report on March 19, 2021. Even as the SC action on the report was pending, on November 19, 2021 Prime Minister Narendra Modi announced repeal of the laws even whilemaintaining that these lawsare beneficial to small and marginal farmers who are in a majority. Now, in a startling revelation, Anil Ghanwat,a member of the committee has revealed that around 85.7 percent of the 73 farmer organizations, representing more than 33 million farmers,had supported the laws. This should prompt the government to revisit the laws. Meanwhile, let us look atthe Committee's recommendations:

First, claiming that the three laws would be beneficial for farmers, the committeehas averred their repeal or long suspension "would be unfair to the silent majority" who supported the reforms. The observation could not have been more apt.

Under the extant arrangements, farmers can sell their produce only in the Agricultural Produce Market Committee or APMCs mandi (marketplace notified under the State APMC Act) wherein the commission agents (known asarthiyas) and the licensed trader/buyer rule the roost. The duo ensure that the farmers get a low price, face rejection, weighed less, delayed payment, etc. Levies such as market fee, arthiyas' commission and rural development cess (RDC) further reduce their net-back.

The capacity of APMCs being woefully low, the small farmers are forced to sell most of their produce inthe so-called private local markets at 'throwaway' prices. Though legally barred, these sales happenbecause the buyers are none other than the arthiyas and licensed traders in the mandi who have the blessings of corrupt bureaucrats and politicians (in many cases, they or their kinalso masquerade as traders); hencethey don't face any legal action.


The three central laws gave farmers umpteen opportunities to sell their produce in outlets other than APMC mandis by legitimizing sales to private traders, processors, aggregators, exporters and so on. When farmers get dozens of options to sell, plain common sense says they are bound to get a good deal in every respect including a good price. They don't have to pay any levies for selling at non-APMC platforms and can save on transport cost in case the buyer picks up from their doorsteps.

In times, when the demand is buoyant, they can get a fair slice of the gain resulting from higher price. For instance, the steep increase in the international price of wheat following Ukraine crisis is expected to yield a bonanza of about US\$ 5 billion on the export of wheat from India. Had the three laws been in force, the farm-

ers would have got a good slice of this windfall which under the extant dispensation will be cornered mostly by traders/exporters.

Secondly, the committee has suggested that the States may be allowed flexibility in implementing and designing the three farm laws albeit with the Centre's approval.

Here, it may be pertinent to recall in 2017, the Modi Government had passed a Model Agricultural Produce and Livestock Marketing (Promotion and Facilitation) Law. It contained provisions to give more options to farmers for selling their crop and greater flexibility to traders such as 'single pan-State licence' for buying from anywhere in the State. But the model law has remained a mere showpiece as a majority of the States showed no interest.

In early 2020, in the wake of Covid-19 pandemic, Prime Minister Narendra Modi had asked the States to suspend certain provisions of their APMC laws for three months to make way for purchase of farmers' produce directly from their doorsteps by large buyers such as processors, millers, exporters, cooperatives, individual traders and so on. Only four states viz. Madhya Pradesh, Uttar Pradesh, Gujarat and Karnataka responded by making amendments in their APMC laws.

Clearly, leaving it to the states won't help. The way forward is for the Centre to resurrect its law, which allowsit to regulate inter-State trade and intra-State trade and enable an entity to buy specified farm commodities - under entry 42 of the Union List and entry 33 of the Concurrent List -'directly' from

farmers anywhere in the country, even outside APMCs.

Thirdly, the committee has opined that the farmer unions' demand to legalize MSP was not based on sound logic and was infeasible to implement. However, its concurrent suggestion to give freedom to States to make MSP legal is anomalous. When the idea is illogical for the Centre how can it work for the state?

Put simply, a legal guarantee implies, if an entity say, private trader is found paying a price less than MSP, he can be jailed. No one will ever take that risk. The ball does not stop here. The state will have to buy at MSP every grain of what the farmers offer for sale. This purchase obligation will have to cover all crops and not limited to 23 crops already under MSP regime. This can make the state bankrupt, overstrain the limited handling and storage facilities, increase wastage manifold and embarrass India at the WTO (World Trade Organization) as food subsidy to farmers balloons.

Neither the Centre nor the States should take the idea on board.

Fourthly, the committee has proposed discontinuation of the extant open-ended procurement policy; instead, it wants a cap on procurement of wheat and rice commensurate to the needs of the Public Distribution System (PDS)/National Food Security Act (NFSA). It has also mooted giving freedom of choice to beneficiaries of PDS/NFSA to choose cash transfers equivalent to MSP + 25 percent for every kilogram of grain entitlement or get it in kind. The proposal makes sense.

Initially the system intended to procure quantity needed to meet PDS needs plus a strategic buffer. But thanks to vote bank politics (guaranteed purchase at ever increasing MSP helps in elections), this has become an end in itself.

This has put the country on a dangerous trajectory viz. swinging cropping pattern towards wheat and rice, adverse environmental consequences, burgeoning stocks, increasing wastage and ballooning subsidy. Things must be set right by taking committee's recommendation on board.

As for the second part, the government should consider giving subsidy under direct benefit transfer (DBT) to 'all' beneficiaries. It may put Rs 125 a month on wheat (@Rs 25 per kg for 5 kg) in a beneficiary's account. Including Rs 10 from her pocket, she can buy 5 kg wheat from the market @ Rs 27 per kg by paying Rs 135.

Under DBT, there is no ratio-

nale for continuing with PDS though fair price shops (FPSs) can continue - like any other trader - to sell grains at market-based price. With guaranteed state purchase of wheat and rice gone, for deciding what to grow, farmerswill be guided solely by the demand pattern. This will help in crop diversification and resultant environment benefits. There will also be huge saving in subsidy due to saving in handling, storage and distribution cost.

As for remunerative price to farmers, resurrection of the three central lawswill enable them sell their produce at all non-APMC platforms and get a price of their choice (this could be even be higher than MSP).

Zelenskyy seeks peace 'without delay'

Ukraine could declare neutrality and offer security guarantees to Russia to secure peace "without delay," President Volodymyr Zelenskyy said ahead of another planned round of talks - though he said only a face-to-face meeting with Russia's leader could end the war.

Holocaust survivors flee from Ukraine to Germany for safety

When the bombs started falling on Ukraine's capital, Kyiv, last month, Tatyana Zhuravliova had a horrible deja vu: the 83-year-old Ukrainian Jew felt the same panic she suffered as a little girl when the Nazis were flying air attacks on her hometown of Odesa.

"My whole body was shaking, and those fears crept up again through my entire body - fears which I didn't even know were still hidden inside me," Zhuravliova said.

Her eyes welled up with tears as she remembered how the bombs during World War II, and eventually fled with her mother to Kazakhstan when the Nazis and their henchmen started massacring ten of thousands of Jews in Odesa. "Now I'm too old to run to

the bunker. So I just stayed inside my apartment and prayed that the bombs would not kill me," Zhuravliova, a retired doctor, told The Associated Press on Sunday.

But as Russia's military attacks on Ukraine become even more brutal and demolished residential apartment

blocks, she realized that she had to flee again if she didn't want to die. So Zhuravliova accepted an offer from a Jewish organization to bring her out of Ukraine to safety.

In an unexpected twist of history, some of the 10,000 Holocaust survivors who had been living in Ukraine have now been taken to safety in Germany - the country that unleashed World War II and organized the murder of 6

million Jews across Europe. Zhuravliova was part of the first group of four Jewish Holocaust survivors evacuated Germany, also referred to as the Claims Conference. The group represents the world's Jews in negotiating for compensation and restitution for victims of Nazi persecution and their heirs, and provides welfare for Holocaust survivors around the globe. A second group of 14 Holocaust survivors, many of them ill and bed-ridden, were brought out of Ukraine on Sunday. The Claims Conference is working with its partners, among them the al have had their homes hit by American Jewish Joint Distribution

as many Holocaust survivors out of Ukraine as possible.

Around 500 Holocaust survivors in Ukraine are especially in need of help because of their ailing health - their evacuation is a top priority, says the

It's a highly difficult and complex operation to transport such frail people out of Ukraine, where constant shelling and artillery fire make any evacuation very dangerous. It involves finding medical staff and ambulances in numerous war zones, crossing interfrom Ukraine by the New national borders and even con-York-based Conference on vincing survivors, who are ill without help, to flee into uncertainty again, this time without the vigor of youth.

However, the risks of staying behind are also very high. This month, 96-year-old Boris Romanchenko, who survived several Nazi concentration camps during World War II, was killed during an attack in the Ukrainian city of Kharkiv.

Russian President Vladimir Putin placed his country's nuclear forces on high alert shortly after the Feb. 24 inva-

Roughly 9 in 10 Americans are at least somewhat concerned that Putin might use a nuclear weapon against Ukraine, including about 6 in 10 who are very concerned.

"He is out of control, and I don't think he really has concern for much of anything but what he wants," said Robin "And he has nuclear weapons."

Seventy-one percent of Americans say the invasion has increased the possibility of nuclear weapons being used anywhere in the world. The poll was conducted before North Korea test-fired

its biggest intercontinental ballistic missile on Friday but also shows 51% of Americans saying they are very concerned about the threat to the U.S. Posed by North Korea's nuclear program. An additional 29% expressed moder-

Fear of nuclear war has been a fact of life for decades. The Bulletin of the Atomic Scientists has published its "Doomsday Clock" since 1947, showing a theoretical countdown to nuclear annihilation. The latest update, in January, put the time at 100 seconds to midnight - unchanged since 2020, but still closer than ever to Armageddon.

Ukraine war threatens food supplies in fragile Arab world food, and governments should

Layal Aswad was already exhausted by Lebanon's devastating two-year economic collapse. Now, as Russia's invasion of Ukraine sends food and energy prices soaring even further, she finds herself struggling to put food on the table for her family of four.

"Even bread is not something we take for granted anymore," said the 48-year-old housewife, standing recently in a supermarket aisle in front of gallons of cooking oil whose prices had risen to an all-time

From Lebanon, Iraq and Syria to Sudan and Yemen, mil-East whose lives were already upended by conflict, displacement and poverty are now wondering where their next meals will come from. Ukraine and Russia account for a third of global wheat and barley exports, which countries in the Middle East rely on to feed millions of people who subsist on subsidized bread and bargain noodles. They are also top exporters of other grains and the sunflower seed oil that is

used for cooking.

Even before the war in Ukraine, people in countries

North Africa were not getting enough food to eat. Now with trade disruptions spurred by the conflict, more commodities are becoming either unaffordable or unavailable.

"Put simply, people cannot afford food of the quality or quantity that they need, with those in conflict- and crisis-affected countries ... At greatest risk," said Lama Fakih, Middle East and North Africa Director at Human Rights A similar set of circum-

stances led to a series of uprisings starting in late 2010 known as the Arab Spring, when skyrocketing bread prices protests across the Middle East, noted Kristalina Georgieva, managing director of the International Monetary Fund.

"When prices jump, and poor people cannot feed their families, they will be on the streets," Georgieva remarked Sunday at the Doha Forum, a policy conference in Qatar.

In Iraq and Sudan, public frustration at food prices and a lack of government services erupted in street protests on several occasions over the past several weeks.

"People have a right to

do everything in their power to protect that right, otherwise we risk not only food insecurity but the insecurity and instability that gross deprivation on this scale could trigger," Fakih

The war also has sparked concern that much of the international aid upon which so many in the Arab world depend will be diverted to Ukraine, where more than 3.7 million people have fled the war, Europe's largest exodus since World War II.

"For the millions of Palestinians, Lebanese, Yemenis, Syrians, and others who live in countries experieconomic meltdowns, and increasing humanitarian needs, this would be equivalent to shutting down critical life support," states an analysis released by Carnegie Middle East

experts last week. In Syria, 14.6 million peoole will depend on assistance this year, 9% more than in 2021 and 32% more than in 2020, Joyce Msuya, the United Nations' assistant secretarygeneral for humanitarian affairs and deputy emergency relief coordinator, told the U.N. ¬hina began its most exten-Csive coronavirus lockdown in two years Monday to conduct mass testing and control a growing outbreak in Shanghai as questions are raised about the economic toll of the nation's "zero-COVID" strate-

Shanghai, China's financial capital and largest city with 26 million people, had managed its smaller previous outbreaks with limited lockdowns of housing compounds and workplaces where the virus was spreading.

But the citywide lockdown that will be conducted in two phases will be China's most extensive since the central city of Wuhan, where the virus was first detected in late 2019, confined its 11 million people to their homes for 76 days in early 2020. Millions more have been kept in lockdown since

Shanghai's Pudong financial district and nearby areas will be locked down from Monday to Friday as mass testing gets underway, the local government said. In the second phase of the lockdown, the vast downtown area west of the Huangpu River that divides the city will start its own five-day lockdown Friday

Residents will be required to stay home and deliveries will be left at checkpoints to ensure there is no contact with the outside world. Offices and all businesses not considered essential will be closed and public transport suspended. Already, many commu-

nities within Shanghai have been locked down for the past week, with their housing compounds blocked off with blue and yellow plastic barriers and residents required to submit to multiple tests for COVID-19. Shanghai's Disneyland theme park is among the businesses that closed earlier. Automaker Tesla is also suspending production at its Shanghai plant, according to media reports.

The increase reflects a quarter-on-quarter increase of 2.15 per cent in October-December 2021-22.

In absolute terms, the total liabilities, including liabilities under the 'Public Account' of the government, jumped to Rs 1,28,41,996 crore at the end of December 2021. As of September 30, the total liabilities stood at Rs 1,25,71,747 crore.

The report released by the finance ministry on Monday said public debt accounted for 91.60 per cent of the total outstanding liabilities in December quarter compared to 91.15 per cent at the end of September.

Nearly 25 per cent of the outstanding dated securities had a residual maturity of less than 5 years.

If the breast lump isn't cancerous, your doctor will decide whether you need short-term monitoring with clinical breast exams or repeat breast imaging. You may have to see the doctor again in two to three months. The doctor will monitor again if there have been changes in your breast.

If the diagnosis is in question or the clinical breast exam and the cion, but the biopsy reveals benign tissue-you'll be referred to a surgeon or other specialist for further consultation.

If the breast lump is cancerous, you'll work with your doctor to create a treatment plan. The stage and type of breast cancer will decide the further treatment procedure. Generally, surgery is performed if the lump is proven to be cancer. The surgeon before performing the surgery will explain appropriate surgical options and provide you with the information necessary to make this decision. You may have several consultations with other physicians for additional treatment, including radiation therapy and chemotherapy or hormone therapy.

with a pandemic of this magnitude, it needed to develop a potent vaccine to protect its population. And in less than a year, the country developed and produced vaccines for its

The Government decided to first immunise the healthcare workers on priority. It was a matter of great pride for us when the government recognised the healthcare community's efforts in fighting the pandemic in the absence of a potent drug or therapy.

Indeed, healthcare workers were at the greatest risk of contracting the disease while treating their patients. But initially, there were concerns within the medical fraternity regarding the safety of these vaccines as they were developed in such a short time.

But IMA had immense faith in Prime Minister Narendra Modi, scientists, and the country's stringent regulatory mechanism. In fact, India, which is known as the pharmacy of the world, has a glorious history when it comes to developing vaccines. The country has eradicated and eliminated various deadly and debilitating diseases with the help of vaccines.

Across India, we, the healthcare workers came forward and took the vaccine. We took it as an opportunity to show our trust and confidence in the system, and we decided to become an ambassador for the vaccines, developed because of the dedication and relentless efforts of our scientists.

Bajrang's leg defence is not weak,

it's just his style of play: Coach **PTI** ■ NEW DELHI

Contrary to the popular opinion that Bajrang Punia's leg defence is a major shortcoming in his game, Sujeet Maan, the new personal coach of the star grappler says the wrestler looks vulnerable only because of his attacking style and all he needs to do is to convert the moves into points.

Bajrang[†]s leg defence has been a major talking point in the last three years, especially in run up to the Tokyo Games, where he won a bronze medal.

His coach Shako Bentinidis also worked on the same but Bajrang, 28, never made the desired progress, something which irked the national federation and eventually the Georgian was removed from his support staff.

However, Maan, who started working with Bajrang from January this year, says Bajrang's leg defence is not as weak as it is thought of.

"A lot of people opine that his leg defence is weak but that's not the case. It's a style. In cricket, the aggressive batters go for their shots and in the process they run the risk of losing their wicket. In Bajrang's case when he plays attacking game, he appears vulnerable in his leg defence," Maan told PTI in an interview.

"It's not that we are not working on his leg defence. We are trying that even if the rivals get hold of his legs, he wriggles out of it with solid defence.'

One of the main reasons for his leg-defence struggle has been linked with his training and competition on the soil (dangal) in his formative years. The wrestlers usually adopt a high stance during 'dangals' but when it comes to competition on the mat, the strategy does not work.

Many traditional wrestling stars like Jassa Patti, one of the famous and most successful dangal wrestlers in the country could not succeed on mat, struggling to win bouts even in

"I have devised a plan for him. When Bajrang is not competing, he

could be a reason for whatever issues he has in his leg defence.

"On the mat you need to compete more on low and middle stance while in the Dangal, the wrestler maintains high stance. Habits are difficult to change, especially when it becomes muscle

Maan said he has been a part of the national camp and has observed Bajrang's game whenever he was there. He and Bajrang, recently, watched the wrestler's bouts from the 2019 World Championship, 2018 Asian Games, the 2021 Asian Championship videos and he is sure that going forward, adding more aggression to his style should help "He needs to be aggressive and

attack more. Attack is the best defence. The change he needs to make is he should attack but must not end up losing points or fail to score despite taking the risk. "If he is managing to grab legs

of his opponent, he must convert that move into points, that's what we are working on," Maan who won four Asian Championship medals, including a silver in 2004, said.

Talk about the 2024 Paris Olympics and Maan quickly points that they "don't have much time on our hands to prepare. But why?


