Sonia calls for urgent, big ticket reforms in Cong

Says, situation demands extraordinary steps, slams PM for polarisation

ongress president Sonia Gandhi on Friday called for urgent reforms in the party as "extraordinary situations demand extraordinary action" and also launched a blistering attack on Prime Minister Narendra Modi accusing him of keeping the country in a state of permanent polarisation, "brutalising" minorities and "threatening" political opponents.

The party, which is holding a three-day Chintan Shivir in Udaipur also held discussions on enforcing the 'One family, one ticket' formula, granting exemption to only another family member who has been doing "exemplary work" for the party for a period of at least five years. This will leave scope for members of the Gandhi family to contest polls and allow other senior leaders to get their sons and daughters accommodated in the ticket

Sending out a clear message to Congress ranks while launching the brainstorming conclave, Sonia said the party will have to change its style of functioning and urged them

to keep the organisation above their personal ambitions and pay back their debt to the party as it had given a lot to everyone.

She urged around 450 delegates to deliberate with an open mind but send out a sin-

gle message of a strong organisation, resolve and unity. "In one way this (Congress transformation) is the most fundamental issue. Our revival is only possible through collective efforts. Such collective

efforts will not be deferred.

This Shivir is the start of the journey," Sonia said.

The three-day 'Nav Sankalp Chintan Shivir' is being held in the backdrop of a string of electoral defeats and dissent in the party for the past many years

Protests erupt in Kashmir over Rahul Bhat's killing

Three terrorists killed, hundreds of Kashmiri Pandit employees offer to resign

day after the killing of a Kashmiri Pandit man A Rahul Bhat by terrorists, Kashmiri Pandit Government employees held protests on Friday, demanding relocation to safer places outside the Valley. At the same time, security forces gunned down three terrorists in an encounter that broke out in Brar Aragam area of Bandipora on Friday. Sources said two of the three ultras were involved in the attack on Bhat.

Protests erupted at the Sheikhpora camp, located in Budgam district of central Kashmir, where Kashmiri Pandit employees have been given makeshift accommodations. The police used batons and tear gas shells to disperse the protestors who were marching towards the airport road, seeking an audience with Lieutenant-Governor Manoj Sinha. The migrant employees were moving peacefully in the area when local police requested them to disperse. When they refused to budge and kept marching on, police used force

and lobbed tear gas shells. A sitin protest also continued in Vessu, Qazigund area of Anantnag district on Friday where migrant employees offered mass resignations to register their protest against the failure of the Union Territory administration to protect them.

Seething with anger the aggrieved employees also demanded speedy justice and the "severest" punishment for killers of Bhat.

Meanwhile, in Jammu, the mortal remains of Rahul Bhat were consigned to flames after the body arrived from Kashmir in the wee hours. The entire neighbourhood in Durga Nagar area of Jammu had converged outside the residence of Rahul to pay their homage and perform the last darshan.

Meenakshi, who brought back the mortal remains of her husband after traveling during the night, wept inconsolably on reaching their Durga Nagar home in Jammu.
"My husband used to say

everyone behaves nicely with him and nobody can harm him. Yet nobody protected him, they (terrorists) must have asked someone about him, otherwise, how would they've known. I am left alone. He was everything for me," she said.

Rahul leaves behind a seven-year-old daughter and aging parents. Rahul's father Bitta Jee Bhat retired from active police service years ago. Bitta Jee Bhat has also demanded a high-level inquiry to ascertain how the killers entered a Government office.

With the Women's Helpline 181 being prominently visible within the Truecaller dialler, the Delhi Commission of Women witnessed a huge spike in the calls that were landing on the Helpline in Delhi. Prior to Truecaller's integration, the Commission's helpline 181 received around 2000 calls per day, which has now grown to more than 4,000 calls per day resulting in almost a 200% increase in total calls received per day. A significant portion of the 65.5k calls received in March were to enquire about the role of the 181 Women Helpline and understand its role in the safety of womenandgirls.

The women and girls of Delhi continue to seek help from the 181 women helpline in cases related to domestic violence, sexual assault and other crimes against women.

SC refuses to pass interim status quo CBI books Army officer posted at Port Blair for graft order on survey of Gyanvapi complex

The Supreme Court on Friday refused to grant an interim order of status quo on the survey of the Gyanvapi-Shringar Gauri complex at Varanasi in Uttar Pradesh. The apex court agreed to consider listing the plea of a Muslim party against the survey of the Gyanvapi premises, when mention was made.

The Bench comprising Chief Justice NV Ramana and justices J K Maheswari and Hima Kohli was told by senior advocate Huzefa Ahmadi, appearing for the Muslim side in the Gyanvapi mosque case, that a plea has been filed against the survey being conducted at the Varanasi site.

"We have filed in relation to a survey which has been directed to be conducted in relation to the Varanasi prop-erty. This (Gyanvapi) has



immemorial and this is clearly interdicted by the Places of Worship Act," Ahmadi said.

He said the direction to conduct a survey has been passed and an order of status quo be passed at the moment. Î do not know anything. How can I pass such an order? I will read. Let me see," the CJI said. The Muslim side has

been referring to the Places of Worship (Special Provisions) Act, 1991 and its section 4 which bars filing of any suit or initiating any other legal proceeding for a conversion of the religious character of any place of worship, as existing on August 15, 1947.

SC seeks Centre, J&K admin, ECI replies on plea against delimitation commission

The Supreme Court on Friday sought a response from the Centre, the Jammu and Kashmir administration and the Election Commission of India on a plea of two Kashmir residents challenging Government's decision to constitute the delimitation commission for redrawing the Assembly and Lok Sabha constituencies in the UT.

A bench of Justices Sanjay Kishan Kaul and MM Sundresh issued notice to the Centre and Election Commission of India and sought their responses within six weeks and said the rejoinder affidavit shall be filed in two weeks thereafter. The bench said

the delimitation commission was formed sometime back and asked the petitioners, where were they during that time and why did not they challenge the Constitution of the commission.

The counsel said as per the delimitation order, it is the Election Commission that is empowered to do any changes.

The bench told the counsel, who was making objectionable submissions, to choose his words properly and said that Kashmir was always part of India and just a special provision was removed.

Solicitor General Tushar Mehta said effectively the plea is two-fold and that delimitation can be conducted only by the ECI and not the delimitation

Chandra allegedly misused his official position and ensured award of the contract for supply of food items including spices to Base Victualling Yard, Minnie Bay, Port Blair, Andaman without Price Negotiation Committee (PNC) to Rochak Agro Food Products Pvt Ltd., Kolkata and also extended favour in return of bank guarantee of the said company, deposited for the previous contract with BV Yard, Port Blair, it alleged.

In return for the favours, Chandra allegedly demanded and agreed to accept a bribe of Rs 75,000 from Choudhary either in the form of two cheques issued from the account of anyone except the favoured company or in the form of two gift vouchers of

jewellery brand Tanishq. Choudhary could not arrange gift vouchers so

Chandra allegedly got the amount deposited in two bank accounts (Jharkhand) through NEFT.

It was also alleged that Chandra had demanded a bribe of Rs three lakh from a representative of another supplier based in Port Blair. On June 6, Muthu, the representative, allegedly tried to pay Rs 1 lakh as part payment but Chandra refused and demanded the full amount. Muthu then used debit cards to withdraw money from the ATM and made a payment of Rs 2.5 lakh to Chandra, the FIR alleged.

1 serving, 2 retired IAF officers get life sentence for custodial death of cook 27 years ago

Aspecial CBI court in Ahmedabad has sentenced two retired and one serving officers of the Indian Air Force (IAF) to life imprisonment for the custodial murder of a cook 27 years ago, officials said here on Friday.

Girija Rawat, a cook at the air force station in Jamnagar, was tortured to death in November 1995 after it was suspected that he stole liquor the canteen.

The convicted officers are Anoop Sood, then a Squadron Leader at the Air Force-I in Jamnagar, and then Sergeants Anil K N and Mahendra Singh

Sood, who retired as Group Captain, claims to be an orientation programme speaker and a trained commando from the NSG on his social media profile.

Anil also retired from the IAF, while Sehrawat was still serving. The CBI had taken over the case on February 22, 2012 on the orders of the Gujarat High Court on a plea of Rawat's wife.

"...It was further alleged

that on November 13, 1995, 10-12 Air Force Police Officials, including then Squadron Leader Anoop Sood, conducted searches at the residence of Rawat and took him with them

forcibly to confess about stealing of liquor from the Air Force Canteen," CBI Spokesperson R C Joshi said.

He said Rawat's wife visited the guard room in the evening seeking release of her husband.

"She was told that her husband would be released soon. The accused allegedly tortured him which caused his death. On November 14, 1995, she was informed about the death of her husband and was asked to collect the body,'

After thorough investiga-tion, the CBI filed a charge sheet on July 30, 2013 against the accused on the charges of criminal conspiracy and murder, he said.

Monsoon to hit Kerala on May 27, five days early: IMD

South-west monsoon, considered as the lifeline of India's agri-based economy, is likely to bring first showers to Kerala by May 27, five days earlier than the normal onset date, the weather office announced on Friday.

"This year, the onset of southwest monsoon over Kerala is likely to be earlier than the normal date of onset. The monsoon onset over Kerala is likely to be on May 27 with a model error of four days," India Meteorological Department (ID) said.

In 2009, the south-west monsoon had reached Kerala on May 23. Weather scientists

attribute the early onset of

southwest monsoon over

Kerala to the influence of the remnants of cyclone Asani that triggered the cross-equatorial flow, a key factor for the seasonal rains. The early arrival of the south-west monsoon comes at a time when parts of northwest India were experiencing extremely high maximum temperatures. On Thursday, the weather

office had forecast the onset of south-west monsoon over Andaman & Nicobar islands on May 15, nearly a week ahead of schedule. "In association with

enhanced cross equatorial winds, conditions are becoming favorable for the advance of Southwest Monsoon into South Andaman Sea, Nicobar Islands and some parts of southeast Bay of Bengal, around May 15,"

At the same time, the weather office made it clear that past data suggest that there is no association of the date of monsoon advance over the Andaman Sea either with the date of monsoon onset over Kerala or with the seasonal monsoon rainfall over the

The IMD said due to strong westerly flow from Arabian Sea to south peninsular India in lower tropospheric levels fairly widespread light/moderate rainfall with isolated thunderstorm/lightning/gusty winds likely over Kerala, Mahe, Tamil Nadu, Puducherry and Karaikal, south interior Karnataka and Lakshadweep over the next

Tamil Nadu Higher Education Minister K Ponmudy on Friday asserted that the State Government will continue with the two-language formula as its policy, and decried any attempts of alleged Hindi imposition and questioned claims that learning the language will fetch jobs.

Taking a dig on those who insist jobs will be available for people learning Hindi, the Minister asked who are selling 'pani puri' in the Coimbatore now, an obvious reference to the predominantly Hindispeaking vendors involved in the trade in the city. He, however, later clarified his comments on pani puri sellers did not amount to profiling.

His comments came at the 37th convocation of Bharathiar University in Coimbatore, presided over by state Governor R N Ravi, also the varsity Chancellor, where the minister reiterated the ruling



DMK's stand against 'imposition' of Hindi, a claim which Ravi sought to dismiss by saying "there is no question of imposition of Hindi or any other language on anyone.'

Ponmudy said he used the platform to highlight Tamil Nadu's sentiments over the language issue as the Governor would convey them to the Centre. He recalled that English and Tamil have been in vogue in Tamil Nadu for long and that the same will continue while students were not against learning other languages, including Hindi.

'Many said you will get jobs if you learn Hindi. Is it so...Look here in Coimbatore, who is selling pani puri. It is them (Hindi-speaking individuals)," he said.

"If a cat can go through a hole, can't a rat," he asked cryptically. Ponmudi said students of the state were ready to learn any language and that they were not against other languages including Hindi. Noting that the state gov-

ernment was ready to adopt good schemes in the New Education Policy (NEP 2020), the minister said there should not be any imposition of Hindi and students can prefer any language as the third option, but the state will follow the system prevailing now. Alleging Hindi imposition through NEP 2020, the Tamil Nadu government has already said the twolanguage policy, comprising Tamil and English, will continue to remain in practice.

"We don't want to agitate against the good things in NEP. We are ready to follow them. But at the same time, in Tamil Nadu we should have our own language. India is a land of unity in diversity. In Tamil Nadu we shoould follow our own education system.. We should follow certain good policies from the NEP," Ponmudy added.



Panama Papers: ED seizes ₹88.30 L after raids in MP, Goa

The Enforcement Directorate (ED) has seized Rs 88.30 lakh in cash after it searched the premises of a man, whose name figured in the Panama Paper leaks, in Madhya Pradesh and Goa as part of money laundering investigation against him.

The ED has conducted searches at four premises based at Bhopal (Madhya Pradesh) and Goa in a money laundering case registered against Sanjay Vijay Shinde. "Sanjay Vijay Shinde figured

in the Panama Paper Leaks, wherein, names of various individuals were revealed who had beneficial interests in various offshore entities.

Sanjay Vijay Shinde had beneficial interests in a British Virgin Islands based offshore entity, in whose Singapore-based bank account, more than Rs 31 crore were deposited by various offshore entities," the ED said in a statement.

Tax Income Department filed a prosecution complaint against Sanjay Vijay Shinde under provisions of



Black Money (Undisclosed Foreign Income and Assets) and Imposition of Tax Act, 2015. Subsequently, investigation under provisions of Prevention of Money Laundering Act (PMLA) was initiated by the ED.

Searches were conducted at the four premises related to Shinde, including the residential premises at Goa and Bhopal, the premises of his then employer VS Dempo Holdings Pvt Ltd, Goa and the premises of RPM Sonic Adventures and Caravan Resorts at Bhopal.

ED files chargesheet against two PFI leaders under PMLA

Enforcement ▲ Directorate (ED) has filed a Supplementary Prosecution Complaint (charge sheet) against two leaders of the Popular Front of India (PFI) under the Prevention of Money Laundering Act (PMLA) before the Special PMLA Court, Lucknow with a prayer for awarding punishment to the

The Court has taken cognizance of the offence of money laundering against the duo.

Earlier, a Prosecution Complaint had been filed by the ED on February 6 last year against five office bearers / members of PFI and its student wing Campus Front of India.

The latest supplementary prosecution complaint has

been filed against PFI leaders Abdul Razaq Peediyakkal alias Abdul Razak BP and Asharaf Khadir alias Ashraf MK who, in association with other PFI leaders and members associated with overseas entities, were developing a residential project Munnar Villa Vista Project (MVVP) at Munnar,

The motive of the accused was to launder money collected from foreign countries as well as within the country and to generate funds for PFI to finance its radical activities, the ED said in a statement.

"Investigation established that 'proceeds of crime' in the form of unaccounted & unexplained cash as well as foreign funds were parked in MVVP and were projected as untainted," it said.


Scientists report spotting of fossil of Madtsoiidae snake

S cientists from Wadia Institute of Himalayan Geology, Dehradun and a few other academic institutions including Panjab University Chandigarh and IIT, Ropar, have reported sighting of the fossil of a Madtsoiidae snake from the molasse deposits of Ladakh Himalaya for the first time indicating their prevalence in the subcontinent for much longer time than previous-According to the scientists, Madtsoiidae is

an extinct group of medium-sized to gigantic snakes, firstly appeared during the late Cretaceous and mostly distributed in the Gondwanan landmasses, although their Cenozoic record is extremely scarce. From the fossil record, the whole group dis-

appeared in the mid-Paleogene across most Gondwanan continents except for Australia where it survived with its last known taxon Wonambi till late Pleistocene. The lucky team members included Dr.

Ningthoujam Premjit Singh, Dr. Ramesh Kumar Sehgal, and Mr. Abhishek Pratap Singh from Wadia Institute of Himalayan Geology, Dehradun, India in association with Dr. Rajeev Patnaik and Mr. Wasim Abass Wazir from Panjab University Chandigarh; Dr. Navin Kumar and Piyush Uniyal from Indian Institute of Technology Ropar, and Dr. Andrej Cernanský of Comenius University Slovakia.



ligocene of Ladakh indicates their continuity at least to the end of the Paleogene (geologic period and system that spans 43 million years from the end of the Cretaceous Period 66 million years ago). The research published in Journal of Vertebrate Paleontology shows that the members of this group were successful in this subcontinent for much longer time than previously thought

The global climatic shifts and the prominent biotic reorganization across the Eocene-Oligocene boundary (which correlates to the European Grande Coupure), did not cause the extinction of this important group of snakes in India, said an official from the Science and Technology Ministry.

Judicial panel recommends criminal proceedings Justice RK Bag (retd) committee submits report showing how 381 people were illegally appointed in Group C posts circumventing panel of candidates

A judicial panel instituted by the Calcutta High Court to look into an alleged West Bengal School Service Commission recruitment scam has submitted a damaging report before the court that threatens to implicate a flock of senior Government staff and Ministers, sources said.

Recommending criminal proceedings against four former SSC officials and the then president of the autonomous institution, Justice RK Bag (retd) committee on Friday submitted a report showing how 381 people were illegally appointed in Group C posts circumventing the panel of candidates who had cleared the recruitment tests. The said 381 appointees had not

even appeared for the examinations. The report says that recommendations for appointment were made by an advisory panel allegedly created during when TMC General Secretary Partho Chatterjee was the Education Minister. The advisory panel thus created by the ministry did not have any legal validity as the SSC is an autonomous body with its own time-tested recruitment procedures — the judicial committee has said.

According to sources another 222 successful candidates whose names figured in the waiting list — were given appointments upon the recommendations of the advisory committee much after the date of appointment had elapsed. The report has also held the

then West Bengal Board of Secondary Education and the five-member advisory panel headed by SP Sinha — created by the Education Ministry to supervise the appointment procedures — responsible for the recruitment scam.

The Division Bench of justices Subrata Talukdar and Ananda Kumar Mukherjee hearing the case would pass an order on May 18.

The single Bench of Justice Abhijit Gangopadhyay had earlier ordered a CBI investigation into the matter asking the central agency to go to the extent of arresting any one — even a minister. The ordered was stayed by the Division Bench.

Similar recruitment cases involving hundreds of aspirants

for primary and secondary teachers' posts as well as Group D staff are pending in the High Court while the aspirants who had cleared the tests and whose names appeared in the waiting lists were still holding dharnas.

According to sources appointments were made in lieu of crores of rupees.

Maha: Firm owner arrested for GST fraud of ₹8 crore

Officials of the Central Goods and Services Tax (CGST) have busted racket involved in generating fake input tax credit worth Rs 8 crore and arrested the proprietor of a firm dealing in trading of construction material, an official said

Acting on a specific input, the anti-evasion wing of the CGST Thane Commissionerate initiated an investigation against J.J. Lime Depot, which deals in trading of construction material, he said.

The probe revealed that the firm had fraudulently claimed input tax credit of Rs 8.05

crore and had also issued bogus invoices of more than Rs 40 crore for passing on of this tax credit, without any supply of goods, in gross violation of provisions of the CGST Act, 2017,

In his statement, recorded during the investigation, the proprietor of the firm admitted that he had issued fake invoices to many Mumbai-based infrastructure companies, for commission,

The firm's proprietor was arrested on Thursday under the CGST Act, 2017 and has been remanded to judicial custody for 14 days, the official

An unforgiving May

Revised work hours protocol for extreme summers is needed

he effect of Cyclone Asani has waned. The moisture-laden easterly winds did lower temperatures for a couple of days in the north. The plains are back to witnessing a return of the debilitating heatwave. The weather office has issued a yellow alert that could soon be upgraded into an orange alert. Are any steps afoot to mitigate people's misery as the temperatures threaten to cross 46 degrees Celsius in Delhi and neighbouring states? A welcome step is shortening school hours, limiting students' outdoor activities, and relaxing the dress code norm. However, is there a need for primary schools to function? The heat threatens the adult population in no less measure. Sunstrokes are on the rise and dehydration is common. And yet there is no attempt to advance or shorten office hours. Private offices can easily shift to the WFH mode if advancing office hours is not possible. Online work in digitised government departments is recommended. The situation eminently suits half-day work timings. Routine activities in courts like date extensions, submission of documents, and bail arguments, especially related to petty crimes, can be online. However, what about the daily-wage labourers, agricultural labourers, and civic workers of the public works departments?



Millions spend their days under the unrelenting sun with barely any protection or nutritious supplements. The civic works have not been stopped or postponed anywhere. Big projects related to national highways, track-laying, and construction of bridges and buildings have no systems to allow for reduced working hours. In some states, the governments make arrangements for cool drinking water, buttermilk sachets, and medical camps. Most states have firstaid kits at the primary health centres in rural areas. But all these efforts miss the point. They essentially deal with basic resuscitation measures for labourers

and workers suffering heat strokes. We are witnessing a definite, recurring pattern of extreme summer heat. The pattern is already an intrinsic part of summers, and climatologists fear things may become worse in the coming years. So, we should be talking about more than the basics. The focus should be on tweaking working hours without affecting productivity but sparing the workers from heat fatigue. Proposals for the work hours to begin earlier than usual or shift to the late afternoons and early eveningsare worth examining. Implementing them is not easy without backup infrastructure, including the provision of power and, possibly, transport and arrangements of creches, temporarily in 'anganwadis', for the children of the labourers. By now, the National Disaster Management Authority could have met to discuss a summer public works protocol roping in organisations from the Centre, the States, and the non-governmental sector. The Authority's website does recognise the threat that extreme summers pose. The homepage lists the criteria offered by the weather office for heatwaves and spells out first-aid and stroke-prevention measures. It also acknowledges that India is also feeling the impact of heatwaves. But that is all.



If Congress did not resolve the leadership issue then talks about revamp will have few takers

Ironically, the grand old party which wants to lead the nation has no permanent leader itself. The continuation of Sonia Gandhi as interim president is not only a perceptional disaster but it also



sion not to allow anyone outside the Gandhi family to steer its course even when 10 Janpath has failed to perform, at least electorally. An army is as good as its general, the saying rings so true in the case of Congress. Sonia Gandhi rarely makes any public appearance, and Rahul Gandhi has yet to project himself as a leader who can keep the party together, mend fences with old guards, and sacrifice his foreign jaunts for the party's sake. Somehow a perception has gained ground over the years that Rahul Gandhi lacked the killer instinct to lead the party to electoral victories. It's one thing to address public rallies and hit out at the Modi Government, it's another to plan and plot strate-

gies to fight electoral battles. Take the case of Punjab and Uttarakhand, where Congress virtually gave walkovers to the BJP in the assembly polls because of the failure of the leadership to resolve the infighting even at the peak of electioneering.

Sonia Gandhi's words in her inaugural address at the Chintan Shivir that "We need to change the way of our working", apply as much to the party workers as to the leadership. Similarly, when Sonia urged party leaders to keep the organization above personal ambitions, saying the party has given "us a lot and it's time to pay back," many would ask should not charity begin from home. For years the Congress leaders have been playing the same old tune. It's time they walk the talk themselves. Sonia Gandhi may have rightly said that the Shivir is an occasion to discuss the challenges before the party and bring organisational changes, but if Congress did not resolve the leadership issue and showed a readiness to empower leaders from outside the Gandhi family, too, then all the talks about organizational revamp will have few takers.

few people know what Sir Arnold Toynbee told his Indian audience when he came to address them to commemorate Maulana Abul Kalam Azad. Toynbee had come at Jawaharlal Nehru's special invitation in the early 1960s. Arnold Toynbee said: "In the course of the first Russian occupation of Warsaw, the Russians had built an Eastern Cathedral in the city that had been the capital of the once independent Roman Catholic country Poland. The Russians had done this to give the Poles a continuous ocular demonstration that the Russians were now the masters. After the re-establishment of Poland's independence in 1918, the Poles pulled this cathedral down. I do not blame the Polish Government for having pulled down the Russian church. The purpose for which the Russians had built it had been not religious but political, and the purpose had also been intentionally offensive."

In the Abrahamic religious tradition, a church or mosque is a prayer hall. It is not unusual for a parish in Europe to sell for money a church; say, for the reason it does not attract an adequate number of worshippers on Sundays. I was present in England when such a sale was made in Leicester and the soldoff place was brought down to be replaced with a temple. In West Asia, including Saudi Arabia, mosques are brought down to straighten or widen highways. By sharp contrast, in the Hindu belief, a temple is the residence of the divine. Therefore, it is very impious to meddle with its structure. Contrast a prayer hall with a residence of God, and one would know how deeply the Hindu sentiment has been hurt for centuries by the demolition of temples by Islamic invaders and conquerors from West and Central Āsia; it is almost impossible for an Abrahamic person to imagine the extent of the psychological injury thus caused.

Quite to the contrary, when the communists came to power in Russia in 1917, they went about targeting all places of wornism is the fourth sibling in the Abrahamic family of religions and shares their intolerance towards any other belief system and like its siblings, has no hesitation in turning upon its fellow siblings as well.

BACK-BREAKING INFLATION

Sir—The retail inflation shoots up to a 95month high in April, paving the way for more policy rate hikes by the central bank. Inflation has remained above the central bank's upper tolerance limit for four consecutive months. The data released by the National Statistical Office showed the food inflation rate in April soared to 8.38 per cent as prices of edible oils and vegetables shot up by 17.3 per cent and 15.4 per cent, respectively.

Fuel inflation also breached the double-digit mark at 10.8 per cent in April due to rising retail prices of petrol, diesel, and cooking gas even as crude oil prices softened from March. The second round impact of higher energy prices has become



THE JAPANESE HAVE THEIRS, **WE'LL SOON HAVE OURS**

It's all about commuting from home to work and back!



rbanisation the world over has spawned transport systems ranging from bicycles to horse drawn carriages, buses, cars, trains. The ultimate in trains being the 'Bullet' trains which first appeared in Japanin 1964. Typically, a commute should last no more than 2 or 3 hours beyond which sustaining it on a daily basis,5 days a week, months on end, would be somewhat inconvenient. The urban sprawl has been somewhat limited by this need to commute where typically the Railway commuter systems world over such as the Delhi Metro, London tube, or New York Transit system running at an average speed of 100 kmph would cover 200 kms in 2 hrs. However, the Japanese found a way to beat this limit by introducing trains with an average speed of 250 kmph, the bullet-shaped nose of the lead bogie earning it the name — 'Bullet' train. It connected Osaka 500 kms away to Tokyo, enabling a daily commute in just 2 hours. Rising out of the ashes of the Second World War II, Shinkansen was a bold reasser-



tion of Japanese national pride, and involved concerted effort by the Government, business and the scientific community to place priority on train travel. These state-of the-art trains run on dedicated tracks laid usually on concrete to minimise maintenance, and have few level crossings, enabling them to maintain an accident-free record for the last almost 60 years. Tokaido Shinkansen, covering 515 km between Tokyo and Shin-Osaka, was the first service, serving a number of major cities Shin-Yokohama, Shizuoka, Nagoya, and Kyoto en route.

Laid with tracks having a curve radius of no less than 4 km, the speed could now be raised to 260 km. Serving the major cities of Shin-Osaka, Shin-Kobe, Okayama, Hiroshima, Kokura, and Hakata, the line was a precursor to a nationwideShinkansen network. Now, most trains attain a maximum speed of 300 kmph. A new station complex at Shinagawa, just south of Tokyo station, was opened in October 2003, which allowed some trains to start and terminate there, thereby increasing the number of trains on the Tokaido line from 11 to 15 per hour, that is, one every four minutes. In all, nine lines, ranging from the smallest of Hakata-Minami with just 8.5 km run by JR West, and the longest of Tokyo-Hachinohe of 593 km, totalling 2556 km are now in operation. Japan, being a relatively small country, the short runs at high speeds have successfully made the nation virtually a suburb of Tokyo. And to keep commuters happy, trains run, as suburban trains of Mumbai do, on some sections atthreeand-half-minute intervals during peak hours. Back home, we still have to dream about our own "Bullet" trains soon becoming part of the Indian scenery running between Ahmedabad and Mumbai, making the 492-km journey in just two hours against the seven now taken by the super-fast Shatabdi Express.In the process it would also put fast growing tier 2 cities such as Surat, Valsad, Bharuch, and Vadodara, on a quick transit map connecting to India's financial capital, Mumbai. With trains running at an average speed of 250 kmph, completing a journey from city-centre to city-centre in just under two hours would also save a traveller the hassles of a long commute to and from the airport, security checks and uncertaintycreated during foggy days. Trains may be delayed, but you don't have to cool your heels in the passenger lounge waiting for the announcement to board. Last but not the least, they will always reach you to the intended destination, and in one piece

Venture Capitalists to provide strategic direction to startups

The role of venture capitals has to be much more than selecting a good business to provide funding and should extend to value-creation

The importance of start-ups in an economy can-not be undermined as they are technological revolutionaries, disruptors and creators. They create new industries, provide jobs, increase income levels, improve quality of life and play a critical role in the changing the image of a nation. With as many as 50,000 startups, of which a significant increase is from tier-II and tier-III cities like Kochi, Ahmedabad and Pune, India is now considered world's 3rd largest ecosystem, according to Startup India portal.

However, failure is the other side of Startup industry. In a study conducted by Oxford Economics and IBM's Institute of Business Value, it was found that 90% of India's startups fail due to lack of innovation. In

fact, according to KPMG report, in 2020, revenue of atleast 30 percent of Indian startups declined by about 80 percent, whereas 70 percent of them had the probability of running for the next three months only.

Apart from business environment created by government and a robust banking network, a strong venture capital industry is one of the crucial requirements to develop successful startups. Overall, the success of start-ups is a collaborative effort of both entrepreneurs and venture capitalists.

Venture capitalists work in a highly competitive environment and yet typically generate a mediocre return. Add to this the high failure rate of entrepreneurs, a better working strategy is a critical need of the hour



for venture capitalists. The type of financing provided by venture capitalists is unique and very different from that provided by private equity funds or commercial banks. These organizations provide funds in the form of corporate lending to firms that are established and have a proven track record of operations and profitability. On the other hand, venture capitalists provide funding to new,

high risk, technology-oriented companies that operate in a fast and volatile environment with constantly changing paradigms. They work with entrepreneurs with an idea but fairly less experience about implementing the idea, identifying and putting together a competent team and developing the customer base. The lack of experience and an established record of performance of startups make investments in them extremely risky and uncertain. According to Harvard Business School's entrepreneurship professor Shikhar Ghosh, about threequarters of startups backed by venture capitalists are not successful enough to return cash to their investors. Therefore, the role of venture capitals has to be much more than selecting a

funding and should extend to value-creation. In addition to providing strategic direction, most venture capitalists are already extending their support to various functional aspects of start-ups. Firstly, venture capitalists help in team building in start-ups by identifying and recruiting appropriate talent, which is the most important asset of a start-up. Secondly, providing support to the administrative activities like accounting, legal and other routine organizational responsibilities can free up founders' time which can be further used for growing business. Thirdly, venture capitalists help start-ups in building the right skills for all employees and the leadership team. Fourthly, probably the most important, is providing good business and provide strategic focus by defining the

target market, underlining the scope of the product or service, identifying the competitive advantage and providing appropriate strategic direction. Additionally, support to building a customer base is an essential encouragement. And lastly, the most important aspect of venture capitalist and entrepreneur relation is access to its network. Venture capitalists also provide performance metrics to startups to monitor, measure and report their performance at their early stage.

So, on what basis should a venture capital fund decide the extent of its involvement in a startup - at a very basic level, the participation is only financial; the next level is mentorship and guidance; and the advanced level is operational. The decision is ought to be made by ana-

that represents the absolute amount of funds available. If the cash resources are strong, VCs would invest in an administrative function that would add value to a startup, and in case the cash resources are not strong, VCs can introduce the startups to their network which can meaningfully assist them. Brand resources are also very important for a VC which can be evaluated by the frequency of their citing in print, electronic and social media. Network resources are perhaps the most crucial of all contributions towards the growth of startups. Introductions to members of personal networks can help startups in either time-savings or cost-savings or both.

"We want the Russian army to leave our land, we aren't on Russian soil," Zelenskyy replied. "We won't save Putin's face by paying with our territory. That would be unjust."

In another comment, Zelenskyy sounded a forwardlooking note. "We have to think of the future of Russia. I, as president of Ukraine, say these are our neighbors. There will be other presidents, other presidents and other generations" of Russia, Zelenskyy said.

UN: Ukraine war child rights | Ukraine puts Russian crisis with school attacks

The war in Ukraine is a "child rights crisis" where education is under attack, nearly 100 youngsters have been killed in just the last month, and millions more have been forced to flee their homes, the UN children's agency said Thursday.

Omar Abdi, deputy executive director of UNICEF, told the UN Security Council that children are paying "an unconscionably high price" in the war, with 239 confirmed killed and 355 wounded since Russia's invasion of Ukraine on Februrary 24. He said the actual numbers are much higher.

"These attacks must stop," he said. "Ultimately, children need an end to this war -- their futures hang in the balance."

Abdi said the school year came to a standstill after Russia invaded its smaller neighbour, and as of last week, at least 15 of 89 UNICEF-supported schools in the country's east had been damaged or destroyed in the fighting.

"Hundreds of schools across the country are reported to have been hit by heavy artillery, airstrikes and other explosive weapons in populat-



are being used as information centres, shelters, supply hubs or for military purposes -- with long-term impact on children's return to education," Abdi said.

In mid-March, over 15,000 schools resumed education in Ukraine, mostly through remote learning or in-person hybrid options, he said. "It is estimated that 3.7 million (37 lakh) children in Ukraine and abroad are using online and distance learning options," he said.But, Abdi said "enormous obstacles" to education remain, including school availability, resources, language barriers and movement of children and their families. Less than five per cent of refugee pre-school children are estimated to be enrolled in public kinder-

Abdi and many council members spoke about what he called a "horrifying attack" on a school in the eastern Ukrainian town of Bilohorivka last weekend, when a bomb hit while women and children

sheltered in the building.

US deputy ambassador
Richard Mills said the blast killed as many as 60 people, many of them children. "And reliable reports indicate that when first responders arrived at the school to assist victims of the bombing, Russia's forces opened fire on them," he

Ukraine's UN ambassador, Sergiy Kyslytsya, said only 30 civilians were rescued and the school that had once been filled with joyful children "was turned by a Russian pilot into

The killing occurred in the early days of the war, when Russian tanks advancing on Kyiv were unexpectedly routed and tank crew retreated.

Shyshimarin, a member of a tank unit that was captured by Ukrainian forces, admitted that he shot the civilian in a video posted by the Security Service of Ukraine.

"I was ordered to shoot," said Shyshimarin, of the killing on Feb. 28. "I shot one (round)



at him. He falls. And we kept

on going."
Shyshimarin's video statement is "one of the first confessions of the enemy invaders," according to the Ukrainian security service.

The trial comes as Russia's campaign to take Ukraine's east slowly grinds on - but its invasion has resulted in widespread repercussions beyond tĥe battlefield.

Two and a half months after Russia's invasion of Ukraine sent a shiver of fear through Moscow's neighbors, Finland's president and prime minister announced Thursday that the Nordic country should apply right away for member-ship in NATO, the military defense pact founded in part to counter the Soviet Union.

Russia took losses in failed river crossing, officials say

R ussia lost significant numbers of troops and important equipment when Ukrainian forces thwarted their attempt to cross a river in the east, British officials said Friday, another sign of Moscow's struggle to win decisive victories and salvage a war gone awry.

Ukrainian authorities, meanwhile, opened the first war crimes trial of the conflict, in proceedings that will be closely watched by international observers eager to ensure atrocities are fairly prosecuted. A Russian soldier stands accused of killing a Ukrainian civilian in the early days of the war.

The trial gets underway as Russia's campaign in Ukraine's eastern industrial heartland of the Donbas makes faltering progress.

Ukraine's airborne forces command has released photos of what it said was a damaged Russian pontoon bridge over the Siversky Donets River and several destroyed or damaged Russian military vehicles nearby. Ukrainian news reports said troops thwarted Russian passage across the river earlier this week, leaving dozens of tanks or military vehicles damaged or forcing troops to abandon them.

Britain's Defense Ministry said Friday that Russia lost "significant" elements of at least one battalion tactical group — about 1,000 troops — as well as equipment used to quickly deploy a makeshift floating bridge while trying to cross the river.

Russian pipeline sanctions raise fears of gas interruption

Natural gas prices rose Friday after Russian stateowned exporter Gazprom said it would no longer send supplies to Europe via a pipeline in Poland, citing new sanctions that Moscow imposed on European energy companies. The move doesn't immediately block large amounts of natural gas to Europe but intensifies fears that the war in Ukraine will lead to wide-ranging cutoffs.

Gazprom said Thursday that it would ban the use of the Yamal pipeline that reaches Germany through Poland. While that cuts off a supply route to Europe, the pipeline's entry point to Germany has not been used in recent months. Plus, Gazprom has already cut meet Moscow's demand to make payments in rubles.

"A ban is in place on making transactions with and payments to persons under sanctions. In particular, for Gazprom, this means a ban on the use of a gas pipeline owned by (the Polish company) EuRoPol GAZ to transport Russian gas through Poland," Gazprom representative Sergey Kupriyanov wrote in a

Telegram post.

The fear is that gas disputes and cutoffs will keep escalating amid the war in Ukraine. Last month, Gazprom said it had completely cut off natural gas supplies to Poland and Bulgaria

over the rubles dispute.

On Tuesday, Ukraine's pipeline operator shut down a pipeline that carries gas from Russia to Europe, saying Russian forces were interfering with a compressor station in Russian-held territory and diverting gas. It asked Gazprom

to move gas through another pipeline, which the company said it could not do. By itself, the shutdown was not expected to cut off major amounts of gas.

Energy tensions ramped up when Russia imposed sanctions Wednesday on Gazprom Germania, a subsidiary of the Russian supplier that the German government took control of in

German Vice Chancellor Robert Habeck said the loss of gas from the Russian moves was , manageable" at around 10 million cubic meters per day and could be made up from other

sources. The actions further roiled volatile energy markets. Natural gas traded Friday at 104 euros per megawatt hour, up from 94 euros

before the announcements. "Moscow has fired a second Europe, causing fresh uncertainty and spiking prices," said Kaushal Ramesh, senior analyst

at Rystad Energy. Éuropean utilities and governments have scrambled to refill underground gas storage that was depleted over the winter and have made enough progress to cover gas needs for the year without Russian supplies. But they would face difficulty in getting through the end of the upcoming winter without rationing. High natur-al gas prices have led to higher bills for home heating and elec-

tricity generated by the fuel. European governments are trying to get off Russian energy and the EU's executive commission has proposed measures to reduce imports from Russia by two-thirds by year end. It remains to be seen if that can be achieved.

Before the war, Europe got 40% of its natural gas and 25% of its oil from Russia.

The resolution was adopted by a vote of 33 in favour, China and Eritrea voting against and 12 abstentions, including India, Armenia, Bolivia, Cameroon, Cuba, Kazakhstan, Namibia, Pakistan, Senegal, Sudan, Uzbekistan and Venezuela. deplored Russian aggression against Ukraine.India's Permanent Representative to the UN and other International Organisations in Geneva, Ambassador Indra Mani Pandey, at the session said that India's position on the Ukraine conflict has been steadfast and consistent. "We remain deeply concerned at

the unfolding developments in Ukraine. We have constantly called for immediate cessation of violence and an urgent end to hostilities," he said, adding that Prime Minister Narendra Modi has reiterated this in his interactions with global leaders, including the leaderships of Russia and Ukraine. "India continues to believe that pursuing the path of dialogue and diplomacy is the only way out," he said.

In the resolution as orally revised the Human Rights Council reiterated its demand for an immediate cessation of military hostilities against Ukraine, to refrain from any human

rights violations and abuses in the country, refrain from any State-sponsored disinformation, propaganda for war or advocacy of national, racial or religious hatred that constitutes incitement to discrimination, hostility or violence, related to the aggression against Ukraine.

The Council also requested the Commission of Inquiry to conduct an inquiry, consistent with its mandate and international standards, and in coordination with other national and international mechanisms, to address the events in the areas of Kyiv, Chernihiv, Kharkiv and Sumy regions in late February and March 2022, including their gender dimension, with a view to hold to account those responsible.

Pandey said that the impact of the Ukraine situation is being felt beyond the region as oil prices are skyrocketing, there is shortage of food grains and fertilisers in the world.

ost of the Opposition parties in Sri Lanka on Friday announced that they would not become a part of Prime Minister Ranil Wickremesinghe's interim government but would support its economic policies from outside to help the debt-ridden island nation's

early recovery.


The 73-year-old United National Party (UNP) leader was appointed as Sri Lanka's 26th prime minister on Thursday as the coun-

try was without a government since Monday when President Gotabaya Rajapaksa's elder brother and prime minister Mahinda Rajapaksa resigned after violence erupted following an attack on the anti-government protesters by his supporters. The attack triggered wide-spread violence against Rajapaksa loyalists, leaving nine people dead and wounding over 200 others.

'We cannot become a part of this Rajapaksa-Wickremesinghe government," Wimal Weerawansa, legislator for the independent roup from President Gotabaya Rajapaksa's SLPP said.

Former President Maithripala Sirisena's SLFP central committee has also decided not to be part of the The Marxist Janatha Vimukthi

Peramuna (JVP) said they would also not be part of the government



while the main Opposition Samagi Jana Balavegaya (SJB) said United as he was not even elected in National Party (UNP) leader 2020 parliamentary election.

Wickremesinghe has no legitimacy as he was not even elected in the

Madduma Bandara said the party would not accept ministerial positions and called Wickremesinghe's resignation.

JVP leader Anura Kumara Dissanayake said the decision taken by President Gotabaya Rajapaksa to appoint Wickremesinghe as Prime Minister, is one that was made with zero regard to the voice of the people. The JVP leader ridiculed the decision, saying the appointment has no legitimacy and has no democratic value.

"Wickremesinghe is a person who held the post of Prime Minister, formed governments, and yet could not even win a single seat at the last General Election. He did not even have the required number of votes to enter parliament. If an election is used to measure the consent of the people, elections have shown that he people sent him packing," he said.

The interim government idea was mooted by the powerful Buddhist clergy and civil society as a means to find a solution for the ongoing economic crisis. With Mahinda Rajapaksa's resignation on Monday, President Gotabaya Rajapaksa said he was talking to political parties to set up an interim government.

Wickremesinghe, who had been sworn in as the prime minister of Sri Lanka on five occasions before, said his primary task was to tackle the worst economic crisis with assistance from all parties. The new prime minister, who

has only his seat in the Parliament, said he commanded a majority coming from both sides.

Sri Lanka's worst economic crisis has provoked widespread protests resignation of President Gotabaya Rajapaksa. On April 1, President Rajapaksa imposed a state of emergency, lifting it five days later. The government reimposed a state of emergency on May 6 after police fired teargas and arrested students protesting near parliament, which was adjourned until May 17.

Although the protests have been overwhelmingly peaceful, the police fatally shot a protester on April 19, and on several occasions have used teargas and water cannons against protesters. The authorities have made numerous arrests and repeatedly imposed curfews. The political crisis was triggered in late March when people hurt by long hours of power cuts and essential shortages took to the streets demanding the resignation of the government.

Missile attack kills 10 Syrian soldiers: Report

Amissile struck a Syrian military bus in the country's north early on Friday, killing 10 soldiers, Syria's state-run media and an opposition monitor said.

It wasn't immediately clear who was behind the attack, one of the deadliest since a truce deal reached more than two years ago.

The official news agency SANA said "terrorists" targeted the bus in the western countryside of Aleppo, in the Anjara area. Nine soldiers were wounded in the attack, the report said.

There was no claim of responsibility. The area is dominated by the al-Qaida-linked militant group, Hayaat Tahrir al-Sham.

(UF/IFAS).

"For future, longer space missions, we may use the Moon as a hub or launching pad. It makes sense that we would want to use the soil that is already there to grow plants," Ferl said.

The researchers designed a simple experiment: plant seeds in lunar soil, add water, nutrients and light, and record the results.

They only had 12 grammes just a few teaspoons -- of lunar soil with which to do this experiment. On loan from NASA, this soil was collected during the Apollo 11, 12 and 17 missions to the moon.

Twitter deal temporarily on hold, says Elon Musk

Plon Musk said on Friday that his plan to buy Twitter for \$ 44 billion is "temporarily on hold" as he tries to pinpoint the exact number of spam and fake accounts on the social media platform, another twist amid signs of internal turmoil over the proposed acquisition.

Musk, who has been vocal about his desire to clean up Twitter's problem with "spam bots" that mimic real people, appeared to question whether the company was underreporting them.

In a tweet, the Tesla billionaire linked to a Reuters story from May 2 about a quarterly report from Twitter that estimated false or spam accounts made up fewer than five per cent of the company's "monetisable daily active users" in the first quarter.

"Twitter deal is temporarily on hold pending details supporting calculation that spam/fake accounts do indeed represent less than five per cent of users," Musk said, indicating



he's sceptical that the number of unauthentic accounts is that

It wasn't clear whether the issue could scuttle the deal. Stocks of both Twitter and Tesla swung sharply in opposite directions, with Twitter's stock tumbling 18 per cent, and shares of Tesla, which Musk had proposed using to help fund the Twitter deal, jumping five per cent.

Musk has already sold off

more than USD 8 billion worth of his Tesla shares to finance

Wedbush analyst Dan Ives, who follows both Tesla and Twitter, said Musk's "bizarre" tweet will lead Wall Street to either think the deal is likely falling apart, Musk is attempting to negotiate a lower deal price, or he is simply walking away from the deal with a USD 1 billion penalty.

"Many will view this as Musk using this Twitter filing/spam accounts as a way to get out of this deal in a vastly changing market," Ives wrote.

He added that the Musk's use of Twitter rather than a financial filing to make the announcement was troubling and "sends this whole deal into a circus show with many questions and no concrete answers as to the path of this deal going forward."

Investors have had to weigh legal troubles for Musk, as well as the possibility that acquiring Twitter could be a distraction from running the world's most valuable auto-

Fisheries subsidies: WTO talks to resolve sticky issues

Members of the World Trade Organization (WTO) will hold intensive negotiations from May 16-20 in Geneva to resolve contentious issues related to the proposed global deal on curbing harmful fishing subsidies, ahead of the 12th Ministerial Conference (MC12) next month.

The chair of the negotiations, Ambassador Santiago Wills of Colombia, has said this 'Fish Week' will be an opportunity for members to work on finalising the draft agreement, according to a WTO statement.

"WTO members on May 16-20 will hold intensive negotiations aimed at resolving remaining issues for a global deal to curb harmful fishing subsidies ahead of the MC12 next month," it said.

Members are negotiating a proposed fisheries subsidies agreement. The objective is to discipline subsidies for sustainable fishing and eliminate IUU (Illegal, Unreported and Unregulated) fishing subsidies and prohibit them from contributing to overcapacity and

begin on June 12 — that is only four weeks away. So now is the time to end decades of negotiations and conclude the WTO fisheries subsidies negotiations so that the results can be adopted by ministers," the chair said in a video message.

The 12th ministerial conference, the highest decisionmaking body of the WTO, is scheduled to meet on June 12-15 in Geneva.

'Ultimately, we should not be negotiating against each other but against the unrelenting depletion of global fish stocks so vital for livelihoods, food security, and a healthy

The contentious issues which ar yet to be resolved include matters related to special and differential treatment, and non-specific fuel subsidies.

India has time and again emphasised that it is keen to finalise an agreement on fisheries subsidies in the WTO as irrational benefits and overfishing by many countries are hurting domestic fishermen and their livelihood.

The country wants an equitable and balanced outcome as it provides support to its small and marginal fishermen who depend on the sector for sustenance.

The new plant's first phase with a manufacturing capacity of 2.5 lakh units per annum is expected to be commissioned by 2025, subject to administrative approvals.

In the first phase, the investment would be over Rs 11,000 crore, MSI said.

The site will have space for capacity expansion to include more manufacturing plants in the future," MSI

At present, MSI has a cumulative production capacity of around 5.5 lakh units per quarter or about 22 lakh units per annum across its manufacturing plants in Haryana and Gujarat. *PTI*

Govt fixes LIC issue price at ₹949 a share; policyholders, retail investors get discount



New Delhi: The government has fixed the issue price of LIC shares at Rs 949 apiece, the upper end of the IPO price band, ahead of the listing of the country's largest insurer on May 17.

However, LIC policyholders and retail investors have got the shares at a price of Rs 889 and Rs 904 a piece, respective-

(IPO) of Life Insurance Corporation (LIC) closed on May 9 and shares were allocated to bidders on May 12. The government sold over 22.13 crore shares or 3.5 per cent stake in LIC through the IPO at a price band of Rs 902-949 a share.

The retail investors and eligible employees of LIC were offered a discount of Rs 45 per equity share over the issue price, while policyholders got

As per the prospectus filed by LIC on May 12, the offer price of the share sale has been fixed at Rs 949 per equi-

Shares were allocated to policyholders and retail investors after applying the discount applicable to them.

The share sale fetched the government around Rs 20,557 largest to date -- closed with nearly 3 times subscription, predominately lapped up by retail and institutional buyers, but foreign investor participation remained muted.

So far, the amount mobilised from the IPO of Paytm in 2021 was the largest ever at Rs 18,300 crore, followed by Coal India (2010) at nearly Rs 15,500 crore and Reliance Power (2008) at Rs

Vodafone Idea debt a challenge; fundraise critical for competitiveness, say analysts

den telecom operator Vodafone Idea's financial performance in the March 2022 quarter has been in line with the industry expectations, the long-pending fundraise is crucial for the company to remain competiive, say analysts. According to a JP Morgan

report, high leverage makes the value of Vodafone Idea (VIL) equity complicated and very sensitive to small changes in assumptions, thus largely unforecastable.

"We expect value to migrate to debt holders, including the government of India, which is effectively the largest creditor via spectrum obligations including AGR dues,' the report said.

VIL expects the government to complete the conversion of around Rs 16,100 crore dues into 33 per cent stake in the company in the coming weeks, a top official of the firm

During the company's earnings call, Vodafone Idea CEO Ravinder Takkar said as part of the telecom reforms package, the company has opted for converting government dues into equity and its proposal has been confirmed by the Department of Telecom

Post the conversion, the government will hold a 33 per cent stake in the company while promoters' holding will



come down from 74.99 per cent to 50 per cent, he said.

"We have already opted for deferment of spectrum and AGR dues as well as conversion of interest arising from such ent into equity

"The net present value of the interest liability on moratorium period amounting to Rs 161.3 billion towards AGR dues and deferred spectrum liabilities have been confirmed with the DoT. With this we expect the conversion sub process to conclude in the coming weeks," Takkar said.

JP Morgan said that the March 2022 quarter was a decent one but fundraise still remains critical for VIL's com-

"The board has approved another Rs 100 billion (Rs 10,000 crore) of fundraise and the company is in talks with investors and lenders. We improve competitiveness," the

India-UAE trade pact to create huge job opportunities, boost economy: Goyal **Mumbai:** The comprehensive

trade agreement between India and the UAE will help in creating huge job opportunities and boost growth of the domestic economy, Commerce and Industry Minister Piyush Goyal said on Friday.

The bilateral pact, officially dubbed as the Comprehensive Economic Partnership Agreement (CEPA) is expected to increase the bilateral trade in goods to over USD 100 billion and trade in services to over USD 15 billion within five years. It came into effect from

May 1. The agreement opens the door for many sectors, particularly labour-intensive ones such as textiles, gem and jewellery, pharmaceuticals and agriculture, Goyal said while briefing the media along with the UAE Minister for Economy Abdullah Bin Touq Al Marri here. The ministers launched 'India-UAE Start-up Bridge' at the India-UAE Partnership Summit, organised by industry body CII here.

'Clearly millions of jobs will be added if our exports which are now at about USD 36 billion, which is about nearly Rs 2.5 lakh crore, grows as we are planning. And my own guess estimate is this partnership can finally go up to about USD 250 billion of bilateral trade on both sides.

"So my sense is that this will give a big boost to economic growth, to jobs. And the opportunities it opens not only in the UAE, but in the larger ground for the African region. (It) should significantly give a bump up to the Indian economy as well," Goyal said.

He added that the pact would not only open doors for Indian businesses to UAE but also to other countries as UAE is a transit point for large parts of Africa, CIS (Commonwealth of Independent States) countries, and the Gulf region.

CIS countries include Armenia, Azerbaijan, Belarus, Kazakhstan, Georgia, Kyrgyzstan, Moldova, Russia, and Tajikistan. Further, Goyal said that

Indian pharma products will get immediate access to the UAE market and "we believe (bilateral) trade will grow to at least to USD 100 billion in the near future....Our own commitment is to take it to a much higher level". According to the minister,

"I'm very proud to belong to great, very ambitious club, ays aiming higher."

Donnarumma arrived in France after being named the best player in the European championships which Italy won.

'The debut was not easy, because it was my first outside Italy, in a new club, a new city (but) pressure, no," explained Donnarumma, who had spent six years in Milan.
