The India Meteorological Department (IMD) on Sunday said that the current heatwave that has been making life tough for people and animals alike, is likely to abate over Delhi and adjoining parts of northwest and central India from Monday.

The IMD predicted a partly cloudy sky with the possibility of thunder development at isolated places over Delhi, Himachal Pradesh, Punjab, Haryana-Chandigarh, east

This is likely to give some respite to residents from the scorching heat as the IMD had on Saturday informed that northwest and central India had recorded the highest temperatures in April in 122 years. March was also the hottest month in 122 years.

Meanwhile, the World Meteorological Organisation has announced that maximum temperatures in widespread

Rajasthan and parts of Uttar areas hit 43-46 degrees Celsius on April 28 and that the extreme heat will last until May 2. The IMD data showed that

Bikaner in Rajasthan was the hottest city on Sunday recording 47 degrees Celsius, followed by Ganganagar at 46.9 degrees

At least 30 cities across India recorded the maximum temperature above 44 degrees

PM Modi sets off on three-nation tour

Europe trip coming at time when region is facing many challenges. says Modi

PNS NEW DELHI

Drime Minister Narendra Modi on Sunday said his three-nation visit to Europe, starting Monday, comes at a time when the region faces many challenges and choices. He also said he intends to strengthen the spirit of cooperation with European partners. The visit comes in the backdrop of the ongoing Russia-Ukraine conflict and several nations in Europe are

now against Russia.

It will be the Prime Minister's first overseas visit this year and Modi will tour Germany, Denmark and France. In a statement, the Prime Minister said he would be visiting Berlin on May 2 at the invitation of German Chancellor Olaf Scholz, following which he will travel to Copenhagen on May 3-4 at the invitation of his Danish counterpart Mette Frederiksen to hold bilateral engagements and also participate in the Second India-Nordic Summit.

On the way back to India, Modi said, he will make a



brief stopover in Paris for a meeting with French President Emmanuel Macron. "My visit to Europe comes at a time when the region faces many challenges and choices," Modi

'Through my engage ments, I intend to strengthen the spirit of cooperation with our European partners, who are important companions in India's quest for peace and prosperity," the Prime Minister said in his departure statement. Detailing his engagements, Modi said his visit to Berlin will be an opportunity to hold detailed bilateral discussions with Chancellor Scholz, whom he met at G-20 last year in his previous capacity as Vice-Chancellor and Finance Minister.

"We will co-chair the 6th India-Germany Inter-Governmental Consultations (IGC), a unique biennial format which India conducts only with Germany. Several Indian Ministers will also travel to

Germany and hold consultations with their German counterparts," Modi said. The Prime Minister said

he sees this IGC as an early engagement with the new Government in Germany, within six months of its formation, which will be helpful to identify priorities for the medium and long term.
In 2021, India and

Germany commemorated 70 years of the establishment of diplomatic relations and have been strategic partners since 2000, he noted

Underlining the long-standing commercial ties between India and Germany that form one of the pillars of their strategic partnership, Modi said Chancellor Scholz and he would also jointly address a Business Roundtable with the goal of energising industry-to-industry cooperation, which will help strengthen the post-Covid economic recovery of both countries.

GST revenues touch all-time high of ₹1.68 L cr in April on improved compliance

New Delhi: Amid rising inflation and growing joblessness, there is some good news for the Indian economy. The Goods and Services Tax (GST) colection in April touched the highest-ever level of about ₹1.68 lakh crore, up 20 per cent from the period a year-ago, on improved compliance, the Finance Ministry said on Sunday. In April this year, 1.06 crore returns in GSTR-3B were

The gross GST collection in April is ₹25,000 crore more than the previous highest collection of ₹1.42 lakh crore recorded in March. The gross GST revenue collected in April is ₹1,67,540 crore, of which CGST is ₹33,159 crore, SGST is ₹41,793 crore, IGST is ₹81,939 crore (including ₹36,705 crore collected on import of goods) and cess is ₹10,649 crore (including ₹857 crore collected on import of goods), the Ministry said.

Zomato staffer, 2 teens die in horrific car-bike crash

ov died and two others suffered major injuries in a high-impact crash involving a car and a motorcycle in East Delhi's Shakarpur area on Sunday. The car turned turtle following the collision, trapping its occupants. Two of the deceased have been identified by the police as sisters Jyoti (17) and Bharti (19) who were inside the car, while the third victim is the motorbike rider wearing a Zomato T-shirt, who

is yet to be identified. After the accident, all the seven car occupants — members of a family — were taken out of the vehicle by the police. According to police, the bike was in front of the car but the sequence of events that led to the accident is yet to be established. The CCTV cameras are being scanned to ascertain its

Three persons, including two teenagers and a Zomato of Police (Éast) Priyanka Kashyap said, "On May 1, around 1 a.m., a PCR call about an accident involv car and a bike on Vikas Marg was received at Shakarpur police station. The staff immediately reached the spot and found one damaged motorcy-cle and one Wagon R car turned upside down." Both the vehicles were severely damaged

Debt-ridden Pak gets \$8bn package from **Saudi Arabia**

In a huge relief to Pakistan, major economic slump, the beleaguered nation has secured a "sizeable package" of around \$8 billion from Saudi Arabia during the visit of Prime Minister Shehbaz Sharif, reported local media.

The generous \$8 billion package from Saudi Arabia includes a doubling of the oil financing facility, additional money either through deposits or Sukuks, and rolling over of the existing \$4.2 billion facili-ties, reported *The News* International.

Bengal BJP MP threatens stir against Centre's raw jute price cap

Global warming could cause next pandemic, warns study

The world, which is reeling under the impact of the Covid-19 pandemic, just got some more bad news. As the Earth heats up, researchers have predicted that wild animals will be forced to relocate their habitats — likely to regions with large human populations — dramatically increasing the risk of a viral jump to humans that could lead to the next pandemic.

Climate change could drive over 15,000 new cases of mammals transmitting viruses to other mammals, say researchers who have studied the link between climate change and viral transmission.

The study conducted by the research team led by scientists at Georgetown University and published in Nature, is one of the first to predict how global warming will shift wildlife habitats, increase



encounters among species capable of swapping pathogens, and quantify how many times viruses will jump between The study is "a critical first

demic", says Kate Jones, who models interactions between ecosystems and human health at University College London, and who was not involved in

SC junks PIL seeking 'cooling off period' for babus to contest polls

The Supreme Court has refused to entertain a PIL to impose restrictions to prevent civil servants from contesting elections immediately after retirement or resignation from service, by imposing a "cooling off period", saying it cannot direct the legislature to enact a

A bench of Justices Indira Banerjee and A S Bopanna said whether there should be any "cooling off period" for civil servants for them to contest elections or not is best left to the legislature concerned.

"In this case, there is no complaint of violation of any fundamental right of the petitioner or any group of persons represented by the petitioner. Nobody has the fundamental right to get a mandatory order of this court directing the appropriate legislature to enact law or the executive to frame rules imposing restrictions on the eligibility of civil servants to contest elections. This writ petition cannot, therefore, be entertained by this court," the bench said.

The top court said a mandamus cannot be issued to direct the respondents to enact law and/or to frame rules even

ferred under Article 226 of the Constitution.

"A mandamus lies for enforcement of a fundamental right or a statutory right, or the enforcement of a fundamental duty related to enforcement of a fundamental right or a statu-

"In exceptional cases, a writ may even lie for enforce-ment of an equitable right. The breach or threat to breach a fundamental, statutory or may be enforceable equitable right, is the sine qua non for issuance of a writ of mandamus," the bench said.

The apex court said this court or a high court cannot direct the legislature to enact a particular legislation or the executive to frame rules.

This court, and/or the high court, does not give any direction to the State to enforce an Act passed by the legislature. Nor does the court enforce instructions in a departmental manual not having statutory force, any non-statutory scheme or concession which tion made by an authority such as the Election Commission.

does not give rise to any legal right in favour of the petitioner, far less, any recommenda-

"It is for the Union of India

ommendation of the Election Commission, in accordance with law. It is not for this Court to decide what should be the policy of the government. Policy matters are never interfered with, unless patently arbitrary, unreasonable or violative of Article 14 of the Constitution," the bench said.

The top court said it cannot even issue a mandamus to the government for enforcement of a Cabinet decision.

"It is only when an administrative order confers rights or creates estoppel against the government, that mandamus can be issued to enforce the circular. Similarly a mandamus may be issued to cancel an administrative order, which violates the rules of fairness," the bench said.

The apex court said there can be no doubt that law may be enacted, laying down the norms and qualifications for contesting specific elections.

There can be no doubt that civil servants should maintain the highest ethical standards of integrity and honesty; political neutrality; fairness and impartiality in the discharge of duties, courtesy, accountability and transparen-cy."Integrity, impartiality, neutrality, transparency and honesty are non-negotiable. Ethical standards necessarily have to be enforced and stringent action taken against the officer concerned whenever there is any breach of ethical standards as laid down in the All India Services (Conduct) Rules, 1968.

It is not for this court to interfere in matters relating to framing of law, rules or policy, the bench said. "Whether there should be

any 'cooling off period' for civil servants for them to contest elections or not is best left to the legislature concerned.The allegations of bureaucrats deviating from strict norms of political neutrality with a view to obtaining party tickets to contest elections, is vague, devoid of particulars and unsupported by any materials which could justify intervention of this court.

"No particulars have been given of the number and/or percentage of erstwhile bureaucrats, who have contested elections on the ticket of a political party, not to speak of any act on their part, prior to their retirement, in deviation of the standards required of bureaucrats," the bench said while dismissing a plea filed by one Vivek Krishna.

Kashmiri youths travelling to Pakistan on valid visas sneak back in with terrorists

17 killed so far

Seventeen Kashmiri youths who had travelled to Pakistan on valid travel documents but sneaked back into the valley have been killed in anti-terror operations, with officials raising concerns that the ISI has adopted a new modus operandi to paint the militancy here as an indigenous movement.

Since 2015, a large number of youngsters procured travel documents to visit Pakistan to pursue higher studies, meet relatives or for marriage purposes, officials said.Recently, the University Grants Commission and the All Indian Council for Technical Education, the higher and technical education regulators of the country, had issued a statement, advising students not to travel to Pakistan for pursuing higher

Indian national/Overseas Citizen of India who intends to take admission in any degree college/educational institution of Pakistan shall not be eligible for seeking employment or higher studies in India on the basis of such educational qualifications (in any subject) acquired in Pakistan," the UGC and the AICTE had said in a joint statement.

The reason, the officials said, was that these youths were brainwashed across the border and some of them were imparted with arms training or used for money

laundering.
The State Investigation
Agency (SIA) of Jammu and Kashmir Police has filed a charge sheet against a Hurriyat leader and others for selling MBBS seats in Pakistani colleges and using the proceeds for terror activ-

Hundreds of students from Jammu and Kashmir have travelled to Pakistan in recent years for higher studies and a few of them were brainwashed, provided arms training or recruited in sleeper cells with a motive to gather information to be shared with the handlers sitting across the border, the officials said. They said a well-oiled separatist lobby would arrange recommendation letters from Hurriyat leaders and other valid travel documents from the Pakistan Embassy to facilitate their visit to Pakistan for

All the arrangements of parents as well as students in Pakistan were usually done by the separatists under a wellplanned conspiracy with their co-conspirators based in Pakistan.

The students were made to appear in the National Talent Search (NTS) test at Hurriyat office in Pakistan as a stealth tactic to make them believe that they were writing a pre-qualifying test which would lead to their admission in professional colleges in Pakistan.Such tests were mostly facilitated by Kashmiri separatists and their relatives who had gone to Pakistan in the 1990s to get illegal arms training and had settled in Pakistan-occupied Kashmir and other areas there.

After the test, some of the students were brainwashed and taken for arms training and later pushed into Jammu and Kashmir along with infiltrating terrorists.

The officials said that as

many as 17 youths who had gone on valid travel documents to Pakistan and were believed to be in that country receiving education were killed either at the Line of Control or during encounters, leaving their parents in disbelief. Security officials have been tracking the youths who travelled to Pakistan on valid visas for short durations and disappeared after their return as they believe that they could be possible sleeper cells of terror groups operating from across the border.

Security agencies believe that there was a six weeks training course for new terror recruits and intelligence inputs suggest that some of the youths were provided a quick module of fabrication of improvised explosive devices using easily available explosive material within a week's time.

'BJP creating artificial issues like Hindi national language debate, hijab controversy to divide Indians'

Senior Congress leader Abhishek Manu Singhvi has alleged that the BJP was creating "artificial issues" such as the debate over "Hindi as the national language" or hijab

controversy to divide Indians and cautioned people against fighting amongst them-selves "on the saffron party's

Singhvi, in an interview with PTI, called West Bengal Chief Minister Mamata Banerjee a "vital and indispensable" part of the anti-BJP space but refused to acknowledge her as the only opposition

On Congress-TMC relations, the Rajya Sabha member from West Bengal said that the

Trinamool Congress's attack on the Congress was in the context of assembly elections in Goa and other states, and "we will have to wait for the whole thing to pan out for the 2024 Lok Sabha polls".

He said that reforms are needed in the Congress but it doesn't necessarily have to take place holding the hand of poll strategist Prashant Kishor, who did not join the grand old party after negotiations between the two sides failed.

"BJP is fishing in troubled waters, it is creating Frankenstein monsters...They want to divide, scare, provoke and antagonise people. Someday they bring up hijab, someday they find language. These are artificially created issues. They draw you into the



them...Don't fight on their terms," he said on the sidelines of the annual awards ceremony of the Ladies Study Group Charitable Trust in Kolkata on Saturday.

Union Home Minister Amit Shah's statement in April that Hindi should be accepted not to local languages evoked a controversy.

Presiding over the 37th Official Parliamentary Language Committee meeting in Delhi, Shah had said that Prime Minister Narendra Modi has decided that the medium of running the gov-

ernment is in the official language and this would definitely increase the importance of

Singhvi, however, batted for the 1968 three-language formula first incorporated into the National Education Policy by the Indira Gandhi govern-

"We have a three-language formula - English, Hindi and the local language. It has stood the test of time for the last 60 years. But the BJP is trying to destablise it as per their political gameplan," he said.

The three-language formula calls for study of Hindi, English and a modern Indian language (preferably from the South) in Hindi-speaking states and Hindi, English and regional language in non-

Hindi speaking regions.

On Banerjee, Singhvi said, "I have been repeatedly saying that Mamataji is a vital and indispensable part of the non-BJP space. But to say that she is the only opposition face, this exclusively monopolising approach is wrong. But nobody can deny she is a pillar of strength for the entire non-BJP

Noting that the TMC's approach of attacking the Congress and stressing on the importance of regional parties was limited to assembly elections in Goa and other states, he said, "We will have to wait for the whole thing to pan out for the 2024 general elections. Who knows what will happen

He said that the sooner all opposition parties realise that their strength lies in preventing a split in anti-BJP votes the On Banerjee repeatedly

calling for more space for regional parties in national politics in place of Congress, Singhvi asserted, "It is very clear that no party can ignore or devalue Congress in any non-BJP formation. 77-yr-old builder found dead with throat slit

In a shocking incident, a 77-year-old builder was brutally murdered by unknown persons in his home in north Delhi's posh Civil Lines area on Sunday morning. According to police, the victim, identified as Ram Kishore Agrawal, was sleeping alone when the unknown attackers broke into his house, robbed a large amount of cash from the room and attacked him with a weapon. Police said some cardboard boxes containing cash were also found missing from the room of the deceased and robbery is suspected to be the motive behind the killing.

Agrawal, a resident of Kothi number 1, Ram Kishore Agarwal Marg of the Civil Lines area, used to live on the ground floor of his two-storey house while his son and family lived on the first floor.

The entire family was inside the house when the incident took place. The builder's wife had passed away last year due to coronavirus.



They have four-five servants in their house, police said.

According to Sagar Singh lsi, the Deputy Commissioner of Police (DCP), North district, on May 1, at 6:52 am a police control room (PCR) call was received at Civil Lines police station from a person informing about the death of his father.

"He told police that his father had been found with his throat slit and was taken to hospital," said the DCP adding that Agrawal was declared brought dead at Sushrut Trauma Centre

"During initial investigation, it has been revealed that at around 6:40 am, Agrawal's

bed with four knife injuries on his body and some cardboard boxes containing cash were also found missing from the room. Though the exact amount of cash is yet to be ascertained," said the DCP.

"However, a security guard told police that he had spotted two persons trying to flee from the house in the early morning hours," said the DCP.

"Police have registered a case under section 302 (murder), 397 (Robbery, or dacoity, with attempt to cause death or grievous hurt) and 34 (common intention) of Indian Penal Code (IPC) at Civil Lines police station and an investigation has been taken up," said the DCP. "The spot was inspected by

the crime team and multiple teams have been formed from across the district to nab the culprits at the earliest," said the

Meanwhile, police teams are also scanning CCTV cameras in the area to identify the accused and to ascertain the crime sequence, said police.

Eye conditions like allergies and infections are quite prevalent in summers due to scorching heat and industry experts are of the view that this time of the year is crucial to take care of ocular health.

"Allergies, infections such as conjunctivitis and dry eye are some of the conditions. We need to be extra careful as these conditions can worsen if timely medical advice is not followed," says Dr. Tushar Grover, Medical Director, Vision Eye Centre, New Delhi.

High level of pollutants and irritants in the air pose another challenge. The symptoms may include itchiness, redness of the eyes or experiencing a burning sensation.

"Our eves become sensitive during summer, so it is essential to protect them. Even if you are wearing contact lenses, wearing eyeglasses can protect your eyes,

says Dr Chikirsha Jain, Senior Consultant, Retina and Ophthalmology, Ujala Cygnus Rainbow Hospital, Agra.

In case one does not use roper eye protection, he/she can also develop dry eyes as the tear film in the eye can evaporate more quickly. If left untreated, the condition may lead to eye inflammation.

"Exposure to sun's ultraviolet rays during the summer months can increase the risk of various eye conditions, reiterating the imperativeness of regular eye examinations. As schools have reopened now, eye examination must be considered as a mandate in school readiness.

"Studies show that the pandemic has increased the number of children who may be identified with myopia and those who have refractive error may further need correction," says Dr. Rishi Raj Borah, Country Director, Orbis India.

HC directs Govt to decide complaint against pvt school

The Delhi High Court has ■ directed the Delhi Government to decide within six weeks a complaint against a private school here for allegedly charging an excessive fine on delayed payment of tuition

Hearing a petition by Ajay Aggarwal, father of two students studying in classes 12 and 8 in the school, Justice Rekha Palli directed the department of education to decide the petitioner's complaint by passing a reasoned and speaking order in accordance with the laid down procedure and principles of natural justice.

In case the petitioner is aggrieved by any order passed by the authorities, it will be open to the petitioner to seek legal recourse as permissible in

"The writ petition... is accordingly disposed of by directing the respondent no. 2 (DoE) to decide the petitioner's complaint dated 22.12.2021 by passing a reasoned and speaking order within a period of six weeks in accordance with the laid down procedure and by following principles of natural justice," the court said in its order dated April 27.

The counsel for the Delhi Government told the court that the authorities will examine the petitioner's complaint and expeditiously pass an order. The petitioner claimed that the private school in question indulged in unethical practices, including levying excessive late fines on delayed payment of tuition fees, which was in utter violation of the Delhi School Education Rules

The Transport Department of the Delhi Government valid certificate of fitness. Íf caught without a valid fitness certificate, vehicle owners may face imprisonment up to one year or fine up to Rs 10,000 or

The move comes after the department found that many such vehicles were found plying without valid fitness certificates in violation of the the Motor Vehicles (MV) Act. The enforcement teams have been asked to keep looking for such vehicles on the roads and soon a drive will be launched to catch the violators, said a senior officer of Delhi government's Transport department.

"It has been observed by the Transport department that many owners or drivers, including transport vehicles belonging to government departments, local bodies and public sector units, are plying transport vehicles without valid fitness certificate which is gross violation of The Motor Vehicles (MV) Act, 1988 and rules framed their under," said a public notice recently issued by the Transport department.

All vehicle owners and drivers, including those using public service vehicles, goods carriage vehicles, buses and cabs of schools and colleges, need to have a valid vehicle fitness certificate.

According to section 56 of the MV Act, a transport vehicle is not deemed to be validly registered unless it carries a valid certificate of fitness issued by the Transport department of

Such transport vehicle is not eligible to ply on the roads till the fitness certificate is obtained. According to rule 62 of the Central Motor Vehicles Rules, 1989, the fitness certificate is valid for a period of two years for vehicles up to eight years old and one year for vehicles older than eight years.

The owners and drivers plying transport vehicles with-out valid fitness certificate attract a fine of Rs 2,000-5,000 for first offence and Rs 5,000-10,000 for second and any subsequent offence. In such cases, there is also a provision of imprisonment of owner or driver, the notice said.

The fitness certificate for erickshaws and e-carts is valid for a period of 3 years

SDMC chalks out plan for waste management

According to a senior SDMC official, with the inception of several measures such as setting up of an 'engineered landfill site', a new waste to energy plant, material recovery facility, etc, the civic agency is rapidly achieving its goal of

proper waste management. While informing the details of the plan for the Okhla landfill site, he said that this landfill site is spread over an area of about 47 acres and the land has been allotted to the civic agency

for setting up a new landfill site.
"South Corporation has planned to close the existing landfill site in a phased manner and for segregation of traditional and legacy waste at this site, 25 trommel machines of 2500 tons per day capacity have also been deployed. The

traditional method of segregation of 51 lakh metric tonnes of garbage at this landfill site is expected to be completed by December 2023," he informed. "The civic body has also planned to construct a new waste to energy plant in Tehkhand," said a senior official adding that the work to set up a new waste to energy plant is going on in a speedy manner. Once operational, the facility will be able to dispose of 2000

tons of garbage every day and

He was apparently referring to the ongoing Kussia-Ukraine con-

Interacting with media after inspecting Guard of Honour here on Sunday, the new Army chief said he will focus on the ongoing reforms, restructuring and transformation of the Army to enhance its operational and functional efficiency besides giving importance to achieving self-reliance

He said his "utmost and foremost" priority would be to ensure very high standards of operational preparedness to face current, contemporary and future security challenges across the entire spectrum of

On the situation at the Line of Actual Control(LAC)in Ladakh, Pande said in an interview to ANI, the Indian troops are holding important physical positions and will not permit any change in the status quo or any loss of territory.
Calling the situation at the

LAC normal, he said the Indian Army has given an adequate response to unilateral and provocative actions by China to nange the status quo by force. On the India-China border

talks, the new Army chief said the process is ongoing. "We believe this is the way forward. We are confident that as we continue to talk with the other side we will find a resolution to the ongoing issues," he said.

Highlighting the pre-paredness of the Indian security forces, the Army Chief said additional equipment and troops have been inducted in the border areas. Our focus has also been on infrastructure development to match logistic and operation requirements, he added.

On the situation with

Pakistan, Pande said the DGMOs of the two armies arrived at an understanding a year ago that helped in improving the situation for the civiland situation for the civilian population on the ground on both sides of the Line of Control(LOC).

The Army chief said he will take forward the "good works" of his predecessors, and assured the soldiers and officers of the Army that ensuring their welfare will be his key priority.

Pande on Saturday took charge as the 29th Chief of the Army Staff after incumbent General M M Naravane retired. Pande, who was serving as the Vice Chief, became the firstever officer from the Corps of Engineers to rise to the top job.

"I am aware of the big responsibility and I am praying to God that I am given strength, capability and wisdom so that I can carry on with the responsibility," Pande said.

Pak MBBS degree not valid in **India, NMC cautions aspirants**

The National Medical Commission (NMC) has cautioned medical aspirants in India against travelling to Pakistan for an MBBS degree, BDS or any other equivalent medical degree, making it clear that such degrees will not be valid.

The NMC, top medical education regulator body said that such students shall not be eligible to appear for FMGE or seek employment in India on the basis of the educational qualifications gained from universities in the neighboring country.

"Any Indian national or overseas citizen of India who intends to take admission in Bachelor of Medicine Bachelor of Surgery (MBBS) or Bachelor of Dental Surgery (BDS) or equivalent medical course in any medical college of Pakistan shall not be eligible for appearing in Foreign Medical

Graduates Examination (FMGE) or seeking employment in India on the basis of educational qualifications (in any subject) acquired in Pakistan except those who had joined Pakistan degree colleges before December 2018 or later after obtaining security clearance from Ministry of Home Affairs till date," stated Dr Sandhya Bhullar, secretary, NMC in a circular on April 28, 2022.

However, the Commission has also clarified that migrants and their children who acquired higher education or medical degree in Pakistan but have been awarded Indian citizenship will still be eligible to appear for FMGE/NEXT and seek employment in India, after obtaining Security Clearance from the Union Ministry of Home Affairs.

This notice from the NMC comes a days after a similar notice was issued by UGC and AICTE. In the notice, which was issued on April 22, the UGC and the AICTE said that any Indian national or overseas citizen of the

country who intends to take admission in any degree college or educational institution of Pakistan "shall not be eligible for seeking employment or higher studies in India"

Sources said that higher education regulatory bodies have taken the step following consultations among the Union Home Affairs Ministry, Union Ministry of External Affairs and NMC officials in view of continuation of terrorist funding activities from the neighbouring country. The NMC had earlier issued

a warning against the online medical courses being offered by several Chinese universities. Students aiming to pursue medical or any other courses from foreign universities have been advised to "exercise due diligence, said the Apex medical reg-

2 new Omicron sub-lineages can dodge antibodies from previous infection: Study

wo new sub-lineages of the 1 Omicron coronavirus variant can dodge antibodies from earlier infection well enough to trigger a new wave, but are far less able to thrive in the blood of people vaccinated against COVID-19, South African scientists have found.

The scientists from multiple institutions were examining omicron's BA.4 and BA.5 sub-lineages - which the World Health Organization last month added to its monitoring list. They took blood samples from 39 participants previously infected by omicron when it first showed up at the end of last year.

Fifteen were vaccinated eight with Pfizer's shot; seven with J&J's -- while the other 24 were not. "The vaccinated group

showed about a five-fold higher neutralization capacity ... and should be better protected," said the study, a pre-print of which was released over the weekend.

In the unvaccinated samples, there was an almost eightfold decrease in antibody production when exposed to BA.4 and BA.5, compared with the original BA.1 omicron lineage. Blood from the vaccinated people showed a threefold decrease.

South Africa may be entering a fifth COVID-19 wave earlier than expected, officials and scientists said on Friday, blaming a sustained rise in infections that seems to be driven by the BA.4 and BA.5 omicron subvariants.Only about 30 percent of South Africa's population of 60 million is fully vaccinated.

"Based on neutralization escape, BA.4 and BA.5 have potential to result in a new infection wave," the study said.

India has enough stock of edible oils, says Govt

Quoting industry sources, the Ministry of Consumer Affairs has said that the present stock of all edible oils in the country is around 21 LMT (lakh metric tonne) while another 12 LMT is in transit, arriving in May 2022 in the country.

On the oilseeds front, the Department of Agriculture and Farmers Welfare's second advance estimate released in February 2022 shows a positive picture of soyabean production for the year 20221-22 at 126.10 LMT, which is higher than last year's production

of 112 LMT, the ministry

As a result of the higher sowing of Mustard seeds by 37 per cent in all major producing states including Rajasthan in comparison with last year, the production may

rise to 114 LMT in the 2021-

Palm oil (Crude + Refined) constitutes roughly around 62% of the total edible oils imported and are imported mainly from Indonesia and Malaysia, while Soyabean oil (22%) is imported from Argentina and Brazil and Sunflower oil (15%) is imported mainly from Ukraine and Russia.

In a statement, the ministry said that a close watch is being kept on day to day basis on prices of Edible oils so that appropriate measures can be taken to keep a check on the prices of edible oil for ensuring that the prices remain stable and interest of

The Inter-Ministerial Committee held weekly on Agri-Commodities chaired by Secretary (Food) closely monitors the prices and availability of agricultural commodities including edible oil keeping in view the interest of the farmers, industry and

consumers. The committee reviews orice situation on weekly basis, consider relevant measures in relation to edible oils and other food items depending on the domestic production, demand, domestic and international prices and international trade volumes. Special teams have also been constituted by both Central & State Governments to prevent hoarding and profiteering under the Essential Commodities Act. These surprise checks shall continue to check unscrupulous elements.

Indian education sector biggest target of cyber threats, remote learning among key triggers: Report

India is the biggest target of cyber threats to educational institutions and online platforms followed by the USA, the UK, Indonesia and Brazil, according to a report.

The report also says that the adoption of remote learning during the COVID-19 pandemic, digitisation of education, and prevalence of online learning platforms are key triggers that enlarged the attack surface.

The report, titled "Cyber Threats Targeting the Global Education Sector", also claimed that data shows a 20 per cent increase in cyber threats to the global education sector in the first three months of 2022 when compared to the corresponding period of 2021.

The report has been compiled by the Threat Research and Information Analytics Division of CloudSEK, a Singapore-based AI-driven Digital Risk Management Enterprise. CloudSEK's XVigil plat-

form scours thousands of sources (across the surface, deep and dark web) to detect cvber threats, data leaks, brand threats and identity thefts. "Of the threats detected in Asia and Pacific last year, 58 per

cent of them were targeted at Indian or India based educational institutions and online platform. Indonesia was distant second being the target of 10 per cent cyber threats. This included attacks on BYJU's, IIM Kojhikode and Tamil Nadu's Directorate of Technical Education," the report said.

"Overall, the USA was the second most affected country across the globe with a total of 19 recorded incidents, accounting for 86 per cent of the threats in North America. These include ransomware

attacks on prestigious institutions such as Howard University and University of California. In addition, highrisk API vulnaribilities were uncovered in Coursera, the massive open online course provider," it added. According to Darshit

Ashara, Principal Threat Researcher at CloudSEK, the growing global education and training market both online and offline, is expected to reach USD 7.3 trillion by 2025. This promising outlook is predicated on the expanding

education technology market,

population growth and increasing digital penetration in developing countries. Hence, it's no surprise that cybercriminals are gravitating towards entities and institutions in the sector," Adoption of remote learn-

ing by schools, universities and related entities to combat the disruption caused by the ongoing COVID-19 pandemic; large-scale digitisation of educational content material, student data and documents and online learning platforms catering to the needs of everybody ranging from preschool children to retired professionals are among the reasons listed in the report, behind the

The report findings indicate that several cybercriminals are actively leaking databases,



accesses, vulnerabilities and exploits, and other information belonging to educational institutions, on cybercrime forums.

"Databases and accesses are the most commonly sought after data types. The databases leaked from educational

institutions primarily contain information Personally Identifiable Information (PII) of students and their families, including name, date of birth, email address, phone number,

and physical address; website

user records and credentials

and examination results and The experts have asserted

in the report that given the size and impact of the education sector, it is critical for institutions, students, parents, teachers, and the government to ensure that the information gathered and stored is not leaked and exploited by cybercriminals.

Creating awareness among users regarding cyber-attacks, online scams, and phishing campaigns; enacting strong password policies and enable multi-factor authentication (MFA); updating and patching software, systems, and networks on a regular basis; maintaining multiple backups, both online and offline, in separate and secure locations; monitoring logs for unusual traffic and activity to websites and other applications are among the recommendations made in the report. 'The institutions should

block illegitimate IP addresses and deactivate port forwarding using network firewalls. They should perform real-time monitoring of the internet to identify and mitigate low-hanging threats, such as misconfigured apps, exposed data, and leaked accesses, that are leveraged by cybercriminals to carry out large scale attacks. "The students, parents, fac-ulty, and staff should avoid

clicking on suspicious emails, messages and links; not download or install unverified apps; use strong passwords and enable multi-factor authentication (MFA) across accounts," the report added.

The observance of May 1 as Labour Day brings no hope for betterment to about 1 lakh labourers employed in Aligarh's lock and hardware units when seminars, conferences and rallies were organized in different parts of the city to mark Labour Day. Getting education for their children aged 8 to 14 years is a mirage. For earning little sums, they pay a heavy price in terms of their health by working in closed room under unhygienic conditions.

Busy in searching rags from the garbage container of Nagar Nigam kept at the roadsides in Aligarh Development Colony of Marris road, Labour Day meant another day for Suneeta and RajKumari, labourers engaged in Brick kiln in the unorganized sector. Aligarh district ranking second in the state for labours engaged in both the organized and unorganized sectors. The offices of district magistrate and deputy labour commissioner have not come out with a single plan or project which can act as a silver lining in the process of welfare of labour Although government has introduced more than 17 welfare scheme for labour but they are running on papers as out of 1 lakh, only 8000 labour are registered in labour depart-

Belonging to large families, Suneeta work with her three sisters, all aged below 20 years and involved in rags picking business, to provide evening meals for her family. Raj Kumari is the eldest among her six brothers and sisters. Her other brothers are also engaged in a polishing locks factory. Not only this, several poor

and street girls holding a sack on their back bigger than the children's height do their duty of collecting useful rags in front of convents schools on Ramghat Road at the same time when children of rich families come out with joys after finishing their day studies by schooling and none notices the yawning gap between the two. The labour department

conducts raids just to achieve



the given target and then what happens to the like Suneeta and Raj Kumari Seema after that, the department is not concerned with.

These labours do not have any roof. They do not get any support from any non govern-ment organizations. Life for them is hard but they do not complain of harsh realities of

daily life. They appear to be as satisfied as a moneyed person. They do not leave others to think of their wreathed condition. So this labour Day has no meaning to life.

Not only this, ninety three percent of the one -lakh-strong unorganized workers in Aligarh work as bonded labourers. And 85 percent of them cannot avail weekly offs without pay cults, while 0.5 percent workers succeeded in drawing additional wages for additional works. These are the findings in study conducted by Bonded Labour Liberation Organization, an NGO from

Aligarh administration including Labour Department is apathic to the blatant violation by Private Employers of the Supreme Court Verdict regarding mandatory weekly, closure of all shops and factories thus depriving the workers a weekly rest day.

According to Labaour Act, weekly closure is compulsory for everyone whether concerned under the Shop and Commercial Establishment Act or Factory Act. These Acts stipulate that the employers are bound to give four days rest without any pay deduction in a month to their employees.

Besides this, not a single migrants workers from other states like Bihar, Bengal and Orissa has received benefits entitled under the Inter-State migrant Workman's Act 1979.

It is learnt that out of 2 lakh unorganized workers, 36 percent are migrant workers from Bihar, Bengal and Orissa.

The main markets of Aligarh like Railway Road, Mahavirganj, Centre Point, Ramghat Road and Sudamapuri are scheduled to be closed on Tuesday. Similarly markets in Muslim areas like Amir Nishan, Dodhpur and Upper Kot should remain closed on Friday. But these markets operate throughout the week due to the negligent attitude of the labour department. The employees are also forced to slog for long hours in the shops and factories, stretching beyond the statutory 10

"This end to end online pension portal has been developed to make the process of receiving pension simpler and it will eliminate the need for pensioners to go anywhere physically," he added.

India's leading legal luminary Soli Sorabjee's biography hits stands

The first ever authorized L biography of Soli Sorabjee, one of the leading legal wizards of modern times, who played a prominent role in many Constitutional issues in postindependence has hit book shelves across India. "Soli Sorabjee: Life and Times" authored by Abhinav Chandrachud, takes readers through the most tumultuous period of India marked by many communal riots, Ram Janmabhmi Temple issue and Constitutionals crisis.

Sorabjee, who was keeping good health, was claimed by the pandemic Covid-19 on April 30, 2021. The biography has been released on April 30, the first anniversary of Sorabjee. Besides being a widely respected lawyer, Sorabjee cian of good standing.

Soli Sorabjee, a name synonymous with Indian judicial system, holds many distinctions which may not have many parallels in the country's history. A contemporary of the legendary Nani Palkhivala, Sorabjee was highly critical of the Hindutva forces when they demolished the structure by name Babri Masjid. Language of justice

It is a long-standing tussle between link language and common language

anguage is an emotive issue in India. It was the basis of the reorganisation of the Indian states. The logic was that people who spoke the same language are better off living in the same State. However, there are places where people cannot speak their languages. The Supreme Court and the High Courts are examples where even linguistic chauvinists are expected to follow the court language - English. Early this year, such a case came before the Gujarat High Court. A journalist, facing contempt proceedings, addressed the bench in Gujarati. The court asked him to speak only in English. The contemnor insisted on speaking in the local language, arguing everyone in Gujarat speaks Gujarati. The bench offered him the services of an interpreter and refused to accept his submissions when he did not speak English. In its order, the court said "we will not permit the contemnor to address the court in the language which is not understood by this court". Article 348(1)(a) provides that the proceedings before the Supreme Court and High Courts should be conducted in English unless the law provides otherwise. Uttar Pradesh, Bihar, Rajasthan, and Madhya Pradesh are authorised to use Hindi in their High Courts. Tamil Nadu, Gujarat,



Chhattisgarh, West Bengal and Karnataka have sought permission to use their respective local languages. In 2012 and in 2016, the Chief Justice of India after extensive deliberations disapproved of the proposals. The official website of the Department of Justice says "the Government has abided by the decision of the Supreme Court".

On Saturday, the Prime Minister told a joint conference of Chief Ministers and High Court Chief Justices that local languages must be used in the courts because "unless the common man understands the basis of the justice, there is no difference

between justice and a Government order". The Chief Justice of India said it would happen over some time. Both the Executive and the Judiciary are aware of two facts. One, under Article 348(2), the Governor of a state may "authorise" the use of "any other language" in the proceedings of the High Court. Two, the CJI can permit the use of a local language in a High Court. The problem is that the High Court judges are at present seamlessly transferred to various states because the language of the courts is English and not the local language which they may not understand. Secondly, the language of the court, used for articulation and writing judgements, must be precise, certain and understood by all officers of the courts. Thirdly, the current system of the higher judiciary is unified by a link language which would stand disrupted by the use of local languages. And yet, the fact remains that the litigant, the ordinary citizen, has the fundamental right to "understand" and participate in court proceedings and the judgement delivered. The question is how to reconcile these issues without either emotion or politics creeping in.

he shocking report of a Police inspector getting a body massage from the mother of a rape accused in a police outpost in Saharasa district has once again underlined the grim reality that the difference between the criminal and police is fast getting blurred. The Inspector has been placed under suspension after the video went viral. But everyone knows what happens in cases of such suspension. An inquiry held, bribe paid, and the culprit exonerated. By then the media forgets



the epoxide and the victims are terrorized to remain silent. Such police atrocity does not take place only in far-flung places of states like Bihar. But Delhi, which takes pride in its policing, has its own black sheep. A fortnight ago, the Delhi High court sought a status report on a vigilance inquiry in a case of police atrocity that led to spinal injury to a victim. The inquiry found that the charges of police atrocity were true. The police actively frame innocent citizens to brush up their own records, too. Take the infamous case of Liagat. The 46-year-old Liagat Shah of frontier district Kupwara in Jammu and Kashmir was arrested on March 23, 2013, at the Indo-Nepal

border as a "suspected" Hizbul Mujahideen (HM) terrorist. Later, it was established that the police had created fake documents and shown fake seizures of weapons from him to frame him up. Liagat was returning home from across the border of Kashmir along with his family. He wanted to take advantage of the rehabilitation policy for those who had crossed over to the Pakistani side of Kashmir in the early 1990s and now wanted to return home and live a dignified life.

But sadly successive Governments, both at the Centre and states have done nothing to make the police accountable. The police have been given such caste blanche to play with the lives of people, only because people in power need them to execute their designs. When we are talking about freedom, liberty, the right to equality, Ram Rajya, and national pride, it's time we guarantee the self-respect and dignity of the common man from the law enforcement agencies. If the police cannot nab criminals for a variety of reasons in many cases, at least they should not make scapegoats of innocent citizens.

Hurdle in excellence in higher education



We all understand why Vice-chancellors in some states work under tremendous political pressure

reat institutions the world over owe their credibility and acceptability to academic leaders, who get respect and admiration for generations. Recall the creation of Banaras Hindu University (BHU) by Pandit Madan Mohan Malaviya. He could persuade Dr. S. Radhakrishnan to accept its Vice-Chancellorship. It would be impossible now. There are set rules, regulations, and laid-down procedures to select a VC. The VC presides over considerable funds and makes a considerable number of academic and non-academic appointments. He too has to follow clearly articulated rules, regulations, and procedures. We all understand why VCs in some states work under tremendous political pressure. In the majority of the States, the Governor is also the Chancellor of state-funded universities. He has the statutory authority to oversee the process and procedure for the appointment of VCs and holds the power to select the person he considers best from among the panel of three/five names prepared by the search committee. In the ancient Indian tradition of knowledge quest, which led to the creation of great global centers like Taxila, Nalanda, Vikramshila, and others, the Kulapati - now VC is supposed to be an embodiment of knowledge, scholarship, values, compassion, empathy, and an outstanding luminary of eminence. He is the ultimate Acharya, his conduct and behavior have to be exemplary. That is why, independent India put such appointments within the authority of the Governor, who is supposed to be a non-partisan person. There are ample instances - again, exceptions apart - that we had and have- Governors/ Chancellors who strictly adhered to values and principles in appointing university leaders. Of course, some Chief Ministers, who want total control of the universities, do not relish such independent assertion

It was in early December when the Keraia Governor, Arif Mohammad Khan, deeply peeved by the blatant interference of the state government, offered interests or the aspirations of

to transfer the powers of Chancellor to the Chief Minister. The CM had given another term to his favorite VC, without any concurrence of the Chancellor, the legally stipulated appointing authority. It was done against his wishes. They are worried about the recommendations in the National Education Policy - NEP-2020 - which proposes the constitution of a strong Board of Governors -BoG -and shall become the appointing authority of the VCs and other heads of the Higher Education Institutions -HEIs. The NEP-2020 mentions: "It is envisaged that all HEIs will be incentivized, supported and mentored during this process, and shall aim to become autonomous and have such an empowered BoG by 2035." Some politicians in power are disturbed about it. The Kerala and Tamil Nadu Governments are supposed to be working on their own education policy, rejecting the NEP-2020. If it happens, it would damage the interests of the young people from these states permanently, on the national and also

international stage. Despite impediments being thrown in the well-initiated implementation of the NEP-2020, the nation must move ahead with the policy mandate, which said, "It is effective governance and leadership that enables the creation of a culture of excellence and innovation in higher education institutions. The common feature of all world-class institutions globally including India has indeed been the existence of strong self-governance and outstanding meritbased appointment of institutional leaders."

In the third decade of the 21st century, several luminaries have predicted ted at the time of decimation of the era of imperialism that 'future empires shall be empires of knowledge. This has already come true. Nations that fail to realize its import shall certainly lag behind others. However, it is encouraging that Indian academia and scholarship accept the new outlook, and its finds reflection in the resolve made at the national level —

"All leadership positions and Heads of institutions shall be offered to persons with high academic qualifications and demonstrated administrative and leadership capabilities

along with abilities to manage complex situations. Leaders of an HEI will demonstrate strong alignment to constitutional values and the overall vision of the Institution, along with attributes such as a strong social commitment, belief in teamwork, pluralism, ability to work with diverse people, and a positive outlook. The selection shall be carried out by the BOG through a rigorous, impartial, merit-based, and competencybased process by an Eminent Expert committee constituted by the BOG.

Some politicians need to be reoriented on what India needs to better the lot of its generations ahead. The task is to bring education out of and away from political interference; the uninitiated must be brought to the fold in light of the words of Mahatma Gandhi: "To me political power is not an end but one of the means of enabling people to better their condition in every department of life."

SILENCE OF THE STRESSED CITIZEN

When freedom is the exercise of voice - one's own or the collective's

ay before yesterday, I heard a mynah on the kitchen window sill - its tone rang clear. There was conviction, energy and a deep declaration in the chirp. It struck me that fewer people speak like that, and a discreet quietude is more in vogue. Is there a decline in the number of questions or beliefs we ought to express ourselves on? A friend recently remarked that there are more - isms than before but far fewer believers. If we consider an - ism to be a set of strongly held beliefs, a few come immediately to mind. Progressivism and conservatism. Activism and fatalism. Skepticism and utopianism. Science has fostered an abandonment of intense beliefs because it shows us that our schematic understanding necessarily changes perhaps 2-3 times in a century. We have to stay open to a change of paradigm. This seems to leave us with prag-



matism and opportunism! There may be deterrents to an open exchange of views or to an exploration of possible positions. For a few, it could be a lack of access and opportunity, but there are many more who opt to not have a say or to be disengaged. A popular phrase that came up in US politics is 'silent majority'. But what might it mean - is it to be understood as a tacit assent, an apathy, or as a muted protest. Many tell us that our vote is our main opportunity but they forget that it is voice that is actually participation. A vote is once in a few years. Many of our freedoms, in order to be exercised, could call for the exercise of voice. A citizen of a State isn't like a subject in a monarchy - hers is a participatory role. Will the State reflect mainly its powerful, affluent and privileged while it promotes the welfare of the disadvantaged? The modern conservative feels this to be right - proper for economic prosperity, offering reward and opportunity while being considerate to weaker sections as they are sometimes termed in India. Subscribers to various shades of reformism want more visibility, role and even dominance of large communities in the populace, who have been only toilers and troops in earlier centuries. Conservatives and reformists differ on how to use incentives and concessions to spur development. Their priorities don't match. The reformists or progressives are doubtful about the efficacy of the trickle-down model of prosperity and want to guarantee essentials that the bottom rungs cannot afford on their own.

The simple challenge before humanity is to see if it is feasible to adequately reward doctors, teachers and researchers. Somehow a market-dependent, commercialised way of delivering healthcare and education, while providing ready funding on a large scale, also brings them down to the level of wall enamels or mango varieties. Defence personnel serve with a special code and dedication, different from civilians. Similarly, medicare, education and lab research too are fundamentals. There ought to be enough prestige and common perks to keep these specialists out of the market scramble. That's the hurly-burly where mammon takes precedence over man. Unaffordability is as much or a steeper barrier as untouchability, and thus a modern-day casteism has resulted: some term it as 'capitalism'. In the last 300 years or so, since many formal tracts in economics started to get published, concepts like use value and exchange value have been unrestrictedly applied across all types of services. Prior to this era, it's not like there wasn't efficiency, standard of service, and continuous upgradation in capacity in medicine, scientific research and education. Market principles maybe, but the struggle for these basics silences the potential mynahs.

Noida Land Scam, a throwback - Part IV



RERA failed to detect limitations on 70 per cent of the Sports City plot, endangering the interests of home-buyers

hough the Noida Authority had committed to monitor the progress of project in the brochure, none of the envisaged sport infrastructure projects has been completed as yet. Neither has the Authority encashedon the indemnity bond of the allottees for failure to complete the project within stipulated time.

In case of allotments in SC 01 in

Sectors 78/79(allotted in May 2011), SC 01 in Sector 150 (allotted in May 2011) and SC 02 in Sector 150 (allotted in September 2014), the allottees were required to complete the project in phases within five years from the date of execution of lease deed. In case of SC-01 in Sector 152 (allotted in July 2015), the allottee was required to complete the construc-tion of the international level cricket stadium in the first phase within three years and the remaining residential and commercial projects within five years from the date of execution of the lease deed.

The C&AG has pointed out that

plots for Sports Cities were allotted without preliminary consultation with national/international bodies like BCCI, ICC and without fixing and prescribing the technical specifications, etc., required for different sports infrastructure -golf course, international level cricket stadium, Tennis centre, Multi-purpose Sports Hall for Gymnasium, Volleyball, TT, Basket Ball etc. They also didn't do any due-diligence and analysed the reasonableness of the rates/bids quoted by the allottees. It was therefore no wonder that none of the envisioned sports infrastructure have been completed in last ten years though the construction of sports infrastructure was to be given priority in Sport City and completed first and only afterwards, other residential and commercial projects were to be taken up. However, the allottees took up the GH projects first and two residential projects have not only been taken up but completed or partially completed.

Though the terms and conditions prescribed in Brochures permitted sub-division of the plots meant for only residential and commercial use (30% of the sport city plots), the Authority allowed sub-division of the entire plot (826 acres) of the sport city projects into 81 sub-plots thereby destroying the entire concept of development of integrated Sport City. The 578 acres of land earmarked for sport infrastructure in 4 sport cities was too subthe objectives of Integrated Sports infrastructure like nine-hole golf course in three sport cities in sectors-78/79 and 150, international cricket stadium in Plot SC-02 in sector 150, unachievable. The work on cricket stadium has not even commenced though it was to be completed by the end of 2018. The Authority has not yet encashed the indemnity bond of

It is also observed that UP RERA has registered residential and commercial projects of the allottees/sub-allottees without noting the limitations on the use of 70 percent of plot of land for Sports infrastructure as mentioned in the lease agreement executed by the Authority. As none of the major Sport infrastructure has been undertaken till date and none of the 9-hole golf courses and International Level Cricket Stadium are likely to be complet-ed in near future, the homebuyers of those residential projects being constructed are likely to face issues in getting their flats registered. Incidentally, most directors of all 4 SPCs at the time of allotment have since resigned and left. The decision of the Noida Authority to approve the use of increased FAR of the entire area of the sport city in residential/ commercial projects of allottees/sub-allottees without ensuring the construction of integrated sport infrastructure in 70% area of each Sport city project is injudicious and highly improper. It would affect the future prospects of the home buyers of these residential projects as their flats cannot be régistered unless envisioned integrated sport infracity project.

Further, the C&AG has determined that NOIDA Authority had given significant incentives of Rs 8,643.61 crore in terms of reduced pricing of plots and allowance of extra Floor Area Ratio (FAR) and Ground Coverage (GC) to the 3 real estate developers for development of sporting infrastructure as against the payment of ₹5598 crores made for 33, 44, 193 sqm (826 acres) of land. Keeping in

these three developers. NOIDA Authority, while allowing the builders to pursue group housing projects, abdicated its total responsibility towards completion of

envisioned sports infrastructure. Thus, the world class sports infrastructure envisioned by the Board in 2007 for holding national and international sports events failed to materialise even after a decade. Though the main objectives of establishment of sports city have not been achieved, these developers appeared to have grabbed nearly 825 acres of prime land in the city at one-third of the market rate with aid and abetment of senior officials of the Authority. Incidentally, there was a single CEO of the Authority who dealt with the allotment of Sport City plots in 2010-11 and 2014-2015.

Discretionary allotment of Farm Houses at prime locations on throwaway prices: In 2009-2011, Noida Authority allotted 157 plots for farm houses of 10,000 sqm each aggregating prime sectors of Noida at one-fifth of market rates in an arbitrary and discretionary manner mostly to big business houses, influential real estate developers/ builders, politicians, prominent lawyers and their family members without following any transparent bidding process under schemes which did not have any objective criterion for selection of the beneficiaries. Many companies, their directors, family members etc cornered multiple plots at throwaway prices. There was no bidding and selection of allottees was done based on an

Allotment of 11 plots (FH -3 & FH-19/164, FH-4 & FH-18/164, FH-2 & Fh-20/164, FH-5/164, FH-6/164, FH-17/164 and FH-1 & FH-20/165) was made on 30 March 2011 to the companies/entities of the same group (Anil Kumar and Company).

Allotment of four plots (FH-2, 3, 4, 5 sector 131) was made on 27 July 2009 to a group of companies with the promoter/director (Rajiv Kumar).

Allotment of seven plots (FH-15 & FH-18/128, FH-25 & FH-26/128, FH-27, FH-28 & FH-29/128) was made on 30 October 2009 to four companies of the same promoters (Sanjeev J Aeren and Sunita S Aeren).

Allotment of seven plots (FH-16 & FH-17/128, FH-11 & FH 22/128, FH-23, FH-24 & FH-33/128 was made (two on 26 March 2010 and five on 30 October 2009) to three companies (Meadows Infradevelopers Pvt. td., Glory Infrabuild Pv Handful Infra Developers Pvt.Ltd.) of same promoters (Ankur Chadha and Geetu Arora).

In two cases it was observed that four plots (FH-11 & FH-22/128, FH-12 & FH-21/128) of sector 128 of two companies (Meadow Infradevelopers Pvt. Ltd and Snerea realtors Pvt. Ltd.) allotted on 30 October 2009 were transferred to the same individual, Vichitra Lata, on 28 September 2010. (To be continued)

Futuristic forest management strategies

Today it is essential to enlarge the scope of the forest service and rename it as Indian Forest and Environment Service

n the corridors of Indira Paryavaran Bhawan there ▲ are whispers about the the Environment Minister's intention to revamp the forest service cadres.The Indian Forest Service (IFS)is one of the oldest civil servicesand today is in the midst of a big challenge to meet the growing aspiration of the changing society in view of rising population, shrinking resources base, dependency of tribal and rural poor on the forests as also of agriculture and water availability in the country. The threat of climate change and meeting the millennium development goals and the role played by forest in environmental conservation, climate change mitigation and adaption have assumed international dimensions and hence there is a need to revamp the cadre manage-

ment of various levels of posts. One of the weakest links in environmental management is the lack of an organized set up at the field and district level. A few years ago, there was a proposal to enlarge the scope of Forest Service and rename it as Indian Forest and Environment Service (IFES). Today it is considered essential to do by reorganizing the IFS. The training of officers shall have to be revised to broaden the course contents. The present cadres of pollution control board, etc., shall be subsumed in this new service. At the headquarters there should be different independent wings to give focus to emerging challenges in the

The job profile of foresters of all rankshas changed a lot since its organizational struc-



ture was created in British period which proved the test of that time. However, after independence, the number of posts increased haphazardly to meet the new policy framework yettoday the structure remains truncated at the point of delivery i.e. the forest beat level which is headed by the forest guards who have no in depth knowledge of policy issues and spreading dimensions of forest

district level the set-up is incongruous with civil administration. In Tripura, the government in 2015 replaced the Divisions with functional territorial forest sub-division headed by the State Forest Service (SFS) officers. The Ranges were made co-terminus with blocks and the District set-up with District Forest Officers made co-terminus with civil administration for better coordination and to integrate with other departments and for better man power utilization. There may be more officers at the district level for other line functions but territorial administration becomes unified and focused. The experience improved the efficiency at delivery point with the use of state forest officers gainfully. This

management and also at the exercise should be done all over India by review of SFS, range officers and other subordinate cadres. The forest beats should be headed by the forester rank official. Forest Thana should also be established in certain locations. All ranks in subordinate forest officials should be at par with police in rank and pay. Like police personnel the forest field staff must be paid 13 months' salary and other facilities. Forest field staff needs to be provided with better weapons, vehicles and other infrastructure to meet the challenges from smugglers. However, in many big forested districts like Saranda and Chaisbasa, etc., it may be possible to do it by posting more Additional DFOs in senior scale.

Forests constitute more than 21 percent of our land mass. Many economists argue that its contribution to GDP should also be commensurate. Eco-development has tremendous potential to garner revenue for the government as well as local people and farmers and it should be made central activity of forest management. National and State level independent Eco-development wings/ boards or corporations need to be set up to harness the potential.

It would be necessary to set up a study group outside the Ministry to propose changes and then discuss it extensively with states before implementation.

Ukrainians plead for Mariupol rescue, Russian advance crawls

krainian forces fought village by village Saturday to hold back a Russian advance through the country's east, while the United Nations worked to broker a civilian evacuation from the last defensive stronghold in the bombed-out ruins of the port city of Mariupol.

An estimated 100,000 civilians remain in the city, and up to 1,000 are living beneath a sprawling Soviet-era steel plant, according to Ukrainian officials. Ukraine has not said how many fighters are also in the plant, the only part of Mariupol not occupied by Russian forces, but Russia put the number at about 2,000.

Russian state media outlets reported Saturday that 25 civilians had been evacuated from the Azovstal steelworks, though there was no confirmation from the UN Russia's RIA Novosti news agency said 19 adults and six children were brought out, but gave no further details.

A top official with the Azov Regiment, the Ukrainian unit defending the plant, said 20 civilians were evacuated during a cease-fire, though it was not clear if he was referring to the same group as the Russian news reports.

children," Sviatoslav Palamar said in a video posted on the regiment's Telegram channel. He also called for the evacuation of the wounded: "We don't know why they are not taken away and their evacuation to the territory controlled by Ukraine is not being discussed."

Video and images from inside the plant, shared with The Associated Press by two Ukrainian women who said their husbands are among the fighters refusing to surrender there, showed unidentified men with stained bandages; others had open wounds or amputated limbs.

A skeleton medical staff was treating at least 600 wounded people, said the women, who identified their husbands as members of the Azov Regiment of Ukraine's National Guard. Some of the wounds were rotting with gangrene, they said.

In the video the men said that they eat just once daily and share as little as 1.5 litres (50 ounces) of water a day among four people, and that supplies inside the besieged facility are depleted.

One shirtless man appeared to be in pain as he described his wounds: two broken ribs, a punctured lung and a dislocated arm that "was



hanging on the flesh".

"I want to tell everyone who sees this: If you will not stop this here, in Ukraine, it will go further, to Europe," he said.

AP could not independently verify the date and location of the video, which the women said was taken in the last week in the maze of corridors and bunkers beneath the

Pelosi meets Zelenskyy in Kyiv, vows to help Ukraine defeat Putin

U.S. Speaker of the House Nancy Pelosi has met with Ukraine's president. Footage released early Sunday by President Volodymyr Zelenskyy's office showed Pelosi in Kyiv with a Congressional delegation. Those with Pelosi included Reps. Jason Crow, Jim McGovern and Adam Schiff.

Zelenskyy told the delegation: "You all are welcome." Pelosi later said: "We

believe that we are visiting you to say thank you for your fight for freedom. We are on a frontier of freedom and your fight is a fight for everyone. Our commitment is to be there for you until the fight is done."

The visit was not previously announced.Pelosi met with Zelenskyy in Kyiv

The American legislators assessed Ukraine's needs for the next phase of the war, with U.S. Military, humanitarian Democrat from New York would stand with the country until it defeats Russia.

Pelosi, a California Democrat who is second in line to the presidency after the vice president, was the most senior American lawmaker to visit Ukraine since Russia's war began more than two months

Her previously unannounced visit came just days after Moscow bombed the Ukrainian capital while the U.N. Secretary-general was

Pelosi and a half-dozen U.S. Lawmakers met for three hours late Saturday with Zelenskyy and his top aides to get a first-hand assessment of the war effort to date.

Their visit came two days after U.S. President Joe Biden asked Congress for \$33 billion to bolster Ukraine's fight against Russia, more than twice the size of the initial \$13.6 billion aid measure that Congress enacted early last month and now is almost drained.

Regiment, the Ukrainian unit defending the plant, said 20 civilians were evacuated during a ceasefire, though it was not clear if he was referring to the same group. There was no confirmation from the UN.

"These are women and children," Sviatoslav Palamar said in a video posted on the regiment's Telegram channel. He also called for the evacuation of the wounded: "We don't know why they are not taken away and their evacuation to the territory controlled by Ukraine is not being discussed."

Video and images from inside the plant, shared with The Associated Press by two Ukrainian women who said their husbands are among the fighters refusing to surrender there, showed unidentified men with stained bandages; others had open wounds or amputated limbs.

Evidence mounts of GOP involvement in Trump election schemes

 $R_{\text{Capitol}}^{\text{ioters}}$ who smashed their way into the U.S. Capitol on Jan. 6, 2021, succeeded — at least temporarily — in delaying the certification of Joe Biden's election to the White House.

Hours before, Rep. Jim Jordan had been trying to achieve the same thing. Texting with then-White House chief of staff Mark Meadows, a close ally and friend, at nearly midnight on Jan. 5, Jordan offered a legal rationale for what President Donald Trump was publicly demanding — that Vice President Mike Pence, in his ceremonial role presiding over the electoral count, somehow assert the authority to reject electors from Biden-won states. Pence "should call out all electoral votes that he believes are unconstitutional as no electoral votes at all, Jordan wrote. "I have pushed for this," Meadows replied. "Not sure it is going to happen."

The text exchange, revealed in a court filing from the congressional panel investigating the Jan. 6 riot, is in a batch of startling evidence that shows the deep involvement of some House Republicans in Trump's desperate attempt to stay in power. The evidence provides new details about how, long before the attack on the Capitol unfolded, several GOP lawmakers were participating directly in Trump's campaign to reverse the results of a free and fair election.

It's a connection that members of the House Jan. 6 committee are making explicit as they prepare to launch public hearings in June. The Republicans plotting with Trump and the rioters who attacked the Capitol were aligned in their goals, if not the mob's violent tactics, creating a convergence that nearly upended the nation's peaceful transfer of power.

"It appears that a significant number of House members and a few senators had more than just a passing role in what went on," Rep. Bennie Thompson, the Democratic chairman of the Jan. 6 committee, told The Associated Press last week. Since launching its investigation last summer, the Jan. 6 panel has been slow-



ly gaining new details about what lawmakers said and did in the weeks before the insurrection. Members have asked three GOP lawmakers — Jordan of Ohio, Rep. Scott Perry of Pennsylvania and House Minority Leader Kevin McCarthy of California — to testify voluntarily. All have refused. Other lawmakers could be called in the coming days.

So far, the Jan. 6 committee has refrained from issuing subpoenas to lawmakers, fearing the repercussions of such an extraordinary step. But the lack of cooperation from lawmakers hasn't prevented the panel from obtaining new information about their actions.

The latest court document, submitted in response to a lawsuit from Meadows, contained excerpts from just a handful of the more than 930 interviews the Jan. 6 panel has conducted It includes information on several high-level meetings nearly a dozen House Republicans attended where Trump's allies flirted with ways to give him another term.

Among the ideas: naming fake slates of electors in seven swing states, declaring martial law and seizing voting machines. The efforts started in the weeks after The Associated Press declared Biden president-elect.

Black doctors say they face discrimination based on race

Dr Dare Adewumi was thrilled when he was hired to lead the neurosurgery practice at an Atlanta-area hospital near where he grew up.

But he says he quickly faced racial discrimination that ultimately led to his firing and has prevented him from getting permanent work elsewhere.

His lawyers and other advocates say he's not alone, that Black doctors across the country commonly experience discrimination, ranging from microaggressions to careerthreatening disciplinary actions. Biases, conscious or not, can become magnified in the fiercely competitive hospital environment, they say, and the underrepresentation of Black doctors can discourage them from speaking up.

"Too many of us are worried about retaliation, what happens when you say something," said Dr Rachel Villanueva, president of the National Medical Association, which represents Black doctors. "We have scores of doctors that are sending us letters about these same discriminatory practices all the time and seeking our help as an association in fighting that."

According to the Association of American Medical Colleges, Black doctors made up just 5 per cent of active physicians in the US in 2018, the most recent data

Sloganeering against Pak PM in | Woman rescued 50 hours Saudi: Police books Imran, 150 others under blasphemy laws

A case under stringent blasphemy laws was registered against Pakistan's ousted premier Imran Khan and 150 others, including some members of his former cabinet, in connection with the hounding of Prime Minister Shehbaz Sharif and his delegation at Masjid-e-Nabwi in Saudi Arabia, officials said. Video clips circulating on social media showed some pilgrims - apparently supporters of Khan – shouting 'chor' (thief) and 'gaddar' (traitor) as soon as Sharif and other members of his delegation arrived at the Prophet's Mosque in Madina last Thursday.

The Pakistani pilgrims also used abusive language against the delegation members. Madina police claim to have arrested five Pakistanis involved in the sloganeering.

Punjab police on Saturday night registered an FIR against Khan, who is also the chairman of the Pakistan Tehreek-e-Insaf (PTI) and 150 others, including former federal ministers Fawad Chaudhry and Sheikh Rasheed, former adviser to the prime minister Shahbaz Gul, former deputy speaker of the National Assembly Qasim Suri, and Khan's close aides in London, Anil Musarrat and Sahibzada Jehangir, officials said.

The case has been registered in a police station in Faisalabad, around 180 km from Lahore, on the complaint of local resident Naeem Bhatti on the charges of desecration of the Prophet's mosque in Madina, hooliganism and hurting the sentiments of Muslims, they said.

The FIR has been registered under different sections, including 295 A (deliberate and malicious acts intended to outrage religious feelings of any class by insulting its religion or religious beliefs) of the Pakistan Penal Code.

According to the FIR, over 100 supporters of Khan were sent to Saudi Arabia from Pakistan and the UK to carry out the mission of targeting Sharif and his delegation at Masjid-e-Nabwi in Madina. Khan and other nominated leaders of the PTI had given directions to party workers in this regard, it said.

'Strictly speaking, we are below the threshold limit of management control but then, what government really means is that management control is to be given in such a way that a private entity picks up and runs the bank, and government in the process gets value out of that," Kumar said.

He further said that "since LIC is also in the picture, my stand has always been very clear that we will also divest along with the government, but it may be 49 per cent.

So, it will depend on how this whole transaction plays out and what kind of investors express interest". He further said LIC does not want to

holding as it has been a winwin for both entities.

IDBI Bank has been the strongest contributor to the bancassurance channel, he said, adding for the bancassurance arrangement to continue LIC may not require to hold the entire stake

The committee has suggested that the insurers should be allowed to adopt a modular approach using various permuta tions and combinations for Combi MI (Micro Insurance) prod ucts. 'MI' aims to protect low-income people with insurance products that are affordable. The objective of MI is to empower people to cope with and recover from common risks such as death of the breadwinner, paying for treatment of serious illnesses, reconstructing destroyed homes and businesses, among others.

A one-stop solution to meet the insurance protection needs of these targeted groups will go a long way in achieving the objective of increasing insurance penetration in these strata of society, the panel said in its report. "There is a case to have a Combi MI product which can be

developed on a modular basis, giving flexibility to the insurer to offer coverage to different groups and individuals as per their specific protection needs," the report said.

The panel has recommended 14 standard modules and suggested that such products may be sold by insurers either on indi vidual basis or group basis.

Insurers, it said, may follow a modular approach using various permutations and combinations, leaving the choice to the proposer. Certain standard products prescribed by the Insurance Regulatory and Development Authority of India (IRDAI) can be offered as modules

Several industry leaders hint that they will reduce their reliance on palm oil in phases and shift to alternatives such as rice bran oil and cottonseed oil for food products.

Last week Indonesia, the world's largest palm oil producer, banned shipments of crude palm oil (CPO), adding to the previous sanctions on refined oil, to soften the prices in its domestic market. However, the Indian indus-

try and experts expect the impact of this will be transitory in nature as Indonesia consumes only around one-third of its palm oil output.

India Ratings and Research (Ind-Ra) "believes that the ban is unlikely to sustain for a long duration, given that Indonesia consumes less than 40 per cent of its total palm oil production, resulting in the impact being

India is the world's largest importer and second-largest consumer of palm oil, which accounts for around 30 per cent of the country's edible oil consumption, said Ind-Ra.

Expressing similar views Mayank Shah, senior category head at Parle Product, said palm oil is perishable and eventually they (Indonesian exporters) would have to open up. Their production is much higher than the local requirement.

"Hopefully, there could be some reversal in this in the next 10 days as it is not possible for them to continue with the ban for a longer time," Shah told PTI.

Resolution primary objective of IBC; but need to be mindful of recovery too: SBI MD J Swaminathan olution, disregarding the recov-

Mumbai: The primary objective of the Insolvency and Bankruptcy Code (IBC) process is resolution of a distressed firm, but the recovery percentage also needs to be ept in mind, SBI Managing Director J Swaminathan said on Sunday.

Financial and operational creditors owe money to companies facing insolvency proceedings and so recovery has to be an important factor while achieving resolution of stressed assets, he noted.

"All of us clearly understand, as the lenders' forum, that resolution is the primary objective of legislation like IBC. So, I don't think that there is any moving away from that particular point.
"We will stay the course on

those lines, despite the criticism that either we are being pushed more towards recovery, or we are just being mindful of a resery percentage," Swaminathan said at an event organised by Indian Institute Management, Ahmedabad.

He, however, added that while attempting a resolution, "we cannot lose sight of recovery".Swaminathan said if the narrative starts building towards haircuts, then it is likely that the lenders may not take any decision, which will lead to paralysis, and then the stressed units will go into liquidation. "In such a case, the entire objective of legislation like IBC towards resolving corporate stress in an orderly manner will be defeated," he pointed out. Haircut taken by lenders as part of resolution plans approved under IBC refers to the shortfall in recovery to creditors as compared to their claims submitted in the

As prices rise fuel sales growth moderates, LPG consumption falls

New Delhi: India's petrol and diesel sales growth moderated in April while cooking gas LPG consumption fell as record high prices dented demand, preliminary industry data showed on Sunday.

Petrol sales growth mod-

erated to 2.1 per cent in April when compared with the same period in the preceding month, while diesel demand was almost flat. Cooking gas LPG, which had consistently shown growth even during the pandemic period, saw a massive 9.1 per cent month-on-month drop in consumption during April. State-owned oil firms had on March 22 ended a 137day hiatus in rate revision and began passing a USD 30 per barrel increase in cost of raw material (crude oil) during that period when five states including Uttar Pradesh went to polls.

Petrol and diesel prices



rose by Rs 10 per litre between March 22 and April 6 -- the highest-ever increase during a 16-day period since fuel prices were deregulated two decades back.On March 22, cooking gas prices too were hiked by Rs 50 per cylinder to Rs 949.50 -- the highest-ever rate for the subsidised fuel. The price increases moderated the consumption.

Petrol sales by state-owned fuel retailers, which control roughly 90 per cent of the market, at 2.58 million tonnes during April were nearly 20.4 per cent higher than the same period last year.

India-UAE trade pact comes into force

New Delhi: The free trade agreement between India and the UAE has come into effect on Sunday, under which domestic exporters in various sectors like textiles, agriculture, dry fruits, gems and jewellery will get duty-free access to the UAE market.

In a symbolic gesture for operationalising the agreement, Commerce Secretary BVR Subrahmanyam handed over Certificates of Origin to three exporters from the gems and jewellery sector here.

These consignments to Dubai will not attract any customs duty under the pact, which is officially termed as Comprehensive Economic Partnership Agreement

The Central Board of Indirect Taxes and Customs

(CBIC) and the Directorate General of Foreign Trade (DGFT) has issued relevant notifications for the operationalisation of the agreement from May 1.

"Today, CEPA between India and the UAE is coming into force. Today, we are sending the first consignment from India to UAE, which will benefit from this agreement," Subrahmanyam said here.

The UAE is the second or third largest trading partner of India and that country is a gateway to the middle east, North Africa, Central Asia and sub-Saharan Africa, he noted. The trade pact will help in

taking the two-way trade to USD 100 billion in five years from the existing USD 60 billion. "USD 100 billion is just a starter...As we go along, it will

become USD 200 billion and then USD 500 billion in the years to come," the secretary said, adding 99 per cent of "our exports will go to zero duty in UAE". The gems and jewellery sector contributes a substantial portion of India's exports to the UAE and is expected to benefit significantly from the tariff concessions obtained for Indian products under this pact.Overall, India will benefit from preferential market access provided by the UAE on over 97 per cent of its tariff lines (or goods), which account for 99 per cent of Indian exports to

the UAE in value terms -- particularly from labour-intensive sectors such as textiles, leather, footwear, sports goods, plastics, furniture, and engineering products. Underscoring the need for

Indian products to be compet itive in the international market, the secretary said that there was a need to build and augment domestic capacities.

He also informed that India is negotiating trade agreements at a very fast pace with complementary economies, including the UK, Canada and

Exports of goods and services account for about 22-23 per cent of India's GDP, Subrahmanyam noted.

"Our vision is that we should take India to a point where 25-30 per cent of our GDP is (from) exports," he added. He asserted that the Department of Commerce has also been strengthening itself to be futureready and meet the challenges of tomorrow with a focus on trade

It was skipper KL Rahul's 77 off 51 balls and newly promoted Deepak Hooda's 52 off 34 balls that propelled LSG to an imposing 195 for 3 despite stuttering towards the end of the innings.

In reply, Mohsin (4/16 in 4 overs) got breakthroughs exactly when things seemed to spiral out of control as Delhi Capitals finally managed 189 for 7 in the end.
