No winner in Ukraine war, world peace in peril: Modi

German Chancellor Olaf says India an important partner

Prime Minister Narendra Modi and German Chancellor Olaf Scholz on Monday reviewed the strategic partnership between the two nations and the fallout of the ongoing Russia-Ukraine conflict with both the leaders warning "no one will be the vic torious party" in this war. Reiterating that talks are

the only way to solve the crisis in Ukraine, Modi, who held bilateral meetings with Scholz in Berlin, said, "Recent geopolitical incidents have shown that world peace and stability is in critical condition and showed how all countries are interconnected. We had said that talks are the only way to solve the Ukraine crisis. We believe that no one will be the victorious party in this war." Modi further said, "I am

happy that my first foreign visit of 2022 is happening in Germany. And my first telephonic conversation with any foreign leader happened with my friend Chancellor Olaf Scholz. Holding of the IGC Governmental Consultations) shows how

much importance we place in our strategic ties?

The two leaders held bilateral talks and later took part in the sixth round of Biennial IGC between India and Germany. It is a unique biennial format which India conducts only with Germany. The high-profile IGC also saw participation of Finance Minister Nirmala Sitharaman, External Affairs Minister S Jaishankar and National Security Adviser

The German Chancellor said through its attack on Ukraine, Russia has violated fundamental principles of international law. "The war and the brutal attacks against civilian population in Ukraine show how unrestrained Russia has been in violating the fundamental principles of the UN Charter," he said.

"Thus, I repeat my appeal to Vladimir Putin — end this

senseless killing, withdraw your troops from Ukraine," he said.

On relations with India, he said it is among Germany's important partners here. "The world can only develop well if we are clear as to the fact that future relations in the world will be characterised and marked by many countries, not by a few powerful countries," the German Chancellor

Covid jab can't be forced: SC

'No curbs on unvaccinated in public areas till Covid case numbers low'

The Supreme Court on Monday said no individual can be forced to get vaccinated against Covid-19 and asked the Centre to make public data on the immunisation's adverse events. Bodily autonomy and integrity are protected under Article 21 of the Constitution, a bench of Justices L Nageswara Rao and BR Gavai said while suggesting that there be no restrictions on unvaccinated people in public areas till Covid numbers are low.
On the basis of available

material, and considering expert views, the current Covid-19 vaccine policy cannot be said to be manifestly arbitrary and unreasonable, the apex court said.

"Till numbers are low, we suggest that relevant orders are followed and no restriction is imposed on unvaccinated individuals on access to public areas or recall the same if already not done," the bench said. The apex court also directed the Centre to publish reports



on adverse events of vaccines from the public and doctors on a publicly accessible system without compromising on the data of individuals.

The SC was hearing a plea filed by Dr Jacob Puliyel, a for-mer member of the National Technical Advisory Group on Immunisation, who sought directions to also disclose postvaccination data regarding adverse events.

On the issue of vaccination for children, the bench said it is not possible to second guess the opinion of experts and the vaccination indeed follows global standards and practices.

Prashant Advocate Bhushan, appearing for the petitioner, had earlier argued that whether to get vaccinated or not is an individual decision, and in the absence of informed consent, mandatory vaccina tion is unconstitutional.

"On paediatric vaccines, the decision taken by the Union of India to vaccinate children in the country is in tune with global standards... We direct the Union of India to make sure the key findings of the stages of trials already approved by regulatory authorities for children be made public at the earliest," the court said.

Speculation about the leadership change has been triggered by BJP general secretary (org) BL Santosh asserting that the party leadership has the courage and strength to implement wholesale changes in State leadership, citing local polls in Delhi and Gujarat.

India's Covid positivity rate went past one per cent again country witnessed a singleday rise of 3,157 infections and 26 fatalities, according to the Union Health Ministry data updated on Monday.

The Government officials have ruled out a fourth wave in the near future, still they stressed on vaccinating kids.

"People have a casual attitude towards vaccination of children as the first and the second Covid wave did not see many severe infections and deaths in them," said Dr Balram Bhargava, director, Council of the Indian Council of Medical Research (ICMR), in Lucknow recently.

In the meantime, the rise reported on Monday pushed the overall Covid tally of the country to 4,30,82,345 cases and 5,23,869 deaths. The num-

per cent, according to the Health Ministry. The death toll has climbed to 5,23,869 with the 26 new fatalities being reported. The active cases constituted 0.05 per cent of the total infections, while the country's Covid-19 recovery rate was recorded at 98.74 per cent, the Health Ministry said.

He was taken to hospital fearing he was bitten by a snake," a staff of the Minister said on Monday.

DGCA derosters SpiceJet crew, inspects fleet

The Directorate General of Civil Aviation (DGCA) on Monday said that it is carrying out an inspection of the entire SpiceJet aircraft fleet after its Mumbai-Durgapur plane ran into a severe turbulence leading to injuries to 17 people. Two of the injured — one with head injury and another with spinal injury — are in ICU right now, it mentioned.

Respite from heatwave for 7 days: IMD PIONEER NEWS SERVICE

The India Meteorological Department (IMD) on

Monday announced that heatwave conditions are over in most parts of the country. The maximum temperatures are not likely to rise for the next 6-7 days, and it is expected to fall by two to three degrees Celsius in northwest parts of the country for the next three days and rise thereafter. The IMD also forecast that

the national Capital is very likely to receive rainfall on May 3. The IMD further said as per weather pattern, a heatwave cannot form till May 7. Senior scientist of IMD, RK Jenamani, said there are chances of the heatwave ending in most parts of India, including Delhi, Punjab, Haryana and Uttar Pradesh, as per the analysis of IMD on Monday.

The heatwave in west Rajasthan and Vidarbha may persist, but it may not be so severe. "We are also giving a yellow warning to Northwest

India as there is a Western disturbance. Delhi is likely to experience rain mainly on May 3. Rajasthan, Delhi, Haryana, and Punjab are on yellow alert and strong winds will be there on Tuesday and rain may occur," he said.

Amid the heatwave, the Haryana Government has changed the schools timing from 7 am to 12 noon from May 4. The IMD data showed that Ganganagar and Churu were the hottest cities on Monday and recorded 45.3 degrees Celsius each. In its weather bulletin, the

IMD said thunderstorms and gusty winds are very likely to be witnessed over northwest India till Wednesday, over northeast till Tuesday and over eastern and southern peninsular India till Friday. According to the IMD,

Western disturbance is very active and the wind pattern can be seen in Delhi, Lucknow, and Jaipur. For the next 6-7 days, 4 and 5.2. east winds will also be very strong and the temperature will not rise.

"Light rainfall with dust storm, thunderstorm, lightning, gusty winds (speed reaching 40-50 kmph) very likely over Punjab, Haryana-Chandigarh-Delhi, Uttar Pradesh and Rajasthan during the next 3 days, "said IMD. A cyclonic circulation is

likely to form over South Andaman Sea and neighborhood around May 4. Under its influence, a low pressure area is likely to form over the same region around May 6. It is liketo become more marked during subsequent 24 hours. It is very likely to cause heavy rainfall at isolated places, very likely over Andaman & Nicobar Islands on May 5 and isolated heavy to very heavy rainfall on May 6.

MNS chief softens stand ahead of Eid

No maha-arati on Eid: Raj Thackeray

In a dilution of his earlier stand a day ahead of the stipulated deadline for "compliance" of his call for removal of loudspeakers from mosques, MNS chief Raj Thackeray said that he did not want to cause any "hindrances" from celebrating Ramzan Ed on Tuesday.

In line with an indication he had given at a public rally that he addressed on Sunday at Aurangabad where he said that "Hanuman Chalisa" will be played at a louder volume than azaan in front of the mosques, the MNS chief said: "Eid is being celebrated tomorrow. The Muslim community should also celebrate their feswithout any hindrances".

"I have already mentioned this in my Sambhajinagar (Aurangabad) rally, I appeal to Maharashtra Sainiks' not to perform Maha-Aaratis on the auspicious occasion o0f Akshyaya Tritya which will also be celebrated tomorrow.

We do not intend to cause any hindrances or obstacles to any religion during the festivities Raj said in a statement put out on his twitter handle.

The loudspeaker issue is NOT RELIGIOUS ONE: IT IS A SOCIAL ISSUE with related I N C O N V E N I E N C E . Regarding the loudspeaker issue, I will further notify what we intend to do via social media," Raj said in his state-

It may be recalled that on April 17, the MNS chief had exhorted the "Hindu brothers" across the country to prepare themselves to give a "fitting reply" to the Muslims - in the form of playing Hanuman Chalisa in front of mosques five times a day—if the loudspeakers are not removed from the mosques by May 3.

Talking to media persons in Pune, the MNS chief had said: "Playing of Azan through loudspeakers from mosques is more a social issue than a religious issue. It is not just Hindus but people from all sections of the society get disturbed by the

playing of azan through loud-

"I appeal to all the Hindu brothers across the country to give a fitting reply if the loudspeakers are not removed from mosques by May 3. We do not want any kind of riots in the country, but they (mosque management) should remove loudspeakers peacefully from the mosques. Otherwise, we will play Hanuman Chalisa in fron \bar{t} of mosques five times a day," Raj had said.

At a rally he addressed at Marathwada Samajik Mandal ground in Aurangabad on Sunday evening, Raj said: 'Today is May 1 and Eid is on May 3. I don't want issues during their festival. But from 4th, we will not listen. I have requested all my Maharashtra Sainiks to play Hanuman Chalisa loudly in front of all the places where loudspeakers are played. If you can't understand even after requesting, then we have no other option left. Loudspeakers in your not allowed

Mumbai Court defers call on Ranas' bail plea till May 4

A Mumbai Sessions court on Monday deferred till Wednesday its ruling in the applications of Independent MP from Amravati Naveent Rana and her MLA-husband Ravi Rana in the case involving their arrest over threat to recite "Hanuman Chalisa" in front of Chief Minister Uddhav Thackeray's private residence "Matoshri" at Bandra in nort west Mumbai.

Special Judge RN Rokade, who was to deliver his verdict on the bail pleas of Ranas on Monday, postponed his ruling to Wednesday morning.

After hearing Senior Advocate Abad Ponda and Advocate Rizwan Merchant representing Navneet and Ravi Rana and Special Police Prosecutor Pradip Gharat, Special Judge Rokade reserved his ruling on the bail applications of the Rana couple for Monday.

Ranas were arrested on April 23 for offences registered initially against them under sections 153A (causing enmity between different groups), 34 (common inten-

124A (sedition) of IPC for challenging the government machinery and making remarks against Maharashtra Chief Minister Uddhav Thackeray in a controversy arising out of their threat to recite "Hanuman Chalisa" in front of Maharashtra chief minister Uddhav Thackeray's Bandra residence.

They were also booked under provisions of the Bombay Police Act for causing a law and order situation in the city. Making a strong case for release of Ranas on bail, Ponda had argued before the sessions court that the Mumbai Police had neither bothered to take custody of the Rana couple nor did they interrogate them even for a single day during their judi-

cial custody. Ponda had said that while reciting Hanuman Chalisa outside a mosque would have different repercussions, "but it is not that case here, because CM himself is a staunch Hindu".

Ponda contended that that the Rana couple had not criticised the Muslim community by using loudspeakers nor were intending to use loudspeakers for the recita-

Ponda pointed out that since the police sent notice to Ranas not to recite Hanuman Chalisa, they could not go ahead with their plans and that being the case, the offence did not amount to sedition. He said that the citizens have a right to criticise the government as long as the criticism did not incite violence. Ponda had said that criticism of Uddhav Thackeray or Shiv Sena did not amount to criticism of the Government, as this Sena was one of the three constituents of the coalition government in

Opposing the grant of bail to Ranas, Special Police Prosecutor Pradip Gharat told the court that the place in question where the recitation was to happen belonged to the Chief Minister of the State. "While citizens have the right to criticize the Government, the same has to be done within a limit, and if that limit is crossed, it will fall under the ambit of Section 124A of IPC," he

J&K delimitation panel to give report on May 5

three member Delimitation Commission headed by Justice (Retd) Ranjana Prakash Desai is all set to finalise its report on

Highly-placed official sources on Monday confirmed to *The Pioneer*, "ahead of the completion of its tenure the Jammu and Kashmir Delimitation Commission is scheduled to finalise its report by May 5 before submitting the same to the Government". The tenure of the commission was extended up to two month by

The three member commission had visited both the twin capital cities of Jammu and Srinagar last month where they interacted with 400 delegations from different parts of Jammu and Kashmir after releasing the draft report for public remarks and objections.

The Commission had given assurances to these delegations that they would incorporate their suggestions before finalising their report. The Assembly are expected to take place after the completion of the Delimitation exercise.

The entire exercise has been carried out as per the provisions of the Delimitation Act 2002 and the J&K Reorganization Act 2019, keeping in view population, public conveniences, communication facilities, geographical compactness of the areas as well as the existing administrative boundaries while delimiting the constituencies.

The commission, which also included Chief Election Commissioner (CEC) Sushil Chandra and State Election Commissioner (SEC), J&K, KK Sharma, had originally recommended six additional seats for Jammu region and only one for

After the marathon exercise the total Assembly seats for Jammu region would go up from 37 to 43 and for Kashmir from 46 to 47 in the new Assembly.

Nine seats were proposed for Scheduled Tribes and seven for Scheduled Castes in the interim draft proposal.

He also said India is a "super" partner for Germany in Asia in economic terms, security policy terms, and climatepolitical terms. The German Chancellor also invited Modi to attend the G-7 summit there in June as a special invitee.

The summit is likely to focus on Ukraine and various steps taken, including sanctions against Russia. The Ğ-7 grouping includes the UK, the US, Canada, Germany, Italy, Japan and France.

Meanwhile, the one-onone talks between the two leaders was followed by delegation-level parleys which covered key areas of bilateral cooperation under the overall strategic partnership, as well as regional and global developments.

The two nations also reviewed the situation in the strategically important Indo-Pacific region where China is now flexing its muscle. Modi and Scholz signed the green and sustainable energy part-

SC tells Centre to decide in 2 mths Rajoana's plea

PNS NEW DELHI

The Supreme Court on Monday directed the Centre to decide within two months Balwant Singh Rajoana's plea that his death penalty in the 1995 assassination of former Punjab Chief Minister Beant Singh be commuted to life imprisonment on ground of his long incarceration of nearly 26 years. A bench headed by Justice UU Lalit said the pendency of appeals of other co-convicts in the apex court in the case would not come in the way of authorities in deciding Rajoana's plea.

Rajoana, a former Punjab police constable, was convicted for his involvement in an explosion outside the Punjab civil secretariat that killed Beant Singh and 16 others on August 31, 1995. Apex court has been hearing Rajoana's plea seeking commutation of the death sentence to life term on the ground that he has been in jail for 26

SHO suspended for girl's death during police raid in Chandauli

The station house officer (SHO) of Saiyadraja police station in Chandauli district has been suspended after a 21year-old girl died after she was allegedly assaulted by policemen during a raid.

The police, however, denied the allegation saying the woman appeared to have com-

The alleged incident took place on Sunday when the police raided the house of gangster Kanhaiya Yadav in Manrajpur village to arrest him after a non-bailable warrant was issued against him. Yadav has been accused in a case of illegal sand mining.

However, as the police officials could not find Yadav at his home, they allegedly tried to take his brother with them. Yadav's daughter, Nisha, tried to stop the police, following which she was allegedly beaten by the officers.

In a video widely shared on social media, a woman can be seen saying that her elder sister was killed by the police. On being asked if she had also been beaten up, the woman replied in the affirmative.

Superintendent of Police Ankur Agarwal, however, denied all the allegations and said, "At 4:30 pm, a police team went to conduct a raid for arresting Kanhaiya Yadav against whom a non-bailable warrant has been issued. The police team had female constables with it and a video of the action is also available. When the accused was not found, the police team returned.'

Heat raises power demand to 6,194 MW

Owing to the killing heat, power demand in the national Capital on Monday clocked 6,194 MW, which is the highest-ever in the first week of May. On Monday the maximum temperature of Delhi settled at 40.8 degrees Celsius, two notches warmer than normal for this time of the year. The minimum temperature in the city settled at 27.4 degrees Celsius, three notches above the normal temperature.

According to sources in discoms, the Capital's peak power demand touched 6,194 MW, which is the highest-ever in the first week of May till date. With Delhi experiencing abnor-

mally high temperatures in April this year, the city's power demand scaled up by 34 per cent since beginning of April. On six occasions in April this year, Delhi's peak power demand clocked highest-ever in April, each breaking the previous record in quick succession. On April 19, it was 5,735 MW,

5,761 MW on April 20, 5,781

This is highest-ever consumption in first week of May; IMD predicts fall in temp

MW on August 21, 5,786 MW on April 27, 6,050 MW on April 28, and 6,197 on April 29," sources said.

"Delhi's peak power demand had breached the 7,000 MW-mark for the first time – peaking at 7,016 MW in 2018. The expected peak power demand of around 8,200 MW is an increase of around 285 per cent over the peak power demand of 2,879 MW in 2002," sources stated. On Sunday, Union Power

Minister RK Singh, in a letter to Delhi Government, expressed displeasure at alleged misleading of public, a source said. According to Singh's letter, coal stock at the Dadri plant was 202.40 thousand tonnes, which is sufficient for 8.43 days at 85 per cent PLF (plant load factor) on April 29. Similarly, coal stock at Unchahar plant was 97.62 thousand tonnes, suffi-

PLF or capacity utilisation. Earlier at a review meeting, the Minister directed officials to ensure the required power demand for Delhi. Meanwhile,

on Monday, the India Meteorological Department (IMD) data showed that the relative humidity recorded at the Safdarjung observatory at 8:30 A.M. was 61 per cent and 38 per cent at 5:30 P.M.

The weather stations at Ridge, Ayanagar, Mungeshpur, Najafgarh, Pitampura, Palam, and Lodhi Road recorded maximum temperatures of 41.4 degrees Celsius, 40.6 degrees Celsius, 41.7 degrees Celsius, 42.5 degrees Čelsius, 41.3 degrees Celsius, 40.6 degrees Celsius and 39.8 degrees Celsius

respectively.
The IMD predicted a fall in maximum temperatures by three-four degrees Celsius over most parts of Northwest India during the next three days.

The IMD said that thunderstorms and gusty winds were likely over Northwest India till May 4; over East India and south Peninsular India till May 6, and over Northeast India till May 3.



Parts of Nizamuddin Markaz to stay open till Oct 14: HC

The Central Government, in its affidavit, has opposed fully re-opening the Nizamuddin Markaz and stated that only a few people may be allowed to offer prayers on certain religious occasions.

Covid positivity rate rises to 6.42%

Delhi on Monday reported 1,076 Covid-19 cases, around 27 per cent less than a day ago, though the positivity rate rose to 6.42 per cent. No death occurred due to the disease in the last 24 hours. The Government has increased the number of beds dedicated to Covid patients at two of its facilities, including an 80 per cent escalation in its count at the Lok Nayak Hospital

According to a bulletin released by the Delhi Government's health department, out of 16,753 tests conducted in last 24 hours, 6.42 per cent were found positive. This positivity rate refers to percentage of all Coronavirus tests performed that return positive results. A higher positive rate means a higher transmission rate for virus. The data showed that 4,490 patients are in home isolation. With these new cases, national Capital's overall tally has increased to raised to 850 from 350 earlier.

18,85,636, while death toll stands at 26,175. Delhi had on Sunday recorded 1,485 cases and no death due to the disease, while the positivity rate stood at 4.89 per cent. On Saturday, it had recorded 1,520 cases and one death, with the positivity rate at 5.10 per cent. A total of 16,753 Covid tests were conducted in the city on Sunday. She had worked for over 30 vears in different Government schools across the Capital and eventually retired in 2012 from a Government school in Dallupura, officials said.

However, despite passage of over 10 years, the complainant didn't receive her GPF dues and had been struggling to get it. Acting on the complaint, DCW member Promila Gupta met the retired teacher and thereafter, issued a notice to the Education Department of Delhi Government for speedy redressal of the matter.

"Subsequently, action was taken by authorities and the commission was informed by the Education Department that an amount of ₹20,59,881 has been disbursed to the teacher and the process of providing her retirement benefits has been initiated," said the DCW offi-

DCW chief Swati Maliwal also issued summons to Education Department in matter for speedy disbursal of complainant's retirement benefits.

"This is very unfortunate that a retired teacher, despite working hard for over 30 years, had to wait for 10 long years for getting her GPF dues which is her right.

The Commission shall ensure that her other retirement benefits are also provided to her and fix responsibility for delay. We have a zero tolerance policy towards harassment and shall be taking strong action in this matter," said Maliwal.



Delhi's Indira Gandhi International Airport (IGIA) emerged as the world's second-busiest airport in March, in terms of total seat capacity and frequency of domestic and international flights. IGIA handled about 31.65 million domestic passengers and 5.49 million international ones. It had emerged

as the top airport in the country in terms of handling domestic as well as international passenger traffic in 2020 and 2021. Now it has surpassed China's Guangzhou airport, which was the fourthbusiest airport globally. Before the pandemic, IGIA had ranked 23rd among the busiest airports of the world. According to the Official Airline Guide (OAG), a leading

global travel data provider, whilst Atlanta retains its position as the largest, Dubai was knocked out of second place in March by Delhi which moved up from third place in February. According to the report, IGIA (3,611,181 seats), which is India's busiest airport, has knocked out Dubai International Airport (3,554,527 seats) to grab the second position. Atlanta Hartsfield-Jackson

International Airport (ATL) has retained its top position (with 4,422,436 seats).

"London's Heathrow Airport ranked fourth with a seating capacity of 3,510,941, Dallas/Fort Worth International Airport obtained fifth position (3,460,566 seats), Chicago's O'Hare International Airport stands at sixth position (3,293,417 seats), Los Angeles International Airport ranked





Newly released research from US Department of Energy's (DOE) Brookhaven National Laboratory said that three measures can cut down transmission of airborne pathogens like SARS-CoV-2, the virus that causes Covid-19, by more than 98 percent in more than 95 percent of scenarios examined.

"Wide adoption of layered controls dramatically reduces exposure to existing airborne viruses, such as SARS-CoV-2, and will be critical to control outbreaks of novel airborne viruses in the future," said scientist at DOE's Pacific Northwest Laboratory. "These non-pharmaceutical interventions can be applied in combination with vaccinations.'

For some respiratory infections such as COVID-19, a low building ventilation rate worsens both long- and short-range airborne transmission. Policy makers in public health should target indoor environments with insufficient ventilation by either mandating improved ventilation or setting a maximum occupancy when the total ventilation supply is fixed.

Indo-Swiss Building Energy Efficiency Project (BEEP) India director Dr. Sameer Maithel agreed that ventilation should be considered as one strategy which provides the best protection against infection while adequate masks can reduce a person's exposure to viral particles by 95%. Reforms in UP power sector needed: Yogi

Uttar Pradesh Chief Minister Yogi Adityanath, on Monday, underscored the "huge need" for reforms in the power sector.

The Chief Minister, on Monday, presided over a review meeting of the power sector. He emphasised the need for making efforts to make comprehensive reforms at every level of the power sector.

UP is in the grip of a power crisis due to huge spurt in demand due to heat wave leading to sharp spike in power consumption. The situation has been aggravated by the shortage of coal in thermal power plants of UP Vidyut Utpadan Nigam.

The chief minister asked UP's Energy Minister AK Sharma to thoroughly review the functioning of the department. Showing signs of urgency vis-a-vis power situation in the state the review meeting came days after Yogi met the Union Coal and

Railway ministers urging them to provide an extended help to meet the ever-increasing demand for power in

Already, the state has recorded the highest ever power demand of 22,500 megawatt. Making the matter worse were the technical glitches in the power plants much to the disappointment of the power officials. It was only after the state government managed to get an additional 2,000 MW power that the situation came somewhat under control, officials in the UP Power Corporation Limited (UPPCL) admitted.

Yogi nevertheless stressed on ensuring uninterrupted power supply in all 75 districts as per roster. The chief minister maintained that the Centre was lending "all possible help' to mitigate the crisis.

The chief minister said that while the Railways had arranged additional rakes for augmenting coal supply to thermal power stations, the

coal from mines to power plants by road should also be explored. He also underlined the need for timely payment of electricity bills which also requires timely issuance of electricity bills.

"Overbilling, false billing or late billing causes inconvenience to the consumers. To improve this system, the Energy department will have to make a concrete action plan to increase the billing and collection efficiency. Special efforts are needed in rural areas," the chief minister said.

Yogi also advised bringing in a one-time settlement (OTS) scheme for the recovery of the outstanding arrears of the power bills. He said the OTS scheme to be formulated should provide exemption from interest on arrears and facility of payment in installments. UP is currently facing a power crisis. Against a demand for about 23,000 MW of electricity, only 20,800 MW is

Indian professionals in China urge Jaishankar to press Chinese Govt to permit return of their families

s China finally consented Ato permit "some" Indian students to return to re-join studies after over two years of delay, a number of Indian professionals whose families are stuck back home due to Beijing's stringent Covid visa rules have appealed to External Affairs Minister S Jaishankar to take up their plight with the Chinese Government.

Many Indian professionals working in China for a long period ranging from five to 27 years sent a joint petition to Jaishankar on May 1, highlighting their anguish.

"We have been separated from our respective families including kids for more than 26 months due to the Covid-19 pandemic and related travel and visa disruptions," these professionals, who are based in Beijing, Shanghai and other cities, said in the petition submitted to the Indian Embassy

Among the petitioners are parents who have not seen their newborn babies for over two years besides others whose children were studying in China and could not return to re-join the schools due to the cancellation of visas and flights, disrupting their studies.

The families of dozens of Indian professionals left China in 2020 soon after coronavirus broke out in Wuhan. But many Indian professionals who have their business in China besides lucrative jobs could not return causing complete disruption of their lives and businesses.

According to unofficial data, over 2,000 Indians, mostly those working in China or and Children, are stuck in





Beat the heat

Like with the pandemic we need a plan to live with excess heat

The last two days have brought a brief respite from the scorching summer heat. Normal summer day temperatures of 40-41 degrees Celsius seem pleasant in face of the 45+ degrees we saw in the previous fortnight. Global attention is at present on South Asia for the unheard-of temperatures since April 28. Some satellites have indicated that land surface temperature in some parts of India, like Rajasthan, may have recorded up to 60 degrees Celsius. Pockets in northwest India have raised concerns following the extreme temperatures hitting the region. The European Space Agency also recorded 55+ degree temperatures here. The Indian Meteorological Department, however, terms the figures alarmist and says unconfirmed data can create unnecessary fears. But if the temperatures have gone beyond 45 or even 47 degrees, it does not matter, does it? The heat has extracted its pound of flesh already. Scientists will now begin to quote the Intergovernmental Panel on Climate Change that predicted that South Asia will experience frequent and intense heat. Our scientists tell us the extreme heat is abating because some regions might experience light rain in the coming days. The

government has done its job of issuing a formal advisory to the States to review healthcare facilities to handle heat-related illnesses.



every year, but we are now being forced to think of long-term plans to live with heat stress in the same way we have learnt to live with the Covid-19 pandemic. Life-style and work changes are a must to protect the health of workers and importantly, minimise loss of man-days. We may lose five per cent or more of total working hours when it is too hot to work or the heat slows down the pace of work. In India, we will have collateral issues to deal with. Heat stress compounds the situation when the workers already suffer from irregular employment, unorganised labour, and the absence of social security. Agriculture, construction, and textile workers will be the worst affected along with those engaged in tourism, transport, municipal and public works, and deliveries. Older workers may have to optout of work in the summers because of low physiological levels. The story is the same for students, especially in north India where the summer breaks are May-June rather than April-May. We have to make work and study alignments, change working hours, in fact, re-design how we function in the season. Morning shifts can begin early to wind up by noon. The rural economy and the manufacturing sectorwill need structural transformation. We have to start planning now.

PK's political gambit

PK should remember it's not always easy to walk the talk

oll strategist Prashant Kishor's Monday morning tweet — cleverly framed and deliberately ambiguous — shows his intent to launch a political outfit. The expression "Time to go to the Real Masters, THE PEOPLE, to better understand the issues & the path to "jan suraaj" Peoples Good Governance" is clear as far as it goes to show his desire to take a plunge into active power politics. But Kishor has left it vague on how he wants to do it. Whether he would go for a national-level polit-



ical party or a Bihar-specific outfit? It's expected that when Kishore holds a Press conference in Patna, most probably on May 5, he would answer questions on the agenda of his party. Needless to say that as a consultant it' was relatively easy for PK to chalk out election strategy for a party that has its own structure and cadres, but it could be a demanding task for him to float his own outfit, raise resources, mobilize the cadres, give a narrative, and contest polls.

Kishor recently said that a regional party like AAP would need at least 20 years to become a national alternative to the BJP. Going by the fact that AAP already rules in Delhi and Punjab, and PK has to yet

cut his teeth into active politics, at best Kishor could come up with a State-level party and hope to gradually expand it. No one can deny that Kishor is well-networked and capable of drawing hundreds of influential leaders from different parts of the country. But if Kishor tries to go for a national outfit, he will have to stop working for other political parties, and his money-spinning outfit, I-PAC, will lose huge revenue that sustains his infrastructure. That's not the only challenge. Kishor will always be on the watch, and any failure will dent his charisma and lead to the erosion of his credibility. At the same time, Kishor will face a daunting task in making any inroads in the caste-ridden politics of Bihar, where both the NDA and RJD-led alliance have committed voters. There is hardly any space available for him to straightaway get a toehold in the state's politics. It'll be interesting to see how PK practices what he preaches the best. It's not always easy to walk the talk.

he recent passage of two bills in the Tamil Nadu State Assembly amending various acts regulating the thirteen state universities, including the prestigious Madras University, to replace the "Chancellor" (who is the state Governor) with "Government" has once again, brought the issue of appointment of Vice-Chancellors(VC's) to the limelight. It's the Chancellor who appoints the VCs. The two bills state, "It is con-

sidered that in line of the aforesaid (Gujarat and Telengana) State University Laws, the Government of Tamil Nadu should be empowered to appoint the Vice-Chancellors of the State

The DMK Government had been at loggerheads with the Governor on his inaction regarding the bills passed by the state assembly on exempting Tamil Nadu from NEET. The DMK has often accused the Governor of pushing the Centre's agenda at the cost of the interests of the state. Accusing the Governor of disregarding the state government's opinion on the appointments of VCs, TN Chief Minister MK. Stalin told the House, "A government elected by the people being unable to appoint the Vice-Chancellor to a university run by it creates a lot of issues in the overall varsity administration. This is against the democratic principles."

Earlier, similar arguments have been made by the states of Telangana, Maharashtra, and West Bengal where there are sharp political differences between the state and the Centre on the role of Governors in the appointment of VCs.

What is the legal position regarding the appointment of VCs who are entrusted with the responsibilities of managing the affairs of the universities? The position is clear. Education falls under the Concurrent List. Entry 66 of the Union List clearly states "Coordination and determination of standards in institutions for higher education or research and

versities and colleges are regulated through the University Grants Commission (UGC) Act which states that the (Minimum Qualifications for Appointment of Teachers and other academic staff in universities and colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018, the "Visitor/chancellor" mostly the Governor in statesshall appoint the VC out of the panel of names recommended by search-cum- selection committees. The institutions of higher education, especially those funded by the UGC, are required to follow its regulations.

However, the actual position is that the Central Universities are mandated to follow the regulations in total whereas at times, due to certain differences of opinion the state universities defy the orders of the UGC because education is a state subject as well Gujarat and Telangana are the case studies that provide the muchneeded ammunition in favour of the state universities. The Gujarat University Act,1949 clearly states that "the Vice-Chancellor shall be appointed by the State Government from amongst the three persons recommended by a searchcum-selection committee." The Telangana Universities Act,1991 states that the search committee shall "submit a panel of three persons to the Government and it shall appoint the Vice-Chancellor from out of the said list." However, the situation

underwent a drastic change

due to the recent Judgement of the Supreme Court which observed that " any appointment as Vice-Chancellor contrary to the provisions of the UGC Regulations can be said to violate the statutory provisions, warranting a writ of quo warranto". It said that every subordinate legislation of the UGC, in this case, the one on Minumum Standards on appointment flows from the parent UGC Act,1956. Therefore, being subordinate legislation, UGČ Regulations become part of the Act. In case of any conflict between state legislation and central legislation, central legislation shall prevail by applying the rule/principle of repugnancy as enunciated in Article 254 of the Constitution as the subject 'education' is in the Concurrent List of the Seventh Schedule of the Constitution".

There is no denying the

fact that over the years, the appointments to the higher office of Governors have been highly politicized and compromised. Considering the key role of the Governors in the states during times of political insecurity and crises, the ruling parties, irrespective of their political affiliations, have appointed their handpicked favorites in the position. This has led to an overall deterioration in all spheres of life -selection processes and decision making. The appointment of substandard professionals in key positions in the universities has led to frustration amongst the rank and file of the entire workforce. This explains the situation of chaos and unrest in our universities.

The inter-se shares of Madhya Pradesh and Uttar Pradesh, to mention two states, in the divisible pool of taxes are 127 percent and 106 percent respectively of their population, whereas the shares of southern states ranged between 66.7 percent (Tamil Nadu) and 96.0 percent (Andhra Pradesh). That gave great leeway for the former to reduce VAT as well.

RING IN THE EASY, RING **OUT THE DIFFICULT**

Getting out of comfort zone applies to administrators too

ecently, in his first face-to-face interaction with students after a twoyear gap, at the fifth edition of "Pariksha Pe Charcha, the Prime Minister talked, among other things, about students' general tendencyto prepareeasy and comfortable part of their syllabus, leaving aside hard, difficult portions. He exhorted them to come out from this comfortable zone to gain confidence and do well at the examination. While the advice is very useful for the students, it also applies equally to our administrators, bureaucrats, and policy makers. It is not uncommon to see howat timesthey are found to ignore or sidestep the difficult and challenging part in implementation of policies or projects to avoid hard work, complexity or potential conflictsinvolved. The reasons or motives may be many- lack of diligence or courage, temptation to winquick brown-



ie points with higher-ups or herald a success pre-maturely. Take for instance, the banking reforms. To review governance of Boards of Banks in India, a committee, well known as PJ Nayak Committee, was set up by the Reserve Bank of India in 2014. A landmark onein the recent decades, the Report recommended far-reaching reforms in Indian banks. The objective was to improve corporate governance in the banking sector, making it resilient and efficient, and to also provide autonomyto the banksin strategic decision making. The government showed right signals and commitment to implement the Report. The hard part of the recommendations was to repeal the Bank Nationalization Act, set up a Bank Investment Company(BIC) as a holding company, and transfer government shares in the BIC. Until BIC is formed, the Report recommended, a temporary body, called the Banking Boards Bureau (BBB), will be formed to carry out the functions of the BIC. Among the simple partwas the recommendation that BBB will advise on appointments to the Board, Banks's Chairmanand Managing Director and other Executive Directors, Compensation issues, etc. After eight years of the submission of the Report, only the relatively easy-to-implement prescriptions like splitting of the post of CMD and formation of BBB werepromptly pushed, sidestepping the hard and onerous ones. Again, the same proclivity to push easy part of reform package, and avoiding the difficult ones, was seen in the implementation of power reforms.

In 2015, Ujjwal DiscomAssurance Yojana (UDAY) was launched to make financially stressed power distribution companies (DISCOMs) stand on their own feet. Under the scheme, States were to take over 75% of DISCOM outstanding debts to improve the fiscal health of the latter. Clearly, the transfer of debt burden was the soft part of the implementation of the scheme. Whatwas critical and essential was that DISCOMs were required to reduce Aggregate Technical and Commercial (AT&C) losses, eliminate Average Cost of Supply (ACS) and Average Revenue Realized (ARR) gap, Feeder Metering, among others. Sadly, while the easy partdebt transfer-of the package was promptlyimplemented, as all DISCOMs got on board and utilised the facility of debt transfer to the State governments, most DISCOMs gave the implementation of the critical partthat is ensuring efficiency- a short shrift. The two illustrations cited above, show how by not facing the challenging part of implementation, be it in Banking or Power, have shaken confidence of both the sectors and has made progressive and sustainable change so elusive. The pitfalls of taking easy routes and avoiding discomfort of facing challenging tasks are serious, particularly in the domain of public policy and governance. Any piecemeal, half- hearted, and hasty implementationsnot only severely affect efficiency and competitiveness but also, as a result, risk huge drain of scarce resources of the nation, including tax-payers money.

The C&AG has stated that multiple allotments to applicants on a single date were given and front companies were used for allot-ment of plots through different applications. There is evidence of dereliction of duty by the members of the PAC whereby fraudulent actions have been permit-

ted by the officials of NOIDA. A national newspaper has also reported based on RTI documents that 3C Universal Developers Pvt Ltd's promoters, directors and shareholders, and their companies took eight plots. Dharampal Satyapal Sons Pvt Ltd, makers of Rajnigandha pan masala, and its promoters and directors together got six plots.

Businessman Late Gurdeep Singh Chadha, better known as Ponty Chadha, bagged a plot along with Rajinder Singh Chadha and Javed Ahmed as promotercum-director of Brilliant Builders Pvt Ltd. His wife Jatinder Kaur was allotted another plot as promoter-cum-director of Jagat Guru Real Estate Developers Pvt Ltd. Ajay Rastogi, an official in Ponty Chadha's liquor business, too got a plot.

Among the other beneficiaries of the scheme, prominent lawyers Shanti Bhushan and his son Jayant Bhushan, former ASG Vikas Singh, HCL CEO Vineet Nayar, etc., were also included.

Thus, the land of farmers acquired at lower rate, invoking the urgency clause for industrial development, was allotted on discretionary basis to affluent and influential individuals/companies for their personal/leisure use at a highly subsidised rate.

Noida Authority allotted 134 plots ranging from 1000-5000 sqm each, covering an area of 2,41,072 sqm at the rate of ₹7800 per sqm for the corporate offices of the Private Companies/Firms in 2008-09 treating them as Institutions rather than Commercial profit-making firms. As these companies run on commercial basis and earn profits, they should pay for the plot of land at commercial rate. The Authority used to charge commercial rate from them earlier. However, the Authority changed the status of these commercial companies to Institutional in October 2008 thereby giving undue benefit of ₹6600 per sqm to these private companies. Therefore, the decision by the Authority to change the status of private companies to Institutional category was injudicious, selective and without basis. rate, invoking the urgency clause for industrial development was allotted at a highly subsidised rate on discretionary basis, thereby affording undue benefits of ₹161.75 crore to 134 Private companies. Undue favour in allotment of industrial plot to CBS International Projects Ltd.

Noida Authority allotted an industrial plot (No. 01/90) measuring 1,02,949 sqm on 03 September 2007 CBS International Projects Ltd at a premium of ₹52.77 crore for establishment of IT Park. The allottee claimed to be a consor-

tium of three companies (Burchill VDM, Carnoustie Management and RS Resource Management Consulting). However, on verification, it was found that the CBS was actually owned by Carnoustie Management and RS Resource Management Consulting only on the date of the application (06 August 2007). The name of Burchill VDM, an overseas company was added to present a rosy picture of inancial health in order to qualify for allotment of the plot. These wrong facts were not verified and were accepted by NOIDA without any documentary evidence. This has resulted in allotment to an ineligible applicant of a plot worth ₹52.77 crore. Further, the Authority failed to restrict sale of commercial and residential portion for noncaptive use in the Plot as 'Bhutani Group, the promoter advertised the projects 'Alphathum' and NOIDA World One in Sector 90 wherein residential studio apartments and sold to non-IT/ITES units, which has resulted in undue benefit to the allottee to the extent of ₹745.56

The C&AG has therefore raised a serious question of probity, integrity and the governance failure at every level in the functioning of Noida Authority. The Authority appeared to have abdicated its responsibility to protect its own as well as public interests. Senior officials had acted in clear

breach of public trust and in complete disregard to the interest of Authority and the home buyers. There was little monitoring of the projects and negligible compliance of the terms and conditions which has put the interests of stakeholders in peril. In spite of the clear evidence of breaches, the Authority failed to act against builders /allottees and take action against its own officials for their dereliction of duty and collusive role in permitting/abetting the continuing infractions. As Noida is a subset of NCR and also an important part of UP which contributes to about 10 percent of GDP of India, it is necessary that Yogi 2.0 as well as GOI take immediate action to stem the rot and hold the

culprits accountable. The Government should immediately order for an investigation by a SIT including a senior official of C&AG, IT and MCA or CBI and punish all such officials opers/builders in the illegal/irregular transactions over the years, as pointed out by the C&AG of India.

All allotments of plots where full premium/cost have not been paid, should forthwith be cancelled and the possession of the plots of land be taken back. Indemnity bonds of each allottee should be encashed.

All allottees who have illegally sold/transferred the plots/subplots to third parties in violations

Tell young man, always remember, here on, your religion is that of your troops"; this was one of the quatrain initiatory directives I had from my Commanding Officer on joining the Battalion in January 1969 and since then it got resonantly etched in my memory neurons. That is how an officer is baptised into the armed forces and exposed to the military traditions and its values. Though it sounds simple, it implies that an officer is obliged to follow the secular legacy of the forces and respect the sentiments of his command which incidentally plays an important role in execution of his duties. I was fortunate as my unit, being a "Mixed Class composition" having troops from all religious/territorial denominations, made it incumbent to partake in

all ceremonies. Incidentally, having done my academics in Khalsa education institutes, it further ingrained my spiritual heirloom of respect for It is due to these proven fac-

tors that make our armed forcesa reflection of secularism. Where else one would see a Muslim officer performing havan, a Hindu offering namaz, a Sikh doing church service and the Christian officers and jawans reciting Gurubani. I agree that these practices would surely sound odd to others, but these are the hard realities of Military Secular Culture. Further, we have the live practice which is still continuing, wherein the officers commanding Muslim troops observe *'roza'* during Ramadan. It takes me back to 1991-92 while com-



manding my battalion in the Valley, I too had the privilege of observing three days'fast during the Holy Month as a mark of solidarity to our local civilian support staff. Going further back, my unit was deployed along the Line of Control (LOC) in Poonch, in October 1984 we conducted a presentation on "1971 Operations in Punch Sector" at the Forward Post. Being a major event, in addition

Units, we had also invited a few journalists and correspondents to cover the proceedings. They were happily surprised beyond belief when they saw that "all faiths" were being housed and worshiped together in one bunker. Branding as a paragon of true secularism, in a questionable exclamation they said: "Yeh dekh kar yakeen nahin hota, bahar to log in Bhagwanon ko alagkarne pe ladai kar rahe hain aur yahaan sab ikath the! "These feelings mattered a lot, and more so, coming close on the heels of the 1984 riots.

To further buttress the military secular traditions, there are two gurudwaras fully managed, administered and maintained in all respects by the Army.

Having been brought up in such a harmonious and sine qua non environs of secularism, a soldier, when exposed to the ongoing politico-communal scenario, finds himself lost in a whirlpool of ambivalent secular practices prevailing in our country. Before proceeding further, let me dig out a few historical

facts. Starting with the basics, the word secular means; "an action not concerned or connected with any religion". Whereas the term secularism implies that religion and the religious considerations should be ignored or excluded from social and political fora. Going further deep into the historical annals, one finds that the word secularism was first coined by a British, George Holyoake in 1851 to promote social order free from religion, subsequently it laid the foundation of separating the State from the Church, thus insulating the Government, political, social functionaries and the religious institutions from one another.

Over time, Articles 14 to 25 of the Constitution have been brazenly mauled by political and religious outfits and interpret-

ed to suit their myopic charters. The end result is in front of us. Marred by the ongoing disturbances, we look more divided than being united and face the worst kind of "socio-communal" polarisation. In other words, the prevailing scenario is the cumulative manifestation of various socio-politically sponsored practices such as bigotry, exploitation, vote-bank tactics, appeasement, migrations,lynching and radicalisation. This has not only spiralled into inter-faith acrimony but is also indirectly endangering our internal security. As a soldier, I find myself at

the cross-roads between the true secularism I was taught by the Army and the other whatever we name it — being currently patronised in our country.

First civilians leave Mariupol steel plant, hundreds remain

 $P_{\text{Mariupol described weeks}}^{\text{eople fleeing besieged}}$ of bombardments and deprivations as they arrived on Monday in Ukrainian-held territory, where relief workers awaited the first group of civilians freed from a steel plant that is last redoubt of Ukrainian fighters in the devastated port city. Video posted online Sunday by Ukrainian forces showed elderly women and mothers with small children climbing over a steep pile of rubble from the sprawling Azovstal steel plant and eventually boarding a bus.

More than 100 civilians from the plant were expected to arrive in Zaporizhzhia, about 140 miles (230 kilometers) northwest of Mariupol, on Monday, Ukrainian President Volodymyr Zelenskyy said.

The evacuation, if successful, would represent rare progress in easing the human cost of the almost 10-week war, which has caused particular suffering in Mariupol. Previous attempts to open safe corridors out of the city on the Sea of Azov and other places have

Russian-occupied areas in the past have said their vehicles were fired on, and Ukrainian officials have repeatedly accused Russian forces of shelling agreed-upon evacua-

Today, for the first time in all the days of the war, this vitally needed green corridor has started working," Zelenskyy said Sunday in a pre-recorded address published on his Telegram messaging channel. At least some of the people

evacuated from the plant were apparently taken to a village controlled by Moscow-backed separatists, though Russian state media reported they would be allowed to continue on to Ukrainian-held territory if they wanted to. In the past, Ukrainian officials have accused Moscow's troops of forcibly relocating civilians

from areas they have captured to Russia; Moscow has said the people wanted to go to Russia. While official evacuations have often faltered, many people have managed to flee Mariupol under their own steam in recent weeks. Others are unable to escape.

Anastasiia Dembytska, who took advantage of the brief cease-fire around the evacuation of civilians from the steel plant to leave with her daughter, nephew and dog, told The Associated Press her family survived by cooking on a makeshift stove and drinking well water.

"We could see the rockets flying" and clouds of smoke over the plant, she said.

A defender of the plant said Russian forces resumed shelling the plant Sunday as soon as some civilians there were evacuated. Denys Shlega, commander of the 12th Operational Brigade of Ukraine's National Guard, said in a televised interview that several hundred civilians remain trapped alongside nearly 500 wounded soldiers and "numerous" dead bodies.

"Several dozen small children are still in the bunkers underneath the plant," Shlega said. It was unclear whether there would be further evacuation attempts.

Zelenskyy calls US visit 'powerful' signal

Ukraine's president is describing his hourslong weekend meeting with US House Speaker Nancy Pelosi in Kyiv as a powerful signal of support in a difficult time.

In a televised address on Sunday evening, President Volodymyr Zelenskyy said his meeting with Pelosi included discussions of defense supplies to Ukraine, financial support and sanctions against Russia.

Pelosi and a half dozen U.S. Lawmakers met with Zelenskyy and his top aides for about three hours late Saturday to voice American solidarity with the

besieged nation and get a firsthand assessment as she works to steer a massive new Ukraine aid

package through Congress. Zelenskyy says Ukrainians "are grateful to all partners who send such important and powerful signals of support by visiting our capital at such a difficult time."Additionally, Zelenskyy estimated that more than 350,000 people had been evacuated from combat zones thanks to humanitarian corridors prearranged with Moscow since the start of Russia's invasion of Ukraine in late February. Many civilians were evacuated Sunday from at a steel plant in the bombed-out city of Mariupol.

Russia resumes shelling of steel plant in Mariupol after civilian evacuations

 $R^{ussian \ forces \ resumed}_{shelling \ of \ a \ steel \ plant \ in \ the}$ war-torn city of Mariupol immediately after the partial evacuation of civilians, a Ukrainian military officer has said.

Ukrainian National Guard brigade commander Denys Shlega said on Sunday in a televised interview that at least one more round of evacuations is needed to clear civilians from the Azovstal steel mill and dozens of small children are inside bunkers below the industrial facilities.

The shelling began as soon as rescue crews ceased evacuating civilians from the plant, Shlega said. The commander estimated that several hundred civilians still

are trapped at the site alongside nearly 500 wounded soldiers and numerous dead bodies. The plant is the only part of the city not occupied by the Russians. A video published earlier on

Sunday by the Russian defence ministry showed people walking out of the steel plant, including a small group of women accompanied by two pet dogs.

Do not worry about securing a working majority in Parliament: Former PM Wickremesinghe

Sri Lanka's former Prime Minister Ranil Wickremesinghe has said that political leaders should focus on seeking financial assistance from a number of countries, including India and China, to get the debt-ridden island nation out of its worst economic crisis rather than worrying about securing a working majority in Parliament.

Addressing the United National Party's (UNP) Jathika Sevaka Sangamaya May Day

ceremony at New Town Hall in Colombo on Sunday, Wickremesinghe said the government led by President Gotabaya Rajapaksa should give priority to resolving the ongoing economic crisis and take immediate action to control the prices of essential

"It should pay attention to saving the banking system from collapsing. It should. We saw how the banking sector collapsed in Greece and the same happened in Indonesia in 1998. The government should



speak to India, China, Japan and South Korea to seek help,' he said. "Having 113 MPs in Parliament is no longer the solution for the present problem. The country is facing an economic crisis of unprecedented proportion," he was quoted as saying by The Island newspaper. Sri Lanka is in the grip of an unprecedented economic turmoil since its independence from Britain in 1948.

The minister noted that there appears to be shortage of power in the country as the requirement has increased on account of economic growth.

Jos hasn't taken his form for granted in IPL 2022: Knight

 $F^{ormer} \ \ England \ \ cricketer \ \ Nick \ \ Knight \ \ is \\ impressed \ with \ the \ way \ Rajasthan \ Royals' \ star$ opener Jos Buttler is scoring runs game after game in the ongoing IPL 2022.

The top-order English batter is on a run-

scoring spree in the ongoing IPL and there's no stopping him. In the 15th edition of IPL, the explosive right-handed batter is leading the Orange Cap race by a margin of more than a hundred runs. The Royals' wicketkeeper-batter is at the top of the run-scoring list with 588 runs to his name

Knight has applauded Buttler for forgetting the success of the previous game every time he walks into the field and taking his time to get used to the pitch, conditions and then construct his innings accordingly.

Speaking on 'Cricket Live' on Star Sports, Knight said: "What impressed me hugely about Jos Buttler is the way he's started every innings. I mean if we' look at the outcome of his innings, mostly it's either the 50s or 100s, he's (looking) in a different gear. (But) He tends to forget what he did in the previous game and starts afresh.

(He) Hasn't taken his form for grant-

ed at all. He's giving himself a few balls to get in and then play those big shots." Former England spinner Graeme Swann, however, has cautioned Rajasthan Royals to not

rely heavily on Buttler and advised the middleorder batters to start scoring runs in the middle overs. Swann reckons scoring at a decent pace in the middle overs will augur well for the teams in the upcoming games as the pitch-

es will slow down at the far end of the tournament while most of the Rajasthan batters love batting on fast surfaces. Swann said, "The worrying thing

from Rajasthan Royals' point of view, if there is something they need to worry about, is that at the back end of the tournament the wickets are going to slow down where it will start skidding more. Up until now, they've played on some brilliant batting tracks and the RR batting has been so good that they've won

every game."
"They've been too far ahead of every team. But with the wickets turning and getting slow (as the tournament progresses) may distract them going forward and they might lose some close games. So, they'll have to find a way because it cannot always be smash-smash, and they can't heavily rely on Buttler. They need to find a way in the middle overs to score those 10-20 runs extra even in low scoring games," he added.
