WHO: 47L died of Covid in India; Centre says no

India objects to model used by WHO to project death numbers

 $T^{\text{here were 4.7 million Covid}}_{\text{ deaths in India }-10 \text{ times}}_{\text{the official figures }-\text{ between}}$ January 1, 2020 and December 31, 2021 and almost a third of Covid deaths globally, the World Health Organization (WHO) said on Thursday, releasing new estimates on the death toll of the Covid-19 pan-

India has, however, strongly objected to the use of mathematical models by the global health agency for projecting excess mortality estimates linked to the coronavirus pandemic in view of the availability of authentic data, saying that validity and robustness of the models used and methodology of data collection are questionable

The WHO report claimed more than three times the number of deaths than officially recorded worldwide — a total of approximately 14.9 million fatalities.

"These sobering data not only point to the impact of the pandemic but also to the need



for all countries to invest in more resilient health systems that can sustain essential health services during crises, including stronger health information systems," said Dr Tedros Ádhanom Ghebreyesus, WHO director-general. The WHO data showed

that till August 2020, a period when the country had mostly been under lockdown that began in late March, there were approximately 62,000 fewer deaths. Deaths began to rise from September, coinciding with the first waves in many States. More than half of the excess deaths, at 2.7 million,

took place during the peak of the second nationwide wave in the months of April, May and June last year.

Excess mortality, WHO said, is calculated as the difference between the number of deaths that have occurred and the number that would be expected in the absence of the pandemic based on data from earlier years.

Most of the excess deaths (84 per cent) are concentrated in South-East Asia, Europe, and the Americas. Some 68 per cent of excess deaths are concentrated in just 10 countries globally, the world health body

J&K Delimitation panel gives 43 seats to Jammu, 47 seats to Kashmir

The Delimitation Commission on Thursday recommended an increase of seven Assembly seats for J&K, from the earlier 83 seats in the erstwhile State to 90 seats now. While 43 seats will be a part of Jammu region, 47 seats will be

in the Kashmir region.
This apart, for the first time nine seats have been reserved for Scheduled Tribes six in Jammu region and three in the Valley. The Commission asked the Centre to also consider a provision of at least two members (one of them must be a female) from the community of Kashmiri migrants from Pakistan Occupied Jammu & Kashmir (PoJK) in the Legislative Assembly with the power of nominated members.

Delimitation The Commission, tasked with redrawing the Assembly constituencies of Jammu & Kashmir, was headed by Justice (Retd) Ranjana Desai. The commission signed the final order on redrawing the Assembly constituencies of the Union Territory, a day before its term was to end. A gazette notification for the same was also published on Thursday.

"Out of the 90 Assembly constituencies in the region, 43 will be a part of Jammu region and 47 of the Kashmir region keeping in view the provisions of Section 9(1)(a) of the Delimitation Act, 2002 and

Section 60(2)(b) of the Jammu & Kashmir Reorganisation Act, 2019. After consultation with associate members, representatives of political parties, citizens and civil society groups, nine ACs have been reserved for STs, out of which, 6 are in Jammu region and 3 ACs in the Valley," the Commission said in its final report on Thursday.

There are Parliamentary constituencies in the region. The Delimitation Commission has seen the Jammu & Kashmir region as one single Union Territory. Therefore, one of the Parliamentary constituencies has been carved out combining Anantnag region in the Valley and Rajouri, Poonch of Jammu region. By this reorganisation each Parliamentary constituency will have equal number of 18 Assembly con-

stituencies each. Names of some of the Assembly constituencies have also been changed keeping in view the demand of local representatives. These name changes included naming Tangmarg Assembly seat as Gulmarg Assembly seat, Zoonimar as Zaidibal Assembly seat, Sonwar as Lal Chowk, Padder as Padder-Nagseni, Kathua North as Jasrota, Kathua South as Kathua, Khour as Chhamb, Mahore Assembly seat as Gulabhgarh Assembly seat, Darhal as Budhal Assembly

Modi, Macron review ties, call for end to **Ukraine war at once**

Prime Minister Narendra Modi and French President Emmanuel Macron reviewed the entire gamut of strategic and defence ties between India and France and the situation in Ukraine. The two leaders called for "an immediate cessation of hostilities" there.

In their meeting late on Wednesday, Modi and Macron also took stock of the situation in the strategically important Indo-Pacific region and the after-effects of the corona pandemic and food crisis arising due to ongoing conflict in Ukraine. After visiting Germany and Denmark, the

Paris to meet Macron who was last week re-elected as the President of France.

In a joint statement released after the talks between Modi and Macron, France reit erated its "strong condemnation of the unlawful and unprovoked aggression against Ukraine by Russian Forces".

India and France expressed serious concern about the ongoing conflict and humanitarian crisis in Ukraine. They unequivocally condemned civilian deaths in Ukraine and called for an immediate cessation of hostilities to bring par ties together to promote dialogue and diplomacy to find an immediate end to the suffering

of the people.

City reports 1,365 Covid cases, positivity rate rises to 6.35%

The national capital on Thursday reported 1,365 COVID-19 cases with no death, while the positivity rate stood at 6.35 per cent, according to data shared by health department. With these new cases, the

national capital's overall tally has increased to 18,85,636, while the death toll stands at 26,177. Delhi on Tuesday reported 1,414 COVID-19 cases with one death, while positivity rate stood at 5.97 per cent. Delhi on Monday reported 1,076 COVID-19 cases with no death, while positivity rate stood at 6.42 per cent. On Sunday, the city recorded 1,485 cases and no

death due to disease, while positivity rate stood at 4.89 per cent On Saturday, it recorded 1,520 cases and one death, with positivity rate at 5.10 per cent. A total of 16,753 Covid tests were conducted in city on Sunday according to the latest health

The Delhi government has increased number of beds dedicated to Covid patients at two of its facilities, including an 80 percent escalation in its count at . Lok Nayak (LNJP) Hospital. The Delhi government also made masks mandatory at public places with immediate effect and imposed a fine of Rs 500 for any violation as covid cases rise in city again.

Govt nod for setting up 4 'Zila Sainik Boards'

The Arvina Rej.....
Government on Thursday Arvind Kejriwal gave nod to a proposal to set up four 'Zila Sainik Boards' in four districts. The government has also approved a start-up policy which seeks to provide the youth with financial and procedural help in setting up com-panies and formed a 20-member task force for the purpose. The decision was taken at a

cabinet meeting on Thursday.
Under the Rajya Sainik
board, the Zila Sainik boards will be set up in Southwest, East, Northwest and Central Delhi. As per the proposal, the authority to establish the Zila

Sainik Board in districts where the number of retired soldiers exceeds 7,500. A total of 11 officers will be appointed in each Zila Sainik Board, which will include the Secretary, Assistant Secretary, head clerk and staff, and other employees.

"Each board will also

receive approximately Rs four crore per year from the Delhi Government. As per the start up policy, a Startup Policy Monitoring Committee will be formed to oversee Delhi Startup Policy. It will be headed by Delhi's Finance Minister and it will consist of the city's Industries Minister and senior representatives of other state departments as members.

Reconsider amendments in Juvenile Justice Amendment Act 2021, urges NGO

Prayas, one of the country's prominent NGO working for juveniles has urged the Government to reconsider some amendments in the Juvenile Justice Amendment Act, 2021 to protect children.

In a letter to the ministry of women and child development, Prayas founder secretary Amod Kanth enunciated in specific and detailed recommendations, regarding amendments to be reconsidered, such as, section (86)2 of the Juvenile Justice (Care & Protection of Children) Amendment Act,

2021. Giving detailed reasons, he said the above section was retrogressive and having worked for years in child protection and care, he felt that it created a legal discrepancy which in turn diluted the commitment of the government towards children to protect them and safeguard their rights. The key question which Kanth from his long service in law enforcement and Prayas posed whether an offence could be non-cognizable and non bailable at same time. The non-cognizable offences as per law are not serious and are considered for bail.

"In an intelligence-led operation, the Punjab Police and the Haryana Police arrested four persons today at Karnal with the recovery of 3 IEDs weighing 2.5 kg each and one pistol. Further investigation is on," the Punjab Police said in a

The four — all residents of Punjab — were nabbed near Bastara toll plaza after the Haryana Police intercepted them. Three containers each weighing 2.5 kg suspected to contain RDX, a Pakistan-made pistol and 31 live cartridges, besides ₹1.3 lakh in cash, have been seized from the vehicle.

After the vehicle was intercepted in Karnal, a bomb disposal squad and forensic experts reached the spot. A case under the Unlawful have also been named as Arms Act and the Explosive Substances Act has been registered. The Haryana Police has constituted a special investigation team to conduct further probe in the matter. The four —

identified as Bhupinder Singh from village Bhatian in Ludhiana and Gurpreet Singh, Parminder Singh and Amandeep Singh from Vinijoke village in Zira, Ferozepur were headed to Adilabad in Telangana to deliver a consignment of explosives.

"They were in touch with a Pakistan-based man Harvinder Singh Rinda, who is involved in terror activities and who used to send locations through an app to them to deliver explosives and weapons. Rinda used to drop weapons and explosives at a pre-designated location in the fields in Ferozepur with the help of drones," Punia said, adding, "We are ascertaining the terrorist outfit with which they were associated."

Punia said Gurpreet Singh, the key accused, had met Rajbir Singh, an associate of Rinda, in jail. In the FIR registered on Thursday, Rinda and Rajbir Ludhiana jail, he came in contact with Rajbir. And Rajbir connected him to Rinda. Earlier too, the suspects had delivered explosives at Rinda's behest to various locations told by him,

according to the FIR. "Rinda is involved in terror activities, he supplies arms and drugs and sends location to them and their task is to transport these explosives and arms...," he said. The four suspects, two of whom are stated to be brothers, were produced before a court in . Karnal and remanded to 10-day police custody.

The Punjab Police, in a statement later, said in a wellcoordinated operation, they successfully averted a possible terrorist attack by giving a hot chase of over 300 km to the suspects and passing on inputs to their Haryana counterparts about their movement.

Giving details of the incident, Punjab DGP VK Bhawra said that central agencies earlier shared an input that some suspects, who may be carrying explosive material and weapons, are moving in the border districts of Fazilka and Ferozepur.

India which has contested the WHO estimates is likely to raise the issue at the World Health Assembly and required multilateral forums, sources in the Union Health Ministry said.

'Those numbers, which are in sync with India's stated death toll, are of actual deaths, Niti Aayog's Dr VK Paul, one of the people in charge of India's response to Covid-19 said, adding that there's no need to resort to models to arrive at the death toll when actual numbers are available.

India has been consistently objecting to the methodology adopted by the WHO to project excess mortality estimates based on mathematical models, the Ministry said in a statement. "Despite India's objection to

the process, methodology and outcome of this modelling exercise, WHO has released the excess mortality estimates without adequately addressing India's concerns," the statement said. India had also informed

the WHO that in view of the availability of authentic data published through Civil Registration System (CRS) by the Registrar General of India (RGI), mathematical models should not be used for projecting excess mortality numbers for India.

Registration of births and deaths in India is extremely robust and is governed by decades old statutory legal

framework, i.e. "Births & Deaths Registration Act, 1969". The civil registration data as well as sample registration data released annually by the RGI has been used by a large number of researchers, policy makers and scientists both domestically and globally, the Ministry said.

India had also underlined the fact that given the accuracy of the mortality data collected through an effective and robust statutory system, India doesn't deserve to be placed in Tier II countries, the statement said. "WHO till date has not

responded to India's contention. India has consistently questioned WHO's own admission that data in respect of seventeen Indian States was obtained from some websites and media reports and was used in their mathematical model.

This reflects a statistically unsound and scientifically questionable methodology of data collection for making excess mortality projections in case of India," the statement said.

Despite communicating this data to WHO for supporting their publication, WHO for reasons best known to them conveniently chose to ignore the available data submitted by India and published the excess mortality estimates for which the methodology, source of data, and the outcomes has been consistently questioned by India," the statement said. Orders issued against forcing students to buy 'costly' books, uniforms from school vendors

STAFF REPORTER NEW DELHI

The Delhi Government on Thursday issued orders to private schools asking them not to force parents to buy expensive education material and uniforms from the school or any specific vendor, failing which they would risk facing "stringent action". An order from the Directorate of Education (DoE) said private schools are run by trusts/societies and have "no scope of profit and commercialisation".

The order states that schools should display the classwise list of books/writing material to be introduced in the coming session, well in advance on the school website, and also communicate it clearly to parents via other media. The DoE has additionally ordered that the schools must not change colour, tions of uniforms for at least the

"Apart from this, schools shall also display the names, addresses and telephone numbers of at least five shops in proximity to the school where books and uniforms shall be made available for students. However, schools are not allowed to force parents to purchase these from any of the selected vendors particularly. Parents can buy the books and uniforms from any shop as per their convenience and suitability," the order stated.

Delhi's Deputy Chief Minister and Education Minister Manish Sisodia said that this order will give a breather to parents who are struggling to pay heavy amounts for books and uniforms in private schools. "Many households have lost their source of income since the pandemic hit two years ago, making it difficult for them to purchase expensive books and uniforms from specific shops that charge arbitrarily. This order will give freedom

books and uniforms for their children as per their convenience. No school has the authority to compel parents to buy books or uniforms from a specific vendor. The main cause of education should be to nurture the future of the nation, not minting money. Schools should know that they are under the strict supervision of the Government and will not be allowed to arbitrarily charge parents for books and uniforms," said Sisodia.

Meanwhile, Rajiv Sharma, a resident of Preet Vihar, whose child studies at Universal Public School alleged that the school had given them a name and number of a specific vendor, who sits in the school and is charging much more for books and uniforms as compared to the market rates.

"I had to buy my child books for ₹5,200 from the school and in the market those books are available at cheaper rates. They are charging almost double the amount from parents," Sharma alleged.

Parents can't be forced to SDMC puts brakes on its bulldozers

anti-encroachment drive postponed till May 8 due to non-availability of adequate police protection

The South Delhi Municipal Corporation (SDMC) on Thursday put the brakes on its bulldozers and halted the first phase of its anti-encroachment drive till May 8 due to the nonavailability of adequate police protection.

the Kalindi Kunj-Jamia Nagar area near Shaheen Bagh and in Sriniwaspuri was cancelled till Sunday, due to the unavailability of an adequate police force.
The SDMC's Central Zone

Chairman, Rajpal Singh told The Pioneer that the drive was cancelled, following a communication from the Delhi Police stating that adequate police force was not available to maintain law and order in the area during the demolition. "We will reschedule the drive that was supposed to take place in the Kalindi Kunj-Jamia Nagar area today. The civic body has also asked Delhi Police to provide us with a sufficient number of police personnel to peacefully conduct the demolition drive. On May

DJB chalks out mega development plan

25K East Delhi households to get 100% sewer connectivity, RO water for JJ clusters to end tanker system

STAFF REPORTER NEW DELHI

The Delhi Government has chalked out a mega-plan for the development of free sewer connections, new sewer lines, and Reverse Osmosis (RO) plants in the State. To meet the long-pending demand for the same, under this plan, the city Government will provide 25,000 households in East Delhi with 100 per cent sewer connectivity free of cost. The Government will also install 30 RO plants in JJ clusters to end the existing tanker system.

Delhi Water Minister and Delhi Jal Board (DJB) Chairman Satyendar Jain on Thursday chaired a Board meeting with senior officials and approved proposals for

sewer connectivity free of cost, installing ROs and connecting sewer lines. "These free sewer connections will be provided under the 'Mukhyamantri Muft Sewer Connection Yojna' and the regions of Karawal Nagar and Mustafabad will benefit the most out of it," Jain said after the meeting. These 12 colonies where sewer connections will be installed include Chandu Nagar, Moonga Nagar, Rajiv Gandhi Nagar, Nehru Vihar, Old Mustafabad Gali No. 1-9, Mustafabad Extension Gali No. 10-27, Dayalpur Extension A,B,C,D,E and F Blocks and Khajuri Khas area. Sewer connectivity in these

colonies will prevent 2.5 crore litres of untreated waste from falling into the Yamuna. New 25 KM and 10 KM sewer lines will be laid in Burari and Narela, too, benefitting lakhs of residents of the region.

"During the meeting, laying of new sewer lines, providing household sewer connections, upgrading existing Sewage Treatment Plants (STPs), providing RO water

providing 25,000 households in East Delhi with 100 per cent and improving the revenue and improving the revenue management system of the DJB were discussed," said a senior DJB official. "A decision to provide sewer connections to individual houses of 12 colonies in East Delhi's Karawal Nagar

and Mustafabad constituen-

cies was taken, for which a bud-

get of Rs 19 crore will be allo-

cated," he said. "We have also decided to upgrade the 40 MGD Rithala STP on a unique financial model to reinforce quality. The BOD and TSS levels will also come down from 15 mg/L to 10 mg/L and 20 mg/L to 10 mg/L respectively, following the upgradation," said Jain.

There will be construction of a vertical 7 MGD STP at Sonia Vihar and a 12 MGD wastewater pumping station at Rajiv Nagar. At present, 7 MGD of sewage is generated from six unauthorised colonies in Sonia Vihar group of colonies under the Karawal Nagar constituency. This waste will be transported to WWTP through a pumping station for proper treatment," said Jain.

"To cater to the long-standing issue of treating the increased ammonia in raw water being received from Haryana, the Board has approved the work of rehabilitating the existing non-functional water treatment plant into a 6 MGD water treatment

plant to treat ammonia up to 10

ppm," said Jain. "The DJB has also decided to install 30 RO plants in JJ Colonies in the first phase of the scheme. These plants will be functional 24×7 and will be equipped with 8-10 dispensing units in different locations to cater to a larger population in a hassle-free manner," said

"The water will be completely free of cost to the public. Each RO machine will have a capacity to dispense 50,000 liters of water every day and in case of high demand, the same machine can deliver up to 65,000 liters. RFID cards will be issued to the families that can be punched on the RO water dispenser which will then dispense volumes in the range of 10 liters and 20 liters as per demand," said Jain.

The first train set of Regional Rapid Transit System (RRTS) will be handed over to the National Capital Region Transport Corporation (NCRTC) NCRTC in a ceremony in Gujarat's Savli on Saturday. The NCRTC is establishing India's first RRTS which is a rail-based, high-speed, highfrequency regional commuter transit system. According to the CPWD's written communication issued last week, the MoHUA Ministry has been asked to give a detailed report on projects that can be initiated and inaugurated by Prime Minister Modi. The Central Public Works Department (CPWD), which comes under the Union Housing and Urban Affairs

tion agency of the central government. The CPWD has also been executing the Modi gov-ernment's ambitious Central Vista redevelopment project.

'PMO requires the information of details of projects of the Ministry of Housing and Urban Affairs for which foundation stone can be laid and which are ready for inauguration in next 2 years by the PM," the document states. CPWD executive engineer

Damanjeet Singh asked officials concerned to furnish the compiled information at regional level to the directorate. The officials had been asked to submit such details by May 2. Singh said that only those projects will be considered for foundation stone lay ing where acquisition and other clearances such as forest or environmental are complete. According to the document, details like project cost, name of state and expected date of completion and inauguration have been sought. Details such as after inauguration, any negative sentiments or protest

project, have also been sought. For projects whose foun-

dation will be laid, the CPWD asked officials concerned to submit information like expected date of foundation stone laying and expected date of completion of land acquisition.

Under the Central Vista redevelopment project, the CPWD has set the deadline of October this year to complete the construction work of a

new parliament building.

The agency will also construct an 'Executive Enclave' that will house the PMO. Cabinet Secretariat, India House and National Security Council Secretariat. The project is expected to be completed within 24 months.

The redevelopment of the Central Vista, the nation's power corridor, envisages a new parliament building, a common central secretariat, revamping of the three-km Rajpath from the Rashtrapati Bhavan to the India Gate, new office and residence of the prime minister, and a new vice-president enclave.

India, Australia discuss ways to combat terrorism

The Supreme Court on Thursday said it will hear in July Lok Sabha MP Navneet Kaur Rana's appeal challenging the Bombay High Court verdict cancelling her caste certificate. The Independent MP represents Maĥarashtra's Amravati constituency, reserved for Scheduled Castes. A bench of Justices Vineet Saran and J K Maheshwari adjourned the matter after senior advocate Mukul Rohatgi, appearing for Rana, said the matter will take some time. "We will have it in July," the bench said. The matter is likely to come up before a new bench after the vacation as Justice Saran is due to retire on

On June 22 last year, the top court stayed the high court ver-dict cancelling Rana's caste

certificate. Mumbai High Court had said the caste certificate was obtained fraudulently using fabricated documents and had also imposed a fine of Rs 2 lakh on her. Rana, backed by the Nationalist Congress Party (NCP), won from Amravati in 2019 by claiming to be a member of the 'Mochi' caste.

The High Court, in its judgement, had asked Rana to surrender the certificate within six weeks and had asked her to pay a penalty of Rs two lakh to the Maharashtra Legal Services Authority within two weeks. HC had held that Rana's claim of belonging to the 'Mochi' caste for obtaining the Scheduled Castes certificate itself was fraudulent and made with the intention of obtaining various benefits available to a candidate from such category, despite knowing she does not belong to that caste.

SC upholds Delhi HC order on ₹4.6Kcr arbitral award to DAMEPL in favour of DAMEPL, which

The Supreme Court on Thursday upheld a Delhi High Court order directing the Delhi Metro Rail Corporation (DMRC) to pay over Rs 4,600 crore of arbitral award along with interest to Anil Ambani Groups' Delhi Airport Metro Express Private Limited (DAMEPL) in two equal installments in two months. The order was passed by a bench of Justices L Nageswara Rao and B R Gavai.

Delhi High Court on March 10 had directed the DMRC to pay over Rs 4,600 crore of arbitral award along with interest to DAMEPL. HC's judgment had come on DAMEPL's execution petition filed against DMRC concerning the arbitral award in its favour. An arbitral tribunal in its May 2017 award had ruled had pulled out from running the Airport Express metro line over safety issues, and accepted its claim that the running of operations on the line was not viable due to structural defects in the viaduct through which the train would run. The arbitral award per-

tained to a concession agreement between the two entities, which was signed on August 25, 2008. Under the agreement, the DMRC was to carry out civil works, excluding at the depot, and the balance, including the project system works, were to be executed by DAME-PL, a joint venture of Anil Ambani Group's Reliance Infrastructure (R-infra) and a Spanish construction company Construcciones Y Auxiliar

ED files chargesheet against Ahmed AR Buhari in money laundering case

PNS ■ NEW DELHI

Enforcement Directorate (ED) has filed a Prosecution Complaint (chargesheet) before a Chennai court against Ahmed AR Buhari and others in a money laundering case of over valuation of coal prices whereby the Public Sector Undertakings paid higher price for the purchase of lower quality of coal. The agency has also sought confiscation of properties of the accused worth Rs 565 crore.

The court has taken cognizance of the Prosecution Complaint.

The ED had initiated money laundering investigation on the basis of an FIR registered by the CBI, New Delhi against Ahmed AR Buhari, Promoter of Coastal Energy Pvt Ltd, Chennai and other unknown officials of PSUs under various sections of Indian PenaL Code and relevant provisions of the

Prevention of Corruption Act. The investigation in the matter was also conducted by

the Directorate of Revenue Intelligence (DRI) and a show cause notice to the party has been issued under the provisions of Customs Act, 1962. The ED probe revealed

that Buhari is controlling the companies Coastal Energy Private Limited, Chennai, Coastal Energen Private Limited, Coal & Oil Group Dubai and other offshore entities located in Mauritius and British Virgin Islands.

The PSUs were supplied coal of lower calorific value instead of the higher specifi-cation for which the tenders were floated and executed by the CEPL or MMTC and the coal was supplied by CEPL either directly or through MMTC on the strength of overvalued invoice for lower quality supported with fraudulent Certificate of Sampling and Analysis (COSA) whereas

the original COSA depicting the genuine quality of coal was suppressed," the ED said in

Investigation further revealed that Buhari generated proceeds of crime (POC) to the tune of Rs 564.48 crore from the over valuation of coal. Buhari had diverted the proceeds of crime through various companies and finally integrated the same in the installation of a power plant by another company Coastal Energen.

The prosecution complaint has been filed against Buhari, Coastal Energy Private Limited, Chennai, Coastal Energen Private Limited, Chennai, CNO DMCC, Dubai, CNO LLC, Dubai, Precious Energy Holdings Limited, British Virgin Island and Mutiara Energy Holdings Limited, Mauritius. All the six accused companies are managed, controlled and beneficially owned by Buhari, the agency said.

It was further alleged that the accused demanded initial part payment of Rs 2 lakh, out of the total demand of Rs 20 lakh from the complainant and told him that a private person would come to collect the said amount at Pune.

The CBI laid a trap and caught the said private person while accepting the initial part payment of Rs 2 lakh from the Complainant.

Later, the Interim Resolution Professional (IRP) and the Proprietor/Jeweller of Mumbai whose alleged role came in the case were also caught.

Searches were conducted at the premises of the accused at Pune, Navi Mumbai which led to recovery of incriminating documents. All the three arrested accused are being produced in the Court of Special Judge, CBI Cases, Pune.

Covid infection may boost antibodies against common cold

etting sick with a common Gcold doesn't make you immune to Covid-19, but a Covid infection might, at least temporarily, boost the number of antibodies you have against common cold-causing coronaviruses and the SARS-CoV-1 and MERS-CoV viruses, all of which are closely related, a study has said.



Under National Film Heritage Mission, approximately 2,200 films will undergo restoration. The titles have been shortlisted by language wise committees consisting of

filmmakers, documentary film- material. makers, film historians, producers etc. Eminent film personalities such as Aparna Sen, Shriram Raghavan, Anjali Menon and Vetrimaaran were part of the committees.

"National Film Heritage Mission in addition to restoration also involves the on-going preservation processes of film condition assessment, preventive conservation and digitization, with the total allocated budget of Rs. 597 crores, which is one of the world's largest film preservation mission," the Minister said.

'The process involves frame-to-frame digital and semi-automated manual picture and sound restoration from the best surviving source

The source negative/print will be scanned at 4K to .dpx files, which will be then digitally restored. The damages including scratches, dirt and abrasions in every frame of the picture negative will be cleaned during the restoration process.

Fat in the fire

COVID obesity is a stark truth staring us in the face, and the prediction is scary

The COVID pandemic is giving rise to a second one that is tugging at the waistline of a growing number of adults and children — the obesity pandemic. The World Health Organisation thought it fit to issue an alert that rates of obesity are reaching epidemic proportions at present. Its European Regional Obesity Report says that in the post-lockdown world, only the Americas have a higher level of obese adults than Europe. India is not far behind. The Indian Journal of Community Medicine says the prevalence of obesity has reached 40 per cent. That makes it 135 million people, give or take a few thousand. The National Centre for Biotechnology Information warns that by 2030, around 28 per cent of all overweight people in the world would be Indians. That is a scary prediction and the Indian Council of Medical Research is teaming with the National Institute of Nutrition to conduct a national survey to assess the correlation between obesity and the pandemic. The reasons are already well known. Lifestyles became sedentary during the lockdowns. Confined to home for months together, binge eating and junk eating became the norm for most. As the restrictions relaxed, a second binge followed as meal delivery apps became popular, giving access to unhealthy food and beverage

options. Stress was the other culprit. Job losses, food insecurity and economic hardships added to stress levels. Stress makes the body store more fat, and that leads to obesity. Left untreated, it attracts co-morbidities including heart ailments, hypertension and diabetes.

It is time obesity is recognised as a disease which it is. As individuals, people have a responsibility to deal with it. It is not merely about medical treatment. It is also about a sustainable lifestyle, balanced eating and, in the case of mental stress, going in for counselling. It is also the responsibility of the wider society, including the Governments, to address obesity. Take the case

of the food industry. Many of the marketed foods are unhealthy, particularly for children. The industry must be asked to follow a strict front-of-pack labeling system. Access to such foods must be restricted for children in school and cinema canteens. However, it remains a bone of contention between the Government and the industry. It also means that obesity is a problem not of the health sector alone but other sectors as well. For instance, fighting post-COVID obesity calls for addressing social determinants of health like job and food security of people to create stress-resilient environments — that is where the non-health sectors come in. So, we are looking at a cross-sectoral engagement with the disease. Another key issue that needs Government intervention is for medical insurance to cover obesity drugs and behaviour counselling. In India, bariatric surgery was included under medical insurance in 2019 but obese people shell out higher premiums and face several insurance plan exclusions. Many obese customers are forced to compromise on coverage for financial reasons.

he decision of the Indian National Congress to field Uma Thomas as its candidate for the May 31 bypoll from Thrikkakkara appears to be a step in the right direction. The bypoll was necessitated because of the sudden demise of sitting MLA PT Thomas, who was a popular Congress leader in Kerala. Uma, herself a Congress worker, had shadowed her late husband and is widely respected as an environment and ecology enthusiast. What stands out is the promptness with which the Kerala Pradesh



Congress Committee finalised her candidature. The Election Commission of India had declared the poll schedule on Friday and the Congress high command approved Uma's candidature by Tuesday evening. This is the first time in recent history that the Congress announced the name of its candidate well ahead of the date of filing nominations. The coordination and unity among the Congress leadership paved the way for the smooth selection of the candidate. The only name that came up for consideration was that of Uma, which was instantly approved by KPCC president K Sudhakaran, leader of the Opposition VD Satheeshan and top functionaries that include former Chief Minister Oommen

Chandy. Other States have a lot to learn from the Kerala experience.

It is a fact that the Congress is suffering from internecine wars waged by various groups and subgroups. The Congress high command is engaged fully in resolving this internal warfare, leaving it with less time to plan election strategies. Every day, we read reports about faction leaders undertaking "pilgrimages" to 10 Janpath and the AICC headquarters with their bundle of woes. It is in stark contrast to the 1960s and 1970s when the Congress had regional satraps whose decisions were the last word in their respective States. The dithering and withering within the Congress started when the high command started nurturing groups against the officially appointed leaders. That was the era of leaders like K Kamaraj, Devaraj Urs, S Nijalingappa, N Sanjeeva Reddy, Biju Patnaik, VP Patil, SK Patil and YB Chavan, who were entrusted with the task of running the party in their regions of influence. The Congress now is a pale shadow of its old self because of the absence of such leaders. Let's hope the high command notices the speed with which the Kerala leaders reached unanimity. Happy days are perhaps waiting for the 'grand old party'.




The Civil Registration System accurately captures death registration data and proves COVID is not the only reason for increased death registration

he Civil Registration System (CRS) data released by the office of the Registrar General of India (RGI) shows a 6.2 per cent increase in the number of death registrations in 2020. From 76.4 lakh registered deaths in 2019, it went up to 81.2 lakh in 2020, which is consistent with the recent trend of increasing registrations of deaths in the country.

The 2018 figures showed a 7.5 per cent increase over the previous year's death registration, and then an almost 10 per cent spike in 2019. With India making steady strides towards 'maximum and people-friendly digitalisation, death registration has also become easier, which reflects in the trends over the last few years. The heightened social awareness towards requirement of such certificates for bank accounts, property settlements and more has also been a factor in increased registration. Due to sensitisation conducted by RGI and Chief Registrars of the States and UTs, increased use of IT and mobile-based apps, the level of birth and death registration has increased substantially.

While the country reports a downward trend in Crude Death Rate, which is 6/1000 live births as per the SRS 2016-18, the estimates for death registrations have improved over time, which does not indicate actual increase in number of deaths. This improved trend of death registration may be attributed to several factors and mechanisms strengthening the CRS and spans detailing of work division (Microplan), digitalisation of death registration system in CRS (more than 54 per cent in 2020 and 85 per cent in 2022), and global commitment to attain Sustainable Development Goals (SDG) targets (16.9 and 17.1). One of the crucial and beneficial steps taken in CRS of India along the years is the 'linkage of data points across the sources' for, say, hospital admission and discharge register, hospital mortuary register, disease surveillance register, cancer register and police records, thus further enhancing the robustness.

The RGI's annual CRS figures capture 'all-cause mortality'. The deaths due to COVID make a subset of the overall figure. And, it is these reliable figures released by the Statutory Authority of RGI that should be utilised. As on May 3, 2022, India had recorded 4,30,85,166 COVID cases with 5,23,889 deaths with a Case Fatality Rate of 1.2 per cent. India reported its first death due to the pandemic on March 13, 2020, and reported cumulative deaths of 1,48,738 in 2020. The number nearly doubled to 3,32,342 in 2021 during the second wave. The close tracking of

COVID cases and mortality statistics on a daily basis, with the help of real-time dash board, has also reiterated on the importance of the process, The raised eyebrows and thus supporting the systems in

Along with the success stories of COVID-19 mitigation in India, the country's efforts to contain the virus with active engagement of Frontline workers, uninterrupted service delivery, and vital registrations at district level should also be referred and captured.

An increase of 4.8 lakh death registration in 2020 from the previous year reaffirms the CRS' efficiency. The COVID deaths out of total registered deaths of 81.2 lakh in 2020 are reported as 1.48 lakh. The figures of death registration provided by CRS 2020 do not need statistical measures like 95 per cent confidence interval as these are actual figures and not estimates.

Moreover, the modellingdriven estimates or studies have a great scope for fallacy owing to selective-restrictive sample datasets, analysis assumptions, overestimations and interpretations. They rely more on the assumption software as compared to vigorous data collation technique adopted by the Union Government. The RGI methodology is

extremely robust, with the birth and death registration done under 'Registration of Birth and Death Act 1969'. Under that legal framework, CRS provides for universal, continuous, compulsory and permanent recording of birth, death and still birth.

To rectify an underestimation, say reported COVID deaths in India, the mathematical models do not seem to be a suitable solution which would be providing an unclear and incorrect picture by proposing the death count very high as compared to reported by National reports. Modelling software were meant and used to identify the hotspot with attributable risk factors to support the prevention and treatment decisions by the local authority to control the event and thus save

Thus, estimates obtained from modelling techniques are inappropriate to counter the actual national level statistics showing actual numbers of death registration by a robust system using multiple data points complemented with using appropriate definitions for labelling COVID deaths.

When journalists are gagged, they are forced to report news in a distorted way.

DECODING NARENDRA MODI'S EUROPE VISIT

Post-Ukraine, Europe looks at the Indo-Pacific as new sphere of influence

ndian Prime Minister's three-day European tour is a strategic tilt towards building closer ties with the once-ignored and yet extremely important ally. India and Europe have historically not had strategic partnerships in the past due to their respective domestic and geopolitical orientations. India has always viewed post-World War Europe from a UK or the cold-war frame of reference. It has in the last six decades worked with Russia to arrest Europe's dominance. Meanwhile Europe too has largely ignored the strategic importance of India and placed bets on China as a stabilising factor in pan-Asian geopolitics. This doesn't mean individual countries in Europe or power blocs haven't had strong bilateral ties with India in the past few decades. This status quo has now been challenged by Russian aggression in Ukraine. It has forced Europe as a bloc to rethink its external engagements, find new allies and partners



and look at the Indo-Pacific as new sphere of influence. Many countries in Europe must rewrite their energy budgets by reducing heavy dependence on Russia. Similarly, there is a sudden need to upgrade their defence machinery and not be dependent on the US-led NATO. It is against this backdrop that Prime Minister Narendra Modi's meetings in Berlin, Copenhagen and Paris assume importance. Germany and India have had long standing bilateral relationship reflected institutionally in the high level Inter Governmental Consultations (IGC) mechanism. This dialogue is extended by Germany to its privileged allies and has involvement of the heads of state along with senior ministers to steer the relationship. India knows Germany's preeminent role in steering European Union's political, strategic and security framework. Also, India and Germany seem to be on the same side, as far as receiving criticism from global powers regarding their energy dependency on Russia is concerned. However, India buys only a fraction of its total fuel requirements from Russia, when compared to Germany. Meanwhile, the Ukraine crisis has forced Germany to commit to significantly reducing its energy dependency on Russia by year end. The visit by the prime minister also marked signing of agreements between the two nations on areas related to green energy, migration and environment.

partnership. The Nordic nations comprising of Finland, Sweden, Iceland, Norway and Denmark comprise a relatively sparsely populated, yet wealthy group of nations in Europe. It is in 2018 that India held its first Nordic summit to align better with these powerful bunch of nations. India and the Nordic countries have huge areas of mutual cooperation untapped, all of which can be significantly important for each other's prosperity. The Nordic nations are known for their expertise in clean energy, healthcare, and green technology. It is an ideal situation for India to scout for investments from these countries, as it builds on its zero-carbon economy and emerge as global leader in clean energy. It also helps India save billions by way of cutting down on 'polluting fuel' import bills. Meanwhile, for Nordic countries India represents a vastly untapped market growing faster than many of their neighbours. It is also a market which boasts of billions of new customers hungry for new innovative products and servicers at "the right price." The last stop for the prime minster, Paris, was to reiterate the continued bilateral dialogue between India and France. France remains one India's most vocal supporters in almost all multilateral and plurilateral platforms. It is also India's close defence partner, having supplied strategic Rafael aircrafts to India. India would be looking at deepening the security partnership with France in the wake of changed geopolitical headwinds.

ndia's diversity is reflected not only through its cultural, religious, social-political, and linguistic practices, but also through its diverse geographical, climatic, environmental, developmental and educational landscapes. The diversity of religion, culture and social systems has not only made India a vibrant society and fully functional democracy but also given it a powerful voice in international arena across the continents. To some extent such diversity has provided a muchneeded breathing space to groups of all segments of the society but the diversity of education and educational institutions which currently prevails in India has limited the right of equality of opportunity in higher education to the students especially living in remote, inaccessible and climatically dangerous geographical and underdeveloped zones

On the other hand, the diversity of education systems also reflects an unhealthy diversity in terms of knowledge and skills being tested by myriad boards like CBSE, AICSE, NIOS, and state boards. The problem is that the lack of an integrated education landscape in India increases the dilemma of the students and their parents, particularly those living in remote areas. The lack of a single-window system for providing admission into the institutions of higher learning and undergraduate courses irrespective of geographical, linguistic or cultural diversity is viewed as a hin-drance to the overall development of the

Therefore, National Educational Policy 2020 proposed access, equity, affordability and integration of educational system of India from primary to higher education level. The way forward for such integration and uniformity was addressed by NTA established under the ministry of education, which has taken this Herculean task as a mission to admit the registered Students who are able to score good marks for clearing the admission test for under graduate courses to be held in the month of July 2022 for various central universities through one single test.

What could be the best way to fulfil the aims of NEP 2020 from the 2022-2023 session than holding one single test for admission in the various subjects ed and shared by the universities with NTA and their own websites. The focus of the exam will be to test the subject/domain and general knowledge of the students based on the NCERT syllabus of the class 12 and thus establish a better connect of the students particularly of the remote areas with the central universities of India and other participating institutions in this common entrance test.

The exam which will be conducted through Multiple Choice Questions will also provide an atmosphere for

objective assessment which will replace the subjectivity in evaluation of the descriptive traditional types of papers of the class 12 exams conducted by different boards. The hand-written answer books will be replaced by computer-based test which will not only facilitate computer literacy among the students of remote areas but also fair assessment of every student participating in this admission process. Such integration and congregation of all central universities of India as well as other private universities, state universities under one banner of NTA was not only unthinkable but also unprecedented in the history of higher education of India because all universities had their own set norms or exams for admissions.

The diversity of exams and processes was not only very taxing financially but also mentally for the prospective students and their parents as a student even scoring 99% marks in class 12 also had no guarantee to be admitted in the university or college of his or her choice or getting the subjects of their temperament. To put an end on the monopoly of certain institutions and bringing all centrally-funded universities under one umbrella is thus not only a very praise worthy step but also very challenging in view of the limited access and awareness among the stakeholders, primarily, the students, parents and teachers of the

inter schools of the rural areas. The CUET (UG) aims to provide wide variety of options like 27 subjects and 33 languages and general test to choose from. This is not only aimed to mitigate the educational and linguistic diversity as the test will be conducted into thirteen languages specified as medium of test for the students but also to provide one step solution to the admission process as through a single form the student may opt for many universities by entering their choices in the registration form. Any student living in the remotest corner of India can now think of getting admission into the big-league universities like Delhi University, JNU, BHU, Hyderabad and many more on the basis of the CUET score as well as according to the norms, condition and policy of that particular university.

This is likely to make the whole admission process very easynot only for the students but also to fulfil the aims of NEP which clearly indicated that the entrance to higher education should be through a common entrance test at the national level so that there is uniformity in standards for bench marking of candidates. As this type of test is being conducted for the first time in all over India through many centres of NTA, therefore, it should be clearly understood by all that there would be many hiccups and problems for which vigorous publicity and awareness drive about the test, registration and connecting with the NTA website or Samarth portal will be

necessary.

Such awareness needs to be especially generated among the students of rural and remote areas where they not only face the issues of connectivity, but also are less computer savvy. In this situation the task of those universities located in remote and geographically difficult areas becomes much more daunting as they not only need to popularise the forthcoming NTA's computer-based test among the class 12 students for admissions in universities of India or those located near their places but also to convince their teachers and parents about the utility of this. These universities and their teams not only have to display all features in local language but also to demonstrate each and every step from registra-tion to filling up of forms by the deadline so that no student who is interested in taking admission in the central universities is left behind in the want of awareness and proper knowledge.

Now, besides NTA, MOE and UGC the basic onus is on the universities particularly the ones located in remote geographical areas to achieve this herculean task of bringing students to their institutions and achieving the target of equity and easy access in education through this common entrance test. This is just the beginning of the step one of the NEP, the next will be more challenging when the NEP will be implemented in all universities with revised pattern of certificate, diploma and degree courses.

Climate change reality: Second hottest April in 72 years

The irony is dependence on coal-fired power plants is proportionately increasing with rising temperatures caused by climate change

he throes of summer seem to have descended upon India prematurely as a shockingly hot and dry month of April dismayed the people across the nation. Average temperatures of over 40 degrees Celsius have been recorded for the second time since 1951 making April the second hottest month in the last 72 years. April usually has a maximum temperature of 36 degree Celsius. The torrid heat waves this year began as early as March which also witnessed record temperatures in the last

122 years The severity can be gauged by the fact that the Indian Railways is cancelling trains to move coal to thermal power stations as the demand for power sky-rocketed. Still,

the gap between coal supply and electricity generation is widening and has caused acute power shortages, especially in Rajasthan, Andhra Pradesh and Haryana. The irony is the dependence on coal-fired power plants is proportionately increasing with the rising temperatures caused by climate change. This vicious cycle seems too difficult to break as the only alternative of renewable energy is not sufficient enough.

According to environmental experts, the unabated accumulation of greenhouse gases is resulting in increased temperatures. Vehicular and industrial pollution have been one of the main causes for GHG emissions in India. But specific pollution events across the nation are making



already bad conditions worse. For instance, the continuous fires at the Bhalswa landfill in Delhi NCR in recent days havespun the air quality and ambient temperatures in Delhi out of control. Considering the fact that the Bhalswa landfill is spread over 36 acres and has 80 lakh tonnes of garbage, any fire here is sure to be a

large-scale disaster. Pollution aside, the number of heatwave days in India

every 10 years, an ongoing study by the Met Department showed. From 413 in 1981-90 to 575 in 2001-10 and 600 in 2011-20, the number of days that see extremely hot days is persistently increasing at 103 weather stations, mostly in inland areas, the study showed.The study also showed that most of the 103 weather stations have recorded a significantly increasing trend in heatwave frequency between April and June during the 1961-2020 period.

The scorching temperatures are causing heat stress conditions for India's poor and marginalised engaged in hard labour for their livelihoods. Additionally, almost half of India's working age

are increasing at a rapid pace farming, which requires long hours of outdoor heat exposure in summer. These situations are causing heat-related health disorders and even deaths amongst this section of population. While India's average temperatures rose by more than 0.5 degrees between 1960 and 2009, the probability of a massive heatrelated mortality event, defined as more than 100 deaths, shot up by as much as 146%, according to a 2017 Increasing probability of mortality during Indian heat

According to a report by the Euro-Mediterranean Center on Climate Change, if global temperatures rise and carbon emissions are not contained to 2 degrees Celsius, population is engaged in then heatwaves in India are

likely to last 25 times longer by 2036-2065. These conditions can have disastrous impact on the delicate ecological environs of the Himalayas as it will directly lead to faster melting of glaciers which in turn will cause floods initially and followed by hard spells of drought after that.

The need of the hour is to adopt a proactive method of prevention of extreme pollution events. Four instance the Bhalswa landfill fire was entirely avoidable and if prevented in time it could have helped reduce ambient temperatures in Delhi besides critical amounts of pollution. Similarly, it is more important now than ever to urgently ramp up renewable energy capacities so that this helpless dependence on thermal energy is controlled.

The Government must aim at making every household and business take ownership of its electricity requirement and generate at least 50 per cent of the same from solar energy by applying to relevant government schemes on renewable energy. This will ensure grassroot level energy self-sufficiency and reduce the demand for thermal energy.

The climate change led spike in temperatures that necessitated a jump in thermal energy requirements should serve as a writing on the wall for India to start focusing on creation of renewable energy as a viable alternative to thermal energy. Unless this is done, India will be a victim of climate change sooner than later.

Ukraine repels Russian attacks, Russian strikes try Mariupol plant battle rages

kraine's military said on Thursday that it recaptured some areas in the south and repelled Russian attacks in the east, as a bloody battle raged at a steel mill in Mariupol where Ukrainian troops are holed up in tunnels and bunkers fending off a Russian onslaught.

Ten weeks into a devastating war, Ukrainian and Russian forces are fighting village by village, as Moscow struggles to gain momentum in the eastern industrial heartland of the Donbas. Russia switched its focus to that region - where Moscow-backed separatists have fought Ukrainian forces for years - after a stiffer than expected resistance bogged its troops down and thwarted its initial goal of overrunning the capital.

In addition to heavy shelling of the Donbas, Russian forces also kept up their bombardment of railroad stations and other supply-line targets across the country — part of an effort to disrupt the supply of Western arms, which have been critical to Ukraine's defense.

Ukrainian forces said Thursday they made some gains on the border of the southern regions of Kherson and Mykolaiv and repelled 11 Russian attacks in the Donetsk and Luhansk regions that make up the Donbas.

Five people were killed and at least 25 more wounded in shelling of cities in the Donbas over the past 24 hours, Ukrainian officials said. The attacks damaged houses and a

More than 300 evacuated from Mariupol, says UN

The United Nations says more than 300 civilians from the besieged southeastern city of Mariupol and four other towns have been evacuated to Ukrainianheld Zaporizhzhia in a second successful operation to get civilians out of areas subject to Russian shelling and attacks.

Rajapaksa-led Govt emerge stronger after defeat of Opp candidate in Deputy Speaker election

n a major victory for Sri Lanka's embattled Rajapaksa clan, their I nominee on Thursday emphatically won a key vote for the a position of Deputy Speaker in Parliament, demonstrating the government's ability to prove their parliamentary majority despite raging public protests demanding the resignation of President Gotabaya Rajapaksa for mishandling the worst economic crisis in decades.

MP Ranjith Siyambalapitiya, who was backed by the ruling coalition led by President Gotabhaya Rajapaksa, was re-elected as the Deputy Speaker with 148 out of 225 MPs voting in favour of him while Imithiaz Bakeer Markar, who was nominated by the main opposition the Samagi Jana Balavegaya (SJB) received only 65 votes.

Three votes were rejected, and six MPs including "dissident" government member Wimal Weerawansa were absent during the

Siyambalapitiya, a member of the former President Maithripala Sirisena's Sri Lanka Freedom Party (SLFP), had resigned as his party SLFP decided to stay independent of the government.

He had been bouncing back and forth between the deputy speaker position since early last month, and his re-election followed his latest resignation that was accepted by President Gotabaya Rajapaksa on

Despite the SLFP going independent, the ruling Sri Lanka Podujana Peramuna (SLPP) decided to back Siyambalapitiya in their bid to show that the government majority was intact. Speaking after his election as the Deputy Speaker, Siyambalapitiya said he had expect-



ed to be unanimously appointed by both the government and the Opposition.

The main Opposition leader Saiith Premadasa said they decided to field their nominee Markar as they had learnt the ruling SLPP was to back Siyambalapitiya at a possible secret vote.

Premadasa accused Siyambalapitiya as a "government stooge." The government majority was seen as fragile since the decision by some 40 lawmakers from the ruling coalition declaring independence in view of the raging public protests calling for the resignation of the entire Rajapaksa family.

With more members from the ruling coalition calling for the resignation of Prime Minister Mahinda Rajapaksa to make way for an interim government of all parties, Rajapaksa stayed put claiming

The Deputy Speaker's vote appears to have restrengthened his position, experts said. Prime Minister Mahinda Rajapaksa and President Gotabaya Rajapaksa are coming under increasing pressure to step down in the simmering economic meltdown where people struggle with all essentials, including having to put up with power cuts.

In an impassioned speech fol-

lowing the vote, Opposition Tamil National Alliance (TNA) MP Shanakiyan Rasamanickam said that the near two thirds' vote in favour of Sri Lanka's government-backed deputy speaker candidate revealed the likelihood of the government easily defeating a proposed no confidence motion against it, the EconomyNext news website reported. Rasamanickam said that only 65 MPs were with the people of Sri Lanka who have been demanding Lanka who have been demanding the resignation of the government, while 148 MPs continue to stand for the ruling Rajapaksa family.

'They're here to save the Rajapaksas. No matter what no confidence motion is brought against this government, these dramatists, crooks and liars will never vote against the Rajapaksas," he was quoted as saying. The TNA MP also berated former prime minister and United National Party (UNP) MP Ranil Wickremesinghe for allegedly supporting the government dur-

"It's clear that this is all theatre. We saw the former PM, who sits in the opposition, approaching each individual sitting here this morning asking them to support Mr Siyambalapitiya," the MP claimed. Former Prime Minister

Wickremesinghe told parliament following Siyambalapitiya's re-election that the lack of consensus on the Deputy Speaker post which was contested by two candidates from the opposition ranks shows the country the divisions within the House.

Wickremsinghe urged the house to work together and solve the pressing issues in the country, warning that otherwise the public will reject parliament as an institution in

Sri Lanka's government has been facing a wave of protests around the tricity supply.

country with an increasingly furious public demanding its resignation. The main opposition Samagi Jana Balavegaya (SJB) has tabled a no confidence motion against the government, but it is unclear at present how much support it will be able to muster in favour of it.

The SJB has handed over to the Speaker two motions of no-confidence against the SLPP coalition government and embattled President Gotabaya Rajapaksa under Article 42 of the Constitution.

Article 42 stipulates that the President is responsible to Parliament for the exercise, performance and discharge of his func-

Any motion needs seven days' notice before getting into the order paper for debate. A date has not yet been announced for a vote on the no-confidence motions.

The Opposition parties accuse top government officials of excessively printing money, hurting farm production by banning chemical fertilizers to make the production fully organic and minimize import costs, failing to order COVID-19 vaccines in a timely manner and buying them later at higher prices.

Sri Lanka is currently in the throes of unprecedented economic turmoil since its independence from Britain in 1948. The crisis is caused in part by a lack of foreign currency, which has meant that the country cannot afford to pay for imports of staple foods and fuel, leading to acute shortages and very high prices.

Thousands of demonstrators have hit the streets across Sri Lanka since April 9, as the government ran out of money for vital imports; prices of essential commodities have skyrocketed and there are acute shortages in fuel, medicines and elec-

Crisis-hit Lanka re-introduces fuel rationing

Sri Lanka's state-owned petroleum corporation on Thursday re-introduced fuel rationing for vehicles, as the worst economic crisis in decades roils the country with massive public protests against the government. Petroleum

Ceylon Corporation head Sumith Wijesinghe said that now motorcycles and other twowheelers can purchase fuel up to worth Rs 2,000 per visit to a fuel station. Similarly, threewheelers can purchase fuel worth Rs 3,000 and cars upto Rs 8,000. Mid last month, fuel rationing for vehicles was introduced and came to be later scrapped with the last hike of retail prices.

For several months, Sri Lankans have endured long lines to buy fuel, cooking gas, food and medicine, most of which come from abroad. Shortages of hard currency have also hindered imports of raw materials for manufacturing and worsened inflation, which surged to 18.7 per cent in March. As oil prices soar during

the Russia-Ukraine conflict, the island nation's fuel stocks are running out. Authorities have announced countrywide power cuts extending up to 7 1/2 hours a day because they can't supply enough fuel to power generating stations. Speaking in Parliament on

As diversity rises, US boards still disproportionately white

mid the push to get U.S. ABoardrooms to look more like companies' customers and employees, advocates are finally seeing just how steep the task will be.

Boards of directors at publicly traded US companies are much more white and much less diverse than the overall population, often starkly so. Just 2.7% of directors at the start of the year were Hispanic, for example. That would need U.S. Population.

Outside of looking at a photograph of each director, it hasn't always been easy to measure racial diversity on corporate boards. On Thursday, executive data firm Equilar released its first racial breakdown of boards for companies in the Russell 3000 index, which covers about 97% of all investable U.S. Stocks.

The survey found only 6.2% of directors are Black, versus 13.4% of the country. And the 5% of directors who are of Asian or Pacific islander



descent also fell short of the 6.1% for the entire U.S.

Equilar pulled the numbers ing disclosures from companies, data from affiliate networks and lists of influential executives from racial and ethnic minorities. Its results are similar to the disproportionate representation found in other surveys of more limited groups.

Executive search firm Heidrick & amp; Struggles earlier this week released its roundup of boards at a smaller group of companies, those in the Fortune 500. It found that Black directors hold 26% of board seats, while Asian or Asian American directors had

Once conflicted, Biden embraces role as abortion defender

Soon after being elected to the U.S. Senate, Joe Biden was pulled aside by a Democratic colleague who wanted to know how he was going to vote on abortion. Biden explained that

while he was personally opposed to abortion and would resist federal funding for the procedure, he didn't want to impose his view on others by overturning Roe v. Wade, the 1973 Supreme Court decision that legalized abortion nationwide.

"That's a tough position, kid," said Sen. Abraham Ribicoff of Connecticut. Then Ribicoff offered him some advice, Biden recalled years later in a memoir: "Pick a side. You'll be much better off politically. Just pick a side." During five decades in

elected office, Biden has tried to avoid picking a side on abortion whenever he could. Now that's impossible as the Supreme Court seems poised to strike down the constitutional right to abortion. A draft copy of the court's majority opinion was pub-

lished by Politico earlier this week, and a final decision is expected this summer. As the Democratic presi-

dent who happens to be serving when the Republicans' anti-abortion agenda reaches its crescendo, Biden is being drafted into the kind of fight that he's sidestepped for much of his career.

It's not a natural role for him, despite his longtime defense of a woman's right to choose whether to end her pregnancy. Like many Catholic Democrats, he's expressed conflicting opinions on abortion, which his church regards as a sin but his political party views as a legal Mini Timmaraju, presi-

dent of NARAL Pro-Choice America, said Biden "understands there's a difference between his personal view and what he would do in his personal life, and what he and his party stands for in terms of protecting freedoms for the American people."

Services sec activities 5-month high in April

New Delhi: Services sector activities improved further and touched a five-month high in April driven by a surge in incoming new work orders that boosted business activity and supported a renewed increase in employment,

according to a survey.

The seasonally adjusted S&P Global India Services PMI Business Activity Index jumped to 57.9 in April, from 53.6 in March, highlighting a sharp rate of expansion that was the fastest since last November amid mounting price pressures.For the ninth straight nessed an expansion in output. In Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion while a score below 50 denotes con-

"In isolation, the PMI data for the services sector were mostly encouraging, as surging demand underpinned quicker increases in new business inflows and output," said

Pollyanna De Lima, Economics Associate Director at S&P

The Indian services sector growth continued to gain momentum amid a near-record upturn in input costs. Selling prices rose at the fastest rate since July 2017 and inflation concerns continued to dampen business confidence, the survey noted.

'Service providers reported having paid more for food, fuel and materials, with some mentions of higher wage costs also pushing up overall expenses. The overall rate of inflation quickened to the second-highest in the survey history, leading companies to hike their selling prices to the greatest extent in close to five years,"

Survey members continued to suggest that the lifting of COVID-19 restrictions led greater consumer footfall and a general improvement in

Although still positive overall the level of sentiment slipped from March and was much lower than its long-run average.

On the employment front, companies resumed their hiring efforts in April, as seen by the first increase in employment since last November. Those firms that took on extra staff linked the rise to ongoing growth of new business, the survey said.

Lima further noted that consumer Services and Finance & Insurance were the top-performing areas of the service economy, while Real Estate & Business Services was the only sub-sector to post contractions in sales and output.

RBI's rate hikes to weigh down on banking system credit growth: India Ratings

Mumbai: The surprise rate hike by the RBI signalling a reversal of the interest rate cycle will weigh down on the banking system's credit growth, which was showing signs of revival with an 11 per cent growth, a report said on Thursday

The tailwinds supporting a pick-up in credit growth will be in demand from the industry and services segments, even as growth in the agriculture segment remains stable and muted in the retail segment, India Ratings and Research said.

Over the medium term, inflationary pressures, supply chain disruptions and a weak consumption demand could upset the current revival in credit growth, it added.

.the reversal of the interest rate cycle as signified by the 0.40 per cent increase in repo rate by the Reserve Bank of India would weigh down on the credit growth as borrowings become costlier," it said.

The agency added that it has received feedback from the companies rated by it,

which points to a delay in capital expenditure plans as they await more clarity on the macroeconomic front.

It said that banking system credit growth offtake has shown a significant pick-up in the early part of FY23, with credit growth of 11.2 per cent as of April 8, 2022, compared to 5.3 per cent in the same period in 2021, it said, adding that this is the highest since July this is the highest since July 2019. The agency believes that while the second Covid wave had significantly impacted the credit outlook in 2021, the outlook reasonably normalised at the beginning of 2022.

In a report published in February, the agency had estimated that the system-wide credit growth will stand at 10 per cent for FY23. The number was not revised in the latest update. On Monday, it said the sectors which are likely to continue to perform well will include power, metals, cement, chemicals and textiles, while telecom, pharma, and commercial real estate will be under pressure.

'India exports 7 mn tons of sugar this marketing year' New Delhi: India, the world's

second largest sugar producer after Brazil, has exported 7 million tonnes of the sweetener so far in the ongoing 2021-22 marketing year, and exports from the country may touch a new record of 9 million tonnes, industry body ISMA said on Thursday.

Indian Sugar Mills Association (ISMA), in a statement, said the country's sugar output has risen to 34.23 million tonnes till April of the current marketing year, from 30 million tonnes in the year-ago period.

Sugar marketing year runs from October to September.

The country had export-

ed a record 7.23 million tonnes of the sweetener in the 2020-21 marketing year with much of the shipments undertaken with the help of government subsidy.

"As per reports from the trade, around 8.2-8.3 million tonnes of sugar export have been contracted for so far. Out of that, about 6.8-7 million

tonnes of sugar is estimated to have been physically exported from India up to April," ISMA

Accordingly, it is estimated that the "Indian sugar industry should be able to export over 9 million tonnes," it said.

The sugar being exported this year is without the government subsidies.

On sugar production, ISMA said it has risen by 14 per cent to 34.23 million tonnes during the October-April period of the 2021-22 marketing year, from over the year-ago period.

Instead of using actual card details, this token is used to perform card transactions in contactless mode at point of sale (POS) terminals and quick response(QR) payments.

City looked certain to go through when Riyad Mahrez put them 1-0 up and 5-3 ahead on aggregate but Rodrygo, on as a substitute, scored an incredible late double, his goals in the 90th and 91st minutes sending the tie to extra time

With City still reeling, Real Madrid landed the knock-out blow as Benzema earned and then converted a spot-kick to snatch a 6-5 win on aggregate, with another remarkable fightback at the Santiago Bernabeu added to the club's long list of magical European

This season, Madrid had already performed the unlikeliest of rescue acts to defeat both Paris Saint-Germain in the last 16 and Chelsea in the quarter-finals but, given the stakes and how close they were to defeat, this one against Manchester City was surely the most dramatic.

Like PSG and Chelsea before them, City will wonder how they emerged as losers from a match they largely controlled and there will be fresh scrutiny too on coach Pep Guardiola, who, for all his success, goes another year without leading City to the European glory they so crave.

City's collapse would have been almost inexplicable had it been against anyone other than Real Madrid, who advance to their 17th final in the competition. They are a victory against Liverpool

Real's 'history keeps us going': Ancelotti



arlo Ancelotti said the "history of the club" helped his Real Madrid side stage another Champions League comeback to down Manchester City on Wednesday and reach the final.

The 13-time European champions trailed 1-0 on the night and 5-3 on aggregate in the last-four tie entering the 90th minute, but Rodrygo scored a late double and Karim Benzema's extra-time penalty sent them through.

Real had also come from behind to beat Paris Saint-Germain in the last 16 and Chelsea in the quarter-finals.

"I cannot say we are used to living this kind if life, but what happened tonight it happened against Chelsea and also against PSG," Ancelotti told BT Sport after becoming the first coach in history to reach five finals in the compe-

tition. "If you have to say why, it is the history of this club that helps us to keep going when seems that we are gone.

"The game was close to finished and we managed to find the last energy we had."

The 6-5 aggregate tri-umph sends Madrid into a record-extending 17th Champions League final, where Ancelotti could set a new record of four European Cups as a coach.

Six-time Liverpool will be their opponents in the final on May 28 in Paris.

"I am happy to be there in the final, in Paris against another great rival," added the 62-year-old Ancelotti.

"We are used to it. It will be a fantastic game for foot-

Ancelotti also became the first coach to win all five of Europe's top leagues when Real sealed the La Liga title

Karim Benzema has scored seven UEFA Champions League goals against English teams this season; the most by a player in a single campaign in the competition's history. The Frenchman has also netted four goals in five previous games versus Liverpool in the competition.

Pep Guardiola has now suffered six eliminations at the semi-final stage of the UEFA Champions League (also 2009-10 and 2011-12 with Barcelona, 2013-14, 2014-15 and 2015-16 with Bayern Munich); the ioint-most of any manager, along with José Mourinho.

Carlo Ancelotti has reached his fifth UEFA Champions League final (2003, 2005 and 2007 with AC Milan, 2014 and 2022 with Real Madrid), the most of any manager in the competition's history.

Since 2003-04 when the last 16 was introduced. Real Madrid are the first team to lose a match in the last 16 (0-1 vs PSG), quarter-final (2-3 vs Chelsea) and semi-final (3-4 vs Man City) in a season and still reach the UEFA Champions League


"This has been one of those seasons where we have not been able to win those close matches and we have not been able to ruthlessly finish games off.

Virat Kohli has not been able to score fluently in the IPL this season and it is a matter of concern that he is getting out to different types of bowlers, observed former West Indies pacer Ian Bishop.

Kohli has managed just 216 runs with a top score of 58 at a strike rate of just 111.91, which is the third lowest among batters with at least 150 runs this season. On Wednesday, Kohli was cleaned up by

Mooen Ali after a laboured 30 off 33 balls and Bishop said he is concerned about Kohli's struggles against spin, especially off-spin. For a while, for 10 or 15 runs, he wasn't even going at a run-a-ball, or he was just

going at a run-a-ball," Bishop said on ESPNcricinfo's "T20 Time Out'. "He didn't get ahead, and there wasn't much intent. He hit one (six) over extra-cover off the seamer, and that was when he just went ahead to a run-a-ball and then he came

Indian Olympic discus thrower suspended after failing dope test

India's top woman discus thrower **▲**Kamalpreet Kaur, who finished sixth at last summer's Tokyo Olympics, has been provisionally suspended after testing positive for a banned drug, the Athletics Integrity Unit (AIU) said.

The 26-year-old faces the prospect of being banned for a maximum four years if the positive test is confirmed.

'The AIU has provisionally suspended discus thrower Kamalpreet Kaur of India for the use of a prohibited substance (Stanozolol), a breach of the @WorldAthletics Anti-Doping Rules," it tweeted. A national record holder, Kaur cannot participate in any competition until a final decision is taken at a hearing conducted under the World Athletics antidoping rules. The Commonwealth Games and Asian Games are both taking place this year.Stanozolol is a synthetic anabolic steroid banned in 1974.

It became infamous after Canadian sprinter Ben Johnson tested positive for it at the 1988 Seoul Games and was stripped of his 100m gold medal.

India are ranked third in the number of doping violations behind Russia and Italy, according to a World Anti-Doping Agency report released last year.
