Nationwide curfew imposed; anti-Govt protesters attacked, 3 killed, 154 injured

Sri Lanka's Prime Minister Mahinda Rajapaksa resigned on Monday after clinging on to power for weeks, following unprecedented anti-Government protests demanding his ouster as well as the administration led by his vounger brother and President Gotabaya Rajapaksa over the country's worst economic crisis that led to acute shortages of staple food, fuel and power. Mahinda's resignation

comes hours after his supporters attacked anti-Government protesters outside President Gotabaya's office, leaving three people killed and at least 154 people injured, prompting authorities to impose a nationwide curfew and deploy Army troops in the national Capital.

Meanwhile, the ancestral home of the Rajapaksas in Hambantota was set on fire by a group of anti-Government protesters, hours after Mahinda, the patriarch of the powerful clan resigned as Sri

. Lanka's Prime Minister. An MP from Sri Lanka's

ruling party shot dead an anti-Government protester and then took his own life during a confrontation outside the capital, police said on Monday, reported AFP.

Video footage showed the entire house of Prime Minister Mahinda Rajapaksa and his younger brother and President Gotabaya Rajapaksa in Medamulana in Hambantota

city was burning away as protestors hooted away, the Daily Mirror reported.

Earlier, several properties of Ministers and lawmakers of the ruling coalition were destroyed by the protesters. Sri Lankan media also reported that a fire broke out near the back gate of Temple Trees, the official residence of the Sri Lankan PM in Colombo.

Police water cannons have been called but anti-Government protesters are attacking the vehicles, the report said. Protesters also attacked the house of Badulla District parliamentarian Tissa Kuttiarachch and later set it on fire. The house of Puttalam MP Santha Nishantha was completely destroyed.

SDMC calls off anti-encroachment drive after protest. MLA booked; SC refuses to stop Op

Shaheen Bagh gained centrestage yet again on Monday as hundreds of locals protested and foiled a demolition drive of the South Delhi Municipal Corporation (SDMC). With hundreds of locals besides the Congress and the AAP workers staging a protest, the SDMC had to call off its drive to rare allocaded. off its drive to raze alleged encroached structures in the area under its first phase of demolition drive.

An FIR was registered against AAP MLA Aamanatullah Khan and his supporters for obstructing antiencroachment drive in Shaheen Bagh, the Delhi Police said.

The bulldozer returned without carrying out any exercise from Shaheen Bagh, famous for its anti-CAA

The matter also reached the Supreme Court, which refused to entertain a plea filed by the CPI(M) against the demolition drive in Shaheen

Bagh. The court said it cannot interfere with the antiencroachment drive at the instance of a political party.

A bench of Justices L Nageswara Rao and BR Gavai asked the party to approach the Delhi High Court.

"Why is CPI(M) filing a petition? What is the fundamental right that is being violated? Not at the behest of political parties. This is not the platform. You go to the High Court," the bench said. At the outset, senior advo-

cate PV Surendranath, appearing for the petitioner, submitted that the plea has been filed in the public interest and there is no "party interest" involved in the matter. He further submitted that the second petitioner is a hawkers' union and they are being removed with-

The bench said if hawkers are encroaching they will be removed and in case there is any violation of law by authorities, the petitioner can go to the High Court. The top court clarified that it interfered in the Jahangirpuri demolition case because structures were being demolished. The senior lawyer said the authorities are demolishing buildings.

Will revisit sedition law, put off hearing, Centre urges SC

Two days after it strongly defended the sedition law, the Centre on Monday told the Supreme Court to defer hearing on the matter as the Government has decided to reconsider and re-examine the

provisions of the colonial law. The Centre also said it was cognizant of various views, and concerns about civil liberties while being committed to

protecting the "sovereignty and integrity of this great nation".

The Ministry of Home Affairs (MHA), in an affidavit, referred to the views of Prime Minister Narendra Modi on shedding "colonial baggage" and said he has been in favour

of the protection of civil liber-

ties and respect of human rights, and in that spirit, over 25,000 compliance burdens have been scrapped

The MHA's affidavit said the PM has said India has to work even harder to shed colonial baggage that has passed its utility which includes outdat-

ed laws and practices.

ED summons Jharkhand Mining Secy in Ranchi in MGNREGA funds fraud

The Enforcement Directorate (ED) has summoned Jharkhand Mining Secretary Pooja Singhal for office in Ranchi in connection with a money-laundering probe linked to embezzlement of MGNREGA funds during her stints as district collector in

various districts of the State. Singhal is a 2000-batch IAS officer. She has been asked to depose before the investiga-tion officer at the zonal office of ED in Ranchi. The agency will record her statement under the Prevention of Money Laundering Act (PMLA),

they said. During the searches against her, her businessman husband Abhishek Jha, and others on May 6 in Jharkhand and at a few other locations, she was **Continued on page 2** | briefly questioned by the ED officials. Her husband was also

questioned by the agency.

The ED investigation relates to a money laundering case in which a former junior engineer in the Jharkhand Prasad Sinha, was arrested by the agency on June 17, 2020 from West Bengal after he was booked by the agency under the PMLA in 2012. The ED case was based on the FIRs of the State Vigilance Bureau

against Sinha and others. Sinha was booked by the Vigilance Bureau under the IPC sections relating to cheating, besides corruption under the Prevention of Corruption Act for allegedly defrauding public money and investing it in his own name as well as in the name of his family members while working as a junior engineer from April 1, 2008 to March 21, 2011


4th Covid wave unlikely in India: IIT prof Agarwal

The prof has developed SUTRA to predict Covid pandemic trajectory

An IIT-Kanpur professor, who has developed the SUTRA mathematical model to accurately predict the trajectory of the Covid pandemic, on Monday said that there may be no fourth wave in the country. Prof Maninder Agarwal has based his assessment on the fact that over 90 per cent of India's population has acquired natural immunity.

At the same time, he cau tioned that the fourth wave cannot be ruled out if there is a new mutant that bypasses natural immunity significantly. In an article, Agarwal, a professor in the department of computer science engineering, said there are two major rea sons for this conclusion.



The first reason is the level of natural immunity in the country. Natural immunity is defined as the immunity acquired by a previous infection. As per the SUTRA model for India, over 90 per cent of India's population has acquired natural immunity. This is also validated by data from ICMR surveys that have consistently found the actual number of

infected people to be more than

30 times the reported numbers,

Natural immunity acts as a strong protection against infection. In an extensive study done for 36 countries across the world covering all continents and more than half of the world's population, it was found that the severity of the Omicron wave in these countries was inversely proportional to the level of natural immunity present in them.

₹ all-time low at 77.44/\$ on forex outflows

Extending its losses for a second day, the rupee on Monday slumped by 54 paise to close at a record low of 77.44 against the US dollar, pressured by the strength of the American currency overseas and unabated foreign fund outflows.

Forex traders said risk appetite has weakened amid rising bond yields in the US and mounting concerns about inflation that may trigger more aggressive rate hikes by global central banks. At the interbank foreign exchange market the rupee opened lower at 77.17 against the greenback, and finally settled for the day at 77.44, down 54 paise over its previous close. During the trading session, the rupee touched its lifetime low of 77.52.

On Friday, the rupee had slumped 55 paise to close at 76.90. In the last two trading sessions, the rupee has lost 109 paise against the greenback. Detailed report on P10

Yogi warns leaders against taking cuts

In a terse message, Chief Minister Yogi Adityanath has asked the public representatives and senior party functionaries not to take commission while implementing development schemes of the government and has warned that any complaint in this regard will be severely dealt with.

Addressing MPs, MLAs and party leaders in a function held at the Police Lines auditorium in Lalitpur, the chief minister said on Sunday night that party leaders should stop taking bribes in the form of commission, adding that he would root out corruption from the bureaucracy.

"The message should first go from the party leaders. You are the people's representative and you have no right to ask for commission during implementation of development schemes," he said while expressing displeasure over allegations of corruption.

This terse reaction came when some leaders complained to Yogi Adityanath about officers taking bribes. "First cleanse yourself, I will set the officers

SC refuses to stay Shaheen Bagh demolition drive



"It's the first time that we have witnessed such a drive. The SDMC is targeting only Muslim-dominated areas, we hope that everything goes back to normal. The streets were jam packed, which riageways was kept open for affected our business," he said.

"This is a blatant falsehood for which the deponent who has affirmed this on affidavit needs to be prosecuted so as to maintain the sanctity of averments being made on affidavits before

this court," the affidavit reads."The petition deserves to be dismissed only on the ground that the petitioner has resorted to falsehood and has unfortunately attempted to sensationalise a routine administrative exercise by giving it an unwarranted communal colour," the NMC said. In an court, the NMC highlighted that no house or shop was demolished at all either on April 20 or in any of the pre-

If the affected parties would have approached this court, they would have truthfully required to point out that what was being undertaken was the removal of unauthorised projections on the footpath or public road and such private parties also would have been bound by the order of the

status quo," the NMC said. Concerning the use of bull-dozers, the NMC submitted that some temporary projections on public road/footpaths are of such nature, for which, the machine is required to be

The corporation alleged that the petitioner has deliberalised the matter and denied the allegations that a particular religion or community was being targeted.

May," the IMD said. The capital city on Monday witnessed the maximum temperature of 40 degree Celsius which is one notch above than the normal for this time of year. The minimum temperature in

degree Celsius which is three notches warmer than the normal temperature for this sea-

The relative humidity on Sunday morning at 8:30 was recorded at 60 per cent and 40 per cent in the evening at 5:30.

As stand-offs persist at the Line of Actual Control(LAC) in Ladakh for the last more than two years, Army Chief General Manoj Pande said here on Monday the basic issue is to resolve the boundary question but China is "keeping it alive.

Assuring the nation that adequate number of troops are deployed to meet any threat, Pande, who assumed charge of the top job on May one, said India is firm on the point that status quo ante prior to April 2020 be restored.

He said the basic issue with China remains the resolution of the boundary question but Beijing's intent has been to keep it "alive." Making this assertion while interacting with media, the Army Chief said instructions to the troops on the ground are clear. They have to remain firm and resolute in their tasks.

Pande said the Indian troops continue to hold "important positions" along the LAC and the Army has a "robust posture" to confront any situation.

"What we need as a country is a whole of nation' approach and in the military domain, this is to prevent and counter any attempt to alter the status quo at the LAC," he added.

drop, the parleys at diplomatic and military talks between the two sides resulted in the disengagement of troops on the north and south banks of Pangong Tso, Gogra and Patrolling Point 14 in Galwan, the Army Chief said. He also said "We hope to find resolution through dialogue in remain

ing areas.' The aim is to establish trust and tranquility on both sides but it cannot be a one-way affair", he said.

As regards the fall-out of the ongoing Ukraine conflict, Pande said foremost is that relevance of conventional wars still remains and they need not necessarily be short and swift. He also said the Army's supply chains were impacted to "some extent" but they have sufficient stocks to last for a "reasonable" period of time. He also said the conflict has taught a lesson and that is to be self reliant in terms of weapons, armaments, equipment and spares from outside.

"We are dependent on certain weapon systems specially in the area of air defence, rockets, missiles and certain tanks from Russia and Ukraine," he said. Admitting that the supply chain of certain spares and ammunition was impacted to some extent, Pane, howev-

In order to address this issue, India is looking at certain alternate ways and identifying alternate sources from friendly foreign countries while in the long term, this is also an opportunity for the private industry to step up production and meet the requirements, he said.

SC stays proceedings against IT Rules 2021 in all High Courts

The Supreme Court on Monday stayed further proceedings in all High Courts challenging the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules 2021 or the Cable Television Networks (Amendment) Rules 2021.

A bench of Justices AM Khanwilkar and A S Oka passed the order while hearing a batch of petitions, including those raising the issue of hate speech and seeking regulations for OTT (over-the-top) plat-

"We direct stay of further proceedings pending before the High Courts in the respective cases or to be filed hereafter until the next date of hearing involving a challenge to the IT Rules or Cable TV (Amendment) Rules, which are the subject matter of proceedings in these cases," the bench

said and posted the matter for hearing on May 19. Solicitor General Tushar Mehta, appear-ing for the Centre, told the bench that there are several petitions in the matter pending before the apex court.

He said some High Courts have stayed the statutory regulations and the Centre has filed special leave petitions (SLPs) against those orders.

"Can your lordships consider granting stay so far as transfer petitions are concerned so that no further orders are passed," Mehta said. The bench also issued notices on the petitions before it in which notices were not yet issued.

After the apex court stayed further proceedings before the HCs in these matters, one of the advocates appearing in the matter said they had filed a petition before the Kerala High Court which had passed an interim order. "We are not interfering with those interim orders as of now," the bench observed.

Zoom fatigue more common among young, introvert women, says study

Video conference fatigue, commonly known as 'Zoom fatigue', is more common among young and introvert women than others, according to a study published in International Journal of Environmental Research and Public Health. The researchers have also found a number of factors that they believe contribute to 'Zoom fatigue'.

Covid-19 pandemic induced a boom in both private and professional video-conferencing in the early 2020s that elicited controversial public and academic debates about its pros and cons.

One main concern has been the phenomenon of videoconference fatigue

A group of researchers at Blekinge Institute of Technology in Sweden studied the phenomenon of video conference fatigue and concluded that age, gender and personality play a role in how tired you get.

"We have found direct evidence that age, gender and personality affect. For example, young introvert women are affected more than others. But Zoom fatigue depends on many factors, ranging from personal circumstances via the meeting's organisation and technology, to the environment in which the video conference takes place," said Markus Fiedler, researcher at the Institute.

However, the researchers believe that doing some simple things can reduce Zoom fatigue. These include not scheduling meetings one after the other; using simple technology; raising your hand if you want to speak during meetings and turning off the microphone and camera when is not needed.

"Most likely, we are heading to a hybrid future with daily face-to-face and videoconference meetings that both should spare us from fatigue but save and even fuel our physical and mental energy," Fiedler

The researchers state that more research and evidence is needed when it comes to the contributing factors behind Zoom fatigue. They also mean that research is needed on other ways of communicating, for example, immersive experiences and technology.

CBI FIR against former staffer of Babul Supriyo in corruption case

The CBI has filed a corruption case against Sushanta Mallick, a former staffer of the then Minister of State for Heavy Industries and Public Enterprises Babul Supriyo, who quit BJP and joined Trinamool Congress a few months back. Supriyo was the Heavy Industries

The then executives of EPIL conspired and demanded Rs 50 lakh from Ashutosh Bandhopadhayay, for providing favour for

the tenders awarded and being awarded by EPIL during the period 2016-2017.

Verification has revealed that out of Rs 50 lakh, Rs 40 lakh were to be given to SPS Bakshi, the then CMD, EPIL and Rs 10 lakh were to be given to Harcharan Pal, the then Executive Director (Contracts) and Paritosh Kumar Praveen, the then Manager (Grade II), EPIL.

Verification has revealed that SPS Bakshi had got conveyed to Ashutosh Bandhopadhayay through RS Tyagi, the then DGM (contractual basis) that out of the bribe amount of Rs 40 lakh, Rs 5 lakh be transferred into the bank account of Sushanta Mallick, staff of the then Minister of State for Heavy Industries and Public Enterprises," reads the FIR.

The accused have been booked under Indian Penal Code section relating to crim-

Covid-19 oral vax not only protects but also reduces its spread: Report

Adesigned to be taken orally, not only protects against the disease but also decreases the airborne spread of the SARS-CoV-2 virus to other close contacts, according to a study conducted on animals.

The research, published in 'Science the journal Translational Medicine', demonstrates the potential of the vaccine to work through the mucosal tissue to neutralise SARS-CoV-2, limiting infections and the spread of active virus in airborne parti-

cles.
"Considering most of the world is under-immunised -and this is especially true of children -- the possibility that a vaccinated person with a breakthrough infection can spread Covid-19 to unimmunised family or community



risk," said Stephanie N Langel from Duke University Medical Center in the US

There would be a substantial benefit to develop vaccines that not only protect against disease, but also reduce transmission to unvaccinated people," Langel said in a

The researchers -- including teams from the US vaccine developer, Vaxart, and clinical research non-profit, Lovelace Biomedical Research Institute tested the vaccine that uses an adenovirus as a vector to express the spike protein of the

The spike protein is used by SARS-CoV-2 to enter and infect the human cells.

The human vaccine is designed to be taken as a pill, they said.

In studies using hamsters, the vaccine elicited a robust antibody response in blood and the lungs.

When the animals were exposed to the SARS-CoV-2 virus at high levels, prompting breakthrough infections, they were less symptomatic than non-vaccinated hamsters, and had lower amounts of infectious virus in the nose and

Because of this, they did not shed as much virus through normal airborne

researchers. Unlike vaccines that are injected into the muscle, they said, mucosal immunisations increase production of immunoglobulin A (IgA)

the immune system's first line of defence against pathogens -- in the nose and

These mucosal ports of entry are then protected, making it less likely that those who are vaccinated will transmit infectious virus during a sneeze or cough, the researchers said.

"Our data demonstrate that mucosal immunisation is a viable strategy to decrease the spread of Covid-19 through airborne transmission," Langel said.

The researchers noted that the study focused on the original SARS-CoV-2 virus, and new studies will be designed to test the vaccine against Omicron variants

Tuesday night. Under the influence of the cyclone, coastal Odisha and adjoining areas of north coastal Andhra Pradesh and coastal West Bengal witnessed heavy

rainfall. The IMD said that very high sea conditions were likely to prevail over west-central and adjoining south Bay of Bengal and asked fishermen not to venture out in the region from Tuesday for at least two It also advised that tourism activities in coastal areas and sea beaches be suspended till May 13.

In Odisha, two to three spells of rain occurred in districts such as Khurda, Ganjam, Puri, Cuttack and Bhadrak. The Odisha government on Monday planned evacuation of people residing in four coastal districts.

Distant warning signal 2 (asking ships not to come near the coast) has been hoisted in all ports in Odisha in view of the approaching severe cyclone. According to Dr IMD Director General Mrutunjay Mohapatra, the cyclone will not make landfall either in Odisha or Andhra Pradesh but will move parallel to the east coast and

cause rainfall. The cyclone is likely to cause heavy rain in the south-

Didi slams CBI for failing to find Tagore's stolen Nobel Prize; BJP blames TMC

On a day Bengal Chief Minister Mamata Banerjee lamented the failure of the Central Bureau of Investigation to track the Nobel medallion of Poet Laureate Rabindranath Tagore, senior Bengal BJP leader Rahul Sinha on Monday alleged it was her Trinamool Congress that had links with the Nobel theft.

Sinha, a former State BJP president, recalled how the Chief Minister once asked the CBI to transfer the case to the State police which would in no time track down the medallion that was stolen from Shantiniketan about 15 years

"The Chief Minister once claimed that "if CBI cannot recover the Nobel medallion then the case should be given to the State police which would track it down in no time ... Truth to be told TMC had connections with the Nobel theft they are involved in all kinds of illegal activities ... this is proved by the TMC



Government's non-cooperation with CBI in tracking the Nobel medallion," Sinha said inviting immediate response from Trinamool Congress spokesperson Kunal Ghosh who reminded "when Nobel prize was stolen TMC was not

Sinha's comment came on a day when the Chief Minister while addressing the intelli-gentsia on the occasion of Tagore's 161st birth anniversary expressed her displeasure at how the central investigating agency failed to track down 'Asia's Nobel Medallion."

Tagore was the first Asian to win a Nobel Prize in the year 1913. He won it for his contri-

She said "it hurts me to recall how the Nobel Prize which was stolen during the Left Front rule could not be recovered ... the CBI which was responsible for cracking the case could not do so after so many years ... it is the first Nobel Prize that came to Asia ... It is really shameful to recall how the medallion was stolen and how it continues not to be

Earlier TMC mouthpiece Jago Bangla gave out a strong message to the central agency demanding immediate recovery of the Nobel medallion. The article read "Listen CBI.

We want the Nobel Prize back."

Incidentally the CBI has been investigating about a dozen cases of corruption and violence related to the Trinamool Congress functionaries. Much to the chagrin of the Bengal ruling outfit the Calcutta High Court last month transferred at least five cases of violence and corruption — involving a senior Bengal minister — to the CBI.


AMU teacher gives triple talaq to wife; case lodged

Reprieve for widows

Village bansarchaic widowhood practices forced on women

remote Maharashtrian village has shown India how to stop Brahminical social tyranny against widows. It just takes a collective, conscious decision to make it happen. Herwad village in Kolhapur district has banned regressive customs that force a woman into widowhood after the death of her husband. Women losing their husbands will no longer have to perform rituals like breaking bangles, wiping off 'kumkum' (vermillion), and removing the 'mangalsutra' (symbol of Hindu marriage). These ancient customs were hitherto seriously enforced, especially in Brahmin homes, and later coopted by other castes, to distinguish widows from other women. Widows were also discouraged by their families to attend celebrations like marriages where their presence was considered unlucky. These rituals are practiced even today in many Hindu households across the country even though the winds of social reforms are sweeping across. Herwad's urge for change came about after it lost over a dozen men to COVID-19. The villagers could not bear to see the rituals adding to the misery of the new widows. They eventually passed the resolution and will now launch an awareness campaign about the ban on widow customs. The decision of this small village

> stands alongside revolutionary social reforms like the end of "sati" and allowing widow remarriage. The progressive sections of the society and Governments in the States and at the Centre should take over the baton from Herwad. It is significant that this village falls in Kolhapur dis-

> trict, considered the social reform capital of Maharashtra. The panchayat resolution coincided with the death anniversary of the erstwhile ruler of Kolhapur state, Chhatrapati Sahuji Maharaj, who is credited with introducing social reforms and loosening the Brahmin stranglehold over religion, culture and society. The man who

introduced reservation in India by allocating 50 per cent of all vacancies to the backward classes, was instrumental in banning the Devadasi system and child marriages and legalising widow remarriages and inter-caste marriages. Women's rights and reforms for Dalits eventually brought in remarkable social changes in the State. The development of roads and rapid urbanisation allowed new ideas to trickle into the villages, thus weakening the age-old social hierarchies. Much of rural Maharashtra is now semi-urban. Urban migration led to a large-scale division of land and that impacted traditional agricultural practices. The services industry entered the rural areas in a big way. Greater participation of women in education, work and entrepreneurship loosened the grip of archaic customs because women spend as much time as men outside their homes. However, the total emancipation of widows is still a distant goal. A majority of the widows in India are unaware of their legal rights. Confined to home, mostly uneducated and burdened by patriarchy, they have no idea about their rights to inheritance, maintenance, adoption, and right to property after remarriage. Older widows are mistreated by their families or are left in old-age homes. Their lack of economic independence is their undoing. Making them aware of their rights is the way forward.

It is obvious that Kejriwal wants to use the 2024 Lok Sabha polls to turn AAP into a national outfit and take its footprint across the nation. It will be an understatement to say that Kejriwal is an ambitious man. Kejriwal is not only



ambitious but he is also endowed with patience and perseverance. Establishing the AAP rule in Delhi was only the first step for him. Now that his party has captured power in Punjab, Kejriwal has set his eyes on the 2024 Lok Sabha polls. Undeterred by the fact that outside Delhi and Punjab his party has a limited support base, Kejriwal seems determined to make AAP a major player in the Lok Sabha polls two years from now. Even an ambitious and determined person like him would know that it would be impossible for him to give a direct fight to the BJP in the next general elections. To do that, Kejriwal will have to push aside Congress in sev-

eral key states and occupy the number two slots there.

Already, AAP has created a buzz in Gujarat and Himachal Pradesh, where Congress is busy with suicidal infighting. Unlike the Congress, which is drifting aimlessly without a settled leadership, AAP has a decisive leader. Secondly, unlike senior Congress leader Rahul Gandhi, who is always in the news for his foreign jaunts, Kejriwal is engaged in 24x7 politics. Kejriwal will know well that if he wants to someday rule the country, he will have to first defeat the Congress., then only he can dream to be in the final. Kejriwal cannot even ream to turn the 2024 Lok Sabha contest into an AAP Vs BJP duel, but in 2029 he could hope to mobilise enough resources to take on the saffron outfit provided the Congress did not do a course correction. Why they opt out of job market?



Gender imbalance in employment and opportunities of earning livelihood needs immediate correction by drawing the attention of the Government & policy makers

ndia is a society of "young people". With a demographic profile of 65 per cent of the population below 35 years of age, obviously, the country has a lot of advantages. Youths are generally upbeat, vibrant, motivated, more enthusiastic, having more energy, ready to work for long hours, take lesser days of leave and are willing to work for a lower pay. Unfortunately, the situation is just the opposite in India. The data from the Centre for Monitoring Indian Economy (CMIE) indicates that India's Labour Force Participation Rate (LFPR) has fallen to 40 per cent from 47 per cent in 2016. It is a clear indication that more than half of India's population in the working age group is deciding to opt out of the job market. To be more specific, fewer youth in the 20-24 age group are working or looking for employment. In 2017, about 49 per cent of them were part of the labour force which dropped to 38 per cent in 2021-22. This should have caused a sharp decline in their employment rate. Yet, despite that sharp 11 percentage point decline in their LFPR, the unemployment rate in the 20-24 age group rose from 32 per cent in 2016-17 to 48 per cent in 2021-22, which shows that nearly half of those in their early 20s, who wanted to work, are unemployed.

Before going further, let us have a basic understanding about certain important terminologies. We need to define the Labour Force (LF) which, according to CMIE, consists of persons who are of 15 years of age and older and belong to the two categories: first employed, and second unemployed who are willing to work and are actively looking for a job. LFPR is the percentage of the working age group, i.e. 15 years or older population that is seeking jobs; it represents the "demand" for jobs in an economy and includes both those who are employed and those who are unemployed. The Unemployment Rate (UER) is the number of unemployed (category 2) as a proportion of the labour force. We, generally, expect that the LFPK will, by and large, remain stable. So, any analysis of unemployment in an economy can be done just by looking at the UER.



However, the case of India is different from the rest of the world as the LFPR here is not only lower, but, falling. This affects the UER because the LFPR is the base, i.e. the denominator on which the UER is calculated. The LFPR is around 60 per cent the world over, but, in India, it has been sliding over the last decade and shrunk from 47 per cent in 2016 to 40 per cent in 2021. The interpretation of data

on employment shows that the jobs are available, but, the salaries are so low that they don't attract young people. So, they either prefer to remain unemployed or to altogether get out of the workforce. This is truer in the case of graduates and postgraduates because there is a total mismatch between education and job industry. This leads to a frustrating situation because, initially, they are offered jobs which are below their qualification and dignity which they decline, but, later on having no choice they are forced to accept the same jobs. Looking at the global employment workforce data, we find that in rich countries, the LFPR is about 60 per cent; in poor countries, it is about 65 per cent; and in lower middle income countries like India, about 53 per cent of those in the working age population are in the labour force

According to CMIE data, five years ago, India's LFPR was 48 per cent which consisted of

not just those who were working or were looking for work, but, also of those who wanted to work, but were not actively seeking it. An additional 60 million people should have joined the labour force by 2021-22 if our LFPR had stayed at that level. Instead, our labour force has dropped by 22 million and the LFPR has come down to 42 per cent. Some 575 million people should have been either working or looking for jobs if the LFPR had been similar to that of other lower-middle

income countries. Instead, our labour force consists of just 452 million which means about 120 million people who should participate have withdrawn from it. For clarity, let us assume that there are 100 people in the working age group, but only 60 ask for jobs, i.e. the LFPR is 60 per cent. Out of them, 6 don't get the job. This would imply a UER of 10 per cent. Now, let us consider a different situation, when the LFPR has fallen to 40 per cent and, as such, only 40 people are demanding work. Out of them, only 2 people fail to get a job. The UER would have fallen to 5 per cent and it would have appeared that the economy is doing better on the jobs front. But, in reality, beyond the 2 who are unemployed, a total of 20 eopie nave stopped demanding work. Typically, this happens when people in the working age get disheartened by not finding quality work of their choice. Something similar has happened in the case of India. Every time when the LFPR falls, the UER also falls because fewer people are now demanding obs — giving an incorrect impression to policymakers that the situation has improved. Several reasons are attrib-

uted to such a dismal situation. The official government version is that a large number of young people of 15-19 age group are enrolled in schools and colleges and are not inclined towards taking jobs. Another reason given is that the emergence of affluent middle class families has made the demands of jobs irrelevant which seems unlikely. Yet another reason is that many young people have shifted to their villages during the pandemic and have started their own businesses or taken jobs under MNERGA. Distribution of free ration has made the workforce idle is quoted as one of the reasons. However, the most convincing answer is women leaving the workforce in large numbers and pushing down the overall labour force participation. According to CMIE data, in December 2021, while the male LFPR was 67.4 per cent, the female LFPR was as low as 9.4 per cent. In 2021, the overall unemployment rate for men was about 9 per cent, whereas for women it was 27 per cent, the situation being worse in urban areas where women unemployment rate is 36 per cent, three times that of men. Main reasons being adverse and insecure working conditions, discrimination at work and societal norms, low wages, violence against women, etc. This gender imbalance in employment and opportunities of earning livelihood needs immediate correction. Undoubtedly, the unemployment situation is serious and demands immediate attention of the government and

UNIFICATION OF MCD FOR STRUCTURAL REFORMS

Functional domain of MCD must be restored, clear duties assigned

elhi Municipal Corporation (Amendment) Act 2022 and NCTD (Amendment) Act 2021 specify the governance structure of Delhi. The 2022 Act has introduced unification of three municipal corporation of Delhi (MCDs) on the grounds of equity (tackling uneven municipal revenue), optimal utilisation of resources, transparency, and improved governance with overarching powers to centre to control MCD, reduction of the seats (272 -250) ,removal the office of Director Local Bodies and inclusion of e-governance system for citizen centricity along with efficiency in expenditure (Rs 1500 million annually) with one Mayor and Commissioner in place of three, 25 committees in place of 75. The 2021 Act places LG as Government of NCTD consolidating overall governance with representative of centre. Yet it is noted that (I) the three-tier governance structure in Delhi is different from other states; (ii) One or other municipal functions are delivered by each of the three tiers; and (iii) Accountability at grassroot level is fairly diversified at the cost of citizen



centricity and grievance redressal. Accordingly, current structure of MCD emerging from the three governance characteristics has over a period of time developed five mainweaknesses such as (i) erosion of functional domain with gradually withdrawal of functions namely Water, sewage, PWD roads, in-situ slum development and rehousing, city transport, poverty alleviation and electricity, (ii) dilution of role of Mayor with Inadequate (one year) tenure (iii) lack of downward accountabilitybelow town hall/zonal level of municipal administration , (iv)widening of resource gap to meet expenditure requirement even at current level of assignments and (v)absence of inter -ULB (urban local Body) coordination in the cityregion (Gurugram, Faridabad, Kundli, NOIDA, and Ghaziabad popularly known as central NCR) pertaining to waste management, connectivity, mobility, pollution control and disaster management.

MCD is also expected to perform tasks towards achievement of objectives of MPD 2041 (a future ready, 24*7 city), green blue policy (interim agenda of COP 26 and zero carbon city 2070) along with implementation of Gol urban missions and NCAP (National Clean Air Programme). Therefore, structural reforms should be considered. First, the functional domain of MCD may be restored with the assignment of functions as handled by mega cities in India and elsewhere covering local economic development, slum improvement and development /delivery or control on water, sanitation, city transport and electricity, etc. Second the tenure of Mayor should be 2.5 or 5 years. The Mayor and commissioner should have adequate powers and authority for mutual coordination and complimentary role. Third, the decentralization below the zone should have institutional arrangements likeward committees with local councillor as chairperson and local representatives (women, professionals, weaker sections) and a nodal officer from ULB as in Bengaluru. The committee should prepare micro plan for waste management, drainage and other local services with 750/1000 households using the proactive community leaders and NGOs including exclusive allocation and bottom-up budgeting.Bengaluru (fastest mover megacity:2021)has achieved 53% segregation and decentralized treatment of waste as a landmark for megacities and drastic reduction in the waste going to landfill. Fourth, the innovative methods of resource mobilization for capex and opex should be used covering monetization of land, land value captureand municipal bonds and long-pending revision of property tax rates. Fifth, MCD should play the mother city role on jurisdictional and distributional issueswith other ULBs. Finally, there is also a need to deliberate on overall governance issue on functional domain of vertical and horizontal layers of governance so as to make the capital city at par with similar governance structures elsewhere. The transition period of next MCD elections provide an opportunity to deliberate and decide on these issues amicably.

Reining in fertilizer subsidy in India



From an already high of ₹ 83,000 crore during 2019-20, the subsidy could cross ₹200,000 crore during 2022-23.

ertilizer subsidy or payments made to manufacturers or importers to cover the excess of the cost of production/import and distribution over a low maximum retail price (MRP) - they are asked by the Union Government to charge from the farmers -has increased by leaps and bounds during the last three years. From an already high of ₹83,000 crore during 2019-20, it increased to ₹138,000 crore during 2020-21, ₹162,000 crore during 2021-22 and could cross ₹200,000 crore mark during 2022-23.

Is there a way this escalating trend could be reined in?

Subsidy payments are made under two broad categories of fertilizers viz. (i) urea; (ii) phosphate or 'P' and potash or 'K' fertilizers - also branded as non-urea fertilizers. For determining how much payment is made, apart from the quantum of use, we need to focus on two overarching factors: (i) MRP and (ii) cost of supply.

In case of urea, the Government exercises 'mandatory' control on MRP and reimburses the manufacturers for the excess of cost over it as subsidy on a 'unitspecific' basis under the New Pricing Scheme (NPS). As for non-urea fertilizers, it fixes 'uniform' subsidy on per nutrient basis for all manufacturers and importers under the Nutrient Based Scheme (NBS).

There is a fundamental difference in the policy for the two categories. In case of urea, farmers are assured of a fixed (albeit low)MRP even asthe manufacturers or importers get reimbursement forall increases in the cost of supply as higher subsidy. In case of non-urea fertilizers however, the producers/importers get a fixed subsidy while, they are free to increase MRP to reflect increase in the cost.

This has led to sharp increase in the prices of P&K fertilizers even as the MRP of urea remained unchanged. Resulting imbalance in price ratio (during 2020-21, the price of di-ammonium phosphate or DAP -a widely used 'P' fertilizer - was 4.5 times that of urea)has contributed to increasingimbalance in fertilizer use and adverse effect on crop yield, soil health, environment etc.

The government started 2021-22 with this policy bias against non-urea fertilizers which received an allocation of ₹21,000 crore against ₹59,000 crore for urea. But, steep increase in international prices of P&K fertilizers(price of DAP more than doubled over the previous year while, price of urea and muriate of potash or MOP went up three times each) forced Modi to change its stance.

To maintain MRP at same level as during 2020-21, in May, 2021, the government increased subsidy on DAP from ₹10,000 per ton to ₹24,000 per ton. In October, 2021, it was further increased to ₹32,760 per ton (subsidy on three other commonly used P&K fertilizers - was also increased by ₹2000 per ton each). As a result, the actual subsidy payment on non-urea fertilizers was about ₹57,000 crore - ₹36,000

crore higher than budget allocation (BE). Subsidy payment on urea was

₹105,000 crore - ₹46,000 crore higherthan BE (courtesy, increase in price of imported urea and price of natural gas). Overall, during 2021-22, the Government spent ₹162,000 crore on fertilizer sub-

For 2022-23, in the hope that prices would decline, the Finance Minister, Nirmala Sitharaman reduced allocation for fertilizer subsidy to ₹105,000 crore including ₹60,000 crore on urea and ₹45,000 crore on non-urea fertilizers. But thanks to the Ukraine crisis, these numbers have gone haywire. Given the profound implications of war, the prices are expected to further increase from the 2021-22 level and stay high for the whole year.

In this backdrop, the government has further hikedsubsidy on DAP to ₹50,000 per ton(likewise on other P&K). As a result, the spendduring Kharif (April - September) 2022 alone would be ₹61,000 crore. For the whole year, it may touch ₹100,000 crore. With subsidy on urea also expected to be much higher than the BE, the total outgo on tertilizer subsidy would be over ₹200,000 crore.

ndia is impacted because no effort was made in the past to reduce dependence on imports which currently is - Phosphate: 90 percent; Potash: 100 percent; Urea: 33 percent; Gas: 50 percent. Efforts to reduce this dependence can pay off only in the long-term.

Meanwhile, the Government needs to address voids in other areas namely large-scale diversion of subsidized fertilizers especially urea; excessive use by farmers; large/rich undeserving farmers getting access to subsidized material; inflated paymentsmade tomanufacturers under a costplus regime,etc.

Look at diversion of urea which could be as high as 30 percent or around 10.2 million ton in total consumption of 34 million tons (2021-22). Eliminating itcan yield saving of about ₹32,000 crore (10.2x31,000/-being the average subsidy per ton). Additionally, even if urea use efficiency

improves by 10 percent, this will

yield further savings of about Rs 7,500 crore [(34-10.2)x0.1x31,000]. Likewise, significant savings are possible if subsidy is denied to medium and large farmers (land holding > 2 hectare). Taking their consumption to be about 25 percent or 6 million tons, excluding them from the scheme will save around ₹19,000 crore (6x31,000). All these savings add up to ₹58,500

Rationalizing payment to manufacturers by encouraging low-cost firms to supply more and at the same time, discouraging highcost firms will also help in generating more savings. There is also ample scope for improving efficiency and reducing cost at various levels in the supply and distribution chain.

All of the above things are doable. But this will require a major overhaul of the pricing and subsidy regime. The Government should stop routing subsidy through manufacturers; instead, it may be given as direct benefit transfer (DBT) to the farmers on per hectare basis (albeit to marginal and small farmers). The manu-

facturers/importers should be free to sell at market determinedprice. Urea import should be freed even as import of non-urea fertilizers is already free.

This will ensure adequate competition amongst suppliers and survival of the fittest, i.e., those who can supply at low cost.With no subsidized fertilizer in the market (as subsidy goes to farmer's account), diversion will be completely eliminated. Moreover, in view of MRP reflecting fertilizer's true cost, farmers will use judiciously - taking into account soil/crop requirement - leading to improved efficiency of use and reduction of imbalance in fertiliz-

The Government also needs to look into the extant taxation structure. Currently, all fertilizers attract GST (Goods and Services Tax) @ 5 percent. Phosphoric acid and ammonia (raw materials used for making P&K fertilizers) attract GST @ 12 percent and 18 percent respectively. Natural gas (it is outside GST) attracts VAT which can go up to a high of 21 percent say in Uttar Pradesh.

It makes no sense to impose tax on fertilizers only to be reimbursed as additional subsidy. Gas should be brought under GST and put under 5 percent slab. GST on phos acid and ammonia should be lowered from existing 12 percent/18 percent to 5 percent each.

The DBT regime can help in drastically reducing subsidy even in the face of high international prices of fertilizers. But, kicking these reforms will require taking the bull (read: all those who are unfairly benefiting from the existing dispensation) by the horns.

then he must be Sauron." You can guess what happened next. We started trying to link other characters in the current drama with other characters from 'The Lord of the Rings', which many have begun to see as a tract for our times. Frodo was easy: that's Ukraine's president Volodymyr Zelensky, diminutive, vulnerable, but also

very brave. We couldn't figure out who plays Aragorn, but France's newly re-elected president, Emmanuel Macron, is a dead



ringer for Legolas. Britain's Prime Minister Boris Johnson is one of the more boastful and self-serving dwarves, not Gimli but maybe Bombur.

Alexander Dugin, also known as 'Putin's Brain', is the obvious candidate for the role of Saruman. He's the Christian fascist philosopher who advises Sauron/Putin on how to destroy the West, 'the kingdom of the antichrist' that seeks to submerge Russia in 'the abyss of chaos and corruption.' But I'm getting too technical here.

Joe Biden is Treebeard, the eldest of the Ents, and I'll leave it to you to flesh out the rest of the characters in this low-budget remake of LOTR. But do let me know if you figure out where the hell Gandalf is when we need him. Probably late, as usual. But here's the thing.



harmless after-dinner game, but it's a very poor guide to policy. Yet many Western leaders are starting to sound like J.R.R. Tolkien is their speech-writer. That's clear evidence that they're

losing the plot. It's perfectly normal for war aims to expand after an early success, but it's usually a mistake. Ukraine didn't collapse in which was what both Putin and everybody in Western leadership positions expected it to do.

So Western pundits (and even Western politicians) are now predicting that Ukraine will reconquer not just the land Russia conquered since February, but also the territory that it seized in 2014. That may be possible despite Russia's three-time-bigger population

and tenfold bigger economy, though I doubt it.

But are the Ukrainians sure they want to push a nucleararmed enemy who has shown himself to be irrational and unstable into such a humiliating corner? Are they sure their Western supporters would still back them if that leads to a nuclear showdown (as it probably would)?

Moreover, are the Ukrainians sure they really want the lost provinces of 2014 back? The people who remain in them now are not only Russian-speakers, but mostly people who actually identify as Russian. If Kyiv tried to forcibly reintegrate them into a victorious Ukrainian state, it would

guarantee that state at least a eneration of instability. We will probably be spared

all these awkward questions, because such a decisive Ukrainian victory is unlikely. What is of greater concern is the way that Western leaders have slipped so easily into a Tolkienesque mindset that lets them see themselves as the embattled defenders of a West that faces mortal peril from a great evil in the east.

Tolkien had an excellent excuse for writing that sort of books, because he wrote his 'Lord of the Rings' trilogy between 1937 and 1949, when the West did indeed face a great threat, first from Nazi Germany and then from the Soviet Union. It was a fitting fable for his times. It is not relevant to ours.

How is it possible to see Russia one moment as a power so weak that it could be pushed

If 'the test of a first-rate intelligence is the ability to hold two opposed ideas in mind at the same time and still retain the ability to function', then the current leadership class of the West are all geniuses.

Australia aware of China plans for Solomon Islands wharves

leaked four-page draft maritime cooperation agreement between China and the Solomon Islands dated this year. That follows the recent confirmation by China and the Pacific island nation that they have signed a separate security agreement that the United States and its allies fear could lead to a Chinese naval base less than 2,000 kilometers (1,200 miles) from the Australian coast.

Security experts suspect that maritime infrastructure built under the latest draft

used by the Chinese military.

Prime Minister Scott Morrison said his government was not surprised by the reported draft agreement to develop "port wharves, submarine optical cable construction, shipbuilding and ship repair." "We're very aware of what the Chinese government's ambitions are in the Pacific, whether it be in relation to facilities such as that or naval bases or other presence of their military in the Pacific, Morrison told reporters.

"I am very concerned, as many other Pacific leaders are, about the interference and intrusion of the Chinese government into these types of arrangements and what that can mean for the peace, stability and security of the southwest Pacific,' Morrison added.

police only identified the woman as a resident of southern Israel; police said further details of the case remained under a court-issued gag order.

Bennett's family received two death threats in the mail, along with the bullets. In response, security around the premier and his family was tightened and police and the

Shin Bet internal security agency opened an investigation.

Bennett, who leads a small nationalist party, has come under intense criticism from Israeli hard-liners who accuse him of abandoning his ideology. In 1995, Prime Minister Yitzhak Rabin was assassinated by a Jewish ultranationalist opposed to his peacemaking attempts with the Palestinians.

Shanghai tightens lockdown despite falling Covid cases

AP ■ BEIJING

Authorities in Shanghai have again tightened anti-virus restrictions, just as the city was emerging from a month of strict lockdown due to a COVID-19 outbreak.

Notices issued in several districts said residents were ordered to stay home and are barred from receiving nonessential deliveries as part of a "quiet period" lasting at least until Wednesday. The tightened measures could be extended depending on the results of

mass testing, the notices said. "Thank you for your understanding and cooperation. Together we can lift the lockdown at an early date," said one notice issued in the city's Huangpu district and posted online. It wasn't clear what prompted the renewed tightening, with numbers of new COVID-19 cases in the city continuing to fall.

Shanghai on Monday reported 3,947 cases over the previous 24 hours, almost all of them asymptomatic, along with 11 deaths. Authorities have been gradually lifting isolation rules on the city's 25 million residents, but the new orders appear to be returning to conditions at the early stage of the outbreak.

Shanghai originally ordered mass testing along with a limited lockdown, but extended that as case numbers rose. Thousands of residents have been forced into centralized quarantine centers for showing a positive test result or merely having been in contact with an infected person.

Two Shanghai residents reached through social media said they'd had no prior notice of the new restrictions, which they were told could last for up to a week.

Yoon faces tough challenges as new South Korean Prez

 $F_{\text{Suk Yeol takes office as}}^{\text{ormer top prosecutor Yoon}}$ South Korea's president on Tuesday, facing a tougher mix of foreign policy and domestic challenges than other recent South Korean leaders encountered at the start of their presidencies.

Yoon's single, five-year term begins at midnight on Monday before he takes the oath of office on Tuesday morning at a formal ceremony in Seoul. Since winning election in March, Yoon, a conservative who advocates a more hard-line approach toward North Korea, has been denied a honeymoon period. Surveys show less than 60 per cent of respondents expect he will do well in his presidency, an unusually low figure compared to his predecessors, who mostly received about 80-90 per cent before they entered office.

His approval rating as a president-elect was 41 per cent, according to a survey by Gallup Korea released last week that put outgoing liberal President Moon Jae-in's rating at 45 per cent. Yoon's low popularity is blamed in part on an acute divide between conservatives and liberals and on contentious policies and Cabinet picks.

Some experts say Yoon, a foreign policy novice, also hasn't shown a clear vision for how to navigate the world's 10th largest economy amid challenges such as North Korea's advancing nuclear arsenal, an intensifying US-China rivalry and pandemic-hit livelihoods.

Our foreign policy, national security and economy are all in trouble. Yoon should have presented some visions, hopes or leadership to show how he can pull the public together in these difficult times. But I don't think he has shown such things," said Professor Chung Jin-young, a former dean of the Graduate School of Pan-Pacific International

With US-led nuclear disarmament talks deadlocked. North Korean leader Kim Jong Un recently threatened to use nuclear weapons against his rivals and reportedly is preparing to conduct his first nuclear test in nearly five years.

The US-China confrontation is posing a separate security dilemma for South Korea as it struggles to strike a balance between Washington, its chief military ally, and Beijing, its biggest trading partner.

During his campaign, Yoon accused Moon of tilting too much toward North Korea and China and away from Washington while exploiting ties with Japan, Korea's former colonial ruler, for domestic political purposes. Russia presses Ukraine assault as Putin marks Victory Day

 $R^{\text{ussian forces pushed for-}}_{\text{ward Monday in their}}$ assault on Ukraine, seeking to capture the crucial southern port city of Mariupol as Moscow celebrated its Victory Day holiday.

Determined to show success in a war now in its 11th week, Russian troops pummeled a seaside steel mill where an estimated 2,000 Ukrainian fighters are making their last stand in the port city of Mariupol

The mill is the only part of the city not overtaken by the invaders. Its defeat would deprive Ukraine of a vital port and allow Russia to establish a land corridor to the Crimean Peninsula, which it seized from Ukraine in 2014.

The Ukrainian military's General Staff warned of a high probability of missile strikes and said that Russian troops

were seizing "personal documents from the local population without good reason" in Russian-controlled areas of Zaporizhzhia - the city where many fleeing Mariupol have gathered. The military alleged Russian troops were seizing documents to force residents to join in Victory Day commemorations.

Ukrainian President Volodymyr Zelenskyy warned the anniversary, which marks the Soviet Union's triumph over Nazi Germany in 1945, could bring a renewed onslaught.

"They have nothing to celebrate," Linda Thomas-Greenfield, US ambassador to the United Nations, said of the Russians, speaking on CNN.

"They have not succeeded in defeating the Ukrainians. They have not succeeded in dividing the world or dividing NATO. And they have only succeeded in isolating themselves internationally and becoming a pariah state around

Speaking Monday at a military parade marking the hol-Russian President Vladimir Putin sought to justify his invasion, by claiming that it was necessary to ward off what he described "an absolutely unacceptable threat just next to our borders." He has repeatedly alleged that Ukraine was planning to attack Russia which Kyiv has flatly denied.

Putin again scolded the West for failing to heed the Russian demands for security guarantees and a rollback to NATO's expansion, arguing that it also left Moscow no other choice but to invade.

Ttalian Premier Mario Draghi Imeets with US President Joe Biden this week in Washington as Europe faces another "whatever it takes" moment with Russia's war in Ukraine raging on its eastern flank.

"There is the position of the countries that see in the war in Ukraine the possibility, or the hope, of the diminishment of Russian power. I think this current is strong in the US.

"I don't think this is the position of the Italian government, which in the past has had cordial and positive relations with Russia.

Draghi, a former central banker skilled at measuring his words, is one of the only European Union leaders to visit Washington since the war broke out, and can be expected to represent not only Italy's perspective, but also that of

Pale and drawn, the last civilians sheltering in bunkers beneath a sprawling steel mill in the decimated Ukrainian port city of Mariupol arrived late Sunday night in Zaporizhzhia, the first major Ukrainian city beyond the frontlines.

The shattered survivors spoke of constant shelling, dwindling food, ubiquitous mold - and using hand sanitiser for cooking fuel.

Ten buses slowly pulled into Zaporizhzhia's deserted streets under darkness, carrying 174 evacuees from the Mariupol area.

They included more than 30 of the 51 civilians evacuated in the last day from the Azovstal steel mill, where an

fighters are making what

appears to be their last stand. Both Ukrainian and Russian officials have said these civilians are the last non-combatants from the industrial complex.

"It was terrible in the bunkers," said 69-year-old Lyubov Andropova, who had been in Azovstal since March 10. "Water would run down from the ceilings. There was mold everywhere. We were worried for the children, for



their lungs."The shelling was constant, and there was fear "that our bunker would collapse," she said. "Everything shook, we didn't go out."

The seaside steel mill is the only part of Mariupol not under Russian control. Thanks to its warren of tunnels and bunkers deep underground, many civilians had chosen it as the safest place to take cover from the relentless shelling of the formerly thriving port city that has now been largely destroyed.

Rupee slumps to all-time low of 77.44 on forex outflows



 $E^{\text{xtending its losses for a sec-}}_{\text{ond day, the rupee on}}$ Monday slumped by 54 paise to close at a record low of 77.44 against the US dollar, pressured by the strength of the American currency overseas and unabated foreign fund outflows.

Forex traders said risk appetite has weakened amid rising bond yields in the US and mounting concerns about inflation that may trigger more aggressive rate hikes by global central banks. At the interbank foreign exchange market, the rupee opened lower at 77.17 against the greenback, and finally settled for the day at 77.44, down 54 paise over its

previous close. During the trading session, the rupee touched its lifetime low of 77.52. On Friday, the rupee had slumped 55 paise to close at 76.90. In the last two trading sessions, the rupee has lost 109 paise against the greenback.

Indian Rupee spot plunged to record lows, tracking weakness in Asian peers amid a stronger dollar index and surging treasury yields in the US," Royce Vargheese Joseph - Research Analyst -Currency and Energy, Anand Rathi Shares and Stock Brokers said. Equity markets witnessed a sharp sell off as real rates in the US turned positive and investors turned risk averse evaluating the need for a highgoing forward, Joseph said.

Joseph further said "elevated crude prices and rising domestic inflation, well above RBI's upper band, might prompt further FII selling from securities. domestic Meanwhile, RBI's off cycle meeting on 4th May did little to strengthen the Rupee. Going forward, we might see the rupee spot weakening towards 77.8 levels.

The dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.33 per cent higher at 104, tracking rising JS yields amid fears about higher interest rates.

"Rupee fell to fresh all time lows on Monday as the dollar rose broadly against its major crosses. Last week's central bank policy action led to heightened volatility in most of the currencies.

Stronger dollar and sustained up move in global crude oil price is weighing on the overall market sentiment," said Gaurang Somaiya, Forex & Bullion Analyst, Motilal Oswal Financial Services. Somaiya further said that this week. focus will be on inflation data of India and the US. "We expect

According to Jateen Trivedi, Senior Research Analyst at LKP Securities, "Dollar staying above USD 104 indicates FII's aggressively exiting from emerging markets, higher Vix indicate no trend is sustainable and due to higher inflation, aggressive liquidity squeeze from central banks pressures rupee altogether. Crude prices have also been rising for a month now making the rupee even weaker."

"I look at the rupee continuing its downward journey as the dollar rise is a major risk to prices. A relief on the rupee front can only be seen if the dollar index cools off," Trivedi said. Global oil benchmark Brent crude futures fell 1.68 per cent to USD 110.50 per barrel The 30-share BSE Sensex

India, Tata Steel, Tech Mahindra, SBI, HUL and ITC were among the other major laggards, losing as much as 2.97

per cent. In contrast, PowerGrid, HCL Technologies, Infosys, Maruti, Bajaj Finserv and HDFC featured among the gainers, climbing up to 2.83 per cent. "The market continued its downward rally amid lingering concerns over weakening rupee, global interest rate hikes and tightening lockdowns in

"We hope India will provide a fair, just, and non-discriminatory business envinies, conduct investigation, and law enforcement in accordance with laws and regulations so as to increase the confidence of global investors," Zhao said. He said the Chinese government always asks its

companies to abide by laws and regulations while doing business overseas. "But at the same time it firmly supports the Chinese companies in upholding their lawful rights and interests," he said. Xiaomi is accused of making illegal remittances abroad "in the guise of royalty" payments.

The ED on Saturday

rejected as "baseless" the allegations that the statements of Xiaomi India officials, the wholly-owned subsidiary of Chinese mobile manufacturing company Xiaomi, were recorded "under coercion", saying the charges were an afterthought.

The federal agency was responding to certain news reports that said Xiaomi alleged in a recent filing before the Karnataka High Court that its top executives were threatened with "physical violence and coercion" during tigators in Bengaluru.


KKR STILL ALIVE IN IPL

TTFI name 16 probables for CWG, final squad after national camp from May

 $R^{\text{eigning national champions}}_{\text{Sharath Kamal and Sreeja}}$ Akula were on Monday named in the 16-member probables list for the Birmingham Commonwealth Games, scheduled to be held in July-August.

SD Mudgil, member of the Delhi High Court-appointed Committee of Administrators running the suspended Table Tennis Federation of India (TTFI), said that the final squad will be announced after completion of the training camp from May 23 to May 30.

In a first, the training camp will be held at Padukone-Dravid Centre for Sports Excellence in Bengaluru.

"After their meetings on April 25, May 1 and May 2, the selectors shortlisted the probables for the upcoming Commonwealth Games.

"The list was finalised after watching the players at the national championships in Shillong, detailed deliberations and discussions on past performance and medal prospects," said Mudgil, who is a former

athlete himself.

"We want to take the game to every nook and corner of the country. Our focus is also on making the administration transparent. The CoA, headed by retired Justice Gital Mittal has been very proactive on that front. "The performance of our athletes have also been encouraging of late. They give us a lot of hope going into the CWG and Asian Games (now postponed) and Olympics 2024," said Mudgil.

Earlier this month, Indian players including star woman paddler Manika Batra made massive gains in the ITTF world rankings after the sport's governing body approved changes to the points system.

Manika attained a careerhigh singles ranking of 38 with a jump of 10 spots while G Sathiyan was the best placed Indian male at 34.

Veteran Sharath, who won his 10th national title in Shillong, also gained a place to be world no 37 while Sreeja Akula, who won her maiden national title, gained as many as 39 places to be ranked 68th.

Thomas and Uber Cup: Indian men's team qualify PTI BANGKOK



Asia Cup is a World Cup qualifier but India, being the hosts, have a confirmed entry in the big-ticket event, which will be held in January next year. Defending champions India have been clubbed along side Japan, arch-rivals Pakistan and hosts Indonesia in Pool A, while Malaysia, Korea, Oman and Bangladesh have been
