# Can sedition cases be put on hold till relook, asks SC

**Centre given** 24 hrs to reply

PNS NEW DELHI

The Supreme Court on Tuesday asked the Centre to inform within 24 hours whether the filing of sedition cases in future will be kept in abeyance till the proposed reexamination of the sedition law by an "appropriate" forum. The bench headed by Chief

Justice NV Ramana asked this in response to the submissions of the Centre that said it has decided to "re-examine and reconsider" the sedition law by an "appropriate forum".

Solicitor General Tushar Mehta, appearing for the Centre, said he would take from the instruction Government and apprise the bench on Wednesday.

'We are making it very clear. We want instructions. We will give you time till tomorrow. Our specific queries are: one about pending cases, and the second, as to how the Government will take care of future cases...," said the bench, comprising Justices Surya Kant and Hima Kohli.

The Bench also asked Centre to inform if future cases can be kept in abeyance till reconsideration is over.

"We have perused the affidavit by the respondent (Central Government). Meanwhile, to protect the interest of the people already booked under 124A as well as the future of this provision, the SG will take instructions whether cases can be kept in abeyance till further time till reconsideration is over," the court said in its order giving

Centre a day to clarify. Senior lawyer Kapil Sibal opposed the Centre's new affidavit on place the davit on plans to re-consider sedition law and said the court should proceed to decide the validity irrespective of whether the Government is examining the provision or not. "This court cannot wait for another jurisdiction. It is for the judiciary to consider whether it is constitutional or not," he said.

The CJI asked the SG on how much time the Government would take to complete the exercise. "I won't frame. The process has started Please see the tenor and spirit of the affidavit," the SG said.

The Ministry of Home Affairs in an affidavit filed before the apex court on Monday said the decision was in tune with the views of Prime Minister Narendra Modi on shedding "colonial baggage", noting he has been in favour of the protection of civil liberties and respect of human rights and in that spirit, over 1,500 outdated laws and over 25,000 compliance burdens have been

The apex court has been hearing a clutch of pleas challenging the validity of the law on sedition which has been under intense public scrutiny for its alleged misuse to settle political scores by various Governments.

Tipplers in Delhi would soon be able to order liquor online. The Excise Department of Delhi has proposed to allow the home delivery of liquor and counts offered by vendors. A proposal to this effect is likely to be brought before the Cabinet meeting.

The document accessed by *The Pioneer* showed that Group of Minister (GoM) has recommended home delivery of liquor sourced from retail liquor vends

The GoM has also viewed that there should not be any restriction on the rate of discounting by the retail liquor vends as long as the market operates in a healthy manner.

The GoM also proposed to discontinue a policy to open two shops in a ward. After the Cabinet approval, the Excise Department will have to frame rules and identify agencies to supply liquor at home.

The home delivery of liquor may be done by empanelled intermediaries who will



be collecting the liquor from respective retail vends and delivering it to respective public localities through ordering by the chosen empanelled agency/agencies chosen to do home delivery," the document said. However, no delivery will be made to any hostel, office, and institution. The GoM also noted that the mandate of equitable distribution of retail vends across Delhi has not fructified due to issues related to non opening of retail vends

in the non conforming areas. At the same time ensuring quitable coverage of authorised liquor to solve the problem of underserved and un served areas in Delhi including non conforming area is one of the prime objectives of the government so that area no

instance of hooch tragedy due to intake of spurious liquor, bootlegging and interstate smuggling of liquor due to orous border with neighbouring States.

The new 2021 rules stated will be allowed to deliver both Indian and foreign alcohol/liquor to the homes of people, only if the order is received through an online

web portal or app.
However, this rule restricts all deliveries to hostels, offices or institutions.

The Law department of the Delhi Government had pointed out that in absence of any enabling provision, home delivery of liquor by an intermediary, except a licensee, is impermissible.

According to the 2021-22 excise policy, every liquor outlet in the city will provide a walk-in experience to its customers who will have multiple choices of brands, and the entire selection and sale process will be completed within the vend premise.

## You can soon order liquor online AAP MLA detained as bulldozers roll in Delhi

Aday after Shaheen Bagh, bulldozers on Tuesday rolled in New Delhi's New Friends' Colony, Vasant Kunj, Mangolpuri to remove illegal encroachment from roads pavements and footpaths amid heavy security. The police detained an AAP MLA in Mangolpuri for obstructing

the drive. As per a data shared by the local bodies, the North Delhi Municipal Corporation (NMC) removed 66 illegal structures, while South Delhi Municipal Corporation (SDMC) removed 12 structures from roads pavements and footpaths on Tuesday. According to local bodies, the corporation plans anti-encroachment drive in all its four zones on May 11.

According to SDMC, the drive started at 11 am and went on till 2 pm. Over 12 temporary structures were removed from the area which caused incon

venience to the locals.

The CBI conducted a major countrywide operation against Union Home Ministry sentatives, and middlemen for alleged involvement in receiving foreign donations in violations of the Foreign

Contribution Regulation Act. Till late in the evening on Tuesday, the searches yielded hawala transactions worth ₹2 crore and led to the arrest of six public servants connected to the FCRA division of the MHA, officials said.

The coordinated operation over the alleged breaches of the Contribution (Regulation) Act covered around 40 locations in Delhi, Chennai, Hyderabad, Coimbatore, Mysore, and some

places in Rajasthan, they said. In addition to the arrest of six public servants, questioning of some other suspects, including NGO representatives, was

### Modi to visit Lumbini on Buddha Purnima

In an effort to give a boost to historical ties between the two countries, Prime Minister Narendra Modi is likely to visit Nepal on May 16 on the occasion of Buddha Purnima. It will be his first visit to Nepal after becoming Prime Minister for the second time in 2019.

Nepal Prime Minister Sher Bahadur Deuba, accompanied by his spouse Arzu Deuba, paid an official visit to India from April 1 to 3. It was his first bilateral visit abroad after assuming his office in July 2021. Besides official engagements in New Delhi, Deuba also visited Varanasi.

The PM will travel to Lumbini, the birthplace of Gautam Buddha, at the invitation of his Nepalese counterpart. His hour-long trip will come on the occasion of Buddha Purnima, Lord

participate in the programme. In his first term as the Prime Minister, Modi had visited the Himalayan nation four times. Later this month, Modi

#### Santoor maestro Pandit Shivkumar bids final adieu Mumbai: Santoor virtuoso Pt Shivkumar Sharma, who took the stringed instrument to the global stage and successfully straddled the worlds of classi-

cal and film music, died here on Tuesday following a heart attack. He was 83. Sharma, one of India's most well-known classical musicians, died between 8 and 8.30 am at

his Pali Hill residence here, his secretary Dinesh told PTI. He had been active till the end and was due to perform in Bhopal next week. He was also

suffering from renal ailments.
"He had a severe heart attack in the morning... He was active and was to perform in Bhopal next week. He was on regular dialysis but was still active," a family source said. Sharma, one half of the

famous 'Shiv-Hari' composer duo along with flautist Hari Prasad Chaurasia, is survived by his wife Manorama and sons Rahul, also a santoor player, Rohit

The Shiv-Hari duo com-

posed music for an array of films such as "Silsila", "Lamhe", 'Chandni" and "Darr".

A Padma Vibhushan recip ient, Sharma was born in Jammu in 1938 and is believed to be the first musician to have played Indian classical music on the santoor, a folk instrument from Jammu and Kashmir. Describing his father as his 'guruji', Rahul said the end was peaceful.

"He is not with us anymore but his music lives on. He went away peacefully. He has given the entire world his music, peace through his music and what he did for santoor... It's now known across the

"His music will always live on. He will be with us through his music. He had age related issues. He was 83. We had done a concert together 15 days ago, everything was fine. He passed away peacefully," Rahul told reporters outside his home.

The santoor legend's longtime collaborator and friend



Chaurasia was at Sharma's residence for nearly eight hours and broke down while talking to the media.

'Ye aapne kaise keh diya woh hamare beech nahin rahe. Aisa ho hee nahin sakta. Woh hamare saath the, aur hamesha rahenge (How could you say he is no more? It can't be. He was with us and will always be)," the flautist said.

Durga Jasraj, daughter of the late classical vocalist Pandij Jasraj and a close friend of Sharma, said the santoor legend fainted in the bathroom and was "gone in a fraction of a second".

"I have lost my second father. I have been trying to coordinate all the other arrangements but what happened is that he fainted in the bathroom in the morning and that was a cardiac arrest and he could not be revived."We called for the ambulance and everything but he was gone in a fraction of a second.

# 2 terrorists neutralised by forces in Anantnag

had earlier escaped from the Watnad encounter site

¬wo terrorists were neu-I tralised by the joint team of security forces in Kreeri, Dooru area of Anantnag on Tuesday evening while one civilian injured during cordon and search operation in Pandoshan area of Shopian late Monday evening succumbed to his fatal injuries. At present an injured jawan of the Indian army and another civilian were receiving treatment in the 92 Base hospital, Srinagar.

According to Inspector General of Police, Kashmir terrorists killed in Anantnag belonged to the same group of terrorists who escaped from Watnad encounter site on 16/4/22 in which one soldier made a supreme sacrifice.

Meanwhile, a civilian identified as Shahid Gani Dar succumbed to his injuries in the command hospital, Srinagar. Dar was injured during the cordon and search operation in Shopian late Monday evening. According to a Srinagar

based Defence PRO, "a joint cordon & search operation was launched by Indian Army & Jammu and Kashmir police at about 07:45 pm on 09 May 22. At around 8:30 pm, while the secuirty forces were establishing a cordon around the target house, the terrorists started firing indiscriminately in all directions in an attempt to breach the cordon, thereby putting the lives of civilians at

As the security personnel started shifting civilians from the operation site the terrorists started firing on the civilians in order to create chaos to assist them in their escape bid.

Despite shifting the majority of the civilians to a safe location one soldier Lance Naik Sanjib Das and two civilians namely Shahid Gani Dar and Suhaib Ahmad received gunshot wounds. All the injured were immediately evacuated in an army helicopter to 92 Base Hospital, Srinagar.

According to Defence PRO, civilian Shahid Gani Dar succumbed to his injuries. The other injured civilian, Suhaib Ahmad is reported to be critical but stable. He will be undergoing life saving surgeries. Lance Naik Sanjib Das is stable and out of danger. Taking advantage of cover of the dark, the terrorists managed to escape the operation site.

### 12 UP cities to get metro rail network; DPRs almost ready

To ensure world-class connectivity, Uttar Pradesh will soon have the metro rail network in 12 cities, DPRs of which are almost ready.

Metro rail services already exist in Lucknow, Ghaziabad, Noida, Greater Noida and Kanpur while Gorakhpur, Kashi, Meerut, Bareilly, Jhansi and Prayagraj are also expected to get the same soon.

Urban population constitutes 24 per cent of the total population of Uttar Pradesh, which contributes 65 per cent to the state's GDP. The Yogi government is working towards providing eco-friendly and viable commuting options to make the lives of these people in urban areas easier.

A government spokesman said that to realise the objectives, the detailed project reports (DPRs) for Varanasi, Prayagraj, Jhansi and Meerut are in final stages. Chief

Minister Yogi Adityanath has also instructed the officials concerned to prepare DPRs for Metro Neo projects in Bareilly, Meerut, Jhansi, Prayagraj and Varanasi.

The metro services in Agra are also nearing completion on a war-footing. Over 35 per cent of the first phase of Agra Metro Project has been completed while the work of priority corridor in Kanpur was completed in less than two years' time despite two waves of the Covid-19 pandemic, the spokesman said.

He added that the chief minister has issued directives to start work on the Gorakhpur Metro Lite project within six months. "In its first phase, the 15.14-km Metro Lite of Gorakhpur at a cost of Rs 2,670 crore will connect major centres of the city, including Gorakhnath Gorakhpur Railway Station, Gorakhpur University and the newly-built AIIMS," he said.

### Illegal e-health-care: HC asks AAP Govt for affidavit on action

The Delhi High Court has directed the AAP government to file an affidavit regarding the mechanism being followed to ensure that the earlier direction to take action against online health service aggregators which are operating illegally and collecting samples for COVID-19 tests is being complied with. The high court was hearing a petition by Dr. Rohit Jain seeking contempt action against the authorities for not adhering to the court's earlier direction to take action against online health service aggregators which are operating illegally and collecting samples for Covid-19 tests.

The court also asked authorities regarding the steps taken when a complaint is received that a lab is functioning without the requisite licence in the city of Delhi.

Justice Subramonium Prasad perused the division bench's August 6, 2020 order by which the authorities were

online aggregators and said the decision indicates that a direction has been passed to the respondents to initiate action against such violators of law who are engaged illegally operating in Delhi, after giving

the adequate opportunity of being to the concerned parties.

"The letter and spirit of the said order indicate that this court had intended to ensure that labs and online health service aggregators, which were not accredited by NABL and had not received approval from the ICMR to collect samples and provide reports, did not

function in the city of Delhi,"

the high court said. It further said, respondents are directed to file an affidavit delineating the mechanism being followed to ensure that the order dated August 6, 2020, is being complied with in its letter and spirit, and the steps that are taken when a complaint is received that a lab is functioning without the requisite licence

It listed the matter for further hearing on June 1, while directing that the responsible officers of the Delhi government, ICMR, and Delhi Police shall be present in the court on that day to assist the court in this regard. While hearing the contempt plea, the high court had earlier asked the Delhi government to consult with the Indian Council of Medical Research (ICMR) and publish the requisite standards for the collection of blood samples

for COVID-related tests.

It had also said the ICMR will highlight, on its website, how much blood sample is permitted to be collected for conducting the COVID-related tests. Advocate Shashank Deo Sudhi, appearing for the petitioner, had urged the court to allow the contempt plea and restrain the illegal online health service aggregators, which are not authorised to collect diagnostic samples for COVID-19 tests, from further committing contempt of order passed by the court in 2020.

# City temp drops below 40 degrees C

The maximum temperature dropped below the 40-degree mark on Tuesday as moisturecarrying easterly winds prevailed in the city under the impact of severe cyclone Asani.

According to the India Meteorological Department (IMD), no heatwave is predicted for the next two days.

Earlier the IMD predicted, 'heatwave spell from Wednesday with temperatures soaring to 44 degrees Celsius."

In a revised forecast, it said the maximum temperature will settle around 40 degrees Celsius on Wednesday and 42 degrees Celsius on Thursday.

The Safdarjung observatorv. Delhi's base station, recorded a maximum temperature of 39.5 degrees Celsius, a normal for this time of the year. The minimum temperature settled at 28 degrees Celsius.

The relative humidity on Tuesday morning at 8:30 was recorded at 61 per cent and 45



## Delhi may get world-class mega liquor vends soon

GoM for increasing max size of retail vends to 5,000 sq ft and above in Excise Policy 2022-23

Tipplers in Delhi may soon have an altogether different shopping experience in worldclass mega liquor vends spread over more than 5,000 square feet (sq ft), with tasting rooms and merchandise like cigars, liquor chocolates and art paintings on sale.

The minimum and maximum sizes of retail liquor stores in the city were fixed at 500 sq ft and 2,000 sq ft by the new Excise Policy being implemented by the Delhi Government from November last year.

The Delhi Government's Group of Ministers (GoM) has made several recommendations for formulating the Excise Policy 2022-23, including increasing the maximum size of retail vends to 5,000 sq ft and above, officials said.

The minimum size of 500 sq ft mandated by Excise Policy 2021-22 for retail vends to provide walk in experience to customers should be maintained, the GoM recommended in its meeting last month.

"However, the upper limit of 2,000 sq ft may be increased to 5,000 sq ft," it said as per an official document. The GoM

further recommended that in case licensees intend to open a retail vend of more than 5,000 sq ft then an additional annual licence fee of Rs 5 crore will

be applicable.
"Such vends will be converted from L-7 V to L-7MV licence, providing the customers a better experience," the document said.

These converted retail vends may also be allowed to sell ancilliary products including cigars, liquor chocolates, art paintings, high value merchandise such as bottle openers, ice boxes, bar glasses and other gift items, it said.

Approximately 29 per cent of the space may be allocated for the merchandise in the converted vend.

These vends can set up a tasting room within the premises. These rooms may only have training and tasting sessions and will not be used to

serve liquor to consumers, added the document.

The recommendations of the GoM will become part of the Excise Policy 2022-23 after approval of the Delhi Cabinet, added the officials.

The Excise Policy 2022-23 being framed by the Delhi Government may discontinue the norm of opening two vends per municipal ward in view of problems arising out of constraints of doing so in unregularised parts of the city, officials

said on Tuesday. The Excise Policy 2021-22 notified by the government had divided the city into 32 zones with 850 retail vends distributed over a total of 272 municipal wards as well as the New Delhi Municipal Council areas and the airport. It had made it mandatory for each zonal licence holder to open two retail liquor stores in each

### Heat delays transfer of deer herd from Delhi Golf Club to Asola sanctuary

Scorching heat has delayed the transfer of a herd of Sambar deer from the elite Delhi Golf Club (DGC) to their new home in the capital's Asola Bhatti Sanctuary.

One of the oldest and reputed institutions in the heart of Delhi, the DGC had last year approached the Delhi and Wildlife Forest Department, requesting them to shift the deer to the Asola Sanctuary, which is witnessing an increase in wildlife popu-

"It is not exactly known if the deer existed from the beginning or if someone introduced them to the DGC...Their number has increased over time," an official said. The deer stomp on the grass of the golf course and damage it. In winter months, when food is scarce, they start eating the grass, which increases the maintenance



cost, the DGC official said. Deer need a natural environment with minimal human interference, officials said, adding the transfer will improve the prey base for leopards in the Asola sanctu-

An official said around six to seven deer have been shifted from the DGC to the wildlife sanctuary in a meticulously planned operation. "Shock and stress are a leading cause of death among deer. It is being ensured that they are

shifted from one place to another when there is minimal traffic movement and human interference," the official said. However, the intense heat has impeded the drive. 'Since Asola is a new place

for these Sambar deer, they may not know the location of water holes, which will create stress among them.So, the transfer of the remaining deer has been deferred," the official

"We have not removed the infrastructure, including the cages and camera traps, from the DGC. The transfer will now be carried out after the heat abates," he said. The DGC official quoted above said some of their members have also opposed the transfer of the deer.

### **Shooter of Tyagi and Gauri gang held for Subhash Nagar attack**

Police said that he along with his associates Adnan Tyagi and Faizal surrounded Chaudhary's Toyota Innova car and opened more than 10 rounds of bullets targeting them at a busy traffic junction in Subhash Nagar According to Rajiv Ranjan Singh, the Deputy Commissioner of Police (DCP) Special Cell, after the incident which was captured on CCTV, the three assailants fled away. "Paras, who is a sharp shooter of gangster Salman Tyagi and Saddam Gauri, came out of jail on April 28. During the investigation it was revealed that due to an old enmity, Salman hatched conspiracy to eliminate Chaudhary," said the DCP. "On the directions of Salman, the three assailants attacked Chaudhary and his brother. Bhumia was arrested on Monday. One pistol and six rounds were recovered from Bhumia's possession," said the DCP. ### Bid to make city's roads safer

Three-lane Speed Violation Detection System, Al camera installed at flyover near Green Park Metro Station

To check traffic violators, the Delhi Government's transport department has installed a three-lane Speed Violation Detection System (SDVS) and an Artificial Intelligence (AI) camera at a flyover near the Green Park Metro Station, in collaboration with Keralabased PSU Keltron State Electronics Development Corporation Limited as a pilot

project.

The decision to install the SDVS and AI camera in Delhi was taken after a World Economic Forum (WEF) and Fédération Internationale de l'Automobile (FIA) conference held recently to address the issue of road safety in India. The Head of Communication Project Group, Keltron, Binsun NT told The Pioneer that the WEF and FIA requested them

to make a Proof of Concept (PoC) of the product in Delhi-NCR for five to six months to evaluate its effectiveness and scalability. Giving the specification of the three-lane SDVS, Binsun said, "The SDVS is mainly used for identifying overspeeding vehicles.

If the vehicle is moving above the speed limit set for the road, the SDVS system will detect the vehicle and issue a challan which will be fully admissible in court as we have a calibrator certificate and the violators cannot challenge it.

The system will also click the images of the car and the number plate of the violators." 'The current speed violation detection systems installed in Delhi are camera-based solutions with limitations. If the vehicle is moving at more than a particular speed then the system won't be able to detect it. But, the SDVS system is a radar-based system and it can detect a vehicle moving at a speed of up to 240 kms per hour," said Binsun. "In Delhi, people use different kinds of number plates such as reflective, non-reflective etc. But the current cameras are not able to click pictures of the number plate of the violators clearly. However, the SDVS can click the picture of any kind of number plate with 99 per cent

The technology used in the SDVS cameras is a global shutter system which is mainly used to click the images of fast moving objects," he said.

# **Identify minorities at State level** within 3 months: SC to Centre

 $E^{\rm xpressing\ displeasure\ over}_{\rm its\ changing\ stands,\ the}$  Supreme Court on Tuesday asked the Centre to take a decision on identification of minorities including Hindus at the State level within three months.

A bench of Justices S K
Kaul and MM Sundresh
directed the Centre to consult
the States. The Centre had in March said that it was for the States and Union Territories (UTs) to take a call on whether or not to grant minority status to Hindus and other communities where they are less in

But, on Monday, the Centre told the apex court that the power to notify minorities is vested with the Union Government and any decision in this regard will be taken after discussion with States and other stakeholders. "Later, you say the Centre has powers. In a country like ours, which has so much diversification, we understand but somebody should have been more careful. Before these affidavits are filed everything is in public domain which has



consequences. Therefore, you have to be more careful in what you say," the bench observed.

Dictating its order, the bench said, "A fresh affidavit has been filed by the Ministry of Minority Affairs which seems to back out what was said in the earlier affidavit. Something we don't appreciate. It is now sought to be stated that the question sought to be adjudicated has far reaching ramifications throughout the country.

"The stand has already been taken in the first affidavit. But as per fresh affidavit, the power is vested with the Central government to identify minorities...Aforesaid being the position, it is necesthe answer from the Government of India. You decide what you want to do. If you want to consult them do it. Who is stopping you from doing so," asked the Judges.

The apex court had earlier granted four weeks to the Centre to respond to a plea, which has sought directions for framing of guidelines for the identification of minorities the identification of minorities at the state level, contending that Hindus are in minority in 10 states. In an affidavit filed in response to a plea filed by advocate Ashwini Kumar Upadhyay, the Ministry of Minority Affairs said the central government has notified six communities as minority communities under section of the National Commission for Minorities

Upadhyay had challenged the validity of section 2(f) of the National Commission for Minority Education Institution Act, 2004, alleging that it gives unbridled power to the Centre and termed it "manifestly arbitrary, irrational, and offending". Section 2(f) of the Act empowers the Centre to identify and notify minority com-

### Ministry warns Ola, Uber of strict action over failure to redress consumer plaints

The Ministry of Consumer Affairs on Tuesday warned cab aggregators, including Ola and Uber, of strict action unless they improve their

systems and redress rising consumer complaints.
The Government held a meeting with the ride-hailing platforms amid a rise in consumer complaints of alleged unfair trade practices by them, including ride cancellation policy, as drivers force customers to cancel trips after accepting bookings, which results in customers paying cancellation penalties.

The meeting was attended by representatives of Ola, Uber, Meru, Rapido and Jugnu.

'We told them about the rising consumer complaints against their platforms. We gave them the statistics also. We have asked them to improve their system and redress the consumer complaints otherwise the competent authority will take strict action," Consumer Affairs Secretary Rohit Kumar Singh said after the meet-

Hinting at the scale of customer unhappi ness against the cab aggregators, he said the complaints on the Jago Grahak Jago helpline are just the tip of the iceberg. The Central Consumer Protection Authority (CCPA) Chief Commissioner Nidhi Khare said the cab aggregators should immediately come out with solu-

The authority is likely to issue an advisory to ensure that unfair trade practices by cab aggregators are not carried on in violation of consumers' rights," she added.

Khare also said the government has com-

municated that there will be "zero tolerance against such malpractices" by cab aggregators. On Monday, Singh had said the government

has sought information from the cab aggrega-tors on how they handled cancellation charges

and surge pricing and how they calculated fares.
"We have asked why the charges to go from point A to point B are different for two different people," Singh had said, adding the ministry was also keen to know whether these ride-hailing apps have taken adequate measures to safeguard consumer data on their platforms.

Last week, Khare said the CCPA received several complaints from consumers regarding the cancellation and pricing policy of cab aggregators. "The number of complaints is very high and therefore we have called the cab aggregators for an explanation of their policies," she said.Citing a few examples, she said the regulator received many complaints of alleged unfair trade practices, including cab drivers forcing consumers to cancel a trip and bear a penalty as the drivers do not want to accept the ride for

Khare further said existing consumers are being charged high rates for a ride, while new users are lured with lower charges for the same

"It appears that cab aggregators are using algorithms to lure new customers, putting old customers at a disadvantage. This is an unfair practice," she added.

Against this backdrop, Khare said the reg-ulator would like to understand their algorithms and other policies adopted for operating as cab aggregators in the country.

# CBI searches 8 sites in case of ₹180 cr building purchase by J&K Bank

PNS NEW DELHI

The CBI on Tuesday ■ searched eight locations in Jammu, Srinagar and Mumbai, including premises of then J&K Bank chairman Haseeb Drabu, in connection with alleged irregularities in purchase of a building by the bank for its integrated office in Mumbai in 2010.

The Akruti Gold Building was purchased for around Rs 180 crore and the agency had registered the case on November 11 last year on a reference from the Jammu and Kashmir government.

The premises of the then directors of the bank M I Shahdad and Vikrant Kuthiala, and Executive Director AK Mehta were also searched dur-

ing the operation, they said. "The CBI is today conducting searches at eight locations including at Jammu,

Srinagar and Mumbai at the premises of then members of the Estate Committee of the Board of Directors, including then Chairman of J&K Bank, then directors, then executive director," the CBI said in a

The CBI had also conducted searches earlier at various locations including at Mumbai, Hyderabad and

Incriminating documents, articles and electronic evidence, several bank account details and bank locker keys have been recovered during

searches, the agency added.

This is the second search in this connection. The four accused persons were also members of the estate committee of the bank.

In its FIR, the CBI has alleged that the bank had entered into a deal for its branch office at the Bandra Kurla Complex (BKC) with Akruti Gold at a much higher rate than offered by other shortlisted builders causing a loss of over Rs 100 crore to the

The case was earlier probed by the Anti-corruption Branch of the Jammu and Kashmir Police, which had registered an FIR following a preliminary inquiry.

The inquiry report, now part of the FIR, had said an advertisement was issued by the J&K Bank on November 6, 2008, inviting offers for outright sale of integrated office premises at Bandra Kurla, Mumbai, requiring 20,000 sqft space. Twenty-five builders had responded to the advertisement which were opened by the committee formed for the purpose and out of the offers received, eight properties Ashapura Builders (Hallmark

Business Plaza), Topaz Akruti,

Crescenzo (BKC), Platin BKC Naman Centre, Golden Homeland agencies (Wockhardt), Windsor and KRC Towers were shortlisted.

Of these eight, the rates offered by Ashapura Builders were the lowest at Rs 25,000 per sqft, Ashapura Builders on July 28, 2009, made an offer for its building's third floor of 30,000 sqft built up area at Rs 22,500 per sqft chargeable area.

"The application was processed and submitted to the then chairman to take a decision but no decision was taken regarding finalisation of the contract with Ashapura Builders.

A committee was constituted with approval of the chairman to take a view with regard to the offer received. The committee so constituted has done nothing in respect of offers received," the FIR had

### Centre set target to reduce 50% deaths on road by 2024: Gadkari

¬he Centre on Tuesday set a **1** target to reduce 50 per cent road accident deaths by 2024. Union Road Transport and Highways Minister Ñitin Gadkari said a sensitisation of stakeholders like the Road Ministry and NHAI for collectively addressing issues regarding road safety is also being done as road safety is a very serious issue and there should be zero tolerance for road acci-

The Minister also said action should be taken immediately on black spots. Black Spots are locations having higher concentration of road accidents.

The minister rued the fact that India accounted for the highest number of accidents in the world, one of the major reasons for which was poor road engineering. "In our country,



every year about five lakh accidents take place and 1.50 lakh people lose their lives and a majority of the victims are aged between 18 and 45," said Gadkari.

Gadkari directed the senior officials to consider and implement various strategies and solutions to improve road safety as early as possible. The Minister said action should be taken immediately on black spots. He said while taking action three things have to be considered: immediate measures, mid-term action, and long-term action. He said all

Ros (Regional officers) & PDs (Project directors) should take a pledge of zero accidents.

He said that India was losing 3 percent to 5 percent of its Gross Domestic Product due to accidents. He noted that a person could get a driving license in the country very easily unlike in the United States. It is also not good for me to tell you that when we referred to the records of driving licenses, at least 30% of them were bogus and one person had three to four licenses," Gadkari mentioned.

"We have changed the system and with the help of the Income Tax department, were able to take some action on those people who had multiple driving licenses," the minister added.

Gadkari earlier has said that the road accident scenario in India is more dangerous than the pandemic, pointing to potential savings of 90

lakh per person if such deaths

"For the government, each life is precious, whether poor or rich, urban or rural, male or female. The situation is alarming. There are more deaths than in Covid-19. It is more dangerous than Covid-19," said

The Road and Transport and Highways ministry have swung into action following a World Bank report on accidents in India which has one per cent of the world's vehicles and accounts for 10 percent of all road crash victims

The report noted that while the attention last year shifted due to Covid-19, there is an interesting link between road safety and pandemic losses and unfortunately, the road crashes have not been going down and any time 10 percent of the capacity in hospitals was being used for the treat-

# Alcohol taking 1 life Int'l sports medal winners to be BJP leader's autopsy every second: WHO

Ayouth is dying every second due to alcohol consumption, the World Health Organisation (WHO) has revealed in its new report released on Tuesday which highlights the increasing use of sophisticated online marketing techniques for alcohol and the need for more effective regulation.

It shows that young people and heavy drinkers are increasingly targeted by alcohol advertising, often by digital means and in many cases regardless of the social, economic or cultural environment in receiving countries. In many cases, the marketing goes unabated regardless of the social, economic or cultural environment in receiving countries, said the report titled "Reducing the harm from alcohol — by regulating cross-border alcohol marketing, advertising and promotion" which was released on Tuesday. Talking about the health hazards of alco-

alcohol is taking a toll on one person every 10 seconds. Almost three million people lose their lives every year due to consumption of liquor. The WHO has called upon the countries for the need for more effective reg-

"A disproportionate number of these alcohol — related deaths occur among younger people, with 13.5% of all deaths among those who are 20-39 years of age being alcohol-related. "Alcohol robs young people, their families and societies of their lives and potential," said Dr Tedros Ghebreyesus, Director General, WHO. "Yet despite the clear risks to health, controls on the marketing of alcohol are much weaker than for other psychoactive products. Better, well enforced and more consistent regulation of alcohol marketing would both save and improve young lives across the world."

In addition, alcohol consumption among women is an hol production and sales. "While three quarters of the alcohol is consumed by males, alcohol marketers tend to see the lower rate

# report: TMC wants Amit Shah's apology

The ruling Trinamool Congress has demanded apology and resignation of Union Home Minister Amit Shah for "peddling an untrue story about an unfortunate death" and "terming the mysterious death of Arjun Chowrasia a BJP youth wing leader at Cossipore in North Kolkata political murder.'

Hours after the autopsy report of the deceased — indicating suicide — became pub-Bengal ministers Chandrima Bhattacharya and Dr Shashi Panja on Tuesday said "the version of the Trinamool Congress has been proved true and that of Home Minister Amit Shah who called it a 'political murder' - without even waiting for the autopsy reports — false," adding "he owes an apology to the people of Bengal for making misleading statement."

Earlier the military command hospital authorities submitted the autopsy report before the Calcutta High which had after hearing a petition ordered an impartial authority to conduct the postmortem. The autopsy reports said that the death of Chaowasia, whose body was found hanging in an abandoned room near his residence at Cossipore in North Kolkata on May 6, was antimortem in nature.

postmortem report said "it was unbecoming of the Home Minister of the country to draw a conclusion without any authentic report at hand ... he definitely owes and apology ... it is not a political murder as insisted by the Home Minister."

Local TMC MLA and Kolkata Deputy Mayor Atin Ghosh too attacked Shah for making a "sweeping statement ... he should resign for the

comment he made out of turn ... this is blatant interference in the State Government's juris-

TMC spokesperson Kunal Ghosh said that Shah would 'do good to take a lesson from the Cossipore incident and desist from making hurried statements ... he was misled by his party men who fed him with a false story for narrow political gains and he relied on this demanding a CBI investigation into the incident."

Senior Bengal minister Frihad Hakim too attacked the BJP for playing the politics with dead bodies. "Having failed to mislead the people of Bengal and win their trust in the last year's Assembly elections the BIP has resorted to playing the politics of corpses ... this will take them nowhere ... instead of working for the people like Mamata Banerjee does they are always in the hunt for a dead body in order to remain relevant in the politics."

# J&K admin to provide transport to nomads National Highway-44 National Highway-44

The Union Territory Administration in Jammu and Kashmir has embarked on a transhumant population comprising Bakkerwals, Gaddi and Sippis to the highland pastures in Kashmir this summer season.

It is for the first time the government has decided to provide transport facilities to minimize hardship of the nomads during the seasonal migration.

According to the first survey of the transhumant tribal population conducted by the Tribal Affairs department in 2021 around 6.12 Lakh people migrate every year to highland pastures known as 'Dhoks'.

Shahid Iqbal Choudhary, Secretary to the Government, Tribal Affairs department said, "To start with, a fleet of 40 trucks have been deployed to transport around 30,000 families from Jammu to Kashmir via Mughal road and

connecting Jammu with Srinagar". Dr Choudhary said, funds amounting to already been released to the Jammu and Kashmir Transport Corporation for 30

trucks. "The deptt endeavours to include more trucks and some passenger vehicles for movement of migratory tribal families during the annual seasonal migration and on return", he added. On Tuesday a fleet of six

trucks was formally flagged off by Assistant Commissioner Revenue Rajouri, Imran Rashid Kataria carrying the migratory population to dokhs of Peer

While speaking at the event, the ACR said that the initiative has been taken to minimise the hardships of the migratory population during their journey to the upper

The India Meteorological Department (IMD) on Tuesday issued a "red" warning for the Andhra Pradesh coast for cyclone Asani. This means local authorities need to take action to prevent disasters associated with the cyclone as severe cyclone Asani has changed its track significantly and is likely to touch the Andhra Pradesh coast between Kakinada and Visakhapatnam.

Union Home Secretary Ajay Bhalla on Tuesday reviewed preparedness for severe cyclone Asani, which is moving over Bay of Bengal, off Andhra Pradesh and Ödisha coasts, where rescue troops were deployed for assistance of civilians.

According to the IMD, Asani is likely to weaken gradually into a cyclone by

a depression by May 12 morning but before it weakens, it is forecast to cause intense rainfall and extremely strong winds along Andhra Pradesh and Odisha coasts.

Asani, which means wrath in Sinhalese, is likely to move northwestwards and reach west central Bay of Bengal close to Kakinada-Vishakhapatnam coasts by Wednesday morning. Thereafter, IMD said, Asani is likely to recurve slowly northnortheastwards and move along Andhra Pradesh coast between Kakinada and Vishakhapatnam and then emerge into northwest Bay of Bengal off North Andhra

Pradesh and Odisha coasts. The cyclone would have wind speeds of 75-85 kmph gusting to 95 kmph on the Andhra Pradesh coast and 45-55 kmph gusting to 65 kmph on

the Odisha coast. Suspension of fishing operations has been suggested. Storm surge of height of about 0.5 m above astronomical tide is likely to inundate low lying areas of Krishna, East and West Godavari and Vishakhapatnam districts of Andhra Pradesh, IMD has warned. Moderate rainfall at many places with heavy to very heavy rainfall at isolated places is likely over coastal Andhra Pradesh and Odisha is likely from May 10 night. The National Disaster

Response Force (NDRF) has earmarked a total of 50 teams for undertaking rescue and relief operations in areas affected by Asani. ### Lanka under seige

Demand for interim Govt and fresh elections are growing in the country

he violent turn of events in Sri Lanka leading to the resignation of Prime Minister Mahindra Rajapaksa and subsequent arson and rioting have raised fears of continued instability in the island nation. The way protestors freely went around setting fire to the houses of the powerful Rajapaksa family even after the Prime minister submitted his resignation has worsened the situation. Amid fears that if the violence did not subside martial law had to be imposed, Mahinda Rajapaksa and his family have reportedly taken shelter at a naval base in the northeast part of the island nation. Demand for an interim Government, the resignation of President Gotabaya Rajapaksa, and fresh elections under an interim Government are growing in the country. It is unlikely that these could be ignored much longer. Sri Lanka has been a victim of both prolonged mis-governance and misfortune. Deep-rooted corruption and disastrous handling of the economy coupled with the destruction of the truism industry by the COVID-19 pandemic have brought Sri Lanka to the brink of a collapse. The Russian invasion of Ukraine, which impacted oil prices and food grains import, turned out to be the last nail in the coffin. It's time President



Gotabaya Rajapaksa reached out to the opposition parties and protestors, showed statesmanship, and restored the democratic process. This is important for Sri Lanka because the imposition of martial law could invite global sanctions with disastrous consequences. By Now Sri Lanka must have realized that easy access to Chinese dole has its flip side too. Such loans cannot sustain the economy of a country. They can only lure a nation into a debt trap.

India must take serious note of the developments in Sri Lanka. New Delhi has done its bit by extending a line of credit. But the crisis is far too

deep to be tackled by such measures. Still, India has to do everything in its command to restore peace on the island. Such upheaval in a neighboring country cannot be ignored. The Lankan situation also has another lesson for India: That populism comes at a heavy price. The reduction of central taxes in Sri Lanka in 2018 was one such step that drastically reduced the Government revenue prompting rating agencies to downgrade Sri Lanka to near default levels. The country's access to overseas markets was lost, leaving Colombo no option but to dig into its foreign exchange reserves to pay off Government debt. In no time, the foreign reserves came down from \$6.9 billion in 2018 to less than \$1 billion. The ill-conceived decision of the Lankan Government to ban the use of fertilizers in farming also led to a sharp fall in agricultural produce, further deepening the crisis. India and the world need to do everything possible to ensure peace returns to the island nation.

# Common ground

Balanced judiciary-executive ties can help settle contentious issues

he judiciary and the executive appear to be looking for a mutually acceptable method of dealing with issues on which opinions are divided. Such a mindset, if seriously pursued, helps democracy. The immediate case in point is the demand for scrapping Section 124A of the Indian Penal Code, commonly known as the sedition law. The current debate was triggered after the Supreme Court admitted petitions against the controversial section. Chief Justice N V Ramana of the Supreme Court also indicated sim-



ilar views last year when he wondered why the sedition clause was still in use even 75 years after Independence. The section was inserted by the British to quell voices in favour of independence. However, the court did not impose its views on anyone and gave adequate time to the Union government to respond to the petitions. The executive's affidavit said it wanted to consult the civil society for a re-look at the controversial legislation.

The affidavit mentioned the Prime Minister was aware of the divergent views and that he was in favour of protection of civil liberties and respect for human rights. With the judiciary and executive committed to

upholding civil liberties, a level playing field is achieved to deal with the sedition section. Of late, several instances have cropped up that tested the resilience and maturity of these two pillars of democracy. In the case of the Tamil Nadu Governor referring to the President the state cabinet decision the remission plea by AG Perarivalan, convicted in the Rajiv Gandhi assassination case, the Governor's authority to refer it to the President and the Union government's support to the Governor's stand came sharply into question. In another case related to the constitutional validity of the Tribunal Reforms Act, 2021, the Supreme Court asked the government when it had struck down the tribunals' ordinance why were the same provisions revived through a separate legislation. Arguments over criminal appeals pending in various High Courts for decades reached a head when the Attorney General said the apex court through its judgements had entered "into the policy domain". The Prime Minister and the Chief Justice at the recent Chief Minister's conference addressed the contentious issues, underlining the importance of periodically clarifying the roles of the judiciary and the executive to maintain a balance between them. The sedition case will put this balance to test.

# Rising hate crimes in India



What started with lynching is now upgraded to rioting. It is coming of age of a mindset guided by expediency and hatred that is moving in the direction of a pogrom

ecently Nityanand Rai, Minister of State for Home Affairs, informed the Lok Sabha that 3,399 communal riots took place in five years from 2016 to 2020. That is almost two riots a day. It is no mean achievement for any Government to manage two riots a day. For the home media, it may not be newsworthy, but for the western media it is. It is reporting riots in India ardently.

Riots are not new to our country. It saw the worst riot when India became free. Thereafter, it became a recurring phenomenon. The story was the same, almost rerun of the past, two groups, generally religious, clash, loot and kill.

The administration takes its own time to control it and sooner or later restores normalcy. But till properties worth millions of rupees are destroyed and scores are left dead, no one is responsible, no one is guilty. Dead are buried or consigned to flames, and life goes on, burying the riots in yet another statistical figure for posterity. Needless to mention, it happens in most populous areas where people are weak and vul-

So why is the world media crying hoarse about riots now? Why so much hullabaloo about the riots that happened in recent times, especially in Delhi and Uttar Pradesh?

The short answer is "motives". It is not localised in its scope. It is scripted and orchestrated with precision. And of course, it has political dimensions to it. It is correlated to electioneering and translates into electoral gains. 75 years hence the rioting finds a new purpose

While all these years the riots were localised. They did not spread simultaneously in several States. While some parts of the country burned, the rest remained peaceful, even in the aftermath of the Babri Masjid demolition. Or for that matter in Gujarat in 2002.

Let's face it, there has been simmering unease between Hindus and Muslims. But they have coexisted, tolerating each other's differences in their stride. But someone has to provide the that it is an innocuous

spark for fire to ignite. Today they look orches-

trated, timed, and choreographed to achieve a political end. Earlier the perpetrators were generally local leaders abetted by land mafia and petty criminals. They had small goals, grabbing land, wielding power at the local level, and making money. The riots that are taking place now have bigger scope and yield timed to bring in the political

For instance, Ramnavmi processions pass through Muslim areas waving swords, hurling abuses at Muslims. It is no religious celebration but a war cry. As a result, the riots take place in six-seven States simultaneously as its command centre is the same. It is of course facilitated by social media. Hate speech, attacking the lifestyle and cultural ethos, and provoking the other community with abuses and arms. The foot soldiers know

they have impunity; they would not be touched. The excruciatingly slow judicial process would ensure they go

Another point of departure is the aftermath. The administration blatantly punishes the riot victims rather than the perpetrators. After the Ramnavmi processions are gone, bulldozers arrive. The authorities have you believe

encroachment removal drive. But it happens exactly at the same spot in Jahangirpuri where stones were pelted.

The Muslim residents are locked while their shanties are flattened. To make it look even-handed some Hindu houses also bear the brunt. When the media lights are out and bulldozers are gone, both communities pick up their belongings and life again as if it was their destiny.

What started with lynching is now upgraded to rioting. It is coming of age of a mind-set guided by expediency and hatred that is moving in the direction of a pogrom. 75 years on the wheel has come full circle. The idea now is not to kill or grab land by making minorities flee but to instil a sense of insecurity and fear, to teach them a lesson so that they know their place in the country. While the majority gets a sense of one-upmanship, right-wing supremacy touches a new high. The vote harvest replaces the vote banks!

The political scientists Gareth Nellis, Michael Weaver, and Steven Rosenzweig of Yale University made some startling observations in their paper "Do political parties matter for ethnic violence? Evidence from India". They statistically proved that the election of a Congress legislator in State Assemblies significantly reduced the likelihood of riots

there. And that the BJP gains in the aftermath of riots while Congress rule diminishes the probability of riots by as much as 10 per cent.

If the Yale study is right, which has strong data to back it, riots are a sure-fire way for the BJP to win a constituency where Muslims are in majority. The riots and the rightwing BJP are a winsome combination. The majority votes polarise and voters think beyond their Jahangirpuri in Delhi is a point in the case. It has a Muslim majority. The riots in Kishtwar in Jammu and Muzaffarnagar in Uttar Pradesh preceding the general elections in 2014 saw the BJP

Today hijab, halal, meat ban, masjid loudspeakers, Mughal atrocities, and bulldozers are new trending buzz words in political discourse. A divided society seldom prospers and grows. For time being, pressing issues of mismanagement, price rise, and unemployment may be eclipsed by hate mongering but sooner than later they return to haunt the country. Just for reference, our neighbour Sri Lanka did something of this sort to Tamils and today it is fighting for its survival.

### **REDUCE LOGISTICS COST VIA RAILWAY REFORMS**

Corporatise core railway ops for fresh capital, efficiency

he cost of logisticsin India is double or triple than in advanced countries. That makes India lose its export competitiveness and deems it a high-cost economy. This also invites "cost push" inflation mainly due to high dependency on road transport. The share of goods transported by railways has fallen from 86% in 1950-51 to about 29.5% in 2015-16. It might further reduce unless more rail tracks are built. For reducing logistics costs, railways must double its shareof goods trafficand improve efficiency in the next five years. Rail transport is supposed to be cost efficient, energy efficient and eco-friendly compared toroad transport. Its dependency on imported energy is also quite low. However, its potential is not yetfully exploited. Currently, the average speed of goods train is barely 24 kmph due to inadequate tracks and traffic congestion. Goods terminals have poor facilities for loading, unloading and storage; which adds to logistics costs. The railways don't have an integrated model of road and rail transportation and modern storage for small consign-



ments. Hence, dependency on the costlier road transport continues. In the past two decades, the capital investment inrailways has been less than a fifth of funds invested in the road sector. Railways profits are used up in subsidizing passenger fares, leaving a marginal surplus for capital investment. Considering the backlog, Railway needs new investment of about ₹30-40 trillionin the next 5 years. This can't be done with the budgetary sources alone and needs some financial innovations. Noncore activities in Railway must be hived off and rail operations split into six corporates individually dealing rolling stocks (wagons/trains), goods and passenger traffic, all engines (power) and workshops for repairs and maintenance, railway track and bridges, goods terminals and railway stations, and manufacturing plants for rail coaches and engines.

Railways assets, including the land and buildings, be suitably distributed among the six corporates. Such investment value may be treated as the Government's contribution to the corporates as equity or debt and equity. About 10-20% equity may be divested to public through the stock exchange to ensure accountability towards public shareholders. Each corporate can raise funds for meeting its investment needs like any other PSU with the government providing sovereign guarantee. Surplus land and buildings and obsolete equipment and stores in each corporate should also be monetised for raising resources for new investment. However, land for expansion must be preserved. The corporates can bill one another for services sought or rendered. A regulator may be appointed for fixing tariff for goods freight and passenger fares. At an appropriate time private operators may be invited to compete with these PSUs. That will bring in additional investment and technologyand improve efficiency. However, traffic control must remain with a separate authority for monitoring the movement of trains. One of the corporates can develop existing terminals or build new goods terminals with modern handling facilities to improve operational efficiency. Development of warehouses, cold storages attached to goods terminals will reduce the distribution cost and promote goods traffic. The aforesaid strategy will certainly augment ambitious investment, expand capacity and modernize railway that too, without any major budgetary support. Competition among private and PSU corporates shall gradually improve overall operating efficiency besides building capacity. Its impact shall be quite visible on the overall economic growth, logistics costs, inflation and exports. Dependency on the imported fuel shall also dilute. A fast and comfortable rail travel shall partially replace air traffic and promote tourism as well. Besides private sector, States should also join the team. This will indeed generate lot of goodwill for the government becauserailwaysis the most visible infrastructure.

# Defections: Take away the Speaker's powers



For the anti-defection law to be effective, the power to decide on disqualification cases must be vested in an independent authority

n a recent address at Bengaluru, Vice-President Venkaiah Naidu lamented that the anti-defection law had failed to check mass defections and suggested an amendment in the law to stop it. The lamentation and suggestion coming from someone who had been BJP president sounds bold, as several mass defections in the recent years have been engineered by the party. However, Naidu was speaking there not as a BJP man but as Vice-President and his observation does not apply to one party. And indeed, why blame the BJP alone? Given their time, all parties have trampled the anti-defection law under their feet.

The central flaw in the anti-defection law has been the assignment of total authority to the speaker to decide on the petition. All political parties have used the speaker as the weapon to defeat the law. In theory an MLA or MP, after being elected as speaker (presiding officer of the house), ceases to be partisan. In practice they remain partisan. They do the bidding of the top leadership of the party they

Any party leadership usually wants the speaker to sit over the disqualification petition till the term of the house is over. That helps the leadership kill the petition without looking like having done so, because the case is not carried on to a new house. The speaker adroitly follows the party leadership's brief by giving long dates of hearing and stretching on issues of procedure and evidence.

Nobody can question the speaker. The petitioners and the aggrieved political party in opposition have to put up with his naked partiality. Even the judiciary cannot question the speaker, because the law does not allow it to interfere with the case prior to the making of the decision by the speaker. That has allowed the party leaderships to reward the defectors immediately with offices of power and help them enjoy it till the end of the term of

The anti-defection law, referred to as the Tenth Schedule, was added to the Constitution through the Fifty Second (Amendment) Act, 1985. For 35 years since then the speakers colluded with their party leaderships to stretch the proceedings in disqualification cases to defeat the purposes of the law, without the fear of the judiciary intervening to set a time for their decision. However, it changed in early 2020 with Thounaojam Shyamkumar

Thounaojam Shyamkumar Singh was elected as an MLA on a Congress ticket in Manipur in 2017. Immediately after his election he defected to the BJP and was rewarded by the party with a cabinet berth with several portfolios-town planning and forest and environment and horticulture and soil conservation. The Congress party filed a petition in the Manipur High Court seeking directions to the speaker Y. Khemchand to decide the disqualification

The case reached the Supreme Court where a three-judge bench headed by Justice Nariman asked the speaker Y. Khemchand to decide the disqualification petitions within four weeks. This was the first time the court had set a time limit for a speaker's decision. Khemchand did not pass his order in four weeks. He asked for ten more days, and when the ten days passed, he asked for another fifteen days, which the bench did not accept. The bench Thounaojam removed Shyamkumar Singh from the state cabinet and restrained him from entering the Legislative Assembly till

further orders.
Article 212 of the Constitution bars the judiciary from interfering with the proceedings of the legislature. That was the article under which the speakers took protection to enjoy the licence and liberty to

petitions to invoke Article 142, which allows the Supreme Court to pass any order necessary for doing complete justice in any cause or matter. A year or so later the Supreme

Court intervened again to set a time limit for the speaker's decision in the Goa case. In July 2019, ten Congress MLAs and two Maharashtrawadi Gomantak Party MLAs defected to the BJP and were rewarded with ministries and other offices of power. The speaker sat over the disqualification petitions against them for one and half years, until the Congress went to the Supreme Court, which asked the speaker to make his decision by April 20, 2021. The same year the Calcutta High Court set a time for the Speaker of the West Bengal Assembly to decide on the disqualification petition against Mukul Roy who, after being elected on a BJP ticket, had defected to the Trinamool Congress.


The conclusion is obvious. For the anti-defection law to be effective, an amendment has to be made to take away the power of the speaker to decide on disqualification cases. The power must be vested in an independent authority. In the Thounaojam Shyamkumar Singh case the

may seriously consider amending the Constitution to substitute the Speaker of the Lok Sabha and Legislative Assemblies as arbiter of disputes concerning disqualification which arise under the Tenth Schedule with a permanent Tribunal headed by a retired Supreme Court Judge or a retired Chief Justice of a High Court, or some other outside independent mechanism, to ensure that such disputes are decided both swiftly and impartially, thus giving real teeth to the provisions contained in the Tenth Schedule, which are so vital in the proper functioning of our democracy.

An independent authority that decides the case within a reasonable time limit alone can deter political parties and elected representatives from arriving at opportunistic pacts to twist and mangle the mandate of the people. The time limit should be three months. extendable by three more months only on reasonable grounds.

The law should also be amended to deny any defector an office of power during the term of the house. If the defectors would not get anything after they defect why

would they defect? Vice-President Venkaiah Naidu should advise his Government to move amendments in the law to make these changes in order to establish, what he said, the primacy of "character, conduct and caliber" in politics.

# Stalin's year in office: Time to come good on promises

ter M. K. Stalin completed one year in office on May 7. He has emerged out of the shadows of his famous father and late former chief minister M. Karunanidhi. Stalin now has to live up to the voters' expectations, given the fact that he assumed office when Tamil Nadu lacked charismatic leaders.

Secondly, the coffers of the Tami Nadu Government are not in a healthy state. Thirdly, having been out of power for ten years, the Stalin-led DMK had promised the moon to the voters for coming to power. Stalin said after taking oath: "The DMK Government will function so that those who voted for the party will be happy about its performance and those who did not will feel

He has delivered on some promises, such as free busrides for women, medical care, and education for the homeless. More promises in a list of 500 are vet to be met, including the monthly provision of Rs 1,000 to homemakers, and custodial deaths, which have focussed on the law enforce-

ment personnel. Stalin is now confident of acquiring a national profile.



Apart from the electoral success, the DMK strengthened its position by winning the urban polls in a big way three months ago. DMK has dabbled in national politics and participated in the National Front, Ûnited Front, NDA, and UPA Governments. So, there is nothing wrong with Stalin's

Secondly, having emerged as a good negotiator in alliance politics at the state level, he aims to take it to the national level. He could bring together 12 parties, including the Communist parties and the Congress in the state. He would like to play a role in elections in 2024 and be a galvanizing force among non-BJP parties, some of whom do not see eye to eye with

Congress Thirdly, Stalin is playing an aggressive role in promoting the ideas of federalism and

Social Justice to "achieve principles of social justice and federalism at the national level". Fourthly, Stalin used the emotional issue of language and encouraged the anti-Hindi

imposition sentiments. Fifthly and more importantly, Stalin has shown his initiative on the foreign policy front vis a vis Sri Lanka, which faces an unprecedented political and economic crisis. Stalin has not only met Modi offering to help the Sri Lankan Tamils but also expressed concern about the refugee inflow. Tamil Nadu has always wanted a say in the Sri Lankan policy, and the Centre often went along with the sentiments of

Tamil Nadu political parties. Stalin recently got a unanimous resolution passed in

the Assembly and has appealed to the public to make voluntary donations to the Sri Lankan cause. As chief of the DMK, he announced an Rs crore donation. He announced that the Tamil Nadu government would soon be sending 40,000 tonnes of rice, 500 tons of milk powder, and lifesaving drugs in the first phase to the neighbouring country.

Sixthly, Stalin recently inaugurated the DMK office in Delhi as part of his national ambition. "For me, all state parties opposing BJP should join hands with Congress and the Left to form a team against

BJP," he said. Seventhly, to enhance his growing national stature, he mobilised a galaxy of non-BJP leaders for his book release on February 28. They included

Sonia Gandhi, Rahul Gandhi, Farooq Abdullah, Tejaswi Yadav, Uddhav Thackeray, among others. Stalin launched a struggle

against the Centre on many issues. He has been networking with chief ministers to press the Centre to share a more significant share of Goods and Services Tax. The resolution against the NEET selection measures to bring back education on the state list, and reservations in medical education, are some of the

# Lanka crisis: Def Ministry orders tri-forces to open fire on rioters

Sri Lanka's Ministry of Defence on Tuesday ordered the Army, the Air Force and the Navy personnel to open fire on anyone looting public property or causing harm to others amidst violent protests in the island nation over the unprecedented economic crisis.

The order came after embattled President Gotabaya Rajapaksa urged people to stop "violence and acts of revenge" against fellow citizens and vowed to address the polit-

ical and economic crisis facing the nation. The death toll rose to eight in the unprecedented violence that erupted after supporters of then prime minister Mahinda Rajapaksa attacked anti-government protesters here on Monday.

Though Mahinda Rajapaksa, 76, has quit as prime minister, this has failed to bring calm.

Nearly 250 people have been injured in the violence in Colombo and other parts of the country. The Ministry of Defence has ordered the triforces to open fire on anyone

looting public property or harm to others, the Daily Mirror newspaper quoted the Army Spokesman as saying. A curfew is in force across the island nation after mobs burned down the ancestral home belonging to the ruling Rajapaksa family amid

#### FIA officer investigating high-profile corruption cases against Pak PM Sharif and others dies of heart attack

one of the leaders accused plotting Moise's assassination. The source said Joseph paid cash for rental cars that suspects used and met with them ahead of killing. Joseph is one of more than 40 suspects arrested in presidential slaying, and third one to be extradited to US to face charges as proceedings in Haiti languish, with at least two judges stepping

# China patriots firmly in charge

Hong Kong leader Carrie Lam said Chinese patriots are now firmly in charge of the city following the election of its new leader, who ran unopposed in a process controlled by Beijing.

Lam's comments came a day after a carefully vetted election committee voted overwhelmingly to approve John Lee, a hard-line security chief who oversaw a crackdown on Hong Kong's pro-democracy movement after massive protests turned violent in 2019.

The protests led to the imposition by Beijing of a sweeping National Security Law and the reorganisation of the city's legislature. Political opponents were subsequently

# Russia pounds Ukraine's vital port of Odesa, Mariupol plant

 $R^{ussian}$  forces pounded away at the vital port of Odesa, Ukrainian officials said Tuesday, as part of an apparent effort to disrupt supply lines and weapons shipments.

On the other end of the southern coast, they hammered a steel plant where Ukrainian fighters are denying Moscow full control of another critical port.

Days after the dramatic rescue of what some officials said were the last civilians trapped at the plant in Mariupol, authorities said about 100 were still believed to be in the network of underground tunnels under bombardment. The strikes come as the grisly toll of the war continued to take shape, with the Ukrainians saying they found the bodies of 44 civilians in the rubble of a building in the northeast that was destroyed weeks ago.

The Ukrainian military said Tuesday that Russian forces fired seven missiles a day earlier from the air at the crucial Black Sea port of Odesa, hitting a shopping center and a warehouse. One person was killed and five were wounded, the military said.

Washington sought to portray a united front against Russia's invasion of Ukraine as President Joe Biden signed a bipartisan measure to reboot the World War II-era "lend-lease' programme, which helped defeat Nazi Germany, to bolster Kyiv and Eastern European allies. The signing Monday came as the U.S. Congress is poised to unleash billions more to fight the war against Russia with Democrats preparing \$40 billion in military and humanitarian aid, larger than the \$33 billion package Biden has requested.

It all serves as a rejoinder to Russian President Vladimir Putin, who has seized on Victory in Europe Day - the anniversary of Germany's unconditional surrender in 1945 and Russia's biggest patriotic holiday - to rally his people behind the invasion. "This aid has been critical to

Ukraine's success on the battlefield," Biden said in a statement.

Biden said it was urgent that Congress approve the next Ukraine assistance package to avoid any interruption in military supplies being sent to help fight the war, with a crucial deadline coming in 10 days.

"We cannot allow our shipments of assistance to stop while we await further Congressional action," he said. He urged Congress to act - and "to do so quickly."

on Tuesday said the country's coal output rose 29 per cent to 66.58 million tonnes (MT) in

This comes at a time when the country is witnessing a power crisis on account of various factors, including shortages of the dry fuel.

The country's coal output in April 2021 stood at 51.62 MT, as per provisional statistics of the Ministry of Coal.

The ministry in a statement said dispatch of coal to power utilities grew 18.15 per cent to 61.81 MT during April 2022, compared to 52.32 MT in April 2020.

Of the top 37 coal producing mines, 22 have performed more than 100 per cent while the production from another 10 mines stood between 80 and

The ministry further said decline in the prices of imported coal has been observed since the end of October last year. However, international prices are still at a high level. The coal ministry had ear-

crisis is mainly on account of sharp decline in electricity generation from different fuel sources and not due to nonavailability of domestic coal. In an interview to PTI,

Coal Secretary A K Jain had attributed the low coal stocks at power plants to several factors such as heightened power

demand due to the boom in the economy post pandemic, early arrival of summer, rise in price of gas and imported coal and sharp fall in electricity generation by coastal thermal power

He had added that a slew of measures are already underway to enhance total power supply in the country.

LIC commands the largest market share of 65.31 per cent, while the rest of the 23 private players have the remaining 34.69 per cent. The rest of the private sec-

tor players witnessed over 27 per cent jump in their combined new business premium at Rs 6,223 crore. Their collective first year premium was Rs

# Life insurers log 84% | Equity MFs see ₹15,890 cr inflow in April amid volatile stock market

New Delhi: Sustaining positive momentum for the 14th straight month, equity mutual funds attracted a net sum of Rs 15,890 crore in April amid heightened volatility in stock market and consistent selling by foreign portfolio investors.

This was much lower

compared to a record net inflow of Rs 28,463 crore seen in the preceding month, data from the Association of Mutual Funds in India (AMFI) showed on Tuesday.

The lower quantum of net inflow from the previous month could be attributed to investors going slightly cautious given the ongoing challenges to the investment environment, Himanshu Srivastava, Associate Director - Manager Research, Morningstar India, said.

Akhil Chaturvedi, Chief Business Officer, Motilal Oswal AMC, said that it will be interesting to see ongoing investment trends, given the intensity of volatility being very high, and expect positive trend to continue going forward though.

Equity schemes have been witnessing net inflow since March 2021, after the second wave of COVID-19 resulted in the correction in the markets, highlighting the positive sentiment among investors.
Prior to this, such schemes

had consistently witnessed out-flows for eight months from July 2020 to February 2021, los-ing Rs 46,791 crore.

All the equity-oriented categories received net inflows in April with sectoral/ thematic funds category being the biggest beneficiary with a net inflow of Rs 3,843 crore. The segment also saw a launch of a new fund -- ICICI Prudential Housing Opportunities Fund, which mobilised Rs 3,130 core.

This was followed by largeand mid-cap fund and that witnessed over Rs 2,000 crore net

"Despite volatility in markets and fear around macros both globally and locally, it is good trend to see continued positive flows in equities. Though lower than last month, which may be due to NFO allotment, SIP flows are holding strong, which is also very positive," Chaturvedi said.

Monthly SIP (Systematic Investment Plan) contribution dropped to Rs 11,863 crore in April compared to Rs 12,328 crore in March.

However, the number of SIP accounts stood at all-time high in April at 5.39 crore. During the month under review, 11.29 lakh SIP accounts were added. Apart from equities, the debt segment saw a net inflow of Rs 69,883 crore in April after witnessing a net outflow of Rs 1.5 lakh crore in the preceding month.

Also, gold exchange traded funds experienced a net inflow of Rs 1,100 crore in the month under review.

Overall, the mutual fund industry registered a net inflow of Rs 72,846 crore last month as compared to a net withdrawal of Rs 69,883 crore in March. "It has been a good start to new fiscal (FY23) with net flows for overall mutual funds schemes in the positive

The revised interest rates on bulk term deposits amounting to Rs 2 crore and above are effective from Tuesday, the bank said. While interest rate on

deposits maturing between 7 days and 45 days has been kept unchanged at 3 per cent, those maturing between 46 and 179 days will now attract an interest rate of 3.50 per cent as against 3 per cent earlier. The public sector lender

also revised interest rate on bulk term deposits maturing between 180 and 210 days by 40 basis points to 3.50 per cent, as against 3.10 per cent earlier, as per the bank's website. Deposits maturing

between 211 days and less than 1 year will earn an interest of 3.75 per cent, up 45 bps



The interest rate on bulk deposits having maturities between 1 year and less than two years has been increased by 40 bps to 4 per cent. For deposits having 2 years to less than 3 years maturity period, the rate has been hiked by 65 bps to 4.25 per cent.

The interest rate on bulk term deposits for 3 years and up to 10 years has been increased by 90 basis points to 4.50 per cent as against 3.60 per

Last week, Punjab National Bank said had increased interest rates on term deposits in selected buckets up to 60 basis points from May 7. The new fixed deposit rates are applicable on deposits up to Rs 10 crore, PNB said. PTI

CEPI will fund the initiative under its USD 200 million programme to advance the development of vaccines that provide broad protection against SARS-Cov-2 variants and other betacorona viruses

The funding will support the consortium as it seeks to establish preclinical and clinical proof of concept for an adjuvanted subunit vaccine designed to provide broad protection against all known SARS-CoV-2 variants of concern, as well as future variants of the virus which have not yet

CEPI will fund the researchers to conduct activities including immunogen design, preclinical studies, manufacturing process development and a Phase 1 clinical

'As repeated waves of COVID-19 infection remind us, we will be living alongside the virus for many years to come. The threat of a new variant emerging that might evade the protection of our current vaccines is real, so investing in R&D for variant-proof SARS-CoV-2 vaccines is a global health security imperative," CEPI CEO Richard Hatchett

He further said: "Our partnership with Bharat Biotech, University of Sydney and ExcellGene will advance the development of a vaccine candidate to protect against future variants of COVID-19, potentially contributing to the long-term control of the virus." *PTI*

"As there is a huge

untapped market, we will explore both organic as well as inorganic opportunities. The funds will only give us further impetus to our growth momentum. Further fund infusion will be decided based on the future opportunities,' Neralla said.

With the new funds, the company is looking to foray into newer segments such as Bharat Bill Payment Operating Unit. Neralla said the company will apply for Bharat Bill Payment Operating Unit permit this year.

### Hospitality industry body seeks regulation on travel food aggregators

New Delhi: Hospitality industry body FHRAI has sought intervention of the parliamentary standing committee on finance for regulation of online travel and food aggregators, alleging anti-competitive practices by the tech platforms.

In a letter to the parliamentary standing committee on finance chairman Jayant Sinha, FHRAI said a handful of Online Travel Aggregators (OTAs) as well as Food Service Aggregators (FSAs) have created havoc.

The parliamentary panel is examining alleged illegal practices of big tech players and technology platforms that could adversely impact competition in the Indian market.

The primary reason for the intervention of the committee is enormous public interest /consumer interest in this matter. The customers face continuous problems of nonfulfilment of prior commitments coupled with almost zero complaint redressal mech-

anism from the OTAs and FSAs," Federation of Hotel & Restaurant Associations of India (FHRAI) vice president Gurbaxish Singh Koĥli wrote.

He further said, "Due to plundering of business interests of lakhs of hotels and restaurants in the country, it is imperative to ensure a protective mechanism in the face of predatory pricing and anticompetitive tactics adopted by OTAs and FSAs.'

It is also a matter of concern that through international funding the FSAs and OTAs used to garner customers or divert them to their forum, Kohli added.

According to FHRAI, the common problems from FSAs and OTAs arise from their inability to service customers.

"At times, the OTAs and FSAs show on their platforms that the restaurants are not operating and rooms are sold out, but in fact, they are unable to service their customers thereby causing great trouble to both the customer and the service provider," it said.

Alleging hidden charges levied by OTAs and FSAs, the hospitality industry body said these platforms "often indulge in double dipping by inflating charges payable by consumers through levies raised under different names and pretexts, and which consumers are often confused to think that the same is levied by hotels and restaurants.

These charges include convenience fees, service and packaging charges which are not levied by the business, delivery charges, transaction fees to offset credit card commission, tips which are supposed to be paid to delivery persons, and donations collected for different charities.

"None of these charges are levied by the hotel or the restaurant and the consumers are made to believe that the charges are levied by the hospitality industry," it pointed

#### **BoB hikes** lending rate by up to 10 bps

The bank has hiked the marginal cost of funds based lending rate (MCLR) by up to 0.1 per cent on various tenures effective May 12, BoB said in a

regulatory filing.
The 1-year MCLR -- the rate to which a majority of consumer loans are linked -- has been revised to 7.40 per cent from 7.35 per cent, an increase

of 5 basis points. Similarly, MCLR for threemonth and six-month tenures has been increased by 5 basis points to 7.15 per cent and 7.25

respectively. At the lower end, overnight and one-month MCLR has been raised by 10 basis points to 6.60 per cent and 7.05 per cent, respectively.

Shastri feels what sets Rusell, one the most destructive batters in T20 cricket, apart from the other is the clarity of mindest, which will also serve Pant, who is capable of playing belligerent knocks, well.

"Russell is very, very clear in his mindset. It

is bang-bang once he's in the mood. There's no stopping him, there's not even a negative thought that will peep through his system - it is (all about) smacking.

"Rishabh is totally capable of playing in that fashion, and I hope he thinks in that way because you'll see some special innings from him in T20 "He's getting off to starts and then getting out

a manner which he wouldn't like, but I don't think he should change his tempo," added

### Cricket SA withdraws racism charges against coach Mark Boucher

ricket South Africa announced on Tuesday that all charges against head coach Mark Boucher have been withdrawn, leading to the abandonment of a disciplinary hearing which was due to start on May 16.

The 45-year-old former Test wicketkeeper was facing charges of racism, laid by CSA, which could have resulted in his dismissal.

The controlling body admitted in a statement that there was "no basis to sustain any of the disciplinary charges".

The allegations against Boucher followed Social Justice and Networking hearings last year into discrimination into

Boucher was accused by former teammate Paul Adams of leading a song with racially derogatory words during fines meetings after matches while they were playing.

Adams announced on Sunday that he was not prepared to testify at the hearing, stating his comments to the SJN ombudsman related to the overall culture of the team rather than any particular player. CSA noted in its statement that Boucher had apologised to Adams and the apology had been accepted.

It was also alleged that Boucher had sidelined his black assistant coach Enoch Nkwe, leading to Nkwe's resignation, but Nkwe was also unwilling to testify at the planned hearings.



A further charge was that Boucher had failed to deal effectively with a controversy over "taking the knee" in solidarity with the Black Lives Aatter movement.

CSA said its lawyers had consulted with other potential witnesses and concluded that none of the three charges were sustainable

The recent exoneration of director of cricket Graeme Smith, who like Boucher had been the subject of "tentative findings" by SJN ombudsman, Advocate Dumisa Ntsebeza, fortified the conclusion that the charges against Mr Boucher would be dismissed."

Board chairman Lawson Naidoo said CSA had been committed to treating issues raised at the SJN hearings "with utmost seriousness" with a view to ensuring fairness. "The decision to withdraw

the charges brings about finality on these issues for CSA and Mark and allows the focus to return to the cricket field." Boucher is contracted until the end of the 2023 Cricket World Cup.


