SC puts sedition law on hold; no FIR till 'relook'

In a major victory for right activists and civil society crusaders, the Supreme Court on Wednesday put on hold the 152-year-old colonial sedition law till an "appropriate" Government forum re-examines it and directed the Centre and States to not register any fresh FIR invoking the offence

Overruling the Centre's stand on the status of law dur ing the interregnum, a bench headed by Chief Justice NV Ramana also ordered that all ongoing probes, pending trials and proceedings under the sedition law across the country be kept in abeyance. The persons currently facing the sedition charges can approach the courts for bail, said the apex

Taking note of the concerns of the Centre, the apex court said the "rigours of Section 124A (sedition) of the IPC is not in tune with the current social milieu" and permitted reconsideration of the

provision.
"We expect that, till the reexamination of the provision is complete, it will be appropriate not to continue the usage of the aforesaid provision of law by the Governments," said the bench, also comprising Justices

- A 21-year-old Bengalurubased environment activist, Disha Ravi, was arrested by the Delhi Police on February 14, 2021 for creating and disseminating a "toolkit" against farm laws.

Any affected party is at liberty to approach concerned courts. which are requested to examine the reliefs sought taking into the consideration the present order, the apex court said.

'This court is cognizant of the security interests and integrity of the State on one hand, and the civil liberties of citizens on the other. There is a requirement to balance both sets of considerations, which is a difficult exercise. The case of the petitioners is that this provision of law... pre-dates the Constitution itself, and is being misused...," said the Bench, listing the matter in the third week of July.

The order referred to the Centre's affidavit, which accepted there were divergent views on the law and had also quoted Prime Minister Narendra Modi's views about protection of civil liberties and respect for human rights. "In view of the above, it is clear that the Union of India agrees with the prima facie opinion expressed by this Court... In light of the same, the Union of India may reconsider the aforesaid provision of law," it said.

The order said the interim stay granted to some petitioners by the apex court would continue to operate. "All pending trials, appeals and proOngoing probes, trials in courts on hold till Govt re-examines Act, says apex court

ceedings with respect to the charge framed under Section 124A of IPC be kept in abeyance. Adjudication with respect to other Sections, if any, could proceed if the courts are of the opinion that no prejudice would be caused to the

accused," said the SC. If any fresh case is registered, the affected parties are at liberty to approach the courts and the courts are requested to examine it, taking into account the present order passed as well as the clear stand taken by the Centre, it said.

The bench did not agree with the Centre's suggestion that a superintendent of police rank be made responsible for monitoring the registration of FIRs for the offence of sedition. Solicitor General Tushar Mehta, appearing for the Centre, had also said the registration of FIRs on the matter cannot be prevented as the provision dealt with a cognisable offence and was upheld by a Constitution bench in 1962.

With regard to pending sedition cases, the Centre suggested that hearing on bail pleas in such matters may be expedited as the Government did not know the gravity of the offence in all the cases and they may have terror or money laundering angles.

Delhi HC split on marital rape crime

Both judges allow parties to move SC

The Delhi High Court on Wednesday delivered a split verdict on the issue of criminalisation of marital rape with one of the judges favouring striking down the provision, the other holding it was not unconstitutional. The division bench granted leave to the parties to file an appeal before the Supreme Court.

While Justice Rajiv Shakdher, who headed the division bench, favoured striking down the marital rape exception, Justice C Hari Shankar said the exception under the IPC is not unconstitutional and was based on an intelligible differentia. The petitioners had challenged the constitutionality of the marital rape exception under Section 375 IPC (rape) on the ground that it discriminated against married women who are sexually assaulted by their husbands. Under the exception given in Section 375 of the IPC, sexual intercourse by a man with his wife, the wife not being

minor, is not rape. While delivering the verdict, Justice Shakdher said "as far as I am concerned, the impugned provisions — exception 2 to section 375 (IPC) ...

are violative of Articles 14 (Equality before law), 15 (prohibition of discrimination on grounds of religion, race, caste, sex or place of birth), 19(1) (A) (right to freedom of speech and expression) and 21 (right to life and personal liberty) of the Constitution and are hence struck down." He said this declaration will operate from the date of its pronouncement.

However, Justice Shankar said, "I have not been able to agree with my learned brother' and added that these provisions do not violate Articles 14, 19 (1) (A), and 21 of the Constitution

He said the courts cannot substitute their subjective value judgment for the view of the democratically elected legislature and the exception is based on an intelligible differentia. He said the challenge to the provisions by the petitioners cannot sustain.

The court's verdict came on PILs filed by NGOs RIT Foundation, All India Democratic Women's Association, a man and a woman seeking striking down of the exception granted to husbands under the Indian rape law. In its 2017 affidavit, the Centre had opposed the pleas, saying that marital rape cannot be made a criminal offence as it could become a phenomenon that may destabilise the institution of marriage and an easy

tool for harassing husbands. However, the Centre told the court in January that it was "re-looking" at its earlier stand on the petitions as that was brought on record in the affidavit filed several years ago. In February, the Centre had urged the court to grant more time to enable it to State its stand on the issue after a consultative

In a surprise move, Uttar Pradesh police chief Mukul Goel was on Wednesday shunted out from his post for neglecting his duties and not taking interest in work.


Goel, who assumed the charge as the UP's Director-General of Police (DGP) in as DG, Civil Defence.

Rlys removes, forces 20 top officers to retire

DEEPAK KUMAR JHA ■ NEW DELHI

In an unprecedented step, the Indian Railways on Wednesday removed from service 20 top class one officials, including eight joint secretary level officers, and top electrical and mechanical engineers. With this, around 100 top

level officers have either been dismissed or forced to opt for Voluntary Retirement Services (VRS) in the last 10 months. They include three secretary rank level officers. While a general manager rank officer was 'advised' to opt

for VRS to make an honourable exit from the services on Tuesday, the largest employer of the country dismissed 20 officers who had adverse vigi lance reports against them.

The railways invoked rule 56(J) of the Department of

Personnel and Training service

rules which says a Government

employee can be forced to retire or be dismissed after being served a minimum of three month's notice or a simperiod's pay.

The move is part of the Union Government's efforts to weed out non-performers. Railway Minister Ashwini Vaishnaw, after he took over the office in July 2021, has repeatedly warned officials "to take VRS and sit at home" if they do not perform.

Railway Ministry sources said the 20 people against whom the 56(J) were invoked include four officials each from the electrical and signalling services, three each from medical and civil, two from personnel and one each from stores, traffic and mechanical.

Under the VRS scheme, an employee is paid a salary equivalent to two months' pay for

every year of service left.

Claims 55% of families had one or more members down with one or more symptoms in April-May

study by an online health Applatform claimed that 55 per cent of the families residing in Delhi and its neighbouring cities have had "one or more members" down with one or more Covid-like symptoms in April and Mav.

The LocalCircles recently conducted a survey and sought responses from residents in Delhi-NCR to a prepared questionnaire.

According to the statement issued by LocalCirlces, one of questions is: "When you or someone else in the family was unwell in April or May, (with symptoms like fever, sore throat or cough, cold or

congestion, fatigue or body ache, stomach ache, diarrhea, nausea, breathing difficulties, uneasiness, etc.), did you/they take any type of Covid-19 test?" In response, the majority, 66 per cent of the residents said, "No". Only 22 per cent said, "Yes, once", and another 12 per cent said, "Yes, multiple times."

"This means, of Delhi-

NCR families that had one or more members exhibiting Covid-like symptoms in April-May, two in three did not take Covid test. This question in survey received 11,235 responses," the statement read.

The survey also found that of the people who were getting tested, 42 per cent of them were opting only for Rapid Antigen Test, it said in a state-

Marital rape is a reality and it is high time action

is taken against it, says DCW chief Maliwal

erming the Delhi High on the issue of criminalisation of marital rape "disappointing", some women activists here expressed hope that Supreme Court will exercise "much more wisdom" in matter, saying current provisions are discriminatory against one category of rape victims.

Following verdict, the Delhi Commission for Women (DCW) chief Swati Maliwal said that marital rape is a reality and it is high time that action was taken against it. "Don't know how many more years we will have to wait to change a British era law! Marital rape is a reality and it's high time we take strongest action against it!" she tweeted. Noting that HC has "simply passed buck" to the Supreme Court in matter, All India Progressive Women's Association member Kavita Krishnan said: "The verdict by High Court is very disappointing and upsetting. "The legal issue is very

clear and it is discriminatory against one category of rape victims -wives. I hope that Supreme Court will show courage and clarity needed for removing this shameful law."

The Delhi High Court delivered a split verdict on issue of criminalisation of marital rape with one of judges favouring striking down the provision, and other holding it was not unconstitutional. The Division Bench granted leave to the parties to file an appeal before Supreme Court. Vani Subramanian, a member of women's group Saheli Trust, questioned that if domestic violence is a crime, then how

is it that marital rape not a crime. She also pointed out that just because a woman got married, does not mean that she has given consent once and for "It is a very sad day. If this

(marital rape) has happened, we need to acknowledge it, we cannot only consider the cases where it is very brutal. A woman's consent is central to this and the idea of equality, of bodily integrity. There needs to be some

clarity on violence, that violence is violence wherever it happened. This is also a part of domestic violence. So domestic violence is a crime so how come rape is not a crime. I hope the Supreme Court will exercise much more wisdom, Subramanian said. Meanwhile, anti-rape activist Yogita Bhavana is content that at least a discussion around marital rape has begun. She believes as the matter has been referred to

a Bench of the Supreme Court,

there will be a robust discussion

on the matter."I am happy that it has been referred to Supreme Court Bench because now the order will be unbiased. The discourse around the matter has started. One year ago, people were not even talking about this. Now they have started discussing it," she said.

The petitioners had challenged the constitutionality of the marital rape exception under Section 375 IPC (rape) on the grounds that it discriminated against married women who are sexually assaulted by their husbands.

Under the exception given in Section 375 of the IPC, sexual intercourse or sexual acts by a man with his wife, the wife not being minor, is not rape.

While Justice Rajiv Shakdher, who headed the Division Bench, favoured striking down the marital rape exception, Justice C Hari Shankar said the exception under the IPC is not unconstitutional and was based on an intelligible differentia.

3-day Chintan Shivir of Cong to focus on time-bound restructuring of party

The three-day brainstorming L conclave of the Congress is likely to focus on time-bound party restructuring for strengthening the organisation to take on the might of BJP and Prime Minister Narendra Modi in the general elections of 2024. Party sources said leaders are to discuss solutions on key issues including polarisation, Centre-state ties, forming of alliances and attempts at bringing in "uniformity", especially in the Northeast, that are confronting the country and the party.

Former Union Minister Sachin Pilot said ground-level feedback from youth leaders will be important in preparing the Congress' strategy. Youths have been prioritised by the party for its Nav Chintan Shivir with nearly half of the delegates being under the age of 40, said Pilot, the former Rajasthan deputy chief minister.

He also said the session will reenergise the Congress and the organisational changes will be done after the Chintan Shivir. "The Nav Sankalp Chintan Shivir in Udaipur will prove to be very important in deciding the future strategy, Pilot told reporters at Jaipur.

The party is holding the

Chintan Shivir at Udaipur in Rajasthan from May 13 to 15 after a gap of almost nine years while facing "an unprecedented crisis" as it remains in power on its own in just two states and has less than 100 members in both Lok Sabha and Rajya

Unlike in the past, when Chintan Shivirs did not set any set timelines, the Udaipur declaration will state time-bound initiation and accomplishing of structural changes in the organisation at all levels. "We have to make changes which are meaningful and not merely cosmetic" in order to revamp the party, a senior leader said ahead of the session.

The last such conclave was held in Jaipur in 2013 when the Congress-led UPA was in power. It focussed on the elevation of Rahul Gandhi as vice president of the party. The earlier 'shivirs' were held in Pachmarhi in 1998 and Shimla in 2003. While stressing the importance of alignment of non-BJP forces, Congress leaders on Wednesday said the party would need to be internally strengthened first to gain a pole position in the event of an opposition understanding for the 2024 general elections.

They noted that no opposition alliance could be viable without the Congress. "But the Congress needs to revive and rebuild to gain a place of prominence at the centre of any potential anti-BJP alliance, said a senior leader.

"There will also be a discussion on what should be the Congress stand on alliances, he said, adding that the party would also delve into the growth of some regional parties like the TMC, AAP, YSRCP

and the TRS. The leader specified that the party is clear that it cannot have a tie-up with the TRS and AAP and that has already been made clear. The party will focus on issues of polarisation, center-state relations, the situation in Jammu and Kashmir, economic downturn, disinvestment of PSUs, MSP, social inequities and problems facing the youth. The conclave will begin with introductory remarks of Congress President Sonia Gandhi on May 13 and a valedictory address by Rahul

India, Uzbekistan review bilateral ties during 15th FoC

The talks particularly focused on greater economic cooperation and steps to enhance connectivity between India and Uzbekistan. Both sides agreed to exploit the full potential of Chabahar port for trade between the two countries, the ministry of external affairs said in a statement.

The two sides exchanged



views on regional and international issues of mutual interest, including Afghanistan. They agreed to further enhance cooperation in the UN, SCO

and other multilateral fora. Indian side conveyed its full support for Uzbekistan's ongoing chairmanship of the Shanghai Co-operation Co-operation

Organisation(SCO). Both sides assessed the holding of the 1st India-Central Asia Summit in January 2022 and agreed to expeditiously implement its outcomes along-with other Central Asian countries.

The talks were held in the traditional spirit of friendship and understanding.

The FoC was useful in taking stock of the implementation of decisions taken during high-level meetings held in the last two years, including the Virtual Summit in December 2020. Both sides agreed to hold the next round of consultations on a mutually conve-

Leaders of a number of countries are expected to participate in the summit. The summit will also be attended by heads of state/government of Belize in its capacity as Chair of CARICOM, Senegal as Chair of African Union, Indonesia as President of G20 and Germany as President of G7 respectively.

Secretary-General of the United Nations, Director General of World Health Organization and other dignitaries would also participate.

CBI arrests 14 persons in case related to FCRA division officials taking bribes from NGOs

The CBI has arrested 14 accused persons, including six public servants and has recovered cash of Rs 3.21 crore, several incriminating documents and mobile phones during countrywide searches at the premises of accused at around 40 locations including in Delhi, Haryana, Rajasthan, Jharkhand, Himachal Pradesh, Telangana, Andhra Pradesh, Tamil Nadu,

A case was registered on Tuesday against 36 accused including seven public servants of FCRA Division of the Union Home Ministry National Informatics Centre (NIC) and middlemen besides representatives of various NGOs. They were booked on the allegations that some officials of FCRA

Division, in conspiracy with the promoters/ representatives of different NGOs, middlemen, were indulging in corrupt activities for getting backdoor FCRA registration/ renewal to NGOs illegally with an object to continue receiving donations despite not fulfilling the prescribed norms, the CBI said in a statement.

"It was further alleged that some public servants were impersonating themselves as Division and were indulging in said practices and obtaining bribe from NGOs for facilitating them for their registration/ renewal of registration under FCRA and for other FCRA related works," it said.

During investigation, two accused were caught while delivering and accepting the

bribe amount of Rs 4 lakh on behalf of a Senior Accountant of MHA, New Delhi. It was alleged that the delivery of bribe was done through a hawala operator and a close associate of said public servant, at Avadi (Tamil Nadu), the agency said.

The arrested accused are being produced before the Competent Court and further investigation is continuing.

Didi slams BJP on price rise; nephew attacks Congress

Abhishek Banerjee berates Grand Old Party for failure to be effective Opp

 \mathbf{I}^{n} presumably tactical move the Trinamool Congress on Wednesday trained its guns both at the BJP and the Congress with Bengal Chief Minister Mamata Banerjee attacking the Centre for stoking an oppressive price regime and her nephew and TMC general secretary targeting the Congress for failing to make a viable opposition against a "saffron tyranny."

While Banerjee attacked the Centre for tormenting the people of the country by "extorting the people through tel (fuel) and toll" her nephew picked on Congress leader Rahul Gandhi for resorting to Twitter war instead of fighting the battle against the BJP on the

"They (BJP Government) has increased the price of 800 medicines," Banerjee said adding, "the price of tel and toll (toll tax) is going up by the day whereas the (political) courtesy is getting devalued." The TMC earlier said that in a country where the essential items were getting dearer by the day the government was raising prices of medicine and giving tax cut to movies. The Chief Minister said that the Centre had no sympathy for the common people who are suffering greatly due to the rising prices.

"At a time the country is suffering from unprecedented inflation this Government is minting money at the cost of the common people by hiking the price of tel (fuel) and toll (increasing toll taxes)," she said adding no humane government would have increased the price of essential medicines the way the BJP Government did. The Chief Minister had earlier urged the Centre to suspend the toll tax for a while and put a cap on the rising fuel prices. While the Chief Minister attacked the Centre her nephew and Diamond

Harbour MP concentrated on the Congress even as he went to Guwahati to inaugurate the TMC's State party office.

Saying that the Congress party had failed to live up to the expectations of the people junior Banerjee whose outfit has an eye on the massive Bengali vote bank in Assam said without naming the Congress leader, "though we have come out of the Congress like many other party have but the big difference between the Congress and the TMC is that we have not confined ourselves to the twitter war only ... if we have to raise our voices against fuel price hike we descending on the street because Twitter does not win

For winning battles "you have to take it to the streets, get beaten up by the powers that be ... you cannot win wars without taking part in it," he added saying the difference between his party and the Congress was

that "in the past 8 years we have always defeated BJP whereas the BJP has always defeated the Congress ... this raises our credibility level ... we are not afraid of anything ... that is what Mamata Banerjee has

taught us." Saying that his party would establish itself in at least 10 States of the country the Diamond Harbour MP said that his party would contest polls and win in Meghalaya and Tripura. "We will go all out in Assam and if we can win even 10 seats here then we will make the BJP's seat of power in the Centre tremble.'

Reacting to his statements Congress Lok Sabha leader Adhir Chowdhury said that the TMC was in fact acting like the BJP's B team by helping it in States where the Congress was stronger — by cutting its votes.

"Remember what the TMC did in Goa ... it is trying to do the same in Assam as the agent of the BJP," he said.

Those travelling abroad may be allowed to get the Covid-19 precaution jab before the stipulated nine-month waiting period as required by the destination country, according to sources in the Union Ministry

An official announcement, nowever, is yet to be made by the Ministry, according to a news agency.

Sources said the decision to relax the norms about the precaution dose for overseas travellers was based on recommendations by the National Technical Advisory Group on Immunisation (NTAGI).

The advisory panel had recommended that those who need to travel overseas can take the precaution dose of Covid vaccine as required by the country they are travelling to before the mandatory ninemonth gap.

As of now, all those above 18 years who have completed nine months after the second dose are eligible for the precautionary jab.





A welcome step

There was a need to balance the interest of citizens with that of the state

The Supreme Court's decision to put on hold the much-abused sedition law is a welcome step. It goes a long way in assuring the people that the top court of the country is keeping its eyes and ears open and doing everything within its jurisdiction to prevent the state from trampling on the right of a citizen. The SC must be complimented for allowing the centre time to re-examine and reconsider the law with a rider that in the interval the colonial law will be kept in abeyance. Rejecting the Centre's argument that several accused under the sedition law may be involved in terror and money laundering cases, the SC also gave relief to those rotting in jails under the law and said they can approach courts for bail. The Centre looked desperate to cling to the law when it told the Court that cases under Section 124A of the Indian Penal Code (IPC) cases under sedition law be registered only when the area Superintendent of Police spelled out the reason in writing. The centre contended that it was not right to prevent the registration of a cognizable offense and a responsible officer should be there for scrutiny for filing of cases under the sedition law. The court did not agree with this view and altogether put the law in abeyance. It is



been booked under the draconian law for exposing cases of corruption and crime against powerful politicians. Similarly, filmmakers, poets, and political activists have also been accused of committing offence against the state under the seduction law and booked for waging or attempting to wage war or abetting waging of war against the Government (Section

121 of the IPC), conspiracy to commit offences punishable by Section 121 (Section 121A) and collecting arms to wage war against the government (Section 122). The law has been so blatantly misused that during five years between 2-14 and 198, of the 326 cases of sedition filed against people in different parts of the country, the state could secure conviction only in six cases. The SC's decision has not gone down well with the Government. Shortly after the order, Union Law Minister Kiren Rijiju said while he "respected the court and its independence", there is a "Lakshman Rekha" that cannot be crossed. It's not clear what the minister meant by the `Lakshman rekha' because the court was well within its right to review or put on hold any law. On his part, Chief Justice N V Ramana righty said that there was a need to balance the interest of civil liberties and the interests of citizens with that of the state.

Appeasement in Congress DNA



Over the years, minority appeasement has been the most obsessive pursuit and political agenda of the Congress

ajasthan Chief Minister Áshok Gehlot's political *'Karmabhoomi'* Jodhpur is seething with anger. The city has seen incidents of stone-pelting, violent attacks on police personnel and innocent people, besides riotous fury of mobs, while the administration helplessly knotted their hands for want of an order from the Chief Minister.

The communal fuse was lit in Jalori Gate in Jodhpur on May 3 when groups clashed on a day the city celebrated Eid-ul-Fitr and AkshayaTirtiya, with reports showing that the mobs disgraced the freedom fighter Bal Mukund Bissa's statue. But that wasn't the one-off incident, since the embers of the communal tension had been flaring with the Karauli incident when a procession of the Rashtriya Swayam Sewak Sangh (RSS) came under the attack of stone-pelting, while the CCTV footage holds the evidence of sabre rattling by the mobs, chasing innocents with swordson April 3. The Jalori Gate and Karauli incidents are separated by about a month, but share a close bond in the fact that the Chief Minister on both the occasions chose to remain a benign protector of the riotous mobs.

Ashok Gehlot is a Congress veteran. His deeds as the Chief Minister of Rajasthan aren't isolated, for they truly symbolize Congress' age-old Muslim appeasement politics, while no cost is too big for the party to stick with the legacy of the political instrument to nurse the minority vote base.

The administration has the wherewithal to make the cost too high for the participants in the mobs that perpetrate violence. Uttar Pradesh Chief Minister Yogi Adityanath by rolling out his law and order machinery without any communal colour has demonstrated the efficacy of the administration. UP in the first term of Yogi Government and thereafter too remained free from communal violence, and the fear of the administration is isible among the goons let loose by the proponentsof minority appeasement.

The Congress Governments



cannot be expected to give free hand to rule of law. Minority appeasement in the past seven decades has become the core of the DNA of Congress. The party worked closely with the Britishers, and after Independence it didn't shed the legacy of 'divide and rule that it inherited from the colonizers by nursing fear among Muslims.

For Jawaharlal Nehru, the reconstruction of Somnath Temple was Hindu-revivalism. as noted in his letter to Rajendra Prasad, even while it was reclaiming the national glory for Sardar Patel. Despite Rajendra Prasad and other luminaries calling for Uniform Civil Code, Nehru kept perpetuating that Muslims needed 'extra protection', and presided over enactment of Hindu Code Bill, and others to push the minority community into a silos and make them a separate class.

Under the watch of Indira Gandhi, Muslim Personal Law Board came into existence, much against the spirit of Article 44 of the Constitution, which called for uniform civil code. Rajiv Gandhi scripted Muslim Women Protection on Divorce Act, solely to overturn the Shah Bano judgment of the Supreme Court. For Congress'

The economist-turnedpolitician Manmohan Singh helped radicalization of Congress further by declaring unabashedly that the minorities, particularly the Muslims, have the first right on the national resources.

Congress' political journey over the decades saw the party sucked by the politics of minority appeasement. Its leaders, including Digvijay Singh, Salman Khurshid, questioned the Batla House encounter to the shock of many.

Compulsive practice of minority appeasement by the grand old party, besides radicalizing Congress, has pushed India to face monsters of illegal infiltrators in Assam and West Bengal, which changed demography, while also causing decades of insurgencies. Impact is visible on Muslims seemingly carrying the pre-Independence socio-political outlook that they're a separate class in the country.

Congress is also accountable for democratizing its compulsive politics of minoreasement. Not only its Chief Ministers swore by it, Centre, and he can be followed even the political offshoots, including Samajwadi Party,

Rashtriya Janata Dal, Trinamool Congress, Telangana Rashtra Samithi, have been as radical as the grand old party in sowing the crop of Muslim appeasement to harvest secured vote base.

Muslims constitute a large chunk of the beneficiaries of Pradhan Mantri Awas Yojna, PM Garib Kalyan Anna Yojna and others. None of the schemes of the Governmentled by Prime Minister Narendra Modi is directed for any particular community, for they're for all the people without any discrimination. Inclusive governance is the cornerstone of PM Modi's statecraft. This is seen in his mantra of 'Sabka Sath, Sabka Viswas, Sabka Prayas'. Besides, PM Modi has taken the popular mandate in his both the terms to unshackle the Muslim women by freeing them from the curse of triple talaq, and promoting the ecosystem for them to benefit from education. In Jammu and Kashmir, PM Modi-led Government has taken the benefits of several schemes, besides reservation, to the socially marginalized sections, just by undoing Congress' decades of politics of minority appeasement.

PM Modi's inclusive politics has hit Congress hard electorally and psychologically. Congress is without the status of the main opposition party in Lok Sabha, and it's racing to the same fate in Rajya Sabha soon.

Psychologically, Congress knows its life-blood is minority appeasement, but enacts drama to board Hindutva, as seen in acts of Rahul Gandhi in Gujarat (2017) and Madhya Pradesh (2018) Assembly polls and other state elections, when he launched himself on temple hopping spree. That reveals chaos in Congress, and also admission that people have seen through its radicalization.

Government estimates for 2019 show 1,700 illegal colonies across the national capital. The situation in, say, Mumbai, is probably worse. Bengaluru, Hyderabad, Chennai, Ahmedabad, and Kolkata have their own stories. What India is witnessing today is a surge of aspirations in the countryside driving thou-

sands of educated youth and daily-wage labourers, and landless peasants toward the

cities. The whole of Maharashtra is turning into a semi-urban landmass. In other states, the divide between the urban and rural areas is getting blurred. Unfortunately, the civic consciousness of the authorities is also blurry. The inability to take a holistic view of encroachments and ham-handed, reactive measures are the root cause of the problems. There is no effort to provide shelter to urban migrants. The poor take care of the poor and the new-comers also end up living in slums. Many of them occupy pavements to sell vegetables or trinkets, clothes or utensils and drive autos or rickshaws. They come to the attention of the political parties only at election time when it is also the time to grant permits to illegal dwellings, regularise unauthorised colonies, or permit vegetable carts along busy roads. The bulldozers should target the unauthorised colonies inhabited by the rich. The focus must be on providing for low-income housing - the PM UDAY Yojana has a lot of backlogs to cover - in a time-bound manner and give the illegal residents welfare benefits and job opportunities. Unauthorised colonies cannot be left to municipalities to resolve. They should become part of the

'They' are the British government led by Prime Minister Boris Johnson, who has never shown any concern for the subtle and delicate peace deal that former Prime Minister Tony Blair and Powell, his chief of staff, wove a quarter-century ago. Indeed, it's doubtful that Johnson even understands it. For the first time in Northern Ireland's 101-year history, last weekend's election saw Sinn Féin, a Catholic, 'Nationalist' party that is pledged to unify Northern Ireland with the 'Republic of Ireland' that occupies the rest of the island, win the largest number of seats. This dismayed the three political parties that split the votes of the former Protestant ascendancy between them, but it didn't sur-



prise them. A higher Catholic birthrate has already produced a Catholic majority in Northern Ireland's schools, and perhaps by now in the whole population as well. But a lot of people in Northern Ireland are scared, and not just Protestants. Twenty-five years of peace is not long enough to forget the previous thirty years of what was effectively a civil war, when people only a few streets over might see you as the enemy and sectarian bombings and murders were a daily occurrence. The old fears and hatreds are clearly diminishing in Northern Ireland among the generation born since 1998 (and in some of their elders too). But many believe that it's too soon to gamble on a peaceful transition to a post-sectarian all-Ireland republic.

It would only take a few dozen diehard 'Loyalists' (Protestants) to derail such a process: there are undoubtedly plenty of guns and explosives still hidden away. The militants would lose in the end, but only after years of violence and a whole new wave of fear and hatred. Unfortunately, Northern Ireland may be starting down this road, because the Good Friday deal says that any Northern Irish government must be a power-sharing entity in which a 'first minister' and a 'deputy first minister' are drawn from the two biggest parties. No government can be formed without both. In a deliberate act of sabotage, the biggest Protestant party, the Democratic Unionist Party, is refusing to accept the 'deputy first minister' role. The rules say that if no government can be formed, there must be another election within twelve weeks. None of this is inevitable, but the great project of the English nationalist party, the Conservatives, makes it much more likely. That project was Brexit. which automatically required the re-creation of a real border in Ireland between Northern Ireland, part of the United Kingdom, and the Republic of Ireland, still a member of the European Union. The magical part of the Good Friday deal was to make that border invisible: no customs check, no passports, nothing. So Catholic Nationalists could pretend they already lived in a united Ireland, while Protestant Loyalists could pretend that 'power-sharing' didn't really mean things had changed. But when the UK left the EU, that fiction died. The Loyalists feel betrayed and abandoned, and they're right. Secretly, most English politicians have wanted to unload them for decades now, so unification will still happen eventually. The problem with trying to do that now, before generational turnover has done its work, is that there may be one more round of violence before it happens.

India's critical need for cyber doctrine

Cyber power projection will deter the adversary from initiating attacks on India in the first place

the news regarding attempts of Chinese hackers in December 2021 and January 2022 to attack State Load Dispatch Centres (SLDCs) near the LAC was considered by many as routine. Of course, the military establishment would have taken a serious note. However, the people of India should understand the more significant consequences of cyber-attack, which do not remain restricted only to disruption in internet connectivity or financial transactions.

From a security point of view, such cyber-attacks aim to collect information to prepare for any future activity by the People's Liberation Army. China's 'Science of Military Strategy', published by the PLA's Academy of Military Sciences, speaks of 'winning local wars under the conditions of informationization" (2013). China has modernised its cyber warfare units through this initiative, thereby possessing both offensive and defensive technologies. Combined with its wolf-warrior diplomacy and its eyes on Ladakh and Arunachal, it leaves no room for doubt that in the future, China will have intentions and the power to unleash cyber-warfare against both civilian and military establishments

How can a future warfare situation look? Malware can be unleashed on an adversary's Command, Control, Communications, Computers, Intelligence, Surveillance and Reconnaissance (C4ISR) that can go undetected for months or probably years until the system is on a very high operational level in times of an open conflict. Alternatively, the electrical grids that supply electricity to the military bases, hospitals, and print and online media could be cut off just before a major offensive. Even AI can be used to create fake videos and deliver them to infinite end users of the internet. Such videos can attempt to disturb the internal peace and security of the country. It might occur even before retaliatory attacks are initiated, or the country comes to terms with the new realities. Future warfare would thus be swift, intense, and of a relatively shorter duration of 5-6 hours or maybe of a few days. Such an attack blurs the lines of distinction and neutrality as outlined by the International Humanitarian Law. The proliferation of offensive cyber

capabilities of our adversaries and their easy access even to non-state actors has created tactical issues of an asymmetric power struggle. Such weaponisation makes space as well as non-space-based communications mechanisms vulnerable to cyberattacks. Currently, in the realm of cyber deterrence, the government possesses passive deterrence or the deterrence by denial in which the cyber-attacks are thwarted. In this scenario, cyber security experts focus on building resilient networks to secure the digital infrastructure and minimise the attacks. To ensure a double safety mechanism and hence success, the operational domain should be expand-

ed to include active deterrence, ensuring an equal and proportionate cyber retaliation. More retaliatory or disruptive capabilities should be incorporated into the armed forces' operational domain. Such technologies can be a relatively inexpensive affair to protect the indigenously developed missile systems, which have taken years of hard work of our scientists and others who have contributed to it.

At the highest level, the armed forces should be able to disable the military command and structure system and create alternate pathways to their missile command system. Active deterrence will ensure a scenario wherein adversary's missiles would not be able to take off, or their trajectories can be altered to secure the country. Strategic communication of our deterrent declaration is a must to ensure the credibility of our response which should be able to instil fear in the perpetrator's mind. Cyber power projection will deter the adversary from initiating attacks in the first place. Additionally, they can be coupled with the active use of artificial intelligence and other propaganda and psychological warfare techniques.

As it is clear that we need to orepare for a mix of open nostillties and hybrid warfare, we can consider what other countries are doing for their cyber defence. Washington's National Security Presidential Directive No. 54 (2008) adopted a comprehensive approach to cyber security. Later, in 2010, the National Security Strategy of the US prioritised the digital infrastructure as a strategic national asset and hence warranted a national policy to ensure its safety. Further, the U.S. missile defence

pre-emptive action is taken to prevent the adversary from launching missiles. This has been used actively against Iran for its national security interests. On the lines of the US, NATO adopted an enhanced policy and action plan on cyber defence in 2014.

In the context of Russia, its Information Security Doctrine (2000) had enlisted threats endangering information support and had mentioned threats of propaganda and psychological warfare that "the propaganda of speci-mens of mass culture based on the cult of violence or on spiritual and moral values contrary to the values adopted in Russian society". It also paved the way for adopting different measures to enhance the security of systems related to "informatizing weapons and military equipment, security of troop and arms control systems, and the security of management systems for environmentally hazardous and economically important enterprises". The ongoing conflicts between Russia and Ukraine have actively used AI maliciously apart from the cyber-

Through its National Cyber Security Policy (2021), Pakistan nas treated cyber-attacks at par with attacks on the core aspects of national security and hence speaks of "active defence" in a very camouflaged manner. Further, its doctrine of 'full spectrum' deterrence (2013) that replaced 'minimum deterrence' seeks to "plug the gaps" ranging from "sub-conventional to strategic levels" surely has components of cyber-attacks. Although India has taken maiden steps in the right direction by institutionalising

bilateral research with Australia to improve regional cyber resilience by creating a joint 'Centre of Excellence for Critical and Emerging Technology Policy', much needs to be done with other strategic partners.

Two-three years from now, the geopolitical and the tactical situation will be more hostile, and if the situation demands that India revisit its NFU status in the case of its nuclear missiles, an essential condition will mandate that the missiles are loaded with the warheads and kept for ready to launch, unlike what it is today. Then in such a case, it would be a matter of extreme necessity to adopt a similar approach to the 'left-of-launch' strategy, which involves pre-emptive action to prevent the adversary from launching missile attacks.

For the aforesaid purpose, we

should focus on the development of indigenous technologies apart from getting help from our strategic allies such as Russia, France and Japan. Also, cooperative mechanisms at the level of QUAD and AUKUS should be initiated for joint cyber defences. In the last few years, the government's visionary strategic foresight has led to the establishment of various agencies such as the office of the National Cybersecurit Coordinator and a National Critical Information Infrastructure Protection Agency (NCIIPC). They are parallel to the Defence Cyber Agency (DCA) and the Military Defence Space Agency (DSA) of the Indian Armed Forces. However, a synchronisation or a fusion of the civilian and the military establishments and the incorporation of a strategic doctrine encompassing power projection for a fruitful deterrence is a must.

Sri Lanka's former prime Mahinda Rajapaksa is being protected at the Trincomalee naval base after he was evacuated from his official residence, Defence Secretary Gen (retd.) Kamal Guneratne said on Wednesday, as security forces in armoured vehicles patrolled across the country with orders to shoot at sight amid continuing protests at the government's handling of the worst economic crisis.

The 76-year-old Sri Lanka People's Party (SLPP) leader, known for his brutal military campaign against the Liberation Tigers of Tamil Eelam (LTTE) during his presidency from 2005 to 2015, resigned on Monday after violence erupted following an attack on the anti-government protesters by his supporters.

The attack triggered widespread violence against pro-Rajapaksa politicians, leaving nine people, including two police officers, dead. Mahinda, who served as the country's prime minister thrice, saw his residence set on fire on Monday. He, along with his took shelter at the naval base in Trincomalee after a series of deadly attacks on his support-

"He (Mahinda Rajapaksa) was evacuated to the Trincomalee naval dockyard," Guneratne told reporters during an online briefing. Trincomalee is a port city on the northeast coast of Sri

Gunaratne said after it was determined that it was not suitable for Mahinda to remain at Temple Trees, the necessary decision was made to relocate him.As word spread about Mahinda's presence at the Trincomalee Naval Base, people started a protest near the key military facility. "He will not live there forever.

After the situation returns to normal, he will be relocated to a residence or location of his choice," Gunaratne said.The defence secretary said it is important to protect every single life in the country, and after it was determined that it was not suitable for Mahinda to remain at Temple Trees, the necessary decision was made."He is a former President and is entitled to adequate security," he added. UN human rights chief Michelle Bachelet has condemned the escalation of violence in Sri Lanka and called for a thorough and transparent probe into the attacks on peaceful anti-government protestors and members of the ruling party.

UN High Commissioner for Human Rights Bachelet called on the authorities in Sri Lanka to prevent further violence and urged restraint and meaningful dialogue to address the grievances of the population amid the severe economic crisis in the coun-

"I am deeply troubled by the escalation of violence in Sri Lanka after supporters of the Prime Minister attacked peaceful protestors in Colombo yesterday 9 May and the subsequent mob violence against members of the ruling party," she said on Tuesday. Clashes broke out in Sri Lanka on Monday after government supporters

attacked peaceful anti-government protest sites in Colombo and elsewhere, killing at least 8 people and leaving over 200 others injured in the violence.

"I condemn all violence

and call on the authorities to independently, thoroughly and transparently investigate all attacks that have occurred. It is crucial to ensure that those found responsible, including those inciting or organising violence, are held to account," Bachelet said in statement in Geneva.

She also called on the authorities to prevent further violence and to protect the right to peaceful assembly. 'Authorities, including military personnel deployed in support of security forces, should exercise restraint in policing the situation and ensure that measures adopted in the context of the state of emergency comply with international human rights norms and are not used to stifle dissent or hinder peaceful protest," she said.

Bosnia's political crisis called worst since 1992-1995 war

The top international official in Bosnia called the escalating political crisis in country the most serious since 1992-1995 war that saw 100,000 people die and warned in a report circulated Tuesday that its potential "to become a security crisis is very real".

Christian Schmidt, the high representative overseeing implementation of 1995 peace agreement that ended devastating war, said leaders of country's Bosnian Serb-dominated entity have systematically challenged its provisions and intensified their activities aimed at usurping powers granted to federal government. The US-

brokered Dayton peace agreement established two separate entities in Bosnia — one run by Bosnia's Serbs and another dominated by country's Bosniaks, who are mostly Muslims, and Croats.

The two entities are bound together by joint central institutions, and all important decisions must be backed by both.

Schmidt said in the report to UN Security Council that actions by Bosnian Serb entity, known as Republika Srpska, 'not only erode fundamentals of the agreement, but directly threaten to undo more than 25 years of progress in building up Bosnia and Herzegovina as a state firmly on the path towards European Union integration".

The ties between India and China will "remain strained" in wake of "lethal clash" in 2020, the US intelligence community has told lawmakers as it also expressed concerns over any potential crisis between India and Pakistan.

In its annual threat assessment presented before the Senate Armed Services Committee during a Congressional hearing on Tuesday, the US intelligence community said the expanded military posture by both India and China along disputed border elevates risk of armed confrontation between two nuclear powers that might involve direct

threats to US persons and interests and calls for America's intervention. "Relations between New Delhi and Beijing will remain strained in wake of lethal clash in 2020, the most serious in decades," it said. Previous standoffs have demonstrated that persistent low-level friction on Line of Actual Control (LAC) has potential to escalate swiftly, the report said.

India has been consistently maintaining that peace and tranquillity along LAC were key for overall development ofbilateral ties. The eastern Ladakh border standoff between Indian and Chinese militaries erupted on May 5, 2020, following a violent clash in Pangong lake areas. Both sides gradually enhanced their deployment by rushing in tens of thousands of soldiers as well as heavy weaponry.

India and China have held 15 rounds of military talks so far to resolve eastern Ladakh row. As a result of the talks, the two sides completed disengagement process last year on north and south banks of Pangong lake and in Gogra area. Each side currently has

around 50,000 to 60,000 troops along LAC in sensitive sector. The assessment also noted that crises between India and Pakistan are of particular concern because of risk - however low -of an escalatory cycle between two nuclear-armed

Pillen defeated eight challengers, including Charles Herbster, a Trump-backed businessman accused late in the campaign of groping young women, and Brett Lindstrom, a state senator and Omaha financial adviser who was generally viewed as a more mod-

eraté choice. The results were a setback for Trump after a decisive win in last week's Ohio Republican Senate primary for his candidate, ID Vance. The former president has released hundreds of endorsements in races across the country, all in an effort to reshape the GOP and

Herbster's loss raises the stakes on other high-profile races this month in Pennsylvania and Georgia, where Trump has also intervened in campaigns.

Pillen will be a strong favourite in November's general election against his Democratic opponent, state Sen. Carol Blood, in the Republican-majority state.

Nebraska hasn't elected a Democrat as governor since 1994.Pillen was endorsed by many top GOP leaders in the state, including Gov. Pete Ricketts, former Gov. Kay Orr, and renowned former University of Nebraska football coach and congressman Tom Osborne. Ricketts, the incumbent, was prevented by term limit laws from running again. In Nebraska, the allegations against Herbster, a longtime supporter of Trump's, didn't stop the former president from holding a rally with him earlier this month.

Russia pummels port of Odesa in attempt to disrupt supplies

m ussia}$ pummeled the vital port of Odesa, Ukrainian officials said on Tuesday, in an apparent effort to disrupt supply lines and Western weapons shipments as Ukraine's foreign minister appeared to sug-gest the country could expand its war aims.

With the war now in its 11th week and Kyiv bogging down Russian forces and even staging a counteroffensive, Foreign Minister Dmytro Kuleba seemed to indicate that the country could go beyond merely pushing Russia back to areas it or its allies held on the day of the February 24 inva-

The idea reflected Ukraine's ability to stymie a larger, better-armed Russian military, which has surprised many who had anticipated a much quicker end to the con-

One of the most dramatic examples of Ukraine's ability to prevent easy victories is in Mariupol, where Ukrainian fighters remained holed up at a steel plant, denying Russia's full control of the city.

The regiment defending the plant said Russian warplanes attempted to storm the plant and continued bombarding it, striking 34 times in

In recent days, the United Nations and the Red Cross organised a rescue of what some officials said were the last civilians trapped at the plant.

But two officials said on Tuesday that about 100 were believed to still be in the complex's underground tunnels. Donetsk regional Gov. Pavlo Kyrylenko said those who remain are people "that the Russians have not selected" for evacuation.

Kyrylenko and Petro Andryushchenko, an adviser to Mariupol's mayor, did not say how they knew civilians were still in the complex - a warren of tunnels and bunkers spread over 11 square kilometers (4 square miles). Others said their statements were impossible to

Fighters with the Azov regiment released photos of their wounded comrades inside the plant, including some with amputated limbs.

They said the wounded were living in unsanitary conditions "with open wounds bandaged with non-sterile remnants of bandages, without the

In its statement on Telegram, the regiment appealed to the UN and Red Cross to evacuate the wounded servicemen to Ukrainiancontrolled territories.

The photos could not be independently verified.

In another example of the grisly toll of the war, Ukrainian officials said they found the bodies of 44 civilians in the rubble of a building destroyed weeks ago in the northeastern

city of Izyum.

New UN figures, meanwhile, said that 14 million Ukrainians were forced from their homes by the end of April, including more than 5.9 million who have left the coun-

In Washington, a top US intelligence official testified Tuesday that eight to 10 Russian generals have been killed in the war. Lt. Gen. Scott Berrier, who leads the Defense Intelligence Agency, told a Senate committee that because Russia lacks a noncommissioned officer corps, its generals have to go into combat zones and end up in dangerous

The House emphatically approved a fresh USD 40 billion Ükraine aid package on Tuesday as lawmakers beefed up President Joe Biden's initial request, signalling a magnified, bipartisan commitment to thwart Russian President Vladimir Putin's bloody threemonth-old invasion.

The measure sailed to passage by a lopsided 368-57 margin, providing USD 7 billion more than Biden's request from April and dividing the increase evenly between defense and humanitarian programs.

Ambassador nominee for Ukraine seeks quick embassy reopening

The Biden administration's I nominee for US ambassador to Ukraine promised senators Tuesday she would work to make Russia's invasion of that country a "strategic failure", in a war-zone appointment that for the time being will focus more on coordinating Western weapon shipments for Ukraine's forces than on diplomacy.Bridget Brink, who has spent the majority of her 25-year diplomatic career in former Soviet republics, spoke to members of the Senate Foreign Relations Committee ahead of what's expected to be her easy Senate confirmation.

The post has been vacant since former President Donald Trump abruptly forced out Marie Ambassador Yovanovitch in 2019. She later became a key figure in the first impeachment proceedings against Trump.

Committee Republicans and Democrats alike Tuesday emphasized getting Brink confirmed and in place in Ukraine's capital, Kyiv, as soon as possible, as Ukraine's forces are in their fourth month of battling invading Russian troops, with the help of an extraordinary campaign of military and financial support by the United States and European

Zelenskyy pays tribute to Leonid Kravchuk

Ukrainian Vol President Volodymyr Zelenskyy ended his nightly video address by paying tribute to Leonid Kravchuk, the first president of an independent Ukraine, who died on Tuesday at age 88.

"He was not just a politician, and even not just a historical figure," Zelenskyy said late Tuesday. "He was a man who knew how to find wise words and to say them so that all Ukrainians would hear

This was particularly important in "difficult, crisis moments, when the future of the whole country may depend on the courage of one man," said Zelenskyy, whose own communication skills and decision to remain in Kyiv when it came under Russian attack have helped make him a strong wartime leader.

"Leonid Makarovich (Kravchuk) showed just such courage," Zelenskyy said. "Perhaps it was because of

Quoting PAN, Aadhaar must | Markets give up; Sensex falls 276 points to deposit, withdraw ₹20 L

has made it mandatory to quote either PAN or Aadhaar for depositing or withdrawing over ₹20 lakh in a financial year or opening of a current account.

The Central Board of Direct Taxes (CBDT), in a notification, said furnishing the Permanent Account Number (PAN) or biometric Aadhaar will be mandatory for such high-value deposits or withdrawals from banks in a financial year, or opening of a current account or cash credit account with a bank or post

Commenting on the move, AKM Global Tax Partner Sandeep Sehgal said this shall bring in more transparency to financial transactions where banks, post offices and cooperative societies would be required to report the transactions of deposits and withdrawals aggregating to Rs 20 lakh or more in a financial year.

"Further, the mandatory condition of obtaining PAN for deposit and even for with-



drawals would help the government in tracing the movement of cash in the system. All in all, this would tighten the entire process of suspicious cash deposits and withdrawals with the already present TDS provision u/s 194N under the Încome-tax Act, 1961," Sehgal

Currently, PAN and Aadhaar are interchangeable for income tax purpose.

An assessee needs to mention his/her PAN in all communications with the I-T department and while entering into specified financial trans-

However, there can be sit-

uations where a person entering into high-value transactions, such as purchase of foreign currency or huge withdrawal from banks, does not possess a PAN. The Finance Act, 2019,

has provided for interchangeability of PAN with Aadhaar.

It has been provided that

every person who is required to furnish or quote his PAN under the Income Tax Act, and who has not been allotted a PAN but possesses the Aadhaar number, may furnish the biometric ID in lieu of PAN.

Nangia & Co LLP Partner Shailesh Kumar said once such person quotes the PAN it will be easier for the tax authorities to track the transactions.

'The government has constantly been striving to increase its taxpayer base to be able to bring such people under the tax net who may be entering into large transactions but do not hold a PAN," Kumar said.

It may eventually become difficult where a person tries to avoid filing return of income,



FIFA video game to be rebranded 'EA Sports FC'

The hugely successful FIFA ■ video game series, which dates back to 1993's release of FIFA International Soccer, is set to end when the Women's World Cup concludes in August

FIFA, football's global governing body, and EA Sports, its biggest commercial partner, failed to reach an agreement to extend a partnership that's drawn 150 million players. Part of the separation was due to FIFA demanding at least double the annual \$150-million fee it gets from the video game developer and publisher, according to The New York Times' Tariq Panja.

The new name for the series

is "EA Sports FC."
"If (FIFA) is not No 1, it's certainly in the top three game franchises of all time," Gareth Sutcliffe, a senior analyst specialising in the video games sector at Enders Analysis, told Panja. "And the reason for that is there are so many releases. Every year, they change the number on the box, put a new player on the front, and it's pretty much the same under the hood."

UEFA revises CL revamp, new format from 2024

The European Champions League will see an increase of four teams to 36 and the present group stage replaced by one single league from the 2024-25 season, UEFA said on Tuesday.

The revamp of European football's premier club competition will see each team play eight league games — four home and four away — as opposed to six in the group

The top eight sides in the league will qualify automatically for the knockout stage, while the teams finishing in ninth to 24th place will compete in a two-legged play-off to secure their path to the last 16 of the

competition.
"We are convinced that the format chosen strikes the right balance and that it will improve the competitive balance and



can be distributed to clubs, leagues and into grassroots football across our continent," president Aleksander Ceferin.

Ceferin and UEFA will be hoping the reforms - passed unanimously by their executive board - will kill off once and for all any thought of the rebel Super League making a reappearance.
