Mundka fire: Building Putin seriously ill: owner Lakra arrested Ex-British spy

The Delhi Police on Sunday arrested Manish Lakra, the owner of the commercial building in outer Delhi's Mundka where a massive fire claimed the lives of at least 27 people.

The police said Lakra—arrested from West Delhi's Ghevra Mod, near the Haryana-Delhi border — was planning to flee to Haridwar in order to evade arrest.

According to police, the building was transferred to Lakra after the death of his father in 2015

Meanwhile, the Aam Aadmi Party (AAP) on Sunday blamed the Bharativa Janata Party (BJP) for the death of 27 people in the Mundka fire incident. The AAP alleged that "illegal industrial activities" were going on in the building as its owner Lakra enjoyed protection from the BJP leaders. In a media briefing Deputy Commissioner of Police

(DCP), Outer district Sameer Sharma said on Sunday police received specific inputs that Lakra was going towards Haridwar following which a trap was laid by the police team and he was arrested from Ghevra Mod.

"Lakra's building had a shop on the ground floor and on the first, second and third

floor. There is a company named "Cofe Impax Pvt Ltd" which imports parts of CCTV cameras, and SIM routers. Around 100 employees were working there. He was living in a 2-BHK house on the fourth floor along with his wife moth-

New Delhi: Russian President Vladimir Putin is "seriously ill" and it is an "element" of what is happening in Ukraine, said a former British spy. "It's not clear exactly what this illness is whether it's incurable or terminal, or whatever.

But certainly, I think it's part of the equation," he

Christopher Steele, who wrote a dossier on Donald Trump and alleged Russian interference in the 2016 US election campaign, told Sky News: "Certainly, from what we're hearing from sources in Russia and elsewhere, is that

Putin is, in fact, quite seriously ill."

Meanwhile, an oligarch with close ties to the Russian leader has reportedly been recorded as saying "Putin is very ill with blood cancer". In a recording obtained by

a US magazine New Lines, the unnamed oligarch was heard discussing Putin's health with a Western capitalist.

Speculations around the Russian President's health intensified since the Ukraine war as the leaders appeared frail at public events including the Victory Day celebrations last week.

In the photos and videos doing the rounds on social media, Putin had a thick green cover draped over his legs as he sat among Second World War veterans and senior dignitaries to watch a military parade in

Probe ordered into use of force against Kashmiri Pandit protesters

 $F_{\text{``brutal force'' against the}}^{\text{acing allegations of use of ``brutal force'' against the Kashmiri Pandit employees}$ who were protesting the killing of Rahul Bhat, Lieutenant-Governor Manoj Sinha on Sunday ordered an enquiry to find out why the police used batons and tear gas shells against peaceful marchers outside Sheikhpura transit camp in Budgam on May 13.

The SIT has been formed to probe into all aspects of Bhat's killing, and it will also look into the tear gas shelling incident. Strict action will be taken against those found guilty," Sinha announced after meeting a delegation of Bharatiya Janata Party leaders at Raj Bhawan in Srinagar.

Sinha also met a delegation of People's Alliance for Gupkar Declaration (PAGD) before heading to New Delhi.

According to official Moscow's Red Square. sources, Sinha is expected to stay put in the national Capital



for a couple of days. In Delhi, he will attend high-level security review meetings in the backdrop of a fresh surge in the incidents of terrorist violence in different parts of Jammu and Kashmir ahead of the start of Amarnath Yatra from June 30.

The recent incident of the mysterious fire in a passenger bus near Katra town, the base camp for the pilgrims visiting the Mata Vaishno Devi shrine in Reasi district, is also under the scanner even as forensic teams of the National Investigation Agency (NIA) have collected samples to determine the nature of the blast, if

any. Four persons were killed when a fire ripped apart the moving bus, mostly carrying devotees, near Nomai, about 3 kilometers from Katra, shortly after it left for Jammu from the base camp. A team of NIA inspected the wreckage of the bus on Saturday and collected samples during their one-and-a-half-hour stay at the scene.

"The NIA has extended all requisite assistance to I&K Police in the investigation of the case of passenger bus catching fire near Katra on Friday. Detailed forensic probe is continuing to identify the reasons for the cause of fire," the agency

said in a tweet.

Though the survivors and the people residing in the vicinity of the incident spoke about hearing the sound of an explosion in the bus, Additional Director General (ADG) of Police, Jammu zone, Mukesh Singh, said the initial probe does not point to use of any blast. *Continued on Page 2*

Devasahayam was recommended for the process of Beatification by the Vatican in 2004, at the request of the Kottar diocese, Tamil Nadu Bishops' Council and the Conference of Catholic Bishops of India.

Pope Francis canonised Blessed Devasahayam Pillai along with nine others during a Canonisation Mass in St Peter's Basilica in the Vatican.

Record 1.33 lakh flamingos flock to Navi Mumbai wetlands

 $F_{\text{thousands on the wetland}}^{\text{lamingos descending in}}$ areas of Navi Mumbai is a common sight between November and May, but environmentalists and lovers of the pink-winged guests are thrilled as a record .33 lakh migratory birds have been sighted during 2021-22.

No wonder that ahead of the World Migratory Bird Day the World Migratory Dird Day (WMBFD) celebrated on Saturday, Chief Minister Uddhav Thackeray at a State Cabinet meeting held on Thursday cleared for submission to the Centre the proposal for designating the biodi-versity-rich Thane Creek Flamingo Sanctuary (TCFS) in Thane-Navi Mumbai belt as a Ramsar site as per the Ramsar Convention on Wetlands.

The Ramsar Convention on Wetlands of International Detailed Report on P 9 | Importance Especially as



Waterfowl Habitat is an inter-

national treaty for the conservation and sustainable use of wetlands. Also known as the

Convention on Wetlands, it is named after the city of Ramsar in Iran, where the convention was signed in 1971.

If approved by the Centre, FS — spread over 1,690.5 hectares — will be the first such wetland site in Mumbai Metropolitan Region (MMR) and the third in Maharashtra to be designated as a Ramsar site of international importance under the Ramsar Convention.

Himself a wildlife and aerial photographer and a naturalist, Uddhav is keen on TCFS being declared as a Ramsar site. His son and State Environment Minister Aaditya Thackeray — who had cleared the proposal on December 9 last for final approval by the Chief Minister — is pushing for declaration of TCFS as a

Ramsar site. Between November and May every year, pink-winged guests flock the mudflats, creeks and wetlands of MMR in vast numbers, mostly for feeding purposes from breeding sites in the Gujarat region

as well as Iran. Migration from breeding ground starts after the monsoon when water-filled

monsoon when water-filled regions start drying up.
Thousands of people from Mumbai and neighbouring areas throng parts of TCFS and other creek areas in MMR to catch a glimpse of the sea of pink in the wetland areas.

The State Government's decision to send a proposal to the Centre to designate the TCFS as a Ramsar site as per the Ramsar Convention on Wetlands could not have come at more appropriate time than when informed researchers from the Bombay Natural History Society (BNHS), a pan-India wildlife research organisation which has been monitoring, tracking and tagging flamingos since 2018, have recorded highest-ever 1.33 lakh of flamingos in MMR during 2021-22.

Addressing a rally of North Indian community at Goregaon in north Mumbai Mumbai, Fadnavis said that if late Shiv Sena chief Balasaheb Thackeray, if he were to be alive, would have been pained to see that during his son's rule reciting Hanuman Chalisa would be a sedition and going to Aurangzeb's tomb would be

Vowing to bring down the "Babri" and "Lanka of corruption" of the three-party MVA government comprising Shiv Sena, NCP and Congress, Fadnavis retaliated to the allegations made against him by Uddhav at the rally that the latter addressed in Mumbai on Saturday evening. Slamming Uddhav for ridi-

In a politically significant development, the Bharatiya Kisan Union (BKU) on Sunday expelled its firebrand leader Rakesh Tikait, the face of the farmers' protest in 2020.

Apart from Rakesh Tikait, his brother Naresh Tikait has also been removed from the post of BKU's national presi-

Farmer leader Rajesh Singh

Chauhan has replaced Naresh Tikait and has been elected as the new BKU (Apolitical) chief. Chauhan was elected as the

new BKU chief in a meeting on Sunday. Rakesh Tikait tried hard to persuade the farmers to

remain united and not to float a new organisation but the farmers' leaders opposed to political activities refused to

The meeting was organised to commemorate the death anniversary of Mahendra Singh Tikait, the founder of BKU. Chauhan asserted that the

farmers' body would not work for any political party. He announced the formation of a new faction, Bhartiya Kisan Union (Apolitical). The farmers' meeting also

elected Harnam Singh Verma

as the state president of the

BKU (A) and Mangeram Tyagi as national vice-president. The Tikaits have been accused by farmer leaders of playing politics, and working in

the interests of a political party. With the ouster of the Tikaits, the organisation, which was responsible for spearheading and leading the farmers' protest against the three farm laws for nearly a year has been divided into two facAddressing a press conference here on Sunday, Chauhan remarked that a lot of hard work had been put in to create the unified Bhartiya Kisan Union, which was formed to safeguard the interests of the farmers. The organisation under the Tikaits was turned into a "political zone", he added.

"Today our organisation held a meeting. Our new organisation's name will be Bharatiya Kisan Union (Apolitical). We have no comment on Rakesh Tikait, or Naresh Tikait; they can keep doing what they want to do. The BKU was turned into a political zone. It was inspired by electoral politics," the BKU

(A) chief said. He added, "We spoke to Rakesh Tikait and expressed our concerns. We did a lot of hard work to create BKU, but he asked us to support one party. We object to that. Our motive is to look into the problems of farmers. We will not work for any party."

After the farmers' protest

fizzled out with the repeal of the three farm laws, Rakesh Tikait was spotted campaigning for political parties. As the spokesperson of the farmers' outfit, Tikait's alleged political affiliations had raised eyebrows. In March 2021, he had gone to campaign for the Trinamool Congress (TMC) in West Bengal's Nandigram

and Kolkata in April last year. The Bharatiya Janata Party had alleged that "background support" was voiced by Mamata Banerjee to Tikait-led farmers' protest.

In Uttar Pradesh, his elder brother Naresh Tikait, while addressing the people, said that he hoped that the state would support the Samajwadi Party-Rashtriya Lok Dal coalition candidates in the UP assembly elections.

Although Rakesh Tikait vowed to go to UP voters with the slogan of 'Defeat BJP', he did a complete U-turn after the party's victory and asserted that the people's wish was

Mumbai Magistrate's court remands Ketaki Chitale in police custody

Aday after she was arrested for sharing an objectionable and derogatory post on Facebook against NCP founder-President Sharad Pawar, a Mumbai magistrate's court in Thane on Sunday remanded Marathi actress Ketaki Chitale in police custody till Wednesday.

Twenty-nine-year-old Ketki, who was arrested by the Thane Crime branch police from Kalamboli in Navi Mumbai on Saturday evening, was produced before a holiday court at Thane, which sent to police custody till May 18.

Though the objectionable Facebook post shared by the actress did not mention the NCP chief's full name, it referred to him through his surname as Pawar and mentioned his age as 80 years. The FB post, which described Pawar as "a mosquito", carried

comments like "hell is waiting" and "you hate Brahmins". The tweet mentioned the name of Advocate Nitin Bhave.

Acting on a complaint lodged by one Swapnil Netke, the police had registered a case against Ketki under sections 500 (defamation), 501 (printing or engraving matter known to be defamatory), 505 (2) (making, publishing or circulating any statement, rumour or report promoting enmity, hatred or ill will between classes), 153 A (spreading disharmony among people) of the

Incidentally, Chitale has been booked under three FIRs by as many police stations in Thane, Pune, Pimpri.

Chitale, who is known for her controversial posts on social media, earned the wrath of the NCP women workers, who hurled ink at her while she was being taken to a police jeep at Kalmboli in Navi Mumbai.

Four drown in Ganga

Station House Officer of Jalesar police station, Irfan Khan, said that in Nagla Dhaniram village, a 35-year-old farmer, Yogesh, had gone to his tube well to water his field and as soon as he switched on the pump, he came in contact with a live wire and was electrocuted.

According to Khan, the policemen who reached the spot on getting information, registered a case and sent the body for post-

"Approximately 1,33,000 flamingos were observed this year (during April) across the Thane Creek Flamingo Sanctuary (TCFS), Sewri-Nhava and adjacent zones In comparison, 1,03,000 flamingos were spotted in 2020-21 (during February), 96,400 during 2019-20 (February), and 1,20,000 during 2018-19 (March)," Rahul Khot, deputy director, BNHS, said.

According to Khot, the number of lesser flamingos from December 2021-March 2022 has been 65,000 at wetland areas of TCFS, 25,000 at Sewri and 9000 at Nhava. The population of this species has witnessed a marginal increase across all three locations this year.

Mundka fire: Building owner enjoyed protection from BJP leaders, claims AAP

The Aam Aadmi Party (AAP) on Sunday blamed the Bharatitya Janata Party (BJP) for the death of 27 people in Mundka fire incident.

The AAP alleged that the "illegal industrial activities" were going on in the building as its owner Manish Lakra enjoyed protection from the saffron party leaders. Lakra was arrested by the Delhi Police on Sunday.

Addressing a Press conference in the national Capital, Durgesh Pathak, the senior AAP leader also showed some pictures in which Lakra was seen with some BJP leaders, including former Mayor of the North Delhi Municipal Corporation.

"The BJP is the real culprit behind the Mundka fire tragedy. The building owner, Lakra and BJP MP Parvesh Verma's chacha Master Azad Singh have deep ties. The BJP's 2015 Delhi Assembly election's campaign office was in this very building that caught fire," said Pathak.

"Being a Lal-Dora area, Industrial

"If there is an individual or an organisation to blame for the 27 innocent lives that were lost in the tragic fire, it is the BJP, its leaders, their flagrant corruption, and their undying greed which had cost us so many poor lives. I urge for a thorough investigation in the matter at the earliest," said

L-G gives nod to probe

Delhi Lieutenant Governor Anil Baijal on Sunday gave nod to magisterial inquiry into the recent fire tragedy in Outer Delhi's Mundka area which claimed the lives of 27 people. According to officials, the District magistrate (West) will probe lapses on the part of the concerned departments and agencies, recommend action against the erring officials and fix responsibility. The DM will also suggest remedial measures to prevent such tragedies in future, the officials said.

According to the officials, the file on the probe has been approved by the LG. The terms of reference of the inquiry include ascertaining the circumstances and the cause of the fire. "The probe will also ascertain lapses on the part of the concerned departments and agencies and their officers in relation to their expected roles. It will fix responsibility of the concerned officials for the lapses and recommend action against erring officials, individuals and agencies, the officials said.

'The probe will also suggest remedial measures to prevent such tragedies in future. As part of the inquiry, the DM will also ascertain if there was any violation of laws," the officials added.

The fire, one of the deadliest in recent years, ripped through a four-storey building in outer Delhi's Mundka area on May 13. It started on the first floor of the building due to a suspect-



ed explosion in an AC, according to fire officials Nineteen people are still missing

The magisterial probe into the incident was announced by Chief Minister Arvind Kejriwal when he visited the spot on Saturday. The Delhi government has announced a compensation of Rs 10 lakh each for the kin of deceased and Rs 50,000 for those injured in fire. Earlier on Sunday, the Delhi Police arrested the owner of the building following multiple raids in the national capital and Haryana.

"You are hereby informed that a case has been registered against you at PS Sadar Bazar, Delhi. You are hereby directed to appear before the undersigned and to join investigation by May 18 at 1.00 pm at PS Sadar Bazar along with any relevant record/document available with you," the notice

The team did not visit the official residence of Minister Mahesh Joshi. In her complaint, the woman had alleged that she was raped on several

occasions between January 8 last year and April 17 this year. Later, the Delhi Police converted the zero FIR into a regular FIR since the allegations of commission of sexual assault committed in Sadar Bazar police station jurisdiction has also been mentioned

The case was registered on May 8 at a police station in North District under sections 376 (rape), 328 (causing hurt by means of poison, etc., with intent to commit an offence), 312 (causing miscarriage), 366 (kidnapping, abducting or inducing woman to compel her marriage, etc), 377 (unnatural offences) and 506 (criminal intimidation) of the Indian Penal Code, the police said.

The woman had said she developed friendship with Rohit Joshi on Facebook last year and since then they have been in contact.

The two met in Jaipur first and he allegedly invited her to Sawai Madhopur on January 8,

During their first meeting, she alleged, he spiked her drink and took advantage of it. When she woke up the next morning, he showed her naked photographs and videos which

worried her, reads the FIR.

Bangladeshis held in cross-border money laundering case by ED

The Enforcement Directorate (ED) has carried out search operations at 11 premises linked to Bangladesh nationals and their associates across West Bengal and arrested a citizen of that country, along with others, wanted in a 10,000 crore Bangladesh Taka bank fraud case there. Out of the two

Bangladeshi nationals whose premises were searched -Proshanta Kumar Halder and Pritish Kumar Halder, the former was nabbed along with his five other associates during these searches, the ED said in a statement here on Sunday.

Proshanta Kumar Halder was found in the disguised identity of an Indian citizen as Shibshankar Halder.

During the searches, it was revealed that he along with his other associates fraudulently obtained various gov-ernment identities like Ration Card from the State of West Bengal, Indian Voter ID card, PAN (Permanent Account Number) and Aadhar

"The ED has ascertained that these Bangladesh nationals have also managed to float companies in India on the basis of fraudulently obtained identities and have even pur-chased properties in West Bengal," the ED said.

Govt: Country has constraints in availability of domestic coal

The country is facing constraints in the domestic coal availability and the rest of the dry fuel demand needs to be met with imports, according to the Coal Ministry.

The Ministry has also emphasised that coal block holders -- both captive and commercial — have a major role to play in mitigating the coal shortfall situation. Domestic coal production is about 800 million tonnes, according to the coal additional secretary, who is also the chairperson of an inter-ministerial panel on coal linkages for the power sector.

The inter-ministerial panel met ?recently to consider the requests for coal linkages to central/state sector power plants and to review the status of existing coal linkages.

The additional coal secretary stated that "there are constraints in domestic coal availability and the domestic coal production is roughly about 800 MT".

Therefore, the rest of the coal demand of the country has to be met through imports from other countries", according to the minutes of the meeting on fuel linkages.

Coal Secretary A K Jain had earlier attributed the low coal stocks at power plants to several factors such as heightened power demand due to the boom in the economy post-COVID-19, the early arrival of summer, a rise in the price of gas and imported coal and a sharp fall in electricity generation by coastal thermal power plants. He had added that a slew of measures is already underway to enhance the total power supply in the country.

Antibiotics overuse can harm microbes: Study

Antibiotics are life-saving drugs, but their indiscriminate usage can also harm the beneficial microbes that live in the human gut, researchers have said after they found that following antibiotic treatment, some patients are at risk of developing inflammation or opportunistic infections such as Candidiasis.

And if the intestines become damaged by chemotherapy or surgery, then the Candida can get out of the gut and cause a bloodstream infection, they said in the study published in Cell Host and Microbe

Gut microbiomes are generally known to carry genetically encoded strategies to survive contact with antibiotics.

But the study, led by researchers from the University of Birmingham in the UK and the US National Institutes of Health, discovered that antibiotics disrupt the immune system in the intestines, meaning that fungal infections become poorly controlled in that area.

The team also found that where fungal infections developed, gut bacteria were also able to escape, leading to the additional risk of bacterial infection. While the study, published in Cell Host and Microbe, demonstrated the potential for immune-boosting drugs, the researchers said their work also highlights how antibiotics can have additional effects on our bodies that affect how we fight infection and disease. This in turn underscores

the importance of careful stewardship of available antibiotics.
"We knew that antibiotics

make fungal infections worse, but the discovery that bacterial co-infections can also develop through these interactions in the gut was surprising. These factors can add up to a complicated clinical situation and by understanding these underlying causes, doctors will be better able to treat these patients effectively," said lead Rebecca Drummond, fungal immunol-

ogist at Birmingham.

In the study, the team used mice treated with a broadspectrum antibiotic cocktail and then infected these animals with Candida albicans, the most common fungus that causes invasive candidiasis in humans. They found that although infected mice had increased mortality, this was caused by infection in the intestine, rather than in the kidneys or other organs.

In a further step, the team pinpointed what parts of the immune system were missing from the gut after antibiotic treatment, and then added these back into the mice using immune-boosting drugs similar to those used in humans.

They found this approach helped reduce the severity of the fungal infection.

The researchers followed up the experiment by studying hospital records, where they were able to show that similar co-infections might occur in humans after they have been treated with antibiotics. An estimated 1.2 million

people worldwide died in 2019 from antibiotic-resistant infections, and this number is predicted to increase ten-fold by 2050. The new "findings demonstrate the possible consequences of using antibiotics in patients who are at risk of developing fungal infections," said Dr. Drummond.

"If we limit or change how prescribe antibiotics we can help reduce the number of people who become very ill from these additional infections — as well as tackling the huge and growing problem of antibiotic resistance?

DGFT directs regional authorities to issue RCs to wheat exporters

The Directorate General of Foreign Trade has directed its regional authorities to issue registration of contracts to the wheat exporters who have irrevocable letters of credit, so that they can honour their contracts.

The direction came after the government banned wheat exports but allowed the overseas shipments for which irrevocable LoC (Letters of Credit) have been issued on or before May 13. The Directorate General of Foreign Trade (DGFT) is an arm of the commerce ministry which deals with exports and imports related matters.

"All RA (Regional Authorities) under the DGFT are hereby directed to issue

to the exporters of wheat, preferably within a prescribed time limit of 24 hours, on submission of application, complete in all respects, by the exporters," the DGFT has said in a trade notice.

It has added that the wheat export on humanitarian ground as aid/assistance/government-to-government shall be allowed on a case to case basis, with the specific approval of the competent authority.
India's wheat exports stood

at an all-time high of 7 million tonnes, valuing USD 2.05 billion, in 2021-22 fiscal year on better demand for Indian wheat from overseas. Of the total wheat exports, around 50 per cent of shipments were exported to Bangladesh in the last fiscal.

'Over-counter painkillers linked to increased risks in pregnancy'

Would-be moms should not take painkiller pills over-the-counter and instead take medical advice. A study has found that maternal use of over-the-counter painkillers is about one and a half times more likely to increase the risk of delivering a baby with health issues. The researchers of the study have called for a reassessment of medical advice about the use of analgesics during pregnancy. The study is published in BMJ Open.

Researchers at

University of Aberdeen in the UK analysed data from more than 151,000 pregnancies over

The team looked at medical notes for non-prescribed maternal consumption of five common painkillers, paracetamol, aspirin and non-steroidal anti-inflammatory drugs (NSAIDs), diclofenac, naproxen, and ibuprofen, either as single compounds or in combinations

Among mothers who took painkillers such as paracetamol and ibuprofen during pregnancy, the risk of a preterm delivery before 37 weeks was 50 per cent more likely, while the

risk of stillbirth was 33 per cent. Other risks of using painkillers include neural tube defects (64 per cent more likely); admission to a neonatal unit (57 per cent more likely); neonatal death (56 per cent

more likely);and birthweight under 2.5 kg (28 per cent more likely), among others, revealed the study published in BMJ

"It should be reinforced that paracetamol in combination with NSAIDs is associated with a higher risk and pregnant women should always consult their doctor or midwife before taking any over-the-counter drugs. We would encourage a strong reinforcement of the official advice for pregnant women," said Aikaterini Zafeiri from the University.

Between 30 per cent and 80 per cent of women globally use non-prescription painkillers in pregnancy to relieve pain for common pregnancy symptoms such as flu, fever, and inflammatory or rheumatological conditions.

However, current evidence

regarding safety of use during pregnancy varies widely, with some drugs considered safe and others not.

Overall, nearly three in ten women have taken overthe-counter analgesics during pregnancy, a figure which more than doubled to 60 per cent during the last seven years of the 30-year study period. This suggests use is growing rapid-

"In light of the study findings, the ease of access to nonprescription painkillers, in combination with availability of misinformation as well as correct information through the internet, raises safety concerns," Zafeiri said.

"This is especially when misinformed or partiallyinformed self-medication decisions are taken during pregnancy without medical advice,

'Sense of insecurity among Kashmiri Pandit employees increasing in valley'

The Jammu and Kashmir unit of BJP on Sunday said a sense of "insecurity" among Kashmiri Pandit employees is increasing due to the recent spurt in killings of Hindus by terrorists, asserting that an exodus of members of the community from the valley will be a "black spot" on the initiatives of the Government.

In a memorandum to Lieutenant Governor Manoj Sinha by a BJP delegation led by its J&K unit president Ravinder Raina, which called on Sinha at Raj Bhavan here, the party also said it will be a "disastrous step" if the Kashmiri Pandit (KP) employees leave

The BJP's memorandum to LG comes in the aftermath of the killing of Rahul Bhat, a Kashmiri Pandit government employee, which has sparked protests by community mem-

"The sense of insecurity is increasing high among Kashmiri Pandits employed under the prime minister's package due to chain of killings of Hindus in valley during the past over a year. Repeated assurances were given to them at each time the killing of any Hindu took place that it won't be repeated. And Rahul Bhat's

killing in a busy government office in broad daylight by terrorists has shattered them," the memorandum read.

The BJP said the KP employees, who protested the Bhat's killing, faced batons and teargas shelling instead of getting a sense of security by the administration of the Union Territory.

"Some of them were injured and a video of which went viral resulting in anti-BJP and anti-Modi ji sloganeering by them, which was seen for the first time in the past three decades in Jammu and Kashmir," the party said.

The BJP said that on Friday, the administration locked gates of the transit complexes housing KP employees and their families "denying" the movement to markets to get food, vegetables and milk and, as per their grievances, they could not send their children to school.

They are not bonded labourers brought here. What happened in the day was a protest and (they) clashed with police to open gates. It was heating touch instead of confidence building measure, they alleged. Multi-disciplinary study confirms Mahabharat true chronicle of history

A new study incorporating archaeology, astronomy, carbon dating, geography, hydrology, archaeo-botany and a host of scientific methods have established that the Mahabharat era was not mythology but a part of the history of ancient

Saroj Bala, a Delhi-based former Indian Revenue Service officer who quit her Government job as a Member of the Central Board of Direct Taxes to undertake research that took her more than a decade to complete has found that the Mahabharat was fought in 3139 BCE (Before Current Era) which is more than 5,000 years ago.

"Though the Mahabharat contains more than 1,00,000 verses and 200 references to planetary positions, most of the studies undertaken hitherto had focussed on just 30 to 40 verses and then fixed many different astronomical and archaeological dates for Mahabharat war spanning the period from 5567 BCE to 575 BCE. This had enabled the pseudo-schola mythological story composed by Poet Vyas and that it had nothing to do with the history of India," says Saroj Bala.

All proofs from multiple disciplines of

science were correlated with the text of trip on January 14, 3138 BCE, the day Sun Planetarium and Stellarium software.

Detailed evidence from archaeology, archaeobotany, geography and geology, oceanography and hydrology, remote sensing and genetic studies was gathered and after that was beautifully woven into the story. These support the astronomical data sequence," said Saroj Bala.

The Planetarium and Stellarium software used by the National Aeronautics and Space Administration and has proved its efficacy and replicability over the years.

Jaipal Poonia, a salt trader, was shot dead by around six men in broad daylight in Nawan town in Nagaur district on Saturday.

Poonia's family has accused Choudhary and his associates of being involved in the attack. Choudhary termed the allegation baseless and politically motivated.

A case against Choudhary and seven others was lodged at Nawan Police Station under Indian Penal Code sections 302 (murder) and 120B (criminal conspiracy) following a complaint by the family of

Poonia, police said.
In the FIR lodged by the victim's wife, she alleged that on the directions of Choudhary, who is the ruling Congress MLA from Nawan, his brother Moti Singh, Moolchand Saini, Virendra Saini and others killed her

husband.

"My husband left home at 10.30 am for court on Saturday but returned at 11 am, saying that the hearing would be held at 12.30 pm. While having lunch, he told me that the MLA and others are trying to implicate him in a false case. He said he was getting threats and may be killed," Poonia's wife alleged in the complaint.

According to police, Poonia has several criminal cases registered against him.

Reacting to the allegation, Choudhary said, "All the charges are baseless and politically motivated."

Diluted ethos

The Congress seems to have abandoned its core philosophy; it's emulating others

he Congress has to find its lost creed to revive itself. It may have given ground to the BJP nationally. It may be a junior partner in alliance Governments in some States. What cannot be denied, however, is its core vote bank across the country. It is the only national rival of the BJP. It is in a direct fight with the ruling party in half the Lok Sabha seats. What it has failed to do is win. The reason for its embarrassing existence is losing hold of the national narrative that characterised it for nearly 70 years. It was a combination of Nehruvian nationalism and secularism that remained its core despite the party banking on questionable and corrosive characteristics over the years. In a country that thrived on wearing religion and its public practice on its sleeve, the Congress saw no contradiction in practising secularism. Yes, there were exceptions, violent exceptions, but these were still exceptions. However, faced with a dynamic and rejuvenated plank of the BJP's Hindutva nationalism, the Congress appeared to wilt. Self-doubt ate away at its core, weakening its secular resolve. It began to ape its political rival to survive. It swapped the secular banner with what it called 'soft Hindutva', realising

> quite late that it had lost its creed in the process. It began to wander in the wilderness of a potent ideology it fought to keep at bay in the past.

> Rahul Gandhi on a temple spree wearing the Hindu sacred thread, his supporters calling him a 'janeu-dhari Brahmin', was the image Congress workers were armed with to carry on with their politics. Leaders like Kamal Nath issued more circulars about celebrating Hindu festivals than governance in Madhya Pradesh. Today, at a political crossroads, the Congress introspects where it went wrong. It went wrong because it abandoned its path.

It can correct itself by getting back its narrative that advertises its core philosophy instead of emulating rival ideologies. It would do well to recall how Jawaharlal Nehru's active intervention in Ayodhya stemmed religious passions from aggravating in 1949. His stand was reflected in the Congress victory in both parliamentary constituencies in Faizabad. That was political will in action. It was not based on surrendering Congress' ideology to mime someone else's. NT Rama Rao came up with Telugu 'pride' to counter the Congress narrative in Andhra Pradesh. Lalu Yadav's answer to 'Kamandal' was Mandal. In contrast, Rajiv Gandhi allowed a religious ceremony at the disputed Ayodhya site. Simply opposing Hindutva or adopting soft Hindutva is as good as surrendering one's identity. There is nothing called 'soft' Hindutva, incidentally. It is all about having a counter-narrative to carry a strong, parallel conversation within the country. The Congress needs to explain to itself why its voice is subdued when anti-secular issues like 'hijab' or 'halal' controversies erupt. Celebrating festivals is secular; promoting festivals of only one religion is not. That, in sum, is the creed.



Going backwards

The Gyanvapi complex video survey and subsequent unrest are issues best avoided

survey of part of the Kashi Vishwanath temple Gyanvapi mosque complex in Varanasi is underway. It began on Friday as per a court's order and quickly ran into a controversy. The Anjuman Intezamia Masjid Committee, which manages the Gyanvapi mosque, is against the videography of the complex. They say it is against their belief. As the survey began, protesters shouted slogans at the site and loud noises were made in TV newsrooms. The survey, along with the videography, is being done by court-appoint-



ed advocate commissioner Ajai Kumar and his team. The survey was ordered by a Varanasi civil court on April 26 on a 2021 petition by five women, who sought daily prayers and worship rights at the Maa Shringar Gauri Sthal, which is in the Kashi Vishwanath-Gyanvapi complex. The court ordered a survey of the entire area of plot number 9130, which includes Maa Shringar Gauri Sthal and the Gyanvapi complex. The court has asked the survey report to be presented before the next hearing in the case on May 17. There is the fear that the city's law and order may be disturbed as tempers are running high.

Unfortunately, the development has opened a Pandora's box at a time when the society is already suffering from the plague of schism. There has been a sudden surge in claims on the ASI-protected monuments. Petitioners are mushrooming everywhere and claiming that these monuments were once Hindu shrines or temples. Recently people have staked a claim on Qutub Minar, Taj Mahal, Humayun's Tomb, and so on. Gyanvapi mosque happens to be just one of the many sites on the radar of right-wing elements. Besides, reaching conclusions on half-baked theories and flimsy evidence are a travesty of justice. For instance, the survey being conducted in the Gyanvapi complex is not even by the ASI, which is a competent authority. 'Correcting' history is fraught with dangerous consequences and does nobody any good, including to the plaintiff. The country has suffered enough for 30 years in the aftermath of the Babri Masjid demolition; numerous lives were lost, property worth

crores destroyed and social fabric tattered beyond repair. If we again go down that

path, we may end up burning the country yet again.

New prospects in India-Nepal ties



The bonhomie between the neighbours was re-established when Nepalese Prime Minister Sher Bahadur Deuba came here in April

epalese Prime Minister Sher Bahadur Deuba concluded a three-day visit to India on April 3, 2022. He arrived in India with a 25-member delegation on his maiden overseas visit after assuming office in July 2021. Prime Minister Deuba was scheduled to visit India earlier in January this year to attend the Vibrant Gujarat Summit. However, due to the rise in COVID-19 cases in India, the visit was postponed.

Prime Minister Deuba's July visit assumed great importance in India-Nepal bilateral ties considering Nepal's assertive stance over a border dispute with India over the past three years. During the previous administration, then Prime Minister KP Oli chose to politicise the border row rather than resolving it through diplomatic means. The number of high-level delegations from Nepal to India had also gone low in the last three years.

Meanwhile, Prime Minister Deuba has made efforts in resolving misunderstandings with India and his India visit has opened up more avenues of cooperation and helped to fill the existing thaw. Soon after Prime Minister Deuba took office, a delegation of the ruling Nepali Congress Party led by the former Foreign Minister of Nepal, Prakash Sharan Mahat, had come to India in October 2021.

Beyond Politics: The latest visit of Prime Minister Deuba has proved to be more outcome-oriented. In the past seven decades of formal diplomatic ties, India and Nepal have proved their economic potential, and, to date, India is the largest trading partner of Nepal. However, due to the low export volume from Nepal to India, a large trade deficit remains an existing challenge for Nepal. On many occasions, political parties in Nepal have made it a political agenda. Meanwhile, there are no political solutions to resolving the trade imbalance since Nepal does not have substantial industry outputs to export nisnea goods to india.

Despite these challenges, the two countries have shifted focus to more viable areas of coopera-



tion. These include connectivity, energy, digital, and infrastructure development.

Connectivity: Connectivity is an important aspect of India-Nepal cooperation in the present context. As a landlocked country, Nepal's thirdcountry trade takes place through the Indian ports of Haldia in West Bengal and Visakhapatnam in Åndhra Pradesh and the imported goods reach Nepal through twenty-two designated trade routes between India and the Nepal border. To give a major boost to border trade, the two countries are working to upgrade major check posts to facilitate smooth trade.

There is also a focus on upgrading the highway infrastructure in southern Nepal with India's assistance which will further reduce the travel time. Other than improving the existing road infrastructure, the Prime Minister Modiled Government has attached great importance to the railway connectivity with Nepal, India's next-door neighbour. Since

India's bilateral ties are primarily based on people-to-

people ties, the rail connectivity boosts the shared cultural and religious bonhomie. During his visit to India.

Prime Minister Deuba jointly inaugurated the launch and operationalisation of a 35km-long cross-border rail link from Jaynagar in Bihar to Kurtha in Nepal. This railway route is a benchmark in providing connectivity to pilgrims travelling from India to Janakpur, which is the birth-place of Hindu Goddess, Sita. The freight services through Jaynagar-Kurtha will also contribute to advancing the trade ties. The Jaynagar-Kurtha section is part of the 68.7-km-long Jaynagar-Bijalpura-Bardidas rail link, which has been entirely built with Indian assistance and, so far, India has spent nearly ₹550 crore (INR) on the project.

Vision statement on the power sector: The 'Vision Statement on the Power Sector' was the major highlight of Prime Minister Deuba's visit to india. The statement was jointly launched by the two Prime Ministers. The major points in the statement include joint

development of power generation projects in Nepal, development of cross-border transmission lines and, most importantly, bi-directional power trade with appropriate access to electricity markets in both countries based on mutual benefits, and market demands.

It is noteworthy that Nepal is home to thousands of Himalayan rivers and, with advanced technology in place, these rivers can provide uninterrupted power to Nepal and then it can export the surplus power to neighbouring countries, including India and Bangladesh, and India has already agreed to purchase power from Nepal. Over the past few decades,

India has also advocated exploring Nepal's hydropower potential for mutual benefits. Meanwhile, projects like the Pancheshwar Multipurpose Project were signed in 1996 but, to date, even the Detailed Project Report has not been prepared. Despite these challenges, the two Governments are working towards exploring the hydropower potential and the recent progress made in the 900 MW Ārun-III hydro-electric project in Nepal is a welcome step. Also, the joint inauguration of the 90-kmlong 132 KVDC Solu Corridor Transmission line and substation built under the Line of Credit extended by India further contribute to the sector.

Conclusion: Prime Minister Deuba's visit to India has exhibited positive and tangible outcomes. The visit re-energised the 'special ties' between India and Nepal as these aim to improve bilateral trade and economic relations. The visit also signified India's commitments toward Nepal under its 'Neighbourhood First Policy'.

WHAT'S WRONG WITH THE PHILIPPINES?

Pact between Marcos. Duterte families shaped the vote



Ongbong' Marcos didn't just win the presidential election in the Philippines this week. He won it by a two-to-one lender. Philippines this week. He won it by a two-to-one landslide, despite the fact that he is the extremely entitled son of a former president who stole at least ten billion dollars and a mother who spent the loot partly on the world's most extensive collection of designer shoes (3,000 pairs)

Moreover, Ferdinand Marcos Jr, to give him his real name, has virtually no accomplishments other than that name. Yet his name and his inherited wealth, originally stolen from the parents of the people who voted for him, have enabled him to hold various political offices almost continuously (apart from five years in exile) since he was 23.

Equally deplorable is the electoral triumph of his vice-presidential ally, Sara Duterte, daughter of the mass murderer Rodrigo Duterte. The latter is leaving the presidency at the end of his six-year term, still wildly popular despite the many thousands of extra-judicial killings of alleged 'drug fiends' that he has ordered.



Indeed, those killings are precisely why Rodrigo Duterte is so popular, and his daughter basks in the reflected glory of his violence. A lot of Filipinos adore politicians and other prominent people who are loud, rude and macho - but it's more complicated than that. Sometimes they elect murderers and thieves; sometimes they elect apprentice saints.

The senior Ferdinand Marcos was legitimately elected president in 1965 but declared martial law when he was nearing the end of his second term in 1972. Martial law lasted for another fourteen years, with Marcos's henchmen dividing their time between stealing public funds and torturing or killing perceived opponents.

After that first President Marcos ran the country's economy into the ground, he was ousted in 1986 in the first of the 'people power' non-violent revolutions. The saintly Cory Aquino, whose husband had been assassinated on Marcos's orders, was elected to the presidency, while everybody applauded the Philippines' restored democracy.

But in 1998 the Filipinos elected Joseph 'Erap' Estrada, a former movie star famed for playing the villain, in another landslide. After the fall of Estrada there were two modestly competent and non-criminal presidents - and then, in 2016, Rodrigo Duterte. Another landslide, of course, and if Duterte stole a lot in the past six years it has not yet been exposed, but he killed even more people than Marcos Senior.

The Philippines is a leading contender for the title of 'world's most populist country', which is hard to explain because its lost twin behaves in a quite different way. Just to the west of the Philippines is Indonesia, another country of many islands whose people are ethnically and linquistically very close to the Filipinos.

Per capita income is about 30% higher in Indonesia, mainly because of oil, but the economies are basically quite similar. Both countries lived for decades under murderous dictators, and both finally overthrew them in non-violent revolutions, the Philippines in 1986, Indonesia in 1998.

However, since Indonesia became a democracy it has elected only presidents who were neither killers nor thieves, while the Filipinos hurl themselves enthusiastically at any plausible fraud who gains a bit of notoriety. Why?

Two hypotheses, both weak, come to mind. First, the Philippines has an unusually powerful elite of big, rich families with strong regional bases. This week's vote, for example, was shaped by a recent alliance between the Marcos family (northern and central Philippines) and the

Duterte family (southern Philippines) The other hypothesis? Ninety-nine percent of adult Filipinos are online, and Filipinos aged 16 to 64 spend on average nearly four hours a day connected to social networks.

Scientific temper can be imparted in society only if we deliver science to each one of them. It is not an easy task

ontemporary society is built on materials of science. But unless the common man understands what oratories, science becomes meaningless. Communicating science to the public-whether through the media, museums, or outreach - is now a burgeoning global

The question of who should communicate science to the public has been debated several times in the long history of science. Most of the scientific community members are interested in communicating with their peer group through scholarly publications. Unfortunately, to digest this scholarly publication is beyond the capacity of the common man. A good scientist is not necessarily a good communicator. Nobel laureate Paul Dirac was achingly shy and could not face reporters. He had even thought of refusing the Nobel Prize in order to shun publicity.

The main reason is that most of these great scientists incur lots of knowledge that they often find difficult to translate into lay man's language. When these scientists make landmark discoveries, they are overwhelmed by their achievements and try to explain them using scientific jargon, which often becomes dull for a non-science person. This will be misinterpreted and appear sinister, leading to misunderstanding and fear among the public.

Even though communication skills can be enhanced through training or by reading specified books, it's an inherent quality of a person that, in turn, depends on the passion for the subject one has. We can see such power when we listen to the speeches of our former President, the late Dr Abdul Kalam, even though his accent and pronunciation may not be at par with western standards. Many of our great scientists in the pre-independence era like Sir C V Raman and Sir JCBose were lively speakers because of their passion for research and their subject of interest.


Gone are the days when engaging in popular science communication was seen as career suicide. Every prospective young researcher nowadays is expected to be a practitioner, someone who is willing to carry science out of the lab and into the culture. The field has now moved away from didactic, top-down approaches to communication to consider more inclusive approaches to communication that emphasize the need to engage a wider range of so-called 'public' in decisions about science, stemming from an initial concern among scientists and politicians that the general public lacked an understanding and appreciation of science.

In fact, Public Engagement in Science and Technology (PEST) continues to be a key priority as governments around the globe seek to encourage citizens to participate in debates about new emerging science, such as quantum technology, nanotechnology, gene-editing, or stem cells. Whether personal or societal, tackling

global problems, such as climate change, also requires citizens to engage with science and technology. A science communicator of this age should be aware of science and technology, the economy, social structure of society and should have a world view of science.

Engaging diverse people in the community is a challenging task. Society includes varied types of people, a scientifically elite group, illiterate people, students, retired people, homemakers, old age people etc. Scientific temper can be imparted in society only if we deliver science to each one of them. This is an arduous task, and conventional science communication practices may not be sufficient. A storytelling mode or puppet show maybe not be liked by the older people. Similarly, a science magazine or newspaper cannot be understood by an illiterate group. If science should be propagated among the masses in this century, we need to explore alternative strategies for harnessing the potential of digital technology.

The covid pandemic has shown the strength of digital media. When all communication channels stopped functioning, it was the intelligent phones that acted as a friend for millions of people across the globe. Every section of society uses smartphones as an entertainsource. People started believing what was delivered through Whatapp, and it acted as a knowledge resource for millions. Whatsapp has achieved what our universities failed to do for hundreds of years. Of course, the information through Whatsapp was not regulated, and many misinformations also were forwarded to people that few believed blindly.

We need to promote a reliable

and authentic digital platform for scientific information dissemination. India's mammoth internet user base of 500 million, split between 305 million urban Indians and 195 million rural Indians, can be reached with authentic science and technology content. Government has to give impetus to digital tools like OTT in science communication activities. OTT stands for Over-the-top. This means streaming across different devices whenever we want, possible because of "over-the-top," a convenient little term that explains the new delivery method of film and TV content over the internet. The beauty of OTT platforms is that one can view videos on their handset. There is no need for antennae or cable

The gaining popularity of OTT among the public is due to their cost-effectiveness, easy connectivity and broader outreach. The contents can be viewed by a person sitting in polar regions also if they have internet connectivity. Thanks to OTT video distribution technology, people now have a plethora of options at their fingertips. They can watch content on a variety of devices, including Smart TVs, Roku, PCs, tablets, smartphones, and gaming consoles. They can also use ap switching ment source and information to access numerous distributors for speciality programmes and view channels, providing them more control over the content they buy

In science communication, OTT platforms can be used to show live programmes or recorded videos on various topics. The public can directly interact with scientists working in remote corners of the world, for example, from our research stations in Antarctica or

Arctic regions. During the covid lockdown period, most of the scientific information was delivered to the public through the India Science, the OTT channel managed by the Department of Science and Technology. This science channel has made 681 programmes to disseminate corona-related information alone, apart from other regular shows. Unlike different science communication modes like print magazines or science demonstration lectures, OTT is cost-effective and has a broader reach. All types of science content can be streamed through it. Moreover, the peers from the science can directly interact with the viewers making it more

The generation who grew up during the pandemic has adapted to using smartphones either for entertainment or economic transactions. Even kids are comfortable playing and gaining knowledge through smartphones. Similarly, even illiterate persons in society are comfortable using smartphones, and they enjoy the video messages being forwarded to them.

Today's generation may not like the traditional forms of science communication like magazines, drama or puppet shows. They are interested in animation and virtual reality. OTT has shown its strength in the entertainment industry by replacing the stress given to cinema halls. Similarly, many infotainment channels like Discovery, National Geographic, Animal Planet, History etc. have started their OTT versions sensing its benefits. Science policymakers should give thrust to science communication by leveraging the potential of digital technologies to suit the new generation of our citizens

mid rising disaster risk threats to infrastructure, the world plans massive investments of \$94 trillion for disaster resilience in the Indiainitiated Coalition for Disaster Resilient Infrastructure (CDRI).

A disaster related to weather, climate or water hazard occurred every day on average over the past 50 years - killing 115 people and causing US\$ 202 million in losses daily, according to a new report of the World Meteorological Organization (WMO). Russians stymied in Ukraine; Finland favours joining NATO

lmost three months after ARussia shocked the world by invading Ukraine, its military faced a bogged-down war, the prospect of a bigger NATO and a defending country buoyed by its win in a hugely popular pan-European music competition on Sunday.

Finland announced it would apply to join NATO, as top diplomats from the Western alliance, including US Secretary of State Antony Blinken, gathered Sunday in Berlin to discuss the war.

Sweden's governing party plans to announce its position on seeking NATO membership later Sunday.

The two nonaligned Nordic nations becoming part of the alliance would pose an affront to Russian President Vladimir Putin, who has cited NATO's post-Cold War expansion in Eastern Europe as a threat to Russia. NATO says it is a purely defensive alliance.

Ukraine said it was holding off Russian offensives Sunday in the country's east. Western military officials said the campaign Moscow launched there after its forces failed to seize Kyiv, Ukraine's capital, had slowed to a snail's pace.

Defence Minister Oleksii Reznikov said Ukraine was

"entering a new — long-term phase of the war".

Russian forces control a horseshoe-shaped swath of territory in the Ukrainian areas of Donetsk and Luhansk, which make up the eastern Donbas region, along the border of the industrial region where Ukraine has battled Moscow-backed separatists since 2014.

In the southern Donbas, the Azov Sea port of Mariupol is now largely in Russian control, except for the few hundred troops left in the steel factory.

Neutral Europe recedes as Finns, Swedes edge toward NATO

With Finland and Sweden taking steps to join NATO, the list of "neutral" countries in Europe appears poised to shrink. Like two Nordic countries, other nations joined European Union for its promise economic and political unity without taking sides in East-West divide that has endured beyond end of

Cold war. But security concerns over Russia's ongoing invasion of Ukraine changed calculus for Finland and Sweden which have long espoused neutrality and caused other traditionally "neutral" countries to re-think what that term really means for them. Finland said it will decide on NATO membership in coming days while Sweden could follow suit as public opinion in both

favour of membership. While EU members are committed to coming to each other's defense in case of an external attack, the pledge has largely remained on paper as NATO's might overshadows bloc's own notions of collective defence. Yet, Turkey could still pour

The outbreak has triggered concern about a humanitarian crisis in North Korea because most of the country's 26 million people are believed to be unvaccinated against the coronavirus and its public health care system has been in shambles for decades. Some experts say North Korea might suffer huge fatalities if it doesn't immediately receive outside shipments of vaccines, medicines and other medical sup-

"Without COVID-19 test kits, North Korea is resorting to body temperature checks to guess at infections. But with such a very inferior and inaccurate method of examination, it's impossible to find asymptomatic virus carriers and control viral surges," said analyst Cheong Seong-Chang at South Korea's Sejong Institute. "As North Korea's (sus-

pected) COVID-19 infections are explosively increasing, its death toll is expected to continue to rise," Ĉheong added.

Devasahayam Pillai becomes 1st Indian layman to be declared saint

Devasahayam Pillai, who embraced Christianity in the 18th century, on Sunday became the first Indian layman to be declared a saint by Pope Francis during an impressive canonisation ceremony here at the Vatican. Devasahayam was recommended for the process of Beatification by the Vatican in 2004, at the request of the Kottar diocese, Tamil Nadu Bishops Council and the Conference of Catholic Bishops of India.

Pope Francis, 85, canonised Blessed Devasahayam during a Canonisation Mass in St Peter's Basilica in the Vatican.

A miracle attributed to Devasahayam was recognised by Pope Francis in 2014, clearing the path to his canonisation in 2022. It was the first canonisation ceremony at the Vatican in over two years. Pope Francis, who has been complaining of strained liga-ments in his right knee for months, used a wheelchair to preside over the ceremony. Nine others, including four women, were also canonised along with Devasahayam."Our calling is to serve the Gospel and our brothers and sisters, to offer our lives without expecting anything in return, or any worldly glory," the Pope said during the ceremony.


Govt working on comprehensive national tourism policy: GK Reddy

The government is taking a slew of initiatives to promote river cruise tourism, which include river front development, increasing the number of cruise ships to 1,000, infrastructure development for water parks, among others, he said at the event hosted by the Ports, Shipping and Waterways Ministry in collaboration with industry body Ficci.

During the day, as many as eight memorandum of understanding (MoUs) were signed between Mumbai Port Trust, Inland Waterways Authority of India (IWAI) and various

The domestic river cruise industry is at a nascent stage with an initial focus on NW 1 (Ganga) and NW 2 (Brahmaputra) servicing around 13,000 passenger movements in 2019, across 100 cruise trips, accounting for around 1 per cent of the glob-

PSB frauds fell 51% to ₹40K cr; number of cases not falling fast enough: RBI

New Delhi: Public sector banks 4,192 cases -- reflecting incireported over 51 per cent dip dents of a large number of in the amount involved in frauds to Rs 40,295.25 crore during the financial year ended March 2022, the Reserve Bank

of India has said. The 12 PSBs (Public Sector Banks) had reported frauds worth Rs 81,921.54 crore in preceding fiscal 2020-21, the Reserve Bank has said in response to an application under the Right to Information (RTI) Act.

However, the number of fraud cases didn't fall at the same pace as a total of 7,940 frauds reported by the PSBs in 2021-22, against 9,933 incidents reported in FY21, said the RBI's reply to Madhya Pradesh-based RTI activist Chandrashekhar Gaur.

According to the RBI data on frauds reported by PSBs in all categories during FY22, the highest amount of Rs 9,528.95 crore was reported by the citybased Punjab National Bank (PNB), involving 431 such inci-

The country's largest lender State Bank of India reported frauds worth Rs 6,932.37 crore in as many as

small value frauds.

Bank of India reported frauds worth Rs 5,923.99 crore (209 incidents), followed by Bank of Baroda at Rs 3,989.36 crore (280); Union Bank of India Rs 3,939 crore (627), while Canara Bank reported frauds worth Rs 3,230.18 crore in just 90 cases -- showing that the transactions were of high value frauds.

Among others, Indian Bank customers faced frauds amounting to Rs 2,038.28 crore in 211 cases; Indian Overseas Bank Rs 1,733.80 crore (312); Bank of Maharashtra Rs 1,139.36 crore (72 cases); Central Bank of India Rs 773.37 crore; UCO Bank Rs 611.54 crore (114 crore) and Punjab & Sind Bank reported frauds of Rs 455.04 crore in as many as 159 incidents.

RBI said that the data may change subject to rectification/update made subsequent to first reporting of banks (in respect of individual frauds). As per the RBI reply, the amount of frauds worth less than Rs 1 lakh has been recorded from April 1, 2017. PTI

Sale of low-unit price packs jumps as inflation soars



turers are opting to reduce product weight rather than price of items targeted at lowerend consumers, while resorting to single-digit price increase on some large packs and launching 'bridge packs', as they seek to overcome the impact of commodity price rise and unprecedented inflation.

Besides, they are also using economical packaging, recycled products, and cutting spending on advertising and marketing to counter sudden spur in costs due to geopolitical crises such as the Russia-Ukraine War as well as the export ban of Palm oil from Indonesia.

The growing commodity prices and unprecedented inflation touching a new high, has forced the consumers to tighten their purse strings and opt for the low-unit price (LUP) packs to maintain their household budgets.

Homegrown FMCG maker Dabur India has responded to this challenge with a mix of pricing actions and cost control measures, said its CEO Mohit Malhotra.

"In the urban markets, where the per capita income is higher and consumers have the spending power, we have taken up prices in larger packs. In the rural markets, on the other hand, where LUP packs are sold, we have seen grammage reduction to protect sacred price points like Re 1, Rs 5 and Rs 10," he said.

With no sign of inflation coming down in the coming quarters, FMCG companies are fighting back through grammage cuts, launch bridge packs and a single-digit price increase on some large packs.

have reduced the grammage of their products available at popular price points, ranging from soaps to noodles, chips to Aloo Bhujia and biscuits to choco-

"We have observed that some consumers have shifted to affordable packs or LUPs to manage their monthly grocery budget. We have also increased supplies of LUPs of our key brands across categories to meet this consumer need," Malhotra said.

Senior Category Head Mayank Shah said there are "some early signs" of downtrading, consumers turning to value packs, as the sale of low unit price packs is slightly going up.

Steel prices ease over 10%, coal crisis playing havoc on secondary steelmakers

Kolkata: Steel sector players are facing some heat owing to high input commodity prices as finished steel products have begun to decline since April after the Russia-Ukraine war

He was 46 and is survived by his wife and two young children.

Cricket Australia has now lost three prominent figures in the past two months. Spin legend Shane Warne and former wicketkeeper Rodney Marsh had died within hours of each other in March.

According to a statement issued by Queensland police, the accident happened in Hervey Range Road, about 50 km outside Townsville in northeast Australia on Saturday night.

An attacking batter, who could also bowl both medium pace and spin and an outstanding fielder, Symonds featured in 26 Tests, 198 ODIs and 14 T20Is in a successful career between 1998 and 2009.



He helped Australia win the ODI world Cups in 2003 and 2007 and was one of the key members of Australia's Test side in the 2000s

With the ball, he snared a total of 165 wickets in his international career, including 24 in ests, 133 in ODIs and 8 in T20Is.

One of his greatest moment the cricketing field came playing in the IPL for now-

after coming on to bat with Australia at 86 for four against Pakistan in the opening ODI of the 2003 World Cup. Symonds scored 5088 runs,

including six hundreds, in his ODI career since making debut in 1998. He also featured in 14 T20Is and averaged 48.14, besides

A hard-fought final had finished a 0-0 draw after extra-time, setting the stage for a nerve-jangling shoot-out that featured misses by Chelsea's Cesar Azpilicueta and Sadio Mane, whose shot was saved by Edouard Mendy when he had a chance to clinch the trophy.

For the second time this season, Liverpool emerged victorious against Chelsea on penalties, having already beaten them 11-10 following another 0-0 draw in the

Barcelona coach Xavi Hernandez suggested on Saturday the club's dire financial situation could force them to consider selling Frenkie de Jong this summer.

De Jong joined Barca for 75 million euros from Ajax in 2019 and while he has been a solid performer and a regular starter at Camp Nou, the Dutchman has not quite lived up to expectations.

With the likes of Pedri, Gavi, Nico Gonzalez and Sergio Busquets all competing for spots in midfield, Barcelona could view the 25year-old De Jong as an opportunity to raise funds. "He is a very important

player, he has been a starter almost always. He is a fundamental footballer," said Xavi in a press conference on Saturday. "Then there is the financial situation of the club, which we depend on. He should be a big part of this era of the club but we'll see what happens." La Liga have set Barca's spending limit at minus 144 million euros for the upcoming summer transfer window, after financial losses were found to be 242 million

euros more than expected. Barcelona president Joan Laporta said at the start of the season the club were 1.35 bil-



lion euros in debt, with La Liga rules stating they would have to save four euros for every one

spent on new additions. "The circumstances of the club dictate everything," said Xavi. "We depend on the financial situation. In a few days we will know where we are and we have to start planning now." Barca are, though, interested in Robert Lewandowski, the 33-yearold striker who said on Saturday he will not be extending his Bayern Munich contract, which expires in June 2023.

Asked about buying older players, Xavi said: "It doesn't stop me. I signed Dani Alves at 38. It's not about age, it's about performance.

Lewandowski confirms he wants to leave Bayern

Robert Lewandowski confirmed on Saturday that he wants to leave Bayern Munich this summer amid reports Barcelona are ready to offer the 33-year-old star striker a threeyear contract. Lewandowki banged in

Kumar rated this as Indian badminton's biggest ever achievement. 'I will rate this the biggest ever. Of
