China builds bridge at Pangong face-off site

2nd Chinese bridge 15 km from LAC will enable PLA to rush troops, tanks to border front quickly



China is constructing a bridge on its side at the Pangong Tso (lake) there to enable its troops to rush to the front in the shortest possible time. This even as talks are on to defuse tension at the border in Ladakh. The first stand-off between the two Armies took place in May in 2020 snow-

balling into a major crisis.

The latest development came to light after satellite images captured the scene of China constructing the second bridge at the lake, sources said here on Wednesday. It will enable China to rapidly deploy tanks and armoured columns. The first bridge built was for troops and later used as a service bridge for construction of the second bridge. It is just 15 km from the Line of Actual Control (LAC).

The construction of the first bridge finished last month in about a year, sources said. China is building the second



bridge simultaneously from both sides for speedy construction. It is broader and stronger to enable the tanks to cross over from one side to another, they said.

The first bridge has cut

down travelling time at the 180-km loop from Khurnak to the southern banks through Rudok. Now, the route is just 50 km, thereby giving China an edge in logistical terms.

Damien Symon, a geospatial intelligence researcher, who keeps track of Chinese activities along the LAC, posted satellite images of the new

construction on Twitter. Symon, who uses the handle @detresfa_ said a "larger bridge" is being developed parallel to the first one, adding the likely aim of the construction is to "support larger/heavier movement" (of the military) over the lake.

China is rapidly strengthening its military infrastructure after Indian troops captured several strategic peaks on the southern bank of the Pangong lake in August 2020 after the Chinese PLA attempted to intimidate them in the area.

Hardik resigns,

Gujarat Congress working president Hardik Patel on Wednesday resigned from all party posts and took to Twitter to share the letter to party pres ident Sonia Gandhi in which he made scathing remarks against the party leadership, including Rahul Gandhi.

In his resignation letter months ahead of the Gujarat Assembly elections, the young Patidar leader accused the Congress of "working against the interest of the country and society". Patel, who joined the Congress in 2019 promising to die as a Congressman, said in his letter that whenever he raised issues of the people of Gujarat, senior Congress leaders were busy checking messages on their mobile phones, and some leaders were "enjoying abroad" when the party and the country needed them.

"Today, after mustering courage, I am resigning from my party post and primary membership of the Congress. hope my followers and people of Gujarat will welcome my step. I believe that I will be able to serve the State better after this step," Patel said in a tweet.

Patel claimed that despite several attempts to steer the Congress in the right direction, the party has constantly been working "against the interests of my country and our society".

Delhi Lieutenant-Governor Anil Baijal on Wednesday submitted his resignation to President Ram Nath Kovind, citing personal reasons. Baijal, a 1969-batch IAS officer, was appointed as the 21st Lieutenant Governor of Delhi on December 31, 2016 after the sudden resignation of his predecessor Najeeb Jung.

Baijal had often been at loggerheads with Delhi Chief Minister Arvind Kejriwal over several issues. In 2018, the strife between Baijal and the Delhi Government escalated into an ugly confrontation after Kejriwal and his Ministers staged a dharna at Baijal's office alleging that IAS officers posted with the State Government were not cooperating with elected representatives. There was acrimony over the non-approval of the doorstep deliv-

ery of ration scheme by Baijal. The tense relations between the LG and the AAP dispensation became less frequent after the Supreme Court ruling in July 2018 that states the LG of Delhi is bound by the "aid and advice" of the $\dot{D}elhi$ Government.

SC orders release of Rajiv's assassin after 30 yrs in jail

Cong accuses Govt of petty politics for **AG Perarivalan's** release from prison

The Supreme Court Wednesday ordered the release of AG Perarivalan, who has served over 30 years in jail in the Rajiv Gandhi assassination case. Congress slammed the Centre for creating "a situation" in the court to get the killer of a former Prime Minister released for their "petty and cheap politics", but the DMK, the AIADMK and the CPI wholeheartedly welcomed the verdict.

The SC bench headed by Justice L Nageswara Rao said the Tamil Nadu State Cabinet's advice recommending the premature release of all seven convicts in the case was binding on the Governor. The apex court also discarded the Centre's argument that the pleas of pardon under Article

President exclusively has the power to grant pardon in a case under Section 302 of the Indian Penal Code, saying this would render Article 161 (power of Governor to grant pardon) functionless.



On March 9, the top court had granted bail to Perarivalan while taking note of his long incarceration and no history of complaints when out on parole.

SC has been hearing pleas, including the one in which Perarivalan sought suspension of his life sentence in the case till the Multi Disciplanary Monitoring Agency (MDMA) probe is completed.

Indrani gets bail in Sheena Bora murder case

PNS NEW DELHI

The Supreme Court on Wednesday granted bail to Indrani Mukerjea, the prime daughter Sheena Bora, saying six-and-a-half years in prison is too long a term and that the trial will not be completed

anytime soon. A three-judge bench headed by Justice L Nageswara Rao noted that Indrani has been in jail since 2015. He said the trial could not be over soon as out of 237 witnesses cited by prosecution only 68 have been examined till date.

'We do not intend to make comments on the merits of the case as it might be detrimental to the interests of the parties. Taking into account that petitioner has been in custody for six-and-a-half-years and even if 50 per cent witnesses are given by prosecution, the trial would not be over soon, we are of the considered view that the

petitioner is entitled to be released on bail. Continued on Page 2

Post-corona eco recovery on BRICS summit agenda

Issues including economic situation post-corona pandemic will figure prominently at BRICS foreign ministers summit in Beijing on Thursday. External Affairs Minister S Jaishankar will take part in it through video conference. The high-profile meet takes place against the backdrop of the ongoing Ukraine conflict. Brazil, China, India, Russia and South Africa are members of the BRICS

Besides Jaishankar, South African Minister International Relations and Cooperation Naledi Pandor, Brazilian Foreign Minister Carlos Franca and Russian Foreign Minister Sergey Lavrov will attend the meeting chaired by China's State Councillor and Foreign Minister Wang Yi.



Yi had visited India in late March and held bilateral dialogue with Jaishankar on the stand-offs for the last two years at the Line of Actual Control (LAC) in Eastern Ladakh. It was the first visit by a Chinese minister to India since the face-off erupted at the border.

Giving details of the upcoming BRICS conclave, Chinese Foreign Ministry spokesperson Wang Wenbin said in Beijing that the minister will have a "BRICS+" dialogue with their counterparts

from emerging markets and devel oping countries. He, however, did not disclose the names of the countries taking part in the BRICS+ dialogue. China holds the chair of the BRICS this year.

About China's expectations of the BRICS foreign ministers meeting, Wang Wenbin said the meeting will send a "clear message" of unity and make preparations for the annual summit of the fivemember bloc.

"We will send a clear message of BRICS countries working together in solidarity, upholding true multilateralism, staying united in fighting Covid-19, and promoting peaceful development," he said. Continued on Page 2

9.8 lakh were caused by PM2.5 pollution, and another 6.1 lakh

Although the number of deaths from pollution sources associated with extreme poverty (such as indoor air pollution and water pollution) has decreased, these reductions are offset by increased deaths attributable to industrial pollution (such as ambient air pollution and chemical pollution),

Overall, global ambient air

pollution was responsible for 45 lakh deaths, and hazardous chemical pollutants for 17 lakh, with 9 lakh deaths attributable to lead pollution.

Nearly 93 per cent of India lives in areas where air quality is below WHO's standards, says the study. In an update of a 2015 estimate on premature deaths caused by pollution, the study said data from the Global Burden of Diseases, Injuries and Risk Factors Study 2019 (GBD) showed that pollution "remains responsible for approximately nine million deaths per year."

According to the report, air pollution is most severe in the Indo-Gangetic Plain which covers New Delhi and many of the most polluted cities. Burning of biomass in households was the single largest cause of air pollution deaths in India, followed by coal combustion and crop burning.

The study noted that despite India's considerable efforts against household air pollution, including through the Pradhan Mantri Ujjwala Yojana programme, the number of deaths remained high. It pointed out that India has developed a National Clean Air Programme, and in 2019 launched a Commission for Air Quality Management in the

National Capital Region. However, India does not have a strong centralised administrative system to drive its air pollution control efforts and consequently improvements in overall air quality have been limited and uneven.

In its May 1999 order, the top court had upheld the death sentence of four convicts --Perarivalan, Murugan, Santhan and Nalini. In April 2000, the Tamil Nadu Governor had commuted the death sentence of Nalini on the basis of the State Government's recommendation and an appeal by former Congress president and Rajiv Gandhi's widow Sonia Gandhi. On February 18, 2014, Supreme Court had commuted the death sentence of Perarivalan to life imprisonment, along with that of two other prisoners -- Santhan and Murugan -- on the grounds of an 11-year delay in deciding

Earlier, the single Bench of Justice Abhijit Gangopadhyay directed Chatterjee to appear before the CBI on Wednesday, failing which, the agency was asked to take him into custody for interrogation if it so wished.

The single bench order was challenged by the Bengal Minister in the Division Bench of Justice Subrata Talukdar, which, after hearing the case, preserved the earlier order on Wednesday.

Subsequently, Chatterjee moved the Division Bench of Justice Harish Tandon seeking modification in the single Bench order — to the extent of restraining the CBI from arresting him.

The Bench of Justice Tandon, however, dismissed

his plea on technical grounds leaving the Central agency free not only to interrogate but also arrest him if itso wished.

Bhardwaj said Khattar will have to bear the repercussions as a large number of people from Haryana living and working in Delhi are grappling with

The curtailment of water production has severely affected water supply in the administratively sensitive areas of south Delhi and New Delhi, including diplomatic areas, President's House, Supreme and establishments of national and international impor-

"Against Delhi's potable water requirement of 1,260 MGD, only 819 MGD was produced against the desired production of 875 MGD on May 16... As adequate raw water was not available through the river Yamuna," the DJB

Order CBI probe into maintenance of old DTC buses, Gupta urges Shah

fter the national Capital After the national Capital reported several incidents of buses catching fire this season, Delhi BJP chief Adesh Gupta wrote a letter to Union Home Minister Amit Shah urging him to order a Central Bureau of Investigation (CBI) probe into the maintenance of old Delhi Transport Corporation (DTC) buses. He also claimed that the buses running in the Capital city were catching fire because they were old and had reached end of life.

According to the Delhi BJP chief's letter, "A ₹50 lakh tender has been awarded for the maintenance of the old DTC buses for three years and this smells of corruption."

Gupta wrote, "There was a provision for phasing out these buses after running for 7.5 lakh kms or completing 12 years. But the Kejriwal Government wrongly changed the provision, making it 15

years."
"The lives of Delhiites are in danger due to the negligence of the Delhi Government. A big accident might occur any day, the Delhi BJP chief said, urging Shah to order a CBI probe into the matter.

Gupta further alleged that no new bus has been bought for the DTC since Arvind Kejriwal became Chief Minister of Delhi. The number of DTC buses has come down from 6,200 to 3,700, he claimed.

According to a DTC official, "At present city has only two electric buses but by the next week 100 more e-buses will arrive for the public service. The buses will be officially inaugurated by the chief min-

ister or the transport minister." Last month, the Delhi Government formed a sixmember committee to find the root cause of DTC buses catching fire. The committee's report

In a recent order dated 06/05/2022, the court questioned DDA for not taking possession of the land since 2019 and directed the authority to take over the possession of land forthwith," he informed.

"The demolition programme on the land under reference was earlier scheduled thrice, but could not be carried out due to the non-availability of sufficient police force. The demolition programme on the land under reference was again fixed for today in accordance with the above facts, which has been only partially carried out due to protests by the locals,

Farmhouses, shops demolished in Bhondsi, Sohna in Gurugram

Gurugram: A team of the District Town and Country Planning (DTCP) on Wednesday carried out a demolition drive in the villages of Bhondsi and Sohna in which commercial farmhouses, shops and under-construction structures were demolished. RS Bhath, District Town Planner (Enforcement), said that the colonies were being developed in violation of rules, without necessary permissions from the competent authority.

We conducted the drive after a complaint was received on the CM's window. We will conduct such drives in future to build people's trust in the CM's window. The department will soon recommend filing of FIRs against those who were involved in developing illegal colonies. Notices were also issued to plot owners earlier as well," Bhath said.

During the drive, six unauthorised colonies in approximately 35 acres located in the area were demolished with the help of three earthmovers. 100 policemen were present at the spot to deal with any untoward incident.

Three earthmoving machines were pressed

into service to demolish illegal constructions.

"All six colonies were in initial stages and demarcation of plots by way of DPCs, boundary walls was being done. Commercial farm houses spread in over 2.5 acres and under construction shops and road network was demolished," Bhath added

CBI books Karti's frontman in cash-for-visa scam case

Post-day-long searches in the cash-for-visa scam allegedly masterminded by Lok Sabha MP Karti Chidambaram, the CBI on Wednesday arrested his Chartered Accountant and close associate/front man S Bhaskararaman.

Karti, son of former Union Home and Finance Minister P Chidambaram, along with Bhaskararaman and others are accused in a Rs 50-lakh bribery case for clearing visas of 263 Chinese nationals working at Talwandi Sabo Power Ltd (TSPL) in Punjab.

The bribery incident allegedly took place in 2011 when Karti's father P Chidambaram was the Union Home Minister.

Officials said the CBI took Bhaskararaman for questioning late on Tuesday night and he was arrested in the early hours of Wednesday.

In its FIR, the agency has alleged that Bhaskararaman was approached by Vikas Makharia, the then Associate Vice President of TSPL, for the reissuance of project visas for 263 Chinese workers working at the Mansa-based power plant which was in the process



The CBI FIR, which contains the findings of the investigating officer of the Preliminary Enquiry (PE), has alleged that Makharia approached Karti through his 'close associate/front man" Bhaskararaman.

They (accused persons in the case) devised a backdoor way to defeat the purpose of ceiling (maximum number of project visas permissible to the company's plant) by granting permission to reuse 263 project visas allotted to the said Chinese company's officials," officials said.

Project visas were a special type of travel document introduced in 2010 for the power and steel sectors for which detailed guidelines were issued

during senior Chidambaram's tenure as the Home Minister but there was no provision of reissuance of project visas, the FIR alleged.

"As per prevalent guidelines, deviation in rare and exceptional cases could be considered and granted only with the approval of the Home Secretary. However, in view of the above circumstances, the deviation in terms of reuse of project visas is likely to be approved by the then Home Minister...," the FIR further alleged.

Makharia allegedly submitted a letter to the Home Ministry on July 30, 2011, seeking approval to reuse the project visas allotted to his company, which was approved within a month and permission

Tuesday when the agency conducted coordinated searches at 10 locations, including Karti's residence in Chennai and Delhi. "On August 17, 2011, Makharia, on being directed by Bhaskararaman, sent a copy of the above letter dated July 30, 2011 to him through e-mail which was forwarded to Karti... Bhaskararaman after discussion with P Chidambaram, the then Home Minister, demanded an illegal gratification of Rs 50 lakh for ensuring the approval," the FIR further

The payment of the said bribe was routed from TSPL to Karti and Bhaskararaman through Mumbai-based Bell Tools Ltd with payments camouflaged under two invoices raised for consultancy and out of pocket expenses for Chinese visas related works. However, the Mumbai-based firm was never engaged in any kind of work relating to visas, rather it was in an entirely different business of industrial knives, the agency has alleged.

SC appoints CoA | SC permits reservation to manage affairs of football union

he Supreme Court on The Supreme Court on Wednesday appointed a three- member Committee of Administrators (CoA) headed by former top court judge AR Dave to manage the affairs of the All India Football Federation (AIFF) and adoption of its constitution in line with the National Sports Code and model guidelines. A bench of Justices DY Chandrachud, Surya Kant and PS Narasimha said the COA will comprise two earlier members--Dr SY Qureshi, former Chief Election Commissioner and Bhaskar Ganguly, former captain of the Indian Football Team besides Justice (retd) Dave. The apex court said the current state of affairs is not in the interest of proper governance of the federation. It directed the CoA to forthwith take charge of the AIFF and assist the court by providing inputs to the court in facilitating the adoption of the constitution by the AIFF in accordance with the National Sports Code and model guide-

lines. The bench said the COA will prepare electoral rolls for the purpose of conducting elections to the executive committee of AIFF as per the constitution to be submitted by the two-member committée (ombudsman) of Qureshi

and Ganguly. "The committee of administrators shall carry out day-today governance of the All India Football Federation", the bench said, adding the COA will be at a liberty to take the assistance of the erstwhile committee of the federation in holding of tournaments and selection of players and other affairs. The bench said the newly constituted committee of administrators shall sit in Football House at Dwarka or any other place of convenience.

The top court clarified that this is pro-tem arrangement in order to facilitate the holding of elections and handing over the affairs to the democratically elected body in accordance with the constitution. It added that it is anticipated the elections are held at the expeditious date.

The Supreme Court Wednesday permitted reservation for the Other Backward Classes (OBCs) in the local body elections in Madhya Pradesh.

The apex court, which had passed an order on May 10 and noted that no reservation for OBCs can be provisioned until the triple test formality is completed "in all respects" by the state government, permitted the state to notify the reservation pattern local body wise as delineated in the reports of the dedicated commission.

A bench headed by Justice A M Khanwilkar passed the order on an application filed by the state seeking modification of the May 10 order and permitting the conduct of elections based on recently notified delimitation.

In the application, the state government had also urged the court to permit it to notify reservation for OBCs based on the recommendation of the OBC Commission in the second report of May 12 and for Scheduled Castes/Scheduled Tribes with-

The World Meteorological Organisation (WMO) State of the Global Climate in 2021 report said, "It (climate change) wreaked a heavy toll on human lives and well-being and triggered shocks for food and water security and displacement that have accentuated in

Global annual mean temperature difference is considered from pre-industrial conditions (1850-1900) for six global temperature data sets (1850-2021).

The report confirmed that the past seven years have been the warmest seven years on record and that year 2021 was 'only" one of the seven warmest because of a La Nina event (ocean phenomenon in the Pacifics) at the start and end of the year. "This had a temporary cooling effect, but did not reverse the overall trend of rising temperatures.



The average global temperature in 2021 was about 1.11 (plus/minus 0.13) degrees Celsius above the pre-indus-

The Supreme Court order I releasing A G Perarivalan, one of the accused in the 1991 assassination of former Prime Minister Rajiv Gandhi, has been welcomed by the DMK and its trusted allies in Tamil Nadu. The Dravidian major and a number of fringe elements like VCK, MDMK, the Communists and various frontal organisations of the LTTE operating in the State were demanding from rooftops for the release of all the accused held in connection with the

It was on May 21, 1991 Rajiv Gandhi who was campaigning for the party candidate at Sriperumbudur Lok Sabha constituency was assassinated by the Liberation Tigers of Tamil Eeelam terrorists operating in Tamil Nadu with impunity. The DMK was extending full support to the LTTE which had made the southern districts of the State their base camp. Even as this matter is on its way to the Press, the Congress leaders in Tamil Nadu have not reacted publicly to the decision.

The Supreme Court order to release Perarivalan (50) from imprisonment comes three days prior to the 31st anniversary of the martyrdom of Rajiv

Gandhi. All the accused in the assassination case were sentenced to death by the trial court and was upheld by the Supreme Court. But the delay in taking a decision over their clemency petitions to the President of India saved them from the gallows. Nalini, one of the prime accused was pardoned by the then Governor of Tamil Nadu at the instance of the then chief minister M Karunanidhi and her death sentence was commuted to life imprisonment. Efforts are on to get the six other assassins too released and the mission has full political patronage of Chief Minister M K Stalin.

It is a strange paradox that the Congress (of which Rajiv Gandhi was the president at the time of his murder) is finding itself in a no-man's land in this crucial hour. No senior leaders of the party in the State, including P Chidambaram, the main party ideologist, has dared to tell anything against the move by the DMK to get the assassins released. Latest victim of targeted killing cremated in Rajouri

He is survived by his wife, four daughters and a minor son. According to family members, Singh left home only two weeks ago to earn his livelihood. He along with three other employees received injuries in the grenade attack. Singh, later, succumbed to his injuries in the hospital.

One of the daughters, holding her minor brother in her lap, appealed to the UT administration to do justice with the

family.
"We need justice. Our father was earning his livelihood when he was targeted and killed. He was innocent. How can we survive, who will look after our family and feed us after his untimely death in a terror attack? Before the cremation ceremony was performed the local administration had to persuade the agi-



tating family members to lift the dharna in the middle of the road. BJP leader Ravinder Raina and Surinder Choudhary also attended the cremation ceremony.

unfortunate that the assassin of a former prime minister has been released, he said. "Today is a sad day for the country. There is sorrow and fury not only in every Congress worker, but in every Indian who believes in India and Indianness, who believes in fighting against extremism and every force that challenges the sovereignty and integrity of India," he told reporters. He also wondered if the

lakhs of convicts facing life terms should be freed. This is not a question about Rajiv Gandhi, but about a prime minister who was killed, he said, adding the soul of every person fighting against terrorism has been hurt. "Rajiv ji had sacrificed his

life for the country, not for the Congress. And if today's government creates a situation in

the court to get his killers released for their petty and cheap politics, then it is very unfortunate and it is condemnable.

"We condemn this in the strongest possible way. All Indians must see what kind of governments are in power today and what are their attitude towards extremism is," he said. Invoking its extraordinary power under Article 142 of the Constitution, the Supreme Court Wednesday ordered the release of A G Perarivalan, who has served over 30 years in jail in the Rajiv Gandhi assassination case.

A bench headed by Justice Nageswara Rao said the Tamil Nadu state cabinet's advice recommending the premature release of all seven convicts in the case was binding on the governor.

Hawking tuitions

Colleges promote coaching institutes on their campuses to make a fast buck

nommercialisation of education has reached brazen levels of exploitation. A few Delhi University colleges stand accused of tying up with private coaching institutes to allow them access to the college premises to conduct classes for various examinations. A college promotes private coaching classes for UPSC examinations. Another recommends on-campus classes for this year's Common University Entrance Test (CUET). Students taking admission to undergraduate courses are the targeted "clients". A three-year coaching session can cost up to ₹1.5 lakh per person. It is big money at no cost. These private centres gain legitimacy too, thanks to the collusion with colleges of repute. A group of students and teachers is protesting the tie-ups. Shockingly, public-funded institutions supposed to give subsidised education are involved in this com-



mercial activity. The University Grants Commission and the Union Ministry of Education must nip this exercise in the bud. Private coaching classes for IAS aspirants have been around for decades, propagating the myth that cracking the exam is impossible without coaching. It is nothing but a myth, an expensive one because in recent years many candidates have made it to the IAS and other services without private coaching. A candidate from rural Bihar secured 10th rank last year with no coaching. The son of a cloth seller got into IAS with self-study. A girl from Harvana cleared the UPSC in her final attempt without attending coach-

ing classes. A majority of successful candidates who hail from the countryside are clearing the examination on the strength of their fortitude.

This is not to say coaching classes should be avoided. Those who can afford the fees can go ahead. However, colleges cannot join the business by teaming up with private coaching centres. That is not their remit. The bane of the Indian education system is two-fold. One, the formal system of education is affected by an unscientific, even controversial, approach to selecting the curriculum and teaching and evaluation methods. Two, as a result, private tuitions are now a necessary evil, running a parallel system that is gradually eating into the core of formal education. The tie-up experiment deliberately undermines institutional education. China recently found out how deeply entrenched the malaise of private coaching is when it banned the expensive private tutoring industry; parents merely turned to the black market for tutors. This is not the only facet of commercialisation that plagues education in India. The Department of Education recently intervened in the money-making methods of private schools by warning them not to force parents to buy books, uniforms and even shoes from shops on the school premises or specific private vendors at expensive rates. It also asked schools not to change the colour or design of school uniforms for at least three years to plug an additional source of easy profit. Most private engineering and medical colleges exist for profit in the form of high capitation fees. What next? Home delivery of education?



Death by breath

Air pollution is the single largest killer in India, and climate change is compounding it

ndia has been hit by a double whammy: Climate change impact and spiralling pollution levels. Though the country has made significant strides against household air pollution, most notably through the Pradhan Mantri Uijwala Yojana programme, it hasn't been enough to prevent it from the ignominy of having the world's largest estimated number of air pollution-related deaths. Rising temperatures and untimely rain are linked to climate change, which led to a manifold rise in vectorborne diseases in 2021. With last year recording the number of dengue infections at 1,93,245 and the number of deaths at 306, the figure was the highest since 2018. But that's not all — the country is likely to witness erratic and excess rain-



As for the rising pollution levels, more than 6.6 million premature deaths were recorded across the

globe due to air pollution in 2019, with India accounting for the highest share of these fatalities at 1.67 million, or 17.8 per cent. Overall, the various types of pollution wiped off nine million people though, if there's a macabre consolation, it's that the number has remained unchanged since the last analysis in 2015. Unfortunately, the nine million fatalities correspond to one in six reported deaths worldwide to various reasons. Besides air, water pollution was responsible for 1.36 million premature deaths while lead exposure claimed another nine lakh lives. However, alarm bells should ring as regards the ambient air pollution, which refers to air under the normal circumstances and which was responsible for 4.5 million deaths in 2019. The rising threat from ambient air pollution can be gauged from the fact that it had claimed a relatively lower 4.2 million lives in 2015 and 2.9 million way back in 2000.

very year, April 18 marks the World Heritage Day. The origin of this special day can be traced back to 1982 when the International Council for Monuments and Sites (ICOMOS) established it as the International Day for Monuments and Sites. Later, during its 22nd general conference, Unesco adopted it as the World Heritage Day. The dignity of a society is reflected in the value it attaches to its cultural heritage. The sum total of cultural heritage is a nation, community or group's language, books, literature, rituals, knowledge, traditions, performing arts, crafts, festive events, monuments and sites of historical relevance. It's, therefore, our moral and civic duty to preserve, conserve and protect our cultural heritage.

In India, the 500-years-old Babri Masjid in Ayodhya was demolished on December 6, 1992, by a radical Hindu mob led by Sangh Parivar leaders. Intellectuals across the globe, irrespective of caste, creed, religion or region, condemned the demolition. Muslims across the world protested. Several lives were lost. In its landmark judgment of 2019, the Supreme Court held that the demolition was illegal and directed the authorities to allot an alternative plot for a mosque as compensation.

On the other hand, the more heinous crime of multiple demolitions of holy shrines, relics and heritage sites together with massacres took place in Saudi Arabia. This was done at the behest of Saudi Arab's Wahabi/Salafi rulers of Zionist ancestry who, wearing the cloak of Islam, in the middle of the 18th century introduced a new distorted version of Islam purely based on terrorism. This new cult was named 'Wahabism' in the name of its founder, Sheikh Muhammad Najdi-ibn-Abd-al-Wahab, who was born in the desert of Najd of Arabian

On June 2, 1792, Sheikh Najdi, the founder of Wahabism died, leaving behind 24 wives and 18 children. His son-in-law Abdal-Aziz speeded up his violent

actions and conversions. In 1802, he attacked the holiest shrine of Hazrat Imam Husain in Karbala (Iraq), desecrating the shrine. Lieutenant Francis Warden wrote: "They pillaged the whole of it and plundered the tomb of Hazrat Imam Husain, slaying in the course of the day, with circumstances of peculiar cruelty, above 5,000 of the inhabitants. A huge amount of booty was seized."

In 1803, Abd-al-Aziz-ibn-Saud obtained a visit permit from the Shareef of Mecca on the pretext of performing Hajj; wherein, his Wahabi fighters laid waste in Islam's holiest shrine (Ka'aba), like the accursed Yazid-ibn-Muawiya desecrated Ka'aba in 682 AD. According to TE Ravenshaw, author of A memorandum on the sect of Wahhabis': "They robbed the splendid tombs of the Mahomedan saints, who were interred there; and their fanatical zeal did not even spare the Prophet's Mosque journalist and author. The (Masjid ul Nabavi) in Medina,

which they robbed of the immense treasures and costly furniture to which each Mahomedan Prince of Europe, Asia and Africa had contributed his share.

In 1804, a Wahabi gang of terrorists again crossed the great desert in the Hijaz and destroyed tombs of the Prophet's family members at Jannat-ul-Baqi, the ancient cemetery of Medina, and even despoiled the grave of Prophet Mohammad. Again in 1925 (On 8th Shawwal 1344 Hijri), Wahabi terrorists demolished the holy shrines of Hazrat Fatima Zehra, daughter of Holy Prophet, and his grandsons, Hazrat Imam Hasan, Hazrat Imam Zain ul Abedeen, Hazrat Imam Mohammad Bagar.

On December 6, every year marking the anniversary of the demolition of Babri Masjid, Muslims organise protests, file petitions in court. Whereas, on 8th Shawwal, 1344 Hijri (1925 AD), Saudi Arab rulers had razed the holy tombs of Prophet Mohammad's family, but surprisingly no Muslim of any sect reacts or protests against the pseudo-Muslim Saudi rulers. Is it because those perpetrators are not non-Muslims?

TOBACCO: WORST ENEMY OF WOMEN AND KIDS

Passive smoking snuffs out at least one million lives every year

le must work on strategies to make tobacco products out of the reach of people in the larger interest of the society and also save them as well as women and kids from exposure to second-hand smoke at home, work and in public places. Exposure to tobacco, either active or passive, is associated with not only health but also financial burden on the consumer, family, economy and ultimately the nation. In the case of women, tobacco use has all the more serious gender-related health complications like breast cancer, reproductive related health ailments besides its adverse impact on unborn babies. Contrary to the general perception, unfortunately tobacco consumption is widely prevalent among the fair sex in India. I remember, as a child when I used to visit my village, I saw many women, cutting across economic strata, engaged in consumption of a range of tobacco products. Beedi is particularly more common. It is just the tip of the iceberg. More and more women, particularly the younger generation, are indulging into smoking habits, viewing it as a fashion symbol. In this context, I would like to share an observation made by a recent study published in the journal 'Breast Cancer Research, according to which, smoking is associated with a significantly increased risk of breast cancer, especially in those women who started smoking during adolescence or who have a family history of the disease. Spiralling rise in tobacco consumption by girls and women is directly linked to aggressive marketing strategies adopted by tobacco com-



panies that increasingly target this group, particularly in low-income and middle income countries like India. In a bid to earn quick bucks, players in the sector are not even sparing small children as they target them by selling candies alongside tobacco products.

The Government must work on strategies to make these products out of the reach of people in the larger interest of the society; and also save them as well as women from exposure to second-hand smoke at home, work and in public places. First, it can be done through major amendments in the Cigarettes & Other Tobacco Products Act of Government of India (COTPA) having provisions such as ban on designated smoking zones that will help in cutting down tobacco consumption among the public and thus suffering from several ill effects of tobacco. In this regard, regular counselling is needed. Once the children become addicted to tobacco products like gutkha, khaini or cigarettes, it becomes difficult for them to shun the habit. While awareness and education of this vulnerable group is mandatory, stringent measures should be taken to ensure that such sin goods are not sold to the children. The Government must ensure that the cigarettes and other tobacco items should be out of the immediate eye contact of children when they purchase their candies in the shops. This gap in COTPA that allows 'point of sale' advertising and product displays, is being blatantly misused by tobacco players to target children and youth; so, this gap must be plugged immediately. At least we can do this much for our younger generation. The Government also needs to scrutinise and keep a tab on what is being shown in films; and if tobacco is promoted by celebrity film stars and cricketers. Media, on its part, can also play a major role in the campaign to stop the use of tobacco. The policymakers and authorities cannot afford to take their eye off the health hazards that tobacco is causing on its vulnerable and productive citizens before the epidemic becomes uncontrollable. After all, a stitch in time saves nine.

Urban forestry or unplanned forestry



Urban forestry is the only plausible and most effective nature-based solution for building green, sustainable and resilient cities

oday, over half of the world's population lives in urban areas and this proportion is estimated to increase to 66 percent by 2050. It is also estimated that India, China, and Nigeria will experience significant urban growth in the coming years, and by 2050, India is projected to add nearly 404 million urban dwellers.

A major factor behind this rise is an influx of millions of workers, students, and families seeking jobs, education, and a better quality of life. As a consequence, cities today are overcrowded, urban space is becoming more concrete, and urban infrastructure is under tremendous pressure. Further, urban sprawl and massive human intervention have depleted the urban ecosystems and increased urban vulnerability to

Urban management like ensuring adequate food supplies, clean water, clean air, energy, housing, education and green space has become this century's greatest development challenge for urban planners and city administrators. In many cities, the air quality index is also worrisome and air toxicity is compounding health problems such as respiratory diseases. Similarly, extreme temperatures and more frequent heatwaves are contributing to heat-related mortality and aggravating urban heat island effects. Today, many cities are fast running out of space needed for trees, forests, and animals, which are essential to make any city a liveable and healthy place.

Considering the current situation, urban forestry is the only plausible and most effective nature-based solution for building green, sustainable and resilient cities. Urban forestry is the "sustained planning, planting, protection, maintenance, and care of trees, forests, greenspace and related resources in and around cities and communities for the ecological, sociological, economic, aesthetic and public health benefits".

Urban greening can have a substantial impact on the lives of city dwellers. It can improve air quality by cooling and purifying the air, ground-level ozone and greenhouse effect; mitigates the heat island effect, thereby reducing air-conditioning needs, which in turn reduces the amount of fossil fuels required to generate electricity. The ability of urban forests to sequester atmospheric carbon dioxide and act as a long-term carbon sink is a crucial factor in addressing the effects of global warming. However, the amount of carbon sequestered by trees depends upon the density of the wood, size health and tree species. Trees canopies can also break rain velocity, reduce runoff flow rates and their roots stabilize soils against erosion, hence, reduce flooding and sedimen-

Similarly, urban forests provides habitat to animals; decrease wildfire risk; contribute to community economic stability by attracting businesses and tourists and provide a way for children to learn about nature and natural processes in an otherwise artificial environment. They also help in preserving and augmenting biodiversity; promoting men-





Yet, they are often disregarded because their ecosystem services are neither well understood nor quantified by the decision-makers. In June 2020, the Government announced 'Nagar Van' scheme with a goal to establish 200 urban forests across country in the next five years. A similar initiative called the 'Urban Forestry Scheme' had also been launched in 2016. Unfortunately, there are no official details and figures available which outline progress of the project and what goals were achieved on planting "200 city forests" between 2016 and 2020.

A comprehensive plan for careful installation and long-term maintenance is necessary for all green infrastructure. Often, these wellintended initiatives fail to produce the desired benefits because city governments lack the skills, expertise and funds necessary for urban forestry management. It also falls due to wrong selection of species, improper placement of trees and inadequate care and ownership.

Therefore, plantation projects must take into account - native vegetation, urban forest dynamics, biodiversity, species composition, spatial variation of soil-water dynamics, costs associated with planting and managing designed spaces, since these factors play a significant role in the outcome. Selection of species are also important for urban forestry

because trees in urban areas face more stress in comparison to rural areas such as restrictive soil volume and crown space, soil pollution, air pollution, etc. Low species diversity, poor site condition and planting palettes that aren't conducive to changing climates are further threats to urban tree population. It is also essential to consider spatial and temporal dynamics in defining planting strategies and management goals because these factors greatly influence the environment.

Multifarious dimensions of trees require location-based management for maintenance and periodic treatments. It is also necessary to develop new skills to deal with the challenging issues for which we lack institutional memory and working plan. This necessitates intensive and extensive research and development particularly in the areas of architecture and engineering.

Hence, to ensure more sustainable urban forests, local policymakers have to identify and design local strategies that fit into their region's specific circumstances. Organizing and coordinating between various stakeholders can also be challenging, particularly when urban forests are spread across multiple jurisdictions. Further, political support for passing an ordinance remains elusive, even in places where public support for urban tree management is strong. Providing sustainable funding for tree care and management is another obstacle. In some cases, the maintenance responsibility of trees and forests remains obscure due to limited details of land ownership or tenure. Many times, the costs associated with training professionals and establishing a network for monitoring and assessing the health of the urban forest exceeds the budget of local Government.

However, proper maintenance is critical for a thriving urban forest, but

it demands time, resources and coordination between various stakeholders. Data on the current state of urban forests are vital, for assessing the impact of tree planting campaigns, maintenance need, tree replacement strategies, new planting opportunities and a comprehensive understanding of how to improve the quality of planning and forests construction in

Many cities are entering into partnership with organized citizen groups, non-profit organizations and private landowners in order to effectively manage urban ecosystem and to deal with their budgeting and resource problem. There are instances where citizens have also participated in advisory commissions and provided inputs to local officials on urban forest policy and regulations. A partnership of this kind can contribute to innovative greening strategies that complement and augment existing programs, improve urban forest health, strengthen community social ties, increase environmental awareness and assist in addressing national and local issues more effectively. Furthermore, implementing advanced technologies such as remote sensing and geospatial artificial intelligence will help to monitor, assess and analyze the natural resources like, individual trees, vegetation changes, forest composition, etc.

Thus, modern technology combined with the desire for a greener city could lead to the incorporation of urban forestry and urban greening into smart city planning and operation. In addition, to address the problem of urban forestry holistically, a constitution of a 'Tree Commission' with mandate to radically change the planning, management and execution of urban green spaces with a multidisciplinary teammust be created.



renew my acquaintance with President (Joe) Biden but also meet, very importantly, with (Japanese) Prime Minister (Fumio) Kishida and (Indian Prime Minister) Narendra Modi who are important friends of Australia," Albanese told The Australian newspaper.

Sydney University constitutional law expert Anne Twomey said Morrison would have to resign as prime minister before Governor General

David Hurley could swear in Albanese. Caretaker conventions have constrained what the government can do since April 10 when Morrison called the election. But conventions are not binding.
"If result is unclear, then

prime minister is still prime minister. He continues to be prime minister and has all powers of prime minister until such time as he resigns," Twomey said. "The caretaker conventions in those circumstances would normally dictate that you can't go around doing significant things, making policy announcements and that sort of stuff," she added. PTI

Indian nurses drive UK's health service foreign intake

PTI ■ LONDON

Indians are driving a rise in I foreign nurses coming in to boost the workforce of the UK's National Health Service, according to official figures released in London on Wednesday.

The Nursing and Midwifery Council (NMC) data for 2021-22 shows 37,815 Indian nurses on the council's register of those qualified to work in the UK, up from 28,192 the previous year and a jump from 17,730 four years ago. The Philippines remains the top-most source country with 41,090 nurses and Nigeria is third with 7,256 nurses on the register.

"Our register is at the highest level ever. This is good news considering all the pressures of the last two years. But a closer look at our data reveals some warning signs," said Andrea

Registrar at the NMC. "The total number of people leaving the register has risen, after a steady and welcome fall over the previous four years. Those who left shared troubling stories about the pressure they've had to bear during the pandemic.

A focus on retention as well as attracting new recruits needs to be part of a sustainable workforce plan to meet rising demands for health and care services," she said.

In total there were 48,436 joiners, up from 34,517 the previous year and 38,317 in 2019-2020, which was seen as a welcome sign for the health service coping with nursing staff short-

ages. The NMC found that of all

the joiners almost half (48 per cent) had trained overseas and of those, 66 percent had trained in India or the Philippines.

Ukraine ordered the fighters to save their lives - and said their mission to tie up Russian forces is now complete - but has not called the column of soldiers walking out of the plant a surrender. The fighters face an uncertain fate, with Ukraine saying they hope for a prisoner swap but Russia vowing to try at least some of them for

It's not clear how many fighters remain inside the stronghold, Ukraine's last in a city now largely reduced to rubble. Both sides are trying to shape the narrative and extract propaganda victories from what has been one of the most important battles of the war.

Russian Defence Ministry spokesman Maj Gen Igor Konashenkov said Wednesday that 959 Ukrainian troops have now abandoned the Avozstal

out Monday. At one point, officials put the number of fighters holed up in the mill's sprawling network of tunnels and bunkers at 2,000.

The figures, if confirmed, suggest that Moscow might be within touching distance of being able to claim that all of Mariupol has fallen. That would be a boost for Russian President Vladimir Putin in a war where many of his plans

have gone awry.

But already another setback loomed: Sweden and Finland both officially applied to join the NATO military alliance on Wednesday, a move driven by security concerns over the Russian invasion. Putin launched

now bent on capturing. It would also give Russia an unbroken land bridge to the Crimean Peninsula, which it seized from Ukraine in 2014, while depriving Ukraine of a

Russia soldier pleads guilty over war crimes

A Russian soldier facing the first war crimes trial since the start of the war has pleaded guilty to charges of killing a Ukrainian civilian.

Sgt Vadim Shyshimarin pleaded guilty to the charges during his trial in Kyiv on Wednesday. The 21-year-old soldier could get life in prison if convicted of shooting a Ukrainian man in the head through an open car window in a village in the northeastern Sumy region on Feb 28, four days into the invasion.

Ukraine's Prosecutor General Iryna Venediktova has previously said her office was readying war crimes cases against 41 Russian soldiers for offenses including bombing civilian infrastructure, killing civilians, rape and looting.

It was not immediately clear how many of the suspects are in Ukrainian hands and how many could be tried in absentia.

Cabinet amends biofuels policy, advances ethanol blending target to 2025-26

New Delhi: The Union Cabinet on Wednesday approved advancing the target of blending 20 per cent ethanol in petrol by 5 years to 2025-26 as well as allowing more feedstocks for the production of biofuels in a bid to cut reliance on imported oil for meeting the country's energy needs.

The Cabinet, headed by Prime Minister Narendra Modi, at its meeting on Wednesday approved the amendments to the National Policy on Biofuels, an official statement said. The main amendment is

for advancing the target of blending 20 per cent ethanol in petrol (20 per cent ethanol, 80 per cent petrol) to 2025-26 from 2030. Currently, about 10 per cent of ethanol is blended in petrol. Also, more feedstocks have been allowed for the production of biofuels which can be doped with auto fuels.

It also provides for promoting the production of biofuels in the country, under the Make in India programme, by units located in Special Economic Zones (SEZ)/ Export Oriented Units (EoUs).

These decisions will help India, which depends on imports for meeting 85 per cent of its oil needs, to cut reliance on overseas shipments.

The Cabinet also approved granting "permission for export of biofuels in specific cases," the statement said

RBI Governor Shaktikanta Das, as per the minutes, said the off-cycle monetary policy actions were aimed at lowering inflation and anchoring inflation expectations with a view to strengthening the mediumterm growth prospects of the economy and protecting the purchasing power of the weaker sections of society.

The MPC after its meeting on May 2 and 4 had recommended raising the key interest rate (repo) by 40 basis points. The rate was hiked with immediate effect. It was the first hike since August

"As several storms hit together, our monetary policy response should be seen as an important step to steady the ship. The Indian as well as global evidence clearly shows



that high inflation persistence hurts savings, investment, competitiveness and growth," the governor had said as per the

RBI Deputy Governor and MPC member Michael Debabrata Patra said at the meeting that in this milieu, a measured approach and a cool head is warranted.

"Recent incoming data

suggest that India's macro-fundamentals, barring imported food and fuel inflation, are still intact and in sync with the recovery that has been tenaciously making its way through waves of the pandemic," he said. All the six members of the panel had voted to raise the repo rate or short-term lending rate by 40 basis points to 4.4 per cent. *PTI*

SEA pointed out that the exports of oilmeals fell to 23.8 lakh tonnes last fiscal year from 36.8 lakh tonnes in previous year. In term of value,



exports declined to Rs 5,600 crore from Rs 8,900 crore in 2020-21.

In the current year (2022-23), the exports of oilmeals are likely to be lower.

AHF to conduct Olympic qualifiers independently if Asian Games not held by September 2023

The Asian Hockey Federation (AHF) on The Asian Hockey received. qualifiers independently if the postponed Hangzhou Asian Games is not held by September next year.

The Asian Games, originally scheduled to be held from September 10 to 25 this year, has been postponed indefinitely earlier this month due to the worsening pandemic situation in

But AHF's chief executive officer Tayyab Ikram said the Asian hockey body is closely monitoring the situation and is in regular consultation with Olympic Council of Asia (OCA).

China. The new dates will be decided in future.

"The Asian Games is an Olympic qualifier for the continent, but we still have enough time in hand. If the Asian Games Games are postponed to September 2023, we will be in the same position to conduct the qualifiers.

"We are closely monitoring the develop-

ments," he said during a virtual press conference ahead of the men's Asia Cup, to be held in Jakarta.

'We do have a plan B, an independent Olympic qualifier tournament for Asia if the Asian Games are postponed beyond September 2023. We want to provide fair opportunity and even platform to our players. But we have to see the feasibility. We are very positive at this stage.

"The pandemic in China is much more in a precautionary level now... We are closely monitoring the situation there. We will implement plan B if required.'

Asked if there is any time frame to fall back on plan B, Ikram said: "For us it is very clear if the decision is that Asian Games will be held in September 2023 or before, obviously the OCA has to make that decision, if that happens it's fine or else we will have to implement plan B. I'm not too concerned about the first half of 2023." The Hangzhou Asian Games is of high value for the hockey teams of the continent as Olympic berths are at stake in both men's and women's events. The winners will earn direct right to compete at the 2024 Paris

Meanwhile, the Asia Cup in Jakarta from

May 23 to June 1 is a World Cup qualifier. Being the hosts, India have secured a direct entry in next year's World Cup but the Olympic Bronze medallists would look to defend their title in the Asia Cup. India will open their campaign against arch-rivals Pakistan on the opening day of the tournament.

Mushfigur reaches 5,000 Test runs

After the day's play was delayed by 30 minutes because of rain, Bangladesh, which resumed on 318-3, moved slowly in the morning session. Mushfigur was 15 runs short of the 5,000-run milestone when play resumed and he hit the mark, in his 81st Test match, with two runs to fine leg off pace bowler Asitha Fernando.

Mushfiqur helped Bangladesh then earn the lead and completed his eighth Test century off 270 balls, glancing Asitha Fernando for a boundary through fine-leg. It was, however, the slowest century for him in terms of facing balls.
