# SC shifts Gyanvapi trial to 'experienced' dist judge

# Do not leak things to Press, only judge opens report: SC

The Supreme Court on Friday transferred the Gyanvapi mosque case from Civil Judge to District Judge, Varanasi and said because of the "complexities" and "sensitivity" of the issue, it is better if a senior judicial officer having an experience of over 25-30 years handles this case.

The SC also took exception to selective leak of the survey report submitted by the court commissioners to the civil court, Varanasi. The apex court said once the report is presented, there could not be selective leaks. "Do not leak things to the Press, only the judge opens the report," it said.

The top court said its ear-

lier interim order of May 17 directing protection of the area where "shivling" is said to be found and allowing Muslims to offer "namaz" on mosque premises shall remain in operation till the maintainability of the suit is decided by the District Judge and thereafter for eight weeks to allow the aggrieved parties to approach

the higher court. The bench also directed the District Magistrate to make adequate arrangements for "wazu" (ablution) for the Muslims coming for offering namaz in the mosque in consultation with the parties involved in the dispute. In an important observation, the top court also said the process to ascertain the religious character of a place of worship is not barred under the Places of Worship Act of 1991.

A bench of Justices DY Chandrachud, Surya Kant, and PS Narasimha said the matter involves complexity and sensitivity and it would be better if a district judge handles the case and made it clear that it is not casting any aspersion on the Civil Judge who was earlier dealing with the suit.

"Having regard to the complexities of the issue involved in the case, in the civil suit and their sensitivity, we are of the considered view that the suit before the Civil Judge (senior division) Varanasi should be tried before a senior and experienced judicial officer of the Uttar Pradesh Higher Judicial Service," the bench said.

"We accordingly order and direct that the suit shall stand transferred from the file of Civil Judge (senior division) to the court of the District Judge, Varanasi for trial, and all the interlocutory and ancillary pro ceedings in the suit shall be addressed to and decided by the court of the District Judge," the bench said.

The SC directed the District Judge to decide on the priority of the application under Order 7 Rule 11 of CPC (on maintainability) filed by the mosque committee, which said the civil suit is barred by the 1991 Act, be decided upon the transfer of papers of suit from the Civil Judge (senior divi-

# SC panel terms Hyd rape accused's encounter fake

#### 10 cops guilty, their story is concocted, reports panel

The Supreme Courtappointed Justice VS Sirpurkar panel has found that the Hyderabad Police killed four accused, caught for the rape and murder of a woman veterinary doctor in a fake encounter in 2019.

The panel rejected the police claims and recommended to prosecute 10 police officials present during the fake encounter under murder

Rejecting the police claims that the accused snatched pistols and tried to harm the policemen and tried to escape, the panel said this police version is totally wrong and unbelievable. The panel said arrest-ed accused were "deliberately fired upon by the police to kill them when they were taken to the sport of the crime".

The SC also turned down Telangana Government's plea to get a copy of the panel report and decided to send the report to the High Court to initiate charges against the policemen.

A bench comprising Chief Justice NV Ramana and Justices Surva Kant and Hima Kohli did not agree to the submissions of senior advocate Shyam Divan, appearing for the State, that the enquiry commission's report be kept in a sealed cover.

# MNS chief defers | At 44.4 degrees C, **Ayodhya visit**

In an apparent tactical retreat, MNS chief Raj Thackeray on Friday announced that he was "temporarily" deferring his much-discussed visit to Ayodhya scheduled earlier for June 5. In a brief announcement made to this effect on his Twitter handle, the MNS chief did not cite any reason for postponing his visit to Ayodhya but said that he would talk about the issue at a later stage. Raj's decision to postpone his visit to Ayodhya sparked speculation in the state political circles. One of the inferences being drawn are: since he has already bitten more than he can chew on by raking up the "Hanuman Chalisa" issue and associating himself indirectly with the Opposition, he wants to see if the timing of his visit to Ayodhya is right.

The inference should be seen in the light of the fact that his visit to Ayodhya will have happened around the time when Shiv Sena leader and Maharashtra Minister Aaditya Thackeray is visiting the place along with hundreds of party workers. Whether he likes it or not, Raj's visit to Ayodhya will be compared with that of Aaditya, a thing that the MNS chief does not want.

Secondly, he wants to first decide whether he will formally tie-up with the BIP for the cru-



cial Brihanmumbai Municipal Corporation (BMC) elections scheduled to be held in September/October this year. Maybe he wants to complete the seat sharing negotiations with the BJP first before embarking upon his visit to Lord Rama's birth place.

The MNS chief's decision postpone his visit to Ayodhya has come in the midst of vociferious protests by some BJP leaders and activists in Uttar Pradesh and other northern states who are opposing Raj's proposed visit to Lord Ram's birth place.

A section of the BJP leaders and workers has for some time been demanding Raj's unconditional apology for the treatment meted out to north Indians in the MNS agitation in 2008. The anti-Raj protests are led by BJP mp from Uttar Pradesh Brijbhushan Sharan Singh who warned that unless he apologises, Lakhs of his supporters would block his entry to Ayodhya on June 5.

The minimum temperature recorded at the Safdarjung Observatory was 28.2 degrees Celsius, which was two notches above the normal for this season, stated the weather sta-

The relative humidity on Friday morning at 8:30 was recorded at 58 per cent and 22 per cent in the evening at 5:30.

The weather stations at Ridge, Ayanagar, Mungeshpur, Najafgarh, Pitampura, Palam, and Lodhi Road recorded maximum temperatures of 45.7 degrees Celsius, 46 degrees Celsius, 47.1 degrees Celsius, 47.5 degrees Celsius, 47.1 degrees Celsius, 47 degrees Celsius, 45.1 degrees Celsius and 44.6 degrees Celsius respectively, according to India

The IMD said that the thunderstorm or duststorm with light to moderate intensity rain and gusty winds with speed of 30-40 Km/h occurred over and adjoining areas of West, North-West, North-East, South-West, Central, New, East Delhi, and NCR (Bahadurgarh, Ghaziabad, Indirapuram, Chhapraula, Noida Gurugram) Gohana, Gannaur,

#### Shivpal receives Azam on release from Sitapur jail

Senior Samajwadi Party Sleader and former minister Mohammad Azam Khan was released from Sitapur district jail on Friday, a day after the Supreme Court granted him interim bail in a case of cheat-

The apex court granted the bail by exercising its powers under Article 142 of the Constitution.

Shivpal Singh Yadav, the estranged uncle of Samajwadi Party chief Akhilesh Ýadav, and Khan's two sons were present at the Sitapur prison gate to welcome Azam Khan.

Welcoming Azam Khan's release from the jail, Akhilesh Yadav later tweeted, "Hearty welcome to Shri Azam Khan ji on his release on bail. With this decision of bail, the Supreme Court has given new standards to justice. I am sure that he will be acquitted in all other false cases. Lies have moments, not centuries."

Azam Khan was accused in 88 cases registered against him and he has been in jail since February, 2020. Earlier, the court had granted him bail in 87 cases while the 88th case pertained to land-grabbing and forgery at Rampur Public School. Azam Khan was accused of forging building certificates to get recognition

# Govt lifts prohibition on bamboo charcoal export; KVIC thankful

he Central Government The Central Government lifted the "export prohibi-tion" on bamboo charcoal, a move that would facilitate optimum utilization of raw bamboo and higher profitability in the Indian bamboo industry.

The Khadi and Village

Industries Commission (KVIČ), which is supporting thousands of bamboo-based industries in the country, was persistently requesting the Government to lift the export restriction on bamboo charcoal. Chairman KVIC Vinai Kumar Saxena had written to the Minister of Commerce and Industries, Piyush Goyal, seeking to lift the export restriction on bamboo charcoal for the larger benefit of the bamboo industry.

"All the bamboo charcoal made from bamboo obtained from legal sources are permitted for export subject to proper documentation/certificate of origin proving that the bamboo used for making charcoal has been obtained from legal sources," read the notification issued by the Directorate General of Foreign Trade (DGFT). Saxena thanked Minister Piyush Goyal for the policy amendment saying the decision would reduce the high input cost of raw bamboo and make the bamboo-based industries, mostly in the remote rural areas, financially profitable.

"Bamboo charcoal has a huge demand in the interna-tional market and lifting of export prohibition by the government will enable the Indian bamboo industry to tap this opportunity and exploit the huge global demand. "This will also ensure opti-

mum utilisation of bamboo waste and thus contribute to the Prime Minister's vision of Waste to Wealth," Saxena said.

Notably, the Indian bamboo industry, at present, is grappling with extremely high input cost owing to inadequate utilization of bamboo. In India, bamboo is mostly used in manufacturing of Agarbatti wherein, a maximum of 16 per cent is used for manufacturing bamboo sticks while the remaining 84 per cent of bamboo is a complete waste.

As a result, the Bamboo input cost for Round Bamboo Sticks is in the range of Rs 25,000 to Rs 40,000 per MT as against the average Bamboo cost of Rs 4,000 to Rs 5,000 per MT.

Kumar, who was the Chief secretary of Puducherry, had recently been transferred to Delhi by the Central Government and was awaiting

Kumar had earlier served as the Principal Secretary to the Public Works Department in the Government of National Capital Territory of Delhi, before being transferred to Puducherry.

The present SDMC Commissioner Gyanesh Bharti, is the senior most among the Municipal Commissioners of Delhi.

Bharti, who hails from Bihar, was posted as Joint Secretary and Cabinet Secretary with the Government of India before being repatriated to his parent cadre in 2019.

Earlier, in a notification, the MHA said that the unified MCD will come into effect from May 22 as the terms of the three municipal bodies in the Capital are coming to an end.

There were 12 administrative zones under the MCD out of which SDMC got four (Centre, South, West, and Najafgarh); NMC got (Rohini, Civil Lines, Karol Bagh, City Sadar Paharganj, Keshavpuram, and Narela);

and the EDMC (Shahdara North and Shahdara South).

# Varsities divided over CUET for PG admissions

JNU says will allow admissions through CUET this year; DU. Jamia will not

Universities in the national Capital are divided over opting for the Common University Entrance Test (CUET) for admissions in postgraduate courses from the new academic session.

While the Jawaharlal Nehru University (JNU) has announced that it will allow admissions to postgraduate and advanced diploma courses of proficiency programmes through the CUET, the Delhi University (DU) and Jamia Millia Islamia (JMI) University have informed that they will not conduct the admission process through CUET-PG this

Officials at DU and JMI said the admission process for post-graduate courses has already begun for the academic session 2022-23 and it will not be feasible to change the process on such a short notice.

University Grants Commission (ÚGC) Chairman M Jagadesh Kumar said the CUET for PG admissions will be introduced from the 2022 academic session. However, he added that unlike the CUET- mandatory for central universities. "The admission process has already begun and on such a short notice, the university cannot implement a new sys-

The Academic Council and Executive Council of university will take a decision on matter and based on that, we will proceed," said DU Registrar Vikas Gupta. JMI Registrar Nazim

Husain Al-Jafri said the university will conduct admissions through ongoing procedure. "This year, we will conduct admissions through the ongoing procedure. For future years, we will decide on matter," he said.

The JNU announced on Friday that admissions to postgraduate and advanced diploma courses of proficiency programmes will be held through CUET this year. The exam for CUET-PG will be conducted in third week of July. The application process began on Friday and will conclude on June 18.

"The NTA will conduct Postgraduate Entrance Test for 42 central and participating universities for academic ses sion 2022-2023. The CUET will provide a single-window opportunity to students to seek admission in participating universities across country," the UGC Chairman had said. The UGC's announcement on Thursday came weeks after

announced that CUET scores, and not Class-12 scores, will be mandatory for admission to 45 central universities and these universities can fix their minimum eligibility criteria. The DU announced last month that admissions for graduate courses would be held through

Entrance Test (CUCET) from now on.The JMI had announced that it will conduct admissions for the academic session 2022-23 through CUET-2022 for 10 courses. Over 10.46 lakh candidates have registered for CUET-UG

### College of Art staff write to President, PM to stop merger into Ambedkar Univ

**New Delhi:** The employees association of College of Art has written to Vice-President Venkaiah Naidu and Prime Minister Narendra Modi, calling for an urgent "equitable and just" action to stop "merger" of the college into Ambedkar University.

This came on the day the BR Ambedkar University issued a notification, beginning the admission process for undergraduate (UG) and postgraduate (PG) courses in the College of Art.

In its letter on Thursday, College of Art Employees Association has made a "distress call to protect constitutional rights of the stakeholders of College of Art". "We, the employees of College of Art are aggrieved due to allegedly initiated unjust merger of college

into Ambedkar University," the letter read. They also demanded that BS Chauhan, the principal, be sacked and asked Naidu to "reprimand" him for his "mischief" of dismemberment of University of Delhi

"...Requesting you for an urgent equitable and just action stopping "Merger" immediateand also removing Dr BS Ćhauhan from the position of Offg. Principal of College of Art, New Delhi," the letter stated.

Their other demand was to carry out admissions for 2021-2022 session to be conducted under DU "on war-footed priority". The association has alleged that consent of stakeholders i.e. students and employees was not taken by the management before starting the merger process.

### 2 CAs detained for ₹15 cr GST refund scam

#### **ICAI Gurugram** members allege wrong detention

The Central Goods and Service Tax department detained two Chartered Accountants (CAs) on Thursday night over an alleged ₹15 crore GST refund scam. The CAs were detained by the Directorate-General of GST Intelligence, Gurugram CGST department for issuing a certificate in a GST refund matter. But a group of CAs has called for a protest, terming the detention as

On Friday, Gurugram police said though a protest by the CAs

had been allowed to function. Members of the Institute of Chartered Accountants of India (ICAI), Gurugram chapter, said the two CAs had been wrongly detained by the department since May 17, and on May 19 they were sent to judicial custody. They claimed that about 40-50 CAs were also detained for nearly four

hours by the department.

Terming the arrest "completely wrong," ICAI members said the refund was issued with connivance of officials. The protestors claimed that rather than punishing CAs, action should be taken against the benefitting party - a trader and GST official. According to police, a few days ago, some men had faked up a business and filed a refund of ₹15 crore of GST. The two CAs attested their documents and

In a bid to create new employment opportunities, the Arvind Kejriwal Government has decided to redevelop 27 notified industrial areas in the national Capital.

The Delhi Government has entrusted the task of preparing the layout of these notified industrial areas to the Delhi State Industrial and Infrastructure Development Corporation (DSIIDC).

DSIIDC will appoint a consultant firm in the industrial area that will prepare the layout of the various industrial

In this context, Industries Minister Satyendar Jain held a meeting with the office-bearers of the associations of industrial areas and local MLAs of the respective areas, at the Delhi Secretariat He discussed the redevelopment of

these notified industrial areas along

with security measures. A separate budget provision has also been made by the government for the redevelopment of these industrial areas.

After the meeting, Jain said, "There are 27 notified industrial areas in Delhi and there are many industrial units running here. Initially, these industrial areas were categorized on the basis that they would be redeveloped.

However, this matter had been dragged on by the previous governments for years and little to no attempt was made to complete the initiative. Now, the Kejriwal government has taken the initiative to redevelop these

A time limit has been fixed for preparing the layout plan of all these 27 areas." The expenditure on the consultants preparing the layout will be split on a 50-50% basis between the Delhi Government and the Industrial Association. This will be an exemplary model of cooperation between the public and the Government.

The Delhi Government has announced that the notified industrial areas will be redeveloped in the next five years to generate employment opportunities for lakhs of people in the The Delhi government is working

### DA of daily wagers hiked by Delhi Government

NEW DELHI: The Arvind Kejriwal Government on Friday raised dearness allowance for daily wagers in national Capital. The official said that monthly wages for unskilled laborers have been raised from ₹16,064 to ₹16,506 per month while wages for semi-skilled labourers have been increased from₹17,693 to ₹18,187 per month.

Delhi's Deputy Chief Minister, Manish Sisodia said that move will benefit unskilled, semi-skilled, skilled and other workers in all scheduled employment under aegis of the Delhi Government.

"These steps have been taken in the interest of the poor and working-class, who have suffered disproportionately due to the current pandemic. This order shall also benefit those in

clerical and supervisory jobs," Sisodia added. Sisodia further said that people employed on minimum wages in the unorganized sector should also get the benefits of the dearness allowances, which are usually offered to state and central government employees.

'Minimum wages in Delhi are the highest in comparison to any other state. Delhi government is constantly revising the dearness allowance every six months, to provide respite to all workers of Delhi from the inflation," said Sisodia.

For skilled labourers, the wages have been increased from ?19,473 to ?20,019 a month. Additionally, the minimum wage rates for the supervisor and the clerical cadre of employees have also been revised, said an official.

### At 7070 MW, Delhi's power demand shatters records

The national capital's peak power demand broke all records late on Thursday nightas Delhi's power demand clocked 7070 MW, the highest ever in the month of May.

According to sources in discoms, the capital city's power demand continues its northwards climb, creating new records along the way. Last night at 11:24 pm, the city's peak power demand not only clocked the season's highest of 7070 MW, but also the highest ever in the month of

May.
"The highest peak demand on Friday was recorded at 6,943 that is also likely to shoot past 7,000 MW late in the night," discom official said. "It's only the fourth year in

Delhi's history when the capital's peak power demand has breached the 7000 MW. It breached the 7000 mark for the first time in 2018 (July 10), when it clocked 7016 MW.

The following year (2019), it clocked 7409 MW (July 2), the highest ever recorded in the history of Delhi. In 2020, it did not cross the 7,000 MW and peaked at 6314 MW. In 2021 (July 2), the city's peak power demand clocked 7323 MW," he

2 ROBOTS HELPED CONTROL A FIRE IN TIKRI KALAN PVC MARKET MONTHS AGO

The Delhi Government has inducted two robots into the city's firefighting fleet. The robots were bought from an Austrian company and a few months ago a fire in the PVC market at Delhi's Tikri Kalan was controlled with the help of these robots.

Delhi Chief Minister, Arvind Kejriwal, took to Twitter to inform people about the robots and tweeted: "Our Government has procured remote-controlled fire fighting

machines. Our brave fireman can now fight fires from a maximum safe distance of up to 100 meters. This will help reduce collateral damage and save precious lives. Meanwhile, Delhi Home

Minister Satyendra Jain, said that there was an increase in cases of large-scale fires every year during the scorching summer days, and for the first time, such remote controlled robots have been brought into the country to deal with blazes.

Cameras can take stock of the situation inside the fire zone. With this, it will be easy to know whether a person is trapped inside or not.

# Goraiya Gram opened in city to save sparrow

The Arvind Kejriwal Government has created a first-of-its-kind 'Goraiya Gram' in Garhi Mandu city forest in East Delhi for the protection and conservation of the State bird the sparrow. The Government also plans to develop to Mitraun city forest in South West Delhi, Alipur city forest in North Delhi and Jaunapur city forest in the com-

ing days. Delhi Environment Minister, Gopal Rai who visited the Goraiya Gram in Garhi Mandu, said that more such sparrow villages are planned at several other places in the Capital.

"Pollution and excessive use of pesticides is leading to a decline in the number of sparrows and considering this, the forest and wildlife department is trying to provide ecological support for the protection and conservation of the little bird," he said. "We have tried to give them nesting places and food sources in the Goraiya Gram'. We do not only want to increase the green cover in Delhi but create a healthy ecological system and give a suitable environment to birds and animals,

Sohail Madan, assistant director, Bombay Natural History Society, said, "The spunky bird thrives in places that have plenty of grains and insects. But the use of pesticides and insecticides has led to a scarcity of food for them. The toxic chemicals have driven them away.'

We have planted native berries like karonda and kundni, grasses and shrubs, and kept feeder boxes, artificial nests and earthen pots in the sparrow village, which was opened to the public last month," the conservationist, who helped build the Goraiya Gram," said. Two insect hostels have also been created at the 'Gauraiya Gram' as sparrows feed on insects and worms. A



forest department official said this is the first such effort in national Capital to make people aware about the protection and conservation of State bird.

"The rapid decline in the number of sparrows had hogged headlines a few years ago. Several studies attributed it to urbanisation and mindless use of pesticides and insecticides, and even electromagnetic radiation. So we thought

In its FIR, the CBI has alleged that Amrapali Leisure Valley Developers Pvt Ltd was sanctioned a term loan for construction of flats at Greater Noida. However, despite taking full disbursal of the loans, the project is still incomplete and the account turned non-performing asset (NPA) on March 31, 2017. It was also alleged that the borrower company had

made rampant diversion of funds to various other compa-

Besides borrower company and its director Anil Kumar Sharma, the CBI has booked other directors/erstwhile director/corporate guarantors-Shiv Priya, Suvash Čhandra Kumar, Pankaj Mehta, Atul Mittal, Ashish Jain, Gagandeep Singh and unknown public servants and private persons.

The banks had sanctioned credit facilities to develop a housing building at the Tech Zone IV in Uttar Pradesh's Greater Noida on a plot measuring 1.06 lakh square metre, the FIR alleged.

Some Amrapali Group flat buyers had approached the Supreme Court owing to the non-delivery of promised flats to them in Noida and Greater Noida area where the company had promised to develop and sell 42,000 units.

The apex court had ordered a forensic audit in the affairs of the company, the complaint has alleged.
The forensic audit revealed

that the group allegedly diverted ₹5,619 crore through different companies -- Amrapali Leisure Valley Developers Pvt Ltd, Amrapali Homes Projects Pvt Ltd, Ultra Home Constructions Pvt Ltd and Amrapali Grand.it said.

# SC extends time for committee to submit report on Pegasus row

The Supreme Court on Friday extended the time for submitting the report by the apex court-appointed technical and supervisory committees to look into the Pegasus row, saying 29 "infected" mobile phones are being examined for the spyware and the process should be over in four weeks.

A bench headed by Chief Justice N V Ramana said the technical committee has been examining mobiles for the spyware and has also recorded statements of persons including some journalists and activists.

cedure for testing the 'infected devices' will be finalised too, it said, adding the probe by the technical committee may be over by the May end and then the supervisory judge would be making a report for the perusal of the bench. Referring to the receipt of an interim report, the bench, also comprising justices Surya Kant and Hima Kohli, said that the technical committee, which has received 29 mobiles for examining the spy-



ware, has developed its software for this purpose and issued notices to some gov-ernment agencies and individuals including journalists.

'Preferably, the process by the technical committee should be over in four weeks and the informed. The supervisory judge shall submit his report thereafter. List sometime in July," said the bench.

The bench did not pass any order concerning the request made by senior lawyer Kapil Sibal, who has been appearing for some petitioners, that the interim report be made available to the parties. Solicitor General Tushar Mehta, appearing for the Centre, said the report being an interim one need not be made public at this

The bench, which on October 27, last year had ordered a probe into the allegations of use of Israeli spyware by government agencies for targeted surveillance of politicians, journalists, and activists, has now fixed the case for further consideration in July. salary, perks and perquisites as per Section 3 of the Election Commission (Conditions of Commissioners Transaction of Business) Act, 1991. They are entitled to a monthly sumptuary allowance of Rs 34,000.

There is no income tax payable by the CEC and ECs on this allowance. They are also entitled to three LTCs in a year for self, spouse and dependent members of the family.

The Commission felt the need of observing austerity in personal entitlements.

# **Under-construction Jammu tunnel** collapses; 1 dead, 9 still missing

One construction worker from West Bengal was found dead while the fate of nine others remained unknown after an under construction 'adit' tunnel collapsed near 'Khooni nallah' between Ramban and Ramsoo along the Jammu-Srinagar National Highway late Thursday night. Three laborers were safely rescued from the accident site late in the night by the rescue teams launched by the district administration.

At least nine trapped workers could not be rescued during the day-long joint rescue operations conducted by the teams of National Disaster Response Force, State Disaster Response Force, civil, army and police authorities.

According to official sources, the rescue operations were hampered by the inclement weather conditions late Friday evening and the same were suspended by the authorities to prevent further loss of lives. The rescue operations would be resumed on Saturday morning.

Deputy Commissioner Ramban, Masrat-ul-Islam who led the rescue teams late Thursday night told reporters at the accident site on Friday, "at around 10.45 p.m, I first



received an information that mouth of an 'adit tunnel' to tunnel T4 have collapsed. We immediately mobilised our teams and rushed to the accident site. We started the rescue operations around 12.00 a.m". The rescue operations were delayed because the accident site was still active and the rescue teams were not allowed to launch the operations to avoid further loss of lives". Three laborers were rescued late last night while we recovered one dead body of a labourer from West Bengal during the day. Out of these three one of them has been referred to the Government Medical college hospital in Jammu. He said the rescue teams were still looking for 9 survivors as they remained untraceable. Out of these four hailed from West Bengal, two

last person is reached.

Masrat Ul Islam informed the adit tunnel which collapsed was an escape tunnel which is normally used for emergency purposes, supplies and ventilation. It was only punctured three meters when it collapsed Thursday night. 'Unfortunately there was not enough space for the labourers to move inside the tunnel which could have saved them. We are still keeping our fingers crossed and hope to find some people alive", he added.

According to a local eyewitness the tunnel collapsed around 10.15 p.m when big boulders hit the front portion. Local reports suggested the construction agency had triggered local blasts at the contruction site earlier.

"It was pitch dark. There was no power supply in the area. The labourers were trapped under the debris", claimed Yasir, an eyewitness.

Another eyewitness Manjeet said, some labourers were standing on the mouth of the tunnel and others were working on the ground when suddenly big boulders hit them and everything including heavy machinery was buried. Senior officers of the National Highway Authority of India along with Divisional Commissioner Jammu Ramesh Kumar Jangid, ADGP Police, Jammu range Mukesh Singh and representatives of the project execution agency visited the spot to take stock of the

Divisional Commissioner Ramesh Kumar Jangid said, teams of NDRF, SDRF local police and civil authorities are all working together to rescue the survivors from the accident site. He said the machinery was mobilised late in the night and rescue operations were launched to rescue the trapped workers, "We are facing challenges because we have to first cut the boulders and then push the same downhill to create gaps to look for survivors. We have to ensure safety of the rescue workers and using minimal machinery to prevent fresh landslide in the area", said DC Ramban Masrat-ul-Islam.

An expert Geologist Prof GM Bhat observed, "it appears the project execution agencies going ahead with unplanned excavation, subletting the job to non professional people".

They are blasting the rocks by adopting an 'unscientific' approach. Prof Bhat claimed the rocks in the region are strong enough. # India exported wheat worth \$473 m in April

from Nepal, 1 from Assam and

India has exported wheat worth 177 million in March and \$473 million in April this year. The government data showed that India exported wheat even at a time when about eight nations, including Ukraine, Belarus, Turkey, Egypt, Kazakhstan and Kuwait, had imposed wheat export restrictions. Top sources said that several countries have approached the Ministry of External Affairs (MEA), seeking clarification on whether their requests for Indian wheat would be fulfilled.

According to sources, over three dozen countries have sought food grains from India, with many others hinting they 13, the government banned all private wheat exports with immediate effect to control rising domestic prices and ensure food security of India, neighbouring nations and vulnerable countries. The G7 nations had criticised the Indian government's decision to restrict the exports.

"Still, after the conflict began on February 24, 2022, India has exported wheat worth USD 177 million and USD 473 million in March and April, respectively, despite facing challenges of low wheat production as a result of extreme heat wave that enveloped the northern part of the country that caused shrivelled grains and resultant drop in yield per acre," one of the sources said



(Directorate General of Foreign Trade) notification, wheat exports are allowed on the basis of permission granted by the Government of India to other countries to meet their food security needs and based on the request of their governments.

Among the wheat exporting India ranked 2020, 35th in 2019, 36th in 2018 and 2017, which shows that it has an insignificant share (0.47 per cent) while seven countries (Russia, the US, Canada, France, Ukraine, Australia and Argentina) have largest share in the overall quantity of wheat export in the past five years,

"A negotiation-based approach instead of conflict would have prevented removal of nearly a quarter of wheat exports from Russia and Ukraine," the source said, adding "export restrictions have been a regular feature of major food producers which has adversely affected India too".

Egypt and Turkey have also

The SC says disability and police jobs can go hand in hand but it must spell out the details

he Supreme Court merits appreciation for backing persons with disabilities to apply for jobs in India's police forces. The court asked the Centre on Thursday to reconsider its stand on the issue. The court's logic is that not all police jobs require personnel to perform field duties. Candidates with disabilities are suitable for taking up desk jobs and policy-making tasks. The three-judge Bench told the Centre: "Experiment with it for a while and if it does not work, then you may not continue with it." This approach of the court needs amending. Applicants with disabilities expect the court to lay down the broad parameters of the recruiting process. The judiciary should also convince the Government and recruiters to change their mindset when dealing with candidates with disabilities. However, if the court treats the process as an "experiment", it amounts to



leaving the final decision with the Government on recruiting such candidates. We should draw inspiration from the Americans with Disabilities Act (ADA) which states that not every physical impairment is ground for immediate disqualification from employment as a law enforcement officer. The Disabled Police Association of the UK tells disabled applicants that "there are many aspects of policing where having a condition or disability will in no way hold you back". The European Convention explains equal opportunities for disabled people that every person has an equal right not to be discriminated against.

It does not mean that a disabled person can serve the police force in any role. It "depends on the nature of the job and the individual's capacity, and the extent of their disability". These examples make it clear that giving a job in the force to a disabled person is not an act of charity but recognition of such a person's natural right. The Supreme Court should now take the case to its logical conclusion and ask the Union Government to design the recruitment process for disabled candidates. The operating guideline is that recruiters cannot think that disabled people cannot do a job just because they cannot imagine how these people can do it. Joining the police force requires passing a rigorous physical test. However, nobody is asking for the test to be made easy for disabled candidates. The force can rightly refuse to hire a candidate whose impairment prevents the person from performing the job with "reasonable accommodations" made by the employer. Western guidelines are so encouraging that, for instance, the British police force does not allow disabled candidates to disclose any impairment in the application form. The police department is mandated to give the candidates a conditional offer of employment "before requiring them to undergo a medical examination". The examination corresponds to the specific job function the applicants are being considered for. This gives the candidates a chance to prove the "flexibility, strength and range of motion" the job requires. These candidates ask only for a reasonable chance.

Tamil Nadu, Kerala and Karnataka are falling victim to the vagaries of monsoon

he southern States of Tamil Nadu, Kerala and Karnataka are reeling under floods for the last few days following heavy rains from the southwestern monsoon. Though the monsoon is yet to formally commence its annual visit to India, the rain along the south Indian coast has caused enough damage in urban and rural areas to leave policy makers aghast about the impact of the real weather phenomenon that is expected to hit the shores in June-July. This has been the reality since 2018, with deluges and cloudbursts becoming regular features in these three States. Surprisingly, though the Chief Ministers of Tamil Nadu and Kerala wax eloquent over the Dravidian model and Kerala development model, the truth is that infrastructure



al disasters. Though Pinarayi Vijayan took a Statesponsored junket to the Netherlands to learn stateof-the-art technology to counter waterlogging, nothing has changed in Kerala. The State is facing hitherto unseen waterlogging that has brought public life to a grinding halt. Several deaths have been reported from various districts as rivers are overflowing even with the short spell of rains.

A similar situation prevails in Tamil Nadu and Karnataka. There are many common factors behind these floods and waterlogging. The waterholding capacity of these States has taken a beating because of many reasons. There is no provi-

sion to hold back or store rainwater and it results in sudden floods. Meteorological scientists like Dr S Abhilash, Department of Atmospheric Sciences, Cochin University of Science and Technology, are of the view that monsoon has become erratic over the last few decades. There is a flaw in the natural water regulation mechanism because of urbanization, apart from other issues. The only option is to change the conventional flood prevention mechanism to suit the changed monsoon pattern. The storm water drain model and canal system has to be reworked to accommodate the increased rain water quantity. Global warming and sea-level rising alone are not responsible for this new phenomenon. The pattern of rainfall has changed from the traditional system to short spells. Earth's absorption and accommodating power has changed. An out-of-the-box solution making use of the knowledge gained by scientists like Dr Abhilash is the need of the hour.

# Will the Taliban cookie crumble?



Ties between the Taliban-led Islamic Emirate and Pakistan are under severe strain, and the Afghan dispensation is running into a sea of other troubles

he Russian invasion of Ukraine has shoved events in Afghanistan to the margins of global public discourse. Yet, much has been happening in the blighted land. The country is in trouble. The economy is prostrate. The law and order situation is in shambles, with the Islamic State of Khorasan Province (ISKP, also referred to as ISIS-K), the Afghan affiliate of the Islamic State in Iraq and Syria (ISIS), posing a violent challenge. The ties between Taliban-led Islamic Emirate and Pakistan are under severe strain. Hence the question: Will the regime crumble?

To begin with the economy, essential commodities are scarce. Prices are skyrocketing. Large sections are going hungry. Unemployment is soaring. According to the International Labour Organisation (ILO), more than 500,000 Afghan workers lost their jobs in the third quarter of 2001. According to Khaama Press, one of Afghanistan's leading news agencies, the number of people losing their jobs since the Taliban takeover is expected to rise between 700,000 and 900,000 by mid-2002 — which is round the corner. The figure is in accordance with those of the US Special Inspector-General for Afghanistan Reconstruction (SIGAR), which holds that 900,000 Afghans have lost their jobs since the Taliban captured power in August 2001. Women, SIGAR further holds, have been disproportionately affected the number of jobs is likely to fall by 21 per cent since the Taliban's ascent to power. The result has been a surge in migration to other countries. Christina Goldbaum and Yaqoob Akbary state in the The New York Times (February 2, 2022): "From October [2021] to the end of January [2022], more than a million Afghans in southwestern Afghanistan have set off down one of the two major migration routes into Iran, according to

has sharply stepped up the frequency and lethality of its terror strikes. Asfandyar Mir, a senior expert at the US Institute of Peace, points out in a paper, titled The ISIS-K Resurgence, that the latter advocates "mass casualty attacks" against civilians and States. It intends "to topple the Pakistani Government, punish the Iranian Government for being a 'vanguard' of the Shias" and "purify" Afghanistan — "both by dislodging the Afghan Taliban as the main jihadi movement in Afghanistan and punishing minority groups, like the

In 'Countering a Resurgent Terrorist Threat in Afghanistan' (Foreign Affairs, April 24, 2022), Seth G Jones cites the estimate that "the ISKP carried out 76 attacks on Taliban forces between September 18 and November 30, 2021, a significant jump from 2020, when it conducted only eight attacks during the entire year". There was a fall in the incidence of ISKP's strikes during the winter following the Taliban's harsh military action, particularly in Nangarhar province. However, there is an upward trend again. pitals suggest, and stoked fears that Afghanistan is heading into a violent spring, as the Islamic State's affiliate in the country tries to undermine the Taliban Government and assert its newfound reach."

Will the Taliban be able to squelch the ISPK's challenge? The latter had been confined mostly to eastern Afghanistan during the past six years. Goldbaum points out that since the Taliban takeover, it "has grown in reach and expanded in nearly all 34 provinces". One reason, of course, has been the release of jailed ISKP prisoners by the Taliban after capturing power, which virtually doubled the former's strength from around 2,000 to around 4,000. Also drawn to it are young Taliban fighters who have gained little from the Islamic Emirate. Further, as Seth G Jones points out, some of the former members of Afghanistan's military and main intelligence agency, the National Directorate of Security, have joined the ISKP as it is "the most active opposition group to the Taliban". This may well make a difference given their expertise.

The Taliban have the advantage of having a wellequipped army with a background of waging successful guerrina wariare, and a strong presence throughout the country. Guerrilla warfare, however, is very different from counter-insurgency, to which the Taliban are new. Also, continued failure on the economic front may starve it of resources to fight the ISPK and cause disaffection benefiting the latter. Growing tensions with Pakistan, involving border clashes, can stand in the way of mutual cooperation in fighting the ISIS-K. Besides, tensions between the Kandahar and Haqqani groups in the Taliban, which are manifest, may lead to migration to the ISIS-K by disgruntled ele-

ments on either side. Besides, it is not just the ISKP. According to a report, 'Mapping Afghan Resistance Movement', by Security Risks Research of Security Risks Asia, resistance groups comprising former opponents of the Taliban, are gearing up. These include the Supreme Council of National Resistance for the Salvation of Afghanistan, National Resistance Front of Afghanistan, Tehreek-e-Azadi Afghanistan and Afghan Islamic National and Liberation Movement. The seriousness of their challenge, however, remains to be seen. Nevertheless, the Islamic Emirate clearly has a squally passage ahead.

### WTO WELCOMES QUAD ON **PANDEMIC IP RESPONSE**

Prospects of text-based negotiations on an intellectual property response to COVID-19

t a General Council meeting on May 10, WTO members agreed that the outcome document emerging from the informal process that the outcome document emerging from the conducted with the Quad (European Union, India, South Africa and the United States) opens the prospect for text-based negotiations on an intellectual property (IP) response to COVID-19. Efforts should be made to bring a waiver on the cost of COVID-19 vaccinations, as the least developed countries cannot afford the costly vaccinations. The QUAD is the right forum to take this initiative along with other members. DG Okonjo-Iweala thanked delegations for the "constructive spirit" shown during the General Council meeting. Following an impasse of more than a year in the Council for Trade-Related Aspects of Intellectual Property Rights (TRIPS), the text was forwarded by DG Okonjo-Iweala and shared immediately by TRIPS Council Chair Ambassador Lansana Gberie (Sierra Leone) with all delegations, who had the opportunity to express their initial views about the proposal at a formal meeting on the TRIPS Council on May 6. In their discussions facilitated by DG Okonjo-Iweala and working with Deputy Director-General Anabel González, the Quad adopted a problem-solving approach aimed at identifying practical ways to clarify, streamline and simplify how Governments can override patent rights, under certain conditions, to enable diversification of production of COVID-19 vaccines. China announced at the meeting that it will not avail itself of the flexibilities under the Quad waiver text provided that language is used opening benefits of the waiver to all devel-



oping members while encouraging those with capacity to export vaccines to opt out. China and several other members rejected a second option in the text that would restrict waiver eligibility to those developing countries that exported more than 10 per cent of the world's vaccine doses in 2021. Ambassador Gberie urged members to be pragmatic in working for an outcome on the waiver text by the time ministers gather in Geneva for the WTO's 12th Ministerial Conference (MC12) between June 12-15. The issue of food security and the impact of the Ukraine crisis was also addressed at the General Council meeting. The United Kingdom presented a joint statement endorsed by more than 50 WTO members underlining the importance of maintaining open and predictable agricultural markets and trade to ensure the continued flow of food. Members then took the floor to voice their views on how best to address the sharp rise in commodity prices and ensure food security, particularly among countries most dependent on food imports.

The majority of the members appreciated India providing food security to the least developed countries on humanitarian grounds. India and the US have resolved their disagreements on food security issues, paving the way for the implementation of a global trade pact. The deal to simplify trade procedures was done at a WTO meeting summit in Bali in Indonesia last year. However, India has been blocking implementation of that agreement. It wanted assurances that its food security programme would not be challenged under the WTO's rules. India's concern was that complaints based on rules limiting farm subsidies might undermine its spending on food stockpiles intended to ensure that the poor have enough to eat. Food security programmes are covered by a so-called "peace clause" in which countries agreed to refrain from making such challenges until 2017. The US has now agreed to extend that commitment, in effect indefinitely. This bilateral agreement between the US and India still has to be endorsed by the full WTO membership, and it's likely to be discussed in WTO's 12th Ministerial Conference (MC12) in Geneva.

# UP Government's trillion-dollar hopes



Looking at the past, it doesn't seem probable but it is indeed an aspirational goal and would require a comprehensive action plan for all economic sectors

ttar Pradesh has 16 percent of the population of India but contributes only 8 percent to its GDP. If UP was to be a country it would be the fifth largest country in the world. At the time of Independence, the per capita income of UP was the same as the national average but today it is less than 50 percent of the same at ₹65,431 per annum. It is true that UP has become the third largest economy with the current GDP of around \$220 billion (₹17 lakh crore) but in terms of per capita income it is second from the bottom.

Recently the UP Government has issued a tender for hiring a consultant to take the UP economy to \$1 trillion by 2027. Looking at the past this does not seem very probable as it would involve the UP economy growing at a rate of more than 30 percent per annum. However, it is indeed an aspirational goal and would require a comprehensive action plan for all sectors of economy because what is required is not an incremental push but a quantum leap.

UP is primarily an agricultural economy with 25 percent of the GSDP coming from this sector which employees more than 65 percent of the population. This is one of the main reasons for the poverty in the State as large number of people are under employed or in a State of disguised unemployment and, hence, not contributing to the economic development of the state. UP has nine agro-climatic zones and each would require a separate strategy for deciding upon issues like cropping pattern and also on ways to improve the productivity to bring it above the national level.

There are huge regional imbalances with western UP being far ahead of eastern UP in terms of productivity and income of farmers. Similarly, Bundelkhand is a rain-fed area where most of the farmers only taking one crop in a year. However, the same Bundelkhand if provided with adequate drip and sprinkler irrigation facilities can become a hub for citrus fruits, vegetables, medicinal herbs. Moreover, the real problem is the fragmentation of holdings with average size of land holding being 0.80 hectare meaning that most of the farmers are small and marginal and this has a huge impact on their viability. They are often in urgent need of cash and dispose of the produce at low prices. Aggregation of farmers through farmer producer companies is the answer. Further, huge investment is required in development of cold chains and storages so that the farmers can store their produce and release them in the

market at an appropriate time.
Animal husbandry is often a neglected sector but it has been my experience that this can significantly add to the income of the farmers. A mission should be launched to bring about a dairy revolution in the state with its entire complement of feed, fodder, medicines, artificial

insemination, chilling plants and processing centers. Similarly, a neglected sector of UP is that of fisheries where the state has a potential of growing at more than 15 percent per annum and through this the farmers of UP can become agribusiness entrepreneurs.

MSME sector is next only to agriculture in terms of generating employment and this is a vital sector for the state of UP. A forward looking and dynamic MSME policy is required which provides credit, technology and market to the MSME sector. Often the governments focus only on bringing in new industry but the existing industries also need a supporting hand. A separate cell has to be created to cater to the problems of the micro sector which is more than 90 percent of the MSME. This sector is largely unorganized and needs an approach specifically suited to its needs. Noida is the industrial hub of UP but industries need to move to other regions of the state.

The textile and leather sector has a great potential for developing and also generating large scale employment. Noida can easily become a hub for the electronic industry. Lucknow, Prayagraj and several other tier II cities have great potential for development of the IT sector which will give a big push to the UP economy. Besides, the network of expressways the eastern freight corridor and Delhi Mumbai corridor can easily stimulate industrial development in large areas adjoining to them.

The game-changing sector is

the agro-processing one. A very small percentage of agriculture produce is processed today. At every block level a center for the development of the food processing sector can easily be developed which will provide employment to rural youth near their homes and there would be little need for labor to migrate to other states. These centers can be developed as rural growth engines which will have a transformational impact on the economy.

The vital sectors for the development of UP are health and education. The Government will have to invest heavily in these sectors and also bring about improvement in the governance to make quality health care and education accessible to all.

A special mission for improvement in the learning competencies at the primary education level has to be given the highest priority and the gross enrolment rate in higher education increased to 50 percent. Special attention will have to be given to the recruitment of teachers, motivating them, nota ing them accountable and developing their capacities. The state requires many more medical colleges, nursing institutions and institutes of paramedics. District hospitals have to be converted into centers of excellence.

The energy sector in the state is in the need of large-scale reforms at the distribution level to cut down on line losses and eliminate power theft. Smart meters have to be introduced and many

more power generating plants are required. Solar energy should remain a major area of focus.

UP needs more rapid urbanization and to make cities act as engines of growth innovative means of funding the creation of urban infrastructure is required. Urban governance and urban financing are two areas where a lot of specialization is required. Moreover, greater devolution of powers to the elected urban bodies is the need of the hour.

Above all the steps outlined UP requires a major governance overhaul. E-governance and Mgovernance have to brought in all the sectors. There has to be a result-oriented performance evaluation system for the officers. Monitoring of schemes and projects has to be vastly improved by use of technology. Time bound clearances and approvals to be implemented in all sectors. The transfer industry has to be abolished. Training and orientation of the officers must be ensured to build their capacity. Finally, for a large state like UP it is important to go in for a major governance reform of decentralisation and delegation of powers to the divisions and district as well as elected local bodies.

UP must move fast if India has to develop. The trillion-dollar economy may not be easy but a much higher than the national growth rate is essential to take the people of UP out of the poverty cycle and make UP one of the developed states of the Union.

# Girls drop out of remote Poonch village school for lack of roads

### Basic development infrastructure and safe environment are needed in remote J&K to push up girls' enrolment numbers

Remoteness of a village is one of the biggest hindrances that young girls have to overcome to be able to claim their right to basic education. Chikri Ban village in Mandi block in the border district of Poonch in Jammu and Kashmir is one such place where young girls have been struggling hard to get educated.

Located at 3,349 ft, Chikri Ban is surrounded by the mighty Pir Panjal range. The word 'Ban' stands for 'forest' and one have to trek for two-three hours through a forest to reach this village

For a long time, the villagers have been demanding construction of roads, but to no avail. Qamar Din, a resident, says that the students have to walk thirteen kilometres to Loran High School situated in

Loran village, the closest high school for students belonging to Chikri Ban village. By the time these students reach school. they feel tired and are unable to concentrate on lectures. For girls, it's even more difficult as before and after school, they have to contribute to the household chores, which includes cooking, cleaning and fetching water for the family. Compared to boys, girls get lesser time for themselves. Despite the struggles, girls in this village manage to complete middle school but as the talks of higher education start surfacing, their parents

start opposing Entrenched in poverty, most families prefer not to send their daughters outside their village to acquire higher education. Shaziya, 15, and Tayyaba, 11, two sisters from the village, dropped



entire population. could not afford further studies. Lack of a secondary school has limited their opportunities and chances to advance in their lives. Fatima Zahra, 26, the Deputy Sarpanch of the village, also reflected how the absence

of basic facilities such as water,

electricity, secondary schools

and roads is affecting the edu-

cation of current generation

As there is no road, these students have to trek their way to school through a forest which means increased chances of animal attacks, especially during the summer season. Shamima Akhtar, 37, a mother of four children and a resident of the village, informed that her daughters had to drop

out right after middle school as there is no high school nearby. 'The trek to reach the motorable road is quite risky as there are high chances of attack by wild animals. We fear sending our children to school through that route. Even the teachers of primary and middle schools fear coming all the way up," informed Shamima. While boys have the option to shift closer to their schools, girls are not easily allowed to leave their houses. As a consequence, they are forced to discontinue their education. Locals reported that many young people were attacked by bears in the past, some of whom died on the spot.

These factors along with other development challenges have collectively contributed to the low female literacy rate in

the village. Ayesha Kausar, a 21year-old student, highlighted that the most girls in this village are educated only up to Class 8, 7, and 5. "Young girls here have a keen desire to pursue education after completing primary and middle education but due to lack of development in our village, they are deprived of their dreams. People in the village work really hard to earn a meagre income and are able to make their ends meet. Sending their children away from home means extra expenses which they cannot afford. If they have to make a choice, they send boys and force girls to stay back and concentrate on household chores," expressed Ayesha, who has rented an accommodation for ₹10,000 per month to attend her college, which is 15 km away from Chikri Ban.

For six years the West African country has been ravaged by violence linked to al-Qaida and the Islamic State group that has killed thousands and displaced nearly 2 million people. Mutinous soldiers ousted the democratically elected pres-

ident in January promising to stem the violence, but since then attacks have increased.

Within a 72-hour period last week nearly 60 people, including civilians and security forces, were killed in violence targeting villages in four regions across the country, according to an internal security report for aid workers seen by The Associated Press.

'This attack in Madjoari is yet another indication of militants' capability to target security forces bases and unfortunately showing the severity of (the) security situation in northern and eastern regions," said Rida Lyammouri, senior fellow at the Policy Center for the New South, a Moroccan-based organization focused on economics and policy.

# Prez Rajapaksa swears in 9 Mins amid eco crisis

**S**ri Lankan President Gotabaya Rajapaksa swore in nine new ministers on Friday in an effort to ensure stability until a full Cabinet is formed in the debt-ridden island nation engulfed in the worst economic crisis since its independence. The ministers were sworn

in after a delay of more than a week since the president appointed new Prime Minister Ranil Wickremesinghe. Rajapaksa reappointed five-time former Sri Lankan prime minister Wickremesinghe, after his predecessor — the president's brother Mahinda Rajapaksa – resigned in the wake of violent attacks by his supporters on peaceful anti-government pro-His resignation automati-

cally dissolved the Cabinet, leaving an administrative vacuum.

The new ministers include two from the main Opposition Samagi Jana Balawegaya (SJB), while the rest come from Rajapaksa's own Sri Lanka Podujana Peramuna (SLPP) and from the group which had resigned from the ruling coalition. President Rajapaksa had appointed four ministers last week. Still, no finance minister has been appointed which is significant in the wake of ongoing negotiations with the IMF for a possible bail out. The Cabinet will be limited

to 25 members, including the President and the Prime

Beasley told a UN Security Council meeting Thursday that 49 million people in 43 countries are already "knocking on famine's door." He stressed that conflict, the impact of climate change, and the COVID-19 pandemic were already affecting food security but the war in Ukraine, which grows enough food for 400 million people, now has "the longest bread lines in the world." He said leaders must help open Ukraine's ports and increase food production.

### US accuses Russia of weaponising food in Ukraine war

US Secretary of State Antony Blinken has accused Russia of weaponising food and holding grain for millions of people around the world hostage to help accomplish what its invasion of Ukraine has not — "to break the spirit of the Ukrainian people".

He told a UN Security

Council meeting called by the United States that the war has halted maritime trade in large areas of the Black Sea and made the region unsafe for navigation, trapping Ukrainian agricultural exports and jeopardizing global food supplies.

Blinken said the meeting,

which he chaired, was taking place "at a moment of unprecedented global hunger" fuelled by climate change and COVID-19 "and made even worse by conflict." Since Russia's invasion on February 24, he said, its naval

# CCPA issues notices | Cartelisation going to be challenge, says FM

Nirmala Sitharaman on Friday said "cartelisation is going to be a challenge" and stressed on the need to look at supply disruptions in order to ensure that there are no monopolistic or duopolistic situations causing either price hikes or supply manipulations.

Amidst rising inflation which has also raised concerns about the economic recovery from the coronavirus pandemic, the minister said there are a few grievances that input costs of materials have gone up in spite of India having quite a big capacity to meet the country's own demands and also for exports.

There is a global shortage of commodities and raw mate rials as well as disruptions in the value chains and supply chains due to the pandemic and the war situation in Eastern

Europe, she noted. Addressing the 13th annuday function of the Compétition Commission of India (CCI) in the national capital, Sitharaman said there are disruptions of various kinds.

"There are very many stages at which disruptions are coming in.

Are they genuinely dis-ruptions caused by COVID or war, there is a need to look into these disruptions, look into the causes for the short supply

and also assure that there are no monopolistic or duopolistic situations causing either price hikes or supply manipulations," the minister said.

Sitharaman, who is also in charge of the corporate affairs ministry, said in the last two years, the CCI has stood up and met the challenges with a lot more positivity.

"Challenges are getting more complex, more nuanced and more technology-driven. So, the Competition Commission will have to have such skill sets so that you are never behind the curve and you are on top of the issues," she

According to her, cartelisation is going to be a challenge also due to companies scaling up and growing into areas which are of great demand.

"There could be a situation where cartelisation is a possible threat... Cartelisation is the larger word I am using and cartelisation itself is a selfexplanatory word but I am also

other things which eventually make commodities more expensive," the minister

Noting that the government wants the recovery from the pandemic to be distinctly clear and speedy, she said companies have to scale up to and meet new challenges.

"Scaling up is a proposition before us and it has to be happening in the market. Therefore, CCI will have to be very understanding of what is happening... Generally on what is this scaling up leading to.

"There is a need for a proactive understanding of whatever developments in the name of mergers and acquisitions... I am not saying that you straight away engage based on what you have understood but the knowledge you keep acquiring... Is going to keep you informed better in handling cases," Sitharaman said. In the context of digitisa-

tion, the minister said that calibrated challenges and calibrated responses are both the realities before us.

Delving into the topic, Sitharaman said that though tools of digitisation are the market forces being effectively, fairly and transparently used for the benefit of consumers, there is something which raises a question.

### 'Utility vehicles' share in new car sales likely on upward trajectory'

Mumbai: Share of utility vehicles in the overall sales of new cars is expected to be on an upward trajectory amid growing popularity of such vehicles and automakers' reduced focus on compact hatchbacks owing to rising production costs, Fitch Ratings The increasing share of higher-margin UV (Utility Vehicle)

sales will help carmakers cushion the impact on production cost due to high commodity prices and compliance to additional safe-Citing SIAM (Society of Indian Automobile Manufacturers) data, Fitch said that UV's volume share in overall car sales

increased to 49 per cent in the previous fiscal, up from 28 per cent in the year-ago period. This underscores the rising popularity of UVs over hatchbacks and sedans, whose combined share dropped from 66 per cent to 48 per cent.

Within the UV category, the share of entry- and mid-level UVs in overall car sales rose to 38 per cent in the financial year ended March 2022 from 20 per cent in FY19, underscoring customers' shift in favour of vehicles offering more space and versatile road capabilities, it said.

The agency said that higher numbers of new launches in UVs compared to hatchbacks in the past few years have supported growth. Fitch Ratings believe UVs are well-positioned to gain further share in overall car sales as UVs remain popular, particularly among upgraders and high-income customers who are typically less price conscious than buyers of entry-level cars. Entryand mid-level UV sales rose by 21 per cent year-on-year in FY21 19 pandemic, it stated. Still, the rising production costs will weigh on demand and profitability for the price-sensitive compact hatch backs and sedans, according to the ratings agency. High commodity prices and more stringent vehicle safety and emission standards have caused 20—30 per cent increase in entry-level car prices since 2018, it said.

# NADAL DISMISSES DOUBTS OVER FOOT INJURY

"There is nothing to recover," Nadal told reporters on Friday. "What happened in Rome is something that happened very often in my prac-

tices.
"I was suffering after that for a couple of days, but I feel better. That's why I'm here."

Nadal began the year with a 20-match winning run, capturing a second Australian Open title to claim a record 21st Grand Slam and move ahead of Novak Djokovic and Roger

The 35-year-old then missed six weeks with a rib injury sustained during his run to the final in Indian Wells, where he suffered his first loss of the season to Taylor Fritz.

Nadal complained of a recurring foot problem in Rome, but he appears confident it can be managed in Paris.

"The pain is there always. It's not going to disappear now. It's about if the pain is high and strong enough to allow me to play with real chances or not,"
