# Nitish Kumar keeps suspense on RCP

Hints at a 'big' decision

Amid talks of strain in the relationship between the BJP and the Janata Dal (U), and Chief Minister Nitish Kumar's hint to his MLAs that he would take some big decision in the interest of the nation, the ID(U) has kept suspense on the Rajya Sabha nomination to Union Steel Minister RCP Singh.

"Barring a last-minute surprise, it looks unlikely that the D(U) will not nominate RCP Singh to the RS for the third time," said a senior JD(U) leader. RCP's Rajya Sabha tenure is ending on July 7.

JD(U) MLAs and Ministers have authorised Nitish Kumar to take a final call on the issue.

Nitish Kumar has been quoted as having said in his meeting with MLAs and Ministers that he could make a "big" decision in the interest of the nation. "That's what he hinted at," said an MLA who was present in the meeting on Saturday

The denial of an RS berth will mean the end of the road for RCP Singh, unless the BJP adopts him and offers him a nomination from its own quota. RCP Singh is reported to have paid the price for his "closeness" to the BJP leadership. In the event of the JD(U)

In another blow to Bengal BJP, its Barrackpore MP Arjun Singh on Sunday staged a homecoming by rejoining the Trinamool Congress (TMC).

Arjun Singh joined the TMC in the presence of its national general secretary Abhishek Banerjee and a host of other leaders from the North 24 Parganas district where his constituency falls.

Singh, a strongman of Bengal's jute belt, had joined the BJP in March 2019 just ahead of the general elections and wrested the Barrackpore parliamentary seat in a fiercely-fought poll from the then sitting TMC MP, Dinesh Trivedi. Incidentally, Trivedi is in the BJP at present. Singh followed in the foot-

steps of former Railway Minister and BIP national vicepresident Mukul Roy and exsaffron MP Babul Supriyo to rejoin his old party.

He claimed that no development of Bengal is possible

without the guidance of Chief Minister

At least half-a-dozen BJP MLAs have already deserted the party and joined the Bengal ruling outfit after it roared back to power with a thumping majority in last year's Assembly elections. Dwelling on the immediate

reasons for his rejoining the TMC, Singh said, "I come from a jute belt and have been the product of jute politics ...today, 15 out of the 62 mills are closed and the jute workers and farmers are in big trouble. Centre has an apathetic approach towards them ..though there was given a small concession after I raised the issue ... Modi will also hold a bilateral meeting with US President Joe Biden. The Prime Minister is visiting Tokyo, Japan from May 23-24 at the invitation of the Prime Minister of the coun-

In his statement ahead of his visit to Japan, the Prime Minister said, "In March 2022, I had the pleasure of hosting Prime Minister Kishida for the 14th India-Japan Annual Summit. During my visit to Tokyo, I look forward to continuing our conversation further, with an aim to strengthen the India-Japan Special Strategic and Global Partnership."

### **Delhi mother, two daughters gas** themselves; leave suicide notes

A 55-year-old woman and her two daughters were found dead in their house in the posh Vasant Vihar area on pect that the three died of inhaling deadly poisonous gas and "suffocation". The women have been identified as Manju Srivastava and her daughters Anshika (30) and Anushta (26).

According to Manoj C, the Deputy Commissioner of Police (DCP), southwest district, it is presumed that they died due to suffocation.

Manju's husband had died in April last year due to coro-navirus and since then the family was in depression, and she was also bedridden due to

illness, police said. After finding the bodies, police also found three suicide notes. One of the suicide notes read, "Too much deadly gas... carbon monoxide inside. It's



flammable. Please ventilate the room by opening the window and opening the fan. Do not light match, candle or anything!! Be careful while removing the curtain because room is full of hazardous gas. Do not inhale.

The content and veracity of the note are yet to be verified and are still under investigation, said a senior police officer. Police found that the cooking gas cylinder's knob was turned on and an angithi (coal fire) was

left burning. The coal fire and lack of ventilation must have led to the build-up of poisonous carbon monoxide in the room, killing the three, police said. Police said a Police Control Room (PCR) call was received at Vasant Vihar police station around 8.55 pm on Saturday in which the caller, a local resident, stated that a house was locked from the inside and the people were not

### IPL gambling racket busted, six arrested

The Delhi Police has busted an Indian Premier League (IPL) gambling racket and arrested six people in this con-

The accused were identified as Rahul Garg (30), Kunal Garg (30), Sanjeev Kumar (50), Ashok Sharma (51), Dharmatma Sharma (46), and Kanhaiya (21). "We have registered a case under Section 3/4/9/55 Gambling Act at PS Nihal Vihar. All the accused persons were arrested and the investigation was taken up," said Deputy Commissioner of Police (DCP) Outer Sameer Sharma

"Acting on a specific input, received by Special Staff on May 15, a team of Delhi Police arrived at the premises with the informer and raided the building where they found six persons gambling on IPL matches using a laptop and other electronic devices," the police

said. According to the police, a special team was formed to conduct this raid under the supervision of the DCP.

From the spot, they also recovered ₹74,740 in cash, 10 mobile phones, two laptops. three internet routers, two LED TVs, voice recorders, call merger microphones, two notebooks (having a record of gambling) and one suitcase carrying a gambling device with five mobile phones (that were used for gambling) being attached to it. Last month, the Delhi Police arrested three people involved in an IPL betting racket in the

Vijay Vihar area.

The accused were identified as Tarun, Deepak and Dinesh Khatri. The police had recovered five mobile phones, one laptop, 1 LED TV, ₹1,09,260 cash from their possession. According to MHA officials, over a dozen gambling rackets have been busted across the country this season during



## Maha, Kerala, Raj reduce **VAT** on petrol and diesel

DELHI/MUMBAI/CHENNAI

Maharashtra, Rajasthan and Kerala have decreased VAT on petrol and diesel after Finance Minister Nirmala Sitharaman's call to provide further relief to consumers following a cut in excise duty by the Centre, though some other states appeared reluctant citing their inability to take more

strain on revenue. Senior Congress leader P Chidambaram on Sunday wondered whether the states can afford to give up revenue from the Value Added Tax (VAT) on petrol and diesel unless the Centre devolves more funds or gives them more grants, likening their situation to being between "the devil and

The Shiv Sena-led Maharashtra government slashed the VAT on petrol by Rs 2.08 per litre and diesel by Rs 1.44 per litre. A statement issued by the government said

bear an annual loss of Rs 2,500 crore as a result of this decision.

However, the DMK-led government in Tamil Nadu said that it is neither fair nor reasonable to expect states to reduce their taxes.

State Finance Minister Palanivel Thiaga Rajan said the central government had never consulted states when it increased the taxes and Tamil Nadu was already incurring a loss of over Rs 1,000 crore due to the earlier tax cut announced by the union government in November 2021. Despite the tax reduction announced by the Centre on Saturday, the rates were still high compared to 2014, he pointed out.

"The Union Government's levies on petrol have gone up substantially in the past seven years. Though the revenue to the Union Government has increased manifold, there has not been a matching increase in the revenues to states.

This is because the Union

cess and surcharge on petrol and diesel while reducing the basic excise duty that is shareable with the states," he averred.

The meeting was earlier called on Saturday but SP president Akhilesh Yadav had to rush to the national capital to meet Delhi Chief Minister Arvind Kejriwal and Telangana Minister Chandrasekhar Rao, it was rescheduled for Sunday.

The meeting was convened to finalise the party's strategy for the budget session of the UP assembly and how to corner the Yogi Adityanath government

However, with Azam Khan and Abdullah Azam skipping the meeting, the worries of the SP leadership may increase in the coming days Speculations are once again

rife that Azam Khan may take the path of Akhilesh Yadav's uncle Shivpal Singh Yadav who had earlier accused the SP chief of neglect and disrespect. Former minister and SP

MLA Ravidas Mehrotra said, Azam Khan is not well so he could not come to attend today's meeting. Tomorrow (Monday), both Azam Khan and his son Abdullah will be attending the budget session. Azam Khan will be sitting next to SP chief Akhilesh Yadav in the assembly."

### Delhi's woes to get worse as UP, HP nix plans to give extra water

elhi's water crisis is expected to worsen in the coming days as Uttar Pradesh and Himachal Pradesh have "backed out" from plans to give extra water, while Haryana is not keen to pursue a water exchange proposal with the national Capital. Amid a scorching heatwave, several parts of the national Capital are facing a water crisis these

According to Delhi Jal Board (DJB) officials, proposals involving Himachal Pradesh and Uttar Pradesh were being pursued since 2019. The two States pulled out around six to eight months ago. Delhi had a plan to exchange 140 million gallons a day (MGD) of treated wastewater for freshwater from Uttar Pradesh.

'Uttar Pradesh said it could share 270 cusecs of water from the Ganga through the Murad Nagar regulator and Delhi had promised to release an equal amount of treated wastewater to UP from Okhla for irrigation purposes.

"After multiple meetings and field inspections, Uttar



Pradesh wrote to us around six months ago that the idea has been dropped," DJB officials said.

The Centre was in favour of the proposal but Uttar Pradesh denied it. They did not give any reason for doing so, they said. Delhi also held deliberations with Haryana on a proposal to share 20 MGD of treated wastewater for irrigation through Jaunti and Auchandi regulators in lieu of freshwater through Carrier Lined Canal (CLC) and Delhi Sub Branch (DSB).

"Harvana has not agreed to the proposal yet. There is a very slim chance of it happening now," the officials

Another official said the

for a water exchange with Haryana is pending at the level of the Jpper Yamuna River Board. Delhi generates around 770 MGD of wastewater. The 34 sewage treatment plants located at 20 locations across the city treat up to 570 MGD

Around 90 MGD of treated wastewater is being utilised for horticulture in parks and forests, irrigation and DTC depots. The capital is obligated to release 267 MGD of treated wastewater into the Yamuna to maintain the environmental

In December 2019, Himachal Pradesh signed an MoU to sell its share of Yamuna water to Delhi at Rs 21 crore per annum. Water had to be delivered at Tajewala (in Haryana's Yamuna Nagar district) to

According to a statement released at that time, Himachal Pradesh was supposed to "provide regular, daily supply of 368 cusecs (198 MGD) from November to February and 268 cusecs (144 MGD) from March to June every year".

According to a multistate agreement signed in 1994, Himachal Pradesh gets a three per cent share of Yamuna water.

This share has remained unclaimed since then. It was Haryana which had first

share of Yamuna water to Delhi. Haryana contended that its "canals did not have the capacity to carry extra water from Himachal Pradesh to Delhi", another

Thereafter, Himachal Pradesh also "backed out" from the agreement around six months ago. An official said, "Our engineers worked really hard to turn these plans into reality, but the neighbouring states backed out due to political rea-

Delhi requires around 1,200 MGD of water, while the DJB supplies around 950 MGD. Haryana supplies a total of 610 million gallons of water a day to Delhi through two canals -- CLC (368 MGD) and DSB (177) -- and the Yamuna (65 MGD). CLC and the DSB are supplied water from Hathni Kund via the Munak

canal and Bhakra Beas Management Board. Besides, Delhi receives 253 MGD from Uttar Pradesh through the Upper Ganga Canal, and 90 MGD is drawn from ranney wells

across the city.

### Ashwani Kumar, Gyanesh Bharti assume charge in unified MCD

After 10 long years, the trifur-cated Municipal Corporation of Delhi (MCD) once again merged into a single entity on Sunday, as IAS officers Ashwani Kumar and Gyanesh Bharti assumed charge as the new civic body's special officer and commissioner, respectively. Making the unified MCD financially stable will be among the key challenges before Kumar and Bharti.

After assuming the charge on Sunday, Kumar told *The Pioneer* that they would make sure that the MCD gets the appropriate funds from both the State Government and the Central Government as cited in the constitution.

"Our top priority will be the sanitation work in the national capital, to make the city clean. We will ensure that people of the city will get a hygienic environment to live in," he said. Kumar said that he would discuss with officials of MCD to improve its financial health. "The state government has recently released some money to the civic body, he added.

Kumar's appointment as the special officer of the unified MCD is considered significant as he is expected to play a vital role in the functioning of the unified municipal corporation, months before the civic elections.

While informing about the plan to make the corporation work in a more effective and environment friendly way, he said that they will



make the MCD paperless, in order to save the trees and bring digitalisation to the civic body.

"The Civic body will speed up the work at Ghazipur landfill area to avoid any further fire incidents at the place. The further steps for the betterment of the city will be discussed in a meeting with the officials," he added.

A day before taking the charge as the SO of the MCD, Ashwani Kumar along with the Commissioner Gyanesh Bharti and Chief Secretary, Government of NCT Delhi, Naresh Kumar visited the Ghazipur landfill site which has been in the headlines for the past few months and took the stock of the situation.

Meanwhile, in its first order after assuming the charge of MCD commissioner, Bharti made it clear that erstwhile Central Establishment Department (SDMC) shall be the nodal Central Establishment Department of unified MCD. Similarly, the erstwhile Office of CA-cum-FA and the Accounts Department (HQ), SDMC shall be Finance/Accounts Department of unified MCD

On Sunday, MCD Commissioner welcomed Kumar and introduced officers to him. He also briefed him about the working of the corporation and also briefed him about challenges being faced by the civic body. Senior officials from various departments of the MCD, who were present on the occasion, also greeted both.

Bharti, was the commission-er of the South Delhi Municipal Corporation prior to this assignment, and he was the seniormost among Delhi's erstwhile three municipal commissioners said that his priority will be to provide the best municipal services delivered to the people of Delhi in a transparent manner.

### Join Lakshadweep admin now or face action: MHA to 6 DANICS officers

Taking note of challenging its transfer order, the Ministry of Home Affairs has warned of disciplinary action "without any further reference" against six DANICS (Delhi, Andaman and Nicobar Island Civil Services) officers, working with the Delhi Government, if they fail to join the Lakshadweep Administration "immediately".

In a fresh order dated May 20, the MHA directed six officials -Sandeep Kumar Mishra, Sravan Bagaria, Shailendra Singh Parihar, Ramchandra Mahadev, Nitin Kumar Jindal and Rakesh Kumar have been asked to immediately report to the Union Territory (UT) Lakshadweep administration and forward a copy of their joining report, failing which Das ruled that there was "no

rules will be initiated without any further reference. The ministry has marked its order to all UTs and Chief Secretary of Delhi. They were initially served the transfer order in November last year, after which the officers moved the CAT. They were again served with a reminder in February to join their new posting but that too was ignored as the matter was pending before the

Sources said that there are over two dozen DANICS officials staying in Delhi despite their transfer order. The MHA has prepared a list of such officials who have refused to go outside Delhi despite their transfer orders.

In its 23 pages order, the CAT Principal Bench said, "We are of the view that it is not necessary to give the reason in the transfer order itself".

"It is his duty to first report for work where he is transferred and to make a representation subsequently as to what may be his personal problems, which has admittedly not been done in the instant case.

The Principal bench also said that no government servant has any legal right to be posted at any particular place since the transfer of an employee appointed to the class or category of transferable posts from one place to another is not only an incident but a condition of service, "necessary too in public interest and efficiency in the public administration". Aam Aadmi Party (AAP) leader Amanatullah Khan has sent a legal notice to the Delhi Police through his lawyer demanding an "unconditional public apology" for allegedly vio-lating his and his family's "fundamental rights".

ly targeting me. This time Delhi Police attacked my right to live with dignity besides defaming my family. Delhi Police is weaving imaginary stories about me without any evidence," Khan tweeted Sunday sharing the copy of the notice.

The legal notice sent to

Delhi Police Commissioner on Saturday by Khan's lawyer demanded an "unconditional, written, public apology" to his wife and children allegedly for "brazen infraction" by the force of their fundamental rights.

The notice claimed that Khan, who is also the chairman of Delhi Waqf Board, was "peacefully" protesting against the anti-encroachment drive by South MCD in the interest of the local public on May 12.

### Completed 66% of desilting of drains: MCD

**STAFF REPORTER** ■ NEW DELHI

The Municipal Corporation ■ of Delhi (MCD) on Sunday said that it has removed about 60,000 metric tonnes of silt and completed nearly 66 per cent of the work of desilting of drains. The civic body also said that the remaining work will be completed by June 15. However, the MCD statement came after the AAP leader Durgesh Pathak alleged that with monsoon approaching, the Bharatiya Janata Party (BJP)-ruled that MCD fails to make preparations to desilt drains in time to avoid water-

logging. Amit Kumar, Director of the Directorate of Press and Information, said that the Civic Agency has so far removed about 60000 metric tonnes of silt from various drains, completing about 66 per cent of the total target and the remaining work will be com pleted by June 15.

The silt taken out from the

drains is being sent to the landfill site and its monitoring is being done through RFID tags. The entire process is fully computerized and there is no manual interference. The MCD is fully committed to providing better and improved civic amenities to the citizens," he said.

Meanwhile, the AAP leader, Durgesh Pathak said that monsoon showers are on the verge of hitting the national Capital and 95 per cent of drains come under BJP-ruled MCD's purview but they haven't even started cleaning them yet.

"It is May 22 today, and there isn't much time left before June 5floats by, and the monsoons are upon us. Despite a mere 10-15 days remaining, the BJP-ruled MCD has not yet begun the process of cleaning the silt out of drains measuring 60 foot or less, which cover 95 per cent of Delhi's drainage system," Pathak claimed.

"It is important to bring this dismal state of affairs to public

If the due process had been followed, the process of cleaning out these drains, which come under the BJP-led MCD, should have been completed by now. ### Cong attacks Centre's cut in fuel prices, calls it trickery, optical delusion

The Congress on Sunday attacked the ■ Modi Government over the Centre's cut in fuel prices by saying the BJP is resorting to "trickery" and is creating an "optical delusion". The party remarked that even after the cut in excise duty, the prices of petrol, diesel and LPG cylinder are much higher than in April 2014.

Former Finance Minister P Chidambaram said whether the states can afford to give up revenue from VAT on petrol and diesel unless the Centre devolves more funds or gives them more grants, likening their situation to being between "the devil and the deep sea".

The senior Congress leader remarks come a day after the government announced Rs 8 per litre cut in excise duty on petrol and Rs 6 reduction on diesel.

"The notification on reduction of

duty on Petrol and Diesel is now available. FM used the words 'Excise Duty', but the reduction is in Additional Excise Duty which is not shared with the states. Hence contrary to what I said yesterday, the entire burden of the reduction falls on the Centre. To that extent, I stand corrected," Chidambaram said.

"The states are getting very little by VAT on petrol and diesel. I wonder if they

the Centre devolved more funds or gave them more grants,' Chidambaram said.

Congress spokesman Gaurav Vallabh said the BJP government's cluelessness about the economy and financial management has been open for a long now. "Instead of accepting it and seeking guidance from experts, BJP only resorts to trick-

It also mentioned Kalyanmoy Ganguly, the president of the West Bengal Board of Secondary Education in the first information report.

The CBI slapped charges of criminal conspiracy, cheating and forgery against them, the official said.

The agency has asked the five officials to submit "details of their bank balance and income tax returns as well as details of properties they have purchased in the names of

other people", the agency official said.

In its FIR, the central agency also mentioned that the SSC advisory panel was formed on the insistence" of the then education minister Partha Chatterjee, he said.

The development came after state minister Paresh Adhikari was interrogated for the third consecutive day on Saturday on the 'illegal" appointment of his daughter as a teacher in a government-aided school. The agency had also quizzed Chatterjee in connection with its investigation into the alleged irregularities in recruitment to schools.

Chatterjee, who is now the industry and commerce minister of the Mamata Banerjee government, was the education minister when the alleged illegal appointments were made. A division bench of the

## to reduce VAT on fuel

### **Quick march**

The Army is mulling recruitment of jawans on a four-year 'Tour of Duty'

he Indian armed forces may no longer recruit jawans permanently. A shortterm 'Tour of Duty' (ToD) scheme is on the anvil. Recruits will be trained for six months and take up soldiering for three and a half years. They get discharged at the end of the four-year term with a decent severance package and a degree or a certificate attesting to their ToD status. The Government feels this is the best way to tackle shortages and infuse the services with fresh blood at short intervals. The short tenure saves the Government expenses on pension and medical benefits — one of the largest cost components. Some of the ToD retirees could later be selected for a longer or a permanent position. The scheme will thus save money and wipe out personnel shortages. The armed forces are short of person-



nel at present because recruitment rallies were not held in the last two pandemic years. On average, 50,000-60,000 soldiers retire every year. With recruitment suspended, the shortfall stands at over one lakh soldiers. The existing process will take around one and a half years to select and train recruits. By that time, the shortfall will pinch the services much more. The ToD scheme, if implemented right away, cannot solve the problem overnight. If the selection process — the same as the current one — takes six months and the training another six months, the new soldiers will be ready in a year. Thereafter, the process will become seamless.

It remains to be seen how the youth react to the ToD programme. On the face of it, they have no reason not to take up the attractive challenge. It targets those who are at least matriculates and gives them a chance to join the services and retire after just four years, still in their mid-20s, and armed with decent savings and a work certificate to boot. The opportunity saves them from hunger pangs, makes them employed and, in the end, leaves them qualified for better jobs. Importantly, it will keep them off the streets where circumstances force many of them to get into questionable activities. Some immediate thoughts come to mind about the unique scheme. What happens if forces need to be rushed to the borders or when hostilities break out? Can a ToD jawan with six-month training handle a situation at the front line? It is said a soldier needs up to three years to be fully ready for combat and acquire skills related to combat support and combat service support. By the time the recruits become combat-ready, it will be time for them to retire. Will all ToD recruits be trained as combat personnel only? Or are there avenues to promote other careers within the military? For ToD recruits, most of whom may not return for a permanent role in the services, the four-year tenure can then mean an opportunity to acquire vocational skills that can lead them to jobs as discharged soldiers.

### A futile effort?

The Congress Chintan Shivir failed to throw up anything concrete to help it regain lost footing

'he latest Congress jamboree at Udaipur, aka Chintan Shivir, is over. It was supposed to be an exercise by the 'grand old party' to soul search, find faults within and tread on the path to revival. If one goes by the reaction of party men and media persons at the Shivir, it was just another meeting without any effort to usher in radical changes that could revive the party. The Chintan Shivir, which was called 'Nav Sankalp Chintan Shivir', failed to achieve anything meaningful. The main agenda, however, was to absolve the party's high command of all the electoral debacles in the recent past. A camp like this should have been an interactive exercise that could obliterate the line between the leaders and workers. But



Rahul Gandhi seemed aloof and reluctant to connect with his party workers. The Congress seems to have made peace with its existing situation and status quoist mindset. There were no sessions dedicated to introspecting and rectifying the problems alienating the party from people. Despite the BJP handing it issues on a platter, it has been unable to cash in on these. Hardly any Congress leader on the ground connects with people or takes up their issues.

One of the decisions taken at the Shivir is to take up Bharat Jodo Yatra, starting October 2. It would be a 3,500-km rally to create awareness about the BJP's game plan among people. How far

it would serve the purpose we don't know yet, but it's indeed a good strategy. Advani's Rath Yatra and Chandrashekhar's yatra did make a difference. The Congress could also think of galvanising State and district units to create awareness among people and stop polarisation. Congress president Sonia Gandhi was right in her speech about polarisation and the ruling party's strategy to deflect attention from real issues. But the moot question remains what the Congress is doing to call the bluff. The BJP sets the agenda and blames Congress for the problem; yet it is unable to effectively retort to it. Of course, the Congress' revival strengthens Indian democracy as only a national party can effectively play the role of meaningful Opposition. Regional satraps are regional in their scope and approach. For a vibrant democracy, a strong Congress in and out of Parliament is the only guarantee against the BJP's bulldozer.

# The current mess in Lankan politics PRAFULL GORADIA



The installation of a new, and experienced, Government in the island nation is a harbinger of good change, and India must lend a helping hand

ow that a responsible and experienced replacement for the unpopular and forcibly ousted Prime Minister Mahinda Rajapaksa has been appointed, it is time for Sri Lanka to decide how it wants to recoup the current economic depression. On television, Ranil Wickremesinghe, the new Prime Minister, has stated that he has a revival plan. He has some credibility because of his track record, as well as his having served as the PM five times. What role India wishes to play is for South Block to decide; I personally do feel that India should try and play a significant role in Sri Lanka, especially because of its geopolitical situation. Both New Delhi and Colombo are aware that India has a 7,500-km coastline in the Indian Ocean. On the other hand, Sri Lanka is strategically at the southern end of the Indian praayadweep (peninsula). Coming to the current situ-

ation in our southern island neighbour, there is an unalienable law and order scenario with Sri Lanka's citizens in open conflict with security forces. I have visited Sri Lanka four times in my lifetime and am somewhat familiar with the political and ethnic issues there, but I must admit that the torching of recently deposed PM Mahinda Rajapaksa's ancestral home in Hambantota by a mob has come as a bit of a shock as people there are generally an amiable and easygoing lot. However, keeping cordiality is difficult when one has to wage a daily struggle merely to survive; in Sri Lanka's case, the country has been suffering prolonged power cuts (up to eight hours a day in several parts of the country, according to several reports), lack of food and inflated cost of all essential items.

Most international agencies have severely downgraded the country's sovereign ratings and its foreign exchange has fallen, too. Sri Lanka, even in happier times, lived mainly on tea, rubber, coconut and tourism as the main revenue earners. vioreover, the ruling Kajapaksa dynasty's profligate ways and majority Sinhalas have har-



If one talks to a Sinhala scholar or journalist, he may well begin by blaming the cost of Lanka's civil war with its Tamils. He would not admit that the Tamils have been in eastern Sri Lanka since the beginning of civilisation. I first visited the country in 1964, and could soon thereafter sense that the Sinhala jealousy towards the Tamils was noticeably intense. For example, my father-in-law predicted that the next chief executive of the British Ceylon Corporation (like the British Indian Corporation at Kanpur) would be Pereira and not Swamidasan, who was more competent. The former was a Sinhala. The latter subsequently migrated to Australia. This was less than





#### THE CAUSES OF RUPEE **HITTING ALL-TIME LOW**

Policy intervention could reverse the trend

he rupee has shown a lot of irregularities since January,2022 The Rupee stood 73.77 against the Dollar on 12th January, 2022 and since then it is in downward trend. On 16th May, 2022, the Indian rupee fell to an all-time low of 77.81 against the previous low of 76.98 against the USD.

The increase in the rate hike by the Fed earlier this week by 50 bps has created a huge demand for USD in local markets. Foreign investors are pulling their money out of the Indian stock market owing to greater demand for USD. The outflow of foreign investors has pulled 1.5 lakh crores so far from the Indian stock market. This has caused a huge gap to be filled by domestic investors. About one-fifth of India's total imports are accounted by crude oil. Because of the Russia-Ukraine war, crude oil prices have skyrocketed. The cost per barrel has broken all records after the 2008 recession and came to a high of \$123.70 in the year 2022. This has caused the strengthening of the USD and caused a major concern in the current account deficit of India.

It is expected to hit a 10 year high of 3.3% of GDP this year, causing the rupee to fall even more. While China and Japan are unable to adjust their monetary policy according to the US federal rate hike, it has drastically affected the value of their currencies along with major



Performing poorly, the rupee was bound to be affected. The lockdown in China has made it difficult to deal with a lot of companies, which has caused the yuan to depreciate further, affecting sentiments of emerging market currencies. Economists believe the dollar is strengthening not only as a result of aggressive Fed policy, but also as a result of weak rising sentiment. There is a greater risk in the market because of the Russia-Ukraine war and a tighter lockdown in China. Therefore, the significance of safe currency in a changing world increases.Food inflation, which accounts for almost half of the Consumer Price Index (CPI), has been increasing in multilevel due to the global rise in the price of vegetables and cooking oil. A global supply shortage has caused the inflation level to reach an all-time high. Wholesale price index of India also jumped to an all-time high of 15.1% in April 2022 compared to the previous 14.6% in March 2022. All these factors are putting pressure on emerging markets like India causing them to depreciate against the USD.

To ensure the safety of the rupee, the Reserve Bank of India has started selling large chunks of foreign reserves. The \$642.5 billion foreign Reserve has fallen to \$597.7 billion because of selling. There is a continuous fall in weekly foreign Reserve. The Reserve Bank of India also increased the repo rate by 40 basis points, changing from 4% to 4.40% and CRR increased by 50 basis points (4.5%) to tackle inflation among the falling rupees. Feweconomists believe that the rupee will continue to lose as there is a significant difference in longterm inflation between India and the USA. On the other hand, someeconomistscontend that value of the rupee will rise again through intervention of tools of monetary policy.

minister Nitish Kumar, Shahnawaz himself dubbed industrialization of the state as impossible when he said that his party always assigns him impossible tasks and he was never found wanting. Nitish Kumar not long ago said without pretence that Bihar being landlocked is unfit for industrialization.

Hussain said Prime Minister Narendra Modi has mandated him to pull out all stops to bring industries to Bihar and he has his full blessings. The ethanol plant has been a dream of Modi and Bihar emerged as the first state to take it up. Textile and leatner policies are in the offing and once they are in place, investment proposals will pour in. Food Park, Mega Textile Park, Logistic Park, leather parks are in the pipeline.

MOUs are flaunted in any Investors' meet but they were conspicuous by near absence. Hussain rationalised it by saying that the meet was organised just to fathom the interests of industrialist. The interest they evinced was palpable. Hussains goodwill in the media was equally palpable which spared him many blushes. The rough edges around gaps in Investors
Meet were safely put on the back
burner. Questions around CM
Nitish Kumar could have queered the pitch. The absence of Nitish Kumar itself was tricky issue.

## Russia presses Donbas offensive as Polish leader visits Kyiv

 $R^{\hbox{\it ussia pressed its offensive in}}_{\hbox{\it Ukraine's eastern Donbas}}$ region on Sunday as Ukrainian President Volodymyr Zelenskyy said the outcome of the gruelling conflict would determine whether his country's fate lies with the West or under Moscow's domination.

After declaring its full control of a sprawling seaside steel plant that was the last defence holdout in the port city of Mariupol, the Russian military launched artillery and missile attacks in Ukraine's industrial heartland, seeking to expand the territory Moscow-backed separatists have held since

In a Saturday night video address to the nation, President Zelenskyy described the situation in the Donbas as "really hard" but "the fact that we are able to say this on the 87th day of a full-scale war against Russia is good

"Every day that our defend-

ers take away from these offensive plans of Russia, disrupting them, is a concrete contribution to the approach of the main day. The desired day that we are all looking forward to and fighting for: Victory Day," Zelenskyy said.

Zelenskyy's remarks came as Poland's president prepared to meet with him to support Ukraine's goal of becoming a candidate for European Union membership, a issue set to be decided at an EU summit in

As the West rallies behind Ukraine, Polish President Andrzej Duda made an unannounced visit to Kyiv and on Sunday became the first foreign leader to address the Ukrainian parliament since the start of the Poland, which has wel-

comed millions of Ukrainian refugees since Russia invaded its neighbour, has become a major gateway for Western humanitarian aid and weapons going into Ukraine. The government in

Warsaw also is a strong sup-



porter of Ukraine's desire to join the European Union.

The 59-year-old career politician, who has described ĥimself as the only candidate with a "non-Anglo Celtic name" to run for prime minister in the 121 years the office has existed, referred to his humble upbringing in the inner-Sydney suburb of Camperdown while thanking electors for making him the country's 31st leader.

"It says a lot about our great country that a son of a single mom who was a disability pensioner, who grew up in public housing down the road in Camperdown, can stand before you tonight as Australia's prime minister," Albanese told jubilant supporters after tipping Scott Morrison out of office to end nine years of conservative rule.

"Every parent wants more

for the next generation than they had. My mother dreamt of a better life for me. And I hope that my journey in life inspires Australians to reach for the stars," he said.

But it remained unclear whether Albanese's party could form a majority government or have to rely on the support of an increased number of independents and minor party lawmakers who won seats in Saturday's election, in results analysts described as extremely complicated, and which also mirrored the face of modern Australia.

With counting set to continue for many days as postal votes are tallied, one prospect that emerged was that Albanese

may need to be sworn in as acting prime minister - possibly as early as Sunday - to attend Tuesday's Quad summit in Tokyo with US President Joe Biden, Japanese Prime Minister Fumio Kishida and Indian Prime Minister Narendra

The election delivered a clear rebuke to Australia's traditional two-party system, both to Labour and the heavily defeated conservative coalition led by the Liberal party's outgoing Prime Minister Morrison.

The major parties bled votes to fringe parties and independents, including in many seats considered Labour or coalition strongholds.

Needing 76 seats in the lower Parliamentary chamber, the House of Representatives, to govern in their own right, Labour on Sunday morning had won 72, with 66.3% of votes counted, according to the Australian Broadcasting Corp. The Liberal-National coali-

tion had secured just 50 drastically down from its baremajority 76 in the 2019 poll, in what analysts called a fierce rejection of Morrison and his team's handling of many issues in its three-year term including climate, COVID-19, women's rights, political integrity and natural disasters such as bushfires and floods.

A total of 15 seats had been declared for independents or minor party candidates. Of these, three were from the environment-centric Green party and 12 were non-aligned politicians, with up to nine of those so-called teal independents. In a new wave in Australian politics, the teal independents are marketed as a greener shade than the Liberal Party's traditional blue colour and want stronger government action on reducing Australia's greenhouse gas emissions than either the government or Labour are propos-

Most of their successful candidates are women, their success seen partly as a repudiation of Morrison for his handling of gender issues including sex scandals that have rocked Parliament during his latest three-year term.

While Labour will form either a majority or minority government, both major parties lost ground, with support for the coalition dropping by more than 6% from the 2019 election, and Labour's vote falling by around 1.2% as of Sunday

Albanese vowed to bring Australians together in a government of unity, to increase investment in social services and to "end the climate wars."

"My Labour team will work every day to bring Australians together. And I will lead a government worthy of the people of Australia," he said.

Albanese, who revealed in a 2016 interview he had tracked down his biological father in Italy in 2009, four years before his death, said his surname and that of new government Senate leader Penny Wong, who is of Chinese ancestry, reflected modern, multi-cultural

An Indian ship carrying durgent relief supplies like rice, life-saving medicines and milk powder for the people of crisis-hit Sri Lanka arrived in Colombo on Sunday and the consignment was handed over to the government in the island nation.

Indian Commissioner Gopal Baglay handed over to Lankan Foreign Minister G L Peiris the consignment which consists of 9,000 metric tonne (MT) of rice, 50 MT of milk powder and more than 25 MT of drugs and other medical supplies.

"Sri Lanka today received Rs. 2 Billion worth Humanitarian aid including milk powder, rice and medicines from India. Our sincere gratitude to the Tamil Nadu Chief Minister Hon. @mkstalin and the People of India for the support extended. I also appreciate the assistance given by the @IndiainSL and CWC . Leader @S\_Thondaman in Sri Lanka," Prime Minister Ranil Wickremesinghe tweeted.

This is also the first consignment under a larger USD 16 million commitment of 40,000 MT of rice, 500 MT of milk powder and medicines by Government of Tamil Nadu, an official release said. "A message of care!!! From

the people of India to the people of Sri Lanka... High Commissioner handed over rice, milk powder & medicines worth more than SLR 2 billion to Hon'ble FM Prof.G.L Peiris in #Colombo today," the High Commission of India in Sri Lanka tweeted.

"More consignments from #India to follow," it said in another tweet. Speaking at the ceremony here attended by several Lankan ministers, Foreign Minister Peiris said "India has not sent any assistance anywhere of this scale

"They are to assist us more for which we would be grateful," Peiris said, adding that India had so far extended assistance worth USD 4.5 billion.

A record 31 candidates entered the race, but the battle being watched most closelv is between two who registered as independents.

One is former Transport Minister Chadchart Sittipunt, a front-runner, and the other Asawin Kwanmuang, who served as the military-appointed governor since 2016. He stepped down in March to contest the election.

The candidates campaigned on issues including congestion, pollution and persistent flooding. There are 4.4 million registered voters in the city, the country's biggest.

Apart from governor, they're also electing city council members. Bangkok's last gubernatorial election was in 2013, a year before the military toppled a democratically elected government. Neither the main opposi-

tion party in Parliament, Pheu Thai, nor the ruling Palang Pracharath party, associated with the military and the ruling conservative establishment, officially have candidates on the ballot.

However, 55-year-old Chadchart is seen by both supporters and opponents as a proxy for Pheu Thai, for which he stood as a prime ministerial candidate in the 2019 general election. He served as transport minister in a Pheu Thai government in 2012-

His main rival is 71-yearold Asawin, who was appointed governor in 2016 by Prayuth Chan-ocha. As army commander, Prayuth seized

power in the 2014 coup to lead a military regime, and he dismissed the previous governor over corruption allegations. Prayuth was returned to office following the 2019 election as prime minister in a coalition government.

Prayuth, in power for eight years, is expected soon to face a no-confidence motion in Parliament, and rivals on his own side have long been rumored to be seeking to remove him. Even if he survives, there must be a general election by early next year.

Prayuth was able to rule by decree as head of a military government but has struggled within the limits of parliamentary democracy, taking fire especially for fumbling Thailand's coronavirus vaccination program and recovery

Other candidates include Suchatvee Suwansawat of the Democrat Party. He's seen as having an outside chance if conservative voters support him instead of Asawin. The Democrats have historically been a power in Bangkok but have fractured badly in the past two decades of polarized politics that have seen street vio-

lence and two coups. A fourth candidate whose results will be carefully watched Lakkhanaadisorn from the progressive opposition Move Forward Party, which takes a more critical stance than Pheu Thai toward the government.

Political science professor Thitinan Pongsudhirak of Bangkok's Chulalongkorn University noted this was the first significant election since the 2014 coup.

# impact 425 infra projects

New Delhi: As many as 425 infrastructure projects, each entailing an investment of Rs 150 crore or more, have been hit by cost overruns of more than Rs 4.83 lakh crore, according to a report.

According to the Ministry of Statistics and Programme Implementation, which monitors infrastructure projects of Rs 150 crore and above, out of 1,579 projects, 425 projects reported cost overruns and as many as 664 projects were delayed.

"Total original cost of implementation of the 1,579 projects was Rs 21,95,196.72 crore and their anticipated completion cost is likely to be Rs 26,78,365.62 crore, which reflects overall cost overruns of Rs 4,83,168.90 crore (22.01 per cent of the original cost)," the ministry's latest report for March 2022 said.

According to the report, the expenditure incurred on these projects till March 2022 stood at Rs 13,88,760.73 crore, which is 51.85 per cent of the anticipated cost of the projects.

However, the number of delayed projects decreased to 561, if delay is calculated on the basis of the latest schedule of completion.

Further, for 606 projects neither the year of commis-



sioning nor the tentative gestation period has been report-

Out of the 664 delayed projects, 94 have overall delays in the range of 1-12 months, 124 have been delayed for 13-24 months, 331 projects for 25-60 months and 115 projects have been delayed for 61 months and above.

The average time overrun in these 664 delayed projects was 42.41 months.

Reasons for time overruns as reported by various project implementing agencies include delay in land acquisition, delay in obtaining forest and environment clearances, and lack of infrastructure support and

Delay in tie-up for project financing, delay in finalisation of detailed engineering, change in scope, delay in tendering, ordering and equipment supply, and law and order problems are among the other reasons. The report also cited state-wise lockdowns due to COVID-19 as a reason for the delay in implementation of these projects.

It has also been observed that project agencies are not reporting revised cost estimates and commissioning schedules for many projects, which suggests that time/cost overrun figures are underreported, it stated.

### Cost overruns of ₹4.83 L cr | Taxpayers can now claim refund of IGST on ocean freight: Experts

New Delhi: Taxpayers who have paid GST on 'Ocean Freight' on imported goods will be entitled to claim refunds, following the Supreme Court verdict, provided they have not claimed input tax credit, experts said.

Giving its ruling in the Mohit Minerals case, the Supreme Court held that since the Indian importer is liable to pay IGST on the 'composite supply', comprising of supply of goods and supply of services of transportation, insurance, etc in a CIF (Cost Insurance Freight) contract, a separate levy on the Indian importer for the 'supply of services' by the shipping line would be in violation of ... The CGST Act.

In this particular case, the company had challenged the validity of the CBIC notification regarding levy of Integrated GST on ocean freight in the Gujarat High Court. The Supreme Court upheld the decision of the Gujarat High Court which had favoured the company.

Tax Connect Advisory Services Partner Vivek Jalan said this is a big relief for importers and GST taxpayers. "Infact those taxpayers who had already paid the GST may also seek a refund of the same

This is a dual levy of IGST as the same has already suffered tax as part of the value of goods. Moreover, these services are received by the foreign exporter, thus the Indian importer shall not be held liable to pay GST on the same, he said.

"Through this, a window of opportunity has been opened for the importers who have already paid the tax to demand refund from the exchequer,' Mohan added.

Federation of Indian Export organisations (FIEO) DG Ajay Sahai said FIEO has already represented that ocean freight on goods imported on CIF basis should not be charged as it is tantamount to double taxation, adding to the liquidity problem.
"While the set off of IGST

on imports was available but after a time lag, it was adding to the challenges for manufac-turers and exporters," Sahai

Nangia Andersen LLP, Director- Indirect Tax, Tanushree Roy said levy of reverse charge on ocean freight is now unconstitutional in view of the landmark judgement of the Supreme Court of India in ocean freight matter.

"Indian importers (who had paid GST under RCM on Ocean Freight) should evaluate the possibility of filing refund claims for claiming the said amounts (to the extent not utilized as input credit).

"Further, importers who had not paid the tax on import of such Ocean Freight services would no longer be required to pay GST on such services in view of the said judgement,'

#### Excise duty cut on petrol to help pare logistics cost; promote exports'

New Delhi: Excise duty cut on petrol and diesel and rationalisation of customs duties on goods such as raw material for plastic and steel will help reduce logistics cost, promote competitiveness of manufacturing and exports of valueadded goods, exporters said on Sunday

The government on Saturday announced reduction in excise duty on petrol by a record Rs 8 per litre and that on diesel by Rs 6 per litre. It also cut import duty on raw material of steel and plastic and increased export duty on iron ore and steel intermediates.

Federation of Indian Export Organisations (FIEO) President A Sakthivel said these measures will bring down the domestic prices of key inputs thereby softening inflation.

This will also add to the competitiveness of the manufacturing and export sector and will further push valueadded exports from the country. These proactive measures will also ease the logistics pressure and bring down the freight bill of the country as in some cases the same raw material was being exported from the country and subsequently being imported by the down-stream users," he said.

Sharing similar views, leading Mumbai-based exporter and Chairman of Technocraft Industries. Sharad Kumar Saraf said reduction in excise duty on petrol and diesel will reduce logistics costs and will support exports particularly of commodities which are freight sensitive. "Export duty on iron ore and semi finished steel products like HR coils and bars already has a desired effect. Steel prices have started softening and this will have a significant positive impact on our engineering exports. The government must be complimented for such actions," Saraf said.

Tools Association President S C Ralhan too said the iron and steel industry should pass on the benefits to the engineering sector, particularly the MSME units, which are reeling under the impact of high iron and steel prices. Plastics Export Promotion Council Chairman Arvind Goenka said it is a welcome move that will help the plastic processors be more competitive in the domestic market for sure. ### Sun Pharma recalls over 10,000 bottles of generic anti-depression

New Delhi: Drug major Sun Pharma is recalling around 10,500 bottles of a generic drug meant for the treatment of major depressive disorders in the US market following a customer complaint.

According to the latest enforcement report of the US Food and Drug Administration (USFDA), the US arm of the domestic pharma major is recalling 10,548 bottles of bupropion hydrochloride extended-release tablets in the American market.

The drug is used to treat depression and prevent Seasonal Affective Disorder (SAD). It is also used to help people stop smoking.

As per the USFDA, the company is recalling the affected lot due to "presence of foreign substance: Customer complaint for the presence of dark, gritty substance found within the bottle, which was determined to be activated carbon from the desiccant canister inside the bottle".

The drugmaker is recalling the product in 150 and 200 mg strengths, it added.

The company is recalling 9,804 bottles of 150 mg strength and 744 bottles of 200 mg strength, the US health regulator stated.

The affected lot of the medication was manufactured by the drug maker in its Halol (Gujarat) based manufacturing plant. In the US, the medication was distributed by New Jersey-based Pharmaceutical Industries Inc.

hile there have been many guidelines published by pediatric ophthalmologists from the west, there have been no such practice patterns available for Indian ophthalmologists and what would be the preferred clinical practice for our country. This document, "Consensus Guidelines for Prevention and Management of Childhood Myopia" hopes to fill this void and provide guidelines in the Indian scenario, says Dr Namrata Sharma, pediatric ophthalmologist, AIIMS, Delhi.

The goal is to spread awareness about the dangers of myopia and ultimately reinforce the benefits associated with implementing myopia management treatment during early childhood, pointed out Stating that the myopia epidemic will affect half of the global population by 2050, she tells you.

between six and 13 years of age. "Cases of shortsightedness in urban settings in India are all set to spike to 48 per cent by 2050. Cases are on the increase in rural areas also," the ophthalmologists dwelled deeper into the threat creeping in the kids' world at the AIOS meet.

The Members broke down cases from their real-life experiences to highlight the significant risks that are associated with myopia in children.

"Unattended or uncorrected shortsightedness is the most common cause of vision loss. In fact, too often, myopia is considered a simple refractive error that can be easily remedied with spectacles or contact lenses. But myopia can lead to physical changes in the eye's structure, increasing the risk for retinal complications, cataracts and glaucoma, Dr Nayak says.

"While in some children it remains stable, others show gradual progression

Don't rub eyes

till the age of 18 to 20 years. This makes the 2nd part of preventing and arrest-ing the progress of Myopia, equally important," he adds. It is mandatory to seek immediate intervention to prevent complications in adulthood, the members were unison in their views.

making children spend more time outdoors, exposing them to natural lights during class recess and less screen time are some of the ways to check Myopia progression, they note.

The guidelines deal with the various aspects of myopia such as classification, appropriate clinical evaluation, and corrective options of management, counseling and guidelines for the measures taken for arrest of progression in myopia.
"There is an urgent need to

address this potential public health crisis and raise awareness among ophthalmologists about the various modifiable environmental risk factors for myopia, available anti myopia interventions and their correct usage," adds Prof. Rohit Saxena from Dr. Rajendra Prasad Centre for Ophthalmic Sciences, AIIMS, Delhi.

"Hence, it is important that parents and teachers are made aware of how to identify onset of myopia in kids and when identifying what steps needed to check its progression. Facts should be presented in simple, uncomplicated terms and should include available options to mitigate the risk.

The document also dwells in detail about the usefulness and limitations of optical Interventions like spectacles, contact Lenses, orthokeratology or multifocal soft contact lenses besides pharmacological Interventions like low dose atropine therapy.

And he has been doing this religiously for the past nine years under the Chandrakanti Devi Cancer Foundation in Bihar, set up in the name of his mother, a cancer survivor

He says matter-of-factly that many are not lucky like his mother to get timely treatment. "Though treatment is free at AIIMS, many of the patients cannot afford the travel costs to Delhi. Some do not have a relative to accompany them. The others are old while many are diagnosed with cancer at an advanced stage. Our foundation tries to reach out to them to ensure that detection and treatment is at the earliest. These patients are suggested alternative treatments in neighbouring hospitals for palliative care."

This foundation runs a cancer clinic where free consultation with treatment planning is done, and if advanced treatment at AIIMS is needed, the patients are provided with all the assistance.

Born to a middle-income family--his father was a Class challenges of healthcare in the remote parts of the country.

"The motivation to help the needy rose from the circumstances around me. I wanted to contribute my bit to the society," he says modestly.

#### **DOCS SAVE LIFE OF WOMAN WITH RARE DISORDER**

A 19-year-old woman from Uttar Pradesh, who suffered from primary pulmonary hypertension — a rare condition found in just one or two persons per 10 lakh people — was successfully treated at the Sir Ganga Ram Hospital (SGRH) here. The woman had a history of shortness of breath, malaise, persistent nausea, and palpitation which her parents correlated with her unwillingness to attend school.

Dr. Atul Kakar, Vice Chairman, Department of Medicine, diagnosed that the woman had symptoms suggestive of pulmonary artery hypertension (PAH). "The patient was started on drugs to decrease PAH which included endothelin receptor antagonist along with phosphodiesterase 5 inhibitor. These drugs are now available for the treatment of this rare disease," said Dr. Kakar who also arranged for the funds from Uttar Pradesh Chief Minister Relief Fund, the hospital said.

#### CRANBERRIES CAN IMPROVE MEMORY: STUDY

Adding cranberries to your diet, particularly in middle age, could help improve memory and brain function, and lower 'bad' cholesterol, according to new research that highlights the neuroprotective potential of cranberries, says a study published in the Frontiers in Nutrition.

#### **BLOOD TEST TO DETECT EARLY-STAGE BOWEL CANCER**

UK researchers have developed a novel blood test that can detect early-stage bowel cancer in 80 per cent cases. Bowel cancer begins in the large bowel. Depending on where the cancer starts, bowel cancer is sometimes called colon or rectal cancer. It takes one of the longest waiting times for diagnosis and treatments. Researchers at Swansea University developed the blood test using Raman spectrometry and a recent trial showed the test picked up about 80 percent of early-stage cancers.

#### APP FOR INFLAMMATORY BOWEL DISEASE PATIENT

ICMR DG, Dr Balram Bhargava, released the 'IBD NutriCare App' for inflammatory bowel disease patients on the occasion of World Inflammatory Bowel Disease Day on May 19. This Android and iOS-based digital health platform in the form of a smartphone application is developed and validated for real-time tracking of dietary details and recording the data on a large scale for patients with IBD, said the ICMR.

## Assistive Technology: Bridge The Gap

People in need of assistive technology (AT) include older people and the disabled besides those affected with communicable and non-communicable diseases, mental health conditions, gradual functional decline or loss of intrinsic capacity and by humanitarian crises. However, a lot remains to be desired, finds out THE HEALTH PIONEER

ay back in 2013, Dr Úma Tuli, a rehabilitation expert and founder of Amar Jyoti School for children with disability had pointed out that mostly people in the sector are forgotten when assistive technology (AT) is talked about. "We need to consider ways to develop assistive technology for making inclusive education a reality. We introduce so many things, but if we do not look at their accessibility, the work remains half done. We have to look at education with a holistic approach to make vocational training a part of the curriculum. We need to have structured sports and cultural activities for the differentlyabled," she had noted.

It's now 2022. Seems not much has changed in the world of the PwDs. A report "The Global Report on Assistive Technology" jointly released by the WHO and UNICEF recently has noted that almost one billion children and adults with disabilities and older persons in need of AT are denied access.

It reveals that more than 2.5 billion people need one or more assistive products, such as wheelchairs, hearing aids, or apps that support communication and cognition. Yet nearly one billion of them are denied access, particularly in low- and middleincome countries, where access can be as low as 3% of the need for these life-changing products.

The report presents evidence for the first time on the global need for and access to assistive products and provides a series of recommendations to expand availability and access, raise awareness of the need, and implement inclusion policies to improve the lives of millions of

## **ANATOLY KARPOV- THE MOST ORIGINAL PLAYER**

In the series 'Champion born this month', I wish to present a story on a champion who can considered to be the most original player of all times, someone who never followed the known paths of the Chess strategy, someone who never worked hard, someone who was criticised of 'having no clue of what Chess is', someone who wouldn't elaborate on his thinking process and yet someone who was the most feared opponent for almost two decades because not many could guess his next move! Yes, I am talking of the one and the only one Anatoly Karpov!

Anatoly Evgenevich Karpov was born on 23rd May, 1951 at Zlatoust, Russia in a normal simple Russian family. He showed exceptional talent in defeating well known Chess players very early in life and improved faster than other players of In fact, as a boy, he was better than his friends in all intellectual activities and even

In 1969, Karpov won the World Junior Chess Crown, thereby becoming a real force to reckon with. The Western Chess world started taking him a bit seriously but still, he was never considered to be a genius because the Chess fraternity did not possess the objectivity to assess the depth of Karpov's play. When Karpov won the World Championship Throne in 1975 due to 'forfeit' by Bobby Fischer, the Western media looked down upon Karpov as if it was his fault. However, despite all this, Karpov reigned supreme for a full decade before losing the World Championship Match to the 'Child of change', Garry Kasparov. (We presented a story on Gary Kasparov in our issue



of 13th April, 2022).

Even today, Karpov is known to be unique and unparalleled in several aspects of Chess. Probably he is the strongest endgame player of all times, with deep sense of endgame planning and strategy, combined with engine-like accuracy. Karpov's ability of improving his position without letting the opponent have a slightest clue of it often angered of his opponents. He possessed the unique quality of easily winning 'drawn' endgames. Karpov is probably the only Chess player who remained the World Championship Challenger for almost a decade after losing the World Chess Crown. In fact, Kasparov and his team took several years to find the right way of fighting Karpov, which involved a multi-fold complex strategy. Karpov's contribution to

closed Ruy Lopez (Spanish) opening and the Boleslavsky Pawn structure in Sicilian defence is unparalleled. One of his moves in the Spanish opening, against Grandmaster Unzicker, is still known as 'Move of the (20th)Century'.

Today I have chosen a little known game of Karpov for two reasons. Firstly, it exhibits his extraordinary positional understanding at tender age of 15 and secondly, it is the first known game of a variation which is now known as 'Karpov Variation'. 1.e4 e5 2.Nf3 Nc6 3.Bb5 a6 4.Ba4 Nf6

First half goals from Amandine Henry, Ada Hegerberg and Catarina Macario were enough to take the title from pre-match holders Barca, who pulled one back through captain Alexia Putellas just before half-time. Expectation was high

among Barca fans, who descended in large numbers on the Allianz Stadium in Turin to watch a team who have been tipped to end Lyon's dominance of the women's game in Europe.

However they couldn't come back from going three goals down in the first 33 minutes

Patricia Guijarro thought she had cut the deficit to just one in the most spectacular way possible when she launched an audacious shot from just after the half-way line which crashed back out from the underside of the bar.

From there Barca were the better team but lacked the killer touch, with Ana-Maria Crnogorcevic volleying a great chance wide with seven minutes remaining highlighting a wastefulness which in the end cost them their European crown.
