Police on Monday arrested nine people, including four from the Oreva Group that was managing the Morbi suspension bridge, and filed a case against firms tasked with maintenance and operation of the British-era structure which collapsed, killing 134

people on Sunday. Those killed in the tragedy also included 12 members of the family of Lok Sabha mem-

ber from Rajkot Mohan Kundariya. Kundariya said the 12 were close relatives of his older brother and hailed from villages in the State's Tankara

Video footage emerged of the moments before Sunday evening's deadly collapse, showing the bridge snapping in a few seconds, taking down scores of visitors seen walking on the swaying structure which reopened five days ago after extensive repair but sans a fitness certificate

"Nine people have been arrested in the Morbi bridge collapse case. They include two managers and two ticket booking clerks of the Oreva Group that was managing the bridge," Rajkot Range Range Inspector-General Ashok Yadav said, informing media of the criminal investigation into the tragedy that has shocked the country. The death toll in the bridge collapse has mounted to 134, he said. A day after

King Kohli slams fan who shot video of his hotel room in Australia **PTI** ■ PERTH

Aflabbergasted former Indian skipper Virat Kohli on Monday denounced the "absolute invasion" of his privacy by a fan, who shot a video of his hotel room and put that in public domain.

In the video, titled 'King Kohli's Hotel Room', a man is seen walking around the room

showing Kohli's personal belongings such as health supplements, collection of shoes, his opened suitcase that contained India jerseys, caps and a pair of glasses on his table. It appears that more than one person, possibly members of hotel staff, were inside the room when the video was shot. Kohli re-shared the video,

that went viral on social media, on his Instagram account along with a message, saying he is not okay with such kind of "fanati-

Hours after India's defeat to South Africa in the Super 12 stage of the ICC World T20 2022, Kohli shared an angry post about the invasion of his



privacy at the Indian team hotel. Taking to Instagram, Kohli revealed that his privacy was invaded at a hotel room in Australia by an unknown

"I understand that fans get the group.

very happy and excited seeing their favourite players and get excited to meet them and I've always appreciated that. But this video here is appalling and it's made me feel very paranoid about my privacy," Kohli wrote.

"If I cannot have privacy in my own hotel room, then

where can I really expect any personal space at all?? I'm NOT okay with this kind of fanaticism and absolute invasion of privacy. Please respect people's privacy and not treat them as a commodity for entertainment," the former Indian skipper added.

Later the hotel said that the oerson had been removed from

9 held in Gujarat bridge collapse...

Sanghavi told reporters the State Government has formed a committee to conduct a probe into the bridge collapse. Police have registered a First Information Report (FIR) on charges of culpable homicide not amounting to murder and attempt to commit culpable homicide against agencies given the task of maintenance and operation of the bridge. In the FIR lodged at the Morbi 'B' division police station on Sunday night, police have shown "agencies responsible for maintenance and management of the hanging bridge" as the main accused.

The FIR, lodged by 'B division Inspector Prakash Dekivadia, stated that the bridge over the Machchhu river was not in use for nearly eight months as the local administration had roped in a "private agency" for its maintenance. After completion of the maintenance, the agency opened the bridge for the public on October 26, the FIR said. As per the FIR, the incident took place because of the "callous approach" of the agency people. The FIR further stated agencies did not pay attention to the quality of maintenance as well as repair work of the bridge. The bridge was opened

These discourses have been attended by scores of his followers, including many BJP leaders from Haryana.

"I am saying it is for the law to see...People on parole have

Panel to facilitate easing hotels, eateries' licensing

¬he Delhi Lieutenant 1 Governor Vinai Kumar Saxena on Monday constituted a high power committee to ease and facilitate the licensing requirements of restaurants, eating houses and hotels. Sources at Raj Niwas said that the Principal Secretary (Home) will head the committee, which has been asked to submit its report within 15 days.

The move came days after the Lieutenant Governor recent decision to allow 314 establishments in the national Capital to operate round-theclock. Their applications were pending since 2016. These establishments included online food and medicines delivery services, logistics, transport and travel services from Knowledge Outsourcing (KPOs) and Business process outsourcing

The other members of the committee included from senior representatives of the department of Information Technology, Delhi Pollution Control Committee (DPCC), and Municipal Corporation of Delhi, Delhi Police, Delhi Fire Services and New Delhi Municipal Council (NDMC). The committee will inter alia focus on reducing the number of licenses, tweaking and deleting archaic regulations rooted in subordinate legislation, minimum documentation, fixed timelines for grant of licenses, complete online processes embedded in a single window portal and promotion of self

As per the statement released by the Raj Niwas, this



move will provide an overall fillip to the Hospitality Sector, and pave the way for late night dining, Alfresco Eateries and dining in open air and terraces.

Giving details about the factors on which the committee will focus, the statement stated that its main focus will be reducing the number of licenses, tweaking and deleting archaic regulations rooted in subordinate legislation, minimum documentation, fixed timelines for grant of licenses, complete online processes embedded in a Single Window portal and promotion of self regulation etc.

"The committee will be able to co-opt members and will take comprehensive input from stakeholder Hotel and Restaurant Associations, etc," it

'Red light on, gaadi off' file again at LG desk AAP Govt submits file for LG's nod with proof of drives taken to check pollution

A mid controversy, the Delhi Government has resubmitted a file regarding the "Red Light On, Gaadi Off" campaign to curb vehicle pollution to Lieutenant Governor Vinai Kumar Saxena for his approval. Delhi Environment Minister Gopal Rai on Monday said the Delhi government has resubmitted the file to Lieutenant Governor with evidence that such drives have reduced vehicular pollution in cities in India, the US and the

Addressing a press conference, Rai said the Lt Governor had put a hold on the campaign and returned the file on October 29 (Friday) questioning the effectiveness of such measures. "We have answered all queries raised by the LG and resubmitted the file for his approval. Delhi is heading towards an emergency situation. We request the LG to give permission (to launch the campaign) as soon as possible," Rai

The minister said a study by the Central Road Research Institute in 2019 showed that keeping the engine on at traffic signals can increase pollution levels by over nine per cent. Another study by the Petroleum Conservation Research Association (PCRA) under the Union Ministry of Petroleum and Natural Gas at the Bhikaji Cama Place traffic intersection showed that over 62 per cent people started switching off their vehicles after a similar campaign.

"We had considered these studies before launching the campaign in 2020," Rai said. HDFC bank ran such drives at



126 traffic intersections in 40 cities across India on June 5, 2022, he said. "We also found that similar campaigns were conducted in London, the UK, and North Carolina, the US," the minister said, adding that the government has sent all evidence to the Lt Governor. Citing data from PCRA, Rai had earlier said if people switch off engines at traffic signals, pollution can be cut down by 15-20 per cent.

According to government estimates, the transport sector accounts for 28 per cent of the PM2.5 emissions in Delhi. Vehicular contribution also makes up 80 per cent of nitrogen oxides and carbon monoxide in Delhi's air.

On Saturday, Saxena had returned the file to Chief Minister Arvind Kejriwal asking him to reconsider the campaign. He questioned the effectiveness of such an "ad-hoc" measure as the national capital reels under high air pollution. Sources at Raj Niwas said that Kejriwal sat on the file for 10 days from 11.10.2022 to 21.10.2022, before sending it to

Niwas has received several calls from CMO and minister to clear the file immediately.

The Raj Niwas sources further pointed out that the proposed date of commencement of the project was October 31, 2022, and not 28th October, 2022, as being wrongly told by environment minister Gopal

Govt to discontinue free yoga classes from today

The Delhi Government on ■ Monday said that free yoga classes provided to Delhiites will be discontinued from November 1 in what could trigger a fresh confrontation between the AAP government and the Lieutenant Governor. Sources in the Arvind Kejriwal government claimed on Monday that Lieutenant Governor Vinai Kumar Saxena has not approved the extension of the scheme after October 31. The board of governors of the Delhi Pharmaceutical Sciences and Research University (DPSRU), which runs the programme, had given its nod to the continuation of the scheme at its meeting held last week.

Sources at the LG's office, however, said they have not received any file on the continuation of the programme beyond October 31. They said even earlier, they had not even earlier, they had not received any file and Sisodia had only written a letter demanding that the programme be continued. "It is wrong to state that the LG has not approved the extension of the program due to which it is being discontinued. How can we consider a letter as a prowe consider a letter as a pro-

posal?" sources asked. "The 'Dilli ki Yogshala' classes have been discontinued from tomorrow i.E. 1.11.22 via a government order. In the BoG meeting of DPSRU decision to continue the classes was

not given permission yet. We will keep you informed upon further information," said a tweet from the official Twitter page of Dilli Ki Yogshala.

The Municipal Corporation of Delhi (MCD) has granted permission to set up a kitchen and dining facility for in lodging and boarding guest houses. It is expected that around 1200 guest houses in the city will be benefitted from

"It was the long pending owners which has been taken into consideration and on the basis of the MCD has given its nod for the same," he said.

According to MCD officials, the customers who will be staying in the guest houses do not have to go anywhere for the food, as they will be able to get good quality cooked food in the guest house itself.

The civic body will check the kitchens set up by these establishments to ensure that the cleanliness and quality of the food are maintained," he

The holders of the establishments do not have to pay any additional charges to the MCD for setting up the cooking facilities in the guest houses as the civic body is allowing them to run it as an additional service with the current license," the official said.

Giving details about the capacity of the kitchens, he said that the capacity of the dining facility will be according to the guest rooms in the establishments. They will not take any contracts for the wedding, birthday parties, etc, they will only be able to cook food for the guest staying on the premis-

For availing the license for ment in the city, "The owners of the guest houses will be able to get the Health trade license on fulfillment of requisite terms and conditions from the Public Health department of the civic body," he said.

"All other permission related to sanction of building plan and fire NOC should also be in order for granting of the health trade license. This facility was available in erstwhile SDMC; now the policy has been made uniform across all the zones of the MCD," the official said.

'The Corporation will provide licenses to guest houses for catering to the needs of inhouse guests. The number of seats in the dining hall should be equal to the number of beds permitted in the guest house and PNG connection will be mandatory for running the kitchen," he said.

MCD gives nod for City air 'very poor', to worsen as temp dips

 $T^{\text{he air quality index (AQI)}}_{\text{ of the national Capital on }} \\ \text{Monday stood at 392 in the}$

very poor' category.

"The AQI is expected to worsen in the coming days as the meteorological conditions are not favourable due to the low pressure winds and minimum temperature dipping in the city," said the weatherman. Low wind speed allowed

the air and the situation might deteriorate to "severe" Tuesday morning, said Mahesh Palawat, vice president (meteorology and climate change), Skymet Weather.

He said humidity may increase and the wind speed may reduce further from November 4 under the influence of a strong Western Disturbance leading to another episode of smog.

According to SAFAR, a forecasting agency under the Union Ministry of Earth Sciences, the share of farm fires in Delhi PM2.5 pollution stood at 22 per cent on Monday. It was 26 per cent on Sunday, the highest this year so far, and 21 per cent on Saturday.

Palwat said the transportlevel wind direction and speed is favourable for transport of smoke from stubble burning.



According to an analysis by the Delhi Pollution Control Committee (DPCC), people in the capital breathe the worst air between November 1 and November 15 -- the period when stubble burning peaks.

The city records an average PM2.5 concentration of 285 micrograms per cubic metre from November 1 to November 15. PM 2.5 level from 61 to 120 is considered "moderate to poor", 121 to 250 is "very poor", 251 to 350 is "severe" and more than 350 is "severe plus", as per analysis.

The Indian Agricultural Research Institute (IARI) reported 2,131 farm fires in Punjab on Monday - the highest so far this season, 1,761 on Sunday, 1,898 on Saturday, 2,067 on Friday and 1,111 on Thursday. It logged 70 and 20 cases of stubble burning in Haryana and Uttar Pradesh, respectively, on Monday.

However, the adjoining states of the Capital, also recorded the AQI under the very poor category, with Noida (374), Ghaziabad (353), Faridabad (363), and Greater Noida (352), according to the Central Pollution Control Board (CPCB) bulletin at 4 pm.

Out of the 35 stations of the Capital, 19 stations recorded the AQI in the 'Severe' category including Alipur, Anand Vihar, Ashok Vihar and Bawana while 16 stations recorded the AOI in the 'Very poor' category are Aya Nagar, CRRI Mathura Road, Dr. Karni Singh Shooting Range and IGI

Over 40% domestic consumers didn't opt for power subsidy till Oct: Govt

More than 40 per cent of the 56.98 lakh domestic consumers did not opt for power subsidy provided by the Delhi government till the last date of application on October 31. While more than 34 lakh domestic consumers applied for power subsidy, those who could not opt for it will have another chance to do so in the billing cycle of next month,

A total of 22,81,900 (40 per cent) domestic consumers were yet to apply for the subsidy. The Delhi government has made changes in its free electricity scheme deciding to provide subsidy to only those domestic consumers who apply for it. Till Monday afternoon,

34.16 lakh applicants opted

for the subsidy and the num-

ber may slightly increase by the

end of the day, officials said. "It means that many consumers have willingly given up subsidy. Chances are also that some consumers could not apply for the subsidy due to various reasons," a Delhi government offi-The data will be studied

and reasons for more than 22 lakh people not applying for subsidy will be found out to see if genuine consumers failed to get covered by the subsidy scheme, said the officer. The subsidy applicants included 15,54,646 consumers of BRPL discom, 8,49,756 BYPL consumers, over 10 lakh TPDDL consumers and 10,920 NDMC consumers, officials said.

Chief Minister Arvind Kejriwal had launched the process for subsidy application on September 14, issuing a mobile number for power consumers to fill up forms. He had

Teams of Indian Navy, Coast Guard also deployed

More than 300 Army personnel are involved in the search and rescue operation at the accident site in Morbi, Gujarat, where a cable suspension bridge collapsed on Sunday. Teams of the Indian Navy and Coast Guard are also deployed there. Giving details of the army effort, sources said here on Monday that multiple Army Columns (total nine columns) including Engineer Task Force and Medical detachments mobilised from Dhrangdhara, Jamnagar and Bhuj. They started moving at 2040 hours on Sunday and the first column reached the incident site at 2130 hours. One column has about 100 soldiers. The teams are equipped with Engineer Stores and are assisting NDRF, SDRF, Indian Navy, Coast Guard in rescue efforts in addition to helping civil administration and police in crowd management and security, sources said.

Immediately after arrival, Army columns first started crowd control and dispersal including route clearance from the accident site to the civil hospital. The columns immediately got into the National Disaster Response Force(NDRF), State Disaster Response Force(SDRF) and state fire services boats and assisted in search operations.

Four medical columns assisted in treatment of survivors in three hospitals including the civil hospital, Krishna hospital and Ayush hospital, they said. The Indian Army is fully committed in assisting the civil administration and all other agencies for humanitarian operations to prevent loss of lives, treatment of survivors and further retrieval of the remaining bodies as part of search operations, they said.

Referring to this, TMC Rajya Sabha MP Sukhendu Shekhar Roy said, "PM Modi taunted Mamata Banerjee over Kolkata flyover collapse. Let there be a few drops of tears, Modi ji over the death of 132 persons in newly renovated bridge collapse in Gujarat yesterday.'

About 135 people died and more than 50 on Sunday went missing when the cable bridge over Macchhu River in Morvi district of Gujarat collapsed apparently on account of overweight. The bridge had allegedly been thrown open to the public without any fitness certificate four days after its repair was completed by a maintenance company. Senior TMC leader and

party spokesperson Kunal Ghosh slammed the BJP government saying "whenever something happens in Bengal fact finding teams are sent here now we ask whether fact

Ghosh said both Prime Minister Modi and Home Minister Amit Shah "who jointly supervise the Gujarat model of the so-called double engine government will have to take responsibility of the death of so many people ... they cannot wash of their hands by announcing a few lakh of rupees to the next of kin of the deceased." He said, "Why fact finding teams and central agencies like ED and CBI will not be sent to Morvi to find out the real fact of the matter," asking is ED and CBI reserved for the opposition-ruled states only or whether the death of 135 people is not enough to merit serious probe.'

Another TMC leader and MLA said "it is a shame for the BIP which calls itself a party with a difference that they handout only a meagure Rs 2-Rs 4 lakh to the relatives of the dead persons while shelling hundreds of crores in buying MPs and MLAs to topple opposition governments. Congress Lok Sabha leader

Adhir Chowdhury too taunted the Prime Minister wondering whether the Morvi represented the best model of a double engine government. "I want to ask Modi ji whether it is the famed Gujarat model of development that comes via a double engine government that was responsible for the mishap or it was lack of efficiency on the part of the BJP-run administration that brought about such a big disaster ... ¬he Congress has a "solid The Congress has a bone base" in Gujarat and will win the upcoming Assembly polls, former party chief Rahul Gandhi said on Monday, contending that there is "massive" anti-incumbency against the BJP while the AAP is "only in the air" with no support on the ground.

Addressing a press conference here during his Bharat Jodo Yatra, Gandhi said the march is "not a magic wand" but a good first step to connect with the people. He also ruled out any alliance with the TRS, saying it is "diametrically opposite" to what the Congress stands for.

Dismissing the challenge posed by Aam Aadmi Party in Gujarat, Gandhi said the Congress has a solid base in the

"Congress is fighting the Gujarat elections effectively and the Congress will win the polls. AAP is only in the air. It has nothing on the ground," he told reporters here to questions on his party's prospects in Prime Minister Narendra Modi's home state.

"There is massive antiincumbency. The media has



created a buzz based on the advertisements given by AAP. The Congress party is a solid party in Gujarat. The Congress is going to win the election there," he said.

On when and where he will campaign in the poll-bound states of Himachal Pradesh and Gujarat, Gandhi said, "Kharge Ji is the president of the party and he will decide how I am to be utilised." In the 2017 Gujarat assem-

bly polls, the Congress had put up a spirited fight and bagged seats to the BJP's 99. However, there have been several defections from the Congress post-2017 and their current tally in the assembly stands at 62, while the BJP's tally has risen to 111.

Many political observers feel that the Congress is on a weak footing this time and with

the Aam Aadmi Party being a contender this time, it would be a triangular contest that could dent the Congress' chances.

On a question about the tragedy in Morbi where a bridge collapsed leaving more than 130 dead, Gandhi said he did not wish to politicise the incident.

"I don't want to politicise this incident. People have died here. It is disrespectful for them to politicise this incident, so I am not going to do it,' Gandhi said. A two-minute silence was held in memory of those killed in the tragic acci-

Asked about his remarks at the Udaipur Chintan Shivir that the Congress' connection with the people has been broken and how far he has been able to reestablish it with the Yatra, Gandhi insisted that he had stated that the connection of the Congress Party with the

people has "weakened".

"The connect of the Congress party with the people has not broken in any way, but it has weakened. This is a good first step in connecting with the people, it is not a magic wand...The Congress party is an idea. It stands for a certain vision of India... But I think,

to be done," Gandhi added.

On a question about the OBC census, Gandhi said as far as the OBC census is concerned, it is the Congress that came up with the idea and did the census.

"I am very clear, I have absolutely no question in my mind, the OBC census needs to be made public. People need to understand the makeup of India's population," he assert-

The former Congress chief said the fight in India today is between two ideologies -- one that is seeking to divide the nation and the other that wants to bring the nation together.

"The line is very clear. I feel, and the Congress party feels, that it is very important that the Opposition works together harmoniously to defeat the ideology of the RSS and the BJP," Gandhi said.

On the Telangana Rashtra Samithi (TRS), he said there is absolutely no possibility of any relationship between the TRS and the Congress.

"The corruption, the approach, the attitude of the TRS is not acceptable to us. We are diametrically opposed to what they are doing," he said.

The survivor had accompanied the SIT team. The room where she was taken by the homestay's owner was examined by the investigators.

Apart from Narain, Labour Commissioner R L Rishi, a police inspector and the homestay's owner have been named in the police case lodged in connection with the gang rape.

The team was seen coming out of the homestay with envelopes but refused to divulge any information Narain is unlikely to leave

Questions galore

How could the local authorities be ignorant that the Morbi bridge had no fitness certificate?

he death of at least 141 people in Gujarat's Morbi is yet another case that highlights the low priority given to public safety by administration. For seven months, the cable bridge over Machchhu river underwent repair work. On October 26, the Gujarati New Year, it was reopened for the public, even though it didn't have a fitness certificate from the local authorities. Sandeep Singh, head of Morbi's civic body, told the media that the company responsible for repairs, Oreva, had to inform the civic authorities that the bridge's renovation was complete. This is followed with an inspection. According to him, the reopening happened "of a sudden," resulting in the mishap. But this raises several questions: How could a bridge be opened without the administration knowing about it? And, even if it opened without the local authorities' consent, how could they remain unaware of this fact for three-four days? Then there is



the issue of overcrowding; there is also a report that some "mischievous kids" were shaking the ropes of the bridge which by the way happens to be a major tourist spot in the area. In fact, people have to pay to use the bridge. Oreva managing director Jaysukhbhai Patel told the media that the company didn't want "to overwhelm the sturdiness of the bridge." So, he added, it was decided to limit the crowd and charge for an entry. Apparently, his company failed miserably in this role.

In fact, the choice of Oreva for repairing the bridge was also surprising. The Oreva Group specialises in the manufacture of home and electrical appliances, wall clocks, calculators, ceramic products, e-bikes,

etc. It owns the famous Ajanta and Orpat brands. Infrastructure and construction works, however, were never its forte. So, how could it get the contract to repair the bridge and also collect the ticket money for its usage? It has been reported that the bridge was supposed to open in 8-12 months, so what was the haste to open it in seven months? And that too without a fitness certificate? Was it greed that drove the company to prepone the opening? These and other questions can be answered only after a proper inquiry into the accident. Gujarat Home Minister Harsh Sanghavi has announced that a criminal case has been registered and a five-member high-powered committee constituted to look into the matter. The case has been registered under charges of culpable homicide not amounting to murder; nine accused persons are being interrogated. The police have already arrested nine persons, including two Oreva managers. While senior Congress leader Rahul Gandhi has said that he doesn't want to "politicise this incident," his party colleagues are less forgiving. Congress MP Randeep Singh Surjewala tweeted: "This is not a natural accident, it is a man-made tragedy. The BJP government of Gujarat is directly guilty of this heinous crime." Only time will tell if the tragedy would have an impact on the forthcoming Assembly poll.

Gagging social media

With the new rules in place, the social media may have to comply with the govt dictates

he censorship on social media is on its way, though not called so and sugarcoated to sound like a redressal system. The new rules the government has put in place would reign in social media like never before. The government has notified rules under which it will set up appellate panels to redress grievances that users may have against content posted on social media. Though it sounds rather benign, in effect it takes away the independence and neutrality of social media platforms in a big way. Social media content posted is already monitored but there is no mechanism to leash them. Not anymore. Now the onus would be on social media platform to correct any incriminating content posted by anyone on its platform, or else there would be consequences. To put the mechanism of redressal in place the Centre would form panels in three months to hear appeals on social media posts. MoS Rajeev Chandreshakhan has his reasons

for doing so he said that the move was necessitated as lakhs of grievances were not responded to by social media firms despite complaints, which is not acceptable. These Platforms will have obligation to remove within 72 hours of flagging, any "misinformation" or illegal content or content that promotes enmity between different groups on the grounds of religion or caste with the intent to incite violence.

Perhaps the government's motive is not to safeguard the individuals but to save its own skin. Lately, many social media channels on YouTube etc have mushroomed which are rather critical of the government and cause it an embarrassment. Things were different earlier as the electronic media danced to its

tunes and the government did not care much about social media. The cheap internet and ubiquitous smartphones have been game changers. The cumulative reach of social media now far exceeds the reach of TV channels whose credibility and reach is fast declining. Besides, the BJP had first mover advantage in social media but now other political parties are also catching up. The appellate system could change all that. It is easy now, a drop of a complaint letter from a proxy or dummy individual could set the ball rolling and the social media platform would have to oblige without much deliberations. It is backdoor censorship which could become more stringent with time. Social media has done some very good work in exposing lies and misadventures of the governments but that could be a thing of the past.

Sunak must deliver to remain saddled

ishi Sunak, as Prime Minister of Great Britain, is a child of desperation; he is not the choice of all British people. Most leaders in his shoes would instinctively prioritize protecting what his predecessor Boris Johnson described as "the best job in the world". This is a mistake young Rishi should not make. More so, because he has been selected, not elected, to deal with Britain's greatest crises after World War II. Moreover, Sunak is brown, young as well as relatively inexperienced; only seven years have passed since his first election as an MP and his selection as PM. He is a Hindu and not a Christian, or a Muslim.

Incidentally, Rishi Sunak is not the youngest Prime Minister in British history. William Pitt the younger in the 18th century was only 24 years old when he was elected to the top job. He brought prosperity to Britain as never before and ruled continuously for 22 years. He died, as it were, on his chair at the age of 46. Uncannily, Pitt had planned to generate such a budget after budget that before the end of his rule, the treasury would be so rich that thereafter, the country could live off the interest earnings so that the people would have to pay no tax. Unfortunately for him and his people; Napoleon Bonaparte, in his expansionist urge to be the master of all of Europe, had declared war and Pitt had to finance it.

Prime Minister Rishi Sunak might find this interesting. Under all these circumstances, he has few alternatives other than finding a magical or miraculous formula to prevent Britain from falling into a financial ditch. However risky the formula, he would have to carry the risk. He happens to have told the Conservative Members of Parliament that they have no other choice but "unite or die". We now ought to tell him that he must "succeed or perish" in public life.

Thereafter, attention can be devoted to bilateral trade agreements. To start with, an Indo-UK accord would be desirable. The economies of the two countries are comparable in size; plus, the officials and businesspersons of the two countries should be familiar with each other's ways of working. For example, we are familiar with the Rolls Royce automobile and engine, and the post-War British combat aircraft, which were the initial mainstay of our air force. In any case, this particular opposition party carries the image of being pro-Pakistan. It should also be realized that in the event of failure, Britain's only refuge would be to merge with the USA; say, as four states, England, Scotland, Wales, and North Ireland. These four states should be rewarded with eight Senate seats. If Hawai in the Pacific Ocean can be a part of the USA, why cannot there be states of that country in the Atlantic Ocean? 

In the last eight years, Haryana has witnessed an ecosystem firming up which encourages institutional autonomy, best and honest practices in research. Shri Vishwakarma Skill University (SVSU) has been granted powers to affiliate private institutions for skill certification. Pursuant to the NEP-2020, the government has decided that all government colleges and universities should be accredited by 2023. In order to promote 21st century skills, STEM Labs, on the lines of Atal Tinkering Labs, will ensure exposure and training to students in 3D Printing, drone technologies, AI, Augmented Reality, Virtual Reality, Block Chain management and so on.

Though smaller in size, today Haryana has 70 government hospitals, giving a boost to the state's healthcare at primary and secondary level. The state has 121 Community Health Centres and 640 Primary Health Centres as compared to 470 in 2014. It has a huge network of 2,674 Sub Health Centres (SHCs). As on April 16, 2022, a total of 1150 Ayushman Bharat-Health and Wellness Centres are operational in the state, out of which 364 are in Rural PHCs, 684 in Sub-Centres and 102 in Urban PHCs. The number of medical colleges has gone up to 12 from eight in the last eight years ical colleges rose from 850 in 2014

The hike in old age pension from Rs 1,000 to Rs 2,500 is a reflection on the government's commitment to take care of elderly people. Currently, about 18 lakh senior citizens are getting old age pension in the state. The benefits under Ayushman Bharat -Pradhan Mantri Jan Arogya Yojana have been extended to 17 lakh more families by changing the income slab of BPL from Rs 1.20 lakh per annum to Rs 1.80 lakh per annum.

One needs to understand the importance of Antyodaya, as envisioned by great thought leader Pandit Deen Dayal Upadhyay, in governance. The empowerment of the poorest among the poor should be at the core of governance. It is praiseworthy indeed that in the first phase of 'Mukhyamantri Antyodaya Parivar Utthan Abhiyan, there is a target to identify around two lakh such poor families whose annual income is less than Rs 1 lakh, and enhance their annual income to

oor families nave been provided with loan sanction letters for their self-employment in three phases of Antyodaya Gram Utthan Melas. A massive boost has been given to farmers' ease of life through 'Meri Fasal, Mera Byora' web portal, where about 9 lakh farmers registered themselves in Rabi and Kharif seasons.

A critical challenge for governance lies in enabling people to reap benefits of schemes and services in a hassle-free manner. As

many as 547 services and schemes of 42 departments have been made online on Antyodaya Saral Portal. As many as 150 schemes have been uploaded on DBT portal, of which 94 are state schemes and 56 centrally sponsored schemes. A total of 29.63 crore transactions have taken place since 2017, in which Rs 52,374 crore have been deposited in the accounts of the beneficiaries.

Through DBT, 36.75 lakh ineligible beneficiaries were also identified in the last eight years, resulting in a saving of about Rs 6,700 crore. During 2019-20, Haryana was ranked first in the country for the successful implementation of the DBT Mission.

Three big dams are being built from where Haryana will get 47 per cent of their waters. Nearly 14,000 ponds are being repaired. Check dams are also being built on the hills. Under the Jal Jeevan Mission, fresh tap water is being supplied to every household in all villages by giving about 18 lakh water connections. Only recently, the Union Home Minister, Mr. Amit Shah, inaugurated and laid Similarly, more than 33,000 the foundation stone of four proects costing about Ks 6,629 crore These include laying the foundation stone of Haryana Orbital Rail Corridor costing Rs 5,618 crore, inauguration of Rail Coach Refurbishment Factory in Sonipat district costing Rs 590 crore, and India's first longest elevated railway track built in Rohtak at Rs 315.40 crore. Collective efforts of all stakeholders must continue for accelerated and balanced development, bringing more prosperity to the people of the state.

Russian strikes hit Ukraine, most of Kyiv without water

massive barrage of Russian strikes on Monday morning hit critical infrastructure in Kyiv, Kharkiv and other cities, knocking out water and power supplies in apparent retaliation for what Moscow alleged was a Ukrainian attack on its Black Sea Fleet over the weekend.

The mayor of Ukraine's capital said that 80 per cent of consumers in Kyiv were left without water supplies "due to the damage to a power facility near" the city from Russian military strikes on Monday.

Local authorities were working on restoring the supplies as soon as possible, Mayor Vitali Klitschko said, telling Kyiv residents in the meantime to "stock up on water from the nearest pump rooms and points

In a separate Telegram post, Klitschko added that water supplies in some areas of Kyiv will be restored in "three to four hours," and power had already been restored in one of the city's

Loud explosions were heard across the Ukrainian capital in the early morning as residents prepared to go to work. Many

emergency services about the threat of a missile attack, and air raid sirens wailed for three straight hours.

The attacks occurred just before Czech Prime Minister Petr Fiala and many top members of his government, including the foreign, defence and interior ministers, arrived in Kyiv in the latest show of support from European leaders for Ukraine.

Ukrainian Foreign Minister Dmytro Kuleba said there was no justification for Russia launching missiles meant to inflict so much suffering on civilians.

"Don't justify these attacks calling them a 'response'. Russia does this because it still has the missiles and the will to kill Ukrainians," he tweeted.

There was a heavy military presence north of Kyiv. Smoke was rising from the left bank of the Dnieper River, either from a missile strike or where it was shot down by Ukrainian forces.

A resident of the area said he heard four loud explosions that rocked the area. "At first I thought I heard a

jet going by, but then I realised it was a missile," said Serhii, who refused to give his full name.

"The explosions were so loud! I consider myself experienced and prepared for attacks like this. But it was way too close and loud. I was frightened, really

frightened." In the outlying region,

authorities warned people to be prepared for a long power outage because of the emergency

Kyiv region Gov. Oleksii Kuleba also said that one person was wounded and a number of

houses were damaged as a result of the morning attack.

In the eastern city of Kharkiv, two strikes hit critical infrastructure facilities, according to authorities, and the subway ceased operating. Officials

also warned about possible power outages in the city of Zaporizhzhia resulting from the strikes there.

The Lviv region in western Ukraine was also targeted, but the missiles were shot down,

Critical infrastructure objects were also hit in the Cherkasy region southeast of Kyiv, and explosions were reported in other regions of Ukraine. In the Kirovohrad region of central Ukraine, the energy facility was hit, according to local authorities. In Vinnytsia, a missile that was shot down landed on civilian buildings, resulting in damage but no casualties, according to region-

al Gov. Serhii Borzov. Some parts of Ukrainian railways were also cut off from power, the Ukrainian Railways reported.

This time, however, the Ukrainian forces say they were able to intercept most of the missiles launched by Russia.



decision Monday, saying that authorities in Kabul have not established that "Afghanistan has investigated, or was investigating, in a manner that covers the full scope of the Prosecutor's intended investigations and that would justify even a partial deferral of the court's investiga-

The decision comes just over a year after Prosecutor Karim Khan announced that he wanted to resume an ICC probe in Afghanistan because under the country's new Taliban rulers there was "no longer the prospect of genuine and effective domestic investigations" in the Judges at the global court

authorised an investigation by Khan's predecessor, Fatou Bensouda, in 2020 covering offenses allegedly committed by Afghan government forces, the Taliban, American troops and U.S. Foreign intelligence operatives dating back to 2002. The United States are not a member of the court and do not

recognize its jurisdiction.

The decision to investigate Americans led to the Trump administration slapping sanctions on Bensouda, who has since left office. However, the probe was shelved after Afghan authorities asked to take over the case - known at the court as requesting deferral. The ICC is a court of last

Trump's firm faces criminal tax fraud trial over perks

 $F^{or\;years,\;as\;Donald\;Trump}_{was\;\;soaring\;\;from\;\;reality}$ TV star to the White House, his real estate empire was bankrolling big perks for some of his most trusted senior executives, including apartments and luxury cars.

Now Trump's company, the Trump Organisation, is on trial this week for criminal tax fraud — on the hook for what prosecutors say was a 15-year scheme by top officials to hide the plums and avoid paying

Opening statements and the first witnesses are expected Monday in New York. Last week, 12 jurors and six alternates were picked for the case, the only criminal trial to arise from the Manhattan district attorney's three-year investi-gation of the former presi-

Among the key prosecution witnesses: Trump's longtime finance chief Allen Weisselberg, who pleaded guilty and has agreed to testify against the company in exchange for a five-month jail sentence.

If convicted, the Trump Organisation could be fined more than \$1 million and could face difficulty in securing new loans and deals. Some partners and government entities could seek to cut ties with the company. It could also hamper its ability to do business with the US Secret Service, which sometimes pays the company for lodging and services while protecting Trump as a former

Neither Trump nor any of his children who have worked as Trump Organization executives are charged or accused of wrongdoing. Trump is not expected to testify or even attend the trial.

India e-logistics industry set to touch \$9 billion



IANS NEW DELHI

ndia's e-logistics sector has become one of the largest and fastest growing logistics markets globally and is all set to reach the \$9 billion industry, with a compound annual growth rate of 35 per cent, a report showed on Monday.

The number of e-commerce logistics shipments is expected to grow by four times in the next five years.

"Thanks to new-age tech enabled players who have entered India's logistics arena, it is now easier for small- and medium-sized businesses to transport goods, and there is a drastic increase in the speed and efficiency in which parcels

are delivered," says the report by Bengaluru-based Redseer Strategy Consultants.

Among such players, Delhivery is well positioned at the cross-section of the various logistics sector growth drivers including infrastructure, offline commerce, digital consumption, and adoption of technology and data sciences.

The ecommerce logistics sphere has contributed to the overall growth of India's logistics sector and enabled the eretail boom in India.

Proliferation of smartphones and localisation of the internet in non-English languages is drawing in new consumers from non-metro locations into the internet economy and creating new demand

for online commerce, thus

paving the need for disruption

According to the report, the availability of multiple payment options such as UPI, nocost EMI, BNPL (buy now, pay later) etc. are further driving the adoption of digital commerce by more consumers, thereby creating a need for ecommerce logistics.

"Multiple segments in the India logistics market are addressable by full-stack-techenabled logistics service providers. There seems to be great headroom for growth as tech-enabled logistics players venture into adjacent segments such as hyperlocal delivery, express delivery, trucking, and more," the report mentioned.

pilot of Digital Rupee today

India's first Digital Rupee pilot project will commence on Tuesday with nine banks, including SBI, HDFC Bank and ICICI Bank, issuing the virtual currency for transactions in Corrence part as well in the state of t tions in Government securities.

"...The first pilot in the Digital Rupee - Wholesale segment shall commence on November 1, 2022," the RBI said in a statement on 'Operationalisation of Central Bank Digital Currency Wholesale (e?-W) Pilot'.

It also announced that the first pilot in Digital Rupee Retail segment is planned for launch within a month in select locations in closed user groups comprising customers and merchants. The use case for the pilot is settlement of secondary market transactions in government securities, the RBI said regarding the maiden project starting Tuesday. "Use of e?-W is expected to make the inter-bank market more efficient," it added.

Settlement in central bank money would reduce transaction costs by pre-empting the need for settlement guarantee infrastructure or for collateral to mitigate settlement risk.

Nine banks -- State Bank of India (SBI), Bank of Baroda, Union Bank of India, HDFC



Bank, ICICI Bank, Kotak Mahindra Bank, Yes Bank, IDFC First Bank and HSBC have been identified for participation in the pilot project.

Going forward, other wholesale transactions and cross-border payments will be the focus of future pilots, based on the learnings from this pilot, the cental bank said.

In a recent concept note on Central Bank Digital Currency, the RBI said CBDC is aimed to complement, rather than replace, current forms of money and is envisaged to provide an additional payment avenue to users, not to replace the existing payment systems.

CBDC is a digital form of currency notes issued by a central bank. While most central banks across the globe are exploring the issuance of CBDC, the key motivations for its issuance are specific to each country's unique requirements.

RBI to launch first | Sebi bans Mehul Choksi from capital market for 10 yrs, slaps ₹5 crore fine


Sebi on Monday barred fugi-tive businessman Mehul Choksi from the securities markets for 10 years and imposed a fine of Rs 5 crore on him for indulging in fraudulent trading in the shares of Gitanjali Gems Ltd.

He has been directed to pay the penalty within 45 days, as per the Securities and Exchange Board of India (Sebi)

Choksi, who was the chairman and managing director as well as part of promoter group of Gitanjali Gems, is the maternal uncle of Nirav Modi. Both of whom are facing charges of defrauding stateowned Punjab National Bank (PNB) of more than Rs 14,000

Both Choksi and Modi fled India after the PNB scam came to light in early 2018. While Choksi is said to be in Antigua and Barbuda, Modi is lodged in a British jail and has challenged India's extradition request.

The present proceedings emanate from a common show cause notice issued by Sebi in May 2022 against Choksi pursuant to an investigation by the regulator into the alleged manipulative trading in the scrip of Gitanjali Gems. The regulator conducted an investigation into the trading activities of certain entities in the



scrip of the company for the period July 2011 to January

In its order, Sebi said that Choksi had funded a set of 15 entities known as 'front entities', who were directly or indirectly connected with him and with each other and who had taken position in the scrip of Gitanjali Gems both in the cash and derivative segments during the investigation period. He had used them as front entities for manipulation in the company's scrip.

It was observed that the

fund transfers by the company to front entities were to the extent of Rs 77.44 crore, out of which funds to the tune of Rs 13.34 crore were used by front entities to trade in the scrip.

The regulator noted that immediately prior to the investigation period, the shares of Gitanjali Gems, excluding promoter holding and holdings of banks/ financial institueral investors was 28.96 per cent for the quarter ended June 2011. This was reduced to 19.71 per cent in the quarter ended September 2011. Subsequently, the shares available to general investors increased to 25.36 per cent post the investigation period.

This indicates that Choksi, through front entities, tried to corner the shares available in the market during the investigation period to reduce the shares available for general investors which subsequently increased after the front entities sold the shares in the market. Further, the front entities cornered the position limits in the scrip of Gitanjali Gems by building up substantially large position in the derivatives seg-

"I find that the above mentioned findings coupled with the noticee's (Mehul C Choksi) failure to rebut the said findings, clearly establishes the noticee's role in creation of false and misleading appearance of trading in the scrip of GGL by using and funding the front entities in executing manipulated trades.

"I thus find that the noticee has violated the provisions of... PFUTP (Prohibition of Fraudulent and Unfair Trade (PFUTP) Practices Regulations," Sebi Whole Time Member Ashwani Bhatia said in his 20-page order.

apital markets regulator Capital Illarices regularion Sebi on Monday came out with fresh guidelines in order to standardise the usage of rating scales used by Credit Rating Agencies (CRAs).

Issuer rating or corporate credit rating indicates the degree of safety of the issuer or the rated entity with regard to timely servicing of all its debt obligations.

Pursuant to the consultation with the CRAs, standardised symbols and their definitions have been devised for issuer rating or corporate credit rating, the Securities and Exchange Board of India (Sebi) said in a circular, adding that the new guidelines will come into force from January 1, for rating watch and rating out-
