## Morbi bridge fall needs | AAP Min extorted ₹10 cr thorough probe: Modi

PM meets victims. calls for learning from probe must be implemented at the earliest

Prime Minister Narendra Modi on Tuesday called for a "detailed and extensive" enquiry into the Morbi bridge collapse tragedy and said its key learnings must be implement ed at the earliest. As many as 135 bodies have been recovered from the Machchhu river in Gujarat's Morbi town by the armed forces, National Disaster Response Force and other rescue agencies after the Britishera suspension bridge collapsed on Sunday, officials said.

Modi visited the collapse site and the local hospital where the injured have been admitted. He also chaired a high-level meeting at Morbi to review the situation, the PM's Office said in a release.

'The need of the hour is to conduct a detailed and extensive enquiry which will identify all aspects relating to this mishap," Modi said. Key learnings from the enquiry must be implemented at the earliest and authorities must stay in touch with the affected families and ensure that they receive all possible help in this tragic hour, he said.

The meeting was attended by Chief Minister Bhupendra Patel, Gujarat Minister of State for Home Harsh Sanghavi, local MLA and minister Brijesh

Merja, State Chief Secretary Pankaj Kumar and State Director General of Police Ashish Bhatia, among others.

Modi also interacted with those involved in rescue and relief work and lauded their efforts. State Minister Rajendra Trivedi said as many as 170 persons were rescued after the

collapse.

"The kin of all the deceased have already been paid a compensation of ₹4 lakh each as announced by the Gujarat Government. A compensation of ₹2 lakh announced by Prime Minister Narendra Modi will be deposited soon into their bank accounts through DBT (direct bank transfer)," the Minister told reporters in Gandhinagar.

#### SC to hear plea for judicial probe into cave-in on Nov 14

The Supreme Court on Tuesday said it would list for hearing on November 14 a PIL seeking constitution of a judicial commission to probe the Morbi bridge collapse incident in Guiarat.

"You are very quick. What are your prayers," a bench comprising Chief Justice UU Lalit and Justice Bela M Trivedi said when lawyer Vishal Tiwari mentioned his PIL on the issue

for urgent hearing. "I am seeking a judicial enquiry by a panel headed by a former Supreme Court judge," the lawyer said. Tiwari, in the PIL, said the

accident leading to the collapse of the bridge resulting in more than 134 casualties, showed the negligence and utter failure of government authorities.

From the past decade, various incidents have taken place in our country wherein due to the mismanagement, lapse in duty, negligent maintenance activities, there have been cases of huge public casualties which could have been avoided, the

**BJP calls AAP 'maha** thug' for charges against Jain: AAP says BJP diverting attention from Morbi

Tailed conman Sukesh Chandrashekhar has caused the latest round of face-off between the BJP and the AAP. Chandrashekhar has written to the Delhi Lt Governor alleging that AAP leader Satyendar Jain "extorted" ₹10 crore from him in 2019 to ensure his safety in prison. The BJP lost no time to attack AAP calling it a "maha thug" party which even "extortage" ed an extortionist".

Delhi Chief Minister Arvind Kejriwal rubbished the allegation saying it was an attempt to divert attention from the Morbi bridge collapse incident in Gujarat. Chandrashekhar, who is

lodged in Mandoli jail in connection with the ₹200-crore money laundering case, submitted a letter to LG Saxena on October 8 through his advocate Ashok K Singh, making the startling allegations against the

In Chandrashekhar has alleged that he has been receiving threats and was under pressure from Minister Jain and Sandeep Goel, the Director General of Prison, Delhi. Chandrashekhar said that he had known the AAP leader since 2015.

The letter alleged that more than ₹50 crore was given to the AAP on a promise of giving Chandrashekhar an important



post in the party in South zone, and also help him in getting nominated to the Rajya

According to the LG office sources, the letter from Chandrashekhar was forwarded to the Chief Secretary of the Delhi Government for necessary action on October 18.

Chandrashekhar also alleged that he was visited by Jain in Tihar jail, where he was lodged after his arrest in 2017 in the "two leaf symbol corruption case". Jain, who held the portfolio of the Jail Ministry, asked him if he had disclosed anything to the probe agency related to his contribution to

the AAP, he alleged.
The Tihar Jail is run by the Department of Delhi Prisons, Government of Delhi.

"Thereafter in 2019 again I was visited by Jain and his secretary and his close friend Sushil in jail, asking me to pay

protection money to live safely in jail, and to get even basic facilities," he alleged.

"Jain asked me to pay ₹1.50 crore to DG prison Sandeep Goel, who, he said, was a loyal associate of his. He forced me to pay and an amount of ₹10 crore was extorted from me through constant pressure in a matter of two-three months, he alleged in the letter. He also alleged that the amounts were collected in Kolkata through Jain's associates.

"Hence a total amount of ₹10 crore was paid to Jain, and ₹12.50 crore to DG prison Sandeep Goel," Sukesh alleged and added that he has already given this information to the Enforcement Directorate.

Kejriwal said the BJP is planting a fabricated story to divert attention from the Morbi bridge collapse in Gujarat. "Morbi tragedy occurred the

day before yesterday. All TV channels raised this issue yes terday but it disappeared today and Sukesh Chandrashekhar's allegations appeared. Doesn't this look like a completely fic-titious story planted to divert attention from Morbi?" Kejriwal said at a press conference. "What can be more blatant than this? Nearly 150 people have died but all channels are discussing a conman," he

Minutes later, BJP pokesperson Sambit Patra held a press conference saying the AAP did a thuggery with a

thug and termed the AAP a "maha thug" party.

"It is learned from news that there has been a thuggery in the house of a thug. And the name of the thug is Sukesh Chandrashekhar. And the person who cheated the thug is Aam Aadmi Party leader Satyendar Jain," Patra said.

The accused even ransacked the house and took the couple's belongings, including the CCTV camera's DVR to mislead police, planting it as a robbery bid. The entire conspiracy was unearthed after police nabbed two accused

within six hours of the incident. The victims have been identified as Sameer Ahuja (38), his wife Shalu (35), and their maid Sapna (33).



According to West district Deputy Commissioner of Police Ghanshyam Bansal, Sachin (19), a resident of Najafgarh, and Sujeet (21), a resident of Uttam Nagar, have been arrested.

A call was received at Hari Nagar police station around 9.15 am regarding an incident

of burglary in a house at Ashok Nagar area following which Emergency Response Vehicle (ERV) was rushed to the spot.

"When police team reached the spot, the bodies of Sameer, Shalu and their maid Sapna were found. Both Shalu and Sapna were found lying on the ground floor of a salon owned by the couple, while Sameer was found lying in a pool of blood on the first floor

of the building," said the DCP.
"Throat of both, Shalu and Sapna had been slit with sharp edged weapon and Sameer had multiple injuries on face and head. However, the couple's minor daughter was found unhurt on the first floor in the

## plea against pre-poll freebie pledges: SC

Athree-judge bench will hear "in entirety" the pleas against the practice of political parties promising pre-election freebies, the Supreme Court said on Tuesday.

A bench comprising Chief Justice UU Lalit and Justice Bela M Trivedi said it is sitting in a combination of two and according to a reference order on the matter, it should go before a bench of three judges for disposal.

"Once there is a reference order that the matter has to be heard by a three-judge bench then it will be heard by a three-judge bench," the CJI said, adding the judicial records be placed before the Chief



Justice in his administrative capacity for listing these cases before an appropriate bench.

Considering the nature of the controversy and submissions made by the parties in the earlier hearings, the matter would be listed as early as possible, the bench said.

Ashwini Upadhayay, one of the PIL petitioners, said the matter has to be heard by a larger bench with an aim to examine the earlier judgment in the Subramaniam Balaji

## Ex-staffer kills man, slits 3-judge bench to hear Hurdle in Ukrainian exports to worsen food insecurity: India

 $\mathbf{I}$ ndia has expressed concern over the suspension of food exports from strife-torn Ukraine and said it may further "exacerbate" food security, fuel and fertiliser supply challenges, particularly in the global South.

This plea was made in the United Nations Security Council (UNSC) late on Monday by R Madhu Sudan, Counsellor in India's Permanent Mission to the UN against the backdrop of the suspension of the Black Sea Grain initiative, an UN-brokered deal that allowed food

exports from Ukraine. He said the grain initiative, a result of the UN Secretary-General's efforts, had aimed to avert a global food crisis and ensure food security.

The initiative resulted in the export of more than nine million tons of grains and other food products out of Ukraine.

"The Black Sea Grain initiative and cooperation by the parties so far had provided a glimmer of hope for peace in Ukraine... The suspension of the Black Sea Grain initiative, we believe, is expected to further exacerbate the food security, fuel and fertiliser supply challenges faced by the world, particularly the global South, Sudan Madhu at the Security Council briefing on the Black Sea Grain Initiative.

He said India supports the engagement of UN Secretary-General Antonio Guterres with the parties on "renewal and full implementation of the initiative, including facilitation of exports of food and fertiliser from Ukraine and Russia.

Russia on Saturday announced it was suspending its involvement in the deal, citing an attack on ships in the Ukrainian port of Sevastopol

in the Crimean peninsula. Guterres had said he is deeply concerned about the ongoing situation regarding the Black Sea Grain initiative. A statement issued by his spokesperson had said the UN chief continues to engage in "intense contacts" aiming at the end of the Russian suspension of its participation in the Black Sea Grain initiative.

"The same engagement also aims at the renewal and full implementation of the initiative to facilitate exports of food and fertiliser from Ukraine, as well as removing the remaining obstacles to the exports of Russian food and fertiliser," the UN statement



## 'India's role in ensuring regional stability helped Bangladesh's growth'

Tndia's role in ensuring  $oldsymbol{1}$ regional stability has helped Bangladesh in maintaining political stability that essentially facilitated the country's growth trajectory, Bangladesh Information Minister Hasan Mahmud said on Tuesday

In a media interaction, Mahmud also said that the relationship between India and Bangladesh is "very diverse" and it does not depend only on

the Teesta water-sharing.
"Political stability in a country is one of the most essential pre-conditions for prosperity. I strongly believe that to maintain the political stability in Bangladesh, regional stability is also important,"

"I would like to thank (India). To keep regional stability, and thereby political stability in Bangladesh, India has played a role," he said during the interaction at the Press



The ties between India and Bangladesh have been on a significant upswing in a range of areas including trade and connectivity in the last few

Mahmud also recalled India's role in the 1971 Bangladesh liberation war.

To a question on the longpending issue of Teesta river water sharing, Mahmud said the bilateral relationship does not revolve only around this issue and that both sides are engaged in resolving it.
"The relationship between

India and Bangladesh is very diverse, it doesn't depend only on the Teesta water-sharing. We are sharing many things,

There are some obligations and procedures under India's Constitution. I hope that after following all the procedures, (they) will be resolved in the future," he noted.

The Teesta deal was set to be signed during the then prime minister Manmohan Singh's visit to Bangladesh in September 2011 but was postponed at the last minute due to objections raised by West Bengal Chief Minister Mamata

Banerjee had expressed strong reservations against giving Bangladesh a greater share water from the Teesta river.

Asked about incidents of attacks on Hindu minority members in Bangladesh and whether they could impact bilateral ties, Mahmud said Dhaka came down hard on elements that attempted to foment sectarian tensions.

"This year, Durga Puja was celebrated in a festive manner, and the number of puja pan-

dals increased by 700 over last year. The government has ensured the safety and security of those who follow the Hindu religion," he said.

'No one is a minority in Bangladesh. Our prime minister says don't feel you are a minority, you are the son of the soil, this is your country," he

The minister said everyone has equal rights in Bangladesh country's under the Constitution. "There are fanatic groups

both in India and Bangladesh, they try to ignite fanaticism, they try to destabilise harmoacross religious groups. That happens everywhere," he Asked about the

Citizenship Amendment Act (CAA) in India, he described it as the country's "internal "As an appeal has been

submitted in (India's) Supreme Court, that way it has also become a legal issue," he said.

Prez Murmu to start Nagaland, Sikkim visit from today

President Droupadi Murmu is scheduled to visit two northeastern states - Nagaland and Sikkim - on a four-day tour beginning Wednesday, officials said. On her maiden visit to both states after assuming office, she will inaugurate and lay the foundation stone of several projects.

Murmu will first reach Kohima, the Nagaland capital, on Wednesday and the state government will accord her a civic reception. The President will virtually inaugurate newly constructed government schools, Pradhan Mantri Gram Sadak Yojana (PMGSY) roads, and Kohima Super Market, officials said.

She is also scheduled to meet state ministers at Raj Bhavan which will be followed by a state banquet at the chief minister's residential complex on November 2.

On Thursday, the

Kohima War Cemetery and Kigwema, one of the oldest villages inhabited by people of the Angami tribe, located about 15 km from the state capital.

From November 4, Murmu will start her two-day visit to

### Maharashtra political crisis: SC to hear pleas filed by Uddhav, Shinde groups on Nov 29

The Supreme Court will hear a batch of pleas on the Maharashtra political crisis filed by the Shiv Sena factions led by Uddhav Thackeray and Eknath Shinde on November 29, when it is likely to issue some directions.

A five-judge bench of Justices D Y Chandrachud, M R Shah, Krishna Murari, Hima Kohli and P S Narasimha on Tuesday asked both the parties to file their written submissions and a joint compilation on the issues to be adjudicated by the constitution bench.

The bench said, "It has been agreed by the counsels of both the parties that they will meet and formulate the issues which arise for considerations and deciding the reference before the constitution bench. List the matter on November 29 for directions."

On August 23, a threejudge bench of the top court headed by then chief justice N V Ramana had formulated several questions of law and referred to a five-judge bench

## Conman's extortion claim triggers BJP-AAP fight

Jailed conman Sukesh Chandrashekhar has written to the Delhi Lt Governor Vinai Kumar Saxena alleging that AAP leader Satyendar Jain extorted ₹10 crore from him in 2019 to ensure his safety in prison, triggering a political slugfest between the AAP and

In a letter written to the L-G by Chandrashekhar, dated October 7, was submitted to Saxena October 8 by his advocate Ashok K Singh. In the letter, Chandrashekhar alleged that he has been receiving threats and was under pressure from Minister Satyender Jain and Sandeep Goel, the Director General of Prison, Delhi, on corruption and extortions.

The letter alleged that more than ₹50 crore was given to the giving Chandrashekhar an important post in party in South Zone, and also to help him get nominated to Rajya Sabha. According to LG office sources, the letter from Chandrashekhar was received by LG office and was forwarded to Chief Secretary of Delhi government for necessary action on October 18. Chandrashekhar, who is lodged in Mandoli jail here in connection with ₹200 crore money laundering case, alleged that after his arrest in 2017 in the two leaf symbol corruption



case he was lodged in Tihar Jail and was visited by Jain, who held the portfolio of Jail ministry, asking him if he had disclosed anything to the probe agency related to his contribution to AAP.

"Thereafter in 2019 again I was visited by Satyendar Jain and his secretary and his close friend Sushil in jail, asking me to pay ₹ 2 crore every month to him as protection money to live safely in jail, and to get even basic facilities," he alleged.

Jain "asked me to pay ₹1.50 crore to DG prison Sandeep Goel, who, he said, was a loyal associate of his. He forced me to pay and an amount of ₹10 crore was extorted from me through constant pressure in a matter of two-three months," he alleged.

He claimed the the amounts were collected in Kolkata through Jains associate. "Hence a total amount of ₹10 crore was paid to Satyendar Jain, and ₹12.50 crore to DG prison Sandeep Goel," the letter alleged, adding that Chandrashekhar had given this information to the ED.

There was no immediate reaction available from Goel to the allegations. Chandrasekhar further said that he also filed a petition before the Delhi High Court seeking a CBI inquiry, and the court has issued notice and the matter is scheduled for hearing next month.

## Allegations fictitious, planted by BJP Conman conned by AAP: BJP to divert attention from Guj: Kejriwal

Terming jailed conman Sukesh Chandrashekhar's letter to Lieutenant Governor as a fabricated story, AAP supremo and Chief Minister Arvind Kejriwal on Tuesday brushed it aside, saying "the fact that the BJP has to rely on a conman, as you say he is, shows their sorry state in Gujarat".

## Pollution worsens to 'severe', AQI highest this year so far

 $P^{\text{ollution levels in Delhi deteriorated on Tuesday to the}}$ severe category with an air quality index (AQI) of 424 on Tuesday the highest so far this year as the layer of acrid smog persisting over the capital thickened amid calmer winds and raging farm fires in Punjab.

NASA's satellite images showed a dense cluster of red dots denoting farm fires in Punjab and parts of Haryana, and a layer of smoke blanketing huge swathes of the Indo-Gangetic plains -- from east Pakistan to east Uttar Pradesh.

Yoga won't be stopped at any cost. These people may be blinded with power, they may be misusing the law, they may be threatening our officers, they may draw back the support of the administration from the elected government but the 2 crore citizens of Delhi are standing against them," he said.

"Even if I have to carry a begging bowl in my hands and go to every doorstep asking for alms to support this programme, I will. Even if I have to beg at

every corner of Delhi, I will, but will pay every single yoga teacher. Your charges will be taken care of, it is my responsibility now," he said Asserting that the 2 crore

citizens of Delhi would ensure that the yoga classes continued, he appealed to all the teachers to go and take the classes as they were doing earlier. Kejriwal also said the public was miffed over the discontinuation of the classes.

"Several teachers called me and asked me not to stop the They said they'd go to the

parks and teach yoga to the public on their own without any payment from the government but won't let the yoga mass-movement stop. I got calls from many well-meaning citizens from across the nation, they said they'd donate money to pool in funds to pay the teachers and asked me not to stop the classes," he said.

'There were 17,000 people attending these classes at 590 sites daily. Of these 17,000 people, a large share, around 10,000-11,000, was constituted by those suffering from post-Covid symptoms," Kejriwal

Asserting that the government intended to scale up the programme exponentially, he said "certain forces have got together to conspire against Delhi's wellbeing by stopping this programme". "These people have forcefully suspended the free yoga classes.

"This is why the free yoga classes did not take place in Delhi today (Tuesday). How can someone have a problem with yoga of all things in the world? How can you make yoga a victim of your petty politics? Is this the level of your intoxication of power?' Kejriwal said.

## **India, Bhutan discuss** ties, regional security

Against the backdrop of China rapidly improving its infrastructure in Doklam region, which resulted in a military standoff in 2017, India and Bhutan on Tuesday reviewed the entire spectrum of their bilateral defence ties during talks here between visiting Bhutan Army Chief Operations Officer Lt General Batoo Tshering and Army chief General Manoj Pande.

The talks took place in the backdrop of China rapidly improving its infrastructure in Doklam region which saw a military stand off between India and China in 2017.

The two chiefs focused on various key dimensions of India-Bhutan defence cooperation and reviewed the evolving regional security scenario. Tshering's visit to New Delhi comes three months after Pande travelled to Bhutan.

"General Manoj Pande #COAS extended a warm welcome to Lieutenant General Batoo Tshering, Operations Officer, Royal Bhutan Army and discussed



#DefenceCooperation between the two Armies," the Army tweeted. Earlier, the Bhutanese chief laid a wreath at the National War Memorial. He was also accorded a guard of honour in the South Block

The Doklam plateau is considered an important area for India's strategic interest. The Indian and Chinese armies were locked in a 73-day standoff at the Doklam tri-junction in 2017 after China tried to extend a road in an area that

Bhutan claimed belonged to it. India strongly opposed conimpacted its overall security interests. The India-China faceoff was resolved following several rounds of talks.

In October last year, Bhutan and China signed an agreement on a "three-step roadmap" to expedite negotiations to resolve their festering boundary dispute. Bhutan shares an over 400km-long border with China and two countries have held over 24 rounds of boundary talks in a bid to resolve dispute.

### Connectivity projects should respect sovereignty of member States: EAM

"Represented India at the meeting of SCO Council of Heads of Government which has just concluded. Underlined



that we need better connectivity in the SCO region built on centrality of interests of Central Asian states," he tweeted.

The External Affairs Minister said "connectivity projects should respect the sovereignty and territorial integrity of member states and respect international law.'

His remarks are seen as a reference to China's Belt and Road initiative. "Our total trade with SCO Members is only \$141 billion, which has potential to increase manifold. Fair market access is to our mutual benefit and only way to move forward," Jaishankar said.

The CHG meeting is held annually and focuses on the trade and economic agenda of the bloc and to approve its annual budget.

The SCO was founded at a

summit in Shanghai in 2001 by the presidents of Russia, China, Kyrgyz Republic, Kazakhstan, Tajikistan and Uzbekistan

Over the years, it has emerged as one of the largest trans-regional international organisations. India and Pakistan became its permanent members in 2017.

The annual SCO summit took place in the Uzbek city of Samarkand last month. Prime Minister Narendra Modi, Russian President Vladimir Putin, Chinese President Xi Jinping and other leaders of the grouping attended it.

Usually, the heads of government meeting of the SCO is represented by foreign ministers while a number of coun tries send their prime ministers

### GM mustard release landmark decision, will encourage more research: Scientists India desperately requires an increase in the productivity of oilseed crops grown in the country, say researchers

Days after the Rashtriya Swayamsevak Sangh (RSS) -affiliated Swadeshi Jagran Manch (SJM) and Bharatiya Kisan Sangh (BKS) opposed the environmental release of genetically modified (GM) mustard hybrid for cultivation saying it could cause cancer and is injurious to health, a group of scientists has hailed the move, terming it a land-

mark decision. The scientists, under the umbrella of National Academy of Agricultural Sciences (NAAS) and the Trust for Advancement of Agricultural

Sciences (TAAS), said it would break a long logjam on the release of GM food crops. "The GM technology for hybrid seed production developed by the University of Delhi will play an important role in reducing the edible oil import burden and in moving towards self-sufficiency in edible oil production.

The decision to release GM mustard will encourage more research and innovations to reduce the environmental footprints of agriculture, develop climate resilient crops, and thereby assure food and nutritional security of the country," scientists Trilochan Mohapatra, RS Paroda and KC Bansal said in a statement here.

They said that at present India had a deficit production of edible oils by almost 55-60% of the total consumption.

"In the financial year 2020-21, around 13.35 million tonnes of edible oils were imported at a total cost of around? 117,000 crore in foreign exchange. India desperately requires an increase in the productivity of oilseed crops grown in the country.

The average mustard yield India is 1.0-1.3 tonnes/hectare. This has been stagnant for almost two decades. Globally, yields of rapeseed have considerably increased with the introduction of hybrids. More than 90% of

the rapeseed crop in Canada, grown in around 8.7 million hectares, is under hybrids. Most of the rapeseed grown in China and Europe is also hybrids," they added. The scientists added that hybrid varieties had helped the country. They said that GM Mustard could be grown in the fields They added that trials con-

ducted over three years at eight locations under the supervision of Indian Council of Agricultural Research-Directorate Of Rapeseed Mustard Research showed that the variety had a yield advantage of 28% over the mega variety Varuna and 37% over the

zonal checks. In its letter to the Centre, the BSK had alleged that GEAC, Delhi University and the Food Safety and Standards Authority of India (FSSAI) are working hand-inglove in matters pertaining to Genetic Modification in food crops. Mohini Mohan Mishra,

All India General Secretary of BKS said that the actions of the GEAC are unscientific, non socio-economic in cases of GM crop and asked the Government to revisit the matter. The SJM wrote to Union Environment Minister urging him to ensure that crop's "dangerous" seed is not allowed to be planted "now or ever".

## **Army fully prepared: Lt Gen** on Rajnath's reclaiming PoK

## Maha ex-HM Deshmukh completes 1 year in jail today

s he waits for the Bombay AHigh Court to hear his bail plea in the alleged corruption case lodged against him by the Central Bureau of Investigation (CBI) on November 11, Maharashtra's former Home Minister and senior NCP leader Anil Deshmukh will on Wednesday complete one year of incarceration in the CBI's corruption case and also alleged money laundering case filed by the Enforcement Laundering Act (PMLA) on Directorate (ED). Laundering Act (PMLA) on charges of bribery, conspiracy

After skipping the summons issued by the ED for five consecutive times on the alleged money laundering case, Deshmukh had finally appeared before the central investigating agency officials on November 1, 2022 and his questioning had gone on well past midnight. At around 1.30 am on November 2, 2021, the formally arrested Deshmukh under the Prevention of Money and misuse of office.

Deshmukh -- who is also being investigated by the CBI in connection with a First Information Report (FIR) registered by it on April 24 2021 under section 7 of the amended Prevention of Corruption Act and section 120-b (conspiracy) of IPC for an "attempt to obtain undue advantage for important and dishonest performance of the public duty" -

was granted bail by the Bombay High Court on October 4, 2022 in the alleged money laundering case registered against him by the ED.

In view of the observations made by the Bombay High Court while granted bail to him in the alleged money laundering case, Deshmukh hopes to get bail in the alleged corruption case filed against him by the CBI, when the high court hears his bail application on November 11.

While granting bail to

Deshmukh on October 4 2022, the high court had indirectly held that the ED had failed to prove two of its allegations against the former minister, while Deshmukh was given benefit under law in the third allegation.

Deshmukh is currently in judicial custody at the Arthur Road Central Prison.

Ahead of hearing Deshmukh's bail application on November 11, the high court has asked the CBI to file its reply by November 9.

Gujarat would be accorded under the Indian Citizenship Act 1955 instead of the much Citizenship Amendment Act of 2019 the Bengal BJP leader's statements is being seen as an attempt no only to play to the Matua gallery but also ensure that the electoral atmosphere remains polarised as it had been during the recent elections, experts say.

Matua leader and Union minister of State Shantanu Thakur who had last year given the Centre an ultimatum to implement the CAA too said that implementation of the amendment act would be of great help to the 80-lakh strong Matua community that had a direct impact on at least 75 assembly seats in the State.

The Central government decision to provide citizenship is likely to benefit non-Muslim people of two who had earlier migrated from the neighbouring countries including Pakistan, Bangladesh,

Going by the results of the recently conducted by-elections and the Kolkata Municipal Corporation polls a moribund Left has come up to the second position by displacing the BJP.

The ruling Trinamool Congress on the other hand too has suffered politically in the recent months particularly after a number of its ministers and leaders went to jail post school level appoint scam and coal and cattle smuggling expose. This has seen the TMC losing a number of panchayats to the Congress and the Left in Muslim dominated districts like Murshidabad.

Congress State president Adhir Chowdhury said "the BJP is trying to play divisive politics ... By telling the half truth Suvendu Adhikari is trying to mislead the people of Bengal... In Gujarat citizenship is being provided under the Citizenship Act of 1955 and not the CAA?

Trinamool Congress spokesperson Kunal Ghosh said that the citizenship drive was a ploy to divert attention from the Morbi Bridge collapse case. ## **Tough road ahead**

Musk would have to do a lot of balancing to fly his sparrow in India without runing into trouble

fter purchasing Twitter, Elon Musk, the co-founder and CEO of Tesla, has sacked its Indian CEO Parag Agrawal. Another Indian, Sriram Krishnan, will be closely associated with the revamp. The exit of Agrawal was inevitable, given the value system Musk subscribes to. Musk is a "free speech absolutist." Ironically, this has made him a villain in the eyes of liberals. There was a time when the world's richest man was adored by thought leaders and glitterati, for he believed in, among other things, climate change. All this changed when he championed the cause of free speech. On the face of it, this is surprising because liberals are expected to uphold individual liberty and freedom of expression; but that doesn't happen anymore. So, the antipathy towards Musk is enormous. There have been rumours right from the beginning about massive layoffs if he takes over the company. There were reports that three-fourths



of the employees would lose their jobs once the \$44billion deal is closed; Musk denied any such plan. Then several media organisations showed two laid-off employees moving out; it turned out that they were pranksters. The fact that multiple media platforms were tricked by a pair of pranksters also underlines the fact that reporting on Twitter takeover has to be taken with a pinch of salt. What is undeniable is that Krishnan is, in his own words, "helping out" Musk in the social media giant's revamp.

A tech guy and general partner at Silicon Valley venture capital firm, Krishnan "led core consumer teams at Twitter where he was responsible for products including the home timeline, new user experi-

ence. search, discovery, and audience growth," his profile said. He is expected to play a key role in carrying out the changes Musk wants to carry out. The billionaire owner wants to revise its user verification process. Twitter is reportedly contemplating charging for the blue check mark which verifies the identity of an account holder. There is also a report about a \$19.99 payment for the new Twitter Blue subscription. How Musk's Twitter fares in India, a big market, will be interesting to see. The Government hasn't commented anything substantive on the takeover. "Our rules and laws for intermediaries remain the same regardless of who owns the platforms," said Minister of State for Electronics and Information Technology Rajeev Chandrasekhar. "So, the expectation of compliance with Indian laws and rules remains." Musk's free speech absolutism will be severely tested in our country, where freedom of expression faces assaults on an hourly basis and from all quarters. Sentiments in India are so delicate that they keep getting hurt all the time; worse, political parties and governments are always concerned about sentiments and never about freedom of expression. In a nutshell, Musk would have to take care of a variety of factors—his free speech beliefs, India's sentimentalism peddlers, and liberals in the West. A great deal of balancing will be needed.

## The death bridge

The greed, corruption, political expediency all played their part in the bridge tragedy in Gujarat

he collapse of a colonial era cable bridge at Morbi in Guiarat on Sunday in which nearly 145 persons lost their lives and many got injured was a gruesome tragedy. Global leaders like Russian president Vladimir Putin, Dalai Lama, Sri Lanka's Ranil Wickremesinghe expressed their shock and condolences and this speak about the seriousness of the situation. The collapse of the recently renovated bridge happened on the day Prime Minister Narendra Modi laid the foundation stone for building the manufacturing plant of the C-295 Transport Aircraft being built by Air Bus Industries of France at Vadodara adds to the seriousness of the disaster. The Prime Minister's new mantra "Make in India. Make for the Globe" falls all flat with the collapse of the Morbi cable bridge.

What adds to the mystery behind this accident is the continued silence of Chief Minister



Bhupendrabhai Patel even after 24 hours of the disaster. Patel should have been the first person to tell the world that an accident of heavy magnitude has taken place and those who are responsible for the collapse of the bridge should be brought before the law. But he remained incommunicado and media persons who tried to speak to him were driven away by his personal staff. The fact that a clock manufacturing company based in Morbi with no experience in renovating bridges or specialisation in heavy engineering works was given the contract for the renovation and restoration work of the bridge. A former Fire Safety Officer has come out in the open saying that he had alerted the authorities three times about the sub-stan-

dard works being carried out under the pretext of renovation.

The catchword is that the leader should always lead from the front. But Patel is not seen anywhere near the rescue and relief operations. The death toll definitely mandates that Patel should have been present on the scene in the first hours of the accident itself. His action does not augur well for a person of his stature. The fact that the company Oreva that had been awarded the contract to renovate the bridge is owned by the family of Odhavji Raghavji Patel, founder of the group too needs to be investigated. Initial reports say that the deal looks fishy and filthy. The days of driving away media persons and scaring the people who ask questions are long over and we live in an open society. The attitude of Chief Minister Patel is highly condemnable.

## Criticism and free speech not welcome



The present-day world leaders are becoming increasingly intolerant about criticism and wouldn't mind nudging away their challengers

magine former Prime Minister Atal Behari Vajpayee when alive or former Party President Rajnath Singh being removed from a BJP Chintan Shivir presided over by PM Modi. Unthinkable. Wrong. It is possible if Modi, as things are going, becomes the supreme leader of the BJP and the country's ultimate ruler. But even then it will not be easy. In President Xi Jinping's new China, under Emperor Xi (or Maximum Xi), anything is possible: from a warlike lockdown zero COVID policy where in some places COVID tests are held twice a day, to remove for-mer President Hu Jintao (79) his predecessor from the closing day proceedings of the recent 20th National Party Congress. Journalists who were allowed into the Great Hall opposite Tiananmen Square have reported this event backed with video footage - many with more than one set of footage - of the stunning event which, but for this unprecedented incident, passed off with peace and tranquility.

The first reports of the tumultuous incidents appeared on BBC on 23 October which showed Hu's 'extraction' with the explanation it was due to Hu being unwell. But the clips that have now become collector's items, do not indicate an un-well Hu. He is shown remonstrating with the Emperor and also his protégé, Prime Minister Li Keqiang, sitting on Xi's right. Nevertheless, he has whisked off the stage without a murmur from the 2300-odd delegates in the Great Hall.

The Hindu was the first Indian newspaper to report that something had gone amiss at the Party Congress. Ananth Krishnan wrote that Hu had attended the opening on 16 October and was known to be in ill health and sat beside Xi. Hu insisted on attending the last session despite health issues. On the closing day, he appeared to mistakenly take a white sheet of paper placed in front of Xi which the latter then removed away from nim. Ainnua, China's official news agency, reported that incident showed that twice Hu was not feeling well so his Hu attempted to return to his

staff took him to the room next to the venue meeting for rest. Throughout the Party Congress sessions, Hu was shown following behind Xi to indicate his hallowed status. Meanwhile, on its Twitter

handle, Xinhua's reporter Li Jiawen reported the incident on the same lines as Krishnan. The event depicting Hu escorted out against his will when he insisted on attending the closing session has caused a stir. Anybody seeing the video footage will also draw this conclusion. Li's tweet suggested that Hu should not have attended the session but he did so in defiance of Xi's wishes. Observers that included several foreign media outlets interpreted Hu's removal as preventing him from apparently expressing dissent on the removal of his faction (as part of collective leadership of the past) which represented their wipeout from the leadership. With Li Keqiang and Vice Premier Wang Yang dropped and Hu Chunhua, demoted, (all from the Communist Youth League associated with Hu Jintao) the seven-member Politburo Standing Committee is now stacked with Xi loyalists.

Otner video footage of the

seat: he was not permitted to return by his aides, fearing words of dissent from him. This supplements clips of how outgoing Politburo members Li Zhanshu, sitting to Hu's left, took a file away from Hu while speaking to him. Then, Xi is seen giving instructions to the escorts who persuade Hu to leave not before he is seen muttering words to Xi and Le Keqiang. Krishnan had earlier reported that Hu's removal was to ensure that he did not vote in the session where several sweeping amendments proposed Xi is "everything" in the constitution.

Richard McGregor of Lowy Institute Sydney described 'truly extraordinary' the incident that reflected a lack of basic courtesy to Hu while 'wooden men elevated by Hu were frozen and dumbfounded in stony silence. Another video shows Hu going to look at the contents of the red folder in front of him only to be stopped by Lin. Hu later reaches for papers in front of Xi who puts his hand on them to prevent Hu from taking them. The footage read together tells the story: Health issues or not, one thing is clear; Hu could have created a big stir that was not in the script. Every event in the Party Congress is so perfectly choreographed

that a misstep is almost impossible. Still Hu did it.

In the new Xi era, he is everything forever. His three aides promoted and chose military commanders in the Central Military Commission (CMC) only a powerful insider can rock the boat. Xi has ignored age caps, replaced rules with political standards (loyalty), and brought core interests (Taiwan, South China Sea, and Senkaku Islands) to the front and middle of the great rejuvenation. The video footage of the Galwan clash attracted applause. The image of the PLA commander, the injured Qi Fabio standing with his arms outstretched facing Indian soldiers heralded the start of the conference. Qi was one of the delegates. He was also the torchbearer during the winter Olympics. China has regaled Galwan heroes signaling longer winters in Ladakh. And rubbing salt on wounds PLA had earlier painted in red in 1962 on a stone at Nakula in north Sikkim. India has to show it is 2022, not 1962. But



Atma Bal is also the basis of life, ananda



## Xi's 3rd term calls for closer India-Japan ties



### China may escalate tensions on borders with neighbours, including India; counter-measures must begin

hinese President Xi Jinping's announcement of vision for his upcoming tenure threatens democratic countries. His ambitious plan of troop training and combat preparedness to "fight and win" apart from creating a "strategic deterrence" strongly indicates how the situation would be on China's borders. China has already started funding for expanding its military capabilities and greater synergy between its civil-military fusion.

At the end of 2020, Beijing launched a three-year plan to improvise its stateowned enterprise system, which is an essential part of its defence-industrial sector. Initiatives of mixed private-public ownership and defence research institutes via the methodology of stock market listings of principal state-owned defence contractors have been aggressively adopted.

As per the Military Balance Report (2022), a total of \$370 billion was raised between 2012 and 2020, out of which \$20.7 billion was done in 2020 alone. Consequently, for the fiscal year 2022, Beijing announced a defence budget of \$229 billion, which was a sharp 7.1 per cent increase from 2021. The reforms, due for completion in 2023, will lead to active civil-military fusion in different domains such as maritime, space, cyber, biotechnology, new energy, A.I. and quantum technologies.

Further, showcasing the Galwan clip at the 20th Chinese Communist Party Congress may be an official recognition of India as an enemy. Prior to this, Zhou Bo, a senior fellow at Tsinghua University's Centre for International Security and Strategy, commented on India-China relations in a very intimidating manner. He warned that "friction and even conflict between the two sides is possible if (New Delhi) regards the Indian Ocean as the 'Great Ocean for Hindus' or India as a 'net security provider' for the Indian Ocean". Thus, there are indications that Xi's new tenure could snowball into turmoil and conflict in the region.

On the other front, Japan has genuine concerns about the increased Chinese aggressiveness. It fears that China might simulate the Russia-Ukraine conflict in the region. In case of a military conflict on the Taiwan issue, it may have a spillover effect in the region. After the incidents of the launch of missiles into Japan's Exclusive Economic Zone (EEZ) besides the hostility displayed during Nancy Pelosi's visit to Taiwan, Japan is eager to increase its strategic outreach and reformulate its military policies.

In terms of regional military expenditures in 2021, China's share of entire Asia's defence spending accounted for 43 per cent at \$207 billion. On the contrary, in 2022, India's military spending was merely \$70 billion. Japanese PM Fumio Kishida asked for a budget of \$40.4 billion for the fiscal year 2023. Thus, China essentially surpasses the efforts of India



the Chinese threat. Each triangular dynamic between the US, China and India, apart from China, India and Japan, would have its challenges and opportunities for India. A high level of military cooperation is already in place with the US and its primary ally Israel, which has helped India with technical cooperation in intelligence and counter-terrorism. Much can be achieved in the tactical cooperation between India and Japan.

Kishida has aimed to "drastically" increase Japan's defence spending to two per cent of its GDP within the next five years and develop "counter-strike capabilities". In 2017, Japan spent 13 per cent of its defence budget on R&D. Given Japan's technological edge, joint R&D apart from the production in defence innovation can help India as the china factor is common to them. For instance, Japanese private players like Mitsubishi Electric Corporation can play an essential role in the Indian defence company. Mitsubishi's J/FPS-3 active electronically scanned array radar and J/TPS-P14 mobile air surveillance radars have been recently exported to the Philippines to help counter the Chinese threat, including the South China Sea. India can also seek such technologies which have not been exported to any other country.

In a hostile situation, the Quad can become a military counterweight to China's aggressiveness.

informal arrangement that has not been institutionalised with an anti-China purpose. Focusing on the freedom of navigation, the interplay of bilateral and multilateral agreements revolves around Malabar naval exercises, information sharing, interoperability and coordinated military activities. As India and Japan have a shared perception of the growing military challenge, on the lines of various treaties amongst the Quad members, both countries can go in for multiple agreements in the future, such as Mutual Logistic Support Arrangement, Preventing and Combating Serious Crime, Reciprocal Access Agreement, and, Geo-Spatial Cooperation. Thus, the two groupings could broadly cooperate depending on China's hegemonic tendencies.

Indo-Japan cooperation needs to be strengthened. The two countries have taken new initiatives for defence Projects such as UAVs, anti-drone systems, robotics and underwater communication. In particular, using robotics in the defence sector to produce military robots with artificial intelligence to decrease casualties in counter-terrorism operations and natural disasters can be a pathbreaking development. Although there is active robotic cooperation between india and Japan, with many Japanese companies like ABB Robotics, Kawasaki Robotics, and Yaskawa having heavy investments in India, these are for civilian uses, mainly commercial in nature. India and Japan must evolve their tactical partnership and civil-military fusion at a greater pace.

Further, trilateral cooperation between Taiwan, India and Japan can help us as a possible synergy between the three can help maintain the freedom of the Indo Pacific region. Taiwan is a leading country in the manufacture of semiconductors, with Taiwan Semiconductor Manufacturing Company (TSMC) occupying 80 per cent of the microcontrollers used in cars. Trilateral cooperation involving Taiwan for microcontrollers, Japan for robotics and India for its software technology and the final end manufacturing of robot soldiers can add new dimensions to the expanding domain of the Indo Pacific.

Nevertheless, there can be active cooperation between the Japan Meteorological Agency and the Indian Meteorological Department. In the last few years, the number of cloud bursts in Uttarakhand, Himachal Pradesh Ladakh, especially at critical locations such as the Jawahar tunnel, Line of Actual Control (LAC), etc., has increased. In the near future, the Bilaspur-Leh rail line should be protected from all sudden weather changes. Such incidents are related to global warming, but our adversaries capabilities to use artificially induced calamities such as avalanches, artificial rains and cloud bursts as a tool to achieve their political interests is no less. Using such technologies drastically reduces the cost of military operations, avoiding detection, retaliation and nuclear escalation. The emerging domain of 'weather warfare' and hybrid warfare, where the weather can be artificially modified and used as a weapon of war to accelerate food shortages and military casualties, should not be overlooked by the Indian defence agencies and their research institutes. Thus, a strong Indo-Japan military cooperation is the need of the hour and would serve the strategic interests of both.

## Powerful PM may not be benign to the ruling party

#### Congress is paying heavily for Indira Gandhi's deeds, but history may repeat itself as BJP is going down the same road

ritten off as a 'dumb doll (gungi gudiya)' by veterans of Congress, Indira Gandhi emerged from their shadows to become one of the most powerful prime ministers of the country. As a resurgent BJP under an equally domineering Prime Minister Narendra Modi goes about its self-professed task of a Congress-free India, there are educative parallels of how powerful leaders have ended up pulverizing the very organisations that seeded their growth. The past, thus, indicates that the present Congress could be the future of the BJP.

Indira Gandhi began with a whimper but soon came into her own with a bang. Thereafter, there was no look-



ing back. "Indira is India" is how then party president DK Barooah described her. In time, her power dominated every facet of governance as well as the party, diminishing all others to merely the roles assigned by her. The BJP is headed the same way, as Modi eclipses his mentoring edifice. Today, he is the government and he is the party.

Once upon a time, Congress chief ministers would vanish without a word; now BJP chief ministers are here today, gone tomorrow. Biplab Deb became the latest BJP chief ministerial head to roll into history in the north-eastern state of Tripura. Until September last year four BJP chief ministers had been sent packing in six months in

three states - Uttarakhand, remove corruption)". 'They' Karnataka and Gujarat.

If Nehru was essentially a statesman and a democrat with strong secular credentials and a zest for promoting science and technology, his daughter Indira Gandhi metamorphosed fast into a strong, aggressive hard boiled politician, who could captivate and cut down with equal ease. She was as much at ease in the countryside of India as holding her own in "Woh kehte hain Indira hatao, main kehti hoon garibi hatao (They say remove Indira, I say remove poverty)". 'They' included the Jan Sangh then. Sounds familiar! Years later, Modi was heard saying "who kehte hain Modi hatao, main kehta hoon corruption hatao (they say remove Modi, I say

Indira Gandhi's propensifor playing on the front foot formed the basic template of Modi's politics which, however, deviated sharply thereafter into the rough and tumble of no-holds-barred freestyle fighting.

In Indira Gandhi's case, she went slam-bang into the old guard of her father's era and bludgeoned her way to the top by splitting Congress. She was one of the most powerful Prime Ministers in the history of India who was famously described by BJP leader Atal Bihari Vajpayee as "Durga' after she split Pakistan to carve out

Bangladesh in 1971.

her 15 years at the helm that the PMO became all powerful and the party was reduced to an add-on to Indira. All power flowed down from her whether it was the government, party or constitution-

al appointments. In fact, the Congress return to power after defeating the Atal Bihari Vajpayee led 'India shining' NDA in 2004 and the two terms thereafter lulled the Congress led UPA into a false sense of complacency while the RSS was busy cobbling together a new narrative which was being tested in its political laboratory in Gujarat by strategist chief minister Narendra Modi. The recipe involved a potent blend of heightened religiosity, com-

indulgence, grandiose schemes, global lobbyists and tech-savvy social media management. This was topped with Modi's masterful oratory and skilled self-marketing.

However, after eight years in power the Narendra Modiled BJP is today suffering from all the infirmities which has brought Congress to its present state. The Jan Sangh and its present avatar the BJP prided in being cadrebased party where decision making flowed from the bottom to the top. The pyramid stands inverted and today power flows from a single source down to the bottom.

In a tearing hurry for a 'Congress-mukt' Bharat, the ruling party at the Centre is a bloated 'Congress-yukt' BJP. However, it was during munal cleaving, corporate Manik Saha, the replacement

for Deb in Tripura, is the fourth leader of Congress lineage in the North East to become BJP chief minister in the region. That he was elected to the Rajya Sabha just two months ago also confirms that there is no method in the measure, just a summary step to neutralise anti-incumbency as Tripura goes to polls next year. Hardly any of those who

served as state party chiefs or chief ministers after Narendra Modi in Gujarat have risen on the strength of their own standing. Vijay Rupani disappeared along with his cabinet, a day after he was praised for good work during the pandemic, as did many other BJP CMs countrywide. Modi's domination has reduced all others to insignificance.

## **UN inspecting Russia's unfounded 'dirty bomb' claim**

Rations' nuclear watchdog agency inspected two sites in Ukraine on Tuesday that Russia identified in unfounded claims that Ukrainian authorities planned to set off radioactive "dirty bombs" in their own invaded country.

Russian strikes targeting eight regions of southeastern Ukraine killed at least four civilians and wounded four others in 24 hours, the Ukrainian president's office said. Tens of thousands of people faced power blackouts and water shortages following Russian shelling of energy infrastructure in 10 regions on Monday.

International Atomic Energy Agency Director General Rafael Grossi said the inspections for evidence of a so-called dirty bomb, requested by Kyiv in the wake of the unsubstantiated Russian allegations, would be completed soon.

In the wake of battlefield set-

Ukraine, top Russian officials, including President Vladimir Putin, made unsubstantiated accusations that Ukraine was manufacturing such an explosive device, which scatters radioactive

The Russians, without providing evidence, alleged the Ukrainians planned to make the purported bomb look like Russia's doing. Russia's UN ambassador,

Vassily Nebenzia, alleged in a letter to Security Council members last week that Ukraine's nuclear research facility and mining company "received direct orders from (President Volodymyr) Zelenskyy's regime to develop such a dirty bomb?

Western nations have called Moscow's repeated claim "transparently false." Ukrainian authorities dismissed it as an attempt to distract attention from Moscow's own alleged plans to detonate a dirty bomb as a way to justify a further escalation of hostilities.

## Ships sail from Ukraine despite Russia suspending grain deal

Ships loaded with grain departed Ukraine on Tuesday despite Russia suspending its participation in a UN-brokered deal that ensures safe wartime passage of critical food supplies meant for parts of the world struggling with hunger.

The UN said three ships carrying 84,490 metric tons of corn, wheat and sunflower meal left through a humanitarian sea ridor, brokered by Turkey and UN, was seen as a breakthrough that would ensure Africa, the Middle East and parts of Asia would receive grain and other food from the Black Sea region during Russia's war in Ukraine.

Russia cited an alleged Ukrainian drone attack against its Black Sea fleet in announcing the suspension of its part of the grain deal over the weekend. The Russian Defence Ministry said Monday that ship traffic from ports in southern Ukraine



was halted, calling the movement "unacceptable"

But a total of 14 ships sailed Monday, including one chartered by the UN World Food Programme to bring wheat to Ethiopia, which along with neighbouring Somalia and Kenya, is badly affected by the worst drought in decades.

Analysts say that because Russia is bound by the conditions of the grain deal it signed with Turkey and the UN, which include a commitment not to

"When you're relying on electricity, the worst thing is that you can't plan ... Psychologically it's very uncomfortable," said Vedmid, a 44-year-old business owner in Bilohorodka. The cuts are getting longer — nearly 12 hours of outages a day, he said.

So far, Russia has destroyed about 40 per cent of Ukraine's energy infrastruc-



ture, affecting 16 regions, according to the Ukrainian government. The latest assault came on

Monday, when a massive barrage of Russian cruise missile and drone strikes hit Kyiv, Kharkiv and other cities, knocking out water and power supplies in apparent retaliation for what Moscow alleged was a Ukrainian attack on its Black

The unpredictable rolling blackouts are increasing as the government scrambles to stabilise the energy grid and repair the system ahead of winter. The cuts add another layer of angst and uncertainty to a population already strug-gling with the stress of nearly

nine months of war.

To try to ease people's burdens, energy companies are publishing daily schedules of when neighbourhoods won't have power. But it's not consistent, especially as strikes intensify.

Last week a power station in the central region was damaged, causing an emergency shutdown and prompting the government to warn citizens of tougher and longer outages.

Unfortunately, the destruction and damage are serious," Kyiv region Gov. Oleksiy Kuleba said in a Telegram post. "It is necessary to prepare for emergency power outages for an indefinite period," he said.


## Ukrainians grapple with power | No breakthrough in Armenia, outages as winter approaches | Azerbaijan peace talks in Russia

 $R^{\mathrm{ussian}}$  President Vladimir Putin hosted the leaders of Armenia and Azerbaijan on Monday to try to broker a settlement to a longstanding conflict between the two ex-Soviet neighbours, but announced no breakthrough.

The peace talks took place as Putin's military delivered a new missile barrage targeting Ukraine's critical infrastructure in the conflict that has entered its ninth month. After meetings with

Armenian Prime Minister Nikol Pashinyan and Azerbaijani President Ilham Alivev in the Black Sea resort city of Sochi, Putin said they had to remove continuing points of disagreement from a prepared statement that was to have formed the basis of a peace deal. He called the meetings "very useful" but declined to answer a reporter's question about the remaining sticking points, saying they were too delicate to discuss publicly.

Before the meeting with Pashinyan, Putin had said the goals would be to ensure peace and stability, and unblock transportation infrastructure to help



Armenia's economic and social development.

A joint statement released after the talks said the two sides pledged to refrain from the use of force, to negotiate issues based on respect for each other's sovereignty, territorial integrity and inviolability of borders. It said Armenia and Azerbaijan

would work to normalise relations, foster peace and stability, as well as the security and economic development of their

Armenia and Azerbaijan have been locked in a decadesold conflict over Nagorno-Karabakh, which is part of Azerbaijan but has been under

forces backed by Armenia since a separatist war there ended in 1994.

"We see the approaches of our colleagues to what is happening on the Armenian-Azerbaijani border and around Karabakh," Putin said Monday. "This conflict has been going on for a decade, so we still need to end it."

The meetings concern implementation of a 2020 peace deal that Russia brokered. During a six-week war in 2020, Azerbaijan reclaimed broad swaths of Nagorno-Karabakh and adjacent territories that Armenian forces held for decades. More than 6,700 people died in the fighting. Moscow deployed about 2,000 troops to the region to serve as peacekeepers.

Pashinyan said Monday that he would press for Azerbaijan to withdraw its troops from the Russian peacekeeping zone in Nagorno-Karabakh, and seek freedom for Armenian prisoners of war.

An extension of the Russian peacekeeping mandate was also under discussion, Russian state news agencies

afterward that extension of Russia's peacekeeping mission would depend on resolution of A new round of hostilities

erupted in September, when more than 200 troops were killed on both sides. Årmenia and Azerbaijan traded blame for triggering the fighting.

Russia is Armenia's top ally and sponsor. In a delicate balancing act, it maintains a military base in Armenia but also has developed warm ties with Azerbaijan.

In an apparent reflection of tensions with Armenia's leadership, Putin noted last Thursday that the Kremlin had advised Pashinyan's government before the 2020 hostilities to agree to a compromise in which Armenian forces would give up Azerbaijani lands outside Nagorno-Karabakh that they seized in the early 1990s. Putin lamented that "the Armenian leader-

ship has taken a different path." During the 2020 fighting, Azerbaijan reclaimed not only those territories but significant chunks of Nagorno-Karabakh

## Greece: Dozens missing after boat carrying migrants sinks

**AP** ■ ATHENS (GREECE)

major search and rescue Aoperation was underway on Tuesday for dozens of migrants reported missing after the overloaded sailing boat they were on capsized and sank in stormy weather overnight off an island near the Greek capital, authorities said.

The incident was the latest in a series of recent shipwrecks involving migrant boats in Greek seas that have left dozens

of people dead or missing.

The coast guard said nine survivors, all men, had been found on an uninhabited islet south of the island of Evia and had been picked up by a coast



guard vessel in the early hours of Tuesday

None had been wearing lifejackets, the coast guard said. The survivors told authorities they had been on board a sailboat with a total of around 68 people that had left from Izmir on the Turkish coast, and that the vessel had capsized and sank. The rescue operation was hampered by particularly rough weather, with gale force winds on Tuesday morning, the coast guard said.

The area where the boat sank, the Kafireas Strait between the islands of Evia and Andros

is notoriously treacherous, with even light winds kicking up rough seas. Wind strength eased in the early afternoon, but the ongoing search had not yet located any further passengers from the sailing boat.

Images of the rescue operation released by the coast guard showed a small group of people standing on rocks beneath a cliff waving for help, and waves crashing over the coast guard patrol boat during the night-

time search and rescue.

A photo released by the coast guard showed the survivors wrapped in emergency foil blankets sitting on the deck of the patrol boat.

The coast guard said author-

ities were initially alerted by a distress call in the early hours of Tuesday from passengers saying the boat they were on was in trouble, but they did not provide a location. An aircraft, a coast guard patrol boat and two nearby ships were participating in the search and rescue operation. A separate search and res-

cue operation was also continuing on Tuesday afternoon off the coast of the eastern Aegean island of Samos, which lies near the Turkish coast, for seven people still missing from an inflatable dinghy that capsized on Monday with 12 people reportedly on board. Four survivors were rescued Monday from that incident.


#### Roberts delays handover of Trump tax returns to House panel committee has broad authority to obtain tax returns and

Chief Justice John Roberts on Tuesday put a tempo-rary hold on the handover of former President Donald Trump's tax returns to a congressional committee.

Roberts' order gives the Supreme Court time to weigh the legal issues in Trump's emergency appeal to the high court filed on Monday.

Without court intervention, the tax returns could have been provided as early as Thursday by the Treasury Department Democratic-controlled House



Ways and Means Committee. Roberts gave the commit-

tee until November 10 to respond. The chief justice handles emergency appeals from the nation's capital, where the fight over Trump's taxes has been going on since 2019.

Lower courts ruled that the

rejected Trump's claims that it was overstepping. If Trump can persuade the nation's highest court to inter-

vene in this case, he could potentially delay a final decision until the start of the next Congress in January. If Republicans recapture control of the House in the fall election, they could drop the records request.

The temporary delay imposed by Roberts is the third such order issued by justices in recent days in cases related to Trump.

## Biden paints oil firms as war profiteers, talks windfall tax

President Joe Biden on Monday accused oil companies of "war and a panies of "war profiteering" as he raised the possibility of imposing a windfall tax on energy companies if they don't boost domestic production.

Biden in brief remarks criticised major oil companies for making record-setting profits while refusing to help lower prices at the pump for the American people. The president suggested he will look to Congress to levy tax penalties on oil tax companies if they don't begin to invest some of their profits in lowering costs for American consumers. The president issued the warning just days before the November 8 midterm elections.

"My team will work with Congress to look at these these options that are available to us and others," Biden said. "It's time for these companies to stop war profiteering, meet their responsibilities in this country and give the American people a break and still do very well."

Biden took aim at one company, ExxonMobil, that reported \$19.7 billion earnings in the third quarter alone. He lashed at the Irving, Texas-headquarter

North Korea's Foreign Ministry criticised the United States for expanding joint military exercises with South Korea that it claims are practice for a potential invasion, and it warned on Tuesday of "more powerful follow-up measures" in response.

The statement from the ministry came as the US and South Korea conduct aerial drills involving more than 200 warplanes, including their advanced F-35 fighter jets, as they step up their defense posture in the face of North Korea's increased weapons testing and growing nuclear threat.

North Korea has ramped up its weapons demonstrations to a record pace this year, launching more than 40 ballistic missiles, including developmental intercontinental ballistic missiles and an intermediate-range missile fired over Japan.

The North has punctuated those tests with an escalatory nuclear doctrine that authorizes preemptive nuclear attacks in loosely defined crisis situa-

North Korea has said its testing activities are meant as a warning amid the joint military drills. But some experts say Pyongyang has also used the drills as a chance to test new weapons systems, boost its nuclear capability and increase its leverage in future dealings with Washington and Seoul.

In comments attributed to an unidentified spokesperson, the North Korean Foreign Ministry statement said the military drills exposed the United States as the "chief culprit in destroying peace and security." It said the North was ready to take "all necessary measures" to defend against outside military

"If the US continuously persists in the grave military provocations, the DPRK will take into account more powerful follow-up measures," the spokesperson said, using North Korea's formal name, the Democratic People's Republic of Korea. The statement did not specify what those measures

## **UK Home Secretary** Suella under fire over migrant 'invasion' claim

UK Home Secretary Suella Braverman is under fire from the Opposition and refugee activists for classifying an increase in the number of refugees landing on the country's shores seeking asylum as an "invasion" by migrants on the

The Indian-origin Cabinet minister told Parliament on Monday evening that illegal migration to the country "is out of control" and that the asylum system is "broken", with the sheer numbers arriving via the English Channel in small boats making it impossible to provide accommodation for all.

Her statement followed a violent incident involving a petrol bomb attack at one of the migration centres on England's southern coast over the weekend. "The British people deserve to know which party is serious about stopping the invasion on our southern coast, and which party is not," Braverman told the House of Commons.

"Some 40,000 people have arrived on the south coast this year alone. For many of them, that was facilitated by criminal gangs; some of them are actual members of criminal gangs, so let us stop pretending that they are all refugees in distress. 

ST revenues registered the second highest collection ever at ₹1.52 lakh crore in October, reflecting pick up in economic activity in the festive

Goods and Services Tax (GST) collection had touched a record high of nearly ₹1.68 lakh crore in April. In September, it was ₹1.48 lakh

"The gross GST collected in the month of October 2022 is ₹1,51,718 crore, of which central GST is ₹26,039 crore, state GST is ₹33,396 crore, integrated GST is ₹81,778 crore (including ₹37,297 crore collected on import of goods) and cess is ₹10,505 crore (including Rs 825 crore collected on import of goods), which is second highest till date," an official statement said.

The total revenue of the Centre and the states after regular as well as adhoc settlements in the month of October 2022 is ₹74,665 crore for CGST and ₹77,279 crore for the

GST mop-up has been over ₹1.40 lakh crore for eight months in a row, while for two months it has crossed the  $\overline{1.50}$ 



During the month of September 2022, 8.3 crore eway bills were generated, which was significantly higher than 7.7 crore e-way bills generated in August 2022

ICRA chief economist Aditi Nayar said the sharp sequential pickup in the headline GST collections in October 2022 reflects a combination of quarter-end flows relating to the transactions in the previous month, as well as the surge in GST e-way bills ahead of a robust festive season.

"With the festive season in October 2022, the generation of GST e-way bills is expected to have remained high, which should bolster the GST collections in the month of November 2022," Nayar said.

ICRA expects the CGST collections to exceed the FY23 Budget Estimates by ₹1.3-1.4

N. A. Shah Associates Partner Indirect Tax Parag Mehta said October was also a month of festivals and holidays wherein people have splurged on real estate, vehicles, holidays and other necessities.

## Sensex rallies for 4th day, breaches 61,000-mark

Equity indices darted up for the fourth day running on Tuesday to close at over ninemonth highs, buoyed by positive macroeconomic data and a bullish trend overseas.

A recovering rupee and continuous foreign fund inflows added to the momentum, traders said.

The 30-share BSE Sensex climbed 374.76 points or 0.62 per cent to settle at 61,121.35 closing above the 61,000level for the first time since January 17 this year.

On similar lines, the broader NSE Nifty advanced 133.20 points or 0.74 per cent to end at 18,145.40.

NTPC was the top gainer among the Sensex constituents, spurting 5 per cent, followed by PowerGrid, Dr Reddy's, Infosys, TCS, UltraTech Cement, HCL Technologies, Sun Pharma and Asian Paints.

Only four stocks logged losses - Axis Bank, Maruti, Reliance Industries and Tata Steel, dropping as much as 3.76 per cent.

The bulls are driving the trend in the domestic market with backing from FIIs and the global markets. The PMI numbers show that manufacturing activity in India remained strong in October and that pricing pressures were kept in check as new orders and pro-



duction increased, albeit slow-

"Investors are keeping ar eye on the central banks' policy meetings for any indications of a slowdown in the pace of rate hikes," said Vinod Nair, Head of Research at Geojit Financial Services.

## India's gold demand hits pre-pandemic levels

Q3 demand up 14% to 192 tonnes: WGC

India's gold demand has reached pre-pandemic levels and has witnessed an annual growth of 14 per cent during the July-September quarter at 191.7 tonnes mainly driven by strong consumer interest, according to a World Gold Council (WGC) report.

According to the 'Gold Demand Trends Q3 2022' report by WGC, the total demand stood at 168 tonnes during the July-September quarter of 2021.

In value terms, gold demand grew by 19 per cent to ₹85,010 crores during the third quarter of 2022, compared to ₹71,630 crores in the corresponding period of 2021.

India's total gold demand in the third quarter of 2022 at 191.7 tonnes is a 14 per cent increase over last year, which reflects better-than-expected performance and strong consumer interest, helping year-todate demand return to pre-Covid levels, Somasundaram PR, Regional CEO, India, World Gold Council told PTI.

Meanwhile, total jewellery demand in India during the third quarter increased by 17 per cent at 146.2 tonnes, compared to 125.1 tonnes in the

Value-wise jewellery demand was up by 22 per cent at ₹64,860 crore during the quarter under review, from ₹53,330 crore in July-September 2021.

"Credit expansion added impetus to this demand, with bank loan growth touching a nine-year high by quarter-end. Recovery in gold jewellery demand was primarily driven by urban India, more specifically southern parts, underpinned by robust economic activities with a 17 per cent yo-y increase in tonnage terms," Somasundaram noted.

#### Power consumption grows marginally to 114.64 bln units in October

**▼**ndia's power consumption grew 1.64 per cent to 114.64 billion units in October compared to the year-ago period, according to government data.

The power consumption rose only marginally in October, mainly due to incessant unseasonal rains which kept the mercury levels low and reduced the use of cooling appliances.

However, experts said power consumption and demand will further increase in the coming months due to use of heating appliance especially in the northern part of the country, and improvement in economic activities on account of the beginning of the new rabi crop season. The farmers use electricity to run tubewells for irrigation for new crops. In October last year, power consumption was 112.79 Billion Units (BU), higher than 109.17 BU in the same month of 2020, the data from the power ministry showed.



### Govt's paddy procurement up 12% at 170.53 lakh tonnes till October

The government's paddy I procurement for the central pool rose 12 per cent to 170.53 lakh tonnes till October of the ongoing 2022-23 kharif marketing season, according to the food ministry data.

Higher quantities of paddy were purchased from Punjab, Haryana and Tamil Nadu.

Normally, paddy procurement begins immediately after the withdrawal of the Southwest monsoon from October onwards. However in southern states, especially in Kerala and Tamil Nadu, it begins from September.

The government aims to procure 771.25 lakh tonnes of marketing season (October-September). The actual procurement stood at record 759.32 lakh tonnes in the previous kharif marketing sea-



According to the official data, the overall paddy buying has increased to 170.53 lakh tonnes till October 31 of the 2022-23 kharif marketing seathe year-ago period.

Out of the total, about 107.24 lakh tonnes of paddy has been purchased from Punjab till October-end compared to 99.12 lakh tonnes in the year-ago period. From Haryana, 52.26 lakh tonnes were bought as against 48.27 lakh tonnes in the same period a year ago.



Rishabh Pant's flair and chutzpah at the top might be in demand but India could still persist with an out-of-form KL Rahul when it takes on a relatively weaker Bangladesh in the T20 World Cup, here on Wednesday.

Matches against Bangladesh across formats are always like a proverbial banana peel where slipping remains a possibility but India would certainly start favourite in their penultimate Super 12

The rude jolt the famed Indian batting line-up got on the paciest of tracks in Perth would have left the coaching staff, especially coach Rahul Dravid, pondering a few points.

The 22 runs in three matches with flop show against big teams like Pakistan and South Africa has once again raised questions about KL Rahul's big-match temperament and technique against quality

However, KL Rahul might continue as opener as Dravid has unshakeable faith in the fellow Bengaluru player's ability.

Bangladesh, not the most decorated of T20 sides in this competition due to their mediocre bowling attack, might just be the ideal opposition for Rahul to gain

The attack comprising Mustafizur Rahaman, Taskin Ahmed, Mehidy Hasan Miraj, skipper Shakib al Hasan and Hasan Mahmud is decent but certainly not world class by any standards.

Suryakumar Yadav and Virat Kohli have already played brilliant knocks while Rohit Sharma looked good in his fifty against the Netherlands.

However, Pant's exclusion from the playing XI is pretty baffling as he and Suryakumar Yadav bring that x-factor in the batting line-up.

Dinesh Karthik's back spasms issue might just be a blessing in disguise for the Indian team. It may open up the opportunity for Pant's inclusion in the playing XI for the Bangladesh game.

Bangladesh have four left-handers in their batting line-up, including skipper Shakib, openers Soumya Sarkar and Najmul Hossain Shanto and middleorder batter Afif Hossain Dhrubo and it will be interesting to see if India continue with Ravichandran Ashwin, who was mauled by David Miller in the previous game, or play Axar Patel.

India's attack may not struggle much in dealing with Bangladesh as the troika of Bhuvneshwar Kumar, Arshdeep Singh



and Mohammed Shami holds a distinct edge over rival side's batting line-up.

A few numbers would corroborate how Bangladesh's batters have struggled in this tournament. Out of the two games they have won, one was a thriller against Zimbabwe while they played a close game against the Netherlands.

Despite facing minnows, Shakib's batters have struggled on bowler-friendly Australian pitches.

After three games, opener Shanto is the only batter to have aggregated more than 100 runs and that too at a strike-rate of 125 which isn't commendable at all for

The second highest run getter is Afif, the middle-order enforcer. A lot will depend on how Afif and Mosaddek Hossain bat towards the back-end but against an Indian attack of this quality, they will be under pressure.

The team that opts to bowl first might make the best use of the famous Adelaide evening twilight when the ball swings a wee bit more than usual. With three potent swing bowlers, it

won't be a bad idea if Rohit Sharma opts to bowls first and try to restrict Bangladesh to a low score. For Bangladesh, the sharp slump in their only world class player Shakib's form

is the reason that they aren't considered a threat for quality teams. Shakib, who has had his run-ins with the BCB even during the ongoing World Cup, isn't in the best frame of mind and the deterioration in his batting is difficult

He is still bowling some restrictive leftarm spin but the bite is no more there and hence it could just be meat and drink for the Indian batters during their duel with the Bangladesh captain.
