# Shraddha's 13 body parts found: Police

Victim's father seeks death for Aftab for 'love jehad'

STAFF REPORTER NEW DELH

A mid public scrutiny of the Shraddha murder case, the Delhi Police on Tuesday went about recreating the crime scene and dozens of cops spent nearly three hours combing the forest areas in South Delhi's Chhatarpur.

The police teams collected 13 body parts of the 35 pieces of victim Shraddha Walkar on the basis of information provided by his killer live-in part ner Aftab Ameen Poonawala. The murder weapon is still missing. The case is likely to be transferred to the crime

According to the police, the body parts recovered on Tuesday from different areas will be sent for DNA analysis. If remains are confirmed to be of a human, they would be matched with the DNA of the father of the victim.

The CBI's forensic team too reached Delhi's Mehrauli police station to examine the fridge, where the victim's body pieces were stored.

Head of the Department of Crime Scene Management at FSL Rohini Sanjeev Gupta said a two-member team of experts on Saturday visited the scene of crime and collected at least seven-eight bone pieces along

"We want to access his account to analyse his profile and know how many women he was in contact with and ood stains. screen the chats to understand his psyche. Based on the pro-

file analysis we will also be approaching those people with whom he was in contact with and inviting them to the same residence where he had killed the woman," a police official

Aftab and Shraddha met on the dating app "Bumble" while both were working in Mumbai. It is reliably learned that Aftab was dating other girls on the dating app Bumble and at least one of them visited him in his residence in Mehrauli, Delhi, when Shraddha's body parts were in

the fridge.

#### Killer got 'knife' wound treated in May, he was aggressive: Doc

**STAFF REPORTER** NEW DELHI

A doctor who treated Aftab Poonawala, the accused of the gruesome murder of his live-in partner Shraddha Walkar, revealed that the accused had visited him in May, the same month he had chopped the woman in 35 parts, for treatment of a wound and he was confident but also very arrogant and aggressive

during his treatment.

Dr Anil Kumar Singh revealed that the accused showed up at the hospital with a wound on his right forearm that he claimed was from a knife while cutting fruits.

Further during the conversation, he revealed that he was able to identify the accused after coming across the news of Shraddha's murder. Notably Dr Singh was the one who identified the accused when the Delhi Police approached him for questioning. In May, he (Aftab) came

in the morning hours. My assistant told me that one person has come with an injury. When I saw him, I found it was not a deep injury but a superficial one. The underlying structure was intact. When asked him how he sustained this injury, he replied he cut himself while he was cutting fruits," the doctor said.

# Modi advocates Ukraine war ceasefire, nonstop fuel supply

With the Ukraine conflict unraveling tales of horror and triggering economic crisis across the globe, Prime Minister Narendra Modi on Tuesday advocated a return to the path of "ceasefire and diplomacy" to resolve the war.

He also opposed any restrictions on the supply of energy amid the West's call against procurement of discounted Russian oil and gas. India is a major importer of Russian oil.

Stressing upon the issue of unhindered fuel supply, the Prime Minister said Índia's energy-security is also important for global growth as it is the "world's fastest growing economy".

Addressing the G-20 summit session on food and energy security at Bali, Modi said, "We must not promote any restrictions on the supply of energy and stability in the energy market should be never at ""

Modi made these observations in the presence of top G-20 leaders, including US President Joe Biden and UK Prime Minister Rishi Sunak. Russian Foreign Minister Sergey Lavrov also attended the summit representing President Vladimir Putin.

Expressing concern over the raging conflict, the PM said climate change, the Covid-19 pandemic, the developments in Ukraine and the global problems associated with it have caused havoc in the world and lamented that the global supply chains are in "ruins".

Referring to India's upcoming G-20 presidency, Modi

said he was confident when the leaders of the grouping meet in the "holy land of Buddha and Gandhi, we will all agree to convey a strong message of peace to the world."

Participating in the session on food and energy security, the Prime Minister highlighted the implications of global problems and said there is a crisis of essentials and essential goods all over the world and that the challenge for the poor citizens of every country is "more severe" today.

Modi's call for not putting any restrictions on energy supplies came amid the West's call against procurement of Russian oil and gas in view of Moscow's invasion of Ukraine.

# India climbs two spots to rank 8th in climate goals

Indicating that India's green Imeasures like cutting on emissions and the increasing use of renewable energy are delivering results, a new study has noted that the developing nation climbed two spots to rank eighth out of 63 in the Climate Change Performance Index (CCPI) 2023.

India also earned a high rating in the GHG Emissions and Energy Use categories, while it got a medium rating in Climate Policy and Renewable Energy sections, as per the report prepared by three environmental non-governmental organisations that track climate performance of the European Union and 59 countries, which together account for over 92 per cent of the greenhouse gas (GHG) emis-



sions in the world

The rankings by German watch, New Climate Institute and the Climate Action Network are based on how well the countries are doing to halve their emissions by 2030 — an essential aspect to keep the 1.5-degree Celsius goal within reach and prevent dangerous climate change.
The CCPI, which has been

published since 2005, aims to enhance transparency in international climate politics and it enables comparison of individual countries' climate protection efforts and progress.

The report leaves the first three places empty as "no country performed well enough in all index categories to achieve an overall very high rating". It puts Denmark in fourth place, followed by Sweden and Chile.

China, which is the world's biggest polluter now, fell 13 places to 51st in this year's CCPI and received an overall very-low rating due to plans for

new coal-fired power plants.
The US rose by three ranks to the 52nd place. Iran (63rd), Saudi Arabia (62nd) and Kazakhstan (61st) fared the worst. The report said India is "on track" to meet its 2030 emissions targets, compatible with a well-below 2-degree-Celsius scenario.

The Gujarat High Court on Tuesday heard a suo motu PIL on Morbi bridge tragedy and asked the State Government as to how no expression of interest was tendered, and how the "largesse of the state" was given to an individual without floating a ten-

The collapse of the Britishera suspension bridge on the Machchhu river in Gujarat's Morbi district on October 30 claimed 135 lives, including women and children.

Hearing the suo motu PIL, the high court wanted to know from the State Government as to whether a 2008 MoU and 2022 agreement with the Ajanta Manufacturing Private Ltd (Oreva Group) imposed any conditions regarding fitness certification and if so, who was the competent authority required to do so.

"This agreement is one-

# Why Morbi bridge contract | World Cup marks Qatar's feat to shed shadow of turmoil

Hosting the World Cup marks a pinnacle in Qatar's efforts to rise out of the shadow of its larger neighbours in the wider West Asia, where its politics and its upstart ambitions have brought both international attention and region-

The road to the tourna-

ment — and Qatar's increased prominence on the global stage - has been fuelled by the country becoming one of the top exporters of natural gas. That newfound wealth built the stadiums that fans will fill for the tournament, creat-

ed the Arab world's most recognised news network, Al Jazeera, and enabled Doha's diplomatic outreach to the wider world. But that rise has not been

without intrigue. A palace coup in 1995 installed a more assertive ruler in the country, who used Qatar's wealth to



back the Islamists who emerged stronger amid the 2011 Arab Spring protests the same figures his fellow Gulf Arab leaders viewed as threats to their rule.

A yearslong boycott of Qatar by four Arab nations that began in 2017 nearly sparked

And while the overt tensions have eased in the region, Qatar likely hopes the World Cup will serve to boost its standing as it balances its relations abroad to hedge against any danger to the country in

the future.
"They know there are these potential threats; they know they are very vulnerable," said Gerd Nonneman, a professor of international relations and Gulf Arab studies at Georgetown University in Qatar.

"Anything they can do to have an international network of if not allies, at least a sympathetic element, they will."

Qatar, a little larger than Jamaica or just smaller than the US State of Connecticut, is a peninsular nation that sticks out into the Persian Gulf like a thumb. It shares 60-kilometres border with Saudi Arabia, a nation 185 times larger, and sits

just across the Gulf from Iran. Through its sovereign wealth fund, Qatar owns London's famed Harrods department store, Paris Saint-Germain soccer club and billions of dollars in real estate in New York City



# **Army grapples with task of** logistics for jawans in winter

head of the 17th round of Atalks between India and China, aimed at breaking the ice to ensure withdrawal of troops from the two left over friction points at Demchok and Depsang in eastern Ladakh sector, senior army officers deployed in the cold desert region have been grappling with the challenge of organising logistics for every foot soldier for the long winter season

Maintaining supply lines and ensuring logistics support to over 50,000 troops is going to be a herculean task for the third consecutive year. The two sides have been locked in the military standoff on the Line of Actual Control (LAC) since May 2020.

On the ground the troops of the Indian army are racing against time to further beef up their defences as the harsh winter season has already set in the high altitude region.

So far talks at the diplomatic and military levels have vielded positive results and led to de-escalation of tensions following clashes at the Galwan



valley. At the same time the tough posturing by both the sides have so far prevented the complete withdrawal of troops to their pre April 2020 status.

Referring to the prevailing security situation on ground zero in the cold desert region of Eastern Ladakh the Indian army Chief General Manoj Pande Saturday maintained the situation in eastern Ladakh is "stable but unpredictable". Gen Pande was speaking at an event 'Chanakya Dialogues' in

On the ground the Indian army is fully geared up to tackle the chilly weather conditions.

The troops deployed at the forward locations and high altitude posts have been adequately stuffed with winter clothing to ensure their good health in sub zero weather conditions.

#### **Defences being** strengthened amid tensions in Ladakh

Tn an effort to maintain **⊥** operational readiness in the backdrop of tension at the border in Ladakh, the Army is further strengthening its defences there by planning to build fortified bunkers, observation posts and forward ammunition depots. These steps will ensure safety to frontline troops and maintain unhindered supply of weapons and ammunition.

Some of the main features of the infrastructure projects include 3-D printed permanent defences that can withstand a direct fire by a T-90 tank from mere 100 metres, sources said here on Tuesday.

Moreover, modern and state-of-the-art habitat and technical storage have been constructed in Eastern Ladakh in the last two years to cater to 22,000 troops besides approximately 450 tanks,

armoured personnel carriers and guns. These are movable habitats, many of which have also come up as high as 18,000

The stress is now on construction of permanent defence structures to ensure preparedness. These defences are 3D printed and have undergone various trials, sources said.

They said the product has been made by start-ups of exstudents under the guidance of IIT, Gandhinagar. These defences will come up along Control(LAC)facing China. The nearly 4,000 km long LAC stretches from Ladakh in the west to Arunachal Pradesh in the east.

The project is set to take off next year once the winter subsides, sources said, adding the maximum weight of each part is 40 kg and that a team of two to three soldiers could set it up easily.

### Modi interacts with Indian Diaspora on sidelines of G-20 summit in Bali

Prime Minister Narendra Modi on November 15 asserted that there is a huge difference between pre-2014 and post-2014 India, saying the country is now moving ahead at an "unprecedented speed and scale" as he underlined that it is now the fastest growing large economy and ranked first in several sectors.

The Prime Minister also played the drums as he arrived to interact with the members of the Indian diaspora in Indonesia on the sidelines of the G20 summit.

Amid cheers and slogans of 'Bharat Mata ki Jai', a huge crowd of people dressed in Indian attire and turbans greeted Prime Minister Modi with folded hands as he arrived at the venue to interact with the Indian community.

Modi joined in the festivities and played the drums for a few beats alongside the drum-

Addressing the diaspora, Modi said India is a ray of hope for the world in the 21st cen-

"Today, India is the fastest growing large economy in the

world," Modi said amid a huge round of applause.

The Prime Minister said that India is number one today in digital transactions, global fintech, IT outsourcing, smartphone data consumption and vaccine manufacturing.

And this has become possible because "today's India doesn't think small. Today India is going ahead at unprecedented scale and speed", he said.

"We don't dream small anymore. Since 2014, we have opened more than 320 million bank accounts. More than the population of USA," he said. Modi said Indonesia was

fortunate to attain independence two years before India and there is a lot that India can learn from Indonesia. He said India has stood

firmly with Indonesia during its "challenging times", while acknowledging the shared shared heritage and culture between the two countries.

Modi recalled the devastating 2018 earthquake in Indonesia and New Delhi launching the massive operation 'Operation Samudra Maitri' for humanitarian assis-

"However, the renewable energy pathway is not on track for the 2030 target," it said.

Since the last CCPI, India has updated its Nationally Determined Contribution (NDC) and announced a netzero target for 2070. Net zero means achieving a balance between the greenhouse gases put into the atmosphere and those taken out.

The NDCs are national plans to limit global temperature rise to well below 2 degrees Celsius, preferably to 1.5 degrees Celsius in accordance with the Paris Agreement.

In August, India released its updated NDCs and now stands committed to reducing emissions intensity of its GDP by 45 per cent by 2030 from the 2005 level.

It aims to achieve about 50 per cent cumulative electric power installed capacity from non-fossil fuel-based energy resources by 2030. These NDCs are, however, contingent on delivery of finance and technology transfer.

Despite India's medium rating in the Renewable Energy category, the country has included renewable targets in its updated NDC.

# Delhi gearing up for G-20 Summit

Beautification work of 8-km stretch from Dhaula Kuan to IGIA to be ready by Nov-end

 $B^{\rm eautification\ work\ of\ an}_{\rm eight\ km\ stretch\ of\ road}$ from Dhaula Kuan to Indira Gandhi International Airport is expected to be completed by November end, ahead of the first visit by an official delegation associated with the G-20 Summit. India will assume the presidency of the influential group for a year from December 1, 2022 to November 30, 2023.

The makeover plan, that includes aesthetic upgrading of the stretch by way of uniform colour patterns on flyovers and Footover Bridges, horticultural overhaul through flowering plants to achieve a stepped three-coloured pattern, general cleanliness and symmetric installation of fountains and big lion statues, is almost complete.

The works completed so far include covering of open drains, overall sprucing up of the stretch by repairing the pavements, central verges and dividers, planting 30,000 seasonal flowers or plants and painting flyovers in a new red

The makeover and beautification works on the stretch of road from IGI Airport to Dhaula Kuan and beyond, on the Sardar Patel Marg, is being personally supervised on a weekly basis by Lieutenant-Governor VK Saxena, and the work is going on in earnest. It is expected to be completed by

the end of November, well in advance of the first visit by an official delegation related to the G-20 Summit on December 1," sources at Raj Niwas said.

This has been made possible by seamless coordination between L-G and various implementing agencies including the Municipal Corporation of Delhi (MCD), the Public Works Department (PWD), Delhi Development Authority (DDA), the Delhi Jal Board (DJB) and the New Delhi

District, apart from various corporate houses who have chipped in through their CSR funds," the sources added. ## Maid attacked by dog to get ₹2 lakh compensation

Consumer forum orders Gurugram civic body to cancel licences of owners of 11 foreign dog breeds

STAFF REPORTER

The District Consumer Dispute Redressal Forum on Tuesday ordered the Municipal Corporation of Gurugram (MCG) to give interim compensation of Rs 2 lakh to a woman who was injured after being attacked by a pet dog in August.

The forum also said if the MCG wants, this compensation amount can be recovered from the dog owner. On August 11, victim Munni, who works as a domestic help in the locality, was attacked by Vinit Chikara's dog while she was on her way to work with her sister-in-law.

She had suffered critical injuries on her head and face and was referred from the civil hospital in Gurugram to Delhi's Safdarjung Hospital. In the FIR registered at Civil Line police station, the dog's breed was

mentioned as 'Pitbull'. Later, the owner informed that the breed is a 'Dogo Argentino'. The forum directed the MCG to take the dog into custody and cancel Chikara's licence to own a dog with immediate effect. It also directed to ban 11 foreign breeds and instructed MCG to keep all strays in pounds after taking them into custody.

The forum also directed MCG to formulate a policy for pet dogs within three months. In the interest of justice an amount of Rs 2 lakh is ordered to be paid as compensation by way of interim relief by the MĆG to the victim who is stated to be a very poor lady doing the household works in the houses of others," the order read. "It is further made clear that the owner of the dog had blatantly violated the law of the land and rules for having kept

the banned breed of dog i.e. Dogo Argentino as a pet dog, so the MCG is put at liberty to recover the amount of Rs 2 lakh from the owner of the dog," it

Sandeep Saini, a lawyer had filed a complaint in the consumer court on behalf of the victim, under the Consumer Protection Act 2019, in which compensation of Rs 20 lakh was demanded and the MCG and dog owner Chikara

was made a party.
After hearing all the parties, the consumer court of Sanjeev Jindal on Tuesday issued orders to completely ban 11 dangerous breed dogs in the district along with an order to pay interim compensation to

"As per the notification of the Government of India dated 25.4.2016 the following pet dogs of foreign breeds are hereby completely banned with immediate effect: American Pit-bull terriers, Dogo Argentino, Rottweiler, Neapolitan mastiff, Boerboel, Presa Canario, Wolf dog, Bandog, American Bulldog, Fila Brasileiro and Cane Corso," the court order read.

# 2,585 nominations for civic body polls: SEC

The State Election (SEC) on Tuesday informed that a total of 2,585 nominations of 2021 candidates have been received for the forthcoming Municipal Corporation of Delhi (MCD)

"Papers of 20 were received from the All India Majlis-e-Ittehadul Muslimeen, while five candidates have applied for the nomination from the Communist Party of India (Marxist- Leninist)," they informed.

"From Indian Union Muslim League two people have applied for enrollment and the papers of 31 candidates were received from the Janata Dal (United)," they said.

"The nomination documents of one, four, and one candidate were received from the Lok Janshakti Party (Ram Vilas), Rashtriya Janata Dal, and Samajwadi Party respectively," they told. A total number of 507candidates filled their nomination on Monday to contest the forthcoming civic elections independently, taking the tally to 2012, said

## Issues in filling seats in science courses due to delay in DU admissions

 $S_{\rm es}$  eats in several science courses, especially in the South campus and off-campus colleges, remain vacant despite the Delhi University (DU) admission process reaching the third round of seat allocation. College principals attributed the vacancies to delays in the admission process. They also said science students have a wider choice as they can elect commerce courses as well.

The colleges expect some of the vacancies to be filled by the third round. The varsity declared the third list of seat allocation on Sunday and students can accept the seats allo-

cated by Tuesday.

At the end of the second round of allocations, over 61,500 students have taken admission to the university. In the third round, 16,231 seats for undergraduate programmes were allocated. As of 7 PM on ed the college and courses allotted to them.

At Deen Dayal Upadhyaya College, most seats in the commerce and arts departments have been filled with only one of two remaining vacant. However, vacancies in science courses are still in the double digits. Principal Hem Chand Jain told PTI that the college

had 912 sanctioned seats and 748 students had confirmed their admission by paying the

fees as of 3 pm. Seats in the commerce and arts departments have been filled already, Jain said. "We are facing problems in filling seats in science courses even in the third round. However, we are hopeful that the majority of seats will be filled in this

round," he said. For BSc (Hons) courses at Deen Dayal Upadhyaya College, 14 seats are vacant in Botany, 10 in Computer Science, 14 in Electronics, 19 in Eight and 12 seats are also vacant in Zoology and Life

Sciences, respectively. At off-campus Rajdhani College, the maximum vacancies are in Sanskrit and science courses, including Chemistry, Electronics, and Physics.

The college has 1,192 sanctioned seats and 900 have been filled by Monday night.

# **SC:** People holding public office should show some self-restraint

They must not blabber things disparaging or insulting to countrymen, observes top court

The Supreme Court on Tuesday observed that people holding public office should exercise self-restriction and not blabber things which are disparaging or insulting to other countrymen. And it reserved its judgment on whether restrictions can be imposed on a public functionary's right to freedom of speech and expression.

The top court said this approach is part of our constitutional culture and there is no need for it to formulate a code of conduct for public functionaries. A five-judge Constitution bench headed by



Justice SA Nazeer, which reserved its verdict on whether restrictions can be imposed on a public functionary's right to freedom of speech and expression, said there is always a civil remedy available to citizens on account of a public functionary making a speech that affects

The court noted that irrespective of what Article 19(2) may say, there is a constitutional culture in the country where there is an inherent limitation or a restriction on what people holding responsible positions say. Article 19 (2)

## India abstains from UNGA vote against Russia

Having, so far, refrained from criticising Russia for its military action in Ukraine, India has abstained from voting in the UN General Assembly on a draft resolution calling for Russia to be held accountable for violations of international law by its invasion of Ukraine and requiring Moscow to pay reparations to Kyiv for damages, loss and injury resulting from the war. The draft resolution,

'Furtherance of remedy and reparation for aggression against Ukraine', introduced by Ukraine was adopted late Monday in the 193-member UN General Assembly by a recorded vote of 94 in favour, 14 against and 73 abstentions, including by India, Bangladesh, Bhutan, Brazil, Egypt, Indonesia, Israel, Nepal, Pakistan, South Africa and Sri Lanka. Belarus, China, Cuba, North Korea, Iran, Russia and Syria voted against the resolu-

We need to avoid steps which preclude or endanger the possibility of dialogue and negotiations and from bringing this protracted conflict to an early end."

Reiterating Prime Minister Narendra Modi's assertion to Russian President Vladimir Putin that "this is not an era of war", Kamboj said, "With this firm resolve to strive for a peaceful solution through dialogue and diplomacy, India has decided to abstain on resolution."India has mostly abstained on resolutions related to Russia-Ukraine war in the UN, including in the Security Council, General Assembly and Human Rights Council.

#### MoRTH issues notification to simplify tourist permit regime

New Delhi: With an aim to further streamline and strengthen the tourist permit regime, the ministry of road transport and highways (MoRTH) has issued a draft notification to supersede the All India Tourist Vehicle (Authorisation or Permit) Rules, 2021. The proposed rules aim to simplify the pro-cedure for All India Permit applicants and to reduce compliance burden. The provision of authorization and All India Tourist Permit have been made independent of each other.

À senior MoRTH official said the move is expected to provide considerable financial relief to smaller tourist operators having smaller vehicles with lower seating capacity as they will now be required to pay lower fees commensurate with the seating capacity of their vehicle. According to an official statement from MoRTH the rules notified in 2021 provided a significant boost to the tourism sector in India by streamlining and simplifying the permit regime for

# Mining case: ED nixes Hemant Soren's plea to reschedule summons



Preparing growth charts will provide easy detection, they

Their observation at the webinar on 'Diabetes Free India' organized recently by the Associated Chambers of Commerce and Industry of India (ASSOCHAM) echoes in the finding of an international multi-center study which noted that during the Covid crisis, significantly more children and young people had already developed diabetic ketoacidosis (metabolic imbalances) when diagnosed with type 1 diabetes than in previous years.

The study is published in The Lancet Diabetes & Endocrinology. "If children and young people have already developed metabolic imbalances (diabetic ketoacidosis) at the time of diagnosis of type 1 diabetes (T1D), this can result in complications such as extended stays in hospital, poorer long-term control of blood sugar levels, brain edema,



young people aged between 6 months and 18 years old who were diagnosed with T1D between 1 January 2006 and 31 December 2021. The increase in the prevalence of Diabetic Ketoacidosis during the pandemic was greater than expect-

ens to be the home state of Prime Minister Narendra Modi. Former chief ministers of Madhya Pradesh, Digvijaya Singh and Kamal Nath, are also scheduled to campaign in Gujarat where state leaders have shouldered most of the campaign efforts so far. Kanhaiya Kumar, who joined the Congress last year, will also campaign for the party.

The list of star campaigners also features around 11 leaders from the state, includ-

ing Gujarat Pradesh Congress Committee (GPCC) president Jagdish Thakor and Leader of Opposition Sukhram Rathva. Chronically depressed girl student kills self in AMU hostel

Four other girl students also stay in the same room with her. According to the events, a program was organized in the college campus in which she was to participate. But she wrote an application for the warden/class teacher citing ill health and sought permission to go to JN Medical College.

On getting permission, she went back to the room and committed suicide. Her fellow students found her hanging when they returned.

# Shraddha redux: UP girl's chopped body found in well

Close on the heels of a sen-sational killing of a girl in the national Capital, a similar murder took place in Azamgarh where the body of the victim was recovered in several pieces on Tuesday morning. After brutally killing the girl and chopping her body into pieces, the killer dumped the body into a well.

The local police rushed to the spot along with senior officers and took out the body pieces and sent them for autopsy. Further investigations are being made to identify the victim and to arrest the killer.

The incident came to light when the people of the village came out of the village for their farming work. During this,



someone looked into a well at the roadside and saw the mutilated body of a young girl lying in it. The villagers informed the police about the incident. On getting information, the police rushed to the spot.

According to reports, some villagers in Gauri Ka Pura of Paschimpatti village in Azamgarh district reached the well on Tuesday morning and were shocked to see some pieces of a body inside the well. They immediately called the police who took out all the pieces and later suspected it to be a woman, probably in their

mid-twenties. The girl's head, arms and legs were chopped off. There were no clothes on the body of the deceased and it appeared that she was gangraped before being killed. A watch was also found in one of the hands of the girl. Station House Officer Yogendra Bahadur Singh said it appeared that the victim was killed two days ago but they were waiting for a post-mortem report besides trying to ascertain the identity of the

Meanwhile, a woman and her daughter were found murdered in their home in Ghazipur district. Both were probably killed some time on Sunday night and the victims were found dead on Monday

# **Perils of realpolitik**

By welcoming Rajiv's killers, Tamil Nadu politicians are playing a very dangerous game

Ravichandran and his thuggish LTTE cronies would like us believe that they were and are the champions of Tamils, if not the entire south India, but facts suggest otherwise. First, on May 21, 1991, it was not just Rajiv who was murdered but also over a dozen Tamils. Second, such was the revulsion against the LTTE-friendly DMK that in the Assembly polls next month, it was thoroughly trounced. The DMK-led alliance got just seven seats, whereas the coalition headed by the AIADMK and comprising the Congress got 225 out of 234 seats, the biggest electoral victory for an



alliance. It was not that the DMK was a small party; the DMK-led had won a landslide in 1989, the DMK alone winning 150 seats. And Ravichandran has the cheek to portray himself as a "victim." Yet, this should not surprise us. After all, Tamil Nadu Chief Minister MK Stalin welcomed the Supreme Court's decision to release the six convicts including Nalini Sriharan. He hailed the judgment as "a historic foreword to democratic principles.'

Stalin's reaction was in tune with his Government's and his party's pro-assassins stand. The DMK has long campaigned for the release of the killers. When one of them, AG Perarivalan, was released in May, Stalin felicitated him. It is disheart-

ening to know that the release of Rajiv Gandhi's was supported by all political parties, except the Congress and Bharatiya Janata Party, in Tamil Nadu. In fact, even the Gandhi family wanted to forgive the killers, but the grand old party as a whole didn't pay homage to cheap sentimentalism and opposed the release. One wonders what happened to the anti-LTTE mood in the State in the last 31 years. How did the pro-LTTE parties become popular in the State? The DMK and other TN parties might be accused of appealing to the basest instincts of the masses, but sadly they are not the only ones doing that. For instance, the BJP did not cover itself in glory when its leaders felicitated the released convicts of the Bilkis Bano rape and murder case. It is unfortunate that we don't see any red lines in the Indian political arena. Anything goes: murderers of a prime minister can be lauded; rapists and murders can be honoured. Over a period of time, politics and morality had become estranged with each other; now they have parted ways. The champions of realpolitik snigger at any mention of ethics in politics. They have a point: it is impossible for a practice politician to stick to their principles and beliefs all the time. But, at the same time, it is also harmful to banish all ideals and values from politics.

# peep in deep space

Human curiosity has no bonds, it leads to new discoveries enhancing understanding of universe

In a rare find and something thought of as near impossible, the scientists have been able to get a glance at a galaxy just behind ours. Scientists have discovered a huge "extragalactic structure" hidden behind the Milky Way known as the "zone of avoidance" (ZoA) because it is shadowed by our own galaxy's opaque bulge. The discovery has far-reaching implication in astronomical studies as it would help fill in this shadowy part of the cosmic map which have not been observed so far. Our galaxy, the Milky Way, is distributed inside a thin plane that circles around a central bulge that contains a supermassive black hole. The galactic plane has numerous constituents' including stars, dust, and gas that block our view. Though scientists have been able to peep through the zone of avoidance (ZoA), a region that obscures 10 to 20 percent of the sky, most of this region remains out of view. A team led by Daniela Galdeano, an astronomer at

> the National University of San Juan in Argentina, report the discovery of "a new galaxy cluster, behind the Milky Way bulge," which helps to complete "the picture of the large-scale structure in this still a little explored area of the sky."

> It is incredibly difficult to find galaxies behind the galactic plane, because of the high density of stars and also the obscuration by dust along the line of sight, and this looked like one of the most prominent candidates. One of the biggest implications of this finding is the possibility of not one or two but several galaxies being hidden behind dark spots The team estimated that the cluster contains about 58 galaxies, but it will take more observations to be sure of its mass and

contents. The discovery of this cluster offers an exciting glimpse behind the Milky Way, and scientists will need to continue pulling back this curtain to understand our place in space. It is indeed a great achievement that can open the door for several other related discoveries and enhance the knowledge of the universe and what is hidden behind it. But for that to happen large investments would have to be made in making finer equipment which often is not available. This is so true of our country where fundamental research is still in infancy. Scientists work hard to enhance human knowledge but their names seldom become popular. It is about time that we gives due respect and honour to scientists and researchers and make them role models along with the cinema and sports stars.

# Vintage Hawksley thriller arrives



Against the background of the war in Ukraine, a new thriller containing international geo-political tensions and intrigue

journalist can and often does become a person for all seasons: politician, diplomat, teacher, and of course a best-seller author of fact and fiction. Humphrey Hawksley — HH to some — is in that class. Besides he is a delightful person to know, a great raconteur.

What a cracker of a book-Ice Islands.

First, a disclaimer: Humphrev is a dear friend. But that notwithstanding, I have great respect for him as a reporter. His work as a BBC foreign correspondent has taken him all over the world with postings in Beijing, Hong Kong, Manila, Delhi, and Colombo. He has contributed to ABC, National Public Radio and other networks in the United States and global publication of his work includes the Financial Times, New York Times, Yale Global, Nikkei Asian Review, and others. So he's no stranger to superpower rivalry, intrigue, and backstabbing – he's reported on it extensively. Ice Islands may be fiction. But it has the hallmark of authenticity. The inside story of the Ukraine military campaign must have sub-plots inspired by his works.

Hawksley's protagonist is the hard-as-nails Rake Ozenna who comes from the Alaskan island of Little Diomede right on America's border with Russia. Little Diomede, I learnt, is a craggy, rough island with a population of around eighty Indigenous Alaskans living less than three miles across a narrow stretch of water from a Russian military base. Rake is a Major belonging to the Alaska National Guard. He is tasked with breaking into the Kato family, a Yakuza crime organization that is turning Japan against the United States. The weak link is Sara Kato, the family's rejected daughter, whom Rake plans to turn into an informant. He is to approach her at a peace conference on the Finnish Aland Islands in the Baltic Sea. As Rake flies in, assassins murder a delegate who turns out to be the secret son of the Russian presi-

implicated. Rake is ordered to get Sara out and keep her safe. The action moves from the Baltic Sea through Washington D.C. to Hokkaido in northern Japan against a broader context of the unresolved dispute between Russia and Japan over the Kuril Islands or Northern Territories.

Admiral uncle, Artyom Semenov, a specialist in submarine technology. Semenov is hoping to use Carrie to transfer some highly classified state secrets to the West. The operation is botched amid indications that the British embassy in Moscow has been compromised, leading to frantic efforts on Carrie's part to stay alive. Rake goes to her rescue.

## **FIRST COLUMN VILLAGES LACK SPORTS GROUNDS FOR GIRLS**

Gender bias is prevalent in remote villages of Uttarakhand

ot much attention is given here [Kapkot, Uttarakhand] to girls' participation in sports. There are many girls in the village, who can bring laurels to Uttarakhand in national and international tournaments if they are given the chances and facilities," said Mamta and Pooja, a duo from Dhurkot Village in Bageshwar district in

Lack of a proper playground with adequate facilities is a major problem in several places in Bageshwar. As a result, youth, especially girls, face a lot of difficulties in practicing and making their careers in sports. Moreover, even with the presence of a ground, girls are barred from using the ground, as playgrounds predominantly become spaces for boys in villages.

Dhurkot Village, which is situated on the banks of the river Saryu, is 25 kms from Bageshwar in Uttarakhand. The population of this village is about 5,000. But being in a hilly area, there is a lack of a playground in the village. Although it affects both boys and girls in developing their skills, boys have the option to travel and access a proper field, whereas girls are not allowed to travel far from their villages

"There is a ground available about three kms away from the village, where boys easily go to practice, but it is not easy for girls to go there every day. The locals do not take this issue very seriously," said Deepa Devi, an Asha worker from the village.

Echoing similar sentiments, Sita Devi, the village head, said, "The



absence of a playground in the village is a big drawback. It has the most negative effect on girls. Not only is their physical development curbed, but their talents are also suppressed. Despite taking this issue to the local administration several times, our effort has not been suc-

Although schools provide grounds for sports, girls are not encouraged to play or given sufficient time to hone their skills. "The only place where we can practice is our school. But even that right is not with us. We are given the chance to practice only one day prior to the tournaments, whereas boys practice for months," rued Prema Gariya, a 16-year-old girl from the village.

In India, 29 per cent of women take part in sports in comparison to 42 per cent men, according to a report. A little more than 33 per cent of respondents consider sports like boxing, kabaddi, and weightlifting inappropriate for girls and women. They believe sports are unsafe for girls and that women cannot play at all times. So far, the southern states of India, such as Maharashtra, Tamil Nadu, have shown the highest participation of women in sports and physical activ-

Supporting how women are restricted from playing due to gender inequality, Neelam Grundy, a social worker from Bageshwar, reflected on the effect it has on the holistic development of children. "Sports are imperative in building qualities like leadership, decision-making skills, and teamwork. But without any space to build these qualities or support from families, how can girls inculcate these qualities,' Neelam said

The notion that sports are more appropriate for men results in all the discrimination against girls. Although we have come a long way in terms of women's participation in sports globally, there is a need to focus on the remote villages where a horde of talents lies.

n 2016, the Government had put in place an institutionalised framework, the Monetary Policy Committee (MPC), to formulate monetary policy and determine the key interest rates. It mandated the Reserve Bank of India (RBI) to fix rates, especially the repo rate or RR (interest rate at which the RBI lends to banks), in such a manner as to maintain inflation—as represented by the consumer price index (CPI)—within the target range of 4 per cent (+/- 2 per cent) for a five-year period ending March 31, 2021 (the mandate has now been extended for further five years ending March 31, 2026).

In the case of a failure to maintain the inflation target for three consecutive quarters, the central bank, under section 45ZN of the RBI Act, is required to submit a report to the government explaining the reasons and spelling out the remedial actions it would be taking to check the price rise. For the first time ever, this situation has arisen during 2022 as the CPI has remained above the higher end of the range i.e. six per cent for three consecutive quarters beginning January 2022.

Inflation has a devastating effect on stakeholders across the board -- eroding the purchasing power, especially of the poor and unemployed; millions of depositors, particularly those who are totally dependent on interest income for their livelihood; increasing pressure on industries to grant wage hikes and the government whose budget is destabilized due to sharp increase in expenditure on welfare schemes such as fertilizer, food subsidies etc.

The CPI, which was well within the target of 4 per cent (+/- 2 per cent) until 2021, spurted in the beginning of 2022 and has ruled consistently above six per cent. It is supply-driven, being the result of geopolitical tension and disruption in global supply chains (caused primarily by the Ukraine War), and resultant steep increase in prices of commodities, most importantly food, fuel and fertilizers.

Broadly speaking, the RBI has three policy instruments in its armory to deal with inflation. First, it can increase RR. A hike in RR implies that the banks will have to pay a higher interest rate on the money they borrow from the RBI. This will force them to charge more from their customers if only to recover the higher cost of their iunas. Facea with nigher borrowing individuals, businesses/firms, etc., will borrow less from the banks, leading to contraction in demand.

Second, it can increase the cash reserve ratio (CRR). CRR is the percentage of a bank's total deposits that it needs to maintain with the RBI as liquid cash; the bank does not earn interest on this liquid cash, nor can it use this for investing and lending purposes. An increase in CRR produces a similar effect as a hike in RR by reducing the quantum of funds available for onward lending.

per cent of natural gas (NG), both being the basic ingredients for making a whole range of products viz. petrol, diesel, LPG, CNG, PNG, ATF, etc. A major disruption in supplies from the war region has led to their skyrocketing international prices impacting our import cost. The current NG price at over \$50 per million Btu and crude oil hovering around \$100 per barrel is five times the respective level prevailing in April 2020.

Another major source of inflation is food. The spurt in its price too has a lot to do with disruption in supplies caused primarily by seasonal factors (for instance, the impact on wheat crop during Rabi 2021-22 triggered by unusually high temperature). This is getting exacerbated by high diesel cost (also triggered by supply side factors) leading to higher cost of transportation. In such a scenario, measures on the demand side are of little help.

The central bank often talks of anchoring 'inflationary expectation' wnich it seeks to rein in by adoj ing a tight monetary policy. The underlying premise here is when prices rise, people think that more of it will come in future; so they tend to buy more than their current consumption/use for stocking. This inflates the demand thereby accentuating the price rise.

The assumption is far-fetched. Is it possible for a truck owner to stock diesel? Can a car owner buy petrol more than what the fuel tank can accommodate? The answer is a categorical 'no'. The situation in food is no different. No household can buy food in quantity more than its current requirement. Even if consumers were to go for stocking (theoretical), they would be doing so with their own surplus money; it would be too much to expect them to do it with funds borrowed from banks. So, the fact of credit availability being tight will have little relevance.

To conclude, in the present extraordinary times wherein inflation is driven primarily by supplyside factors, the RBI should avoid banking too much on monetary policy instruments. Yet, if it pursues this course, it could pose a serious risk to growth due to rise in lending rate, increase in EMIs of millions of borrowers and higher cost loans to industries especially

In the October 2022 meeting of the MPC, two members were against continuing with an aggressive policy stance. The RBI should go with their view, refrain from further increase in interest rates and ensure adequate liquidity in the system. At the same time, there should be greater focus on supply side management.

Already, the Modi Government has taken such measures as diversifying sources of supply (for instance, more oil from Russia), reduction in import duty on vegetable oils, and cut in central excise duty (CED) on petrol and diesel. More such measures are needed.

# Long Live the Liberal Order

#### No matter how chaotic the world today might look, the liberal world order is the only way forward

¬he recent meeting between US President Joe Biden and Chinese leader Xi Jinping on the sidelines of the G20 summit in Indonesia underscored the importance of the liberal international order. Both countries made a firm commitment to work together on a range of issues and emphasized the healthy spirit of competition. This development, apart from concurrent events, do indicate that although the liberal order appeared to be showing signs of fatigue, earlier this year, it has found relevance

once again. In February this year, when the world was slowly emerging from the horrors of Coronavirus and its ensuing global economic dis-



ruptions, the international interest with other allies. community found itself grappling with a monumental challenge. Russia's invasion of Ukraine with tacit support from China reignited a recurrent theme in the international relations discourse. And how can one forget China's spectacular failure and futile attempt to bully Taiwan after Nancy Pelosi's visit which raised global alarms

Then Xi Jinping's selfawarded third term as President added to the woes. In the G20 summit, China highlighted a range of issues, but stressed that Taiwan is the very bedrock of the bilateral ties between the US and China. America will take cognizance of China's

Proponents of the liberal order who frequently emphasise that the international regime is rule based found themselves in a

quandary. With Russia's special military operation in Ukraine, a euphemism for war, raised questions about the validity of the liberal order. Its theoretical underpinning was weakening. Russia may have ratcheted up tensions but its abil-

ity to do so for a prolonged period always had constraints. The Russian withdrawal from Kherson has been humiliating for Moscow. With Ukraine regaining lost territory, systematic weaknesses in Russia's purportedly expan-

come to light. Veiled threats of a 'nuclear option' are cowardly. Both the US and China understand this position but the latter has not mentioned it explicitly in the joint statement issued in Bali. Its internal working apparatus is opaque and human rights violations in Tibet, Hong Kong and Xinjiang are rampant. The issue of human rights was emphasized by the US in the G20. A country with blatant

ideals the world cherishes cannot fulfil the role of a true power. The image Beijing portrays is one of fear and tyranny; not respect and responsibility.

When Russia launched devastating strikes, the realists, who argued that nation states are in constant struggle with each other to defend their own economic interests, found themselves in a comfortable position to spearhead their arguments. They felt emboldened. Many nations found themselves in a veritable dilemma. Who should they side with? Should economic interest like energy, which Russia produces in colossal amounts, take the backseat?

There is also no need for

have our own independent foreign policy which is tailored to the needs and aspirations of a burgeoning economy. But will the prominence of Russia fade in India's calibrated decisions? It does seem plausible.

For now, it is safe to assume that the recent overreactions to global events in no-way undermine the legitimacy of the liberal order. But if history is an indicator, international relations have always been fraught with surprises. They have always been chequered. The lingering debate between those who espouse a liberal order and the ones who call the international environment anarchic seems to be favouring the former; at least for now.

## Strike on Kyiv as Ukraine probes reports of Russian torture

Strikes hit residential buildings in the heart of Ukraine's capital on Tuesday, authorities said.

Further south, officials announced probes of alleged Russian abuses in the newly retaken city of Kherson, including torture sites and enforced disappearances and detentions.

Video published by a presidential aide showed a fivestory, apparently residential building on fire in Kyiv. The city mayor said three residential buildings were struck and that air defence units shot down other missiles. Vitali Klitschko added on his Telegram social media channel that medics and rescuers are being scrambled to the sites of the attacks.

The strikes followed air raid sirens in the capital and break what had been a period of comparative calm since previous waves of drone and missile attacks several weeks ago.



The strikes also follow what have been days of euphoria in Ukraine sparked by the retaking of Kherson. The southern city, however, is without power and water and the head of the UN human rights office's monitoring mission in Ukraine, Matilda Bogner, on Tuesday decried a "dire humanitarian situation"

Reports of abuses are also emerging in newly liberated Kherson areas now that Russian troops have gone. Speaking from Kyiv, Bogner

said her teams are looking to travel to Kherson to try to verify allegations of nearly 80 cases of enforced disappearances and arbitrary detention it has turned up in the area and "understand whether the scale is in fact larger than what we have documented already".

The head of the National

Police of Ukraine, Igor Klymenko, said authorities are to start investigating reports from Kherson residents that Russian forces set up at least three alleged torture sites in now-liberated parts of the wider Kherson region and that "our people may have been detained and tortured there". "Mine clearance is currently underway. After that, I think, today, investigative actions will begin," he said on Ukrainian TV.



#### Zelenskyy: Battle for Kherson was D-Day-like watershed

Ukrainian President Volodymyr Zelenskyy on Tuesday likened the recapture of the southern city of Kherson to the Allied landings in France on D-Day in World War II, saying both were watersheds on the road to eventual victory.

Ukrainian police, meanwhile, announced plans to investigate alleged Russian torture sites in now-retaken areas, and UN investigators said they'll look into enforced disappearances and deten-

Speaking via video link to a Group of 20 summit in Indonesia, Zelenskyy said Kherson's liberation from eight months of Russian occupation was "reminiscent of nany battles in which became turning points in the wars"

"It's like, for example, D-Day — the landing of the Allies in Normandy. It was not yet a final point in the fight against evil, but it already determined the entire further course of events. This is exactly what we are feeling now," he said.

The retaking of Kherson was one of Ukraine's biggest successes in the nearly 9month-old Russian invasion and dealt another stinging blow to the Kremlin.

## Russian airstrikes reported in cities across Ukraine

Uted waves of Russian airstrikes across the country on Tuesday, from east to west, including attacks in Kyiv that struck residential buildings and, elsewhere, attacks on energy facilities that knocked out power.

The barrage of strikes came as air raid alerts were issued across Ukraine. They followed what have been days of euphoria in Ukraine after one of its biggest military successes so far of the nearly nine-month Russian invasion — the retaking last week of the southern city of Kherson. As its battlefield losses

months increasingly resorted to targeting Ukraine's power grid, seemingly hoping to turn the approach of winter into a weapon by leaving people in the cold and dark. Among regions where offi-

cials reported strikes were Lviv, Zhytomyr, Khmelnytskyi and Rivne in the west, and Kharkiv, Ukraine's second largest city in the northeast.

Several missile strikes also hit Kryvyi Rih, President Volodymyr Zelenskyy's native city, according to its mayor, Oleksandr Vilkul.

# **GOP** on cusp of retaking House control with slim majority

Republicans were on the cusp of retaking control of the House late Monday, just one victory shy of the 218 seats the party needs to secure a majority, narrowing the path for Democrats to keep the cham-ber and raising the prospect of a divided gov-ernment in Washington.

Democrats have already won control of the Senate, securing 50 seats with a runoff in Georgia next month that could give President Joe Biden's party an additional seat. The GOP came into the election needing to gain a net of just five seats for House control. Nearly a week after the midterm elections, Republicans were closing in on the majority, giving conservatives leverage to blunt Biden's agenda and spur a flurry of investigations. But a slim numerical advantage will pose immediate challenges for GOP leaders and complicate the party's ability to

The full scope of the party's majority may not be clear for several more days - or weeks — as votes in competitive races are still being counted. Still, the party was on track to achieve 218 with seats in California and other states still too early to call.



Even barely achieving 218, though, means Republicans will likely have the narrowest majority of the 21st century. It could rival 2001, when Republicans had just a nineseat majority, 221-212 with two independents. That's far short of the sweeping victory Republicans predicted going into this year's midterm elections, when the party hoped to reset the agenda on Capitol Hill by capitalizing on economic challenges and Biden's lagging popularity.

Instead, Democrats were able to large ly blunt an expected big GOP election, holding on to moderate, suburban districts from Virginia to Minnesota and Kansas. The results could complicate House GOP leader Kevin McCarthy's plans to become speaker as some conservative members have questioned whether to back him or have imposed conditions for their support.

#### Trump prepares to launch third campaign for White House

Former President Donald Trump is preparing to launch his third campaign for the White House on Tuesday, looking to move on from disappointing midterm defeats and defy history amid signs that his

grip on the Republican Party is waning.
Trump had hoped to use the GOP's expected gains in last week's elections as a springboard to vault himself to his party's nomination by locking in early support to keep potential challengers at bay.

Instead, he now finds himself being blamed for backing a series of losing candidates after disappointing results in which Democrats retained control of the Senate and House control remains too early to call.

Hopefully, tomorrow will turn out to be one of the most important days in the history of our Country!" Trump wrote on his social media network on Monday.

#### Afghanistan regrets deadly border shooting incident: Taliban

**AP** ■ ISLAMABAD

 $T \\ \text{aliban expressed regret on} \\ \text{Tuesday for a shooting incident that killed a Pakistani sol-} \\$ dier over the weekend and led to the closure of a main border crossing. Chaman, in Pakistan's southwestern Baluchistan province, is the most important border point for trade between

the two countries.

Taliban-appointed spokesman Zabihullah Mujahid said Afghanistan "expresses regret" for the incident and has appointed a high-level committee to investigate it. He said the border guard was shot dead by an unknown person.

"The security institutions of the Islamic Emirate are trying to pay serious attention to prevent such incidents from happening again," Mujahid said. The frontier between Pakistan and Afghanistan has seen similar shooting incidents before at Chaman, Torkham and other crossing points.

### Amid tensions with China, Taiwan shows off military drones

**AP** ■ TAICHUNG (TAIWAN)

Taiwan displayed its self-developed drone technology Tuesday, amid rising concerns over China's threats to use force to assert its claim to the self-governing island republic. The National Chung-Shan

Institute of Science and Technology, which develops military technology, offered a rare look at the Jian Xiang drone designed to destroy enemy radars, and other unmanned combat aerial vehicles. A dozen of the single-use drones, officially termed loitering munitions, are carried on a truck. Launched with a built-in rocket, they are guided by a propeller engine before crashing

into their targets. Any country that is "confident in itself" will come up with strategies and develop defense technologies, said Chi Li-ping, director of the institute's Aeronautical System Research



Unmanned combat aerial vehicles are "a future trend", Chi said. "This is why we are doing research about it and laying out some strategies."

Taiwan's army began taking delivery last month of the first of 100 helicopter drones ordered from the institute. Chi emphasised their importance in relaying images to the army's command and communication systems for analysis and forwarding to combat units. Taiwan has also developed the Teng Yun, which resembles the American MQ-9 Reaper unmanned aerial vehicle and can stay aloft for up to 24 hours.



B'desh issues directives to navigate through challenges next yr

IANS DHAKA

A mid an ongoing economic crisis, the Bangladesh cabinet has issued half a dozen directives for the country to navigate through the domestic and external challenges posing serious threats to the macroeconomic stability next year.

After a cabinet meeting on Monday with Prime Minister Sheikh Hasina, Cabinet Secretary Khandker Anwarul Islam told journalists that the directives include on relaxation of taxes on food imports, augmenting food production domestically and sending more skilled månpower abroad, reports Xinhua news agency.

The meeting instructed relevant authorities to ensure more inflow of foreign direct investment as well as remittances.

Maintaining adequate food storage ahead of 2023 was the other very important directive from the cabinet meeting, said Anwarul Islam.

After reviewing the international situation, according to the official, the cabinet said that 2023 is very likely to be a critical year because of interest rate hikes by the US Federal Reserve, the Russia-Ukraine war and the slump in food production in parts of the world.

## Nepalese parties fail to meet women quota in elections

Although the Constitution of Nepal guarantees a 33 per cent representation of women in all three tiers of the government, no political party has fulfilled that criteria while fielding candidates for the November 20 general elections.

The mandatory constitutional provision however is honoured while picking up names under the proportionate representation system.

As women are heavily under-represented in all political bodies in Nepal, the Constitution, which came into effect in 2015, made a mandatory provision of providing adequate representation to them through this fast-track formula, pointed out constitutional expert Dinesh Tripathi.

Among the major political parties, the CPN-Maoist Centre has offered the highest number of tickets to women candidates contesting for the House of Representatives (HoR), the percentage of which comes to around 28 per cent, close to the mandatory 33 per cent mark,



ointed out Sunil Manandhar, Politburo member of CPN-Maoist Centre.

"Apple's iPhone is now getting made in India and it's the biggest plant in India is being set up at Hosur near Bengaluru. 60,000 people work in a single factory. The first 6,000 employees of these 60,000 employees are our tribal sisters from places nearby Ranchi and Hazaribagh. Tribal sisters have been trained to make Apple iPhone," the minister said.

Apple has outsourced the manufacturing of iPhone enclosures to Tata Electronics, which has a plant at Hosur.

The company gets iPhones manufactured by electronics giants - Foxconn, Wistron and Pegatron in India.


## Mining industry seeks regulatory flexibility to increase contribution to GDP

The mining industry seeks flexibility in the regulations if India aims for a high contribution from this sector to its growth trajectory, a senior official from Vedanta said.

#### **Exports decline** sharply by 17% to \$ 29.78 bn in **October**; trade deficit widens to \$ 26.91 bn

India's exports entered negative territory after a gap of about two years, declining sharply by 16.65 per cent to USD 29.78 billion in October, mainly due to global demand slowdown, even as trade deficit widened to USD 26.91 billion, according to data released by the commerce ministry on Tuesday.

Key export sectors, including gems and jewellery, engineering, petroleum products, ready-made garments of all textiles, chemicals, pharma, marine products, and leather, recorded negative growth during October.

Imports during the month under review rose by about 6 per cent to USD 56.69 billion on account of increase in the inbound shipments of crude oil and certain raw materials such as cotton, fertiliser and machinery. During April-October 2022, exports recorded a growth of 12.55 per cent to USD 263.35 billion. Imports rose 33.12 per cent to USD

The Ministry of Power (MoP) has written to all the State elec-L tricity regulatory Commission on non-compliance of the provisions of the Electricity Act, Tariff Policy and directions of Appellate Tribunal for electricity (APTEL) and Supreme Court on the issue of on non-cost reflective tariffs and liquidation of

the regulatory assets. As per the Electricity Act, 2003 and the Revised Tariff Policy, 2016, the tariff is required to be cost reflective. It mandates that Regulatory Assets (RA) shall not be created and where it has been created, a trajectory has to be laid down for recovery thereof, along with carrying costs within a specified period.

The letter cites the APTEL order directing the State Commissions that in determination of ARR/tariff, no revenue gaps are to be left and Regulatory Asset(s) should not be created and where it has been created, the recovery of the Regulatory Assets should be a time bound one and within a period not exceeding three years at the most and preferably within the Control Period

Carrying cost of the Regulatory Asset(s) should be allowed to the utilities in the ARR of the year in which the Regulatory Asset(s) are created to avoid problems of cash flow to the distribution licensee.

Recently, the Supreme Court upheld the above directions of APTEL by dismissing a batch of civil appeals filed by the DERC and observed that the appellant has to comply with the directions issued by the Appellate Authority, namely, Appellate Tribunal

This year's championship was overshadowed by nine-time Australian Open champion Djokovic being put on a plane on the eve of the contest after a highstakes legal battle over his visa sta-

Djokovic's three-year ban can be overturned at the discretion of Prime Minister Anthony Albanese's centre-left government, which is different to the conservative coalition in power when he was kicked out.

Over the past month there have been hints that the Australian government might have a change

"Nothing official yet," Djokovic



told reporters after winning his opening match at the ATP Finals in Turin on Monday night.

"We are waiting. They are communicating with the govern-ment of Australia. That's all I can tell you for now."

**'LOVE TO COME BACK'** 

Last month, Australian Open chief Craig Tiley said he had spent time with Djokovic recently and the Serbian wanted to return for the first major of the year in January in Melbourne.

"What we're saying at this point is that Novak and the federal government need to work out the situation. And then we'll follow any instruction after that," Tiley told The Age newspaper at the tournament's official launch. Novak at the Laver Cup. We spoke generally. He said that he'd obviously love to come back to Australia but he knows it's going to be an ultimate decision for the federal government. "He's accepted that position. It's a private matter between

But Australian border officials said he did not meet requirements to be exempted from strict vaccination rules, his visa was cancelled and a protracted legal appeal failed.

Australia has since lifted its requirement for visitors to show proof of vaccination against Covid.

## Novak dispatches Tsitsipas in ATP Finals opener

Novak Djokovic had enough of an edge at the beginning and the end as he beat Stefanos Tsitsipas 6-4, 7-6 (7/4) on Monday in the ATP Finals, a defeat that ended the Greek's hopes of finishing the year at number one.

Djokovic is ranked just eighth in part because he missed two majors over his vaccination status, starting the year by being thrown out of Australia ahead of the Australian Open.

In Turin, Djokovic is chasing a record-equalling sixth title in the season-ending event, previously known as the Masters Cup, that brings together the season's top eight fit players.

The Serbian broke Tsitsipas in the opening game and was not threatened on his own serve as he took the first set.

The first game was very important to break his serve," Djokovic said. 'Starting with a break of serve is obviously a huge boost in confidence and a relief as well because we both knew it would be a tight match.'

Alexander Alexandrovich Alekhine was born into a wealthy Russian family in Moscow on October 31, 1892. He was introduced to Chess by his mother Anisya and his elder brother Alexei [who also played Chess tournaments.

to the year 1791! Though Russia flourished in Chess in the 19th Century, their champions Alexander Petrov and Mikhail Chigorin were unable to match their German contemporaries Adolf Anderssen and Wilhelm Steinitz. After Chigorin, it was Alekhine who became the strongest player in Russia and started making regular appearances in Chess tournaments in Europe.

In St. Petersburg International Chess tournament April-May 1914, Alekhine took third place, behind Emanuel Lasker (then World Champion) and José Raúl Capablanca (next world champion).

Tsar Nicholas II, a great Chess lover, was so impressed by young Alekhine's play that he chose to include Alekhine (alongwith Dr Emanuel Lasker of Germany, Jose Raul Capablanca of Cuba, Dr Sigbert

In our series "Champion Born This Month", I have the pleasure of writing a story on the "Ĝenius of Chess combinations", a world champion who got more 'First Brilliancy Prizes' than any other player and a player who 'terrorised' the Chess world for almost two decades by his brilliant combinations and apt comments. Yes, it is none other than the great

Alekhine's motherland Russia, has had a long Chess history. The first

Chess book in Russia 'Pravila dlia Shashechnoi Igry' (Rules for the Game of Chess) can be traced back

Tarrasch of Germany and Frank James Marshall of USA) for a new title 'International Chess Grand-

master'. (These five all time great players are known as 'Five original Grandmasters'.) World War I and the Soviet revolution completely changed the

International Chess scenario. Chess in Germany suffered a setback while things improved considerably in the Soviet Union due to patronage by the Communist Party of the USSR. As per the stories narrated by Alexander Alekhine subsequently, he was jailed by the new Soviet administration for belonging to aristocracy but was soon released as they saw a 'potential world Chess champion' in him. [Alekhine indeed won the World Chess Crown in 1927 and retained it till his death (1946) except a short period 1935-1937, to become the first one in the legacy of Soviet Chess World Champions] Alekhine's contempo-

players called him "Genius of Chess combinations" as they were bewitched by his sparkling combinational ideas.

It took some time for even the Chess strategists to realise that Alekhine's combinations were always based on a very solid positional foundation. Sacrifices and sudden tactical blows made his strategic ideas far more effective, practical and powerful. Alekhine was, in fact, the founder of a universal playing style, where strategic and tactical means are fully integrated into a general long term game plan. Alekhine was a true master of all departments of Chess.

He often boasted "In order to beat

Alekhine, one has to outplay him thrice in a single game, in opening, in middlegame and in endgame". Perhaps an exaggeration but true to a great extent. Though Alekhine's strongest point was his middlegame, he had exceptional flair in the opening phase and as well as in rthe

endgame technique. Alekhine started his association with Chess as a Chess journalist. He was a truly multi-faceted personality. His annotations were often full of sarcastic humour. Once, in order to describe his opponent's poor position, he wrote "Black's position is perfectly balanced; it is weak on the King's side and equally so on the Queen's!" His brilliant combinations often demoralised his opponents who usually attributed their loss to bad health on the day. Alekhine's famous quote 'I am yet to beat a player who is physically fit!' was aimed against such opponents. Here are some of his quotes which will help the reader to understand how passionate he was about Chess.

"I believe that true beauty of Chess is more than enough to satisfy all possible demands. "Ĉhess first of all teaches you to

# BRAVO, WILLIAMSON, POORAN RELEASED AHEAD OF IPL AUCTION

PL giants Chennai Super Kings on Tuesday ended their hugely successful 11-year association with legendary all-rounder Dwayne Bravo while Sunrisers Hyderabad released star batter Kane Williamson ahead of the cash-rich league's mini auction.

Tuesday was the last date to announce the full list of players retained and released by the teams ahead of the mini auction, scheduled to be held on December 23 in Kochi.

The day started with Mumbai Indians' longstanding West Indian allrounder Kieron Pollard announcing his retirement from the IPL, only to be drafted as the five-time champions' batting

Mumbai Indians have released as many as 13 players.

In other big movements, Punjab Kings have released their last edition's captain Mayank Agarwal, while West Indies skipper Nicholas Pooran was released by Sunrisers Hyderabad.

Besides Bravo, CSK have also decided to let go of England's death-overs specialist Chris Jordan, a move that might

surprise some. CSK chief executive officer Kasi Viswanathan said, "It's a very tough call. As far as retention is concerned and releasing of players, you know that CSK has always been very passionate with the players, and they have also been contributing to the franchise. It becomes very difficult for us to decide while releasing

"The contribution they have made to CSK will always be cherished and we know that if there is an opportunity for any of them to come back, they will be back in CSK colours.

As far as CSK's captaincy is concerned, Kasi made it clear that their talisman Mahendra Singh Dhoni will lead

"Everybody knows that Thalaiva (Dhoni) will lead the side and he will do his best and the team will do well," he

Meanwhile, Delhi Capitals have released four players which include Indians Mandeep Singh, KS Bharat and Ashwin Hebbar and New Zealand wicketkeeper-batter Tim Seifert.

The Delhi Capitals have also traded all-rounder Shardul Thakur to Kolkata



Knight Riders and brought all-rounder Aman Khan in his place.

Inaugural edition winners Rajasthan Royals have released nine players in total comprising four Indians and five overseas players, leaving them with a purse of Rs 13.2 crore. The players released include James Neesham, Nathan Coulter-Nile, and Rassie van der Dussen among

This time the teams will also receive an extra Rs 5 crore to spend at the auc-
