Modi attacks Cong for being unaware of tribals' existence; Rahul hits at BIP for neglecting tribals

Gujarat on Monday saw fierce campaigning for the State Assembly elections scheduled for next month as India's top political personalities, including Prime Minister Narendra Modi and Congress leader Rahul Gandhi, canvassed in the State along with Delhi Chief Minister Arvind Kejriwal, Home Minister Amit Shah and Uttar Pradesh Chief Minister Yogi Adityanath.

Modi addressed three back-to-back Vijay rallies while Shah attended four public meetings. Rahul held a rally in Surat and public meetings, while Kejriwal took part in road shows and addressed pub-

lic meetings. In the tribal dominated regions, Prime Minister Modi took a swipe at the Congress claiming that "for very long time" it was "unaware of the existence of tribals" and instead of talking of development it was trying to show him his "aukat' as Rahul alleged that BJP was taking away the rights of tribals and soon they would have "lost their jungles" which

Congress to challenge Rajiv killers' release

Party is yet to decide on modalities: Cong; Centre already moved SC against remission

The Congress is set to file a Supreme Court challenging the decision to release six convicts in the Rajiv Gandhi assassination case. The party had termed the top court order "totally unacceptable" and completely erroneous". It had also stated that the convicts have been released from the prison and not acquitted, and should not be seen as "heroes". The petition will be filed in the

next 3-4 days. "We are yet to decide on the modalities — whether we will intervene in the Central Government's review application or intervene otherwise, senior party leader and lawyer Abhishek Manu Singhvi said on Monday.

Delhi girl found in bag on Yamuna E-way was killed by father, dumped by parents

The girl whose body was **▲** found stuffed inside a trolley bag abandoned on a service road of Yamuna Expressway in Mathura district last Friday belonged to Delhi and was

killed by her father. The police arrested the parents of the girl, who not only eliminated the victim but also dumped the body to evade detection. However, the footage from the CCTVs installed all over the expressway gave their game away.

The parents later confessed to the killing.

According to reports, the Mathura police, after sending the body for autopsy, scanned over one hundred CCTVs footage which helped them identify the accused who dumped the body. It showed a man and a woman dumping the suitcase.

Nitesh Yadav, a resident of Delhi's Badarpur, had contacted the police and reported

Suspended Andaman Labour Commissioner held in gangrape case

Suspended Andaman and Nicobar Labour Labour Commissioner RL Rishi was on Monday arrested in connection with the gangrape of a 21-year old woman, police said.

Rishi arrived here aboard a flight from Chennai around 1 pm, and was taken into custody by the Andaman and Nicobar Police, they said. So far, three accused have

been arrested in the case, including former Andaman and Nicobar Chief Secretary Jitendra Narain and Sandeep Singh, alias Rinku, a Port Blairbased businessman.

A special investigation team (SIT) was constituted to

probe allegations that the woman was lured to the chief secretary's home with the promise of a government job, and then raped there on April 14 and May 1. The SIT has already ques-

tioned Narain thrice. The Andaman and Nicobar Police had on November announced a reward of ₹1 lakh each for providing information on Singh and Rishi

Singh, who had been absconding, was apprehended from Haryana on November 13. The FIR in the case was registered on October 1 when Narain was posted as the chairman and managing director of Delhi Financial Corporation.

Covid death: Docs of private hosp booked for negligence

STAFF REPORTER ■

Five doctors of a private hospital in Noida have been booked for negligence in treatment of a COVID-19 patient which allegedly led to his death during the second wave of the pandemic in 2021.

According to the officials, the family of the patient, who was in his early 20s, claimed that he was not administered remdesivir injection in time at the hospital despite them purchasing it on the basis of doctor's prescription, according

The first information report (FIR) has been lodged against the doctors of Yatharth Hospital at the Phase 2 police station under Indian Penal Code section 304A (causing death by negligence) over a complaint by Gautam Buddh Nagar's deputy chief medical officer Dr Tikam Singh.

Dr Singh also headed an official probe committee which had investigated the complaint of the Ghaziabad-based family and the allegations to be true. However, Yatharth

Hospital's managing director Kapil Tyagi claimed that the allegations were misplaced. 'The patient was brought to our hospital in a critical condition. I believe had there been a delay of even half an hour, the patient would not have sur-

vived. But here his condition started improving and after about 35 days, the family took him to another hospital in Delhi," Tyagi told PTI

He said the team of doctors at the hospital did a good job

at their end, considering the challenging situation during the second wave of the pandemic last year.

'Also, on the family's allegation of not administering remdesivir injection in time, there are multiple research reports which later showed remdesivir had no impact in treating coronavirus. We understand that the family has lost a young child and it is very unfortunate," Tyagi said.

Paramhans Tiwari, the incharge of the Phase 2 police station, said the police are investigating the matter and further action would be taken on the basis of findings of their probe.

Social media celeb dies in car crash

25-year-old social media A²⁵-year-old social means celebrity died and his two friends were injured after their speeding car crashed into a tree in Greater Noida on Monday, police said.

Rohit Bhati also known as Rowdy Bhati died in the accident while his friends are undergoing treatment at hospitals - one in Greater Noida and the other in Delhi, a police official said.

"They are said to be returning from a party when the incident took place around 3 am near the Chuhadpur underpass. Apparently the speeding car failed to negotiate a turn and hit a tree," Anil Kumar, incharge of the local Beta 2 police station, said.

Bulandshahr but was living in Chi sector of Greater Noida. Belonging to the Gujar com-



munity, Bhati was popular on social media platforms like Facebook and Instagram where he posted videos and had followers in thousands.

"One of the injured is being treated at the Government Institute of Medical Sciences (GIMS) in Greater Noida, while the other has been referred to Delhi in view of the serious condition,"

The court made the observation while noting that a kind of agony and frustration may be caused to society tim in particular if the accused involved in the heinous crime go unpunished or are acquitted.

Police recover bone fragments from Mehrauli forest

Cops seek court's permission to conduct polygraph test on Aftab

On a day the Delhi Police recovered more human remains, mostly fragments of bones, in further searches in the Mehrauli forest area, it filed an application in a city court seeking permission for conducting a polygraph test on Aftab Poonawala, accused of killing his partner Shraddha

The hearing is likely to take place on Tuesday before the Metropolitan Magistrate, who had earlier heard the application on Poonawala's narco analysis test and given his nod Meanwhile, a dentist, who did not wish to be named, said, "The police came today. They had a picture of the jaw which they recovered during investigation. I asked them to get an X-ray from the Mumbai-based

for a root canal treatment. Without X-ray, it is very difficult to identify." In the mean-time, a PIL has been filed in the High Court (HC) for transferring the probe to the CBI as the Delhi Police has a paucity of personnel and technical equip-

The Forensic Science Laboratory (FSL) Assistant Director Sanjeev Gupta said that the narco analysis test on Poonawala could not be conducted on Monday.

A polygraphic test is to be conducted on Poonawala before the narco test, for which his consent is needed, and the police have been informed about that, the FSL said.

Dr Punit Puri, also an Assistant Director at the FSL, said the polygraphic test will conducted if the consent is

"It will be followed by medical tests and after these only the narco will be performed. Within 10 days, narco will be done," he said.

A PIL was filed in the Delhi HC on Monday seeking a direction to transfer the investigation into the case from Delhi Police to the CBI, alleging that the presence of the media and the public at places of recovery amounts to tampering with evidence.

The plea, which is likely to be listed for hearing on Wednesday, alleged that so far the Delhi Police has revealed each and every detail to the media and public regarding the investigation which is not permitted under law.

On its part, the Delhi Police team in Mumbai has recorded the statements of 11

case, even as details emerged about Poonawala having shifted belongings from his flat in Maharashtra's Palghar district to Delhi in 37 boxes in June and paid Rs 20,000 for it.

Poonawala has stated that he and Walkar fought about who would pay for shifting the items from their house in Vasai. A police officer said they will find out whose account was used to pay Rs 20,000 for the transportation of furniture and other household items in June through the Goodluck Packers and Movers.

said the sources.

It was also revealed that Poonawala and Walkar had on May 6 visited Tosh in Himachal Pradesh and bought 'weed' there and police have some digital evidence which collaborates this.

Admissions to pvt nursery schools to begin from Dec 1

The Delhi Government on Monday released a circular stating that admissions to private nursery schools for the academic year 2023-24 in the national Capital will commence from December 1.

The last date for filling applications is December 23 and the first list of shortlisted candidates will be declared on January 20. The admission process for pre-school, pre-primary and class 1 will commence from December 1 for open seats in private unaided and recognised schools for the 2023-24 session.

According to the schedule released by the Delhi Government's Directorate of Education (DoE), all private schools will have to upload their admission criteria by November 28 and the application process will begin on December 1. The upper age



limit for admissions is four, five and six years for nursery, KG and class I respectively as of March 31, 2023. After the first list of selected candidates and the waiting list is issued on January 20, the second list, if any, will be issued on February 2, and any subsequent list on March 1. The admission process will close on March 17.

There are no significant changes in the admission guidelines from previous years.

All schools are required to reserve 22 per cent of their seats in entry level classes for economically weaker sections (EWS) and disadvantaged group (DG) students and 3 per cent for children with special needs (CWSN). Admissions to

these are conducted through a centralised process of draw of lots by the DoE and a separate schedule for this will be released

Schools have been asked to notify their number of seats and the admission criteria by December 16. The criteria on the basis of which admission will be take place is for the schools to formulate but there are certain "discriminatory" criteria which they are not allowed These include taking into

consideration parents' education qualifications, their food and drinking habits (vegetarianism and alcohol, non-veg consumers), their professional fields or any kind of expertise, oral tests or interviews, or a firstcome-first-get system. Most schools usually allot points to applicants based on their distance from the school, on having siblings in the school and if a parent is an alumnus.

The notification said that a non-refundable amount of Rs 25 can be charged as admission registration fee. The purchase of the prospectus of the school by the parents will be optional, it

The DoE has also directed that the number of seats at the entry level will not be less than the highest number of seats in entry level classes during the last three academic years -- 2020-21 2021-22 and 2022-23.

"Eligible parents of students in the draw of lots will be informed at least two days before the date of draw through website, notice board and e-mail by the school," the notification said. It said the draw of lots will be conducted under videography and its footage will be maintained and retained by the school. The slips will be shown to the parents before being putting in the box, being used for the draw of lots, the notification said.

Pending NI Act cases: L-G nod to hiring of court staff



Pradesh, who was suffering from Gender Dysphoria had visited us two months ago to get completely transformed into a male. She had over the past six years transitioned from female to male, having been put on male hormone replacement therapy since 2016, undergoing bilateral breast removal in 2017,

as well as uterus, ovary and vaginal removal in 2019. "After her psychological

evaluation, we found that although the patient was a female but mentally she was a male, a condition which is called Gender Dysphoria," said Dr. Bheem Singh Nanda, Senior Consultant, Department of Plastic & Cosmetic Surgery, Sir Ganga Ram Hospital.

According to Dr Nanda,

"We decided to perform penile

reconstruction (Phalloplasty) for complete male transformation by state-of-the-art microsurgical technique of tissue transfer. Our aim was to give good shape, length, urethra (to pass urine) and erotic sensation to the patient.

"Of all the techniques we chose the forearm as a donor for penile reconstruction. This was a challenging surgery as

forearm with preservation of vessels and all the important nerves. The next step was to implant the reconstructed penis from the forearm to the genital area of the patient."
Dr. Nanda continued, "The

second challenge was to join the urethra (urine tube) and then connect the vessels to establish the blood circulation again in the reconstructed penis. The last and the most important step was to join the nerves of the reconstructed penis with the erotic nerves (Pudendal nerve and nerve to clitoris) which is the most important pre-requisite for penile implant and sexual satisfaction later."

Section 64 on who can receive summons discriminatory against women, says petitioner; SC gives notice to Centre

ANI NEW DELHI

The Supreme Court on Monday issued notice to the Centre on a PIL challenging Section 64 of the Code of Criminal Procedure (CrPC) which stated that it discriminates against women by treating the female members of the family incapable of accepting the summons on behalf of the person summoned.

A Bench of Chief Justice of India DY Chandrachud and Justice Hima Kohli sought a response from the Ministry of Law and Justice and the Ministry of Home Affairs.

Section 64 CrPC states Where the person summoned cannot, by the exercise of due diligence, be found, the summons may be served by leaving one of the duplicates of him



of his family residing with him, and the person with whom the summons is so left shall, if so required by the serving officer, sign a receipt, therefore, on the back of the other

The plea said that Section 64 Cr.P.C. essentially fails to account for - When the person summoned resides only with the female family members or when the only person available at the time of service of summons is a female.

'The possibility of such a situation (the only person available at the time of service of summons is a female) is particularly high in light of the stark gender gap in the workforce between the males and the females, i.e., only 22 per cent of the Indian women are at work, which entails that the remaining 78 per cent of women are at home," the plea stated filed by advocate Kush

"Issue an appropriate Writ or Order, declaring the part of Section 64 of the Code of Criminal Procedure, 1973 which excludes female family on behalf of the summoned person as violative of Articles 14, 15, 19, and 21 of the Constitution," the plea stated.

It said the larger purpose behind the enactment of Section 46 of the Code of Criminal Procedure (CrPC) is to facilitate the criminal justice system in not causing any unreasonable delay in the criminal proceedings which might otherwise be caused if a personal service to the person summoned is mandated in all circumstances whatsoever.

"Furthermore, the section is premised on the fact that the notice of the service of summons might be conveyed later on to the person summoned.

Thus, given the purpose, thereby excluding the female family members by insertion of the word 'male in the section, doesn't have any reasonable nexus with the object of the section, therefore, the same is blatantly violative of Articles 14 and 15," the petition added.

tions by Indian representatives, it was agreed upon that any number of Dalbergia sissoo timber-based items can be exported as a single consignment in a shipment without CITES permits if the weight of each individual item of this consignment is less than 10 kg.

It was in 2016 that the Dalbergia genus species was brought under the Appendix-II of the CITES after several African and Latin American countries had raised concerns over a "considerable rise in interest in the wood of Dalbergia in international markets, primarily in China".

According to them, this was fuelling an illegal trade, which was decimating Dalbergia populations. However, since all species of Dalbergia are not threatened, India had submitted that

CITES should regulate the trade of individual species based on their conservation status. Since then India along with Nepal, Bhutan and Bangladesh have been jointly demanding removal of trade restrictions on the Dalbergia sissoo, one of the Dalbergia genus species. India had also argued that

listing of Dalbergia genus may create unnecessary complications in the trade of common species like D sissoo, which are being managed and monitored through the management plans of forest areas and are protected under the forest laws of India, said the Ministry.

"Further, it was agreed that for the net weight of each item only timber will be considered and any other item used in the product like metal etc. will be ignored. This is a great relief for the Indian artisans and furni ture industry," summed up the

Nikah under personal law not exempt from POCSO Act: HC

 $M_{\text{personal law are not excluded from the POCSO}}^{\text{uslim marriages under excluded}}$ Act and sexual intercourse with a minor, even if it is under the guise of marriage, is an offence, the Kerala High Court has said.

The court denied bail to a 31-year-old man charged under the Act for allegedly abducting and impregnating a 15-year old minor girl whom he claims he had married.

Justice Bechu Kurian Thomas, in his order dismissing the bail, said child marriage is a bane of the society and the POCSO Act is to prohibit physical relationships with a child, even under the cover of marriage.

"I am of the considered view that marriage between Muslims under personal law is not excluded from the sweep of the POCSO Act. If one of the parties to the marriage is a minor, irrespective of the validity or otherwise of the marPOCSO Act will apply," Justice Thomas said in an order issued on November 18.

The high court was hearing a bail plea filed by a West Bengal native, Khaledur Rahman, who claimed that the girl was his wife whom he married on March 14, 2021 as per Mohammedan law. He claimed that he cannot be prosecuted under the Protection of Children from Sexual Offences (POCSO) Act as Mohammedan law permits marriage of girls below 18

The matter came to light after a Family Health Centre at Kaviyoor in Pathanamthitta district informed the police when the victim had gone there for an injection for her pregnancy. On noticing the victim's age as 16 from her Aadhaar Card, the Medical Officer informed the police on August 31, 2022.

Sexual exploitation of every nature against a child is treated as an offence. Marriage



is not excluded from the sweep of the statute," the court said.

The court noted that the advances and progress achieved in societal thinking have resulted in the enactment of the POCSO Act.

"A child marriage comromises the growth of the child to her full potential. It is the bane of society. The legislative intent reflected through the POCSO Act is to prohibit physical relationships with a child, even under the cover of marriage. This is the intent of society, too, for a statute is, as is often said, the expression or reflection of the will of the people," the court said. It observed that when the

provisions of a statute are repugnant to, or contrary to the customary law or personal law, in the absence of any specific exclusion of the said customary or personal law from the statutory provisions, the statute will prevail, and the personal law or the customary law shall stand abrogated.

The court noted that as per the prosecution, she was brought to Kerala from West Bengal, allegedly behind the back of her parents.

Over 200 people from Bangladesh have fled to Mizoram's southernmost Lawngtlai district due to an armed conflict between the Bangladesh Army and Kuki-Chin National Army (KNA), an official said on Monday.

KNA is the armed wing of the Kuki-Chin National Front (KNF), a political front formed by the ethnic Kuki-Chin-Mizo community in Bangladesh, that demands a separate state and safeguard for the community in the neighbouring country.

The official said that 274 Bangladeshis, including 125 women and children, fled their



villages in Bangladesh and entered Siminasora in Lawngtlai district on Sunday evening due to a recent encounter between Bangladesh Rapid Action Battalion (RAB) and KNA. The Bangladeshi nationals, belonging to the Kuki-Chin-Mizo community, came from seven villages to take shelter in the northeastern state, he said. The district administration and NGOs are providing relief to them on humanitarian grounds, he added. Meanwhile, Zo Reunification Organisation has condemned the attack on the Kuki-Chin-Mizo community by the Bangladesh army.

The defeat of the SP in the bypoll to Azamgarh parliamentary constituency in June, was a major blow to the party. The by-election was held as SP president Akhilesh Yadav had vacated this seat following his election to UP assembly in March this year from Karhal assembly constituency in Mainpuri district. The SP also lost from

Rampur Lok Sabha seat, its bastion, in June last where bypoll was held as SP MP Azam Khan had resigned following his election to UP assembly from Rampur assembly seat.

Too late

Rahul and other Congress leaders must get serious about fighting elections and act accordingly

ahul Gandhi has finally entered the election battle, addressing a rally at Mahuva in Surat district, Gujarat. Even though it's too late, it may encourage Congress cadres, as its campaign did not have many top leaders, whereas the arch-rival Bharatiya Janata Party is leaving no stone unturned. Prime Minister Narendra Modi and Union Home Minister Amit Shah are leading the battle. The Aam Aadmi Party is also trying hard, with its chief Arvind Kejriwal and other senior leaders canvassing for votes in the western state. Himachal Pradesh still remains neglected by the Congress top brass. Sonia Gandhi is not there because of health issues. Priyanka Vadra is campaigning but not as much as the state leaders want her to. A few weeks earlier, the BJP's prospects in the hill state, which is known to change the government every five years, were dim. Apart from anti-incumbency, there is the problem of rebels. A video went viral show-

ing PM Modi beseeching a rebel BJP leader to stand down. BJP detractors were gleeful, saying that the party was so desperate that the PM had to intervene. What they failed to notice was the steadfastness of the BJP: party cadres do get a fillip when they see that the country's biggest leader is so serious about a state poll.

Compare and contrast this with the GOP top leadership's approach to the state Assembly elections. The top leader, Rahul Gandhi, remains occupied with his Bharat Jodo Yatra. Then he rakes up an unnecessary controversy, on VD Savarkar, annoying his ally in Maharashtra, the Uddhav Shiv Sena. Soon after, Medha Patkar's joining the yatra attracts criticism from the BJP. Without naming Rahul and Patkar, Modi

attacked the Congress leader, questioning his (Rahul's) proximity with "those who were against Narmada dam." It seems that Rahul is trying to build a counter-narrative to that of the BJP's hyper-nationalist, Hindu-centric one. Hence the name Bharat Jodo, and hence Patkar's publicised presence at the yatra. The counter-narrative may be the thread that would help his party have some sort of understanding with NGOs and activists, most of whom are Left-leaning. It may be pointed out here that these activists had played a key role in discrediting the Atal Bihari Vajpayee government in 2004, which resulted in the return of the Congress to power after eight years in the wilderness. Therefore, Rahul's wanderings may have a theme; there may be a longterm plan. But a political party cannot afford to ignore short- and medium-term matters; it must fight elections seriously; good intentions and noble sentiments must never be lost sight of; but realpolitik too cannot be ignored. And it is here that Rahul's leadership has been lacking. What the country has witnessed in the last nine years is the unstoppable march of the Modi juggernaut and the concomitant diminishing of the Congress. Rahul and other Congress leaders like party president Mallikarjun Kharge must get serious about fighting elections and act accordingly.

As the fight between the Kerala Governor and the CPI(M) government becomes bitter, this might be the right time to play Shloka to the CPI(M) cadres who seem to be going overboard in their fight against the Governor. The SC by a verdict on October 21 declared as null and void the appointment of vice chancellor of the Kerala Technical University made by the Pinarayi Vijayan-led Government as the

incumbent has no qualifications mandated by the UGC. On Monday, the Kerala High Court quashed the appointment of the vice-chancellor of KUFOS for the same reason. Tuesday saw the CPI (M) laying siege to Raj Bhavan demanding the dismissal of Arif Mohammed Khan. The real fight is between the BJPruled Centre and the Marxists in control of Kerala.

Last week saw all constituents in the Left Democratic Front staging a rally addressed by Sitaram Yechury, the CPI (M) general secretary. Thousands of party cadres took part in the demonstration which is being termed as the bugle for the 2024 Lok Sabha election. The anguish of the CPI (M) against the "high-handed behaviour" of the Raj

Bhavan was visible all over the State. The larger-than-life-size flex boards installed by the student's wing of the CPI (M) were a shocker. The Government Sanskrit College at Thiruvananthapuram, established in 1889 by the then Maharaja of Travancore and labelled once as a centre of excellence, had the slogan "Raj Bhavan is not the property of Arif Mohammed Khan's father" and this was justified by none other than the minister for higher education. Nothing surprising as the SFI had held a symbolic funeral of the Principal of Government Victoria College in Palakkad the day she retired from service. The junior comrades burnt the chair of the principal of Maharaja's College Ernakulam when she was transferred out. Is this how tomorrow's citizens justify the dictum Acharya Devo Bhava? Are you listening, Mr Yechury?

Choosing the next Pakistan army chief BHOPINDER SINGH



Make no mistake, Pakistan has always been under military rule though by proxy, with periods of democracy as occasional aberrations

Pakistani Military has taken over national leadership of Pakistan thrice (1958-71, 1978-88, 1999-2008). Unofficially, it has been under the Khakhi coloured Dock Marten boots since 1958, barring the post-71 phase of Pakistan's 'worst hour' till the return of the 'establishment' (read, Pakistani Military) with General Zia-ul-Haq in 1978.

Each of three times that the surly and burly Generals took over the Pakistani leadership, they had double-crossed the same political power that was responsible for their ascendancy to Generalship. Biting the same hand that feeds, is a consistently repeated phenomenon. The trend started with the then Defence Secretary Iskandar Mirza lobbying for the junior-most Maj Gen Ayub Khan to become the first native Commander-in-Chief of Pakistani Army (despite Ayub's name not even figuring in the nomination list). Later as President, Iskandar Mirza, abrogated the constitution and declared Martial Law with General Ayub Khan as the Chief Martial Law Administrator (CMLA) - within 20 days of the move, General Ayub bumped Iskandar Mirza and banished him to England! Decades later, Zulfiqar Ali Bhutto superseded seven senior Generals to appoint the junior-most Lt Gen in seniority, Zia-ul-Haq, as the Army Chief. Despite his junior-most status, Zia also had a dodgy track record, creepy nature and above all, and reputation of being overtly obsequious and beholden to Zulfiqar Ali Bhutto – in less than a year of becoming the Army Chief, General Zia declared Martial Law and a couple of years thereafter, sent his initial benefactor to the gallows! A couple of decades later, General Zia's political protégé Nawaz Sharif, too sprung a similar surprise when he appointed an ostensible 'safe' Pakistani Army Chief in General Pervez Musharaf, superseding two seniors. History was to repeat for the third time with General—record of having rocky rela



and banished the hapless Nawaz to Saudi Arabia!

Interestingly each of the three civilian governments that were dethroned in the coup d'états represented the 3 varied persuasions of Pakistani politics - Musharaf had removed *PML-N* dispensation, Zia had removed the PPP dispensation and Ayub had removed an illiberal-authoritarian strain (closest in instinct to Imran Khan's PTI) in bumping-off Iskander Mirza. Also, each of these Military usurpers were from the so-called 'minority/safe' ethnic denominations as Ayub was a Hazara from Haripur (and not a Pathan as popularly postured), while both Zia-ul-Haq and Pervez Musharaf were Mohajirs (immigrants from India). These ultra-ambitious Generals were not from the traditional *Punjabi* (Rajput/Jat) or Pathan ethnicity that makes the bulk of Pakistani soldering stock, yet their institutionalised bearing allowed them to roughshod the entrenched politicos.

However even when the civilian politicians ostensibly ruled the roost, the decisive imprint of the 'Army House' in overruling the politicians, who were in fact responsible for their appointment as Chief of Pakistan Army, is consistent. Nawaz Sharif has the dubious Pervez Musharaf deposing the man who made him the COAS all six Chiefs that he had

'handpicked' - first Gen Waheed Kakar forced Nawaz to resign, next was Gen Jehangir Karamat who was forced into premature retirement, third was Gen Pervez Musharaf whose revenge needs no reiteration, fourth was Gen Pervez Kayani who unilaterally gave himself a second term, fifth was Gen Raheel Sharif who gave Nawaz sleepless nights with his popularity and talks of an extension (though didn't take) and the sixth, is the current Gen Qamar Bajwa who in 2018 was singularly responsible for dumping Nawaz and 'selecting' Imran Khan as Prime Minister!

Today, ironically it is the same Gen Qamar Bajwa who has done a complete 360 degree turn by flirting with Imran's PTI (till Imran got too big for his own boots) and then returned to the coalition of PML-N and PPP. The Pakistani 'establishment' or Military has always been its own entity with no permanent loyalty to any political leader, partisan flag or ideology – it has sided tactically with *PML*-N, PPP or even PTI as it deemed topically necessary, but never subscribed or rooted itself into any partisan pref-

erence, for long.

With this backdrop, topicality suggests that the next Chief (as confirmed by Gen Qamar Bajwa in Washington DC, hence believable) will

preference e.g., Lt Gen Faiz Hameed (previous DG-ISI, believed to be close to Imran). It is also clear that the Sharif brothers, though in a coalition with PPP may not take to kindly to a perceived PPP loyalist like Lt Gen Mohammad Amir (once the Military Secretary to Asif Zardari). İt will also stay away from appointing anyone with known religious conservatism as the 'establishment' fears a redux to Zia's 'shariaization'. Even suggestions of manipulating the system to accommodate any contender would be avoided, and that may cost Lt Gen Asim Munir to be left out. The law of elimination leaves the field to the likes of Lt Gen Sahir Shamshad Mirza, Lt Gen Azhar Abbas and Lt Gen Nauman Mehmood to fill the posts of the Chief of Army Staff and the nominally more senior, Chief Joint Chiefs of Staff Committee. All three are supposedly experienced professionals with no known partisan loyalty or overt religiosity — thus affording farcical optics of the 'final word' to the civilian politicos in Islamabad, whilst having the institution-

FIRST COLUMN DRUGS FOR KIDS MUST BE CHILD-CENTRIC

It is wrong to continue to see children as miniature adults

ffectiveness of a drug lies not just in the quality, formulation, and efficacy of the APIs but also in the commitment of the patients to take it as instructed. Across the globe, the problem of patient noncompliance with medication continues to slow down recovery rate, leading to treatment failure, and even death in some cases. The overall financial burden on the health system is another major consequence of non-

In the pediatric population, poor pharmacotherapy literacy of parents can cause unnecessary complications or not getting treated at all. It is always advisable to consult the doctor for children's medications.

Drug formulation is a highly complex process that poses a lot of challenges. However, the process is 10 times more complex and challenging when producing drugs for children. This is as a result of physical, physiological, and psychological considerations that must be met in order to support the growth and development of the affected child. It is wrong to continue to see children as miniature adults who can simply take one tablet if an adult is expected to take two.

The paediatric population is made up of several subgroups, including preterm and term newborns (0 to 27 days), infants and toddlers (28 days to 23 months), kids (2 to 11 years), and teenagers (12 to 18 years). Each of these subgroups has its own peculiarities, characteristics and preferences. Metabolism evolves and changes rapidly as a child moves from infancy through teenage.



While forgetfulness is the reason cited by 60 per cent of adults in a recent study for medical noncompliance, the situation is different among children who have a distinctly different preference for flavours, texture, and formulations. Hence, pharmaceutical companies must recognise the clear distinctions in the biological and biochemical properties of adults

Size is a crucial factor in considering oral forms. Smaller tablets, caplets and capsules are more appealing to children. Naturally, it is easier for them to swallow, and this will also reduce the possibility of choke hazards. In a similar vein, scoring a drug to encourage splitting can be considered, but caution must be applied to avoid dosage inaccuracies. Another factor that requires critical attention is the form of the medication itself. Chewables, dispersible tablets, granules, powders, sprinkles

and pellets are forms that may appeal more to children than solid tablets. Additionally, orodispersible tablets (ODTs), composed of superdisintegrants, are helpful. The superdisintegrants help them to dissolve the tablets within a minute in the mouth in the presence of saliva without any difficulty of swallowing. It offers several advantages with respect to its stability, administration without water, accurate dosing, easy manufacturing, small packaging size, and handling. Its ease of administration in the paediatric population makes it a very popular dosage form. In recent years, manufacturers have also begun introducing preservative-free eye drops that do not contain harsh preservatives like benza-Ikonium chloride (BKC). The goal with these preservative-free eye drops is to maintain an antimicrobial environment in a multidose container while minimising toxicity.

The overall goal of paediatric medicine is to ensure that the medications formulated and produced for children—across all segments are tailored to suit their unique biological and biochemical features, as well as their preferences. It is about making sure that paediatric medicine truly becomes child-centric in a manner that doesn't compromise the efficacy and safety of the drug—in whatever form—and also makes it easy for them to comply with therapy.

AAP offers fiscal mess in Gujarat, as in Punjab GOVIND BHATTACHARJEE

If Aam Aadmi Party and Congress have their way, Gujarat will be soon on its way down the slippery slope of insolvency

ujarat, an urbanised, proentrepreneurship state with 90 per cent Hindu population has long been the saffron lab-oratory for the Bharatiya Janata Party's social re-engineering strategies. In polls due in December, the BJP, which has ruled the state for 27 years and had bagged all its 26 seats in 2019 Lok Sabha elections, is expected to make a comeback and beat the anti-incumbency, which the other two major challengers

After the removal of the Vijay Rupani government last year, perceived to be corrupt and inefficient, the BJP has salvaged its image somewhat, though the Morbi disaster which has exposed the deep-seated cronvism and corruption in administration take its toll, but may not be enough to beat PM Narendra Modi's charisma and the high trust he enjoys among Gujrati voters. Even Muslims seem to be siding with the BJP, whether out of fear one doesn't know. The BJP flaunts its Gujrat model as a shining example of growth, progress and prosperity.

Gujrat has pioneered many exemplary initiatives, backed by efficient delivery. Its Kanya Kelavani for girls' education launched in 2003 has been replicated in many states in India and its ecosystem of innovation, start-ups, and incentives for new industries is an envy of other states. Gujaratis are known for their hard-work and business acumen.

Given the work ethic of Gujaratis, they are more inclined towards social justice being delivered through the market or workplace rather than through government doles.

The AAP is yet to release its manifesto but going by the promises it has made, it has no need for a formal manifesto. They are copying the Punjab model: 300 units of free electricity a month, Rs 3,000 for unemployed youth and Rs 1,000 for every adult woman every month, 80 per cent quota for local youth in private sector jobs, Rs 40 per day for the upkeep of each cow and reverting to old pension

In response to Modi's criticism of 'revdi' or freebies culture as opposed to development – "those with revdi culture will never build new expressways, new oorts, or detence corridors", Kejriwal told women voters, "Rs 1000 is not revdi. This is your right. People's money should go to the people, not in the Swiss

As election approaches, more freebies will surely be promised. In his lust for power, Kejriwal will stop at nothing, even if it means selling the whole state of Gujrat. In 2017 elections, the BJP got 99 of the total 182 seats, with 49 per cent vote share to Congress's 72 seats, with 41 per cent vote share. The AAP had contested 29 seats, but won none, and lost deposits

With a per capita debt of Rs 1 lakh, it is in the throes of a vicious debt trap when borrowing is made just to repay the past loans and interests. Still, in its first two months in power, it has spent Rs

37 crore on advertisements. It is the worst managed economy in India today.

In contrast, Gujrat is in a much better position, through in FY21, the growth rate of its gross state domestic product (GSDP) had plummetted to only 0.57 per cent from 9.75 per cent a year earlier, a fallout from the pandemic. Inadequacies in its public healthcare delivery were severely exposed during the pandemic, something that the AAP hopes to gain from electorally. Since 2011-12, Gujrat has continuous surpluses in its revenue account, but in FY21, the revenue account had a huge deficit of Rs 22,548 crore. However, it still contained its fiscal deficit at 2.44 per cent, well within the limit of three per cent prescribed by the Gujarat Fiscal

s after every climate summit, the air is filled with shouts of rage and despair. What was agreed was unclear and inadequate, and what was left undecided or simply ignored was vast and terrifying. For example, they still haven't managed to agree that the world needs to stop

burning fossil fuels. What? Isn't that what this whole traveling circus is about? The climate is getting hotter because we're burning fossil fuels for energy, soon people will be dying in large numbers, in twenty or thirty years entire countries will become uninhabitable, so stop! Alternative energy sources are available! Act now, or global disaster will

happen! Yes, that's what it's about,

and every year tens of thousands of politicians, experts, campaigners, and lobbyists trek to a different location— Glasgow last year, Sharm-al-Sheikh this year, the United Arab Emirates next year—to debate and decide how to deal with this literally existential

And in all those 27 years they haven't even managed to mention the name of the threat? No, they haven't. Last year, for the first time, they actually inserted the word 'coal' into the final report—we will eventually 'phase it down' (not 'out'), they said—but the words 'gas' and 'oil' are still taboo

This is what you get when a global institution is ruled by nighters, in fact), they manconsensus. Everybody has a veto, including the coal-, gasaged to agree on a new fund

and oil-dependent countries—and the short-term interests of some (money and rapid fossil-fueled economic growth) clash with everybody's long-term interest in not experiencing a huge population die-back and civilisational collapse

Oh, well. This is the price you pay for belonging to a species still emerging from a long tribal past that has developed a high-tech, high-energy civilisation before it was culturally equipped to manage it. Do the best you can, and hope that it will be enough.

So much for the philosophy. What actually happened at Śharm-al-Sheikh? After the inevitable allnight negotiations (two allcountries that suffer 'loss and damage' from extreme climate events. The money will come from the developed countries whose historic and current emissions are the reason

for the damage. Pakistan's catastrophic floods made it this year's poster boy. Prime Minister Shehbaz Sharif told the conference: "Despite seven times the average of extreme rain in the south, we struggled on as raging torrents ripped out 8,000 km. of [paved] roads, damaged over 3,000 km. of railway track, and washed away standing crops on four

million acres. "We became a victim of something with which we had nothing to do, and of

that will recompense poor aster... How on Earth can one expect from us that we will undertake this gigantic

task on our own?' "Loss and damage' is not charity; it's climate justice," said Pakistan's climate envoy Nabeel Munir, and this time the message got through. That's about par for the course: if you bring up the same obvious injustice at the climate summits every year for a decade or so, eventually those who did the harm and should pay the price will

admit that you have a case. It should now take only two or three more years to set up the new 'loss and damage agency and agree on the rules for who pays how much into it each year, and exactly what qualifies as climate-

The biggest remaining question by far is what about China? It is still classed as a developing country and therefore automatically a victim, but actually it is a middleincome country and the world's single biggest emitter of carbon dioxide. It's bigger than all the rest of the developed countries together, and almost three times bigger than the United States.

Should it be paying into the loss and damage fund, rather than claiming money from it? And how about India? It's only third in total emissions now, after the United States, but it will also probably overtake America in the next ten years.

So the titanic struggle course it was a man-made dis- related damage eligible for over who pays for the climate-

linked loss and damage inflicted on the poorest countries will continue, but at least the next climate summit can also focus on other things. Just as well, because stopping at the 'aspirational' target of no more than a 1.5°C rise in average global temperature is probably a lost cause by now. The 'never-exceed' hard

target is no more than +2.0°C, because after that we lose control. The heating we have already caused will trigger warming 'feedbacks' in the system that we cannot turn off, and away we go into the nightmare future.

So it's good to see them getting a little more reasonable each year at these summits. There's still a very long way to go, but at least we're moving in the right direction.

UKRAINE URGES CIVILIANS TO LEAVE LIBERATED AREAS FOR WINT

krainian authorities have started evacuating civilians from the recentlyliberated areas of the Kherson region and the neighbouring province of Mykolaiv, fearing that damage to the infrastructure is too severe for people to endure the upcoming winter, officials said on Monday.

Residents of the two southern regions, regularly shelled in the past months by Russian forces, have been advised to move to safer areas in the central and and western parts of the country, said Ukraine's Deputy Prime Minister Iryna Veresh

The government will provide "transportation, accommodation, medical care," she

The evacuations come more than a week after Ukraine retook the city of Kherson and areas around it. The liberation of the area marked a major battlefield gain, while the evacuations now highlight the difficulties the country is facing following heavy Russian shelling of its power infrastructure as winter weath-

Russian-installed authorities in the Kherson region on Monday also reiterated their call to people to evacuate an area on the eastern bank of the Dnieper River, which Moscow now controls. Officials cited a "high level of military treat" in the Kakhovskiy district as they asked residents to go to evacuation points.

Russia has set up defence lines along the eastern bank of the Dnieper River, fearing that Ukrainian forces would push deeper into the region.

Since Ukraine retook the Kherson city just over a week ago, Russia has stepped up pounding Ukraine's power grid and other infrastructure from the air, causing widespread blackouts and leaving millions of Ukrainians without heat, power or water as frigid cold and snow blankets the capital, Kyiv, and other cities.

In 15 Ukrainian regions, four-hour or longer power outages were expected on Monday, according to Volodymyr Kudrytsky, the head of Ukraine's state grid operator, Ukrenergo. More than 40 per cent of the country's energy facilities were damaged by Russian missile strikes in recent weeks.

On Sunday, powerful explosions from shelling shook Ukraine's Zaporizhzhia region, the site of Europe's largest nuclear power plant. The IAEA, the global nuclear watchdog, called for "urgent measures to help prevent a nuclear accident" in the Russian-occupied facility.

Kyiv and Moscow blamed each other for the shelling that came after weeks of relative calm in the area.

The area has been the site of fighting ever since Russian forces occupied the plant soon after their invasion of Ukraine, sparking fears of a nuclear acci-

On Monday, Russia's nuclear plant operator, Rosatom, conceded that there is a risk of a nuclear accident at the Zaporizhzhia power plant. Rosatom

Russian-installed authorities later said that more than 105,000 consumers in the province's capital, Donetsk, were left without electricity on Monday after Ukrainian shelling damaged power lines. Cold and dark: Kyiv readies for 'worst winter of our lives'

When the power is out, as it so often is, the high-rise apartment overlooking Ükraine's war-torn capital feels like a deathtrap. No lights, no water, no way to cook food. And no elevator by which to escape from the 21st floor should a Russian missile strike. Even when electricity comes back, it's

never on for long.
"Russian strikes are plunging Ukraine into the Stone Age, says Anastasia Pyrozhenko. In a recent 24-hour spell, her 26story high-rise only had power for half an hour. She says the "military living conditions" have driven her and husband from their apartment.

"Our building is the highest in the area and is a great target for Russian missiles, so we left our apartment for our parents' worst winter of our lives," said the 25-year-old.

The situation in Ukraine's capital, Kyiv, and other major cities has deteriorated drastically following the largest missile attack on the country's power grid on Tuesday. Úkrainian state-owned grid operator Ukrenergo reported that 40 per cent of Ukrainians were experiencing difficulties, due to damage to at least 15 major energy hubs across the country.

Warning that electricity outages could last anywhere from several hours to several days, the network said that "resilience and courage are what we need this winter.

Kviv Mavor Vitali Klitschko, too, stressed the need to be ready and resilient in the face of a potential blackout: "Worst case scenario. Actually, I don't like to talk about that, but I have to be prepared if we (do not) have electricity, blackout, no water, no heating, no services and no communication," Klitschko told

Ukrenergo said in a statement that "thousands of kilometres of key high-voltage lines are not working," affecting the entire country.

It published a picture of a transformer station that was destroyed by a Russian missile, leaving around 400,000 people without power. According to the report, "there are dozens of such transformers in the power system now. This equipment cannot be replaced quickly."

President Volodymyr Zelenskyy said after last week's strikes that more than 10 million Ukrainians were left without electricity; by Sunday, he said some areas had seen improve-

"The restoration of networks and technical supply capabilities, the de-mining of power transmission lines, repairs clock," Zelenskyy said in his nightly address.

Blackouts were scheduled Sunday night in 15 regions and the city of Kyiv, he said. Ukrenergo said there would be scheduled outages in every region on Monday.

A sharp cold snap and the first snow have significantly complicated the situation in Kyiv. The cold forces people to turn on their heaters, which drastically increases the load on the grid and makes power outages longer. In light of the dropping temperatures, the Kyiv authorities announced they were setting up communal heating points.

In the city of 3 million people, 528 emergency points have been identified. Here, residents will be able to keep warm, drink tea, recharge their phones and get any necessary help. The heating points will be equipped with autonomous power sources, as well as special boiler rooms.



Diplomats are drumming up money and other support on Monday for Europe's poorest country, Moldova, which is suffering massive blackouts, heavy refugee flows and potential security threats from the war in neighbouring Ukraine.

Monday's international aid conference in Paris is aimed at "concrete and immediate assistance" for the land-locked former Soviet republic, according to the French Foreign Ministry.

Two previous conferences for Moldova this year raised hundreds of millions of euros, but as the war drags on, its needs are growing. "This international support

Hungary's Foreign Minister travels to Russia for energy expo

■ elled to Russia on Monday to take part in an international forum on nuclear energy, underscoring his country's persistently close ties with Moscow amid the war in Ukraine.

Foreign Minister Peter Szijjarto gave a speech at the opening plenary session of the two-day ATOMEXPO international forum in the Black Sea resort city of Sochi, according to the event's website.

The forum, titled "Nuclear Spring", is aimed at the global nuclear industry and serves as a "business platform for discussing the current state of the nuclear industry and setting future trends," the website says.

In a post on Facebook early Monday, Szijjarto said his appearance at the expo would include talks with the head of Russia's state atomic energy company, Rosatom, over a planned Russiabacked expansion of Hungary's only nuclear power plant. He said the project was "in Hungary's national strategic and



national security interests."

"The global energy crisis means that it is of unprecedented importance for a country to be able to produce the energy it needs. The Paks nuclear power plant plays a key role in our energy security," Szijjarto wrote.

The trip was the latest sign of Hungary's continuing diplomatic and trade ties with Russia which have confounded some European leaders as the war in Ukraine nears nine months.

Szijiarto was last in Russia in October for natural gas negotiations with Russian state energy company Gazprom, a visit Czech Foreign Minister Jan Lipavsky called "scandalous" since some of those present

under populist Prime Minister Viktor Orban has pursued close diplomatic and economic ties with Moscow, and sought to protect its supply of Russian oil and gas — on which it is heavily dependent - as other European countries have aimed to cut off their Russian energy imports to punish the Kremlin for its war in Ukraine. Orban, considered Russian

President Vladimir Putin's closest ally in the EU, has lobbied vigorously against EU sanctions on Moscow, arguing they have led to skyrocketing energy prices that are hurting European economies more than they are Russia.

On Monday, Szijjarto insisted that "no sanctions of any kind can limit Hungary's energy supply, since one of the basic principles of our country's energy strategy is that the energy mix is an exclusive national competence," according to Hungarian state news agency MTI.



North Korea calls **UN's Guterres** 'puppet of US' after launch

AP ■ SEOUL

North Korea's foreign minister called UN Secretary-General Antonio Guterres ["]a puppet of the United States" as she slammed the UN chief for joining US-led condemnation of the North's recent intercontinental ballistic missile test.

UN Secretary-General Antonio Guterres earlier issued a statement strongly condemning North Korea's ICBM launch on Friday and reiterating his call on the North to "to immediately desist from taking any further provocative actions." Guterres's statement came after the United States and other countries issued similar criticism of the North's ICBM test that showed an potential to strike anywhere in the continental US.

"I often take the UN secretary-general for a member of the US White House or its State Department," North Korean Foreign Minister Choe Son Hui said in a statement carried by state media. "I express my strong regret over the fact that the UN secretary-general has taken a very deplorable attitude, oblivious of the purpose and princi-ples of the UN Charter and its proper mission which is to maintain impartiality, objectivity and equity in all matters."

Choe accused Guterres of overlooking the US and its allies taking the North's ICBM test to the UN Security Council, saying that "This clearly proves that he

Palestinians: Israeli forces kill man in West Bank

The Palestinian Health Ministry said ■ on Monday that Israeli forces shot and killed a young man near the occupied West Bank city of Jenin. The ministry said in a statement that the man died of a gunshot wound to the abdomen. Palestinian media identified the man as 18-year-old Mahmoud al-Saadi.

The Israeli army said it carried out arrest raids across the West Bank on Monday. It said its soldiers apprehended three suspects. During an arrest in Burqin, a town near Jenin, it said its troops came under fire, and shot back. It said its troops confirmed a hit.

The violence was the latest in a wave of Israeli-Palestinian fighting in the West Bank and east Jerusalem that has killed more than 130 Palestinians this year, making 2022 the deadliest since 2006.

Israel says its almost nightly arrest raids in the West Bank — which began

after Palestinian attacks killed 19 Israelis last spring — are needed to dismantle militant networks at a time when Palestinian security forces are unable or unwilling to do so. The Palestinians say the raids undermine their security forces and are aimed

at cementing Israel's open-ended 55-year occupation of lands they want for their hoped-for state. Hundreds of Palestinians have been

rounded up in such raids, with many placed in so-called administrative detention, which allows Israel to hold them without trial or charge.

STRONG QUAKE TOPPLES HOUSES US pushes defence ties with Indonesia as China strengthe

strong, shallow earth-quake toppled buildings and walls on Indonesia's densely populated main island on Monday, killing at least 162 people and injuring hundreds of others as residents fled into the street, some covered in blood and debris.

Officials were gathering information on the toll of those injured and killed by the quake in the remote area.

West Java Governor Ridwan Kamil said the number of confirmed dead had risen to 162. "The majority of those who

died were children," he said. Many were public school students who had finished their regular classes for the day and were taking extra lessons at Islamic schools, he said.

Cianjur is known for having a large number of Islamic boarding schools and mosques. "So many incidents occurred at several İslamic schools," Kamil said.

He said more than 13,000 people whose homes had been heavily damaged were being taken to evacuation centres.

Emergency workers treated the injured on stretchers and blankets outside hospitals, on terraces and in parking lots in the Cianiur region, about three



hours drive from the capital, Java. The injured, including children, were given oxygen masks and IV lines and were being resuscitated.

Indonesia as China strengthens

US Defence Secretary Lloyd J. Austin met his Indonesian counterpart on Monday to push stronger defence ties amid growing Chinese naval activity in the Indo-Pacific region.

Austin, at a joint news con-ference after meeting with Indonesian Defence Minister Prabowo Subianto, said they discussed ways to deepen the two countries' partnership, including through expanding interoperability and increasing investments in defence educa-"The United States is proud

to partner with you as we work together to advance our shared vision of a free and open Indo-Pacific," Austin said.

But Subianto stressed Indonesia's neutral stance.

"I like to emphasise that Indonesia always takes the position of trying to maintain the best relationships with all nations, especially all the major powers," Subianto said.

Austin arrived in Jakarta late Sunday from a visit to Canada's Halifax city where he spoke about US efforts to build a more resilient security architecture with allies and partners across the Indo-Pacific and Europe at the Halifax International Security Forum.



His visit to Indonesia comes less than a week after leaders of the Group of 20 economies met on Indonesia's resort island of Bali. In a declaration, most strongly condemned the war in Ukraine and warned that the conflict is making an already delicate world economy worse.

"We are meeting as the world is grappling with assaults on the rules-based international order, especially Russia's unprovoked invasion against Ukraine," Austin said, "And it's especially vital now that more like-minded countries come together to uphold our shared principles, including the rule of

He applauded Indonesia for its vote at the UN General Assembly earlier this year condemning Russia's aggression in Ukraine

While Indonesia and China enjoy generally positive ties, Jakarta has expressed concern about Chinese encroachment on its exclusive economic zone in the South China Sea, which China claims virtually in its

Subianto said Indonesia sees China as a friendly nation, and the two countries have ways to manage possible misunderstandings and differences of opinion in disputes over territorial waters.

"We consider that we will be able to resolve them with dialogue," Subianto said, "However, we do emphasise that Indonesia will defend its sovereignty and we will defend our indepen-

Lesser known RSP emerging as dark horse in Nepal elections

he Rastriya Swatantra Party, I floated by a former television personality, has emerged as the dark horse in the Nepal elections, coming third behind heavyweights like the Nepali Congress and the CPN-UML, and leading in seven constituencies.

The counting of votes started at 7 am local time on Monday and continued till 5 pm, a day after about 61 per cent polling was recorded across the Himalayan nation.

The Rastriya Swatantra Party (RSP) is floated by Rabi Lamichhane, a 48-year-old former television personality, who shot to fame while attempting to set the Guinness world record for hosting the longest-ever marathon talk show in 2013.

The RSP is currently leading in three constituencies in Kathmandu and one in Lalitpur district.

The ruling Nepali Congress (NC), which has so far won in one constituency, is leading in 32 constituencies, while CPN-UML led by former prime minister K P Sharma Oli is leading in 17 constituencies.

RSP is leading in 7 constituencies, while the Rastriya



Prajatantra Party has the lead in 5 constituencies and CPN-Maoist Centre in 4 constituencies respectively.

Similarly, CPN-Unified Socialist is leading in 4 constituencies, followed by Janamat Party in 2 constituencies and Lokatantrik Samajwadi Party and Hamro Nepal Party in one constituency each.

"The bell is ringing against larger parties," read a social media post, in reference to the bell, which is RSP's election symbol. The RSP's impressive performance is a wake-up call for larger parties like NC and the CPN-UML, observers said.

Kazakh president wins new term against weak Opposition

✓azakh President Kassym-Klomart Tokayev easily won a new seven-year term in a snap election in which the second biggest choice by voters was to reject all six candidates, the country's central elections com-

Tokayev received more than 81 per cent of the votes in Sunday's election, according to elections commission chairman Nurlan Abdirov. Five candidates were on the ballot against Tokayev. Nearly 6 per cent of voters chose the "against all" option.

With a short campaign period that began in late October, candidates had little opportunity to mount significant challenges.

Tokayev has taken steps to keep Kazakhstan's distance from longtime ally and domi-



nant regional power Russia.

He pointedly said the country did not recognise the Ukrainian regions that Russia declared to be sovereign states at the outset of the conflict that began in February. Kazakhstan has also taken in hundreds of thousands of Russians who fled after President Vladimir Putin issued a conscription order in September.

When Tokayev became president in 2019 following the resignation of Nursultan Nazarbayev, he was widely expected to continue the authoritarian course of the man who had led the resource-rich country since it gained independence from the Soviet

Nazarbayev remained highly influential as head of the national security council, and the capital was renamed Nur-Sultan in his honour.

Then a wave of violence arose in January, when provincial protests initially sparked by a fuel price hike engulfed other cities, notably the commercial capital, Almaty, and became overtly political as demonstrators shouted "Old man out!" in reference to Nazarbayev.

More than 220 people, mostly protesters, died as police harshly put down the unrest.



Rupee falls 7 paise to close at 81.81 against US dollar

The rupee depreciated 7 paise to close at 81.81 (provisional) The rupee depreciated / paise to close at one of against the US dollar on Monday, tracking the strength of the American currency in the overseas markets and a muted trend in domestic equities. At the interbank foreign exchange market, the local unit opened at 81.84 and later witnessed an intraday high of 81.74 and a low of 81.91 during the session.

The domestic unit finally settled at 81.81 against the American currency, registering a fall of 7 paise over its last close.

On Friday, the rupee depreciated 10 paise to close at 81.74 against the US currency. The rupee depreciated on weak domestic markets and a strong dollar. FII outflows put downside pressure on the rupee, said Anuj Choudhary - Research Analyst at Sharekhan by BNP Paribas. The US dollar gained amid hawkish tone by most Federal Open Market Committee (FOMC) members and concerns over rising COVID-19 cases in China, which dimmed hopes of reopening in China. Economic data from the US remained mixed. The US existing home sales declined to 4.43 estimates of 4.41 million. "We expect the rupee to trade with a negative bias on strength in the US Dollar amid risk aversion in global markets. However, weak crude oil prices may support the rupee at lower levels. Traders may remain cautious ahead of the Federal Open Market Committee (FOMC) meeting minutes later this week," Choudhary said.

Crisil lowers FY23 growth by 30 bps to 7%; Icra slashes Q2 GDP to half of last fiscal at 6.5%

 $R^{\text{ating agencies Crisil}}_{\text{Icra on Monday revised}} \ \text{and} \ \text{down their India growth pro-}$ jections for the current fiscal and the second quarter mainly due to the ripple effect of slowdown in global growth and mixed crop output.

Crisil downgraded the India growth forecast by 30 bps to 7 per cent while Icra pegged the economic expansion at 6.5 per cent for the second quarter of FY2022-23.

"We have revised down our forecast for real gross domestic product growth to 7 per cent for fiscal 2023 from 7.3 per cent, primarily because of the slowdown in global growth that has started to impact our exports and industrial activity. This will test the resilience of domestic demand," Crisil chief economist Dharmakirti Joshi said in a note.

Aditi Nayar, his counterpart at Icra, in her report pencilled a 6.5 per cent growth in Q2 of the current fiscal, nearly half of the year-ago quarter when the economy had clipped at 12.7 per cent, but which is still a tad higher than the monetary policy committee's September forecast of 6.3 per cent and at 6.5 per cent in gross value added (GVA) less than half of 13.5 per cent a year ago.

She attributed the lower numbers to the mixed crop advance estimates of kharif production, adverse input cost movements for certain sectors with a higher fuel intensity, as well as the impact of the flag-ging external demand on non-



oil merchandise exports, which whittled down the gains from robust demand for contactintensive services, healthy capital spending by government and pre-festive season stocking

She also said, however, GDP growth over the pre-Covid levels is expected to double to around 8 per cent in Q2 relative to 3.8 per cent seen in the previous quarter. The agency estimates the sectoral growth in Q2 to be driven by the services sector (9.4 per cent), with a subdued trend foreseen for the industry (2 per cent), and agriculture, forestry and fishing (2.5 per cent).

Joshi said he is paring

growth forecast only by 30 bps as domestic demand still remains supportive, helped by a catch-up in contact-based services, government capex, relatively accommodative financial conditions, and overall normal monsoons for the fourth time in a row.

Sitharaman to meet State FMs for pre-budget consultation on **Friday**

On November 22, the minister will meet the agriculture and agro-processing industry, representatives from the financial sector and capital market.

She will also be meeting the representatives of the services sector and trade bodies, besides experts from the social sector, including health, education, water and sanitation, on

November 24, in virtual mode. The budget for the next year will have to address critical issues of high inflation, boosting demand, job creation sustained 8 per cent-plus growth path.

It will be the fifth budget of Sitharaman and the last full budget before the general elections slated for April-May 2024.

Jagadeesan breaks world record for highest ever List A score

Tamil Nadu batter Narayan Jagadeesan on Monday shattered the world record for the highest ever individual score in men's List A cricket by hammering a 141-ball 277 against Arunachal Pradesh in the Vijay Hazare Trophy here.

Tamil Nadu won the Group C match by 435 runs, making it the biggest victory margin in a List A match. The previous record was Somerset's 346-run win over Devon in 1990.

The 26-year-old Jagadeesan bettered the record of Alistair Brown's previous high of 268 for Surrey against Glamorgan in 2002. The Indian record for Rohit Sharma in an ODI against Sri Lanka was also obliterated in

Tamil Nadu's 506 for two in the match is also the highest team total in men's List A cricket, bettering the previous best of 498 for four by England against the Netherlands earlier this

The previous highest List A total in India was 457 for four by Mumbai against Puducherry in Jaipur in 2021. Veteran India cricketer and

Door opens for Warner's Oz captaincy ban to be lifted

ricket Australia amended its player code of conduct policy on Monday, paving the way for David Warner to apply to have his lifetime leadership

The dynamic opener and former Test vice-captain was banned from any leadership role in Australia over his part in the Cape Town ball tampering affair in 2018.

He was also slapped with a one-year playing suspension, but bounced back to reclaim his place in the national side across all three formats of the game.

Under Cricket Australia's amended policy, Warner will now be able to request a review of his captaincy ban before a panel of three code of conduct commissioners. The 36-yearold must show that "exceptional circumstances exist to justify modifying a sanction", including

demonstrating remorse and evidence of improved behaviour. The new rule "acknowledges that players and player support personnel are capable of genuine reform or rehabilita-

"It is intended to provide the

player or player support personnel with an opportunity to resume their previously held positions or responsibilities in specific circumstances," CA added. Under the previous code of

conduct, players had no right to review a sanction once it had been accepted. Pat Cummins is currently

Djokovic finishes troubled year with 'satisfying' ATP Finals title

Novak Djokovic said winning a record-equalling sixth ATP Tour Finals title on Sunday was a "deeply satisfying" ending to his troubled and truncated year. The Serb beat Norwegian

Casper Ruud 7-5, 6-3 in Turin to match Roger Federer's record of six titles in the year-ending tournament for the top-ranked players. The 35-year-old Serb, the old-

est player to win the Finals, ended in style after a season in which he missed two majors because of his vaccine status "It feels deeply satisfying and,

at the same time, a huge relief because of the circumstances that I have been through this year, situations earlier this year, of course, with Australia," he said.

"We don't need to go back. We know what happened

In January, Djokovic was detained and deported from Australia over his Covid non-vaccinated status and missed the Australian Open.

"That had an effect obviously on my start of the year. For the first several months, I was trying to find that balance game-wise but also mentally in order to be able to come back to the court and find that tennis level that I need."

Djokovic was initially barred from returning to Australia before 2025 but earlier in the week the new government in Canberra said the nine-time Australian Open champion would be free to compete in January's tournament. "I don't know what the future holds but I know that what I hold

in my mind is a huge hunger still to win trophies," said Djokovic. The win in Turin, which also
