UAE BARS ENTRY OF PEOPLE WITH SINGLE NAME IN PASSPORTS

ndividuals having only single name as surname or given name in their passports will not be allowed to enter the United Arab Emirates (UAE) with new guidelines coming into force. "Any passport holder with a single name (word) either in surname or given name will not be accepted by UAE immigration and the passenger will be considered as INAD, according to a circular issued by Air India and Air India Express, mentioning about the latest UAE guidelines. INAD refers to Inadmissible Deportee. According to the circular, dated November 21, such passengers will not be issued a visa and in case, the visa was issued previously, then he or she will be considered as INAD by the immigration authorities

Pradeep Mondawe (64), a resident of Mankapur area, had filed a complaint about a theft of jewellery and cash worth Rs 5 lakh from his house, said a police official The police apprehended a minor suspect who disclosed Kshatriya's alleged involvement in the crime and the latter was arrested on Tuesday, the official said. He was produced before a court which remanded him in police custody till November 25. The stolen items were recovered from a pigeon box in Gaddigodam area, the official said.

INDIANS OVERTAKE CHINESE AS LARGEST GROUP OF STUDENTS IN UK

ndian students have for the first time overtaken Chinese as the largest group of foreign students studying in the UK with a massive 273 per cent hike in visas granted over the past few years, according to the country's official immigration statistics released on Thursday. The UK Home Office data collated by the Office for National Statistics (ONS) reveals that Indians also continue to be the top nationality granted visas in the skilled worker category, with 56,042 granted work visas in the past year. Indian nationals also represented the highest number of visas at 36 per cent of the total under the tailored Skilled Worker Health and Care visa targeted at medical professionals, reinforcing Indian contribution to the state-funded NHS.

HC slaps Rs 1L fine for false info

In a big setback to the farmers who took recourse to legal remedy over road-widening at Ippatam village in Guntur district, the Andhra Pradesh High Court on Thursday imposed a penalty of Rs 1 lakh on each of the 14 petitioners for misleading the court with false information.

The High Court issued a stay order against the demolition of structures for road widening in Ippatam village against the petition filed by 14 farmers of the village. The counsel for the farmers told the court that no notices were given to the farmers during the hearing of the case. The council on behalf of the State government told the court during the hearing that they demolished the structures on the encroached government land only after serving notices. In this context, the High Court has ordered all the 14 farmers to appear before the court on



Thursday for giving false information. The villagers attended the court and when the court asked if notices were served to them, they said that they were ignorant of the notices they received. However, the High Court rejected their argument and issued a verdict imposing a fine of Rs 1 lakh on each of them.

The US Commission on International Religious Freedom (USCIRF) is a Congressional-appointed body. Its recommendations are, however, not mandatory to be implemented by the US State Department. Religious freedom and related human rights in India are under ongoing threat, the USCIRF alleged on Tuesday in an unusual year-end update of the status of its assessment of religious freedom in the country. Asked about the report at a media briefing here, Ministry of External Affairs Spokesperson Arindam Bagchi said, We consider these biased and inaccurate observations about India by USCIRF. They (USCIRF) have a tendency to consistently misrepresent facts and this shows their lack of understanding of India, our constitutional framework, plurality and our robust democratic system.'

SC comments on panel recommendations for Election Commissioner post

PNS ■ NEW DELHI

The list of bureaucrats the Union law ministry recommended to the prime minister for picking an election commissioner did not have the name of even one person who could complete the stipulated six-year tenure at the poll panel, the Supreme Court said on Thursday.

A five-judge Constitution bench headed by Justice KM Joseph wondered was the government not closing the doors on meritorious younger candidates by

appointing retired bureaucrats.

"There is a law. We expect you that you would act in such a way that you would comply with the statutory requirements. Why is that you will have a pool of retired bureaucrats, why not others? Why only

four names, why not have a larger pool

'Are you not shutting out the meritorious younger candidates? You seems to be hell bent that no chief election commissioner or for that matter EC gets a complete six years tenure and it is against the statute," Justice Joseph said.

Under the Election Commission (Conditions of Service of Election Commissioners and Transaction of Business) Act, 1991 an EC can have a tenure of six years or up to the age of 65, whichever is earlier.

Justice Joseph said the point is that from the pool of a large number of officers the government has selected only those people who are never going to complete the six-year tenure.


"Why were the names sent to prime minister and not the council of ministers?" Justice Joseph asked. Attorney General R Venkataramani

responded, "Batch is one criteria, date of birth is other, seniority from the batch is other. Similarly, there are several other aspects which are being considered. Several discussions are done. Everything is not in black and white. There are several ways of appointment. Some files go to the Appointments Committee of Cabinet (ACC) through cabinet secretariat and some go directly to the prime min-

The bench, also comprising Justices Ajay Rastogi, Aniruddha Bose, Hrishikesh Roy and CT Ravikumar, clarified there should not be any misunder-

standing that the court is against the government and it is only debating and discussing the issue. The AG replied, "Yes, My Lord. It is a debate and I am bound to answer the court's questions. If we start doubting every appointment, look at the implications for institution's reputation". Justice Joseph said, "So, ultimately your point is that only those people need to be appointed who are on the verge of retirement, so that they don't get a

India's Central engineering agency Survey of India, which is in-charge of mapping and surveying, has lauded Andhra Pradesh Chief Minister YS Jagan for his visionary steps to correct land records in the

Speaking at a State government event at Narasannapeta in Srikakulam district, the agency's Director SV Singh said, "Everyone knows the condition of land records in India. Maps used in villages across the country are not correct. An attempt was made to correct this anomaly in 2002 which was revised again in 2008. But nothing happened on that

He then added how Andhra Pradesh became the first state in the country to take up the exercise of correcting land records due to the efforts of CM Jagan.

"AP has a good, visionary Chief Minister. He not just dreamt but decided to correct land records in the state. At first, 10,000 surveyors were appointed. The state government then started using technology for land resurvey programme, including drones, helicopters, GNSS rovers etc to identify the land. Due to this, maps have now been made accurate, with a variation of just five centimetres," Singh detailed.

It was 47.5 per cent in April-June 2022. Labour force refers to the part of the population which supplies or offers to supply labour for pursuing economic activities for the production of goods and services and, therefore, unemployed persons.

NSO launched PLFS in

April 2017. On the basis of PLFS, a quarterly bulletin is brought out giving estimates of labour force indicators namely unemployment rate, Worker Population Ratio (WPR), Labour Force Participation Rate (LFPR), distribution of workers by broad status in employment and industry of work in CWS. The estimates of unemployed persons in CWS give an average picture of

unemployment in a short period of seven days during the survey period.

In the CWS approach, a person is considered unemployed if he/she did not work even for one hour on any day during the week but sought or was available for work at least for one hour on any day dur-

Labour force, according to CWS, is the number of persons either employed or unemployed on average in a week preceding the date of the survey. LFPR is defined as the percentage of the population in the labour force. WPR (in per cent) in CWS in urban areas for persons aged 15 years and above stood at 44.5 per cent in July-September, 2022, up from 42.3 per cent in the same period a year ago. It was 43.9 per cent in April-June, 2022.

State govt plans to conduct housewarming function on December 21

Though the State government is giving top priority to the construction of houses under the prestigious Pedalandariki Illu, the works are not progressing at the desired pace. The State gov-ernment had decided to conduct the housewarming function on December 21 after completing the construction works. However, not even 40 per cent of houses are complete in the last week of November. The remaining 60 per cent of houses must be completed by December 21.

The State government has sanctioned 83,633 houses to NTR district, and the district administration set a target to complete 12,264 of them by December 21. As of today, however, only 4,780 houses have been completed. The remaining houses are in different stages of construction. According to the Housing Department officials, at least 7,500 houses must be com-

Day for completing the targets. As per the data available at the NTR District Housing Department, 2,351 houses are on the basement level (BL) and 1,843 houses are on the roof level. Besides, 3,290 houses are on the roof cast level, the sources said. The department targets to

For the past month, District Collector Dilli Rao has been conducting review meetings with Housing, Panchayat Raj, MPDO, Revenue, and other departments to complete the targeted 12,264 houses. But the works are so slow, only 100 to 150 houses are completed every week, the sources added.

In NTR district, there are seven assembly constituencies and the department plans to conduct housewarming of a total of 12,264 houses on December 21 -- 5,184 in Mylavaram constituency, 2,771 in Nandigama, 2,086 in Jaggaiahpet, 1,196 in Vijayawada Central, 500 in Vijayawada East, 392 in Tiruvuru and 135 hous-

es in Vijayawada West. However, in the Mylavaram constituency, 3,161 houses are still in various stages of construction. As many as 1,614 houses are to be completed in Nandigama, 1,108

Jaggaiahpet, 986 in Vijayawada Central, 385 in Vijayawada East, 178 houses are to be completed in Tiruvuru and 52 in the Vijayawada West constituency.

The department observes every Saturday as Housing Day, but due to the lack of funds, the beneficiaries are unable to complete their houses.

'The sanctioned amount of Rs.1.80 lakh is not sufficient to complete the house. Due to the increasing prices of building materials such as cement, iron, and others, the construction cost is more than Rs. 6 lakh. So, I am unable to complete the house with the amount allocated by the government," said D Subrahmanyam Raju, a beneficiary.

The State government has assigned the house construction works to a third party, but the agency is not ready to continue because the sanctioned amount is inadequate, he said. He urged the State government to take steps to complete the houses as early as possible.

Paddy procurement tardy in Krishna, NTR districts

Farmers approaching middlemen because of fast payment

Paddy procurement is taking place slowly both in Krishna and NTR districts though the harvest started one month ago. As the State government had delayed the payments last time, the farmers are not interested in selling their grains at the paddy procurement centres in Krishna and NTR districts and they are approaching mid-

dlemen for speedy payments. Though the State government has announced that 486

procurement centres would be set up in Krishna and NTR districts for the purchase of paddy, the procure-ment process is happening slowly due to the non-opening of several centres.

As per the official data, about procured from 387 farmers in Krishna and 1,800 tonnes from 50 farmers in NTR district. Millers and middlemen are purchasing the grains at the paddy procurement centres, even though Sachivalayam staff and volunteers are present

According to sources, the Civil Supplies Department has paid Rs.2 crore to the farmers in Krishna district and Rs.80 lakh to those NTR district farmers. The State government has permitted the sale of paddy to others if they are willing to pay the Minimum Support Price (MSP) of Rs.2, 060 for Grade-A per quintal and Rs.2,

040 for common grade variety per quintal.

The Agricultural Department has expected about 5.50 lakh metric tonnes

of paddy yielding in Krishna district and 1.24 lakh MT in NTR district. For this, both the district administrations have arranged 486 procurement centres at the YSR Rythu Bharosa Kendars (RBK) -- 316 in Krishna and 170 in N ITR dis-

"If we sell paddy to the middlemen, we may lose Rs.500 per quintal. But we will receive the amount within two weeks. The State government will not give the money until it's at least one month," said farmers.

Naidu blames YSRCP govt policies for crisis in aqua sector PNS AMARAVATI Aquaculture is in deep crisis now in

Andhra Pradesh due to the faculty policies of the State Government, said the former chief minister and TDP national president, Nara Chandrababu Naidu, here on Thursday.

Concentrated global push of millets key for food security: Jaishankar

External Affairs Minister S Jaishankar on Thursday said a concentrated global push for millets is needed as the three Cs of climate change, Covid-19 and conflict are impacting food security in some way or the other.

Millets are grown in 130 countries, including India, and a concentrated push by these countries for millets would enhance food security, increase self-reliance and global availability, the minister said.

Speaking at a pre-launch celebration of 2023 as the International Year of Millets, the minister shared how each of the 3Cs has impacted food security putting the global economy at risk due to the concentration of production centres and trade disruption.

He said de-risking the glob al economy requires more decentralised production and more self-reliance as well as willingness" on part of the country not only to grow for themselves but to help each other. Against this backdrop, the minister asked High Commissioners Ambassadors to India to give much greater attention to food security and think of millets from the point of view of international relations apart

and climate benefits. Agriculture Minister Narendra Singh Tomar, Minister of State for Agriculture Shobha Karandlaje, Minister of State for External Affairs Meenakshi Lekhi and Agriculture Secretary Manoj Ahuja were present at the

"Look at the state today of the world. I would like you to reflect on the relevance of millets to that. If there are three big challenges which we have experienced and continue to experience. They are to my mind are 3Cs: Covid, Conflict, and Climate. Each one of them some way has impacted food security," Jaishankar said.

He suggested that in international relations, every country

should be giving "much greater attention to food security" and looking for more resources, diversity, production, reliable and resilient supply chain.

"If there is today a concentrated global push of millets grown in 130 countries, what you will see (is) these 130 countries will surely enhance their own self-reliance and food security," he said.

In the process, they will

actually contribute to a larger amount of foodgrains which will be available for global consumption, he added.

He said millets-growing nations should not only think purely as nutritional or agricultural exercise or something which will improve farmers income, which is extremely important but do also think of larger implication, greater pro-tection of more diversity of food which has other virtues."

Sharing the impact of 3Cs on food security, Jaishankar said concentrated production centres and trade disruptions affect the global economy. The Covid-19 period reminded what the pandemic would do to food security. "I think this was not the first pandemic and I am sure this will not be the last one. ...I think there will be a future pandemic.

BJP committed to bring **Uniform Civil Code: Shah**

Union Home Minister Amit Shah on Thursday said the BJP is committed to bring Uniform Civil Code (UCC) in the country but only after following all démocratic processes and discussions on it.

Addressing an event here, he also exuded confidence in BJP's victory in the Himachal Pradesh and Gujarat assembly elections as also in the MCD (Municipal Corporation of Delhi) polls.

The home minister credited Prime Minister Naredra Modi for making the country's politics free from the "naasur" (canker) of casteism, dynasty and appeasement.

"Modi ji has made country's politics free from casteism, dynasty and appeasement and started politics of performance.

Whosoever perform, will govern the country. Whosoever puts in effort, will govern the country. Those who are pro-country will govern (it).

"Nobody would rule on the basis of place of one's birth or to the caste he or she belongs or how much appeasement somebody does," he said, adding that the country's people have accepted this policy of the Modi government.

Talking about the UCC, Shah said it has been a promise of BJP since its days of Bhartiya

"Not only BJP, the Constituent Assembly had also advised the Parliament and states that UCC should come in the country at an opportune time," he said at the Times Now Summit on 'India: A vibrant democracy, global bright spot'. Shah said for any secular country, laws should not be on the basis of religion.

"If a nation and states are secular, how can laws be based on religion? For every believer, there should be one law passed by the Parliament or the state assemblies," he said.

He, however, said that the commitment of the Constit uent Assembly was forgotten over a period of time.

"Except the BJP, no other party is in favour of the Uniform Civil Code. They don't even speak on it. If they don't have courage, they won't

As Debroy created havoc on the road, Khowai Police Station officer-in-charge Satyajit Mallik along with a large police contingent reached the spot and tried to take him into cus-But in the melee, Debroy

attacked Mallik and he later died at a state-run hospital in Agartala. Eventually, police took him into custody.

After conducting a speedy investigation into the gruesome murders, police submitted the chargesheet with the

However, why Debroy had suddenly turned violent on the night of the incident was not immediately known.

The National Anti-profiteering Authority will live on as a part of Competition Commission of India

he Government has given the Competition Commission of India (CCI) the mandate that the National Anti-profiteering Authority (NAA) enjoys. The reason is that the NAA will cease to exist by the end of this month. The NAA has a mandate to ensure that reductions in goods and services tax (GST) are passed on to consumers. It was meant to check any profiteering by businesses; hence the name. The decision is reportedly in accordance with a recommendation by the GST Council, which has representation from the Centre as well as state governments. So now, even as the NAA will cease to exist, its work will be carried out by the CCI mandarins. Right from the beginning—that is, 2017 when the NAA came into being—it was an affront to the business class. In fact, the very word 'profiteering' has a ring of dirigisme around it; this is the reason that Leftists use it quite often. It presup-



poses that all businesspersons are unconscionable, blood-sucking villains who exploit their employees and fleece their customers. Added to the malice is the erroneous notion that government can control or check prices by coercive means. Right from the brutal regime of Alauddin Khilji to the pre-1991 days of Nehruvian socialism, such controls were put in place; they never brought any relief to the man on the street; invariably they led to shortages, blackmarketing, and corruption. One of the most anti-business decisions in the last few years has been the setting up of the NAA.

It was supposed to complete its work of monitoring GST rollout in two years, so it was given a

two-year term. But that was not to be. As the famous economist Milton Friedman said, nothing is so permanent as a temporary government programme. The NAA kept getting extensions; what was supposed to die in 2019 is still alive—and will remain so. It needs to be mentioned here that it is not just the Narendra Modi Government that is responsible for the perpetuation of a price control mechanism; the entire political class is involved in it, for the GST Council includes various states. The NAA perpetuation highlights a disturbing fact: our political masters have little faith in economic reforms. What liberalisation they have carried out in our country, they have done under compulsion, not by choice. This is not surprising, for liberalisation is essentially the process of the retreat of the State from the processes of economy; it involves less regulation, less intervention in the market. While all this is good for the economy and the people at large, it is not so good for politicians and a section of intellectuals who are ideologically wedded to the theories which are predicated upon the big State. Besides, there are a lot of people—bureaucrats, economists, technocrats, et al—who grew up reading and internalising Leftwing books. This is the reason that Leviathan marches on and abominations like NAA never die.

s the hearing on the demonetization gets underway in the the Supreme Court, new , facts and new arguments might tumble out after six years when the Prime Minister Modi had announced demonetization on November 8, 2016; banning high-denomination currency notes of Rs.500 and Rs.1000 and replacing them with the new currency notes of Rs. 500 and Rs. 2000 denomination. The standard argument at that time was that it would be a big blow to the black money and the economy would be purged in one stroke. The government sticks to its argument in the affidavit submitted to the apex court saying that it was a 'well-considered decision' taken after duly consulting the Reserve bank of India. The Union government filed the affidavit in response to a batch of 58 petitions that had challenged demonetisation. A five-judge constitution bench comprising Justices S.A. Nazeer, B.R. Gavai, A.S. Bopanna, V. Ramasubramanian, and

B.V. Nagarathna is now hearing the matter again.



The new facts that have come to light through an RTI give a very different picture than what the govt would have us believe. The RBI was not in favour of demonetization as it maintained that black money in the country was not in the form of currency notes but its opinion was brushed aside. The govt submitted that demonetisation was executed on the specific recommendation of the RBI's Central Board. However, according to RTI activist Venkatesh Nayak, who accessed the minutes of the 561st Meeting of the Central Board of Directors of the RBI through a RTI application, Para 4.4 of the minutes seems to indicate that the Board was simply not aware of this planning before the tabling

of the Deputy Governor's memorandum on the subject at its meeting less than six hours before the Prime Minister announced the decision to the country. The minutes provide that the Board was only "assured" that the matter had been under discussion between the Central government and the RBI. Nayak noted that the RBI's directors had - contrary to the government's stand - opined that most of the black money is not held as cash but in the form of real estate, jewelery etc. The matter is subjudice and it is for the court to decide upon the validity of the claims made by both sides but one thing is clear; there is more to demonetization than meets the eye. Apart from bringing hardships to people, it did not succeed in either curbing the black money or ending terrorist funding. Will people ever know the truth?

However,

he and other world leaders hardly explained why the promises made earlier were not met to date. Biden rightly said that the world faced a 'pivotal moment' in the fight against the climate crisis. But failed to lay out the steps that humanity should take.

With the COP27 having come to an end, some inspiration has been rekindled. What global leaders do in the coming years will be watched carefully, but at the same time, the citizenry all across the world must also do what they can at individual level. We need more people actively raising clamour around this subject. FIRST COLUMN INDIA-UAE TRADE PACT: PATH TO PROSPERITY

India is close to starting free trade negotiations with GCC

atar was in news, not just for dazzling the world with billions of dollars of investments for showcasing and hosting one of the largest sports events of all time, the FIFA world cup, but also for pulling off one of its kind supply deals with China. Qatar signed a 27-year natural gas supply deal with China, which is being touted as one of the longest in the history of hydrocarbons.

The agreement according to Chinese government officials would also provide access to the strategic North Field South Project in (NFS) in Qatar. The NFS expansion project is a mega LNG transport train which promises to make Qatar one of the largest natural gas traders in the world in a decade. The expansion project allows international enterprises participation and so far all western big names from Total, Shell, Exxon Mobil, etc., are partners for helping Qatar reach its stated target. In comes China, with a long agreement with Qatar and it also wants to have full access and share in the hydrocarbon-led geopolitical rubric playing out. This agreement with China comes at a time when the European Union is scrambling for securing natural gas supplies from sources other than Russia.

The traditional European inertia to get into long term binding contracts is one of the other reasons such agreements between the West and Qatar are not maturing. In the middle of all this, India is close to starting Free Trade Negotiations with the Gulf Cooperation Council (GCC) of which Qatar is an important member. The GCC is an intergovernmen-



tal, political, economic union consisting of six Arab nations. India has had a framework agreement with the GCC since 2004. The framework, according to the commerce ministry, provides for exploring ways and means for extending and liberalizing trade relations and initiating dialogue towards a free trade agreement.

However, despite two formal dialogues in 2006 and 2008 the GCC, according to the Government of India, could not persuade its member countries to move further to a Free Trade Agreement level negotiation. Regional economic issues among the Arab states, their bilateral relations with India played a significant role in the delay.

The recent pandemic has made Gulf countries willing to expand their economic clout beyond hydrocarbons; this has led to a change in the mindset. India signed a CEPA (Comprehensive Economic Partnership Agreement) with one of the most influential GCC countries, the UAE, earlier this year. This CEPA allows India's goods to have preferential access for 97 per cent tariff lines, which accounts for 99 per cent of India's exports to the UAE. India primarily exports gems and jewellery, textiles, leather footwear, sports goods, plastics, furniture, wood products, engineering products, pharma and medical devices to the UAE.

India's major import from UAE is primarily energy. The CEPA, one of the first off the block, agreed by India after it has been dragging its feet on getting into binding trade agreements for more than a decade aims to achieve \$115 billion bilateral trade of goods and services in just five years. India had earlier walked out of Regional Comprehensive Economic Partnership, one of the largest economic partnerships, citing a China dictated framework.

India now realises the importance of trade as a significant contributor to the national GDP. India realises that trade in goods and services will be a key contributor towards the economy reaching \$40 trillion in the next two decades. India signed a Free Trade Agreement with Australia earlier. Similarly, a free trade agreement negotiation with the UK has been progressing for more than six months now. FTA negotiations with GCC, if concluded successfully, could be another milestone in India's multi trillion-dollar economic path.

BJP aims record haul in a three-way poll



The BJP is set on its target again, lest an undercurrent shakes it off or throws a fractured delivery

fter 27 years in the saddle in Gujarat, the Bharatiya Janata Party wants to do it again. And when one says it is 'the BJP contesting the poll' in Gujarat, it actually translates into Prime Minister Narendra Modi who may have vacated Gandhinagar in 2014 but it is he who is seeking mandate for the seventh time in the western Indian state in 2022 and in turn in his decisive run-up to the 2024 Lok Sabha polls.

Another win for the saffron party tiding over almost three-decade anti-incumbency would possibly press a 'delete' button on the Congress and allow the 'thirdfactor' Aaam Admi party (AAP) to rise in

Ironical as it may sound for the BJP backers, the Congress despite the BJP's 'double-engine' domination over the power, in last 2017 state elections not only increased its Assembly seats tally but also improved upon its vote share. In contrast, there has been a steady decline in the number of seats collected by the BJP since 2002.

The BJP's seats at 99 went downwards in 2017 from 116 of 2012 Assembly results, but its vote share at 49.1 increased by 1.25 per cent. The Congress, which had won 60 seats in 2012 Gujarat assembly elections, had gained significantly in 2017 by winning 77 seats. The main opposition party had thus not only improved its position by 17 seats but also collected 41.5 per cent vote share, a jump of 2.57 per cent from 2012 Gujarat Assembly polls.

The Congress could not gather enough steam in 2017 to beat the BJP, which had the formidable advantage of its well-oiled organizational machinery and Modi's 'realpolitik' checks and balances to keep the voters interest in the party vis-a-vis a faceless Gujarat Congress and its unimagina-

tive central leadership.

As the stage is set for 2022 December one and five poll for the 15th Gujarat assembly polls, the dynamics of Gujarat elections can be read as "waveless" which could be won by technical management which is: ITS SITTING MLAS over 135 people, is another reflection of candidates coupled with right booth handling that is ensuring good AND GIVEN PLACE management of seat distribution. turnout of the support base.

Palpably anxious of declining number seats in successive assembl BJP has denied tickets to 40 of its sitting MLAs and given place to the fresh and young, not loaded with the burden of antiincumbency. With winnability being the prime factor for all political parties visà-vis the 'ideology', the BJP too has, so far, blessed 10 out of 19 Congress MLAs who resigned and joined the BJP after the 2017 elections with its tickets.

In contrast, Congress has, 'understandably', retained most of its sitting MLAs as party candidates. It is indeed a game of reshuffling of the available players on the ground for both the parties and creating a 'new rainbow' before the voters.

Currently, campaigning most aggressively, the AAP is now banking on its success in Gujarat in 2021 civic polls when it ousted congress from the Surat municipal corporation, winning over Patidar votes. The AAP also won one seat in Gandhinagar Municipal

In the 2022 Gujarat poll, the AAP is not without some resonance and digging deep to create its place as against the well-entrenched BJP and Congress. The AAP's approach to Patidars and fielding of backward community member Isudan Gadhvi as the chief Ministerial candidate indicates its calculated longterm planning after scoring victory in Punjab.

The 'Hindutava' card of Kejriwal, however, may not pay its dividend against the BJP which has its master key with itself.

The main challenger to the ruling BJP, the Congress is currently on to its 'door-to-door' silent campaigning, bridging the connection it left uncovered in 2917.

As for the BJP, its 'guarav vatra' apart, the Prime Minister has laid votes of the BJP and may do less out a slew of mega projects in

Gujarat, two of which shifted from Maharashtra to convince voters that continuity in its governance would ensure uninterrupted 'development' in the state with the guarantee of funds from the central government. The hair-splitting analysis of television anchors notwithstanding, the election match in Gujarat, in a way, seem to be dominated by 'turncoats', including the likes of Hardik Patel and Alpesh Thakor.

he Reserve Bank of India on October 7 released a concept note on Central Bank Digital Currency (CBDC). The purpose behind the issue, as claimed by the RBI, is to create awareness about CBDCs in general and the planned features of the Digital Rupee (e?), in particular. It explains the objectives, choices, benefits, and risks of issuing a CBDC in India. The Note also seeks to explain Reserve Bank's approach towards introduction of the CBDC, which has been launched on

a pilot basis now. As explained by the RBI the e? will provide an additional option to the currently available forms of money. It is substantially not different from banknotes, but

There can be two types of currencies which are used for settlement of transactions. One is physical currencies and another digital form of currency. As we have now all the bank deposits which can be transacted through digital platforms are part of digital currencies only. So whose custody is not important. How digitally it can be transHence the question aris-

es why there should be a digital currency from the RBI now? If the aim is to completely wipe out the physical currency, it is a different matter. Not only is our country, no other country in the world is aiming for any such propo-

Our bank accounts provide seamless digital transactions by means of debit cards, credit cards, NEFT, RTGS, IMPS, UPI etc. Now in this concept paper RBI broadly defines CBDC as the legal tender issued by a central bank in a digital form. It is akin to sovereign paper currency but takes a different form, exchangeable at par with the existing currency

medium of payment, legal tender and a safe store of value. Hence, it is almost identical to the digital transactions provided by banks except the sovereignty.

The RBI says that the key motivations for exploring the issuance of CBDC in India among others include reduction in operational costs involved in physical cash management, fostering financial inclusion, bringing resilience, efficiency, and innovation in payments system, adding efficiency to the settlement system, boosting innovation in cross-border payments space and providing public with uses that any private virtual currencies can provide, without the associated risks. Again, these are and shall be accepted as a already available for digital

transactions through bank accounts.

The RBI claims that CBDCs have some clear advantages over other digital payments systems, as it being a sovereign currency, ensures settlement finality and thus reduces settlement risk in the financial system. This may be theoretically and conceptually true. But then this undermines the banking system we have under the same RBI regulation. If any bank fails in any settlement system, then it will speak about RBI's supervision.

As per the scheme, the CBDC issued will be the liability of the RBI and whoever wants to have this will have to pay to RBI to acquire this deposits obtained by com- and a store of value.

mercial banks. But the RBI has decided not to pay any interest on this. As it is primarily introduced as a method of payments like cash, it would not bear interest.

Instead of going in for CBDC, the RBI can further improve penetration of digital transactions by making many transactions compulsory through digital mode. There can be limits on cash payments. There can even be restricted use of cheques. This will reduce cost for the economy as well as arrest illegal and unaccounted transactions.

India to grow at 'moderately brisk rate', inflation to ease: FinMin

India is well placed to grow at a "moderately brisk rate" in the coming years on the back of macroeconomic stability, despite global monetary tightening, a finance ministry report said on Thursday.

It further said inflationary pressures will ease in the coming months with the arrival of kharif crops and at the same time job opportunities will increase with improvement in

The 'Monthly Economic Review for October 2022' also cautioned that the US monetary tightening is a "future risk" which could lead to dip in stock prices, weaker currencies and higher bond yields, resulting in higher borrowing costs for many governments around the world. It said a rapid deterioration in global growth prospects, high inflation, and worsening financial conditions have increased fears of an impending global recession.

Rooftop solar capacity installations in India fell 29 per cent to 320 megawatt (MW) in July-September 2022, according to Mercom Research India. The country added 448 MW

rooftop solar capacity in the same quarter a year ago, the research firm said in a report on Thursday.

During January-September, the installations at 1,165 MW were also down 11 per cent compared to 1,310 MW in the corresponding nine-month period of the last year, the report titled 'Mercom India Rooftop Solar Market Report

In the third quarter of 2022, 46 per cent of rooftop solar capacity was installed in the industrial sector, followed by 32 per cent in residential, commercial 21 per cent and the remaining in the government sector. According to the report, at the end of Q3 2022,



cumulative rooftop solar installations reached 8.3 GW.

"We are seeing rooftop solar installations trending down as costs have risen. The market is struggling with supply issues because of the Approved List of Module and Manufacturers (ALMM), and installers are finding it a tough environment to operate in overall," said Raj Prabhu, CEO of Mercom Capital Group.

The government on Thursday said it is planning to augment coal stock at thermal power plants to 45 million tonnes by March-end. The coal ministry said that it further plans to increase the stock of fossil fuel at the pithead.

"The Ministry of Coal is planning to build stock at domestic coal-based plants to the tune of 30 million tonnes by the end of November, 2022," the coal ministry said in a statement.

It has plans to keep building the stock so that by the end of March 31, 2023, coal stocks at Thermal Power Plants (TPP) go up to 45 million tonnes.

The total coal output in the country stands at 448 million tonnes (MT) as of October, 18 per cent higher than the production of the corresponding period of the previous financial year.

"The growth of coal production from Coal India Ltd (CIL) is also more than 17 per cent," the ministry said.

The average coal rakes per day availability registered a growth of nine per cent in the April-October period of the current fiscal, thereby helping transportation of higher quan-



tity of dry-fuel and building up stocks at power plants. The power ministry is also augsea route. menting transportation of coal

Exporters demand fiscal incentives, credit at affordable rates

Exporters on Thursday demanded fiscal incentives, tweaking in customs duties on certain products and credit at affordable rates in the forthcoming Budget to boost

exports and create jobs. În a pre-budget virtual meeting with Finance Minister Nirmala Sitharaman, the Federation of Indian Export Organisations (FIEO) said the depreciation of the rupee against the US dollar is affecting exports' competitiveness and the sector requires more

support.
"Creation of employment is

the biggest challenge faced by the country...We would urge the government to provide fiscal support to units which provide additional employment in the export sector," the exporter's body said.

It said that incentives may be provided based on twin criteria of growth in exports and the creation of additional jobs.

The body stated that at a time when global demand for goods is declining, it has pecome fundamental to go for aggressive" marketing.

It argued that the Rs 200

crore support given under Market Development Assistance (MDA) scheme for



promoting exports to USD 460-470 billion is just a "drop in the ocean".

Therefore, for aggressive marketing, there is a need for the creation of an Export

pus of minimum 0.5 per cent of preceding year's exports," it suggested adding a special scheme for goods exported by MSME can be introduced in

the Budget. On the direct tax front, it has demanded an increase in the deduction for investment. On R&D, and procedural simplification by the abolition of TCS (Tax Collected at Source) has

been sought. It also asked for a 200 per cent tax deduction on the expenditure made by exporters for overseas marketing; and extension of tax incentives for the private sector to set up a global Indian shipping line to tap the market.

On loans to MSMEs (micro, small and medium enterprises), FIEO said the credit rate is currently between 11-13 per

cent and it may increase further in the next few months.

Therefore, there is an urgent need to restore the interest equalization (subsidy) benefit of 5 per cent to manufacturer MSMEs and 3 per cent to all 410 tariff lines (broad sectors) as existed prior to October 2021, as cost of credit has crossed the pre-COVID level and is adversely impacting exporters," it added.

On Goods and Services Tax (GST), the body asked for a tax refund to foreign tourists at the airport as it would give a fillip to tourism and exports of handicrafts, carpets, khadi, and leather goods.



Enrique backs Spain to stay hungry after historic rout

The 2010 champions dominated their opponents, who did not manage a shot at goal in the whole match, and in their second group game on Sunday face a desperate Germany, who were beaten 2-1 by Japan earlier.

Spain's previous record victory was a 6-1 thrashing of Bulgaria at the 1998 World Cup, a match in which Luis Enrique scored for La Roja.

However, while the Spain coach thinks that too much flattery can weaken a team's resolve, he is confident his side will stay grounded and focused.

"I have no doubt that we will play the next game with the same spirit, if not more," Luis Enrique told reporters.



ony LIV's *Meet Cute* is a 5-part anthology that follows a set of accidental meetings between strangers. The anxiety that kicks in when you have to meet someone for the first

meet someone for the first time is suffocating. How about that crippling anxiety gradually withering away as time passes on the first meeting? Not just that, but also the conversations you have that lead to life changing experiences. To be succinct, this is what *Meet Cute* thrives on.

If there is something that the series excels at, it is to put the idea right across the viewer's face. Ever thought of how a rigid first meeting could go well or how meeting an old man at a consulate when you're pissed off with your husband can change your perspective about love. What about faking your name inorder to know who your son is dating? Or how about giving a superstar a ride because her car breaks down?

The series has some really good lines that make you think. Like "What doesn't break you makes you stronger" and "Where there is no love, there is no relationship". The aim of the series is to perhaps put forward some of our deepest fears and make us feel like it's okay to

feel nervous about the uncertainties in life. Director Deepthi Ghanta tries her best to put the idea across, but shines only in parts. The production values, camera work, set design and the music add up quite well, but the writing seems half cooked in a few portions.

Episode one is a big let down. *Meet the boy*: It is about Swati Ganta, an Improtech manager, who is reminded by her mother to meet Abhi, a consultant at Demoite. I know, the fake names of these famous companies are funny? The matrimonial set up is what frustrates a lot of would be married guys and girls. That same frustration can be seen in the face of Swati. While Swati waits in the parking lot, we see "Dude No 11" popup on her phone screen. This just shows how disinterested she is in meeting Abhi. Anyway, let's cut to the chase. What starts off as a forced meeting turns rosy when Abhi tells Swati that it is not the first time he's seeing her. "Meet the boy" just doesn't land right. Although the idea is in the right place, the execution could have been better. When Abhi describes the nature of his job to Swati, she seems disturbed. She asks him, "So! All that you did was just a marketing trick, huh? Just like your job!". Abhi comes off as a yes man as he keeps concurring with Swati's idea of love.

Some of the most brilliant moments from the series come from episodes two and three. For instance, the super irritated Saroja recognises this old journalist at the consulate struggling with his papers and helps him out. Through the conversation, Saroja begins to understand that love is all about the small things. The Urban Herald journalist asks pertinent questions like Are you sentimental or expressive? The director does a good job in episode three where the idea of companionship is promulgated. The most cherished thought of



Romanticism seems childish after watching the episode ends. You begin to wonder, "Right! Companionship is the truest form of love isn't it?". As we go ahead with the series, episodes four and five don't really offer much except for some good lines here and there. The narrative slows down and turns too filmy at times and makes it harder to believe some of the situations that the characters have been put in. A random stranger meeting another is fine, but giving a ride to a superstar? Umm... okay! Fine, but taking her home? Quite not believable even if you consider the

theme of the series. Scenes like this make the series look unreasonable at times.

Despite having a great idea, *Meet cute* doesn't quite hit the target with most of its writing and narrative. Technically, the series is great and it's visually pleasing to the eye. From the standpoint of narration, it takes a backseat. *Meet Cute* is a genuine attempt at presenting a beautiful idea but it is caught up in a storm where the captain tries too hard to sail the ship in the right direction.


