Steps promising, but LAC situation not normal: India

Disengagement at Point 15 'one problem less' on border: MEA



India on Friday said there has been some positive development in eastern Ladakh but the situation is not yet normal. "We have not reached there... I would not like to say the situation is normal. There have been some positive steps, but some steps are vet to be taken, said Ministry of External Affairs (MEA) Spokesperson Arindam Bagchi in his weekly

media briefing.

Bagchi also referred to
External Affairs Minister S Jaishankar's remarks last month that the disengagement at Patrolling Point 15 in eastern Ladakh was "one problem less' on the border.

By all account, the Central Government has all along maintained that as far as India was concerned several other issues remains unresolved, and it is not satisfied with merely from the disengagement Patrolling Point 15 since there has been no progress yet on resolving the standoff in the

The MEA Spokesperson said India has been maintaining that it expects disengagement followed by de-escalation for the return of normalcy on the border, which could pave the way for normal ties between the two neighbouring

Bagchi's comments are also in line with Indian Air Force (IAF) chief Air Chief Marshal V R Chaudhari's statement on Tuesday that the benchmark for the situation to become normal in eastern Ladakh would be to return to status quo ante prior to the standoff and a complete withdrawal of troops from all friction points.

Incidentally, China's Ambassador to India Sun Weidong recently claimed that the situation at the Line of Actual Control is moving towards being "normalised and under control".

"The current border situation is overall stable," Sun said. "The phase of emergency response since the Galwan Valley incident has basically come to an end."

Sun made these comments during an event to mark the 73rd anniversary of the People's Republic of China at the Chinese Embassy in New

"Some steps are required for full normalcy, we have not reached there," Bagchi said when asked about the Chinese Ambassador's remarks.

The MEA Spokesperson said India has been maintaining that it expects disengagement followed by de-escalation for the return of normalcy on the border, which could pave the way for normal ties between the two neighbouring countries

Following the eastern Ladakh standoff, India has been consistently maintaining that peace along the Line of Actual Control (LAC) is key for the overall development of its ties with China and the State of the border will determine the State of the bilateral relationship.

major controversy has Amajor controversy has erupted over the presence of the Delhi Minister and AAP MLA from Seemapuri, Rajendra Pal Gautam, at a mass conversion event on October 5 where "thousands' of people can be heard taking an oath denouncing Hindu

At the controversial event, organised by the Buddhist Society of India and conducted at the Dr BR Ambedkar Bhavan in Jhandewalan in the national Capital, people were allegedly asked to take a pledge not to worship Hindu gods and goddesses. They were also asked to show full faith in Buddhism.

Sources in the AAP claimed that the Chief Minister was "extremely displeased" with Gautam. Interestingly, neither Kejriwal nor any party leaders defended him. Meanwhile, at a Press con-

ference, BJP national spokesperson Gaurav Bhatia accused the AAP of hurting the sentiments of Hindus.

BJP leaders also asked Kejriwal to sack Gautam within 24 hours for showing "dis-

respect" towards Hindu deities in the presence of thousands of people. Delhi BJP president Adesh Gupta also lodged a police complaint against Gautam on the issue.

Gautam, who holds the portfolios of Social Welfare, SC & ST, Cooperative, Gurudwara Elections and Women & Child Development in the Kejriwal led Government himself had also tweeted the pictures of the event, saying more than 10,000 people pledged to join Buddhism and work for mak-ing India free from casteism and untouchability.

Several videos of the event and the initiation have gone viral on the internet. One clip showed people being asked to vow not to worship Hindu gods and goddesses, and not to ollow Hindu rituals.

In the purported video that went viral four days after the event, Gautam can be seen sharing the dias with other persons attending the programme. He could also be seen standing in the pledge gesture.

The pledge was, "I will never hold Brahma, Vishnu and Mahesh as gods and wor-ship them. I will neither hold Ram and Krishna as God nor worship them ever. I will not believe in or worship Gauri, Ganapti or any other deity of the Hindu religion." Later, he was seen deliver-

ing a speech wherein he urged Hindus to renounce their faith and tread the path of Dr Ambedkar. As per the video clips, during the event, a saffron-clad man administered an oath to the crowd, which closely resembled the controversial 22 vows of BR Ambedkar. The man urged the Hindus to disassociate themselves from their original faith and desist from the worship of



Afghan heroin worth ₹1,200 cr seized; 6 held

 $A^{\rm n}$ Iranian fishing vessel with around 200 kg of heroin worth over Rs 1,200 crore has been seized in a joint operation by the Narcotics Control Bureau (NCB) and the Indian Navy, the NCB said

Sanjay Kumar Singh, Deputy Director General (operations) of the NCB, who met reporters here, said the agency has arrested six Iran nationals and the boat, along with the heroin, was brought to Mattancherry wharf here.

The NCB has now seized the vessel and 200 kg of heroin. The six Iranian crew members have also been arrested under relevant sections of the NDPS Act, 1985," Singh said, adding that interrogation was on. He said the drug was found in 200 packets each of which has markings and packing spe-cialties unique to Afghanistan-

"While some of the drug packets had 'Scorpion' seal markings, the others had 'dragon' seal markings. The drug was also packed in a waterproof seven-layered packing. Preliminary investigation revealed that the seized drug was sourced from Afghanistan and was transported to Pakistan. This consignment was then loaded into the nowseized vessel off Pakistan coast in a mid-sea exchange," NCB said. The agency said the vessel then set sail to Indian waters for further delivery of the consignment to a Sri Lankan vessel. It said efforts were made to identify and intercept this Sri Lankan ves-

sel but it couldn't be traced. Singh said the accused tried to escape by jumping into the sea and also tried to dump the consignment into the

MCD identifies 250 mosquito breeding hotspots in Delhi

The Municipal Corporation of Delhi (MCD) has identified 250 hotspots breeding mosquitoes at a large scale across the national Capital.

The Capital has recorded 638 cases of Dengue in the past week, according to the reports released by the MCD. MCD officials said that

the corporation has identified around 250 hotspots where large scale breeding of mosquitos have been found in the "Some of the areas where the mosquito breeding has

been found are Gali No. 3, Ambedkar Nagar, A4 Kothi near MCD Primary School, Gali No. 1 and 2, Sri Nagar, C Block, Omkar Nagar, Macchli Market, Chander Shekhar Azad Colony, Wazirpur Industrial Area, 1, B and D Block, Jailer Wala Bagh Huts, Ashok Vihar, Phase-ll, K and L Block, JJ Colony, Wazirpur, B Block, Derawal Nagar, MIG, LIG, HIG Motia Khan, Arva Nagar Paharganj," he informed.



Gautam, who is Social Welfare and Women & Child Development Minister in the Delhi Government, said he has faith in Buddhism and that the Constitution gives the freedom to follow any religion. "The BJP is afraid of AAP. They can only lodge fake cases against us," he said.

ED raids 35 locations in Excise Policy case



PWD issues norms after finding instances of fast deterioration in building structures

STAFF REPORTER ■ NEW DELHI

The Public Works
Department (PWD) in Delhi has issued a set of guidelines to be followed during construction to ensure quality and durability of buildings. It has also instructed officials to ensure that there was no use of substandard material in construction activity.

The move comes after the department found instances of deterioration in building structures in a very short period as compared to their designed life, it said in a circu-

Works department officials said the department had issued a circular asking executive engineers, assistant engineers, junior engineers and contractors to thoroughly inspect each building and other development works and prepare a list of building-wise deficiencies.

They have been asked to attend to these deficiencies in a systematic manner to ensure quality. "It is very important to ensure desired quality of the structures so as to live its designed life as well as to reduce the future maintenance

expenditure," the works department said in the circular issued on Thursday.

The guidelines stated that it should be ensured that the structural design was based only on the site's soil investigation report and foundations rested on firm ground and not filled-up soil.

Along with the soil, the quality of water to be used in construction should be tested before start of work, it said.

For repair of minor honeycombing in concrete, the guidelines dissuaded dismantling and suggested that it be repaired after removing the loose portion, followed by

injection grouting.

The circular stated that the honeycombed area should not be plastered before proper treatment. Honeycombs are hollow spaces or cavities in concrete mass that may be dangerous for any building or flyover as it reduces structural strength, the officials said. It is not the first time that the products of Maiden Pharmaceuticals Ltd — whose cough syrups allegedly caused the death of 66 Gambian children — have come under the scanner. Its tablets for diabetics have earlier been declared "substandard" by states like Bihar, Jammu & Kashmir, Kerala and Gujarat.

In 2015, authorities in Gujarat reported that samples of Maiden-manufactured Macipro, a drug containing the popular antibiotic ciprofloxacin, had failed the dissolution test. In 2021 and early 2022, Kerala authorities found Maiden's products to be of substandard quality by at least five times.

Two sets of tablets of metformin – used to treat type-2 diabetes – from a hospital in

from a primary health centre in Ernakulam in September 2022 had failed the dissolution test, according to a news agency

The Central Drugs Standard Control Organisation (CDSCO) has sent the samples of the same batch of the four Maiden Pharmaceuticals Ltdmanufactured cough syrups, on which the WHO issued alert, for testing. The Union Health Ministry has said that the further course of action in the matter will depend on the CDSCO probe outcome.

"The samples (controlled samples of the same batch manufactured by M/s. Maiden Pharmaceuticals Ltd for all the four drugs in question) have been taken and sent for testing to Regional Drug Testing Lab, Chandigarh, by the CDSCO, the results of which will guide further course of action as well as bring clarity on the inputs received, to be received from WHO," said the Ministry in a statement here.

The CDSCO in its preliminary report has said that it has been found that Maiden Pharmaceuticals is a manufacturer licensed by the State

Drug Controller for products Promethazine Oral Solution BP, Kofexnalin Baby Cough Syrup, MaKoff Baby Cough Syrup, and MaGrip n Cold Syrup under reference, and holds manufacturing permission for these products for export only. The company has manufactured and exported these products only to The Gambia. "As per the MoP on appointment of Chief Justice of India and Supreme Court Judges, today the Hon'ble Minister of Law and Justice sent a letter to the Hon'ble Chief Justice of India for sending his recommendations for appointment of his successor," the Ministry of Law and Justice said in a tweet, which many believe is the first such instanc.

According to the Memorandum of Procedure (MoP), the CJI names the

senior-most judge as his or her successor. The MoP is a document which guides the appointment and transfer of Supreme Court and high court

Justice D Y Chandrachud is the senior-most judge after the CJI. Going by the established practice and convention, Justice Chandrachud would be the 50th CJI and take oath on November 9.

He would have a tenure of two years and demit office on November 10, 2024. While Supreme Court judges retire after attaining the age of 65, high court judges retire at 62 years.

Incidentally, Chief Justice Lalit's move to get four Supreme Court appointments cleared by circulating a written proposal has been opposed

The CBI on Friday filed a chargesheet against former Railways Minister Lalu Prasad Yadav, ĥis wife Rabri Devi and 14 others in connection with an alleged land-for-jobs scam during his tenure in the Railways.

Yadav's daughter Misa Bharti and former general manager Sowmya Raghvan of the Railways have also been named as accused in the charge sheet, officials said.

Kamal Deep Mainrai, the then CPO, Railways, substitutes Rajkumar Singh, Mithlesh Kumar, Ajay Kuma, Sanjay Kumar, Dharmendra Kumar, Vikas kumar and Abhishek Kumar besides private persons Ravindra Rai, Kiran Devi, Akhileshwar Singh and Ramashish Singh have also been named as accused in the chargesheet, officials said.

The agency had registered a Preliminary Enquiry on September 23, 2021 related to the alleged land-for-jobs scam



in the Railways which was converted into a Regular Case or an FIR on May 18.

Candidates were allegedly appointed as substitutes in group D positions within three days of applying in "undue haste" by Railways officials and were later, regularised when the "individuals themselves or their family members transferred their land" to the accused persons, according to the agency.

Scavengers to take final bow as 'Bandicoots' do the job

Manual Scavenging, a job that claims hundreds of lives across the country every year, is coming to an end and that too soon. The profession looked down by the society and categorized the workers into untouchables would soon be buried for ever and the present day manual scavengers are all set to take a new avatar as technology professionals thanks to Bandicoot, an innovation developed by a group of young engineers based in

Thiruvananthapuram. True to its name, the Bandicoot itself would go into manholes and clean the entire sewage clogged in the area while its "masters" manipulate and manoeuvre the system with robotic arms and instruments. "Bandicoot is a robot developed start-up

Thiruvananthapuram's Technopark and it would do away with manual scavenging once and forever. Bandicoots, designed and manufactured by us are in use in cities like Indore, Surat, Vadodara etc," said Afsal Muttikkal, the young chief marketing officer of Genrobotics, the start-up firm and one of the founders of the company

He said the robot is capable of cleaning ten manholes in day compared to three or four by human beings. "The Bandicoot



all sectors of the process. They will tackle solid waste clogging in sewers effectively than any other machines or humans. You can take it from us, the days of manual scavenging are coming to an end and for ever," Afsal told The Pioneer.

The fact that Bandicoot walked away with the top honours in the Swachhata Start-Up Challenge underscores the observation by Afsal. What makes it distinct is its capability to warn the users of any hazardous emissions from below. "These machines are fitted with gas sensors to provide warning about any kind of hazardous emissions," he said.

When Afsal and his colleagues in the engineering college, M K Vimal Govind, K Rashid, Arun George, and N P Nikhil set out for the long journey of life, they decided to do something revolutionary and the age-old scavenging is coming to an end because of this silent revolution. "We are indebted to the Union Ministry

for the support given to us. It was at their initiative the Governments of Madhya Pradesh, Gujarat and 14 other States chose Bandicoots and the result is there to see," said Afsal.

Bandicoot could be one of the reason behind Indore emerging as the cleanest city in the country by topping the survey Swachch Survekhan 2022 held by the Union Government. The second and third prize winners, Vadodara, Navi Mumbai and even Ulhas Nagar in Maharashtra too have deployed Bandicoots for scavenging jobs.

According to Afsal, more than 1700 sanitary workers have been shifted to higher levels of their jobs and the process was on to eliminate the manual work at the earliest.

Aziz Shaikh, the young municipal commissioner of Ulhas Nagar says his corporation made considerable savings through the deployment of Bandicoot as part of eliminating manual scavenging.

Gujarat police chief orders probe into Kheda flogging incident

The Gujarat police chief has ordered a probe into an incident where cops were caught on camera allegedly publicly flogging a few Muslim community members accused of hurling stones at garba dance participants in Kheda district, while a voluntary group has sent legal notices to the Chief Secretary and the Director General of Police (DGP) over the issue. DGP Ashish Bhatia ordered the probe after videos of the flogging incident surfaced on social media and the authorities took cognisance of the widely circulated clips, officials said on Friday. Kapadvanj Deputy Superintendent of Police V N Solanki has been asked to conduct the inquiry and submit a report.

"Late last night, I was given the responsibility of conducting the inquiry into the incident. I will submit my report as soon as possible," Solanki told PTI. However, he declined to provide details about the policemen allegedly involved in the flogging incident earlier this week. Seven persons, including a policeman, were injured after a mob comprising members of the Muslim community allegedly hurled stones at a garba dance event organised as part of Navratri cel-

ebrations at Undhela village of

Kheda district on Monday night.

The attackers objected to the event being organised near a

The next day, videos sur-faced purportedly showing police personnel publicly flogging three of the 13 accused arrested in the stone pelting case with a baton by holding them against an electric pole at an intersection in Undhela village. Of the 13 alleged attackers arrested for stone pelting, police had sought the remand of three. A court in Kheda on Wednesday sent them to two-day police remand, while 10 others were sent to jail under judicial cus-

According to the public prosecutor, two of the accused complained to the judge regarding the police action, following which the judge ordered their medical examination.

The viral video clips purportedly showed three men being brought out of a police van near the event venue on Tuesday before being taken towards an electric pole and held against it by a policeman, who pulled their hands. Another policeman can be seen hitting them below the waist with a baton. The images showed the alleged attackers apologising to the people gathered at the spot with folded hands after policemen asked them to do so. People present in a large number at the site cheered the police action.

Quality in the pharmaceutical sector should be enforced without resorting to inspector raj

fter the World Health Organization (WHO) warned that it suspected four cough syrups could be linked to the deaths of 66 children in Gambia, the Delhi-based manufacturer, Maiden Pharmaceuticals, is in the news. The syrups, the WHO said, have been "potentially linked with acute kidney injuries and 66 deaths among children." The global body also suspects that the syrups were contaminated with diethylene glycol or ethylene glycol, both of which are toxic substances. The Central Drugs Standard Control Organisation (CDSCO) has sent the samples of the four syrups—Promethazine Oral Solution BP, Kofexnalin Baby Cough Syrup, MaKoff Baby Cough Syrup and MaGrip n Cold Syrup for testing to the Regional Drug Testing Lab, Chandigarh, and the Central Drugs Laboratory, Kolkata, for examination. The CDSCO has also launched a probe into the matter. Meanwhile, the Union Health Ministry has announced that none of these four drugs are being sold in India currently. In fact, the Ministry pointed out that Maiden Pharmaceuticals does-

n't have the permission to sell these syrups in India. Naresh Kumar Goyal, one of the directors at Maiden, told a news agency that the company came to know about the deaths only on Thursday morning.

One hopes that the investigation ordered by the Government will expose the culprits if the wrongdoing was done in India at any level. The past record of Maiden Pharmaceuticals, however, is not spotless. Many state governments have reportedly questioned its quality control standards in the past. Bihar, for instance, blacklisted it in 2011 for supplying substandard drugs. Maiden Pharmaceuticals was penalised in Kerala in 2017. In Sonipat too, the company faced prosecution for quality violations. In 2014, Vietnam

blacklisted Maiden, along with 38 other companies for violating quality control and drug regulations. Yet, Maiden's website says, even after the tragedy in Gambia, that it "is a WHO-GMP & ISO 9001-2015 certified pharmaceutical company." The CDSCO is carrying out the investigation into the deliveries Maiden made to Gambia, but the organisation (CDSCO) also has to do some explaining. Why did it take the death of scores of children to launch an investigation into a company whose history is littered with a string of violations? Why wasn't it done earlier? How did it get the certifications that it claims it has? If the claim is false, how is the company allowed to make such a claim? Besides, what were the other authorities doing? As per a CDSCO estimate in 2018, around 4.5 per cent of all generic drugs in the Indian market were substandard. A year later, the US Trade Representative office on intellectual property rights protection in 2019 said that up to 20 per cent drugs in India were counterfeit. With the Gambia tragedy, Indian drugs may be viewed with suspicion, which will have an adverse effect on the domestic pharma industry. It is time the authorities in our country enforced quality in the pharma sector without augmenting the incidence of inspector raj.

he death of former CPI(M) Kerala secretary Kodiyeri Balakrishnan and the ban-related issues of the Popular Front of India, came in handy for the CPI, I the poor cousins of the former, to tide over the dilemma of an internal struggle that cropped up during its State Conference held at Thiruvananthapuram last week. Though Kanam Raiendran, the reigning State Secretary was re-elected unanimously, many delegates went back sobbing for being left out of the State Council. Even the presence of D Raja, the national secretary of the party failed to minimise the dissident activities, something unheard of in the CPI. C Divakaran and K E Ismail, the main challengers to Rajendran, were dropped out of all decision-making bodies citing the fact that

> both have crossed the age limit of 75. Divakaran declared that he would die as a CPI member though his dream of becoming the party secretary was shattered.

Raja went to the extent of repeating the willingness of the CPI to merge with the CPI(M). But the CPI(M) which was formed by the 32 members of the CPI national council who walked out in protest against the stance of the parent party vis-à-vis the then Soviet Union and China, remained indifferent to the plea. Though both the CPI and the CPI(M) are in the same front since 1980, the Marxists, the more leftist than the parent party, have not pardoned the CPI for its

cohabitation with the Congress till 1980. The CPI enjoyed the chief ministership of Kerala from 1969 to 1980 with the support of Congress. C Achutha Menon and P K Vasudevan Nair were sworn in as chief ministers with the support of the Congress and the Muslim League. Though there are no ideological differences between the two Communist outfits, the CPI(M) has no love lost towards its mother organisation despite the open invitation by the CPI leaders for the merger. The truth is that the CPI is a party of leaders while the CPI(M) has a vast cadre. The Marxists are not interested in carrying extra baggage which is of no use for it. Though secularism and socialism would get a shot in the arm by the merger of two parties, the CPI reminds one of "Barkis is Willing" syndrome in Charles Dickens's novel David Copperfield.

he war in Ukraine, the new focal point of global concern, has pushed developments Myanmar to the fringes of awareness from where they hardly impinge on public consciousness. And this is even though the most terrible things continue to happen in that country. On September 29, 2022, a court in Myanmar, in a trial whose procedures were customized to produce spurious verdicts, sentenced Aung San Suu Kyi, the iconic symbol of Myanmar's democratic aspirations, to three years imprisonment on the trumpedup charge of breaching the country's Official Secrets Act. Also sentenced with her by the same court and on the same day, was Sean Turnell, associate professor of economics at Sydney's Macquarie University, who was an advisor to her when she was in office. In a sentence to run concurrently, he was also given three years in prison for violating the country's immigration laws. Three other former ministers in her government were also sentenced to three years imprisonment on September 29, 2022, for breaching the Official Secrets Act.

Aung San Suu Kyi has already been sentenced to over two decades in prison on trumped-up charges including those of illegally importing and possessing walkie-talkie sets, violating coronavirus restrictions, sedition, fraud, and five corruption cases. She is being tried on a further seven counts under Myanmar's anti-corruption laws and can be punished with up to 15 years in jail on each. She can be imprisoned for nearly 200 years if convicted of all the charges, including the above seven, leveled against her.

The purpose is to finish her off politically. Unfortunately, not a squeak has been heard from the eaders of the world's democracies about her latest round of sentencing. The Australian government has strongly taken up Sean Turnell's case from the beginning. bresent instance, the country's foreign minister, Penny repression, opposition to the Wong has rejected the court's rul- junta has understandably

ing and called for his immediate release. Describing his detention as unjust and stating that Australian diplomats were denied access to the court's hearing, her office said in a statement, "We will continue to take every opportunity to advocate strongly for Professor Turnell until he has returned to his family in Australia."

The latest sentences are a part of Myanmar's junta's efforts to continue in power, which it usurped by a coup on February 1, 2021, by the ruthless suppression of opposition at all levels. Among those killed were four pro-democracy activists and leaders, including a former legislator, executed by the Junta, most probably by hanging in Yangon's notorious Insein prison on July 23, 2022.

Simpson adds that while these figures were difficult to verify, it was clear that most of the country was now in open revolt against the Junta. Those fighting for democracy in Myanmar, however, have a difficult road ahead. The People's Defence Force lacks numerical strength besides heavy artillery, tanks, and aircraft, essential for winning large battles in the plains. The junta will eventually end up in history's dustbin, but not before inflicting immense suffering on Myanmar's people.



Tough triangular fight looms large in Gujarat



At best, the Aam Aadmi Party may bruise BJP, at worst sear Congress. A good showing will see AAP's stock soaring

bitter battle lies ahead as the Congress and the Aam Aadmi Party (AAP) brace to take on Narendra Modi's Bharatiya Janata Party (BJP) in its citadel of Gujarat this state Assembly election which is due in

For the Prime Minister, Gujarat must be convincingly retained if the 2024 electoral war for the right to rule India has to be waged handicap-free for a third stint. The Congress, which has been steadily losing ground since Modi took charge in 2001, must hold its consolidated Opposition space as a brash-bubbly challenger AAP seeks to muscle into both menacingly.

AAP, the third angle of this emerging triangular contest, has nothing to lose for it was nil in 2017. At best, it may bruise the BJP, at worst sear the Congress. A good showing, on the other hand, will see its stock soaring. Thus the Gujarat poll paradigm is pregnant with possibilities and stocked with probabilities.

The Election Commission has completed its due diligence through overlapping visits and is into the final assessment of preparedness. Speculation is rife that the elections to Gujarat as well as Himachal Pradesh may be declared in the middle of the month bringing the model code of conduct into force. This will bring to an end the rash of foundation stone laying ceremonies and inaugurations by the ruling BJP and mouth-watering promises by the respective rivals.

The BJP has been in the saddle in Gujarat for 27 years, barring a 17-month stint wherein party rebel Shankersinh Vaghela's splinter held fort with Congress support.

Now considered the home state of the Prime Minister and his Home Minister Amit Shah, the two cannot afford to take any chances. Thus, they have one foot permanently pegged in their realm, enmeshed in all manner of inaugurations and dedications from flyovers to foot bridges. More so, after Arvind Kejriwal and his AAP turned the spotlight full scale on their electoral challenge.

The Congress is waking up to the harsh reality of a triangular fight as the AAP seeks to muscle its way into Gujarat. With Rahul Gandhi pre-occupied with the Bharat Jodo Yatra, the likelihood of Priyanka Gandhi Vadra taking his place in helming the Congress challenge is being speculated in party circles, though no official confirmation is available.

A late starter in comparison to the Prime Minister and Arvind Kejriwal, Rahul Gandhi arrived in Ahmedabad on September 5 to flag off the Congress election campaign, addressing a gathering of

over 50,000 booth level workers. Party leaders are emphatic that Rahul Gandhi still remains a strong crowd puller for the party. Though the Kanyakumari-Kashmir Bharat Jodo Yatra will give the state a miss, the traction that it has been gain-

The Congress is not leaving anything to chance. Party general secretary KC Venugopal was in Ahmedabad on August 24 for a review of the preparedness with state leaders and senior observer Ashok Gehlot and Gujarat in-charge Raghu Sharma.

The Congress has named seven working presidents, appointed incharges from Maharashtra, Rajasthan and Chhatisgarh to oversee each one of the 26 parliamentary constituencies in the state, and assigned four other leaders to assist Sharma with Gehlot overseeing things. The Rajasthan Chief Minister was the Gujarat in-charge in the 2017 state Assembly elections and is well conversant with make or break nuances.

According to present Gujarat in-charge Raghu Sharma, the Congress is targeting 125 of the total 182 seats but does not propose to announce a chief ministerial candidate. "We shall fight collectively," he adds.

Party national spokesperson Shaktisinh Gohil holds firm that the main contest is between the two traditional combatants, and AAP will not add up to much because a third party has never succeeded in Gujarat. Gohil has a point, since such veteran leaders like Chimanbhai Patel (Kisan Paksha), Mazdoor Lok Shankersinh Vaghela (Rashtriya Janata Party, Jan Vikalp and this time the Prajashakti Democratic Party), and veteran late Keshubhai Patel (Gujarat Parivartan Party) have all come a cropper.

However, the AAP's aggressive forays and the response it is beginning to elicit seem to be making enough dent for BJP to take the threat seriously. The Prime Minister is personally overseeing things and on his last two visits to the state on August 27 and September 29 had detailed discussions with those helming the party's election affairs.

The main reason for both the BJP and the AAP targeting the Congress is that the principal Opposition party had picked up 30 of the total 54 seats in Saurashtra-Kutch region, helping it bag a creditable 78 seats while bringing the BJP to 99 seats in a 182-member House, the lowest after Modi took over as chief minister in 2001. In 2012 the BJP had bagged 35 seats in Saurashtra-Kutch but was down to 23 in 2017 with one going to others.



In north Gujarat both the BJP and the Congress had maintained their previous seat share in 2017 with 32 and 21 seats, respectively. In south Gujarat, the BJP had faced a marginal loss winning 25 of 35 seats compared to 28 in 2012, while the Congress improved its seat share from 6 to 10.

In central Gujarat, the BJP scored with 25 of 40 seats, while the Congress was down by 5 to 13 seats in 2017. The last elections were held in the shadow of the Patidar unrest and the Congress had emerged as a beneficiary at the polls. This factor does not seem to be at play in 2022 but rising prices and agrarian dissatisfaction is evident in rural areas which the BJP is hopeful of leveling up with what it sees as its urban popularity.

If the AAP has a sackful of sops that include 300 units of free electricity every month, free education in government schools and free medical care in government hospitals, unemployment allowance, a Rs 1,000 per month allowance to women, the Congress has announced all this and more. It includes LPG cylinders for Rs 500, Rs 4 lakh compensation for Covid victims and loan waivers up to Rs 3 lakh for farmers. How much of this works remains to be seen but the Congress will need to strain a

Missiles, drones hit Zaporizhzhia again as death toll rises

→he death toll from a missile attack on apartment buildings in a southern Ukrainian city rose to 11 as more Russian missiles and for the first time — explosive packed drones targeted Ukrainian-held Zaporizhzhia on Friday.

As the war sparked by

Russia's February invasion of its neighbour ground on, the Norwegian Nobel Committee awarded the Nobel Peace Prize to human rights organisations $\,$ in Russia and Ukraine, and an activist jailed in Russian ally Belarus.

Asked by a reporter whether the prize shared by Belarus rights activist Ales Bialiatski, the Russian group Memorial and the Ukrainian organization Center for Civil Liberties should be seen as a "birthday gift" to Russian President Vladimir Putin, who turned 70 on Friday, committee chair Berit Reiss-Andersen

"The prize is not addressing President Putin, not for his birthday or in any other sense, except that his government, as the government in Belarus, is representing an authoritarian government that is suppressing human rights activists," Reiss-Andersen said.

Putin this week illegally claimed four regions of Ukraine as Russian territory, including the Zaporizhzhia region that is home to a sprawling nuclear power plant under Russian occupation; the city of the same name remains under Ukrainian control.

With its army losing ground to a Ukrainian counteroffensive in the country's south and east, Russia has deployed Iranian-made drones to attack Ukrainian targets. The unmanned, disposable "kamikaze drones" are cheaper and less sophisticated than missiles but have proved effective at causing damage to targets on the ground.

The regional governor, Oleksandr Starukh, said Iranian-made Shahed-136 drones damaged two infrastructure facilities in the city of Zaporizhzhia, the first time they were used there. He said missiles also struck the city again, injuring one person.



S-300 missile strikes on the city a day earlier rose to 11 and The Émergency Services of another 21 people were res-

cued from the rubble of destroyed apartments.

"This was not a random

aimed at multi-story buildings," Starukh wrote on his Telegram channel.

Russia was reported to

have converted the S-300 from its original use as a long-range antiaircraft weapon into a missile for ground attacks because of a shortage of other, more suitable weapons.

The Ukrainian military said most of the drones it shot down Thursday and into Friday were the Iranian-made Shahed-136. The weapons are unlikely to significantly affect the course of the war, however, the Washington-based Institute for the Study of War

"They have used many drones against civilian targets in rear areas, likely hoping to generate nonlinear effects through terror. Such efforts are not succeeding," analysts at the think tank wrote.

Meanwhile, Ukraine's abil-

ity to capture and put back into service Russian tanks and other equipment continues to be an important factor in its forces' push to repel the inva-

"The failure of Russian crews to destroy intact equipment before withdrawing or surrendering highlights their poor state of training and low levels of battle discipline," the British said.

"With Russian formations under sever strain in several sectors and increasingly demoralized troops, Russia will likely continue to lose heavy weaponry."

The Ukrainian military

also said Friday that 500 former criminals have been mobilized to reinforce Russian ranks in the eastern Donetsk region, where Ukrainian forces have retaken some territory. The new units are commanded by officers drawn from law enforcement, the military said.

US President Joe Biden warned Thursday that Putin has driven the risk of nuclear "Armageddon" to the highest level since the 1962 Cuban Missile Crisis. Russian officials have spoken of the possibility of using tactical nuclear weapons to defend Russia's territory, including the newly annexed regions of Ukraine.

Speaking at a fundraiser for the Democratic Senatorial said Putin was "not joking when he talks about the use of tactical nuclear weapons or biological or chemical

weapons. Turkish President Recep Tayyip Erdogan held another telephone call with Putin on Friday to discuss bilateral ties

and the war in Ukraine. Erdogan told Putin that Turkey was ready to fulfil its part for a "peaceful resolution of the Ukraine issue in a manner that would be to the benefit of everyone," according to a statement from the Turkish

leader's office.
In the Czech capital, European Union leaders converged on Prague Castle to try to bridge significant differences over a natural gas price cap as winter approaches and Russia's war on Ukraine fuels a major energy crisis.

As the Europeans bolster their support for Ukraine in the form of weapons, money and aid, Russia has reduced or cut off natural gas to 13 member nations, leading to surging gas and electricity prices that could climb higher as demand peaks during the cold months.

Putin's path: From pledges of stability to nuclear threats

As he turns 70, Russian President Vladimir Putin finds himself in the eye of a storm of his own making: His army is suffering humiliating defeats in Ukraine. Hundreds of thousands of Russians are fleeing his mobilisation order, and his top lieutenants are publicly insulting military lead-

With his room for maneuvering narrowing, Putin has repeatedly signalled that he could resort to nuclear weapons to protect the Russian gains in Ukraine — a harrowing threat that shatters the claims of stability he has repeated throughout his 22-year rule. "This is really a hard

moment for him, but he can't accuse anyone else. He did it himself," said Andrei Kolesnikov, a senior fellow at the Carnegie Endowment. "And he is going straight ahead to big, big problems."

By unleashing the disastrous war in Ukraine, Europe's largest military conflict since World War II, Putin has broken which Russians tacitly agreed to forgo post-Soviet political freedoms in exchange for relative prosperity and internal stabil-

Mikhail Zygar, a journalist who has had extensive contacts among the Kremlin elite and

published a bestselling book about Putin and his entourage, noted that the invasion came as a complete surprise not only for the public but for Putin's closest associates.

"All of them are in shock," Zygar said. "None of them wanted to see the developments unfold in such a way just because they are going to lose everything. Now they are all stained by blood, and they all

With the Russian army retreating under the blows of Ukrainian forces armed with Western weapons, Putin raised the stakes by annexing four Ukrainian regions and declaring a partial mobilisation of up to 300,000 reservists to buttress the crumbling front line.

Europe hails united stand over Russia's war in Ukraine


eaders across Europe hailed on Thursday their united front against Russia's war on Ukraine at a summit that also saw the heads of old foes Turkey and Armenia meet face-to-face for the first time since they agreed last year to put decades of bitterness behind them. The inaugural summit of

the European Political Community brought together the 27 European Union member countries, aspiring partners in the Balkans and Eastern Europe, as well as neighbours like Britain — the only country to have left the EU.

Russia was the one major European power not invited to the gathering at Prague Castle along with Belarus, its neighbor and supporter in the war against Ukraine; a conflict fueling an energy crisis and high inflation that are wreaking havoc on Europe's economies.

"Leaders leave this summit with greater collective resolve to stand up to Russian aggression. What we have seen in Prague is a forceful show of for the principles of freedom and democracy," said U.K. Prime Minister Liz Truss.

Her Belgian counterpart, Alexander De Croo, said "if you just look at the attendance here, you see the importance. The whole European continent

Russian President Vladimir Putin got an unusual gift for his 70th birthday on Friday: As the leaders of several ex-

Soviet nations met at the Czarist-era Konstantin Palace in St. Petersburg, President Alexander Lukashenko of Belarus presented Putin with a gift certificate for the vehicle. Tractors have been the pride of Belarusian industry since Soviet times. Lukashenko, an autocratic leader who has ruled the ex-Soviet nation with an iron hand for nearly three decades while cultivating a man of the people image, told reporters he used a model in his garden similar to the one he gifted Putin.

It wasn't clear how the Russian leader responded to the gift, which Lukashenko's

office revealed. Putin didn't mention the gift in televised remarks at the start of the meeting when he talked about the need to discuss ways of settling conflicts

between ex-Soviet nations. He also emphasised the need to exchange information and other crime.

The leaders Commonwealth Independent States, a loose alliance of ex-Soviet nations, have another gathering to attend next week in Kazakhstan's capital of Astana.

UN rights body agrees to appoint expert to scrutinise Russia

The UN's top human rights body voted Friday I to appoint an independent expert to step up scrutiny of Russia's rights record at home as arbitrary arrests, a crackdown on dissenting voices and limits on free speech worsen during the war in Ukraine.

The 47-member Human Rights Council passed the proposal, presented last week by all European Union member countries except Hungary, on a 17-6 vote, with 24 abstentions. Shortly before the vote in Geneva, Russian human rights group Memorial was named a cowinner of the 2022 Nobel Peace Prize.

The original proposal expressed concerns about "mass forced shutdowns" of independent media, non-governmental organisations and opposition groups in Russia.

The Human Rights Council majority agreed to name a "special rapporteur" to keep tabs on rights violations in Russia, in part by relying on help from Russian groups and activists who are both still in the country and abroad.

It's the first time the council has authorized a special rapporteur to look into human rights issues in any of the five countries that are permanent members of the U.N. Security Council: Britain, China, France, Russia and the United

Russian ambassador Gennady Gatilov called the draft proposal a "despicable document" that was intended "to find yet another way of exerting leverage for bringing pressure to bear on

"This scheme by the EU and its allies is yet another attempt to punish our country for pursuing an independent foreign and domestic policy, and to entrench for the long-term the topic of Russia on the agenda of the HRC so as to unleash a stream of false allegations and accusations directed at us," Gatilov said.

Western countries provided most of the votes in favor, joined by Paraguay, Marshall Islands and Ukraine. Diplomats from Bolivia,



China, Cuba, Eritrea, Kazakhstan and Venezuela

voted against the proposal.

The number of abstentions in part reflected hesitations about authorizing a special rapporteur for a country that opposed the initiative: It's unlikely that Russia will let the special rapporteur to visit the country.

The council previously appointed a Commission of Inquiry — the UN-backed body's highest form of scrutiny — that is looking into rights abuses related to Russia's war in Ukraine. The Russian government has taken a number of steps to limit domestic dissent over the war, including passing a law that criminalizes spreading "fake" news about Russia's military. British ambassador Simon Manley said repression at home, aggression abroad" by Russian authorities had increased since Russian forces invaded Ukraine in February.

"The truth is that (Russian) President (Vladimir) Putin uses repressive legislation to restrict freedom of speech and assembly. He crushes dissent through arbitrary detention and violence and has created a climate of fear and intimidation in order to deter civil society and activists from speaking out against the authorities," Manley said.

Russia was a member of the Human Rights Council until earlier this year, when it suspended its participation as the UN General Assembly was set to strip the country of its membership due to the invasion of Ukraine.

UK offers new North Sea oil, gas licenses despite opposition

The British government opened a new licensing round for North Sea oil and gas exploration Friday despite criticism from environmentalists and scientists who say the move undermines the country's commitment to fighting climate change

The Conservative government argues that extracting more fossil fuels from the North Sea will create jobs and strengthen UK energy security, and is less environmentally harmful than importing gas and oil from abroad.

"I know it sounds contradictory - but it's actually good Minister Graham Stuart said.

"When we burn our own gas, it's got lower emissions around its production than foreign gas ... as well as supporting British jobs," he told the

Russia's invasion of Ukraine has pushed gas and electricity prices higher and squeezed energy supplies across Europe, prompting countries to focus urgently on securing new sources.

The organisation that oversees the UK's electricity grid has said that planned blackouts might be needed this winter if the gas-fired power plants that produce 43% of Britain's elec-



tricity can't get enough gas to continue operating.

The UK last saw planned blackouts in the 1970s, during an international oil crisis and

series of coal miners' strikes. The North Sea Transition Authority, or NSTA, said blocks and partial blocks of the North Sea are available, with up to 100 licenses likely to be issued. Priority will be given to four areas off the east coast of England that are known to contain hydrocarbons and are close to existing infrastruc-The government and fossil

fuel industry say drilling for more oil and gas would not undermine Britain's pledge to cut its carbon emissions to net zero by 2050.

"Security of supply and net zero should not be in conflict," NSTA chief executive Andy Samuel said. "The industry has committed to halving and investing heavily in electrification, carbon storage and hydrogen?

Environmentalists say the only way to limit global warming to the internationally approved target of 1.5 degrees Celsius (2.7 degrees Fahrenheit) above pre-industrial levels is to stop extracting fossil fuels.

'The government's claim that burning ever more fossil fuels from the North Sea will help the UK meet its international obligations to become net-zero by 2050 has no connection to reality," UK Green Party co-leader Adrian Ramsay

'Suspect in killing of Sikh family in Lanka's top court California once worked for them'

⊣he suspect in the killing of an Indian-origin Sikh family, including an eight-month-old baby girl, had once worked for the family's trucking business and had a longstanding dispute with them that got "pretty nasty" and culminated in an act of senseless killing, authorities and a relative said.

Merced County Sheriff Vern Warnke said the bodies of 36-year-old Jasdeep Singh, 27-year-old Jasleen Kaur, their eight-month-old child Aroohi Dheri and the baby's uncle, 39year-old Amandeep Singh were found on Wednesday evening in an orchard after they were kidnapped on Monday.

The family, originally from Harsi Pind in Hoshiarpur, Punjab, was kidnapped at a business in Merced County, California.

"The primary suspect in the kidnapping and murder, Jesus Manuel Salgado, is a former employee who used to drive for the victim's trucking company. They had a disagreement and parted ways," a relative of the deceased fami-



ly was quoted as saying by the The relative also revealed

that baby Aroohi Dheri was left for dead and died from exposure, the report said.

Warnke also said that he believes there might be a second person involved in the kidnapping and killings, but investigators are still collecting evidence.

"If that person is watching, might as well turn yourself in," Warnke was quoted as saying by NBC Bay area.
"Our detectives are like

bulldogs. They're not going to give up. Once we find or determine that there was in fact a second person, they're going to go after and go after hard," he said.

The longstanding dispute between Salgado and the victims "got pretty nasty," Warnke was quoted as saying by KTVU television station.

tors that Salgado had sent angry text messages or emails about a year ago after working with a trucking business, Warnke said.

Family members said nothing was stolen from the trucking company but that their relatives were all wearing jewellery. Warnke had said that after the kidnappings, an ATM card belonging to one of the victims was used in Atwater. Public records show the family owns Unison Trucking Inc. And family members said they had recently opened an office for it in a parking lot the Singh brothers also operated, the report

Salgado was officially booked into the Merced County Jail on four counts of kidnapping and four counts of murder on Thursday evening. Deputies say he tried killing himself before being taken

into custody on Tuesday. The report added that Amandeep, the baby's uncle, is survived by his wife and two

kids in their teens. The city of Merced has organised a candlelight vigil for the family every night at 7 pm from October 6 to October 9. On Monday, the family members were kidnapped from a business at the intersection of Dickenson Ferry Road and South Highway 59

in Merced County.

Warnke said that a farm worker near the orchard found the bodies and immediately contacted authorities.

Salgado, already a convicted robber, was previously convicted of first-degree robbery with the use of a firearm in Merced County, as well as attempted false imprisonment and an attempt to prevent or dissuade a victim or witness. He was sentenced to 11 years in state prison in that case, according to the California Department of Corrections and Rehabilitation.

He was released from prison in 2015 and discharged from parole three years later. He also has a conviction for possession of a controlled substance, the corrections agency

allows economic crisis case against Rajapaksas

Sri Lanka's Supreme Court on Friday allowed proceedings of a case filed by a rights group against the Rajapaksa clan, alleging that the members of the erstwhile powerful family were directly responsible for the country's foreign debt and the worst economic crisis.

Transparency International Sri Lanka on June 17 filed a public interest petition, claiming that former President Gotabaya Rajapaksa, his brothers Mahinda Rajapaksa and Basil Rajapaksa, former central bank governor Ajith Nivard Cabraal and top finance ministry bureaucrat S R Attygalle were directly responsible for the economic crisis.

The rights group claimed that the respondents named in the petition were directly responsible for the unsustainability of Sri Lanka's foreign debt, its debt default and the current economic crisis.

The lawyers for the petitioner had argued that the failure to take timely action by the Rajapaksa leadership caused Sri Lanka to go bankrupt and declare that the country was unable to meet its international debt commitments.

The Rajapaksa family had dominated Śri Lanka's political scene for nearly two decades before all the brothers were forced to quit following unprecedented anti-government protests.

The top court's permission came a day after the UN Human Rights Council in

Geneva incorporated Sri Lanka's economic crimes and corruption in its latest resolution calling for accountability for alleged rights abuses coming from 2009.

The resolution has called to investigate the on-going economic crisis and prosecute those responsible.

It also "calls upon the government of Sri Lanka to address the ongoing economic crisis including by investigating and where warranted prosecuting corruption includ-ing where committed by pub-lic and former public officials and stands ready to assist and support independent impartial and transparent efforts in this

India abstained on the draft resolution on promoting reconciliation, accountability and human rights in Sri Lanka which was adopted.

While abstaining, India stressed that it will work with Sri Lanka and the international community to attain the related objectives of legitimate aspirations of Tamils of Sri Lanka and prosperity for all Sri

The draft resolution on 'Promoting reconciliation, accountability and human rights in Sri Lanka' was adopted at the 51st Session of Human Rights Council in Geneva, with 20 nations voting in favour in the 47-member Council, seven against, including China and Pakistan, and 20 abstentions, including by India, Japan, Nepal and Qatar.

Sri Lanka had expressed opposition to the resolution as a violation of its sovereignty other than in 2015 when they co-sponsored the resolution.

Gotabaya Rajapaksa was ousted mid July in a popular public uprising against him for bungling in the economic

Sri Lanka is nearly bankrupt and has suspended repaying its USD 51 billion foreign debt, of which it must repay USD 28 billion by 2027.

Credit guarantee scheme for startups notified: **DPIIT**

The Government has noti-The Government and Infinite field the credit guarantee scheme for startups to provide them collateral-free loans up to a specified limit.

In a notification, the Department for Promotion of Industry and Internal Trade (DPIIT) said that loan/debt facilities sanctioned to an eligible borrower on or after October 6, would be eligible for coverage under the scheme.

"The Central Government has approved the 'Credit Guarantee Scheme for Startups (CGSS) for the purpose of providing credit guarantees to loans extended by member institutions (MIs) to finance eligible borrowers being startups," it said.

This scheme would help provide the much needed collateral-free debt funding to startups, it added.

MIs include financial intermediaries (banks, financial institutions, NBFCs, AIFs) engaged in lending/investing and conforming to the eligibility criteria approved under the Scheme.

Recognised startups that have reached the stage of sta-ble revenue stream, as assessed from audited monthly statements over a 12 month period, amenable to debt financing; and startups that are not in default to any lending/investing



institution and not classified as non-performing asset as per RBI guidelines, are eligible to avail benefits of this scheme.

Maximum guarantee cover per borrower shall not exceed Rs 10 crore. The credit facility being covered here should not have been covered under any other guarantee scheme," the Department said.

For the purpose of this scheme, a trust or fund would be set up by the government of India with the purpose of guaranteeing payment against default in loans or debt extended to eligible borrowers, managed by the Board of National Credit Guarantee Trustee Company Ltd as the Trustee of

India aiming for QF berth, says U-17 women's coach

Head coach Thomas Dennerby has full faith that Indian team will give stronger nations like Brazil and USA a run for their money and qualify for the quarterfinals in the upcoming FIFA U-17 Women's World Cup, starting Tuesday.
India will begin their cam-

paign against the mighty USA on October 11 and play Morocco and Brazil on October 14 and 17 respectively at the Kalinga Stadium here.

"Of course, we're up against absolute top teams, but if we have a really good day and the teams have a little bit weaker outing, there's always a chance for the team coming out like underdogs to win that game," the 63-year-old told reporters during a virtual interaction ahead of the big meet.

"If we can score an early goal against one of these teams, they may get a little bit nervous, get stressed and so on. There's always a chance and if we get a chance we'll take it."

The top two teams from each group will make the cut for the quarters and if their respective senior FIFA rankings are of any indication, then USA are the world no 1. Brazil are in top-10, while Morocco (76) are the only nation below the 58-ranked India in the senior women's rankings.

"Of course, we want to be in the quarters, no doubt about that, and we are going to play with all our hearts. The way to do it is only by focusing on our

He was asked at his prematch press conference on Friday whether that was the blueprint for the future.

"This is not the only system we can play. It was now a 4-4-2. Always when you name systems, it's 'Is it 4-3-3 or is it 4-5-1? Is it 4-4-2 or 4-2-3-1?'

"We don't want to make it more complicated than it is, but there are obviously different systems for us available and we have to choose from now on which one is the best for the next opponent, or the best for us in the moment.

"We have to be more unpredictable, definitely."

Klopp said even though some teams had worked out how to play Liverpool over the past few years, those opponents had often come up short because his own side had been "exceptional".

He said no system was without its weaknesses but he



wanted Liverpool to put doubts in the minds of opponents.

"If you prepare for (playing) us it makes sense that you just have to think twice or three times where there might be something you could use," he

Uruguay forward Nunez has scored just one competitive goal since arriving from Benfica for an initial fee of 75 million euros (\$73 million) in the summer transfer window.

But Klopp, whose side face in-form Arsenal at the Emirates, said he showed some positive signs in the midweek win against Rangers.

"Nevertheless, it's always nice to end the day top of the timesheets.

The home team were cruising at 95-1, but they lost three wickets for five runs, including Warner, as the visitors got back into contention. The dangerous Tim David
