Sisodia: Asked to quit AAP 96% cast vote; Kharge, during grilling; 'lies': CBI

PNS NEW DELH

The CBI on Monday questioned Delhi Deputy Chief Minister Manish Sisodia for over nine hours in connection with a corruption case linked to the now-scrapped excise policy scam. Sisodia is the prime accused in the case.

The CBI investigators quizzed Sisodia on various aspects of the Delhi Government's Excise Policy, Delhi his relations with other accused, including businessman Vijay Nair, and documents recovered during searches in the case, officials said.

After the questioning, Sisodia alleged that this was all part of the BJP's "Operation Lotus" to pressurise him to quit the AAP. He also claimed that the post of the CM was also offered to him. "During the questioning, I was told to leave the AAP and all the cases against me would vanish in a blink of an eye, and would get the post of CM too, or else cases like these would keep getting registered against me," he

Denying Sisodia's charges, the CBI in a statement said,

"CBI strongly refutes these allegations and reiterates that examination of Shri Sisodia was carried out in a professional and legal manner strictly as per the allegations against him in the FIR. The investigation of the case will continue as per

"Manish Sisodia was today (17.10.2022) examined by CBI in connection with ongoing investigation in Delhi Excise Policy case. He was examined

strictly on the allegations in the FIR and the evidence collected so far during the course of investigation. His statement will be verified in due course and further action taken as per requirements of investigation."

Sisodia arrived at the agency headquarters here at 11.15 am and he was taken straight to the first floor of the building where the anti-corruption branch is located, officials said, adding, his interrogation continued till about

Sisodia also said that about Satyender Jain, the AAP leader who is behind bars for the past few months, they told me 'Jain *par konsa sacha* case hai phir bhi vo jail mei hai".

"The questioning was all part of the big conspiracy to make the BJP's Operation Lotus successful in the national

Capital," Sisodia said.
"During the duration of nine hours, I understood that there is no liquor scam, it is just a conspiracy against me by the BJP. It's clear to me that the saffron party is unconstitutionally using agencies like the CBI and the ED to pressure the people to join them," Sisodia said.

Delhi Chief Minister Arvind Kejriwal and senior leaders of his party throughout the day defended Sisodia and claimed he would be arrested to keep him away from cam-

paigning in Gujarat.
"Gujarat results will be out on December 8. These people will keep Manish in jail till then. So that Manish does not go for campaigning in Gujarat elections," Kejriwal tweeted. Continued on Page 2

Voting ended on Monday in the Congress presidential poll amid a high-pitched contest between senior leaders M Mallikarjun Kharge and Shashi Tharoor for the top post about which the incumbent and the longest-serving president Sonia Gandhi said she had been waiting for this day".

"I have been waiting for a long time for this day," Sonia said after voting at the AICC headquarters in Delhi.

The turnout was about 96 per cent, said the AICC office. With the party now set to

name its first non-Gandhi president in over 24 years on Wednesday, senior party leaders, including Rajasthan Chief Minister Ashok Gehlot, stressed the Gandhi family's guidance will be crucial and will play an important role in the party in the days to come.

Both Kharge and Tharoor have emphasised that the Gandhis hold a special place in the party. Kharge has gone to

The new party chief will have to deal with the Rajasthan crisis.


Corona may return with vengeance, fear experts

As India detects a case of Omicron BF.7. next 2-3 weeks crucial as festivals ahead

mid reports that a case of Amu reports that of Omicron "BF.7" has been detected in India, experts have warned that Covid-19 cases could spike after the festive seasons. BF.7 (also known as BA.2.75.2) is a sub-lineage of the Covid Omicron variant BA.5.2.1.

"The next two to three weeks are crucial. Covid-19 is still around, and new variants are being reported in different parts of the world. Obviously, we cannot remain unscathed from them. So, we need to be careful as festivals are a few days ahead," said Dr NK Arora, chairman, National Technical Advisory Group Immunisation (NTAGI).



China has already seen the spread of highly infectious Omicron variants that include BA.5.1.7 strains.

Sore throat, congestion, fatigue, cough and runny nose continue to be the most reported symptoms of this sub-vari-

Reports say that the case (of BF.7 variant) has been detected by the Gujarat Biotechnology Research centre and that the new sub-variant of Omicron is highly infectious and has a greater transmissi-bility. The World Health Organisation (WHO) had warned against the highly infectious BF.7 sub-variant.

White House chief medical adviser Dr Anthony Fauci has already warned that a new, more dangerous Covid variant is likely to emerge this upcoming winter.

New Delhi: The police have arrested two Nigerian nationals involved in allegedly cheating more than 200 people after befriending them on social media. After contacting the victims, Simon Odikpo Onuorah (34) and Koutani Arrisetes Nibaja (34) first pretended to send them gifts, police said. Later, they asked the victims to transfer money in the name of custom duty or other clearance charges, police said. The matter came to light after a woman filed a complaint alleging that she was duped of over Rs 12 lakhs.

New Delhi: The Delhi High Court Monday sought the response of the National Medical Commission. Delhi Medical Council and two government hospitals to a plea by a woman holding several doctors liable for the medical negligence which led to the death of her 15-year-old daughter in 2019.

DENGUE CASES RISE IN DELHI, 1,572 THIS YEAR

New Delhi: The number of dengue cases in Delhi has seen a spike with 635 new infections being reported in the first 12 days of October taking the total tally to 1,572 so far this year, a civic body report said on Monday. Of the total 1,572 cases recorded this year, as many as 693 were reported in September alone. The city had logged 937 cases of dengue this year till September-end, and 635 fresh cases were reported in the first 12 days of October, taking the tally of the vector-borne disease in the city to 1,572, according to the report released by the Municipal Corporation of Delhi (MCD) on Monday.

Defamation case: SC nixes | Teenagers thrashed by Tiwari plea against summons guards in G'gram society

The Supreme Court on Monday dismissed a plea of BJP leader Manoj Tiwari challenging a Delhi High Court order refusing to quash summons of a trial court here against him in a criminal defamation case filed against him by Delhi Deputy Chief Minister Manish Sisodia.

A Bench comprising Justices S Abdul Nazeer and V Ramasubramaniam, however, allowed the plea of BJP leader Vijender Gupta challenging the high court order.

We have dismissed the appeal by Manoj Tiwari and allowed the appeal by Vijender Gupta on grounds that the



history of the law commission report was not properly traced," the bench said.

The private defamation complaint was filed by Delhi Deputy Chief Minister Manish Sisodia against the BJP leaders for allegedly levelling corruption charges against him.

The BJP leaders have challenged a trial court's November

28, 2019 order summoning them and others as accused in the criminal defamation case filed by Sisodia.

Sisodia had filed the complaint against BIP leaders -Members of Parliament Tiwari. Hans Raj Hans and Pravesh Verma, MLAs Manjinder Singh Sirsa and Gupta, and BJP spokesperson Harish Khurana -- for allegedly making cor-ruption charges against him in relation to Delhi government school classrooms.

Sisodia had stated that all the allegations made by the BJP leaders jointly and individually were false, defamatory, and derogatory with an intention to harm and damage his reputation and goodwill.

"When my son along with his friends reached the society gate, the guards posted at the gate of the society and some residents stopped them. My son and his friends waited at the gate of the society for a long time and requested the guards that uncle let us go inside, but the guard suddenly started abusing them," she said.

"When my son protested against the abuse, the guards started beating him and also

beat up two friends of my son. Apart from the guards, there were some people who were not in the guard's dress who also threatened to kill my son," she added. Police said the boy is a class 10 student of a private school who informed his parents about the incident after returning from society. His mother rushed to the police with him on Sunday.
Following the complaint an

FIR was registered against unknown security guards of the society under sections 147 (riots), 149 (unlawful assembly), 323 (causing hurt), 506 (criminal intimidation) of the IPC and section 75 of the juvenile justice act at Sector 50 police station on Sunday.

AQI of Delhi poor for 2nd day on account of stubble burning

 $T^{he\;Air\;Quality\;Index\;(AQI)}_{of\;the\;national\;Capital\;on}$ Monday remained "poor" for the second consecutive day and no improvement is likely in the next six days.

According to the bulletin released by the Central Pollution Control Board (CPCB), Delhi's 24-hour average air quality index (AQI) stood at 237 at 4 pm, worsening from 232 at 4 pm on Sunday. It is 247 in Ghaziabad, 286 in Faridabad, 254 in Greater Noida, 232 in Gurugram and 254 in Noida.

As per the Decision Support System of the Indian Institute of Tropical Meteorology (IITM), the transport sector accounted for 19 per cent of PM2.5 pollution in Delhi on Monday.

The Early Warning System of the IITM said the air quality was likely to "remain largely in the poor category" over the next six days.

The System of Air Quality and Weather Forecasting and Research (SAFAR) predicted a peak wind speed of 12 km per hour over the next three days which will lead to only moderate dispersion of pollutants.Data from the Indian Agricultural Research Institute showed a spike in the incidents of stubble burning in

The agrarian state reported 169 farm fires on Saturday,

206 on Sunday and 403 on Monday.

Meanwhile, Commission for Air Quality Management (CAQM) said that the total of 1,695 incidents of stubble burning have been reported this year so far from Delhi, its adjoining states and Punjab as against 3,431 farm fires in the corresponding period last vear.

Punjab has reported 1,444 incidents of farm fires as against 2,375 incidents in the corresponding period last year, the statutory body constituted in 2021 said in a statement.

Haryana has logged 244 fire events as compared to 1,026 in 2021 and National Capital Region (NCR) districts of Uttar Pradesh have recorded only five such incidents as against 30 last year.

Delhi has reported two incidents of stubble burning this year so far. The first paddy residue

burning incident was reported

on September 15 in Punjab, September 18 in Haryana, September 30 in the NCR districts of Uttar Pradesh and October 5 in Delhi, the CAQM The CAQM has been regularly reviewing the situation along with chief secretaries of

Punjab, Haryana, Uttar Pradesh, Rajasthan and Delhi, and secretaries of agriculture and environment departments of these states.

The CAQM stated that centres and cooperatives have been set up in Punjab, Haryana and NCR districts of Uttar Pradesh and more than two lakh crop residue management machinery are available for utilisation.



Following the registration of the FIR, the CBI had conducted searches at the premises of Sisodia and opened his locker at a bank in Ghaziabad.

The FIR has flagged payments in crores allegedly made to "close associates" of Sisodia by Sameer Mahendru -- the owner of Indospirits -- one of the liquor traders actively involved in irregularities in the framing and implementation of the excise policy.

The FIR alleged that Sisodia's "close associates" Amit Arora, the director of Buddy Retail Pvt. Limited in Gurugram, Dinesh Arora and Arjun Pandey were "actively involved in managing and diverting the undue pecuniary advantage collected from liquor licencees" for the accused public servants.

Minor murderer of Ryan boy Mentally-ill man detained for attacking to be tried as adult: JJB

The juvenile accused of mur-L dering a junior boy at Gurugram's Ryan International School, will be tried as an adult, the Juvenile Justice Board (JJB) in Gurugram said on Monday. As per reports, the trial will begin on October 31 at the session court of Gurugram.

The victim's body, with the throat slit, was found in the washroom of the school in the Bhondsi area, While the sevenyear-old victim was referred to as "Prince" by the court, the juvenile accused was called 'Bholu" and the school was referred to as "Vidyalaya".

On July 13 this year, the Supreme Court ordered that the juvenile accused be examwhether he should be tried as an adult or a minor for the alleged crime and remanded

the case to the JJB. The Central Bureau of Investigation (CBI) also argued before the JJB, that the juvenile accused in the murder case must be tried as an adult.

A report from the PGIMS, Rohtak, asserted that "there is no valid test or examination that can retrospectively determine the medical capacity, maturity, and ability of the

accused

Earlier, the JJB board members separately assessed the accused for a few hours to determine his mental state. Counsel for the victim side said, termed it a "turning point" in the case. "The verdict of the board that the juvenile will be historic. The juvenile will now be produced before a sessions court and the judge will then assign the case to the relevant Child Sessions Court for the

trial," he said. He said the verdict meant that the juvenile if convicted, would not be set free after three years and could be sentenced to even 14 years in jail. But as per Section 21 of the JJ Act, he cannot be sentenced to death or life imprisonment."

nine-member panel set up Aby Delhi University last year to study admission trends from various boards, had found that the number of admissions in DU from the southern boards is higher than from Haryana, Uttar Pradesh, and Punjab State boards despite them being Delhi's neighbours. Among state boards, the

percentage of students from Bihar seeking admissions at DU has doubled this year. The percentage of students from CBSE seeking admission in undergraduate programmes at Delhi University has gone up by nearly 1.5 per cent as against last year, even as applicants from other state boards including Kerala and Haryana registered a considerable dip. The



declined by nearly 40 per cent this year. Students from Kerala board, who are known for scoring 100 per cent marks and bagging seats at prestigious DU colleges, have dropped from 4,824 to 1,847. The admission to several soughtafter programmes in DU this year are being done through Common University Entrance the traditional merit lists based on class 12 marks which without fail saw sky-rocketing cut offs in past years. The varsity has witnessed a decline of a total of 1,12,078 paid registrations this year compared to the previous year. As many as 1,75,149 students have registered for this academic session against 2,87,227 students in

2021, according to the data provided by the university. Last year, registration was open from August 2 to August 31. However, this year registration portal was opened on September 12 and closed on October 13. The DU began admissions for over 70,000 seats last month. Like the previous year, the

maximum applications are from CBSE students. This year, the total number of applicants from the board is 1,42,473. Last year, the number of applicants was 2,29,264.

If the ratio of students from CBSE board with respect to the total number of applications is compared, the number has gone up by 1.43 per cent. Last year, CBSE students accounted for over 79.8 per cent of the total applicants. In 2022, CBSE students account for 81.34 of the total applicants. This implies that though the number of applicants at Delhi University has declined, the percentage of CBSE applicants have increased.

Among state boards, the applicants from Bihar School Examination Board (BSEB) have increased from 4,470 in 2021 to 5,305 in 2022. These students account for three per cent of the total applicants this year, as compared to 1.5 per cent the previous year. Meanwhile, the number of applicants from Haryana board has come down drastically from 9,918 (2021) to 1895 (2022). Last year, Haryana stood second after CBSE in terms of the number of applicants among all boards. This

year, it has come down to sixth

Haryana applicants has dropped from 3.4 per cent to

1.08 per cent. After CBSE, the maximum number of applicants are from Council for the Indian School Certificate Examination (CISCE) with 6,774, which is 2,885 less than the previous year. As many as 2,430 students from Boards of Secondary Education, Rajasthan have applied for undergraduate programmes at the varsity.

This is nearly half the number of applicants (4789) from the board in 2021. Following a steady trend, only 958 students from Jammu and Kashmir State Board of School Education filled out the applications for Delhi University this year. Last year, the number of applicants was 1,806.

The Ministry received a report on Sunday from the Andaman and Nicobar Police regarding the alleged sexual assault of the 21-year-old woman by Narain, when he was serving as the Chief Secretary there, and another officer. As the report indicated the possibility of grave misconduct and misuse of the official position on the part of

While 163 drones will be deployed for high altitude areas the remaining 200 UAVS are meant for medium altitude, they said adding all the drones will come through the fast track procedure.

The RFP for buying 200 medium-altitude drones says the platforms should be capable of withstanding strong

The document says each medium-altitude logistics drone should be able to carry at least 20 kgs of payload and the overall weight of each platform would be around 100 kg.

The weight of the payload for high-altitude logistics drones has been kept at not less than 15 kg. Both medium-alti-tude and high-altitude drones would also have a range of 10 km for delivering payloads,

tance of the topic, they said with the growing prevalence of technology and the rapid rise in digitization, addressing the use of new and emerging technologies for both terrorist purposes and for countering terrorism is an issue of increasing concern for Member States, policymakers and researchers.

The United Nations Security Council has given focus to this issue in a number of counter-terrorism related resolutions, most recently its specifically refers to "emerging technologies".

SC nixes Kerala Govt plea against leasing int'l airport to Adani

The Supreme Court on Monday rejected the plea filed by Kerala Government challenging Central Government's decision to privatise Thiruvananthapuram International Airport and handing over to Adani Group.

A Bench of Chief Justice of India UU Lalit and Justice Bela M Trivedi also rejected the plea filed by Airport Authority Employees Union (AAEU) on The Court said that in


view of the fact the private entity has been managing the operations of the aiport since October 2021, there is no reason to interfere at this stage. "Considering the fact that

the private entity has been in operation since October 2021, we see no reason to entertain the special leave petition. Thus, appeal dismissed," the Court ordered.

However, the Court clarified that the question regarding ownership of land on which the airport is situated, would remain open.

The plea filed by the State

challenged the action of the Airports Authority of India to prefer Adani over the State Government for management of the Thiruvananthapuram Airport. The plea said that the decision was not in public interest and that the entire



proceedings including tender process was vitiated by malafides and also in violation of the provisions of the Airports Authority of India

It was contended that grant of concession to Adani was in violation of an earlier undertaking by the Union Ministry of Civil Aviation rejecting the proposal of the State Government to form a Special Purpose Vehicle (SPV) to take over and run the Airport on a revenue-sharing basis.

It was also contended that granting concession to Adani, who has "no previous experience in managing airports", was violative of the provisions of the Airports Authority of India Act, 1994 as well as proprietary rights of State Government as regards land on which Thiruvananthapuram Airport is situated. The Kerala High Court had, in October 2020, rejected the challenge to the Central government's decision

lease Thiruvananthapuram Airport to Adani Enterprises.


SC notice to RBI on Swamy plea for probe into role in loan frauds

Kerala's total literacy claim is hogwash, says former Mizoram Guv

Human sacrifice is just one face, there are many cruel rituals in Kerala, says Rajsekharan

KUMAR CHELLAPPAN

⊓he April 18, 1991 declara-1 tion by the Government of Kerala that the State has become fully literate was a fraud committed on the people, according to Kummanam Rajasekharan, former Governor of Mizoram.

"By total literacy, what we understand is that the entire population in the State has the capacity to read and write the mother tongue Malayalam. But a major portion of Keralaites are still illiterate and the declaration of the State as fully literate was a 'publicity stunt' by the then Government," the former Governor told The Pioneer. He said the subsequent governments failed to expose this folly and hence they too are part of this fraud.

"Had the entire population

been literate, the State would not have fallen prey to the evil designs of sorcerers like Mohammed Shafi who is the master brain behind the recent 'human sacrifice' in

Pathanamthitta district. Suddenly the police have woken up to the reality that there was widespread sorcery and black magic prevailing in Kerala. Newspapers in the State publish frequent advertisements issued by the sorcerers and black magicians promising prosperity, well being and elimination of enemies," said Rajasekharan.

Suresh Gopinath, a volunteer who had worked in the literacy mission of the then Kerala Government in 1987-1991 agreed that the project was a publicity unleashed by the ruling party. "It is true that we held evening classes to educate the illiterates to write their names in Malayalam and

affix the signature. There was no attempt to teach them Malayalam alphabets. People aged 60 and above were the targeted groups. The claim that the State had achieved total literacy was a hoax," said Gopinath, a financial consultant who had worked as a volunteer teaching the aged people to write their names.

According Rajasekharan, Mizoram, where he was the Governor was much ahead of Kerala in preserving and sustaining the culture of the region. "There are no cases of sexual molestations, abuse of girl children and young girls. Though I was freely accessible to the citizens of the State, no one has come to me with this kind of grievances during my entire tenure," said the former Governor.

He pointed out that Kerala failed to preserve and sustain its culture and heritage and

that is the root cause of all these human sacrifice and sorcery. The former Governor is credited with leading an agitation demanding the ban of the ritual of "Thookkam" (hanging) at Elavoor Devi Temple in Ernakulam district. Flesh of men would be pierced with iron hooks and they would be lifted up with pulley and rope and taken around the temple with a crane-like con-

traption. It was a gruesome site," said Kanchana Menon, a septuagenarian homemaker who has seen it personally. The ritual came to an end only in the 1980s but it is continued as a symbolic style. Rajasekharan says Kerala has still a long way to go before attaining total literacy. "Statistics and indexes are not the indicators of literacy and culture," signed off Rajasekharan.

Learn, not nitpick

Instead of trashing Global Hunger Index (GHI) 2022, Govt should draw some lessons from its findings

n international agency comes up with a report which exposes some unpleasant , fact about India, the Government and the Bharatiya Janata Party slam it on one pretext or the other, and Opposition leaders slam both the Government and the BJP for having failed the nation—this is the pattern that all of us have discerned for quite some time. The Global Hunger Index (GHI) 2022, which showed India slipping six notches, is no exception. The Congress has said that the BJP Government is "living in denial" after GHI 2022 showed that India was ranked at 107 out of 121 countries, lagging behind all South Asian countries except Afghanistan. European NGOs Concern Worldwide and Welthungerhilfe, which brought out the index, have called the level of hunger in India as serious. Typically, the Government trashed the GHI 2022, claiming that it is an effort to taint the country's image and questioning the "serious methodological issues" the index suffers from. The Women and Child Development



Ministry said that three out of the four indicators used for calculation of the index are related to the health of children and cannot be representative of the entire population. The fourth and most important indicator estimate of Proportion of Undernourished (PoU) population is based on an opinion poll conducted on a very small sample size of 3,000. Last year too, the Government had rejected GHI 2021. Women & Child Development Minister Zubin Irani said in a written reply in Lok Sabha on December 3 that the index did not reflect India's true picture as it was a flawed measure of hunger.

There may or may not be serious methodological issues, but dubbing the index as an attempt to taint

India's image smacks of self-righteousness. Instead of making statements that allude to some conspiracy theory, the Government should introspect and scrutinise GHI 2022. And if there are serious flaws with the report, it should interact with the body that prepares the index rather than just dismiss the index with disdain it does not deserve. India's child wasting rate, at 19.3 percent, is the highest of any country in the world, the index says. It also says that child stunting rates in India, Pakistan, and Afghanistan range between 35 and 38 per cent, the highest being in Afghanistan. Now Afghanistan has been a war-torn nation for decades, and Pakistan's economy is tottering, but why is child stunting rampant in our country, the fifth largest economy with political stability, a sprightly entrepreneurial class, a vibrant middle class, and zillion welfare programmes? GHI 2022 talks about a decline in stunting in Chhattisgarh, Gujarat, Odisha, and Tamil Nadu between 2006 and 2016. Stunting fell mainly in response to improvements in the coverage of health and nutrition interventions, household conditions, and maternal factors (such as mothers' health and education). Perhaps the authorities at various levels can draw some lessons from findings of GHI 2022.

The ostrich effect

As the free fall of the rupee against the US dollar continues, the finance minister adds insult to injury.

he finance minister NirmalaSitharaman has earned the ire of social media as well as the opposition for her statement that it is not the rupee that is sliding but the dollar which is strengthening. The finance minister has drawn flak from the opposition especially NCP for her statement in which she defended the rupee rate which has gone past Rs. 82.00 against the dollar. Indeed she added insult to injury as the rupee fall has hit the Indian importers hard and led to rising in prices in the domestic market not to mention the psychological impact of the falling rupee which offsets the margin calculations of the manufacturer's traders and importers. Besides, India's forex reserves went down to USD 532.87 billion in the first week of October from USD 642.45 billion. The Finance minister defended the nose-diving rupee in the US after she attended IMF and World Bank meetings. The rupee has



been in a free fall for a year now and went down 8 per cent against the US dollar. Rupee fell to an alltime low of 82.68 against the US dollar on Monday calling for the Reserve Bank of India's intervention. Many experts feel that the RBI has spent over USD 100 billion in the year to stabilize and check the fall of the rupee. Had it not intervened it could have touched the 100 mark.

There is some merit in what the finance minister has said. The dollar is strong and the currencies of many other emerging countries have gone down too. Though Indian inflation is still manageable others are struggling to fight the

runaway inflation which is a direct impact of their weakening currencies. Having said that it is also a fact that the government has not managed the fiscal deficit well which is also a factor. She is right when she said that the fundamentals of the Indian economy are good. But challenge she has at hand is on two counts, first to offset the losses of the importers due to high dollar cost, and second to keep the inflation within manageable limits. Right now it is single digit but there are ominous signs. The consumer price index inflation in September rose to a five-month high of 7.41 per cent from 7 per cent. She has said that the government is making efforts to bring the inflation to six per cent how that will happen, no one, including the finance minister, has a clue. The finance minister has time and again said that the rupee will eventually find its own level. The big question is what that level would be!

Can new president salvage Congress?



The congress presidential election would do little to fix the party's leadership crisis but it is an interesting event to watch

t the time of writing this, the developments inside Congress are enough to Loutdo the best of television soaps. The Gandhi dynasty, realizing that it needs to present a face as its official president, put forth the octogenarian Mallikarjun Kharge as its preferred choice to act as a family retainer carrying the label of party president. The flamboyant and West-educated Shashi Tharoor, squashing talk of his having withdrawn from the race said that he is very much in what he called a "friendly contest", but described it as a "fight to the finish". Congress veteran and former Madhya Pradesh chief minister Digvijay Singh were reported to have thrown his hat in the ring, only to withdraw soon. Diggy sahib inadvertently let the cat out of the bag when he told a journalist that whoever becomes the Congress president will have to work with the blessings of the Gandhi family. Translated, this reads: the Gandhi dynasty was, is, and will remain the real boss, even if somebody else occasionally gets to sit on the chair.

This is why Rajasthan chief minister Ashok Gehlot, whose loyalty to Sonia Gandhi was not in doubt and who was reportedly her choice to occupy the chair, had no qualms about letting her down. Gehlot's loyal MLAs kicked off a storm in the state unit of the party, threatening to bring down the government if the CM's rival Sachin Pilot was made the chief minister after Gehlot became Congress president. While the internal drama of the Congress may interest journalists and news-watchers, what must engage our attention is why India's oldest political party is so bereft of any leadership outside the Gandhi family, whose political heft has dissipated to the extent that it no longer is taken seriously, leave alone command respect.

Political parties, whether in power or opposition, have a duty towards the country, and more so those parties that have a hoary nistory like the Congress. As it appears, Congress does not seem devoted to this idea. Its only call-

ing card is blind hatred of Prime Minister Modi, which has no place in a democracy. An opponent is an adversary, nothing more. Abuses like "chowkidarchorhai" only betray the speaker's character and pollute the political atmosphere.

The Congress has mostly functioned on the Führer Princip or the leadership principle. From 1921, Mohandas Gandhi continued to dominate the party until 1946. Then it was the turn of Jawaharlal Nehru, especially after Sardar Patel's passing away. He was followed by his illustrious daughter Indira Gandhi and in turn by her son Rajiv Gandhi, who knew or understood little of politics but managed somehow for five years. But he left a dent in the party. The poor man and woman ceased to think it was their party. It was now the organization of the rich who wore Gucci shoes, Rayban glasses, and so on.

However, the Congress was still not seen as an anti-Hindu outfit. After P.V. Narsimha Rao completed his term as prime minister, the party began to slide down that path. The 'consensus' that only a Nenru-Gandhi can noid the party together began to be spoken about more publicly. Thus,

Sonia Gandhi was virtually fished out from the Mediterranean Sea for the presidency of the Congress. She did hold the party together for ten years, also enabling it to return to power, not by hit or miss but by mediocre partiality. The secret was Ahmed Patel, who was loyal to Indira Gandhi right through the Emergency. He was a young MP from Bharuch in Gujarat. Her demands for a political advisor are very tall. Herein lies the knotty issue of the troubles the party finds itself in. It is utterly bereft of any political strategy. Nehruvian to Hindu. What to do in this situation?

Today, the discourse is dominated by productive ideas and the culture of India's homegrown talent in the enterprise. The Congress, with its overwhelming Lutyenism, understandably sees itself as a new and possibly unknown realm. It also has no answer to a formidable giant called Narendra Modi, an entirely self-made leader, whose singular commitment is to the nation, and not any



here was an American boy born with serious mental problems, which afterwards became unmanageable. He was admitted to a hospital. Doctors could only make him sleep but not cure him. As time passed, this case drew wide attention. Many expert psychiatrists, psychoanalysts, etc., were called but nothing worked. Finally, they decided that they really could not help the boy. They called his parents and in a mood of despair told that they had done all they could and now only God can help. The boy's parents took the advice literally and sent him to a known church and entrusted his care to the Father. This priest was exceptional. Years passed and the boy began to improve. Time came when he was considered fit enough to start missionary activities locally. The boy made tremendous progress and was allowed to travel abroad to continue his noble work.

The story tells us that all of us are small intrinsically; material bodies don't make us big. Does it mean that God has been unkind to make us so small? No, it doesn't. The creation cannot exist if we were any bigger. God has to be big, so big that it is incomprehensible. Only then, the creation can exist for any length of time. Fortunately, God is omnipotent, omnipresent and omniscient, and the world goes on.



Let us examine what a normal person does in this set up. I have identified five traits, which are normal to all of us. The first one is our thoughts. The third commonality is our wanting to be feted through birthday parties or generally honoured publicly. Another common characteristic is to be addressed with respect, saluted, etc. And the last one is to take shelter of wealth or of some person or of some material opulence like fame, power, etc.

Lord Krishna instructs, "Develop My consciousness; become My devotee; make sacrifice for Me; and offer obeisance to Me." Did you find similarities in what we normally do vis-à-vis ourselves and what God expects from us to do towards Him. He only expects us to change the direction of our thinking and activities. Whatever we are doing towards ourselves should now be directed towards Him. If we can do that the Lord promises, "You shall attain Me only. This I truly promise to you, because you are very dear to Me." (18.65)

Beginning with thinking endlessly about ourselves, we only harm ourselves. What are worries, anxieties, fears, depression, etc.? How are they caused? Yes, by self-centered consciousness. And when we change our consciousness to God, we become deserving of God's rewards. The next mistake we make is to become our own 'bhakta'.

The third mistake we make is to celebrate our birthdays, etc. We gather a lot of people. Contrarily, if we celebrate God's appearance days then all auspiciousness descends upon us and we qualify for God's munificence. The fourth mistake we make is to expect and even make others salute us. Greetings are fine but 'namaskar' in a formal way is specially meant for God, who alone is really deserving of such respect. Remember how Arjuna began doing many namaskar to Lord Krishna after the Lord displayed His 'Viswa-Roop to him.

≺here is a native American saying, "We do not inherit the world from our ancestors, we borrow it from our children". Our planet has seen unbelievable degradation, especially over the last 300 years after the creation of electricity, which resulted in a motorised world. Mining, manufacturing, transport and shipping all contribute to global warming through different kinds of emissions.

Transport related emissions contribute 30 per cent into all kinds of emissions. Someone might argue that 30 per cent is less and why not attack other sources of pollution like the thermal power plants or ships, and why go after the transport sector? Well, the answer is simple,

first of all there is a law of able to see Dhauladhar exponential margin harm that suggests that each per-centage point increase in level of pollution beyond certain threshold years is proportionate and a reversible harm for the planet and this only increases at higher threshold.

Waves of suicide drones strike Ukraine's Capital, 4 killed

raves of explosives-laden suicide drones struck Ukraine's capital Monday, setting buildings ablaze and tearing a hole in one of them while sending people scurrying for shelter or trying to shoot down the kamikazes.

The concentrated use of the drones was the second barrage in as many weeks — after months where air attacks had become become a rarity in central Kyiv. The assault sowed terror and fraved nerves as blasts echoed across the city. Energy facilities were struck, and one drone slammed into a residential building, killing four people, authorities said.

The drones appeared to include Iranian-made Shaheds. Intense, sustained bursts of gunfire rang out as they buzzed overhead, apparently from soldiers trying to destroy them. Others headed for shelter, nervously scanning the skies. But Ukraine has become grimly accustomed to attacks nearly eight months into the Russian invasion, and city life resumed as rescuers picked through the debris.

Previous Russian airstrikes on Kyiv were mostly with missiles. Mayor Vitali Klitschko said Monday's barrage came in successive waves of 28 drones — in what many fear could become a more common mode of attack as Russia seeks to avoid depleting its stockpiles of long-range precision missiles.

Five drones plunged into Kyiv itself, said Prime Minister Denys

13 were shot down, all of them flying in from the south, said Yurii Ihnat, a spokesman for Ukraine's air

One strike appeared to target the city's heating network, hitting an operations center. Another slammed into a four-story residential building, ripping a large hole in it and collapsing at least three apartments on top of each other. Four bodies were recovered, including those of a woman who was 6 months pregnant and her husband, Klitschko said. An older woman and another man also were killed there.

An Associated Press photographer caught one of the drones on camera, its triangle-shaped wing and pointed warhead clearly visible against the blue sky.

The whole night, and the whole morning, the enemy terrorizes the civilian population," Ukrainian President Volodymyr Zelenskyy said in a social media post. "Kamikaze drones and missiles are attacking all of Ukraine.'

"The enemy can attack our cities, but it won't be able to break

Andrii Yermak, head of the presidential office, posted on social media that Shahed drones were among those used.

"The challenges are serious because the air defense forces and means are the same as they were at the beginning of the war," Ihnat said. Some air defense weaponry supplied by the West can only be used during daylight hours when targets are visible, he added.

Russia forces also struck enerinfrastructure elsewhere on Monday, apparently seeking to compound pressure on Kyiv's government after previous attacks that knocked out power supplies. Shmyhal, the prime minister, said hundreds of settlements were without power after missile attacks on critical infrastructure in the Dnipropetrovsk and Sumy regions.

The nuclear plant, Europe's largest, needs power for critical safety systems. When shelling severs its power supply lines, the plant is forced to fall back on diesel gen-

erators – a temporary stopgap. Russian President Vladimir Putin had said Friday that there was no need for more widespread attacks against Ukraine — after a barrage of strikes earlier in the week that he said were in retaliation for the bombing of a bridge connecting the Crimean Peninsula with the Russian mainland.

However, Putin also said that seven of 29 targets designated after the bridge attack were not hit "the way the Defense Ministry had planned," so Moscow's forces would continue to target them. He didn't specify the targets.

After months during which strikes in central Kyiv were rare, last week's attacks put the country and its capital back on edge.

The strike on Kyiv comes as fighting has intensified in the eastern regions of Donetsk and Luhansk in recent days, as well as the continued Ukrainian counteroffensive in the south near Kherson and Zaporizhzhia. Zelenskyy said Sunday that there was heavy fighting around the cities of Bakhmut and Soledar in the Donetsk region.

EU headquarters said in a statement that the mission's aim is to allow the Ukrainian armed forces to "effectively conduct military operations," so that Ukraine can "defend its territorial integrity within its internationally recognised borders, effectively exercise its sovereignty and protect civilians."

It said that the EU will provide "individual, collective and specialised training."

¬he overarching theme emerging from China's ongoing Communist Party congress is one of continuity, not change.

The weeklong meeting, which opened Sunday, is expected to reappoint Xi Jinping as leader, reaffirm a commitment to his policies for the next five years and possibly elevate his status even further as one of the most powerful leaders in China's modern history.
A look at what's happened so

far, and what's to come:

MORE OF THE SAME

This is not an inflection point for the party. That happened 10 years ago when it named Xi as leader, though it wasn't evident at

Since then, Xi has reoriented China both domestically and internationally. The military has staked claims to disputed territory while diplomats have become more assertive, saying China won't be bullied by the U.S. And others.

Xi has brought back stronger state control over the economy and society, expanding censorship and



arrest to stifle dissent. An unprecedented crackdown on corruption has brought down hundreds of senior officials, including some potential political rivals.

All of that is here to stay was the message from a one-hour and 45minute party report that Xi delivered to the opening session on Sunday, extolling the party's efforts toward what he calls the "rejuvenation" of the nation.

ELEVATING XI Xi has already swept away competitors and consolidated power. The question is whether he will gain even more power — and how.

Impact of policy inflation curb after 5-6 qtrs: MPC

In order to control rising inflation, the RBI on September 30, has raised short-term lending rate for the third consecutive time by 50 bps to take the repo rate to 5.9 per cent.

Since May it has cumulatively increased the key interest rate by 190 bps.

"No doubt it (inflation) will come down. Because we have done monetary policy

tightening. "That tightening will have its impact. The monetary policy takes, you know, five to six quarters to have its impact and cool prices," he told PTI in a telephonic interview.

India's consumer price index (CPI) based inflation in September rose to five-month high of 7.41 per cent from 7 per cent recorded in the preceding month, with the print remaining well above the upper tolerance level of RBI's inflation targeting framework for the ninth

Varma, currently a professor of Indian Institute of Management (Ahmedabad), noted that India's economic growth has actually been depressed for many years now.

"We are not fearing recession to say but growth is not what we would like," Varma

Neymar appears in Spanish court in Barca transfer trial

A few hours after scoring the Winning goal in Paris Saint-Germains victory over Marseille in the French league, Neymar arrived in court in Spain on Monday to face a trial for alleged irregularities involving his transfer to Barcelona in 2013.

Neymar left the Barcelona court about two hours after arriving, without talking to reporters.

Neymar and the rest of the defendants had to be in court for the first day of the trial, but the player is only expected to testify on Friday.

World Cup hosts Qatar will stage the 2023 Asian Cup, Asian Football Confederation said on Monday, after China withdrew earlier this year because of Covid.

China in June 2019 won the bid to host the event but pulled out in May because of its "zero-Covid" policy, leaving the AFC scrambling to find a new host for its flagship men's 24-team football tournament.

The tournament had been due to be held in 10 Chinese cities from June 16 to July 16 next year.

South Korea and Indonesia were the other two countries in the running after China's withdrawal, but Qatar got the nod.

"The Asian Football Confederation (AFC) executive

committee has today confirmed the Qatar Football Association (QFA) as the host association for the AFC Asian Cup 2023," the Malaysia-based AFC said in a statement.

The AFC did not give dates for the Asian Cup. It also said its executive committee has shortlisted India and Saudi Arabia for the 2027 Asian Cup. AFC president Shaikh

Salman bin Ebrahim Al Khalifa said Qatar is ready to put on the event despite the short lead time to prepare. It will also host the World Cup starting next

The Asian Cup is staged every four years. Qatar won the tournament's last edition, in 2019, which was hosted by the United Arab Emirates.

Qatar hosted the 1988 and

ohammad Shami put the concerns over his fitness to rest with a sensational 20th over as India pulled off a six-run win over Australia in their first warm-up fixture of the T20 World Cup here on Monday. K L Rahul (57 off 33) and

Suryakumar Yadav (50 off 33) smashed entertaining half-centuries to power India to 186 for seven after Australia opted to bowl at the Gabba.

Needing 16 runs off the last 12 balls with six wickets in hand, Australia were on course for a comfortable win before Shami, Harshal Patel and Virat Kohli the fielder scripted a turnaround for India.

Shami, who last played a competitive game in July and landed here after suffering a long bout of COVID-19, turned up to bowl the last over of the game and made a decisive impact on the game. He landed yorker after

yorker and ended up with three wickets in the over besides a run out. Shami was drafted into the squad as a replacement for the injured Jasprit Bumrah.

In the penultimate over, under-fire Harshal Patel delivered after being hammered early on, as he conceded only five runs in an over that also included a brilliant run out off a Kohli direct hit.

The star India batter had also plucked a stunning onehanded catch out of thin air at the boundary line to dismiss Pat Cummins.
