Act against hate speech Army chopper with or face contempt: SC

Apex court issues notices to Delhi, UP, Uttarakhand

The Supreme Court on Friday once again came down heavily on authorities for failing to take action against the growing menace of hate speech. Asserting that the Constitution of India envisages a secular nation, the apex court warned any delay on the part of the administration in taking action on this "very serious issue" will invite the court's contempt.

A bench of Justices KM Joseph and Hrishikesh Roy issued notices to Delhi, Uttar Pradesh and Uttarakhand Governments on the petition filed by journalist Shaheen Abdullah and directed them to promptly register criminal cases against the culprits without waiting for a complaint to be filed.

"The Constitution of India envisages a secular nation and fraternity among citizens assuring the dignity of the individual...The unity and integrity of the nation is one of the guiding principles enshrined in the preamble. There cannot be fraternity unless the members of the community from different religions are able to live in har-



sions, no action has been taken and there is a need to serve constitutional principles. We feel this court is charged with a duty to protect the fundamental rights and also protect and serve the constitution where the rule of law is maintained," the top court said.

The apex court said action must be taken against those making hate speeches irrespective of their religion to preserve the secular fabric of the nation. "Respondents 2-4 (the three States) will file a response as to what action has been taken for the speeches highlighted. They shall ensure that as and when any (hate) speech or action takes place, suo motu action is taken in such cases in future without waiting for com-

"The spread of hate towards Muslims and other minorities gets accelerated and becomes all the more far-reaching in its impact as a result of the support, directly or indirectly, extended to radical miscreants, who engage in acts of hate crimes, physical violence as well as communally charged speeches by the ruling political party," he has said in the petition. Smoke billows after an advanced light helicopter of the Indian Army crashed at

An Indian Army helicopter with five personnel, including two pilots on board crashed on Friday, in Arunachal Pradesh, Rescue teams have, so far, recovered two bodies from the crash site and efforts are on to find the others.

The Rudra helicopter crashed at 10.43 am.

The remote area is not connected by any roads. Local village folk are engaged in the rescue operation. Three IAF helicopters are engaged in the operation along with Army

"A military helicopter crashed near Singging village, 25 kilometres away from the Tuting headquarters in the Upper Siang district today. Site of accident not connected by road, rescue team sent. Further details awaited," Defence officials said, adding the helicopter was on a routine sortie.

Upper Superintendent of Police Jummar Basar said the crash site is a mountainous region, and it will take time for the search and rescue team to reach the spot.

The Indian Army's aviation wing has been deploying the Weapon System Integrated (WSI) variant of the Advanced Light Helicopter Rudra in the region adding more teeth to its tactical missions in view of the lingering border row with China in eastern Ladakh.

The multi-role helicopter of 5.8 ton class is a multi-role, multi-mission new generation helicopter. An ALH-WSI had crashed

into the massive Ranjit Sagar reservoir near Pathankot on August 3 last year, killing two Army pilots. In October 2019, a Dhruv

helicopter of the Indian Army carrying the then Chief of the Northern Command Lt General Ranbir Singh and other senior officers had crash landed in Jammu and Kashmir's Poonch.

Between March 2017 and December 2021, 31 people lost their lives in accidents involving 15 military helicopters that included four ALH, four Cheetah, two ALH (WSI), three Mi-17V5, an Mi-17 and a Chetak, according to official details.

The total number of deceased in the 15 accidents included 14 people killed in the December 8, 2021 crash near Coonoor. Then Chief of Defence Staff (CDS) General Bipin Rawat, his wife Madhulika and 12 Armed forces personnel were killed in

HM urges Interpol to plan for next 50 years amid transforming mode of crimes

PNS ■ NEW DELHI

Union Home Minister Amit Shah on Friday exhorted the Interpol to formulate prospective plans for the next 50 years to cope with the changing modes of crimes. He also underscored the need for defining terms like "terrorism" and "terrorists" to better deal with terror threats.

He also emphasised that terrorism is the biggest violator of human rights and crossborder propagation of terrorist ideologies through online radicalisation cannot be considered "political problem".

The Minister was speaking at the valedictory of the four-day General Assembly of the Interpol.

"When Interpol was established in 1923, crime and policing challenges at that time, and modes and methods of crime today are very different, a lot of changes have taken place, and it is quite natural that in the decades to come, even more

changes will take place," he said. He further said, "Criminal mindsets have not changed, but the means for crime are changing. In this regard, it is my suggestion that based on its experience and achievements over the last 100 years, Interpol prepares a future plan for the next 50 years.

"Interpol can also set up a study group under its aus-pices, which can carry out detailed research on the challenges likely in the next 35-50 years, and solutions for them,

₹3,400 crore, including the Gaurikund-Kedarnath and way projects and widening of the NH-7 from Mana to Mana Pass and NH 107 B from Joshimath to Malari, both in the region bordering China. Modi said, "Slave mental-

ity has gripped people in such a way that they find every work of progress akin to a crime. Works related to culture are praised abroad but not in India. The slave mentality had brought our venerable centres of faith to a deteriorated condition. Our religious places were ignored for decades. Such centres of faith are not mere structures but carry the power of life for yet they are sources. of life for us; they are sources of power which keep us energised even in the most difficult of circumstances.

The PM spoke of the works being done in Badrinath, Kedarnath, Ayodhya— and from Pavagarh in Gujarat to Devi Vindhyachal corridor stating that these works are part of the nation's cultural revival. Continued on Page 2

'No PUC, no fuel' order Pak taken off FATF's grey list in Capital put on hold

n a relief to thousands of In a relier to unousands of vehicle owners, the Delhi Government has put on hold the order making it mandatory to carry a valid pollution-under-check (PUC) certificate

to buy fuel from October 25.
The Delhi Government
will launch the "Red Light on
Gaadi off" campaign again to
curb vehicular pollution from
October 28 October 28.

"The diesel and petrol dealers' association has given some suggestions regarding law and order... These will be discussed with the Chief Minister and a decision will be taken thereafter," Delhi Environment Minister Gopal Rai said on Friday.

"For now, it is not being implemented from October the Minister said.

Sources in the Government said the agencies, including petrol pump owners and the Delhi Police, advised deferring the move keeping in view the law and order situation.

The Government had earlier asked vehicle owners to compulsorily carry a valid PUC certificate for buying fuel at petrol pumps from October 25 to check air pollution caused by vehicles in the national capital.

Over 19.36 lakh vehicles in the national Capital do not have PUC certificate, according to the Delhi Transport

Pakistan has been taken off from the grey list of the Financial Action Task Force (FATF), the global watchdog on terror financing and money laundering, four years after the country was put in the infamous categorisation. mous categorisation.

Significantly, for the first time, the FATF put Myanmar in the "high risk jurisdictions subject to a call for action", often referred to as the watchdog's black list.

In a statement, the FATF said it welcomes Pakistan's significant progress in improving its anti-money laundering, combating financial terrorism (AML/CFT) regime. The decision was taken by



Paris on October 20-21. "Pakistan has strengthened

the effectiveness of its AML/CFT regime and addressed technical deficiencies to meet the commitments of its action plans regarding strategic deficiencies that the FATF identified in June 2018 and June 2021, the latter of which was completed in advance of

the deadlines, encompassing 34 action items in total. "Pakistan is

therefore no longer subject to the FATF's increased monitoring process. Pakistan will

continue to work with APG to further improve its AML/CFT system," the statement said. With Pakistan's exit from

Shootouts rock Thane, two people injured

aharashtra chief minister Manarashira since Eknath Shinde's home turf of Thane reeled under panic on Friday, as Mumbai's satellite city witnessed two shoot-outs -within hours of each other -leaving two persons injured.

In the first shoot-out that took place at around 5 am on the Ghantalidevi temple road located in the heart of Thane, some miscreants opened three rounds of fire, in which one person was injured. The injured, identified as one Ashwin Gamle, a property deal-

Gamle was standing near a diwali light decoration material shop when the incident took place. He was rushed to the Chhatrapati Shivaji Maharaj Hospital at Kalwa, while the Naupada Police are incident

While it is not known yet as to what triggered the firing, police prima facie believe that the incident might have been a fallout of some property dis-

In the second shoot-out that was reported from Lokmanya Pada locality bordering the picturesque Yeoor hill area at around 9 am, a gangster - identified as one Ganesh Jadhav alias Kalia – was injured when he was allegedly fired upon by a rival gangster.

Ganesh Kalia sustained a bullet injury on Ganya's chest. He was rushed to the Vedanta Hospital where his condition was described as 'critical'. The Vartaknagar police are investigating the incident.

Following the two incidents, the Thane Police and Crime Branch formed multiple teams to investigate and track the miscreants behind both the shootouts.

These two shoot-outs come on the heels of two similar shoot-outs that took place during the last two months on Ghodbunder Road. Though no one was injured in them, the two incidents had caused some anxiety among Thanekars.

Friday's two shoot-outs have raised serious questions about the law and order situation in Shinde's home city of Thane. Though deputy chief minister Devendra Fadnavis of the BJP holds the home portfolio, Shinde will have to contend with criticism from his political rivals in the com-

"Presently, there is no mechanism for checking whether the vehicles whose PUCC have expired are plying or not. It can be checked at the time of re- fuelling of the vehicle or during the enforcement drives which are carried out by the transport department regularly, especially during the winter months," said a transport department official who asked not to be named.

According to Government estimates, the transport sector accounts for 28 per cent of the PM2.5 emissions in Delhi. Vehicular contribution also gen oxides and carbon monoxide in Delhi's air.

Under Section 190(2) of the Motor Vehicle Act, 1993, vehicle owners not having a valid PUCC can be fined up to Rs 10,000, or imprisoned for up to six months or both. Officials had earlier said vehicle owners not having a valid PUCC may also face suspension of registration certifi-

The owners are required to get their vehicles tested to ascertain if they meet emission standards for pollutants such as carbon monoxide, ide. According to government data, Delhi has a total of 13.4 million registered vehicles. There are over 900 pollution checking centres authorised by the Transport Department in Delhi. These are set up at petrol pumps and workshops spread all over the city. Rai also announced that

the Delhi Government will launch the "Red Light on Gaadi off" campaign again to curb vehicular pollution from October 28.Under the campaign, first launched on October 16, 2020, to cut down vehicular pollution in the national capital, drivers are encouraged to switch off their vehicles while waiting for the traffic light to turn green.

According to his opponents, Khan failed to show the sales in the income tax returns, making him liable.

The case filed with the ECP seeks his disqualification under Articles 62 and 63 of the Constitution which suggests disqualification if someone is not truthful.

Established in 1974, the Toshakhana is a department under the administrative control of the Cabinet Division and stores tarians, bureaucrats, and officials by heads of other governments and states and foreign dignitaries.

Khan was ousted from power in April after losing a no-confidence vote in his leadership, which he alleged was part of a US-led conspiracy targeting him because of his independent foreign policy decisions on Russia, China and Afghanistan.

The cricketer-turned-politician, who came to power in 2018, is the only Pakistani Prime Minister to be ousted in a no-confidence vote in Parliament.

"It can also produce a report called World Policing between 2048 and 2073. And it will also be relevant to review this plan every 5 years," he said.

The All India Institute of The All Illula Illula Medical Sciences (AIIMS) administration on Friday with drew a set of Standard Operating Procedures (SOPs) it had issued for the handling of MPs who visited the hospital for treatment. The SOPs, which included providing a nodal officer to coordinate and facilitate treatment for the MPs, had to be junked after facing flak from a section of doctors.

In a recent letter to YM Kandpal, Joint Secretary at the Lok Sabha Secretariat, AIIMS Director M Srinivas listed the SOPs for outpatient department (OPD), emergency consultation and in-patient hospitalisation of members of both Lok Sabha and Rajya Sabha.

In his letter, Srinivas has said duty officers from the department of hospital administration will be available at the AIIMS control room roundthe-clock to coordinate and facilitate arrangements. The move drew sharp criticism



from several associations of doctors who called out the "VIP culture" at the premier health institute. On Friday, the hospital administration withdrew the letter.

Letter dated October 17 on the 'medical arrangements for sitting Members of Parliament in AIIMS' may be treated as withdrawn with immediate effect," the latest let-ter signed by Chief Administrative Officer Deo

Soon after this, the Federation of Resident Doctors Association (FORDA) tweeted: "So, Special Privilege stands withdrawn. Proud of everyone who supported."

In another tweet, it said, "A

voice of reason, rationale and resolve can make a big difference. We thank everyone for their support and stand against the VIP culture in healthcare. It's a shared success!

The Federation of All India Medical Association (FAIMA) said, "We always stand against #VIP culture! We will never compromise with our stand! ... Director had to withdrawn letter of Special treatment for

#MPs (sic)!"

The FORDA had on Thursday questioned the SOP, highlighting that the special privilege to MPs might come at the cost of ordinary patients.

The AIIMS director had in his letter said MP's staff could call up the officer on duty. The officer, also a qualified medical professional, would in turn speak to the specialist or superspecialist doctor or the head of the department concerned to fix an appointment, it had mentioned. In case of any emergency, the Lok Sabha or the Rajya Sabha secretariats or the MP's staff could contact the

duty officer, who would guide them to emergency services, the now-withdrawn letter had said. The Federation of All India Medical Association (FAIMA) had also tweeted and

shared a letter sent to Union Health Minister Mansukh Mandaviya, appealing to him to take cognisance of the issue. FORDA had tweeted, "We condemn VIP culture. No patient should suffer at the cost of another's privileges. That of another's privileges. That being said, having a protocol to streamline things should not be viewed as derogatory, provided it doesn't hamper patient

care."
Similarly, FAIMA's presi dent Rohan Krishnan tweeted saying, "Requesting @PMOIndia & @man-sukhmandviya to take cognisance of the letter released by Director @aiims_nd and take appropriate action against him for promoting VIP culture. @FAIMA_INDIA_ condemns the move by #DrSrinivas as it promotes VIP culture, ignorance of general pts."

16th, 17th annual Lokayukta reports to be tabled in House

NewDelhi: Delhi Lieutenant Governor VK Saxena has 17th Annual Consolidated Reports of the Lokayukta pertaining to the years 2017-18 and 2018-19 before the Delhi Assembly. Saxena also flagged that he

has received reports from the Delhi Government after an "inordinate delay" and said being the custodian of public trust, it should display appropriate alertness. The Lieutenant Governor has written to Chief Minister Arvind Kejriwal over the matter. Reacting to the issue, the Delhi Government in a statement said, "The L-G should stop behaving like a school headmaster.

Sources at the Raj Niwas said that Saxena, while conveying his approval to the CM for laying the 16 and 17 reports of the Lokayukta, in the Assembly has specifically underlined his constraint in noting that, "These Annual Reports of 2017-18 and 2018-19, have been submitted after a lapse of three years", despite the fact that the "same were forwarded to the Government on October 23, 2019, official-

The L-G also said that this is unfortunate that these important reports are not taken seriously and dealt with in a very casual manner, reflecting unexplained delays for years. Saxena has brought on record that after obtaining the explanatory memorandum, the department submitted it to Minister (Administrative Reform) on September 22, 2020. However, the Minister submitted it to the CM only on September 19, 2022, after a gap of two years, they said.

"This inordinate delay deprived Legislative Assembly to take cognizance of this important report of Lokayukta, which deals with matters of corruption, abuse or misuse of position etc. in cases of public functionaries," said sources. In a letter to CM regarding the delay of files, the L-G advised that concerned Minister should



be guided to dispose important matters of the public interest within reasonable period, so that the statutory purpose of laying it before the Legislative Assembly is not defeated and Delhi is not deprived of its wisdom, they said. Saxena said that for an

individual (Arvind Kejriwal), who made an entire career out of agitations demanding an empowered Lokpal, and a political party (AAP), whose entire existence revolves around tomtoming accountability, probity and transparency in governance, this deliberate de-teething and emasculation of the Lokpal, yet again displays the politics of opportunism, anarchic subversion of the Constitution and Statutes and systematic annihilation of the systems of governance- traits that Arvind Kejriwal and the AAP have become masters of, sources

"The LG has asked the CM to recall even on "earlier occasion, such delays were brought to CM's notice and subsequently the matter was placed in the Assembly". CSE: Extra rainy days helped to keep pollution low

August-September quarter this year stood at 37 microgram per cubic metre, only marginally higher than the five-year low of 36 microgram per cubic metre recorded during 2020, according to an analysis by the Centre for Science and Environment (CSE).<Pollution levels in the July-August-September quarter were preceded by one of the most polluted summers this year, unlike in 2020 when the trimester followed the cleanest ever summer (March-May) due to extraordinary conditions created because of hard pandemic lockdowns, the green

think tank said. "Therefore, it is important to understand what aided in cleaning up the Delhi air. Looking at the rainfall data it becomes evident that distribution of rainfall has a relatively higher impact on seasonal air quality than the absolute quantity of rainfall," it said.

There have been 45 rainy days in July, August and September this year as compared to just 39 rainy days in the quarter last year. "These six extra rainy days helped keep

STAFF REPORTER ■ NEW DELHI the seasonal average low despite total rainfall this mon-Delhi's PM2.5 pollution soon having been just onesoon," the CSE said.

These additional rainy days also pushed the regular start of bad air quality days further down the month of October, it said. The PM2.5 average for the quarter stood at 38 microgram per cubic metre in 2021, 41 microgram per cubic metre in 2019 and 43 microgram per cubic metre in 2018.

The CSE had on Thursday said the average PM2.5 pollution in Delhi in the winter season has declined by about 20 per cent as compared to the

pre-pandemic period.
The PM2.5 concentration for winter (October 1 to February 28) used to hover around 180-190 microgram per cubic metre before the pandemic. It has come down to 150-160 microgram per cubic

metre since then, it said. However, the seasonal average is still over 150 per cent above the 24-hour standard (60 microgram per cubic metre) and almost four times the annual standard (40 microgram per cubic metre) despite the improvement, the green think tank noted.

Made-in-India Agni Prime missile successfully test fired

Giving a boost to its Defence capabilities, India on Friday successfully test-fired indigenously built Agni Prime missile off the Odisha coast in Balasore. The missile has a range between 1,000 km to 2,000 km and can carry nuclear warheads.

This weapon is a new generation missile built by the Defence Research and Development Organisation (DRDO). The sleek missile was test fired from a mobile launcher from the APJ Abdul Kalam Island around 9.45 am, officials here said.

The solid-fuelled canisterised missile met all mission parameters during the test. All its navigation was tracked and monitored by radars and telemetry equipment positioned along various points.

The last trial of the missile was conducted on December 18 last year from the same base, which was also successful, officials said adding all test objectives were met and said that the third consecutive (and successful) test of the 'Agni Prime' had 'established the accuracy and reliability of the system.

ED attaches seven properties of Mukhtar Ansari in PMLA case

The Enforcement Directorate (ED) on Friday said it has attached seven immovable assets of Uttar Pradesh gangster-turned-politician Mukhtar Ansari in connection with an ongoing money laundering probe against him and his family. The properties, provision

ally attached under the Prevention of Money Laundering Act (PMLA) are worth Rs 1.48 crore (registry value) while their circle rate at the time of registration was Rs 3.42 crore, the ED said in a statement.

Ansari, a five-time former MLA, is currently lodged in a prison in Banda, Uttar Pradesh. The 59-year-old accused was questioned by the ED in this case last year. In August, the agency also

searched the official residence of his elder brother and BSP MP Afzal Ansari in Delhi and some locations in Ghazipur, district), Mau and state capital

The money laundering case against Mukhtar Ansari stems from multiple FIRs lodged by the Uttar Pradesh Police apart from two more FIRs lodged against a company Vikas Constructions (a partnership firm) that was run by his wife, two brothers-in-law and others.

The agency has alleged that the company was used for constructing godowns on public and government land after "encroaching" on them.

"The godowns were constructed in Mau and Ghazipur districts of Uttar Pradesh. Vikas Construction was being run by Afshan Ansari (wife of Mukhtar Ansari) and her two brothers Atif Raza and Anwar Shahzad, a person identified as Ravindra Narayan Singh, and Zakir Hussain," the agency

"Uttar Pradesh Police has filed a charge sheet in one of the FIRs registered at Mau in which all the partners of the firm (Vikas Construction) have been named as accused," it said.

The probe found that rent of Rs 15 crore was collected by Vikas Construction from the Food Corporation of India by renting out godowns "illegally" constructed by encroaching public/government land at Mau and Ghazipur districts. "This rent was further used

to purchase immovable properties in the name of Vikas Construction and Afshan Ansari. Further investigation to

trace out the remaining process of crime is under progress," the ED said

ED freezes ₹78 cr fresh deposits with Razorpay, banks

PNS NEW DELHI

The Enforcement Directorate (ED) on Friday Enforcement said it has frozen fresh deposits worth Rs 78 crore following raids on the premises of payment gateway Razorpay and some banks as part of an ongoing money laundering probe against the alleged illegal operations of loan apps "controlled" Chinese nationals.

The searches were carried out at five premises in Bengaluru on October 19, the ED said.

The money laundering case stems from 18 FIRs filed by the cyber crime police station of Bengaluru police against numerous entities/persons for their involvement in extortion and harassment of the public who had availed small amounts of loans through the mobile apps being run by them.

These entities are controlled/operated by Chinese nationals. The modus operandi of these entities is to use forged documents of Indians and make them dummy directors and generate proceeds of

It has come to notice that the said entities were doing their suspected/illegal business through various merchant IDs/accounts held with payment gateways and banks," the ED said in a statement.

These entities were generating "proceeds of crime" through various merchant IDs/accounts held with pay-ment gateways and banks and they have submitted fake addresses in KYC documents. 'An amount of Rs 78 crore has been seized in merchant IDs (held in payment gateways) and bank accounts of these Chinese persons-controlled entities. The total seizure in the case now stands at Rs 95 crore," the agency said. The agency had earlier seized deposits worth Rs 17 crore in the case. It said fresh searches were carried out at the

premises of Razorpay Pvt Ltd and compliance offices of some of the banks. These payment gateway firms have been in the ED's crosshairs since 2020, soon after the Covid-19 outreak started in the country.

The ED initiated a probe under the criminal sections of the Prevention of Money Laundering Act (PMLA) after a number of instances of sullible debtors ending their lives came to the fore from various States.

The victims, according to the police, were being coerced and harassed by these loan app (application) companies by publicising their personal details available in their phones and using high-handed methods to threaten them.
It was alleged that the com-

panies sourced all personal data of the loan-takers at the time of downloading these apps on their phones, even as their interest rates were "usu-

The ED had said the alleged proceeds of crime in this case were routed through these payment gateways. Meanwhile, the ED has arrested Romen Agarwal in a separate case under PMLA in an ongoing investigation of Mobile Gaming Application, namely E-nuggets. Agarwal is actively

involved in inter/intra country transactions related with transfer of ill-gotten money within and outside the country received from criminals. He acts as a conduit for arrangement of parking/routing/transferring of funds generated from illegal activities, the agency

Agarwal has used his crypto exchange accounts for parking of funds received from Aamir Khan, main accused in the E-nuggets App case. He was arrested by ED and produced before Special Court (PMLA), Kolkata that granted his custody to ED till October 28.



Criminals no more free in UP, either in prison or killed: CM Yogi lauds State police for maintaining rule of law

hief Minister Yogi • Adityanath, on the occasion of Police Commemoration Day, lauded the contribution of gallant policemen in maintaining the rule of law in the state, saying, "It is the result of UP's zero tolerance towards crime and criminals and the contribution of brave policemen that no criminal is free in the state today; they are either in prison or have been killed."

Saluting the courage, valour and dedication of brave police personnel, Yogi Adityanath said, "Maintenance of rule of law in the state is ensuring peaceful celebration of every festival and safer environment for women, weaker sections, traders and the common man." On the occasion, the chief

minister announced an increase in Rs 200 cycle allowance given to police personnel by providing them with



a Rs 500 motorcycle allowance. He also dedicated the facility of the e-pension portal to the policemen. The chief minister, who

was present among the police personnel just before Diwali, also announced the approval of reimbursement of medical expenses of more than Rs 5,00,000 from the level of director general of police (DGP) for the convenience of policemen.

"Till now, this was being addressed at the government level, which caused an unnecessary delay, now there will be no delays," the chief minister

During the event organised at Reserve Police Lines in

Lucknow, Yogi Adityanath said that taking great inspiration from Gita, the brave policemen had made the supreme sacrifice to maintain the external and internal security of the country and the state. He pointed out that in 2021-22, seven brave policemen of Uttar Pradesh were martyred.

Saluting the martyrs, the chief minister assured the dependents of the martyred policemen that the government would extend all possible help to them with utmost sen-

The chief minister said that the police force served the state with dedication even in adverse circumstances. "In the midst of the COVID-19 pandemic, the state police force presented a perfect example of humanity. During this, 45 policemen also succumbed to the novel coronavirus, and their families were given jobs and a sum of Rs 22.50 crore as per rules. Moreover, assistance

amounting to Rs 141.9 crore was given to the dependents of 581 martyrs of Uttar Pradesh origin serving in Central Para Military Forces, Indian Army, among others," he said.

Lauding the efforts of the police in improving law and order in Uttar Pradesh, the chief minister said that while taking strict action against the criminals, assets worth Rs 44. 59 billion had been confiscated or destroyed so far and schools for daughters and houses for the poor were being constructed on such properties.

The chief minister said that from March 30, 2017 to October 13, 2022, about 166 dreaded criminals were killed and 4,453 were injured across the state. He said action under the Gangsters Act was taken against 58,648 persons and under National Security Act against 807. He said the property of 50 dreaded mafias and their accomplices worth about Rs 2,268 crore was confiscated

or demolished and in this, one mafia and eight of his accomplices were also killed in an

encounter. While 39 were sentenced to life imprisonment due to effective prosecution, two were sentenced to death. In the same period, 13 policemen were also martyred.

In the period from September 1, 2021 to August 31, 2022, 264 policemen in the country laid down their lives. These included seven policemen of Uttar Pradesh -- Sub-Inspector Virendra Nath Mishra, Sub-Inspector Kadir Khan, chief constable Munil Kumar Choubey, constable Sarvesh Kumar, constable Sumit Kumar, constable Lalit Kumar and constable Manish

The chief minister said that the entire police force of the state was proud of the valour of these heroes who sacrificed their lives while giving their services.

Virtue of impatience

Liz Truss had to quit because she went with tax cuts without taking public finance into account

The race to succeed British Prime Minister Liz Truss is heating up in the United Kingdom, with the Indian-origin Rishi Sunak said to be leading the pack and her predecessor Boris Johnson reportedly contemplating a comeback. Some senior leaders like new Finance Minister Jeremy Hunt have decided not to run for the top office, but others, including Defence Secretary Ben Wallace, are non-committal. Any candidate wanting to get elected will need at least 100 nominations from the party MPs. Since there are 357 Conservative MPs, no more than three candidates can participate in the race. If there is only one candidate, he will become the new prime minister without any election. In any case, the country will have a new leader on October 28. The fall of Truss, who was in 10 Downing Street for just 45 days, suggests that impatience is a defining feature of British democracy. In our coun-



try, every elected government feels entitled to 'a honeymoon period'—that is, the span of time when neither the Opposition nor the media shows any harshness towards it. 'Abhi to aaye hain. Kuchh time to do inko'—this is the prevailing mood in the first 100 days, or even longer. And look at the poor Truss; she didn't get even half of that time. Even after over eight years in power, the Bharatiya Janata Party still accuses the previous 'Congress misrule' of everything that is wrong; and before the BJP, the Congress blamed the British for all the country's problems.

The fact is that impatience is a virtue of democracy; it keeps the political class on their toes—and

on the ground. It also forces them to explain how they would keep their promises. Truss' mini-budget last month slashed taxes; her government, however, could never explain how the revenue shortfall would be met. People, public intellectuals, and politicians, including that of the ruling party, in the UK and other developed countries always ask 'how'; this is the reason that they are not as much fooled by election promises as we are. In India, all kinds of promises are made—doubling farmers' income, making India a developed country, etc.—but it is rarely, if ever, explained how these would be kept. Not so in the UK; Truss presented herself as an admirer of former British prime minister Margaret Thatcher, but could not show the mettle the iron lady was famous for. For one, she was too hasty. Tax cuts are good, but they can't be carried out without taking other factors into consideration; they have to be in consonance with the fiscal situation; one can't go on a tax-cutting spree when public finance is strained. In cricketing analogy, she tried to begin her innings with a glory shot—and got out early, much before the nation could witness her skill and capabilities. Her successor would do well to remain grounded and on their toes. For the British public are not as forgiving as Indians are.





Let people breathe!

Banning firecrackers does not tantamount

to banning Diwali celebrations

ven before Diwali fireworks of different types are out. An unnecessary controversy about firecrackers is raging in Delhi. While the Aam Aadmi Party has put a complete ban on the use of firecrackers in Delhi with stringent punishment for those violating the ban, the BJP is out to lift the ban and is taking on the AAP government for deliberately banning firecrackers on a Hindu festival of Diwali. They attacked AAP for its double standards and being anti-Hindu, citing videos of AAP workers burning fire crackers in the party celebrations. They argue that when AAP workers burn firecrackers does that not pollute the air, why do only the Hindus have to suffer due to such a ban? To challenge the ban the BJP Delhi leader Manoj Tiwari moved the Supreme Court for relief but did not get it. The Supreme Court had last week refused to hear the plea against the ban on firecrackers in the capital till January



crackers till January 1. The court advised Tiwari to spend his money on sweets and let people breathe. The observation is apt as this time around the air pollution is at its peak in Delhi, blame it on stubble burning in the fields of Haryana and Punjab or the vehicular pollutionthe Delhi Air Quality is hovering around in 'unhealthy zone'. If you add a night of firecrackers it would become 'hazardous' to even

Delhi environment ministry has put a complete

ban on manufacturing, storing, and selling firecrackers in the national capital and made it a punishable offence, the violators would attract a fine of up to ₹5,000 and three years in jail. Unfortunately, almost everything is politicized even if it is about the health of the people. After all, every political party claims to work for the welfare of the people and so their health should be of paramount concern for them. To score brownie points and add to the political divide on religion one party is deliberately targeting another and branding it anti-Hindu even though there is no precedence of firecrackers in Ramayana. All that people did when Rama returned from the forest was to light diyas or the earthen lamps. Many things got associated with the popular festival of Diwali like gambling, and firecrackers but they are not part of Diwali. So let this be a bright and noise-free Diwali!

Education must for Afghan girls' freedom-

hile the attention of most countries remains riveted to the developments in Ukraine, the Taliban have scripted a new chapter in their continued assault on women's right to education. Girls appearing in the national university entrance examination this year found a number of subjects off-limits. According to a recent BBC report by Hafizullah Maroof titled "Afghanistan: Taliban bar women from many university subjects," faculties open to girls vary from university to university and in different zones in which the Taliban have divided Afghanistan. While they are allowed to take medicine, nursing, literature, and Islamic studies in all zones, they are generally barred from studying engineering, agriculture, economics, veterinary science, journalism and geology. Some courses in journalism are open to girls at Kabul University. Girls from other zones cannot access these.

Not surprisingly, there is despair and gloom among girls. Going by Maroof's report, there were 30,000 girls among the 100,000 who were expected to take the entrance examination this year. Their number, however, seems to be declining. To cite a straw in the wind, 182 of them sat for the exam in Laghman province this year against 1,200 in 2021. The number could be even lower next year if girls continue to be barred from secondary education with classes from seven to 12 shut to them.

The Taliban, of course, have been trying to convince people that the imposition of these restrictions is not a part of their drive to whittle down women's rights to education and work that has been underway since the time they captured power in August last year. Thus, according to Maroof's report, Abdul Qadir Khamosh, who heads the examination division of the Taliban Government's ministry of higher education, has said girls could choose their favourite subjects, with the exception of just three or four. The report quotes him as saying, "We need to provide sep-

arate classes for women. In some areas, the number of female candidates is [sic] low. So, we are not allowing women to apply for certain courses."

Such explanations are hardly credible. The latest restrictions have to be seen in the background of girls continuing to be barred from attending classes seven to 12 in schools despite demonstrations by women in Afghanistan and condemnation worldwide. The UN Secretary-General, Antonio Guterres, wrote on *Twitter* on September 18, 2022, the first anniversary of the school reopening without girls, "A year of lost knowledge and opportunity that they [girls] will never get back. Girls belong to the school. The Taliban must let them back in." On the same day, Markus Potzel, acting head of the UN Assistance Mission in Afghanistan (UNAMA), stated, "The ongoing exclusion of girls from high school has no credible justification and has no parallel anywhere in the world....It is profoundly damagif generation of girls and to the future of Afghanistan.'

There has also been criticism from within. Sher Mohammad Abbas Stanikzai, deputy minister for foreign affairs, told a Taliban gathering in Kabul on September 27, 2022, "It is very important that education must be provided to all, without any discrimination," He said, "Women must get education, there is no Islamic prohibition for girls' education....Let's not provide opportunities for others to create a gap between the government and the people.....If there are technical issues, that needs to be resolved."

er, seems to have been marginalized. Once the head of the Taliban team in talks that led to the agreement with the US on February 29, 2020, in Qatar, which, in retrospect, led to the Taliban's ascent to power in August 2021, he should certainly have got a much higher position. His remarks mentioned above have clearly had no impact; nor, by the look of things, is it likely to have any. A significant indication of this has been the replacement of Noorullah Munir, who reportedly favoured girls' education

and was in charge when the Government Taliban announced the reopening of girls' schools in March 2022 (an announcement that has not been acted upon), on September 20 as education minister. His replacement, Habibullah Agha, who has reportedly had no formal education but is close to the Taliban's supreme leader, Hibatullah Akhundzada, will implement whatever order the latter hands down. He told the AFP on September 21, "We can't make any plans on our own. We don't do that. Rather, I would act according to the instructions given by the supreme leader."

The reclusive supreme leader, it is widely known, is opposed to girls' education. Clearly, women and girls in Afghanistan have a tough time ahead, particularly since the world is prepared to do little more than issue critical and/or condemnatory statements and the Taliban is making do without aid and its funds were frozen abroad.

any of us have read or come across the "Essence Of Gita (Gita Saar)" that says "whatever happened in the past, it happened for the good; Whatever is happening, is happening for the good; whatever shall happen in the future, shall happen for the good only. Powerful and fearless girls of Uttar Pradesh



The girls in Uttar Pradesh are coming out of the closet and claiming their life in the patriarchal society. They are fearless and bold, and speak their mind

ell us about yourself," asked a group of adolescent girls sitting in a room in a remote village in Uttar Pradesh's Ayodhya (erstwhile Faizabad) district. "What do you want to know?" I usually expect a question about my age or marital status. To my pleasant surprise, and for the first time in my field experience of over 10 years, I was asked about the challenges I had to face when I was their age. It took me a couple of seconds to process the question.

These girls — all in the age group between 11-20, mostly from low economic backgrounds belonging to Other Backward Classes (OBC) and Scheduled Castes (SC), are well aware of their rights. All of them are enrolled in schools and colleges. Some are taking coaching for different sports. Some are trained drivers. They fight for their right with village heads and call out discriminatory behavior against girls. They understand violence and how girls and women are subjected to different forms of violence. They are aware of their sexual and reproductive health and sing songs on "Mahvari" (menstrual cycle) together. Along with this knowledgeby their side, these young girls have fire written all over their faces. They are fearless, powerful but how? In a country like ours where adolescent girls face numerous levels of bias based on their age and gender, and owing to intersecting identities - such as caste, class, ethnicity, religion, sexuality, their vulnerabilities are further amplified, what makes these girls stand out?

Adolescent girls, everywhere in India and more so in rural areas, continue to face discrimination and violence at home and are no less vulnerable outside. Their health, education, aspirations and life have no value in a society that still prefers a male child (The latest figures as per National Family Health Survey revealed that nearly 80% of those surveyed said they wanted at least one son). They are not 'allowed' to study and are made to choose household chores over attending school. According to a 2018 report by the National Commission for Protection of Child Rights, 39.4% girls aged 15-18 years drop out of education institutes across India. 64.8% of these do so because they are "forced to take on household chores or are engaged in begging".
Four years later, NFHS-5 reports that

"early marriages and chores at home" are of schools. 21,800 girls who had dropped out of school before the 2019-20 school year, just over 13% girls did as they were required for housework and almost 7% did so as they were married off. The urban and rural break-up shows that of the total girls, 17,786 were from rural areas and 4,065 from urban areas.

"My family always supported my brother's education. Whatever little resources we had, were reserved for him. I had to constantly fight with them to let me complete my next level of education

and somehow managed to complete Class 12. They just did not see any point in my or my sister's education," said Priya* (name changed), a resident of Katauna, Block Tarun. What made Priya reject the idea that was being fed to her since her birth - the idea that girls only job is to learn household chores, marry, procreate, and take care of their families? What instilled in her the courage to question her parents and fight for her education?

Today, she is teaching in a private school and takes extra classes, earning to pursue her education and follow not just her areams but support ner family as well (ap ently her brother is unable to find a job!). All the girls in this group also ensure that no girl in and around their village is forced by their families to drop out of school. They come together to intervene and make their parents understand the importance of education.

There are several reasons why parents want their daughters to drop out from the schools. Cases of early child marriage are the most difficult ones that come our way. We come together to plan a strategy to intervene. It usually involves us speaking to the

girl as at times even girls do not want to go against their parents, if that doesn't work, we speak to their mothers first and when that fails, we make our parents speak to their parents. If nothing goes as per the plan, we dial the child helpline number and file com-plaint," shared Sapna* whom I had met in Dhamhar village in the same block.

These girls have learnt to take a stand not only for their basic rights but for their passion as well. They are entering territories which have been kept sacredfor boys for decades. Sports, for example, is one field that girls are always discouraged to follow. "'Ab tum ladko wale khelkhelogi?' is the question my parents had asked four years ago when I had told them I wanted to play cricket," said Naina*, a girl from the third group I had met in the same block. "My sister supported me to convince them and with several pre-conditions, I was allowed to play cricket," she added explaining how girls in different villages convinced, fought persistently with the village heads to provide them playgrounds where they could practice without any interference. "They would often threaten us that they would inform our parents about our unnecessary demands and that we should not be crossing the line. To be honest, we did feelscared, but we knew that itwas only the beginning of our long struggle and if we had backed off then, we wouldn't have reached here," shared the girls explaining what struggles they had to face in the last six years of their journey. In India, where only 29% women engage in sport, these adolescent girls fighting to play sports in these villages where there is no proper infrastructure education, healthcare, road connectivity, transport etc. is a BIG BIG DEAL!

Today, 120 girls from different villages in the block practice the game early morning or late afternoon wearing proper sports jerseys. Many participate in district and state level Cricket, Athletics and Kabaddi competitions working hard to make it to national teams.

'Today, if someone asks us what good we will do by playing cricket, we show them Mithali Raj's picture," said one of the girls from the group. "What do people say then?"

I asked. "Nothing, many still laugh at us while some support us and tell us to get the world cup for our country one day," she replied adding that although they have come a long way, there is a long journey ahead. How do they know what they want and already fighting for it?

These girls are breaking stereotypes. To ensure that they are financially independent, these amazing girls are learning professional driving (at 33, I don't even know to ride a bicycle!). Acording to the Road Transport Yearbook 2015-2016, only 11% of those behind the wheel are women and even those are made fun of. They are taking up Welder and Diesel Mechanics vocational training courses at Industrial Training Institutes. What's unconventional here? Between 2014-19, only 17%women were enrolled at ITIsof which only 4.3% of enrollments were in engineering trades vs 54.7% in non- engineering trades. For decades, young girls, have been restricted to traditional fields such as beauty, garment and healthcare, which are considered to be "feminized" sectors. They have been almost completely excluded from high technology or more mechanized sectors. Today, in their own small yet strong ways, these girls are fighting for their rightful spaces in these sectors. Since 2019, from this block, 40 girls have successfully completed the Welder Course while 60 have graduated as Diesel Mechanics. Many of these girls have left the village to work in other states.

"Do they continue working after they get married," I asked. "Girls who are working in companies in other states usually find someone in their field. All of themare saying yes to marriage only on one condition that they'll continue working wherever they are," informed didi - a social worker working with the organization that had been working with these girls for the last six years, with a sense of pride.

The answer to all the whys and hows and whats in this article is the fact that one group of committed social workers believed so strongly in working with these adolescent girls that they have changed their realities today. They supported them, organized them, informed and educated them to fight the prejudices their past generations were subjected to -not only to change the status quo for the present generation but toimprove situation for ourfuture generations. This journey of six long years they have taken with these girls is not only inspiring but stands testimony to the fact that all the statistics where adolescent girls and young women are lagging behind in this maledominated society requires such dedicated, planned, long-term interventions that follow the feminist principles and rightsbased approaches. And this is going to take a lot more organized, collective and sustained efforts from our social development sector. As I started to leave, one of the girls looked at me and said, "Aap aana next time, aapko kam se kam cycle chalana toh sikha denge (We will teach you how to ride a bicycle at least the next time you meet us)."

Govt must start a broadbased anti-smoking policy

Gains from the anti-smoking policy are limited and there is a need for a relook into it for better results

he strategy adopted when it comes to L addressing the tobacco menace is either quit or die. There are more than 100 million people in India who use tobacco regularly. India has the world's most diverse range of tobacco options, which vary from dangerous to very dangerous and two in three smokers die of tobacco related illness.

With such a large number of people using tobacco, it is high time to move from "quit or die policy" alone to "harm reduction" policy as well. All tobacco products have been viewed throughout the past 50 years as 'Deadly in Any Form or Disguise, as a 2006 WHO campaign phrased it. The WHO's Framework Convention on Tobacco



Control urges its 150+ Parties, including India, to adopt measures to reduce the demand for tobacco products (e.g., warning labels, public health campaigns, tax increases) and reduce the supply of tobacco products, including encouraging tobacco growers to shift to alternative crops.

Although touted as a success, smoking rates have only modestly declined over the Treaty's first 10 years – around 2% in total, according to a 2017 study published in *The* The WHO Lancet. Framework Convention on Tobacco Control (FCTC) is the first international public health treaty focusing on global public health issue of tobacco control. Its objective is to devise means of tobacco con-

scientific, technical and economic considerations. India ratified the WHO FCTC in 2004. The Treaty also includes the concept of tobacco harm reduction – encouraging tobacco users to switch to less harmful alternatives. The FCTC defines tobacco control as "a range of supply, demand and harm reduction strategies to improve the health of a population by eliminating or reducing their consumption of tobacco products and exposure to tobacco smoke" but little focus has been given to the harm reduction strategies.

Tobacco harm reduction is based on the principle of reducing harm from cigarettes through devices that reduce the harms associated with smoking by providing trol based on current, relevant, nicotine (cleaner form of

nicotine intake) to people who cannot or do not want to quit (by themselves or with currently-approved methods).

Over the last 15 years, technological and scientific innovations have led to the development of a wide variety of tobacco and nicotine products that are significantly safer than cigarettes; over a relatively short period of time, millions of smokers worldwide have switched to these products. Products like snus, e-cigarettes, and heated tobacco products have gained popularity as tobacco harm reduction products in many countries including Sweden, UK, USA, Japan, New Zealand. These products are classified under the broad category of novel tobacco and nicotine products.

Novel tobacco and nicotine products are alternative nicotine delivery systems with significantly less harmful emissions than smoke from the combustion of tobacco leaves and could be an option for those who are unable to achieve smoking abstinence

using other available means. Taking a cue from the tobacco "epidemic", the Indian government imposed a blanket ban on electronic cigarettes with the passing of the Prohibition of Electronic Cigarettes (Production, Manufacture, Import, Export, Transport, Sale, Distribution, Storage and Advertisement) Act, 2019.

The ban was imposed without exploring the possibilities and scientific evi-

uct that can aid in tobacco cessation. Imposing a ban on e-cigarette or less harmful alternatives takes away the right of smokers from shifting to a better alternative.

The direct health expenditure on treating tobacco-related diseases alone accounts for 5.3 per cent of total health spending in India in a year (WHO). It has been found that treatment of tobacco-related diseases and the loss of productivity caused therein cost the country almost Rs 13,500 crore annually. The Government should identify better alternatives and encourage innovation that can eventually lead to the betterment of public health. It is essential for the government to take on a multidimensiondence of e-cigarette as a prod- al and unprejudiced stance in current smoking population.

Ukraine piles pressure on Russian-held Kherson

krainian forces continued to pile on the pressure on Russian positions in occupied Kherson Friday, targeting resupply routes across the Dnieper river as Kyiv inched closer to a fullscale assault to retake the strategic southern port city.
As many as 2,000 Russian

draftees have poured into the Kherson region "to replenish losses and strengthen units on the front line," according to Ukraine's Army General Staff.

The Antonivskyi Bridge that is on a main route from Crimea to Russian-held territories in southern Ukraine was struck late Thursday, said Natalia Humeniuk, a spokesperson for Ukraine's southern operational command, but but only after the 10 p.m. local curfew, to avoid civilian casualties.

"We do not attack civilians and settlements," Humeniuk

Moscow-installed deputy chief of the regional administration claimed that at least four civilians were killed as a result of Ukrainian strikes.

Stremousov said the attack occurred some 40 minutes after the curfew's start. A further 13 people suffered wounds, Kherson's top health official Vadim Ilmiyev said. Among the dead and wounded were journalists from the Russia-created TV channel 'Tamvria,' according to Stremousov

Earlier Ukrainian strikes had made the Antonivskyi Bridge inoperable, prompting Russian authorities to set up ferry crossings and pontoon bridges to ferry supplies to Russian troops in Kherson, which sits on the Dnieper's western bank. Those crossings have been regularly targeted by Ukrainian rockets.

Russian-installed officials



uate from Kherson city for their safety and to allow the military to build fortifications. Ukraine's military reported Friday that bank employees, medical workers and teachers have started to be evacuated as the city's infrastructure also began to wind down. At least 15,000 residents of an expected 60,000 have already been relocated from the city and surrounding areas.

Kherson city, with a pre-war population of about 284,000, was one of the first urban areas Russia captured when it invaded Ukraine, and it remains the largest city it holds. It is a prime target for both sides because of its key industries and major river

The region of Kherson, along with Luhansk, Donetsk and Zaporizhzhia, were illegally annexed by Russian President Vladimir Putin even though not all the territory is

imposed martial law earlier this week in an attempt to assert Russian authority amid a string of military setbacks and strong international criticism.

In the Donetsk region, two people were killed in the past 24 hours after Russian forces shelled the city of Bakhmut, Regional Governor Pavlo Kyrylenko said. Russian troops have been unable to advance toward the city for over a month now.

Some nine people were wounded in two Russian attacks in the eastern city of Kharkiv, according to regional governor Oleh Syniehubov.

Amid the fighting, the Kremlin insisted Friday that Putin has been open to negotiations "from the very beginning," and "nothing has changed" in that respect.

Kremlin spokesman Dmitry Peskov told reporters that Putin "tried to initiate

special military operation" the Russian term for its war in

Peskov was speaking following earlier remarks by Turkey's President Recep Tayyip Erdogan, who said Putin appeared to be "much softer and more open to negotiations" with Ukraine than in

the past. Meanwhile, Russia's deployment of aircraft and troops to air bases in Belarus raised the specter of another front on Ukraine's northern border, although officials said such a move was unlikely.

The Ukrainian army's general staff reported a heightened chance that such an attack could aim to cut supply routes of Western weapons and equipment. The build-up could also aim to divert Ukrainian resources and weaken any counteroffensive



EU leaders avoid deep rift on gas price cap at energy summit

European Union leaders struggled to find immediate practical solutions on how an energy crisi but avoided an open rift between Germany and France on Friday that would have exposed a divided bloc as it confronts Russian President Vladimir Putin over his war in

After daylong talks in Brussels dragged well into early Friday, the 27 EU leaders papered over divisions between some of the biggest member states and at least agreed to continue working on ways to impose a natural gas price cap in case of big price increases.

President French Emmanuel Macron highlighted his work with German Chancellor Olaf Scholz to create a veneer of unity after talks that started early Thursday.

He said that together with close technical advisers, "I will see Chancellor Scholz in Paris next week so that we can move forward, with our teams, on all the issues." Scholz said the main issue was curbing "spikes" in gas trading that may last only a few hours but still send prices excessively upward.

General who led Syrian bombing new face of Russian war oversaw the destruction of entire

The general carrying out President Vladimir Putin's new military strategy in Ukraine has a reputation for brutality - for campaign in Syria. He also played a role in the deaths of three protesters in Moscow during the failed coup against Mikhail Gorbachev in 1991 that hastened the demise of the Soviet

Bald and fierce-looking, Gen. Sergei Surovikin was put in charge of Russian forces in Ukraine on October 8 after what has so far been a faltering invasion that has seen a number of chaotic retreats and other setbacks over the nearly eight months of war.

Putin put the 56-year-old career military man in command following an apparent truck bombing of the strategic bridge to the Crimean Peninsula that embarrassed the Kremlin and created logistical problems for the Russian forces.

Sunak holds firm as bookies' favourite to replace Liz as UK PM

A clear frontrunner to take over from Liz Truss as Conservative Party leader and British Prime Minister remains uncertain on Friday due to deep divisions among the Tories, but the bookies' odds have rocketed in favour of British Indian former chancellor Rishi Sunak.

As the runner up of the leadership election which concluded last month, the former finance minister who had forecast much of the economic crisis unleashed by Truss' mini-budget is seen as a safe pair of hands to take charge at 10 Downing Street.

The 42-year-old is holding a solid 55 per cent lead with the Oddschecker betting odds aggregator, followed by a 29 per cent chance of former prime minister Boris Johnson making a comeback. Third placed in what is emerging as a three-way contest is Leader of the Commons Penny Mordaunt, who had polled third in the first round of parliamentary votes to shortlist candidates for

"I back Rishi Sunak to be our next PM. He has the plan and credibility to: restore financial stability, help get inflation down and deliver sustainable tax cuts over time; and unite the Conservatives by bringing the best talent into government to deliver for the British people," tweeted former Cabinet minister Dominic Raab, among the first of nearly 50 MPs to openly declare support for Sunak.

Trump ally Bannon taces sentencing for contempt

Steve Bannon, a longtime ally of former President Donald Trump, is scheduled to be sentenced Friday after being convicted of defying a subpoena from the House panel investigating the Jan 6 insurrection at the US Capitol.

Bannon was convicted in July of two counts of contempt of Congress: one for refusing to sit for a deposition and the other for refusing to provide documents. Prosecutors have asked

the judge in his case to impose a hefty sentence of six months in jail, while Bannon's lawyers have argued their probation. The statutes for contempt of Congress each carry a minimum sentence of 30 days behind bars, but Bannon's lawyers argue the judge could just sentence him to probation and not send him to jail. The Sri Lankan government has decided to pay SLR 10 million as compensation to the family of a lawmaker who was lynched by an irate mob during the anti-government protests, a media report said on Friday.

Amarakeerthi Athukorala 57, a lawmaker from former Rajapaksa-led Sri Lanka Podujana Peramuna (SLPP) administration, was killed by a mob on May 9 in Nittambuwa in Western Śri Lanka.

The limit for compensating a government official was SLR 5 million. But after the cabinet meeting last week, it was decided to compensate Athukorala's family with SLR 10 million, news portal Economy Next reported, quoting Prime Minister Dinesh Gunawardena.

Initially, police had claimed that Athukorala died by committing suicide.

However, the autopsy report stated that the lawmaker's death was due to multiple injuries, fractures and internal bleeding, but he had no gunshot wounds.

Pro League winners to get direct berths in WC

The winners of FIH Pro League from 2023-24 season in both men's and women's categories will directly qualify for 2026 World Cups and 2028 Olympic Games, said hockey world body's CEO Thierry Weil on Friday.

"From season 5 and season 6, the winners of the men's and women's Pro League will directly qualify for 2026 World Cup. The winners of seasons 7 and 8 will get direct entry into 2028 Olympics," International Hockey Federation (FIH) CEO Weil

said in a virtual interaction. The FIH CEO ruled out fears that direct qualifications given to Pro League winners will have an impact on continental

The direct berth to the continental events winners will stay as will the direct berth to the World Cup and Olympic Games host country. Two berths in each section will go to Pro League winners and the rest will be awarded through a tournament," said Weil. Besides, the FIH has also planned major changes in the Pro League as from the fourth edition -- 2022-23 season -- the world body will introduce relegation and promotion sys-

The last-placed team at the end of the season in both men's and women's competitions will be relegated to the Nations Cup, while the winners of the Nations Cup will be promoted to the Pro

Selecting Green is a risk: Finch

Defending champions Australia have taken a risk by picking all-rounder Cameron Green instead of a back-up keeper for their Twenty20 World Cup campaign, skipper Aaron Finch said on Friday.

Green on Thursday replaced injured reserve wick-etkeeper-batter Josh Inglis in Australia's T20 squad.

'We've taken the risk and not gone with the extra keeper, which obviously had a degree of risk to it, but we feel as though Cam (Green) gives us a little bit better balance to the squad," Finch said in the pre-match press conference.

He, however, said that Green has been roped in as a cover and won't be playing the opening match against New Zealand on Saturday.

Asked about the reasons behind the decision, Finch said: "We went through some numbers, and I think it's 0.5 of a percent chance that something's happened in the past in T20 cricket to a keeper that's ruled him out on the day of the

'We feel as though, if something was to happen pregame and it ruled him out for the tournament, like at training or something, then there would still be enough time. That's the

"It's definitely a risk, no doubt about that, but it's probably one we're prepared to take more so than covering a fast bowler, a batter, and an allrounder. We feel that's a really crucial skill set.

Their World Cup record over the last five or six World Cups has been unbelievable. They're a great side with a great mix of experience, youth as well. They're led unbelievably well. They've got world class players all throughout their 11 or throughout their 15," Finch said.

'You can never ever take any team lightly, and we're seeing how close all teams are in this competition, even through the qualifiers. The teams are so close, and the margins in T20 cricket are so fine that any person on their day can take the game away from the opposition.

Shami could not feature in

India's build-up home series against Australia and flew straight to Brisbane after being picked on October 14. Shami had last played a T20I during the T20 World Cup in UAE-Oman in 2021,

while his last international appearance was in an ODI in

the England series in July this

year.
The 57-year-old Aussie, however, was firm in backing Shami and said he would make a formidable pace trio with Bhuvneshwar Kumar and

Arshdeep Singh. "I'd be going with Shami. I'd just go with his experience. Obviously, Bhuvi and Arshdeep are the first two. I just think that in big tournaments, you back big players. And he's a big player with a lot of experience.
