# Gyanvapi worship plea maintainable: Court

Next hearing on Sept 22; Muslim side to move HC

RAMATMA SRIVASTAVA

The Varanasi District Court on Monday held that the civil suit filed by five Hindu women seeking permission for unhindered daily worship of Shringar Gauri and other visible and invisible deities located on Shri Kashi Vishwanath Temple-Gyanvapi Mosque complex was maintainable and dismissed the application filed by Anjuman Intezamia Masjid Committee, which sees man agement of the mosque, challenging the suit. The court fixed September 22 as the next date of hearing of the case.

District Judge Ajay Kumar Vishvesha, who had on August 25 reserved the order in the case, delivered the 26-page order in 10 minutes in the presence of 32 persons inside the courtroom, including lawyers of the two sides and plaintiffs, according to an advocate who was present in the courtroom.

In his order, the district judge said, "In view of the discussions and analysis, I have come to the conclusion that the suit of the plaintiffs is not

barred by the Places of Worship (Special Provision) Act, 1991, the Waqf Act, 1995 and the UP Sri Kashi Vishwanath Temple Act, 1983, and the application 35C filed by the defendant No. 4 (Anjuman Intezamia) is liable to be dismissed."

The plaintiffs and their advocates welcomed Monday's order of the court and described it as their victory. On the other hand, the defendants expressed disappointment. Merajuddin Siddiqui, the advocate representing the Muslim side, said they would move the Allahabad High Court against the District Court order.

Five women, Lakshmi Devi, Sita Sahu, Rekha Pathak, Manju Vyas and Rakhi Singh had filed a civil suit in the court of Civil Judge (Senior Division) Ravi Kumar Diwakar of Varanasi seeking the right to offer prayer to Goddess Shringar Gauri, located on the

outer wall of Shri Kashi Vishwanath Temple-Gyanvapi Masjid complex and other deities located on the complex.

On the order of the court Advocate Commissioner Ajay Kumar Mishra had conducted a video-survey of the complex on May 6 and 7 but he was removed by the court later on the question of his fairness raised by the Anjuman Intezamia Masjid Committee. Continued on Page 2

# India, China walk the talk on pullback from Pt-15 face-off

Two sides raze structures, return to bases, will now have buffer zone

A biding with their pact to ease tension on the border, India and China on Monday completed the disengagement of their respective troops from the Gogra-Hot Springs (Patrolling Point-15) stand-off site in Eastern Ladakh. The two sides also dismantled temporary structures which came up during the last two years when the face-off started.

The two sides returned to their respective bases in the rear on either side and will now observe a buffer or no patrolling zone

The zone will stretch from two to five km, sources said here on Monday

Earlier in the day, Army Chief General Manoj Pande had said here, the pullback was "going on as per schedule." His remarks came as the two countries agreed to complete disengagement by Monday after the process commenced on Thursday last week.

Moreover, the withdrawal of troops from an eyeball to eyeball situation came days before Prime

Narendra Modi travels to Samarkand, Uzbekistan for the annual Shanghai Cooperation Organisation (SCO) summit on September 15-16. China President Xi Jinping and Pakistan Prime Minister Shehbaz Sharif too will attend the event, besides Russian President Vladimir Putin.

However, there was no official word about any bilateral meeting between Modi and Jinping and Modi and Sharif on the sidelines of the SCO summit. It will be the first time Modi and Jinping will come face to face after their meeting at Brasilia on the sidelines of the BRICS (Brazil, Russia, India, China, South Africa) in

# NIA crackdown on emerging nexus of narco-terror-dons

Houses of Moosewala's killers among 50 places in Delhi, Punjab, Raj Haryana searched

The National Investigation Agency (NIA) on Monday conducted searches at as many as 50 locations in Punjab, Haryana, Rajasthan and Delhi/NCR "to dismantle and disrupt the emerging nexus between terrorists, gangsters and drug smugglers/traffickers based in India and abroad". Some of those raided were also allegedly involved in the killing of Punjabi singer Sidhu Moosewala. The NIA crackdown fol-

lowed the launch of an investigation against this nexus by the agency after the re-registration of two cases, earlier registered by the Delhi Police on August 26. The NIA is probing the

alleged involvement of gangs in Punjab in smuggling drugs from Pakistan and the money later being pumped into terrorrelated activities

The case of Moosewala's murder is being probed by the Punjab and Delhi Police and 23 persons have been arrested in this connection so far.



a case related to narco-terrorism by alleged gangsters, at multiple locations in Outer Delhi on Monday

Moosewala was killed in Mansa on May 29 when he along with his friend and cousin was travelling in a jeep to Jawahar Ke village. A day earlier, the Punjab Police had pruned his security cover on a temporary basis. Goldy Brar, who is a member of the Lawrence Bishnoi gang, had claimed the responsibility for the murder.

Bishnoi is facing nearly 60 cases, including murders, attempt to murders and extortion. He is suspected of running his crime syndicate from behind bars.

Last week, Delhi Police's Special Cell also nabbed three sharpshooters of the Bishnoi and Brar gangs after an encounter in Delhi's Rohini area. Police said the arrested trio was in direct contact with Brar in Canada through the Signal app regularly for the past

# Double whammy: IIP sinks, inflation soars

**Retail inflation shoots** up to 7% in Aug, factory output plunges to 2.4%

In a double whammy of sorts for the Indian economy, retail inflation accelerated to 7 per cent in August driven by high food and fuel costs, while factory output plunged to a four-month low of 2.4 per cent.

month declining trend in CPI inflation will put pressure on the Reserve Bank of India (RBI) to again raise interest rates to tame prices, which have stayed above the comfort zone for the eighth month in a row.

The reversal of a three-

CPI inflation climbed to 7 per cent from 6.71 per cent in July and 5.3 per cent in August 2021, official data released on

Monday showed.
A sharp increase in cereals



and vegetable prices owing to erratic monsoon impacting yield was the main reason.

While the country was already facing double-digit wheat inflation due to unexpected heat wave pulling down the output, a lower area sown under paddy due to the shortfall in monsoon rainfall is expected to reduce the rice output. The twin effect of this means inflation in cereals will remain at elevated levels.

#### **SC** hearing on constitutional validity of CAA on October 31

The Supreme Court on Monday said it will hear on challenging the constitutional validity of the Citizenship (Amendment) Act (CAA) which seeks to grant citizenship to non-Muslim migrants fleeing religious persecution in Pakistan, Bangladesh and Afghanistan who entered India on or before December 31,

A bench comprising Chief Justice UU Lalit and Justice SR Bhat noted the matter will be referred to a three-judge bench.

The 2019 amended law, which seeks to grant Indian citizenship to non-Muslim migrants has come in for stinging criticism by opposition parties, leaders and other entities over exclusion of Muslims.

The ruling BJP, reacting to the development, took pot-shots at the Delhi Chief Minister and termed him as an "actor". Keiriwal, who is on a two-day Gujarat visit as part of the AAP's campaign for the upcoming Assembly polls, addressed a gathering of autorickshaw drivers Ahmedabad. After his address, an autorickshaw driver named Vikram Dantani, a resident of the city's Ghatlodia area, requested Kejriwal to have a



dinner at his home. "I am your fan. In a video I saw on social media, you went to have dinner at the home of an auto driver in Punjab. So, will you come to my home for dinner?' asked Dantani. The Delhi CM immediately replied in the affirmative to the invitation and reached his house to parttake in the meal at night.

#### **Yogi takes stock** of twin towers' debris management

Uttar Pradesh Chief Minister Yogi Adityanath on Monday took stock of the debris management following the demolition of the illegally constructed Supertech's twin towers in Noida that were razed on August 28. The chief minister was apprised by the Noida Authority CEO Ritu Maheshwari that the debris is being processed at the construction and demolition waste management unit in Sector 80, according to an official statement.

The demolition of the nearly 100 metre tall twin towers in Sector 93A has left behind an estimated 80,000 tonnes of debris which is to be recycled and scientifically processed.

"The chief minister was informed that the C&D waste processing unit has a daily capacity of 350 tonnes to 400 tonnes. But due to the debris generated by twin towers demolition, the unit is now functioning at 700 tonnes a day capacity," the Noida Authority said in a statement.

#### New academic session is likely to begin on Nov 1

Delhi University (DU) on Monday launched the Common Seat Allocation System (CSAS) for undergraduate admissions for the 2022-23 academic year, with the Vice-Chancellor (V-C) saying the new academic session is likely to begin on November 1.

Candidates who have appeared for the Common University Entrance Test (CUET) can register on the portal. The admission process will take place over three phases. This marks the much-awaited commencement of the admission process at Delhi University. CUET results are expected to be announced on September 15.

Addressing a press conference, DU V-C Yogesh Singh said the university is likely to begin the new academic session on November 1. "We are launching the CSAS portal today for undergraduate programmes

This is the first time we are taking admission through CUET," he said. The portal will remain open till October 3, giving students a 21-day window to apply for their desired undergraduate programme,

To apply, candidates will have to visit the DU admission website and register by clicking on the link that reads 'admission for undergraduate programmes.' They will have to fill in all basic details, upload mark sheets, photographs and signatures, and pay the regis-

## HC asks St Stephen's to follow DU admission policy

Court also says DU can't insist on single merit list for admission of Christian candidates regardless of denomination

**STAFF REPORTER** NEW DELHI

The Delhi High Court on Monday directed St Stephen's College to follow the admission policy formulated by Delhi University (DU) and accord 100 per cent weightage to the CUET 2022 score while granting admission to nonminority students in its undergraduate courses.

A bench headed by Chief Justice Satish Chandra Sharma, however, held that DU "cannot insist upon a single merit list for admission of candidates belonging to Christian community regardless of denomination etc.

The Bench, also comprising Justice Subramonium Prasad, said the fundamental right under Article 30(1) of the Constitution accorded to a minority institution cannot be accorded to non-minority admissions.

"Aided minority institutions must follow the norms and procedure of the said university. Protection under Article 30 (1) can be extended to the extent that it allows minority institutions to subclassify the reservation accorded to minority community," the court said.

The court's order came on petitions by a law student and St Stephen's College with respect to the legality of admission procedure for admission of students against unreserved non-minority seats for UG



courses."Consequently the communication ... issued by respondent no 1 (DU) is liable to be set aside to the extent that the petitioner college (St Stephen's) shall follow the directive that 100 per cent weightage must be given to CUET 2022 score for students of the non-minority category applying to UG courses. However, respondent 1 cannot insist upon single merit list for admission of candidates belonging to Christian community regardless of denomination, subsets etc," the court ordered.

"The petitioner is, therefore, directed to follow the admission policy 2022 -2023 as formulated by respondent 1 to this extent. The petitioner college must withdraw its admission prospectus and issue of public notice," it ordered.

Law student Konika Poddar, in her public interest litigation, had sought a direction to the college to take admission on its 'unreserved seats' only based on marks received by students in the Common University Entrance Test (CUET). St Stephen's College had challenged Delhi University (DU)'s letter asking it to withdraw its prospectus which gave 85 per cent weightage to CUET and 15 per cent weightage to college interview for admission to its unreserved

# Two AAP MLAs among 15 convicted by court

court has convicted AAP Amlas Akhilesh Pati Tripathi and Sanjeev Jha for being part of a mob that attacked policemen at the Burari police station in north Delhi in 2015. Additional Chief Metropolitan Magistrate (ACMM) Vaibhav Mehta also convicted 15 others in a case of rioting and causing hurt to police personnel.

The court also convicted Balram Jha, Shyam Gopal Gupta, Kishore Kumar, Lalit Mishra, Jagdish Chandra Joshi, Narender Singh Rawat, Neeraj Pathak, Raju Malik, Ashok Kumar, Ravi Prakash Jha, Ismail Islam, Manoj Kumar, Vijay Pratap Singh, Heera Devi and Yashwant.

They were found guilty of offences under Sections 147 (rioting), 186 (obstructing public servant in discharge of public functions), 332 (voluntarily causing hurt to deter public servant from his duty), and 149 (every member of unlawful assembly guilty of offence commit-ted in the prosecution of common object) of IPC.

The court will hear the case on the quantum of sentence on September 21, where they may get a maximum three-year jail term."This court is of the view that the prosecution has been able to prove beyond doubt that the accused persons namely



Tripathi were part of the unlawful assembly... and were part of the mob and they had indulged in sloganeering and had provoked the crowd, and encouraged them to get violent, and as a result of which they resorted to stone pelting thereby causing injuries on some police officials," the judge said in a 149-page judgement passed on September 7.

According to the prosecution, the incident took place on the night of February 20, 2015, when the mob was demanding the custody of two men who had been arrested and brought to the police station. The police had tried to

pacify the crowd but the MLAs joined the mob and attacked them and resorted to stone pelting, the prosecutor told the court.

The judge held that the prosecution witnesses were "consistent" in their statements on the point of presence of the



two Legislators at the place of the incident and had indicated that they were not only "active participants but were in fact eading the crowd".

Besides, the two men were stated to have provoked the mob as a part of a "common object of the unlawful assembly" in order to "teach police officials a lesson and to overawe the police by force". The judgment, however, acquitted 10 people in the case.

Reacting on the court's decision, Delhi BJP president, Adesh Gupta demanded that both the MLAs should be sacked not only from the party but also from the post of MLA. Gupta said that once again

#### Shahberi homebuyers seek help, demolition of illegal homes

m F}$ ollowing the demolition of the illegally constructed Supertech's twin tower in Noida, a group of homebuyers in Greater Noida's Shahberi area has written to local authorities demanding their "illegal" houses, declared "dangerous" in an IIT Delhi audit, be demolished.

The group — Justice For Shaberi Homebuyers — has demanded that after the demolition of the illegal structures. they be given homes as per norms of the Uttar Pradesh Rehabilitation Act 2013.

Shahberi, which lies in Greater Noida (West) also known as Noida Extension, had hogged limelight on July 17, 2018 when two adjoining each other, leaving nine people, including a child and two women, dead.

Subsequent probe reports by the district administration and the local authority had found the buildings had come up illegally and without proper approval, as did several other structures in the area. In a letter to the district administration and the Greater Noida Authority last week, the homebuyers requested the demolition of the "illegally constructed, unsafe buildings" in Shahberi. They said living in those "unsafe buildings" is dangerous for life as they were declared dangerous by the IIT Delhi Team in an structural audit report in 2019.

'We have requested for demolition of residential buildings APS Ashiyana, APS Ashiyana 2, APS Heights, APS Royal Homes, APS Crystal Homes and APS Gold Homes," said Sachin Raghav, a Shahberi resident.

Abhinav Khare, another resident, said a team of IIT Delhi had conducted a building safety survey in Shahberi under the direction of the previous CEO of the Greater Noida Authority and found that these buildings are not safe for living. "The audit had found that living in these buildings is dangerous for life as buildings can fall anytime," he said.

Meena Mohapatra, a Shahberi homebuyer and living in one such building, also raised this demand.

"Even the IIT Delhi audit found that several buildings in Shahberi are a safety hazard, risking the lives of residents. We want these buildings to be demolished and we be provided with homes in different area as per government norms," Mohapatra, who lives in Shahberi's Dev Homes, said.

As kirpan is an integral part of Sikh religion and Article 25 of the Constitution allows wearing and carrying of kirpans by Sikh persons, the incident has hurt the religious sentiment of Sikhs, the statement said.

# As attack incidents rise, MCD asks Delhiites to register pet dogs

It will also help in tracing missing pets with the help of registration number the dog will sport on its collar, says civic body

In view of the increasing number of dog bite incidents in the national Capital, the Municipal Corporation of Delhi (MCD) urged Delhiites to get their pet dogs registered with it.

According to a senior official of the Veterinary Department, MCD, under Section 399 of Delhi Municipal Act 1957, it is mandatory to register all pet dogs with the municipal corporation.

"The Section also gives power to the MCD to detain a dog found in a public place, if a pet dog is not registered with the civic body. There is also a provision of fining the pet owner and even prosecution," a senior municipal offi-

cial said.
"The Delhi Municipal Corporation Act mandates registration of pet dogs with civic body, but residents have remained reluctant to come forward to get their pets registered. We appeal to citizens to get their pet dogs registered at the earliest, otherwise appropriate action can be taken as per the DMC Act.

The rule applies even to those who have adopted stray dogs as pets," he said. While informing about the importance of registration of pet dogs, he said that the registration process helps in maintaining the exact count of pet dogs that are rabies virus vaccinated in different zones.

"It will also help in tracing a missing pet with the help of a registration number that the dog will sport on its collar.

The purpose of the exercise is to prepare a database of pet dog owners, control illegal practices like unregistered dog breeding, and monitor pet's vaccination schedules," he stated. "In order to facilitate the pet owners in the Capital, the

municipal corporation is providing convenient and hasslefree online facility for dog registration," he said.

'Through an online sys-

tem, an applicant can register for a dog licence by providing the relevant details in the application form available on the civic body official portal mcdonline.nic.in. The documents that need-

ed to be submitted are antirabies vaccination certificate, a photograph of the animal, residence proof and identity proof of the owner," official further stated. Earlier, multiple incidents

of attacks by pets have been reported in neighboring cities, Noida, Gurugram and Ghaziabad. A video went viral recently, showing a pet dog attacking a minor boy inside a lift of a residential society in Ghaziabad. In another incident from Ghaziabad, a teenage boy was attacked by a dog leaving him with multiple stitches.

Another video shows a food delivery agent being attacked by a dog while com ing out of a lift.

# Over 67,000 cattle have died since outbreak of LSD: Centre

#### Massive vax drive on in eight badly-hit States

PNS NEW DELHI

The Centre on Monday said ■ over 67,000 cattle have died since the outbreak of the lumpy skin disease in July, prompting a massive effort to vaccinate cattle in over eight States with most cases of the disease.

Animal Union Husbandry and Dairying Department Secretary Jatindra Nath Swain said states are currently using the 'goat pox' vaccine to control lumpy skin disease (LSD) in cattle. The commercial launch of a new vaccine 'Lumpi-ProVacInd' for LSD, developed by two institutes of agri research body ICAR, will take the next "three-four months," he said. The lumpy skin disease has spread mainly in Gujarat, Rajasthan, Punjab, Haryana, Uttar Pradesh, Uttarakhand, Madhya Pradesh and Jammu & Kashmir. There are some stray cases in Andhra Pradesh and Andaman & Nicobar Islands.

"In Rajasthan, the number of death is 600-700 per day. But in other states, it is less than 100 in a single day," he said, adding that the ministry has asked states to accelerate the vaccination process.

According to Swain, the goat pox vaccine is "100 per cent effective" and already 1.5 crore doses have been administered in the affected states.

He also said there is a sufficient supply of goat pox vaccine in the country. Two companies are manufacturing this vaccine and they have the capacity to produce 4 crore doses a month. The total cat-



tle population is around 20 crore. Already, 1.5 crore goat pox doses have been given, he said. While "only 1 ml dose" of the goat pox vaccine is sufficient to help fight LSD in areas where no case has been reported, doses of 3 ml each can be administered in cattle where an outbreak has been reported, he added. With regard to the new vaccine, Swain said the commercial launch of "Lumpi-ProVacInd" would take the

"The manufacturers will have to take permission from the Drugs Controller General of India (DCGI) for commercial production of the new vaccine. It will take next 3-4 months for commercial launch," he added. On the impact of LSD on

# Centre unleashing Agency Raj in Bengal, says Didi

former Archbishop Susai Pakiam have declared that the agitation would be called off only if the Government puts on hold all the works associated with the multipurpose sea-

But many environmental activists including Dr C M Joy questioned the real intention behind the agitation and Father Pereira and other expressed shock over the demand by the Church and

fishermen to put on hold all works associated with the seaport. "The environmental clearance for this project was issued in January 2014 and that too after a comprehensive environmental impact assessment. clinical trial conducted at the Tata AMemorial Hospital has shown that a simple, low-cost intervention significantly and substantially increases the cure rates and survival rate among early breast cancer patients.

Announcing the results of the clinical trial, Dr Rajendra Badwe, Director Tata Memorial Centre (better known as the Tata Memorial Hospital) said that the trial in women undergoing breast cancer surgery involved the injection of a commonly used drug around the tumour on the operating table, just prior

to surgery.
"The results of this trial show that this simple, low-cost intervention significantly and substantially increases the cure rates and survival with a benefit that is ongoing for several years after surgery.

The injection requires no additional expertise, is inexpensive, and can result in saving up to 100,000 lives annually globally," Dr Badwe said.

Dr Badwe said that the benefits of the trial were substantial and they were achieved with an intervention the cost of which was less than Rs.100/- per patient. "For comparison, benefits of far lesser magnitude have been achieved in early breast cancer patients by much more expensive, targeted drugs which cost more than ten lakhs per patient," he said. Dr Badwe presented the results of a landmark multi-centre Indian breast cancer study at the ongoing European Society of Medical Oncology (ESMO) Congress in Paris, one of the most presigious cancer conferences in the world

trial, conceived and designed by Dr Badwe, who is the principal investigator. If implemented across the world, it has the capability to save over

# **Caution ahead**

Hopefully, the Gyanvapi mosque issue won't become another controversy like Ram Temple

The Anjuman Intezamia Masjid Committee's defeat at the Varanasi district and sessions courts on Monday will not be the end of the story; the Muslim side will appeal in the High Court, as it has already indicated. The case would anyway have reached the High Court, and then the Supreme Court, had the Hindu side received such a setback. The Committee had challenged the civil suits that questioned the Gyanvapi mosque's title and the land surrounding it. The suits were filed by five Hindu women who sought the right to worship inside the city's Gyanvapi mosque, which they claimed was a Shivling. The Gyanvapi mosque is adjacent to the famous Kashi Vishwanath temple. District Judge AK Vishvesh's decision implies that the civil suits will now be heard in detail and the evidence examined. The Supreme Court in May had assigned the case to the district judge's court. The Supreme Court had said: "Keeping the complexity and sensitivity of the matter in view, the civil suit



before the civil judge in Varanasi shall be heard before a senior and experienced judicial officer of the UP judicial service." The Varanasi civil court, a month before the apex court's intervention, had ordered the filming of the Gyanvapi mosque. It was followed with considerable controversy as the film was released, apparently in an unauthorised manner.

The ongoing Gyanvapi case has already generated a lot of heat — in the political arena, public discourse and society. While many devout Hindus believe that historical wrongs have to be undone, there is also a large section of the majority community that is wary of such disputes. The wariness is

well grounded, for we have the precedent of the Ayodhya case which caused so much disruption, communal discord, even violence. All sides have their arguments; all of them also have their reasons to claim victimhood — Hindus cite medieval history, Muslims bemoan the demolition of Babri mosque. Then there are Left-liberals who rail against the righting historical wrongs and the Bharatiya Janata Party which talks about cultural nationalism. But neither victimhood nor doctrinaire assertions will do any good to the nation, for the delicate matters pertaining to inter-religious relations have to be dealt with caution and composure, not bombast and bravado. Just as many parties and leaders benefited immensely from Mandal, the BJP gained a lot by posing as the champion of the Hindu cause. But then everything in the world, including political trends, has a use-by date; everything is also subject to the law of diminishing returns. Therefore, if the BJP, or some of its leaders, hope to reap another harvest — the first one being Ayodhya — they may be in for a surprise. Instead of raking up divisive issues like that of Gyanvapi, they would be well-advised to focus on such matters as unemployment and inflation. As a Hindi saying goes, there can't be any worship on an empty stomach.

# **Kappan walks free**

Though the scribe gets bail, at least nine more journalists are still in jail for doing their duty

inally, the Supreme Court granted bail to Kerala journalist Siddique Kappan after nearly two years. He would continue to stay in Delhi for six more weeks and thereafter he could go to his home in Kerala. Kappan's fault — just wanted to go to the site of the rape and murder of a Dalit teenager in Hathras to report in his publication. A story he didn't get a chance to write. Siddique Kappan, 42, was arrested by UP police while on his way to Hathras on October 5, 2020. Kappan's bail once again brings the Hathras Gang rape case that happened two years back and stirred the conscience of the nation. A young teenage girl was gang raped and assaulted by the perpetrators of a high caste influential community in western Uttar Pradesh. On September 14, 2020, four men allegedly from high caste Thakur community, raped the victim and brutally assaulted her. She succumbed to the injuries two weeks later. In the wake of nation-

wide outrage, the police began its operation cover-up to save the State Government from embarrassment.

They secretly cremated the woman's body in the dead of the night on September 30 without the consent of her family. This led to more protests as it was all over the media. More reporters rushed to the spot to report for their publications, and Kappan went to cover the crime for the Malayalam news website Azhimukham. He never reached Hathras and was arrested on the way. Police first accused Kappan of intending to start a caste-based riot and creating communal disharmony but later booked him under the Unlawful Activities Prevention Act (UAPA), and for rais-

ing funds for terrorism. It will take many years before Kappan's case is finally over, but his life has changed forever already. He lost his mother while in jail. This is not the first time the UP Government has given harsh treatment to journalists and used draconian laws to silence their voices. It seems to be working on the maxim of 'process is punishment.' Kappan's case is a living example. Since there are no punitive obligations on the government or police for using harsh sections they use them at leisure while the person suffers immensely. The 'criminalising journalism' thus becomes an easy tool to suppress news that is uncomfortable to the powers that be. It is not surprising that in the World Press Freedom Index, released by 'Reporters without Borders' in May this year, India's ranking went down to 150 from 142 among 180 nations. At least nine other journalists continue to languish in Indian jails.

# Netaji arrives in Delhi, & in style

rime Minister Narendra Modi unveiled the 30 feet tall black granite statue of Netaji Subhas Chandra Bose placed under the canopy of India Gate in Delhi. The grand pathway now has its new identity as Kartavya Path. The earlier Rajpath, a Hindi translation of Kingsway, reminiscent of the Raj, is now history. This is aptly so. The credit for forcing imperial Britain to read the writing on the wall and quit India must go to Netaji Subhas. Prime Minister Modi's decision to consecrate the canopy of India Gate to mark "AzadiKa Amrita Mahotsav", commemorating 75 years of independence as well as Bose's 125th birth anniversary, is a befitting tribute to the legendary warrior who embraced the path of armed struggle to free the nation.
Without the firm moorings

of a healthy society and a free and strong nation, individual greatness is worth a zero. Two Indians from the same province learned this blunt truth of international geopolitics in their way. Rabindranath Tagore in 1913 was to deliver his lecture on human philosophy at Japan's Tokyo University to his dismay and the embarrassment of his hosts found that not a single student of Tokyo University turned up to listen to his words of wisdom. The entreaties of their alma mater's authorities were to no avail. "We refuse to listen to the views of an enslaved nation. What philosophy can such a country have?" The Japanese students only stated what an undeniable truth is-the defeated and enslaved, or colonized, have no business lecturing free and sovereign people on things like philosophy.

memorandum is that ....Gandhi is not a problem. We can deal with him and handle him. Congress is also not a problem. We can easily deal with them. But now that India and Indians know about the INA as also as the mutinies in the Royal Indian Navy and the Royal Indian Air Force, the Indians know that we have lost the love of the Indian Armed Forces. It is time to leave India!" Gandhi's four movements in 24 years came to naught. Upon his prison in 1945, the country's political environ-ment changed. Gandhi was now merely a Bapu, with Nehru and Sardar Patel at the helm. Had he not been assassinated, he might have lost his greatness in his lifetime.

Bose's radical agenda did not suit Gandhi who opposed him for seeking re-election as president of the Congress in 1939. Gandhi's candidate, DrPattabhiSitaramayya, was defeated. The Mahatma could not stomach his candidate's defeat. In his book, The Springing Tiger, historian Hugh Toye has written: that Bose's popular mandate as President of the Congress in 1939 was denied by intrigue, not only against him but

against the very democracy that had elected him.

Bose's INA was living proof that soldiers who had sworn loyalty to the Crown could go back on their vow. Netaji shook the British confidence in the continuing loyalty of not only the defence forces but also the civilian machinery. The British fears were vindicated when Indian Navy sailors mutinied at Bombay in 1946. Subhas's action thus hit the Achilles' heel of the foreign rulers. After independence, Nehru feared that Bose might not have been killed in the reported air crash at Taipei on August 17, 1945, and could return to compete for power. Nehru made it his party's as well as government's policy to obliterate the legend of Netaji. Netaji's clarion call to the brave men and women who joined him was "Chalo Delhi" (March to Delhi). While he did not live to see the culmination of his mission, it is highly gratifying that this valorous son of India is finally coming to Delhi.

#### **US SELLS F-16s TO PAKISTAN**

Sir — India protested with the US over the approval of a \$450 million F-16 fighter jet fleet sustainment programme to Pakistan. The Finance Minister has also said that the RBI has registered its concern over the adverse effects of crypto currency on the Indian Economy. "RBI mentioned that crypto currencies are not a currency because every modern currency needs to be issued by the Central Bank/Government. However, the value of crypto currencies rests solely on the speculations and expectations of high returns that are not well anchored, so it will have a de-stabilising effect on the monetary and fiscal stability of a country," FM said.

It is strange to note that the government is of the view that we can ban crypto currencies only after "evolution of common taxonomy and standards" at international level.



All along the RBI Governor was against permitting crypto currencies in the country. The earlier attempt to restrict crypto currencies was struck down by the Supreme Court as there was no clear policy on crypto currencies. The Supreme Court said, "When the consistent stand of the RBI is that they have not banned virtual currencies and when the Government of India is unable to take a call despite several panels coming with several proposals, including two draft Bills, both of which advocated exactly opposite positions, it is not possible for us to hold that the impugned measure is proportionate."

There is no need to wait for any collaboration with other countries to ban crypto currencies in our country. There are already restrictions and bans by different countries as per their individual requirement.

Algeria currently prohibits the use of crypto currency following the passing of a financial law in 2018 that made it illegal to buy, sell, use or hold virtual currencies.

In Bolivia, there is a complete ban in place on the usage of Bitcoin since 2014. The Bolivian Central Bank issued a resolution banning it and any other currency not regulated by a country or economic zone

China has cracked down on crypto currencies with increasing intensity throughout 2021. Chinese officials have repeatedly issued warnings to its people to stay clear of the digital asset market and have clamped down hard on mining in the country as well as currency exchanges in China and overseas. The People's Bank of China treats Crypto currencies as speculative assets and warns people to protect their pockets. On 24th September last year, China out rightly banned crypto currency transactions.

In Colombia, financial institutions are not allowed to facilitate Bitcoin transactions. Egypt has classified Bitcoin transactions as 'haram' which is prohibited under Islamic law. In Indonesia, Bitcoin cannot be used as a means of payment since January 1, 2018. In Nepal, Bitcoin has been declared illegal since August 2017. Russia has its own restrictions on crypto currencies. In Vietnam, using crypto currencies is a punishable offence

Hence, waiting for some international collaboration to ban crypto currencies in our country does not seem to be logical. Over 115 million Indians have already invested in crypto currencies. By 2030, the total value of investments in crypto currencies from India will cross \$241 million (about ?1,900 crore). To save these common investors, the government must immediately ban crypto currencies.

# India must enact laws for the rights of nature GOVIND BHATTACHARJEE

A number of countries, including even Bangladesh, have prudently put several laws into place to protect the rights of their rivers on a par with humans

he Parana Delta in Argentina is a huge mosaic of wetlands, which are incredibly rich in biodiversity. But for the last three years now, it has been facing severe drought. The receding water level and human activities like clearing the land for cattle grazing or for real estate development combined with intense heat have led to the shrinking of the wetlands.

In July 2020, two NGOs filed a Collective Environmental Appeal before the Supreme Court of Justice to preserve the integrity of the wetlands. Citing precedents from countries like Bolivia, Colombia, Ecuador, India and New Zealand, it urged that "the Paraná Delta lives, breathes, develops, pulses, feels. Our petition goes beyond the demand of the right to live in a healthy environment.... The Delta has its own life and it is succumbing. It deserves protection and the recognition of rights."

The case is pending for a decision, like a similar case in Peru. They are part of an international movement called Nature's Rights—giving the same Constitutional rights to the natural environment as humans, recognising the inherent rights of Nature to exist, thrive and evolve.

Four countries have already enacted laws or amended their Constitutions to this effect. Ecuador was the first country which in 2008 wrote nature's rights in its Constitution, enabling its ecosystem to be defendant in any court of law. Ecuador's largest export, crude petroleum worth some \$6 billion, represents 29 per cent of GDP, but its extraction has led to huge deforestation in the Amazon basin inhabited by eight indigenous tribes, contaminating their water and causing wide-spread illness.

Subjected to increasing encroachment of their land by greedy oil companies, the country witnessed several uprisings by these communities. Now, its Constitution has a chapter called Rights for Nature, which the Ecuadorian refer to as the Rights of Pachamama, the Mother Earth: "Nature, or Pachamama, where life is reproduced and occurs, has the right to integral respect for its existence and for the maintenance and regeneration of its life cycles, structure, functions and evolutionary processes. All persons, communities, peoples, and nations can call upon public authorities to enforce the Rights of Nature."

life and nature as one. The ancient Maori tribes in New Zealand had regarded their Whanganui River as a living being inseparable from them. "Ko au te awa, ko te awa ko au (I am the river, the river is me)", that's their connection to the ancient river they had revered for the past 700 years. An indivisible living whole, the river was their physical healer and spiritual redeemer, their "awa tupua"—the river of sacred

In 2017, the New Zealand Parliament passed a legislation declaring that Te Awa Tupua—the river and all its physical and metaphysical elements will henceforth possess "all the rights, powers, duties, and liabilities" of a legal person, representing "the beginning of a renewed and enduring relationship," with the river, while the government sought to "atone for its past wrongs and begin the process of healing."

The Te Awa Tupua Act, appointed two guardians of the river: one representative of the Maoris and another of the government to facilitate such reconciliation.

Columbia has also protected its part of the Amazon, giving the rainforests the same legal right as humans. In 2018, in response to a petition, the Supreme Court of Colombia recognized that "fundamental rights of life, health, the minimum subsistence, freedom, and human dignity are substantially linked and determined by the environment and the ecosystem" and declared that the Colombian Amazon was entitled to protection, conservation, maintenance and restoration, while it ordered the government to develop and implement action plans to address eforestation

The movement for nature's rights has now spread across all continents. In the USA, some lawsuits are pending before Courts claiming legal rights for ecosystems. In 2010, the City Council of Pittsburgh, Pennsylvania had unanimously passed an ordinance recognizing the rights of nature as part of a ban on shale gas drilling and fracking. In Canada, in 2021, a county municipality recognised the Canadian Magpie River's "legal rights of personhood". Across the world, many countries, including Switzerland, Portugal, France and Brazil, have specified to the government its obligations regarding protection of nature.

Article 48A under the Directive Principles of State Policy demands the State to "protect and improve the environment and safeguard the forests and wildlife of the country", while Article 51A (g) imposes a funda-mental duty upon citizens to "protect and improve the natural environment, including forests, rivers, and wildlife, and to have compassion for all living creatures". In 2017, taking a cue from the

# Putin threatens to punish EU by cutting gas supply

The European Union, particularly Germany, will be in a spot with Russian gas supply squeezed as peak winter months approach

Russian President Vladimir Putin has stopped Russian gas from flowing to Europe in retaliation to its imposition of economic sanctions in the wake of the invasion of Ukraine. By July 25, the flow of gas had fallen to about 20 per cent of usual seasonal

volumes Disruptions to gas supplies over the past few weeks represented an ominous foreshadowing of what Russia might do to Europe this winter. European countries use much more gas in the winter than they do in the summer.

As Putin planned his invasion of Ukraine in 2021, he honoured Russia's long-term contracts, but found excuses to stop selling into European short-term spot markets,



despite the lucrative opportunities of soaring prices. The supply squeeze in the summer and fall of 2021 left Europeans with dangerously low reserves over the winter of 2021–22.

The European Union Commission's president, Ursula von der Leyen, warned recently that a total Russian cutoff was "likely", and she urged member countries to plan to reduce their gas consumption by 15 per cent (from their average level of use over the past five years).

International The Monetary Fund (IMF) has modeled the effect of a Russian gas embargo. It predicts a surge in inflation and outright recession in many countries in Central and Eastern Europe. Germany is at the worst risk

tries. A generation of German politicians bet their country's energy security on faith in Russia as a reliable supplier. That bet is a bust, and Germany must now scramble through the warm-weather months to prepare for Russian economic warfare.

Gas moves to homes and factories via pipelines. Those networks commit countries to patterns of distribution that are not fast, easy, or cheap to change. For example, Spain imports much of its natural gas from North Africa through underwater pipelines.

An ambitious project to build a major new pipeline from Spain to France was abandoned in 2019. If work were resumed, the project would take at least three years among the European count to finish. Germany's network

could receive more gas from neighbours nearer than Spain via France. It has some capacity for receiving more liquid natural gas by sea and is rushing to provide more. A new facility at Wilhelmshaven, on Germany's North Sea coast, might be ready late this year.

Perhaps the most dangerous point of vulnerability is within the German network

To sustain pressure in high-priority pipes, the gas may have to be turned off altogether to lower-priority pipes. Another agonizing dilemma is much of German industrial production is outsourced to nearby EU partners, Hungary and Slovakia. Those countries depend even more on Russian gas than Germany does.

the US has emerged as the world's top producer of natural gas. It produces so much, in fact, that despite its large domestic consumption, the US now ranks second only to Russia as a gas exporter.

Unfortunately, increasing the volume of those exports as rapidly as needed will not be easy. The US gas exports to Europe must be compressed into liquid form to be loaded aboard ships. Building new liquefaction plants is a complex and costly undertaking. A rule-of-thumb calculation suggests a cost of \$5 billion over four to five years, if regulatory approvals are sped up.

The balance of energy power between Europe and Russia is not all one-sided. Over the medium and long

sources of gas more easily than Russia can find new customers. The most economical way for Russia to sell gas to China would require a vast pipeline-building project across Siberia. The distances and costs are mind-boggling and likely prohibitive, given the competition from liquid natural gas shipped across the Pacific from North America. Russia risks a post-Ukrainewar future as an isolated energy pariah, and its energy behaviour this winter will determine whether that risk becomes an enduring reality.

# UN nuclear chief pushes for deal on nuke plant safety zone

The head of the UN nuclear watchdog agency said Monday that he has started consultations with Ukraine and Russia on his call for a "nuclear safety and security protection zone" around the Zaporizhzhia power plant, and the two sides appear to be interested.

Rafael Grossi, the directorgeneral of the International Atomic Energy Agency, made his proposal last week after leading a team of inspectors to the nuclear plant, Europe's biggest with six reactors, but gave few details at the time.

"What we need here really is Ukraine and Russia to agree on a very simple principle of not attacking, or not shelling, at the plant," Grossi told reporters at the agency's Vienna headquarters. The IAEA has not assigned blame for recent shelling, for which Ukraine and Russia have blamed each

The plant has been occupied by Russian forces but operated by its Ukrainian employees since early in the

Pressed on whether his proposal includes demilitarization, Grossi said: "Basically, it's a commitment that no military action will include or will imply aiming ... at the plant, or a radius that could be affecting its normal opera-

Grossi said of the two sides that he has "seen signs that they are interested in this agree-ment." He added that technical details are being explored, including the radius that an accord would apply to and how IAEA experts would work. Two IAEA experts remain at area.

Speaking at the dialogue, an Indian representative noted with concern the lack of "measurable progress" by the Sri Lankan government on their commitments of a political solution to the ethnic issue- through full implementation of the 13th Amendment of the Constitution, delegation of powers to Provincial Councils and holding of Provincial Council elections at the earliest.

"India's consistent view on peace and reconciliation in Sri Lanka has been for a political settlement within the framework of an united Sri Lanka, ensuring justice, peace, equality and dignity for the Tamils of Sri Lanka, the Indian diplomat said.

# Trial opens of 10 accused over 2016 Brussels suicide attacks

m ore}$  than six years after the deadliest peacetime attack on Belgian soil, the trial of 10 men accused over the suicide bombings at Brussels airport and an underground metro station opened on Monday amid high security.

The only survivor among the Islamic State extremists who in 2015 struck the Bataclan theatre in Paris, city cafes and France's national stadium, Salah Abdeslam, is among the accused.

In all, 32 people were killed in the March 22, 2016 Brussels attacks. Around 900 people were hurt or suffered mental

rorist group" over the morning rush hour attacks at Belgium's main airport and on a central commuter line.

If convicted, some of them could be sentenced to terms of up to 30 years in prison.

tenced to life in prison without parole over the atrocities in Paris, was at the Brussels court on Monday but refused to take part, saying it was "unfair" that he should have to watch proceedings from inside a reinforced glass cubicle.

# **Govt working on electric** highways: Nitin Gadkari

he Government is working The Government is working on developing electric highways powered by solar energy that will facilitate the charging of heavy duty trucks and buses, Union road transport and highways minister Nitin Gadkari said on Monday.

Addressing an event organised by the Indo-American Chamber of Commerce (IACC), Gadkari reiterated that the government wants to develop India's public transport system on electricity.

"The government is strongly encouraging solar and wind energy-based charging mechanisms for electric mobil-

"We are also working on developing electric highways, which will be powered by solar energy and this will facilitate charging of heavy duty trucks and buses while running," he

An electric highway generally refers to a road which supplies power to vehicles travelling on it, including through overhead power lines.

Gadkari said that the government is also encouraging toll plazas to be powered by solar energy.

The minister said the road ministry has conducted route optimisation exercises across major corridors and has designed a newer alignment.

Emphasising that a well developed infrastructure enhances economic activities,



creates new businesses and promotes job creation, Gadkari said, "We are constructing 26 greenfield expressways."

With the launch of PM Gati Shakti Master Plan, he said projects will get faster clearance and it would cut down logistic

Stating that both India and the US are natural partners, the minister invited the US private investors to invest in India's logistics, ropeways and cable car sectors.

He informed that around 3 crore trees would be planted along the national highways and the government is adopting tree plantation practices while construction and expansion of highways.

"And till now we have successfully transplanted 27,000 trees in national highways pro-

According to Gadkari, the government is formulating a new policy called 'Tree Bank'

for tree cutting and tree plan-

As per policy, authorities such as National Highways Authority of India (NHAÍ), The National Highways and Infrastructure Development Corporation Limited (NHID-CL) will have to maintain a tree bank account of planting trees during the project develop-ment. Gadkari said the gov-ernment's emphasis has been on creating a sustainable business ecosystem with an inclu-

sive growth model. He said there is a need to encourage out-of-the-box thought processes and promote creative agenda to weave new pathways.

Benchmark BSE Sensex rose by about 322 points to close above the 60,000 level on Monday tracking gains in banking, IT and energy stocks amid positive global equities.

Rising for a third straight day, the 30-share barometer closed higher by 321.99 points or 0.54 per cent at a three-week high of 60,115.13.

As many as 21 of the index constituents closed in the green. After a strong opening, the index touched a day's high of 60,284.55 and a low of 59,912.29. The broader NSE Nifty

spurted by 103 points or 0.58 per cent to settle at 17,936.35 points, with 36 of its constituents ending with gains. In the three-day rally,

Sensex advanced 1,086 points, while Nifty gained nearly 312 Foreign fund buying, crude oil prices trading near

USD 93 level, and macro data reflecting the strong growth recovery, boosted investor sentiment. Gains in global equity markets also propped up the local equities.

"Domestic economy is witnessing strong vigour and



the same is assisting a steady growth in Indian equities. A 15.5 per cent YoY increase in bank credit during August suggests that the economy is recovering rapidly," Vinod Nair, Head of Research at Geojit Financial Services said.

Investors were also awaiting key consumer inflation and industrial production data to be released after market

Due to rising food prices, domestic inflation figures are predicted to show a gradual rise from 6.7 per cent in July, which could add volatility in the short-term, Nair said.

Among Sensex stocks, Titan rose the most by 2.39 per cent, followed by Axis Bank, Tech Mahindra and Tata Steel. Gains in RIL, Infosys, TCS, ICICI Bank, Bajaj Finance and L&T aided the rally.

# Stocks rise for 3rd | 'Indian rupee shown more resilience than other currencies in recent yrs'

**▼**ndian rupee has shown more resilience than most of the other currencies in recent years and the compounded average growth rate of depreciation is lower as compared to pre-2014, commerce and industry Minister Piyush Goyal has said.

He also said that exporters should not be dependent on a depreciating rupee and they should stand on their own based on the quality of prod-ucts and ability to serve the needs of customers in the global markets. "I do not think there is any

comfortable or uncomfortable level for the rupee. Rupee finds its own place. It's a function of several natural factors -- a function of inflation, capital flows and the risk-reward ratio in each country. I am happy that the Indian rupee has shown more resilience than most of the currencies in recent years," Goyal said in a media interaction.

To a query on what could be the comfortable level of the rupee where it does not hurt imports, and make exports competitive, the minister said: "If you look at the Indian rupee solely before 2014, and if you took a CAGR (Compounded Annual Growth Rate) of the rupee depreciation, it was in the range of about 3.25-3.5 per cent. Currently, the Indian rupee is depreciating at about 2.5 per cent CAGR, so there has been a significant improvement in the strength of the Indian rupee.



The Indian rupee was trading at Rs 79.67 to a US dollar in early trade on Monday.

When asked about the European Union's plan to withdraw export benefits under the Generalised Tariff Preference Scheme (GSP), Goyal expressed confidence that Indian exporters will be able to supply significantly on the basis of their strength.

India's exports from sectors such as plastics, stone, machinery and mechanical appliances worth about USD 8 billion to the EU would not be eligible for low- or zero-duty concessions from January 2023 after removal of GSP benefits by the EU.

"We are undertaking free trade agreement negotiations with them (EU). We will focus on that negotiation. I don't think GSP is necessary for expanding trade engagement in any case. It's better to have a FTA with the EU. Without GSP (with the US), our exports have not suffered," he added.



Alcaraz wins US Open and becomes youngest world number one

panish teenager Carlos Alcaraz claimed his maiden Grand Slam title at the US Open on Sunday and became the youngest man to ascend to the world number one

The 19-year-old dragged his weary body to a 6-4, 2-6, 7-6 (7/1), 6-3 victory over Norway's Casper Ruud in the

Alcaraz, the first teenager to claim the top ranking, is the youngest Grand Slam men's champion since Rafael Nadal at the 2005 French Open after a performance which yielded 55 winners and 14 aces.

On a day of landmarks, he is also the youngest champion in New York since Pete Sampras in

"This is something that I dreamt of since I was a kid -- to be number one in the world, to be a champion of a Grand

Slam," said Alcaraz.

"This is something that I worked really really hard for. It's tough to talk right now, a lot of emotions.

"This is something that I tried to achieve, all the hard work that I did with my team and my family. I'm just 19 and all the top decisions were taken by my parents and my team. This is something that is really, really special for me."

İt was a gruelling tournament for Alcaraz who also claimed the record for most time spent on court at a single Grand Slam event, passing the 23 hours and 21 minutes it took Kevin Anderson to finish runner-up at



Wimbledon in 2018.

Most of his 23 hours and 40 minutes were taken up by the more than 13 hours it took him to play three successive five-setters to reach the final.

He had to save a match point in his five-hour 15-minute quarter-final win over Jannik

Nadal was quick to congratulate the player widely seen as his heir apparent. "Congratulations @carlosal-

caraz for your first Grand Slam and for number 1, which is the culmination of your great season, which I am sure will be many more," tweeted the 22-

time Slam title winner.

Defeat for Ruud, who was also vying for the world number one ranking, was his second in a Slam final this year after he was routed by Nadal in the French

"Today was a special evening for both Carlos and I. We knew what was at stake, and I think it's fitting both finalists will be number one and number two in the world," said Ruud. "I'm happy with that num-

The Spaniard sensed his chance, breaking for 4-2 in the fourth set before taking his aces count to 12 to lead 5-2.

show the world - a couple of decades back, we had aggression in our side, and we want ed to create those moments (again) as a unit," a beaming Rajapaksa said at the post match press conference.

oking ic want to keep up this momentum ahead of the World Cup. With the crisis happening back home, this is a tough time for all the Sri Lankans, but hope we brought some smiles on the faces of our people."

This is to the whole nation; they were waiting for this for so long," a smiling Rajapaksha added.

Ŝri Lanka clinched the much-needed Asia Cup title in the backdrop of the country's worst economic crisis coupled with political unrest.

Sitting beside Rajapaksha was Sri Lanka's captain Dasun Shanaka and the 31-year-old praised his teammates for responding so well throughout the tournament despite losing to Afghanistan in their tournament opener.

'After that first loss, we



had a serious discussion," Shanaka said.

"We knew we had the talent, but it was about applying those in game scenarios and all the players stood up. It's the environment we created as a team and coaching staff that has paid off," he added.

The Sri Lankan skipper also had a message for the fans back home following the title

"Believe in our cricketers. A lot of bad things are going around. As cricketers, they too should enjoy their lives as well,

not spreading bad things. They have private lives too. Keep believing, that is the key. As a captain, I give confidence to the players, (whatever) I can. I can't ask more than that," Shanaka said.

Shanaka further said that the Asia Cup win could be a stepping stone for greater things to come for Sri Lanka cricket, which is going through a transition phase for a long time. "Even two-three years back, the team used to play good cricket, but the winning factor wasn't there," he said.

# Raza, Mcgrath win ICC **Player of Month for Aug**

India's Jemimah Rodrigues **⊥**missed out as Australia's Tahlia McGrath and Zimbabwe's Sikandar Raza were on Monday voted as ICC Player of the Month for August following their outstanding international performances in their respective categories.

Rodrigues was nominated for the award in the women's category, which also featured Commonwealth Games gold medal-winning Australian duo of Beth Mooney and Tahlia McGrath.

However, McGrath became the latest Australian star to win the ICC Women's Player of the Month award after helping her country claim the Commonwealth gold in Birmingham.

Following in the footsteps of Alyssa Healy, who claimed the award in April, McGrath amassed 114 runs at an average of 57 during the month, together with five wickets at 13.40.

Amongst a series of strong displays, undoubtedly her star performance came in the victory over Pakistan, where McGrath scored an unbeaten 78, before her three wickets and a run out helped maintain her side's unbeaten path

Raza, on the other hand, became the first Zimbabwe international to win the award among

On his way, the 36-year-old overcame leading all-rounders Mitchell Santner of New Zealand and England's Ben Stokes who also starred during an actionpacked month of men's cricket.

"I'm incredibly humbled and honoured to have won the ICC Men's Player of the Month award from the ICC. It's even more humbling being the first Zimbabwean to ever win the award," he said in an ICC release.

"I would like to thank every-

body who has been in the changing room with me over the past three to four months, namely the technical staff and the players. Without them this would not have been possible.

Raza produced an unforgettable series of scores against Bangladesh and India in Harare across two ODI series.

The all-rounder struck two magnificent unbeaten centuries (135 not out and 117 not out) during the historic 2-1 series victory over Bangladesh, on both occasions securing win for his side in dramatic fashion while chasing big

He scored another memorable century against India later in the month, albeit in a defeat, continuing his sensational form shown throughout 2022.

In addition to his exploits at the crease, Raza also highlighted his bowling threat in the shorter format, taking seven wickets during the month.
