# Major crisis erupts in Raj Cong over CM's job

Gehlot bowls googly on Gandhis; talks on as 90 MLAs loyal to CM threaten to quit

PIONEER NEWS SERVICE JAIPUR/NEW DELHI

Amajor crisis has erupted in Rajasthan Congress with nearly 90 Ashok Gehlot loyalist MLAs submitting their resignation to Assembly Speaker CP Joshi over the High Command's reported decision to hand over the reins of the State Government to Sachin Pilot.

The Speaker is unlikely to accept their resignation and the move is seen as a pressure tactic to scuttle Pilot's chances. The Congress is in search of a new Chief Minister in the State after Gehlot reluctantly agreed to step down from the post if he is elected the new Congress president.

The crisis could not have come at a worse time for the Congress. Despite tall claims by the Congress leaders that the Rahul Gandhi-led 'Bharat Jodo Yatra' is all set to revive the party, the leadership looked as helpless as ever in dealing with dissidents. Clearly, the Congress leadership

was caught off guard.
Few had expected that

Gehlot would bowl such a googly on the leadership, but the wily leader seemed determined not to allow Pilot to take over the reins

Soon after it was 'confirmed' that the Congress High Command wanted to anoint Pilot as the CM, about 90 Gehlot loyalists threatened to resign as MLAs and rushed to Rajasthan Speaker CP Joshi's residence. The MLAs have thrown their weight behind Joshi and want him to replace Gehlot.

These MLAs pointed out that Pilot plotted to bring down attempt, should be made the new Chief Minister.

Earlier, Pilot and nearly 18 MLAs supporting him turned up at Gehlot's residence and waited for the CLP meeting. Congress observers Mallikarjun Kharge and Ajay Maken were present there. But the MLAs loyalist to Gehlot held a parallel meeting at Gehlot held a parallel meeting at the residence of senior Minister Shanti Dhariwal. The CLP meeting could not take place and a

"humiliated" Pilot went back licking his wounds.

Sources said that Sonia Gandhi conveyed to Gehlot and Central observers Maken and Central observers Maken and Kharge that she wanted them to consult each and every MLA through the night and persuade them to fall in line. The entire process was taking place at Gehlot's residence where the MLAs kept returning from CP loshi's residence. Joshi's residence.

"We aren't going to Delhi at the moment. We have been instructed by Congress president to conduct one-to-one talks with Rajasthan Congress MLAs. We'll meet them tonight," said Maken.

Despite publicly claiming that he would do whatever the party wanted, Gehlot did just the opposite. He mobilised his supporters and raised a virtual banner of revolt against the Gandhis, triggering an unprecedented

implosion in the legislative party.

The rally, organised to mark the 109th birth anniversary of late Deputy Prime Minister Devi Lal by INLD supremo Om Prakash Chautala to forge a joint front against the BJP, was attended by Bihar Chief Minister Nitish Kumar, his Deputy and senior RJD leader Tejashwi Yadav, Nationalist Congress Party (NCP) chief Sharad Pawar from Maharashtra, Communist Party of India (CPI) leader Sitaram Yechury, JD(U) leader KC Tyagi, Shiromani Akali Dal president Sukhbir Singh

# **Kejriwal in Gujarat promises to** make contractual staff permanent

Delhi Chief Minister and Aam Aadmi Party national convener Arvind Kejriwal on Sunday promised to make contractual employees permanent and implement "equal work, equal pay" if his party is voted to power in Gujarat.

Addressing a town hall with outsourced and contractual employees, Kejriwal also said his party will end the contract system if voted to power so that money comes directly into the bank account of the employees without middlemen taking away anything.

Assembly polls are likely to be held in December in Gujarat, where the Bharatiya Janata Party has been ruling for the past 27 years.

"I can see that every government is slowly ending gov-



ernment jobs. They say they (contract workers) do not work when they are made permanent. It is wrong to say that a government employee does not work if he is made permanent. He works if he is given respect and full salary, Kejriwal said.

"If we form a government, all contractual employees will be made permanent. And we will do so properly so that the court does not grant a stay later

With Punjab Chief Minister Bhagwant Mann by his side, Kejriwal said there are 36,000 contractual employees in Punjab who will be made permanent. He has made 8,500 teachers permanent.

It is taking time in order to ensure there is no court stay after they are made permanent, Kejriwal added.

The CLP was expected to pass a one-line resolution saying all Congress legislators have full faith in the party president's decision to appoint the new chief minister. But nothing of that sort happened, and most of the MLAs rushed to CP Joshi after holding a meeting at Dahriwal's bungalow.

"All the MLAs are angry and are resigning. We are going to the speaker for that. MLAs are upset that how can CM Ashok Gehlot take a decision without consulting MLAs," Congress MLA Pratap Singh Khachariyawas told Media at Jaipur.

Khachariyawas said Gehlot should pay heed to the suggestions of MLAs. "We have 92 MLAs with us," the Congress

leader claimed.

Gehlot was expected to quit as the chief minister of Rajasthan if he wins the election to the post of the Congress national president, as the party has a "one-man one-post" policy.
Before the meetings, Gehlot

said, "It has been our tradition that whenever the CLP meets during elections or for the selection of chief minister, a one-line proposal is passed that we are giving the right (to make the decision) to the Congress president. I believe this will happen today, too.'

Gehlot loyalists are opposing the move to make Pilot the next CM saying he remained a rebel for a long and always destabilized the Gehlot government. Independent MLA and

Gehlot advisor Sanyam Lodha said, "If the decision is as per the wishes of the MLAs, then the government will run. But if it is not as per the wishes of the MLAs, then can the government function?... Obviously, there will be a threat of the government falling.

"We do believe that in any process if any party is taking a decision, they need to be transparent about it. So the idea that something is blocked without assigning a reason, it sort of

He was responding to a question on the issue of repeated holds and blocks on proposals to list Pakistan-based terror group leaders under the UN sanctions regime and whether this came up in his talks with his global counterparts as he met them during the high-level General Assembly

"It came up in some of my meetings. I also mentioned it in my BRICS intervention," he said referring to the meeting held on Thursday on the margins of the General Assembly between the foreign ministers of Brazil, Russia, India, China, and South Africa group -Brazilian Foreign Minister Carlos Alberto Franco Franca, Russian Foreign Minister Sergey Lavrov, Chinese Minister of Foreign Affairs Wang Yi and Minister of International Relations and Cooperation of the Republic of

South Africa Naledi Pandor. China, a veto-wielding per-

manent member of the Security Council, has repeatedly put holds on listing proposals by India, the US, and other allies to blacklist Pakistan-based terrorists under the 1267 Al Qaeda Sanctions regime of the Council.

Last month, China put a hold on a proposal by the US and India at the United Nations to blacklist Abdul Rauf Azhar, the brother of Jaish-e Mohammed (JEM) chief Masood Azhar and a senior leader of the Pakistan-based terror organisation. Abdul Rauf Azhar, born in 1974 in Pakistan, was sanctioned by the US in December 2010.

In June this year, China put a hold, at the last moment, on a joint proposal by India and the US to list Pakistan-based terrorist Abdul Rehman Makki under the 1267 Al-Qaida Sanctions Committee of the UN Security Council.

"We hope that reason would prevail and people, first of all, would not arbitrarily or politically block," Jaishankar said, underlining that the message is that this is "not inter-state politics which we are talking about.

"We are trying to get across our message that terrorism is not political. It should not be used as a political tool, its consequences should not be made political.

"If you go into the UN and say does everybody consider terrorism a common threat, everybody will say yes. So we are saying well, if that's what your position is, then why don't your policies and your actions follow up on it," he said.

With the Chinese Foreign listening, Jaishankar had said during a ministerial meeting in the Security Council on Ukraine this week that the fight against impunity is critical to the larger pursuit of securing peace and justice. The Security Council must send an unambiguous and unequivocal mes-

sage on this count. He had said "politics should never ever provide cover to evade accountability. Nor indeed to facilitate impunity. Regrettably, we have seen this of late in this very Chamber, when it comes to sanctioning some of the world's most dreaded terrorists.'

"If egregious attacks committed in broad daylight are left unpunished, this Council must reflect on the signals we are sending on impunity. There must be consistency if we are to ensure credibility," he said.

Meanwhile, the Delhi Commission for Women (DCW) also issued a notice to the police in this connection and demanded strict action against the accused.

According to a DCW official, the Commission received a complaint from the mother of the boy who informed that her son was brutally sexually assaulted.

"The complainant informed that her child was gang raped on September 18 by 4 men who even inserted a rod in his private parts. She has informed that the accused also beat him up brutally with bricks and rods. The child



informed his parents about the horrific ordeal on September 22," said the DCW

The victim and the accused are neighbours and belong to the same age-group of 10-12 years. They hail from the same community, police said, adding that the incident took place on

The police received information from LNJP hospital on September 22 that a 10-yearold boy has been admitted after being physically assaulted, officials said.

Immediately, a police team reached the hospital and met the child's parents who, however, refused to give statement. The child was under medical

observation, police said. Although the investigation officer regularly contacted the family, the latter refused to give

a statement till Saturday. The police then arranged a a counsellor from an organisation

On extensive counselling, the victim's mother disclosed that on September 18, her son was physically assaulted and sodomized by his three friends,

the officer said. Based on her statement, a case was registered under section 377 (Unnatural offences) and 34 (common intention) of the Indian Penal Code and Protection Of Children Sexual Offences Act, he added.

The victim is still under medical observation, police said. The Delhi Commission for Women (DCW) on Sunday issued a notice to the police in connection with the matter.

The DCW said it received a complaint from a woman who informed that her child was sexually assaulted by people who even inserted a rod in

his private parts
However, police said investigation so far has not revealed that a rod was inserted in the private parts of victim but the medical examination will ascertain it.

The woman claimed that the accused had also beaten up her son with bricks and rods. The child, who informed his parents about the incident on September 22, is in hospital.

The panel has sought a copy of the FIR registered into the matter along with the details of the arrested accused and a detailed action taken report by September 28. DCW chief Swati Maliwal

said, "This is a very horrific incident. The boy was gangraped by four persons who inserted a rod in his private part and beat him up merci-

"The boy is presently admitted in hospital and is in ICU. Our team is continuously present with the family and assisting them. The accused must be arrested immediately and strictest action must be taken against them.

# 10-year-old boy sodomised Woman alleges bouncers thrashed her, 'tore off' her clothes at club

Owner denies charges, accuses cops of falsely implicating him for not paying '₹5 L extortion'

Awoman and her friends were allegedly thrashed by the bouncers of the "Da Code" club in South Delhi. The women alleged that her clothes were torn off and the manager of the club was also involved in the brawl, said the police. However, the owner of the club denied all charges and accused Delhi Police personnel of mental and physical harassment and demanding 'extortion' money. The club owner Surendra Singh claimed that the club has been falsely implicated in the case as he didn't pay the extortion money amounting to ₹5 lakh.

Police said they are enquiring into the allegations made by the club owner.

According to the police, the incident took place on the intervening night of September 17-18 and a PCR call was received at regarding the inci-

"The female caller told police of misbehaviour and tearing off the clothes of a



woman at the club in South Extension after which the police reached the spot and met the caller," said a senior police official adding that a police

team reached the spot. "On reaching the spot, police team found that the caller's clothes were messed up and disordered. She told police that she was misbehaved and hit by the bouncers and they had also touched her inappropriately and tore her clothes," said the police official. "An FIR under sections

323 (Punishment for voluntarily causing hurt), 354 A (Sexual harassment and punishment for sexual harassment), 354 B (Assault or use of criminal force to woman with intent to disrobe), 509 (Word, gesture or act intended to insult the modesty of a woman) and 34 (common intention) of the Indian Penal Code has been registered.

# City's rain deficiency drops from 49% to 17% due to showers

The national Capital's overall rain deficiency dropped from 49 per cent to 17 per cent due to heavy rainfall in September. The India Meteorological Department (IMD) data showed that the national Capital received 450.9 mm of rain as against the normal of 540.1 mm between June 1 and September 26, a deficit of 17 per cent. According to IMD data, East Delhi is the only area that has seen a surplus rain at 32 per cent

The IMD data showed that Central Delhi received 606.2 mm rain against the normal of 659.7 mm, a deficit of 8 percent; New Delhi received 508.5 mm rain as against the normal of 635.1 mm, a deficit of 20 per cent; North Delhi received 542 mm rain as against the normal of 554 mm, a deficit of 2 percent; North East



Delhi received 301.6 mm as against the normal of 659.7 mm, a deficit of 54 percent; North West Delhi got 322.4 mm rain as against the normal of 398.1, a deficiency of 19 percent; South Delhi got 575.8 mm rain as against the normal of 658.7

mm, deficiency is almost 13 percent and South West Delhi got 485.6 mm rain as against the normal of 549.3 mm, almost 12 percent less this season so far. The East Delhi is exception this monsoon season which received 32 percent excessive rain so far. East Delhi received 868.2 mm rain as against the normal of 659.7 mm.

June saw a deficit of 67 per cent, in July there was surplus rain of 37 per cent and August saw an 82 per cent deficit with only 41 mm of rain recorded against a normal of 233 mm.

The IMD official said that the three consecutive days of rain have not managed to wipe out the city's monsoon rain deficit. The city saw a massive shortfall in June and August, but July received more rain than normal.

"Now, September has brought more than usual rain, but it has still not managed to make up the shortfall," he said.

The temperature is also expected to increase in the days to come. The maximum temperature in the national capital on Sunday settled at 31 degrees Celsius, three notches below the season's average. After three consecutive days of rain, there wasn't any in the national capital on Sunday

The minimum temperature in the city settled at 22.6 degrees Celsius, a notch below the season's average, the IMD said. The relative humidity oscillated between 100 per cent and 63 per cent, it said. In the last 24 hours, the Safdarjung

Observatory, Delhi's primary weather station, received 18.6 mm of rainfall, while the Palam station recorded 23.7 mm of rainfall. Delhi's air quality index (AQI) was recorded in the 'satisfactory' (53) category around 7 pm, Central Pollution Control Board data showed.

# 54-year-old man held with 45 kg opium worth ₹30 cr

The Special Cell of Delhi ■ Police has arrested a 50 year-old man in the national Capital with 45 kg Opium worth more than ₹30 Crore in the international market.

The accused is identified as Jasvir Singh (54), a resident of Moga, Punjab. Police said that he used to hide opium between rice packets to dodge the law enforcement agencies.

According to Rajiv Ranjan 19h, the Deputy Singh, Commissioner of Police (DCP), Special Cell, the sleuths of Special Cell were working on information that an interstate narcotic drug cartel is active in the States of Manipur, Uttar Pradesh, Uttarakhand and Delhi-NCR.

"Police had received information that members of this cartel are involved in supply of opium in Delhi, NCR, Uttar Pradesh (UP), after procuring the same from suppliers of Manipur, who further collect raw material from hilly areas around international borders of Manipur and Myanmar," the DCP said.

"Police had started developing information around 3-4



months ago and during the process, members of the said cartel were identified and their activities were kept under discreet surveillance," said the DCP.

"On September 24, specific inputs were received about Jasvir, who was involved in drug trafficking. He used to supply opium on the directions of Dilbag resident of Bazpur, Uttarakhand after procuring it from one Limanthang resident of Manipur," said the DCP.

"Acting on the inputs, that Jasvir would come near Rajghat DTC depot, Mahatma Gandhi Marg, Delhi to supply heroin to Surender a resident of Delhi, a added.

The accused have been identified as Hermenn Sabherwal (43), Govind Tulsian (52), Diprana Tiwari (32), Trilok Singh (53) and Mrityunjoy Roy (44). Police said Singh is employed as a Multi Tasking Staff at the Health ministry on a permanent basis while Tiwari is also an MTS but on a contract

"Roy was on deputation with Minister of Home Affairs from SSB and was a reception officer in the Ministry of Health and Family Welfare at Nirman Bhawan," a police statement said.

According to Ravindra Yadav, Commissioner of Police, Crime, a probe was initiated after several complaints were received from a person named



Sunil Kaushik and others where the victims alleged that they had been duped of ₹15 crore on pretext of getting them work orders for transportation of Covid vaccines.

"In all the complaints, the victims narrated the same modus operandi. All the complainants claimed that they were made to sit inside the conference room of the Ministry of Health and Family Welfare in order to execute the work order for transportation of Covid vaccines," said the Special CP.

"After preliminary enquiry, the case was registered and investigation was taken up by EOW. A total of six complainants came forward whereas the cheated amount comes out to be ₹15 crore," he said.

"The investigation revealed that in May last year, the

with the complainants and offered them the ministry's work order. To gain the trust of the complainants, the accused also took the victims to the Union Health ministry located inside the Niman Bhavan premises in central Delhi," said the Special CP.

# DDMA's 'garbage in & garbage out' plan averts flood in Capital

The Delhi Disaster Management Authority (DDMA) has managed to avert floods during monsoon by adopting the concept of 'garbage in and garbage out.' This concept means that the water is discharged from the capital at the same speed it is pushed into from the barrages of Hathnikund, Okhla and Wazirabad .


The Authority also monitored, for the first time, the hourly discharge of water from the Okhla barrage which was managed by the Uttar Pradesh flood and irrigation control department. Following this, the water level did not peak from 205.99 despite the discharge rate being 1.91lakh cusecs and 2.21 lakh cusecs on August 11, 2022. One cusec is equivalent to 28.32 liters per second.

The flood warning level of the Yamuna is 204.50 meters, while the danger level is 205.33 meters. The evacuation level for the people living in the low-lying area is 206

Sushil Singh, Special Chief Executive Officer (CEO) of the DDMA said that this year when the water was released by the Harvana from the Hathnikund barrage, the authority started the preparations to avert any flood situation in the capital.

"As the water reached Delhi, the water level at the old railway bridge started rising, I myself visited the Okhla barrage to ensure that the water is discharged from the same speed that is headed from the Hathnikund barrage," Yadav said.

'The water was discharged in a synchronized manner from the Wazirabad and Okhla barrage due to which this year



mark, following which there was no need to shift the people residing in the low lying areas," Yadav added.

During the monsoon, many parts of Delhi, including arterial roads, get waterlogged leading to traffic snarls even in an

hour's rainfall. The main reason is the problems related to the city's storm water drains. The city works on a drainage master plan made in 1976 and one such plan prepared by IIT Delhi for the Delhi Government in 2018 is yet to be implemented. According to officials, in Delhi's case,

flooding could be due to two reasons: floods in the Yamuna or local rainfall. In 1978, Delhi had witnessed a flood due to the rise in the Yamuna water level. But the annual urban flooding we see is due to local rainfall. The run-off water (water left after being absorbed by the earth) from the local rainfall is supposed to drain into the Yamuna through storm water drains. But due to a combination of reasons, including sewage flowing in storm water drains, it does not properly drain into the Yamuna

and leads to urban flooding. The drains were made decades ago to handle a particular amount of run-off water. Over the years, the paved area has increased due to development.

While informing about the preparations made by the DDMA in case of the flood situation, a senior DDMA official said that the arrangements including boats have been deployed at various locations near the Yamuna River. 17 boats are placed at Boat Club under District Magistrate (East). In addition, 34 boats belonging to Irrigation and Flood Control Department are at their Timarpur shore. Out of these 51 boats, 29 are currently plying in the Yamuna River. Rest are kept on standby mode.

In 2021, the Yamuna river breached the danger mark on July 30 and the water level at the Old Railway Bridge had risen to 205.59 meters.

In 2019, the flow rate had peaked at 8.28 lakh cusec in August, and the water level of the Yamuna had hit the 206.60meter mark, while in 1978, the river had swelled to an all-time record water level of 207.49 meters. In 2013, it had risen to 207.32 meters. What creates a flood-like situation in the

#### national Capital? Normally, the flow rate of the water at

the Hathnikund barrage is 352 cusecs, but the discharge increases after heavy rainfall in the catchment areas. The water discharged from the barrage normally takes two to three days to reach the national capital. Following this the water level also increases in Delhi, creating an alarming situation in the city.

### Wild elephants will not be burnt or buried anymore, | World Pharmacists carcass to be left for natural decomposition

VV natural death or in mananimal conflict such as electrocution might not be incinerated or buried as has been the present norm. Instead, their carcass will be left in the open for natural decomposition and scavengers to feed on since they are an important source of energy and nutrients for predators.

However, those who are found poisoned, as confirmed by their post-mortem report, will continue to be buried, a senior official from the Union Environment Ministry said about the Government's plan to tweak the current rules. "Once it is done, a notification will be issued in this regard soon for the States to follow the new norms," he added.

In fact, Kerala has already taken a lead in this direction and way back in April had issued instructions to its forest habitat so that it can be decomposed on its own. Usually, huge earth has to be dug to bury the elephants which are mostly around 3000 kg in

Earlier a wild elephant after its death due to any reason used to be buried or burnt along with its tusks after its post-mortem. But now, if it is found to be succumbed due to like a rail hit or electrocution, the body will be left in the jungles so that other animals can feed on it. However, if found poisoned, then it will be buried so that other animals do not eat the poison-laced body," the official added.

He said that there have been incidents as captured by cameras, even tigers have been found to scavenge on megaherbivores like jumbos. Experts tion.

killed on railway tracks between 2019 and 2021, as per government data.

As per the last count in 2017, India has 29,964 elephants. According to Government data, on average, 500 people are killed annually by elephants, and about 100 elephants are killed in retalia-

#### 'Removing toxic proteins from brain goal of most therapies for Alzheimer's treatment'

 $S_{\text{potential non-invasive ther-}}^{\text{cientists have identified a}}$ apy i.e reducing the amount of toxic protein which, they said when aggregate is the main cause of neuro cell death causing Alzheimer's disease.

These proteins are also present in the blood, and according to this expert of the UMA they are in equilibrium with the brain -if they increase in the brain, they increase in the blood, and vice versa. Based on these results, Moreno proposes removing these toxic aggregates as a target for Alzheimer's disease therapy. The paper was published by the scientific journal Molecular Psychiatry, which belongs to


the Nature Group. "Removing the toxic proteins from the brain is the goal

of most of the current therapies for Alzheimer's disease", explained scientist of the UMA, Inés Moreno, in collaboration with the University of Texas, of the UMA group "NeuroAD". "We have verified that if

we remove toxins from the blood, they drain again from the brain to blood in search of equilibrium, improving the clinical signs and pathology of the disease", says Moreno.

This finding "opens the door to potential non-invasive therapeutic strategies to be implemented at a circulatory "The study holds impor-

tance for India too given that Alzheimer's disease is not only a health issue but also is a social problem as patients suffering from Alzheimer's are converted to dementia patients within five years after which they cannot care for themselves,



said Dr RP Parasher, Medical Superintendent of the Panchkarma hospital, Prashant Vihar in Delhi.

Dr Prashar suggested that people suffering from respiratory diseases, cardiovascular diseases and psychosomatic disorders can be treated by adopting a holistic approach

including ayurvedic medicines, Panchkarma therapy, yoga, counselling and psychotherapy. 'We have Ayush Post

Covid Care Centre at the Panchkarma hospital which was started in July last year. Ayurvedic medicines like Ashwagandha, Jatamansi, Brahami, Mandukparni, Shankhpushpi, Turmeric, Tulsi, Giloy, Smriti Sagar Ras, Yogender Ras, etc. are quite effective to treat Alzheimer's and Dementia," he said, adding that recently they held a fiveday camp for the treatment of neurodegenerative disease.

At present more than 24 million people are suffering from Alzheimer's around the world out of which 6.1 million are in India alone. Cases of Alzheimer's are expected to increase threefold by 2050. People over the age of 60 years will contribute to 19% of the Indian population as reported by Dementia India Report.

Obesity, diabetes, high blood pressure, smoking, and alcohol consumption are among the main factors responsible for developing Alzheimer's disease besides the



# **Himalayas burning**

A young girl, Ankita Bhandari, is murdered but Uttarakhand Govt's response is sloppy

he murder of Ankita Bhandari, a 19-year-old female receptionist at a hotel, has exposed for the nth time the underbelly of Indian politics. A worker at the Vanantara Resort in Pauri district, she was allegedly killed by three persons, including the hotel's owner who is the son of a Bharatiya Janata Party leader in Uttarakhand. According to media reports, the culprits wanted to push her into prostitution, which she resisted. She is also said to have resisted a molestation bid by the main accused Pulkit Arya, son of Vinod Arya. The BJP has expelled Vinod Arya from the party. On Saturday, her body was recovered from a canal. Not surprisingly, the murder has sparked public outrage, not just in the Himalayan State but across the entire country. A young life was snuffed out because the son of a politician thought he could do whatever he wished to — kiss her forcibly, push her into prostitution, throw her into a canal — and get away with it. Ankita's family members are not just angry but also suspicious of the



decisions and actions of the Uttarakhand authorities. Ankita's relatives and others disrupted the Srinagar-Kedarnath highway in protest. They have questioned the State Government's decision to demolish the resort where the victim worked, alleging that it is a bid to destroy evidence. They have also refused to cremate the body until they get the final postmortem report. The provisional postmortem report states that Ankita died because of drowning.

The Opposition has supported the family's stand. Calling it "a planned murder," senior Congress leader and former Chief Minister Harish Rawat said the demolition was carried out to destroy evidence.

The Opposition has also accused the police of lethargy. It may be pointed out that it was the land revenue officials who registered the first information report in this case. Uttarakhand Police chief Ashok Kumar, however, didn't find that awkward, claiming that the State has "a system of land revenue officials registering FIRs". The real problem, however, is politicians' disregard for their basic functions: keeping the administrative machinery well-oiled and maintaining law and order. This disregard is in direct proportion to their fondness for organising events. For instance, days before Ankita's murder, Uttarakhand Chief Minister Pushkar Singh Dhami celebrated his birthday with differently abled children at Dehradun. He called it Sankalp Diwas (Determination Day). A celebrated slogan of his party is 'Beti bachao, beti padhao'. Dhami and other BJP leaders have said many nice things about the education and wellbeing of girl child, women empowerment, gender justice etc, and then there have been programmes like the one on Sankalp Diwas where homilies are delivered. But even a million homilies, platitudes and events can't do what sound administration and good policing can. As it is, Dhami is on a weak wicket politically; he must realise that pro-forma clichés and actions like honouring kanwarias would do little good, but focus on governance can.

The rulers are the ones who set the benchmark of quality and standard in normal life. The stand-off featuring Kerala Governor Arif Mohammed Khan and Chief Minister PinarayiVijayan was a blot not only on democracy but on the entire political discourse. What started as a wordy duel soon degenerated into name-calling and using the choicest of abuses by certain CPI (M) leaders known for their contempt for civility. Arif Mohammed Khan should have used his reign in Thiruvananthapuram Raj Bhavan to learn that the Marxists are blunt and hubristic towards persons who do not agree with their line of thinking. t seems that to the vast majority of us in this country, from every stratum of society, what matters most, is keeping up appearances rather than concentrating on the substantive aspect of the issue. A characteristic that we are willing to defend at any cost, in the courts, indulging in verbal jousting and even letting loose bulldozers.

Take for instance the issue of developing patriotism within our citizenry. Undoubtedly a noble endeavour, but hardly likely to be fulfilled by launching a one-week concerted drive to convince citizens to fly the national flag on their balconies or in their cars, that is if it is to be anything more than just a marketing gimmick. Yet the Central Government did just that with the "Har GhaR Tiranga" initiative, launched by the Prime Minister, just prior to our Nation's 75th Independence Day. Leaving that aside, obvious-

Hardly a reflection of either national pride or reverence for our National Flag. Or, for that matter, take the recent unveiling of Netaji Subhas Chandra Bose's statue at India Gate by the Prime Minister with much fanfare. It was a muchdeserved recognition of the vital contribution to our freedom struggle, not just by Netaji, but the soldiers of the Azad Hind Fauj and other liberation armies, of which we are mostly ignorant. The Italian organized and led 'Battaglione Azad Hindoustan" of Centro Militare and the Germanled "Legion FreiesIndien (Free Indian Legion)" which was first established by Netaji before he moved to Japan. Our history books focussed on the contribuion of Manatma Gandni, Pandit Nehru, and the Congress, while our Independence struggle, it conveniently ignoring the sacri- was re-constructed by the



fice of tens of thousands of men and women, despite over twenty thousand of them having been martyred.

Indeed, one must thank the Prime Minister for this long overdue gesture, but in truth, it has turned out to be just an illusion, largely bereft of any substance, by which Prime Minister Modi and the BJP clearly hope to benefit at the hustings. That would have required the government to institute measures to assist the handful of veterans of the INA and other rebel armies still alive, including those living in penury and without recognition in Myanmar, Malaysia, and Singapore. Sir —The Indian rupee has breached the ₹80 mark against the US dollar and touched ₹81.22. The rupee lost 1.5 percent in two days, said to be owing to the US Federal Open Market Committee's decision to raise the federal funds' target rate. The dollar is expected to strengthen even further. Asheesh Chanda, CEO & Founder, Kristal.AI and winner of the Indian Achievers' Award 2021, has this to say, "As an Indian investor, one would be well advised to dollarise their investments as even rupee is expected to decline further this year." # INDIA MAKING DRUGS, VACCINES FOR WORLD

COVID-19 affirmed India's status as a global pharma manufacturer

In the ever-increasing demand for pharmaceutical solutions and products globally, the Indian pharmaceutical industry has certainly established itself as a significant contributor. During the COVID-19 pandemic, India has been on the forefront with a huge export volume of medicines and medical equipment to different countries to mitigate the impact of the coronavirus, which included exports of over 65 million vaccines globally.

India continues to play a key role in producing various critical, high quality and affordable medicines for domestic and global markets. India caters to 50-60 per cent of the global demand for different vaccines, including ARVs. Almost 40 per cent of generic drugs consumed in the United States and 25 per cent of all the medicines dispensed in the United Kingdom are supplied by India.

India accounts for 60 per cent of global vaccine production, contributing 40-70 per cent of the WHO demand for Diphtheria, Tetanus and Pertussis (DPT) and BCG (Bacillus Calmette–Guerin) vaccines, and 90 per cent of the WHO demand for measles vaccine.

With low-cost skilled manpower and a solid domestic production base, India is gradually emerging as a global base for pharma manufacturing. The Indian pharmaceutical industry has gained from steps taken by the government such as changes in industrial policy, patent law and investments in developing indigenous capacity. Indian pharmaceuticals only had a five per cent share of the market in India, while foreign-owned pharmaceutical companies had a 95 per cent share in 1947.



However, fast forward to 2020, domestic companies held close to an 85 per cent share of the pharma market. By regulating prices through 'Drug Prices Control Order' and encouraging the manufacture of generic drugs, the government paved the way for the growth of both public-sector and private companies. It was the changes in the Indian Patent Act of 1970 that led to a booming generics drugs industry in India which was valued at \$33 billion in 2017.

India joined the World Trade Organisation (WTO) in the 90's and had to sign the Trade-Related Aspects of Intellectual Property Rights (TRIPS) agreement. Though this created certain challenges for the industry, India continued to build on its advantages and manufacture lifesaving and affordable drugs, vaccines and diagnostics which rightfully earned it the moniker—pharmacy of the world.

The Indian pharmaceutical industry is also gaining from research, innovation and manufacturing. An Indian company was the first to develop novel processes for manufacturing a Hepatitis B vaccine and reduce prices to less than \$1 per dose. After WHO prequalification, low-cost mass vaccination was enabled globally through organizations like UNICEF.

In 2002, an Indian pharmaceutical company partnered with the MVP (Meningitis Vaccine Project) in 2002 and successfully manufactured and licensed MenAfriVac (an affordable Meningitis-A conjugate vaccine for Africa) in 2010, the first internationally qualified vaccine that was developed outside the major multinational pharmaceutical companies.

In another notable achievement, an Indian pharmaceutical company became the world's first to launch a clinically proven Typhoid Conjugate Vaccine against typhoid fever and received prequalification from WHO. In 2015, an Indian pharma company launched ROTAVAC- the cheapest Rotavirus vaccine in the world at \$1 per dose.

While the government has introduced several initiatives to boost the advancement of research and development in the pharmaceutical sector, more innovations are required to become the global pharmaceutical leader. It is crucial to create an inclusive environment for industry experts, academicians and other stakeholders to have a common platform for the advancement of R&D in the pharmaceutical sector.

# Xi's Taiwan takeover has to wait till 2027



The Chinese Army is not yet ready for an invasion of Taiwan, and necessary modernisation will take some more time

un Tzu in *The Art of War* wrote: "All warfare is based on deception. Hence, when we are able to attack, we must seem unable; when using our forces, we must appear inactive; when we are near, we must make the enemy believe we are far away; when far away, we must make him believe we are near."

History is the witness of the fact that Chinese attacks occur when they are least expected. 2022 is not the year for World War III to begin. China is not ready for a war yet; it doesn't possess enough defence equipment for the invasion presently, and its forces are also not fully prepared for the joint-op amphibious assault needed for the task.

It is also the year when Xi Jinping seeks re-election for an unprecedented third term in the 20th Party Congress, and therefore seeks stability and eschews boldness. Post re-election, Xi, with uncontested authority, is expected to assert an even more aggressive foreign policy, intervening more directly in disputes on China's periphery (Taiwan and border row with India might be the focal areas) and pushing more forcefully against the United States' presence in the Pacific. The American Congress' scrambling to pass a bill on semiconductor chips is also a signal of the upcoming conflict over Taiwan. The Pentagon has assessed that China will not invade Taiwan for the next two years. The CIA Director has warned that as we move into the decade the risk of Taiwan's invasion aggravates.

Unification of Taiwan is a matter of personal legacy for Xi and essential part of his "China dream"—the "great rejuvenation of the Chinese nation" with the CCP leading China's reemergence as a great power—so Chinese move over Taiwan can most probably happen in his third term, if not, then certainly in his fourth.

Chinese military modernisation was pre-poned to 2035 in 2017 by Xi; the key parts of modernisation are set to be achieved by 2027. So, there exists greater probability of an invasion in the later part of the decade, instead of earlier. Eruption of an accidental war due to increasing hostilities between Taipei and Beijing or with Washington can never be ruled out, but the chances should be rather slim. Xi would not want to repeat Putin's blunder, and attack before China is fully prepared to take over Taipei in an assured short swift move.

US Army General Douglas MacArthur had described Taiwan as "an unsinkable aircraft carrier and submarine tender." It possesses an enormous value from strategic and security perspective for Beijing as well as Washington: keeping a hold over the crucial Philippine Sea -- the waters between East and South China sea and Western Pacific, stretching from Japan to Indonesia and Taiwan to the sec-

ond island chain, wherein falls the US military base Guam. Beijing's control of Taipei would markedly improve Chinese military position by increasing its ocean surveillance capabilities and operations of its submarines in Philippine Sea, curtailing American military's ability to operate there, impeding US naval and air operations needed to come to the defence of its treaty allies Japan, South Korea and Philippines in case of Chinese aggression over disputed islands.

Without the control over Taiwan, in case of a conflict

Taiwan, in case of a conflict between US and China, Washington would destroy China's surface radar system and its warships could move in the Philippine Sea without much danger of detection; however, a control over Taiwan would allow China to deploy hydrophones off the island's eastern coast, which has much deeper waters as compared to waters around first island chain that Beijing controls presently. These difficult to destroy hydrophones would give away the location of US warships thousands of miles away; thus, being a game changer.

Detected US warships will be easy targets of the Chinese submarines moving freely in the Philippine Sea. This will leave the US incapable of protecting its interests in the Pacific. North-East Asian shipping lanes will also become vulnerable to Chinese control in case of a talegover.

control in case of a takeover.

As the biggest semiconductor chip supplier, and almost a monopolistic manufacturer of nano chips, Taipei holds great economic and technological signifi-

cance for Washington as well as Beijing. Control over Taipei could drastically enhance Beijing's space, military and economic advancement while paralyzing Western technological-industrial complex.

Salami slicing is a well-known policy that Beijing adopts in conflicts. It involves creating a non-regular presence in the disputed area, then turning that into a sustained occupation or routine presence.

From denying the existence of the median line and routinely crossing it, violating Taiwan's ADIZ to declaring Taiwan straits as not international waters but under Chinese control, undertaking military drills around the island and creating blockades, Beijing is creating a new normal.

Interestingly, this time around, Beijing had accused Washington for using salami slicing over its 'One China Policy'. The US is not just inching forward in its ties with Taiwan -- commencing the trade initiative to bolster trade and investment between them, high level visits to the island -- but even the policy of "strategic ambiguity" is held all for smoke and mirrors. Biden has declared three times that the US will be involved militarily if the invasion takes place. It is American domestic law -Taiwan Relations Act, 1979 -- to help Taiwan defend itself in case of use of force by Beijing; importantly, not coming to Taiwan's defence runs counter to Washington's self-interest.

In the invasion scenario simulated by Beijing, its weak spots have been noticed as precision logistics which is crucial for

amphibious assault that's needed for invasion. The PLA was also found deficient in amphibious vessels and trained personnel for complex logistics missions and military transport aircraft. Xi has directed China's defence industry to produce weapons specifically designed to prevent the US forces from intervening to help Taipei or other allies in the region. Such weapons include increasingly accurate and lethal ballistic and cruise missiles, integrated air-defence systems and anti-satellite weapons, backed by a growing stockpile of nuclear

Washington is preparing Taiwan for an asymmetric warfare, supplying anti-ship missiles and air-to-air weapons. Taiwan has shifted its defense planning to "porcupine strategy" involving mines, short range missiles, civil defense and guerilla resistance. How direct the American involvement would be during the invasion is difficult to predict, however its military involvement is most probable.

The invasion is bound to be long-drawn out one and Taiwan's preparedness militarily, food and other essential supplies wise would be an essential factor in holding out to China. But the determining factor ultimately will be the resolve of the common Taiwanese people. Taiwan is the toughest and most dangerous problem in the world for Washington as well as Beijing.

A long-stretched out conflict might become a disaster for the Chinese economy and can create political instability and problems for Xi's leadership and the CCP.

# Digitised healthcare depends on faster connectivity

#### Digital health delivery is gaining popularity, but its expansion in rural India will bank on connectivity

ike most industries and spheres of life, healthdcare too is undergoing d digitization in India at many levels. Even as the government has led from the front with its landmark National Digital Health Mission (NDHM), now rechristened Ayushman Bharat Digital Mission (ABDM), the private sector is also embracing digitization. At least in metro cities and big towns apart from a few in smaller cities, several private as well as public hospitals providing tertiary care have been engaged in setting up (or upgrading) some form of digital infrastructure and allocating resources and personnel in the recent past. This would also involve the implementation of healthcare IT applications in terms of Hospital Information System, Hospital

Management Information System and Electronic Medical Records (EMR), etc., to manage the patient data in electronic format.

Likewise, patients too are evolving into more digital technology-savvy healthcare receivers, using smartphones and other devices to not just store diagnostic reports and doctors' prescriptions but also to make appointments, consult, use home-based diagnostics and testing facilities and order medicines.

The NDHM was launched as a pilot in six UTs in 2020 when three principal registries such as Health ID, Health Professional Registry (HPR), Health Facility Registry (HFR) and digital infrastructure for data exchange were developed and implemented. Building on

this success, the programme was expanded in a country-wide rollout in September 2021, focussing on key components such as Ayushman Bharat Health Account (ABHA), Health Facility Registry, ABHA App, Healthcare Professionals Registry and Unified Health Interface (UHI). Within a year, the programme has registered considerable success.

As of Sep 12, 2022 accord-

As of Sep 12, 2022 according to ABDM website, an impressive over 24 crore ABHA numbers have been created with 1,44,371 health facilities and 69,312 health professionals having registered, along with over seven lakh health records App downloads. By July this year, as many as 52 digital health services/applications have integrated with ABDM including 32 private entities.

Besides, by July end, there were as many as 919 healthtech innovators in the ABDM Sandbox, a digital space for experiment of integration before a digital app or health product is made live for the actual use. While the over 24 crore

for health product is made live for the actual use.

While the over 24 crore ABHA numbers may already constitute one-sixth of India's population, the truth remains that a large part of the healthcare value chain remains outside the government-driven ABDM initiative. According to the government's own data, of nearly 12 lakh healthcare facilities, a mere 1.4 lakh have joined the ABDM platform. Similarly, of the 50 lakh healthcare professionals

today, only 69,000 joining the

platform is again an insignificant

cent of primary health centres in rural India had computers. And the fact that over 65 per cent of rural India still has no internet.

However, it has only been a year since the nation-wide ABDM launch was done. The foundations for a country-wide infrastructure for internet and digital connectivity will ensure a far better internet-penetrated India in the next 25 years. It is likely that initially the healthcare facilities in tier I and II towns will take the digital path.

All the stakeholders in the entire value chain need to reach consensus for ensuring readiness as well as interest of all, including regulators and agencies in states, healthcare service providers, hospitals, healthcare professionals, diagnostic labs, healthcare soft-

ware vendors, digital consent solution providers, EHR/EMR/ PHR solution providers, hardware makers and insurance companies.

Given that more than 75 per cent of outpatients and 60 per cent of inpatients get treatment in private facilities, it is important to incentivize the private players sufficiently. Accordingly, suitable PPP models need to be worked out. Moreover, the patient record makers and the software providers need to be convinced to design interoperable systems such as free and open source software.

Similarly, hospitals would need to upgrade their systems. Importantly, privacy and confidentiality of data must be ensured through legal framework as well as technological innovations.

Already, India has seen the emergence of an incredible number of healthtech startups. In a world of IoT, the advent of AI, machine learning and robotic process automation (RPA) is not only catalyzing better clinical decision-making and personalization of treatment but also helping authorities in terms of healthcare research, affordable drug discoveries, disease surveillance and even prediction of diseases. So, digitaisation is vastly improving our public health delivery mechanism. The mammoth Covid-19 vaccination exercise carried out successfully through the digital platform in a country-wide operation is illustrative of this improvement even as we continue to work on and refine the ABDM. By 2047, the healthcare network will be far more efficiently digitalised.

# Winter's approach sets clock ticking for Ukraine, Russia

he onset of autumnal weather, with rains mak-ing fields too muddy for tanks, is beginning to cloud Ukraine's efforts to take back more Russian-held territory before winter freezes the battlefields, a Washington-based think tank said Sunday.

Russia, meanwhile, pressed on with its call-up of hundreds of thousands of men to throw into the seven-month war, seeking to reverse its recent losses. It also deployed suicide drones Sunday against the Ukrainian port city of Odesa, Ukrainian authorities said. No casualties were immediately reported.

The Russian mobilisation its first such call-up since World War II — is sparking protests in Russian cities, with fresh demonstrations Sunday.

It is also opening splits in Europe about whether fightingage Russian men fleeing in droves should be welcomed or turned away.

For Ukrainian and Russian military planners, the clock is ticking, with the approach of winter expected to make fighting more complicated. Already, rainy weather is bringing

starting to limit the mobility of tanks and other heavy weaponry, according to the Institute for the Study of War.

But the think tank said Ukrainian forces are still gaining ground in their counteroffensive, launched in late August, that has spectacularly rolled back the Russian occupation across large areas of the northeast and which also prompted Russian President Vladimir Putin's new drive for reinforcements.

The partial mobilisation has triggered an exodus of men seeking to avoid the draft and sharp differences of opinion in Europe about how to deal with them. Lithuania, a European Union membercountry that borders Kaliningrad, a Russian Baltic Sea exclave, said it won't grant them asylum. "Russians should stay and fight. Against Putin," Foreign Minister Gabrielius Landsbergis tweeted.

His counterpart in Latvia, also an EU member and bordering Russia, said the exodus poses "considerable security risks" for the 27-nation bloc and that those fleeing can't be considered conscientious objectors against the invasion.



"were fine with killing Ukrainians, they did not protest then," the Latvian forminister, Edgars Rinkevics, tweeted. He added that they have "plenty of countries outside EU to go."

Officials in other EU nations, however, say Europe has a duty to help, and fear that turning away Russians could play into Putin's hands, feeding his narrative that the West has always hated Russians and that the war is being waged to safeguard their country against

Western hostility.

"Closing our frontiers would fit neither with our values nor our interests," a 40strong group of senators in France said in a statement. They urged the EU to grant refugee status to Russians fleeing mobilization and said turning them away would be "a mistake by Europe in the war of communication and influence that is playing out."

The mobilization is also running hand-in-hand with Kremlin-orchestrated votes in

four occupied regions of Ukraine that could pave the way for their imminent annexation by Russia. Ukraine and its Western allies say the referendums in Kherson and Zaporizhzhia in the south and the eastern Luhansk and Donetsk regions have no legal force. The votes are set to wrap up Tuesday but are being dismissed in Ukraine and the West as a sham, with footage showing armed Russian troops going door to door to pressure Ukrainians into voting.

# On Ukraine, Russia repeats its claim that it had no choice

R ussia made its case to the world Saturday for its war in Ukraine, repeating a series of grievances about its neighbor and the West to tell the U.N. General Assembly meeting of leaders that Moscow had "no choice" but to take military

After days of denunciations of Russia at the prominent diplomatic gathering, Foreign Minister Sergey Lavrov sought to shift the focus to Washington. His speech centered on a claim that the United States and its allies - not Russia, as the West maintains are aggressively undermining the international system that the U.N. Represents.

Invoking history ranging from the U.S. War in Iraq in the early 2000s to the 20th-century Ćold War to a 19th-century U.S. Policy that essentially proclaimed American influence over the Western Hemisphere, Lavrov portrayed the U.S. As a bully that tries to afford itself "the sacred right to act with impunity wherever and wherever they want" and can't accept a world where others also advance their national interests.



The United States and allies want to stop the march of history," he maintained.

The US and Ukraine didn't retort at the assembly on Saturday but can still offer formal responses later in the meeting. Both countries' presidents have already given their own speeches describing Russia as a dangerous aggressor that must be stopped. Lavrov, for his part, accused the West of aiming to "destroy and fracture Russia" in order to "remove from the global map a geopolitical entity that has become all too independent."

The Ukraine war has largely dominated the discussion at the assembly's big annual meeting, and many countries have

# 'We got our miracle': Freed Americans back home in Alabama

Two U.S. military veterans who disappeared three months ago while fighting with Ukrainian forces against Russia arrived home to Alabama on Saturday, greeted by hugs, cheers and tears of joy at the state's main airport.

Alex Drueke, 40, and Andy Huynh, 27, had gone missing June 9 in the Kharkiv region of northeastern Ukraine near the Russian border. The Alabama residents were released as part of a prisoner exchange. The pair had traveled to Ukraine on their own and bonded over their shared

shouted as the pair appeared at the top of an escalator at the Birmingham-Shuttlesworth International Airport in Birmingham, one of Alabama's

Smiling but looking tired, the two were pulled into long emotional hugs by family members after their connecting flight home. Then they were whisked to a waiting car.

"Surreal. I still have chill bumps. I always imagined this day. I always held not just hope but belief in this day. But I thought it was going to be two or three years from now at best, said Drueke's aunt, Dianna Shaw.



have been held for months and years. There are people who have been detained wrongfully for years and for this to come about in three months is, just, unimaginable to me,' she added. # Serbian Minister defends deal with Russia amid criticism

# Congress under guidelines set by President Xi

The countdown for next **▲** month's key Congress of the Communist Party of China (CPC) began as the ruling party on Sunday announced that all delegates totalling nearly 2,300 were "elected" for the once-in-a-five year meeting in which President Xi Jinping is widely expected to get endorsed for a record third

A total of 2,296 delegates were "elected" to attend the upcoming 20th National Congress of the CPC to be held on October 16, official media reported, citing a statement by the party here.

Scotching rumours and speculation over tensions within the ruling party over Xi's continuation for an unprecedented third term, the statement said that the delegates were elected "under the guidance of Xi Jinping Thought on Socialism with Chinese Characteristics for a New Era," and in accordance with the Party's Constitution, adopting methods required by the CPC Central Committee.

Xi, 69, himself was "elect-

according to the party's earli-

er announcement. The process upheld the Party's nature and purpose, adhered to and enhanced the Party's overall leadership, and fully embodied intra-party democracy, the statement said.

The Congress, in which Xi is expected to get endorsed for an unprecedented third term, is being held amid a big purge of top security officials, stated to be part of a "political clique" opposed to the Chinese President.

Deng, regarded as Paramount Leader for his pragmatic social and economic policies introducing market reforms diluting socialist ideology, directed the leaders to strictly confine to a 10-year tenure to ensure the emergence of new and collective leadership to avert some of the excesses like Cultural Revolution pursued by Mao in which millions of people were killed in the name of ideological experimentation.

Indications are that Xi, who is conferred with the title of "core leader" like Mao, is expected to continue in power for a third term and perhaps for life, which reportedly caused consternation among the 96million-member strong party.

The CPC statement said the "elected" delegates are composed of outstanding CPC members who are highly qualified ideologically and politically, have good work styles and high moral standards, are competent in discussing state affairs, and have made remarkable achievements in their

# Iran summons UK, Norway envoys amid violent unrest

Iran's Foreign Ministry said Sunday it summoned Britain's ambassador to protest what it described as a hostile atmosphere created by London-based Farsi language media outlets. The move comes amid violent unrest in Iran triggered by the death of a young woman in police custody.

The state-run IRNA news agency reported the ministry also summoned Norway's ambassador to Iran and strongly protested recent remarks by the president of the Norwegian parliament, Gharahkhani.

The death of 22-year-old Mahsa Amini in custody after being detained by Iranian morality police launched unrest across Iran's provinces and the capital of Tehran. State TV suggested Saturday that 41 protesters and police have been killed since the protests erupted Sept. 17. It said official statistics would be released by the Interior Ministry.

According to a tally by The Associated Press, there have been at least 11 deaths from both sides since protests



The Foreign Ministry's website said it summoned Simon Shercliff, the U.K.'s ambassador to Iran, on Saturday and protested the hosting of critical Farsi-language media outlets. The ministry alleges the news outlets have provoked disturbances and the spread of riots in Iran at the top of their programmes.

# Weakening ₹ to make import of crude oil, commodities expensive

→he Indian rupee sliding to a historic low of 81.09 to a dollar will make import of crude oil and other commodities expensive further fueling inflation which for the past several months has remained above the Reserve Bank's upper tolerance level of 6 per cent.

The pressure on the domestic currency, which is mainly due to repeated hikes in interest rate by the US Fed, is likely to continue with rise in trade deficit and gradual withdrawal of funds by institutional investors.

The Reserve Bank, which is scheduled to announce its bimonthly monetary policy later this week, is expected to increase the repo-rate or the short-term lending rates by 50 basis points in a bid to tame inflationary pressure.

For a nation that is 85 per cent dependent on imports to meet its oil needs and 50 per cent for gas requirements, a weakening rupee has a bearing on domestic price of fuel.

India's trade deficit more than doubled to USD 27.98 billion in August due to increased crude oil imports. Import of 'petroleum, crude & products' stood at USD 17.7 billion in August this year, an annual increase of 87.44 per cent.

India's forex kitty continued its southward journey, with the overall reserves declin-



USD 545.652 billion for the week ended September 16. The reserves, which have been dipping as the central bank deploys the kitty to defend the rupee amid pressure caused majorly by global develop-ments, had declined by USD 2.23 billion to USD 550.87 bil-

lion in the previous week. SBI in a report said global commodity prices have remained volatile after their fall in June from historical highs. Prices edged up during late July - early August, before moderating towards the end of the

month, largely driven by concerns over demand slowdown.

Crude oil prices are trading decisively below USD 100 per barrel with heightened volatility due to expectations of an imminent slowdown in global demand, it said.

"A depreciating INR will partly counteract the benefit of lower commodity prices on inflation," said Aditi Nayar, Chief Economist, ICRA.

Extractors Solvent Association of India Executive Director B V Mehta said the cost of imported edible oils will go up. The country imports

edible oils every year. "Ultimately, this will be passed on to consumers. However, the only silver lining is India's oilseed sector exports...The rupee depreciation will boost export realisation and support export," he said.

Imports of vegetable oils stood at USD 1.89 billion in August 2022, up 41.55 per cent over the same month last

As per the SBI report, no central bank can prevent currency depreciation currently and RBI may allow the rupee to depreciate for a limited period. Foreign currency assets of RBI have declined by USD 75 billion since Ukraine War, in order to protect the rupee, it said and added that this has led to reduced import cover of nine months, which is at the lower end. "This is also true that once the currency settles at a lower level, appreciation of the currency picks up at a dramatic pace, that is a distinct possibility given India's strong fundamentals," the report said.

Moreover, much of the weakness in rupee is on account of a strong dollar and not because of our domestic economic fundamentals, it said.

Madan Sabnavis, Chief Economist, Bank of Baroda was of the opinion that the RBI's Monetary Policy Committee (MPC) will have a unique issue to debate when it meets next week for the monetary policy. ment of the rupee following the Fed's announcement has made the rupee one of the more unsatisfactory currencies based on the response to the dollar strengthening in the global market, he said.

"This piece will also be actively discussed in the deliberations, as when deciding on interest rates, the currency part of the story cannot be left out," he said.

Dilip Parmar, Research Analyst, HDFC Securities said Indian rupee marked the biggest weekly decline after April 2021 amid a stronger dollar index and risk-off moods.

There seems to be no turning back for the dollar as it made a fresh two-decade high and in turn pushed the rupee to a record low level," Parmar added.

The 38th meeting of the Monetary Policy Committee, constituted under the Reserve Bank of India Act, will be held on September 28-30.

# 'RBI set for fourth straight rate hike to quell inflation'

The Reserve Bank of India (RBI) may take cues from its global counterparts, including the US Federal Reserve, to raise interest rate for the fourth time in a row on Friday to tame stubborn inflation.

The RBI, which has since May raised the short-term lending rate (repo) by 140 basis points (bps), may again go for a 50-bps increase to take it to a three-year high of 5.9 per cent, say experts.

The central bank had

raised the repo rate by 40 bps in May and 50 bps each in June and August. The present rate is 5.4 per cent.

The consumer price index (CPI) based retail inflation, which had started showing signs of moderation since May, has again firmed up to 7 per cent in August. The RBI takes into account retail inflation while framing its bi-monthly monetary policy.

The RBI Governor-headed Monetary Policy Committee (MPC) is scheduled to start its three-day deliberations on Wednesday. The decision of the rate-setting panel would be announced on Friday (September 30).

The US Fed delivered third consecutive rate hike after it raised the rates by 75 bps to take the target range to 3 - 3.25 per cent. The central banks of the UK and the EU have also gone for rate hikes to tame inflation.

Madan Sabnavis, Chief Economist at Bank of Baroda,

said inflation in India remains high at around 7 per cent and is unlikely to come down any time soon.

"This means that a rate hike is given. The quantum is what the market would be interested in. While a hike of 25-35 bps would have signaled that the RBI is confident that the worst of inflation is over, the recent developments in the forex market could prompt a higher quantum of 50 bps to stay on track with other markets so as to retain investor interest," he

The government has tasked the RBI to ensure the retail inflation remains at 4 per cent, with a margin of 2 per cent on either side.

Dhruv Agarwala, Group CEO, Housing.Com, said reining in inflation will remain the RBI's top concern amid resilient economic expansion and robust credit growth.

"Any hike in rates would result in banks increasing home loan interest rates, too. But, we are of the opinion that its impact would not be significant as demand for property remains robust. Demand is only going to accelerate further during this festive season," he

SBI in a special report said a 50 basis points hike in repo rate "looks imminent". "We expect the peak repo

## Tax collections to continue rising in coming months, say experts

The trend of increase in I income tax collection is expected to continue in the coming months on increased compliance, higher corporate profitability and increased trade in festive season, experts said. The gross direct tax col-

lection grew 30 per cent to Rs 8.36 lakh crore in the April to mid-September period of the current fiscal on increased corporate tax and personal income tax (PIT) mop up due to increased economic activity. Deloitte India Partner

Rohinton Sidhwa said the reason for rising tax collection, aside from the increase in economic activity, is attributable to pliance demonstrated by the number of returns filed.

"The increase in compliance also stems from influencing behaviour like the sharing of details of income generating activity that taxpayers are being shown on the e-filing portal.

"It's expected that the trend will continue for now. While corporate tax returns are still to be filed for the last fiscal, advance tax collections show strong trends indicative of earnings," he said.

EY India Tax & Regulatory Services Partner Sudhir Kapadia said India Inc has seen a robust increase in profitable growth, aided to some extent by an increase in consumer prices due to higher

According to a coal ministry official, the coal stocks at power



plants are at "comfortable" level as of now. The coal position in states like Haryana, Punjab which last year faced problems of coal shortages at their plants,

Southgate has credit in the bank having reached the semi-finals of the 2018 World Cup and finished runners-up at last European summer's Championship.

But he was booed by the travelling support in Milan after a 1-0 defeat to Italy on

England have just one more game, against Germany at Wembley on Monday, before their World Cup campaign kicks off against Iran on November 21.

"I think I'm the right person to take the team into the tournament. I think it's more stable that way, without a doubt," said Southgate.

"I don't think (the) performance (against Italy) was far off and I know that's going to get derision just because we're on the back of a run of defeats." England have failed to even

score a single goal from open play in five Nations League games against Hungary, Italy and Germany.

But Southgate defended his side as they experience a World Cup preparation unlike any other.

Just eight days will separate the final round of Premier League fixtures from England's opening game in Qatar, leaving no time for pre-tournament



"We're playing and have been playing some top level sides and we will be better for that," he added.

"In the past we've had runs of friendlies or whatever the matches are and then we've gone into tournaments and that's the first time we've hit high-level opposition and it's hit us in the face quite often.

"Now we know the level, now we know what we've got to improve and we'll be better placed for that by having had the quality of matches that we've had."

India women's team captain Harmanpreet Kaur says her side had committed "no crime" after completing a first-ever whitewash in ODIs on English soil with a legal yet debatable run out.

Harmanpreet was responding to questions on the run out effected by her bowler Deepti Sharma at the non-striker's end to claim the crucial wicket of Charlie Dean, after the batter had backed up too far, and end England's innings 17 short of the target of 170 in the third and final ODI here on Saturday.

Batting at number nine, Dean had staged a dramatic recovery with a fighting 47 and shared a 35-run stand with No. 11 Freya Davies to put England within reach of the target after the hosts had slipped to 65 for 7 and then 103 for 8.

"Today whatever we have done I don't think it was any crime," Harmanpreet said at the post-match press conference.

"It is part of the game and it is an ICC rule and I think we just need to back our player. I'm actually very happy she was aware of that, and the batter she is taking too long a stride I think. I don't think she has done

something wrong and we just need to back her.'

The India skipper, who was named the Player of the Series, did not agree that the controversy took the sheen off the legendary Jhulan Goswami's farewell game.

"I don't think so, because, like I said, I don't think we have done any crime. I don't think we need to talk about that because the first nine wickets were also very important and everybody was working so hard.
