Observing that politicians do not have "higher immunity", a bench of Chief Justice DY Chandrachud and Justice JB Pardiwala expressed disinclination to entertain the petition, saying courts are always there for taking up the grievances of political leaders as they do for common citizens.

"Political leaders do not enjoy any immunity higher



than the common citizens.. Once we accept that political leaders are absolutely on the same footing as common citizens with no higher immunity, then how can we say there can be no arrests unless there is a three pronged test which is satisfied," the bench said.

"Take a case which does not involve the threat of bodily harm. Day-in and day-out, we get cases of financial scams. Somebody takes away 10 thousand crores, five thousand crores from retired pensioners or from ordinary middle class people and does not refund the amount... No payments are made. Complaints are filed. Usually, the FIRs are filed and

then a case is filed for clubbing of the FIRs. We deal with it," the CJI said. "You please come back to

us when you have an individual criminal case or group of cases. Laying down general guidelines without having relation to facts of a case will be dangerous," the bench said.

Sensing the disinclination from the apex court, senior advocate Abhishek Manu Singhvi, appearing for the political parties, sought permission to withdraw the petition which was granted.

During the argument, Singhvi referred to statistics while trying to drive home the point that Opposition leaders

have been targeted by federal investigative agencies from 2014 to 2022 and that there has been a 600 per cent increase in CBI and ED cases.

"Between 2014 and 2022, 121 political leaders have been probed by the Enforcement Directorate, out of whom 95 per cent are from Opposition parties," he claimed. The CBI has probed 124 political leaders and out of these, 108 are from Opposition political parties, said Singhvi.

The bench said even the media, under Article 19(1)(a) (freedom of speech and expression) of the Constitution, does not have higher powers and "the political persons are also citizens and as a citizen they are subject to similar rules".

The senior lawyer said he was not seeking any particular relief in a particular case and the parties, which represent 42 per cent of the electorate in the country, wanted prospective guidelines of pre and post-arrest procedures to be adopted by the central probe

SC quashes telecast ban on MediaOne

Expressing displeasure over sealed-cover submissions, and stressing the importance of freedom of the press, the Supreme Court on Wednesday quashed the Centre's telecast ban on Malayalam news channel MediaOne, and pulled up the Home Ministry for raising national security claims from

Observing that the State can't impose unreasonable restrictions on the press as it would have a chilling effect on press freedom, a bench headed by Chief Justice DY Chandrachud set aside the Kerala High Court order which had upheld the Centre's decision to ban the channel's tele-

cast on security grounds. Saying that critical views of the channel against government policies cannot be termed as anti-establishment as an independent press is necessary for a robust democracy, the SC said, "Press has a duty to speak truth to power and present citizens with hard facts enabling them to make choices that propel democracy in the right direction. The restriction on freedom of press compels citizens to think along the same tangent. Homogenised views on issues that range from socio economic polity to political ideologies would pose great dangers to democracy.

The court added nonrenewal of licence of a channel

is a restriction on the right to freedom of speech.

The top court said the alleged link of the channel's Hind is not a legitimate ground to restrict the rights of the channel. The bench pointed out that the outfit is not at all a banned organisation.

The court said the State is using national security as a tool to deny citizens remedies that are provided under the law. "National security claims cannot be made out of thin air, there must be material facts backing it," the bench said.

Non-disclosure of reasons for denial of security reasons and disclosure only to court in sealed cover has violated principles of natural justice, the bench, also comprising Justice Hima Kohli, said.

'Sealed cover procedure cannot be introduced to cover harms that cannot be remedied by public immunity proceedings," the bench said. The apex court said courts should appoint an amicus curiae to assess the claims of confidentiality and assist the court in coming out with a reasoned

Commando dies as even backup parachute fails

AMarine Commando (MARCOS) of the Indian Navy died on Wednesday morning during free-fall para-chute training in West Bengal during a training exercise.

The 31-year-old Petty Officer carried out a parajump from a military transport aircraft in Panagarh when the accident took place as the parachute reportedly failed to open.

His emergency or the backparachute also reportedly did not function properly. The Navy has ordered a mandatory enquiry to ascertain the cause of the accident.

The deceased was identified as Chandaka Govind, a native of Andhra Pradesh. He was attached to INS Karna, a MARCOS base Visakhapatnam.

"Navy Chief Admiral R Hari Kumar and all personnel of IndianNavy pay tribute to Chandaka Govind, Petty Officer who lost his life whilst undergoing training exercise at Panagarh on 05 Apr 23 and extend heartfelt condolences to the bereaved family," a Navy tweet said

The commando reportedly jumped out of a C-130J Super Hercules aircraft during a routine exercise. These planes stationed at Air Force base Arjan Singh, Panagarh, are used for training of the Special Forces commando units of the Army, Navy and IAF.

Ensure peace on Hanuman Jayanti, MHA tells States; HC orders CAPF in Bengal

The Calcutta High Court on Wednesday directed the West Bengal Government to requisition Central forces for assisting the State police in maintaining peace during

Hanuman Jayanti celebrations. Meanwhile, the Centre on Wednesday asked all States to Hanuman Jayanti on April 6 and monitor any factor that could disturb peace and har-

mony in society.
Close on the heels of communal violence in West Bengal and Bihar during Ram Navami, the Home Ministry's advisory to all States and Union Territories aimed at sensitising law enforcement agencies following the communal violence

last week. The court said in view of events in the recent past, the order was being given to assure the general public that they are safe and will not be affected by any disturbance.

Clashes had taken place at some places in Howrah and Hooghly districts between two groups during and after Ram Navami processions last week

Observing that prevention is better than cure, a division bench presided by Acting Chief Justice T S Sivagnanam directed the West Bengal Government to requisition Central forces to avoid any breach of peace when

The court also directed the Centre to make swift arrangements for such deployment on receipt of requisition from the State.

The order came on a PIL filed by Leader of Opposition in West Bengal Assembly Suvendu Adhikari. It also asked the State to file

an action taken report on the next date of hearing. 'The intelligence wing of

the State police shall be strengthened and all steps be taken to avert any such pre-planned attacks or violence," the bench directed.

'The MHA has issued an advisory to all States in preparation for Hanuman Jayanti. The governments are encouraged to ensure the maintenance of law and order, peaceful observance of the festival, and monitoring of any factors that could disturb communal harmony in society," the Home Minister's Office tweeted.

Covid 163-day high; 4,435 cases, 15 deaths in 24 hours



ovid cases in India for the Ufirst time this year crossed 4,000 mark with 4,435 fresh infections reported in the past 24 hours, taking the active caseload to 21,091, according to the Union Health Ministry data. This 4,435 fresh Covid cases in India is the highest single-day rise in 163 days. A total of 4,777 cases were recorded on

September 25 last year. The death toll at 15 was also on the higher side, as per data updated on Wednesday at 8 am. Four deaths were reported from Maharashtra; one death each was from Chhattisgarh, Delhi, Gujarat, Haryana, Karnataka, Puducherry and Rajasthan; and four were reconciled by

The States which have come under scanner are Himachal Pradesh, Haryana, Punjab. These have witnessed 13-fold rise in daily positive cases in just three weeks. Health experts said coron-

avirus infections in India are doubling every 4-5 days, indicating that the pandemic is still far from being under control despite the return of near-normalcy across society and the economy.

The Indian SARS-CoV-2 Genomics Consortium identifies Omicron subvariant XBB.1.16 as the leading variant in India, making up 60 per cent of cases. The World Health Organization (WHO) too has sounded an alarm in this direction warning that the subvariant is the virus one need to watch' in India.

Though the Health Ministry has advised people not to lower their guard it also at the same time said that Omicron's sub-variant which is circulating in the country has not led to the increase in hospitalisations and there is no need to worry.

NEW DELHI/KOCHI Aquiet street in the famous Shaheen Bagh of South-East Delhi was abuzz with activities on Wednesday morning. TV journalists with camera crews jostled to interview Shahrukh Saifi's father, Fakhruddin Ali, after his son was arrested Maharashtra Anti-Terrorism Squad (ATS), with the help of the National Investigation Agency (NIA), at a railway station in Ratnagiri late on Tuesday in Sunday night's train arson case in Kozhikode.

The arrest was made in connection with the incident on a moving train which happened on Sunday night when Alappuzha-Kannur Executive Express train reached

the Korapuzha railway bridge. Shahrukh had reportedly boarded the train and poured an inflammable liquid on fellow passengers in the moving

The deceased have been identified as Mattannur natives M Rahmath (44), Sehra Bathool (2) and Noufeeq (38). Police believe they fell off the train or jumped out of the train to escape the fire. At least nine people are said to be injured. The police did not rule out a terror angle as they recovered a bag from the tracks that had another bottle of petrol and two

mobile phones. Though the Kerala Police had released the images of the prime suspect, it does not have resemblance with Shahrukh, who was arrested in Ratnagiri. An ATS officer said



52 tigers died this year till April 4

At least 52 tigers have died this year till April 4, highest in the last three years during the period with maximum number of deaths at 15 reported from Madhya Pradesh where most of the officials from the forests departments are engaged in keeping the imported Cheetahs within their home range in Kuno Palpur sanctu-

Of these 52 mortalities, four occurred in the last four days itself. These included a cub and a female.

However, a senior official at the National Tiger Conservation Authority (NTCA) under the Union Environment Ministry said this is no sign of concern as the mortality should be compared with tiger numbers. In



a bid to draw home his point, a senior official said that "no tiger, no death. Less tiger, low death and more tigers more death, average age in the wild is 10-12 years.

In the wild several factors like old age, diseases,

internecine fights, high infant mortality, electrocution, snaring, drowning, road/rail hits etc. account for a majority of tiger deaths, shared another

According to the 2018 census report, India had 2,967

India tiger census report will be released by Prime Minister Narendra Modi in Mysuru on April 9, on the occasion to mark 50 years of Project Tiger. According to the officials, there has been an upward trend in tiger numbers over the last five years. They claimed that the regions which had no tigers were

showing a good presence.

As per the data available from the NTCA, of 52 tigers

first quarter of the year, maximum were from Madhya Pradesh, followed by Maharashtra. Sources said that Madhya Pradesh may lose the status of home of the highest number of tigers in the country.

An analysis of the data shows that in the last four days from 1 April to 4 April, one tiger each has died. In Pardesh's Bandhavgarh Tiger Reserve

separate incidents, one death was reported from Kerala's Wayanad Wildlife Sanctuary and in Maharashtra big cat died outside the village Pataguda.

Last year i.e. in 2022, a total 121 tigers died against 127 the previous year. In the last three years, tiger mortality has crossed the 100 mark annually in the country. In 2019, the country reported 96 tiger deaths.

5 Rajouri cops suspended in bizarre Malkhana theft case

Five police personnel were placed under suspension by the Superintendent of Police. Rajouri district on Wednesday in a bizarre incident of theft reported from inside the high security seizure room (Malkhana) of the district court complex.

'Boxer' sent to 8-day police remand

Deepak Pahal alias Deepak Boxer, one of the mostwanted gangsters in Delhi, was brought to the city from Mexico on Wednesday and remanded to eight days' custody. The Delhi Police had sought his custody for 14 days but the court agreed to eight

days.

The gangster was produced before the Patiala House Courts, directly from the lockup due to security reasons. Boxer had fled India to Mexico on a forged passport. Earlier, a two-member team of the Delhi Police's Special Cell landed with Deepak at Terminal 3 of Delhi's Indira Gandhi International Airport from Mexico via Istanbul at around 6 AM on Wednesday.

Special Commissioner of Police (Special Cell) HGS Dhaliwal said the gangster had taken multiple routes and stops to reach Mexico on his way to the US ("donkey" method). But he landed in their net laid



with the help of the office of the Legal Attache, US Embassy, New Delhi. The gangster, a winner of a national-level boxing championship, was trying to enter the US illegally via Mexico and planning to run his organised crime gang in Delhi and neighbouring States from there. "Boxer got a passport made in Bareilly (Uttar Pradesh) and took a flight from Kolkata.

He changed flights to reach Mexico. His aim was to cross into the US. The US' Federal Bureau of Investigation (FBI) and the Mexico Police really helped a lot," Dhaliwal said.



This is a "big success" for the Special Cell as this was a coordinated effort of all teams, he said and added that Deepak's cousin Sandeep is currently in California but no detention has been made. "There is an elaborate drug syndicate and even human trafficking is common, but in the case of Deepak, a Pakistani national Ali's involvement is being investigated," the officer said.

"It is very early to say about the involvement of the Lawrence Bishnoi gang in his leaving the country but this is clear that he was always aligned towards the gang," Dhaliwal

information on other gangsters and "work is on". Deepak's interrogation will help in gathering more information, the senior officer said. His Gogi gang is allegedly linked to the Lawrence Bishnoi gang, according to police.

"We received inputs in January that Deepak got a fake passport made in the name of Ravi Antil from Bareilly to flee the country. He took a flight from Kolkata to Dubai. Then from Dubai, he went to Almaty, Kazakhstan, and reached Turkey. He then headed for Spain. After taking multiple routes, he finally reached Mexico," Dhaliwal said.

"Our teams were constantly tracking his routes," he said at a press conference held on Tuesday. He said Delhi Police zeroed in on the gangster's location in Cancun, a city notorious for human traffickers and the narcotics mafia, after interrogating several of his aides and using technical inputs. "His intention behind

America, with the help of human traffickers, where he would join his other associates. From there, he had planned to run his organised crime group in Delhi and neighbouring states," Dhaliwal added. Now that he has been brought to India, he will be interrogated in the cases he has been involved including the murder of a builder in Delhi's Civil Lines

It was the first time that Delhi Police arrested a gangster in an operation outside the country. Police had announced a reward of Rs 3 lakh on information leading to the arrest of Deepak, who led the Gogi gang, which is allegedly linked to the Lawrence Bishnoi gang.

According to police, notorious gangster Boxer, a resident of Haryana's Sonipat, was wanted in 10 criminal cases including murder, attempted murder, and under the stringent Maharashtra Control of Organised Crime Act (MCOCA), among others.







"There has been a 10 per cent to 30 per cent hike in rates for residential, agricultural and commercial properties in all the tehsils and sub-tehsils in the district — Sohna, Pataudi, Farrukhnagar, Manesar, Wazirabad, Badshahpur, Kadipur and Harsaru," read the orders issued by Gurugram administration. The new circle rates will be effective from April 1, the order said. Likewise, all the tehsils and



Sohna, Pataudi, Farrukhnagar, Manesar, Wazirabad Badshahpur, Qadipur and Harsaru — saw an increase in circle rates ranging from 10% to 30% on the prevalent rates. Circle rate is the minimum price at which a property is registered with the revenue department when being transferred. The stamp duty levied

on such properties is a major revenue for the state government. Market rate is the rate at which a property transaction takes place and its price is determined by market forces, while circle rates are fixed yearly or twice a year by the district administration.

As per the new rates notified by the government, the circle rates of a housing project on Golf Course Road have been increased and now a home-

buyer will have to pay higher Circle rates have been increased by Rs 2,500 per square foot. The rate of flats in group housing projects in a majority of sectors along Sohna

Road had been increased from

Rs5,500 per square foot to Rs

7,100 per square foot. The rates of floors in colonies and licensed colonies of HSVP [Haryana Shahari Vikas Pradhikaran] in Badshahpur tehsil have been increased from Rs6,500 per square to Rs 7,150 per square foot. The rate of plots in Bajghera near Palam Vihar has

increased from Rs 15,000 square yard to Rs 18,000 per square yard. In upscale Civil Lines, the rate has been increased from 52,800 per square yard to Rs 70,000 per square yard. "The rates have been revised by an average of 10-30% in the district. These rates have been uploaded on the government and department website and can be accessed easily."

IP College counselling its traumatised students

Delhi University's Indraprastha College for Women (IPCW) has started counselling sessions for students who have claimed to have experienced trauma due to the alleged harassment during its annual fest. In her second statement in the last two days, IP college principal Poonam Kumria said Indraprastha College for Women is concerned over the inconvenience experienced by some of the students during the festival and requested the students to avail the services of the counsellor.

More than 1,100 people, including former teachers and students of DU's IPCW, have expressed deep concern over the recent incident of alleged harassment at a fest and demanded an apology from



Principal Poonam Kumria. They have also raised a host of questions regarding the incident questioning the management's action and reaction in a letter signed by all of them. The letter comes a week after some "unknown" men allegedly trespassed, shouted slogans and harassed women students during the annual 'Shruti' festival at the Indraprastha

College for Women (IPCW). The authors of the letters are former teachers of the college, parents and concerned citizens. "The undersigned consist of students since the early 1960s. IPCW has never seen times worse than what we are witnessing now. We, members of the academia and civil society, are deeply concerned with what is happening and strong-

proactively protect its girls rather than further harass them," the letter signed by 1,108 individuals read. "Why is the College threatening students with dire consequences if they continue their protests, calling parents of the already traumatised students and creating an atmosphere of fear through punitive measures?" they asked. On March 28, some "unknown" men allegedly trespassed, shouted slogans and harassed women students during the annual 'Shruti' festival at the college. A host of protests were organised against the principal

following the incident, wherein the students also alleged attempts to "saffronise" college, claimed increased surveillance and curtailment of freedom of speech at the hands of the newly-appointed principal.

India mulling import of dairy products: Official

Supply constraint as milk production remained stagnant last fiscal year

India may import dairy products if needed as there is a supply constraint for such items due to milk production remaining stagnant in the last fiscal year. This has led to an increase in milk prices over the last few months that has been 14 to 15 per cent, much more than the inflation.

According to a top official of the Ministry of Animal Husbandry and Dairy, the Government will intervene to import dairy products like butter and ghee, if required, after assessing the stock position of milk in Southern states, where the flushing (peak production) season has started now. Milk output in the country stood at 221 million tonne in 2021-22, up 6.25 per cent from 208 million tonne in the previous year, as per the official data.

Addressing a press conference, Animal Husbandry and Dairy Secretary Rajesh Kumar Singh said the country's milk production remained stagnant

in the 2022-23 fiscal due to lumpy skin disease in cattle, while the domestic demand grew by 8-10 per cent in the same period because of a rebound in the post-pandemic demand. "There is no constraint in milk supply as such in the country...There is an adequate inventory of skimmed milk powder (SMP). But in the case of dairy products, especially fats, butter and ghee etc, the stocks are lower than the previous year," he said.

The government will intervene to import dairy products like butter and ghee, if required, after assessing the stock position of milk in Southern states, where the flushing (peak production) season has started now, he said. Singh, however, observed that the imports may

not be beneficial at this point in time as international prices in recent months are ruling firm. "If global prices are high, there is no point in importing. We will assess the flush season in the rest of the country and then take a call," he said. The shortage will be less in north India where the lean season has been postponed with temperature cooling down due to untimely rains in the last 20 days, he added.

According to the secretary, the country's milk output remained stagnant due to the impact of lumpy skin disease that killed 1.89 lakh cattle last year and the post-pandemic rebound in milk demand.

"The impact of lumpy skin disease on cattle can be felt to the extent that the total milk production is a little stagnant. Normally, milk production has been growing at 6 per cent annually. However this year (2022-23), it will be either stagnant or grow at 1-2 per cent," Singh said. Since the government takes into account the milk production data of the

cooperative sector and not the entire private and unorganised sector, "we assume it will be stagnant," Singh said. It is a true rise in fodder prices that has led to milk inflation. There is a problem in fodder supply as the fodder crop area has remained stagnant in the last four years, while the dairy sector has been growing annually at 6 per cent,

According to experts, the spike is linked to rising input costs, the disruption caused by the pandemic, and global prices. Demand for milk dried up during the covid-19 lockdown in 2020 as hotels, sweetshops, and canteens closed down and weddings and other public functions got cancelled or curtailed. Prices of milk cheese, butter, and skimmed

milk powder, also crashed. This compelled dairy farm ers to hold limited livestock Even the calves and dry cattle they were left with were mostly underfed. Those calves are now the milk producers but their produce is of low quality and quantity.

Furore in House over nixing of 'Point of order'

Kharge says Govt not letting Opp to speak as Dhankhar disallows discussion

Till now issues like the demand for Rahul Gandhi's apology, a JPC probe in the Adani Group controversy, alleged Chinese intrusions, were among a range of issues that had led to acrimonious exchanges between the Treasury and Opposition Benches in Parliament, resulting in the stalling of the entire Budget Session.

However, a ruling on 'Point of order' by Rajya Sabha Chairman Jagdeep Dhankhar on Wednesday drew further protests and sloganeering between the two sides both in and out of Parliament.

Amid a logjam over Rahul Gandhi's remarks on democracy, Dhankhar rejected Leader of Opposition Mallikarjun Kharge's 'Point of order', saying there can be no issue or individual beyond the purview of discussion in the Upper House of Parliament.

Dhankar declined the 'Point of order' raised by



Kharge on March 13 in which he objected to a call by the Leader of the House, Piyush Goyal for Congress leader Rahul Gandhi to come to the Rajya Sabha and apologise for 'insulting' the Parliament. The Congress said presiding officers in legislatures are expected to be fair, even-handed and nonpartisan, and cannot display their biases or their loyalty to the ruling party.

In a letter to Dhankhar, Kharge said "as regards your ruling vis-a-vis my 'Point of order' with due humility, I must confess that I find it surprising. A simple reference to the content referred to by Piyush Goyal would have answered that question."

Union Minister Piyush Goyal accused the Congress leaders of insulting Rajya Sabha while Kharge charged the Government with not allowing the Opposition to speak as trading of barbs and protests by the two sides led to a washout

of one more day of proceedings. Goyal, without naming Rahul Gandhi, had demanded an apology on March 13 for "the shameless way by which a senior leader of the Opposition in a foreign country has attacked the democracy of India, insulted the Parliament

Reading out his decision in the midst of slogan shouting by Opposition members during the post-lunch session, the Chairman said, "Constitutional 'privilege' of 'freedom of expression' and 'immunity' from any civil or criminal action to Members of Parliament, calls for a high degree of care, caution and accountability."

"This unique freedom privilege comes with heavy obligations. Breach of this privilege by engaging in reckless trading of allegations or free fall of information, invectives and innuendos or setting afoot pernicious narratives entail serious consequences, Dhankar added. 'The sanctity of the temple of democracy cannot be permitted to be outraged as the privilege does not extend to engaging in demeaning parliament, making disparaging observa-tions tarnishing constitutional institutions or set afloat narratives premised on reckless allegations of untenable fact premise," Dhankhar said.

"After due consideration on the matter I am of the firm view that there can be no issue or individual beyond the purview of discussion in the Rajya Sabha and the same is exclusively subject to regulation by the House and the Chairman," Dhankar said.

Kharge had cited a ruling given by late V V Giri on June 19, 1967 that "a member of one House should not use the freedom of speech on the floor of the House to make allegations or charge against the members

of the other House". The other one was made on March 17, 1983 by the then Vice-Chairman in favour of L K Advani that stated: "Before referring to a member of the other House, one has to exercise a lot of care and caution..."

Dhankhar said the authenticated record made available by Goyal, "bears out that his demand of apology on the overseas statements made by a senior leader of the opposition is factually premised and does not graduate to making 'allegation of a defamatory or incriminatory nature."

"In view of categorical and firm constitutional prescriptions, I cannot persuade myself to sustain the point of order raised by the Hon'ble Leader of the Opposition Shri Mallikarjun Kharge and the same is hereby declined," the Chairman said. In response, the Opposition members intensified their sloganeering.

Cong left with no ideology, just works against country: Scindia

The US Senate confirmed 52-year-old Garcetti's nomination earlier last month, ending a protracted hiatus of over two years to fill key diplomatic position. Garcetti's nomination was pending before US Congress since July 2021 when he was nominated by President Joe Biden. Garcetti, who is now headed to New Delhi this month, was not confirmed by the Senate in President Biden's first two years in office amid concerns by some lawmakers that he had not adequately handled allegations of sexual assault and harassment against a former senior adviser. opposing these petitions seeking stausquo as per Act. Many times, the top court has sought Central Government's view on this petitions and Advocate Vrinda Grover pointed out that the Government has notfiled its reply.

Animal pandemic preparedness to be showcased at G20 event

▼ndia will showcase two new Linitiatives, including Animal Pandemic Preparedness Initiative (APPI), at a side event of the G-20 Health Working Group meeting to be held on April 20 in Goa under India's G20 Presidency.

The side event, to be

organised by the Asian Development Bank and UN Environment Programme in collaboration with the Health Ministry, will have participa-tion from the World Health Organisation and World Animal Health Organisation. Briefing media Animal Husbandry and Dairying Secretary Rajendra Kumar Singh said that at the side-

event, his department will showcase two initiatives — the Pandemic Preparedness Initiative (APPI) and the World Bank-funded Animal Health System Support for One Health (AHSSOH).

APPI seeks to bring interministerial coordination for 'One Health Mission'. It aims to track animal diseases through large-scale digital surveillance, bring synergies in advances in the human vaccine in animal vaccine development and institutionalise targeted early response animal health emergencies in sync with human health, he said.

APPI also aims to coordinate with critical partners to ensure successful and timely development of vaccine development. The Rs 1,228 crore

AHSSOH project, with 50 per cent funding from the World Bank, will initially be implemented in five states -- Assam, Odisha, Karnataka, Madhya Pradesh and Maharashtra. The secretary said AHSSOH aims to strengthen 75 district laboratories, provide 100 mobile veterinary units in remote locations and high-risk areas, and upgrade 300 dispensaries and hospitals besides training 5,500 veterinarians as well as 9,000 private diagnostic profession-

Both APPI and AHSSOH, which will be formally launched on April 14, have been conceptualised to approach 'One Health', recognising animal health, human health and the environment are inextricably connected.

NIA files chargesheet in Al Huda terror funding case

New Delhi: The National Investigation Agency (NIA) on Wednesday filed a chargesheet in Al Huda Educational Trust (AHET) terror funding case, linked to the Jamaat-e-Islami (JEI), which had set up the Trust to mobilise funds to further its anti-India agenda even after it was banned

Pakistan-based Hizbul Mujahideen (HM) terrorist, Mushtaq Ahmed Mir alias Mushtaq Ahmed Zargar, is among the four individuals / entities named in the chargesheet. Zargar was released in the aftermath of the Indian Airlines flight 814 hijacking in 1999. JEI, Jammu and Kashmir

was declared an Unlawful Association under the Unlawful Activities (Prevention) Act in 2019. The NIA, which was subsequently mandated to investigate the continued suspicious activities of the banned terror outfit, had registered a case

against JEI in September 2022.

The agency filed the chargesheet before the NIA Special Court, Jammu and Kashmir, after extensive investigations and multiple raids in the Valley, the agency said. "A Pakistan-based Hizbul Pakistan-based Mujahideen (HM) terrorist, Mushtaq Ahmed Mir alias Mushtaq Ahmed Zargar, is among the four individuals /

entities named in chargesheet. Others charged in the case are AHET, Md. Amir Shamshi, a 'rukun' (primary member) and chairperson of AHET, and Abdul Hamid Ganai alias Abdul Hamid Fayaz of Shopian. All four have been charged under various sections of UA (P) Act and Indian Penal Code (IPC),

Investigations have revealed that Md. Amir Shamshi was responsible for the day to day working of AHET, which was formed by JEI with the explicit purpose of mobilising funds to carry on its secessionist activities in Jammu and Kashmir, the agency said in its chargesheet.

India, Japan agree to diversify cooperation in defence, space

New Delhi: India and Japan on Wednesday reviewed their defence ties and agreed to diversify cooperation in new fields like defence, space and cyber during the seventh India-Japan Defence Policy Dialogue here. It was co-chaired by Defence Secretary Giridhar Aramane and Vice Minister of Defence for International

Affairs Oka Masami. Giving details of the talks, officials said a wide range of issues, including Service-level exercises and engagements, regional security issues and cooperation in defence equipment and technology, were discussed. The Japanese Vice

Minister also presented policy updates from their recently released National Security Strategy and National Defense Strategy.

Both the countries appre-

ciated the growing cooperation between the Services through Staff talks and exercises. They welcomed conduct of inaugural fighter exercise 'Veer Guardian' between Indian Air Force and Japanese Air Self Defence Force in January this year in Japan.The Defence Secretary emphasised that both the countries should aim to deepen collaboration between the respective defence industries. He also invited Japanese

defence industries to look at investment opportunities in India under 'Make in India' initiative. Both sides agreed to diversify cooperation in new and emerging domains like defence space and cyber.

India and Japan reiterated

their commitment towards a strong defence partnership and agreed to find opportunities to further enhance bilateral cooperation. Both sides also agreed to hold next Defence Policy Dialogue at mutually convenient dates. India, Bhutan agree to work closely for dev in region

Bhutan claims the plateau is part of its territory. "India and Bhutan share an exemplary bilateral relationship characterised by trust, goodwill and mutual understanding at all levels, strong bonds of friendship and close people-to-people contacts," the joint statement



'Sars-Cov-2 adds to agony of dementia patients'

raretakers of patients with dementia, beware. A study published in the Journal of Alzheimer's Disease Reports has cautioned that infection with Sars-Cov-2 adds to the agony of the people suffering with the neurodegenerative conditions.

Lead investigators Souvik Dubey, from the Department of Neuromedicine, Bangur Institute of Neurosciences (BIN), Kolkata, West Bengal, and Julián Benito-León, from the Department of Neurology, University Hospital "12 de Octubre," Madrid, Spain, explained: "We speculated there must have been some deleterious effect of Covid-19 in patients with preexisting dementia extrapolating our understanding from the cogni-


in patients without dementia. However, post-Covid-19 evaluation of cognitive impairments in patients with preexisting dementia is difficult due to multiple confounders and biases."

Dubey further said that "as the ageing population and dementia are increasing globally, we believe pattern recognition of Covid-19-associated cognitive deficits is urgently needed to distinguish between Covid-19associated cognitive impairments per se and other types of dementia.

In addition to finding that all subtypes of dementia, irrespective of patients' previous dementia types, behaved like rapidly progressive dementia following COVID-19, the team of investigators found that the line of

ormer US President Donald Trump, after pleading not guilty to 34 felony counts of falsifying business records in a New York court, rightly said, "I never thought anything like this could happen in America. While Trump is being prosecuted, pilloried, and denounced for a 'crime' none other than his wife should have complained about, US President Joe Biden is treated with kid gloves despite a mountain of evidence to suggest his brother Frank and son Hunter benefited immensely because of high office. It's unlikely that Trump has heard of Akbar Allahabadi, but the Urdu poet perfectly summed up the ex-president's plight:

Ham aah bhii karte hai.n to ho jaate hai.n badnaam/Vo gatl bhii karte hai.n to charchaa nahi.n hotaa (We are condemned even if when we sigh/They get scot-free even after murder).

This could happen in America because its thought leaders have been corrupted by the pernicious postmodern or New Left doctrines that have infected academics, the media, and other opinion making apparatuses. Then there are the gods of destruction revel in chaos. Like George Soros, the billionaire 'philanthropist.' The 'philanthropy' he believes in and spends his billions for is violent anarchy in which the ideals, values, and norms of civilisation are subverted and replaced with Leftist ideas which have been historically discredited. Partisanship kills institutions

Once partisanship seeps into a system, it starts eating an institution from within; capitulation is rapid and guaranteed

iminishment of institutions towards partisan preferences has severe consequences of backsliding in a vibrant democracy and stifling the air of diversity. Partisanship disallows facts and superimposes 'opinions', that are rarely based on facts. The media landscape is a good reflection of the extent of partisanship that has been inflicted on the organs of democracy. The age-old maxim that media should serve to inform and not influence the public can be readily surrendered at the altar of expediency and favour. Partisanship is a slippery slope full of blind spots, hatred, and unfounded loyalty – the consequences of which were famously made by LK Advani to the Indian media after it had surrendered all pretences of questioning abilities during the Emergency, when he chastised, "You were asked only to bend, but you crawled". India in the 70s was poorer for its media's inability to ask hard questions to the government, as some within the fraternity had thrown in the proverbial towel, and soon the domino effect started. Once the seeds of 'divide' and partisan-ship are sowed and they start asserting themselves within any institution, capitulation is rapid and guaranteed.

Neighbouring Pakistan is witnessing a similar and unprecedented 'divide' and partisanship in almost all institutions of governance, which ought to be apolitical. Never a thriving democracy and given to its manipulations, intrigues, and regressions - yet the current virus of partisanship and implosive 'divide' within its vital organs, has perhaps never been more blatant. Even the socalled 'establishment' (read, Pakistani Military) is increasingly mocked for its purported 'neutrality'. The implosion started within the now divided 'Uniformed' fraternity itself. It has reached a situation where a justretired Pakistani Chief of Army Staff (COAS), General Qamar Bajwa, openly talked about his predecessor, General Raheel Sharif, insisting on a three-year term extension on the pretext of a battle for advantage ahead of the security situation, thereby compromising on the hallowed duty of silence on institutional

matters with 'brother-officer' that warrants rectitude. But an unhinged General Qamar Bajwawho 'selected' Imran Khan in 2018 (instead of getting elected) and then fell foul with him to such an extent that he joined hands with political forces that he had once ousted, speaks volumes of shifting partisan preferences that beset Pakistan, today.
A similar 'divide' within

yet another institution that had remained relatively apolitical earlier, is the Pakistani Judiciary. The days of Chief Justice Iftikhar Muhammad Chaudhry's valiant struggle against various political forces that once led to a transformative civil disorder is a forgotmemory. Justice Chaudhry's activism (or 'overreach' as claimed by detractors) was said to have, "repurposed a once supine judiciary as a fiercely independent force". But today his successor, Chief Justice Úmar Ata Bandial who was ranked amongst the 100 most influential people by Time magazine (2022), must face the ignominy of partisanship and 'divide' within the Judicial institution that has been latched on by politicians to curb the institution. Time had noted about the CJI, "As other institutions lock norns in impending elections, the court looms large as the final arbiter. Widely respected for his

being seen to do so". But such apolitical independence, assertion, and scholarship to 'question' the dispensation of the day by an individual can often be embarrassingly irritating to the politicians who would rather have the wings of such a person clipped. Recently two judges of the Supreme Court challenged the Chief Justice's power to form a bench or take suo motu notices, affording the invaluable opportunity to politicians to jump into the fray and take sides to the detriment of the Chief Justice. A bill to address the supposed 'one-man show' of the CJI by the ruling politicos i.e., Supreme Court (Practice and Procedure) Bill 2023 was hastily passed, and yet another institution of 'checks-and-balances' was immediately compromised, de-fanged and diluted in its ability to question the government. The dissenting Judges who had instigated the dissent against 'own brother' was a throwback to the similar diminishment of the Pakistani Judiciary, as meted to former CJP Sajjad Ali Shah in tne late 90s. vv nile there might have genuine and very pertinent demands to reform the overburdened, inefficacious, and faltering Judicial system, this 'reform' move was not aimed at improving the same, as much as safeguarding itself from probing stances, suo moto activism and questioning, that the government rather not face.

The timing was ominous as the Pakistani Federal Minister for Law and Justice conceded that, "there is a right time for everything" and that they waited patiently, "until a voice came from within the courts" and they swooped in immediately. For once, the Pakistani Minister could not have been more honest – it is the providential or more likely than not the instigated 'divide' within the Judicial ranks (for obvious reasons) that opened the opportunity for insecure politicians to adorn a sanctimonious posture and 'reform' the Judiciary. One after the other, the so-called 'reforms' within various realms like Media, Military or Judiciary will be made that effectively benefit certain partisan persuasions as opposed to the institution, or the nation. The lesson for all institutions is to evolve and reform with time and disallow the politicians to 'reform' to their benefit, by infusing partisanship and politics.

There is no such thing as hate speech



If the fictitious concept of hate speech is accepted as real and valid, we may end up banning most books, including classics



phony concept is haunting India, the concept of 'hate speech.' Phony because there are no objective and universal standards that can define hate speech. Politicians and other public figures all over the world are often accused of making hate speeches. In general, if someone doesn't like a nasty comment—actually, any remark—they often dub it as 'hate speech'.' Demands are made to criminalise it.

Before proceeding to establish my assertion—that hate speech is a phony concept—I would like to discuss the concept of hate crime. Merriam-Webster defines 'hate crime' as "any of various crimes (as assault or defacement of property) when motivated by hostility to the victim as a member of a group (as one based on colour, creed, gender, or sexual orientation)." The US Congress describes a hate crime as "a criminal offense against a person or property motivated in whole or in part by an offender's bias against a race, religion, disability, ethnic origin or sexual orientation."

Hate itself, however, is not a crime—and the Federal Bureau of Investigation of the US is mindful of protecting freedom of beech and other civil liberties, says the FBI website.

Two points need to be made here. First, hate speech should not be confused with hate crime; the former, however offensive and repulsive, is still speech, a form of expression, and any form of expression is and should be protected in a liberal democracy. Hate crime, by definition, is a crime, and should be dealt with accordingly.

Second, hate is not and cannot be a crime in a democracy. On the face of it, this sounds paradoxical. For doesn't the Preamble of the Constitution of India, the world's largest democracy, talk about the resolve "to secure"—apart from justice, liberty, and equality—fraternity? How can fraternity be secured without rooting out, or at least checking, hate?

But this line of thinking is fallacious and fraught with the possibility of bolstering totalitarian tendencies; for hate, like love, lies within an individual's heart and mind; and any move to regulate the hearts and minds of citizens is tantamount to thought control—the defining feature of totalitari-

The purpose of legislation in a liberal polity is to legislate between individuals, to regulate inter-individual conduct and not intra-individual dynamics. Criminalising hate would amount to defining thought crime—another totalitarian tendency. Thankfully, the anti-totalitarian

streak is implicit in the Preamble, in as much as it describes fraternity as "assuring the dignity of the individual." It is obvious, then, that the dignity of the individual will be destroyed if the State decides to indulge in thought control, an endeavour that would necessitate intrusion into the most sacred spaces of the individual. Such fundamental rights as freedom of speech and expression (Article 19) and freedom of conscience (Article 25), enshrined in the Constitution, shield these spaces.

Unfortunately, even the top judicial experts in India have failed to realise that hate speech is a phony concept. Consequently, they keep debating over the need to curb it. But as the very concept of hate speech is phony, fictitious, and phantasmagoric, it can be grasped in any possible manner.

So, the Supreme Court judges, who are incensed by the falling standards of political debate, hold hate speech responsible for the fall. Last week, a Bench of Justices KM Joseph and BV Nagarathna said, "Hate speeches are like a vicious circle. One person will make it and then another will make it. When our Constitution was founded, there were no such speeches. Now cracks are coming up in the idea of fraternity. There has to be some restraint. Some sort of mechanism needs to be developed by the state so that we can curb these kinds of statements."

The apex court's intentions are laudable but its diagnosis of the problem of the perverted political

Solicitor General Tushar Mehta uses the concept of hate speech to defend the Government's position, arguing that such speeches are made not just against Muslims and Christians but also against Hindus. But he also highlighted something important. He quoted "a spokesperson of DMK" who said "whatever Periyar says should have been done... If you want equality, you must butcher all Brahmins."

Evidently, this led to some acrimony, with Justice Joseph reportedly asking if the Solicitor General knew who Periyar was. Mehta said he knew who Periyar was, and that hate speech cannot be justified just because someone great said it.

This brings us to the most important point: a lot of great men and women have said things that would be regarded as hate speech, blasphemous, derogatory, anti-poor, etc. Let's begin with the beginning. For Plato, slavery was a natural state of affairs, something which never bothered the great philosopher. He ...nature nerself intimates that it is just for the better to have more than the worse, the more powerful than the weaker; and in many ways she shows, among men as well as among animals, and indeed among whole cities and races, that justice consists in the superior ruling over and having more than the inferior.

His disciple and another great philosopher, Aristotle, justified slavery. According to him, "But is there any one thus intended by nature to be a slave, and for whom such a condition is expedient and right, or rather is not all slavery a violation of nature? There is no difficulty in answering this question, on grounds both of reason and of fact. For that some should rule and others be ruled is a thing not only necessary, but expedient; from the hour of their birth, some are marked out for subjection, others for rule."

Should the books by Plato and

Aristotle be banned?

Then there was the enfant terrible of Western philosophy, Nietzsche. Here are some of his gems: "Thou goest to woman? Do not forget thy whip!" "Man should be educated for war, and woman for the recreation of the warrior; all else is folly." "Let woman be a plaything." "Everything about woman has one solution: pregnancy."

Another great German philosopher, Schopenhauer, whom Nietzsche considered as his teacher, also made many unedifying comments on fair sex.

Madame Bovary and Anna Karenina could also be accused of glamorizing, if not promoting, adultery. Gone With the Wind, both the novel and the movie, is open to the criticism that it portrays slavery as practiced in the American South in soft focus. Dante's Divine Comedy depicts the Prophet Mohammad in a bad light. In India too, great authors have

expressed uncharitable views about women. Tuisidas famousiy said tha they, along with others, were fit to be beaten at will. Indian literary works can face charges of exalting ideals and values that would harm any society. Agyey's Shekhar: Ek Jiwani has shades of an incestuous relationship. Premchand's Nirmala also has a similar implication. Bimal Mitra's Sahib Bibi aur Ghulam, on which a great Hindi film was also made, is all about the decadence of feudalism, complete with mentions of debauchery and profligacy. UR Anantha Murthy's Kannada novel, Samskara, exposes the hollowness of Hindu traditions. Bankim Chandra's Anandmath does not have a very charitable mention of Muslims. The list of great authors who

Edtech made education accessible in Covid but not for all

Edtech should be developed in such a way that students belonging to disadvantaged groups can get access to it without any hassle

uring Covid-19, it was the internet and edtech that allowed teaching to continue around the world At the same time, its unavailability, and inaccessibility, has deprived several children of education. After Covid-19, with more investment in edtech, children from disadvantaged, underserved communities have been left behind.

In this fast-paced, edtech world, many first-generation learners find it difficult to operate internet-based video conferencing platforms like Zoom and attend classes. Furthermore, the lack of multiple smartphones in these lower-income families creates another barrier for children to benefit equally from online education.

from Uttam Nagar in Delhi, has four siblings and only one smartphone in her family. Recalling the struggle she faced during Covid-19, she explained, "It was very difficult for all of us to take online classes at the same time."

In India, the internet is accessible to only half the population, and 320 million students have been affected as schools went digital, according to the Save The Children Fund report. Mohan, an 18-year-old boy from Uttam Nagar, was one of those who could not adequately prepare for their Class 12 examination due to a lack of a digital device and internet connection. "I do not come from a financially stable background; my family and I faced great difficulties during the lockdown. There was no



food for us; thinking about the internet and a digital device was not our priority. This, however, impacted my education and I couldn't prepare well for such an important exam of my life," said Mohan.

As schools and colleges started conducting classes in

the online mode, some underprivileged parents opted to take loans to buy smartphones for their children. Uma, a factory worker, and the mother of a school-going child, said, "I wanted my child not to remain illiterate like me. I borrowed

phone and ensure that he is able to complete his education. I want him to get a decent

Teachers believe that online education hinders the social and practical development of children. A recent surmoney to buy him a mobile vey states that around 43 per

cent of teachers were not satisfied with online teaching during the pandemic. While the low attention span of students is considered one of the major drawbacks of online education, Akanksha Jain, a teacher from Uttam Nagar, identified absenteeism as another challenge. "Due to the non-availability of digital equipment, absenteeism was also quite common," Akanksha said.

While students residing in the capital of the country struggled to cope with the online classes, one can only imagine the level of challenges students in rural areas would have faced. Virtual classes are considered beneficial and convenient with the assumption that every student has access to the internet. In reality, however, only 600 million are connected to the internet out of India's 1.3-billion population. Besides, not every child in a household is given equal access to the internet and phones, especially girls. Thus, it indicates the level of discrimination children faced to access education, leading to the digital divide. Although edtech has

served as an essential teaching aid and increased the availability of resources for students, it has failed to become inclusive. It should be developed in such a way that students belonging to disadvantaged groups can get access to it without any hassle. Further, the applications used for receiving education should be made available in every language across different social groups.

the first step is to ensure that Ukraine prevails as a sovereign, independent nation." According to the organization's estimates, NATO and its allies have delivered close to 150 billion euros (USD 164 billion) in support to Ukraine since Russia invaded in February 2022.

That ranges from financial backing to field assistance including generators, fuel, tents and medical aid.

Some of the members, bilaterally or in groups, have supplied around 65 billion euros' (USD 71 billion) worth of military equipment: air defence systems, anti-tank weapons, artillery shells and tanks. Poland and Slovakia have even agreed to send Soviet-era jets that Ukrainian pilots are trained on. NATO, as an organisation, does not provide weapons to Ukraine. It's a line the 31 allies refuse to cross together. They are wary of being drawn into a wider war with nuclear-armed Russia. Instead, they defend NATO's

President Vladimir Putin from expanding his war.

The latest thinking is to better use a "comprehensive assistance package" set up for Ukraine in 2016, years before the war, to help the country provide for its own security and, according to the official description, "to implement wide-ranging reforms based on NATO standards, Euro-Atlantic principles and best practices." The idea is to create a fund that could, according to diplomats, total around 500 million euros (USD 548 million) and would run for about

10 years. Almost 200 million euros is believed to have been pledged so far. The amount seems small in comparison with other support, but it specifically targets reforms to help Ukraine help itself. Stoltenberg has been hesitant about publicly stating a figure or a time frame. Doing so could create expectations in Kyiv that the allies might not ultimately be able to meet.

Zelenskyy visits Poland to thank ally

Ukrainian President Volodymyr Zelenskyy and President his wife arrived in Poland Wednesday for a state visit that is meant as a gesture of thanks to the neighbouring nation for its crucial support in Ukraine's defense against Russia's invasion. The visit is a rare foray for Zelenskyy out of Ukraine since Russia unleased the war in February 2022. While it follows visits to the United States, Britain, France and Belgium, it stands out from the others because it was announced in advance without the secrecy of past visits. It is also unusual that the president is joined by the first lady, Olena Zelenska. Marcin Przydacz, the head of Polish President Andrzej Duda's foreign policy office, described it as Zelenskyy's first visit of this

Man in Brazil kills 4 children, injures 3 at daycare centre

London (AP): The husband of former Scottish first minister and Scottish National Party leader Nicola Sturgeon has been arrested in a party finance probe, British media reported Wednesday. Police in Scotland did not identify Peter Murrell as the 58-year old man arrested Wednesday "in connection with the ongoing investigation into the funding and finances of the Scottish National Party." However, Britain's Press Association, the BBC and others reported it was Murrell.

"Clearly it would not be appropriate to comment on any live police investigation but the SNP have been cooperating fully with this investigation and will continue to do so," the party said in a statement released after the arrest. Sturgeon, 52, announced her resignation in February after eight years as party leader and first minster of Scotland's semiautonomous government. Sturgeon said at that time that

Prime Minister Justin Trudeau has said a proper investigation is needed to get answers on the tragedy on the US-Canada border that resulted in the death of eight people from two families of Indian and Romanian descent and cautioned against speculating on what could have contributed it.

The members of the two families drowned last week in the St Lawrence River while they were attempting to enter the US from Canada illegally.Bodies of eight persons were recovered later from the marsh on the riverbank near Akwesasne, a community which straddles Quebec, Ontario and New York state. The Indian victims have been identified by their kin in India as Pravin Chaudhary (50), Dakshaben Chaudhary (45), their daughter Vidhi (23), and son Met (20). It is too soon

Italian ex-leader Silvio Berlusconi hospitalised

Rome (AP): Former Italian Premier Silvio Berlusconi was hospitalised on Wednesday in intensive care because of a problem related to a previous infection, but was alert and speaking, Italy's foreign minister said. The 86-year-old threetime premier was in the ICU at Milan's San Raffaele hospital, the clinic where he routinely receives care, said Foreign Minister Antonio Tajani, who is also a leader of Berlusconi's

Forza Italia party.

Speaking from Brussels, Tajani said Berlusconi was admitted because of an "unresolved problem" related to a previous infection. Berlusconi has had a series of health problems in recent years, most significantly recovering from COVID-19 in 2020. He told reporters after being discharged from a 10-day hospital stay then that disease had been "insidious" and was the most dangerous challenge he had ever faced. He has had a pacemaker for years, underwent heart surgery to replace an aortic valve in 2016 and has overcome prostate cancer. In January 2022 he was admitted for a reported urinary tract infection.Berlusconi had been to San Raffaele, where his personal physician works, for a regular checkup for several days just last week. In a March 31 tweet after he returned home, Berlusconi thanked "all those who wanted to send a thought or sign of affection in these days." He said he was already back at work "ready and determined to commit myself as I've always done to the country I love." Berlusconi, a media mogul-turned politician, made his latest political comeback in September general elections, winning a Senate seat a decade after being banned from holding public office over a tax fraud

Officials at the Korea Disease Control and Prevention Agency said on Wednesday that wastewater surveillance will potentially provide a cheaper and more sustainable tool in the country's

pandemic response. They say it could also improve the detection of other outbreaks, such as influenza, norovirus or drug-resistant bacteria. According to the plans, health workers will conduct tests on sewage samples collected from 64 wastewater facilities nationwide at least once a week and regularly release analyses of the test

results on its website. KDCA said its recent trial runs with cities and provincial

governments showed that the levels of pathogens found in sewage samples largely aligned with infection trends in those areas, confirming the value of testing water released from faucets, toilets and bathtubs. Similar tests have also been adopted in the United

South Korea had maintained a stringent COVID-19 response based on aggressive testing, contact tracing and quarantines during the earlier part of the pandemic, but has eased most of its virus controls since last year as the omicron variant's surge rendered those containment strategies irrele-

Government officials are also eager to revive a devastated service sector economy and attract more tourists. Their plans for wastewater testing are also an extension of their bendbut-not-break approach with COVID-19 that tolerates the coronavirus' spread among the broader population while concentrating medical resources to

Trump hush money case raises thorny legal issues

The cover-up is worse than the crime, the expression goes. And in the hush money case against for-mer President Donald Trump, prosecutors say the cover-up made the crime worse. In an indictment unsealed on Tuesday, prosecutors say the 45th president falsified records about three hush money payments in order to keep potentially damaging stories from coming to light as he campaigned for the presidency.

Manhattan District Attorney Alvin Bragg said it was his effort to cover up crimes related to the 2016 election that allowed prosecutors to elevate the charges to felonies. The indictment, however, raises many thorny issues about state and federal law that could provide openings for the defense to attack the charges to try to get them tossed before the case even gets to

"The bottom line is that it's murky," said Richard Hasen, an expert in election law and professor at the University of California, Los Angeles law school. "And the district attorney did not offer a detailed legal analysis as to how they can do this, how they can get around these potential hurdles. And it could potentially tie up the

case for a long time."

Trump has railed against the charges, saying he did nothing wrong and the case is political persecution. In remarks from his Mar-a-Lago home just a few hours after his court appearance, he said,

"This fake case was brought only to interfere with the upcoming 2024 election and it should be dropped immediately."

In the end, the case isn't about the tawdry details of the hush money payments. It isn't about the porn actor — Stormy Daniels — or Trump's acrimonious relationship with his onetime lawyer-turned government witness, Michael Cohen. It's about a presidential candidate using his money and influence to silence potentially damaging stories that might make voters choose another candidate, particularly as Trump's reputation was suffering at the time from comments he'd made about women. The 34 counts of falsifying business records would normally be misdemeanors, lower-level charges that would not normally result in prison

But they were bumped up to felonies — which carry up to four years behind bars - because, Bragg says, they were done in an effort to commit or conceal other

The USD 130,000 payment to Daniels exceeded the federal cap on campaign contributions, Bragg said. He also cited a New York state election law that makes it a crime to promote a candidate by unlawful means. "That is what this defendant did when he falsified business records in order to conceal unlawful efforts to promote his candidacy, and that is why we are here," one of the case prosecutors,

Chris Conroy, told the judge Tuesday. Prosecutors filed a "statement of facts" that told their story of a scheme to protect Trump's presidential prospects by buying and suppressing unflattering information about him.

Still, some legal observers were surprised that the indictment itself wasn't more specific about how each of the charges was elevated to

"There are an awful lot of dots here which it takes a bit of imagination to connect," said Richard Klein, a Touro Law Center criminal law professor. Bragg said the indictment

doesn't specify the potential underlying crimes because the law doesn't require it. But given the likelihood of Trump's lawyers challenging it, "you'd think they'd want to be on much firmer ground than some of this stuff," said Klein, a former New York City public defender. Hasen said it's not clear whether candidates for federal office can be prosecuted in cases involving state election laws. The defense may also argue the case can't be brought in state court if it involves a federal election law. Prosecutors, however, also alluded to another accusation involving tax law: that Trump's scheme included a plan to mischaracterize the payments to Cohen as income to New York tax authorities. "They did talk about tax crimes, and I think that could be potentially more compelling for the jury," Renato Mariotti, a former federal prosecutor, said on ABC

Trump's next in-person hearing in hush money case set for Dec 4

New York (PTI): The next inperson hearing in a criminal case against former president Donald Trump in New York City has been set for December 4, roughly two months before the official start of the 2024 Republican presidential primary calendar. Trump, the first former US President to be criminally charged, has pleaded not guilty to 34 felony counts of falsifying business records at his arraignment in a Manhattan court on charges relating to hush money payments made to porn star Stormy Daniels before the 2016 presidential election. At the December in-person court appearance, State Supreme Court Justice Juan M Merchan will decide on the expected motions to dismiss the case.

Following Trump's arraignment, prosecutors said they expect to produce the bulk of the discovery in the next 65 days, CNN reported. Trump's team has until August 8 to file any motions and the prosecution will respond by September 19. Judge Merchan said he will rule on the motions at the next in-person hearing on December 4.

Trump's attorney Jim Trusty said Tuesday he expects "robust" motions to challenge the case and hopes they can succeed in stopping the case. If not, Trusty said he expects Trump's attorneys will "figure out if there's a way to try to push this earlier" than the December 4 hearing.

Despite a massive fall in deal making in the March quarter, deal makers laughed their way to the bank with USD 261.5 million in investment banking fees during the same period, according

The amount is 2 per cent higher compared to the year-ago period. In the three months ended March, deal-mak-

ing activities declined for the third consecutive quarter, making it the slowest start to a year since 2016 amid multiple headwinds.

Geopolitical tensions, supply chain disruptions, rising interest hikes and global recession fears continue to dampen boardroom confidence and investor sentiment, Refinitiv, which is an LSEG business unit and among the world's largest providers of financial markets data and infrastructure, said in the report.

Equity Capital Market (ECM) underwriting fees rose 15 per cent to USD 50 million — the highest first quarter fees since 2021 while debt capital market underwriting fees totalled USD 71.4 million. The latter is a 22 per cent increase compared to the year-ago period.

Syndicated lending fees soared 86 per cent on-year generating USD 59.6 million in the first quar-

However, completed M&A advisory fees fell 35 per cent on-year and totalled USD 80.5 mil-

Wall Street investment banker Goldman Sachs took the top position for overall investment banking fees walking away with USD 20.2 million, accounting for 7.7 per cent of the wallet share

Majority of the deal making activity involving India were in the industrials sector which totalled USD 2.3 billion, up 1.1 per cent and captured 21.5 per cent market share.

Financials totalled USD 1.9 billion, down 55.2 per cent with 17.8 per cent market share. Energy & power captured 11.8 per cent market share with USD 1.3 billion deals, which was up 123.6 per cent more than the year-ago period.

"Serie A strongly condemns all instances of racism and any form of discrimination," Italy's top division said in a statement.

"A few people in the stands can't ruin football and don't represent all the fans at the stadium. Serie A clubs will, as they always have, be able to find the individuals responsible and ban them for life from their grounds.'

He will now oversee the introduction of a new format for the Champions League starting next

The new Champions League format will be introduced from the 2024/25 season, with the number of clubs involved in the group stage increasing from 32 to 36 teams all playing in one pool using what is known as the Swiss system. The new format will see all participants play
